Higher order convergence of perfectly matched layers in 3D bi-periodic surface scattering problems

Abstract

The perfectly matched layer (PML) is a very popular tool in the truncation of wave scattering in unbounded domains. In [4], the author proposed a conjecture that for scattering problems with rough surfaces, the PML converges exponentially with respect to the PML parameter in any compact subset. In the author's previous paper [16], this result has been proved for periodic surfaces in two dimensional spaces, when the wave number is not a half integer. In this paper, we prove that the method has a high order convergence rate in the 3D bi-periodic surface scattering problems. We extend the 2D results and prove that the exponential convergence still holds when the wavenumber is smaller than 0.5. For lareger wavenumbers, although exponential convergence is no longer proved, we are able to prove that a higher order convergence for the PML method.

1 Introduction

Since the PML method was proposed in [1] by Berenger in 1994, it has been widely used in the simulation of wave propagation problems in unbounded domains. The main idea is to add an artificial absorbing layer outside the physical domain. The out going wave is abosrbed so fast within the layer that its Dirichlet/Neumann data is approximated by zero. For the summary and drawbacks of the method we refer to [10]. Since this method is not exact, a key question here is the convergence analysis. For bounded obstacles, we refer to [5, 6, 8, 9, 12] for the error estimations.

For the case of unbounded obstacles, the problems become much more complicated and fewer results are available. In [4], for acoustic rough surface scattering problems, a linear convergence result was proved when the Neumann boundary condition was imposed. This also holds for the Dirichlet boundary condition with a similar proof. For Maxwell's equations, an exponential convergence was proved for absorbing wavenumbers, see [15]. For the special cases where the surfaces periodic and the incident fields are quasi-periodic, the exponential convergence is proved, and we refer to [7,17] for details.

In [4], the authors made a conjecture that although the convergence of the PML method was proved to be only linear, exponential convergence holds for any compact subdomains. Motivated by this conjecture, the author considered the 2D periodic surface scattering problems in [16] and exponential convergence was proved except for the cases when the wavenumbers are half-integers. When the wavenumber is a half-integer, since two singularities coincide, it is impossible to prove exponential convergence with the proposed method. What's worse, direct extension to 3D cases holds only for small wavenumbers, i.e., when the wavenumber is smaller than 0.5. For larger wavenumbers, the difficulty is exactly the same as the exceptional cases for 2D problems. In this paper, we will prove the high order convergence by a detailed study of coincided singularities.

First, we introduce the mathematical model and important notations for this problem. Let Γ be a bi-periodic surface in \mathbb{R}^3 defined by

$$\Gamma := \{ (t_1, t_2, \zeta(t_1, t_2)), t_1, t_2 \in \mathbb{R} \},\$$

where ζ is a bi-periodic and bounded function. For simplicity, we assume that ζ is 2π -periodic in both directions. The domain aboved Γ is defined by

$$\Omega := \{ (t_1, t_2, t_3) : t_1, t_2 \in \mathbb{R}, t_3 > \zeta(t_1, t_2) \}.$$

We are considering the following problem:

$$\Delta u + k^2 u = f \text{ in } \Omega; \quad u = 0 \text{ on } \Gamma, \tag{1}$$

where $f \in L^2(\Omega)$ is compactly supported.

Remark 1. The result for (1) can be easily extended to other boundary conditions, such as the impedance boundary condition of periodic layers, as long as the well posedness of the problem is guaranteed.

Let $\Gamma_H := \mathbb{R}^2 \times \{H\}$ be a plane lying above Γ , and the domain

$$\Omega_H := \{ x \in \mathbb{R}^3 : \zeta(x_1, x_2) < x_3 < H \}.$$




Figure 1: Domains and surfaces

For simplicity, let f be compactly supported in Ω_H . For the visualization we refer to Figure 1.

To guarantee that the solution u is physical, we need the so-called upward propagating radiation condition (UPRC, see [3]):

$$u(\boldsymbol{x}) = 2 \int_{\Gamma_H} \frac{\partial \Phi(\boldsymbol{x}, \boldsymbol{y})}{\partial x_3} u(\boldsymbol{y}) \,\mathrm{d}s(\boldsymbol{y}), \quad x_3 > H,$$

where $\Phi(\boldsymbol{x}, \boldsymbol{y}) = \frac{\exp(ik|\boldsymbol{x}-\boldsymbol{y}|)}{4\pi|\boldsymbol{x}-\boldsymbol{y}|}$ is the fundamental solution of the Helmholtz equation in \mathbb{R}^3 . In [3], it was proved that the UPRC is equivalent to the following boundary condition:

$$\frac{\partial u}{\partial x_3} = T^+ u = \mathrm{i} \int_{\mathbb{R}^2} \sqrt{k^2 - |\boldsymbol{\xi}|^2} \widehat{u}(\boldsymbol{\xi}, H) e^{\mathrm{i} \boldsymbol{\widetilde{x}} \cdot \boldsymbol{\xi}} \,\mathrm{d} \boldsymbol{\xi} \,, \quad \text{on } \Gamma_H$$
(2)

where $\widetilde{\boldsymbol{x}} = (x_1, x_2)^{\top}$, the square root takes non-negative real and imaginar parts, and

$$u(\widetilde{\boldsymbol{x}}, H) = \int_{\mathbb{R}^2} \widehat{u}(\boldsymbol{\xi}, H) e^{\mathrm{i}\widetilde{\boldsymbol{x}}\cdot\boldsymbol{\xi}} \,\mathrm{d}\boldsymbol{\xi}.$$

With this boundary condition, the problem is reduced to the 3D bi-periodic domain Ω_H with finite height.

The well-posedness of the problem (1)-(2) has been proved in both standard and weighted Sobolev spaces in [2,3]. We first introduce the weighted Sobolev space

$$H^{1}_{r}(\Omega_{H}) := \left\{ v \in H^{1}_{loc}(\Omega_{H}) : (1 + |\widetilde{\boldsymbol{x}}|^{2})^{r/2} v \in H^{1}(\Omega_{H}) \right\}.$$

Given any compactly supported $f \in L^2(\Omega_H)$, the problem (1)-(2) has a unique weak solution in $H^1_r(\Omega_H)$ where $r \in (-1, 1)$, and the solution u depends continuously on f.

We apply the Floquet-Bloch transform to (1)-(2), the solution u is written as an integral of a family of periodic solutions, with respect to the Floquet parameter in a unit square. From the perturbation theory and Neumann series, the periodic solutions depend analytically on the Floquet parameter except for finite number of circles (called singular curves). For any point on the singular curves, there are square root singularities with respect to the Floquet parameter. It is easily proved that the PML solution converges exponentially when the Floquet parameters are away from the singular curves. But the convergence becomes slower when the point is closer to the singular curves. In particular, the convergence is linear on the curves.

To deal with the slow convergence around the singular curves, we consider two cases separately. When the singular curve does not intersect with other curves, the 2D method is directly extended and the exponential convergence is proved. When multiple curves intersect at one point (fortunately we only have finite number of such points), we consider a small neighbourhood of this point. From a detailed study of the Neumann series around this point, we prove that the higher order convergence of the PML method.

The rest of this paper is organized as follows. In Section 2, the Floquet-Bloch transform and its application is introduced. In Section 3, the PML problems are described. We prove the convergence rate for a special case that k < 0.5 in Section 4, and prove that for larger k's in Section 5.

The following are some important notations in this paper.

2 The Floquet-Bloch transform

2.1 Definition of the Floquet-Bloch transform




Figure 2: One periodicity cell.

First we introduce the following notations. Let $\Omega_0 := \Omega \cap (-\pi, \pi)^2 \times \mathbb{R}$, $\Omega_H^0 := \Omega_H \cap (-\pi, \pi)^2 \times \mathbb{R}$, $\Gamma_0 := \Gamma \cap (-\pi, \pi)^2 \times \mathbb{R}$ and $\Gamma_H^0 := \Gamma_H \cap (-\pi, \pi)^2 \times \mathbb{R}$. For simplicity, we assume that f is compactly supported in Ω_H^0 . Let the first Brilloun zone be denoted as $W := [-1/2, 1/2]^2$. For the visualization of the periodicity cell we refer to Figure 2.

Define the Floquet-Bloch transform \mathcal{F} for any smooth compactly supported function $\phi \in C_0^{\infty}(\Omega_H)$ by:

$$(\mathcal{F}\phi)(\boldsymbol{\alpha},\boldsymbol{x}) = \sum_{\boldsymbol{j}\in\mathbb{Z}^2} \phi(\widetilde{\boldsymbol{x}} + 2\pi\boldsymbol{j}, x_3) e^{-\mathrm{i}\boldsymbol{\alpha}\cdot(\widetilde{\boldsymbol{x}} + 2\pi\boldsymbol{j})}$$

where $\boldsymbol{\alpha} = (\alpha_1, \alpha_2) \in W$ is the Floquet parameter. From [13,14], for any fixed $\boldsymbol{\alpha}$, $(\mathcal{F}\phi)(\boldsymbol{\alpha}, \cdot)$ is bi-periodic with respect to $\tilde{\boldsymbol{x}}$ with the period 2π , and $e^{i\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}}(\mathcal{F}\phi)(\boldsymbol{\alpha}, \boldsymbol{x})$ is bi-periodic with respect to $\boldsymbol{\alpha}$ with the period

1. Moreover, the following equations hold:

$$\left(\mathcal{F}\left(\frac{\partial\phi}{\partial x_{\ell}}\right)\right)(\boldsymbol{\alpha},\boldsymbol{x}) = \left(\frac{\partial}{\partial x_{\ell}} - \mathrm{i}\alpha_{\ell}\right)(\mathcal{F}\phi)(\boldsymbol{\alpha},\boldsymbol{x}), \ \ell = 1, 2, \quad \left(\mathcal{F}\left(\frac{\partial\phi}{\partial x_{3}}\right)\right)(\boldsymbol{\alpha},\boldsymbol{x}) = \frac{\partial}{\partial x_{3}}(\mathcal{F}\phi)(\boldsymbol{\alpha},\boldsymbol{x}).$$

To introduce the important properties of the Floquet-Bloch transform \mathcal{F} , we first need the definitions of the following spaces. For details we refer to [13]. We begin with the space $H^{\ell}(W; H^{s}(\Omega_{H}^{0}))$, where $\ell \in \mathbb{N}_{0}$ and $s \in \mathbb{R}$. This space contains all elements in the distribution space defined in $W \times \Omega_{H}^{0}$ with finite norm

$$\|\psi\|_{H^{\ell}\left(W;H^{s}(\Omega_{H}^{0})\right)} = \left[\sum_{\boldsymbol{\gamma}\in\mathbb{N}^{2}_{0},\,|\boldsymbol{\gamma}|\leq\ell}\int_{W}\|\partial_{\boldsymbol{\alpha}}^{\boldsymbol{\gamma}}\psi(\boldsymbol{\alpha},\cdot)\|_{H^{s}(\Omega_{H}^{0})}^{2}\,\mathrm{d}\boldsymbol{\alpha}\right]^{1/2}$$

Then for any $0 < \theta < 1$, we define the space $H^{\ell+\theta}(W; H^s(\Omega^0_H))$ by space interpolation:

$$H^{\ell+\theta}\left(W; H^s(\Omega^0_H)\right) = \left[H^\ell\left(W; H^s(\Omega^0_H)\right), H^{\ell+1}\left(W; H^s(\Omega^0_H)\right)\right]_{\theta}$$

Thus $H^r(W; H^s(\Omega^0_H))$ is well defined for all $r \ge 0$ and $s \in \mathbb{R}$. The dual space of $H^r(W; H^s(\Omega^0_H))$ with respect to the inner product

$$(\psi_1, \psi_2) = \int_W (\psi_1(\boldsymbol{\alpha}, \cdot), \psi_2(\boldsymbol{\alpha}, \cdot))_{H^s(\Omega^0_H)} \, \mathrm{d}\boldsymbol{\alpha}$$

is denoted by $H^{-r}(W; H^s(\Omega^0_H))$. Let $H^r(W; H^s_{per}(\Omega^0_H))$ be the subspace of $H^r(W; H^s(\Omega^0_H))$, where all the elements are periodic with fixed $\boldsymbol{\alpha}$. Now we are prepared to introduce the following properties of \mathcal{F} .

Theorem 2 (Theorem 8, [13]). The Floquet-Bloch transform \mathcal{F} is extended to an isomorphism between $H^s_r(\Omega_H)$ and $H^r(W; H^s_{per}(\Omega^0_H))$ for any $s, r \in \mathbb{R}$. The inverse transform is defined as

$$\left(\mathcal{F}^{-1}\psi\right)(\widetilde{\boldsymbol{x}}+2\pi\boldsymbol{j},x_3) = \int_W \psi(\boldsymbol{lpha},\boldsymbol{x})e^{\mathrm{i}\boldsymbol{lpha}\cdot(\widetilde{\boldsymbol{x}}+2\pi\boldsymbol{j})}\,\mathrm{d}\boldsymbol{lpha}\,,\quad \boldsymbol{x}\in\Omega^0_H,\,\boldsymbol{j}\in\mathbb{Z}^2.$$

2.2 Periodic problems and regularity

Now we apply the Floquet-Bloch transform to the original problem (1). Let $w(\boldsymbol{\alpha}, \boldsymbol{x}) := \mathcal{F}u$. For any fixed Floquet parameter $\boldsymbol{\alpha}$, from direct computation, $w(\boldsymbol{\alpha}, \cdot)$ is bi-periodic and satisfies

$$\Delta w(\boldsymbol{\alpha}, \cdot) + 2\mathrm{i}\boldsymbol{\alpha} \cdot \widetilde{\nabla} w(\boldsymbol{\alpha}, \cdot) + (k^2 - |\boldsymbol{\alpha}|^2) w(\boldsymbol{\alpha}, \cdot) = e^{-\mathrm{i}\boldsymbol{\alpha} \cdot \widetilde{\boldsymbol{x}}} f \text{ in } \Omega_H^0; \quad w(\boldsymbol{\alpha}, \cdot) = 0 \text{ on } \Gamma_0, \tag{3}$$

with the boundary condition:

$$\frac{\partial w(\boldsymbol{\alpha}, \cdot)}{\partial x_3} = T^+_{\boldsymbol{\alpha}} w(\boldsymbol{\alpha}, \cdot) = \mathrm{i} \sum_{\boldsymbol{j} \in \mathbb{Z}^2} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}|^2} \widehat{w}(\boldsymbol{\alpha}, \boldsymbol{j}) e^{\mathrm{i} \boldsymbol{j} \cdot \widetilde{\boldsymbol{x}}} \text{ on } \Gamma^0_H.$$

Similar to the results in 2D cases in [11], the problem (3)-(4) has a unique solution in $H^1_{\text{per}}(\Omega^0_H)$ for any fixed $\boldsymbol{\alpha} \in W$, where $H^1_{\text{per}}(\Omega^0_H)$ is the subspace of $H^1(\Omega^0_H)$ for bi-periodic functions. Thus $w(\boldsymbol{\alpha}, \cdot)$ is well defined for any $\boldsymbol{\alpha} \in W$, then the original solution u is given by the inverse Floquet-Bloch transform:

$$u(\boldsymbol{x}) = \int_{W} e^{i\boldsymbol{\alpha}\cdot\boldsymbol{\widetilde{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} \,, \quad \boldsymbol{x} \in \Omega_{H}.$$
(5)

The variational form for (3)-(4) is given as follows. Find $w(\boldsymbol{\alpha}, \cdot) \in H^1_{\text{per}}(\Omega^0_H)$ such that

$$\int_{\Omega_{H}^{0}} \left[\nabla w(\boldsymbol{\alpha}, \cdot) \cdot \nabla \overline{\phi} - 2\mathbf{i}\boldsymbol{\alpha} \cdot \widetilde{\nabla} w(\boldsymbol{\alpha}, \cdot) \overline{\phi} - (k^{2} - |\boldsymbol{\alpha}|^{2}) w(\boldsymbol{\alpha}, \cdot) \overline{\phi} \right] d\boldsymbol{x} -4\pi^{2} \mathbf{i} \sum_{\boldsymbol{j} \in \mathbb{Z}^{2}} \sqrt{k^{2} - |\boldsymbol{\alpha} + \boldsymbol{j}|^{2}} \widehat{w}(\boldsymbol{\alpha}, \boldsymbol{j}) \overline{\widehat{\phi}(\boldsymbol{j})} = -\int_{\Omega_{H}^{0}} e^{-\mathbf{i}\boldsymbol{\alpha} \cdot \widetilde{\boldsymbol{x}}} f(\boldsymbol{x}) \overline{\phi}(\boldsymbol{x}) d\boldsymbol{x}.$$

$$\tag{6}$$

From Riesz representation theorem, we define the following operators and functions:

$$\begin{split} \langle A(\boldsymbol{\alpha})\psi,\phi\rangle &:= \int_{\Omega_{H}^{0}} \left[\nabla\psi\cdot\nabla\overline{\phi} - 2\mathrm{i}\left(\boldsymbol{\alpha}\cdot\widetilde{\nabla}\psi\right)\overline{\phi} - (k^{2} - |\boldsymbol{\alpha}|^{2})\psi\overline{\phi}\right]\,\mathrm{d}\boldsymbol{x}\,;\\ \langle B_{\boldsymbol{j}}\psi,\phi\rangle &= 4\pi^{2}\mathrm{i}\widehat{\psi}(\boldsymbol{j})\overline{\widehat{\phi}(\boldsymbol{j})};\\ \langle G(\boldsymbol{\alpha},\cdot),\phi\rangle &= -\int_{\Omega_{H}^{0}}e^{-\mathrm{i}\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}}f(\boldsymbol{x})\overline{\phi}(\boldsymbol{x})\,\mathrm{d}\boldsymbol{x}\,; \end{split}$$

where $\phi, \psi \in H^1_{\text{per}}(\Omega^0_H)$. The operators $A(\alpha)$ and B_j are bounded in $H^1_{\text{per}}(\Omega^0_H)$. Since $|\alpha|^2 = \alpha_1^2 + \alpha_2^2$, all the operators and functions depend real analytically on $\alpha \in \mathbb{R}^2$. The variational equation (6) is written as:

$$\left[A(\boldsymbol{\alpha}) - \sum_{\boldsymbol{j} \in \mathbb{Z}^2} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}|^2} B_{\boldsymbol{j}}\right] w(\boldsymbol{\alpha}, \cdot) := S(\boldsymbol{\alpha}) w(\boldsymbol{\alpha}, \cdot) = G(\boldsymbol{\alpha}, \cdot).$$

Since the problem is always well-posed for any $\alpha \in W$, there is a constant C > 0 such that $||S^{-1}(\alpha)|| \leq C$ holds for all $\alpha \in W$.

From (7), when α is away from zeros of all the square roots, $S(\alpha)$ depends real analytically on α in \mathbb{R}^2 . But when at least one square root is close to 0, there is a square root singularity. Since those points are critical in the following analysis, we need the following notations for simplicity. First, let

$$P := \Big\{ \boldsymbol{\alpha} \in W : \exists \, \boldsymbol{j} \in \mathbb{Z}^2, \text{ such that } |\boldsymbol{\alpha} + \boldsymbol{j}| = k \Big\}.$$

For any $\boldsymbol{\alpha} \in P$, define

$$J(\boldsymbol{\alpha}) := \Big\{ \boldsymbol{j} \in \mathbb{Z}^2 : |\boldsymbol{\alpha} + \boldsymbol{j}| = k \Big\}.$$




Figure 3: Structures of P with different k's.

We refer to Figure 3 for different structures of P with different wave number k's.

Remark 3. There are only finite number of α 's such that $\#J(\alpha) > 1$. In particular, when k < 0.5, $P = S(\mathbf{0}, k)$. Moreover, for all the $\alpha \in P$, $\#J(\alpha) = 1$.

We consider a random point $\boldsymbol{\alpha}_0 \in P$, suppose $\#J(\boldsymbol{\alpha}_0) = m \in \mathbb{N}_0$. Let $J(\boldsymbol{\alpha}_0) := \{\boldsymbol{j}_1, \ldots, \boldsymbol{j}_m\}$. Since the square root function is continuous with real valued variables, there is a sufficiently small $r_0 > 0$ such that for any $\boldsymbol{\alpha} \in D(\boldsymbol{\alpha}_0, r_0), \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}|^2} \neq 0$ for all $\boldsymbol{j} \notin J(\boldsymbol{\alpha}_0)$. In this case, let

$$\widetilde{A}(\boldsymbol{\alpha}) := A(\boldsymbol{\alpha}) - \sum_{\boldsymbol{j} \notin J(\boldsymbol{\alpha}_0)} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}|^2} B_{\boldsymbol{j}},$$

then $\widetilde{A}(\boldsymbol{\alpha})$ depends analytically on $\boldsymbol{\alpha} \in D(\boldsymbol{\alpha}_0, r_0)$. Moreover, when $r_0 > 0$ is sufficiently small, $\widetilde{A}(\boldsymbol{\alpha}) = S(\boldsymbol{\alpha}) - \sum_{\ell=1}^{m} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_{\ell}|^2} B_{\boldsymbol{j}_{\ell}}$ is a small perturbation of $S(\boldsymbol{\alpha})$ thus $\widetilde{A}^{-1}(\boldsymbol{\alpha})$ exists and is uniformly bounded. Then

$$\widetilde{A}(\boldsymbol{\alpha}) + \sum_{\ell=1}^{m} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_{\ell}|^2} B_{\boldsymbol{j}_{\ell}} \right] w(\boldsymbol{\alpha}, \cdot) = G(\boldsymbol{\alpha}, \cdot)$$

is equivalent to

$$\left[I - \sum_{\ell=1}^{m} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_{\ell}|^2} \widetilde{B}_{\ell}(\boldsymbol{\alpha})\right] w(\boldsymbol{\alpha}, \cdot) = \widetilde{G}(\boldsymbol{\alpha}, \cdot)$$

where $\widetilde{B}_{\ell}(\boldsymbol{\alpha}) = -\widetilde{A}^{-1}(\boldsymbol{\alpha})B_{\boldsymbol{j}_{\ell}}$ and $\widetilde{G}(\boldsymbol{\alpha},\cdot) = -\widetilde{A}^{-1}(\boldsymbol{\alpha})G(\boldsymbol{\alpha},\cdot)$. We can easily obtain the form of solution from the Neumann series:

$$w(\boldsymbol{\alpha}, \cdot) = \sum_{n=0}^{\infty} \left[\sum_{\ell=1}^{m} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_{\ell}|^2} \widetilde{B}_{\ell}(\boldsymbol{\alpha}) \right]^n \widetilde{G}(\boldsymbol{\alpha}, \cdot)$$
$$= \sum_{X \subset \{1, 2, \dots, m\}} \left(\prod_{\ell \in X} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_{\ell}|^2} \right) w_X(\boldsymbol{\alpha}, \cdot),$$
(8)

where $w_X(\boldsymbol{\alpha}, \cdot)$ depends real analytically on $\boldsymbol{\alpha}$ in $D(\boldsymbol{\alpha}_0, r_0)$. In particular, when $m = 1, J(\boldsymbol{\alpha}_0) = \{\boldsymbol{j}_1\}$ and

$$w(\boldsymbol{\alpha}, \cdot) = w_0(\boldsymbol{\alpha}, \cdot) + \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2} w_1(\boldsymbol{\alpha}, \cdot),$$
(9)

where $w_0(\boldsymbol{\alpha}, \cdot), w_1(\boldsymbol{\alpha}, \cdot)$ depend real analytically on $\boldsymbol{\alpha}$.

3 Analytic extension and modification of the inverse Floquet-Bloch transform

In this section, we consider the analytic extension of $w(\alpha, \cdot)$ with respect to α , when α is near the singular curves. With this extension, we also obtain an equivalent form of the inverse Floquet-Bloch transform (5). At first, we redefine the square root function " $\sqrt{}$ " to have the branch cut on negative imaginary axis:

$$\sqrt{z} = \sqrt{|z|} \exp\left(\frac{\mathrm{i}t}{2}\right)$$
, where $t \in \left(-\frac{\pi}{2}, \frac{3\pi}{2}\right]$.

3.1 Analytic extension

For simplicity, we first assume for any $-\mathbf{j} \in \mathbb{Z}^2$, either $S(-\mathbf{j}, k) \cap W^\circ \neq \emptyset$ or $S(-\mathbf{j}, k) \cap W = \emptyset$, where $W^\circ = (-1/2, 1/2)^2$ is the interior of W. This means that there are no curves which are tangential to W from the exterior of it. So if a circle $S(-\mathbf{j}, k)$ does not pass through W, it has a positive distance with \overline{W} , defined as:

$$\delta_W := d\Big(S(-\boldsymbol{j},k),W\Big).$$

Actually, this assumption can be guaranteed by the translation of W.

The number of singular circles that have non-empty intersection with W is finite, denoted by

$$S(-\boldsymbol{j}_{\ell},k), \quad \ell=1,2,\ldots,M.$$

Note that when k < 0.5, M = 1 and $j_1 = 0$. It is more convenient to use the polar coordinate to study the analytical behaviour near the circles. For any $\ell = j_{\ell}$, let α be a point close to the circle $S(-\ell, k)$ and set $\alpha := (s \cos \phi, s \sin \phi) - \ell$. With abuse of notation, we replace the variable $\alpha \in \mathbb{R}^2$ in the functions and operators with $(s, \phi) \in \mathbb{R}^2$ to denote the dependence of the new variables s and ϕ . Thus the variational problem (6) is written as the new form:

$$\int_{\Omega_{H}^{0}} \left[\nabla w(s,\phi,\cdot) \cdot \nabla \overline{\phi} - 2\mathbf{i}(s\cos\phi - \ell_{1},s\sin\phi - \ell_{2}) \cdot \widetilde{\nabla} w(s,\phi,\cdot) \overline{\phi} - (k^{2} - (s\cos\phi - \ell_{1})^{2} - (s\sin\phi - \ell_{2})^{2})w(s,\phi,\cdot)\overline{\phi} \right] d\mathbf{x} \\
- 4\pi^{2}\mathbf{i} \sum_{\mathbf{j}\in\mathbb{Z}^{2}} \sqrt{k^{2} - (s\cos\phi - \ell_{1} + j_{2})^{2} - (s\sin\phi - \ell_{2} + j_{2})^{2}} \widehat{w}(s,\phi,\mathbf{j}) \overline{\phi}(\mathbf{j}) \qquad (10)$$

$$= -\int_{\Omega_{H}^{0}} e^{-\mathbf{i}(s\cos\phi - \ell_{1},s\sin\phi - \ell_{2})\cdot\widetilde{\mathbf{x}}} f(\mathbf{x})\overline{\phi}(\mathbf{x}) d\mathbf{x}.$$

From the definition and the analytical dependence of $\boldsymbol{\alpha}$ on (s, ϕ) , $\widetilde{A}(s, \phi)$ and $G(s, \phi, \cdot)$ depend analytically on (s, ϕ) . From the perturbation theory, the inverse operator $\widetilde{A}^{-1}(s, \phi)$ depends analytically in a small neighbourhood of (s, ϕ) . Thus $\widetilde{B}(s, \phi)$ and $\widetilde{G}(s, \phi, \cdot)$ also depend analytically on (s, ϕ) .

=

From the Neumann series (8), each $w_X(s, \phi, \cdot)$ involves finite number of operators $\widetilde{B}_{\ell}(s, \phi)$ and one element $\widetilde{G}(s, \phi, \cdot)$ and finite number of terms $\sqrt{k^2 - |\alpha + j_{\ell}|^2}^{2\ell_m}$ where $\ell_m \in \mathbb{N}$. Since

$$\sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_\ell|^2}^{2\ell_m} = \left(k^2 - (s\cos\phi - \ell_1 + j_2)^2 - (s\sin\phi - \ell_2 + j_2)^2\right)^{\ell_m}$$

where ℓ_m is a non-negative integer, it depends analytically on s and ϕ . Then $w_X(s, \phi, \cdot)$ depends analytically on s and ϕ . Thus there are two small positive numbers $\delta_0, \varepsilon_0 > 0$ such that when $(s, \phi) \in B(k, \delta_0) \times B(\phi_0, \varepsilon_0) \subset \mathbb{C} \times \mathbb{C}, w_X(s, \phi, \cdot)$ depends analytically on (s, ϕ) .

For any point (k, ϕ_0) where $\phi_0 \in [0, 2\pi]$ and subset $X \subset \{1, 2, \ldots, m\}$, the function $w_X(s, \phi, \cdot)$ depends analytically in a neighburhood $B(k, \delta_0) \times B(\phi_0, \varepsilon_0)$. Since $[0, 2\pi]$ is compact and $[0, 2\pi] \subset \bigcup_{\phi \in [0, 2\pi]} B(\phi, \varepsilon_{\phi})$, from Heine-Borel Theorem, there is a finite cover $[0, 2\pi] \subset \bigcup_{\ell=1}^N B(\phi_\ell, \varepsilon_\ell)$. Let $\delta := \min\{\delta_{\phi_\ell} : \ell = 1, 2, \ldots, N\}$, then $w_X(s, \phi, \cdot)$ depends analytically on (s, ϕ) in $B(k, \delta) \times \bigcup_{\ell=1}^N B(\phi_\ell, \varepsilon_{\phi_\ell}) \supset B(k, \delta) \times [0, 2\pi]$. This implies that for any $\phi \in [0, 2\pi]$, $w_X(s, \phi, \cdot)$ depends analytically on $s \in B(k, \delta)$. Note that here $w_X(s, \phi, \cdot)$ is defined piecewisely with respect to the angle ϕ .

Since the above result holds for any $\ell = j_{\ell}$, we can choose a sufficiently small $\delta > 0$ such that $w_X(s, \phi, \cdot)$ depends analytically on $s \in B(k, \delta) \subset \mathbb{C}$ for any fixed $\phi \in [0, 2\pi]$, in its own polar coordinate system. From the periodicity of the distribution of singular circles, this result holds uniformly in the neighbourhood for any circle S(-j, k) with $j \in \mathbb{Z}^2$.

Remark 4. From now on, we also require that $\delta < \delta_W$ to avoid further complexities.

3.2 Reformulation of the inverse Floquet-Bloch transform

For any circle $S(-\mathbf{j}_{\ell}, k)$ where $\ell = 1, 2, ..., M$, we define the annulus $A(-\mathbf{j}_{\ell}, k, \delta)$, where the parameter $\delta > 0$ is chosen in the previous subsection. The set

$$R := W \setminus \left[\cup_{\ell=1}^{M} A(-\boldsymbol{j}_{\ell}, k, \delta) \right].$$

Then for any point in R, its distance to any singular circles is not less than δ .

For the case k < 0.5, there is only one circle $S(\mathbf{0}, k)$ that has non-empty intersection with W. In this case, we also require that $\delta < \min\{k, 0.5 - k\}$ to guarantee that $A(\mathbf{0}, k, \delta)$ is a well defined annulus in the domain W. Then define

$$S := A(\mathbf{0}, k, \delta) \subset W,$$

we easily split $W := S \cup R$. But the case that $k \ge 0.5$ is much more complicated.

Suppose α_0 is a point such that $\#J(\alpha_0) = m > 1$. Let $J(\alpha_0) = \{\ell_1, \ldots, \ell_m\}$, then all the circles $S(-\ell_1, k), \ldots, S(-\ell_m, k)$ have a common point α_0 . Thus in the disk $D(\alpha_0, 2\delta)$, the annuluses $A(-\ell_1, k, \delta), \ldots, A(-\ell_m, k, \delta)$ have intersections with each other; outside this ball, each annulus does not have intersections with any other annuluses. For any ℓ_t where $t = 1, 2, \ldots, m$, we find two angles $\xi_t < \eta_t$ such that $A(-\ell_t, k, \delta, [\xi_t, \eta_t])$ is the smallest such that $A(-\ell_t, k, \delta) \cap D(\alpha_0, 2\delta) \subset A(-\ell_t, k, \delta, [\xi_t, \eta_t])$. Let

$$Q(\boldsymbol{\alpha}_0) = \bigcup_{t=1}^m A(-\boldsymbol{\ell}_t, k, \delta, [\boldsymbol{\xi}_t, \eta_t]),$$

then the area of $Q(\boldsymbol{\alpha}_0) = O(\delta^2)$. Let




Figure 4: Intersection of two annulus. The light blue partial annuluses $A(-\ell_t, k, \delta, [\xi_t, \eta_t])$ are subsets of blue full annuluses $A(-\ell_t, k, \delta)$. The yellow disk is $D(\alpha_0, 2\delta)$. The union of light blue partial annuluses is the set $Q(\alpha_0)$.

$$Q := \bigcup_{\boldsymbol{\alpha}_0 \in P: \#J(\boldsymbol{\alpha}_0) > 1} Q(\boldsymbol{\alpha}_0)$$

then it contains all the intersections with different singular circles. For the definition of the domain $Q(\alpha_0)$ we refer to Figure 4.

Now the inverse Floquet-Bloch transform is written as

$$u(\boldsymbol{x}) = \int_{R} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} + \int_{Q} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} + \int_{W \setminus (R \cup Q)} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha}$$




Figure 5: Distribution of the singular curves. The curves with the same color and line style are identical in the sence of periodic translation.

When k < 0.5, $Q = \emptyset$ and the domain $W \setminus R$ is the full annulus $A(\mathbf{0}, k, \delta)$. But when $k \ge 0.5$, $Q \ne \emptyset$ and the structure of $W \setminus (R \cup Q)$ becomes more complicated. Now we focus on the this domain. First we modify the set $W \setminus (R \cup Q)$. From the distribution of the singular circles (see Figure 5),

$$\cup_{\ell=1}^{M} \left\{ \boldsymbol{\alpha} + \boldsymbol{j}_{\ell} : \, \boldsymbol{\alpha} \in S(-\boldsymbol{j}_{\ell}, k) \cap W \right\} = S(\boldsymbol{0}, k).$$

This result also holds for the annulus, since $\delta < \delta_W$:

$$\cup_{\ell=1}^{M} \left\{ \boldsymbol{\alpha} + \boldsymbol{j}_{\ell} : \, \boldsymbol{\alpha} \in A(-\boldsymbol{j}_{\ell}, k, \delta) \cap W \right\} = A(\boldsymbol{0}, k, \delta).$$

Thus we translate all the partial annulus $A(-j_{\ell}, k, \delta) \cap W$ by $\alpha + j_{\ell}$, then it becomes a subset of $A(\mathbf{0}, k, \delta)$.

Since the domain Q is defined by the union of finite number of partial annulus, the set,

$$\cup_{\ell=1}^{M} \Big\{ \boldsymbol{\alpha} + \boldsymbol{j}_{\ell} : \, \boldsymbol{\alpha} \in A(-\boldsymbol{j}_{\ell}, k, \delta) \cap W \setminus Q \Big\}$$

is the union of several non-intersective partial annuluses, denoted by $A(\mathbf{0}, k, \delta, [\zeta_i, \psi_i])$ where i = 1, 2, ..., nfor some positive integer n. Then from the periodicity of $e^{i\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}}w(\boldsymbol{\alpha}, \boldsymbol{x})$ with respect to $\boldsymbol{\alpha}$, finally we get

$$\int_{W \setminus (R \cup Q)} e^{i \boldsymbol{\alpha} \cdot \widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha}, \boldsymbol{x}) \, \mathrm{d}\boldsymbol{\alpha} = \sum_{i=1}^n \int_{A(\mathbf{0}, k, \delta, [\zeta_i, \psi_i])} e^{i \boldsymbol{\alpha} \cdot \widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha}, \boldsymbol{x}) \, \mathrm{d}\boldsymbol{\alpha}$$

So we define $S = \bigcup_{t=1}^{n} A(\mathbf{0}, k, \delta, [\zeta_i, \psi_i])$, then

$$u(\boldsymbol{x}) = \int_{R} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} + \int_{Q} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} + \int_{S} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} \,.$$

Finally we modify the integral on any partial annulus $A(\mathbf{0}, k, \delta, [\zeta_i, \psi_i])$. With polar coordinate,

$$\int_{A(\mathbf{0},k,\delta,[\zeta_i,\psi_i])} e^{\mathbf{i}\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} = \int_{\zeta_i}^{\psi_i} \int_{k-\delta}^{k+\delta} e^{\mathbf{i}s(\cos\phi,\sin\phi)\cdot\widetilde{\boldsymbol{x}}} w(s,\phi,\boldsymbol{x})s \,\mathrm{d}s \,\mathrm{d}\phi$$

In the form (8), only the term $\sqrt{k^2 - |\boldsymbol{\alpha} + \mathbf{0}|^2} = \sqrt{k^2 - s^2}$ has singularity, thus $w(s, \phi, \cdot)$ has the form of




Figure 6: The domain $B_{-}(k, r)$ and curve $C_{-}(k, r)$. The red ray is the branch cut for the function $w(s, \phi, \cdot)$ with respect to s.

$$w(s,\phi,\cdot) = w_0(s,\phi,\cdot) + \sqrt{k^2 - s^2} w_1(s,\phi,\cdot),$$

where w_0 and w_1 depends analytically on $s \in B(k, \delta)$. Thus $w(s, \phi, \cdot)$ is extended analytically to $s \in B_-(k, \delta)$ due to the new definition of the square root function. For the visualization we refer to Figure 6. From Lemma 5 in [16], we get the modified formulation:

$$\int_{A(\mathbf{0},k,\delta,[\zeta_i,\psi_i])} e^{\mathbf{i}\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} = \int_{\zeta_i}^{\psi_i} \int_{C_-(k,\delta)} e^{\mathbf{i}s(\cos\phi,\sin\phi)\cdot\widetilde{\boldsymbol{x}}} w(s,\phi,\boldsymbol{x})s \,\mathrm{d}s \,\mathrm{d}\phi.$$

Then

$$u(\boldsymbol{x}) = \int_{R} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} + \int_{Q} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} + \sum_{i=1}^{n} \int_{\zeta_{i}}^{\psi_{i}} \int_{C_{-}(k,\delta)} e^{is(\cos\phi,\sin\phi)\cdot\widetilde{\boldsymbol{x}}} w(s,\phi,\boldsymbol{x}) s \,\mathrm{d}s \,\mathrm{d}\phi \,.$$
(11)

4 Approximation by perfectly matched layers

We add a PML layer above Γ_H with thickness $\lambda > 0$. The layer is defined by a function $\kappa(x_3) = 1 + \rho \hat{\kappa}(x_3)$. Here $\rho > 0$ is a parameter, $\hat{\kappa}(x_3)$ is a sufficiently smooth function:

$$\widehat{\kappa}(x_3) = \begin{cases} \mathcal{X}\left(\frac{x_3 - H}{\lambda}\right)^m, & x_3 \in [H, H + \lambda], \\ 0, & x_3 < H, \end{cases}$$

and \mathcal{X} is fixed with positive real and imaginary parts, m a positive integer to guarantee the smoothness of the function. Let

$$\sigma := \int_{H}^{H+\lambda} \kappa(x_3) \, \mathrm{d}x_3 = \lambda \left(1 + \frac{\rho \mathcal{X}}{m+1} \right).$$

We consider the PML solutions with two different boundary conditions, i.e., the Dirichlet and Neumann boundary condition. For simplicity, we denote the two solutions uniformly as u_I^{σ} where I = D, N. The PML solution u_I^{σ} is described by the following equation with boundary condition on Γ :

$$\widetilde{\nabla} \cdot \widetilde{\nabla} u_I^{\sigma} + \frac{1}{\kappa(x_3)} \frac{\partial}{\partial x_3} \left(\frac{1}{\kappa(x_3)} \frac{\partial u_I^{\sigma}}{\partial x_3} \right) + k^2 u_I^{\sigma} = f \text{ in } \Omega_{H+\lambda}; \quad u_I^{\sigma} = 0 \text{ on } \Gamma,$$
(12)

with the Dirichlet boundary condition

$$u_D^{\sigma} = 0 \text{ on } \Gamma_{H+\lambda},\tag{13}$$

or the Neumann boundary condition

$$\frac{\partial u_N^{\sigma}}{\partial x_3} = 0 \text{ on } \Gamma_{H+\lambda}.$$
(14)

Note that in the physical domain Ω_H , the PML solution u_I^{σ} satisfies

$$\Delta u_I^{\sigma} + k^2 u_I^{\sigma} = f \text{ in } \Omega_H; \quad u_I^{\sigma} = 0 \text{ on } \Gamma.$$

From [4], the transparent boundary condition for u_D^{σ} can be given as follows:

$$\frac{\partial u_D^{\sigma}}{\partial x_3} = T^{\sigma,D} u_D^{\sigma} = \mathrm{i} \int_{\mathbb{R}^2} \sqrt{k^2 - |\boldsymbol{\xi}|^2} \coth\left(-\mathrm{i}\sqrt{k^2 - |\boldsymbol{\xi}|^2}\sigma\right) \widehat{u}_D^{\sigma}(\boldsymbol{\xi}, H) e^{\mathrm{i}\widetilde{\boldsymbol{x}}\cdot\boldsymbol{\xi}} \,\mathrm{d}\boldsymbol{\xi}\,. \tag{15}$$

Similarly, the transparent boundary condition for u_N^{σ} is given by:

$$\frac{\partial u_N^{\sigma}}{\partial x_3} = T^{\sigma,N} u_N^{\sigma} = \mathrm{i} \int_{\mathbb{R}^2} \sqrt{k^2 - |\boldsymbol{\xi}|^2} \tanh\left(-\mathrm{i}\sqrt{k^2 - |\boldsymbol{\xi}|^2}\sigma\right) \widehat{u}_N^{\sigma}(\boldsymbol{\xi}, H) e^{\mathrm{i}\boldsymbol{\widetilde{x}}\cdot\boldsymbol{\xi}} \,\mathrm{d}\boldsymbol{\xi}\,. \tag{16}$$

Similar to the convergence result in [4], when $|\sigma|$ is sufficiently large, the PML problems are uniquely solvable and

$$||u_D^{\sigma} - u||_{H^1(\Omega_H)}, ||u_N^{\sigma} - u||_{H^1(\Omega_H)} \le C|\sigma|^{-1}$$

Now we apply the Floquet-Bloch transform to u_I^{σ} . Let $w_I^{\sigma}(\boldsymbol{\alpha}, x) := \mathcal{F}u_I^{\sigma}$, then for fixed $\boldsymbol{\alpha}, w_I^{\sigma}(\boldsymbol{\alpha}, \cdot)$ is bi-periodic with respect to $\tilde{\boldsymbol{x}}$ and satisfies the cell problem:

$$\Delta w_I^{\sigma}(\boldsymbol{\alpha},\cdot) + 2\mathrm{i}\boldsymbol{\alpha}\cdot\widetilde{\nabla}w_I^{\sigma}(\boldsymbol{\alpha},\cdot) + (k^2 - |\boldsymbol{\alpha}|^2)w_I^{\sigma}(\boldsymbol{\alpha},\cdot) = e^{-\mathrm{i}\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}}f \text{ in } \Omega_H^0; \quad w_I^{\sigma}(\boldsymbol{\alpha},\cdot) = 0 \text{ on } \Gamma_0$$
(17)

with the transparent boundary condition:

$$\frac{\partial w_{I}^{\sigma}(\boldsymbol{\alpha},\cdot)}{\partial x_{3}} = T_{\boldsymbol{\alpha}}^{\sigma,I} w_{I}^{\sigma}(\boldsymbol{\alpha},\cdot) = \mathrm{i} \sum_{\boldsymbol{j}\in\mathbb{Z}} h_{I}(\boldsymbol{\alpha},\sigma,\boldsymbol{j}) \widehat{w}_{I}^{\sigma}(\boldsymbol{\alpha},\boldsymbol{j}) e^{\mathrm{i}\boldsymbol{j}\cdot\boldsymbol{\widetilde{x}}} \text{ on } \Gamma_{H}^{0}, \tag{18}$$

where

$$h_D(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}) := \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}|^2} \operatorname{coth} \left(-i\sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}|^2} \sigma \right)$$

and

$$h_N(\boldsymbol{\alpha},\sigma,\boldsymbol{j}) := \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}|^2} \tanh\left(-\mathrm{i}\sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}|^2}\sigma\right).$$

Similar to (3)-(4), the problem (17)-(18) is written as the variational problem

$$\int_{\Omega_{H}^{0}} \left[\nabla w_{I}^{\sigma}(\boldsymbol{\alpha}, \cdot) \cdot \nabla \overline{\boldsymbol{\phi}} - 2\mathrm{i}\boldsymbol{\alpha} \cdot \widetilde{\nabla} w_{I}^{\sigma}(\boldsymbol{\alpha}, \cdot) \overline{\boldsymbol{\phi}} - (k^{2} - |\boldsymbol{\alpha}|^{2}) w_{I}^{\sigma}(\boldsymbol{\alpha}, \cdot) \overline{\boldsymbol{\phi}} \right] \,\mathrm{d}\boldsymbol{x} -4\pi^{2} \mathrm{i} \sum_{\boldsymbol{j} \in \mathbb{Z}^{2}} h_{I}(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}) \widehat{w}_{I}^{\sigma}(\boldsymbol{\alpha}, \boldsymbol{j}) \overline{\widehat{\boldsymbol{\phi}}(\boldsymbol{j})} = -\int_{\Omega_{H}^{0}} e^{-\mathrm{i}\boldsymbol{\alpha} \cdot \widetilde{\boldsymbol{x}}} f(\boldsymbol{x}) \overline{\boldsymbol{\phi}}(\boldsymbol{x}) \,\mathrm{d}\boldsymbol{x} \,.$$

$$\tag{19}$$

This results in the following operator equation:

$$\left[A(\boldsymbol{\alpha}) - \sum_{\boldsymbol{j} \in \mathbb{Z}^2} h_I(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}) B_{\boldsymbol{j}}\right] w_I^{\sigma}(\boldsymbol{\alpha}, \cdot) := S_I^{\sigma}(\boldsymbol{\alpha}) w_I^{\sigma}(\boldsymbol{\alpha}, \cdot) = G(\boldsymbol{\alpha}, \cdot).$$
(20)

From [4], $S_I^{\sigma}(\alpha)$ converges to $S(\alpha)$ uniformly with respect to $\alpha \in \overline{W}$. Thus when $|\sigma| >> 1$, the problem (19) is uniquely solvable for any $\alpha \in W$. Then the PML solution is given by the inverse Floquet-Bloch transform:

$$u_{I}^{\sigma}(\boldsymbol{x}) = \int_{W} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} w_{I}^{\sigma}(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} \,, \quad \boldsymbol{x} \in \Omega_{H}.$$
⁽²¹⁾

With a similar but easier process as in Section 3, the above formula is rewritten as follows:

$$u_{I}^{\sigma}(\boldsymbol{x}) = \int_{R} e^{i\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} w_{I}^{\sigma}(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} + \int_{Q} e^{i\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} w_{I}^{\sigma}(\boldsymbol{\alpha},\boldsymbol{x}) \,\mathrm{d}\boldsymbol{\alpha} + \sum_{i=1}^{n} \int_{\zeta_{i}}^{\psi_{i}} \int_{C_{-}(k,\delta)} e^{is(\cos\phi,\sin\phi)\cdot\tilde{\boldsymbol{x}}} w_{I}^{\sigma}(s,\phi,\boldsymbol{x})s \,\mathrm{d}s \,\mathrm{d}\phi \,.$$

$$\tag{22}$$

Since for sufficiently large $|\sigma|$, $S_I^{\sigma}(\alpha)$ is always invertible and $||S_I^{-\sigma}(\alpha)|| \leq C$ by adjusting the constant C. Let $J(\alpha) = \{\mathbf{j}_1, \ldots, \mathbf{j}_m\}$ and define $\widetilde{A}_I^{\sigma}(\alpha) = A(\alpha) + \sum_{\mathbf{j} \notin J(\alpha_0)} h_I(\alpha, \sigma, \mathbf{j}) B_{\mathbf{j}}$. Within the domain \widetilde{P} defined in the previous section, the solution can be written as the Neumann series:

$$w_{I}^{\sigma}(\boldsymbol{lpha},\cdot) = \sum_{n=0}^{\infty} \left[\sum_{\ell=1}^{m} h_{I}(\boldsymbol{lpha},\sigma,\boldsymbol{j}) \widetilde{B}_{I,\ell}^{\sigma}(\boldsymbol{lpha})
ight]^{n} \widetilde{G}_{I}^{\sigma}(\boldsymbol{lpha},\cdot),$$

where $\widetilde{B}_{I,\ell}^{\sigma} = -\widetilde{A}_{I}^{-\sigma}(\boldsymbol{\alpha})B_{\boldsymbol{j}_{\ell}}$ and $\widetilde{G}_{I}^{\sigma}(\boldsymbol{\alpha},\cdot) = -\widetilde{A}_{I}^{-\sigma}(\boldsymbol{\alpha})G(\boldsymbol{\alpha},\cdot)$. In particular, when k < 0.5, since $P = \partial B(0,k)$,

$$w_{I}^{\sigma}(\boldsymbol{\alpha},\cdot) = \sum_{n=0}^{\infty} \left[h_{I}(\boldsymbol{\alpha},\sigma,\boldsymbol{j}) \widetilde{B}_{I,0}^{\sigma}(\boldsymbol{\alpha}) \right]^{n} \widetilde{G}_{I}^{\sigma}(\boldsymbol{\alpha},\cdot).$$
(23)

5 Convergence of the PML

In this section, we will estimate the error between $u(\mathbf{x})$ and $u_I^{\sigma}(\mathbf{x})$. From (11) and (22), the difference between these two functions can be bounded by the following separated terms:

$$\|u - u_{I}^{\sigma}\|_{H^{1}(M)} \leq \left\| \int_{R} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} \left[w(\boldsymbol{\alpha}, \cdot) - w_{I}^{\sigma}(\boldsymbol{\alpha}, \cdot) \right] \, \mathrm{d}\boldsymbol{\alpha} \right\|_{H^{1}(M)} + \sum_{\boldsymbol{\alpha}_{0}\in P: \, \#J(\boldsymbol{\alpha}_{0})>1} \left\| \int_{Q(\boldsymbol{\alpha}_{0})} e^{i\boldsymbol{\alpha}\cdot\widetilde{\boldsymbol{x}}} \left[w(\boldsymbol{\alpha}, \cdot) - w_{I}^{\sigma}(\boldsymbol{\alpha}, \cdot) \right] \, \mathrm{d}\boldsymbol{\alpha} \right\|_{H^{1}(M)} + \sum_{i=1}^{n} \left\| \int_{\zeta_{i}}^{\psi_{i}} \int_{C_{-}(k,\delta)} e^{is(\cos\phi,\sin\phi)\cdot\widetilde{\boldsymbol{x}}} \left[w(s,\phi,\cdot) - w_{I}^{\sigma}(s,\phi,\cdot) \right] s \, \mathrm{d}s \, \mathrm{d}\phi \right\|_{H^{1}(M)},$$

$$(24)$$

where $M \subset \Omega_H$ is any fixed compact subset of Ω_H . For simplicity, let $\sigma = \sigma_1 + i\sigma_2 = |\sigma|(\cos \theta + i\sin \theta)$ for some fixed $\theta \in (0, \pi/2)$.

5.1 Estimation for the integral on R

In this section, we estimate the following integral:

$$I_R(\sigma, I) := \left\| \int_R e^{\mathbf{i}\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} \left[w(\boldsymbol{\alpha}, \cdot) - w_I^{\sigma}(\boldsymbol{\alpha}, \cdot) \right] \, \mathrm{d}\boldsymbol{\alpha} \, \right\|_{H^1(M)}.$$
(25)

With the definition that $R = W \setminus \left[\bigcup_{\ell=1}^{M} A(-\boldsymbol{j}_{\ell}, k, \delta) \right]$ and the fact that $\delta < \delta_W$, for any $\boldsymbol{\alpha} \in R$,

$$d(\boldsymbol{\alpha}, S(-\boldsymbol{j}, k)) \ge \delta$$
, for all $\boldsymbol{j} \in \mathbb{Z}^2$.

To estimate $I_R(\sigma, I)$, we only need to compare the solutions of the periodic problem (6) and the periodic PML problem (19), when $\alpha \in R$. Since the only difference in the two problems lies in the DtN maps, we only need to estimate

 $\left\|T_{\alpha}^{+} - T_{\alpha}^{\sigma,I}\right\|, \quad \text{where } I = D, N.$

From the definitions of the DtN maps, we only need to estimate the following function for any $z = \alpha + j$:

$$q_D(\boldsymbol{z}, \sigma) := h_D(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}) - \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}|^2} = \sqrt{k^2 - |\boldsymbol{z}|^2} \left(\operatorname{coth} \left(-\mathrm{i}\sqrt{k^2 - |\boldsymbol{z}|^2} \sigma \right) - 1 \right)$$
$$= \frac{2\sqrt{k^2 - |\boldsymbol{z}|^2}}{\exp\left(-\mathrm{i}\sqrt{k^2 - |\boldsymbol{z}|^2} \sigma \right) - 1},$$

or

$$egin{aligned} q_N(oldsymbol{z},\sigma) &:= h_N(oldsymbol{lpha},\sigma,oldsymbol{j}) - \sqrt{k^2 - |oldsymbol{lpha}+oldsymbol{j}|^2} &= \sqrt{k^2 - |oldsymbol{z}|^2} \left(anh\left(-\mathrm{i}\sqrt{k^2 - |oldsymbol{z}|^2}\sigma
ight) - 1
ight) \ &= -rac{2\sqrt{k^2 - |oldsymbol{z}|^2}}{\exp\left(-\mathrm{i}\sqrt{k^2 - |oldsymbol{z}|^2}\sigma
ight) + 1}. \end{aligned}$$

The values of the two functions are estimated in the following lemma.

Lemma 5. The following estimation holds uniformly for $z = \alpha + j$ where $\alpha \in R$ and $j \in \mathbb{Z}^2$:

$$|q_I(\boldsymbol{z},\sigma)| \leq C \exp\left(-c\sqrt{k\delta}|\sigma|\right),$$

where c, C > 0 are independent of $|\sigma|$.

Proof. To prove the exponential decay of q_D or q_N , we only need to prove the exponential increase of the

function $\left| \exp\left(-i\sqrt{k^2 - |\boldsymbol{z}|^2}\sigma\right) \right|$. Since for any $\boldsymbol{j} \in \mathbb{Z}^2$, $d(\boldsymbol{\alpha}, S(-\boldsymbol{j}, k)) \ge \delta$, either $|\boldsymbol{\alpha} + \boldsymbol{j}| = |\boldsymbol{z}| \ge k + \delta$ or $|\boldsymbol{\alpha} + \boldsymbol{j}| = |\boldsymbol{z}| \le k - \delta$. When $|\boldsymbol{z}| \ge k + \delta$, then $|\boldsymbol{z}^2| - k^2 = (|\boldsymbol{z}| - k)(|\boldsymbol{z}| + k) \ge 2k\delta$. Thus

$$\left|\exp\left(-\mathrm{i}\sqrt{k^2-|\boldsymbol{z}|^2}\sigma\right)\right|=\exp\left(\sqrt{|\boldsymbol{z}|^2-k^2}\sigma_1\right)\geq\exp\left(\sqrt{2k\delta}|\sigma|\cos\theta\right).$$

When $|\mathbf{z}| \leq k - \delta$, then $k^2 - |\mathbf{z}|^2 = (k - |\mathbf{z}|)(k + |\mathbf{z}|) \geq k\delta$. Thus

$$\left|\exp\left(-\mathrm{i}\sqrt{k^2-|\boldsymbol{z}|^2}\sigma\right)\right|=\exp\left(\sqrt{k^2-|\boldsymbol{z}|^2}\sigma_2\right)\geq\exp\left(\sqrt{k\delta}|\sigma|\sin\theta\right).$$

Since $\theta \in (0, \pi/2)$ is a fixed angle, $\sin \theta$, $\cos \theta > 0$. Thus there is a constant c > 0 such that

$$\left|\exp\left(-\mathrm{i}\sqrt{k^2-|\boldsymbol{z}|^2}\sigma\right)\right|\geq\exp\left(c\sqrt{k\delta}|\sigma|\right)$$

holds uniformly for both cases. The proof is finished.

Following Theorem 9 in [16], it is easily proved that $||T^+_{\alpha} - T^{\sigma,I}_{\alpha}|| \leq C \left(c\sqrt{k\delta}|\sigma|\right)$, thus $||w(\alpha, \cdot) - v(\alpha, \cdot)| \leq C \left(c\sqrt{k\delta}|\sigma|\right)$ $w_I^{\sigma}(\boldsymbol{\alpha}, \cdot) \|_{H^1_{\mathrm{per}}(\Omega^0_H)} \leq C\left(c\sqrt{k\delta}|\sigma|\right)$. Then it is easy to get the final result in this section.

Theorem 6. When $\theta \in (0, \pi/2)$ is fixed, $I_R(\sigma, I) \leq C \exp\left(-c\sqrt{k\delta}|\sigma|\right)$ holds for sufficiently large $|\sigma|$ and I = D, N.

The following results are concluded as a corollary of Lemma 5.

Corollary 7. Suppose $\delta < \delta_W$. For any $\boldsymbol{\alpha} \in W$, the operator $\widetilde{A}_I^{\sigma}(\boldsymbol{\alpha})$ (where I = D, N) converges to $\widehat{A}(\boldsymbol{\alpha})$ exponentially:

$$\left\|\widetilde{A}_{I}^{\sigma}(\boldsymbol{\alpha}) - \widetilde{A}(\boldsymbol{\alpha})\right\| \leq C \exp\left(-c\sqrt{k\delta}|\sigma|\right).$$

Then the following estimations are obtained directly:

$$\left\|\widetilde{B}_{I,\ell}^{\sigma}(\boldsymbol{\alpha}) - \widetilde{B}_{\ell}(\boldsymbol{\alpha})\right\|, \left\|\widetilde{G}_{I}^{\sigma}(\boldsymbol{\alpha},\cdot) - \widetilde{G}(\boldsymbol{\alpha},\cdot)\right\| \leq C \exp\left(-c\sqrt{k\delta}|\sigma|\right).$$

5.2Estimation for the integral on S

From the formulas (11) and (22), the integral on the set S is equivalent to the sum of integrals on the modified partial annulus. Thus we define

$$I_{S}^{i}(\sigma, I) = \left\| \int_{\zeta_{i}}^{\psi_{i}} \int_{C_{-}(k,\delta)} e^{\mathrm{i}s(\cos\phi,\sin\phi)\cdot\tilde{\boldsymbol{x}}} \left[w(s,\phi,\cdot) - w_{I}^{\sigma}(s,\phi,\cdot) \right] s \,\mathrm{d}s \,\mathrm{d}\phi \right\|_{H^{1}(M)}.$$
(26)

Due to the complex variable s, the notation $|z|^2$ is replaced by $z_1^2 + z_2^2$ in this section.

We need the following assumption to prove the convergence result.

Assumption 8. The angle θ satisfies

$$\theta \in \left(\frac{\pi}{8}, \frac{\pi - \arctan 2}{2}\right).$$

From the polar coordinate, $\boldsymbol{\alpha} = (\boldsymbol{\alpha}_1, \boldsymbol{\alpha}_2) := \boldsymbol{a} + \mathrm{i} \boldsymbol{b}$ satisfies

$$\boldsymbol{\alpha}_1 = s\cos\phi, \, \boldsymbol{\alpha}_2 = s\sin\phi$$

 \square

where $s \in C_{-}(k, \delta)$ and ϕ lies in one interval $[\zeta_i, \psi_i]$. Then $\boldsymbol{a} = \operatorname{Re}(\boldsymbol{\alpha}) \in A(\boldsymbol{0}, k, \delta, [\zeta_i, \psi_i])$ and $\boldsymbol{b} = \operatorname{Im}(\boldsymbol{\alpha})$. From the definition of the partial annulus, it is obvious that for any $\boldsymbol{j} \in \mathbb{Z}^2 \setminus \{0\}$,

$$d(\boldsymbol{a}, S(-\boldsymbol{j}, k)) \ge \delta$$

Similar to the previous section, we still need to estimate the functions $q_I(\boldsymbol{z}, \sigma)$ when $\boldsymbol{z} = \boldsymbol{\alpha} + \boldsymbol{j}$ where $\boldsymbol{\alpha}$ is given as above. The estimation is given in the following lemma, which is mainly based on the proof from Lemma 8, [16].

Lemma 9. Assumption 8 holds. The following estimation holds uniformly for $\mathbf{z} = \mathbf{\alpha} + \mathbf{j}$ where $\mathbf{\alpha} = (s \cos \phi, s \sin \phi)$ with $s \in C_{-}(k, \delta)$, $\phi \in [a_t, b_t]$ and $\mathbf{j} \in \mathbb{Z}^2$:

$$|q_I(\boldsymbol{z},\sigma)| \le C \exp\left(-c\sqrt{k\delta}|\sigma|\right)$$

Proof. Similar to the proof of Lemma 5, we still need to prove the exponential increase of the function $|\exp(-i\sqrt{k^2-s^2}\sigma)|$. Note that here $\mathbf{z}_1^2 + \mathbf{z}_2^2 = s^2$, then $\sqrt{k^2-z_1^2-z_2^2} = \sqrt{k^2-s^2}$. For simplicity, let $\sqrt{k^2-s^2} = de^{i\tau}$. We need to consider the following two cases separately. i) When $\mathbf{j} = \mathbf{0}$. Let $s = k - \delta e^{it}$ where $t \in [0, \pi]$. When j = 0, then

$$k^2 - s^2 = 2k\delta e^{\mathrm{i}t} - \delta^2 e^{2\mathrm{i}t}$$

From direct computation,

$$d \ge \sqrt{2k\delta - \delta^2} > \sqrt{k\delta}$$
 and $\tau \in \left[0, \frac{\pi}{2}\right]$.

Since $\theta \in (0, \frac{\pi}{2})$, there is a $\gamma_1 > 0$ such that $\sin(\tau + \theta) \ge \gamma_1$. Thus

$$\left|\exp\left(-\mathrm{i}\sqrt{k^2-\boldsymbol{z}^2}\sigma\right)\right|\geq\exp(\sqrt{k\delta}\gamma_1|\sigma|).$$

ii) When $j \neq 0$. Since $d(a, S(-j, k)) \ge \delta$, either $|a + j| \ge k + \delta$ or $|a + j| \le k - \delta$. Moreover, $|b| \le \delta$. From direct computation,

$$k^{2} - z_{1}^{2} - z_{2}^{2} = k^{2} - |a + j|^{2} + |b|^{2} - 2i(a + j) \cdot b$$

When $|\boldsymbol{a} + \boldsymbol{j}| \geq k + \delta$,

$$d \ge \sqrt{|\boldsymbol{a} + \boldsymbol{j}|^2 - |\boldsymbol{b}|^2 - k^2} \ge \sqrt{(k+\delta)^2 - k^2 - \delta^2} = \sqrt{2k\delta},$$

and

$$|\tan(2\tau)| = \left|\frac{2(\boldsymbol{a}+\boldsymbol{j})\cdot\boldsymbol{b}}{|\boldsymbol{a}+\boldsymbol{j}|^2 - |\boldsymbol{b}|^2 - k^2}\right| \le \frac{2\delta|\boldsymbol{a}+\boldsymbol{j}|}{\delta(k+|\boldsymbol{a}+\boldsymbol{j}|) - \delta^2} \le 2.$$

This implies that

$$au \in \left[\frac{\pi - \arctan 2}{2}, \frac{\pi + \arctan 2}{2}\right].$$

When $|\boldsymbol{a} + \boldsymbol{j}| \leq k - \delta$,

$$d \ge \sqrt{k^2 + b^2 - |\boldsymbol{a} + \boldsymbol{j}|^2} \ge \sqrt{k^2 - (k - \delta)^2} \ge \sqrt{k\delta},$$

and

$$|\tan(2\tau)| = \left|\frac{2(\boldsymbol{a}+\boldsymbol{j})\cdot\boldsymbol{b}}{|\boldsymbol{b}|^2 + k^2 - |\boldsymbol{a}+\boldsymbol{j}|^2}\right| \le \frac{2(k-\delta)\delta}{k^2 - (k-\delta)^2} < 1$$

This implies that

$$au \in \left(-\frac{\pi}{8}, \frac{\pi}{8}\right).$$

For both cases, when Assumption 8 holds, there is a constant $\gamma_2 > 0$ such that $\sin(\tau + \theta) \ge \gamma_2$. Thus

$$\left|\exp\left(-\mathrm{i}\sqrt{k^2-\boldsymbol{z}_1^2-\boldsymbol{z}_2^2}\right)\right|\geq\exp\left(\sqrt{k\delta}\gamma_2|\sigma|\right)$$

The proof is finished by combing the results from (i) and (ii).

With above result, we can also prove that $||T^+_{\alpha} - T^{\sigma,I}_{\alpha}|| \leq C \exp\left(-c\sqrt{k\delta}|\sigma|\right)$ holds uniformly for $\alpha = (s\cos\phi, s\sin\phi)$ where $s \in C_-(k, \delta)$ and $\phi \in [a_t, b_t]$. Thus we can also prove $||w^{\sigma}_I(\alpha, \cdot) - w(\alpha, \cdot)||_{H^1_{per}(\Omega^0_H)} \leq C \exp\left(-c\sqrt{k\delta}|\sigma|\right)$. Finally we arrive at the main result in this section.

Theorem 10. Assumption 8 is satisfied, then $I_S(\sigma, I) \leq C \exp\left(-c\sqrt{k\delta}|\sigma|\right)$ holds for sufficiently large $|\sigma|$ and I = D, N.

5.3 Estimation for the integral on Q

Now we consider the following value:

$$I_{Q(\boldsymbol{\alpha}_0)}(\sigma, I) := \left\| \int_{Q(\boldsymbol{\alpha}_0)} e^{\mathbf{i}\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} \left[w(\boldsymbol{\alpha}, \cdot) - w_I^{\sigma}(\boldsymbol{\alpha}, \cdot) \right] \,\mathrm{d}\boldsymbol{\alpha} \right\|_{H^1(M)},\tag{27}$$

where α_0 is a point such that $\#J(\alpha_0) = m > 1$. Assume that $J(\alpha_0) = \{j_\ell : \ell = 1, 2, ..., m\}$, then $Q(\alpha_0)$ is the union of m partial annuluses:

$$Q(\boldsymbol{\alpha}_0) = \bigcup_{\ell=1}^m A(-\boldsymbol{j}_\ell, k, \delta, [\boldsymbol{\xi}_\ell, \eta_\ell])$$

In this section, we only consider the case that m = 2 as an example to simplify the notations. For m > 2 everything is very similar.

Recall that from the Neumann series (8),

$$w(\boldsymbol{\alpha}, \cdot) = \sum_{m,n=0}^{\infty} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2}^m \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_2|^2}^n \mathcal{O}\left(\widetilde{B}_{\boldsymbol{j}_1}(\boldsymbol{\alpha}), \widetilde{B}_{\boldsymbol{j}_2}(\boldsymbol{\alpha}), m, n\right) \widetilde{G}(\boldsymbol{\alpha}, \cdot),$$

which contains term with $\sqrt{k^2 - |\alpha + j_1|^2}^m \sqrt{k^2 - |\alpha + j_2|^2}^n$. At the same time,

$$w_{I}^{\sigma}(\boldsymbol{\alpha},\cdot) = \sum_{m,n=0}^{\infty} h_{I}^{m}(\boldsymbol{\alpha},\sigma,\boldsymbol{j}_{1}) h_{I}^{n}(\boldsymbol{\alpha},\sigma,\boldsymbol{j}_{2}) \mathcal{O}\left(\widetilde{B}_{I,\boldsymbol{j}_{1}}^{\sigma}(\boldsymbol{\alpha}),\widetilde{B}_{I,\boldsymbol{j}_{2}}^{\sigma}(\boldsymbol{\alpha}),m,n\right) \widetilde{G}_{I}^{\sigma}(\boldsymbol{\alpha},\cdot).$$

Define the following functions with $\ell = 1, 2$:

$$v_{\ell}(\boldsymbol{\alpha}, \cdot) := \sum_{n=0}^{\infty} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_{\ell}|^2} \widetilde{B}_{\boldsymbol{j}_{\ell}}^n(\boldsymbol{\alpha}) \widetilde{G}(\boldsymbol{\alpha}, \cdot);$$
$$v_{I,\ell}^{\sigma}(\boldsymbol{\alpha}, \cdot) := \sum_{n=0}^{\infty} h_I^n(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}_1) \left(\widetilde{B}_{I,\boldsymbol{j}_{\ell}}^\sigma(\boldsymbol{\alpha})\right)^n \widetilde{G}_I^{\sigma}(\boldsymbol{\alpha}, \cdot)$$

With these functions, we define

$$v_{0}(\boldsymbol{\alpha},\cdot) = w(\boldsymbol{\alpha},\cdot) + \widetilde{G}(\boldsymbol{\alpha},\cdot) - v_{1}(\boldsymbol{\alpha},\cdot) - v_{2}(\boldsymbol{\alpha},\cdot)$$
$$= \sum_{m,n=1}^{\infty} \sqrt{k^{2} - |\boldsymbol{\alpha} + \boldsymbol{j}_{1}|^{2}} \sqrt{k^{2} - |\boldsymbol{\alpha} + \boldsymbol{j}_{2}|^{2}} \mathcal{O}\left(\widetilde{B}_{\boldsymbol{j}_{1}}(\boldsymbol{\alpha}), \widetilde{B}_{\boldsymbol{j}_{2}}(\boldsymbol{\alpha}), m, n\right) \widetilde{G}(\boldsymbol{\alpha},\cdot)$$

and

$$\begin{aligned} v_{I,0}^{\sigma}(\boldsymbol{\alpha},\cdot) &= w_{I}^{\sigma}(\boldsymbol{\alpha},\cdot) + \widetilde{G}_{I}^{\sigma}(\boldsymbol{\alpha},\cdot) - v_{I,1}^{\sigma}(\boldsymbol{\alpha},\cdot) - v_{I,2}^{\sigma}(\boldsymbol{\alpha},\cdot) \\ &= \sum_{m,n=1}^{\infty} h^{m}(\boldsymbol{\alpha},\sigma,\boldsymbol{j}_{1})h^{n}(\boldsymbol{\alpha},\sigma,\boldsymbol{j}_{2})\mathcal{O}\left(\widetilde{B}_{I,\boldsymbol{j}_{1}}^{\sigma}(\boldsymbol{\alpha}),\widetilde{B}_{I,\boldsymbol{j}_{2}}^{\sigma}(\boldsymbol{\alpha}),m,n\right)\widetilde{G}_{I}^{\sigma}(\boldsymbol{\alpha},\cdot). \end{aligned}$$

From the definitions of the new functions, (27) can be bounded by:

$$\begin{split} I_Q(\sigma, I) &\leq \left\| \int_{Q(\boldsymbol{\alpha}_0)} e^{\mathbf{i}\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} \left[\widetilde{G}(\boldsymbol{\alpha}, \cdot) - \widetilde{G}_I^{\sigma}(\boldsymbol{\alpha}, \cdot) \right] \,\mathrm{d}\boldsymbol{\alpha} \right\|_{H^1(M)} + \left\| \int_{Q(\boldsymbol{\alpha}_0)} e^{\mathbf{i}\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} \left[v_0(\boldsymbol{\alpha}, \cdot) - v_{I,0}^{\sigma}(\boldsymbol{\alpha}, \cdot) \right] \,\mathrm{d}\boldsymbol{\alpha} \right\|_{H^1(M)} \\ &+ \left\| \int_{Q(\boldsymbol{\alpha}_0)} e^{\mathbf{i}\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} \left[v_1(\boldsymbol{\alpha}, \cdot) - v_{I,1}^{\sigma}(\boldsymbol{\alpha}, \cdot) \right] \,\mathrm{d}\boldsymbol{\alpha} \right\|_{H^1(M)} + \left\| \int_{Q(\boldsymbol{\alpha}_0)} e^{\mathbf{i}\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} \left[v_2(\boldsymbol{\alpha}, \cdot) - v_{I,2}^{\sigma}(\boldsymbol{\alpha}, \cdot) \right] \,\mathrm{d}\boldsymbol{\alpha} \right\|_{H^1(M)} \\ &:= (I) + (II) + (III) + (IV). \end{split}$$

The exponential convergence of the first term is obtained directly from Corollary 7. In the rest of this section, we first estimate terms (III) and (IV), and then deal with term (II).

5.3.1 Estimation of terms (III) and (IV)

Take (III) as an example. From Neumann series, $v_1(\alpha, \cdot)$ solves the equation

$$\left[\widetilde{A}(\boldsymbol{\alpha}) - \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2} B_{\boldsymbol{j}_1}\right] v_1(\boldsymbol{\alpha}, \cdot) = G(\boldsymbol{\alpha}, \cdot)$$

Similary, $v_{I,1}^{\sigma}(\boldsymbol{\alpha}, \cdot)$ solves

$$\left[\widetilde{A}_{I}^{\sigma}(\boldsymbol{\alpha})-h(\boldsymbol{\alpha},\sigma,\boldsymbol{j}_{1})B_{I,\boldsymbol{j}_{1}}^{\sigma}\right]v_{I,1}^{\sigma}(\boldsymbol{\alpha},\cdot)=G(\boldsymbol{\alpha},\cdot).$$

Recall that the domain $Q(\alpha_0)$ contains the intersection of two circles $S(-\mathbf{j}_1, k)$ and $S(-\mathbf{j}_2, k)$. From the definition of $\widetilde{A}(\alpha)$, it does not contain any singularity within the domain $Q(\alpha_0)$; while the square root only contains one singularity on the circle $S(-\mathbf{j}_1, k)$. We study the singularity of $v_1(\alpha, \cdot)$ with respect to α . Since there is only one square root singularity in the operator, $v_1(\alpha, \cdot)$ has the form (9) in a small neighbourhood of $S(-\mathbf{j}_1, k)$, i.e.,

$$v_1(\boldsymbol{\alpha},\cdot) = v_{0,1}(\boldsymbol{\alpha},\cdot) + \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2} v_{1,1}(\boldsymbol{\alpha},\cdot).$$

Let $\boldsymbol{\alpha} = s(\cos\phi, \sin\phi) - \boldsymbol{j}_1$ where $\phi \in [\xi_1, \eta_1]$ and |s-k| << 1. Following the process in Section 3, there is a constant $\delta_1 > 0$ such that $v_{0,1}(s, \phi, \cdot)$ and $v_{1,1}(s, \phi, \cdot)$ are extended analytically $(s, \phi) \in B(k, \delta_1) \times [\xi_1, \eta_1]$. Then for each fixed $\phi \in [\xi_1, \eta_1]$, $v_1(s, \phi, \cdot)$ is extended analytically to $B_-(k, \delta_1)$ with respect to s. Thus this term is rewritten as

$$\int_{Q(\boldsymbol{\alpha}_0)} e^{i\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} v_1(\boldsymbol{\alpha},\cdot) \,\mathrm{d}\boldsymbol{\alpha} = \int_{Q(\boldsymbol{\alpha}_0)\setminus A(-\boldsymbol{j}_1,k,\delta_1,[\xi_1,\eta_1])} e^{i\boldsymbol{\alpha}\cdot\tilde{\boldsymbol{x}}} v_1(\boldsymbol{\alpha},\cdot) \,\mathrm{d}\boldsymbol{\alpha} \\ + \int_{\xi_1}^{\eta_1} \int_{C_-(k,\delta_1)} e^{is(\cos\phi,\sin\phi)\cdot\tilde{\boldsymbol{x}}} w(s,\phi,\boldsymbol{x})s \,\mathrm{d}s \,\mathrm{d}\phi$$

The above decomposition also holds for $v_{I,1}^{\sigma}$. Thus (III) can be estimated be the following two terms

$$(III) \leq \left\| \int_{Q(\boldsymbol{\alpha}_0) \setminus A(-\boldsymbol{j}_1, k, \delta_1, [\xi_1, \eta_1])} e^{\mathbf{i}\boldsymbol{\alpha} \cdot \tilde{\boldsymbol{x}}} \left[v_1(\boldsymbol{\alpha}, \cdot) - v_{I,1}^{\sigma}(\boldsymbol{\alpha}, \cdot) \right] \, \mathrm{d}\boldsymbol{\alpha} \right\|_{H^1(M)} \\ + \left\| \int_{\xi_1}^{\eta_1} \int_{C_-(k, \delta_1)} e^{\mathbf{i}s(\cos\phi, \sin\phi) \cdot \tilde{\boldsymbol{x}}} w(s, \phi, \boldsymbol{x}) s \, \mathrm{d}s \, \mathrm{d}\phi \right\|_{H^1(M)} \\ := (V) + (VI).$$

The estimation of (V) follows Theorem 6, and the estimation of (VI) follows Theorem 10. Thus there are two constants c, C > 0 such that

$$(III) \le C \exp\left(-c\sqrt{k\delta_1}|\sigma|\right).$$

Similarly, for the term (IV), we can also find a constant $\delta_2 > 0$ and c, C > 0 such that

$$(IV) \le C \exp\left(-c\sqrt{k\delta_2}|\sigma|\right)$$

From now on, we set $\delta := \min\{\delta, \delta_1, \delta_2\}$, and let $\delta_1 = \delta_2 = \delta$. Moreover, we also let $\delta = |\sigma|^{-2\gamma}$ for a sufficiently large $|\sigma|$ and a fixed number $\gamma \in (0, 1)$.

5.3.2 Estimation of term (II)

From the above Neumann series of $v_0(\boldsymbol{\alpha}, \cdot)$ and $v_{I,0}^{\sigma}(\boldsymbol{\alpha}, \cdot)$, we need the function

$$g_D(m, n, \boldsymbol{\alpha}, \sigma) := h_D^m(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}_1) h_D^n(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}_2) - \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2}^m \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_2|^2}^n$$
$$= \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2}^m \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_2|^2}^n$$
$$\cdot \left[\coth\left(-i\sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2}\sigma\right)^m \coth\left(-i\sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_2|^2}\sigma\right)^n - 1 \right]$$

for the Dirichlet boundary condition, and the function

$$g_N(m, n, \boldsymbol{\alpha}, \sigma) := h_N^m(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}_1) h_N^n(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}_2) - \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2}^m \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_2|^2}^n$$
$$= \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2}^m \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_2|^2}^n$$
$$\cdot \left[\tanh\left(-i\sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2}\sigma\right)^m \tanh\left(-i\sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_2|^2}\sigma\right)^n - 1 \right].$$

for the Neumann boundary condition.

We first estimate the function $g_D(m, n, \alpha, \sigma)$. The estimation is based on the following lemma. Lemma 11. For fixed $\theta_1, \theta_2 > 0$, there is a constant C > 0 such that

$$|s \left[\coth\left(-\mathrm{i}s(\theta_1 + \mathrm{i}\theta_2)\right) - 1 \right]| \le C$$

holds uniformly for any $s \in [0, +\infty)$ and $-is \in [0, +\infty)$.

Proof. Since

$$s\left[\coth\left(-\mathrm{i}s(\theta_1+\mathrm{i}\theta_2)\right)-1\right] = \frac{2s}{\exp\left[-2\mathrm{i}s(\theta_1+\mathrm{i}\theta_2)\right]-1}$$

We only need to show that $\exp\left[-2is(\theta_1 + i\theta_2)\right] - 1$ is uniformly bounded from below.

First, from the Taylor series of the exponential function, $\lim_{s\to 0} r(s) = \frac{i}{\theta_1 + i\theta_2}$. From the continuity of the function, there is a small $\varepsilon > 0$ such that $|r(s)| \le 2$ holds for all $|s| \le \varepsilon$.

When s is real and positive, and $s > \varepsilon$,

$$\left|\exp\left[-2\mathrm{i}s(\theta_1 + \mathrm{i}\theta_2)\right] - 1\right| \ge \exp(2\varepsilon\theta_2) - 1 > 0.$$

When s is purely imaginary and $-is > \varepsilon$,

$$\left|\exp\left[-2\mathrm{i}s(\theta_1 + \mathrm{i}\theta_2)\right] - 1\right| \ge \exp(2\varepsilon\theta_1) - 1 > 0.$$

Thus when $|s| \ge \varepsilon$, $|\exp[-2is(\theta_1 + i\theta_2)] - 1| \ge \exp(2\varepsilon\theta) - 1 > 0$. Combining these two parts, we conclude that the function is uniformly bounded. The proof is finished.

Now we are prepared to estimate the function $g_D(m, n, \boldsymbol{\alpha}, \sigma)$.

Lemma 12. Suppose $|\delta| = |\sigma|^{-2\gamma}$ for some large $|\sigma|$. There is a constant C > 0 such that

$$|g_D(m, n, \boldsymbol{\alpha}, \sigma)| \leq C^{m+n} |\sigma|^{-\gamma(m+n)}$$

Proof. Let $s = \sqrt{k^2 - |\alpha + j_1|^2} |\sigma|$ and $t = \sqrt{k^2 - |\alpha + j_2|^2} |\sigma|$. Since $|\delta| = |\sigma|^{-2\gamma}$, |s|, $|t| \le C |\sigma|^{1-\gamma}$ for some constant C > 0. From Lemma 13, there is a constant C, independent of s and t such that

$$s \coth\left(-\mathrm{i}s(\theta_1 + \mathrm{i}\theta_2)\right)| \le C(1+|s|), |t \coth\left(-\mathrm{i}t(\theta_1 + \mathrm{i}\theta_2)\right)| \le C(1+|t|).$$

From direct computation,

$$|g_D(m, n, \boldsymbol{\alpha}, \sigma)| |\sigma|^{m+n} = \left| s^m t^n \left[\coth\left(-\mathrm{i}s(\theta_1 + \mathrm{i}\theta_2)\right)^m \coth\left(-\mathrm{i}t(\theta_1 + \mathrm{i}\theta_2)\right)^n - 1 \right] \right|$$

$$\leq C^m C^n (1+|s|)^m (1+|t|)^n + |s|^m |t|^n$$

$$\leq C^{m+n} \left(1+C|\sigma|^{1-\gamma}\right)^{m+n} + C^{m+n} |\sigma|^{(1-\gamma)(m+n)},$$

then there is a constant C > 0 such that $|g_D(m, n, \alpha, \sigma)| |\sigma|^{m+n} \leq C^{m+n} |\sigma|^{(1-\gamma)(m+n)}$ when $|\sigma| >> 1$. Thus the proof is finished.

Now we move on to the function $g_N(m, n, \alpha, \sigma)$. First we need the following uniform boundedness for the hyper tangent function.

Lemma 13. For fixed θ_1 , $\theta_2 > 0$, there is a constant C > 0 such that

$$|\tanh\left(-\mathrm{i}s(\theta_1 + \mathrm{i}\theta_2)\right)| \le C$$

holds uniformly for any $s \in [0, +\infty)$ and $-is \in [0, +\infty)$.

Proof. Instead of $tanh(-is(\theta_1 + i\theta_2))$, we only need to check if $tanh(-is(\theta_1 + i\theta_2)) - 1$ is uniformly bounded. From definition,

$$\tanh\left(-\mathrm{i}s(\theta_1+\mathrm{i}\theta_2)\right) - 1 = -\frac{2}{\exp\left(-2\mathrm{i}s(\theta_1+\mathrm{i}\theta_2)\right) + 1}$$

Thus we only need to show that

$$r_N(s) := \exp\left(-2\mathrm{i}s(\theta_1 + \mathrm{i}\theta_2)\right) + 1$$

is uniformly bounded from below. For details we refer to the proof of Lemma 11.

Now we are prepared to estimate the function $g_N(m, n, \boldsymbol{\alpha}, \sigma)$.

Lemma 14. Suppose $|\delta| = |\sigma|^{-2\gamma}$ for some large $|\sigma|$. Then there is a constant C > 0 such that

$$|g_N(m, n, \boldsymbol{\alpha}, \sigma)| \le C^{m+n} |\sigma|^{-\gamma(m+n)}.$$

Proof. We use the same notations as in the proof of Lemma 12. From direct computation,

$$N(m, n, \boldsymbol{\alpha}, \sigma) | |\sigma|^{m+n} = |s^m t^n [\tanh(-is(\theta_1 + i\theta_2))^m \tanh(-it(\theta_1 + i\theta_2))^n - 1] | \\ \leq |s|^m |t|^n (C^{m+n} + 1) \leq C^{m+n} |\sigma|^{(1-\gamma)(m+n)}.$$

The proof is finished.

|g|

From Lemma 12 and 14, we can find a constant C > 0 such that

$$|g_I(m, n, \boldsymbol{\alpha}, \sigma)| \le C^{m+n} |\sigma|^{-\gamma(m+n)}$$

holds uniformly for any $\alpha \in Q(\alpha_0)$. Now we are prepared estimate the term (II).

Theorem 15. When Assumption 8 holds. For sufficiently large $|\sigma|$ and $\gamma \in (0,1)$, there is a constant C > 0 such that

$$(II) \le C |\sigma|^{-6\gamma}$$

Proof. From the Neumann series,

$$\begin{split} (v_{I,0}^{\sigma} - v_0)(\boldsymbol{\alpha}, \cdot) &= \sum_{m,n=1}^{\infty} h_I^m(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}_1) h_I^n(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}_2) \mathcal{O}\left(\widetilde{B}_{I,\boldsymbol{j}_1}^{\sigma}(\boldsymbol{\alpha}), \widetilde{B}_{I,\boldsymbol{j}_2}^{\sigma}(\boldsymbol{\alpha}), m, n\right) \widetilde{G}_I^{\sigma}(\boldsymbol{\alpha}, \cdot) \\ &- \sum_{m,n=1}^{\infty} \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_1|^2}^m \sqrt{k^2 - |\boldsymbol{\alpha} + \boldsymbol{j}_2|^2}^n \mathcal{O}\left(\widetilde{B}_{\boldsymbol{j}_1}(\boldsymbol{\alpha}), \widetilde{B}_{\boldsymbol{j}_2}(\boldsymbol{\alpha}), m, n\right) \widetilde{G}(\boldsymbol{\alpha}, \cdot) \\ &= \sum_{m,n=1}^{\infty} h_I^m(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}_1) h_I^n(\boldsymbol{\alpha}, \sigma, \boldsymbol{j}_2) \left[\mathcal{O}\left(\widetilde{B}_{I,\boldsymbol{j}_1}^{\sigma}(\boldsymbol{\alpha}), \widetilde{B}_{I,\boldsymbol{j}_2}^{\sigma}(\boldsymbol{\alpha}), m, n\right) \widetilde{G}_I^{\sigma}(\boldsymbol{\alpha}, \cdot) \right. \\ &- \mathcal{O}\left(\widetilde{B}_{\boldsymbol{j}_1}(\boldsymbol{\alpha}), \widetilde{B}_{\boldsymbol{j}_2}(\boldsymbol{\alpha}), m, n\right) \widetilde{G}(\boldsymbol{\alpha}, \cdot) \right] \\ &+ \sum_{m,n=1}^{\infty} g_I(m, n, \boldsymbol{\alpha}, \sigma) \mathcal{O}\left(\widetilde{B}_{\boldsymbol{j}_1}(\boldsymbol{\alpha}), \widetilde{B}_{\boldsymbol{j}_2}(\boldsymbol{\alpha}), m, n\right) \widetilde{G}(\boldsymbol{\alpha}, \cdot), \end{split}$$

For the estimation of $\|\widetilde{B}_{I,j_{\ell}}^{\sigma}(\boldsymbol{\alpha}) - \widetilde{B}_{j_{\ell}}(\boldsymbol{\alpha})\|$ and $\|\widetilde{G}_{I}^{\sigma}(\boldsymbol{\alpha},\cdot) - \widetilde{G}(\boldsymbol{\alpha},\cdot)\|$, we refer to Corollary 7. Thus we only need to focus on the second term. Let the (m,n)-th term be denoted by

$$I_{m,n} = g_I(m, n, \boldsymbol{\alpha}, \sigma) \mathcal{O}\left(\widetilde{B}_{\boldsymbol{j}_1}(\boldsymbol{\alpha}), \widetilde{B}_{\boldsymbol{j}_2}(\boldsymbol{\alpha}), m, n\right) \widetilde{G}(\boldsymbol{\alpha}, \cdot)$$

Let the norm of $\widetilde{B}_{j_1}(\alpha)$, $\widetilde{B}_{j_2}(\alpha)$ be uniformly bounded by a positive constant C, then

$$I_{m,n}| \le C^{m+n}\binom{m+n}{m} \int_{Q(\boldsymbol{\alpha}_0)} |g(m,n,\boldsymbol{\alpha},\sigma)| \, \mathrm{d}\boldsymbol{\alpha} \le C^{m+n}\binom{m+n}{m} |\sigma|^{-(m+n+4)\gamma}.$$

Since

$$\sum_{m=1}^{\infty} \sum_{n=1}^{\infty} C^{m+n} \binom{m+n}{m} |\sigma|^{-(m+n+4)\gamma} \le \sum_{n=2} (2C)^n |\sigma|^{-(n+4)\gamma},$$

there is a constant C > 0 such that

$$\left|\sum_{m=1}^{\infty}\sum_{n=1}^{\infty}I_{m,n}\right| \le C|\sigma|^{-6\gamma}$$

holds uniformly for sufficiently large $|\sigma|$. The proof is finished.

Combining the estimations on (I), (II), (III) and (IV), we get the main result in this subsection.

Theorem 16. When $\theta \in (0, \pi/2)$ is fixed, $\alpha_0 \in W$ satisfies $\#J(\alpha_0) > 1$. Then for any fixed $\gamma \in (0, 1)$, $I_{Q(\alpha_0)}(\sigma, I) \leq C |\sigma|^{-6\gamma}$ holds for sufficiently large $|\sigma|$ and I = D, N.

5.4 Convergence result for the PML method

From the previous subsections, each component in the right hand side of (24) has been well studied. Thus we only need to combine these results to get the convergence result. In the domains R and S, exponential convergence has been proved, with a similar technique from the 2D cases (see [16]). However, near the intersection $Q(\alpha_0)$ between multiple annluses, only algebraic convergence, i.e., $|\sigma|^{-6\gamma}$. Fortunately we only have finite number of such intersection. For a special case that k < 0.5, any $\alpha_0 \in P$ has the property that $\#J(\alpha_0) = 1$. In this case $W = R \cup S$, thus we can still prove the exponential convergence. We conclude the total convergence for u^{σ} to u in the following theorem.

Theorem 17. Suppose Assumption 8 holds. Then

• When k < 0.5, there are two positive constants C and c such that

$$||u_I^{\sigma} - u||_{H^1(\Omega^0_H)} \le C \exp\left(-c|\sigma|\right).$$

• When $k \ge 0.5$, for any fixed parameter $\gamma \in (0,1)$, there is a positive constant C such that

$$||u_I^{\sigma} - u||_{H^1(\Omega^0_H)} \le C |\sigma|^{-6\gamma}$$

Remark 18. The result is also extendable to the two dimensional cases, when k is a half integer. The only difference is in the area of $Q(\alpha_0)$, which is only $O(|\sigma|^{-2\gamma})$ since it is one dimensional. So in this case, we can prove that the convergence is $O(|\sigma|^{-4\gamma})$, which is slower than the 3D bi-periodic case.

In this paper, we prove that the PML method converges exponentially for small wave numbers but algebraically at a higher order for more general cases. Although the conjecture in [4] is not proved, the convergence result is already improved significantly from this paper. Since the numerical computation for this problem is also challenging, we will discuss that and show numerical results in a following paper.
