# Banach halos and short isometries

#### Abstract

The aim of this article is twofold. First, we develop the notion of a Banach halo, similar to that of a Banach ring, except that the usual triangular inequality is replaced by the inequality $$
|a+b|_{R} \leq\left\|\left(|a|_{R},|b|_{R}\right)\right\|_{p}
$$ involving the $\ell^{p}$-norm for some $\left.\left.p \in\right] 0,+\infty\right]$, or by the inequality $$
|a+b|_{R} \leq C \max \left(|a|_{R},|b|_{R}\right)
$$ for $C \in \mathbb{R}_{+}^{*}$. This allows us to put on Banach halos a natural $\mathbb{R}_{+}^{*}$-flow, and to propose a setting for normed algebra over bases such as $\left(\mathbb{Z},|\cdot|_{\infty}^{2}\right)$ where $|\cdot|_{\infty}^{2}$ is the square of the usual archimedean norm. Then we define and study the groups $\operatorname{SIso}(C, \sigma,\|\cdot\|)$ of short isometries of normed involutive coalgebras over a base commutative Banach halo $R$. An aim of this theory is to define a representable group $K_{n} \subset \mathrm{GL}_{n}$ over $\mathbb{Z}$ whose points with values in $\mathbb{R}$ give $O_{n}(\mathbb{R})$, and whose points with values in $\mathbb{Q}_{p}$ give $\mathrm{GL}_{n}\left(\mathbb{Z}_{p}\right)$, giving to the classical analogy between these two groups a kind of geometric explanation.

## 1 Introduction

A classical leitmotiv of analytic number theory, following Tate's thesis [Tat67], is to treat all places of a number field on equal footing, using adelic methods. Another possible way to interpret this idea, is to try to develop normed algebra and global analytic geometry (see Ber90], Poi07]) in a setting where one can define a natural $\mathbb{R}_{+}^{*}$-flow on Banach rings by setting

$$
\sigma_{t}\left(R,|\cdot|_{R}\right):=\left(R,\left.|\cdot|\right|_{R} ^{t}\right)
$$

We propose here a table of analogies between geometry over $\mathbb{C}$, over a finite field $\mathbb{F}_{p}$ and arithmetic geometry ( $D$ denotes a disc), to show the importance of this flow in analytic geometry:

The usual triangular inequality

$$
|a+b|_{R} \leq|a|_{R}+|b|_{R}
$$

is not stable by this flow on multiplicative semi-norms because (for example) the square $|\cdot|_{\infty}^{2}$ of the archimedean absolute value on $\mathbb{Z}$ doesn't fulfill it. A possible solution to this problem, proposed by Artin in [Art67] is to use the generalized triangular inequality

$$
|a+b|_{R} \leq C \cdot \max \left(|a|_{R},|b|_{R}\right)
$$

for some $C \geq 1$. Developing normed algebra directly in this setting give quite different notions of what one usually gets when the usual triangular inequality is fulfilled. We propose here to also use the family of $\ell^{p}$-norm triangular inequalities

$$
|a+b|_{R} \leq\left\|\left(|a|_{R},|b|_{R}\right)\right\|_{p},
$$

for varying $p \in] 0,+\infty]$ because it is also indeed stable by the above $\mathbb{R}_{+}^{*}$-flow.

We thus define analogs of Banach rings in those two settings, called respectively short and Lipschitz Banach halos, and develop in Chapter 2 the basics of normed algebra over Banach halos. An interesting property of this setting is that there is a natural embedding of Banach halos in the category of monads on normed sets, that is compatible with the natural $\mathbb{R}_{+}^{*}$-flows on both categories. In Chapter 3, we study the groups of short involutions of Banach coalgebras with involutions and show that under some natural finiteness hypothesis, they are representable. We finish by applying this to the definition and study of the subgroups of short isometries of various classical groups over $\left(\mathbb{Z},|\cdot|_{\infty}\right)$.

## 2 Banach halos and their modules

### 2.1 Normed sets and semi-normed abelian groups

We denote $\mathbb{R}_{+}=\left[0,+\infty\left[\right.\right.$ and $\left.\mathbb{R}_{+}^{*}=\right] 0,+\infty[$. Recall from Pau14] the following definition and results.

Definition 1. A normed set is a pair $\left(X,|\cdot|_{X}\right)$ composed of a set $X$ and a map $|\cdot|_{X}$ : $X \rightarrow \mathbb{R}_{+}$. A map $f:\left(X,|\cdot|_{X}\right) \rightarrow\left(Y,|\cdot|_{Y}\right)$ between two normed sets is called

1. a Lipschitz map if there exists $C \geq 0$ with $|f(x)|_{Y} \leq C \cdot|x|_{X}$ for every $x \in X$.
2. a short map if $|f(x)|_{Y} \leq|x|_{X}$ for every $x \in X$, i.e., if it is Lipschitz with constant $C=1$.

We denote $\mathrm{NSETS}_{\text {short }}$ the category of normed sets with short maps, and NSETS Lipschitz the category of normed sets and Lipschitz maps.

The category NSETS $_{\text {short }}$ is complete and cocomplete, but the category NSETS $_{\text {Lipschitz }}$ is not. However, it will be useful for some purposes.

Proposition 1. There is a natural multiplicative symmetric monoidal structure on normed sets given by setting $\left(X,|\cdot|_{X}\right) \otimes^{m}\left(Y,|\cdot|_{Y}\right)$ to be $X \times Y$ with the norm given by

$$
(x, y)_{X \otimes^{m} Y}:=|x|_{X} \cdot|y|_{Y} .
$$

The internal homomorphism object for this monoidal structure on $\mathrm{NSETS}_{\text {short }}$ is given by the set

$$
\underline{\operatorname{Hom}}(X, Y):=\left\{f: X \rightarrow Y, \exists C \geq 0,|f(x)|_{Y} \leq C|x|_{X} \text { for all } x \in X\right\}
$$

of Lipschitz maps with the operator norm given by

$$
\|f\|:=\inf \left\{C \geq 0, ;|f(x)|_{Y} \leq C|x|_{X} \text { for all } x \in X\right\} .
$$

For each $p \in] 0,+\infty]$, there is a symmetric monoidal structure $\oplus^{p}$ on normed sets given by setting $\left(X,|\cdot|_{X}\right) \oplus^{p}\left(Y,|\cdot|_{Y}\right)$ to be $X \times Y$ with the norm given by

$$
(x, y)_{X \oplus^{p} Y}:=\left\|\left(|x|_{X},|y|_{Y}\right)\right\|_{p}=\sqrt[p]{|x|_{X}^{p}+|y|_{Y}^{p}}
$$

if $p<+\infty$ and

$$
(x, y)_{X \oplus^{\infty} Y}:=\left\|\left(|x|_{X},|y|_{Y}\right)\right\|_{\infty}=\max \left(|x|_{X},|y|_{Y}\right) .
$$

The symmetric monoidal structures give variations of norms of the direct product of copies of a normed set. Since we will use them later, we prepare the convention here.
Definition 2. Let $X$ be a normed set with the underlying set $X_{0}, n \in \mathbb{N} \backslash\{0\}$, and $p \in[1, \infty]$. We denote by $\|\cdot\|_{X, p}: X_{0}^{n} \rightarrow\left[0, \infty\left[\right.\right.$ the norm of $X^{\oplus^{p} n}$.

There is a natural $\mathbb{R}_{+}^{*}$-flow on normed sets given by

$$
\sigma_{t}\left(X,|\cdot|_{X}\right)=\left(X,|\cdot|_{X}^{t}\right)
$$

and it acts on both categories NSETS $_{\text {short }}$ and NSETS $_{\text {Lipschitz }}$ and stabilizes $\otimes^{m}$ and $\oplus^{\infty}$, but modifies $\oplus^{p}$.

Since $\ell^{p}$ norms will play an important role in this text, we recall here the following classical result, for the reader's convenience.
Lemma 1. Let $0<q \leq p \leq \infty$. There is a natural short inclusion

$$
\ell^{q}\left(\mathbb{N}, \mathbb{R}_{+}\right) \subset \ell^{p}\left(\mathbb{N}, \mathbb{R}_{+}\right)
$$

Proof. Suppose given a sequence $x=\left(x_{k}\right)_{k \in \mathbb{N}} \in \ell^{q}\left(\mathbb{N}, \mathbb{R}_{+}\right)$. We want to prove the inequality

$$
\|x\|_{p} \leq\|x\|_{q} .
$$

If $x=0$, it is clear. Suppose $x \neq 0$. Suppose first that $p<\infty$. We have

$$
\frac{\left|x_{k}\right|}{\|x\|_{p}} \leq 1
$$

so that

$$
\frac{\left|x_{k}\right|^{p}}{\|x\|_{p}^{p}} \leq \frac{\left|x_{k}\right|^{q}}{\|x\|_{p}^{q}}
$$

for any $k \in \mathbb{N}$, and summing over $k$ gives

$$
1=\frac{\|x\|_{p}^{p}}{\|x\|_{p}^{p}} \leq \frac{\|x\|_{q}^{q}}{\|x\|_{p}^{q}} .
$$

This implies

$$
\|x\|_{p}^{q} \leq\|x\|_{q}^{q}
$$

and the desired inequality follows by taking $q$-th roots. If $p=\infty$, the inequality is also clear.

Definition 3. A short semi-norm on an abelian group $A$ is a norm $|\cdot|_{A}: A \rightarrow \mathbb{R}_{+}$on the underlying set of $A$ such that $|0|_{A}=0$ and there exists $\left.\left.p \in\right] 0,+\infty\right]$ such that the $p$-triangular inequality

$$
|a-b|_{A} \leq\left\|\left(|a|_{A},|b|_{A}\right)\right\|_{p}
$$

is fulfilled for every $(a, b) \in A^{2}$. A Lipschitz semi-norm on an abelian group $A$ is a norm $|\cdot|_{A}: A \rightarrow \mathbb{R}_{+}$such that $|0|_{A}=0$ and there exists $C \in \mathbb{R}_{+}^{*}$ such that the substraction map is $C$-Lipschitz, i.e.,

$$
|a-b|_{A} \leq C \cdot \max (|a|,|b|)
$$

A Lipschitz semi-normed abelian group is thus an abelian group object in the cartesian monoidal category ( $\mathrm{NSETS}_{\text {Lipschitz }}, \oplus^{\infty}$ ), and a short semi-normed abelian group is an abelian group object in one of the monoidal categories ( $\mathrm{NSETS}_{\text {short }}, \oplus^{p}$ ).
Remark 1. If $|\cdot|_{A}$ is a semi-norm on an abelian group $A$, there is a maximal $\left.\left.p \in\right] 0,+\infty\right]$ such that

$$
|a-b|_{A} \leq\left\|\left(|a|_{A},|b|_{A}\right)\right\|_{p}
$$

for every $(a, b) \in A^{2}$. We will denote it $p_{A}^{\max }$.
To every semi-normed abelian group $\left(A,|\cdot|_{A}\right)$ one may associate the corresponding completion $\left(\hat{A},|\cdot|_{\hat{A}}\right)$, defined in the usual way as the quotient of Cauchy sequences by sequences with limit 0 , equipped with the quotient norm, defined by

$$
\left|\overline{\left(a_{n}\right)}\right|_{\hat{A}}:=\lim _{n \rightarrow \infty}\left|a_{n}\right|_{A}
$$

A semi-normed abelian group is called a Banach abelian group if the natural morphism

$$
\left(A,|\cdot|_{A}\right) \rightarrow\left(\hat{A},|\cdot|_{\hat{A}}\right)
$$

is both a (short or Lipschitz) isomorphism of normed sets and of abelian groups. This is equivalent to having the fact that every Cauchy sequence in $\left(A,|\cdot|_{A}\right)$ converges.

### 2.2 Banach halos

A Banach halo is a ring that is a Banach abelian group with a sub-multiplicative seminorm. More precisely, a short Banach halo is a ring object in the bimonoidal category $\left(\mathrm{NSETS}_{\text {short }}, \otimes^{m}, \oplus^{p}\right)$ for some $\left.\left.p \in\right] 0,+\infty\right]$, and a Lipschitz Banach halo is a ring object in the bimonoidal category (NSETS Lipschitz $, \otimes^{m}, \oplus^{\infty}$ ). Let us write all this explicitely.

Definition 4. A short Banach halo is a triad $\left(R,|\cdot|_{R}, p_{R}\right)$ composed of a ring $R$, a map $|\cdot|_{R}: R \rightarrow \mathbb{R}_{+}$, and a constant $\left.\left.p_{R} \in\right] 0,+\infty\right]$ satisfying the following:

1. $|1|_{R}=1$ unless $R=\{0\}$.
2. For any $f \in R,|f|_{R}=0$ if and only if $f=0$.
3. For any $f, g \in R,|f-g|_{R} \leq\left\|\left(|f|_{R},|g|_{R}\right)\right\|_{p_{R}}$.
4. For any $f, g \in R,|f g|_{R} \leq|f|_{R} \cdot|g|_{R}$.
5. The semi-normed abelian group $\left(R,|\cdot|_{R}\right)$ is complete.

For a $p=(C, D) \in] 0, \infty]^{2}$, we denote by $\|\cdot\|_{p}$ the seminorm on $\mathbb{R}^{2}$ defined by

$$
\|(x, y)\|_{p}:=C \cdot \max (|x|,|y|)
$$

for $(x, y) \in \mathbb{R}^{2}$. Although the convention redundantly refers to the unused datum $D$, using the same convention as in the short setting allows us to make parallel arguments. We note that we do not introduce a notation like $\|\cdot\|_{X, p}$ for a normed set $X$, because it leads confusion due to the fact that the $\ell^{\infty}$-norm rescaled by $C$ does not give an appropriate norm for a direct sum of modules with suitable norms introduced in $\$ 2.3 .3$.

Definition 5. A Lipschitz Banach halo is a triad $\left(R,|\cdot|_{R}, p_{R}\right)$ composed of a ring $R$, a map $|\cdot|_{R}: R \rightarrow \mathbb{R}_{+}$, and a pair $p_{R}=\left(C_{R}, D_{R}\right)$ of two constants $C_{R}>0$ and $D_{R}>0$ satisfying the following:

1. $|1|_{R}=1$ unless $R=\{0\}$.
2. For any $f \in R,|f|_{R}=0$ if and only if $f=0$.
3. For any $f, g \in R,|f-g|_{R} \leq\left\|\left(|f|_{R},|g|_{R}\right)\right\|_{p_{R}}$.
4. For any $f, g \in R,|f g|_{R} \leq D_{R} \cdot|f|_{R} \cdot|g|_{R}$.
5. The semi-normed abelian group $\left(R,|\cdot|_{R}\right)$ is complete.

We equip $[0, \infty]^{2}$ with the direct product order of the opposite order of the usual order. Namely, $p_{1} \leq p_{2}$ holds for a $p_{1}=\left(C_{1}, D_{1}\right) \in[0, \infty]^{2}$ and a $p_{2}=\left(C_{2}, D_{2}\right) \in[0, \infty]^{2}$ if and only if $C_{2} \leq C_{1}$ and $D_{2} \leq D_{1}$.

Let $\Sigma$ denote either "short" or "Lipschitz". A $\Sigma$ morphism $\left(R_{1},|\cdot|_{R_{1}}, p_{R_{1}}\right) \rightarrow\left(R_{2}, \mid\right.$. $\left.\left.\right|_{R_{2}}, p_{R_{2}}\right)$ between $\Sigma$ Banach halos is a $\Sigma$ ring homomorphism $\left(R_{1},|\cdot|_{R_{1}}\right) \rightarrow\left(R_{2},|\cdot|_{R_{2}}\right)$ with $p_{R_{1}} \leq p_{R_{2}}$.

For a short Banach halo $\left(R,|\cdot|_{R}, p_{R}\right)$, we denote by $\operatorname{Lip}\left(R,|\cdot|_{R}, p_{R}\right)$ the $\operatorname{triad}(R, \mid \cdot$ $\left.\right|_{R},\left(2^{\frac{1}{p_{R}}}, 1\right)$ ), which forms a Lipschitz Banach halo because

$$
\|(r, s)\|_{p_{R}} \leq\left(2 \cdot \max \left(r^{p_{R}}, s^{p_{R}}\right)\right)^{\frac{1}{p_{R}}}=2^{\frac{1}{p_{R}}} \cdot \max (r, s)=\|(r, s)\|_{\left(2^{\frac{1}{p_{R}}}, 1\right)}
$$

for any $(r, s) \in\left[0, \infty\left[^{2}\right.\right.$. Then Lip is a functor from the category of short Banach halos and short morphisms to the category of Lipschitz Banach halos and Lipschitz morphisms.

Definition 6. A $\Sigma$ Banach halo is called commutative if the underlying ring is commutative. An algebra over a $\Sigma$ Banach halo $R$ is a $\Sigma$ morphism $R \rightarrow A$ between $\Sigma$ Banach halos.

One motivation for introducing Banach halos is that they give a replacement of the notion of Banach ring that is stable by the natural $\mathbb{R}_{+}^{*}$-flow on normed sets. Indeed, one may define such a flow on the category of short Banach halos by the formula

$$
\sigma_{t}(A):=\left(A,|\cdot|_{A}^{t}, p_{A} / t\right)
$$

and on the category of Lipschitz Banach halos by the formula

$$
\sigma_{t}(A):=\left(A,|\cdot|_{A}^{t},\left(C_{A}^{t}, D_{A}^{t}\right)\right)
$$

This flow is already well understood in the non-archimedean context, and the notion of Banach halo allows its extension to the archimedean context, because for example

$$
\sigma_{2}\left(\mathbb{Z},|\cdot|_{\infty}, 1\right)=\left(\mathbb{Z},|\cdot|_{\infty}^{2}, 1 / 2\right)
$$

is not a Banach ring but is a Banach halo.
The Lipschitz case was already known to Artin, and the short case allows an easier treatment of convergent series.
Example 1. We now give various examples of short Banach halos.

1. Let $\left(R,|\cdot|_{R}\right)$ be a Banach ring in the usual sense. Then $\left(R,|\cdot|_{R}, 1\right)$ is a short Banach halo.
2. For example, suppose $n>1$ and equip $V=\mathbb{Z}^{n}$ with the $\ell^{2}$ norm on $\left(\mathbb{Z},|\cdot|_{\infty}\right)$. Then the algebra End $(V)$ of $\mathbb{Z}$-linear endomorphisms of $\mathbb{Z}$ with its operator norm and with constant 1 is a non-commutative short Banach halo (see the proof of Proposition (5).
3. Let $\left(R,|\cdot|_{R}, p_{R}\right)$ be a short Banach halo. Then there is a maximal $p \geq p_{R}$ such that $\left(R,|\cdot|_{R}, p\right)$ is a short Banach halo, denoted $p_{R}^{\max }$ and there is a natural morphism (defined using Lemma 1 )

$$
\left(R,|\cdot|_{R}, p_{R}\right) \rightarrow\left(R,|\cdot|_{R}, p_{R}^{\max }\right)
$$

A short Banach halo of this form is called a maximal halo.
4. For example, the commutative short Banach halos $\left(\mathbb{Z},|\cdot|_{\infty}, 1\right),\left(\mathbb{Z},|\cdot|_{0}, \infty\right),\left(\mathbb{Z}_{p}, \mid \cdot\right.$ $\left.\left.\right|_{p}, \infty\right)$ and $\left(\mathbb{Z},|\cdot|_{\infty}^{2}, 1 / 2\right)$ are all maximal.
5. There is no initial commutative short Banach halo. Indeed, the underlying ring would be $\mathbb{Z}$ and the norm on it should be the limit of all norms $|\cdot|_{\infty}^{t}$ for $t$ going to $\infty$, that is not well defined. This problem may be solved by working with proBanach halos (or ind-Banach halos).

### 2.3 Banach modules

In this Subsection, $\Sigma$ denotes either of the words "short" or "Lipschitz".

### 2.3.1 Definitions

Modules over Banach halos are essentially modules in the bimonoidal categories ( $\mathrm{NSETS}_{\text {short }}, \otimes^{m}, \oplus^{p}$ ) and (NSETS Lipschitz $, \otimes^{m}, \oplus^{\infty}$ ) with bounded constants.

Definition 7. A module over a short Banach halo $\left(R,|\cdot|_{R}, p_{R}\right)$ is a $\operatorname{triad}\left(M,|\cdot|_{M}, p_{M}\right)$ of an $R$-module $M$, a map $|\cdot|_{M}: M \rightarrow \mathbb{R}_{+}$and a constant $\left.\left.p_{M} \in\right] 0,+\infty\right]$ such that $p_{M} \geq p_{R}$ and satisfying the following:

1. For any $m \in M,|m|_{M}=0$ if and only if $m=0$.
2. For any $m, n \in M,|m-n|_{M} \leq\left\|\left(|m|_{M},|n|_{M}\right)\right\|_{p_{M}}$
3. For any $f \in R$ and $m \in M,|f m|_{M} \leq|f|_{R} \cdot|m|_{M}$
4. The semi-normed abelian group $\left(M,|\cdot|_{M}\right)$ is complete.

A morphisms $f: M_{1} \rightarrow M_{2}$ between modules $M_{1}$ and $M_{2}$ over $R$ is a short $R$-linear map with $p_{M_{1}} \leq p_{M_{2}}$. We denote $\mathrm{MOD}_{R}$ the category whose objects are $R$-modules and whose morphisms are short morphisms.

Definition 8. A module over a Lipschitz Banach halo $\left(R,|\cdot|_{R}, p_{R}\right)$ with $p_{R}=\left(C_{R}, D_{R}\right)$ is a $\operatorname{triad}\left(M,|\cdot|_{M}, p_{M}\right)$ of an $R$-module $M$, a map $|\cdot|_{M}: M \rightarrow \mathbb{R}_{+}$and a pair $p_{M}=$ $\left.\left.\left(C_{M}, D_{M}\right) \in\right] 0, \infty\right]^{2}$ of two constants $C_{M}$ and $D_{M}$ such that $p_{M} \geq p_{R}$ and satisfying the following:

1. For any $m \in M,|m|_{M}=0$ if and only if $m=0$.
2. For any $m, n \in M,|m-n|_{M} \leq\left\|\left(|m|_{M},|n|_{M}\right)\right\|_{p_{M}}$
3. For any $f \in R$ and $m \in M,|f m|_{M} \leq D_{M} \cdot|f|_{R} \cdot|m|_{M}$
4. The semi-normed abelian group $\left(M,|\cdot|_{M}\right)$ is complete.

A Lipschitz (resp. short) morphisms $f: M_{1} \rightarrow M_{2}$ between Lipschitz modules $M_{1}$ and $M_{2}$ over $R$ is a Lipschitz (resp. short) $R$-linear map with $p_{M_{1}} \leq p_{M_{2}}$. We denote $\operatorname{MoD}_{R}$ the category whose objects are Lischitz $R$-modules and whose morphisms are Lipschitz morphisms and $\mathrm{SMOD}_{R}$ the category with the same objects and short morphisms.

For a module $\left(M,|\cdot|_{M}, p_{M}\right)$ over a short Banach halo $\left(R,|\cdot|_{R}, p_{R}\right)$, we denote by $\operatorname{Lip}\left(M,|\cdot|_{M}, p_{M}\right)$ the $\operatorname{triad}\left(M,|\cdot|_{M},\left(2^{\frac{1}{P_{M}}}, 1\right)\right)$, which forms a Lipschitz module over $\operatorname{Lip}\left(R,|\cdot|_{R}, p_{R}\right)$ because

$$
\begin{aligned}
|m-n|_{M} & \leq\left\|\left(|m|_{M},|n|_{M}\right)\right\|_{p_{M}} \leq\left(2 \max \left(|m|_{M}^{p_{M}},|n|_{M}^{p_{M}}\right)\right)^{1 / p_{M}} \\
& =2^{\frac{1}{p_{M}}} \max \left(|m|_{M},|n|_{M}\right)=\left\|\left(|m|_{M},|n|_{M}\right)\right\|_{\left(2^{\frac{1}{p_{M}}}, 1\right)} .
\end{aligned}
$$

Then Lip is a functor from the category of short modules over $\left(R,|\cdot|_{R}, p_{R}\right)$ and short morphisms to the category of Lipschitz modukes over $\operatorname{Lip}\left(R,|\cdot|_{R}, p_{R}\right)$ and Lipschitz morphisms.

Definition 9. For $p \geq p_{R}$, and $R$ a short or a Lipschitz Banach halo, we denote $\operatorname{MoD}_{R}^{p}$ (resp. $\mathrm{SMOD}_{R}^{p}$ ) the subcategory of $\mathrm{Mod}_{R}$ (resp. $\mathrm{SMOD}_{R}$ ) whose objects are modules $M$ with $p_{M} \geq p$.

### 2.3.2 Endomorphism rings

Let $\Sigma$ denote either "short" or "Lipschitz". Let $R$ be a $\Sigma$ Banach halo with the underlying ring $R_{0}$, and $M$ an $R$-module. We denote by $\operatorname{End}_{R}(M) \subset \underline{\operatorname{Hom}}(M, M)$ the $R_{0}$-algebra of Lipschitz $R_{0}$-linear endomorphisms of $M$, equip it with the norm $|\cdot|_{\operatorname{End}_{R}(M)}$ the operator norm $|\cdot|_{o p}$ in the case where $\Sigma$ is "short" and the rescaled operator norm $D_{M}^{-1}|\cdot|_{o p}$ in the case where $\Sigma$ is "Lipschitz", and with the constant $p_{\operatorname{End}_{R}(M)}=p_{M}$.
Proposition 2. The triad $\left(\operatorname{End}_{R}(M),|\cdot|_{\operatorname{End}_{R}(M)}, p_{\operatorname{End}_{R}(M)}\right)$ forms an $R$-algebra, and $M$ forms a module over it.

Proof. The only non-trivial condition is the triangular inequality. Let $f, g \in \operatorname{End}_{R}(M)$. If $\Sigma$ is "short", then for any $m \in M$, we have

$$
\begin{aligned}
|(f-g) m|_{M} & =|f m-g m|_{M} \leq\left\|\left(|f m|_{M},|g m|_{M}\right)\right\|_{p_{M}} \\
& \leq\left\|\left(|f|_{o p}|m|_{M},|g|_{o p}|m|_{M}\right)\right\|_{p_{M}} \\
& =\left\|\left(|f|_{\operatorname{End}_{R}(M)},|g|_{\operatorname{End}_{R}(M)}\right)\right\|_{p_{M}}|m|_{M} \\
& =\left\|\left(|f|_{\operatorname{End}_{R}(M)},|g|_{\operatorname{End}_{R}(M)}\right)\right\|_{p_{\operatorname{End}_{R}(M)}}|m|_{M},
\end{aligned}
$$

and hence $|f-g|_{\operatorname{End}_{R}(M)}=|f-g|_{o p} \leq\left\|\left(|f|_{\operatorname{End}_{R}(M)},|g|_{\operatorname{End}_{R}(M)}\right)\right\|_{p_{\operatorname{End}_{R}(M)}}$. If $\Sigma$ is "Lipschitz", then for any $m \in M$, we have

$$
\begin{aligned}
|(f-g) m|_{M} & =|f m-g m|_{M} \leq\left\|\left(|f m|_{M},|g m|_{M}\right)\right\|_{p_{M}} \\
& \leq\left\|\left(|f|_{o p}|m|_{M},|g|_{o p}|m|_{M}\right)\right\|_{p_{M}} \\
& =D_{M}\left\|\left(|f|_{\operatorname{End}_{R}(M)},|g|_{\operatorname{End}_{R}(M)}\right)\right\|_{p_{M}}|m|_{M} \\
& =D_{M}\left\|\left(|f|_{\operatorname{End}_{R}(M)},|g|_{\operatorname{End}_{R}(M)}\right)\right\|_{p_{\operatorname{End}_{R}(M)}}|m|_{M},
\end{aligned}
$$

and hence $|f-g|_{\operatorname{End}_{R}(M)}=D_{M}^{-1}|f-g|_{o p} \leq\left\|\left(|f|_{\operatorname{End}_{R}(M)},|g|_{\operatorname{End}_{R}(M)}\right)\right\|_{p_{\operatorname{End}_{R}(M)}}$.

### 2.3.3 Direct sums

Let $R$ be a short Banach halo, and $\left(M_{i}\right)_{i \in I}$ a family of short modules over $R$. For each $i \in$ $I$, we denote by $\underline{M}_{i}$ the underlying Abelian group of $M_{i}$. For an $m=\left(m_{i}\right)_{i \in I} \in \bigoplus_{i \in I} \underline{M}_{i}$ and a $p \in\left[p_{R}, \infty\right]$, we put $\|m\|_{I, p}:=\sqrt[p]{\sum_{i \in I}\left|m_{i}\right|_{M_{i}}^{p}}$. We introduce a Lipschitz counterpart of $\|\cdot\|_{I, p}$. For this purpose, we introduce convention for binary trees.

Let $S$ be a set. We denote by $B T_{S}$ the set of finite binary trees whose leaves are coloured by $S$, i.e. the set defined in the following recursive way:
(i) $S \times\{0\} \subset B T_{S}$.
(ii) $B T_{S}^{2} \subset B T_{S}$.

For a $t \in B T_{S}$, we denote by leaves $(t)$ the set of leaves of $t$, i.e. the set defined in the following recursive way:
(i) If $t=(s, 0) \in S \times\{0\}$, then leaves $(t)=\{s\}$.
(ii) If $t=\left(t_{0}, t_{1}\right) \in B T_{S}^{2}$, then leaves $(t)=\bigcup_{i=0}^{1}$ leaves $\left(t_{i}\right) \times\{i\}$.

For a $t \in B T_{S}$, we denote by $\operatorname{col}(t)$ the colouring of $t$, i.e. the map leaves $(t) \rightarrow S$ defined in the following recursive way:
(i) If $t=(s, 0) \in S \times\{0\}$, then $\operatorname{col}(t)$ is the inclusion leaves $(t)=\{s\} \hookrightarrow S$,
(ii) If $t=\left(t_{0}, t_{1}\right) \in B T_{S}^{2}$, then $\operatorname{col}(t)$ assigns $\operatorname{col}\left(t_{i}\right)(x) \in S$ to each $(x, i) \in \operatorname{leaves}(t)$.

For a map $f: S_{0} \rightarrow S_{1}$ and $t \in B T_{S_{0}}$, we denote by $f \circ t \in B T_{S_{1}}$ the replacement of the colouring of $t$ by the composition of $f$.

Let $C \in\left[0, \infty\left[\right.\right.$. For a $t \in B T_{[0, \infty[ }$, we define $\|t\|_{C} \in[0, \infty[$ in the following recursive way:
(i) If $t=(s, 0) \in\left[0, \infty\left[\times\{0\}\right.\right.$, then $\|t\|_{C}=s$,
(ii) If $t=\left(t_{0}, t_{1}\right) \in B T_{S}^{2}$, then $\|t\|_{C}=C \cdot \max \left(\left\|t_{0}\right\|_{C},\left\|t_{1}\right\|_{C}\right)$.

Let $R$ be a Lispchitz Banach halo, and $\left(M_{i}\right)_{i \in I}$ a family of Lipschitz modules over $R$. For each $i \in I$, we denote by $\underline{M}_{i}$ the underlying Abelian group of $M_{i}$, and by $X$ the normed set $\bigsqcup_{i \in I} M_{i}$ regarded as a subset of $\bigoplus_{i \in I} \underline{M}_{i}$. For an $m \in \bigoplus_{i \in I} \underline{M}_{i}$ and a $\left.C \in\right] 0, \infty[$, we put $B T(m):=\left\{t \in B T_{X} \mid \sum_{x \in \operatorname{leaves}(t)} \operatorname{col}(t)(x)=m\right\}$, and $\|m\|_{I, C}:=\inf _{t \in B T(m)}\left\||\cdot|_{X} \circ t\right\|_{C} \in$ $[0, \infty[\text {. For a } p=(C, D) \in] 0, \infty]^{2}$, we put $\|\cdot\|_{I, p}=\|\cdot\|_{I, C}$.

Example 2. If the direct sum is of the form $M_{1} \oplus M_{2}$ with $I=\{1,2\}$ and $C=\inf \left(C_{M_{1}}, C_{M_{2}}\right)$, then the Lipschitz norm is given by

& \left\|\left(m_{1}, m_{2}\right)\right\|_{I, C}= \\
& \left\{\begin{array}{l}
C \max \left(\left|m_{1}\right|_{M_{1}},\left|m_{2}\right|_{M_{2}}\right), \\
\inf \left\{C \max \left(C \max \left(\left|m_{1,1}\right|_{M_{1}},\left|m_{2}\right|_{M_{2}}\right),\left|m_{1,2}\right|_{M_{1}}\right) \mid\left(m_{1, j}\right)_{j=1}^{2} \in X_{1,2}\right\},
\end{array}\right. \\
& \inf \left\{C \max \left(C \max \left(\left|m_{1}\right|_{M_{1}},\left|m_{2,1}\right|_{M_{2}}\right),\left|m_{2,2}\right|_{M_{2}}\right) \mid\left(m_{2, j}\right)_{j=1}^{2} \in X_{2,2}\right\} \text {, } \\
& \inf \left\{\begin{array}{l}
\inf _{\left(m_{i, j}\right)_{i, j=1}^{2} \in X_{1,2} \times X_{2,2}}\left\{C \max \left(C \max \left(C \max \left(\left|m_{1,1}\right|_{M_{1}},\left|m_{2,1}\right|_{M_{2}}\right),\left|m_{2,2}\right|_{M_{2}}\right),\left|m_{1,2}\right|_{M_{1}}\right)\right\}, \\
\inf ^{\left(m_{i, j}\right)_{i, j=1}^{2} \in X_{1,2} \times X_{2,2}}\left\{C \max \left(C \max \left(C \max \left(\left|m_{1,1}\right|_{M_{1}},\left|m_{2,1}\right|_{M_{2}}\right),\left|m_{1,2}\right|_{M_{1}}\right),\left|m_{2,2}\right|_{M_{2}}\right)\right\}, \\
\left.\inf _{\left(m_{i, j}\right)_{i, j=1}^{2} \in X_{1,2} \times X_{2,2}}\left\{C \max \left(C \max \left(\left|m_{1,1}\right|_{M_{1}},\left|m_{2,1}\right|_{M_{2}}\right), C \max \left(\left|m_{1,2}\right|_{M_{1}}\right),\left|m_{2,2}\right|_{M_{2}}\right)\right)\right\}, \\
\vdots
\end{array}\right\}
\end{aligned}
$$

for an $\left(m_{1}, m_{2}\right) \in\left(M_{1} \backslash\{0\}\right) \times\left(M_{2} \backslash\{0\}\right)$, where

$$
X_{i, n}=\left\{\left(m_{i, j}\right)_{j=1}^{n} \in M_{i}^{n} \mid m_{i}=\sum_{j=1}^{n} m_{i, j}\right\}
$$

for each $i \in I$ and $n \in \mathbb{N}$. More explicitely, if $M_{1}=M_{2}=\mathbb{Z}$ with $C=2$ and the usual archimedean norm $|\cdot|_{\infty}$ on $\mathbb{Z}$, then we get

$$
\|2 \oplus 2\|_{I, 2}=2 \cdot \max \left(|2|_{\infty},|2|_{\infty}\right)=4
$$

Indeed, the expression

$$
2 \oplus 2=(2 \oplus 0)+(0 \oplus 2)
$$

is the only expression of $2 \oplus 2$ as a binary sum of elements in the subset $(\mathbb{Z} \oplus\{0\}) \cup(\{0\} \oplus \mathbb{Z})$. Therefore all other sum expression of $2 \oplus 2$ are at least 3 -ary sums. Then the value associated to those sum expression is at least $C^{2} \times 1=4$, because the norm of non-zero elements of is at least 1 . This proves that the norm of $2 \oplus 2$ is 4 .

Let $R$ be a $\Sigma$ Banach halo, and let $\left(M_{i}\right)_{i \in I}$ a family of $\Sigma$ modules over $R$. For each $i \in I$, we denote by $\underline{M}_{i}$ the underlying Abelian group of $M_{i}$. When $\Sigma$ is "short", we put $p:=\sup _{i \in I} p_{M_{i}}$. When $\Sigma$ is "Lipschitz", we put $p:=\left(\inf _{i \in I} C_{M_{i}}, \inf _{i \in I} D_{M_{i}}\right)$. We have introduced a seminorm $\|\cdot\|_{I, p}$ on $\bigoplus_{i \in I} \underline{M}_{i}$, and denote by $\bigoplus_{i \in I} M_{i}$ its completion with respect to $\|\cdot\|_{I, p}$.
Proposition 3. The above constructed sum $\bigoplus_{i \in I} M_{i}$ satisfies the universality of the colimit of $\left(M_{i}\right)_{i \in I}$ in the category $\mathrm{SMOD}_{R}$ of $\Sigma$ modules over $R$ and short morphisms.

Here, the reader should be careful that we are considering short morphisms even when $\Sigma$ is "Lipschitz".

### 2.3.4 Free modules

Let $\Sigma$ denote either "short" or "Lipschitz". For a normed set $X$, we denote by $\ell^{p_{R}}(X, R)$ the $\Sigma$ module $\bigoplus_{x \in X_{+}} R|x|_{X}$, where $R r$ for an $\left.\left.r \in\right] 0, \infty\right]$ is the regular $\Sigma$ module over $R$ whose norm is rescaled by $r$. We give another description of $\ell^{p_{R}}(X, R)$ as a completion of $R^{(X)}$ in order to make its universality clearer.

Let $\Sigma$ denote either "short" or "Lipschitz". When $\Sigma$ is "short", for a $p \in] 0, \infty]$, we denote by $|\cdot|_{X, p}$ the seminorm on $R^{(X)}$ given by

\left|\sum a_{x}\{x\}\right|_{X, p}:=\left\|\left(\left|a_{x}\right|_{R} \cdot|x|_{X}\right)\right\|_{p},
$$

When $\Sigma$ is "Lipschitz", for a $p=(C, D) \in] 0, \infty]^{2}$, we denote by $|\cdot|_{X, p}$ the seminorm on $R^{(X)}$ given by

$$
\left|\sum a_{x}\{x\}\right|_{X, p}:=\inf \left\{r \in \left[0, \infty\left[\left|\forall t \in B T\left(\left(a_{x}\right)_{x \in X}\right),\left\||\cdot|_{Y} \circ t\right\|_{C} \leq r\right\}\right.\right.\right.
$$

where $Y$ denotes $\bigsqcup_{x \in X} R|x|_{X}$ and $R r$ for an $r \in[0, \infty[$ denotes the seminormed Abelian group given as the regular Lipdchitz module over $R$ rescaled by $r$. In both cases, $\ell^{p_{R}}(X, R)$ is naturally identified with the completion of the free module $R^{(X)}$ with respect to $|\cdot|_{X, p_{R}}$.
Proposition 4. Let $R$ be a $\Sigma$ Banach halo. Then the forgetful functor $\operatorname{MOD}_{R} \rightarrow$ NSETS $_{\Sigma}$ has a left adjoint functor given by $X \mapsto \ell^{p_{R}}(X, R)$.
Proof. Denote for simplicity $p=p_{R}$. The norm $|\cdot|_{I, p}$ fulfills the $p$-triangular inequality. Indeed, let $(a, b) \in R^{(X)}$ with $a=\sum_{x \in X} a_{x}\{x\}$ and $b=\sum_{x \in X} b_{x}\{x\}$. If $\Sigma$ is "short", then we have

$$
\begin{aligned}
|a+b|_{X, p} & =\left\|\left(\left|a_{x}+b_{x}\right|_{R} \cdot|x|_{X}\right)_{x \in X}\right\|_{p} \\
& \leq\left\|\left(\left\|\left(\left|a_{x}\right|_{R},\left|b_{x}\right|_{R}\right)\right\|_{p} \cdot|x|_{X}\right)_{x \in X}\right\|_{p} \\
& =\sqrt[p]{\sum_{x \in X}\left(\left|a_{x}\right|_{R}^{p}+\left|b_{x}\right|_{R}^{p}\right) \cdot|x|_{X}^{p}} \\
& =\sqrt[p]{\left(\sum_{x \in X}\left|a_{x}\right|_{R}^{p} \cdot|x|_{X}^{p}\right)+\left(\sum_{x \in X}\left|b_{x}\right|_{R}^{p} \cdot|x|_{X}^{p}\right)} \\
& =\left\|\left(|a|_{X, p},|b|_{X, p}\right)\right\|_{p .} .
\end{aligned}
$$

If $\Sigma$ is "Lipschitz", then for any $t=\left(t_{0}, t_{1}\right) \in B T\left(\left(a_{x}\right)_{x \in X}\right) \times B T\left(\left(b_{x}\right)_{x \in X}\right)$, we have $t \in B T\left(\left(a_{x}+b_{x}\right)_{x \in X}\right)$ and

$$
\begin{aligned}
& \left\|\left\|\left.\cdot\right|_{Y} \circ t\right\|_{C} \leq C \max \left(\left\||\cdot|_{Y} \circ t_{0}\right\|_{C},\left\||\cdot|_{Y} \circ t_{1}\right\|_{C}\right) \leq C \max \left(|a|_{X, p},|b|_{X, p}\right)\right. \\
= & \left\|\left(|a|_{X, p},|b|_{X, p}\right)\right\|_{p},
\end{aligned}
$$

where $Y$ denotes $\bigsqcup_{x \in X} R|x|_{X}$ as above. We already know that $X \mapsto R^{(X)}$ is a left adjoint in the algebraic setting. Suppose given an $R$-module $M$ with $p_{M} \geq p$ and a $\Sigma$ map $i: X \rightarrow M$. Then we may extend $i$ by linearity to $\tilde{i}: R^{(X)} \rightarrow M$, and we have

$$
\begin{array}{rll}
\left|\tilde{i}\left(\sum_{x \in X} a_{x}\{x\}\right)\right|_{M} & =\underset{\left.|l| l_{x \in X} a_{x} i(x)\right|_{M}}{ } \leq\left\|\left(\left|a_{x}\right|_{R} \cdot|i(x)|_{M}\right)_{x \in X}\right\|_{p_{M}} \\
& \leq\left\|\left(\left|a_{x}\right|_{R} \cdot|i|_{o p} \cdot|x|_{X}\right)_{x \in X}\right\|_{p_{M}} & \leq|i|_{o p}\left\|\left(\left|a_{x}\right|_{R} \cdot|x|_{X}\right)_{x \in X}\right\|_{p}
\end{array}
$$

by Lemma because $p \leq p_{M}$. This shows that $\tilde{i}$ extends to the completion into a $\Sigma$ morphism

$$
\ell^{p}(X, R) \rightarrow M,
$$

that is a morphism of modules if we further set $p_{\ell^{p}(X, R)}:=p=p_{R}$. Since the restriction of the obtained map to $X$ gives the original map, we have obtained a bijection

$$
\operatorname{Hom}_{\operatorname{Mod}_{R}}\left(\left(\ell^{p_{R}}(X, R),|\cdot|_{p_{R}}, p_{R}\right),\left(M,|\cdot|_{M}, p_{M}\right)\right) \xrightarrow{\sim} \operatorname{Hom}_{\text {NSETS }_{\Sigma}}(X, M) .
$$

We will need an improvement of the above result, whose proof is more technical. First, let us prove a Lemma.

Lemma 2. Let $R$ be a $\Sigma$ Banach halo. Then if $p \geq p_{R}$, there is an algebra $R_{p}$ that is universal among algebras over $R$ with constant greater than $p$.

Proof. Let $\left(S,|\cdot|_{S}, p\right)$ be a triad of a ring $S$, a map $|\cdot|_{S}: S \rightarrow \mathbb{R}_{+}$, and a $p \in(0, \infty]$ (resp. $\left.p=(C, D) \in(0, \infty]^{2}\right)$ satisfying the following:
(i) $|1|_{S}=1$ (resp. $>0$ ) unless $S=\{0\}$
(ii) $|f g|_{S} \leq|f|_{S} \cdot|g|_{S}$ (resp. $D|f|_{S} \cdot|g|_{S}$ ) for any $f, g \in S$

By the conditions, we have $|1|_{S} \in\{0,1\}$ (resp. $|1|_{S} \in(0, \infty)$ ). We denote by $|\cdot|_{S, p}$ the map

f & \mapsto \inf \left\{\left\|\left(\left|f_{i}\right|_{S}\right)_{i=0}^{n-1}\right\|_{n, p} \mid n \in \mathbb{N},\left(f_{i}\right)_{i=0}^{n-1} \in S^{n}, \sum_{i=0}^{n-1} f_{i}=f\right\},
\end{aligned}
$$

where $n$ is regarded as a normed set $\{i \in \mathbb{N} \mid i<n\}$ equipped with the norm given as the constant map with value 1 , the sum of the empty sequence in $S\left(\left(f_{i}\right)_{i=1}^{n}\right.$ in the case $n=0)$ is defined as $0 \in S$, and the $\ell^{p}$-norm of the empty sequence in $[0, \infty)\left(\left(\left|f_{i}\right|_{S}\right)_{i=1}^{n}\right.$ in the case $n=0)$ is defined as $0 \in[0, \infty)$. Then the triad $\left(S,|\cdot|_{S, p}, p\right)$ satisfies the following properties:
(i) $|1|_{S, p} \in\{0,1\}($ resp. $(0, \infty))$.
(ii) $|0|_{S, p}=0$.
(iii) For any $f, g \in S,|f-g|_{S, p} \leq\left\|\left(|f|_{S, p},|g|_{S, p}\right)\right\|_{p}$.
(iv) For any $f, g \in S,|f g|_{S, p} \leq|f|_{S, p}|g|_{S, p}$ (resp. $D|f|_{S, p}|g|_{S, p}$ ).

The condition (ii) immediately follows from the definitions related to the empty sequence. The condition (iii) follows from the definition of $|\cdot|_{S, p}$ using the infimum. The condition (i) follows from the condition (iv). We show the condition (iv). For simplicity, we only consider the case where $\Sigma$ is "short" because the computation is quite similar. By the continuity of the multiplication on $\mathbb{R}$, it suffices to show $|f g|_{S, p} \leq\left(|f|_{S, p}+\epsilon\right)\left(|g|_{S, p}+\epsilon\right)$ for any $\epsilon \in(0, \infty)$. By the definition of $|f|_{S, p}$, there exists an $\left(f_{i}\right)_{i=1}^{n_{f}} \in S^{n_{f}}$ with $n_{f} \in \mathbb{N}$, $\sum_{i=1}^{n_{f}} f_{i}=f$, and $0 \leq\left\|\left(\left|f_{i}\right|_{S}\right)_{i=1}^{n_{f}}\right\|_{p} \leq\left(|f|_{S, p}+\epsilon\right)$. By the definition of $|g|_{S, p}$, there exists a $\left(g_{j}\right)_{j=1}^{n_{g}} \in S^{n_{g}}$ with $n_{g} \in \mathbb{N}, \sum_{j=1}^{n_{g}} g_{j}=g$, and $0 \leq\left\|\left(\left|g_{j}\right|\right)_{S=1}^{n_{g}}\right\|_{p} \leq\left(|g|_{S, p}+\epsilon\right)$. By the definition of $|f g|_{S, p}$, we have

$$
\begin{aligned}
& |f g|_{S, p}=\left|\sum_{i=1}^{n_{f}} f_{i} \sum_{j=1}^{n_{g}} g_{j}\right|_{S, p}=\left|\sum_{i=1}^{n_{f}} \sum_{j=1}^{n_{g}} f_{i} g_{j}\right|_{S, p} \\
\leq & \left\|\left(\left(\left|f_{i} g_{j}\right|_{S}\right)_{i=1}^{n_{f}}\right)_{j=1}^{n_{g}}\right\|_{p}=\left(\sum_{i=1}^{n_{f}} \sum_{j=1}^{n_{g}}\left|f_{i} g_{j}\right|_{S}^{p}\right)^{\frac{1}{p}} \\
\leq & \left(\sum_{i=1}^{n_{f}} \sum_{j=1}^{n_{g}}\left|f_{i}\right|_{S}^{p}\left|g_{j}\right|_{S}^{p}\right)^{\frac{1}{p}}=\left(\sum_{i=1}^{n_{f}}\left|f_{i}\right|_{S}^{p} \sum_{j=1}^{n_{g}}\left|g_{j}\right|_{S}^{p}\right)^{\frac{1}{p}} \\
= & \left(\sum_{i=1}^{n_{f}}\left|f_{i}\right|_{S}^{p}\right)^{\frac{1}{p}}\left(\sum_{j=1}^{n_{g}}\left|g_{j}\right|_{S}^{p}\right)^{\frac{1}{p}}=\left\|\left(\left|f_{i}\right|_{S}\right)_{i=1}^{n_{f}}\right\|_{p}\left\|\left(\left|g_{j}\right| S\right)_{j=1}^{n_{g}}\right\|_{p} \\
\leq & \left(|f|_{S, p}+\epsilon\right)\left(|g|_{S, p}+\epsilon\right) .
\end{aligned}
$$

Therefore the condition (iv) holds.
We denote by $R_{p}$ the completion of $R$ with respect to the uniform structure associated to $|\cdot|_{R, p}$, i.e. the uniform structure generated by the basis $\left\{\left\{(f, g) \in R^{2}| | f-\left.g\right|_{R, p}<\right.\right.$ $\epsilon\} \mid \epsilon \in(0, \infty)\}$. Since $|\cdot|_{R, p}$ satisfies the conditions (i) - (iv), its extension $|\cdot|_{R_{p}}$ to $R_{p}$ also satisfies the conditions, and $\left(R,|\cdot|_{R}\right)_{p}:=\left(R_{p},|\cdot|_{R_{p}}, p\right)$ forms a Banach halo.

In addition, if $\left(R,|\cdot|_{R}, q\right)$ forms a Banach halo for a $q \leq p$, then $\left(R,|\cdot|_{R}\right)_{p}$ forms an $\left(R,|\cdot|_{R}, q\right)$-algebra, which is universal in $\left(R,|\cdot|_{R}, q\right)$-algebras whose constants are greater than or equal to $p$.

Proposition 5. Let $R$ be a $\Sigma$ Banach halo. For $p \geq p_{R}$, the forgetful functor $\operatorname{SMOD}_{R}^{p} \rightarrow$ $\mathrm{NSETS}_{\Sigma}$ has a left adjoint.

Proof. Let $X=\left(X,|\cdot|_{X}\right)$ be a normed set. We need to construct the free $p$-normed module on $X$. For this purpose, we will use Lemma 2 to enlarge $p_{R}$.

We recall that $\ell^{p_{R}}(X, R)$ the $R$-module is naturally identified with the completion of the free module $R^{(X)}$ on the underlying ring of $R$ with respect to the uniform structure associated to $\|\cdot\|_{X, p_{R}}$. For any $p \geq p_{R}$, we denote by $\operatorname{Res}_{R}^{R_{p}} \ell^{p}\left(X, R_{p}\right)$ the restriction of scalar of the $R_{p}$-module $\ell^{p}\left(X, R_{p}\right)$ by the canonical homomorphism $\left(R,|\cdot|_{R}, p_{R}\right) \rightarrow$ $\left(R,|\cdot|_{R}\right)_{p}$. Here, the restriction of scalar works by Lemma 1 .

We show that $\operatorname{Res}_{R}^{R_{p}} \ell^{p}\left(-, R_{p}\right)$ gives the left adjoint functor to the forgetful functor

$$
\operatorname{SMOD}_{R}^{p} \rightarrow \operatorname{NSETS}_{\Sigma}
$$

For this purpose, it suffices to show that for any normed set $X$, any $\Sigma R$-module ( $M, \mid$. $\left.\left.\right|_{M}, p_{M}\right)$ with $p_{M} \geq p$, and any short map $\varphi: X \rightarrow M$, the $R$-linear extension $R^{(\varphi)}: R^{(X)} \rightarrow$ $M$ of $\varphi$ uniquely extends to a short morphism $\operatorname{Res}_{R}^{R_{p}} \ell^{p}\left(X, R_{p}\right) \rightarrow M$ of $\Sigma R$-modules. Indeed, when $\Sigma$ is "Lipschitz", the extension property for a Lipschitz morphism follows from that of a short morphism because the rescaling of a norm on $X$ by a positive
 from the natural isomorphisms $R \cong R_{p}$ and $\operatorname{Res}_{R}^{R_{p}} \ell^{p}\left(X, R_{p}\right) \cong \ell^{p_{R}}(X, R)$. Therefore it suffices to show that the $\Sigma R$-module structure of $M$ uniquely extends to a $\Sigma R_{p}$-module structure, because then the $R_{p}$-linear extension $R_{p}^{(\varphi)}: R_{p}^{(X)} \rightarrow M$ of $\varphi$ uniquely extends to $\operatorname{Res}_{R}^{R_{p}} \ell^{p}\left(X, R_{p}\right)$.

By Lemma 1 and Proposition 2, $\left(\operatorname{End}_{R}(M),|\cdot|_{\operatorname{End}_{R}(M)}, p\right)$ forms an $R$-algebra and $M$ forms a module over it. Therefore by the universality of $R_{p},\left(\operatorname{End}_{R}(M),|\cdot| \operatorname{End}_{R}(M), p\right)$ forms an $R_{p}$-algebra, and $M$ forms an $R_{p}$-module.

There is a natural flow on monads on normed sets induced by the flow on normed sets, and defined (Following Nikolai Durov) by

$$
\sigma_{t} \Sigma(X):=\sigma_{t} \Sigma\left(\sigma_{1 / t} X\right)
$$

Another motivation underlying the definition of Banach halos is given by the following result.

Corollary 1. There is a natural fully faithful functor

$$
\begin{array}{ccc}
\text { CBanhalos }_{\Sigma} & \rightarrow & \text { Monads(NSETS } \\
A & \mapsto & \Lambda_{A}
\end{array}
$$

from commutative $\Sigma$ Banach halos to monads on normed sets defined by

$$
\Lambda_{A}(X):=\ell^{p_{A}}(X, A) .
$$

This functor is compatible with the $\mathbb{R}_{+}^{*}$-flow.

Proof. In the short situation, the functoriality in $A$ follows from Lemma 1. Indeed, if $f: R \rightarrow S$ is a morphism of Banach halos and $\sum a_{x}\{x\} \in \Lambda_{R}(X)$, then we have

$$
\left|\sum f\left(a_{x}\right)\{x\}\right|_{p_{S}}=\left\|\left(\left|f\left(a_{x}\right)\right|_{S} \cdot|x|_{X}\right)_{x \in X}\right\|_{p_{S}} \leq\left\|\left(\left|a_{x}\right|_{R} \cdot|x|_{X}\right)_{x \in X}\right\|_{p_{S}} \leq\left\|\left(\left|a_{x}\right|_{R} \cdot|x|_{X}\right)_{x \in X}\right\|_{p_{R}}
$$

because $p_{R} \leq p_{S}$, so that $f$ induces a short map $\Lambda_{R}(X) \rightarrow \Lambda_{S}(X)$. The same result is also true in the Lipschitz setting. The full faithfulness of the functor follows from the identification

$$
\Lambda_{R}\left(\left\{1_{1}\right\}\right)=R
$$

The fact that it is compatible with the flow, in the short setting, follows from $p_{\sigma_{t} R}=p_{R} / t$ and from the equalities

$$
\begin{aligned}
\left|\sum a_{x}\{x\}\right|_{p_{\sigma_{t} R}} & =\left\|\left(\left|a_{x}\right|_{R} \cdot|x|_{X}\right)\right\|_{p_{\sigma_{t} R}} \\
& =\left(\sum\left|a_{x}\right|_{\sigma_{t} R}^{p_{t} R} \cdot|x|^{p_{\sigma_{t} R} R}\right)^{1 / p_{\sigma_{t} R}} \\
& =\left(\left(\sum\left(\left|a_{x}\right|_{R}^{t}\right)^{p_{R} / t} \cdot\left(|x|^{p_{R}}\right)^{1 / t}\right)^{1 / p_{R}}\right)^{t} \\
& =\left\|\left(\left|a_{x}\right|_{R} \cdot|x|_{X}^{1 / t}\right)\right\|_{p_{R}}^{t}
\end{aligned}
$$

This compatibility with the flow is clear in the Lipschitz setting because the monoidal structure $\oplus^{\infty}$ on normed set is compatible with the flow.

Let $S$ be a Lipschitz Banach halo with the underlying ring $S_{0}$. It is notable that the notion of the freeness of an $R$-module is strictly stronger than the freeness of the underlying $S_{0}$-module even if it is of finite rank. For example, $\operatorname{Lip}\left(\mathbb{Z},|\cdot|_{0}, \infty\right)$ is a $\operatorname{Lip}(\mathbb{Z}, \mid$. $\left.\left.\right|_{\infty}, 1\right)$-module which is not free but whose underlying $\mathbb{Z}$-module is a free $\mathbb{Z}$-module of rank 1. Indeed, there exists no non-trivial Lipschitz $\operatorname{Lip}\left(\mathbb{Z},|\cdot|_{\infty}, 1\right)$-linear homomorphism $\operatorname{Lip}\left(\mathbb{Z},|\cdot|_{0}, \infty\right) \rightarrow \operatorname{Lip}\left(\mathbb{Z},|\cdot|_{\infty}, 1\right)$. In order to avoid such a pathlogic setting, we give a criterion for the boundedness of $S_{0}$-linear homomorphisms using $\|\cdot\|_{S, \infty}$ (cf. Definition (2).

Proposition 6. Let $M$ and $N$ be $S$-modules. Suppose that the underlying $S_{0}$-module of $M$ is a free $S_{0}$-module of rank $n \in \mathbb{N}$ with an $S_{0}$-linear basis $\left(e_{j}\right)_{j=1}^{n} \in M^{n}$ and there exists a $C \in\left[0, \infty\left[\right.\right.$ such that for any $\left(s_{j}\right)_{j=1}^{n} \in S_{0}^{n},\left\|\left(s_{j}\right)_{j=1}^{n}\right\|_{S, \infty} \leq C\left|\sum_{j=1}^{n} s_{j} e_{j}\right|_{M}$. Then every $S_{0}$-linear homomorphism $f: M \rightarrow N$ is Lipschitz.

Proof. Put $\left.C_{E}=\max _{j=1}^{n}\left|e_{j}\right|_{M} \in\right] 0, \infty\left[\right.$ and $C_{f}=\max _{j=1}^{n}\left|f\left(e_{j}\right)\right|_{N}$. For any $\left(s_{j}\right)_{j=1}^{n} \in S_{0}^{n}$,
we have

$$
\begin{aligned}
& \left|f\left(\sum_{j=1}^{n} s_{j} e_{j}\right)\right|_{N}=\left|\sum_{j=1}^{n} s_{j} f\left(e_{j}\right)\right|_{N} \leq C_{N}^{n-1}\left\|\left(s_{j} f\left(e_{j}\right)\right)_{j=1}^{n}\right\|_{N, \infty} \\
= & C_{N}^{n-1}\left\|\left(\left|s_{j} f\left(e_{j}\right)\right|_{N}\right)_{j=1}^{n}\right\|_{\infty} \leq C_{N}^{n-1}\left\|\left(D_{N}\left|s_{j}\right| S\left|f\left(e_{j}\right)\right|_{N}\right)_{j=1}^{n}\right\|_{\infty} \\
\leq & C_{N}^{n-1} D_{N} C_{f}\left\|\left(\left|s_{j}\right| S\right)_{j=1}^{n}\right\|_{\infty}=C_{N}^{n-1} D_{N} C_{f}\left\|\left(s_{j}\right)_{j=1}^{n}\right\|_{S, \infty} \\
\leq & C_{N}^{n-1} D_{N} C_{f} C\left|\sum_{j=1}^{n} s_{j} e_{j}\right|_{M} .
\end{aligned}
$$

This implies that $f$ is of operator norm $\leq C_{N}^{n-1} D_{N} C_{f} C$.

### 2.4 Direct sums, tensor products and symmetric algebras

Let $\Sigma$ denote either "short" or "Lipschitz".
Proposition 7. Let $R$ be a $\Sigma$ Banach halo and fix $p \geq p_{R}$. Let $\left(M_{i}\right)_{i \in I}$ be a family of modules over $R$ such that $\sup _{i \in I}\left(p_{M_{i}}\right)=p$. Then the coproduct of the family in both $\mathrm{SMOD}_{R}^{p}$ and $\mathrm{SMOD}_{R}$, denoted $\bigoplus_{i \in I} M_{i}$ exists.

Proof. One may write the direct sum as a quotient

$$
\bigoplus_{i \in I} M_{i}:=\operatorname{Res}_{R}^{R_{p}} \ell^{p}\left(\coprod_{i \in I} M_{i}, R_{p}\right) / \sim
$$

of the free $p$-normed module of Proposition 5 by the closure of the appropriate direct sum relations. This will fulfill the desired universal property.
Definition 10. Let $\left(M_{i}\right)_{i \in I}$ be a finite ordered family of modules over a $\Sigma$ Banach halo $R$ such that $\sup \left(p_{M_{i}}\right)=p$. Then we define the tensor product $\bigotimes_{i \in I} M_{i}$ as the quotient

$$
\bigotimes_{i \in I} M_{i}=\operatorname{Res}_{R}^{R_{p}} \ell^{p}\left(\otimes_{m, i \in I} M_{i}, R_{p}\right) / \sim
$$

of the free $p$-module of Proposition 5 on the multiplicative tensor product of the underlying normed sets by the appropriate bilinearity relations. The corresponding constant is fixed to be $p$.

Proposition 8. Let $\left(M_{i}\right)_{i \in I}$ be a finite ordered family of modules over a $\Sigma$ Banach halo $R$ such that $\sup \left(p_{M_{i}}\right)=p$. Then the tensor product $\otimes_{i \in I} M_{i}$ represents the functor

$$
\text { Multilin }\left(\left(M_{i}\right)_{i \in I},-\right): \operatorname{MoD}_{R}^{p} \rightarrow \operatorname{NSETS}_{\Sigma}
$$

that sends a $R$-module $M$ with $p_{M} \geq p$ to the set of $R$-multilinear $\Sigma$ maps $f: \otimes_{m, i \in I} M_{i} \rightarrow$ $M$ equipped with the operator norm.

Proof. This follows from Proposition 4 and the classical construction of tensor product of modules on rings.

Proposition 9. The forgetful functor $F: \mathrm{CALG}_{R} \rightarrow \mathrm{SMOD}_{R}$ from commutative algebras over $R$ to the category of $R$-modules with short morphisms has a left adjoint called the symmetric algebra functor and denoted $M \mapsto \operatorname{Sym}_{R}(M)$.

Proof. One may describe explicitely the symmetric algebra by

$$
\operatorname{Sym}_{R}(M):=\bigoplus_{n \in \mathbb{N}} M^{\otimes n} / I_{c}
$$

where $I_{c}$ is the closed two sided ideal generated by commutators $x \otimes y-y \otimes x$ in the free associative algebra $T_{R}(M):=\bigoplus_{n \in \mathbb{N}} M^{\otimes n}$ over $R$. This gives an adjoint because it is a composition of two adjoint functors: the adjoint to the forgetful functor from commutative $R$-algebras to associative $R$-algebras and the adjoint to the forgetful functor from associative $R$-algebras to $R$-modules.

### 2.5 Scalar extensions of modules

Proposition 10. Let $R \rightarrow S$ be a $\Sigma$-Banach halo morphism. Then the restriction of scalar functor $\mathrm{MOD}_{S} \rightarrow \mathrm{MOD}_{R}$ has an adjoint, denoted $\otimes_{R} S$, and called the scalar extension along $R \rightarrow S$.

Proof. The scalar extension of an $R$-module $M$ by a morphism $R \rightarrow S$ is given by the tensor product $M \otimes_{R} S$, seen as an $S$-module. Proposition 8 implies that it is an adjoint of the restriction of scalars.

Example 3. We abbreviate $\|\cdot\|_{\left(\mathbb{R},\left.|\cdot|\right|_{\infty}, q\right)}$ to $\|\cdot\|_{\infty, \ell^{q}}$ and $\|\cdot\|_{\left(\mathbb{Q}_{p},|\cdot| p, q\right)}$ to $\|\cdot\|_{p, \ell^{q}}$ for any $q \in[1, \infty)$. Let us consider the case where $\Sigma$ is "short", $R=\left(\mathbb{Z},|\cdot|_{\infty}, 1\right), S=\left(\mathbb{Z}_{p},|\cdot|_{p}, \infty\right)$, and $M=\left(\mathbb{Z}^{n},|\cdot|_{\infty, \ell q}, 1\right)$ for a $q \in[1, \infty)$. We have a natural $S$-linear isomorphism $M \otimes_{R}^{a l g} S \cong \mathbb{Z}_{p}^{n}$, and hence we identify them. Then $|\cdot|_{M \otimes_{R} S}$ is bounded by $|\cdot|_{p, \ell^{\infty}}$ by the definition of the left hand side using the infimum. On the other hand, $|\cdot|_{p, \ell^{\infty}}$ is known to satisfy the axiom of a module over $S$. Therefore for any $m \in M \otimes_{R}^{\text {alg }} S$ with a presentation $\sum_{i=0}^{n} m_{i} \otimes f_{i}=m$, we have

$$
|m|_{p, \ell^{\infty}} \leq\left\|\left(\left|m_{i} \otimes 1\right|_{p, \ell^{\infty}},\left|f_{i}\right|_{p}\right)_{i=0}^{n}\right\|_{\infty} \leq\left\|\left(\left|m_{i}\right|_{\infty, \ell^{1}},\left|f_{i}\right|_{p}\right)_{i=0}^{n}\right\|_{\infty}=\left\|\left(\left|m_{i}\right|_{M}\left|f_{i}\right|_{S}\right)_{i=0}^{n}\right\|_{\rho S}
$$

Taking the infimum, we obtain $|m|_{p, \ell \infty} \leq|m|_{M \otimes_{R} S}$. Thus we obtain $|\cdot|_{p, \ell \infty}=|\cdot|_{M \otimes_{R} S}$. Since $\mathbb{Z}_{p}^{n}$ is complete with respect to $|\cdot|_{p, \ell \infty}$, its completion is isomorphic to itself, so that we get

$$
\left(\mathbb{Z}^{n},|\cdot|_{\infty, \ell \ell}, 1\right) \otimes_{(\mathbb{Z},|\cdot| \infty, 1)}\left(\mathbb{Z}_{p},|\cdot|_{p}, \infty\right) \cong\left(\mathbb{Z}_{p}^{n},|\cdot|_{p, \ell \infty}, \infty\right)
$$

We can also apply the completely same argument to other norms $|\cdot|^{\prime}$ on $\mathbb{Z}^{n}$, as long as it satisfies the following two conditions:

1. The norm of a vector whose entries are 0 except for a single entry 1 is 1 . (The condition is used to show that $|\cdot|_{M \otimes_{R} S}$ is bounded by $|\cdot|_{p, \ell \infty}$.)
2. $\left(\mathbb{Z}^{n},|\cdot|^{\prime}\right) \rightarrow\left(\mathbb{Z}_{p}^{n},|\cdot|_{p, \ell \infty}\right)$ is short. (This condition is used to show $\left\|\left(\left|m_{i} \otimes 1\right|_{p, \ell \infty},\left|f_{i}\right|_{p}\right)_{i=0}^{n}\right\|_{\infty}$ $\left\|\left(\left|m_{i}\right|_{\infty, \ell^{1}},\left|f_{i}\right|_{p}\right)_{i=0}^{n}\right\|_{\infty}$ above $)$.

Example 4. In particular, the scalar extension of $M_{n}(\mathbb{Z}) \cong \mathbb{Z}^{n^{2}}$ equipped with the $\ell^{2}$ operator norm along $\left(\mathbb{Z},|\cdot|_{\infty}, 1\right) \rightarrow\left(\mathbb{Z}_{p},|\cdot|_{p}, \infty\right)$ is isomorphic to $M_{n}\left(\mathbb{Z}_{p}\right)$ equipped with the $\ell^{\infty}$ norm. Indeed, the first condition is clear, and the second follows from the following argument. Let $A \in M_{n}$. We denote by $A_{i, j}$ the $(i, j)$-entry of $A$ for each $i, j \in \mathbb{N}$ with $1 \leq i, j \leq n$. Then we have $A \delta_{j}=\left(A_{i, j}\right)_{i=1}^{n}$ and hence $|A|_{\ell^{2}, o p}=|A|_{\ell^{2}, o p}\left|\delta_{j}\right|_{\infty, \ell^{2}} \geq$ $\left|\left(A_{i, j}\right)_{i=1}^{n}\right|_{\infty, \ell^{2}} \geq\left|\left(A_{i, j}\right)_{i=1}^{n}\right|_{\infty, \ell \infty}$ (where $|\cdot|_{\infty, \ell q}$ denotes $\left.\|\cdot\|_{q}\right)$ for any $j \in \mathbb{N}$ with $1 \leq j \leq n$. Therefore we obtain $|A|_{p, \ell^{\infty}} \leq|A|_{\infty, \ell^{\infty}} \leq|A|_{\ell^{2}, o p}$ under the natural identification of $M_{n}(\mathbb{Z})$ and $\mathbb{Z}^{n^{2}}$.

### 2.6 Finite colimits of algebras and converging power series

Another good motivation for working with halos is given by the following result.
Proposition 11. Let $A$ be a commutative $\Sigma$ Banach halo. Then finite coproducts exist in the category of commutative $A$-algebras.

Proof. Let $B$ and $C$ be two $A$-algebras. The ( $B, C$ )-bimodule structure on $B \otimes C$ is given by Proposition 10 applied to the pair of $B$ and the underlying $A$-module structure of $C$, and the pair of $C$ and the underlying $A$-module structure of $B$, because of the symmetry of $\otimes$. It gives an $A$-bilinear map $B \otimes_{m} C \rightarrow \operatorname{End}_{A}(B \otimes C)$, which extends to $B \otimes C$ as an $A$-module homomorphism by Proposition 8. Thus $B \otimes C$ is equipped with a multiplication. The ring axiom immediately follows from the continuity of the operations and the ring axiom of the image of algebraic tensor product.

Corollary 2. Let $A$ be a commutative $\Sigma$ Banach halo. Finite colimits exist in the category CBanhalos $_{A}$ of $A$-algebras.

Proof. The coequalizer of a pair $f, g: R \rightarrow S$ of parallel arrows is defined as the quotient of $S$ by the closure of the ideal generated by $\{f(x)-g(x), x \in R\}$. It fulfills the universal property of the coequalizer. Since finite coproducts exist in the category of $A$-algebras, we get the desired result.

Proposition 12. Let $A$ be a commutative $\Sigma$ Banach halo. The adjoint to the forgetful functor $\mathrm{AlG}_{A} \rightarrow \mathrm{NSETS}_{\Sigma}$ exists and is denoted $X \mapsto A\langle X\rangle$. The $A$-algebra $A\langle X\rangle$ is called the $A$-algebra of converging power series on the normed set $X$.

Proof. Let $X$ be a normed set and $(X)_{m}^{\mathbb{N}}$ be the corresponding free multiplicatively normed monoid. Then

$$
A\langle X\rangle:=\ell^{p_{A}}\left((X)_{m}^{\mathbb{N}}, A\right)
$$

is an $A$-algebra that fulfills the desired universal property. One may also use the composition of the symmetric algebra functor and of the free module construction to describe the same algebra.

## 3 Short isometries and classical compact groups

### 3.1 Short isometries of Lipschitz coalgebras

Let $R$ be a Lipschitz Banach halo. In this section, we abbreviate the tensor product $\otimes_{R}$ of Lipschitz $R$-modules, which naturally makes sense by extending the construction for modules over a short Banach halo using free modules, to $\otimes$ as long as there is no ambiguity.

Definition 11. A monoid (resp. comonoid) with involution $(C, \sigma)$ over $R$ is a pair composed of a monoid (resp. comonoid) object in the monoidal category of Lipschitz $R$ modules and of an involution $\sigma$ that is a Lipschitz monoid (resp. comonoid) morphism $C \rightarrow C^{o p}$.

For an $R$-module $M$, we denote by $\operatorname{Hom}_{R}(M, R)$ the $R$-linear dual of $M$, i.e. the $R$ module given as the subset of $\operatorname{Hom}(M, R)$ consisting of Lipschitz $R$-linear homomorphisms equipped with the operator norm $|\cdot|_{\underline{\operatorname{Hom}(M, R)}}=|\cdot|_{o p}$ and the constant $p_{\underline{\text { Hom }}_{R}(M, R)}=p_{M}$. We abbreviate $\underline{\operatorname{Hom}}_{R}(M, R)$ to $M^{\vee}$ unless there is no ambiguity of $R$. Then we obtain a contravariant functor $\vee: \operatorname{MOD}(R) \rightarrow \operatorname{MOD}(R), M \mapsto M^{\vee}$.

Proposition 13. Let $(C, \sigma)$ be a comonoid with involution over $R$. Then $\left(C^{\vee}, \sigma^{\vee}\right)$ is a monoid with involution over $R$.

Proof. For every $R$-module $M$, there is a natural evaluation homomorphism

$$
M \otimes M^{\vee} \rightarrow R
$$

This gives an $R$-linear morphism

$$
C^{\vee} \otimes C^{\vee} \otimes C \otimes C \rightarrow R .
$$

This induces an $R$-linear morphism

$$
C^{\vee} \otimes C^{\vee} \rightarrow(C \otimes C)^{\vee}
$$

Composing it with the dual of the comultiplication on $C$, we get a multiplication

$$
C^{\vee} \otimes C^{\vee} \rightarrow C^{\vee}
$$

for which $C^{\vee}$ forms a monoid object for $\otimes$. This is equivalent to an $R$-algebra structure on $A$.

Remark 2. We note that the dual statement of Proposition 13 is not necessarily true. In other words, the dual of a monoid with involution $(A, \sigma)$ might not necessarily a comonoid with involution, as the dual of the multiplication $A \otimes A \rightarrow A$ is a morphism $A^{\vee} \rightarrow(A \otimes A)^{\vee}$ which might not factor through the natural morphism $A^{\vee} \otimes A^{\vee} \rightarrow(A \otimes A)^{\vee}$.

Let $(C, \sigma)$ be a comonoid with involution over $R$. For a commutative $R$-algebra $S$ and $(c, a) \in C \times\left(C^{\vee} \otimes S\right)$, we abbreviate to $a(c) \in S$ the image of $c \otimes a \in C \otimes C^{\vee} \otimes S$ by the scalar extension by $S$ of the pairing $C \otimes C^{\vee} \rightarrow R$ associated to the $R$-bilinear map $C \otimes^{m} C^{\vee} \rightarrow R,(c, f) \mapsto f(c)$ by the universality of $\otimes$.

Definition 12. We denote by $\mathrm{CALG}_{R}$ be the category of commutative $R$-algebras and bounded $R$-algebra homomorphisms, and define the functor of short isometries of $(C, \sigma)$, which will be denoted by $\operatorname{SIso}(C, \sigma)$, by

$$
\begin{aligned}
\mathrm{CALG}_{R} & \rightarrow \text { GRP } \\
S & \mapsto\left\{\begin{array}{l|l}
a \in C^{\vee} \otimes S & \begin{array}{l}
\exists D \in] 0, \infty\left[, \forall n \in \mathbb{N}, \forall\left(c_{i}\right)_{i=0}^{n-1} \in C^{n},\right. \\
\left|a\left(c_{0}\right) \cdots a\left(c_{n-1}\right)\right| \\
a \sigma_{S}(a)=D\left|c_{0}\right|_{C} \cdots\left|c_{n-1}\right|_{C}
\end{array}
\end{array}\right\}
\end{aligned}
$$

For a comonoid $C$ in $\mathrm{Mod}_{R}$ and an $R$-algebra $S$, we denote by $\alpha_{C, S}$ the Lipshictz $S$-linear homomorphism

$$
C^{\vee} \otimes_{R} S=\underline{\operatorname{Hom}}_{R}(C, R) \otimes_{R} S \rightarrow \underline{\operatorname{Hom}}_{S}\left(C \otimes_{R} S, S\right)
$$

assigning to each $a \in C^{\vee} \otimes_{R} S$ the Lipschitz $S$-linear homomorphism given as the $S$-linear extension of the evaluation map $C \rightarrow S, c \mapsto a(c)$.

Proposition 14. Let $(C, \sigma)$ be a comonoid with involution over $R$ and suppose that for every $R$-algebra $S, \alpha_{C, S}$ is an isomorphism. Then the group of short isometries $\operatorname{SIso}(C, \sigma)$ is represented by the algebra

$$
\mathcal{A}(\operatorname{SIso}(C, \sigma)):=\operatorname{Sym}_{R}(C) / \overline{(\{\nabla((1 \otimes \sigma)(\Delta(c)))-\eta(c) \mid c \in C\})}
$$

Proof. The comonoid structure $(\Delta, \eta)$ (resp. the involution $\sigma$ ) on $C$ induces a comultiplication and a counit (resp. an involution $\sigma$ ) on the tensor $R$-algebra $\left(T_{R}(C), \nabla\right)$ given by

$$
T_{R}(C)=\bigoplus_{n \in N} C^{\otimes n}
$$

by the functoriality of $\oplus$ and $\otimes$, the universality of $\oplus$, and the symmetry of $\otimes$. Moreover, $T_{R}(C)$ satisfies the axioms of a bimonoid expect for the coassociativity with respect to the comultiplication by construction. Those operations induce operations on $\operatorname{Sym}_{R}(C)$ and $\mathcal{A}(\operatorname{SIso}(C, \sigma))$, for which $\operatorname{Sym}_{R}(C)$ forms a bimonoid and $\mathcal{A}(\operatorname{SIso}(C, \sigma))$ forms a Hopf monoid.

Let $S$ be a commutative $R$-algebra. Then every $R$-algebra homomorphism $\mathcal{A}(\operatorname{SIso}(C, \sigma)) \rightarrow$ $S$ corresponds to an $R$-linear homomorphism $f: C \rightarrow S$ such that

$$
\nabla((f \otimes f)((1 \otimes \sigma)(\Delta(c))))=\eta(c)
$$

for any $c \in C$. We denote $f_{S}: C \otimes S \rightarrow S$ the scalar extension of $f$ to $S$. By hypothesis, $f_{S}$ can be represented as $\alpha_{C, S}(a)$ for a unique $a \in C^{\vee} \otimes_{R} S$. By definition, the image of $c \otimes a$ and $c \otimes \sigma_{S}^{\vee}(a)$ by the natural pairing

$$
C \otimes C^{\vee} \otimes S \rightarrow R \otimes S \cong S
$$

coincides with $f(c)$ and $f(\sigma(c))$ respectively for any $c \in C$. We now show that $a \in$ $\operatorname{SIso}(C, \sigma)(S)$.

The converging infinite sums may be permuted in a given halo. Take a presentation $\sum_{h \in H} a_{h} \otimes t_{h}$ of $a$. Let $c \in C \otimes S$. Take a presentation $\sum_{i \in I} c_{i} \otimes s_{i}$ of $c$. For each $i \in I$,
take a presentation $\sum_{j \in J_{i}} c_{i, j, 1} \otimes c_{i, j, 2}$ of $\Delta(c)$. We have

$$
\begin{aligned}
& \iota_{S}\left(a \sigma_{S}^{\vee}(a)-1\right)(c)=\iota_{S}\left(a \sigma_{S}^{\vee}(a)-1\right)\left(\sum_{i \in I} c_{i} \otimes s_{i}\right) \\
= & \sum_{h_{1}, h_{2} \in H} \sum_{i \in I} \iota_{S}\left(a_{h_{1}} \sigma^{\vee}\left(a_{h_{2}}\right) \otimes t_{h_{1}} t_{h_{2}}-1\right)\left(c \otimes s_{i}\right) \\
= & \sum_{h_{1}, h_{2} \in H} \sum_{i \in I} \sum_{j \in J_{i}} \iota_{S}\left(a_{h_{1}} \sigma^{\vee}\left(a_{h_{2}}\right) \otimes t_{h_{1}} t_{h_{2}}\right)\left(c_{i, j, 1} \otimes c_{i, j, 2} \otimes s_{i}\right) \\
& -\sum_{i \in I} \iota_{S}(\eta \otimes 1)\left(c \otimes s_{i}\right) \\
= & \sum_{h_{1}, h_{2} \in H} \sum_{i \in I} \sum_{j \in J_{i}} a_{h_{1}}\left(c_{i, j, 1}\right) \sigma^{\vee}\left(a_{h_{2}}\right)\left(c_{i, j, 2}\right) t_{h_{1}} t_{h_{2}} s_{i}-\sum_{i \in I} \eta(c) s_{i} \\
= & \sum_{h_{1}, h_{2} \in H} \sum_{i \in I} \sum_{j \in J_{i}} a_{h_{1}}\left(c_{i, j, 1}\right) a_{h_{2}}\left(\sigma\left(c_{i, j, 2}\right)\right) t_{h_{1}} t_{h_{2}} s_{i}-\sum_{i \in I} \eta(c) s_{i} \\
= & \sum_{i \in I} s_{i} \sum_{j \in J_{i}}\left(\sum_{h_{1} \in H} a_{h_{1}}\left(c_{i, j, 1}\right) t_{h_{1}}\right)\left(\sum_{h_{2} \in H} a_{h_{2}}\left(\sigma\left(c_{i, j, 2}\right)\right) t_{h_{2}}\right)-\sum_{i \in I} \eta(c) s_{i} \\
= & \sum_{i \in I} s_{i} \sum_{j \in J_{i}} \iota_{S}(a)\left(c_{i, j, 1} \otimes 1\right) \iota_{S}(a)\left(\sigma\left(c_{i, j, 2}\right) \otimes 1\right)-\sum_{i \in I} \eta(c) s_{i} \\
= & \sum_{i \in I} s_{i} \sum_{j=1}^{m_{i}} f_{S}\left(c_{i, j, 1} \otimes 1\right) f_{S}\left(\sigma\left(c_{i, j, 2}\right) \otimes 1\right)-\sum_{i \in I} \eta(c) s_{i} \\
= & \sum_{i \in I} s_{i} \sum_{j \in J_{i}} f\left(c_{i, j, 1}\right) f\left(\sigma\left(c_{i, j, 2}\right)\right)-\sum_{i \in I} \eta(c) s_{i} \\
= & \sum_{i \in I} s_{i} \nabla\left((1 \otimes \sigma(\Delta(c)))-\sum_{i \in I} \eta(c) s_{i}\right. \\
= & \sum_{i \in I} s_{i} \eta(c)-\sum_{i \in I} \eta(c) s_{i} \\
= & 0,
\end{aligned}
$$

and hence $\iota_{S}\left(a \sigma_{S}^{\vee}(a)-1\right)=0$. Since $\iota_{S}$ is injective, we obtain $a \sigma_{S}^{\vee}(a)-1=0$, i.e. $a \in \operatorname{SIso}(C, \sigma)$. The opposite implication follows from the same computation.

A Lipschitz Banach halo $S$ is said to be with submultiplicative norm if $|f g|_{S} \leq|f|_{S}|g|_{S}$ for any $(f, g) \in S^{2}$, and is said to be uniform if $\left|f^{n}\right|_{S}=|f|_{S}^{n}$ for any $(f, n) \in S \times \mathbb{N}$. For example, if $D_{R} \leq 1$, then every $R$-algebra $S$ is with submultiplicative norm by $D_{S} \leq D_{R}=1$.

Proposition 15. For any commutative $R$-algebra $S$ with submultiplicative norm,

$$
\left\{a \in C^{\vee} \otimes S\left|\forall c \in C,|a(c)|_{S} \leq|c|_{C}, a \sigma_{S}(a)=\sigma_{S}(a) a=1\right\}\right.
$$

is contained in $\operatorname{SIso}(C, \sigma)(S)$.
Proof. For any $\left(c_{i}\right)_{i=0}^{n-1} \in C^{n}$ with $n \in \mathbb{N}$, we have

$$
\left|a\left(c_{0}\right) \cdots a\left(c_{n-1}\right)\right|_{S} \leq\left|a\left(c_{0}\right)\right|_{S} \cdots\left|a\left(c_{n-1}\right)\right|_{S} \leq\left|c_{0}\right|_{C} \cdots\left|c_{n-1}\right|_{C} .
$$

Proposition 16. For any uniform commutative $R$-algebra $S$ with submultiplicative norm, we have

$$
\operatorname{SIso}(C, \sigma)(S)=\left\{a \in C^{\vee} \otimes S\left|\forall c \in C,|a(c)|_{S} \leq|c|_{C}, a \sigma_{S}(a)=\sigma_{S}(a) a=1\right\}\right.
$$

Proof. The right hand side is contained in the left hand side by Proposition 15, Let $a \in \operatorname{SIso}(C, \sigma)(S)$. By the definition of $\operatorname{SIso}(C, \sigma)(S)$, there exists some $R \in] 0, \infty[$ such that $\left|a\left(c_{0}\right) \cdots a\left(c_{n-1}\right)\right|_{S} \leq R\left|c_{0}\right|_{C} \cdots\left|c_{n-1}\right|_{C}$ for any $n \in \mathbb{N}$ and $\left(c_{i}\right)_{i=0}^{n-1} \in C^{n}$. Let $c \in C$. For any $n \in \mathbb{N}$, we have $|a(c)|_{S}^{n}=\left|a(c)^{n}\right|_{S} \leq R|c|_{C}^{n}$ by the uniformity of $S$, and hence $|a(c)|_{S} \leq R^{\frac{1}{n}}|c|_{C}$. It implies $|a(c)|_{S} \leq|c|_{C}$, as $\lim _{n \rightarrow \infty} R^{\frac{1}{n}}=1$.

We finish this subsection by giving sufficient conditions for the assumption in Proposition 14.

Proposition 17. Let $C$ be a comonoid of $\mathrm{MoD}_{R}$. If the underlying module of $C$ over the underlying ring $R_{0}$ of $R$ is free of finite rank and every $R$-linear homomorphism $C \rightarrow R$ is Lipschitz, then for every $R$-algebra $S$, the morphism

$$
\alpha_{C, S}: \underline{\operatorname{Hom}}_{R}(C, R) \otimes_{R} S \rightarrow \underline{\operatorname{Hom}}_{S}\left(C \otimes_{R} S, S\right)
$$

is an isomorphism.
Proof. We denote by $R_{0}$ the underlying ring of $R$, and by $S_{0}$ the underlying ring of $S$. Take an $R_{0}$-linear basis $\left(c_{i}\right)_{i=0}^{n-1}$ with $n \in \mathbb{N}$ of the underlying $R_{0}$-module of $C$. Since every $R$-linear homomorphism $C \rightarrow R$ is Lipschitz, the underlying $R_{0}$-module of $C^{\vee}$ admits its dual basis $\left(\delta_{i}\right)_{i=0}^{n-1}$, and hence the underlying $S_{0}$-module of $C^{\vee} \otimes_{R} S$ is a free $S_{0}$-module of rank $n$ with the $S_{0}$-linear basis $\left(\delta_{i} \otimes 1\right)_{i=0}^{n-1}$. Put $C_{0}:=\max _{i=0}^{n-1}\left|c_{i}\right|_{C}$ and $C_{1}:=\max _{i=0}^{n-1}\left|\delta_{i}\right|_{C^{v}}$. The composite of the given morphism and the canonical embedding from $\operatorname{Hom}_{S}\left(C \otimes_{R} S, S\right)$ into the $S_{0}$-module of all $R$-linear homomorphisms $C \rightarrow S$ is an $S_{0}$-linear isomorphism, every $R$-linear homomorphism $C \rightarrow S$ extends to a Lipschitz $R$-linear homomorphism $C \otimes_{R} S \rightarrow S$. This implies that the given morphism is also an $S_{0^{-}}$ linear isomorphism. Therefore it suffices to show that the inverse of the given morphism
is Lipschitz. For this purpose, it suffices to show that for any $d \in C^{\vee} \otimes_{R} S$, its image $d^{\prime} \in \underline{\operatorname{Hom}}_{S}\left(C \otimes_{R} S, S\right)$ is of norm $\geq|1|_{S}^{-1} C_{0}^{-1} C_{1}^{-1} C_{S}^{1-n}|d|_{C^{v} \otimes_{R} S}$.

Take a unique $\left(s_{i}\right)_{i=0}^{n-1} \in S_{0}^{n}$ with $d=\sum_{i=0}^{n-1} \delta_{i} \otimes s_{i}$. We have

$$
\begin{aligned}
& |d|_{C^{\vee} \otimes_{R} S}=\left|\sum_{i=0}^{n-1} \delta_{i} \otimes s_{i}\right|_{C^{\vee} \otimes_{R} S} \leq C_{S}^{n-1}\left\|\left(\left|\delta_{i}\right|_{C^{\vee}}\left|s_{i}\right|_{S}\right)_{i=0}^{n-1}\right\|_{\infty} \\
\leq & C_{S}^{n-1}\left\|\left(\left|\delta_{i}\right|_{C^{\vee}}\right)_{i=0}^{n-1}\right\|_{\infty}\left\|\left(\left|s_{i}\right|_{S}\right)_{i=0}^{n-1}\right\|_{\infty}=C_{S}^{n-1} C_{1}\left\|\left(\left|s_{i}\right|_{S}\right)_{i=0}^{n-1}\right\|_{\infty} .
\end{aligned}
$$

On the other hand, we have

$$
\begin{aligned}
& \left|d^{\prime}\right|_{{\underline{\operatorname{Hom}_{S}\left(C \otimes_{R} S, S\right)}}=\left|d^{\prime}\right|_{o p} \geq} \frac{\left|d^{\prime}\left(c_{i} \times 1\right)\right|_{S}}{\left|c_{i} \otimes 1\right|_{C \otimes_{R} S}} \\
= & \frac{\left|s_{i}\right|_{S}}{\left|c_{i} \otimes 1\right|_{C \otimes_{R} S}} \geq \frac{\left|s_{s^{2}}\right|_{S}}{\left|c_{i}\right|_{C}|1|_{S}} \geq|1|_{S}^{-1} C_{0}^{-1}\left|s_{i}\right|_{S}
\end{aligned}
$$

for any $0 \leq i \leq n-1$ and hence

$$
\left.\left|d^{\prime}{\underline{\operatorname{Hom}_{S}\left(C \otimes_{R} S, S\right)}} \geq|1|_{S}^{-1} C_{0}^{-1}\left\|\left(\left|s_{i}\right|_{S}\right)\right\|_{\infty} \geq|1|_{S}^{-1} C_{0}^{-1} C_{1}^{-1} C_{S}^{1-n}\right| d\right|_{C^{\vee} \otimes_{R} S} .
$$

Corollary 3. Let $C$ be a comonoid of $\mathrm{MoD}_{R}$. Suppose the underlying module of $C$ over the underlying ring $R_{0}$ of $R$ is free of rank $n \in \mathbb{N}$ with an $R_{0}$-linear basis $\left(c_{i}\right)_{i=1}^{n}$, and suppose further that there exists a constant $D \in] 0, \infty\left[\right.$ such that for any $\left(r_{i}\right)_{i=1}^{n} \in R^{n}$, the equality $\left|\left(r_{i}\right)_{i=1}^{n}\right|_{S, \infty} \leq D\left|\sum_{i=1}^{n} r_{i} c_{i}\right|_{C}$ holds. Then the morphism

$$
\alpha_{C, S}: \underline{\operatorname{Hom}}_{R}(C, R) \otimes_{R} S \rightarrow \underline{\operatorname{Hom}}_{S}\left(C \otimes_{R} S, S\right)
$$

is an isomorphism for any $R$-algebra $S$.
Proof. The assertion immediately follows from Proposition 6 and Proposition 17

### 3.2 The global short isometry subgroup of GL ${ }_{n}$

The aim of this whole Section is to prove the following theorem, that is the main result of this paper.

Theorem 1. There exists an explicit Lipschitz coalgebra with involution $(C, \sigma)$ over $\mathbf{Z}=$ $\operatorname{Lip}\left(\mathbb{Z},|\cdot|_{\infty}, 1\right)$ whose short isometry group, denoted $K_{n}=\operatorname{SIso}(C, \sigma)$, is representable by a Lipschitz Banach halo $\mathcal{A}\left(K_{n}\right)$ and fulfils

$$
K_{n}(R) \subset \mathrm{GL}_{n}(R)
$$

for every $R \in \operatorname{CALG}_{\mathbf{Z}}$ and such that, if we denote $\mathbf{R}=\operatorname{Lip}\left(\mathbb{R},|\cdot|_{\infty}, 1\right)$ and $\mathbf{Q}_{p}=$ $\operatorname{Lip}\left(\mathbb{Q}_{p},|\cdot|_{p}, \infty\right)$, we have

1. $K_{n}(\mathbf{R}) \cong O_{n}(\mathbb{R})$,
2. $K_{n}\left(\mathbf{Q}_{p}\right) \cong \mathrm{GL}_{n}\left(\mathbb{Z}_{p}\right)$,
3. $K_{n}(\mathbf{Z}) \cong O_{n}(\mathbb{R}) \cap \mathrm{GL}_{n}(\mathbb{Z}) \equiv \mathrm{GL}_{n}\left(\mathbb{F}_{\{ \pm 1\}}\right)$

Remark 3. We may change $\mathbf{Z}$ to $\sigma_{t}(\mathbf{Z})$ for $t \in \mathbb{R}_{+}^{*}$ without changing these results.
We fix a positive integer $n$. We set $R=\left(\mathbb{Z},|\cdot|_{\infty}, 1\right)$. Let $S$ be a commutative $R$-algebra with the underlying ring $S_{0}$ with $p_{S}=1$. We fix a $q \in[1, \infty]$. We denote by $S_{\ell q}^{n}$ the triad $\left(S_{0}^{n},\|\cdot\|_{S, q}, 1\right)$ (cf. Definition(2), which forms an $S$-module by $1 \leq \min \left\{q, p_{S}\right\}$. We observe the structures of the endomorphism ring of $S_{\ell q}^{n}$ (cf. proposition (2).

Proposition 18. (i) Every $S_{0}$-linear endomorphism of the $S$-modules $S_{\ell q}^{n}$ and $\operatorname{Hom}_{S}\left(S_{\ell q}^{n}, S\right)$ is Lipschitz. In particular, for any $f \in \operatorname{End}_{S}\left(S_{\ell q}^{n}\right)$, its $S_{0}$-linear dual $f^{\vee}$ belongs to $\operatorname{End}_{S}\left(\underline{\operatorname{Hom}_{S}}\left(S_{\ell q}^{n}, S\right)\right)$.
(ii) The map $\vee: \operatorname{End}_{S}\left(S_{\ell q}^{n}\right) \rightarrow \operatorname{End}_{S}\left(\underline{\operatorname{Hom}}_{S}\left(S_{\ell q}^{n}, S\right)\right), f \mapsto f^{\vee}$ is a Lipschitz $S_{0}$-linear isomorphism whose inverse is also Lipschitz.

Proof. The assertions immediately follow from Proposition 6, because we can choose $E$ to be the canonical bases and $C$ to be 1 .

We also denote by $\vee$ the inverse of $\vee$ in the assertion of Proposition 18 (ii). We denote by $M(n, S, q)$ the direct product $\operatorname{Lip}(S)$-algebra

$$
\operatorname{End}_{\operatorname{Lip}(S)}\left(\operatorname{Lip}\left(S_{\ell^{q}}^{n}\right)\right) \times \operatorname{End}_{\operatorname{Lip}(S)}\left(\underline{\operatorname{Hom}}_{\operatorname{Lip}(S)}\left(\operatorname{Lip}\left(S_{\ell^{q}}^{n}\right), \operatorname{Lip}(S)\right)\right),
$$

and equip it with the involution

$$
\begin{aligned}
t_{M(n, S, q)}: M(n, S, q) & \rightarrow M(n, S, q) \\
(f, g) & \mapsto\left(g^{\vee}, f^{\vee}\right),
\end{aligned}
$$

which is a monoid homomorphism $M(n, S, q) \rightarrow M(n, S, q)^{o p}$. In particular, $M(n, S, q)$ is a monoid with involution over $\operatorname{Lip}(S)$, whose underlying $S_{0}$-algebra with involution represents $\mathrm{GL}_{n} \times \times_{\operatorname{Spec}(\mathbb{Z})} \operatorname{Spec}\left(S_{0}\right)$.

We note that the underlying $S_{0}$-module of $M(n, S, q)$ is a free $S_{0}$-module of rank $2 n^{2}$. Therefore its $S_{0}$-linear dual is also a free $S_{0}$-module of rank $2 n^{2}$ and the multiplication of $M(n, S, q)$ induces a comultiplication on it. Contrary to Remark 2, the comultiplication is Lipschitz as a map

$$
\underline{\operatorname{Hom}}_{\operatorname{Lip}(S)}(M(n, S, q), \operatorname{Lip}(S)) \rightarrow \underline{\operatorname{Hom}}_{\operatorname{Lip}(S)}(M(n, S, q), \operatorname{Lip}(S))^{\otimes_{S} 2}
$$

by Proposition 6. Therefore $\underline{\operatorname{Hom}}_{\operatorname{Lip}(S)}(M(n, S, q), \operatorname{Lip}(S))$ forms a comonoid with involution over $\operatorname{Lip}(S)$ with respect to the dual involution of $t_{M(n, S, q)}$.

We denote by $\left(C\left(K_{n}\right), \sigma_{C\left(K_{n}\right)}\right)$ the $\mathbf{Z}$-linear dual of the monoid with involution over $\mathbf{Z}$ given as $\left(M(n, R, 2), t_{M(n, R, 2)}\right)$ except that the norm $|\cdot|_{M(n, R, 2)}$ is replaced by the restriction of $\left.\left.|\cdot|_{M(n,(\mathbb{R},|\cdot|}, 1\right), 2\right)$ along the natural map

$$
M(n, R, 2)=M\left(n,\left(\mathbb{Z},|\cdot|_{\infty}, 1\right), 2\right) \rightarrow M\left(n,\left(\mathbb{R},|\cdot|_{\infty}, 1\right), 2\right)
$$

Then $\left(C\left(K_{n}\right), \sigma_{C\left(K_{n}\right)}\right)$ forms a comonoid with involution over $\mathbf{Z}$ again by Proposition 6,
Since $\left(C\left(K_{n}\right), \sigma_{C\left(K_{n}\right)}\right)$ is a comonoid object in $\operatorname{Mod}(\mathbf{Z})$ with an involution, we can apply SIso to it. The reader should be careful that the $\ell^{2}$ operator norm on matrices over $\mathbb{Z}$ might not be reflexive, i.e. might not coincide with the second dual norm. That is why we use the restriction of $|\cdot|_{M(n,(\mathbb{R},|\cdot| \infty, 1), 2)}$ instead of $|\cdot|_{M(n, R, 2)}$ here.

Proposition 19. The group of short isometries $\operatorname{SIso}\left(C\left(K_{n}\right), \sigma_{C\left(K_{n}\right)}\right)$ is represented by $\mathcal{A}\left(K_{n}\right):=\mathcal{A}\left(\operatorname{SIso}\left(C\left(K_{n}\right), \sigma_{C\left(K_{n}\right)}\right)\right)$.

Proof. The assertion immediately follows from Proposition 14 . Indeed, we will show in Proposition 22 that the dual basis of the canonical basis of $M(n, R, 2)$ satisfies the assumption of Corollary 3 with respect to the constant $D=1$.

We will give an explicit computation of $|\cdot|_{C\left(K_{n}\right)}$ for the reader's convenience in $\$ 3.4$.

### 3.3 Global short isometry subgroups of other classical groups

Let $V=\mathbb{Z}^{n}$ be the free module, that we first consider as a mere module. Recall from KMRT98 the definition of the group of isometries of an algebra with involution $(A, \sigma)$ over a base commutative ring $R$, i.e. a pair of an $R$-algebra $A$ and an involution $\sigma$ on $A$ that is a ring homomorphism $A \rightarrow A^{o p}$.

Definition 13. Let $(A, \sigma)$ be an algebra with involution over a commutative ring $R$ and $S$ be a commutative $R$-algebra. Then the group of isometries of $(A, \sigma)$ with values in $S$ is

$$
\operatorname{Iso}(A, \sigma)(S):=\left\{a \in A \otimes_{R} S \mid a \sigma(a)=\sigma(a) a=1_{A}\right\}
$$

By abuse of notation, if $R, S$ and $A$ are Lipschitz Banach halos, we will also denote Iso $(A, \sigma)(S)$ the corresponding multiplicative subgroup of the scalar extension $A \otimes_{R} S$. By Proposition 15 and Proposition 16, we obtain the following justification of the terminology of "the functor of short isometries" in $\$ 3.1$.

Proposition 20. Let $R$ be a commutative Lipschitz Banach halo with $D_{R}=1,(C, \sigma)$ a coalgebra with involution over $R$, and $S$ a commutative $R$-algebra. We have

$$
\left\{a \in \operatorname{Iso}\left(C^{\vee}, \sigma^{\vee}\right)(S)\left|\forall c \in C,|a(c)|_{S} \leq|c|_{C}\right\} \subset \operatorname{SIso}(C, \sigma)(S)\right.
$$

In addition, if $S$ is uniform, then the inclusion is an equality.

We already know that $\mathrm{GL}_{n}$ is naturally identified with the isometry group $\operatorname{Iso}(A, \sigma)$ of an algebra with involution given by $A=\operatorname{End}(V) \times \operatorname{End}\left(V^{\vee}\right)$ with its transposition involution

$$
\sigma(f, g)=\left(g^{\vee}, f^{\vee}\right)
$$

where End denotes the algebraic endomorphism ring of a mere module. Let $\varphi: V \times V \rightarrow$ $\mathbb{Z}$ be a non-degenerate bilinear pairing and consider the associated involution algebra $\left(\operatorname{End}(V), \sigma_{\varphi}\right)$, where

$$
\sigma_{\varphi}(f)=\left(\varphi^{b}\right)^{-1} \circ f^{\vee} \circ \varphi^{b}
$$

with $\varphi^{b}: V \xrightarrow{\sim} V^{\vee}$ the isomorphism induced by $\varphi$.
There is a natural injective morphism of involution algebras

$$
\begin{array}{clc}
\operatorname{End}(V) & \rightarrow & \operatorname{End}(V) \times \operatorname{End}\left(V^{\vee}\right) \\
f & \mapsto & \left(f,\left[\sigma_{\psi}(f)\right]^{\vee}\right)
\end{array}
$$

that is compatible with the involutions $\sigma$ and $\sigma_{\varphi}$ and induces the natural map

$$
\operatorname{Iso}\left(\operatorname{End}(V), \sigma_{\varphi}\right) \rightarrow \mathrm{GL}_{n}
$$

between the classical group associated to the given non-degenerate bilinear form and $\mathrm{GL}_{n}$.
By $\mathbb{Z}$-linear duality, we get a surjective morphism of comonoid with involution

$$
\left[\operatorname{End}(V) \times \operatorname{End}\left(V^{\vee}\right)\right]^{\vee} \rightarrow \operatorname{End}(V)^{\vee}
$$

Since $\operatorname{End}(V) \times \operatorname{End}\left(V^{\vee}\right)$ is the underlying monoid with involution over $\mathbb{Z}$ of $M(2,(\mathbb{Z}, \mid \cdot$ $\left.\left.\right|_{\infty}, 1,2\right)$, the source of the morphism precisely coincides with the underlying comonoid with involution over $\mathbb{Z}$ of the comonoid with involution $C\left(K_{n}\right)$ over $\operatorname{Mod}(\mathbb{Z})$. We use this map to induce a quotient norm $\|\cdot\|_{\varphi}$ on the target comonoid with involution $\left(\operatorname{End}(V)^{\vee}, \sigma_{\varphi}^{\vee}\right)$ over $\mathbb{Z}$.

This gives a comonoid $C\left(K_{n}(\varphi)\right)=\left(\operatorname{End}(V)^{\vee},\|\cdot\|_{\varphi},(2,1)\right)$ with involution $\sigma_{\varphi}^{\vee}$ over $\mathbf{Z}$.
Definition 14. The short isometry group $\operatorname{SIso}\left(C\left(K_{n}(\varphi)\right), \sigma_{\varphi}^{\vee}\right)$ of the comonoid with involution $\left(C\left(K_{n}(\varphi)\right), \sigma_{\varphi}^{\vee}\right)$ is denoted $K_{n}(\varphi)$ and called the short isometry group of the given bilinear form.

The short surjective comonoid homomorphism

$$
C\left(K_{n}\right) \rightarrow C\left(K_{n}(\varphi)\right)
$$

given by the quotient map

$$
\left[\operatorname{End}(V) \times \operatorname{End}\left(V^{\vee}\right)\right]^{\vee} \rightarrow \operatorname{End}(V)^{\vee}
$$

induces a natural embedding

$$
K_{n}(\varphi) \rightarrow K_{n} \subset \mathrm{GL}_{n}
$$

because of the compatibility of $\sigma_{C\left(K_{n}\right)}$ and $\sigma_{\varphi}$. By Proposition 16, this embedding induces a natural embedding

$$
\begin{aligned}
& K_{n}(\varphi)(S)=\operatorname{SIso}\left(C\left(K_{n}(\varphi)\right), \sigma_{\varphi}^{\vee}\right)(S)=\operatorname{SIso}\left(\operatorname{End}(V)^{\vee},\|\cdot\|_{\varphi}, \sigma_{\varphi}^{\vee}\right)(S) \\
\rightarrow & \operatorname{Iso}\left(\operatorname{End}(V)^{\vee \vee}, \sigma_{\varphi}^{\vee \vee}\right)(S) \cong \operatorname{Iso}\left(\operatorname{End}(V), \sigma_{\varphi}\right)(S)
\end{aligned}
$$

of subgroups of $\mathrm{GL}_{n}(S)$ for any uniform Z-algebra $S$.
Remark 4. More generally, let $B$ be a ring which is a free $\mathbb{Z}$-module of finite rank $m$, and $\gamma$ be an involution of $B$ that is a ring homomorphism $B \rightarrow B^{o p}$. Fix a left $B$-module $M$ which is a free $\mathbb{Z}$-module of finite rank $n$ such that the canonical morphism $B \rightarrow \operatorname{End}(M)$ is injective. We have considered the specific setting $(B, M)=(\operatorname{End}(V), V)$, but $B$ can be chosen arbitrarily because $M$ can be taken as the regular left $B$-module.

Then we may embed $B$ in

$$
A=\operatorname{End}(M) \times \operatorname{End}\left(M^{\vee}\right)
$$

by the left action on $M$ and the dual action on $M^{\vee}$ twisted by $\gamma$, i.e. by $(b \cdot f)(m):=$ $f(\gamma(b) m)$ for $(b, f, m) \in B \times M^{\vee} \times M$. A construction similar to the above one gives a quotient comonoid map

$$
A^{\vee} \rightarrow B^{\vee}
$$

that allows us to define a subgroup

$$
K(B, \gamma) \subset K_{n}
$$

of the standard subgroup $K_{n}$ of $\mathrm{GL}_{n} \cong \mathrm{GL}(M)$ contained in $\operatorname{Iso}(B, \gamma)$.

### 3.4 Computation of $p$-adic and real points

Following the convention in §3.3, we demonstrate the computation of $p$-adic and real points of $K_{n}$. Throughout this subsection, let $R$ denote the short Banach halo $\left(\mathbb{Z},|\cdot|_{\infty}, 1\right.$ ), and $S$ denote a commutative $R$-algebra with undering ring $S_{0}$ and $p_{S}=1$.

For an $A \in \operatorname{End}(V)\left(\right.$ resp. $\left.\operatorname{End}\left(V^{\vee}\right)\right)$ and an $(i, j) \in \mathbb{N}^{2}$ with $1 \leq i, j \leq n$, we denote by $A[i, j]$ the $(i, j)$-entry of $A$ with respect to the matrix presentation for the canonical basis of $V\left(\right.$ resp. $\left.V^{\vee}\right)$. For an $(i, j) \in \mathbb{N}^{2}$ with $1 \leq i, j \leq n$, we denote by $E_{i, j} \in \operatorname{End}_{\mathbb{Z}}\left(\mathbb{Z}^{n}\right)$ the matrix whose $(i, j)$-entry is 1 and whose other entries are 0 . For any $(i, j, b) \in \mathbb{N}^{3}$ with $1 \leq i, j \leq n$ and $b \leq 1$, we denote by $E_{i, j, b} \in M(n, R, 2)$ the image of $E_{i, j}$ in $\operatorname{End}_{R}\left(R_{\ell^{2}}^{n}\right)$ when $b=0$ and in $\operatorname{End}_{R}\left(\left(R_{\ell^{2}}^{n}\right)^{\vee}\right)$ when $b=1$. Then $\left(\left(E_{i, j, b}\right)_{i, j=1}^{n}\right)_{b=0}^{1}$ forms a $\mathbb{Z}$-linear basis of the underlying $\mathbb{Z}$-module of $M(n, R, 2)$. We denote by $\left(\left(e_{i, j, b}\right)_{i, j=1}^{n}\right)_{b=0}^{1}$ the $\mathbb{Z}$-linear basis of the underlying $\mathbb{Z}$-module of $C\left(K_{n}\right)$ dual to $\left(\left(E_{i, j, b}\right)_{i, j=1}^{n}\right)_{b=0}^{1}$.
Proposition 21. For any $(i, j, b) \in \mathbb{N}^{3}$ with $1 \leq i, j \leq n$ and $b \leq 1$, the equality $\left|e_{i, j, b}\right|_{C\left(K_{n}\right)}=1$ holds.

Proof. Set $S=\left(\mathbb{R},|\cdot|_{\infty}, 1\right)$. For any $\left(B_{0}, B_{1}\right) \in M(n, R, 2)$ naturally regarded as an element of $M(n, S, 2)$, we have

$$
\left|e_{i, j, b}\left(B_{0}, B_{1}\right)\right|_{\infty}=\left|B_{b}[i, j]\right|_{\infty} \leq\left|\left(B_{0}, B_{1}\right)\right|_{M(n, S, 2)}
$$

This implies $\left|e_{i, j, b}\right|_{\mathcal{C}\left(K_{n}\right)} \leq 1$. On the other hand, we have $\left|e_{i, j, b}\left(E_{i, j, b}\right)\right|_{\infty}=|1|_{\infty}=1$. This implies $\left|e_{i, j, b}\right|_{C\left(K_{n}\right)} \geq 1$ by $\left|E_{i, j, b}\right|_{M(n, S, 2)}=1$.
Proposition 22. For any $\left(\left(r_{i, j, b}\right)_{i, j=1}^{n}\right)_{b=0}^{1} \in\left(\left(R^{n}\right)^{n}\right)^{2}$, the equality $\left\|\left(\left(\left|r_{i, j, b}\right|\right)_{i, j=1}^{n}\right)_{b=0}^{1}\right\|_{\infty} \| \leq$ $\left|\sum_{b=0}^{1} \sum_{i, j=1}^{n} r_{i, j, b} e_{i, j, b}\right|_{C\left(K_{n}\right)}$ holds.

Proof. Set $S=\left(\mathbb{R},|\cdot|_{\infty}, 1\right)$. For any $\left(i_{0}, j_{0}, b_{0}\right) \in \mathbb{N}^{3}$ with $1 \leq i_{0}, j_{0} \leq n$ and $b_{0} \leq 1$, we have

$$
\left|\left(\sum_{b=0}^{1} \sum_{i, j=1}^{n} r_{i, j, b} e_{i, j, b}\right)\left(E_{i_{0}, j_{0}, b_{0}}\right)\right|_{R}=\left|r_{i_{0}, j_{0}, b_{0}}\right|_{R} .
$$

and hence

$$
\left|\sum_{b=0}^{1} \sum_{i, j=1}^{n} r_{i, j, b} e_{i, j, b}\right|_{R} \geq \frac{\left|r_{i_{0}, j_{0}, b_{0}}\right|_{R}}{\left|E_{i_{0}, j_{0}, b_{0}}\right|_{M(n, S, 2)}}=\left|r_{i_{0}, j_{0}, b_{0}}\right|_{R} .
$$

This implies the assertion.
Let $(f, s) \in C\left(K_{n}\right)^{\vee} \times S$. We denote by $i_{S}(f, s)_{0} \in \operatorname{End}_{S_{0}}\left(S_{0}^{n}\right)$ the $S_{0}$-linear endomorphism

$$
\begin{aligned}
S_{0}^{n} & \rightarrow S_{0}^{n} \\
\left(t_{j}\right)_{j=1}^{n} & \mapsto\left(\sum_{j=1}^{n} s f\left(e_{i, j, b}\right) t_{j}\right)_{i=1}^{n},
\end{aligned}
$$

and by $i_{S}(f, s)_{1} \in \operatorname{End}_{S_{0}}\left(\underline{\operatorname{Hom}}_{S_{0}}\left(S_{0}^{n}, S_{0}\right)\right)$ the $S_{0}$-linear endomorphism

$$
\begin{aligned}
\underline{\operatorname{Hom}}_{S_{0}}\left(S_{0}^{n}, S_{0}\right) & \rightarrow \underline{\operatorname{Hom}}_{S_{0}}\left(S_{0}^{n}, S_{0}\right) \\
u & \mapsto\left(\left(t_{i}\right)_{i=1}^{n} \mapsto \sum_{i=1}^{n} s t_{i} u\left(\left(f\left(e_{i, j, b}\right)\right)_{j=1}^{n}\right)\right) .
\end{aligned}
$$

We put $i_{S}(f, s)=\left(i_{S}(f, s)_{0}, i_{S}(f, s)\right) \in \operatorname{End}_{S_{0}}\left(S_{0}^{n}\right) \times \operatorname{End}_{S_{0}}\left(\underline{\operatorname{Hom}}_{S_{0}}\left(S_{0}^{n}, S_{0}\right)\right)$. By Proposition 2, we have $i_{S}(f, s) \in M(n, S, q)$ for any $q \in[1, \infty]$.

Proposition 23. For any $(f, s, q) \in C\left(K_{n}\right)^{\vee} \times S_{0} \times[1, \infty]$, the inequality $\left|i_{S}(f, s)\right|_{M(n, S, q)} \leq$ $n^{1+\frac{1}{q}}|f|_{C\left(K_{n}\right)}|s|_{S}$ holds.

Proof. For any $\left(t_{i}\right)_{i=1}^{n} \in S_{0}^{n}$, we have

$$
\begin{aligned}
& \left\|i_{S}(f, s)_{0}\left(\left(t_{i}\right)_{i=1}^{n}\right)\right\|_{S, q}=\left\|\left(\sum_{j=1}^{n} s f\left(e_{i, j, 0}\right) t_{j}\right)_{i=1}^{n}\right\|_{S, q} \\
= & \left\|\left(\left|\sum_{j=1}^{n} s f\left(e_{i, j, 0}\right) t_{j}\right|_{S}\right)_{i=1}^{n}\right\| \leq\left\|\left(\left\|\left(\left|s f\left(e_{i, j, 0}\right) t_{j}\right|_{S}\right)_{j=1}^{n}\right\|_{1}\right)_{i=1}^{n}\right\|_{q} \\
\leq & \left\|\left(\left\|\left(|s|_{S}|f|_{o p}\left|e_{i, j, 0}\right|_{\mathcal{C}\left(K_{n}\right)}\left|t_{j}\right|_{S}\right)_{j=1}^{n}\right\|_{1}\right)_{i=1}^{n}\right\|_{q} \\
\leq & |s|_{S}|f|_{o p}\left\|\left(\left\|\left(\left|t_{j}\right|_{S}\right)_{j=1}^{n}\right\|_{1}\right)_{i=1}^{n}\right\|_{q}=n^{\frac{1}{q}}|s|_{S}|f|_{o p}\left\|\left(\left|t_{j}\right|_{S}\right)_{j=1}^{n}\right\|_{1} \\

is a bijective map onto $\left\{\left(U, U^{-1}\right) \mid U \in \mathrm{GL}_{n}\left(\mathbb{Z}_{p}\right)\right\}$.
Lemma 10. When $S=\left(\mathbb{Q}_{p},|\cdot|_{\infty}, 1\right), \iota_{S, \infty}$ is a short map.
Proof. Let $(f, s) \in C\left(K_{n}\right) \times S$. For any $\left(t_{i}\right)_{i=1}^{n} \in \mathbb{Q}_{p}^{n}$, we have

& \left\|i_{S}(f, s)_{0}\left(\left(t_{i}\right)_{i=1}^{n}\right)\right\|_{S, \infty}=\left\|\left(\sum_{j=1}^{n} s f\left(e_{i, j, 0}\right) t_{j}\right)_{i=1}^{n}\right\|_{S, \infty} \\
= & \left\|\left(\left|\sum_{j=1}^{n} s f\left(e_{i, j, 0}\right) t_{j}\right|_{p}\right)_{i=1}^{n}\right\| \\
\leq & \left\|\left(\left\|\left(\left|s f\left(e_{i, j, 0}\right) t_{j}\right|_{p}\right)_{j=1}^{n}\right\|_{\infty}\right)_{i=1}^{n}\right\|_{\infty} \\
= & \left\|\left(\left|s f\left(e_{i, j, 0}\right) t_{j}\right|_{p}\right)_{i, j=1}^{n}\right\|_{\infty}=\left\|\left(|s|_{p}|f|_{o p}\left|e_{i, j, j}\right|_{C\left(K_{n}\right)}\left|t_{j}\right|_{p}\right)_{i, j=1}^{n}\right\|_{\infty} \\
= & \left\|\left(|s|_{p}|f|_{o p}\left|t_{j}\right|_{p}\right)_{i, j=1}\right\|_{\infty}=|s|_{p}|f|_{o p}\left\|\left(\left|t_{i}\right|_{p}\right)_{i=1}^{n}\right\|_{\infty} \\
= & |s|_{p}|f|_{C\left(K_{n}\right)} v\left\|\left(t_{i}\right)_{i=1}^{n}\right\|_{S, \infty}
\end{aligned}
$$

by Proposition 21, and hence $\left|i_{S}(f, s)_{0}\right|_{\operatorname{End}\left(S_{e}^{n}\right)} \leq|s|_{p}|f|_{C\left(K_{n}\right)}$. Similarly, we have $\left|i_{S}(f, s)_{1}\right|_{\operatorname{End} S\left(\operatorname{Hom}_{S}\left(S_{R}^{n} \infty, S\right)\right)} \leq|s|_{p}|f|_{C\left(K_{n}\right)^{\vee}}$. Therefore $i_{S}$ gives a short $\mathbb{Z}$-bilinear map $C\left(K_{n}\right)^{\vee} \otimes^{m} S \rightarrow M(n, S, \infty)$. By Proposition 图, $\iota_{S, \infty}$ is a short map.

Lemma 11. When $S=\left(\mathbb{Q}_{p},|\cdot|_{\infty}, 1\right), \iota_{S, \infty}$ is an isometric isomorphism.

Proof. We denote by $\left(\left(\delta_{i, j, b}\right)_{i, j=1}^{n}\right)_{b=0}^{1}$ the $\mathbb{Z}$-linear basis of the underlying $\mathbb{Z}$-module of $C\left(K_{n}\right)^{\vee}$ dual to $\left(\left(e_{i, j, b}\right)_{i, j=1}^{n}\right)_{b=0}^{1}$, which coincides with the image of the canonical basis $\left(\left(E_{i, j, b}\right)_{i, j=1}^{n}\right)_{b=0}^{1}$ of $\operatorname{End}(V) \times \operatorname{End}\left(V^{\vee}\right)$. For any $(i, j, b) \in \mathbb{N}^{3}$ with $1 \leq i, j \leq n$ and $b \leq 1$, we have $\left|\delta_{i, j, b}\right|_{C\left(K_{n}\right)^{\vee}}=\left|E_{i, j, b}\right|_{M(n, S, \infty)}=1$ by Lemma 5 and the fact from the classical $p$ adic analysis that the second dual embedding $M(n, S, \infty) \rightarrow \underline{\operatorname{Hom}}_{S}\left(\underline{\operatorname{Hom}}_{S}(M(n, S, \infty), S), S\right)$ is an isometry.

Let $a \in C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}$. By Lemma 10, we have

$$
|a|_{C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}} \geq\left|\iota_{S, \infty}(a)\right|_{M(n, S, \infty)} .
$$

By $a=\sum_{b=0}^{1} \sum_{i, j=1}^{n} a\left(e_{i, j, b}\right) \delta_{i, j, b}$, we obtain

$$

|a|_{C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}} & =\left|\sum_{b=0}^{1} \sum_{i, j=1}^{n} a\left(e_{i, j, b}\right) \delta_{i, j, b}\right|_{C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}} \\
& \leq \|\left(\left\|\left(\left|a\left(e_{i, j, b}\right) \delta_{i, j, b}\right|_{\left.C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}\right)}^{n} i_{i, j=1} \|_{\{1, \ldots, n\}^{2}, 1}\right)_{b=0}^{1}\right\|_{\{0,1\}, 1}\right. \\
& =\|\left(\left\|\left(\left|a\left(e_{i, j, b}\right)_{i, j, b}\right|_{\left.C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}\right)}^{n}{ }_{i, j=1} \|_{\infty}\right)_{b=0}^{1}\right\|_{\infty}\right. \\
& =\|\left(\|\left(\left|a\left(e_{i, j, b}\right)\right|_{S}\left|\delta_{i, j, b} \otimes 1\right|_{\left.\left.C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}\right)_{i, j=1}^{n} \|_{\infty}\right)_{b=0}^{1} \|_{\infty}}\right.\right. \\
& \leq\left\|\left(\left\|\left(\left.\left|a\left(e_{i, j, b}\right)\right|_{S}\left|\delta_{i, j, b}\right|\right|_{o p}| |_{p}\right)_{i, j=1}^{n}\right\|_{\infty}\right)_{b=0}^{1}\right\|_{\infty} \\
& \leq\left\|\left(\left\|\left(\left|a\left(e_{i, j, b}\right)\right|_{S}\right)_{i, j=1}^{n}\right\|_{\infty}\right)_{b=0}^{1}\right\|_{\infty} \\
& =\left|\left(\sum_{i, j=1}^{n} a\left(e_{i, j, 0}\right) E_{i, j, 0}, \sum_{i, j=1}^{n} a\left(e_{i, j, 1}\right) E_{i, j, 1}\right)\right|_{M(n, S, \infty)} \\
& =\left|\iota_{S, \infty}(a)\right|_{M(n, S, \infty)}
\end{aligned}
$$

by Lemma 7. It implies $|a|_{C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}}=\left|\iota_{S, \infty}(a)\right|_{M(n, S, \infty)}$ Therefore $\iota_{S, \infty}$ is isometric. By

$$

\operatorname{dim}_{\mathbb{Q}_{p}}\left(C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}\right) & =\operatorname{dim}_{\mathbb{Q}_{p}}\left(\operatorname{End}\left(\mathbb{Z}^{n}\right)^{\vee \vee} \otimes_{\mathbb{Z}} \mathbb{Q}_{p}\right)=2 n^{2} \\
& =\operatorname{dim}_{\mathbb{Q}_{p}}\left(\operatorname{End}_{\mathbb{Q}_{p}}\left(\mathbb{Q}_{p}^{n}\right)^{2}\right)=\operatorname{dim}_{\mathbb{Q}_{p}}(M(n, S, \infty)),
\end{aligned}
$$

$\iota_{S, \infty}$ is bijective.
Lemma 12. When $S=\left(\mathbb{Q}_{p},|\cdot|_{\infty}, 1\right)$, an $a \in C\left(K_{n}\right)^{\vee} \otimes \mathbf{Q}_{p}$ satisfies $|a(c)|_{S} \leq|c|_{C\left(K_{n}\right)^{\vee}}$ for any $c \in C\left(K_{n}\right)$ if and only if $\left|\iota_{S, \infty}(a)\right|_{M(n, S, \infty)} \leq 1$.
Proof. The opposite implication follows from the same argument as the proof of Lemma 9 except we apply Lemma 11 instead of Lemma 8 and use $p_{\mathbf{Q}_{p}}=(1,1)$ instead of $p_{\mathbf{R}}=(2,1)$. Suppose $\left|\iota_{S, \infty}(a)\right|_{M(n, S, \infty)}>1$. Since the norm of $M(n, S, \infty)$ coincides with the $\ell^{\infty}$ norm of entries, there exists an $(i, j, b) \in \mathbb{N}^{3}$ with $1 \leq i, j \leq n$ and $b \leq 1$ such that the $(i, j, b)$ the entry of $\left.\iota_{S, \infty}(a)\right|_{M(n, S, \infty)}$, which coincides with $a\left(e_{i, j, b}\right)$ by the definition of $\iota_{S, \infty}$, is of $p$-adic norm $>1$. Put $c:=e_{i, j, b} \in C\left(K_{n}\right)$. We have $|a(c)|_{p}>1=|c|_{C\left(K_{n}\right)}$ by Proposition 21.

Proof of Proposition 25. By

$$
\operatorname{GL}_{n}\left(\mathbb{Z}_{p}\right)=\left\{\left.U \in \mathrm{GL}_{n}\left(\mathbb{Q}_{p}\right)| | U\right|_{\operatorname{End}_{S}\left(S_{\ell}^{n}\right)}=\left|U^{-1}\right|_{\operatorname{End}_{S}\left(S_{\ell}^{n}\right)}=1\right\},
$$

the assertion immediately follows from Proposition 16, Lemma 11, and Lemma 12.
