# $A_{\infty}$ RELATIONS IN ORIENTOR CALCULUS ON MODULI OF STABLE DISK MAPS 

OR KEDAR AND JAKE P. SOLOMON


#### Abstract

Let $L \subset X$ be a not necessarily orientable relatively Pin Lagrangian submanifold in a symplectic manifold $X$. Evaluation maps of moduli spaces of $J$ holomorphic disks with boundary in $L$ may not be relatively orientable. To deal with this problem, we introduce the notion of an orientor. Interactions between the natural operations on orientors are governed by orientor calculus. Orientor calculus gives rise to a family of orientors on moduli spaces of $J$-holomorphic stable disk maps with boundary in $L$ that satisfy natural relations. In a sequel, we use these orientors and relations to construct the Fukaya $A_{\infty}$ algebra of $L$.

## 1. Introduction

1.1. Overview. Let $L \subset X$ be a not necessarily orientable relatively $P i n^{ \pm}$Lagrangian submanifold in a symplectic manifold $(X, \omega)$. It is of fundamental importance in symplectic geometry to associate to $L$ a Fukaya $A_{\infty}$ algebra, which encodes the geometry of the moduli space of $J$-holomorphic stable disk maps with boundary in $L$. Previous work in the non-orientable case is limited, and in particular, it applies only over fields of characteristic 2 or when $L$ is orientable relative to a local system on $X$. See Section 1.2. The present paper and its sequel [26] construct a Fukaya $A_{\infty}$ algebra for $L$ over the field $\mathbb{R}$ in a way that does not require $L$ to be orientable.

The main difficulty in our construction is the relative non-orientability of the evaluation maps of moduli spaces of $J$-holomorphic stable disk maps with boundary in $L$. This leads us to introduce the notion of an orientor of a map between manifolds, to which the present paper is devoted. To use orientors effectively, we first study the properties of pull-back orientors and induced orientors on boundaries and quotients. These properties are then used to construct a family of orientors $Q_{k, l}^{\beta}$ of the evaluation maps of moduli spaces of
$J$-holomorphic stable disk maps with $k+1$ boundary marked points and $l$ interior marked points. The orientors $Q_{k, l}^{\beta}$ satisfy a series of equations resembling the $A_{\infty}$ relations and the cyclic property of the structure of maps of an $A_{\infty}$ algebra. See Theorems 目 3and 4. The orientors $Q_{k, l}^{\beta}$ for $\beta$ fixed and $k, l$, varying are related by forgetful maps, as formulated in Theorem 2. In [26] we establish relevant properties of pushforward of differential forms along an orientor and use the orientors $Q_{k, l}^{\beta}$ to construct a cyclic unital $A_{\infty}$ algebra structure on differential forms on $L$ with values in a local system of rings. We expect that the orientors $Q_{k, l}^{\beta}$ can also be used to construct $A_{\infty}$ algebra structures on the Morse or singular co-chains of $L$. Furthermore, we expect the orientors $Q_{k, l}^{\beta}$ can be generalized to construct from $L$ an object of the Fukaya category of $X$.

Building on the work of [28, 40, 43, 42], we plan to use the $A_{\infty}$ algebra of $L$ to define open Gromov-Witten invariants for $L$ and to study the structure of these invariants. When $L$ is fixed by an anti-symplectic involution, and $\operatorname{dim} L=2$, we expect the open Gromov-Witten invariants of $L$ to recover Welschinger's real enumerative invariants 44]. When $\operatorname{dim} L>2$ or when $L$ is not fixed by anti-symplectic involution, it appears that $A_{\infty}$ algebra of $L$ plays an essential role in the definition of invariants.

Lagrangian submanifolds arise naturally as the real points of smooth complex projective varieties that are invariant under complex conjugation. Natural constructions in algebraic geometry, such as blowups and quotients, give rise to non-orientable Lagrangians. Examples of computations of open Gromov-Witten-Welschinger invariants for non-orientable Lagrangian submanifolds of dimension 2 appear in [14, 15, 16, 17, 18, 19, 20, 21, 22, 23].
1.2. Previous developments. In [7], a construction of the Fukaya $A_{\infty}$ algebra structure on a version of singular chains of $L$ with $\mathbb{Q}$ coefficients is provided when $L$ is orientable. In [8], the construction of the Fukaya $A_{\infty}$ algebra structure on singular chains is extended to the non-orientable case when $X$ is spherically positive, using coefficients in $\mathbb{Z} / 2$. The spherically positive assumption is used to force stable maps with automorphisms into sufficiently high codimension that they do not lead to denominators when pushing-forward chains by the evaluation maps of moduli spaces. Since the order of automorphism groups can be even, such denominators are not allowable when working with $\mathbb{Z} / 2$ coefficients. However, for planned applications to open Gromov-Witten theory, it is essential to work over a field of characteristic zero.

Given a local system of 1-dimensional vector spaces $\mathcal{T}$ on $X$, it should be possible to construct a version of the Fukaya category in which objects arise from Lagrangian submanifolds $L \subset X$ that are relatively oriented with respect to $\mathcal{T}$. By relative orientation, we mean an isomorphism from $\left.\mathcal{T}\right|_{L}$ to the orientation local system of $L$. In 35], such a construction is carried out when the first Chern class $c_{1}(X)$ is 2 -torsion, for a local system $\mathcal{T}$ that arises naturally in the context of gradings. The relative orientation of $L$ with respect to $\mathcal{T}$ forces the Maslov index $\mu: H_{2}(X, L) \rightarrow \mathbb{Z}$ to take on only even values. It follows that the evaluation maps of moduli spaces of $J$-holomorphic disks are relatively orientable [38], so the main difficulties in the construction of the present work do not arise.

In the construction of Floer homology for two orientable Lagrangians $L_{1}, L_{2}$, that intersect cleanly given in [7, Section 3.7.5], a local system arises when the intersection $L_{1} \cap L_{2}$ is not orientable. The symplectic topology of non-orientable Lagrangians has been studied extensively in [2, 3, 4, 11, 31, 30, 33, 34, 36, 37].
1.3. Orientors. Fix a commutative ring $\mathbb{A}$. Throughout the paper, a local system of graded $\mathbb{A}$-modules will be called simply a local system. For a graded $\mathbb{A}$-module $V$ and an
orbifold with corners $M$, denote by $\underline{V}$ the globally constant sheaf over $M$ with fiber $V$. Moreover, write $\widetilde{M}$ for the orientation double cover of $M$, considered as a $\mathbb{Z} / 2$ principle bundle. For a map $f: M \rightarrow P$, define

$$
\mathcal{K}_{f}:=\operatorname{hom}_{\mathbb{Z} / 2}\left(\widetilde{M}, f^{*} \widetilde{P}\right) \times_{\mathbb{Z} / 2} \mathbb{A} .
$$

In other words, $\mathcal{K}_{f}$ is the relative orientation local system of $f$, concentrated in degree $-\operatorname{dim} M+\operatorname{dim} P$. Let $Q, K$ be local systems over $M, P$, respectively. An $f$-orientor $F$ of $Q$ to $K$ is a morphism

F: Q \rightarrow \mathcal{K}_{f} \otimes f^{*} K
$$

A few examples of orientors are in place. A relative orientation $\mathcal{O}^{f}$ of $f$ may be regarded as an $f$-orientor $\varphi^{\mathcal{O}^{f}}$ of $\underline{\mathbb{A}}$ to $\underline{\mathbb{A}}$. See Definition 3.3. Any morphism of local systems over $M$ is an $\operatorname{Id}_{M}$-orientor.

We list a few important operations on orientors. The precise statements appear in Section 3.1, If $g: P \rightarrow N$ is another smooth map, $R$ is a local system over $N$ and $G$ is a $g$-orientor of $K$ to $R$, then $F, G$ may be composed into a $g \circ f$-orientor $G \bullet F$ of $Q$ to $R$ as in Definition 3.7. The composition is associative, as shown in Lemma 3.8, If $A, B$ are local systems over $P$, the orientor $F$ extends to an $f$-orientor ${ }^{A} F^{B}$ of $f^{*} A \otimes Q \otimes f^{*} B$ to $A \otimes Q \otimes B$. If $f$ is a relatively oriented map, with relative orientation $\mathcal{O}^{f}$, then $G$ may be pulled back to a $g \circ f$-orientor denoted $\left(f, \mathcal{O}^{f}\right)^{\circ} G$, given by

\left(f, \mathcal{O}^{f}\right)^{\diamond} G=G \bullet \varphi^{\mathcal{O}^{f}}
$$

See Definition 3.11. Moreover, consider a pullback diagram of orbifolds as follows.


A $g$-orientor $G$ may be pulled back to a $q$-orientor denoted $(r / f)^{\triangleright} G$ as in Definition 3.17. Finally, if $g: P \rightarrow M$ and $B \subset \partial_{g} P \xrightarrow{\iota} P$ is a closed and open subset of the vertical boundary of $P$ relative to $g$, there exists an $\left.\iota\right|_{B}$-orientor $\partial_{g}$, which induces a notion of boundary of a $g$-orientor $G$, which is the $\left.g \circ \ell\right|_{B \text {-orientor } \partial G \text {, given by }}$

(-1)^{|G|} G \bullet \partial_{g} .

See Definition 3.44.
1.4. Orientors for moduli spaces of stable maps. Let $(X, \omega)$ be a symplectic manifold and $L \subset X$ be a connected relatively $\operatorname{Pin}^{ \pm}$Lagrangian. Let $\mathfrak{p}$ be a relative $\operatorname{Pin}^{ \pm}$ structure on $L$. Denote by $\mu: H_{2}(X, L ; \mathbb{Z}) \rightarrow \mathbb{Z}$ the Maslov index. See [1] for a review on the Maslov index. Denote by $\omega: H_{2}(X, L ; \mathbb{Z}) \rightarrow \mathbb{R}$ the symplectic volume. Let $J$ be an $\omega$-tame complex structure on $X$. Let $\Pi$ be a quotient of $H_{2}(X, L ; \mathbb{Z})$ by a possibly trivial subgroup contained in the kernel of the map $\mu \oplus \omega: H_{2}(X, L ; \mathbb{Z}) \rightarrow \mathbb{Z} \oplus \mathbb{R}$. Thus, the homomorphisms $\mu, \omega$ descend to $\Pi$. Denote by $\beta_{0} \in \Pi$ the zero element.
In fact, throughout the paper we work in a generalized setting of a symplectic fibration $\pi^{X}: X \rightarrow \Omega$ over a manifold with corners $\Omega$ and a relatively Pin $^{ \pm}$exact Lagrangian subfibration $L \subset X$. The group $\Pi$ is generalized accordingly. See Section 4.2 for details. The freedom of having arbitrary $\Omega$ allows, among others, a natural construction of pseudoisotopies of $A_{\infty}$ algebras as well as higher pseudoisotopies. Allowing general $\Omega$ should also prove useful in the context Lefschetz fibrations as developed, for example, in 35].

In what follows, one may assume that $\Omega$ is a point. Occasionally, we clarify in parentheses what is meant in the case of general $\Omega$. Let $\pi^{L}:=\left.\pi^{X}\right|_{L}: L \rightarrow \Omega$, and denote by $\mathcal{L}_{L}$ the relative orientation local system of $\pi^{L}$ concentrated in degree -1 . Set

$$
\mathcal{R}_{L}:=\bigoplus_{j \in \mathbb{Z}} \mathcal{L}_{L}^{\otimes j}
$$

Here, negative powers correspond to the dual local system. Denote by

$$
m: \mathcal{R}_{L} \otimes \mathcal{R}_{L} \rightarrow \mathcal{R}_{L}, \quad 1_{L}: \underline{\mathbb{A}} \rightarrow \mathcal{R}_{L}
$$

the tensor product and the inclusion in degree 0 , respectively, which provide $\mathcal{R}_{L}$ the structure of a local system of unital graded non-commutative $\mathbb{A}$-algebras.

Let $(k, l, \beta) \in \mathbb{Z}_{\geq-1} \times \mathbb{Z}_{\geq 0} \times \Pi$. Let $J$ be an $\omega$-tame (vertical) almost complex structure on $X$. Denote by $\mathcal{M}_{k+1, l}(\beta):=\mathcal{M}_{k+1, l}(X, L, J, \beta)$ the moduli space of (vertical) $J$ holomorphic genus-zero stable maps with boundary, of degree $\beta$, with $k+1$ boundary marked points and $l$ interior marked points. For $0 \leq i \leq k$, denote by

$$
e v b_{i}^{(k, l, \beta)}: \mathcal{M}_{k+1, l}(\beta) \rightarrow L
$$

the evaluation at the $i$ th boundary point. We often omit part or all of the superscripts $(k, l, \beta)$ when they are clear from the context. By vertical stable map, we mean a map that maps entirely to one fiber of $\pi^{X}: X \rightarrow \Omega$, that is, whose composition with $\pi^{X}: X \rightarrow \Omega$ is constant. So, we obtain a map

$$
\pi^{\mathcal{M}_{k+1, l}(\beta)}: \mathcal{M}_{k+1, l}(\beta) \rightarrow \Omega
$$

that forgets everything except the fiber of $\pi^{X}: X \rightarrow \Omega$ to which a vertical $J$-holomorphic stable map maps. To streamline the exposition, we will assume that $\mathcal{M}_{k+1, l}(\beta)$ is a smooth orbifold with corners and $e v b_{0}^{\beta}$ is a submersion. These assumptions hold in a range of important examples [40, Example 1.5]. Our construction of $e v b_{0}$-orientors applies to arbitrary symplectic manifolds and Lagrangian submanifolds by the theory of the virtual fundamental class being developed by several authors [5, 9, 10, 12, 13] as explained in Section 4.2. The orientor analogs of the unit and divisor axioms of GromovWitten theory given in Theorem 2 require compatibility of the virtual fundamental class with the forgetful map of interior marked points. This has not yet been fully worked out in the Kuranishi structure formalism.

Set

$$
\begin{gathered}

In Section 6.1, we construct a family of maps covering $e v b_{0}^{(k, l, \beta)}$ of $E_{L}^{k}$ to $\mathcal{R}_{L}$ of degree $2-k-2 l$

Q_{k, l}^{\beta}:=Q_{k, l}^{(X, L, J ; \beta)}: E_{L}^{k} \rightarrow \mathcal{K}_{e v b_{0}} \otimes\left(e v b_{0}\right)^{*} \mathcal{R}_{L}

indexed by

(k, l, \beta) \in\left(\mathbb{Z}_{\geq 0} \times \mathbb{Z}_{\geq 0} \times \Pi\right) \backslash\left\{\left(0,0, \beta_{0}\right),\left(1,0, \beta_{0}\right),\left(2,0, \beta_{0}\right),\left(0,1, \beta_{0}\right)\right\}
$$

In the exceptional cases, the moduli spaces are empty. These orientors are used in [26] to construct operators $\mathfrak{m}_{k}$ which give an $A_{\infty}$ deformation of the differential graded algebra of differential forms on $L$ with values in $\mathcal{R}_{L}$ when $\mathbb{A}$ is an $\mathbb{R}$-algebra. Similar arguments should allow the construction of $A_{\infty}$ algebras deforming the Morse or singular co-chain
complex of $L$ with $\mathcal{R}_{L}$ local coefficients. The orientors $Q_{k, l}^{\beta}$ are surjective for $k \geq 1$ and injective for $k=0,1$. Moreover, we prove the following theorems.

Let $k \geq-1, l \geq 0, \beta \in \Pi$. Let $\partial \mathcal{M}_{k+1, l}(\beta)$ denote the boundary and denote by $\iota: \partial \mathcal{M}_{k+1, l}(\beta) \rightarrow \mathcal{M}_{k+1, l}(\beta)$ the canonical map. Fix partitions $k_{1}+k_{2}=k+1, \beta_{1}+\beta_{2}=\beta$ and $I \dot{\cup} J=[l]$, such that $k_{1}>0$ if $k \geq 0$. When $k \geq 0$, let $0<i \leq k_{1}$. When $k=-1$ let $i=0$. Let $B_{i, k_{1}, k_{2}, I, J}\left(\beta_{1}, \beta_{2}\right) \subset \partial \mathcal{M}_{k+1, l}(\beta)$ denote the closure of the locus of two component stable maps, described as follows. One component has degree $\beta_{1}$ and the other component has degree $\beta_{2}$. The first component carries the boundary marked points labeled $0, \ldots, i-1, i+k_{2}, \ldots, k$, and the interior marked points labeled by $I$. The second component carries the boundary marked points labeled $i, \ldots, i+k_{2}-1$ and the interior marked points labeled by $J$. The two components are joined at the $i$ th boundary marked point on the first component and the 0th boundary marked point on the second. There exists a canonical local diffeomorphism, called the gluing map,

\vartheta_{i, k_{1}, k_{2}, \beta_{1}, \beta_{2}, I, J}: \mathcal{M}_{k_{1}+1, I}\left(\beta_{1}\right)_{e v b_{i}^{\beta_{1}}} \times_{e v b_{0}^{\beta_{2}}} \mathcal{M}_{k_{2}+1, J}\left(\beta_{2}\right) \rightarrow B_{i, k_{1}, k_{2}, I, J}\left(\beta_{1}, \beta_{2}\right),
$$

which we abbreviate as $\vartheta$. Denote by $\mathcal{O}_{c}^{\vartheta}$ the canonical relative orientation of $\vartheta$ as a local diffeomorphism. Denote by $p_{1}, p_{2}$ the projections on the first and second factors of the fiber product, respectively.

Theorem 1. Let $k, l \geq 0$ and $\beta \in \Pi$. Let $k_{1}, k_{2} \geq 0$ be such that $k_{1}+k_{2}=k+1$, let $I \dot{U} J=[l]$ and let $\beta_{1}+\beta_{2}=\beta$. Set

The following equation of $\left(e v b_{0}^{\beta} \circ \iota \circ \vartheta\right)$-orientors of $\vartheta^{*} \iota^{*} e v^{\beta^{*}}\left(\underset{j=1}{\underset{j}{k}} \mathcal{R}_{L}\right)$ to $\mathcal{R}_{L}$ holds.

Here,

where $\delta \in\{0,1\}$ is 0 if exactly when $\mathfrak{p}$ is a relative $\mathrm{Pin}^{+}$structure.

Theorem 1 is proven in Section 6.3. The theorem can be visualized in the following diagram. An arrow corresponding to a map $f$ and an $f$-orientor $F$ is labeled by a vector
$\binom{F}{f}$.

Proposition 1. In case $(k, l, \beta) \in\left\{\left(2,0, \beta_{0}\right),\left(0,1, \beta_{0}\right)\right\}$, the map

is a diffeomorphism, and we have

The proof of Proposition 1 is immediate from Lemma 6.17.
Extend the indices of the boundary marked points to $\mathbb{Z}$ cyclicly. In particular, $e v b_{k+1}=$ $e v b_{0}$. Let $c_{i j}:\left(e v b_{j}\right)^{*} \mathcal{R}_{L} \rightarrow\left(e v b_{i}\right)^{*} \mathcal{R}_{L}$ be the isomorphism arising from parallel transport along the boundary of the disk in the direction of the orientation induced from the complex orientation. See Definition 5.3 for details. Let $F i:=F i_{k+1, l}^{\beta}: \mathcal{M}_{k+1, l+1}(\beta) \rightarrow$ $\mathcal{M}_{k+1, l}(\beta)$ denote the map that forgets the $l+1$ st interior marked point, and stabilizes the resulting map. Similarly, let $F b:=F b_{k+1, l}^{\beta}: \mathcal{M}_{k+2, l}(\beta) \rightarrow \mathcal{M}_{k+1, l}(\beta)$ denote the map that forgets the $k+1$ st boundary marked point, and stabilizes the resulting map. The maps $F i, F b$, have canonical relative orientations $\mathcal{O}^{F i}, \mathcal{O}^{F b}$, respectively. See Definition 5.11 and Remark 5.12.

Theorem 2. Let $k \geq-1, l \geq 0$ and $\beta \in \Pi$. The following equation of evb ${ }_{0}^{l+1}$-orientors holds.

Additionally, for $k \geq 0$, the following equation of evb ${ }_{0}^{k+1}$-orientors of $E^{k+1}$ to $\mathcal{R}$ holds.

Q_{k+1, l}^{\beta}=m \bullet\left(\left(F b_{k+1, l}\right)^{\diamond} Q_{k, l}^{\beta}\right)^{\mathcal{R}} \bullet F b^{*} E^{k}\left(c_{k+2, k+1}\right)

Theorem 2 is proven in Remark 6.19,
Let $\mathbb{E}_{L}:=\pi_{*}^{L} \mathcal{R}_{L}$ the sheaf pushforward along $\pi^{L}$, considered as a local system over $\Omega$. We construct a surjective $L$-orientor of $\mathcal{R}_{L}$ to $\mathbb{E}_{L}$ of degree $1-n$,

O:=O^{L}: \mathcal{R}_{L} \rightarrow \mathcal{K}_{L} \otimes\left(\pi^{L}\right)^{*} \mathbb{E}_{L}

Informally, $O$ splits off one copy of $\mathcal{L}_{L}$, shifts it by degree $1-n$ to $\mathcal{K}_{L}$, and maps the remaining tensor products to $\mathbb{E}_{L}$ depending on whether they admit a (vertical) section. See Definition 6.13 for the precise definition. Denote by $O_{\text {odd }}$ the map that equals to $O$ on the odd parts of $\mathcal{R}_{L}$ and vanishes on the even parts of $\mathcal{R}_{L}$. The orientors $O, O_{\text {odd }}$ are used to define integration of forms on $L$ with values in $\mathcal{R}_{L}$. In particular, $O_{\text {odd }}$ is used to define the cyclic structure on the $A_{\infty}$ algebra in [26, Section 5].

Denote by $f: \mathcal{M}_{k+1, l}(\beta) \rightarrow \mathcal{M}_{k+1, l}(\beta)$ the map that cyclicly shifts the boundary points $\left(z_{0}, \ldots, z_{k}\right)$ as follows $z_{k} \rightarrow z_{k-1} \rightarrow \cdots \rightarrow z_{0} \rightarrow z_{k}$. The map $f$ is a diffeomorphism. Set

e v^{c y c}:=\left(e v b_{1}, \ldots, e v b_{k}, e v b_{0}\right): \mathcal{M}_{k+1, l}(\beta) \rightarrow \underbrace{L \times_{\Omega} \cdots \times_{\Omega} L}_{k+1 \text { times }}, \\
E^{c y c}:=\left(e v^{c y c}\right)^{*} \mathcal{R}_{L}^{\boxtimes k+1} .
\end{gathered}
$$

Let $T$ be the $f$-orientor of $E^{c y c}$ to $E^{c y c}$ given as follows.

$$
T\left(a_{0} \otimes \ldots \otimes a_{k} \otimes\right)=(-1)^{\left|a_{0}\right| \cdot \sum_{j=1}^{k}\left|\alpha_{j}\right|} \mathcal{O}_{c}^{f} \otimes a_{1} \otimes \cdots \otimes a_{k} \otimes a_{0}
$$

where $\mathcal{O}_{c}^{f}$ is the canonical relative orientation of $f$ as a local diffeomorphism. See Section 2.4.1.

Theorem 3. The following equation of $\pi^{\mathcal{M}_{k+1, l}(\beta)}$-orientors of $E^{c y c}$ to $\mathbb{E}_{L}$ holds.

O_{o d d} \bullet m \bullet\left(Q_{k, l}^{\beta} \otimes I d\right) \bullet T=(-1)^{k} O_{o d d} \bullet m \bullet\left(Q_{k, l}^{\beta} \otimes I d\right)

Theorem 3 is proven in Section 6.5. The theorem can be visualized in the following diagram.

In Section 6.1, we construct a family of $\pi^{\mathcal{M}_{0, l}(\beta)}$-orientors of $\underline{\mathbb{A}}$ to $\mathbb{E}_{L}$ of degree $4-n-2 l$

In the exceptional cases, the moduli spaces are empty. In [26] these orientors are used to construct an element of the Novikov ring $\mathfrak{m}_{-1}$ and the following theorem gives rise to a relation involving $\mathfrak{m}_{-1}$, the cyclic pairing and $\mathfrak{m}_{0}$. In the case that $L$ is orientable, the element $\mathfrak{m}_{-1}$ plays an important role in the definition of open Gromov-Witten invariants given in [6, 40]. We plan to use the element $\mathfrak{m}_{-1}$ defined here along with the $A_{\infty}$ structure to define open Gromov-Witten invariants for non-orientable $L$.

Fix $l \geq 0$ and $\beta \in \Pi$. Fix partitions $\beta_{1}+\beta_{2}=\beta$ and $I \dot{\cup} J=[l]$. Recall the boundary component $B_{-1, I, J}\left(\beta_{1}, \beta_{2}\right):=B_{0,0,0, I, J}\left(\beta_{1}, \beta_{2}\right) \subset \partial \mathcal{M}_{0, l}(\beta)$, and the gluing map $\vartheta: \mathcal{M}_{1, I}\left(\beta_{1}\right)_{\text {evb }}^{0}{ }_{0}^{\beta_{1}} \times{ }_{\text {evb }}^{\beta_{2}} \mathcal{M}_{1, J}\left(\beta_{2}\right) \rightarrow B_{-1, I, J}\left(\beta_{1}, \beta_{2}\right)$. Let $\mathcal{O}_{c}^{\vartheta}$ denote the canonical relative orientation of $\vartheta$ as a local diffeomorphism. Let $\pi^{\mathcal{M}_{0, I}\left(\beta_{1}\right) \times_{L} \mathcal{M}_{0, J}\left(\beta_{2}\right)}$ denote the composition of $\pi^{L}$ and the canonical map $\mathcal{M}_{0, I}\left(\beta_{1}\right) \times_{L} \mathcal{M}_{0, J}\left(\beta_{2}\right) \rightarrow L$ given by the fiber product.

Theorem 4. Let $l \geq 0$ and $\beta \in \Pi$. Let $I \dot{\cup} J=[l]$ and $\beta_{1}+\beta_{2}=\beta$. The following equation of $\pi^{\mathcal{M}_{0, I}\left(\beta_{1}\right) \times{ }_{L} \mathcal{M}_{0, J}\left(\beta_{2}\right)}$-endo-orientors of $\mathbb{A}$ holds.

Theorem 4 is proven in Section 6.4. The theorem can be visualized in the following diagram.

1.5. Base change. Recall that our results hold for a general symplectic fibration $\pi^{X}$ : $X \rightarrow \Omega$ and an exact relatively $\operatorname{Pin}^{ \pm}$Lagrangian subfibration, with an appropriate group $\Pi$ to which the degrees of stable maps belong. Fix a smooth map $\xi: \Omega^{\prime} \rightarrow \Omega$. For any submersion $\pi^{M}: M \rightarrow \Omega$ we abbreviate $\xi^{*} M:=\Omega^{\prime}{ }_{\xi} \times_{\pi^{M}} M$, so we have a pullback diagram as follows.


It holds that $\pi^{\xi^{*} X}: \xi^{*} X \rightarrow \Omega^{\prime}$ is a symplectic fibration, and $\xi^{*} L \subset \xi^{*} X$ is a relatively $\operatorname{Pin}^{ \pm}$exact Lagrangian subfibration. See Corollary 4.6, Moreover, there exist canonical identifications

\xi^{*} \mathcal{M}_{k+1, l}(X, L, J, \beta) \simeq \mathcal{M}_{k+1, l}\left(\xi^{*} X, \xi^{*} L, \xi^{*} J, \beta\right)

that respect the evaluation maps $e v b_{i}, e v i_{j}$ and the maps $F b, F i, f$.
According to Definition 2.32 applied to diagram (1.1) with $M=L$, there exists a canonical isomorphism of local systems of $\mathbb{A}$-algebras

We think of $\xi_{\mathcal{R}}^{\star}$ and $\xi_{\mathbb{E}}^{\star}$ as $\operatorname{Id}_{\xi^{*} L}$ and $\operatorname{Id}_{\Omega^{\prime}}$ orientors, respectively.
Proposition 2. With the above notations, the following diagram is commutative.


That is, the following equation of $\pi^{\xi^{*} L}$-orientors holds.

Let $k \geq 0, l \geq 0$ and $\beta \in \Pi$. Abbreviate

We think of $\xi_{E}^{\star}$ as an $\mathrm{Id}_{\mathcal{M}^{\prime}}$-orientor.
Theorem 5. The following diagram is commutative.

& \mathcal{K}_{e v b_{0}^{\Omega^{\prime}}} \otimes \xi^{\mathcal{M}^{*}}\left(e v b_{0}^{\Omega}\right)^{*} \mathcal{R}_{L} \xrightarrow[1 \otimes e v b_{0}^{*}\left(\xi_{\mathcal{R}}^{*}\right)]{ } \mathcal{K}_{e v b_{0}^{\Omega^{\prime}}} \otimes\left(e v b_{0}^{\Omega^{\prime}}\right)^{*} \mathcal{R}_{\xi^{*} L}
\end{aligned}

That is, the following equation of orientors holds.

Moreover, the following diagram is commutative.


That is, the following equation of orientors holds.

\xi_{\mathbb{E}}^{\star} \bullet \xi^{\diamond} Q_{-1, l}^{(X, L, J ; \beta)}=Q_{-1, l}^{\left(\xi^{*} X, \xi^{*} L, \xi^{*} J ; \beta\right)}

Theorem 5 and Proposition 2 are proven in Section 6.6.
1.6. Outline. In Section 2 we review algebraic notations, orbifolds background and orientation conventions. Section 3 develops the general theory of orientors and orientor calculus. Section 4 is devoted to the discussion of families of Lagrangian submanifolds in symplectic manifolds and related moduli spaces of stable maps. Sections 5.1 5.4 construct basic $e v b_{0}^{\beta}$-orientors and state relations between them for different triplets $(k, l, \beta)$. The proofs of these relations appear in Sections 5.5) [5.8. Section 6 builds on the results of Section 5 and extends the basic $e v b_{0}^{\beta}$-orientors to $e v b_{0}^{\beta}$-orientors which resemble $A_{\infty}$ operators.

## 2. Conventions

2.1. Notations. In the following sections we work in the category of orbifolds with corners, indicated by the Latin capital letters $M, N, P, X, Y$, and smooth amps between them, indicated by $f, g, h$ etc. For a comprehensive guide for the category of orbifolds with corners, we recommend [41]. Throughout this paper, we fix a commutative ring $\mathbb{A}$.
Notation 2.1 (Abuse of notation in equations of natural numbers). Let $M, N$ be manifolds and $f: M \rightarrow N$ be a smooth map. Let $Q, S$ be graded local systems over $M$ and let $F: Q \rightarrow S$ be a morphism of degree $\operatorname{deg} F$ and let $q \in Q$ be of degree $\operatorname{deg} q$. As stated in the introduction, a local system of graded $\mathbb{A}$-modules will be referred to as a local system. A morphism of local systems might be referred to as a map. Let $\alpha \in A(M ; Q)$ be a differential form. Let $\beta$ be a homology class of a symplectic manifold $X$ relative to a Lagrangian $L$. In integral expressions (mostly used as exponents of the number -1 ):
(a) we write $m$ (or $M$ ) for the dimension of the corresponding capital-letter orbifold $M$;
(b) we write $f$ for $\operatorname{rdim} f=\operatorname{dim} M-\operatorname{dim} N$, the relative dimension of $f$;
(c) we write $q$ for $\operatorname{deg} q$ and we write $F$ for $\operatorname{deg} F$;
(d) we write $\alpha$ for $|\alpha|$ which is the degree of $\alpha$;
(e) we write $\beta$ for the Maslov Index $\mu(\beta)$.
2.2. Graded algebra. Throughout the paper we write $x={ }_{2} y$ to denote $x \equiv y \bmod 2$.

Definition 2.2 (Tensor product). Let $\mathbb{A}$ be a ring. Let $A, B, C, D$ be graded $\mathbb{A}$-modules with valuations (or local systems of graded $\mathbb{A}$-modules over an orbifold with corners). Let $F: A \rightarrow C, G: B \rightarrow D$ be linear maps of degrees $|F|,|G|$. Let $a, b$ be homogeneous elements of $A, B$, respectively.
(a) The sign $\otimes$ means the completed tensor product with respect to the valuations.
(b) The tensor product of differential graded algebras with valuations is again a differential graded algebra with valuation in the standard way. For

a \in A, b \in B
$$

the differential is

$$
d_{A \otimes B}\left(a_{0} \otimes b_{0}\right)=\left(d_{A} a_{0}\right) \otimes b_{0}+(-1)^{a_{0}} a_{0} \otimes d_{B} b_{0}
$$

and for

\left\{a_{i}\right\}_{i=1}^{\infty} \in A,\left\{b_{j}\right\}_{j=1}^{\infty} \in B
$$

the valuation is defined as follows

\nu_{A \otimes B}\left(\sum_{i, j} a_{i} \otimes b_{j}\right)=\inf _{a_{i} \otimes b_{j} \neq 0}\left(\nu\left(a_{i}\right)+\nu\left(b_{j}\right)\right) .
$$

(c) The symmetry isomorphism $\tau_{A, B}$ is given by

$$
A \otimes B \xrightarrow{\tau_{A, B}} B \otimes A, \quad a \otimes b \mapsto(-1)^{a b} b \otimes a .
$$

(d) Tensor product of $\mathbb{A}$-algebras:

If $A, B$ are graded $\mathbb{A}$-algebras (or local systems of graded $\mathbb{A}$-algebras) with multiplication $\left({ }_{A},{ }^{\cdot}{ }_{B}\right)$ then the graded $\mathbb{A}$-algebra $A \otimes B:=A \otimes_{\mathbb{A}} B$ is defined as the graded tensor product, with multiplication

\left(a_{1} \otimes b_{1}\right) \cdot\left(a_{2} \otimes b_{2}\right)=(-1)^{b_{1} a_{2}}\left(a_{1} \cdot A a_{2}\right) \otimes\left(b_{1} \cdot B b_{2}\right) .

(e) Functoriality of tensor product:

The tensor product of two maps is given by

F \otimes G: A \otimes B \rightarrow C \otimes D, \quad F \otimes G(a \otimes b)=(-1)^{|G| a} F a \otimes G b .
$$

Lemma 2.3. Let $A, B, C$ be graded $\mathbb{A}$-modules. Then as maps $A \otimes B \otimes C \rightarrow B \otimes C \otimes A$ the following equation holds.

\tau_{A, B \otimes C}=\left(I d_{B} \otimes \tau_{A, C}\right) \circ\left(\tau_{A, B} \otimes I d\right)
$$

Proof. Let $a \in A, b \in B, c \in C$ be of homogeneous degree. Then

\tau_{A, B \otimes C}(a \otimes b \otimes c)=(-1)^{a(b+c)} b \otimes c \otimes a
$$

and
$\left(\operatorname{Id}_{B} \otimes \tau_{A, C}\right) \circ\left(\tau_{A, B} \otimes \operatorname{Id}\right)(a \otimes b \otimes c)=(-1)^{a b}\left(\operatorname{Id}_{B} \otimes \tau_{A, C}\right)(b \otimes a \otimes c)=(-1)^{a b+a c} b \otimes c \otimes a$.

Proposition 2.4 (Koszul signs). With the previous notation, if $F^{\prime}: C \rightarrow C^{\prime}, G^{\prime}: D \rightarrow D^{\prime}$ are maps leaving $C, D$ respectively, of degrees $\left|F^{\prime}\right|,\left|G^{\prime}\right|$, then

$$
\begin{array}{r}
(G \otimes F) \circ \tau_{A, B}=(-1)^{|F||G|} \tau_{C, D} \circ(F \otimes G) . \\
\left(F^{\prime} \otimes G^{\prime}\right) \circ(F \otimes G)=(-1)^{|F|\left|G^{\prime}\right|}\left(F^{\prime} \circ F\right) \otimes\left(G^{\prime} \circ G\right) . \tag{2.2}
\end{array}
$$

Proof. We evaluate at $a, b \in A \otimes B$. For the first equality, we have

G \otimes F \circ \tau_{A, B}(a \otimes b)=(-1)^{a b} G \otimes F(b \otimes a)=(-1)^{(F+a) b} G b \otimes F a,
$$

and

\tau_{C, D} \circ F \otimes G(a \otimes b)=(-1)^{G a} \tau_{C, D} F a \otimes G b=(-1)^{G a+(F+a)(G+b)} G b \otimes F a .
$$

However,

(F+a) b+G a+(F+a)(G+b)={ }_{2} F G .
$$

For the second equality,

\left(F^{\prime} \otimes G^{\prime}\right) \circ(F \otimes G)(a \otimes b)=(-1)^{G a}\left(F^{\prime} \otimes G^{\prime}\right) F a \otimes G b=(-1)^{G a+G^{\prime}(F+a)} F^{\prime} F a \otimes G^{\prime} G b,
$$ and

$$
\left(F^{\prime} \circ F\right) \otimes\left(G^{\prime} \circ G\right)(a \otimes b)=(-1)^{\left(G^{\prime}+G\right) a} F^{\prime} F a \otimes G^{\prime} G b
$$

However,

G a+G^{\prime}(F+a)+\left(G^{\prime}+G\right) a==_{2} F G^{\prime} .
$$

Definition 2.5. Let $A=\bigoplus_{i \in \mathbb{Z}} A_{i}$ be a graded $\mathbb{A}$-module. The dual space $A^{\vee}$ of $A$ is given by

$$
A^{\vee}:=\bigoplus_{i \in \mathbb{Z}} A_{i}^{\vee},
$$

where $A_{i}^{\vee}$ is the space of linear maps from $A_{i}$ to $\mathbb{A}$. Denote by $\nu_{A}: A \otimes A^{\vee} \rightarrow \mathbb{A}$ the pairing $a \otimes a^{\vee} \rightarrow a^{\vee}(a)$.
Remark 2.6. Treating $\alpha$ as the free module of dimension one over $\mathbb{A}, \mathbb{A}^{\vee} \simeq \mathbb{A}$. The pairing $\mathbb{A} \otimes \mathbb{A}^{\vee} \rightarrow \mathbb{A}$ is an isomorphism.
Definition 2.7. Let $T, K$ be graded $\mathbb{A}$-modules and let $S$ be a graded $\mathbb{A}$-algebra. Assume that $\mu: S \otimes K \rightarrow K$ is a module-structure. We define the left (resp. right) $T$ extension of $\mu$ to be a module-structure of $T \otimes K$ (resp. $K \otimes T$ ) as follows.

$$

{ }^{T} \mu(s \otimes t \otimes k)=(-1)^{s t} t \otimes \mu(s \otimes k), \\
\mu^{T}(s \otimes k \otimes t)=\mu(s \otimes k) \otimes t .

We further define an $S$-module structure on $K^{\vee}$ by

\left(\mu^{\vee}\left(s \otimes v^{\vee}\right)\right) \otimes v=(-1)^{s v^{\vee}} v^{\vee}(\mu(s \otimes v)) .
$$

Definition 2.8. Let $F: X \rightarrow Y$ be a graded linear map. The dual map $F^{\vee}$ of $F$ is the graded linear map

F^{\vee}: Y^{\vee} & \rightarrow X^{\vee} \\
\left(F^{\vee} y^{\vee}\right)(x) & =(-1)^{|F| x \mid} y^{\vee}(F x) .
\end{aligned}
$$

Remark 2.9. Let $F: X \rightarrow Y$ be a graded linear map. Then the following diagram is commutative.


Proof. Use the Koszul signs of Lemma 2.4.
For a set $A$, denote the constant map by $\pi^{A}: A \rightarrow *$. For two sets $A, B$, we denote their product and corresponding projections as follows.


When it causes no confusion, we might write $\pi_{A}, \pi_{B}$ for the projections.
For two lists $B_{1}=\left(v_{1}, \ldots, v_{n}\right), B_{2}=\left(w_{1}, \ldots, w_{m}\right)$, denote by $B_{1} \circ B_{2}$ the concatenation $\left(v_{1}, \ldots, v_{n}, w_{1}, \ldots, w_{m}\right)$.
2.3. Orbifolds with corners. We use the definition of orbifolds with corners from [41. We also use the definitions of smooth maps, strongly smooth maps, boundary and fiber products of orbifolds with corners given there. In particular, for $M$ an orbifold with corners, $\partial M$ is again an orbifold with corners, and it comes with a natural map $\iota_{M}$ : $\partial M \rightarrow M$. In the special case of manifolds with corners, our definition of boundary coincides with [24, Definition 2.6], our smooth maps coincide with weakly smooth maps in [25, Definition 2.1(a)], and our strongly smooth maps are as in [25, Definition 2.1(e)],
which coincides with smooth maps in [24, Definition 3.1]. We say a map of orbifolds is a submersion if it is a strongly smooth submersion in the sense of [41]. In the special case of manifolds with corners, our submersions coincide with submersions in [24, Definition 3.2(iv)] and with strongly smooth horizontal submersions in [, Definition 19(a)]. For a strongly smooth map $f: M \rightarrow N$, we use the notion of vertical boundary $\partial_{f} M \subset \partial M$ defined in [41, Section 2.1.1], which extends to orbifolds with corners the definition of [24, Section 4] for manifolds with corners. We write $\iota_{f}: \partial_{f} M \rightarrow M$ for the restriction of $\iota$ to $\partial_{f} M$. When $f$ is a submersion, the vertical boundary is the fiberwise boundary, that is, $\partial_{f} M=\coprod_{y \in N} \partial\left(f^{-1}(y)\right)$. If $\partial N=\varnothing$, then $\partial_{f} M=\partial M$. A strongly smooth map of orbifolds $f: M \rightarrow N$ induces a strongly smooth map $\left.f\right|_{\partial_{f} M}=f \circ \iota_{f}: \partial_{f} M \rightarrow N$, called the restriction to the vertical boundary. If $f$ is a submersion, then the restriction $\left.f\right|_{\partial_{f} M}$ is also a submersion. As usual, diffeomorphisms are smooth maps with a smooth inverse. We use the notion of transversality from [41, Section 3], which is induced from transversality of maps of manifolds with corners as defined in [24, Definition 6.1]. In particular, any smooth map is transverse to a submersion. Weak fiber products of strongly smooth transverse maps exist by [41, Lemma 5.3]. Below, we omit the adjective 'weak' for brevity.

Extending the definition of corners of [24] to corners over a map, we continue with the following definition.
Definition 2.10 (Vertical corners). Let $r \geq 0$, and write $S_{r}$ for the symmetric group on $r$ elements, the group of bijections $\sigma:\{1, \ldots, r\} \rightarrow\{1, \ldots, r\}$. Let $f: M \rightarrow N$ be a strongly smooth map. By abuse of notation, in the current definition, we also denote by $f$ the restriction of $f$ to $\partial^{r} M$. There is a natural free action of $S_{r}$ on $\partial_{f}^{r} M$ by permuting the order of local vertical boundary components. We define the vertical $r$-corners $C_{f}^{r}(M)$ of $M$ to be

$$
C_{f}^{r}(M):=\partial_{f}^{r} M / S_{r} .
$$

Definition 2.11 (Orbifold over a manifold). Let $\Omega$ be a manifold with corners. An orbifold (resp. manifold) with corners over $\Omega$ is an orbifold (resp. manifold) with corners $A$ and a submersion $\pi^{A}: A \rightarrow \Omega$. An orbifold (resp. manifold) over $\Omega$ is an orbifold (resp. manifold) with corners $A$ and a submersion $\pi^{A}: A \rightarrow \Omega$ with empty vertical boundary $\partial_{\pi^{A}} A=\varnothing$.

Definition 2.12. Let $M \xrightarrow{f} P \xrightarrow{g} N$ be such that $g \circ f$ is a proper submersion. In particular, $g$ is a proper submersion. we say $f$ factorizes through the boundary of $g$ if there exists a map $\iota_{g}^{*} f$ such that the following diagram is a fiber-product.


Remark 2.13. If $f$ is a (proper) submersion, and $f$ factorizes through the boundary of $g$, then $\iota_{g}^{*} f$ is also a (proper) submersion.
Definition 2.14. Let $M$ be a topological space. A subset $M^{\prime} \subset M$ is called essential if it is open, dense and for any $x \in M$ there exists a local basis consisting of open sets $U$ such that the inclusion map $\iota: U \cap M^{\prime} \rightarrow U$ induces a bijection on connected components.

Remark 2.15. If $M$ is locally connected, then the local basis in the above definition may be taken to consist of connected open sets $U$, and thus $U \cap M^{\prime}$ is connected.

Example 2.16. Let $M$ be an orbifold with corners and let $D \subset M$ denote either a suborbifold of codimension $\geq 2$, or the image of the inclusion of the boundary $\iota: \partial M \rightarrow M$. Then $M \backslash D$ is essential.

Definition 2.17. Consider a square diagram of orbifolds with corners, as follows.

$S$ is called an essential fiber-product of $M, P$ over $N$ if there exist essential subsets $S^{\prime}, M^{\prime}, P^{\prime}, N^{\prime}$ of $S, M, P, N$, respectively, such that the images of $S^{\prime}, M^{\prime}, P^{\prime}$ under $q, r, f, g$ are in $M^{\prime}, P^{\prime}, N^{\prime}$, and the diagram

is a fiber-product.
Definition 2.18. we say $f$ essentially factorizes through the boundary of $g$ if Definition 2.12 holds with an essential fiber-product.


We make an extensive use of the following lemma in Section 国, to allow orientation calculations on essential subsets of the moduli spaces.

Lemma 2.19 (Unique extension of $\mathbb{Z} / 2$-maps). Let $M$ be a locally connected topological space, and let $P, Q$ be $\mathbb{Z} / 2$-bundles over $M$. Let $M^{\prime} \subset M$ be an essential subset. Let $f:\left.\left.P\right|_{M^{\prime}} \rightarrow Q\right|_{M^{\prime}}$ be a map of $\mathbb{Z} / 2$ bundles over $M^{\prime}$. Then $f$ extends uniquely to a map $f: P \rightarrow Q$ of bundles over $M$.

In particular, if $f, g: P \rightarrow Q$ satisfy $\left.f\right|_{M^{\prime}}=\left.g\right|_{M^{\prime}}$ then $f=g$.
Proof. Let $x \in M \backslash M^{\prime}$ be a point. There exists a connected neighborhood $x \in U \subset M$ such that $\left.P\right|_{U},\left.Q\right|_{U}$ are trivial and that the intersection $U \cap M^{\prime}$ is connected. Therefore, under trivializations of $\left.P\right|_{U},\left.Q\right|_{U}$, the map $\left.f\right|_{U \cap M^{\prime}}$ is constant. Therefore, it extends uniquely to $U$.

Remark 2.20. By Lemma 2.19, in what follows all Lemmas that concern fiber-products or boundary factorization hold for essential fiber-products and essential boundary factorization.

Notation 2.21. generally, for a set $X$ and a topological space $M$, we write $\underline{X}$ for the trivial bundle over $M$ with fiber $X$.
2.4. Orientation conventions. We follow the conventions of 41 concerning manifolds with corners. In particular, we relatively orient boundary and fiber products as detailed in the following. For an orbifold with corners $M$, we consider the orientation double cover $\widetilde{M}$ as a graded $\mathbb{Z} / 2$-bundle, concentrated in degree $\operatorname{deg} \widetilde{M}=\operatorname{dim} M$.

Definition 2.22. Let $M \xrightarrow{f} N$ be a map. We define the relative orientation bundle of $f$ to be the $\mathbb{Z} / 2$-bundle over $M$ given by

$$
\mathbb{K}_{f}:=\operatorname{Hom}_{\mathbb{Z} / 2}\left(\widetilde{M}, f^{*} \widetilde{N}\right)
$$

A local relative orientation is a section $\mathcal{O}:\left.U \rightarrow \mathbb{K}_{f}\right|_{U}$ over an open subset $U \subset M$. A relative orientation is a global section $\mathcal{O}: M \rightarrow \mathbb{K}_{f}$.

Note that it is concentrated in degree $-\operatorname{rdim} f=-m+n$.
Definition 2.23. The orientation bundle of an orbifold $M$ is defined to be the relative orientation bundle of the constant map $M \rightarrow p t$,

$$
\mathbb{K}_{M}:=\operatorname{Hom}_{\mathbb{Z} / 2}(\widetilde{M}, \underline{\mathbb{Z} / 2})=\widetilde{M}^{\vee},
$$

A (local) orientation for $M$ is (local) orientation relative to the constant map $M \rightarrow p t$.
Note that it is concentrated in degree $-\operatorname{dim} M$.
We now relatively-orient chosen operations on orbifolds.

### 2.4.1. Local diffeomorphism.

Definition 2.24. Let $f: M \rightarrow N$ be a local diffeomorphism. The differential $d f$ is regarded as a bundle map $d f: T M \rightarrow f^{*} T N$. Its exterior power induces a $\mathbb{Z} / 2$-bundle map $\left[\Lambda^{t o p} d f\right]: \widetilde{M} \rightarrow f^{*} \widetilde{N}$. It can be thought of as a section $\mathcal{O}_{c}^{f} \in \operatorname{Hom}\left(\widetilde{M}, f^{*} \widetilde{N}\right)$ called the canonical relative orientation of $f$. In particular, $\mathbb{K}_{f}$ is canonically trivial.

Moreover, given a map $g: N \rightarrow P$, there is a pullback map

$$
f^{\star}: f^{*} \mathbb{K}_{g} \rightarrow \mathbb{K}_{g \circ f}
$$

given by composition on the right with $\mathcal{O}_{c}^{f}$.

### 2.4.2. Composition.

Definition 2.25. Let $M \xrightarrow{f} P \xrightarrow{g} N$ be two maps. There is a canonical isomorphism

$$
\mathbb{K}_{f} \otimes f^{*} \mathbb{K}_{g} \simeq \mathbb{K}_{g \circ f}
$$

called the composition isomorphism given by

$$
\begin{aligned}
& \operatorname{Hom}_{\mathbb{Z} / 2}\left(\widetilde{M}, f^{*} \widetilde{P}\right) \otimes f^{*} \operatorname{Hom}_{\mathbb{Z} / 2}\left(\widetilde{P}, g^{*} \widetilde{N}\right) \rightarrow \operatorname{Hom}_{\mathbb{Z} / 2}\left(\widetilde{M},(g \circ f)^{*} \widetilde{N}\right), \\
& \mathcal{O}^{f} \otimes f^{*} \mathcal{O}^{g} \mapsto f^{*} \mathcal{O}^{g} \circ \mathcal{O}^{f} .
\end{aligned}
$$

Remark 2.26. If $f, g$ are local diffeomorphisms, then by the chain rule

$$
\mathcal{O}_{c}^{g \circ f}=f^{*} \mathcal{O}_{c}^{g} \circ \mathcal{O}_{c}^{f}
$$

That is $f^{\star} \circ g^{\star}=(g \circ f)^{\star}$.
Notation 2.27. By abuse of notation, we may omit the pullback notation $f^{*}$ if it causes no confusion, such as

$$
\mathcal{O}^{f} \otimes \mathcal{O}^{g}=\mathcal{O}^{f} \otimes f^{*} \mathcal{O}^{g}, \quad \mathcal{O}^{g} \circ \mathcal{O}^{f}=f^{*} \mathcal{O}^{g} \circ \mathcal{O}^{f}
$$

Remark 2.28. In the setting of Definition 2.4.2, if $t: T \rightarrow M$ is a local diffeomorphism, then the following diagram is commutative.


This follows from the associativity of composition.

Notation 2.29. To ease notations, we notate this isomorphism as equality.
2.4.3. Relative orientation of boundary. Let $M \xrightarrow{f} N$ be a proper submersion. As explained in Section 2.3, the boundary of $M$ can be divided into horizontal and vertical components with respect to $f$. Let $p \in \partial_{f} M$ be a point in the vertical boundary and $x_{1}, \ldots, x_{m-1} \in T_{p} \partial_{f} M$ be a basis, such that

$$
d f_{\iota_{f}(p)} \circ\left(d \iota_{f}\right)_{p}\left(x_{i}\right)=0, \quad i=n+1, \ldots, m-1 .
$$

Let $x_{1}^{\vee}, \ldots, x_{m-1}^{\vee}$ be the dual basis. Let $\nu_{\text {out }}$ be an outwards-pointing vector in $T_{p} M$. We define the canonical relative orientation of the boundary to be

$$
\begin{align*}
\left.\mathcal{O}_{c}^{\iota_{f}}\right|_{p}:=\left[x_{1}^{\vee} \wedge \ldots\right. & \wedge x_{m-1}^{\vee} \bigotimes\left(d \iota_{f}\right)_{p}\left(x_{1}\right) \wedge \ldots \wedge\left(d \iota_{f}\right)_{p}\left(x_{n}\right) \wedge  \tag{2.3}\\
& \left.\wedge \nu_{o u t} \wedge\left(d \iota_{f}\right)_{p}\left(x_{n+1}\right) \wedge \ldots \wedge\left(d \iota_{f}\right)_{p}\left(x_{m-1}\right)\right]
\end{align*}
$$

Remark 2.30. Consider the constant map $p t: M \rightarrow p t$. The total boundary $\partial M$ is the same as $\partial_{p t} M$. Therefore, we get a relative orientation for the inclusion of the total boundary $\iota_{M}: \partial M \rightarrow M$. By virtue of Definition 2.4.1, it is possible to relatively orient $\partial_{f} M$ as an open subset of $\partial M$. That is indeed done in [41: with the previous notations, the relative orientation that is used there is

$$
\left.o_{c}^{\iota_{f}}\right|_{p}:=\left[x_{1}^{\vee} \wedge \ldots \wedge x_{m-1}^{\vee} \bigotimes \nu_{\text {out }} \wedge\left(d \iota_{f}\right)_{p}\left(x_{1}\right) \wedge \ldots \wedge\left(d \iota_{f}\right)_{p}\left(x_{m-1}\right)\right] .
$$

These relative orientations satisfy

$$
o_{c}^{\iota_{f}}=(-1)^{N} \mathcal{O}_{c}^{\iota_{f}} .
$$

Remark 2.31. Given a relative orientation $\left.\mathcal{O}^{f} \in \mathbb{K}_{f}\right|_{p}$ at point $p \in M$, for vectors $x_{1}, \ldots, x_{m-1} \in T_{p} \partial_{f} M$ that form a basis, we have

$$
\mathcal{O}^{f} \circ \mathcal{O}_{c}^{\iota_{f}}\left(x_{1} \wedge \ldots \wedge x_{m-1}\right)=(-1)^{f-1} \mathcal{O}^{f}\left(\left(d \iota_{f}\right)_{p}\left(x_{1}\right) \wedge \ldots \wedge\left(d \iota_{f}\right)_{p}\left(x_{m-1}\right) \wedge \nu_{o u t}\right)
$$

### 2.4.4. Essential fiber product.

Definition 2.32. Let $M \stackrel{f}{\rightarrow} N \stackrel{g}{\leftarrow} P$ be transversal smooth maps of orbifolds with corners. Consider the following fiber product diagram.


There is a canonical isomorphism from the relative orientation bundle of $q$ to the pullback of the relative orientation bundle of $g$. It is called the pullback by $\mathbf{r}$ over $\mathbf{f}$ and denoted

$$
(r / f)^{\star}: r^{*} \mathbb{K}_{g} \simeq \mathbb{K}_{q}
$$

It is given as follows. Let $(m, p) \in M \times P$ be such that $f(m)=g(p)$. Let $\mathcal{O}^{N}, \mathcal{O}^{M}, \mathcal{O}^{g}$ be local orientations of $N, M, g$ in neighborhoods of $f(m), m, p$, respectively. Define $\mathcal{O}^{P}:=\mathcal{O}^{N} \circ \mathcal{O}^{g}$. By the transversality assumption,

$$
F:=d f_{m} \oplus-d g_{p}: T_{m} M \oplus T_{p} P \rightarrow T_{f(m)} N
$$

is surjective, and by definition of fiber product, there is a canonical isomorphism

$$
\psi:=d q_{(m, p)} \oplus d r_{(m, p)}: T_{(m, p)}\left(M \times_{N} P\right) \rightarrow \operatorname{ker}(F)
$$

Therefore, there exists a short exact sequence

$$
0 \longrightarrow T_{(m, p)}\left(M \times_{N} P\right) \xrightarrow{\psi} T_{m} M \oplus T_{p} P \xrightarrow{F} T_{f(m)} N \longrightarrow 0 .
$$

Splitting the short exact sequence, we get an isomorphism

$$
T_{m} M \oplus T_{p} P \xrightarrow{\Psi} T_{(m, p)}\left(M \times_{N} P\right) \oplus T_{f(m)} N .
$$

We define a local orientation $\mathcal{O}^{M} \times \mathcal{O}^{g}$ of $M \times_{N} P$ at $(m, p)$ to be the orientation for which $\Psi$ has $\operatorname{sign}(-1)^{N P}$, and subsequently we define a local orientation $(r / f)^{\star}\left(\mathcal{O}^{g}\right)$ of $q$ to satisfy the following equation.

$$
\mathcal{O}^{M} \times \mathcal{O}^{g}=\mathcal{O}^{M} \circ(r / f)^{\star}\left(\mathcal{O}^{g}\right)
$$

Definition 2.33. If

is an essential fiber product, the pullback by $r$ over $f$ that is defined on the essential part extends uniquely to a map $\mathbb{K}_{q} \rightarrow r^{*} \mathbb{K}_{g}$ by Lemma 2.19. This map is called the pullback by $r$ over $f$.

### 2.4.5. Relatively oriented commutative diagram.

Definition 2.34. Let

be a commutative diagram such that $r, f$ are relatively oriented, with relative orientations $\mathcal{O}^{r}, \mathcal{O}^{f}$. There exists a canonical isomorphism from the relative orientation bundle of $q$ to the pullback of the relative orientation bundle of $g$, with respect to $\mathcal{O}^{r}, \mathcal{O}^{f}$. It is called the pullback by $r$ over $f$ (with respect to $\mathcal{O}^{r}, \mathcal{O}^{f}$ ), and denoted

$$
(r / f)^{\star}: r^{*} \mathbb{K}_{g} \simeq \mathbb{K}_{q}
$$

It is given as follows. Let $\mathcal{O}^{g}$ be a local section of $r^{*} \mathbb{K}_{g}$. The pullback $(r / f)^{\star} \mathcal{O}^{g}$ is the unique local relative orientation of $q$ satisfying

$$
\mathcal{O}^{f} \circ(r / f)^{\star} \mathcal{O}^{g}=(-1)^{f g} \mathcal{O}^{g} \circ \mathcal{O}^{r} .
$$

Note that we omit the relative orientations of $r, f$ in the notation, as they will be fixed and declared in any situation in which we use this notation.
Remark 2.35. In the case the above diagram is a pullback diagram, and $\mathcal{O}^{r}=(q / g)^{\star} \mathcal{O}^{f}$, Lemma 2.43 implies that both definitions coincide.
2.4.6. Base extension. The following definition is an important example of Definition 2.32

Definition 2.36. Let $\Omega$ be a manifold with corners, let $A, X, Y$ be orbifolds with corners over $\Omega$ and let $f: X \rightarrow Y$ be a map over $\Omega$. Consider the following fiber product diagrams.


Assume $f$ is relatively oriented. Then $\operatorname{Id} \times f$ and $f \times \operatorname{Id}$ are relatively oriented, and we denote the pullbacks by $\pi_{X}^{A \times X}$ over $\pi_{Y}^{A \times Y}$ and by $\pi_{X}^{X \times A}$ over $\pi_{Y}^{Y \times A}$ of a relative orientation $\mathcal{O}^{f}$ of $f$ by

$$
1 \times \mathcal{O}^{f}:=\left(\pi_{X}^{A \times X} / \pi_{Y}^{A \times Y}\right)^{\star} \mathcal{O}^{f}, \quad \mathcal{O}^{f} \times 1:=\left(\pi_{X}^{X \times A} / \pi_{Y}^{Y \times A}\right)^{\star} \mathcal{O}^{f}
$$

respectively.
2.4.7. Quotient. Let $G$ be an oriented Lie group with orientation $\mathcal{O}^{G}$ and Lie algebra $\mathfrak{g}$. Denote by $\mathcal{O}^{\mathfrak{g}}:=\left.\mathcal{O}^{G}\right|_{1}$ the orientation of $\mathfrak{g}$ at the unit element $1 \in G$. For a point $g \in G$, denote by $R_{g}: G \rightarrow G$ be multiplication on the right by $g$. Then $\left.\mathcal{O}^{G}\right|_{g}=R_{g^{-1}}^{*} \mathcal{O}^{\mathfrak{g}}$.

Let $M$ be an orbifold with corners. Let $\Phi: M \times G \rightarrow M$ be a smooth proper right-action with finite stabilizers and let $q: M \rightarrow M / G$ be the quotient. The map $\pi_{M}: M \times G \rightarrow M$ carries the pullback orientation

$$
\mathcal{O}_{c}^{\pi}:=\left(\pi_{G}^{M \times G} / \pi^{M}\right)^{\star} \mathcal{O}^{G} .
$$

For a point $p \in M$, there is a short exact sequence

$$
\begin{equation*}
0 \rightarrow \mathfrak{g} \rightarrow T_{p} M \xrightarrow{d q_{p}} T_{q(p)}(M / G) \rightarrow 0 \tag{2.5}
\end{equation*}
$$

Moreover, the following diagram is a fiber-product.


Definition 2.37. The canonical relative orientation $\mathcal{O}_{c}^{q}$ of the quotient map $q$ is defined to be the relative orientation provided by the short exact sequence (2.5), with respect to the orientation $\left.\mathcal{O}^{G}\right|_{1}$ of $\mathfrak{g}$. One may check with methods analog to the proofs that appear in Section [2.6 that

$$
\begin{equation*}
\mathcal{O}_{c}^{\pi}=(\Phi / q)^{\star} \mathcal{O}_{c}^{q} \tag{2.7}
\end{equation*}
$$

The canonical relative orientation of the action $\Phi$ is defined to be the pullback

$$
\mathcal{O}_{c}^{\Phi}:=(-1)^{G}\left(\pi_{M} / q\right)^{\star} \mathcal{O}_{c}^{q}
$$

Remark 2.38. Let $\mathcal{O}^{\mathfrak{g}} \in \mathbb{K}_{\mathfrak{g}}$ be an orientation of $G$. The orientation $\mathcal{O}_{c}^{q}$ is calculated as follows. Choose a basis $v_{1}, \ldots, v_{g} \in \mathfrak{g}$, such that $\mathcal{O}^{\mathfrak{g}}=\left[v_{1}^{\vee} \wedge \cdots \wedge v_{g}^{\vee}\right]$ where $v_{1}^{\vee}, \ldots, v_{g}^{\vee}$ is the dual basis. For a point $p \in M$ and tangent vectors $x_{1}, \ldots, x_{m-g} \in T_{p} M$ such that

$$
\left(x_{1}, . ., x_{m-g}, d \Phi_{p}\left(v_{1}\right), \ldots, d \Phi_{p}\left(v_{g}\right)\right)
$$

is a basis of $T_{p} M$, we denote the dual basis as $x_{1}^{\vee}, \ldots, x_{m-g}^{\vee}, d \Phi_{p}\left(v_{1}\right)^{\vee}, \ldots, d \Phi_{p}\left(v_{g}\right)^{\vee}$. Then

$$
\left.\mathcal{O}_{c}^{q}\right|_{p}:=\left[x_{1}^{\vee} \wedge \ldots \wedge x_{m-g}^{\vee} \wedge d \Phi_{p}\left(v_{1}\right)^{\vee} \wedge \ldots \wedge d \Phi_{p}\left(v_{g}\right)^{\vee} \bigotimes d q_{p}\left(x_{1}\right) \wedge \ldots \wedge d q_{p}\left(x_{m-g}\right)\right] .
$$

One may check the following remark using methods analog to the proofs that appear in Section 2.6. The first equation is simply equation (2.7).
Remark 2.39. Let $\mathcal{O}^{\mathfrak{g}} \in \mathbb{K}_{\mathfrak{g}}$ be an orientation of $G$. The relative orientations $\mathcal{O}_{c}^{\pi}, \mathcal{O}_{c}^{\Phi}$ are calculated as follows. Let $\mathcal{O}^{\mathfrak{g}} \in \mathbb{K}_{\mathfrak{g}}$ be an orientation of the Lie algebra. Choose a basis $v_{1}, \ldots, v_{g} \in \mathfrak{g}$ such that $\mathcal{O}^{\mathfrak{g}}=\left[v_{1}^{\vee} \wedge \cdots \wedge v_{g}^{\vee}\right]$ where $v_{1}^{\vee}, \ldots, v_{g}^{\vee}$ is the dual basis. For a point $(p, g) \in M \times G$ and a basis $x_{1}, \ldots, x_{m} \in T_{p} M$, we have

$$
\begin{aligned}
& \left.\mathcal{O}_{c}^{\pi}\right|_{(p, g)}\left(x_{1}, \ldots, x_{m}, v_{1}, \ldots, v_{g}\right)=\left(d \pi_{M}\left(x_{1}\right), \ldots, d \pi_{M}\left(x_{m}\right)\right), \\
& \left.\mathcal{O}_{c}^{\Phi}\right|_{(p, g)}\left(x_{1}, \ldots, x_{m}, v_{1}, \ldots, v_{g}\right)=\left(d \Phi_{g}\left(x_{1}\right), \ldots, d \Phi_{g}\left(x_{m}\right)\right)
\end{aligned}
$$

where $\Phi_{g}: M \rightarrow M$ is multiplication by $g$ on the right.
2.5. Orientations calculus. The following lemmas describe, in particular, how to orient complex structures from simpler ones. The proofs are provided in Section 2.6

Lemma 2.40. In the setting of Definition 2.32, assume $f$ is a local diffeomorphism. Then $r$ is a local diffeomorphism as well, and if $a: N \rightarrow A$ is a map, then the following diagram is commutative.

$$
\begin{align*}

Proof of Lemma 2.46. Since $f$ is a submersion, so is $\iota^{*} f$. Let $y_{1}, \ldots, y_{m-1}$ be a basis for $T \partial_{g \circ f} M$ at a point, such that $x_{i}=d\left(\iota^{*} f\right)\left(y_{i}\right), i=1, \ldots, p-1$ form a basis of $T \partial_{g} P$. Define a section

$$
\begin{aligned}
s: T \partial_{g} P & \rightarrow T \partial_{g \circ f} M, \\
\sum \alpha_{i} x_{i} & \mapsto \sum \alpha_{i} y_{i} .
\end{aligned}
$$

Note that $\left(d \iota_{g \circ f}\left(y_{i}\right)\right)_{i=1}^{m-1}$ together with $\nu_{o u t}$ form a basis of $T M$, and define a map

$$
\begin{aligned}
t: T M & \rightarrow T \partial M \\
\sum \beta_{j} d \iota_{\text {gof }}\left(y_{j}\right)+\gamma \nu_{\text {out }} & \mapsto \sum \beta_{j} y_{j} .
\end{aligned}
$$

Note that if $(x, z) \in \operatorname{ker}(F)$, then $z \in \operatorname{Im}\left(d \iota_{g \circ f}\right)$, and thus $z=d \iota_{g \circ f}(t(z))$. further,

$$
d \iota_{g} \circ d\left(\iota^{*} f\right)(s(x)-t(z))=d \iota_{g}(x)-d f(z)=0,
$$

and therefore $s(x)-t(z) \in \operatorname{ker} d\left(\iota^{*} f\right)$. Consider the map

$$
C:=\left(\begin{array}{cc}
0 & t \\
d \iota_{g} & -d f
\end{array}\right): T \partial P \oplus T M \rightarrow T \partial M \oplus T P
$$

It is injective. Indeed, if

$$
\left(\begin{array}{cc}
0 & t \\
d \iota_{g} & -d f
\end{array}\right)\binom{x}{z}=0
$$

then $(x, z) \in \operatorname{ker}(F)$, and thus

$$
\operatorname{ker}\left(d \iota^{*} f\right) \ni s(x)-t(z)=s(x),
$$

which implies

$$
0=d\left(\iota^{*} f\right) s(x)=x .
$$

Therefore, $z \in \operatorname{ker}(d f)$ and thus $z \in \operatorname{Im}\left(d \iota_{g \circ f}\right)$. So

$$
z=d \iota_{g \circ f}(t(z))=d \iota_{g \circ f}(0)=0 .
$$

Since the dimensions of the source and target of $C$ are the same, it is an isomorphism, and in fact, a splitting of

$$
0 \longrightarrow T \partial M \xrightarrow{\binom{d\left(\iota^{*} f\right)}{d_{g \circ f}}} T \partial P \oplus T M \xrightarrow{\left(d l_{g},-d f\right)} T P \longrightarrow 0
$$

Let $\mathcal{O}^{P}, \mathcal{O}^{f}$ be local orientations of $P, f$, respectively. Set

$$
\begin{aligned}
\mathcal{O}^{M} & =\mathcal{O}^{P} \circ \mathcal{O}^{f}, \\
\mathcal{O}^{\partial P} & =\mathcal{O}^{P} \circ \mathcal{O}_{c}^{\iota_{g}}, \\
\mathcal{O}^{\partial M} & =\mathcal{O}^{M} \circ \mathcal{O}_{c}^{\iota_{g \circ f}} .
\end{aligned}
$$

With these orientations, the maps

$$
\begin{aligned}
A: \mathbb{R} \oplus T \partial M & \rightarrow T M, & (\alpha, z) & \mapsto \alpha \nu_{\text {out }}+d \iota_{\text {gof }}(z) \\
B: \mathbb{R} \oplus T \partial P & \rightarrow T P, & (\beta, x) & \mapsto \beta \nu_{\text {out }}+d \iota_{g}(x)
\end{aligned}
$$

have $\operatorname{sgn}(A)=\operatorname{sgn}(B)=(-1)^{N}$. Note that $A$ and $B$ are isomorphisms, and

$$
B^{-1}(y)=y-\underset{27}{d \iota_{g \circ f}(t(y)), t(y) . . ~}
$$

Therefore, the map

$$
D:=\left(\begin{array}{ll}
1 & 0 \\
0 & C
\end{array}\right): \mathbb{R} \oplus T \partial P \oplus T M \rightarrow \mathbb{R} \oplus T \partial M \oplus T P
$$

which is equivalent to

$$
\left(\begin{array}{ccc}
1 & 0 & y-d \iota_{g \circ f}(t(y)) \\
0 & 0 & t(y) \\
\nu_{\text {out }} & d \iota_{g} & -d f
\end{array}\right)
$$

has $\operatorname{sgn}(C)=\operatorname{sgn}(D)=1=(-1)^{P \cdot \partial P}$. Therefore,

$$
\mathcal{O}^{\partial P} \times \mathcal{O}^{f}=\mathcal{O}^{M} \circ \mathcal{O}^{\iota_{g} \circ f}
$$

which breaks down to the equation

$$
\mathcal{O}^{P} \circ \mathcal{O}_{c}^{\iota_{g}} \circ\left(\iota_{g \circ f} / \iota_{g}\right)^{\star} \mathcal{O}^{f}=\mathcal{O}^{P} \circ \mathcal{O}^{f} \circ \mathcal{O}^{\iota_{g} \circ f} .
$$

The lemma follows.
Proof of Lemma 2.47. For ease, we assume $\Omega$ is a point. The general case is similar. We identify $\partial_{(\operatorname{Id} \times f)}\left(A \times_{\Omega} X\right)$ with $A \times_{\Omega} \partial_{f} X$, such that $\iota_{f}^{*} \pi_{X}$ reduces to the projection $\pi_{\partial_{f} X}$ and $\iota_{(\operatorname{Id} \times f)}$ reduces to the inclusion $\operatorname{Id} \times \iota_{f}$. Consider the map

$$
C:=\left(\begin{array}{ccc}
1 & 0 & 0 \\
0 & 0 & 1 \\
0 & 1 & d \iota_{f}
\end{array}\right): T A \oplus T X \oplus T \partial_{f} X \rightarrow T A \oplus T \partial_{f} X \oplus T X
$$

which splits the following sequence.

$$
0 \rightarrow \oplus T \partial_{f} X \xrightarrow{\left(\begin{array}{cc}
1 & 0 \\
0 & d \iota_{f} \\
0 & 1
\end{array}\right)} T A \oplus T X \oplus T \partial_{f} X \xrightarrow{\left(\begin{array}{lll}
0 & 1 & -d \iota_{f}
\end{array}\right)} T X \rightarrow 0
$$

With whichever orientations chosen for $A, X, \partial_{f} X$, we have $\operatorname{sgn}(C)=(-1)^{X \cdot \partial_{f} X}$. But $C$ can be interpreted as a map

$$
T(A \times X) \oplus T \partial_{f} X \rightarrow T\left(\partial_{(\mathrm{Id} \times f)}(A \times X)\right) \oplus T X
$$

Let $\mathcal{O}^{X}, \mathcal{O}^{A}$ be local orientations of $X, A$, respectively. Set

$$
\begin{aligned}
\mathcal{O}^{\partial X} & :=\mathcal{O}^{X} \circ \mathcal{O}_{c}^{\iota_{f}}, \\
\mathcal{O}^{A \times X} & :=\mathcal{O}^{A} \times \mathcal{O}^{X}, \\
\mathcal{O}^{\partial(A \times X)} & :=\left(\mathcal{O}^{A} \times \mathcal{O}^{X}\right) \circ \mathcal{O}_{c}^{\iota_{(I \mathrm{I} \times f)}} .
\end{aligned}
$$

With these orientations, the identifying map

$$
T \partial_{(\mathrm{Id} \times f)}(A \times X) \rightarrow T A \oplus T \partial_{f} X
$$

is orientation preserving. Therefore,

$$
\mathcal{O}^{A} \times \mathcal{O}_{c}^{\iota_{f}}=\left(\mathcal{O}^{A} \times \mathcal{O}^{X}\right) \circ \mathcal{O}_{c}^{\iota_{(I X x)}}
$$

which implies by definition that

$$
\mathcal{O}_{c}^{\iota_{(I \mathrm{II} \times f)}}=\left(\iota_{f}^{*} \pi_{X} / \pi_{X}\right)^{\star}\left(\mathcal{O}_{c}^{\iota_{f}}\right) .
$$

## 3. Orientors

### 3.1. Orientors.

3.1.1. Definition and basic examples. In this paper, we will concentrate mostly on bundle maps of the following form.

Definition 3.1. Let $g: M \rightarrow N$ be a map and let $Q, K$ be $\mathbb{Z} / 2$ bundles over $M, N$, respectively. A $g$-orientor of $Q$ to $K$ is a graded bundle map

$$
G: Q \rightarrow \mathbb{K}_{g} \otimes_{\mathbb{Z} / 2} g^{*} K
$$

Its degree is the usual degree as a bundle map, where $\mathbb{K}_{g} \otimes g^{*} K$ is, as usual, the graded tensor product and $\mathbb{K}_{g}$ is concentrated in degree -reldim $g$. A $g$-endo-orientor of $K$ is a $g$-orientor of $g^{*} K$ to $K$.

Terminology 3.2. if $g=\pi^{M}: M \rightarrow *$ is the constant map, then we say $M$-orientor for $g$-orientor.

Definition 3.3 (Orientation as an orientor). Let $f: M \rightarrow N$ be a relatively orientable map of orbifolds with corners. The section $\mathcal{O}^{f}: M \rightarrow \mathbb{K}_{f}$ can be extended uniquely to a $\mathbb{Z} / 2$ equivariant map

$$
\varphi^{\mathcal{O}^{f}}: \underline{\mathbb{Z} / 2} \rightarrow \mathbb{K}_{f}
$$

which satisfies

$$
\varphi^{\mathcal{O}^{f}}(1)=\mathcal{O}^{f}
$$

The map $\varphi^{\mathcal{O}^{f}}$ can be considered as an $f$-endo-orientor of $\mathbb{Z} / 2$. If $f$ is a local diffeomorphism, we denote by

$$
\varphi_{f}:=\varphi^{\mathcal{O}_{c}^{f}} .
$$

If $N=*$ and $M$ is oriented with orientation $\mathcal{O}^{M}$, then we abbreviate

$$
\varphi_{M}:=\varphi^{\mathcal{O}^{M}}
$$

Example 3.4. Let $A, B$ be $\mathbb{Z} / 2$ vector bundles over an orbifold $M$. The symmetry operator $\tau_{A, B}: A \otimes B \rightarrow B \otimes A$ of Definition 2.2 may be considered as an $\mathrm{Id}_{M^{-}}$-orientor. More generally, any bundle map of bundles over an orbifold $M$ may be considered as an $\operatorname{Id}_{M^{-}}$ orientor.

Definition 3.5. Let $M, N, g, Q, K, G$ be as in Definition 3.1 and let $T$ be a $\mathbb{Z} / 2$ bundle over $N$. Then the right $T$ extension of $G$ is the $g$-orientor of $Q \otimes g^{*} T$ to $K \otimes T$ given by

$$
Q \otimes g^{*} T \xrightarrow{G \otimes \mathrm{Id}} \mathbb{K}_{g} \otimes g^{*}(K \otimes T) .
$$

It is denoted by $G^{T}$. Similarly, the left $T$ extension of $G$ is the $g$-orientor of $g^{*} T \otimes Q$ to $T \otimes K$ given by

$$
g^{*} T \otimes Q \xrightarrow{\mathrm{Id} \otimes G} g^{*} T \otimes \mathbb{K}_{g} \otimes g^{*} K \xrightarrow{\tau \otimes \mathrm{Id}} \mathbb{K}_{g} \otimes g^{*}(T \otimes K) .
$$

It is denoted by ${ }^{T} G$.
Remark 3.6 (Repeated extension). In the previous setting, if $T_{1}, T_{2}$ are $\mathbb{Z} / 2$ bundles over $N$, then

$$
\left(G^{T_{1}}\right)^{T_{2}}=G^{T_{1} \otimes T_{2}},{ }_{29}^{T_{2}}\left({ }^{T_{1}} G\right)={ }^{T_{2} \otimes T_{1}} G
$$

### 3.1.2. Composition.

Definition 3.7. Let $M \xrightarrow{f} P \xrightarrow{g} N$ be maps and let $Q, K, R$ be $\mathbb{Z} / 2$ bundles over $M, P, N$, respectively. Let $F: Q \rightarrow \mathbb{K}_{f} \otimes f^{*} K$ be a $f$-orientor of $Q$ to $K$ and $G: K \rightarrow \mathbb{K}_{g} \otimes g^{*} R$ be a $g$-orientor of $K$ to $R$. The composition $G \bullet F$ is the $g \circ f$-orientor of $Q$ to $R$ given as follows.

$$
Q \xrightarrow{F} \mathbb{K}_{f} \otimes f^{*} K \xrightarrow{\mathrm{Id} \otimes f^{*} G} \mathbb{K}_{f} \otimes f^{*} \mathbb{K}_{g} \otimes f^{*} g^{*} P \stackrel{\text { comp. }}{=} \mathbb{K}_{g \circ f} \otimes(g \circ f)^{*} R
$$

Lemma 3.8. The composition of orientors is associative.
Proof of Lemma 3.8. In addition to the data in Definition 3.7, let $h: N \rightarrow L$ be a map, let $T$ be a $\mathbb{Z} / 2$ bundle over $L$ and let $H$ be a $h$-orientor of $R$ to $T$. Then the equality

$$
H \bullet(G \bullet F)=(H \bullet G) \bullet F
$$

can be seen from the following diagram.


### 3.1.3. Pullback along a relatively oriented map.

Lemma 3.9. Let $M \xrightarrow{f} P \xrightarrow{g} N$ be maps, and let $\mathcal{O}^{f}, \mathcal{O}^{g}$ be relative orientations of $f, g$, respectively. Then

$$
\varphi^{\mathcal{O}^{g}} \bullet \varphi^{\mathcal{O}^{f}}=(-1)^{f g} \varphi^{\mathcal{O}^{g} \mathcal{O}^{f}}
$$

Remark 3.10. In particular, if $f, g$ are local diffeomorphisms then Remark 2.26 implies

$$
\varphi_{g} \bullet \varphi_{f}=\varphi_{g \circ f}
$$

Proof of Lemma 3.9. We calculate

$$
\varphi^{\mathcal{O}^{g}} \bullet \varphi^{\mathcal{O}^{f}}(1) \stackrel{\text { Def. } 3.7}{=}\left(1_{\mathbb{K}_{f}} \otimes \varphi^{\mathcal{O}^{g}}\right)\left(\mathcal{O}^{f} \otimes 1\right) \stackrel{\text { Koszul }}{=}{ }^{[2.4]}(-1)^{f g} \mathcal{O}^{g} \circ \mathcal{O}^{f}
$$

Definition 3.11. Let $M \xrightarrow{f} P \xrightarrow{g} N$, and suppose that $f$ is relatively oriented with relative orientation $\mathcal{O}^{f}$. Let $K, R$ be $\mathbb{Z} / 2$-bundles over $P, N$, respectively. Let $G$ be a $g$-orientor of $K$ to $R$. The pullback of $G$ by $\left(f, \mathcal{O}^{f}\right)$ is the $g \circ f$-orientor of $f^{*} K$ to $R$, given by

$$
\left(f, \mathcal{O}^{f}\right)^{\diamond} G=(-1)^{f G} G \bullet\left(\varphi^{\mathcal{O} f}\right)^{K}
$$

where $\varphi^{\mathcal{O}^{f}}$ is the orientor from Definition 3.3, If $f$ is a local diffeomorphism, we write

$$
f^{\diamond} G=\left(f, \mathcal{O}_{c}^{f}\right)^{\diamond} G=G \bullet\left(\varphi_{f}\right)^{K}
$$

Lemma 3.12. Let $M \xrightarrow{f} P \xrightarrow{g} N \xrightarrow{h} L$ be maps, let $\mathcal{O}^{f}, \mathcal{O}^{g}$ be relative orientations of $f, g$, respectively, and let $H$ be an h-orientor. Then

$$
\left(f, \mathcal{O}^{f}\right)^{\diamond}\left(g, \mathcal{O}^{g}\right)^{\diamond} H=\left(g \circ f, \mathcal{O}^{g} \circ \mathcal{O}^{f}\right)^{\diamond} H
$$

Proof. This follows immediately from Definition 3.11 and Lemma 3.9,

### 3.1.4. Orientors restoration.

Lemma 3.13. Let $M \xrightarrow{f} P \xrightarrow{g} N$, and let $Q, K, R$ be $\mathbb{Z} / 2$-bundles over $M, P, N$, respectively. Let $H$ be an $g \circ f$-orientor of $Q$ to $R$, and $G$ be an $g$-orientor of $K$ to $R$. Assume $G$ is invertible as a bundle map

$$
G: K \rightarrow \mathbb{K}_{g} \otimes g^{*} R
$$

Then there exists a unique $f$-orientor $F$ of $Q$ to $K$ satisfying

$$
H=G \bullet F
$$

Proof of Lemma 3.13. Assume such $F$ exists. Then

$$
\left(\operatorname{Id}_{\mathbb{K}_{f}} \otimes f^{*} G\right) \circ F=H
$$

Since $G$ is invertible, this equation defines $F$ uniquely.
Lemma 3.14. Let $M \xrightarrow{f} P \xrightarrow{g} N$, and assume that $f$ is relatively oriented, surjective submersion with connected fibers and with relative orientation $\mathcal{O}^{f}$. Let $K, R$ be $\mathbb{Z} / 2-$ bundles over $P, N$, respectively. Set $h=g \circ f$ and let $H$ be an h-orientor of $f^{*} K$ to $R$. Then there exists a unique $g$-orientor of $K$ to $R$, denoted by $G$ such that

$$
H=\left(f, \mathcal{O}^{f}\right)^{\diamond} G
$$

The connectedness of the fibers of $f$ in the previous lemma is necessary, as is shown in the following examples.

Example 3.15. In the situation of Lemma 3.14, let $M=P=N=S^{1}$ modeled as the group of unit elements in $\mathbb{C}^{*}$. Let $f(z)=z^{2}$ and $g(z)=z$. Let $R=\mathbb{Z} / 2$ and let $K$ be a nontrivial double-cover of $P$. Since $f$ is a local diffeomorphism, it is relatively oriented. Then $f^{*} K$ is trivial, $\mathbb{K}_{f \circ g}$ is trivial and $f^{*} g^{*} R$ is trivial. Therefore, there exists an $g \circ f$ orientor of $f^{*} K$ to $R$. However, there does not exist a $g$-orientor of $K$ to $R$ since $K$ is homeomorphic to $S^{1}$ while $R$ is homeomorphic to two copies of $S^{1}$.
Example 3.16. In the situation of Lemma 3.14, let $M=\{0,1\}, P=N=\{0\}$. Let $R=K=\mathbb{Z} / 2$. The map $p t: M \rightarrow P$ is a local diffeomorphism. Let

$$
F: \underline{\mathbb{Z} / 2} \rightarrow \mathbb{K}_{p t} \otimes \underline{\mathbb{Z} / 2}
$$

be the map that over a point $x \in M$ sends

$$
k \mapsto k+x
$$

Then under any identification $\mathbb{K}_{p t} \simeq \mathbb{Z} / 2$, the set map $F$ has two fixed points, while $(p t)^{\diamond} G$ has either four fixed points or no fixed points, for any equivariant map $G: \mathbb{Z} / 2 \rightarrow \mathbb{Z} / 2$. Therefore, $F$ cannot be written as $(p t)^{\diamond} G$ for any $\operatorname{Id}_{p t}$-endo-orientor $G$ of $\mathbb{Z} / 2$.

Proof of Lemma 3.14. Under the adjunction of the functors $f^{*}$ and $f_{*}$ of sheaves, the map $H$ corresponds to a map

$$
\widetilde{H}: K \rightarrow f_{*}\left(\mathbb{K}_{h} \otimes h^{*} R\right)
$$

By the composition isomorphism of Definition 2.25 and the projection formula for sheaves,

$$
f_{*}\left(\mathbb{K}_{h} \otimes h^{*} R\right)=f_{*} \mathbb{K}_{f} \otimes \mathbb{K}_{g} \otimes g^{*} R
$$

However, since the fibers of $f$ are connected, $f_{*} \underline{\mathbb{Z} / 2}=\underline{\mathbb{Z}} / 2$ and thus the map $f_{*} \varphi^{\mathcal{O}^{f}}$ : $\underline{\mathbb{Z} / 2} \rightarrow f_{*} \mathbb{K}_{f}$ is an isomorphism. Therefore, there exists a unique $g$-orientor $G$ of $K$ to $R$ satisfying

$$
\widetilde{H}=\underset{31}{f_{*} \varphi^{\mathcal{O}^{f}}} \otimes G
$$

By the abovementioned adjunction, it satisfies

$$
H=\left(f, \mathcal{O}^{f}\right)^{\diamond} G
$$

3.1.5. Pullback along a fiber-product.

Definition 3.17. Let

be a pullback square. Let $K, R$ be $\mathbb{Z} / 2$-bundles over $P, N$ respectively, and let $G$ be a $g$-orientor from $K$ to $R$. The pullback of $G$ by $r$ over $f$ is the $q$-orientor of $r^{*} K$ to $f^{*} R$ given by the following composition.

$$
r^{*} K \xrightarrow{r^{*} G} r^{*} \mathbb{K}_{g} \otimes r^{*} g^{*} R \xrightarrow{(r / f)^{*} \otimes \mathrm{Id}} \mathbb{K}_{q} \otimes q^{*} f^{*} R .
$$

It is denoted by $(r / f)^{\circ} G$.
Example 3.18. Let $f: M \rightarrow N$ be a map, $Q, K$ be $\mathbb{Z} / 2$-bundles over $N$ and let $G: Q \rightarrow K$ be a $\operatorname{Id}_{N}$-orientor of $Q$ to $K$. Consider the following pullback diagram.


Then under the canonical isomorphism $\mathbb{K}_{\operatorname{Id}_{X}} \simeq \underline{\mathbb{Z} / 2}$ it holds that

$$
(f / f)^{\diamond} G=f^{*} G
$$

This follows from Lemma 2.41,
Lemma 3.19. Consider the following diagram, in which the square is a pullback square.


Let $K, R, T$ be $\mathbb{Z} / 2$-bundles over $P, N, L$, respectively. Assume $G: K \rightarrow \mathbb{K}_{g} \otimes g^{*} R$ and $H: R \rightarrow \mathbb{K}_{h} \otimes h^{*} T$ are orientors. Let $\mathcal{O}^{f}$ be a relative orientation of $f$. Set $\mathcal{O}^{r}:=(q / g)^{\star} \mathcal{O}^{f}$. Then $\mathcal{O}^{r}$ is a relative orientation of $r$ and it follows that the following diagram is commutative.


That is,

$$
\begin{equation*}
\left(r, \mathcal{O}^{r}\right)^{\diamond}(H \bullet G)=\left(f, \mathcal{O}_{32}^{f}\right)^{\diamond}(H) \bullet(r / f)^{\diamond}(G) \tag{3.1}
\end{equation*}
$$

Proof. Recalling Definition 3.11, this lemma amounts to

$$
(H \bullet G) \bullet\left(\varphi^{\mathcal{O}^{r}}\right)^{K}=(-1)^{f G}\left(H \bullet\left(\varphi^{\mathcal{O}^{f}}\right)^{R}\right) \bullet(r / f)^{\diamond}(G) .
$$

Using the Associativity Lemma 3.8, it is enough to prove that

$$
G \bullet\left(\varphi^{\mathcal{O}^{r}}\right)^{K}=(-1)^{f G}\left(\varphi^{\mathcal{O}^{f}}\right)^{R} \bullet(r / f)^{\diamond}(G) .
$$

To see that, let $k, t, \mathcal{O}^{g}$ be sections of $K, R, \mathbb{K}_{g}$, respectively, such that $G(k)=\mathcal{O}^{g} \otimes g^{*} t$. Then

$$
G \bullet\left(\varphi^{\mathcal{O}^{r}}\right)^{K}\left(r^{*} k\right)=\left(\operatorname{Id} \otimes r^{*} G\right)\left(\mathcal{O}^{r} \otimes r^{*} k\right)=(-1)^{r G} \mathcal{O}^{r} \otimes r^{*} \mathcal{O}^{g} \otimes r^{*} g^{*} t
$$

and

$$
\begin{aligned}
\left(\varphi^{\mathcal{O}^{f}}\right)^{R} \bullet(r / f)^{\diamond}(G)\left(r^{*} k\right) & =\left(\operatorname{Id} \otimes q^{*} \varphi^{\mathcal{O}^{f}}\right)\left((r / f)^{\star} \mathcal{O}^{g} \otimes r^{*} g^{*} t\right) \\
& =(-1)^{f g}\left((r / f)^{\star} \mathcal{O}^{g} \otimes q^{*} \mathcal{O}^{f} \otimes r^{*} g^{*} t\right) .
\end{aligned}
$$

However, by Lemma 2.43 it follows that

$$
\mathcal{O}^{r} \otimes r^{*} \mathcal{O}^{g}=(-1)^{f g}(r / f)^{\star} \mathcal{O}^{g} \otimes q^{*} \mathcal{O}^{f}
$$

and the lemma follows, since $\operatorname{dim} f=\operatorname{dim} r$.
Remark 3.20. In the setting of Lemma 3.19, if $f$ is a local diffeomorphism, then $r$ is a local diffeomorphism, and

$$
r^{\diamond}(H \bullet G)=f^{\diamond}(H) \bullet(r / f)^{\diamond} G
$$

Example 3.21. Let $M \xrightarrow{f} P \xrightarrow{g} N$ be maps, $K, R$ be $\mathbb{Z} / 2$-bundles over $P, N$, respectively, and let $G$ be a $g$-orientor of $K$ to $R$. Assume $f$ is a diffeomorphism. Consider the following pullback diagram.


By applying Remark 3.20 to the preceding diagram extended with $h=\mathrm{Id}_{N}$ and $H=\mathrm{Id}_{R}$, we get

$$
(f / \mathrm{Id})^{\diamond} G=f^{\diamond} G .
$$

Lemma 3.22. Consider the following fiber-product diagram.


Let $Q, K, R, T$ be $\mathbb{Z} / 2$-bundles over $N$. Let $F$ be $f$-orientor of $f^{*} Q$ to $R$ and let $G$ be a $g$-orientor of $g^{*} K$ to $T$. Then we have the following equality of $(f \circ q)$-orientors of $(f \circ q)^{*}(K \otimes Q)$ to $T \otimes R$.

$$
{ }^{T} F \bullet(r / f)^{\diamond} G^{f^{*} Q}=\underset{33}{(-1)^{F G}} G^{R} \bullet{ }^{g^{*} K}(q / g)^{\diamond} F
$$

Proof of Lemma 3.22. Let $\mathcal{O}^{f}, \mathcal{O}^{g}$ be local orientations of $f, g$, respectively. Let $q, k, r, t$ be local sections of $Q, K, R, T$, respectively. Assume

$$
F\left(f^{*} q\right)=\mathcal{O}^{f} \otimes f^{*} r, G\left(g^{*} k\right)=\mathcal{O}^{g} \otimes g^{*} t
$$

Then

$$
\begin{aligned}
{ }^{T} F \bullet(r / f)^{\diamond} G^{f^{*} Q}\left((f \circ q)^{*}(k \otimes q)\right) & =\left(\operatorname{Id}_{\mathbb{K}_{q}} \otimes q^{*}\left({ }^{T} F\right)\right)\left((r / f)^{\star} \mathcal{O}^{g} \otimes q^{*} f^{*}(t \otimes q)\right) \\
& =(-1)^{F g+(F-f) t} \mathcal{O}^{f} \circ(r / f)^{\star} \mathcal{O}^{g} \otimes q^{*} f^{*}(t \otimes r) .
\end{aligned}
$$

There is no sign from passing $\mathcal{O}^{f}$ by $\mathcal{O}^{g}$ by the definition of the composition isomorphism 2.25. On the other hand,

$$
\begin{aligned}
& G^{R} \bullet g^{*} K \\
&(q / g)^{\diamond} F\left((g \circ r)^{*}(k \otimes q)\right)=(-1)^{(F-f) k}\left(1_{\mathbb{K}_{r}} \otimes r^{*}\left(G^{R}\right)\right)\left((q / g)^{\star} \mathcal{O}^{f} \otimes r^{*} g^{*}(k \otimes r)\right) \\
&=(-1)^{G f+(F-f) k} \mathcal{O}^{g} \circ(q / r)^{\star} \mathcal{O}^{f} \otimes r^{*} g^{*}(t \otimes r) .
\end{aligned}
$$

By Lemma 2.43 we see that

$$
{ }^{T} F \bullet(r / f)^{\diamond} G^{f^{*} Q}=(-1)^{s} G^{R} \bullet g^{*} K(q / g)^{\diamond} F,
$$

with

$$
s=F g+(F-f) t+G f+(F-f) k+f g .
$$

However, $G+k \equiv_{2} g+t$, and thus,

$$
s \equiv_{2} F g+(F-f)(G-g)+G f+f g \equiv_{2} F G
$$

Lemma 3.23. Assume that the squares in the following diagram are pullbacks.


Then the rectangle is also a pullback diagram, and

$$
((t \circ r) /(a \circ f))^{\diamond}=(r / f)^{\diamond} \circ r^{*}(t / a)^{\diamond}
$$

Proof of Lemma 3.23. This is a consequence of Lemma 2.44.
Lemma 3.24. Assume that the squares in the following diagrams are pullbacks.


Then the rectangle is also a pullback diagram. Let $Q, R, S$ be $\mathbb{Z} / 2$-bundles over $P, N, K$, respectively. Assume $G$ is a g-orientor of $Q$ to $R$, and $A$ is a a-orientor of $R$ to $S$. Then

$$
(r / b)^{\diamond}(A \bullet G)=\left((f / b)^{\diamond} A\right) \bullet\left((r / f)^{\triangleright} G\right) .
$$

Proof of Lemma 3.24. This is a consequence of Lemma 2.45,

### 3.1.6. Pullback along a relatively oriented commutative diagram.

Definition 3.25. Let

be a commutative diagram such that $r, f$ are relatively oriented, with relative orientations $\mathcal{O}^{r}, \mathcal{O}^{f}$. Let $K, R$ be $\mathbb{Z} / 2$-bundles over $P, N$, respectively, and let $G$ be a $g$-orientor from $K$ to $R$. The pullback of $G$ by $r$ over $f$ is the unique $q$-orientor of $r^{*} K$ to $f^{*} R$, denoted $(r / f)^{\circ} G$, given by the following equation.

$$
\left(r, \mathcal{O}^{r}\right)^{\diamond} G=\left(\varphi^{\mathcal{O}^{f}}\right)^{R} \bullet(r / f)^{\diamond} G
$$

Its existence and uniqueness are guaranteed by Lemma 3.13.
Remark 3.26. Recall the isomorphism $(r / f)^{\star}: r^{*} \mathbb{K}_{g} \rightarrow \mathbb{K}_{q}$ from Definition 2.34. It is easy to check by hand that the composite map

$$
r^{*} K \xrightarrow{r^{*} G} r^{*} \mathbb{K}_{g} \otimes r^{*} g^{*} R \xrightarrow{(r / f)^{\star} \otimes 1} \mathbb{K}_{q} \otimes q^{*} f^{*} R
$$

satisfies the defining property of $(r / f)^{\circ} G$.
Remark 3.27. In addition to the above remark, if the diagram is a fiber-product and $\mathcal{O}^{r}=(q / g)^{\star} \mathcal{O}^{f}$, then both definitions of $(r / f)^{\diamond} G$ coincide. This follows by the uniqueness in the above definition and Lemma 3.19 applied to the following diagram,

noting that $\left(f, \mathcal{O}^{f}\right)^{\diamond} \operatorname{Id}_{R}=\left(\varphi^{\mathcal{O}^{f}}\right)^{R}$.
Lemma 3.28. Consider the following commutative diagram.


Let $\mathcal{O}^{f}, \mathcal{O}^{r}$ be relative orientations of $f, r$. Let $K, R, T$ be $\mathbb{Z} / 2$-bundles over $P, N, L$, respectively. Assume $G: K \rightarrow \mathbb{K}_{g} \otimes g^{*} R$ and $H: R \rightarrow \mathbb{K}_{h} \otimes h^{*} T$ are orientors. Let $\mathcal{O}^{f}$ be a relative orientation of $f$. Set $\mathcal{O}^{r}:=(q / g)^{\star} \mathcal{O}^{f}$. Then

$$
\begin{equation*}
\left(r, \mathcal{O}^{r}\right)^{\diamond}(H \bullet G)=(-1)^{(r-f) H}\left(f, \mathcal{O}^{f}\right)^{\diamond}(H) \bullet(r / f)^{\diamond}(G) \tag{3.2}
\end{equation*}
$$

Lemma 3.29. Assume that the squares in the following diagram are commutative, and that the horizontal arrows are relatively oriented, with relative orientations $\mathcal{O}^{r}, \mathcal{O}^{f}, \mathcal{O}^{t}, \mathcal{O}^{a}$.


Then

$$
((t \circ r) /(a \circ f))^{\diamond}=\underset{35}{(-1)^{a(r-f)}(r / f)^{\diamond} \circ r^{*}(t / a)^{\diamond} .}
$$

Proof. This is a consequence of the uniqueness in Definition 3.25, applying Lemma 3.9,

### 3.1.7. Base extension.

Definition 3.30. Let $\Omega$ be a manifold with corners. Let $A, X, Y$ be orbifolds with corners over $\Omega$ and let $f: X \rightarrow Y$ be a map over $\Omega$. Let $Q, K$ be $\mathbb{Z} / 2$-bundles over $X, Y$, respectively, and let $F$ be a $f$-orientor of $Q$ to $K$. Consider the following Cartesian diagrams.


We denote the pullbacks

$$
F^{A}:=\left(\pi_{X}^{A \times X} / \pi_{Y}^{A \times Y}\right)^{\diamond} F, \quad{ }^{A} F:=\left(\pi_{X}^{X \times A} / \pi_{Y}^{Y \times A}\right)^{\diamond} F .
$$

Lemma 3.31. Let $\Omega$ be a parameter space, let $A, B, X, Y$ be orbifolds with corners over $\Omega$, and let $f: X \rightarrow Y$ be a map over $\Omega$. If $Q, K$ are $\mathbb{Z} / 2$-bundles over $X, Y$, respectively, $F$ is an $f$-orientor of $Q$ to $K$, then

$$
\begin{aligned}
& F^{A \times_{\Omega} B}=\left(F^{B}\right)^{A}, \\
& A \times_{\Omega} B \\
& ={ }^{B}\left({ }^{A} F\right) .
\end{aligned}
$$

Proof of Lemma 3.31. This is an immediate consequence of Lemma 3.23 applied to the following diagrams of fiber-products.


Lemma 3.32. Let $A, X, Y, Z$ be orbifolds with corners over a parameter space $\Omega$, and $X \xrightarrow{f} Y \xrightarrow{g} Z$ be maps over $\Omega$. If $Q, K, R$ are $\mathbb{Z} / 2$-bundles over $X, Y, Z$, respectively, $F$ is an $f$-orientor of $Q$ to $K$ and $G$ is a g-orientor of $K$ to $R$, then

$$
(G \bullet F)^{A}=G^{A} \bullet F^{A}, \quad{ }^{A}(G \bullet F)={ }^{A} G \bullet{ }^{A} F
$$

Proof of Lemma 3.32. This is an immediate consequence of Lemma 3.24 applied to the following diagrams of fiber-products.


### 3.1.8. Base extension and relatively oriented pullback.

Lemma 3.33. In the setting of Definition 3.30, if $\mathcal{O}^{f}$ is a relative orientation of $f$, then $1 \times \mathcal{O}^{f}$ and $\mathcal{O}^{f} \times 1$ are relative orientations for $I d \times f$ and $f \times I d$, respectively, and

$$
\varphi^{1 \times \mathcal{O}^{f}}=\left(\varphi^{\mathcal{O}^{f}}\right)^{A}, \quad \varphi^{\mathcal{O}^{f} \times 1}={ }^{A}\left(\varphi^{\mathcal{O}^{f}}\right) .
$$

Remark 3.34. In the setting of Definition 3.30, if $f$ is a local diffeomorphism, then $\operatorname{Id} \times f$ and $f \times \mathrm{Id}$ are local diffeomorphisms and

$$
\varphi_{\mathrm{Id} \times f}=\left(\varphi_{f}\right)^{A}, \quad \varphi_{f \times \mathrm{Id}}={ }^{A}\left(\varphi_{f}\right)
$$

This follows at once from Lemmas 3.33, 2.42.
Proof of Lemma 3.33. For the first equation, by definition, both sides are given by

$$
\underline{\mathbb{Z} / 2} \ni \underline{1} \mapsto 1 \times \mathcal{O}^{f}=\left(\pi_{X}^{A \times X} / \pi_{Y}^{A \times Y}\right)^{\star} \mathcal{O}^{f} \in \mathbb{K}_{1 \times \mathcal{O}^{f}}
$$

For the second equation, by definition, both sides are given by

$$
\underline{\mathbb{Z} / 2} \ni \underline{1} \mapsto \mathcal{O}^{f} \times 1=\left(\pi_{X}^{X \times A} / \pi_{Y}^{Y \times A}\right)^{\star} \mathcal{O}^{f} \in \mathbb{K}_{\mathcal{O}^{f} \times 1} .
$$

Lemma 3.35. With the setting of Lemma 3.32, assume $\mathcal{O}^{f}$ is a relative orientation of $f$. The $1 \times \mathcal{O}^{f}$ and $\mathcal{O}^{f} \times 1$ are relative orientations of $I d \times f$ and $f \times I d$, respectively. Let $G$ be a $g$-orientor. Then

$$
\left(\left(f, \mathcal{O}^{f}\right)^{\diamond} G\right)^{A}=\left(I d \times f, 1 \times \mathcal{O}^{f}\right)^{\diamond}\left(G^{A}\right), \quad{ }^{A}\left(\left(f, \mathcal{O}^{f}\right)^{\diamond} G\right)=\left(f \times I d, \mathcal{O}^{f} \times 1\right)^{\diamond}\left({ }^{A} G\right)
$$

Proof of Lemma 3.35. We show the first equality. The second equality is left to the reader. First, observe,

$$
\begin{equation*}
\left.\left(\left(\varphi^{\mathcal{O} f}\right)^{K}\right)^{A}=\left(\left(\varphi^{\mathcal{O}^{f}}\right)^{A}\right)^{\pi_{Y}^{*} K} \stackrel{\text { Lem. }}{=}=.33\right]\left(\varphi^{1 \times \mathcal{O}^{f}}\right)^{\pi_{Y}^{*} K} \tag{3.3}
\end{equation*}
$$

Therefore, the lemma is obtained by the following calculation.

$$
\begin{aligned}
& \left(\left(f, \mathcal{O}^{f}\right)^{\diamond} G\right)^{A} \stackrel{\text { Def. } \overline{=} .111}{ }(-1)^{f G}\left(G \bullet\left(\varphi^{\mathcal{O}^{f}}\right)^{K}\right)^{A} \\
& \stackrel{\text { Rem. }}{=}={ }^{[3.32}(-1)^{f G} G^{A} \bullet\left(\left(\varphi^{\mathcal{O}^{f}}\right)^{K}\right)^{A} \\
& \text { eq. }=\left[\begin{array}{ll}
=3.3] \\
= \\
& (-1)^{f G} G^{A} \bullet\left(\varphi^{1 \times \mathcal{O}^{f}}\right)^{\pi_{Y}^{*} K}
\end{array}\right. \\
& \text { Def. } \xlongequal[=]{[3.11}\left(\operatorname{Id} \times f, 1 \times \mathcal{O}^{f}\right)^{\diamond}\left(G^{A}\right) \text {. }
\end{aligned}
$$

Lemma 3.36. With the setting of Lemma 3.32, assume $f$ is a local diffeomorphism. Then, $I d \times f$ and $f \times I d$ are local diffeomorphisms. Let $G$ be a $g$-orientor. Then,

$$
\left(f^{\diamond} G\right)^{A}=(I d \times f)^{\diamond}\left(G^{A}\right), \quad{ }^{A}\left(f^{\diamond} G\right)=(f \times I d)^{\diamond}\left({ }^{A} G\right)
$$

Proof of Lemma 3.36. This is an immediate consequence of Lemma 3.35 and Lemma 2.41,

The proof of the following lemma is similar to that of Lemma 3.35 and thus is omitted.

Lemma 3.37. Consider the following diagram in which all faces are fiber products.


Let $G$ be an $g$-orientor. Then

$$
\left((r / f)^{\diamond} G\right)^{A}=\left(I d_{A} \times r / I d_{A} \times f\right)^{\diamond}\left(G^{A}\right) .
$$

3.1.9. Quotient orientors. For this section, fix an oriented Lie group $G$ with orientation $\mathcal{O}^{G}$, and an orbifold with corners $M$ with a right free proper $G$ action $\Phi: M \times G \rightarrow M$. Denote by $q: M \rightarrow M / G$ the quotient map and by $\pi: M \times G \rightarrow M$ the projection. Denote by $\mathcal{O}_{c}^{\Phi}, \mathcal{O}_{c}^{q}, \mathcal{O}_{c}^{\pi}$ the relative orientations of $\Phi, q, \pi$ from Definition 2.37with respect to $\mathcal{O}^{G}$. Let $G^{\prime}, \mathcal{O}^{G^{\prime}}, M^{\prime}, \Phi^{\prime}, q^{\prime}, \pi^{\prime}$, etc. be another collection as the above. Let $\varphi: G \rightarrow G^{\prime}$ be a homomorphism of groups.

Definition 3.38. With the above setting, a map $h: M \rightarrow M^{\prime}$ is called equivariant if

$$
h \circ \Phi=\Phi^{\prime} \circ(h \times \varphi) .
$$

That is, the following diagram is commutative.


Consider also the following commutative diagram.


For a $G$-equivariant map $h: M \rightarrow M^{\prime}$ and bundles $K, R$ over $M / G, M^{\prime} / G^{\prime}$, respectively, an $h$-orientor $H$ of $q^{*} K$ to $q^{* *} R$ is said to be $G$-equivariant if

$$
\left(\Phi / \Phi^{\prime}\right)^{\diamond} H=\left(\pi / \pi^{\prime}\right)^{\diamond} H
$$

Remark 3.39. An equivariant map $h: M \rightarrow M^{\prime}$ descends to the quotient $\bar{h}: M / G \rightarrow$ $M^{\prime} / G^{\prime}$. That is, there exists a unique map $\bar{h}: M / G \rightarrow M^{\prime} / G^{\prime}$ such that $q^{\prime} \circ h=\bar{h} \circ q$. In diagrammatic form, the following diagram is commutative.


Let $K, R$ be bundles over $M / G, M^{\prime} / G^{\prime}$, respectively. Let $\bar{H}$ be an $\bar{h}$-orientor of $q^{*} K$ to $q^{\prime *} R$. Then $\left(q / q^{\prime}\right)^{\diamond} \bar{H}$ is $G$-equivariant. Indeed, we have

$$
\begin{aligned}
& \left(\Phi / \Phi^{\prime}\right)^{\diamond}\left(q / q^{\prime}\right)^{\wedge} \bar{H} \stackrel{\text { Lem. }}{=} .2 .29(-1)^{G^{\prime}\left(G-G^{\prime}\right)}\left((q \circ \Phi) /\left(q^{\prime} \circ \Phi^{\prime}\right)\right)^{\wedge} \bar{H} \\
& \left.=(-1)^{G^{\prime}\left(G-G^{\prime}\right)}\left(\left(q \circ \pi_{M}\right) /\left(q^{\prime} \circ \pi_{M^{\prime}}\right)\right)^{\wedge} \bar{H} \stackrel{\text { Lem. }}{=}=.29 \text { ( } \pi / \pi^{\prime}\right)^{\circ}\left(q / q^{\prime}\right)^{\circ} \bar{H} .
\end{aligned}
$$

The fact that every $G$-equivariant orientor is of the form $\left(q / q^{\prime}\right)^{\curvearrowright} \bar{H}$ for some $\bar{H}$ is formalized in the following lemma.

Lemma 3.40. Let $h: M \rightarrow M^{\prime}$ be a $G$-invariant map, let $K, R$ be $\mathbb{Z} / 2$ bundles over $\underline{M} / G, M^{\prime} / G^{\prime}$, respectively, and let $H$ be a $G$-equivariant $h$-orientor of $q^{*} K$ to $q^{*} R$. Let $\bar{h}: M / G \rightarrow M^{\prime} / G^{\prime}$ be the map satisfying $q^{\prime} \circ h=\bar{h} \circ q$. There exists a unique $\bar{h}$-orientor $\bar{H}$ of $K$ to $R$ satisfying

$$
H=\left(q / q^{\prime}\right)^{\circ} \bar{H}
$$

Proof. The proof is similar to that of Lemma 3.14. For a sheaf $\mathcal{F}$ with a $G$-action, denote by $\mathcal{F}^{G} \subset \mathcal{F}$ its invariants. Since $h$ is equivariant, $G$ acts on $q_{*}\left(\mathbb{K}_{h} \otimes h^{*} q^{\prime *} R\right)$. Since $H$ is equivariant, under the adjunction of $q^{*}$ and $q_{*}$ it corresponds to a map

$$
\widetilde{H}: K \rightarrow\left(q_{*}\left(\mathbb{K}_{h} \otimes h^{*} q^{\prime *} R\right)\right)^{G}=\left(q_{*}\left(\mathbb{K}_{h} \otimes q^{*} \bar{h}^{*} R\right)\right)^{G}
$$

By the composition isomorphism of Definition 2.25 and the projection formula for sheaves,

$$
\left(q_{*}\left(\mathbb{K}_{h} \otimes q^{*} \psi^{*} R\right)\right)^{G}=\left(q_{*} \mathbb{K}_{h} \otimes \bar{h}^{*} R\right)^{G}=\left(q_{*} \mathbb{K}_{h}\right)^{G} \otimes \bar{h}^{*} R
$$

Consider the map $\left(q / q^{\prime}\right)_{\star}: \mathbb{K}_{\bar{h}} \rightarrow\left(q_{*} \mathbb{K}_{h}\right)^{G}$ corresponding to $\left(q / q^{\prime}\right)^{\star}: q^{*} \mathbb{K}_{\bar{h}} \rightarrow \mathbb{K}_{h}$ under the adjunction of $q^{*}$ and $q_{*}$. Since $G$ acts transitively on the fibers of $q,\left(q / q^{\prime}\right)_{\star}$ is an isomorphism. Denote by $\bar{H}$ the unique $\bar{h}$-orientor of $K$ to $R$ satisfying

$$
\widetilde{H}=\left(\left(q / q^{\prime}\right)_{\star} \otimes 1\right) \circ \bar{H}
$$

By the naturality of the adjunction it follows that

$$
H=\left(\left(q / q^{\prime}\right)^{\star} \otimes 1\right) \circ q^{*} \bar{H}
$$

Recalling Remark 3.26, this is exactly

$$
H=\left(q / q^{\prime}\right)^{\curvearrowleft} \bar{H}
$$

3.1.10. Boundary orientors.

Definition 3.41. The boundary orientor is the $\iota_{f}$-endo-orientor of $\underline{\mathbb{Z} / 2}$

$$
\partial_{f}: \underline{\mathbb{Z} / 2} \rightarrow \mathbb{K}_{\iota_{f}} \otimes \underline{\mathbb{Z} / 2}
$$

given by

$$
\partial_{f}(1)=(-1)^{f} \mathcal{O}_{c}^{\iota_{f}}
$$

Remark 3.42. The composition of $\partial_{f}{ }^{\mathbb{K}_{f}}$ and the composition isomorphism,

$$
\iota_{f}{ }^{*} \mathbb{K}_{f} \xrightarrow{\partial_{f}^{\mathbb{K}_{f}}} \mathbb{K}_{\iota_{f}} \otimes \iota_{f} \mathbb{K}_{f} \stackrel{\text { comp. }}{=} \mathbb{K}_{f \circ \iota_{f}},
$$

is given by

$$
\mathcal{O}^{f} \mapsto(-1)_{39}^{f} \mathcal{O}^{f} \circ \mathcal{O}_{c}^{\iota_{f}}
$$

By abuse of notation, we often denote this composition by $\partial_{f}{ }^{\mathbb{K}_{f}}$. Explicitly, it is given by the contraction with $-\nu_{\text {out }}$ on the right. Indeed, if $x_{1}, \ldots, x_{m-1} \in T_{p} \partial_{f} M$ form a basis, then Remark 2.31 gives

$$
\partial_{f}^{\mathbb{K}_{f}} \mathcal{O}^{f}\left(x_{1} \wedge \ldots \wedge x_{m-1}\right)=-\mathcal{O}^{f}\left(\left(d \iota_{f}\right)_{p} x_{1} \wedge \ldots \wedge\left(d \iota_{f}\right)_{p} x_{m-1} \wedge \nu_{\text {out }}\right) .
$$

Definition 3.43. Let $M \xrightarrow{f} P \xrightarrow{g} N$ be such that $g \circ f$ is a surjective submersion. Assume that $f$ factorizes through the boundary of $g$ in the sense of Definition 2.12. That is, we have the following pullback diagram.


Let $Q, K$ be $\mathbb{Z} / 2$-bundles over $M, P$ respectively, and let $F$ be a $f$-orientor from $Q$ to $K$. The restriction of $F$ to the boundary is $\left(\iota_{g \circ f} / \iota_{g}\right)^{\triangleright} F$, that is, the $\iota_{g}{ }^{*} f$-orientor of $\iota_{g \circ f}^{*} Q$ to $\iota_{g}^{*} K$

$$
\iota_{g \circ f}^{*} Q \xrightarrow{\iota_{g \circ f}^{*} F} \iota_{g \circ f}^{*} \mathbb{K}_{f} \otimes \iota_{g \circ f}^{*} f^{*} K \xrightarrow{\left(\iota_{g \circ f} / \iota_{g}\right)^{*} \otimes \mathrm{Id}} \mathbb{K}_{\iota_{g}{ }^{*} f} \otimes\left(\iota_{g}^{*} f\right)^{*} \iota_{g}^{*} K .
$$

Definition 3.44. Let $M, N, g, Q, K, G$ be as in Definition 3.1. Recall that the $\iota_{g}$-endoorientor $\partial_{g}{ }^{Q}: \iota_{g}^{*} Q \rightarrow \mathbb{K}_{\iota_{g}} \otimes \iota_{g}^{*} Q$ is the $Q$-extension from Definition 3.5 of the boundary orientor from Definition 3.41, The boundary of $G$ is the $\mathbb{K}_{g \circ \iota_{g}}$-orientor of $\iota_{g}^{*} Q$ to $K$,

$$
\partial G=(-1)^{|G|} G \bullet \partial_{g}{ }^{Q} .
$$

Remark 3.45. Recall that the degree of the boundary operator is $\left|\partial_{g}\right|=1$. Thus, if the degree of $G$ is $|G|$, then the degree of $\partial G$ is $|G|+1$.
Example 3.46 (Boundary of orientation). Let $\left(M, \mathcal{O}^{M}\right)$ be an oriented orbifold with corners. Recall the $M$-endo-orientor of $\mathbb{Z} / 2$ denoted by $\varphi^{\mathcal{O}^{M}}$ from Definition 3.3. Then

$$
\partial \varphi^{\mathcal{O}^{M}}=\varphi^{\partial_{M}^{\mathbb{K}_{M}}}\left(\mathcal{O}^{M}\right)=\partial_{M}^{\mathbb{K}_{M}} \circ \varphi^{\mathcal{O}^{M}}
$$

as $\partial M$-endo-orientors of $\mathbb{Z} / 2$. Indeed, acting on the section $\underline{1}$ of $\underline{\mathbb{Z} / 2}$ we have

$$

\partial \varphi^{\mathcal{O}^{M}}(\underline{1})=(-1)^{M}\left(\operatorname{Id}_{\mathbb{K}_{\iota}} \otimes \varphi^{\mathcal{O}^{M}}\right) & \left(\partial_{M}(\underline{1})\right) \\
& =\left(\operatorname{Id}_{\mathbb{K}_{\iota}} \otimes \varphi^{\mathcal{O}^{M}}\right)\left(\mathcal{O}_{c}^{\iota_{M}} \otimes \underline{1}\right)^{\text {Kozsul }}(-1)^{M} \mathcal{O}_{c}^{\iota_{M}} \otimes \mathcal{O}^{M}
\end{aligned}
$$

and

$$
\partial_{M}^{\mathbb{K}_{M}} \circ \varphi^{\mathcal{O}^{M}}(\underline{1})=\partial_{M}^{\mathbb{K}_{M}}\left(\mathcal{O}^{M}\right)=(-1)^{M} \mathcal{O}_{c}^{\iota_{M}} \otimes \mathcal{O}^{M} .
$$

Lemma 3.47. Let $M \xrightarrow{f} P \xrightarrow{g} N$ be such that $g \circ f$ is a surjective submersion and let $Q, K, R$ be $\mathbb{Z} / 2$ bundles over $M, P, N$, respectively. Let $F: Q \rightarrow \mathbb{K}_{f} \otimes f^{*} K$ be a $f$-orientor of $Q$ to $K$ and $G: K \rightarrow \mathbb{K}_{g} \otimes g^{*} R$ be a g-orientor of $K$ to $R$. Assume that $f$ factorizes through the boundary of $g$ as $\iota_{g}{ }^{*} f$, as in Definition 2.12. Then we have an equality of


$$
\iota_{g \circ f}^{*} Q \longrightarrow \mathbb{K}_{g \circ f \circ \iota_{g \circ f}} \otimes\left(g \circ f \circ \iota_{g \circ f}\right)^{*} R
$$

as follows.

$$
\begin{equation*}
\partial(G \bullet F)=\underset{40}{\partial G \bullet\left(\iota_{g \circ f} / \iota_{g}\right)^{\triangleright} F} \tag{3.4}
\end{equation*}
$$

The proof of Lemma 3.47 requires the following remark.
Remark 3.48. Let $M \xrightarrow{f} P \xrightarrow{g} N$ be such that $g \circ f$ is a surjective submersion. Assume that $f$ factorizes through the boundary of $g$ in the sense of Definition 2.12. That is, we have the following pullback diagram.


With the notion of the boundary orientor, Lemma 2.46 can be rephrased as the commutativity of the following diagram.


That is,

\partial_{g \circ f}^{\mathbb{K}_{f}}=\left(\iota_{g \circ f} / \iota_{g}\right)^{\star} \otimes\left(\iota_{g}^{*} f\right)^{*} \partial_{g} . \tag{3.6}

Proof. With the notations of Lemma [2.46, let $\mathcal{O}^{g}$ be a local relative orientation of $g$. Recall the notation

& =(-1)^{f+g} \mathcal{O}^{\iota_{g}{ }^{*} f} \otimes\left(\mathcal{O}_{c}^{\iota_{g}}\right) \\
\stackrel{\text { comp. }}{=} & (-1)^{f+g} \mathcal{O}_{c}^{\iota_{g}} \circ \mathcal{O}^{\iota_{g}{ }^{* f}} \\
\text { Lemma } & \stackrel{\text { L.466 }}{=}(-1)^{f+g} \mathcal{O}^{f} \circ \mathcal{O}_{c}^{\iota_{g \circ f}}=\partial_{g \circ f}^{\mathbb{K}_{f}}\left(\mathcal{O}^{f}\right) .
\end{aligned}
$$

Proof of Lemma 3.47. First, we show that

Indeed, let $q$ be a local section of $\iota_{g \circ f}^{*} Q$. It follows from the Koszul signs of Proposition 2.4 that

& \left(\partial_{g \circ f} \mathbb{K}_{f} \otimes f^{*} K \circ \iota_{g \circ f}^{*} F\right)(q)=\partial_{g \circ f}{ }^{\mathbb{K}_{f} \otimes f^{*} K}(F(q))=(-1)^{f} \mathcal{O}_{c}^{\iota_{g \circ f}} \otimes F(q) .
\end{aligned}

Second, we show that there is an equality of maps

& \stackrel{\text { Koszul }}{=} \stackrel{\text { 2.4 }}{ }(-1)^{|F|}\left[\left(\operatorname{Id} \otimes\left(\iota_{g}{ }^{*} f\right)^{*} \partial_{g}{ }^{K}\right) \circ\left(\left(\iota_{g \circ f} / \iota_{g}\right)^{\star} \otimes \mathrm{Id}\right)\right] \circ \iota_{g \circ f}^{*} F
\end{aligned}
$$

$$
\begin{aligned}
& \stackrel{\text { Def. [3.7 }}{=}(-1)^{|F|} \partial_{g}{ }^{K} \bullet\left(\iota_{g \circ f} / \iota_{g}\right)^{\circ} F \text {. }
\end{aligned}
$$

To prove (3.4), we compile the definitions and use the above equation, as follows.

There is a canonical identification of $\partial_{(\operatorname{Id} \times f)}(A \times X) \simeq A \times \partial_{f} X$. That is, $\pi_{X}$ factorizes through the boundary of $f$ as in Definition 2.12,

Lemma 3.49. Consider the following diagram of Cartesian squares.


Let $Q, K$ be $\mathbb{Z} / 2$-bundles over $X, Y$, respectively, and let $F$ be a $f$-orientor of $Q$ to $K$. Under the identification $\partial_{(I d \times f)}(A \times X) \simeq A \times \partial_{f} X$, it holds that

$$
(\partial F)^{A}=\partial\left(F^{A}\right)
$$

Proof of Lemma 3.49. Notice that

$$
\left(\iota_{f}^{*} \pi_{X} / \pi_{Y}\right)^{\diamond} \partial_{f}=\partial_{(\mathrm{Id} \times f)},
$$

as they are both given by contraction by $-\nu_{\text {out }}$ on the right, as explained in Remark 3.42, Therefore, recalling Definition 3.30 and Definition 3.44, the lemma follows by applying Lemma 3.24 to the above diagram.

& \stackrel{\text { Koszul }}{=}{ }^{[2.4}\left(\operatorname{Id}_{\mathbb{K}_{f}} \otimes \tau_{T, \mathbb{K}_{g}} \otimes \operatorname{Id}_{f^{*} g^{*} R}\right) \circ\left(\tau_{T, \mathbb{K}_{f}} \otimes \operatorname{Id}_{f^{*} \mathbb{K}_{g}} \otimes \operatorname{Id}_{f^{*} g^{*} R}\right) \circ \\
& \circ\left(\operatorname{Id}_{f^{*} g^{*} T} \otimes \operatorname{Id}_{\mathbb{K}_{f}} \otimes f^{*} G\right) \circ\left(\operatorname{Id}_{f^{*} g^{*} T} \otimes F\right) \\

Lemma 3.51. Let $f: M \rightarrow N$ be a map of orbifolds with corners, and let $A, B$ be $\mathbb{Z} / 2$ bundles over $M$ and $C$ be a $\mathbb{Z} / 2$-bundle over $N$. If $F$ is an $f$-orientor of $B$ to $C$, then the following diagrams are commutative.


That is,

$$
\begin{aligned}
\tau_{A, f^{*} C} \bullet{ }^{A} F & =F^{A} \bullet \tau_{A, B}, \\
\tau_{f^{*} C, A} \bullet F^{A} & ={ }^{A} F \bullet \tau_{B, A} .
\end{aligned}
$$

Proof of Lemma 3.51. The second equation is obtained by the first one by composing with $\tau_{B, A}$ on the right and $\tau_{f^{*} C, A}$ on the left. Assume $a, b, c$ are local sections of $A, B, C$ and $\mathcal{O}^{f}$ is a local relative orientation of $f$, such that $F(b)=\mathcal{O}^{f} \otimes f^{*} c$. Then
$\tau_{A, f^{*} C} \bullet{ }^{A} F(a \otimes b)=(-1)^{(F-f) a}\left(\operatorname{Id} \otimes \tau_{A, f^{*} C}\right)\left(\mathcal{O}^{f} \otimes a \otimes f^{*} c\right)=(-1)^{(F-f+c) a} \mathcal{O}^{f} \otimes f^{*} c \otimes a$, while

$$
F^{A} \bullet \tau_{A, B}(b \otimes a)=(-1)^{a b} F^{A}(b \otimes a)=(-1)^{a b} \mathcal{O}^{f} \otimes f^{*} c \otimes a
$$

However, $F+b \equiv_{2} f+c$ by the equality of the degrees of $F(b)=\mathcal{O}^{f} \otimes f^{*} c$. This proves the commutativity of the first diagram.
3.2. Extension to essential subspaces. By Lemma 2.19, All Lemmas of the above section that concern fiber-products or boundary factorization hold for essential fiberproducts and essential boundary factorization.

### 3.3. Extension to arbitrary commutative rings.

Definition 3.52. Let $\mathbb{A}$ be a commutative ring. Let $f: M \rightarrow N$ be a map. Consider the $\mathbb{A}$-representation of $\mathbb{Z} / 2$ given by negation, $(-1) \cdot a=-a$ for $a \in \mathbb{A}$. Then the $\mathbb{A}$-relative orientation bundle $\mathcal{K}_{f} \rightarrow M$ is the local system associated to the negation representation,

$$
\mathcal{K}_{f}=\mathbb{K}_{f} \times_{\mathbb{Z} / 2} \mathbb{A}
$$

Remark 3.53. As $\mathbb{K}_{f}$ is concentrated in degree $-\operatorname{dim} f$, so is $\mathcal{K}_{f}$.
If $Q, K$ are local systems over $M, N$ and $g: M \rightarrow N$ is a map, then a $g$-orientor of $Q$ to $K$ is a morphism of local systems over $M$

$$
G: Q \rightarrow \mathcal{K}_{g} \otimes_{\mathbb{A}} g^{*} K
$$

All definitions, equations and lemmas about $\mathbb{Z} / 2$-orientors extend naturally to orientors of local systems over $\mathbb{A}$.

## 4. Moduli Spaces

4.1. Open stable maps. Let $\left(X_{0}, \omega_{0}\right)$ be a symplectic manifold of dimension $2 n$ and let $L_{0} \subset X_{0}$ be a Lagrangian. Let $\mu_{0}: H_{2}\left(X_{0}, L_{0} ; \mathbb{Z}\right) \rightarrow \mathbb{Z}$ be the Maslov index [1]. The symplectic form $\omega_{0}$ induces a map $\omega_{0}: H_{2}\left(X_{0}, L_{0} ; \mathbb{Z}\right) \rightarrow \mathbb{R}$ given by integration, $\beta \mapsto \int_{\beta} \omega_{0}$. Let $\Pi_{0}$ be a quotient of $H_{2}\left(X_{0}, L_{0} ; \mathbb{Z}\right)$ by a subgroup that is contained in the kernel of $\left(\mu_{0}, \omega_{0}\right): H_{2}\left(X_{0}, L_{0} ; \mathbb{Z}\right) \rightarrow \mathbb{Z} \oplus \mathbb{R}$. Thus, $\mu_{0}, \omega_{0}$ descend to $\Pi_{0}$. Let $J_{0}$ be an $\omega_{0}$-tame almost target structure on $X_{0}$. A $J_{0}$-holomorphic genus- 0 open stable map to ( $X_{0}, L_{0}$ ) of degree $\beta \in \Pi_{0}$ with one boundary component, $k+1$ boundary marked points, and $l$ interior marked points, is a quadruple $\mathfrak{u}:=(\Sigma, u, \vec{z}, \vec{w})$ as follows. The domain $\Sigma$ is a genus-0 nodal Riemann surface with boundary consisting of one connected component. The map of pairs

$$
u:(\Sigma, \partial \Sigma) \rightarrow\left(X_{0}, L_{0}\right)
$$

is continuous, and $J_{0}$-holomorphic on each irreducible component of $\Sigma$, satisfying

$$
u_{*}([\Sigma, \partial \Sigma])=\beta
$$

The boundary marked points and the interior marked points

$$
\vec{z}=\left(z_{0}, \ldots, z_{k}\right), \quad \vec{w}=\left(w_{1}, \ldots, w_{l}\right),
$$

where $z_{j} \in \partial \Sigma, w_{j} \in \stackrel{\circ}{\Sigma}$, are distinct from one another and from the nodal points. The labeling of the marked points $z_{j}$ respects the cyclic order given by the orientation of $\partial \Sigma$ induced by the complex orientation of $\Sigma$. Stability means that if $\Sigma_{i}$ is an irreducible component of $\Sigma$, then either $\left.u\right|_{\Sigma_{i}}$ is non-constant or it satisfies the following requirement: If $\Sigma_{i}$ is a sphere, the number of marked points and nodal points on $\Sigma_{i}$ is at least 3 ; if $\Sigma_{i}$ is a disk, the number of marked and nodal boundary points plus twice the number of marked and nodal interior points is at least 3. An isomorphism of open stable maps

$$
\varphi:(\Sigma, u, \vec{z}, \vec{w}) \rightarrow\left(\Sigma^{\prime}, u^{\prime}, \vec{z}^{\prime}, \vec{w}^{\prime}\right)
$$

is a homeomorphism $\varphi: \Sigma \rightarrow \Sigma^{\prime}$, biholomorphic on each irreducible component, such that

$$
u=u^{\prime} \circ \varphi, \quad z_{j}^{\prime}=\varphi\left(z_{j}\right), \quad j=0, \ldots, k, \quad w_{j}^{\prime}=\varphi\left(w_{j}\right), \quad j=1, \ldots, l .
$$

We denote $\mathfrak{u} \sim \mathfrak{u}^{\prime}$ if there exists an isomorphism of open stable maps $\varphi: \mathfrak{u} \rightarrow \mathfrak{u}^{\prime}$. Denote by $\mathcal{M}_{k+1, l}\left(X_{0}, L_{0}, J_{0} ; \beta\right)$ the moduli space of $J_{0}$-holomorphic genus-0 open stable maps to ( $X_{t}, L_{t}$ ) of degree $\beta$ with one boundary component, $k+1$ marked boundary points and $l$ marked interior points.
4.2. Families. Let $\Omega$ be a manifold with corners. An orbifold with corners $M$ over $\Omega$ is a submersion $\pi^{M}: M \rightarrow \Omega$. We denote by $T^{v} M=\operatorname{ker}\left(d \pi^{M}\right)$ the vertical tangent bundle along $\pi^{M}$. Let $\pi^{N}: N \rightarrow \Omega$ be another orbifold with corners over $\Omega$ and $f: M \rightarrow N$ be a map over $\Omega$. Let $\xi: \Omega^{\prime} \rightarrow \Omega$ be a smooth map of manifolds with corners. As $\pi^{M}$ is a submersion, the fiber product $\xi^{*} M:=\Omega_{\xi}^{\prime} \times{ }_{\pi^{M}} M$ exists. We also get an induced map $\xi^{*} f: \xi^{*} M \rightarrow \xi^{*} N$. The situation is summed up in the following diagram.


Moreover, for a fiber-product

of orbifolds with corners over $\Omega$, we write $\pi_{M}^{M \times P}, \pi_{P}^{M \times P}$ for the corresponding projections. For many purposes, one may assume $\Omega$ is a point.

Definition 4.1. Let $f: M \rightarrow N$ be a map of smooth manifolds. A vector field along $f$ is a section $u$ of the bundle $f^{*} T N \rightarrow M$. A vector field $u$ along $f$ determines a linear map

$$
\begin{aligned}
i_{u}: A^{k}(N) & \rightarrow A^{k-1}(M) \\
\left.i_{u} \rho\left(v_{1}, \ldots, v_{k-1}\right)\right|_{x \in M} & =\rho_{f(x)}\left(u(x), d f_{x}\left(v_{1}(x)\right), \ldots, d f_{x}\left(v_{k-1}(x)\right)\right) .
\end{aligned}
$$

called interior multiplication.
Definition 4.2. Let $\pi^{M}: M \rightarrow \Omega$ be a manifold over $\Omega$. A differential form $\xi \in A^{*}(M)$ is called horizontal with respect to $\pi^{M}$ if its restriction to vertical vector fields vanishes.
Definition 4.3. Let $\pi^{M}: M \rightarrow \Omega$ be a manifold over $\Omega$ and let $\omega \in A^{2}(M)$. The submersion $\pi^{M}: M \rightarrow \Omega$ is called exact with respect to $\omega$ if $\omega$ is horizontal with respect to $\pi^{M}$ and for every vector field $u$ on $\Omega$ there exists a function $f_{u}: M \rightarrow \mathbb{R}$ such that for all vector fields $\widetilde{u}$ on $M$ such that $d \pi^{M}(\widetilde{u})=u$, the 1 -form

$$
i_{\widetilde{u}} \omega-d f_{u}
$$

is horizontal with respect to $\pi^{M}$.
Remark 4.4. When checking whether a submersion is exact with respect to a horizontal 2-form, given a vector field $u$ on $\Omega$, it suffices to construct a lift $\widetilde{u}$ of $u$ to $M$, and a function $f_{u}: M \rightarrow \mathbb{R}$ such that $i_{\widetilde{u}} \omega-d f_{u}$ is horizontal. It follows that for any lift $\widetilde{u}^{\prime}$, the form $i_{\widetilde{u}^{\prime}} \omega-d f_{u}$ is horizontal. Indeed,

$$
i_{\widetilde{u}^{\prime}} \omega-i_{\widetilde{u}} \omega=i_{\left(\widetilde{u}^{\prime}-\widetilde{u}\right)} \omega
$$

is horizontal.

Lemma 4.5. Consider the following commutative diagram,

where $\pi, \pi^{\prime}$ are submersions. Denote by $\xi^{*}(d \pi): \xi^{*} T M \rightarrow \xi^{*} T \Omega$ the map given by

$$
\left.\left(\xi^{*}(d \pi)\right)(v)\right|_{x}=d \pi_{\xi^{M}(x)}(v(x)) .
$$

Assume $\pi$ is exact with respect to the form $\omega \in A^{2}(M)$. Then for every vector field $u$ along $\xi$, there exists a function $f_{u}: M^{\prime} \rightarrow \mathbb{R}$ such that for all vector fields $\widetilde{u}$ along $\xi^{M}$ satisfying $\left(\xi^{*} d \pi\right)(\widetilde{u})=u \circ \pi^{\prime}$, it holds that the 1 -form $i_{\widetilde{u}} \omega-d f_{u} \in A^{1}\left(M^{\prime}\right)$ is horizontal.

Proof. By a standard partition of unit argument, we may assume that $T \Omega$ admits a frame $\left(u_{1}, \ldots, u_{k}\right)$. For $i=1, \ldots, k$, let $f_{i}: M \rightarrow \mathbb{R}$ be the functions corresponding to $u_{i}$ according to Definition 4.3, Let $u$ be a vector field along $\xi$. There exist unique functions $\alpha_{i}: \Omega \rightarrow \mathbb{R}$ for $i=1, \ldots, k$ such that

$$
u(x)=\sum_{i=1}^{k} \alpha_{i}(x) \cdot u_{i}\left(\xi^{M}(x)\right) .
$$

Define

$$
f_{u}:=\left(\sum_{i=1}^{k}\left(\alpha_{i} \circ \pi^{\prime}\right) \cdot\left(f_{i} \circ \xi^{M}\right)\right) .
$$

Similarly to Remark 4.4, it is enough to prove that $i_{\widetilde{u}} \omega-d f_{u}$ is horizontal for a specific $\widetilde{u}$. We proceed to construct $\widetilde{u}$ for which we can compute $i_{\widetilde{u}} \omega$. For $i=1, \ldots, k$, let $\widetilde{u}_{i}$ be vector fields on $M$ such that $d \pi\left(\widetilde{u}_{i}\right)=u_{i}$. Then the vector field $\widetilde{u}$ along $\xi^{M}$ defined by

$$
\widetilde{u}(x):=\sum_{i=1}^{k}\left(\alpha_{i} \circ \pi^{\prime}\right)(x) \cdot \widetilde{u}_{i}\left(\xi^{M}(x)\right)
$$

satisfies

$$
\left(\xi^{*} d \pi\right)(\widetilde{u})=u .
$$

We calculate, using the Leibniz's rule,

$$
i_{\widetilde{u}} \omega-d f_{u}=\sum_{i=1}^{k}\left(\alpha_{i} \circ \pi^{\prime}\right) \cdot\left(\xi^{M^{*}}\left(i_{u_{i}} \omega-d f_{i}\right)\right)-\sum_{i=1}^{k} d\left(\alpha_{i} \circ \pi^{\prime}\right) \cdot\left(f_{i} \circ \xi^{M}\right)
$$

Keeping in mind that pullbacks of horizontal forms are horizontal, all the forms on the right are horizontal.

Corollary 4.6. Recall the notation from diagram (4.1). Let $\omega \in A^{2}(M)$ and assume $\pi^{M}$ is exact with respect to $\omega$. It holds that $\xi^{*} \pi^{M}$ is exact with respect to $\left(\xi^{M}\right)^{*} \omega \in A^{2}\left(\xi^{*} M\right)$.
Definition 4.7. Let $\pi^{X}: X \rightarrow \Omega$ be a manifold with corners over $\Omega$, and let $\omega$ be a closed 2 -form on $X . \pi^{X}$ is called a symplectic fibration if it is a locally trivial fibration such that, for all $t \in \Omega,\left(\pi^{-1}(t),\left.\omega\right|_{\pi^{-1}(t)}\right)$ is a symplectic manifold and the vertical boundary with respect to $\pi^{X}$ is empty. Let $L \subset X$ be a subfibration, that is, the restriction $\pi^{L}:=\left.\pi^{X}\right|_{L}$ is a locally trivial fibration. We say that $L$ is a Lagrangian subfibration if $\left.\omega\right|_{L}$ is horizontal with respect to $\pi^{L}$. That is, the fibers of $\pi^{L}$ are Lagrangian submanifolds in the fibers of $\pi^{X}$. A Lagrangian subfibration is called exact if $\pi^{L}:=\left.\pi^{X}\right|_{L}$ is exact with respect to $\left.\omega\right|_{L}$.

For a vector bundle $V \rightarrow B$, define the characteristic classes $p^{ \pm}(V) \in H^{2}(B ; \mathbb{Z} / 2)$ by

$$
p^{+}(V)=w_{2}(V), \quad p^{-}(V)=w_{2}(V)+w_{1}(V)^{2} .
$$

According to [27], $p^{ \pm}(V)$ is the obstruction to the existence of a $P i n^{ \pm}$structure on $V$. See [27] for a detailed discussion of the definition of the groups Pin ${ }^{ \pm}$and the notion of $\operatorname{Pin}^{ \pm}$structures. We say that the fibration $X \supset L \rightarrow \Omega$ is relatively $\operatorname{Pin}^{ \pm}$if $p^{ \pm}\left(T^{v} L\right) \in \operatorname{Im}\left(i^{*}: H^{2}(X) \rightarrow H^{2}(L)\right)$, and $\operatorname{Pin}^{ \pm}$if $p^{ \pm}\left(T^{v} L\right)=0$. A relative $\operatorname{Pin}^{ \pm}$ structure $\mathfrak{p}$ on $L$ is a relative $\mathrm{Pin}^{ \pm}$structure on $T^{v} L$.

Remark 4.8. The condition that the vertical boundary with respect to $\pi^{X}$ is empty may be replaced with an appropriate convexity property.

We fix a symplectic fibration $\left(X, \omega, \Omega, \pi^{X}\right)$ with an exact Lagrangian subfibration $L$ whose fibers are connected. For $t \in \Omega$, we write $X_{t}, L_{t}$ for the fibers of $\pi^{X}, \pi^{L}$, respectively, and $\omega_{t}$ for the restriction of $\omega$ to $X_{t}$. Set

$$
\mathbb{L}_{L}:=\mathbb{K}_{\pi^{L}}[1-n] .
$$

Definition 4.9. We say that the fibration $L$ is vertically orientable if $\left(\pi_{*}^{L} \mathbb{L}_{L}\right) \neq \varnothing$. This is equivalent to the fiber being orientable.

Definition 4.10. Let $b \in \mathbb{Z}$. We define a sheaf on $\Omega$

$$
\mathcal{X}_{L}^{b}:=\pi_{*}^{L}\left(\mathbb{L}_{L}^{\otimes b}\right) .
$$

Definition 4.11. $b \in \mathbb{Z}$ is called an exponent for $L$ if $\mathcal{X}_{L}^{b}$ is nonempty. In this case, the canonical map $\pi_{L}^{*} \mathcal{X}_{L}^{b} \rightarrow \mathbb{L}_{L}^{\otimes b}$ is an isomorphism, since both are $\mathbb{Z} / 2$ local systems.
Remark 4.12. $b \in \mathbb{Z}$ is an exponent for $L$ if and only if $b$ is even or $L$ is vertically oriented.
Definition 4.13. Let $\underline{H_{2}}(X, L ; \mathbb{Z})$ be the sheaf over $\Omega$ given by sheafification of the presheaf with sections over an open set $U \subset \Omega$ given by $H_{2}\left(\left(\pi^{X}\right)^{-1}(U),\left(\pi^{L}\right)^{-1}(U) ; \mathbb{Z}\right)$.

The sheaf $\underline{H_{2}}(X, L ; \mathbb{Z})$ is the local system with fiber $H_{2}\left(X_{t}, L_{t} ; \mathbb{Z}\right)$ for $t \in \Omega$, with the Gauss Manin connection. Let $\underline{\mu}: \underline{H_{2}}(X, L ; \mathbb{Z}) \rightarrow \underline{\mathbb{Z}}$ be the bundle map given by the fiberwise Maslov index. Moreover, let $\underline{\omega}: \underline{H_{2}}(X, L ; \mathbb{Z}) \rightarrow \underline{\mathbb{R}}$ be the bundle map given over $t \in \Omega$ by

$$
\left.\underline{\omega}\right|_{t}\left(\beta_{t}\right)=\int_{\beta_{t}} i_{t}^{*} \omega,
$$

where $i_{t}: X_{t} \rightarrow X$ is the inclusion.
Lemma 4.14. The bundle maps $\underline{\mu}, \underline{\omega}$ are constant on local sections of $\underline{H_{2}}(X, L ; \mathbb{Z})$.
Proof. For $\mu$, the claim is clear since $\mathbb{Z}$ is discrete. For $\underline{\omega}$, it is enough to show that the map is constant on any path $\gamma:[0,1] \rightarrow \Omega$. Let $s \in[0,1]$ denote the parameter. Let $\beta$ be a section of $\gamma^{*} \underline{H_{2}}(X, L ; \mathbb{Z})$, and let

$$
\sigma:(\Sigma \times[0,1], \partial \Sigma \times[0,1]) \rightarrow(X, L)
$$

be such that the following diagram is commutative
and $\left[\left.\sigma\right|_{\Sigma \times\{s\}}\right]=\left.\beta\right|_{\gamma(s)}$. Let $\xi=\frac{\partial \sigma}{\partial s}$. Recall that $L$ is an exact Lagrangian subfibration. By Lemma 4.5 applied to the above diagram with $u=\partial_{s}$ and $\widetilde{u}=\xi$, there exists a function $f: \partial \Sigma \times[0,1] \rightarrow \mathbb{R}$ such that $i_{\xi} \omega-d f$ is horizontal with respect to $\pi_{[0,1]}$. Since $[0,1]$ is one dimensional and $\pi_{[0,1]}^{*} d s$ is a horizontal 1-form, it follows that

$$
\begin{equation*}
\pi_{[0,1]}^{*} d s \wedge\left(i_{\xi} \omega-d f\right)=0 \tag{4.2}
\end{equation*}
$$

Since $d \omega=0$,

$$
\begin{aligned}
\left.\int_{\left.\beta\right|_{\gamma(1)}} \omega\right|_{\gamma(1)}-\left.\int_{\left.\beta\right|_{\gamma(0)}} \omega\right|_{\gamma(0)} \stackrel{\text { Stokes }}{=} \int_{\partial \Sigma \times[0,1]} \sigma^{*} \omega=\int_{\partial \Sigma \times[0,1]}\left(\pi_{[0,1]}\right)^{*} d s \wedge i_{\xi} \omega \\
\text { eq. } \stackrel{[4.2]}{=} \int_{\partial \Sigma \times[0,1]}\left(\pi_{[0,1]}\right)^{*} d s \wedge d f .
\end{aligned}
$$

However, by Stoke's theorem again,

$$
\int_{\partial \Sigma \times[0,1]}\left(\pi_{[0,1]}\right)^{*} d s \wedge d f=-\int_{\partial \Sigma \times[0,1]} d\left(f \cdot\left(\pi_{[0,1]}\right)^{*} d s\right)=-\int_{\partial \Sigma \times\{0,1\}} f \cdot\left(\pi_{[0,1]}\right)^{*} d s=0
$$

Therefore,

$$
\left.\int_{\left.\beta\right|_{\gamma(1)}} \omega\right|_{\gamma(1)}=\left.\int_{\left.\beta\right|_{\gamma(0)}} \omega\right|_{\gamma(0)} .
$$

This completes the proof.
Definition 4.15. A target is an octuple $\mathcal{T}:=\left(\Omega, X, \omega, L, \pi^{X}, \mathfrak{p}, \underline{\Upsilon}, J\right)$ as follows.
(a) $\Omega$ is manifold with corners.
(b) $\pi^{X}: X \rightarrow \Omega$ is a symplectic fibration with respect to $\omega$.
(c) $L \subset X$ is an exact Lagrangian subfibration with a relative $\operatorname{Pin}^{ \pm}$structure $\mathfrak{p}$.
(d) $\underline{\Upsilon} \subset \operatorname{ker}(\underline{\mu} \oplus \underline{\omega})$ is a sub-bundle such that the quotient $\underline{H_{2}}(X, L ; \mathbb{Z}) / \underline{\Upsilon}$ is a globally constant sheaf.
(e) $J=\left\{J_{t}\right\}_{t \in \Omega}$ is a $\omega$-tame almost complex structure on $T^{v} X$.

The dimension of $\mathcal{T}$ is defined to be $\operatorname{dim} \mathcal{T}:=\operatorname{dim} \pi^{X}$.
Definition 4.16. Let $\mathcal{T}:=\left(\Omega, X, \omega, L, \pi^{X}, \mathfrak{p}, \underline{\Upsilon}, J\right)$ be a target. The group of degrees of $\mathcal{T}$ which we denote by $\Pi:=\Pi(\mathcal{T})$ is the fiber of $H_{2}(X, L ; \mathbb{Z}) / \underline{\Upsilon}$. Lemma 4.14 implies that the bundle-maps $\underline{\mu}, \underline{\omega}$ descend to maps $\mu: \Pi \rightarrow \overline{\mathbb{Z}}$ and $\omega: \Pi \rightarrow \mathbb{R}$. A degree $\beta \in \Pi$ is called admissible if $\mu(\beta)+1$ is an exponent for $L$. Denote by $\Pi^{a d} \subset \Pi$ the admissible degrees.
Example 4.17. Consider $\mathbb{R} P^{1}$ as lines in the $y z$ plane and $S^{2}$ as the unit vectors in the $x y z$ space. For $t \in \mathbb{R} P^{1}$ and a vector $\vec{v} \in S^{2}$, we denote $\vec{v} \perp t$ if $\vec{v}$ is perpendicular to $t$. Set $\Omega=\mathbb{R} P^{1}$ and $X=\mathbb{R} P^{1} \times S^{2}$. Denote by $\pi: X \rightarrow \Omega$ and $p: X \rightarrow S^{2}$ the projections. Let $\omega=p^{*} \omega_{0}$ and $J=p^{*} J_{0}$ where $\omega_{0}, J_{0}$ are the standard symplectic form and complex structure on $S^{2}$, respectively. Let

$$
L=\{(t, \vec{v}) \in X \mid \vec{v} \perp t\} .
$$

Namely, $L$ is a circle rotating on its diameter. Note that $\left.\omega\right|_{L}=0$. In particular, $L \subset X$ is an exact Lagrangian subfibration. It is both relatively $\mathrm{Pin}^{+}$and relatively $\mathrm{Pin}^{-}$. This may be seen as follows. $L$ is the Klein bottle and $T^{v} L \simeq\left(\pi^{L}\right)^{*} \mathcal{O}_{\mathbb{R} P^{1}}(-1)$. By the naturality of the characteristic classes $p^{ \pm}$, it follows that $L$ is both Pin $^{+}$and Pin $^{-}$as a fibration. Let $\mathfrak{p}$ be any $\operatorname{Pin}^{ \pm}$structure on $L$. The fibration $L$ is vertically orientable, yet the map $\pi^{L}$ is not relatively orientable. Moreover, we have

$$
H_{2}\left(X_{t}, L_{t} ; \mathbb{Z}\right)=\mathbb{Z} \oplus \mathbb{Z}
$$

and parallel transporting $(x, y) \in H_{2}\left(X_{t}, L_{t} ; \mathbb{Z}\right)$ along the loop $\mathbb{R} P^{1}$ we get $(x, y) \mapsto(y, x)$. Let $\underline{\Upsilon}=\operatorname{ker}(\mu \oplus \underline{\omega})$ which is the Möbius $\mathbb{Z}$ bundle over $\mathbb{R} P^{1}$. Then

$$
\mathcal{T}_{0}:=\left(\Omega, X, \omega, L, \pi^{X}, \mathfrak{p}, \underline{\Upsilon}, J\right)
$$

is a target. It holds that $\Pi\left(\mathcal{T}_{0}\right)=\mathbb{Z}$. Alternatively, we can take $\underline{\Upsilon}=2 \cdot \operatorname{ker}(\underline{\mu} \oplus \underline{\omega})$ and then $\Pi=\mathbb{Z} \oplus \mathbb{Z} / 2$.
Definition 4.18. Let $\mathcal{T}:=\left(\Omega, X, \omega, L, \pi^{X}, \mathfrak{p}, \underline{\Upsilon}, J\right)$ be a target. Let $\Omega^{\prime}$ be a manifold with corners and $\xi: \Omega^{\prime} \rightarrow \Omega$ be a smooth map. By Corollary 4.6, $\xi^{*} L \subset \xi^{*} X$ is exact with respect to $\xi^{X^{*}} \omega$. Thus, the octuple

$$
\xi^{*} \mathcal{T}=\left(\Omega^{\prime}, \xi^{*} X, \xi^{*} \omega, \xi^{*} L, \xi^{*} \pi^{X}, \xi^{*} \mathfrak{p}, \xi^{*} \underline{\Upsilon}, \xi^{*} J\right)
$$

is a target. Since pullback of sheaves is an exact functor, the canonical map

$$
\underline{H_{2}}\left(\xi^{*} X, \xi^{*} L ; \mathbb{Z}\right) / \xi^{*} \underline{\Upsilon} \rightarrow \xi^{*}\left(\underline{H_{2}}(X, L ; \mathbb{Z}) / \underline{\Upsilon}\right)
$$

is an isomorphism, so $\xi^{*} \mathcal{T}$ is indeed a target. In particular, the canonical map

$$
\xi^{*}: \Pi(\mathcal{T}) \rightarrow \Pi\left(\xi^{*} \mathcal{T}\right)
$$

is an isomorphism.
Definition 4.19. Fix a target $\mathcal{T}=\left(\Omega, X, \omega, L, \pi^{X}, \mathfrak{p}, \Upsilon, J\right)$. For $k \geq-1, l \geq 0$ and $\beta \in \Pi$, denote by

$$
\mathcal{M}_{k+1, l}(\beta):=\mathcal{M}_{k+1, l}(\mathcal{T} ; \beta):=\left\{(t, \mathfrak{u}) \mid t \in \Omega, \mathfrak{u} \in \mathcal{M}_{k+1, l}\left(X_{t}, L_{t}, J_{t} ; \beta_{t}\right)\right\}
$$

Denote by $\pi^{\mathcal{M}}: \mathcal{M}_{k+1, l}(\beta) \rightarrow \Omega$ the map $(t, \mathfrak{u}) \mapsto t$. Denote by

$$
\begin{array}{ll}
e v b_{j}^{(k, l, \beta)}: \mathcal{M}_{k+1, l}(\beta) \rightarrow L, & j=0, \ldots, k \\
e v i_{j}^{(k, l, \beta)}: \mathcal{M}_{k+1, l}(\beta) \rightarrow X, & j=1, \ldots, l
\end{array}
$$

the evaluation maps given by

$$
\begin{aligned}
& e v b_{j}^{(k, l, \beta)}(t,(\Sigma, u, \vec{z}, \vec{w}))=\left(t, u\left(z_{j}\right)\right) \\
& e v i_{j}^{(k, l, \beta)}(t,(\Sigma, u, \vec{z}, \vec{w}))=\left(t, u\left(w_{j}\right)\right) .
\end{aligned}
$$

We may omit part or all superscripts $(k, l, \beta)$ when they are clear from the context.
To streamline the exposition, we assume that $\mathcal{M}_{k+1, l}(\beta)$ are smooth orbifolds with corners and $e v b_{0}^{\beta}$ are submersions for $\beta \in \Pi$. These assumptions hold in a range of important examples [40, Example 1.5].

In general, the moduli spaces $\mathcal{M}_{k+1, l}(\beta)$ are only metrizable spaces. They can be highly singular and have varying dimension. Nonetheless, the theory of the virtual fundamental class being developed by several authors [5, 9, 10, 12, 13] allows one to perturb the $J$ holomorphic map equation to obtain moduli spaces that are weighted branched orbifolds with corners and evaluation maps that are smooth. Thus, we may consider $e v b_{0}$-orientors. Furthermore, by averaging over continuous families of perturbations, one can make $e v b_{0}^{\beta}$ behave like a submersion. So, fiber-products along $e v b_{0}^{\beta}$ exist. See [5, 4, 10]. When the unperturbed moduli spaces are smooth of expected dimension and $e v b_{0}^{\beta}$ is a submersion, one can choose the perturbations to be trivial. Furthermore, as explained in [5, 9], one can make the perturbations compatible with forgetful maps of boundary marked points. The compatibility of perturbations with forgetful maps of interior marked points has not yet been fully worked out in the Kuranishi structure formalism.

Remark 4.20. If $\xi: \Omega^{\prime} \rightarrow \Omega$ is a map, $\mathcal{T}:=\left(\Omega, X, \omega, L, \pi^{X}, \mathfrak{p}, \underline{\Upsilon}, J\right)$ is a target and $\beta \in \Pi(\mathcal{T})$, then

$$
\mathcal{M}_{k+1, l}\left(\xi^{*} \mathcal{T} ; \xi^{*}(\beta)\right)=\xi^{*} \mathcal{M}_{k+1, l}(\mathcal{T} ; \beta)
$$

Moreover, for $i \leq k$ and $j \leq l$,

$$
e v b_{i}^{\left(\xi^{*} \mathcal{T}\right)}=\xi^{*}\left(e v b_{i}^{\mathcal{T}}\right), \quad e v i_{j}^{\left(\xi^{*} \mathcal{T}\right)}=\xi^{*}\left(e v i_{j}^{\mathcal{T}}\right) .
$$

For a finite list of indices $I$, let $\mathcal{M}_{k+1, I}(\beta)$ denote the moduli space diffeomorphic to $\mathcal{M}_{k+1,|I|}(\beta)$ with interior marked points labeled by $I$. It carries evaluation maps $e v b_{i}^{\beta}$ for indices $i=0, \ldots, k$ and $e v i_{j}^{\beta}$ for indices $j \in I$.

The orbifold structure of $\mathcal{M}_{k+1, I}(\beta)$ arises from the automorphisms of open stable maps. Vertical corners of codimension $r$ along the map $\pi^{\mathcal{M}}$ consist of open stable maps $(\Sigma, u, \vec{z}, \vec{w})$ where $\Sigma$ has $r$ boundary nodes. For $r=0,1,2, \ldots$ denote by

$$
\mathcal{M}_{k+1, I}(\beta)^{(r)} \subset \mathcal{M}_{k+1, I}(\beta)
$$

the dense open subset consisting of stable maps with no more than $r$ boundary nodes and no interior nodes. Each of these subspaces is an essential subset of $\mathcal{M}_{k+1, I}(\beta)$. A precise description of the vertical corners in the case $r=1$ is given in terms of gluing maps, as follows.

Let $k \geq-1, l \geq 0, \beta \in \Pi$. Fix partitions $k_{1}+k_{2}=k+1, \beta_{1}+\beta_{2}=\beta$ and $I \dot{\cup} J=[l]$, where $k_{1}>0$ if $k+1>0$. When $k+1>0$, let $0<i \leq k_{1}$. When $k=-1$ let $i=0$. Let

$$
B_{i, k_{1}, k_{2}, I, J}^{(1)}\left(\beta_{1}, \beta_{2}\right) \subset \partial \mathcal{M}_{k+1, l}^{(1)}(\beta)
$$

denote the locus of two component stable maps, described as follows. One component has degree $\beta_{1}$ and the other component has degree $\beta_{2}$. The first component carries the boundary marked points labeled $0, \ldots, i-1, i+k_{2}, \ldots, k$, and the interior marked points labeled by $I$. The second component carries the boundary marked points labeled $i, \ldots, i+k_{2}-1$ and the interior marked points labeled by $J$. The two components are joined at the $i$ th boundary marked point on the first component and the 0th boundary marked point on the second. Let

$$
B_{i, k_{1}, k_{2}, I, J}\left(\beta_{1}, \beta_{2}\right):=\overline{B_{i, k_{1}, k_{2}, I, J}^{(1)}\left(\beta_{1}, \beta_{2}\right)} \subset \partial \mathcal{M}_{k+1, l}(\beta)
$$

denote the closure. Denote by

$$
\iota_{i, k_{1}, k_{2}, I, J}^{\beta_{1}, \beta_{2}}: B_{i, k_{1}, k_{2}, I, J}\left(\beta_{1}, \beta_{2}\right) \rightarrow \mathcal{M}_{k+1, l}(\beta)
$$

the inclusion of the boundary.
There is a canonical gluing map

$$
\vartheta_{i, k_{1}, k_{2}, \beta_{1}, \beta_{2}, I, J}: \mathcal{M}_{k_{1}+1, I}\left(\beta_{1}\right)_{e v b_{i}^{\beta_{1}}} \times_{e v b_{0}^{\beta_{2}}} \mathcal{M}_{k_{2}+1, J}\left(\beta_{2}\right) \rightarrow B_{i, k_{1}, k_{2}, I, J}\left(\beta_{1}, \beta_{2}\right) .
$$

This map is a diffeomorphism, unless $k=-1, I=\emptyset=J$ and $\beta_{1}=\beta_{2}$. In the exceptional case, $\vartheta$ is a 2 to 1 local diffeomorphism in the orbifold sense. The dense open subset

$$
\mathcal{M}_{k_{1}+1, I}^{(0)}\left(\beta_{1}\right) \times_{L} \mathcal{M}_{k_{2}+1, J}^{(0)}\left(\beta_{2}\right)
$$

is carried by $\vartheta_{i, k_{1}, k_{2}, \beta_{1}, \beta_{2}, I, J}$ onto $B_{i, k_{1}, k_{2}, I, J}^{(1)}\left(\beta_{1}, \beta_{2}\right)$. We abbreviate

$$
\vartheta^{\beta}=\vartheta_{i, k_{1}, k_{2}, \beta_{1}, \beta_{2}, I, J}
$$

when it creates no ambiguity. The images of all such $\vartheta^{\beta}$ intersect only in codimension 2 , and cover the vertical boundary of $\mathcal{M}_{k+1, l}(\beta)$, unless $k=-1$ and $\beta \in \operatorname{Im}\left(\Gamma\left(\underline{H_{2}}(X ; \mathbb{Z})\right) \rightarrow\right.$ $\Pi)$. In the exceptional case, there might occur another phenomenon of bubbling, which will not be relevant to this paper.

## 5. Orientors and the gluing map

Fix a target $\mathcal{T}=\left(\Omega, X, \omega, L, \pi^{X}, \mathfrak{p}, \underline{\Upsilon}, J\right)$. In the rest of this section we generalize the result of [7, Proposition 8.3.3], which discusses the orientation of the gluing map $\vartheta^{\beta}$ of Section 4.1. In [7, Proposition 8.3.3] the moduli spaces are canonically oriented, and it is determined whether $\vartheta^{\beta}$ preserves orientation. In our case, the moduli spaces may be non-orientable. There is only an $e v b_{0}$-orientor of a bundle given in terms of the bundle $\mathbb{L}_{\pi^{L}}$, see Definition 5.19 for the construction of the orientors. As a diffeomorphism, the map $\vartheta^{\beta}$ induces a map

$$
\vartheta^{\beta^{\star}}: \vartheta^{\beta^{*}} \mathbb{K}_{e v b_{0}^{\beta} \circ \iota^{\beta}} \rightarrow \mathbb{K}_{e v b_{0}^{\beta_{1}} \circ p_{1}}
$$

where $p_{1}: \mathcal{M}_{k_{1}+1, I}\left(\beta_{1}\right) \times_{L} \mathcal{M}_{k_{2}+1, J}\left(\beta_{2}\right) \rightarrow \mathcal{M}_{k_{1}+1, I}\left(\beta_{1}\right)$ is the projection. In this section we write a formula for $\vartheta^{\beta^{\star}}$ in terms of the bundle $\mathbb{L}_{L}$. See Theorem 5.25.
5.1. Conventions and notations of one moduli space. We identify $D^{2}$ with the unit disk in $\mathbb{C}$ and identify $S^{1}$ with $\partial D^{2}$. In particular, $D^{2}$ carries the induced orientation of $\mathbb{C}$ and $S^{1}$ carries the induced orientation of the boundary of $D^{2}$, which is counterclockwise. In particular, for points $z_{0}, z_{1} \in \partial D^{2}$ there is a notion of oriented segment $\left[z_{0}, z_{1}\right]$.

Following [7, Section 8.3] we fix an orientation for $\operatorname{Aut}\left(D^{2}\right) \simeq P S L_{2}(\mathbb{R})$ as follows. Recall that $\operatorname{Aut}\left(D^{2}\right)$ acts from the left on $D^{2}$ and $S^{1}$ by Möbius transformations

$$
\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right) \cdot z=\frac{a z+b}{c z+d} .
$$

We let it act from the right on $D^{2}$ and $S^{1}$ by $(z, g) \mapsto g^{-1} \cdot z$.
Definition 5.1. The canonical orientation $\mathcal{O}_{c}^{\operatorname{Aut}\left(D^{2}\right)}$ of $\operatorname{Aut}\left(D^{2}\right)$ is given as follows. We pick three points $z_{0}, z_{1}, z_{2} \in S^{1}$ ordered counterclockwise. We embed $\operatorname{Aut}\left(D^{2}\right)$ as an open subset of $S^{1} \times S^{1} \times S^{1}$ by

$$
g \mapsto\left(g^{-1} \cdot z_{0}, g^{-1} \cdot z_{1}, g^{-1} \cdot z_{2}\right)
$$

and we equip $\operatorname{Aut}\left(D^{2}\right)$ with the induced orientation.
For a finite set $I$, set

$$
\mathcal{W}_{k+1, I}=\mathcal{M}_{k+1, I}(\beta=0 ; X=\Omega, L=\Omega)
$$

Set

$$
\widehat{\mathcal{W}_{k+1, I}}:=\Omega \times\left\{\begin{array}{c|cc}
\left(z_{0}, \ldots, z_{k}\right) \in\left(S^{1}\right)^{k+1}, & \forall j_{1}, j_{2} \leq k, \quad j_{1} \neq j_{2} \Longrightarrow z_{j_{1}} \neq z_{j_{2}}, \\
\left\{z_{j}, \ldots, z_{k}\right) & \text { is cyclically ordered, } \\
\{ \}_{j \in I} \in\left(\operatorname{int} D^{2}\right)^{I} & \forall z_{1}, j_{2} \in I, \quad j_{1} \neq j_{2} \Longrightarrow z_{j_{1}} \neq z_{j_{2}}
\end{array}\right\}
$$

The moduli space $\mathcal{W}_{k+1, I}$ is nonempty only if $k+2|I| \geq 2$, since constant maps are unstable unless the condition on the number of marked points holds. If it is nonempty, then

$$
\begin{equation*}
\mathcal{W}_{k+1, I}^{(0)}=\widehat{\mathcal{W}_{k+1, I}} / \operatorname{Aut}\left(D^{2}\right) \tag{5.1}
\end{equation*}
$$

Definition 5.2. Let

$$
U_{k+1, I}: \mathcal{M}_{k+1, I}(\beta) \rightarrow \mathcal{W}_{k+1, I}
$$

denote the map that forgets the holomorphic map and contracts unstable components. For $k \geq 0$, define

$$
E v_{k+1, I}^{\beta}: \mathcal{M}_{k+1, I}(\beta) \rightarrow \underset{\times_{\Omega}}{\mathcal{W}_{k+1, I},} \quad E v_{k+1, I}^{\beta}=\left(e v b_{0}^{\beta}, U_{k+1, I}\right)
$$

Assume that $I \subset[l]$. Denote $\hat{I}=I \dot{\cup}\{l+1\}$. Let

$$
F i_{k+1, I}^{\beta}: \mathcal{M}_{k+1, \hat{I}}(\beta) \rightarrow \mathcal{M}_{k+1, I}(\beta)
$$

denote the map that forgets the $|I|+1$ st interior point and contracts unstable components. Moreover, denote by

$$
F i_{k+1, I}: \mathcal{W}_{k+1, \hat{I}} \rightarrow \mathcal{W}_{k+1, I}
$$

the forgetful map when $X=L=\Omega$.
Similarly, let

$$
F b_{k+1, I}^{\beta}: \mathcal{M}_{k+2, I}(\beta) \rightarrow \mathcal{M}_{k+1, I}(\beta)
$$

denote the map that forgets the $k+1$ st boundary point and contracts unstable components. Denote by

$$
F b_{k+1, I}: \mathcal{W}_{k+2, I} \rightarrow \mathcal{W}_{k+1, I}
$$

the forgetful map when $X=L=\Omega$.
Moreover, for $k \geq 0$, let $f^{\beta}: \mathcal{M}_{k+1, l}(\beta) \rightarrow \mathcal{M}_{k+1, l}(\beta)$ be given by

$$
f^{\beta}\left(\Sigma, u,\left(z_{0}, \ldots, z_{k}\right), \vec{w}\right)=\left(\Sigma, u,\left(z_{1}, \ldots z_{k}, z_{0}\right), \vec{w}\right),
$$

the cyclic map. Denote by $f$ the map $f^{\beta}$ when $X=L=\Omega$.
It holds that

$$
e v i_{j} \circ f^{\beta}=e v i_{j}, \quad e v b_{k} \circ f^{\beta}=e v b_{0}, \quad e v b_{j} \circ f^{\beta}=e v b_{j+1}, j=0, \ldots, k-1
$$

Assume $k+2|I| \geq 2$. The following diagrams are essential pullbacks.


Moreover, for $k \geq 0$ the following diagram is a pullback diagram.

For $k \geq 0$, we extend the boundary marked points from the set of indices $\{0, \ldots, k\}$ to the set $\mathbb{Z}$ cyclicly. For example, $z_{k+1}=z_{0}$, and $z_{-1}=z_{k}$.
Definition 5.3. Let $k \geq 0$. For $i, j \in \mathbb{Z}$, the boundary transport map is the degree 0 isomorphism

$$
c_{i j}:\left(e v b_{j}^{\beta}\right)^{*} \mathbb{L}_{L} \xrightarrow{\sim}\left(e v b_{i}^{\beta}\right)^{*} \mathbb{L}_{L},
$$

given as follows. Define $c_{i i}$ to be the identity. Assume $i<j$. We construct $c_{i j}$ at a point $(t, \mathfrak{u})=(t,(\Sigma, u, \vec{z}, \vec{w})) \in \mathcal{M}_{k+1, I}(\beta)$. We then define $c_{j i}=c_{i j}^{-1}$. The complex structure of $\Sigma$ provides $\partial \Sigma=\sum_{r} S^{1} / \sim$ with the boundary orientation. Consider the unique up to homotopy oriented arc $\gamma:[0,1] \rightarrow \partial \Sigma$ from $z_{i}$ to $z_{j}$, that passes through $z_{i+1}, \ldots, z_{j-1}$ in order, and switches components whenever it reaches a nodal point. Then $u \circ \gamma$ defines a path in $L_{t}$ from $u\left(z_{i}\right)$ to $u\left(z_{j}\right)$. Trivializing $\left.(u \circ \gamma)^{*} \mathbb{L}_{L}\right|_{t}$, as $[0,1]$ is contractible, we get an isomorphism

$$
c_{i j}^{u}:\left.\left.\mathbb{L}_{L}\right|_{t, u\left(z_{j}\right)} ^{52} \rightarrow \mathbb{L}_{L}\right|_{t, u\left(z_{i}\right)} .
$$

If $\varphi: \mathfrak{u} \rightarrow \mathfrak{u}^{\prime}$ is an isomorphism of stable maps, then since $\varphi$ preserves orientation and marked points,

$$
c_{i j}^{u}=c_{i j}^{u^{\prime}} .
$$

Moreover, since $c_{i j}^{u}$ depends continuously on $(t, \mathfrak{u})$ in the Gromov topology, we get a continuous map

$$
c_{i j}:\left(e v b_{j}^{\beta}\right)^{*} \mathbb{L}_{L} \rightarrow\left(e v b_{0}^{\beta}\right)^{*} \mathbb{L}_{L}
$$

on $\mathcal{M}_{k+1, I}(\beta)$.

The following remarks imply that $c_{i j}$ for $i, j \in \mathbb{Z}$ is determined by $c_{0 l}$ for $l \in\{0, \ldots, k\}$.
Remark 5.5 (Full circle). The isomorphism $c_{0, k+1}$ gives the involution $(-1)^{\mu(\beta)}$ of $e v b_{0}^{\beta^{*}} \mathbb{L}_{L}$. Remark 5.6 (Group-like). Let $i, j, k \in \mathbb{Z}$ be indices. Then

$$
c_{i k}=c_{i j} \circ c_{j k} .
$$

The proof of the following lemma is left to the reader.
Lemma 5.7 (Properties of boundary transport). Let $k, l \geq 0$. Then the following equations hold.

$$
\begin{aligned}
\left(F b_{k+1, I}^{\beta}\right)^{*} c_{0 j} & =c_{0 j}, & 0 \leq j \leq k, \\
\left(F i_{k+1, I}^{\beta}\right)^{*} c_{0 j} & =c_{0 j}, & 0 \leq j \leq k, \\
\left(f^{\beta}\right)^{*} c_{0 j} & =c_{1, j+1} . &
\end{aligned}
$$

5.2. Cauchy-Riemann Pin boundary problems. We recall here a number of definitions and results from [38]. See also [7, Chapter 8] and [39]. In the following, given a vector bundle over a manifold $V \rightarrow M$, we denote by $\Gamma(V)$ an appropriate Banach space completion of the smooth sections of $V$.
Definition 5.8. A Cauchy-Riemann Pin boundary value problem is a quintuple $\underline{D}=(\Sigma, E, F, \mathfrak{p}, D)$ where

- $\Sigma$ is a Riemann surface.
- $E \rightarrow \Sigma$ is a complex vector bundle.
- $F \rightarrow \partial \Sigma$ is a totally real sub-bundle of $\left.E\right|_{\partial \Sigma}$ with an orientation over every component of $\partial \Sigma$ where it is orientable.
- $\mathfrak{p}$ is a Pin structure on $F$.
- $D: \Gamma((\Sigma, \partial \Sigma),(E, F)) \rightarrow \Gamma\left(\Sigma, \Omega^{0,1}(E)\right)$ is a linear partial differential operator satisfying, for $\xi \in \Gamma((\Sigma, \partial \Sigma),(E, F))$ and $f \in C^{\infty}(\Sigma, \mathbb{R})$,

$$
D(f \xi)=f D \xi+(\bar{\partial} f) \xi
$$

Such a $D$ is called a real linear Cauchy-Riemann operator.
Definition 5.9. The determinant line of a Fredholm operator $D$ is the one-dimensional vector space

$$
\operatorname{det}(D)=\Lambda^{\max }(\operatorname{ker} D) \otimes \Lambda^{\max }(\operatorname{coker} D)
$$

The determinant lines of a continuously varying family of Fredholm operators fit together to form a determinant line bundle [29, Appendix A]. It is well-known that real linear Cauchy-Riemann operators are Fredholm [29, Appendix C]. The following restates Proposition 2.8 and Lemma 2.9 of [38].

Lemma 5.10. The determinant of the real linear Cauchy-Riemann operator of a CauchyRiemann Pin boundary value problem carries a canonical orientation, which has the following properties:
(a) The orientation varies continuously in families and thus defines an orientation of the associated determinant line bundle.
(b) Reversing the orientation of the boundary condition over one component of the boundary reverses the canonical orientation of the determinant line.

### 5.3. Orientors on moduli spaces.

Definition 5.11. The map $f^{\beta}$ is a diffeomorphism, and thus has a canonical orientation $\mathcal{O}_{c}^{f}$. Moreover, the maps $F b_{k+1, I}^{\beta}$ and $F i_{k+1, I}^{\beta}$ have canonical orientations, denoted $\mathcal{O}^{F b}, \mathcal{O}^{F i}$, originating in the complex orientation of the domains of the $J$-holomorphic maps and the induced orientation on the boundary.
Remark 5.12. Consider the following essential pullback diagram.

$$
\begin{gather*}
\mathcal{M}_{k+2, \hat{I}}(\beta) \xrightarrow{F b_{k+1, \hat{I}}^{\beta}} \mathcal{M}_{k+1, \hat{I}}(\beta) \\
F i_{k+2, I} \downarrow  \tag{5.4}\\
\mathcal{M}_{k+2, I}(\beta) \xrightarrow{\underset{F b_{k+1, I}^{\beta}}{\beta}} \mathcal{M}_{k+1, I}(\beta) \\
\downarrow i_{k+1, I}^{\beta}
\end{gather*}
$$

Then

$$
\begin{equation*}
\mathcal{O}^{F i_{k+1}} \circ \mathcal{O}^{F b_{\hat{I}}}=\mathcal{O}^{F b_{I}} \circ \mathcal{O}^{F i_{k+2}} . \tag{5.5}
\end{equation*}
$$

Moreover,

$$
\mathcal{O}^{F i^{\beta}}:=\left(U_{k+1, \hat{I}} / U_{k+1, I}\right)^{\star} \mathcal{O}^{F i}, \quad \mathcal{O}^{F b^{\beta}}:=\left(U_{k+2, I} / U_{k+1, I}\right)^{\star} \mathcal{O}^{F b},
$$

where the pullbacks are taken according to diagrams (5.2).
Notation 5.13. As this causes no confusion, we write $\left(F b_{k+1, I}^{\beta}\right)^{\diamond}$ for $\left(F b_{k+1, I}^{\beta}, \mathcal{O}^{F b}\right)^{\diamond}$, and similarly for Fi.
 by $k \geq-1, l \geq 0, I \subset[l]$ such that $k+2|I| \geq 2$, with the following properties:
(a) In the zero dimensional cases $(k,|I|) \in\{(0,1),(2,0)\}$, in which the projection maps $\pi^{\mathcal{W}_{k+1, I}}: \mathcal{W}_{k+1, I} \rightarrow \Omega$ are diffeomorphisms, the orientors are the canonical orientors from Definition 3.3

$$
\varphi_{k+1, I}=\varphi_{\pi} w_{k+1, I} .
$$

(b) The orientors are well behaved under cyclic permutations of the boundary points, that is

$$
f^{\diamond} \varphi_{k+1, I}=(-1)^{k} \varphi_{k+1, I}
$$

(c) The orientors are well behaved under arbitrary relabeling of interior points, that is, if $I, J \subset[l]$ and $a: I \rightarrow J$ is a bijection, the induced map $\widetilde{a}: \mathcal{W}_{k+1, I} \rightarrow \mathcal{W}_{k+1, J}$ satisfies

$$
\tilde{a}^{\diamond} \varphi_{k+1, J}=\varphi_{k+1, I} .
$$

(d) The orientors are well behaved under forgetting boundary points, that is

$$
\left(F b_{k+1, I}\right)^{\diamond} \varphi_{k+1, I}=\varphi_{k+2, I}
$$

(e) The orientors are well behaved under forgetting interior points, that is

$$
\left(F i_{k+1, I}\right)^{\diamond} \varphi_{k+1, I}=\varphi_{k+1, \hat{I}} .
$$

Properties (a), (d) and (e) determine the orientors $\varphi_{k+1, I}$ uniquely.
Proof. We follow the proof of [32, Lemma 2.24]. A direct calculation shows that

$$
\left(F b_{2,1}\right)^{\diamond}\left(F b_{1,1}\right)^{\diamond} \varphi_{1,1}=\left(F i_{3,0}\right)^{\diamond} \varphi_{3,0}
$$

See [32, Figure 2]. Equation (5.5) and Lemma 3.12 imply that for any $k, I$ and any $\pi^{\mathcal{W}_{k+1, I} \text {-orientor }} \varphi$ we have

$$
\left(F i_{k+2, I}^{\beta}\right)^{\diamond}\left(F b_{k+1, I}^{\beta}\right)^{\diamond} \varphi=\left(F b_{k+1, I}^{\beta}\right)^{\diamond}\left(F i_{k+1, I}^{\beta}\right)^{\diamond} \varphi .
$$

Therefore, we can define $\varphi_{k+1, I}$ recursively, according to properties (a), (d) and (e).
For property (b) to hold, it suffices to check that $f$ changes orientation by $(-1)^{k}$. This follows by Lemma 3.40 since $\mathcal{W}_{k+1, I}^{(0)}=\widehat{\mathcal{W}_{k+1, I}} / \operatorname{Aut}\left(D^{2}\right)$ and the diffeomorphism of $\widehat{\mathcal{W}_{k+1, I}}$ which cyclicly permutes the $S^{1}$ components changes orientation by $(-1)^{k}$.

Similarly, for property (c) to hold, it suffices to check that $\widetilde{a}$ does not change orientation. This is parallel to the proof of property (b), only that the diffeomorphism does not change orientation because $\operatorname{dim}\left(D^{2}\right)=2$.

Lemma 5.15. Let $k+2|I| \geq 0$. For $k \geq 0$, the relative Pin ${ }^{ \pm}$structure $\mathfrak{p}$ determines a canonical $U_{k+1, I^{-}}^{\beta}$ orientor of $\left(e v b_{z_{0}}^{\beta}\right)^{*}\left(\mathbb{L}_{L}^{\otimes(\mu(\beta)+1)}\right)$ to $\underline{\mathbb{Z} / 2}$ of degree $1-n$

$$
\widetilde{I}_{k+1, I}^{\beta}:\left(e v b_{z_{0}}^{\beta}\right)^{*}\left(\mathbb{L}_{L}^{\otimes(\mu(\beta)+1)}\right) \rightarrow \mathbb{K}_{U_{k+1, i}^{\beta}}
$$

For $k=-1, \beta \in \Pi^{\text {ad }}$, the relative Pin ${ }^{ \pm}$structure $\mathfrak{p}$ determines a canonical $U_{0, I}^{\beta}$-orientor of $\left(\pi^{\mathcal{M}}\right)^{*} \mathcal{X}_{L}^{\mu(\beta)+1}$ to $\mathbb{Z} / 2$ of degree $1-n$

$$
\widetilde{I}_{0, I}^{\beta}:\left(\pi^{\mathcal{M}}\right)^{*} \mathcal{X}_{L}^{\mu(\beta)+1} \rightarrow \mathbb{K}_{U_{0, l}^{\beta}} .
$$

Proof. By Lemma 2.19, it is enough to construct $\widetilde{I}_{k+1, I}^{\beta}$ on $\mathcal{M}_{k+1, I}^{(0)}(\beta)$. Recall Definition 4.19, To an arbitrary point $(t, \mathfrak{u})=\left(t, D^{2}, u, \vec{z}, \vec{w}\right) \in \mathcal{M}_{k+1, I}^{(0)}(\beta)$, associate the Cauchy-Riemann Pin boundary value problem $\underline{D}_{\mathfrak{u}}$ over the disk, with

$$

with the $\operatorname{Pin}$ structure $\mathfrak{p}_{\mathfrak{u}}$ on $F_{\mathfrak{u}}$ pulled-back from the corresponding structure on $L$, and $D_{u}$ the linearization of the $J_{t}$-holomorphic map operator.

We show that there exists a canonical isomorphism

which will imply, since $D_{\mathfrak{u}}$ and $\left.d U_{k+1, I}\right|_{(t, u)}$ are surjective, a canonical isomorphism

\mathcal{M}_{k+1, I}^{(0)}(\beta)=\widehat{\mathcal{M}_{k+1, I}}(\beta) / \operatorname{Aut}\left(D^{2}\right)
$$

To see the existence of the canonical isomorphism (5.6), we examine the following commutative diagram, of which the columns and bottom rows are exact.


By the nine lemma, the top row is exact as well, and thus the canonical isomorphism (5.6) exists.

Consider the case $k \geq 0$. In [38, Section 3] a canonical isomorphism

This isomorphism is continuous due to Lemma 5.10. Note that $\operatorname{dim} U_{k+1, I}^{\beta}=n+\mu(\beta)$, and $\operatorname{deg} \mathbb{L}_{L}=-1$, which implies $\operatorname{deg} \widetilde{I}_{k+1, l}^{\beta}=1-n$.

Consider the case $k=-1 . \quad F_{\mathfrak{u}}$ is orientable exactly if $\mu(\beta)$ is even. Thus, recalling Remark 4.12, the admissibility of $\beta$ implies that either $F_{\mathfrak{u}}$ is non-orientable, if $\mu(\beta) \equiv_{2} 1$, or $L$ is vertically oriented and thus $F_{\mathfrak{u}}$ is equipped with the pullback orientation. By Lemma 5.10, $\operatorname{det}\left(D_{\mathfrak{u}}\right)$ is canonically oriented. In case $L$ is vertically orientable, reversing the orientation of $L$ results in reversing the orientation of $F_{u}$. By Lemma 5.10, the latter reverses the canonical orientation of $\operatorname{det}\left(D_{\mathfrak{u}}\right)$ Thus, we get an isomorphism

Moreover, the canonical orientation is continuous in $(t, \mathfrak{u})$. Globally, this implies an isomorphism of bundles

Its degree is $1-n$.
Remark 5.16. Let $k \geq 0, I \subset[l]$ be such that $k+2|I| \geq 2$. Let $\hat{I}=I \dot{\cup}\{l+1\}$. Consider the essential pullback diagrams (5.2). The proof of Lemma 5.15 implies the following equations.

& \xi^{\diamond} \widetilde{I}_{k+1, l}^{(\mathcal{T} ; \beta)} \stackrel{\text { Def. }}{=}=\xi^{[5.19} \xi^{\diamond}\left(\mathcal{W}_{k+1, l}^{\tau} e_{L} \bullet \widetilde{J}_{k+1, l}^{(\mathcal{T} ; \beta)}\right) \\
& \stackrel{\text { Lem. }}{\text { Lem. }} \text {. } 3.247 W_{k+1, l}^{\varepsilon^{*} \mathcal{T}}\left(\xi^{\diamond} e_{L}\right) \bullet \xi^{\diamond} \widetilde{J}_{k+1, l}^{(\mathcal{T} ; \beta)}
\end{aligned}
$$

Thus, the uniqueness part of Lemma 3.13 implies

$$
\begin{equation*}
\xi^{\diamond} \widetilde{J}_{k+1, l}^{(\mathcal{T} ; \beta)}=\widetilde{J}_{k+1, l}^{\left(\xi^{*} \mathcal{T} ; \xi^{*} \beta\right)} \bullet \operatorname{evb_{0}^{*}}\left(\xi_{\mathbb{L}}^{\star}\right)^{\otimes \mu(\beta)} \tag{5.39}
\end{equation*}
$$

We calculate,

=5.39)}} \varphi_{k+1, l}^{\xi^{*} L} \bullet \widetilde{J}_{k+1, l}^{\left(\xi^{*} \mathcal{T} ; \xi^{*} \beta\right)} \bullet e v b_{0}^{*}\left(\xi_{\mathbb{L}}^{\star}\right)^{\otimes \mu(\beta) \operatorname{Def} \stackrel{[5.22}{=}} J_{k+1, l^{\left(\xi^{*} \mathcal{T} ; \xi^{*} \beta\right)}} \bullet e v b_{0}^{*}\left(\xi_{\mathbb{L}}^{\star}\right)^{\otimes \mu(\beta)} .
\end{aligned}
$$

This is the desired result.

## 6. Orientors of local systems of algebras

### 6.1. On the Lagrangian.

Notation 6.1 (The algebra of relative orientations). Recall the following notations from Section 1.4. For a Lagrangian $L \subset X$ set

$$
\mathcal{R}_{L}=\bigoplus_{k \in \mathbb{Z}} \mathcal{L}_{L}{ }^{\otimes k}
$$

with multiplication operator

$$
m: \mathcal{R}_{L}{ }^{\otimes 2} \rightarrow \mathcal{R}_{L}
$$

defined naturally by the tensor product.
Let $\mathbb{E}_{L}=\pi_{*}^{L} \mathcal{R}_{L}$ be the pushforward of sheaves along $\pi^{L}: L \rightarrow \Omega$. The multiplication $m$ of $\mathcal{R}_{L}$ descends to $\mathbb{E}_{L}$. Let $\mathcal{E}_{L}=\left(\pi^{L}\right)^{*} \mathbb{E}_{L}$. The adjunction of $\pi_{*}^{L}$ and $\left(\pi^{L}\right)^{*}$ provides a canonical morphism $i: \mathcal{E}_{L} \hookrightarrow \mathcal{R}_{L}$. Moreover, there exists a morphism

$$
w: \mathcal{R}_{L} \rightarrow \mathcal{E}_{L}
$$

which assigns to a point $(t, x) \in \mathcal{L}_{L}{ }^{\otimes j}$ the locally-constant section over $t \in \Omega$ that passes through $x$, if it exists, and otherwise 0 . It holds that $w \circ i=\operatorname{Id}_{\mathcal{E}_{L}}$. The maps $i, w$ commute with the multiplication. The map $i$ is an isomorphism exactly when $L$ is vertically orientable. Otherwise, $\mathcal{R}_{L}$ is 2-dimensional over $\mathcal{E}_{L}$ with respect to the algebra structure induced by $i$.

In this section we abbreviate $\mathcal{R}:=\mathcal{R}_{L}, \mathcal{L}:=\mathcal{L}_{L}, \mathbb{E}:=\mathbb{E}_{L}, \mathcal{E}:=\mathcal{E}_{L}$ and for $a \in \mathbb{Z}$ we abbreviate $\mathcal{L}^{a}:=\mathcal{L}^{\otimes a}$. Unless otherwise specified, we use $\mathcal{O}$ for a local section of $\mathcal{L}$.

Remark 6.2. There exists a global section denoted $\chi^{2}$ of $\mathbb{E}$ given locally by $\mathcal{O}^{2}$ for any local section of $\mathcal{L}$. $\chi^{2}$ plays the same role as the variable $e$ in the Novikov ring in [7, Section 1.2].
Remark 6.3 (non-commutativity). Note that on local sections $x, y$ of $\mathcal{R}$,

$$
m(x, y)=m(y, x)
$$

i.e.

$$
\begin{equation*}
m \circ \tau_{\mathcal{R}, \mathcal{R}}(x \otimes y)=(-1)^{x y} m(x \otimes y) \tag{6.1}
\end{equation*}
$$

In particular, restricted to odd degrees,

$$
m \circ \tau_{\mathcal{R}, \mathcal{R}}=-m
$$

Definition 6.4. The twistor $\mathcal{S}: \mathcal{R} \rightarrow \mathcal{R}$ is the $\mathrm{Id}_{L}$-endo-orientor of $\mathcal{R}$ given locally by

$$
\mathcal{S}\left(\mathcal{O}_{L}^{r}\right)=(-1)^{r} \mathcal{O}_{L}^{r}
$$

For $\beta \in \Pi$ we abbreviate $\mathcal{S}^{\beta}:=\mathcal{S}^{\mu(\beta)}=\mathcal{S}^{w_{1}(\partial \beta)}$.
Lemma 6.5. As $I d_{L}$-orientors of $\mathcal{R} \otimes \mathcal{R}$ to $\mathcal{R}$, the following equation holds.

$$
\mathcal{S} \bullet m=m_{71} \bullet \mathcal{S}^{\mathcal{R}} \bullet{ }^{\mathcal{R}} \mathcal{S}
$$

Proof. Let $\mathcal{O}$ be a local section of $\mathcal{L}$, and let $r, t \in \mathbb{Z}$. Then
$(\mathcal{S} \bullet m)\left(\mathcal{O}^{r} \otimes \mathcal{O}^{t}\right)=\mathcal{S}\left(\mathcal{O}^{r+t}\right)=(-1)^{r+t} \mathcal{O}^{r+t}=(-1)^{r+t} m\left(\mathcal{O}^{r} \otimes \mathcal{O}^{t}\right)=m\left(\mathcal{S} \mathcal{O}^{r} \otimes \mathcal{S} \mathcal{O}^{t}\right)$.

Definition 6.6. Let $a \in \mathbb{Z}$. The $a$-splitor

$$
\Psi_{a}: \mathcal{R} \rightarrow \mathcal{L}^{\otimes a} \otimes \mathcal{R}
$$

is the $\mathrm{Id}_{L}$-orientor given locally by

$$
\Psi_{a}\left(\mathcal{O}_{L}^{r}\right)=\mathcal{O}_{L}^{a} \otimes \mathcal{O}_{L}^{r-a}
$$

If $a$ is an exponent for $L$, then $\Psi_{a}$ descends to a map

$$
\Psi_{a}^{\mathbb{E}}: \mathbb{E} \rightarrow \mathcal{X}^{b} \otimes \mathbb{E}
$$

Remark 6.7. Let $b \in \mathbb{Z}$. The following equation holds.

$$
i_{b}^{\mathcal{E}} \bullet\left(\pi^{L}\right)^{*} \Psi_{b}^{\mathbb{E}}=\mathcal{L}^{b} w \bullet \Psi_{b} .
$$

Notation 6.8. We write $m$ for the restrictions of $m$ to sub-local systems of $\mathcal{R} \otimes \mathcal{R}$ in the source and sub-local systems of $\mathcal{R}$ in the image, when the restriction makes sense. For example, we write

$$
m: \mathcal{L}^{a} \otimes \mathcal{L}^{b} \rightarrow \mathcal{L}^{a+b}
$$

Lemma 6.9. Let $a \in \mathbb{Z}$. The following equation of Id $_{L}$-orientor of $\mathcal{R} \otimes \mathcal{R}$ to $\mathcal{L}^{a} \otimes \mathcal{R}$ holds.

$$
\mathcal{L}^{a} m \bullet\left(\tau_{\mathcal{R}, \mathcal{L}^{a}}\right)^{\mathcal{R}} \bullet{ }^{\mathcal{R}} \Psi_{a}=\Psi_{a} \bullet m \bullet\left(\mathcal{S}^{a}\right)^{\mathcal{R}} .
$$

Proof. Let $\mathcal{O}$ be a local section of $\mathcal{L}$ and let $r_{1}, r_{2} \in \mathbb{Z}$. Then

\begin{aligned}
\mathcal{L}^{a} m \bullet\left(\tau_{\mathcal{R}, \mathcal{L}^{a}}\right)^{\mathcal{R}} \bullet \mathcal{R}^{2} \Psi_{a}\left(\mathcal{O}^{r_{1}} \otimes \mathcal{O}^{r_{2}}\right) & =\mathcal{L}^{a} m \bullet\left(\tau_{\mathcal{R}, \mathcal{L}^{a}}\right)^{\mathcal{R}} \bullet \mathcal{R}\left(\mathcal{O}^{r_{1}} \otimes \mathcal{O}^{a} \otimes \mathcal{O}^{r_{2}-a}\right) \\
& =(-1)^{a r_{1}} \mathcal{L}^{a} m \bullet\left(\mathcal{O}^{a} \otimes \mathcal{O}^{r_{1}} \otimes \mathcal{O}^{r_{2}-a}\right) \\
& =(-1)^{a r_{1}} \mathcal{O}^{a} \otimes \mathcal{O}^{r_{1}+r_{2}-a} \\
& =\Psi_{a} \bullet m \bullet\left(\mathcal{S}^{a}\right)^{\mathcal{R}}\left(\mathcal{O}^{r_{1}} \otimes \mathcal{O}^{r_{2}}\right)
\end{aligned}
$$

Lemma 6.10. Let $a, b \in \mathbb{Z}$. The following equation of $I d_{L}$-orientor of $\mathcal{R}$ to $\mathcal{L}^{a+b} \otimes \mathcal{R}$ holds.

$$
\Psi_{a+b}=m^{\mathcal{R}} \bullet{ }^{\mathcal{L}^{a}} \Psi_{b} \bullet \Psi_{a}
$$

Corollary 6.11. Let $a, b, c \in \mathbb{Z}$. Then

\Psi_{a+b+c}=m_{3}^{\mathcal{R}} \bullet \mathcal{L}^{a} \otimes \mathcal{L}^{b} \Psi_{c} \bullet \mathcal{L}^{a} \Psi_{b} \bullet \Psi_{a}
$$

Proof. Let $\mathcal{O}$ be a local section of $\mathcal{L}$ and let $r \in \mathbb{Z}$. Then

$$
\begin{aligned}
m^{\mathcal{R}} \bullet \mathcal{L}^{a} \Psi_{b} \bullet \Psi_{a}\left(\mathcal{O}^{r}\right) & =m^{\mathcal{R}} \bullet \mathcal{L}^{a} \Psi_{b}\left(\mathcal{O}^{a} \otimes \mathcal{O}^{r-a}\right) \\
& \stackrel{(*)}{=} m^{\mathcal{R}}\left(\mathcal{O}^{a} \otimes \mathcal{O}^{b} \otimes \mathcal{O}^{r-a-b}\right) \\
& =\mathcal{O}^{a+b} \otimes \mathcal{O}^{r-a-b} \\
& =\Psi_{a+b}\left(\mathcal{O}^{r}\right)
\end{aligned}
$$

where $(*)$ follows since $\operatorname{deg} \Psi_{b}=0$.

Notation 6.12. For $k \geq 2$, define $m_{k}: \mathcal{R}^{\otimes k} \rightarrow \mathcal{R}$ to be the (associative) $k$-fold multiplication

m_{k}\left(x_{1}, \ldots, x_{k}\right)=m\left(x_{1}, m\left(x_{2}, \ldots, m\left(x_{k-1}, x_{k}\right)\right)\right)
$$

Locally it is given by

$$
m_{k}\left(\mathcal{O}_{L}^{r_{1}} \otimes \cdots \otimes \mathcal{O}_{L}^{r_{k}}\right)=\mathcal{O}_{L}^{r_{1}+\ldots+r_{k}}
$$

Let $m_{1}:=\operatorname{Id}_{\mathcal{R}}$ and $m_{0}: \underline{\mathbb{A}} \rightarrow \mathcal{R}$ be the embedding of $\mathbb{A}$ as the 0 th degree of $\mathcal{R}$.
Recall the $\pi^{L}$-orientor $e$ of $\mathcal{L}$ to $\mathbb{A}$ from Definition 5.18 and the map $w$ from Notation 6.1.

Definition 6.13. Denote by $O=O^{L}$ the $\pi^{L}$-orientor of $\mathcal{R}$ to $\mathbb{E}$ of degree $1-n$ given by the composition

$$
O:=O^{L}:=e^{\mathbb{E}} \bullet \mathcal{L}_{w} \bullet \Psi_{1} .
$$

Moreover, denote by $O_{\text {odd }}$ the $\pi^{L}$-orientor which agrees with $O$ on inputs of odd degree and vanishes on inputs of even degree.
6.2. On disk moduli spaces. Recall the boundary transport orientors $c_{i j}$ from Definition 5.3. We extend $c_{i j}$ to $\operatorname{Id}_{\mathcal{M}}$-orientors of $e v b_{j}^{*} \mathcal{R}$ to $e v b_{i}^{*} \mathcal{R}$ by $c_{i j}^{\otimes a}$ on $\mathcal{L}^{\otimes a}$.

Consider the local system

$$
\underbrace{\mathcal{R} \boxtimes \ldots \boxtimes \mathcal{R}}_{k \text { times }} \rightarrow L^{\times_{\Omega} k} .
$$

Let

$$
e v: \mathcal{M}_{k+1, l}(\beta) \rightarrow L^{\times_{\Omega} k}
$$

be given by

$$
(t, \Sigma, u, \vec{z}, \vec{w}) \mapsto\left(\left(t, u\left(z_{1}\right)\right), \ldots,\left(t, u\left(z_{k}\right)\right)\right)
$$

Definition 6.14 (The operator $\mathcal{I}_{k}$ ). Let

$$
\mathcal{I}_{k}: e v^{*}(\mathcal{R} \boxtimes \ldots \boxtimes \mathcal{R}) \longrightarrow e v b_{0}^{*}\left(\mathcal{R}^{\otimes k}\right)
$$

be the $\operatorname{Id}_{\mathcal{M}_{k+1, l}(\beta) \text {-orientor given by }}$

$$
e v^{*}\left(\mathcal{R}^{\boxtimes k}\right)=\bigotimes_{j=1}^{k} e v b_{j}^{*} \mathcal{R} \xrightarrow{\substack{\bigotimes_{j=1}^{k} c_{0 j}}} e v b_{0}^{*} \mathcal{R}^{\otimes k} .
$$

Recall the $e v b_{0}^{\beta}$-orientor of $\mathcal{L}^{\mu(\beta)}$ to $\underline{\mathbb{A}}$ of degree $2-k-2|I|$,

$$
J_{k+1, I}^{\beta}: e v b_{0}^{*}(\mathcal{L})^{\otimes \mu(\beta)} \xrightarrow{\sim} \mathcal{K}_{e v b_{0}},
$$

and, for $\beta \in \Pi^{a d}$, the $\pi^{\mathcal{M}_{0, I}(\beta)}$-orientor of $\left(\pi^{\mathcal{M}_{0, I}(\beta)}\right)^{*} \mathcal{X}^{\mu(\beta)+1}$ to $\mathbb{A}$ of degree $4-n-2|I|$,

$$
J_{0, I}^{\beta}:\left(\pi^{\mathcal{M}_{0, I}(\beta)}\right)^{*} \mathcal{X}^{\mu(\beta)+1} \rightarrow \mathcal{K}_{\pi^{\mathcal{M}_{0, I}(\beta)}}
$$

from Definition 5.22.
Definition 6.15 (The operator $\mathcal{J}_{k+1, I}^{\beta}$ ). For $k \geq 0$, let

$$
\mathcal{J}_{k+1, I}^{\beta}: e v b_{0}^{*} \mathcal{R} \rightarrow \mathcal{K}_{e v b_{0}} \otimes e v b_{0}^{*} \mathcal{R}
$$

be the $\mathcal{R}$-endo-orientor of degree $2-k-2|I|$, given by

$$
\mathcal{J}_{k+1, I}^{\beta}:=\left(\underset{73}{\left(J_{k+1, I}^{\beta}\right.}\right)^{\mathcal{R}} \bullet e v b_{0}^{*} \Psi_{\beta}
$$

Definition 6.16. For $k \geq 0$, let $Q_{k, I}^{\beta}$ be the $e v b_{0}^{\beta}$-orientor of $e v^{*}(\mathcal{R} \boxtimes \cdots \boxtimes \mathcal{R})$ to $\mathcal{R}$ of degree $2-k-2|I|$, given by

$$
Q_{k, I}^{\beta}:=\mathcal{J}_{k+1, I}^{\beta} \bullet e v b_{0}^{*}\left(\mathcal{S}^{\beta} \bullet m_{k}\right) \bullet \mathcal{I}_{k} .
$$

In particular, $Q_{0, I}^{\beta}$ is an $e v b_{0}^{\beta}$-orientor of $\mathbb{A}$ to $\mathcal{R}$.
For $k=-1$, let $Q_{-1, I}^{\beta}$ be the $\pi^{\mathcal{M}_{0, l}(\beta)}$-orientor of $\underline{\mathbb{A}}$ to $\mathbb{E}$, of degree $4-n-2|I|$, given by

$$
Q_{-1, I}^{\beta}:=\left(J_{0, I}^{\beta}\right)^{\mathbb{E}} \bullet\left(\pi^{\mathcal{M}}\right)^{*}\left(\Psi_{\mu(\beta)+1}^{\mathbb{E}} \bullet m_{0}\right)
$$

if $\beta \in \Pi^{a d}$ and $Q_{-1, I}^{\beta}=0$ otherwise.
Lemma 6.17. For $(k, l, \beta) \in\left\{\left(2,0, \beta_{0}\right),\left(0,1, \beta_{0}\right)\right\}$ we have

When there is no ambiguity, we write $\Psi_{\beta}, \mathcal{S}^{\beta}, m_{k}$ and $\mathcal{R}, \mathcal{L}$ for $e v b^{*} \Psi_{\beta}, e v b^{*} \mathcal{S}^{\beta}, e v b^{*} m_{k}$ and $e v b^{*} \mathcal{R}, e v b^{*} \mathcal{L}$. If $G$ is one of $m_{k}, \Psi_{\beta}, \mathcal{S}^{\beta}, \mathcal{I}_{k}, \mathcal{J}_{k}^{\beta}$ or $Q_{k . l}^{\beta}$, we also let $G$ denote the extension of scalars by $\widetilde{\Lambda}\left[\left[t_{1}, \ldots, t_{N}\right]\right]$ on the right of $G$.
Remark 6.19. Theorem 2 follows immediately from Lemma 5.24 and the following equation.

\mathcal{I}_{k+1}=(F b)^{*} \mathcal{I}_{k} \otimes c_{0, k+1}=\left((F b)^{*} \mathcal{I}_{k}\right)^{e v b_{0}^{*} \mathcal{R}} \bullet(F b)^{*} E_{k} c_{0, k+1} .

6.3. Proof for $k \geq 0$. This section contains the proof of Theorem $\square$ Let $P$ be an ordered 3 -partition of $(1, \ldots, k)$, i.e.

and $I \cup \dot{U} J$ be a partition of $[l]$. Recall the following notation from Section 1.4

When this creates no ambiguity we write $E_{i}$ for $E_{i}^{k}$, for $i=1,2,3$. Recall from Section 5 the gluing map $\vartheta^{\beta}$,

where $B(\beta)$ is a vertical boundary component of $\pi^{\mathcal{M}_{k+1, l}(\beta)}$ from Section 4.1. For simplicity, we abbreviate $\vartheta=\vartheta^{\beta}$ and denote the inclusion $B(\beta) \rightarrow \partial \mathcal{M}_{k+1, l}(\beta)$ by $\iota$. Moreover, we abbreviate $B:=B(\beta)$. This notation replaces the notation from Section 5 since the latter is irrelevant in the current section. In order to prove Theorem [1 We need to consider how $\mathcal{I}$ and $\mathcal{J}$ behave under partitions. Thus, we fix the following.

Let $P \in S_{3}[k], \quad I \dot{\cup} J=[l]$ be partitions, and $\beta_{1}, \beta_{2} \in \Pi$ such that $\beta_{1}+\beta_{2}=\beta$. Let $\alpha=\alpha_{1} \otimes \cdots \otimes \alpha_{k} \in C^{\otimes k}$ and $\gamma=\gamma_{1} \otimes \cdots \otimes \gamma_{l} \in D^{\otimes l}$. Let $k_{1}=|(1: 3)|+|(3: 3)|+1$, $k_{2}=(2: 3)$ and $i=|(1: 3)|+1$.

Throughout this section, we abbreviate

$$
\begin{aligned}
& \mathcal{I}=\mathcal{I}_{k}, \quad \mathcal{J}=\mathcal{J}_{k+1, l}^{\beta}, \quad Q=Q_{k . l}^{\beta}, \\
& \mathcal{I}_{1}=\mathcal{I}_{k_{1}}, \quad \mathcal{J}^{1}=\mathcal{J}_{k_{1}+1, I}^{\beta_{1}}, \quad Q_{1}=Q_{k_{1}, I}^{\beta_{1}}, \\
& \mathcal{I}_{2}=\mathcal{I}_{k_{2}}, \quad \mathcal{J}^{2}=\mathcal{J}_{k_{2}+1, J}^{\beta_{2}}, \quad Q_{2}=Q_{k_{2}, J}^{\beta_{2}} .
\end{aligned}
$$

Remark 6.20 (Rotation around $\beta_{2}$ ). Recall Remark 5.27 and Lemma 5.31;

\begin{gathered}
\left.e v b_{j}^{\beta}\right|_{B} \circ \vartheta= \begin{cases}e v b_{j}^{\beta_{1}} \circ p_{1}, & 0 \leq j \leq i-1, \\
e v b_{j-i+1}^{\beta_{2}} \circ p_{2}, & i \leq j \leq i+k_{2}-1, \\
e v b_{j-k_{2}+1}^{\beta_{1}} \circ p_{1}, & i+k_{2} \leq j \leq k .\end{cases} \\

& \text { Def. [6.14] } \mathcal{S}^{\beta} \bullet m_{k+1} \bullet\left(c_{11} \otimes c_{12} \otimes \cdots \otimes c_{1, k+1}\right) \bullet\left(e v^{c y c}\right)^{*} \tau^{-1} \\
& \text { eq. } \stackrel{[6.24)}{=} \mathcal{S}^{\beta} \bullet m_{k+1} \bullet c_{10}^{\otimes k+1} \bullet\left(c_{01} \otimes c_{02} \otimes \cdots \otimes c_{0 k} \otimes \mathcal{S}^{\beta}\right) \bullet\left(e v^{c y c}\right)^{*} \tau^{-1} \\
& =c_{10} \bullet \mathcal{S}^{\beta} \bullet m_{k+1} \bullet\left(\mathcal{I} \otimes \mathcal{S}^{\beta}\right) \bullet\left(e v^{c y c}\right)^{*} \tau^{-1} \\
& =c_{10} \bullet m_{2} \bullet\left(\left(\mathcal{S}^{\beta} \bullet m_{k} \bullet \mathcal{I}\right) \otimes \mathrm{Id}\right) \bullet\left(e v^{c y c}\right)^{*} \tau^{-1} .
\end{aligned}
$$

Proof of Lemma 6.29. Recalling Definition [6.15, the lemma follows immediately from Lemma 5.24.
6.6. Base change. Let $\xi: \Omega^{\prime} \rightarrow \Omega$ be a map. Let $\mathcal{T}=\left(\Omega, X, \omega, L, \pi^{X}, \mathfrak{p}, \underline{\Upsilon}, J\right)$ be a target over $\Omega$. Recall Section 4.2 regarding families and Section 5.8 regarding naturality. Let

$$
\xi_{\mathcal{R}}^{\star}:\left(\xi^{L}\right)^{*} \mathcal{R}_{L} \rightarrow \mathcal{R}_{\xi^{*} L}
$$

be the map given by $\left(\xi^{L} / \xi\right)^{\star}: \xi^{L^{*}} \mathcal{L}_{L} \rightarrow \mathcal{L}_{\xi^{*} L}$ extended multiplicatively to $\xi^{L^{*}} \mathcal{R}_{L}$. Set

$$
\xi_{\mathbb{E}}^{\star}:=\pi_{*}^{L} \xi_{\mathcal{R}}^{\star}: \xi^{*} \mathbb{E}_{L} \rightarrow \mathbb{E}_{\xi^{*} L}
$$

We think of $\xi_{\mathcal{R}}^{\star}$ and $\xi_{\mathbb{E}}^{\star}$ as $\mathrm{Id}_{\xi^{*} L}$ and $\mathrm{Id}_{\Omega^{\prime}}$-orientors, respectively.
Remark 6.30. $\xi_{\mathcal{R}}^{\star}, \xi_{\mathbb{\mathbb { E }}}^{\star}$ are algebra homomorphisms with respect to the corresponding tensor multiplication maps $m_{L}, m_{\xi^{*} L}$. Similarly, they commute with $\Psi_{b}$ for $b \in \mathbb{Z}$.
Proposition 6.31. With the above notations, the following diagram is commutative.


That is, the following equation of $\pi^{\xi^{*} L}$-orientors holds.

$$
\xi_{\mathbb{E}}^{\star} \bullet \xi^{\diamond} O^{L}=O^{\xi^{*} L} \bullet \xi_{\mathcal{R}}^{\star} .
$$

Proof. This is immediate by the definitions and equation (5.35).
Let $k \geq 0, l \geq 0$ and $\beta \in \Pi(\mathcal{T})$. Abbreviate

$$
\mathcal{M}:=\mathcal{M}_{k+1, l}(\mathcal{T} ; \beta), \quad \mathcal{M}^{\prime}:=\mathcal{M}_{0, l}\left(\xi^{*} \mathcal{T} ; \xi^{*} \beta\right) .
$$

Let

$$
\xi_{E}^{\star}:=\underset{j=1}{\underset{~}{\bigotimes}}\left(e v b_{j}^{\beta}\right)^{*} \xi_{\mathcal{R}}^{\star}: \xi^{\mathcal{M}^{*}} E_{L}^{k} \rightarrow E_{\xi^{*} L}^{k} .
$$

We think of $\xi_{E}^{\star}$ as an $\operatorname{Id}_{\mathcal{M}_{k+1, l}\left(\xi^{*} \mathcal{T} ; \xi^{*} \beta\right) \text {-orientor. }}$
Theorem 6.32. The following diagram is commutative.

$$
\begin{aligned}
& \xi^{\mathcal{M}^{*}} E_{L}^{k} \longrightarrow E_{\xi^{*} L}^{k} \\
& \xi^{\circ} Q_{k+1, l}^{\left(\mathcal{T}_{; \beta}\right)} \downarrow \square Q^{\left(\epsilon_{\left.k+1, \tau^{*} ; \xi^{*} \beta\right)}\right)} \\
& \mathcal{K}_{e v b_{0}^{\left(\xi^{*} \mathcal{T}\right)}} \otimes \xi^{\mathcal{M}^{*}}\left(e v b_{0}^{\mathcal{T}}\right)^{*} \mathcal{R}_{L} \xrightarrow[1 \otimes e v b_{0}^{*}\left(\xi_{\mathcal{R}}\right)]{ } \mathcal{K}_{e v b_{0}^{\left(\xi^{*} \mathcal{T}\right)}} \otimes\left(e v b_{0}^{\left(\xi^{*} \mathcal{T}\right)}\right)^{*} \mathcal{R}_{\xi^{*} L}
\end{aligned}
$$

That is, the following equation of orientors holds.

$$
\xi_{\mathcal{R}}^{\star} \bullet \xi^{\diamond} Q_{k+1, l}^{(\mathcal{T} ; \beta)}=Q_{k+1, l}^{\left(\xi^{*} \mathcal{T} ; \xi^{*} \beta\right)} \bullet \xi_{E}^{\star} .
$$

Similarly, for $\beta \in \Pi^{a d}(\mathcal{T})$, the following diagram is commutative.

That is, the following equation of orientors holds.

$$
\xi_{\mathbb{E}}^{\star} \bullet \xi^{\diamond} Q_{-1, l}^{(\mathcal{T} ; \beta)}=Q_{-1, l}^{\left(\xi^{*} \mathcal{T} ; \xi^{*} \beta\right)}
$$

Proof. By Lemma 5.38 it follows that the following diagram is commutative.

$$
\begin{aligned}
& \left(\xi^{\mathcal{M}}\right)^{*} e v^{\mathcal{T}^{*}} \boxtimes \mathcal{R}_{L} \xrightarrow{\xi^{\mathcal{M}} \mathcal{I}_{k+1, l}^{\tau}} \xi^{\mathcal{M}^{*}} e v b_{0}^{*} \mathcal{R}_{L}^{\otimes k} \\
& \left(e v \varepsilon^{*} \mathcal{T}\right)^{*} \boxtimes \xi_{\mathcal{R}}^{\star} \downarrow \quad \downarrow^{e v b_{0}^{*} \otimes \xi \xi_{\mathcal{R}}^{*}} \\
& \left(e v v^{\xi^{*} \mathcal{T}}\right)^{*} \boxtimes \mathcal{R}_{\xi^{*} L} \xrightarrow[\mathcal{I}^{\xi^{*} \mathcal{T}}]{ } e v b_{0}^{*} \mathcal{R}_{\xi^{*} L}
\end{aligned}
$$

The theorem follows immediately by Lemma 5.41 and remark 6.30, keeping in mind that $\mu(\beta)=\mu\left(\xi^{*} \beta\right)$.
