# $p$-ADIC HYPERGEOMETRIC FUNCTION RELATED WITH p-ADIC MULTIPLE POLYLOGARITHMS

#### Abstract

This paper introduces a $p$-adic analogue of Gauss's hypergeometric function which is constructed along ideas different from Dwork's. Our construction is based on a relationship between the hypergeometric function and the KZ equation. We perform a residue-wise analytic prolongation of our $p$-adic hypergeometric function by investigating its relationship with $p$-adic multiple polylogarithms. By further exploring its local behavior around the point 1, we show that a $p$-adic analogue of Gauss hypergeometric theorem holds for the function.

## 0. Introduction

Let $p$ be a prime. This paper concerns a $p$-adic analogue of Gauss's hypergeometric function. By exploiting techniques of $p$-adic KZ equation, we introduce a formal version (a variant valued on formal power series) of $p$-adic hypergeometric function

in Definition 3. We investigate its convergence under the specialization $(a, b, c) \mapsto$ $(\alpha, \beta, \gamma) \in \mathbb{Q}_{p}^{3}$. Our main result is summarized in quite short as follows:

[^0]Theorem 1. Assume that $\alpha, \beta, \gamma-1 \in p \mathbb{Z}_{(p)}:=p \mathbb{Z}_{p} \cap \mathbb{Q}$ with $\beta \neq 0, \gamma \notin \mathbb{Z}_{\leq 0}$, $\alpha+\beta-\gamma, \alpha-\beta \in \mathbb{Z}_{(p)} \backslash \mathbb{N}_{ \pm}$and a branch of the p-adic logarithm Log is chosen as $\log (p) \in \mathbb{Z}_{p}$. Then the following hold:
(1). The specialization converges and gives a map

(2). It restriction to the open unit disk centered at $z=0$ agrees with the convergent series $\sum_{n=0}^{\infty} \frac{(\alpha)_{n}(\beta)_{n}}{(\gamma)_{n} n!} z^{n}$.
(3). The p-adic Gauss hypergeometric theorem holds at $z=1$, that is,

\end{array} \right\rvert\, z\right)=\prod_{k=1}^{\infty} \frac{\Gamma_{p}\left(1+p^{k} \mu+p^{k} \alpha\right) \cdot \Gamma_{p}\left(1+p^{k} \mu+p^{k} \beta\right)}{\Gamma_{p}\left(1+p^{k} \mu\right) \cdot \Gamma_{p}\left(1+p^{k} \nu\right)}
$$

with $\mu=1-\gamma$ and $\nu=\alpha+\beta+1-\gamma$. Here $\Gamma_{p}$ is Morita's $p$-adic gamma function (cf. (2.21) ).

Actually our results are more technically extended and proved in more general setting; conditions for $\alpha, \beta, \gamma$ are relaxed and $\mathbb{Q}_{p}$ can be replaced with a bigger field. Our idea of the proof is to check its convergence residue-wise by exploiting its relationship with the $p$-adic multiple polylogarithms. The proof on the convergence and the coincidence with the usual power series on the residue disk ]0[ is given in $\$ 2.2$ The proof on the convergence on the residue disk $] \infty[$ is given in $\$ 2.4$ The proof on the convergence on the residue disk $] 1[$ and that of $p$-adic Gauss hypergeometric theorem is given in $\$ 2.5$. The convergence on the rest residue disks is given in $\$ 2.3$.

We note that another $p$-adic analogue of hypergeometric function is intensively explored by Dwork $\overline{\mathrm{Dw}}$, whose region of definition is smaller than that of ours. It is not clear how our function is related to his one.

## 1. Complex case

This section recalls the relationship between KZ equation and Euler's hypergeometric differential equation, and explains Oi's formulas which connect the hypergeometric function with multiple polylogarithms.
1.1. Multiple polylogarithms. The (formal) KZ (Knizhnik-Zamolodchikov) equation is the differential equation over $\mathcal{X}(\mathbb{C})$

\end{equation*}

where $\mathcal{X}$ is $\mathbb{P}^{1} \backslash\{0,1, \infty\}$ and $G(z)$ is analytic (that is, each coefficient is analytic) in complex variables with values in the noncommutative formal power series ring $\mathbb{C}\left\langle\left\langle T_{0}, T_{1}\right\rangle\right\rangle$. It has singularities at $z=0,1$ and $\infty$ that are regular and Fuchsian. In Dr] $\S 3$, Drinfeld considers the fundamental solution $G_{01}\left(T_{0}, T_{1}\right)(z)$ which is uniquely determined by the asymptotic property $G_{01}\left(T_{0}, T_{1}\right)(z) z^{-T_{0}} \rightarrow 1$ when $z \in \mathbb{R}_{+}$ approaches 0 . Here $z^{-T_{0}}$ stands for $\sum_{i=0}^{\infty} \frac{(-\log z)^{i}}{i!} T_{0}^{i}$.

He further investigates 5 other solutions of the KZ equation with certain specific asymptotic properties, which are described as

G_{\vec{\infty} 1}\left(T_{0}, T_{1}\right)(z) & =G_{\overrightarrow{01}}\left(T_{\infty}, T_{1}\right)\left(\frac{1}{z}\right), \\
G_{\vec{\infty} 0}\left(T_{0}, T_{1}\right)(z) & =G_{\overrightarrow{01}}\left(T_{\infty}, T_{0}\right)\left(\frac{1}{1-z}\right), \\
G_{0 \vec{\infty}}\left(T_{0}, T_{1}\right)(z) & =G_{\overrightarrow{01}}\left(T_{0}, T_{\infty}\right)\left(\frac{z}{z-1}\right)
\end{aligned}
$$

with $T_{\infty}=-T_{0}-T_{1}$. The quotient

$$
\Phi_{\mathrm{KZ}}\left(T_{0}, T_{1}\right)=G_{1 \overrightarrow{0}}\left(T_{0}, T_{1}\right)(z)^{-1} \cdot G_{01}\left(T_{0}, T_{1}\right)(z)
$$

is independent of $z$ and is called the $K Z$ associator.
Let $\mathbb{A}=\mathbb{C}\left\langle T_{0}, T_{1}\right\rangle$ be the polynomial part of $\mathbb{C}\left\langle\left\langle T_{0}, T_{1}\right\rangle\right\rangle$. We call an element of $\mathbb{A}$ which is a monomial with coefficient 1 by a word. But exceptionally we shall not call 1 a word. For each word $W$, its weight $\mathrm{wt}(W)$ (resp. its depth $\operatorname{dp}(W)$ ) is defined to be the sum of exponents of $T_{0}$ and $T_{1}$ (resp. of $T_{1}$ ) in $W$. Put $\mathbb{M}^{\prime}=\mathbb{A} \cdot T_{1}=\left\{F \cdot T_{1} \mid F \in \mathbb{A}\right\}$ which is the $\mathbb{C}$-linear subspace of $\mathbb{A}$. Note that there is a natural linear surjection from $\mathbb{A}$ to $\mathbb{A} / \mathbb{A} \cdot T_{0}$. By identifying the latter space with $\mathbb{C} \cdot 1+\mathbb{M}^{\prime}\left(=\mathbb{C} \cdot 1+\mathbb{A} \cdot T_{1}\right)$ we obtain the $\mathbb{Q}$-linear map $f^{\prime}: \mathbb{A} \rightarrow \mathbb{A} /$ $\mathbb{A} \cdot T_{0} \xrightarrow{\sim} \mathbb{C} \cdot 1+\mathbb{M}^{\prime} \hookrightarrow \mathbb{A}$. For each word $W=T_{1}^{q_{0}} T_{0}^{p_{1}} T_{1}^{q_{1}} T_{0}^{p_{2}} T_{1}^{q_{2}} \cdots T_{0}^{p_{k}} T_{1}^{q_{k}}(k \geqslant 0$, $q_{0} \geqslant 0, p_{i}, q_{i} \geqslant 1$ for $i \geqslant 1$ ) in $\mathbb{M}^{\prime}$, we define

\operatorname{Li}_{W}(z):=\operatorname{Li}_{q_{q_{k}-1}}^{1, \ldots 1}, p_{k}+1, \underbrace{1, \ldots 1}_{q_{k-1}-1}, p_{k-1}+1, \ldots \ldots, 1, p_{1}+1 \underbrace{1, \ldots 1}_{q_{0}}(z) .
$$

Here $\operatorname{Li}_{\mathbf{k}}(z)$ for a tuple $\mathbf{k}=\left(k_{1}, \ldots, k_{n}\right) \in \mathbb{N}^{n}(n \in \mathbb{N})$ is the multiple polylogarithm, the complex function defined by the series

$$
\mathrm{Li}_{\mathbf{k}}(z):=\sum_{0<m_{1}<\cdots<m_{n}} \frac{z^{m_{n}}}{m_{1}^{k_{1}} \cdots m_{n}^{k_{n}}} \in \mathbb{Q}[[z]] .
$$

By extending linearly, we get the $\mathbb{C}$-linear map $\operatorname{Li}(z): \mathbb{M}^{\prime} \rightarrow \mathbb{C}[[z]]$ which sends each word $W$ in $\mathbb{M}^{\prime}$ to $\mathrm{Li}_{W}(z)$.

It is shown that coefficients of $G_{01}\left(T_{0}, T_{1}\right)(z)$ are given by polynomial combinations of multiple polylogarithms and the logarithm $\log (z)$.

Proposition 2 (F03, F04]). Expand $G_{01}\left(T_{0}, T_{1}\right)(z)=1+\sum_{W: \text { words }} J(W)(z) W$. Then each coefficient $J(W)(z)$ is expressed as follows:
(a) When $W$ is in $M^{\prime}, \quad J(W)(z)=(-1)^{d p(W)} \operatorname{Li}_{W}(z)$.
(b) When $W$ is written as $V T_{0}^{r}\left(r \geqslant 0, V \in M^{\prime}\right)$,

J(W)(z)=\sum_{\substack{s+t=r \\ 0 \leqslant s, 0 \leqslant t}}(-1)^{d p(W)+s} \operatorname{Li}_{f^{\prime}\left(V ш T_{0}^{s}\right)}(z) \frac{\{\log (z)\}^{t}}{t!} .

(c) When $W$ is written as $T_{0}^{r}(r \geqslant 0), \quad J(W)(z)=\frac{\{\log (z)\}^{r}}{r!}$.

Here $\amalg$ stands for the shuffle product arising from the product of Chen's path iterated integrals.

We note that a similar type of formula describing each coefficient of the KZassociator as a linear combination of multiple zeta values

$$
\zeta(\mathbf{k}):=\sum_{0<m_{1}<\cdots<m_{n}} \frac{1}{m_{1}^{k_{1}} \cdots m_{n}^{k_{n}}}
$$

which is a limit values of multiple polylogarithm to 1 for $k_{n}>1$, is given in [F03.
1.2. Hypergeometric function. Gauss's hypergeometric function (consult AAR for example) is the complex analytic function ${ }_{2} F_{1}\left(\left.\begin{array}{c}a, b \\ c\end{array} \right\rvert\, z\right)$ defined by the power series

which converges for $|z|<1$. Here, $a, b, c$ are complex numbers with $c \neq 0,-1,-2, \cdots$, and $(s)_{0}=1,(s)_{n}=s(s+1) \cdots(s+n-1)$ are the Pochhammer symbols.

The hypergeometric function has been studied for several centuries. Hypergeometric theorem (due to Gauss)

\end{array} \right\rvert\, 1\right)=\frac{\Gamma(c) \Gamma(c-a-b)}{\Gamma(c-a) \Gamma(c-b)}, \quad \text { when } \Re(c)>\Re(a+b),

might be one of the most celebrated results among others.
The hypergeometric function is a solution of Euler's hypergeometric differential equation:

$$
z(1-z) \frac{d^{2} w}{d z^{2}}+\{c-(a+b+1) z\} \frac{d w}{d z}-a b w=0
$$

which enables us to perform the analytic continuation of the function along a topological path starting from 0 to any $z$ in $\mathcal{X}(\mathbb{C})$.

Put $X_{0}=\left(\begin{array}{ll}0 & b \\ 0 & u\end{array}\right)$ and $Y_{0}=\left(\begin{array}{ll}0 & 0 \\ a & v\end{array}\right) \in \operatorname{Mat}_{2}(\mathbb{C})$ with $u=1-c$ and $v=$ $a+b+1-c$. The differential equation can be reformulated as

$$

with $\vec{g}=\vec{g}(w)=\binom{w}{\frac{z}{b} \frac{d w}{d z}} \in \mathbb{C}^{2}$ when $b \neq 0$. Whence its substitution $\left(X_{0},-Y_{0}\right)$ for $\left(T_{0}, T_{1}\right)$ to a solution $G\left(T_{0}, T_{1}\right)(z)$ of the KZ-equation (1.1) yields two solutions $w_{1}, w_{2}$ with $\left(\vec{g}\left(w_{1}\right), \vec{g}\left(w_{2}\right)\right)=G\left(X_{0},-Y_{0}\right)(z) \in \operatorname{Mat}_{2}(\mathbb{C})$ of the above differential
equation when it converges as explained in O . By writing

we recover certain scalar multiples of half of the so-called Kummer's 24 solutions (cf. [F21])
$\left(\begin{array}{ll}1, & 0\end{array}\right) \cdot \mathcal{V}_{01}(z)=\left({ }_{2} F_{1}\left(\left.\begin{array}{c}a, b \\ c\end{array} \right\rvert\, z\right), \quad z^{1-c}{ }_{2} F_{1}\left(\left.\begin{array}{c}b+1-c, a+1-c \\ 2-c\end{array} \right\rvert\, z\right)\right)$,
$(1, \quad 0) \cdot \mathcal{V}_{10}(z)=\left({ }_{2} F_{1}\left(\left.\begin{array}{c}a, b \\ a+b+1-c\end{array} \right\rvert\, 1-z\right), \quad(1-z)^{c-a-b}{ }_{2} F_{1}\left(\left.\begin{array}{c}c-a, c-b \\ c-a-b+1\end{array} \right\rvert\, 1-z\right)\right)$,
$(1, \quad 0) \cdot \mathcal{V}_{1 \vec{\infty}}(z)=\left(z^{-a}{ }_{2} F_{1}\left(\left.\begin{array}{c}a, a+1-c \\ a+b-c+1\end{array} \right\rvert\, 1-\frac{1}{z}\right), \quad z^{b-c}(z-1)^{c-a-b}{ }_{2} F_{1}\left(\left.\begin{array}{c}1-b, c-b \\ 1-a-b+c\end{array} \right\rvert\, 1-\frac{1}{z}\right)\right)$,
$(1, \quad 0) \cdot \mathcal{V}_{\infty 1}(z)=\left(z^{-a}{ }_{2} F_{1}\left(\left.\begin{array}{c}a, a+1-c \\ a-b+1\end{array} \right\rvert\, \frac{1}{z}\right), \quad z^{-b}{ }_{2} F_{1}\left(\left.\begin{array}{c}b+1-c, b \\ b-a+1\end{array} \right\rvert\, \frac{1}{z}\right)\right)$,
$(1, \quad 0) \cdot \mathcal{V}_{\infty 0}(z)=\left((1-z)^{-a}{ }_{2} F_{1}\left(\left.\begin{array}{c}a, c-b \\ a-b+1\end{array} \right\rvert\, \frac{1}{1-z}\right), \quad(1-z)^{-b}{ }_{2} F_{1}\left(\left.\begin{array}{c}c-a, b \\ 1-a+b\end{array} \right\rvert\, \frac{1}{1-z}\right)\right)$,
$(1, \quad 0) \cdot \mathcal{V}_{0 \vec{\infty}}(z)=\left((1-z)^{-a}{ }_{2} F_{1}\left(\left.\begin{array}{c}a, c-b \\ c\end{array} \right\rvert\, \frac{z}{z-1}\right), \quad(1-z)^{-a}\left(\frac{z}{z-1}\right)^{1-c}{ }_{2} F_{1}\left(\left.\begin{array}{c}1-b, a-c+1 \\ 2-c\end{array} \right\rvert\, \frac{z}{z-1}\right)\right)$
where we consider the branch by the principal value under appropriate conditions for $a, b, c$. We note that the other half of the 24 solutions can be obtained by Euler's transformation formula ${ }_{2} F_{1}\left(\left.\begin{array}{c}a, b \\ c\end{array} \right\rvert\, z\right)=(1-z)^{c-a-b}{ }_{2} F_{1}\left(\left.\begin{array}{c}c-a, c-b \\ c\end{array} \right\rvert\, z\right)$.

Specifically, we have

where the right lower suffix 11 means the $(1,1)$ entry.
The formulas in Proposition 2 together with (1.6) yields Oi's formula ( $\mathbb{O}$, Theorem 3.1]) describing the hypergeometric function in terms of multiple polylogarithms:

Here an admissible index means a tuple $\mathbf{k}=\left(k_{1}, \ldots, k_{n}\right) \in \mathbb{N}^{n}(n \in \mathbb{N})$ with $k_{n}>1$ and $\mathrm{wt}(\mathbf{k})=k_{1}+\cdots+k_{n}, \operatorname{dp}(\mathbf{k})=n, \operatorname{ht}(\mathbf{k})=\sharp\left\{i \mid k_{i}>1\right\}$.

## 2. $p$-ADIC CASE

Let $p$ be a prime. We will introduce the $p$-adic hypergeometric function by a $p$-adic analogue of (1.6). By exploiting a $p$-adic analogue of (1.7), we perform its analytic prolongation residue-wise and show the $p$-adic analogue of Gauss hypergeometric theorem.
2.1. Formal version of $p$-adic hypergeometric function. We introduce a formal version of $p$-adic hypergeometric function by exploiting a fundamental solution of the $p$-adic KZ equation.

In F04, a $p$-adic analogue of KZ equation (1.1) is introduced and its fundamental solution

G_{01}^{p}\left(T_{0}, T_{1}\right)(z) \in \mathbb{C}_{p}\left\langle\left\langle T_{0}, T_{1}\right\rangle\right\rangle
$$

with $z \in \mathcal{X}\left(\mathbb{C}_{p}\right)$ is constructed. The $p$-adic version of multiple polylogarithm, denoted by $\mathrm{Li}_{\mathbf{k}}^{p}(z)$, is introduced in [F04]. It is defined by the same power series expansion (1.1) around $z=0$ and to be an element of the $\mathbb{C}_{p}$-algebra $\mathcal{O}_{\text {Col }}$ consisting of all Coleman's functions ( Co ), $p$-adic iterated integrals over $\mathcal{X}$. In $\mathrm{F04}$, it is shown that all coefficient of $G_{01}^{p}\left(T_{0}, T_{1}\right)(z)$ is described by combinations of $\mathrm{Li}_{\mathbf{k}}^{p}(z)$ 's and $\log (z)$, exactly in the same formula as Proposition 2, Here $\log (z)$ stands for the $p$-adic logarithm which is a locally analytic group homomorphism $\mathbb{C}_{p}^{\times} \rightarrow \mathbb{C}_{p}$ with a usual power series expansion $-\sum_{i=1}^{\infty} \frac{(1-z)^{i}}{i!}$ around $z=1$ and which is uniquely determined once we fix an image $\log (p)$ in $\mathbb{C}_{p}$, called a branch. Particularly we have $G_{01}^{p}\left(T_{0}, T_{1}\right)(z) \in \mathcal{O}_{\text {Col }}\left\langle\left\langle T_{0}, T_{1}\right\rangle\right\rangle$. Similarly to $\overline{\mathrm{Dr}}$, we have $p$-adic analogues of the other 5 fundamental solutions

G_{\vec{\infty} 1}^{p}\left(T_{0}, T_{1}\right)(z) & :=G_{0 \overrightarrow{01}}^{p}\left(T_{\infty}, T_{1}\right)\left(\frac{1}{z}\right), \\
G_{\infty 0}^{p}\left(T_{0}, T_{1}\right)(z) & :=G_{0 \overrightarrow{0}}^{p}\left(T_{\infty}, T_{0}\right)\left(\frac{1}{1-z}\right), \\
G_{0 \vec{\infty}}^{p}\left(T_{0}, T_{1}\right)(z) & :=G_{\overrightarrow{01}}^{p}\left(T_{0}, T_{\infty}\right)\left(\frac{z}{z-1}\right)
\end{aligned}

with $T_{\infty}=-T_{0}-T_{1}$. In [F04] the $p$-adic KZ associator $\Phi_{\mathrm{KZ}}^{p}\left(T_{0}, T_{1}\right) \in \mathbb{Q}_{p}\left\langle\left\langle T_{0}, T_{1}\right\rangle\right\rangle$ is defined by the quotient

and it is shown that its each coefficient is given by a linear combination of $\zeta_{p}(\mathbf{k}) \in \mathbb{Q}_{p}$ whose exact formula is given in [F04, Theorem 3.30]. Here $\zeta_{p}(\mathbf{k})$ is the $p$-adic multiple zeta value, which is defined to a certain limit of $\operatorname{Li}_{\mathbf{k}}(z)$ to $z=1$.

Let $a, b, c$ are formal variables and consider $2 \times 2$-matrices

The substitution of $(X,-Y)$ for $\left(T_{0}, T_{1}\right)$ in $G_{01}^{p}\left(T_{0}, T_{1}\right)(z)$ converges in $\operatorname{Mat}_{2}\left(\mathcal{O}_{\mathrm{Col}}[[\mathrm{a}, \mathrm{b}, \mathrm{c}-1]]\right)$, which is denoted by $G_{01}^{p}(\mathrm{X},-\mathrm{Y})(z)$.

Our definition of ${ }_{2} F_{1}^{p}\left(\left.\begin{array}{c}\mathrm{a}, \mathrm{b} \\ \mathrm{c}\end{array} \right\rvert\, z\right)$ is stimulated by the equation (1.6) in the complex case:
Definition 3. We define ${ }_{2} F_{1}\left(\left.\begin{array}{c}\mathrm{a}, \mathrm{b} \\ \mathrm{c}\end{array} \right\rvert\, z\right)$ with $z \in \mathcal{X}\left(\mathbb{C}_{p}\right)$ to be its (1, 1$)$-entry

Since all the coefficients of $G_{01}^{p}\left(T_{0}, T_{1}\right)(z)$ are given by polynomial combinations of $p$-adic multiple polylogarithms and the $p$-adic logarithm in the same way as Proposition 2 in the complex case (see [F04, Theorem 3.15]), Oi's formula (1.7) also holds in the $p$-adic case:

2.2. Local behavior around $z=0$. We show that our $p$-adic hypergeometric function agrees with the usual power series expansion (2.2) in a neighborhood of $z=0$ and investigate its convergence in Theorem 6.

Since the restriction of $\operatorname{Li}_{\mathbf{k}}^{p}(z)$ to $] 0[$ is given by (1.1) in $\mathbb{Q}[[z]]$, the restriction of the above ${ }_{2} F_{1}^{p}\left(\left.\begin{array}{c}\mathrm{a}, \mathrm{b} \\ \mathrm{c}\end{array} \right\rvert\, z\right)$ to $] 0[$ determines the series

Proposition 4. The restriction ${ }_{2} F_{1}^{p,] 0[ }\left(\left.\begin{array}{c}a, b \\ c\end{array} \right\rvert\, z\right)$ agrees with the usual power series expansion, that is, we have

where $\mathbb{Q}[\mathrm{a}, \mathrm{b}, \mathrm{c}]_{(\mathrm{c}-1)}$ means the localization of $\mathbb{Q}[\mathrm{a}, \mathrm{b}, \mathrm{c}]$ at the prime ideal $(\mathrm{c}-1)$.
Proof. The formulas (1.2) and (1.7) lift to equations in the rational structure $\mathbb{Q}[[a, b, c-1, z]]$. Whence we have

By ${ }_{2} F_{1}^{p,] 0[ }\left(\left.\begin{array}{c}\mathrm{a}, \mathrm{b} \\ \mathrm{c}\end{array} \right\rvert\, \mathrm{z}\right) \in \mathbb{Q}[\mathrm{a}, \mathrm{b}, \mathrm{c}]_{(\mathrm{c}-1)}[[\mathrm{z}]]$, its specialization $(\mathrm{a}, \mathrm{b}, \mathrm{c}) \mapsto(\alpha, \beta, \gamma) \in \mathbb{Q}_{p}^{3}$ is possible unless it is not located on poles (that is, when $\gamma \neq 0,-1,-2, \ldots$ ) and in that case it is given by

(2). Let $\alpha, \beta \in \mathbb{Z}_{p}$ and $\gamma \in \mathbb{Z}_{(p)}:=\mathbb{Z}_{p} \cap \mathbb{Q}$ with $\gamma \neq 0,-1,-2, \ldots$. Then the series (2.2) converges on $\left\{\left.\mathrm{z} \in \mathbb{C}_{p}| | \mathrm{z}\right|_{p}<1\right\}$.

Proof. (1). Let $R$ be the radius of convergence of ${ }_{2} F_{1}^{p}\left(\left.\begin{array}{c}\alpha, \beta \\ \gamma\end{array} \right\rvert\, \mathrm{z}\right) \in \mathbb{Q}_{p}[[\mathrm{z}]]$ and denote $d_{n}$ to be the coefficient of $\mathrm{z}^{n}$ in ${ }_{2} F_{1}{ }^{p}\left(\begin{array}{c}\alpha, \beta \\ \gamma\end{array} \mathrm{z}\right)$;

For $\eta \in \mathbb{Z}_{p}$ with the $p$-adic digit expansion $\eta=e_{0}+e_{1} p+e_{2} p^{2}+\cdots\left(e_{i} \in[0, p-1]\right)$ and $k \geq 0$, we put

Put $l_{n}=$ $t\left(-\gamma ;\left\lfloor\log _{p} n\right\rfloor\right), L_{n}=T\left(-\gamma ;\left\lfloor\log _{p} n\right\rfloor\right)$ and $m_{n}=\left\lfloor\log _{p} L_{n}\right\rfloor$. Then we have $n<L_{n}$, $p^{m_{n}} \leq L_{n}<p^{m_{n}+1}$ and $-\gamma \equiv L_{n} \not \equiv 0 \bmod p^{m_{n}+1}$. So we have

we have $-\log _{p} R \leq \frac{S}{p-1}$, which says $R \geq p^{-\frac{S}{p-1}}$.
(2). It is because $S$ in (2.3) is 0 for such $\gamma$.
2.3. Local behavior on $] \mathbb{P}^{1} \backslash\{0,1, \infty\}[$. We perform an analytic continuation of our $p$-adic hypergeometric function to $] \mathbb{P}^{1} \backslash\{0,1, \infty\}[$ residuewise in Theorem 7 .

Let $\xi \in \mathbb{C}_{p}$ be any root of unity whose order is prime to $p$ and assume $\xi \neq 1$. The tube $] \bar{\xi}\left[\right.$ is defined by $\operatorname{red}^{-1}(\bar{\xi})$ under the reduction map red : $\mathbb{P}^{1}\left(\mathbb{C}_{p}\right) \rightarrow \mathbb{P}^{1}\left(\overline{\mathbb{F}}_{p}\right)$. Since the restrictions of all $\operatorname{Li}_{\mathbf{k}}(z)$ 's to $] \bar{\xi}\left[\right.$ are in $\mathbb{C}_{p}[[z-\xi]]$, the restriction of ${ }_{2} F_{1}^{p}\left(\left.\begin{array}{c}\mathrm{a}, \mathrm{b} \\ \mathrm{c}\end{array} \right\rvert\, z\right) \in \mathcal{O}_{\mathrm{Col}}[[\mathrm{a}, \mathrm{b}, \mathrm{c}-1]]$ to the tube $] \bar{\xi}[$ corresponds to the series

Theorem 7. (1). Actually ${ }_{2} F_{1}^{p,] \xi[ }(\underset{c}{\mathrm{a}, \mathrm{b}} \underset{\mathrm{c}}{\mathbb{Z}} \mid \mathrm{z})$ is in $\mathbb{Q}_{p}(\xi)[[\mathrm{a}, \mathrm{b}, \mathrm{c}-1, \mathrm{z}-\xi]]$.
(2). Let $z \in \mathbb{C}_{p}$ and $\alpha, \beta, \gamma \in \mathbb{Z}_{p}$. Then the substitution of (2.4) sending $(\mathrm{a}, \mathrm{b}, \mathrm{c}, \mathrm{z})$ to $(\alpha, \beta, \gamma, z)$ converges when $|z-\xi|<p^{-\frac{1}{p-1}}$.
(3). Let $z \in \mathbb{C}_{p}$ and $\alpha, \beta, \gamma \in \mathbb{Z}_{(p)}:=\mathbb{Q} \cap \mathbb{Z}_{p}$. Then the specialization of (2.4) at $(\mathrm{a}, \mathrm{b}, \mathrm{c}, \mathrm{z})=(\alpha, \beta, \gamma, z)$ converges when $|z-\xi|<1$.
Proof. (1). For an integer $k \geqslant 0$, we consider "the PD-ideal" $\mathfrak{p}^{[k]}$ of $\mathcal{O}_{\mathbb{C}_{p}}$ defined by

From the Taylor expansion

k \geqslant n+s, n \geqslant s}} g_{0, \xi}^{(i)}(k, n, s) \mu^{k-n-s} \nu^{n-s}(\alpha \beta+\mu \nu)^{s-1},  \tag{2.6}\\
& \mu=1-\gamma, \quad \nu=\alpha+\beta+1-\gamma=\alpha+\beta+\mu, \\
& g_{0, \xi}^{(i)}(k, n, s):=\sum_{\substack{\text { wt(k)=k, } \mathbf{c}(\mathbf{k})=n, \text { ht }(\mathbf{k})=s \\
\text { k: admissible index }}} \operatorname{Li}_{\mathbf{k}}^{(i)}(\xi) \in \mathfrak{p}^{[k-i]}
\end{align*}

because the right hand side of (2.6) converges on $\mathbb{Q}_{p}(\xi)$.
(2). Since we have $c_{\xi, i} \in \mathcal{O}_{\mathbb{C}_{p}}$, we see that the series (2.5) converges when $|z-\xi|_{p}<p^{-\frac{1}{p-1}}$.
(3). By the above arguements, we wee that ${ }_{2} F_{1}^{p,] \xi[ }\left(\left.\begin{array}{c}\alpha, \beta \\ \gamma\end{array} \right\rvert\, z\right)$ converges when $|z-\xi|<p^{-\frac{1}{p-1}}$ for any non-unit root $\xi$ of unity whose order is prime to $p$.

The restrictions of all $\mathrm{Li}_{\mathbf{k}}(z)$ 's to $] \bar{\xi}\left[\right.$ is in $\mathbb{C}_{p}[[z-\xi]]$. When $\alpha, \beta, \gamma \in \mathbb{Z}_{(p)}$, a general series solution of the hypergeometric differential equation at $z=z_{0} \in \mathcal{O}_{\mathbb{C}_{p}}$, that is not congruent to 0 and 1 , converges on $\left|z-z_{0}\right|<1$
by [K, Example 9.6.2]. Therefore ${ }_{2} F_{1}^{p,] \xi[ }\left(\left.\begin{array}{c}\alpha, \beta \\ \gamma\end{array} \right\rvert\, z\right)$ is a rigid-analytic function on $] \bar{\xi}$.
2.4. Local behavior around $z=\infty$. We investigate a convergence of our $p$-adic hypergeometric function around a neighborhood of $\infty$ in Theorem 9 ,

The following is required to our convergence.
Lemma 8. Let $K$ be a field extension of $\mathbb{Q}_{p}$ in $\mathbb{C}_{p}$ with

\mathcal{V}_{\overrightarrow{10}}^{p}(z)=G_{\overrightarrow{01}}^{p}(-Y, X)(1-z) \cdot\left(\begin{array}{cc}
1 & 0 \\
-\frac{a}{v} & \frac{v-1}{b}
\end{array}\right) . \tag{2.17}
\end{gather*}
$$

By comparing the (1, 1)-entry of both sides of (2.16) and the calculations in F21, Theorem 3.3], we obtain
${ }_{2} F_{1}^{p}\left(\left.\begin{array}{c}\mathrm{a}, \mathrm{b} \\ \mathrm{c}\end{array} \right\rvert\, z\right)=\Gamma_{\Phi_{\mathrm{KZ}}^{p}}\binom{-\mathrm{u},-\mathrm{v}}{-\mathrm{u}-\mathrm{a},-\mathrm{u}-\mathrm{b}}\left[\mathcal{V}_{\overrightarrow{10}}^{p}(z)\right]_{(1,1)}+\Gamma_{\Phi_{\mathrm{KZ}}^{p}}\binom{\mathrm{u},-\mathrm{v}}{-\mathrm{a},-\mathrm{b}}\left[\mathcal{V}_{\overrightarrow{10}}^{p}(z)\right]_{(1,2)}$
in $\mathcal{R}\left[\frac{1}{\mathrm{vb}}\right]$ because $\Phi_{\mathrm{KZ}}^{p}$ is an associator, where

$$

with $\Gamma_{\Phi_{\mathrm{KZ}}^{p}}(s):=\exp \left\{\sum_{n=1}^{\infty} \frac{(-1)^{n} \zeta_{p}(n)}{n} s^{n}\right\} \in \mathbb{Q}_{p}[[s]]$.
Since the restrictions of all the coefficients of $G_{01}^{p}\left(e_{0}, e_{1}\right)(z)$ to $\left.z \in\right] 0[$ are in

G_{10}^{p,] 1[ }(X,-Y)(\mathrm{z})\left(=G_{010}^{p,] 0[ }(-Y, X)(1-\mathrm{z})\right) \in \mathrm{GL}_{2}\left(\left(\mathbb{Q}\left[\mathrm{~L}_{1}\right][[\mathrm{a}, \mathrm{~b}, \mathrm{c}-1,1-\mathrm{z}]]\right) .\right.

By (2.17), we have the associated matrix
$\mathcal{V}_{10}^{p,] 1[ }(\mathrm{z}):=G_{01}^{p,] 0}(-Y, X)(1-\mathrm{z}) \cdot\left(\begin{array}{cc}1 & 0 \\ \frac{-\mathrm{a}}{\mathrm{v}} & \frac{\mathrm{v}-1}{\mathrm{~b}}\end{array}\right) \in \mathrm{GL}_{2}\left(\left(\mathbb{Q}\left[\mathrm{~L}_{1}\right][[\mathrm{a}, \mathrm{b}, \mathrm{c}-1,1-\mathrm{z}]]\left[\frac{1}{\mathrm{vb}}\right]\right)\right.$
While in the complex case, the matrix

\mathcal{V}_{\overrightarrow{10}}^{\mathbb{C},] 1[ }(\mathrm{z}) \in \mathrm{GL}_{2}\left(\left(\mathbb{C}\left[\mathrm{~L}_{1}\right][[\mathrm{a}, \mathrm{~b}, \mathrm{c}-1,1-\mathrm{z}]]\left[\frac{1}{\mathrm{vb}}\right]\right)\right.
$$

associated with

$$
\mathcal{V}_{\overrightarrow{10}}(z)=G_{\overrightarrow{01}}\left(-Y_{0}, X_{0}\right)(1-z) \cdot\left(\begin{array}{cc}
1 & 0 \\
\frac{-a}{v} & \frac{v-1}{b}
\end{array}\right)
$$

agrees with the matrix $\mathcal{V}_{\overrightarrow{10}}^{p,] 1[ }(z) \in \operatorname{GL}_{2}\left(\left(\mathbb{Q}\left[\mathrm{~L}_{1}\right][[\mathrm{a}, \mathrm{b}, \mathrm{c}-1,1-\mathrm{z}]]\left[\frac{1}{\mathrm{vb}}\right]\right)\right.$, i.e. $\mathcal{V}_{\overrightarrow{10}}^{\mathbb{C},] 1[ }(\mathrm{z})=$ $\mathcal{V}_{\overrightarrow{10}}^{p,] 1[ }(\mathbf{z})$, since $G_{01}\left(T_{0}, T_{1}\right)(z)$ and $G_{01}^{p}\left(T_{0}, T_{1}\right)(z)$ share the same presentation in terms of multiple polylogarithms and the logarithm. By (1.4) and (1.5) the first row is calculated to be

\end{array} \right\rvert\, 1-z\right), \quad(1-z)^{c-a-b-1} \cdot(1-z)_{2} F_{1}\left(\left.\begin{array}{c}
c-a, c-b \\
c-a-b+1
\end{array} \right\rvert\, 1-z\right)\right)
\end{aligned}
$$

for $(\mathrm{a}, \mathrm{b}, \mathrm{c})=(a, b, c) \in \mathbb{C}^{3}$ satisfying suitable conditions. By regarding $a, b, c-1$ and $1-z$ as formal variables, we see that
$\left[\mathcal{V}_{\overrightarrow{10}}^{\mathbb{C},] 1}(\mathrm{z})\right]_{(1,1)} \in \mathbb{Q}(\mathrm{a}, \mathrm{b}, \mathrm{c})[[1-\mathrm{z}]]$ and $(1-\mathrm{z})^{\mathrm{v}-1} \cdot\left[\mathcal{V}_{\overrightarrow{10}}^{\mathbb{C},] 1[ }(\mathrm{z})\right]_{(1,2)} \in \mathbb{Q}(\mathrm{a}, \mathrm{b}, \mathrm{c})[[1-\mathrm{z}]]$.
This implies
$\left[\mathcal{V}_{\overrightarrow{10}}^{p,] 1[ }(\mathrm{z})\right]_{(1,1)} \in \mathbb{Q}(\mathrm{a}, \mathrm{b}, \mathrm{c})[[1-\mathrm{z}]]$ and $(1-\mathrm{z})^{\mathrm{v}-1} \cdot\left[\mathcal{V}_{\overrightarrow{10}}^{p,] 1[ }(\mathrm{z})\right]_{(1,2)} \in \mathbb{Q}(\mathrm{a}, \mathrm{b}, \mathrm{c})[[1-\mathrm{z}]]$,
which are actually calculated to be equal to ${ }_{2} F_{1}^{p,] 0[ }\left(\left.\begin{array}{c}\mathrm{a}, \mathrm{b} \\ \mathrm{a}+\mathrm{b}+1-\mathrm{c}\end{array} \right\rvert\, 1-\mathrm{z}\right)$ and ${ }_{2} F_{1}^{p,] 0[ }\left(\left.\begin{array}{c}\mathrm{c}-\mathrm{a}, \mathrm{c}-\mathrm{b} \\ \mathrm{c}-\mathrm{a}-\mathrm{b}+1\end{array} \right\rvert\, 1-\mathrm{z}\right)$ as elements of $\mathbb{Q}(a, b, c)[[1-z]]$.

Thus by taking $r_{1}=\Gamma_{\Phi_{\mathrm{KZ}}^{p}}\binom{-\mathrm{u},-\mathrm{v}}{-\mathrm{u}-\mathrm{a},-\mathrm{u}-\mathrm{b}}, r_{2}=\Gamma_{\Phi_{\mathrm{KZ}}^{p}}\binom{\mathrm{u},-\mathrm{v}}{-\mathrm{a},-\mathrm{b}}$ in $\mathbb{Q}_{p}[[\mathrm{a}, \mathrm{b}, \mathrm{c}-1]]$, $S_{1}=\left[\mathcal{V}_{\overrightarrow{10}}^{p,] 1[ }(\mathrm{z})\right]_{(1,1)}$ and $S_{2}=\left[\mathcal{V}_{\overrightarrow{10}}^{p,] 1[ }(\mathrm{z})\right]_{(1,2)}$, we obtain the claim.

Therefore, by (2.18) we have the following:

\mathrm{a}, \mathrm{~b} \\
\mathrm{a}+\mathrm{b}+1-\mathrm{c}
\end{array} \right\rvert\, 1-\mathrm{z}\right) \\
\quad+\Gamma_{\Phi_{\mathrm{KZ}}^{p}}\binom{\mathrm{u},-\mathrm{v}}{-\mathrm{a},-\mathrm{b}} \cdot(1-\mathrm{z})^{-\mathrm{v}} \cdot(1-\mathrm{z})_{2} F_{1}^{p,] 0[ }\left(\left.\begin{array}{c}
\mathrm{c}-\mathrm{a}, \mathrm{c}-\mathrm{b} \\
\mathrm{c}-\mathrm{a}-\mathrm{b}+1
\end{array} \right\rvert\, 1-\mathrm{z}\right)
\end{gather*}
$$

where ${ }_{2} F_{1}^{p,] 0[ }\left(\left.\begin{array}{c}a, b \\ \mathrm{a}+\mathrm{b}+1-\mathrm{c}\end{array} \right\rvert\, 1-\mathrm{z}\right)$ and ${ }_{2} F_{1}^{p,] 0[ }\left(\left.\begin{array}{c}\mathrm{c}-\mathrm{a}, \mathrm{c}-\mathrm{b} \\ \mathrm{c}-\mathrm{a}-\mathrm{b}+1\end{array} \right\rvert\, 1-\mathrm{z}\right)$ are regarded to be elements in $\mathbb{Q}(a, b, c)[[1-z]] \cap \frac{1}{v} \mathbb{Q}[[a, b, c-1,1-z]]$.

Theorem 11. Let $z$ be in a field extension $K$ of $\mathbb{Q}_{p}$ in $\mathbb{C}_{p}$ with $e_{K}<p-1$ where $e_{K}$ means the absolute ramification index of $K$. Assume that $\alpha, \beta, \gamma \in \mathbb{Z}_{p}$ with $|\alpha|_{p},|\beta|_{p},|\gamma-1|_{p}<1$ and $\alpha+\beta-\gamma \in \mathbb{Z}_{(p)} \backslash \mathbb{N}_{ \pm}$and that the branch of the p-adic logarithm is chosen to be $\log (p) \in \mathcal{O}_{K}$. Then the specialization ${ }_{2} F_{1}^{p,] 1[ }\left(\left.\begin{array}{c}\alpha, \beta \\ \gamma\end{array} \right\rvert\, z\right)$ sending $\left(\mathrm{a}, \mathrm{b}, \mathrm{c}-1,1-\mathrm{z}, \mathrm{L}_{1}\right)$ to $(\alpha, \beta, \gamma-1,1-z, \log (1-z))$ makes sense and converges on $K$ when $0<|z-1|_{p}<1$.

Proof. By our assumption on the $p$-adic logarithm and $|\nu|_{p}<1(\nu=\alpha+\beta+1-\gamma)$, $\langle 1-z\rangle^{-\nu}:=\exp \{-\nu \log (1-z)\}$ converges by Lemma 8 .

By the conditions $\alpha, \beta, \gamma \in \mathbb{Z}_{p}$ and $\alpha+\beta-\gamma \in \mathbb{Z}_{(p)} \backslash \mathbb{N}_{ \pm}$, we learn from Theorem 6 that both $p$-adic series ${ }_{2} F_{1}^{p,] 0[ }\left(\left.\begin{array}{c}\alpha, \beta \\ \alpha+\beta+1-\gamma\end{array} \right\rvert\, 1-z\right)$ and $\langle 1-z\rangle^{-\nu} \cdot(1-$ $z)_{2} F_{1}^{p,] 0[ }\left(\left.\begin{array}{c}\gamma-\alpha, \gamma-\beta \\ \gamma-\alpha-\beta+1\end{array} \right\rvert\, 1-z\right)$ converge when $|z-1|_{p}<1$.

Again by our condition $|\alpha|_{p},|\beta|_{p},|\gamma-1|_{p}<1$ and $\zeta_{p}(k) \in \mathbb{Z}_{p}$ for all $k$, both $\Gamma_{\Phi_{\mathrm{KZ}}^{p}}\binom{-\mu,-\nu}{-\mu-\alpha,-\mu-\beta}$ and $\Gamma_{\Phi_{\mathrm{KZ}}^{p}}\binom{\mu,-\nu}{-\alpha,-\beta}$ converge on $\mathbb{Q}_{p}$. Therefore we obtain the claim by (2.19).

Actually by (2.19), we obtain

\alpha, \beta \\
\alpha+\beta+1-\gamma
\end{array} \right\rvert\, 1-z\right)  \tag{2.20}\\
& \quad+\Gamma_{\Phi_{\mathrm{KZ}}^{p}}\binom{\mu,-\nu}{-\alpha,-\beta} \cdot\langle 1-z\rangle^{-\nu} \cdot(1-z)_{2} F_{1}\left(\left.\begin{array}{c}
\gamma-\alpha, \gamma-\beta \\
\gamma-\alpha-\beta+1
\end{array} \right\rvert\, 1-z\right)
\end{align*}
$$

when $|z-1|_{p}<1$, which is a $p$-adic analogue of the connection formula

$$
\begin{aligned}
{ }_{2} F_{1}\left(\left.\begin{array}{c}
a, b \\
c
\end{array} \right\rvert\, z\right)= & \frac{\Gamma(c) \Gamma(c-a-b)}{\Gamma(c-a) \Gamma(c-b)}{ }_{2} F_{1}\left(\left.\begin{array}{c}
a, b \\
a+b-c+1
\end{array} \right\rvert\, 1-z\right) \\
& +(1-z)^{c-a-b} \frac{\Gamma(c) \Gamma(a+b-c)}{\Gamma(a) \Gamma(b)}{ }_{2} F_{1}\left(\left.\begin{array}{c}
c-a, c-b \\
c-a-b+1
\end{array} \right\rvert\, 1-z\right)
\end{aligned}
$$

known in the complex case (cf. AAR, 15.3.7]).
The following is a $p$-adic analogue of Gauss hypergeometric theorem (1.3).
Theorem 12. Under the assumption of Theorem 11, we have

$$
\lim _{\substack{z \rightarrow 1 \\
z \in K}} F_{1}^{p}\left(\left.\begin{array}{c}
\alpha, \beta \\
\gamma
\end{array} \right\rvert\, z\right)=\prod_{k=1}^{\infty} \frac{\Gamma_{p}\left(1+p^{k} \mu+p^{k} \alpha\right) \cdot \Gamma_{p}\left(1+p^{k} \mu+p^{k} \beta\right)}{\Gamma_{p}\left(1+p^{k} \mu\right) \cdot \Gamma_{p}\left(1+p^{k} \nu\right)}
$$

with $\mu=1-\gamma$ and $\nu=\alpha+\beta+1-\gamma$, where $\Gamma_{p}$ is Morita's $p$-adic gamma function ([М]) defined by

$$

\Gamma_{p}(1-z)=\exp \left\{\gamma_{p} z+\sum_{n=2}^{\infty} L_{p}\left(n, \omega^{1-n}\right) \frac{z^{n}}{n!}\right\} \tag{2.21}
\end{equation*}

( $\gamma_{p}$ : a p-adic analogue of Euler constant) converging on $|z|_{p}<1$.
Proof. We have

$$
\begin{aligned}
\lim _{\substack{z \rightarrow 1 \\
z \in K}}\langle 1-z\rangle^{-\nu} \cdot(1-z) & \left.=\lim _{\substack{z \rightarrow 1 \\
z \in K}} \exp \{-\nu r \log (p)-\nu \log (1+m))\right\} \cdot(1-z) \\
& \left.=\lim _{\substack{z \rightarrow 1 \\
z \in K}} \exp \{-\nu r \log (p)\} \exp \{-\nu \log (1+m))\right\} \cdot \epsilon p^{r}(1+m)=0
\end{aligned}
$$

when writing $1-z=\epsilon \cdot p^{r}(1+m)$ with $\epsilon \in \mu_{\infty}, r \in \mathbb{Q}_{+}$and $m \in \mathfrak{m}_{K}$. So

$$
\lim _{\substack{z \rightarrow 1 \\
z \in K}}\langle 1-z\rangle^{-\nu} \cdot(1-z) \cdot{ }_{2} F_{1}^{p}\left(\left.\begin{array}{c}
\gamma-\alpha, \gamma-\beta \\
\gamma-\alpha-\beta+1
\end{array} \right\rvert\, 1-z\right)=0 .
$$

By (2.20), we have

$$
\lim _{\substack{z \rightarrow 1 \\
z \in K}} F_{1}^{p}\left(\left.\begin{array}{c}
\alpha, \beta \\
\gamma
\end{array} \right\rvert\, z\right)=\Gamma_{\Phi_{\mathrm{KZ}}^{p}}\binom{-\mu,-\nu}{-\mu-\alpha,-\mu-\beta} .
$$

By

$$
\Gamma_{\Phi_{\mathrm{KZ}}^{p}}(z)=\exp \left\{\sum_{n=2}^{\infty} \frac{(-1)^{n}}{n} \zeta_{p}(n) z^{n}\right\}=\exp \left\{\frac{p \gamma_{p}}{p-1} z\right\} \prod_{k=1}^{\infty} \Gamma_{p}\left(1+p^{k} z\right)^{-1}
$$

and $\Gamma_{\Phi_{\mathrm{KZ}}^{p}}(z) \Gamma_{\Phi_{\mathrm{KZ}}^{p}}(-z)=1$, we obtain the claim.
Remark 13. It is not clear how our $p$-adic hypergeometric function ${ }_{2} F_{1}^{p}\left(\left.\begin{array}{c}\alpha, \beta \\ \gamma\end{array} \right\rvert\, z\right)$ $\left(\alpha, \beta, \gamma \in \mathbb{Z}_{(p)}\right.$ with $\left.\gamma \neq 0,-1,-2, \ldots\right)$ is related to that of Dwork ( $\left.\overline{\mathrm{Dw}}\right)$.
