# NOTES ON KASHIWARA-VERGNE AND DOUBLE SHUFFLE LIE ALGEBRAS

#### Abstract

We explain the current situation of the relationship between the Kashiwara-Vergne Lie algebra $\mathfrak{k r v}$ and the double shuffle Lie algebra $\mathfrak{d m r}$. We also show the validity of Ecalle's senary relation for small depths.

## 0. Introduction

The double shuffle Lie algebra $\mathfrak{d m r}$ (cf. Definition 20) is the graded Lie algebra constructed by Racinet [R02]. The symbol $\mathfrak{d m r}$ stands for 'double mélange et régularisation' in French, the regularized double shuffle relations among multiple zeta values, which serve as defining equations of the Lie algebra.

The Kashiwara-Vergne Lie algebra $\mathfrak{k r v}$ (cf. Definition 17) is the graded Lie algebra introduced by Alekseev, Torossian and Enriquez AT, AET. It is constructed from the set of solutions of the KashiwaraVergne problem.

It is expected that those two Lie algebras are isomorphic (cf. [F14]). So far, we know that there exists an inclusion from $\mathfrak{d m r}$ to $\mathfrak{k r v}$ under a

[^0]certain assumption on Ecalle's mould theory [Ec11] by Schneps's results (Sch12] Theorem 1.1):

Theorem 1 ([Sch12]). Assume that the following senary relation ( $c f$. [Ec11, (3.64)])

holds for any $r \geqslant 1$ and mould $M=\operatorname{ma}_{\tilde{f}}$ for $\tilde{f} \in \mathfrak{d m r}$. Then the map

$$
\begin{equation*}
\nu: \mathbb{L} \rightarrow \mathfrak{d e r} ; \quad \tilde{f} \mapsto d_{F} \tag{0.2}
\end{equation*}
$$

gives a Lie algebra embedding from $\mathfrak{d m r}$ into $\mathfrak{k r v}$.
As for moulds, teru, push, mantar and ma, see $\S \mathbb{1}$. For $\mathbb{L}$, $\mathfrak{d e r}$, $\tilde{f}$ and $d_{F}$, see 82 (particularly for the last two, see (2.2) and (2.4) respectively). Although the assumption (0.1) is stated as a theorem of Ecalle in [Sch12, Theorem 3.1 and A.1], no proof seems to be provided in any references as far as the authors know. Regarding the assumption (0.1), it should be mentioned that the appendix of [Sch12] says the following:

Proposition 2 ([Sch12]). Let $\tilde{f}$ be a Lie element in $\mathbb{L}$ with degree $>2$. Put $M=\operatorname{ma}_{\tilde{f}}$. Then giving the senary relation (0.1) for all $r \geqslant 1$ is equivalent to giving that $d_{F}$ belongs to the Lie subalgebra $\mathfrak{s d e r}$ of $\mathfrak{d e r}$ (cf. Definition 16).

In 83, we extract a direct proof of this statement from the arguments of Sch12. As a corollary of Theorem[1] and Proposition 2, the following inclusion is immediately obtained:

Corollary 3 ([Sch12]). The map (0.2) gives an inclusion

$$
\begin{equation*}
\mathfrak{d m r} \cap \nu^{-1}(\mathfrak{s d e r}) \hookrightarrow \mathfrak{k r v} . \tag{0.3}
\end{equation*}
$$

In this paper we check the validity of the assumption (0.1) in small $r$ :

Theorem 4. The senary relation (0.1) holds for any mould $M=\operatorname{ma}_{\tilde{f}}$ with $\tilde{f} \in \mathfrak{d m r}$ when $r=1,2$ and 3 .

The proof is given by mould theoretical arguments.
Remark 5. Since Drinfeld's Grothendieck-Teichmüller Lie algebra $\mathfrak{g r t}$ is contained in $\mathfrak{s d e r}$ by [D, Proposition 5.7] and the inclusion from $\mathfrak{g r t}$ to $\mathfrak{d m r}$ is constructed in [F11, EF], we have a sequence of inclusions

$$
\begin{equation*}
\mathfrak{g r t} \hookrightarrow \mathfrak{d m r} \cap \nu^{-1}(\mathfrak{s d e r}) \quad \hookrightarrow \mathfrak{k r v} . \tag{0.4}
\end{equation*}
$$

Remark 6. The inclusion

$$
\operatorname{Fil}_{\mathcal{D}}^{2} \mathbb{D}(\Gamma) . \bullet \hookrightarrow \mathfrak{l k r v}(\Gamma) \bullet \bullet
$$

which is regarded to be a bigraded variant of (0.3) in the case of $\Gamma=$ $\{e\}$, where $\Gamma$ is an abelian group, is constructed in [FK].

The remainder of this paper proceeds as follows: $\S 1$ is a quick review on the notions of mould theory which are required in the paper. We recall the definitions of two Lie algebras in $\$ 2$. We give a stream-lined proof of Proposition 2 in 83 . Theorem 4 is proved in $\$ 4$.

## 1. Mould theory

We briefly review several notions of Ecalle's mould theory by borrowing the notations in our previous joint paper [FK, §1] where moulds indexed by a finite abelian group $\Gamma$ is introduced. We put $\mathcal{F}:=$ $\bigcup_{m \geqslant 1} \mathbb{Q}\left[x_{1}, \ldots, x_{m}\right]$.

Definition 7 (Ec81 I, pp.12-13 and Sch15]). A mould on $\mathbb{Z}_{\geqslant 0}$ with values in $\mathcal{F}$ means a sequence

M=\left(M^{m}\left(x_{1}, \ldots, x_{m}\right)\right)_{m \in \mathbb{Z} \geqslant 0}=\left(M^{0}(\emptyset), M^{1}\left(x_{1}\right), M^{2}\left(x_{1}, x_{2}\right), \ldots\right),
$$

with $M^{0}(\emptyset) \in \mathbb{Q}$ and $M^{m}\left(x_{1}, \ldots, x_{m}\right) \in \mathbb{Q}\left[x_{1}, \ldots, x_{m}\right]$ for $m \geqslant 1$. The set of all moulds with values in $\mathcal{F}$ is denoted by $\mathcal{M}(\mathcal{F})$. The set $\mathcal{M}(\mathcal{F})$ forms a non-commutative, associative, unital $\mathbb{Q}$-algebra by

c M & :=\left(c M^{m}\left(x_{1}, \ldots, x_{m}\right)\right)_{m \in \mathbb{Z} \geqslant 0} \\
M \times N & :=\left(\sum_{i=0}^{m} M^{i}\left(x_{1}, \ldots, x_{i}\right) N^{m-i}\left(x_{i+1}, \ldots, x_{m}\right)\right)_{m \in \mathbb{Z} \geqslant 0}
\end{aligned}
$$

for $M, N \in \mathcal{M}(\mathcal{F})$ and $c \in \mathbb{Q}$. Its unit $I \in \mathcal{M}(\mathcal{F})$ is given by $I:=$ $(1,0,0, \ldots)$.

A mould $C=\left(C^{m}\left(x_{1}, \ldots, x_{m}\right)\right)_{m \in \mathbb{Z} \geqslant 0} \in \mathcal{M}(\mathcal{F})$ is called constant when we have $C^{m}\left(x_{1}, \ldots, x_{m}\right) \in \mathbb{Q}$ for all $m \in \mathbb{Z}_{\geqslant 0}$ 's. The unit $I$ is a constant mould. For our simplicity, we denote each component $C^{m}\left(x_{1}, \ldots, x_{m}\right)$ of a constant mould $C$ by $C_{m}$.

We equip $\mathcal{M}(\mathcal{F})$ with the depth filtration $\left\{\operatorname{Fil}_{\mathcal{D}}^{m} \mathcal{M}(\mathcal{F})\right\}_{m \geqslant 0}$ where $\operatorname{Fil}_{\mathcal{D}}^{m} \mathcal{M}(\mathcal{F})$ consists of moulds with $M^{r}\left(x_{1}, \ldots, x_{r}\right)=0$ for $r<m$. The algebraic structure of $\mathcal{M}(\mathcal{F})$ is compatible with the depth filtration and the subspace

$$
\mathrm{ARI}:=\left\{M \in \mathcal{M}(\mathcal{F}) \mid M^{0}(\emptyset)=0\right\} .
$$

forms a filtered (non-unital) subalgebra.
We call a mould $M \in \mathcal{M}(\mathcal{F})$ finite when $M^{m}\left(x_{1}, \ldots, x_{m}\right)=0$ except for finitely many $m$ 's. We put the upper letters "fin" as $\mathcal{M}(\mathcal{F})^{\mathrm{fin}}$, ARI ${ }^{\text {fin }}$, etc. to indicate the finite part.

For our later use, we prepare several operations on $\mathcal{M}(\mathcal{F})$ :
Definition 8 ([Ec11]). We consider the following $\mathbb{Q}$-linear operators defined by, for any mould $M=\left(M^{m}\left(u_{1}, \ldots, u_{m}\right)\right)_{m}$ in $\mathcal{M}(\mathcal{F})$,

& \operatorname{swap}(M)^{m}\left(v_{1}, \ldots, v_{m}\right)=M^{m}\left(v_{m}, v_{m-1}-v_{m}, \ldots, v_{1}-v_{2}\right) \\
& \operatorname{pus}(M)^{m}\left(u_{1}, \ldots, u_{m}\right)=M^{m}\left(u_{m}, u_{1}, \ldots, u_{m-1}\right) \\
& \operatorname{teru}(M)^{m}\left(u_{1}, \ldots, u_{m}\right)=M^{m}\left(u_{1}, \ldots, u_{m}\right) \\
& \quad+\frac{1}{u_{m}}\left\{M^{m-1}\left(u_{1}, \ldots, u_{m-2}, u_{m-1}+u_{m}\right)-M^{m-1}\left(u_{1}, \ldots, u_{m-2}, u_{m-1}\right)\right\} .
\end{aligned}
$$

We remark that swap o swap = id.
Definition 9. (1). A mould $M \in \mathcal{M}(\mathcal{F})$ is called pus-neutral (Ec11, (2.73)]) if

\sum_{i=1}^{m} \operatorname{pus}^{i}(M)^{m}\left(u_{1}, \ldots, u_{m}\right)\left(=\sum_{i \in \mathbb{Z} / m \mathbb{Z}} M^{m}\left(u_{1+i}, \ldots, u_{m+i}\right)\right)=0
$$

holds for all $m \geqslant 1$.
(2). The $\mathbb{Q}$-linear space $\operatorname{ARI}_{\text {sena/pusnu }}$ is the subset of ARI consisting of all moulds $M$ satisfying Ecalle's senary relation (0.1) for all $r \geqslant 1$ and the pus-neutrality for $\operatorname{swap}(M)$.

To explain the notion of the alternality of moulds, we prepare some algebraic formulation: Set $X:=\left\{x_{i}\right\}_{i \in \mathbb{N}}$. We denote by $X_{\mathbb{Z}}$ the free $\mathbb{Z}$ module spanned by all elements of $X$. Let $X_{\mathbb{Z}}^{\bullet}$ be the non-commutative free monoid generated by all elements of $X_{\mathbb{Z}}$ with the empty word $\emptyset$ as the unit. We sometimes write each element $\omega=u_{1} \cdots u_{m} \in X_{\mathbb{Z}}^{\bullet}$ with $u_{1}, \ldots, u_{m} \in X_{\mathbb{Z}}$ by $\omega=\left(u_{1}, \ldots, u_{m}\right)$ as a sequence. We put $l(\omega):=m$ and call this the length of $\omega=u_{1} \cdots u_{m}$.

For our simplicity, we occasionally denote

$$
M=\left(M^{m}\left(\mathbf{x}_{m}\right)\right)_{m \in \mathbb{Z} \geqslant 0} \quad \text { or } \quad M=\left(M\left(\mathbf{x}_{m}\right)\right)_{m \in \mathbb{Z} \geqslant 0},
$$

with $\mathbf{x}_{0}:=\emptyset$ and $\mathbf{x}_{m}:=\left(x_{1}, \ldots, x_{m}\right)$ for $m \geqslant 1$. Under the notations, the product of $M, N \in \mathcal{M}(\mathcal{F})$ is presented as

$$
M \times N:=\left(\sum_{\mathbf{x}_{m}=\alpha \beta} M^{l(\alpha)}(\alpha) N^{l(\beta)}(\beta)\right)_{m \in \mathbb{Z} \geqslant 0}
$$

where $\alpha$ and $\beta$ run over $X_{\mathbb{Z}}$.
We set $\mathcal{A}:=\mathbb{Q}\left\langle X_{\mathbb{Z}}\right\rangle$, the non-commutative polynomial algebra generated by $X_{\mathbb{Z}}$. So $\mathcal{A}$ is the $\mathbb{Q}$-linear space generated by $X_{\mathbb{Z}}^{\bullet}$. ${ }^{1}$ We equip $\mathcal{A}$ with a product $\amalg: \mathcal{A} \otimes \mathcal{A} \rightarrow \mathcal{A}$ which is the linear map defined by $\emptyset$ Ш $\omega:=\omega$ Ш $\emptyset:=w$ and

$$
\begin{equation*}
u \omega \amalg v \eta:=u(\omega ш v \eta)+v(u \omega ш \eta) \tag{1.1}
\end{equation*}
$$

for $u, v \in X_{\mathbb{Z}}$ and $\omega, \eta \in X_{\mathbb{Z}}^{\bullet}$. Then the pair $(\mathcal{A}, ш)$ is a commutative, associative, unital $\mathbb{Q}$-algebra.

We consider the family $\left\{\operatorname{Sh}\binom{\omega ; \eta}{\alpha}\right\}_{\omega, \eta, \alpha \in X_{\mathbb{Z}}}$ in $\mathbb{Z}$ defined by

$$
\omega ш \eta=\sum_{\alpha \in X_{\ddot{Z}}} \operatorname{Sh}\binom{\omega ; \eta}{\alpha} \alpha .
$$

In particular, for $p, q \in \mathbb{N}$ and $u_{1}, \ldots, u_{p+q} \in X_{\mathbb{Z}}$, the shuffle product is rewritten as

$$
\left(u_{1}, \ldots, u_{p}\right) \amalg\left(u_{p+1}, \ldots, u_{p+q}\right)=\sum_{\sigma \in \amalg_{p, q}}\left(u_{\sigma(1)}, \ldots, u_{\sigma(p)}, u_{\sigma(p+1)}, \ldots, u_{\sigma(p+q)}\right),
$$

where the set $Ш_{p, q}$ stands for

and $S_{p+q}$ means the symmetry group with degree $p+q$.
Let us assume that $u_{1}, \ldots, u_{m} \in X_{\mathbb{Z}}$ are algebraically independent over $\mathbb{Q}$ in $\mathcal{F}$. For $M \in \mathcal{M}(\mathcal{F}), M^{m}\left(u_{1}, \ldots, u_{m}\right)$ stands for the image of $M^{m}\left(x_{1}, \ldots, x_{m}\right)$ under the embedding $\mathbb{Q}\left[x_{1}, \ldots, x_{m}\right] \hookrightarrow \mathcal{F}$ which sends $x_{i} \mapsto u_{i}$.

Definition 10 ([Ec81 I-p.118). A mould $M$ is alternal when $M(\emptyset)=0$ and

\sum_{\alpha \in X_{\mathbb{Z}}} \operatorname{Sh}\binom{\left(x_{1}, \ldots, x_{p}\right) ;\left(x_{p+1}, \ldots, x_{p+q}\right)}{\alpha} M^{p+q}(\alpha)=0 \tag{1.3}
\end{equation*}
$$

holds for all $p, q \geqslant 1$.

[^1]Definition 11 ([Ec03, Ec11]). The $\mathbb{Q}$-linear space ARI $_{\text {al }}$ is defined to be the subset of all alternal moulds in ARI.

It forms a filtered $\mathbb{Q}$-algebra under the filtrations induced from the depth filtration of ARI.

Remark 12. The ari-bracket is introduced in [Ec11, §2.2] (cf. [Sch15, $\S 2.2]$ ) and it is known that ARI and $\mathrm{ARI}_{\text {al }}$ form Lie algebras under the bracket (see [FK] for a full detailed proof).

To present the notion of the alternility of moulds, we prepare some algebraic formulation: Set $Y:=\left\{y_{i}\right\}_{i \in \mathbb{N}}$. Let $\mathcal{Y}:=\mathbb{Q}(Y)$ be the commutative field generated by all elements of $Y$ over $\mathbb{Q}$. We denote $\mathcal{A}_{\mathcal{Y}}:=\mathcal{Y}\left\langle X_{\mathbb{Z}}\right\rangle$ to be the non-commutative polynomial algebra generated by all elements of $X_{\mathbb{Z}}$. So $\mathcal{A}_{\mathcal{Y}}$ is the same as the tensor product $\mathcal{A} \otimes_{\mathbb{Q}} \mathcal{Y}$ with $\mathcal{A}=\mathbb{Q}\left\langle X_{\mathbb{Z}}\right\rangle$. It is equipped with a product $\omega_{*}: \mathcal{A}_{\mathcal{Y}}^{\otimes 2} \rightarrow \mathcal{A}_{\mathcal{Y}}$ which is the $\mathcal{Y}$-linear map defined by $\emptyset \amalg_{*} \omega:=\omega \amalg_{*} \emptyset:=\omega$ and (1.4)
$u \omega \amalg_{*} v \eta:=u\left(\omega Ш_{*} v \eta\right)+v\left(u \omega \amalg_{*} \eta\right)+f(u-v)\left\{u\left(\omega Ш_{*} \eta\right)-v\left(\omega Ш_{*} \eta\right)\right\}$, for $u, v \in X_{\mathbb{Z}}$ and $\omega, \eta \in X_{\mathbb{Z}}^{\bullet}$. Here, we define the above map $f: X_{\mathbb{Z}} \rightarrow$ $\mathcal{Y}$ by $f(0):=0$ and

f\left(n_{1} x_{i_{1}}+\cdots+n_{k} x_{i_{k}}\right):=\frac{1}{n_{1} y_{i_{1}}+\cdots+n_{k} y_{i_{k}}}
$$

for $k \geqslant 1$ and for $i_{1}, \ldots, i_{k} \in \mathbb{N}$ and for $n_{1}, \ldots, n_{k} \in \mathbb{Z}$ with $n_{j} \neq 0$ for a certain $1 \leqslant j \leqslant k$. Then the pair $\left(\mathcal{A}_{\mathcal{Y}}, \amalg_{*}\right)$ is a commutative, non-associative, unital $\mathcal{Y}$-algebra.

We consider the family $\left\{\operatorname{Sh}_{*}\binom{\omega ; \eta}{\alpha}\right\}_{\omega, \eta, \alpha \in X_{\mathbb{Z}}}$ in $\mathcal{Y}$ defined by

\omega Ш_{*} \eta=\sum_{\alpha \in X_{\mathbb{Z}}^{*}} \operatorname{Sh}_{*}\binom{\omega ; \eta}{\alpha} \alpha .
$$

Definition 13 (Ec03, Ec11, SaSch $])$. (1). A mould $M$ is alternil when $M(\emptyset)=0$ and

\left.\sum_{\alpha \in X_{\mathbb{Z}}^{\bullet}} \operatorname{Sh}_{*}\binom{\left(x_{1}, \ldots, x_{p}\right) ;\left(x_{p+1}, \ldots, x_{p+q}\right)}{\alpha}\right|_{y_{i}=x_{i}} M^{l(\alpha)}(\alpha)=0 \tag{1.5}
\end{equation*}
$$

for all $p, q \geqslant 1$.
(2). The subset $\operatorname{ARI}_{\underline{\underline{a l} * \underline{1}}}$ is the $\mathbb{Q}$-linear space spanned by all alternal moulds $M$ in ARI such that $\operatorname{swap}(M)$ is alternil up to a constantvalued mould, (that is, there exist a constant mould $C \in \mathcal{M}(\mathcal{F})$ so that $\operatorname{swap}(M)+C$ is alternil).

Remark 14. Under the ari-bracket (cf. Remark (12), the $\mathbb{Q}$-linear space ARI $_{\underline{\underline{l} *} \mathbf{1}}$ forms a filtered Lie algebra (cf. [K, Sch15, SaSch]). The Lie algebra isomorphism between $\mathfrak{d m r}$ and $\mathrm{ARI}_{\underline{\underline{a l} * \underline{\underline{1}}}}$ is realized by the map sending $\tilde{f} \mapsto$ ma $_{\tilde{f}}$ (cf. SaSch, Sch15]).

Let $\mathbb{A}=\mathbb{Q}\langle x, y\rangle$ be the non-commutative polynomial algebra with two variables $x$ and $y$. This $\mathbb{A}$ forms a bigraded algebra; $\mathbb{A}=\oplus_{w, d} \mathbb{A}_{w, d}$, where $\mathbb{A}_{w, d}$ means the $\mathbb{Q}$-linear space generated by all monomials with weight (the total degree) $w$ and depth (the degree with respect to $y$ ) $d$. Put $\mathbb{A}_{w}=\oplus_{d} \mathbb{A}_{w, d}$ and $\operatorname{Fil}_{\mathcal{D}}^{d} \mathbb{A}_{w}:=\oplus_{N \geqslant d} \mathbb{A}_{w, N}$ for $d>0$. Then $\mathbb{A}$ is a filtered graded algebra by the depth filtration $\operatorname{Fil}_{\mathcal{D}}^{d} \mathbb{A}=\oplus_{w} \operatorname{Fil}_{\mathcal{D}}^{d} \mathbb{A}_{w}$.

Definition 15 ([Sch12, Appendix A]). Let $h \in \mathbb{A}_{w}$ be a degree $w$ homogeneous polynomial with

h=\sum_{r=0}^{w} h^{r} \quad \text { and } \quad h^{r}=\sum_{\mathrm{e}=\left(e_{0}, \ldots, e_{r}\right) \in \mathcal{E}_{\mathcal{w}}^{r}} a(h)_{e_{0}, \ldots, e_{r}} x^{e_{0}} y \cdots y x^{e_{r}} \in \mathbb{A}_{w, r}
$$

where $\mathcal{E}_{w}^{r}=\left\{\mathbf{e}=\left(e_{0}, \ldots, e_{r}\right) \in \mathbb{N}_{0}^{r+1} \mid \sum_{i=0}^{r} e_{i}=w-r\right\}$. With such $h \in \mathbb{A}$, the associated mould

\mathrm{ma}_{h}=\left(\mathrm{ma}_{h}^{0}, \mathrm{ma}_{h}^{1}, \mathrm{ma}_{h}^{2}, \ldots, \mathrm{ma}_{h}^{w}, 0,0, \ldots\right) \in \mathcal{M}(\mathcal{F})
$$

is defined by $\mathrm{ma}_{h}^{0}=0$ and

& \operatorname{ma}_{h}^{r}=\operatorname{ma}_{h}^{r}\left(u_{1}, \ldots, u_{r}\right)=\operatorname{vimo}_{h}^{r}\left(0, u_{1}, u_{1}+u_{2}, \ldots, u_{1}+\cdots+u_{r}\right) \\

The map $h \mapsto$ ma $_{h}$ yields a filtered algebra homomorphism

Various properties of the map are investigated in [FHK].

## 2. Kashiwara-Vergne and double shuffle Lie algebra

We recall the definition of Kashiwara-Vergne Lie algebra $\mathfrak{k r v}$ introduced in AET and AT and also that of the double shuffle Lie algebra $\mathfrak{d m r}$ introduced in R02. Then we explain their mould theoretic interpretations.

Let $\mathbb{L}=\oplus_{w \geqslant 1} \mathbb{L}_{w}=\oplus_{w, d} \mathbb{L}_{w, d}$ be the subspace of $\mathbb{A}$ consisting of all Lie polynomials. It is a free graded Lie $\mathbb{Q}$-algebra with two variables $x$ and $y$ with $\operatorname{deg} x=\operatorname{deg} y=1$. We equip $\mathbb{L}$ with the depth filtration $\operatorname{Fil}_{\mathcal{D}}^{d} \mathbb{L}=\oplus_{w} \operatorname{Fil}_{\mathcal{D}}^{d} \mathbb{L}_{w}$ by $\operatorname{Fil}_{\mathcal{D}}^{d} \mathbb{L}_{w}:=\oplus_{N \geqslant d} \mathbb{L}_{w, N}$ for $d>0$.

Definition 16. (1). We denote by $\mathfrak{d e r}$ the set of derivations of $\mathbb{L}$ and by $\mathfrak{t d e r}$ its subset of tangential derivations which are the derivations $D_{F, G}$ of $\mathbb{L}$ such that $D_{F, G}(x)=[x, G]$ and $D_{F, G}(y)=[y, F]$ for some $F, G \in \mathbb{L}$. It forms a Lie algebra under the bracket given by

(2). We define by $\mathfrak{s d e r}$ the set of special derivations, which are tangential derivations such that

The subspace $\mathfrak{s d e r}$ is a Lie subalgebra of $\mathfrak{t d e r}$ and there is a sequence of Lie algebras

$$

Definition 17 ( $\boxed{\mathrm{AT}}, \mathrm{AET}])$. The Kashiwara-Vergne Lie algebra is the graded $\mathbb{Q}$-linear space $\mathfrak{k r v}=\oplus_{w>1} \mathfrak{k r v}_{w}$. ${ }^{2}$ Here its degree $w$-part $\mathfrak{k r v}_{w}$ consists of Lie elements $F \in \mathbb{L}_{w}$ satisfying

with some $G=G(F) \in \mathbb{L}_{w}$ and $\alpha \in \mathbb{Q}$, when we write $F=F_{x} x+F_{y} y$ and $G=G_{x} x+G_{y} y$ in $\mathbb{A}$. Here $\operatorname{tr}$ is the trace map, the natural projection from $\mathbb{A}$ to the $\mathbb{Q}$-linear space $\operatorname{Cyc}(\mathbb{A})$ of cyclic words (cf. (AT]).

We have $\mathfrak{k r v}_{2}=\{0\}$. We note that such $G=G(F)$ is unique if it exists when $w>1$ (for the calculations, see [Sch12, Theorem 1.1]). The condition (KV1) is equivalent to $D_{F, G(F)}(x+y)=0$, i.e. $D_{F, G(F)} \in \mathfrak{s d e r}$. The Lie algebra structure of $\mathfrak{k r v}$ is defined to make the embedding

sending $F \mapsto D_{F, G(F)}$ a Lie algebra homomorphism.
For $d \geqslant 1$, we denote by $\mathrm{Fil}_{\mathcal{D}}^{d} \mathfrak{k r}_{w}$ the subspace of $\mathfrak{k r v}_{w}$ consisting of $F \in \operatorname{Fil}_{\mathcal{D}}^{d} \mathbb{L}_{w}$ and put $\operatorname{Fil}_{\mathcal{D}}^{d} \mathfrak{k v v}=\oplus_{w} \operatorname{Fil}_{\mathcal{D}}^{d} \mathfrak{k r v}_{w}$. Then $\mathfrak{k v v}$ forms a filtered Lie algebra with the filtration $\left\{\text { Fil }_{\mathcal{D}}^{d} \mathfrak{k r v}\right\}_{d}$.

The following is a mould theoretical interpretation of $\mathfrak{k r v}$ :
Theorem 18 ([FK, RS]). The map $F \in \mathbb{A} \mapsto \operatorname{ma}_{\tilde{f}} \in \mathcal{M}(\mathcal{F})$ gives an isomorphism of filtered $\mathbb{Q}$-linear spaces

For $\mathrm{ARI}_{\text {sena/pusnu }}$ and $\mathrm{ARI}_{\text {al }}$, see Definition 9 and 11 respectively.
Remark 19. The above theorem is extended to $\mathfrak{k r v}(\Gamma)$ with an arbitrary abelian group $\Gamma$ and a mould theoretic interpretation of its bigraded variant $\mathfrak{l k v v}(\Gamma)$ is provided in [FK].

Let $\mathbb{A}_{Y}:=\mathbb{Q}\left\langle y_{1}, y_{2}, y_{3}, \ldots\right\rangle$ be the free associative non-commutative $\mathbb{Q}$-algebra generated by the variables $y_{m}$ 's $(m \in \mathbb{N})$ with unit. It is equipped with a structure of Hopf algebra with the coproduct $\Delta_{*}$ given by $\Delta_{*}\left(y_{n}\right)=\sum_{i=0}^{n} y_{i} \otimes y_{n-i}\left(y_{0}:=1\right)$. Let $\pi_{Y}: \mathbb{A} \rightarrow \mathbb{A}_{Y}$ be the $\mathbb{Q}$-linear projection that sends all the words ending in $x$ to zero and the word $x^{n_{m}-1} y \cdots x^{n_{1}-1} y\left(n_{1}, \ldots, n_{m} \in \mathbb{N}\right)$ to $(-1)^{m} y_{n_{m}} \cdots y_{n_{1}}$. For $\varphi=\sum_{W: \text { word }} c_{W}(\varphi) W \in \mathbb{A}$, define

## $\mathfrak{d m r} \subset \mathfrak{d e r}$

sending $\tilde{f} \mapsto d_{F}$ equips $\mathfrak{d m r}$ with a structure of Lie subalgebra of $\mathfrak{d e r}$. For $d \geqslant 1$, we denote by $\operatorname{Fil}_{\mathcal{D}}^{d} \mathfrak{d m r} \mathfrak{r}_{w}$ the subspace of $\mathfrak{d m r _ { w } \text { consisting of }}$ $\tilde{f} \in \operatorname{Fil}_{\mathcal{D}}^{d} \mathbb{L}_{w}$ and we put $\operatorname{Fil}_{\mathcal{D}}^{d} \mathfrak{d m r}=\oplus_{w} \operatorname{Fil}_{\mathcal{D}}^{d} \mathfrak{d} \mathfrak{m} \mathfrak{r}_{w}$. Then $\mathfrak{d m r}$ forms a filtered Lie algebra with the filtration $\left\{\operatorname{Fil}_{\mathcal{D}}^{d} \mathfrak{d m r}\right\}_{d}$.

A mould theoretical interpretation of $\mathfrak{d m r}$ is given as follows:
Theorem 21 ([Sch15, Theorem 3.4.4]). The map $\tilde{f} \in \mathbb{A} \mapsto \operatorname{ma}_{\tilde{f}} \in$ $\mathcal{M}(\mathcal{F})$ gives an isomorphism of filtered Lie algebras

Remark 22. A mould theoretic interpretation of Goncharov's dihedral Lie algebra $\mathbb{D}(\Gamma)($ cf. [G]), which is regarded to be a bigraded variant of $\mathfrak{d m r}$ in the case of $\Gamma=\{e\}$, is given in [FK].

## 3. The senary relation and $\mathfrak{s d e r}$

For the reader's convenience, we give a streamlined proof of Proposition 2 by extracting the arguments in Sch12 and also reproducing those of [FK, §2] in the case of $\Gamma=\{e\}$.

An element $g \in \mathbb{A}_{w}$ is called anti-palindromic when $g=(-1)^{w}$ anti $(g)$ where anti is the palindrome (backwards-writing) operator (explained in [Sch12, Definition 1.3]).

Lemma 23 (Sch12, Theorem 2.1]). Let $F \in \mathbb{L}_{w}$ with $w>2$. Then (KV1) for $\underset{\tilde{f}}{F}$ is equivalent to the anti-palindrome for $\tilde{f}_{y}+\tilde{f}_{x}$ when we write $\tilde{f}=\tilde{f}_{x} x+\tilde{f}_{y} y$.

The claim is nothing but the equivalence between (i) and (v) of Sch12, Theorem 2.1], which is deduced from their equivalence with the intermediate conditions (ii), (iii), (iv) in loc. cit. We present a shorter proof below.

Proof. Let us write $F=F_{x} x+F_{y} y=x F^{x}+y F^{y}$. By Sch12, Proposition 2.6], we have

f_{y}-f_{x}=F_{y}(-x-y, y) .
$$

Therefore the anti-palindrome for $\tilde{f}_{y}+\tilde{f}_{x}$, so for $f_{y}-f_{x}$, is equivalent to the anti-palindrome for $F_{y}$. Since we have $F^{y}=(-1)^{w-1} \operatorname{anti}\left(F_{y}\right)$ for $F \in \mathbb{L}$, it is equivalent to

F_{y}=F^{y} .
$$

Therefore our claim is reduced to prove an equivalence between (KV1) and $F_{y}=F^{y}$.

Assume (KV1) for $F$. Set $H=[y, F]$. We have

H=y F_{y} y+y F_{x} x-y F^{y} y-x F^{x} y
$$

We have $H=G x-x G$ by $[y, F]+[x, G]=0$. So $H$ has no words starting and ending in $y$. Thus we must have $F_{y}=F^{y}$.

Conversely assume $F_{y}=F^{y}$. Then $H$ has no words starting and ending in $y$. By Sch12, Proposition 2.2], there is a $G \in \mathbb{L}_{w}$ such that $H=[G, x]$, which is calculated to be $G(F)=s^{\prime}\left(F_{x}\right)$. We get (KV1).

Whence we obtain the claim.
The following is indebted of the arguments in Sch12, Appendix A].

Lemma 24. Let $\tilde{f} \in \mathbb{L}_{w}$ with $w>2$. Then anti-palindrome for $\tilde{f}_{y}+\tilde{f}_{x}$ is equivalent to the senary relation (0.1) for $1 \leqslant r \leqslant w$ with $M=\operatorname{ma}_{\tilde{f}}$.
Proof. In this proof, we quote the same equation numbers in Sch12, Appendix A].

The first two paragraphs of the proof of [Sch12, Proposition A.3] says that the anti-palindrome for $\tilde{f}_{y}+\tilde{f}_{x}$ is equivalent to

It is noted that the first term corresponds to $\tilde{f}_{y}^{r}$ and the second one corresponds to $\tilde{f}_{x}^{r}$ in both equations. Whence (KV1) is equivalent to

On the other hand, the senary relation (0.1) is equivalent to (A8) swap $\circ \operatorname{teru}(M)^{r}=$ swap $\circ$ push $\circ$ mantar $\circ \operatorname{teru} \circ \operatorname{mantar}(M)^{r}$.
By definition, its left hand side is calculated to be

Let $F$ (so whence $\tilde{f}$ ) be in $\mathbb{L}_{w}$ with $w>2$. By definition, saying $d_{F} \in \mathfrak{s d e r}$ is equivalent to (KV1) for $F$. While by Lemmas 23 and 24, it is equivalent to the senary relation (0.1) for $M=\mathrm{ma}_{\tilde{f}}$. Therefore Proposition 2 follows.

## 4. The senary relation for small $r$

We check the validity of the assumption (0.1) for any mould $M \in$ $\mathrm{Fil}_{\mathcal{D}}^{2} \mathrm{ARI}_{\mathrm{all}^{2 l \boldsymbol{l}}}$ in small depth $r=1,2,3$.

We define the parallel translation map $t: \mathcal{M}(\mathcal{F}) \rightarrow \mathcal{M}(\mathcal{F})$ by

- & \left.M^{m-1}\left(x_{1}, \ldots, x_{i-1}, x_{i+1}, x_{i+2}, \ldots, x_{m}\right)\right\}
\end{aligned}

for $M \in \mathcal{M}(\mathcal{F})$.
Lemma 25. Let $r \geqslant 1$. Ecalle's senary relation (0.1) for $M \in \mathrm{ARI}$ is equivalent to

So by putting $y_{1}:=x_{r+1}-x_{1}$ and $y_{i}:=x_{r+2-i}-x_{r+3-i}(2 \leqslant i \leqslant r)$, we get

Therefore, we obtain the claim.

Proposition 26. Suppose that $M \in \operatorname{Fil}_{\mathcal{D}}^{2} \mathrm{ARI}_{\underline{\underline{l} \times * \underline{1}}}$. Then the mould $M$ satisfies Ecalle's senary relation for $r=1,2$ and 3 .

Proof. Since we have $M^{r}\left(\mathbf{x}_{r}\right)=0$ for $r=0,1$ by $M \in \operatorname{Fil}_{\mathcal{D}}^{2} A R I$, it is clear that $M$ satisfies the senary relation for $r=1$. By Lemma [25, it is enough to prove (4.1) for $r=2,3$.

In the case when $r=2$, by $M \in \mathrm{ARI}_{\underline{\underline{a l} * \underline{1}}}$, there exists a constant mould $C=\left(C_{m}\right)_{m \in \mathbb{Z} \geqslant 0} \in \mathcal{M}(\mathcal{F})$ such that

Here we use $\underset{\sim}{u}(C)^{3}\left(x_{1}, x_{2}, x_{3}\right)=\underset{\sim}{u}(C)^{3}\left(x_{1}, x_{3}, x_{2}\right)=C_{2}$. So by using [Sch15, Lemma 2.5.3] (see also [FK, Lemma 3.7]) and (4.2), we have

& -\sum_{\alpha \in X_{\mathscr{Z}}} \operatorname{Sh}_{*}\binom{\left(-x_{2},-x_{3}\right) ;\left(-x_{4}\right)}{\alpha}\left(\underset{\sim}{u}(M)^{l(\alpha)+1}\left(-x_{1}, \alpha\right)+\underset{\sim}{u}(C)^{l(\alpha)+1}\left(-x_{1}, \alpha\right)\right) \\

Hence, we obtain (4.1) for $r=3$.
We expect that our above calculations would help us to construct a still conjectural inclusion $\operatorname{Fil}_{\mathcal{D}}^{2} \mathrm{ARI}_{\underline{\underline{a l} \times \text { il }}} \hookrightarrow \mathrm{ARI}_{\text {sena } / \text { pusnu }}$.

Now the proof of Theorem 4 is immediate. Remark 14 says ma $_{\tilde{f}} \in$ $\operatorname{Fil}_{\mathcal{D}}^{2} \mathrm{ARI}_{\underline{\mathrm{al}} * \underline{i l}}$ for $\tilde{f} \in \mathfrak{d m r}$. By Proposition [26, we see that $M=\mathrm{ma}_{\tilde{f}}$ satisfies Ecalle's senary relation (0.1) for $r=1,2$ and 3. Whence our claim is shown.
