# A GENERALIZATION OF PIATETSKI-SHAPIRO SEQUENCES 

 (II)JINJIANG LI, JINYUN QI, AND MIN ZHANG


#### Abstract

Suppose that $\alpha, \beta \in \mathbb{R}$. Let $\alpha \geqslant 1$ and $c$ be a real number in the range $1<c<12 / 11$. In this paper, it is proved that there exist infinitely many primes in the generalized Piatetski-Shapiro sequence, which is defined by $\left(\left\lfloor\alpha n^{c}+\beta\right\rfloor\right)_{n=1}^{\infty}$. Moreover, we also prove that there exist infinitely many Carmichael numbers composed entirely of primes from the generalized Piatetski-Shapiro sequences with $c \in\left(1, \frac{19137}{18746}\right)$. The two theorems constitute improvements upon previous results by Guo and Qi [5].


Keywords: Beatty sequence; Piatetski-Shapiro sequences; arithmetic progression; exponential sums

## 1. Introduction

For $1<c \notin \mathbb{N}$, the Piatetski-Shapiro sequences are sequences of the form

$$
\mathscr{N}^{(c)}:=\left(\left\lfloor n^{c}\right\rfloor\right)_{n=1}^{\infty}
$$

For fixed real numbers $\alpha$ and $\beta$, the associated non-homogeneous Beatty sequence is the sequence of integers defined by

$$
\mathcal{B}_{\alpha, \beta}:=(\lfloor\alpha n+\beta\rfloor)_{n=1}^{\infty},
$$

where $\lfloor t\rfloor$ denotes the integral part of any $t \in \mathbb{R}$. Such sequences are also called generalized arithmetic progressions. Let $\alpha \geqslant 1$ and $\beta$ be real numbers. Denote $\mathscr{N}_{\alpha, \beta}^{(c)}$ by the generalized Piatetski-Shapiro sequences

$$
\mathscr{N}_{\alpha, \boldsymbol{\beta}}^{(c)}=\left(\left\lfloor\alpha n^{c}+\beta\right\rfloor\right)_{n=1}^{\infty} .
$$

Note that the special case $\mathscr{N}_{1,0}^{(c)}$ is the classical Piatetski-Shapiro sequences. Let

$$
\pi(x ; q, a):=\#\{p \leqslant x: p \equiv a(\bmod q)\}
$$

and

$$
\pi_{\alpha, \beta, c}(x ; q, a):=\#\left\{p \leqslant x: p \in \mathscr{N}_{\alpha, \beta}^{(c)} \text { and } p \equiv a(\bmod q)\right\} .
$$

Recently, Guo and Qi [5] gave an asymptotic formula of $\pi_{\alpha, \beta, c}(x ; q, a)$ for $1<c<$ $\frac{14}{13}$. Moreover, they also proved that there exist infinitely many Carmichael numbers composed entirely of primes from generalized Piatetski-Shapiro sequences with $1<c<\frac{64}{63}$. In this paper, we shall continue to improve the range of $c$ in

[^0]these problems and establish the following two results by improving the estimate of the weighted exponential sum
$$
\sum_{1 \leqslant h \leqslant H}\left|\sum_{x / 2<n \leqslant x} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}+\Xi n\right)\right|,
$$
where $H, \theta, \gamma, \Xi$ are positive numbers satisfying $H \geqslant 1$ and $0<\theta, \gamma, \Xi<1$.
Theorem 1.1. Let $a$ and $q$ be coprime integers with $q \geqslant 1$. For fixed $1<c<\frac{12}{11}$ and $\gamma=c^{-1}$, we have
\[

$$
\begin{align*}
\pi_{\alpha, \beta, c}(x ; q, a)= & \alpha^{-\gamma} \gamma x^{\gamma-1} \pi(x ; q, a) \\
& +\alpha^{-\gamma} \gamma(1-\gamma) \int_{2}^{x} u^{\gamma-2} \pi(u ; q, a) \mathrm{d} u+O\left(x^{7 \gamma / 13+11 / 26+\varepsilon}\right) \tag{1.1}
\end{align*}
$$
\]

Moreover, define

$$
\pi_{\alpha, \beta, c}(x):=\pi_{\alpha, \beta, c}(x ; 1,1)=\#\left\{p \leqslant x: p \in \mathscr{N}_{\alpha, \beta}^{(c)}\right\} .
$$

Then we conclude that
Corollary 1.2. Suppose that $\alpha \geqslant 1$ and $\beta$ are real numbers. Then for $1<c<$ $\frac{12}{11}$, there holds

$$
\begin{equation*}
\pi_{\alpha, \beta, c}(x)=\frac{x^{\gamma}}{\alpha^{\gamma} \log x}+O\left(\frac{x^{\gamma}}{\log ^{2} x}\right) . \tag{1.2}
\end{equation*}
$$

In the end, we improve the theorem in [5] related to Carmichael numbers, which are the composite natural numbers $N$ with the property that $N \mid\left(a^{N}-a\right)$ for every integer $a$.

Theorem 1.3. For every $c \in\left(1, \frac{19137}{18746}\right)$, there are infinitely many Carmichael numbers composed entirely of the primes from the set $\mathscr{N}_{\alpha, \beta}^{(c)}$.

## 2. Preliminaries

2.1. Notation. We denote by $\lfloor t\rfloor$ and $\{t\}$ the integral part and the fractional part of $t$, respectively. As usual, we put

$$
\mathbf{e}(t):=e^{2 \pi i t}
$$

Throughout this paper, we make considerable use of the sawtooth function, which is defined by

$$
\psi(t):=t-\lfloor t\rfloor-\frac{1}{2}=\{t\}-\frac{1}{2}
$$

The letter $p$ always denotes a prime. For the generalized Piatetski-Shapiro sequence $\left(\left\lfloor\alpha n^{c}+\beta\right\rfloor\right)_{n=1}^{\infty}$, we denote $\gamma:=c^{-1}$ and $\theta:=\alpha^{-\gamma}$. We use the notation of the form $m \sim M$ as an abbreviation for $M<m \leqslant 2 M$.

Throughout the paper, implied constants in symbols $O, \ll$ and $\gg$ may depend (where obvious) on the parameters $\alpha, \beta, c, \varepsilon$ but are absolute otherwise. For given functions $F$ and $G$, the notations $F \ll G, G \gg F$ and $F=O(G)$ are all equivalent to the statement that the inequality $|F| \leqslant \mathcal{C}|G|$ holds with some constant $\mathcal{C}>0$.
2.2. Technical lemmas. We need the following well-known approximation of Vaaler [11].

Lemma 2.1. For any $H \geqslant 1$, there exist numbers $a_{h}, b_{h}$ such that

$$
\left|\psi(t)-\sum_{0<|h| \leqslant H} a_{h} \mathbf{e}(t h)\right| \leqslant \sum_{|h| \leqslant H} b_{h} \mathbf{e}(t h), \quad a_{h} \ll \frac{1}{|h|}, \quad b_{h} \ll \frac{1}{H} .
$$

Lemma 2.2. Let $z \geqslant 1$ and $k \geqslant 1$. Then, for any $n \leqslant 2 z^{k}$, there holds

$$
\Lambda(n)=\sum_{j=1}^{k}(-1)^{j-1}\binom{k}{j} \sum_{\substack{n_{1} n_{2} \cdots n_{2 j}=n \\ n_{j+1}, \ldots, n_{2 j} \leqslant z}} \cdots \sum_{1}\left(\log n_{1}\right) \mu\left(n_{j+1}\right) \cdots \mu\left(n_{2 j}\right) .
$$

Proof. See the arguments on pp. 1366-1367 of Heath-Brown [6].
Lemma 2.3. Suppose that

$$
L(H)=\sum_{i=1}^{m} A_{i} H^{a_{i}}+\sum_{j=1}^{n} B_{j} H^{-b_{j}}
$$

where $A_{i}, B_{j}, a_{i}$ and $b_{j}$ are positive. Assume further that $H_{1} \leqslant H_{2}$. Then there exists some $\mathscr{H}$ with $H_{1} \leqslant \mathscr{H} \leqslant H_{2}$ and

$$
L(\mathscr{H}) \ll \sum_{i=1}^{m} A_{i} H_{1}^{a_{i}}+\sum_{j=1}^{n} B_{j} H_{2}^{-b_{j}}+\sum_{i=1}^{m} \sum_{j=1}^{n}\left(A_{i}^{b_{j}} B_{j}^{a_{i}}\right)^{1 /\left(a_{i}+b_{j}\right)} .
$$

The implied constant depends only on $m$ and $n$.
Proof. See Lemma 3 of Srinivasan [10].
For real numbers $\theta, \Xi \in[0,1]$, the sum of the form

$$
\sum_{0<|h| \leqslant H}\left|\sum_{\substack{k \sim K \\ K L \asymp x}} \sum_{\ell \sim L} a_{k} b_{\ell} \mathbf{e}\left(\theta h(k \ell)^{\gamma}+\Xi k \ell\right)\right|
$$

with $\left|a_{k}\right| \ll x^{\varepsilon},\left|b_{\ell}\right| \ll x^{\varepsilon}$ for every fixed $\varepsilon>0$, it is usually called a "Type I" sum, denoted by $S_{I}(K, L)$, if $b_{\ell}=1$ or $b_{\ell}=\log \ell$; otherwise it is called a "Type II" sum, denoted by $S_{I I}(K, L)$.

Lemma 2.4. Suppose that $f(x):[a, b] \rightarrow \mathbb{R}$ has continuous derivatives of arbitrary order on $[a, b]$, where $1 \leqslant a<b \leqslant 2 a$. Suppose further that

$$
\left|f^{(j)}(x)\right| \asymp \lambda_{j}, \quad j \geqslant 1, \quad x \in[a, b] .
$$

Then we have

$$
\begin{equation*}
\sum_{a<n \leqslant b} e(f(n)) \ll a \lambda_{2}^{1 / 2}+\lambda_{2}^{-1 / 2}, \tag{2.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{a<n \leqslant b} e(f(n)) \ll a \lambda_{3}^{1 / 6}+\lambda_{3}^{-1 / 3} . \tag{2.2}
\end{equation*}
$$

Proof. For (2.1), one can see Corollary 8.13 of Iwaniec and Kowalski [7], or Theorem 5 of Chapter 1 in Karatsuba [8]. For (2.2), one can see Corollary 4.2 of Sargos [9].

Lemma 2.5. Suppose that $\left|a_{k}\right| \ll 1, b_{\ell}=1$ or $\log \ell, K L \asymp x$. Then if $K \ll x^{1 / 2}$, there holds

$$
S_{I}(K, L) \ll H^{7 / 6} x^{\gamma / 6+3 / 4}+H^{2 / 3} x^{1-\gamma / 3} .
$$

Proof. Set $f(\ell)=\theta h(k \ell)^{\gamma}+\Xi k \ell$. It is easy to see that

$$
f^{\prime \prime \prime}(\ell)=\gamma(\gamma-1)(\gamma-2) \theta h k^{\gamma} \ell^{\gamma-3} \asymp|h| K^{\gamma} L^{\gamma-3} .
$$

If $K \ll x^{1 / 2}$, then by (2.2) of Lemma 2.4, we deduce that

$$
\begin{aligned}
x^{-\varepsilon} \cdot S_{I}(K, L) & \ll \sum_{0<|h| \leqslant H} \sum_{k \sim K}\left|\sum_{\ell \sim L} \mathrm{e}(f(\ell))\right| \\
& \ll \sum_{0<|h| \leqslant H} \sum_{k \sim K}\left(L\left(|h| K^{\gamma} L^{\gamma-3}\right)^{1 / 6}+\left(|h| K^{\gamma} L^{\gamma-3}\right)^{-1 / 3}\right) \\
& \ll \sum_{0<|h| \leqslant H}\left(|h|^{1 / 6} x^{\gamma / 6+1 / 2} K^{1 / 2}+|h|^{-1 / 3} x^{1-\gamma / 3}\right) \\
& \ll H^{7 / 6} x^{\gamma / 6+3 / 4}+H^{2 / 3} x^{1-\gamma / 3},
\end{aligned}
$$

which completes the proof of Lemma 2.5.
Lemma 2.6. Suppose that $\left|a_{k}\right| \ll 1,\left|b_{\ell}\right| \ll 1$ with $k \sim K, \ell \sim L$ and $K L \asymp x$. Then if $x^{1 / 2} \ll K \ll x^{19 / 25}$, there holds

$$
S_{I I}(K, L) \ll H^{5 / 4} x^{\gamma / 4+5 / 8}+H^{3 / 4} x^{1-\gamma / 4}+H x^{22 / 25}+H^{7 / 6} x^{\gamma / 6+3 / 4}
$$

Proof. Let $Q$, which satisfies $1<Q<L$, be a parameter which will be chosen later. By the Weyl-van der Corput inequality (see Lemma 2.5 of Graham and Kolesnik [4]), we have

$$
\begin{equation*}
\left|\sum_{\substack{k \sim K \\ K L \leadsto x}} \sum_{\ell \sim L} a_{k} b_{\ell} \mathbf{e}\left(\theta h(k \ell)^{\gamma}+\Xi k \ell\right)\right|^{2} \ll K^{2} L^{2} Q^{-1}+K L Q^{-1} \sum_{\ell \sim L} \sum_{0<|q| \leqslant Q}|\mathfrak{S}(q ; \ell)|, \tag{2.3}
\end{equation*}
$$

where

$$
\mathfrak{S}(q ; \ell)=\sum_{k \in \mathcal{I}(q ; \ell)} \mathbf{e}(g(k))
$$

with

$$
g(k)=\theta h k^{\gamma}\left(\ell^{\gamma}-(\ell+q)^{\gamma}\right)-\Xi k q .
$$

It is easy to see that

$$
g^{\prime \prime}(k)=\gamma(\gamma-1) \theta h k^{\gamma-2}\left(\ell^{\gamma}-(\ell+q)^{\gamma}\right) \asymp|h| K^{\gamma-2} L^{\gamma-1}|q| .
$$

By (2.1) of Lemma 2.4, we have

$$
\begin{equation*}
\mathfrak{S}(q ; \ell) \ll K\left(|h| K^{\gamma-2} L^{\gamma-1}|q|\right)^{1 / 2}+\left(|h| K^{\gamma-2} L^{\gamma-1}|q|\right)^{-1 / 2} \tag{2.4}
\end{equation*}
$$

Putting (2.4) into (2.3), we derive that

$$
\begin{aligned}
& \left|\sum_{\substack{k \sim K \\
K L \curvearrowleft x}} \sum_{\ell \sim L} a_{k} b_{\ell} \mathbf{e}\left(\theta h(k \ell)^{\gamma}+\Xi k \ell\right)\right|^{2} \\
\ll & K^{2} L^{2} Q^{-1}+K L Q^{-1} \\
& \times \sum_{\ell \sim L} \sum_{0<|q| \leqslant Q}\left(|h|^{1 / 2} K^{\gamma / 2} L^{\gamma / 2-1 / 2}|q|^{1 / 2}+|h|^{-1 / 2} K^{1-\gamma / 2} L^{1 / 2-\gamma / 2}|q|^{-1 / 2}\right) \\
\ll & K^{2} L^{2} Q^{-1}+K L Q^{-1}\left(|h|^{1 / 2} K^{\gamma / 2} L^{\gamma / 2+1 / 2} Q^{3 / 2}+|h|^{-1 / 2} K^{1-\gamma / 2} L^{3 / 2-\gamma / 2} Q^{1 / 2}\right) \\
\ll & K^{2} L^{2} Q^{-1}+|h|^{1 / 2} K^{1+\gamma / 2} L^{\gamma / 2+3 / 2} Q^{1 / 2}+|h|^{-1 / 2} K^{2-\gamma / 2} L^{5 / 2-\gamma / 2} Q^{-1 / 2} .
\end{aligned}
$$

By noting that $1 \leqslant Q \leqslant L$, it follows from Lemma 2.3 that there exists an optimal $Q$ such that

$$
\begin{aligned}
&\left|\sum_{\substack{k \sim K \\
K L \asymp x}} \sum_{\ell \sim L} a_{k} b_{\ell} \mathbf{e}\left(\theta h(k \ell)^{\gamma}+\Xi k \ell\right)\right|^{2} \\
& \ll|h|^{1 / 2} x^{\gamma / 2+3 / 2} K^{-1 / 2}+K x+|h|^{-1 / 2} x^{2-\gamma / 2}+|h|^{1 / 3} x^{\gamma / 3+5 / 3} K^{-1 / 3}+K^{-1 / 2} x^{2},
\end{aligned}
$$

which implies

$$
\begin{aligned}
\left|\sum_{\substack{k \sim K \\
K L \asymp x}} \sum_{\ell \sim L} a_{k} b_{\ell} \mathbf{e}\left(\theta h(k \ell)^{\gamma}+\Xi k \ell\right)\right| \ll & |h|^{1 / 4} x^{\gamma / 4+3 / 4} K^{-1 / 4}+|h|^{-1 / 4} x^{1-\gamma / 4} \\
& +K^{1 / 2} x^{1 / 2}+|h|^{1 / 6} x^{\gamma / 6+5 / 6} K^{-1 / 6}+K^{-1 / 4} x .
\end{aligned}
$$

Therefore, from the above estimate and the condition $x^{1 / 2} \ll K \ll x^{19 / 25}$, we obtain

$$
\begin{aligned}
&\left|S_{I I}(K, L)\right|< \sum_{0<|h| \leqslant H}\left(|h|^{1 / 4} x^{\gamma / 4+3 / 4} K^{-1 / 4}+|h|^{-1 / 4} x^{1-\gamma / 4}\right. \\
&\left.\quad+K^{1 / 2} x^{1 / 2}+|h|^{1 / 6} x^{\gamma / 6+5 / 6} K^{-1 / 6}+K^{-1 / 4} x\right) \\
& \ll H^{5 / 4} x^{\gamma / 4+3 / 4} K^{-1 / 4}+H^{3 / 4} x^{1-\gamma / 4}+H K^{1 / 2} x^{1 / 2} \\
& \quad+H^{7 / 6} x^{\gamma / 6+5 / 6} K^{-1 / 6}+H K^{-1 / 4} x \\
& \ll H^{5 / 4} x^{\gamma / 4+5 / 8}+H^{3 / 4} x^{1-\gamma / 4}+H x^{22 / 25}+H^{7 / 6} x^{\gamma / 6+3 / 4},
\end{aligned}
$$

which completes the proof of Lemma 2.6.

## 3. Proof of Theorem 1.1

By a same argument of [5, Section 3], we have

$$
\begin{equation*}
\pi_{\alpha, \beta, c}(x ; q, a)=\Sigma_{1}(x)+\Sigma_{2}(x)+O\left(x^{\gamma-1}\right), \tag{3.1}
\end{equation*}
$$

where

$$
\Sigma_{1}(x)=\theta \gamma \sum_{\substack{p \leqslant x \\ p \equiv a(\bmod q)}} p^{\gamma-1}
$$

and

$$
\Sigma_{2}(x)=\sum_{\substack{p \leqslant x \\ p \equiv a(\bmod q)}}\left(\psi\left(-\theta(p+1-\beta)^{\gamma}\right)-\psi\left(-\theta(p-\beta)^{\gamma}\right)\right) .
$$

For $\Sigma_{1}(x)$, by partial summation, we get

$$
\begin{align*}
\Sigma_{1}(x) & =\theta \gamma \int_{2}^{x} u^{\gamma-1} \mathrm{~d}\left(\sum_{\substack{p \leqslant u \\
p \equiv a(\bmod q)}} 1\right)=\theta \gamma \int_{2}^{x} u^{\gamma-1} \mathrm{~d} \pi(u ; q, a) \\
& =\theta \gamma x^{\gamma-1} \pi(x ; q, a)-\theta \gamma(\gamma-1) \int_{2}^{x} u^{\gamma-2} \pi(u ; q, a) \mathrm{d} u . \tag{3.2}
\end{align*}
$$

Next, we turn our attention to $\Sigma_{2}(x)$. Define

$$
\begin{aligned}
\mathcal{H}(x) & =\sum_{\substack{n \leqslant x \\
n \equiv a(\bmod q)}} \Lambda(n)\left(\psi\left(-\theta(n+1-\beta)^{\gamma}\right)-\psi\left(-\theta(n-\beta)^{\gamma}\right)\right), \\
\mathcal{J}(x) & =\sum_{\substack{p \leqslant x \\
p \equiv a(\bmod q)}}(\log p)\left(\psi\left(-\theta(p+1-\beta)^{\gamma}\right)-\psi\left(-\theta(p-\beta)^{\gamma}\right)\right) .
\end{aligned}
$$

Trivially, we have

$$
\begin{equation*}
\mathcal{H}(x)=\mathcal{J}(x)+O\left(x^{1 / 2}\right) \tag{3.3}
\end{equation*}
$$

Moreover, it follows from partial summation that

$$
\begin{equation*}
\Sigma_{2}(x)=\int_{2}^{x} \frac{1}{\log u} \mathrm{~d} \mathcal{J}(u)=\frac{\mathcal{J}(x)}{\log x}+\int_{2}^{x} \frac{\mathcal{J}(u)}{u \log ^{2} u} \mathrm{~d} u . \tag{3.4}
\end{equation*}
$$

In order to obtain the upper bound estimate of $\Sigma_{2}(x)$, it follows from (3.3) and (3.4) that we only need to derive the upper bound estimate of $\mathcal{H}(x)$. By a splitting argument, it is sufficient to give the upper bound estimate of the following sum

$$
\mathcal{S}:=\sum_{\substack{x / 2<n \leqslant x \\ n \equiv a(\bmod q)}} \Lambda(n)\left(\psi\left(-\theta(n+1-\beta)^{\gamma}\right)-\psi\left(-\theta(n-\beta)^{\gamma}\right)\right) .
$$

According to Vaaler's approximation, i.e. Lemma 2.1, we can write

$$
\begin{equation*}
\mathcal{S}=\mathcal{S}_{1}+O\left(\left|\mathcal{S}_{2}\right|\right) \tag{3.5}
\end{equation*}
$$

where

$$
\begin{aligned}
\mathcal{S}_{1} & =\sum_{\substack{x / 2<n \leqslant x \\
n \equiv a(\bmod q)}} \Lambda(n) \sum_{0<|h| \leqslant H} a_{h}\left(\mathbf{e}\left(\theta h(n+1-\beta)^{\gamma}\right)-\mathbf{e}\left(\theta h(n-\beta)^{\gamma}\right)\right), \\
\mathcal{S}_{2} & =\sum_{\substack{x / 2<n \leqslant x \\
n \equiv a(\bmod q)}} \Lambda(n) \sum_{|h| \leqslant H} b_{h}\left(\mathbf{e}\left(\theta h(n+1-\beta)^{\gamma}\right)+\mathbf{e}\left(\theta h(n-\beta)^{\gamma}\right)\right) .
\end{aligned}
$$

Moreover, we split $\mathcal{S}_{1}$ into two parts

$$
\begin{equation*}
\mathcal{S}_{1}=\mathcal{S}_{1}^{(1)}+\mathcal{S}_{1}^{(2)}, \tag{3.6}
\end{equation*}
$$

where

$$
\begin{aligned}
\mathcal{S}_{1}^{(1)} & =\sum_{\substack{x / 2<n \leqslant x \\
n \equiv a(\bmod q)}} \Lambda(n) \sum_{0<|h| \leqslant H} a_{h}\left(\mathbf{e}\left(\theta h(n+1-\beta)^{\gamma}\right)-\mathbf{e}\left(\theta h n^{\gamma}\right)\right), \\
\mathcal{S}_{1}^{(2)} & =\sum_{\substack{x / 2<n \leqslant x \\
n \equiv a(\bmod q)}} \Lambda(n) \sum_{0<|h| \leqslant H} a_{h}\left(\mathbf{e}\left(\theta h n^{\gamma}\right)-\mathbf{e}\left(\theta h(n-\beta)^{\gamma}\right)\right) .
\end{aligned}
$$

Firstly, we shall consider the upper bound of $\mathcal{S}_{1}^{(1)}$. Let

$$
\phi_{h}(t):=\mathbf{e}\left(h\left((t+1-\beta)^{\gamma}-t^{\gamma}\right)\right)-1 .
$$

Therefore, $\mathcal{S}_{1}^{(1)}$ is

$$
=\sum_{\substack{x / 2<n \leqslant x \\ n \equiv a(\bmod q)}} \Lambda(n) \sum_{0<|h| \leqslant H} a_{h} \phi_{h}(n) \mathbf{e}\left(\theta h n^{\gamma}\right)=\sum_{0<|h| \leqslant H} a_{h} \sum_{\substack{x / 2<n \leqslant x \\ n \equiv a(\bmod q)}} \Lambda(n) \phi_{h}(n) \mathbf{e}\left(\theta h n^{\gamma}\right),
$$

which combined with the upper bound $a_{h} \ll|h|^{-1}$ yields

$$
\mathcal{S}_{1}^{(1)} \ll \sum_{0<|h| \leqslant H} \frac{1}{|h|}\left|\sum_{\substack{x / 2<n \leqslant x \\ n \equiv a(\bmod q)}} \Lambda(n) \phi_{h}(n) \mathbf{e}\left(\theta h n^{\gamma}\right)\right| .
$$

It follows from partial summation and the bounds

$$
\phi_{h}(t) \ll|h| t^{\gamma-1} \quad \text { and } \quad \frac{\partial \phi_{h}(t)}{\partial t} \ll|h| t^{\gamma-2}
$$

that

$$
\begin{align*}
\mathcal{S}_{1}^{(1)} & \ll \sum_{0<|h| \leqslant H} \frac{1}{|h|}\left|\int_{\frac{x}{2}}^{x} \phi_{h}(t) \mathrm{d}\left(\sum_{\substack{x / 2<n \leqslant t \\
n \equiv a(\bmod q)}} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}\right)\right)\right| \\
& \left.\ll \sum_{0<|h| \leqslant H} \frac{1}{|h|}\left|\phi_{h}(x)\right| \sum_{\substack{x / 2<n \leqslant x \\
n \equiv a(\bmod q)}} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}\right) \right\rvert\, \\
& +\sum_{0<|h| \leqslant H} \frac{1}{|h|} \int_{\frac{x}{2}}^{x}\left|\frac{\partial \phi_{h}(t)}{\partial t}\right|\left|\sum_{\substack{x / 2<n \leqslant t \\
n \equiv a(\bmod q)}} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}\right)\right| \mathrm{d} t \\
& \ll x^{\gamma-1} \times \max _{x / 2<t \leqslant x} \sum_{0<|h| \leqslant H}\left|\sum_{\substack{x / 2<n \leqslant t \\
n \equiv a(\bmod q)}} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}\right)\right| . \tag{3.7}
\end{align*}
$$

For $\mathcal{S}_{1}^{(2)}$, by a similar argument with $\phi_{h}(t)$ replaced by $\Xi_{h}(t)$ defined by

$$
\Xi_{h}(t)=1-\mathbf{e}\left(\theta h\left((t-\beta)^{\gamma}-t^{\gamma}\right)\right)
$$

which satisfies

$$
\Xi_{h}(t) \ll|h| t^{\gamma-1} \quad \text { and } \quad \frac{\partial \Xi_{h}(t)}{\partial t} \ll|h| t^{\gamma-2}
$$

one can also derive that

$$
\begin{equation*}
\mathcal{S}_{1}^{(2)} \ll x^{\gamma-1} \times \max _{x / 2<t \leqslant x} \sum_{0<|h| \leqslant H}\left|\sum_{\substack{x / 2<n \leqslant t \\ n \equiv a(\bmod q)}} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}\right)\right| . \tag{3.8}
\end{equation*}
$$

In order to prove Theorem 1.1, it is sufficient to give the upper bound estimate of the following sum

$$
\begin{equation*}
\max _{x / 2<t \leqslant x} \sum_{0<|h| \leqslant H}\left|\sum_{\substack{x / 2<n \leqslant t \\ n \equiv a(\bmod q)}} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}\right)\right| . \tag{3.9}
\end{equation*}
$$

By using the well-known orthogonality

$$
\frac{1}{q} \sum_{m=1}^{q} \mathbf{e}\left(\frac{(n-a) m}{q}\right)= \begin{cases}1, & \text { if } q \mid n-a \\ 0, & \text { if } q \nmid n-a\end{cases}
$$

we can represent the innermost sum in (3.9) as

$$
\begin{equation*}
\sum_{\substack{x / 2<n \leqslant t \\ n \equiv a(\bmod q)}} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}\right)=\frac{1}{q} \sum_{m=1}^{q} \sum_{x / 2<n \leqslant t} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}+\frac{(n-a) m}{q}\right) . \tag{3.10}
\end{equation*}
$$

From (3.9) and (3.10), we know that it suffices to estimate

$$
\max _{x / 2<t \leqslant x} \sum_{0<|h| \leqslant H}\left|\sum_{x / 2<n \leqslant t} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}+n m q^{-1}\right)\right|
$$

By Heath-Brown's identity, i.e. Lemma 2.2, with $k=3$, one can see that the exponential sum

$$
\max _{x / 2<t \leqslant x} \sum_{0<|h| \leqslant H}\left|\sum_{x / 2<n \leqslant t} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}+n m q^{-1}\right)\right|
$$

can be written as linear combination of $O\left(\log ^{6} x\right)$ sums, each of which is of the form

$$
\begin{align*}
\mathcal{T}^{*}:=\sum_{0<|h| \leqslant H} \mid \sum_{n_{1} \sim N_{1}} & \cdots \sum_{n_{6} \sim N_{6}}\left(\log n_{1}\right) \mu\left(n_{4}\right) \mu\left(n_{5}\right) \mu\left(n_{6}\right) \\
& \times \mathbf{e}\left(\theta h\left(n_{1} n_{2} \cdots n_{6}\right)^{\gamma}+\left(n_{1} n_{2} \cdots n_{6}\right) m q^{-1}\right) \mid, \tag{3.11}
\end{align*}
$$

where $N_{1} N_{2} \cdots N_{6} \asymp x ; 2 N_{i} \leqslant(2 x)^{1 / 3}, i=4,5,6$ and some $n_{i}$ may only take value 1. Therefore, it is sufficient for us to give upper bound estimate for each $\mathcal{T}^{*}$ defined as in (3.11). Next, we will consider three cases.
Case 1. If there exists an $N_{j}$ such that $N_{j} \geqslant x^{1 / 2}$, then we must have $j \leqslant 3$ for the fact that $N_{i} \ll x^{1 / 3}$ with $i=4,5,6$. Let

$$
k=\prod_{\substack{1 \leqslant i \leqslant 6 \\ i \neq j}} n_{i}, \quad \ell=n_{j}, \quad K=\prod_{\substack{1 \leqslant i \leqslant 6 \\ i \neq j}} N_{i}, \quad L=N_{j} .
$$

In this case, we can see that $\mathcal{T}^{*}$ is a sum of "Type I " satisfying $K \ll x^{1 / 2}$. By Lemma 2.5, we have

$$
x^{-\varepsilon} \cdot \mathcal{T}^{*} \ll H^{7 / 6} x^{\gamma / 6+3 / 4}+H^{2 / 3} x^{1-\gamma / 3} .
$$

Case 2. If there exists an $N_{j}$ such that $x^{6 / 25} \leqslant N_{j}<x^{1 / 2}$, then we take

$$
k=\prod_{\substack{1 \leqslant i \leqslant 6 \\ i \neq j}} n_{i}, \quad \ell=n_{j}, \quad K=\prod_{\substack{1 \leqslant i \leqslant 6 \\ i \neq j}} N_{i}, \quad L=N_{j} .
$$

Thus, $\mathcal{T}^{*}$ is a sum of "Type II" satisfying $x^{1 / 2} \ll K \ll x^{19 / 25}$. By Lemma 2.6, we have

$$
x^{-\varepsilon} \cdot \mathcal{T}^{*} \ll H^{5 / 4} x^{\gamma / 4+5 / 8}+H^{3 / 4} x^{1-\gamma / 4}+H x^{22 / 25}+H^{7 / 6} x^{\gamma / 6+3 / 4} .
$$

Case 3. If $N_{j}<x^{6 / 25}(j=1,2,3,4,5,6)$, without loss of generality, we assume that $N_{1} \geqslant N_{2} \geqslant \cdots \geqslant N_{6}$. Let $r$ denote the natural number $j$ such that

$$
N_{1} N_{2} \cdots N_{j-1}<x^{6 / 25}, \quad N_{1} N_{2} \cdots N_{j} \geqslant x^{6 / 25}
$$

Since $N_{1}<x^{6 / 25}$ and $N_{6}<x^{6 / 25}$, then $2 \leqslant r \leqslant 5$. Thus, we have

$$
x^{6 / 25} \leqslant N_{1} N_{2} \cdots N_{r}=\left(N_{1} \cdots N_{r-1}\right) \cdot N_{r}<x^{6 / 25} \cdot x^{6 / 25}<x^{1 / 2} .
$$

Let

$$
k=\prod_{i=r+1}^{6} n_{i}, \quad \ell=\prod_{i=1}^{r} n_{i}, \quad K=\prod_{i=r+1}^{6} N_{i}, \quad L=\prod_{i=1}^{r} N_{i} .
$$

At this time, $\mathcal{T}^{*}$ is a sum of "Type II" satisfying $x^{1 / 2} \ll K \ll x^{19 / 25}$. By Lemma 2.6, we have

$$
x^{-\varepsilon} \cdot \mathcal{T}^{*} \ll H^{5 / 4} x^{\gamma / 4+5 / 8}+H^{3 / 4} x^{1-\gamma / 4}+H x^{22 / 25}+H^{7 / 6} x^{\gamma / 6+3 / 4} .
$$

Combining the above three cases, we derive that

$$
x^{-\varepsilon} \cdot \mathcal{T}^{*} \ll H^{7 / 6} x^{\gamma / 6+3 / 4}+H^{2 / 3} x^{1-\gamma / 3}+H^{5 / 4} x^{\gamma / 4+5 / 8}+H^{3 / 4} x^{1-\gamma / 4}+H x^{22 / 25},
$$

which combined with (3.6), (3.7), and (3.8) yields

$$
\begin{equation*}
x^{-\varepsilon} \cdot \mathcal{S}_{1} \ll H^{5 / 4} x^{5 \gamma / 4-3 / 8}+H^{3 / 4} x^{3 \gamma / 4}+H x^{\gamma-3 / 25}+H^{7 / 6} x^{7 \gamma / 6-1 / 4} \tag{3.12}
\end{equation*}
$$

Now, we focus on the upper bound of $\mathcal{S}_{2}$. The contribution from $h=0$ is

$$
\begin{equation*}
2 b_{0} \sum_{\substack{x / 2<n \leqslant x \\ n \equiv a(\bmod q)}} \Lambda(n) \ll \frac{b_{0} x}{\varphi(q)} \ll x H^{-1} . \tag{3.13}
\end{equation*}
$$

On the other hand, by similar arguments of $\mathcal{S}_{1}$ with a shift of $n$, the contribution from $h \neq 0$ is

$$
\begin{aligned}
& \ll \sum_{\substack{x / 2<n \leqslant x \\
n \equiv a(\bmod q)}} \Lambda(n) \sum_{0<|h| \leqslant H} b_{h} \mathbf{e}\left(\theta h n^{\gamma}\right)=\sum_{0<|h| \leqslant H} b_{h} \sum_{\substack{x / 2<n \leqslant x \\
n \equiv a(\bmod q)}} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}\right) \\
& \ll \frac{1}{H} \sum_{0<|h| \leqslant H}\left|\sum_{\substack{x / 2<n \leqslant x \\
n \equiv a(\bmod q)}} \Lambda(n) \mathbf{e}\left(\theta h n^{\gamma}\right)\right|,
\end{aligned}
$$

which can be treated as the process of (3.9) to give the upper bound

$$
\begin{equation*}
\ll H^{1 / 6} x^{\gamma / 6+3 / 4}+H^{-1 / 3} x^{1-\gamma / 3}+H^{1 / 4} x^{\gamma / 4+5 / 8}+H^{-1 / 4} x^{1-\gamma / 4}+x^{22 / 25} . \tag{3.14}
\end{equation*}
$$

From (3.5), (3.12), (3.13) and (3.14), we obtain

$$
\begin{gathered}
x^{-\varepsilon} \cdot \mathcal{S} \ll H^{5 / 4} x^{5 \gamma / 4-3 / 8}+H^{3 / 4} x^{3 \gamma / 4}+H x^{\gamma-3 / 25}+H^{7 / 6} x^{7 \gamma / 6-1 / 4}+H^{1 / 6} x^{\gamma / 6+3 / 4} \\
+H^{1 / 4} x^{\gamma / 4+5 / 8}+x^{22 / 25}+H^{-1 / 3} x^{1-\gamma / 3}+H^{-1 / 4} x^{1-\gamma / 4}+x H^{-1} .
\end{gathered}
$$

Since the above upper bound holds for any real $H \geqslant 1$, using Lemma 2.3 we deduce that

$$
\begin{align*}
x^{-\varepsilon} \cdot \mathcal{S} \ll & x^{5 \gamma / 4-3 / 8}+x^{3 \gamma / 4}+x^{\gamma-3 / 25}+x^{7 \gamma / 6-1 / 4}+x^{\gamma / 6+3 / 4}+x^{\gamma / 4+5 / 8} \\
& +x^{22 / 25}+x^{5 \gamma / 9+7 / 18}+x^{3 \gamma / 7+3 / 7}+x^{\gamma / 2+11 / 25}+x^{7 \gamma / 13+11 / 26} \\
& +x^{\gamma / 7+11 / 14}+x^{\gamma / 5+7 / 10} . \tag{3.15}
\end{align*}
$$

By noting the fact that $\pi_{\alpha, \beta, c}(x ; q, a) \ll x^{\gamma}$, the above bound is trivial unless the exponent of each term in the parentheses is strictly less than $\gamma$, which means that $\gamma>11 / 12$. Under this condition, after eliminating lower order terms, the previous bound of $\mathcal{S}$ in (3.15) simplifies to

$$
\mathcal{S} \ll x^{7 \gamma / 13+11 / 26+\varepsilon}
$$

for any $\varepsilon>0$. Therefore, we obtain $\mathcal{H}(x) \ll x^{7 \gamma / 13+11 / 26+\varepsilon} \ll x^{\gamma-\varepsilon}$ when $\gamma>$ $11 / 12$, and thus $\mathcal{J}(x) \ll x^{7 \gamma / 13+11 / 26+\varepsilon}$. Moreover, from (3.4) we derive that

$$
\begin{equation*}
\Sigma_{2}(x) \ll x^{7 \gamma / 13+11 / 26+\varepsilon} \ll x^{\gamma-\varepsilon} . \tag{3.16}
\end{equation*}
$$

Consequently, according to (3.1), (3.2) and (3.16), we derive the asymptotic formula (1.1). This completes the proof of Theorem 1.1.

## 4. Sketch of proof of Theorem 1.3

By exactly the same argument of [5, Section 4], we conclude that:
Theorem 4.1. Let $\alpha \geqslant 1$ and $\beta$ be real numbers. Suppose that $c \in\left(1, \frac{12}{11}\right)$. Then we have

$$
\begin{aligned}
\vartheta_{\alpha, \beta, c}(x ; q, a)= & \alpha^{-\gamma} \gamma x^{\gamma-1} \vartheta(x ; q, a) \\
& +\alpha^{-\gamma} \gamma(1-\gamma) \int_{2}^{x} u^{\gamma-2} \vartheta(u ; q, a) \mathrm{d} u+O\left(x^{7 \gamma / 13+11 / 26+\varepsilon}\right)
\end{aligned}
$$

where the implied constant depends only on $\alpha, \beta, c$ and $\varepsilon$.
The proof of our Theorem 1.3 is exactly the same as [5, Section 4] by switching the conditions

$$
1<c<\frac{14}{13} \quad \text { and } \quad-\frac{13}{35}+\frac{2 \gamma}{5}
$$

into

$$
1<c<\frac{12}{11} \quad \text { and } \quad-\frac{11}{26}+\frac{6 \gamma}{13}
$$

Let $\pi(x, y)$ be the number of those for which $p-1$ is free of prime factors exceeding $y$. Let $\mathcal{E}$ be the set of numbers $E$ in the range $0<E<1$ for which

$$
\pi\left(x, x^{1-E}\right) \geqslant x^{1+o(1)}
$$

as $x \rightarrow \infty$, where the function implied by $o(1)$ depends on $E$. By the same argument in [5, Section 4], we conclude the following statement.

Lemma 4.2. Let $\alpha \geqslant 1$ and $\beta$ be real numbers. Suppose that $c \in\left(1, \frac{38}{37}\right)$. Let $B, B_{1}$ be positive real numbers such that $B_{1}<B<-\frac{11}{26}+\frac{6 \gamma}{13}$. For any $E \in \mathcal{E}$, there exsits a number $x_{3}$ depending on $c, B, B_{1}, E$ and $\varepsilon$, such that for any $x \geqslant x_{1}$ there exist at least $x^{E B+\left(1-B+B_{1}\right)(\gamma-1)-\varepsilon}$ Carmichael numbers up to $x$ composed solely of primes from $\mathscr{N}_{\alpha, \beta}^{(c)}$.

Taking $B$ and $B_{1}$ arbitrarily close to $-\frac{11}{26}+\frac{6 \gamma}{13}$, Lemma 4.2 implies that there are infinitely many Carmichael numbers composed entirely of the primes from $\mathscr{N}_{\alpha, \beta}^{(c)}$ with

$$
\left(-\frac{11}{26}+\frac{6 \gamma}{13}\right) E+\gamma-1>0
$$

Taking $E=0.7039$ from [3], we eventually have $\gamma>\frac{18746}{19137}$.
