# PRIMES IN DENOMINATORS OF ALGEBRAIC NUMBERS

#### Abstract

Denote the set of algebraic numbers as $\overline{\mathbb{Q}}$ and the set of algebraic integers as $\overline{\mathbb{Z}}$. For $\gamma \in \overline{\mathbb{Q}}$, consider its irreducible polynomial in $\mathbb{Z}[x], F_{\gamma}(x)=a_{n} x^{n}+\cdots+a_{0}$. Denote $e(\gamma)=\operatorname{gcd}\left(a_{n}, a_{n-1}, \ldots, a_{1}\right)$. Drungilas, Dubickas and Jankauskas show in a recent paper that $\mathbb{Z}[\gamma] \cap \mathbb{Q}=\left\{\alpha \in \mathbb{Q} \mid\left\{p \mid v_{p}(\alpha)<0\right\} \subseteq\{p|p| e(\gamma)\}\right\}$. Given a number field $K$ and $\gamma \in \overline{\mathbb{Q}}$, we show that there is a subset $X(K, \gamma) \subseteq \operatorname{Spec}\left(\mathcal{O}_{K}\right)$, for which $\mathcal{O}_{K}[\gamma] \cap K=\left\{\alpha \in K \mid\left\{\mathfrak{p} \mid v_{\mathfrak{p}}(\alpha)<0\right\} \subseteq X(K, \gamma)\right\}$. We prove that $\mathcal{O}_{K}[\gamma] \cap K$ is a principal ideal domain if and only if the primes in $X(K, \gamma)$ generate the class group of $\mathcal{O}_{K}$. We show that given $\gamma \in \overline{\mathbb{Q}}$, we can find a finite set $S \subseteq \overline{\mathbb{Z}}$, such that for every number field $K$, we have $X(K, \gamma)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid \mathfrak{p} \cap S \neq \emptyset\right\}$. We study how this set $S$ relates to the ring $\overline{\mathbb{Z}}[\gamma]$ and the ideal $\mathfrak{D}_{\gamma}=\{a \in \overline{\mathbb{Z}} \mid a \gamma \in \overline{\mathbb{Z}}\}$ of $\overline{\mathbb{Z}}$. We also show that $\gamma_{1}, \gamma_{2} \in \overline{\mathbb{Q}}$ satisfy $\mathfrak{D}_{\gamma_{1}}=\mathfrak{D}_{\gamma_{2}}$ if and only if $X\left(K, \gamma_{1}\right)=X\left(K, \gamma_{2}\right)$ for all number fields $K$.


## 1. Introduction

Let $\overline{\mathbb{Q}}$ be the algebraic closure of $\mathbb{Q}$ and let $\overline{\mathbb{Z}}$ be the set of algebraic integers. We start with the following question:

Question 1.1. For an algebraic number $\gamma \in \overline{\mathbb{Q}}$, how should we define its denominator?
Denote the minimal polynomial of $\gamma$ in $\mathbb{Z}[x]$ as

$$
F_{\gamma}(x)=a_{n} x^{n}+a_{n-1} x^{n-1}+\cdots+a_{0} .
$$

So $F_{\gamma}(x) \in \mathbb{Z}[x]$ is an irreducible polynomial with $F_{\gamma}(\gamma)=0, \operatorname{gcd}\left(a_{n}, \ldots, a_{0}\right)=1$ and $a_{n}>0$. We denote $\operatorname{deg}(\gamma)=n$. The leading coefficient is denoted by $c(\gamma)=a_{n}$. The smallest positive integer $d$ for which $d \gamma$ is an algebraic integer is denoted as $d(\gamma)$. The numbers $c(\gamma)$ and $d(\gamma)$ are two natural candidates for the denominator of $\gamma$ and $d(\gamma)$ is usually called as the denominator of $\gamma$. The two are closely related and it is known that

$$
d(\gamma)|c(\gamma)| d(\gamma)^{n}
$$

In their paper, Arno, Robinson and Wheeler [1] compute $d(\gamma)$ in terms of the coefficients of $F_{\gamma}(x)$ by showing that for every prime $p$

$$
v_{p}(d(\gamma))=\max \left(0, \max _{\substack{0 \leq j \leq n-1 \\ 1}}\left\lceil\frac{v_{p}\left(a_{n}\right)-v_{p}\left(a_{j}\right)}{n-j}\right\rceil\right)
$$

They also show that $d(\gamma)=c(\gamma)$ if and only if there is no prime $p$ such that $p^{2} \mid a_{n}$ and $p \mid a_{n-1}$. Finally, they show that the density of algebraic numbers $\gamma$ for which $c(\gamma)=d(\gamma)$ is $\frac{1}{\zeta(3)}$. Ayad, Bayad and Kihel in [2], fix a number field $K$, a rational prime $p$, integer $k \geq 1$ and determine the sets $\left\{v_{p}(c(\gamma)) \mid \gamma \in K, v_{p}(d(\gamma))=k\right\}$. They show that this set only depends on $[K: \mathbb{Q}], k$ and how $p$ splits in $K$. There is another related quantity $i(\gamma)=\operatorname{gcd}_{m \in \mathbb{Z}} F_{\gamma}(m)$, that has been studied in several papers [3, 4, 6, , 7, 8, 8].

The third candidate for the denominator of $\gamma$ should be

$$
e(\gamma)=\operatorname{gcd}\left(a_{1}, a_{2}, \ldots, a_{n}\right) .
$$

Note that the gcd does not include the constant term $a_{0}$. Drungilas, Dubickas and Jankauskas show the following in [5]:

Theorem 1.2. [5, Theorem 5] Given an algebraic number $\gamma \in \overline{\mathbb{Q}}$, we have

$$
\mathbb{Z}[\gamma] \cap \mathbb{Q}=\left\{\alpha \in \mathbb{Q} \mid \text { for all primes } p \text {, if } v_{p}(\alpha)<0 \text {, then } p \mid e(\gamma)\right\} .
$$

Corollary 1.2.1. An algebraic number $\gamma \in \overline{\mathbb{Q}}$ satisfies $\mathbb{Z}[\gamma] \cap \mathbb{Q}=\mathbb{Z}$ if and only if $e(\gamma)=1$.

Note that if $\gamma$ is an algebraic integer, then $e(\gamma)=1$. However, we can have $e(\gamma)=1$ even if $\gamma$ is not an algebraic integer. For example, take $\gamma=\frac{1}{2+i}$, so $F_{\gamma}(x)=5 x^{2}-4 x+1$. We have $c(\gamma)=d(\gamma)=5$ and $e(\gamma)=1$, it satisfies $\mathbb{Z}\left[\frac{1}{2+i}\right] \cap \mathbb{Q}=\mathbb{Z}$.

In Section6, we classify which tuples of positive integers occur as $(c(\gamma), d(\gamma), e(\gamma), \operatorname{deg}(\gamma))$.
Theorem 1.3. Suppose we are given positive integers $c, d, e, n$ with $n \geq 2$. Then there is a algebraic number $\gamma$ for which $c(\gamma)=c, d(\gamma)=d$, $e(\gamma)=e$ and $\operatorname{deg}(\gamma)=n$ if and only if $d|c, c| d^{n}, e|c, c| d^{n-1} e$ and each rational prime $p$ satisfies at least one of the following:
(1) $v_{p}(d(\gamma))+v_{p}(e(\gamma)) \leq v_{p}(c(\gamma))$.
(2) $v_{p}(c(\gamma))=n v_{p}(d(\gamma))$.

For a number field $K$, we denote the ring of algebraic integers in $K$ as $\mathcal{O}_{K}$ and the set of non-zero prime ideals of $\mathcal{O}_{K}$ as $\operatorname{Spec}\left(\mathcal{O}_{K}\right)$. The ring $\mathbb{Z}[\gamma] \cap \mathbb{Q}$ is controlled by the the prime divisors of $e(\gamma)$. We will show that the ring $\mathcal{O}_{K}[\gamma] \cap K$ is controlled by certain prime ideals of $\mathcal{O}_{K}$ in a similar manner. Denote the monic irreducible polynomial of $\gamma$ over $K$ as $f_{K, \gamma}(x)=b_{n} x^{n}+\cdots+b_{0} \in K[x]$. So, $f_{K, \gamma}(x)$ is irreducible in $K[x]$, $f_{K, \gamma}(\gamma)=0$ and $b_{n}=1$.

Theorem 1.4. Given a number ring $\mathcal{O}_{K}$, an algebraic number $\gamma$ and a prime $\mathfrak{p} \in$ $\operatorname{Spec}\left(\mathcal{O}_{K}\right)$, the following are equivalent:

- For every $i \in[1, n]: v_{\mathfrak{p}}\left(b_{i}\right)>v_{\mathfrak{p}}\left(b_{0}\right)$.
- There exists an $\alpha \in \mathfrak{p}$ for which $\frac{1}{\alpha} \in \mathcal{O}_{K}[\gamma]$.
- For every $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{K(\gamma)}\right)$ : if $\mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p}$ then $v_{\mathfrak{q}}(\gamma)<0$.

Theorem 1.5. Given a number ring $\mathcal{O}_{K}$, an algebraic number $\gamma$ and a prime $\mathfrak{p} \in$ $\operatorname{Spec}\left(\mathcal{O}_{K}\right)$, the following are equivalent:

- There exists $i \in[0, n-1]$ for which $v_{\mathfrak{p}}\left(b_{i}\right)<0$.
- There exists $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{K(\gamma)}\right)$ for which $\mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p}$ and $v_{\mathfrak{q}}(\gamma)<0$.

The collection of primes in $\operatorname{Spec}\left(\mathcal{O}_{K}\right)$ that satisfy the conditions of Theorem 1.4 is denoted by $X(X, \gamma)$. The collection of primes that satisfy the conditions of Theorem 1.5 is denoted by $Y(K, \gamma)$. Clearly we have $X(K, \gamma) \subseteq Y(K, \gamma)$. Note that

$$
X(\mathbb{Q}, \gamma)=\{p \in \operatorname{Spec}(\mathbb{Z})|p| e(\gamma)\}
$$

and

$$
Y(\mathbb{Q}, \gamma)=\{p \in \operatorname{Spec}(\mathbb{Z})|p| c(\gamma)\}=\{p \in \operatorname{Spec}(\mathbb{Z})|p| d(\gamma)\}
$$

We generalize Theorem 1.2 and Corollary 1.2.1 to an arbitrary number ring $\mathcal{O}_{K}$. The set $X(K, \gamma)$ acts as the analog of prime divisors of $e(\gamma)$.

Theorem 1.6. Given a number ring $\mathcal{O}_{K}$ and an algebraic number $\gamma$, the following hold:
(1) $X(K, \gamma)=\emptyset$ if and only if $\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}$.
(2) $Y(K, \gamma)=\emptyset$ if and only if $\gamma \in \overline{\mathbb{Z}}$.

Proposition 1.7. For $\alpha \in K$, we have $\alpha \in \mathcal{O}_{K}[\gamma]$ if and only if

$$
\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid v_{\mathfrak{p}}(\alpha)<0\right\} \subseteq X(K, \gamma)
$$

Moreover, the primes in $X(K, \gamma)$ also control the the class group of $\mathcal{O}_{K}[\gamma] \cap K$.
Proposition 1.8. If $K$ is a number field and $\gamma \in \overline{\mathbb{Q}}$, then $\mathcal{O}_{K}[\gamma] \cap K$ is a Dedekind domain and its class group is

$$
C l\left(\mathcal{O}_{K}[\gamma] \cap K\right) \cong C l\left(\mathcal{O}_{K}\right) /\langle[\mathfrak{p}] \mid \mathfrak{p} \in X(K, \gamma)\rangle .
$$

The following corollaries follow at once from Proposition 1.8,
Corollary 1.8.1. If $K$ is a number field and $\gamma \in \overline{\mathbb{Q}}$, then $\operatorname{Cl}\left(\mathcal{O}_{K}[\gamma] \cap K\right) \cong \operatorname{Cl}\left(\mathcal{O}_{K}\right)$ if and only if all prime ideals in $X(K, \gamma)$ are principal.
Corollary 1.8.2. If $K$ is a number field and $\gamma \in \overline{\mathbb{Q}}$, then $\mathcal{O}_{K}[\gamma] \cap K$ is a principal ideal domain if and only if $\operatorname{Cl}\left(\mathcal{O}_{K}\right)=\langle[\mathfrak{p}] \mid \mathfrak{p} \in X(K, \gamma)\rangle$.

Given a fixed algebraic number $\gamma \in \overline{\mathbb{Q}}$, we consider the problem of determining $X(K, \gamma)$ for every number field $K$. Firstly, if $\gamma \in K$, then Theorem 1.4 implies that $\mathfrak{p} \in X(K, \gamma)$ if and only if $v_{\mathfrak{p}}(\gamma)<0$. However, if $\gamma \notin K$, then we need to look at the primes of $\mathcal{O}_{K(\gamma)}$ that are above $\mathfrak{p}$. There is a simpler way to test whether $\mathfrak{p} \in X(K, \gamma)$.
Definition 1.9. Let $S \subseteq \overline{\mathbb{Z}}$, then $S$ is called a generating set of $\gamma$ if it has the property that for every number field $L$,

$$
X(L, \gamma)=\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap S \neq \emptyset\right\}
$$

For example, we will show that $\{15,4+i\}$ is a generating set of $\frac{1}{60+15 i}$. This means that for any number field $K$, we have

$$
X\left(K, \frac{1}{60+15 i}\right)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid 15 \in \mathfrak{p} \text { or } 4+i \in \mathfrak{p}\right\}
$$

In Section 4, we will show that every algebraic number $\gamma$ has a generating set of finite size. Proposition 1.7 describes the ring $\mathcal{O}_{K}[\gamma] \cap K$ in terms of $X(K, \gamma)$. We can also describe this ring in terms of a generating set of $\gamma$.

Proposition 1.10. For a subset $S \subseteq \overline{\mathbb{Z}}, S$ is a generating set of $\gamma$ if and only if for every number field $K$, we have

$$
\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}[1 / \alpha \mid \alpha \in S \cap K]
$$

Proposition 1.11. Suppose $S$ is a generating set of $\gamma$. Then we have

$$
\overline{\mathbb{Z}}[\gamma]=\overline{\mathbb{Z}}[1 / \alpha \mid \alpha \in S] .
$$

Given an algebraic number $\gamma$, we define its denominator ideal to be

$$
\mathfrak{D}_{\gamma}=\{a \in \overline{\mathbb{Z}} \mid a \gamma \in \overline{\mathbb{Z}}\} .
$$

Note that $\mathfrak{D}_{\gamma} \cap \mathbb{Z}=d(\gamma) \mathbb{Z}$.
Theorem 1.12. Let $S$ be a finite generating set of $\gamma$, then as ideals of $\overline{\mathbb{Z}}$, we have

$$
\sqrt{\mathfrak{D}_{\gamma}}=\sqrt{\left(\prod_{\alpha \in S} \alpha\right) \overline{\mathbb{Z}}}
$$

Let $K$ be a number field, then as ideals of $\mathcal{O}_{K}$ we have

$$
\sqrt{\mathfrak{D}_{\gamma} \cap \mathcal{O}_{K}}=\prod_{\mathfrak{p} \in Y(K, \gamma)} \mathfrak{p}
$$

and

$$
\sqrt{\left(\prod_{\alpha \in S \cap K} \alpha\right) \mathcal{O}_{K}}=\prod_{\mathfrak{p} \in X(K, \gamma)} \mathfrak{p}
$$

In Theorem 4.9, we show that two algebraic numbers $\gamma_{1}, \gamma_{2}$ satisfy $\mathfrak{D}_{\gamma_{1}}=\mathfrak{D}_{\gamma_{2}}$ if and only if for any number field $K, X\left(K, \gamma_{1}\right)=X\left(K, \gamma_{2}\right)$. In Proposition 5.1, we obtain an analog of Proposition 1.7 for finite extensions of $\mathbb{Q}_{p}$.

## 2. Primes in denominators

In this section we will prove Theorem 1.4, Theorem 1.5, Theorem 1.6, Proposition 1.7 and Proposition 1.8, Let $K$ be a number field and $\gamma \in \overline{\mathbb{Q}}$ be an algebraic number. Recall that the monic irreducible polynomial of $\gamma$ in $K[x]$ is denoted as $f_{K, \gamma}(x)=$ $b_{n} x^{n}+\cdots+b_{0} \in K[x]$. We have $b_{n}=1$. For each non-zero prime ideal $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$, let

$$
\alpha_{\mathfrak{p}}=-\min \left\{v_{\mathfrak{p}}\left(b_{i}\right) \mid 0 \leq i \leq n\right\}
$$

Clearly $\alpha_{\mathfrak{p}}=0$ for all but finitely many primes $\mathfrak{p}$. Since $b_{n}=1$, we also know that all $\alpha_{\mathfrak{p}} \geq 0$. Consider the ideal $I_{K, \gamma}=\prod_{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)} \mathfrak{p}^{\alpha_{\mathfrak{p}}}$.
Proposition 2.1. Let $K, \gamma$ and $I_{K, \gamma}$ be as above, then we have

$$
\mathcal{O}_{K}[\gamma] \cong \mathcal{O}_{K}[x] /\left(f_{K, \gamma}(x) I_{K, \gamma}[x]\right)
$$

Proof. First we check that $f_{K, \gamma}(x) I_{K, \gamma}[x] \subseteq \mathcal{O}_{K}[x]$. For any $b \in I_{K, \gamma}$ and $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$, we know that $\mathfrak{p}^{\alpha_{\mathfrak{p}}} \mid I_{K, \gamma}$ and $I_{K, \gamma} \mid(b)$, so $v_{\mathfrak{p}}(b) \geq \alpha_{\mathfrak{p}}$. By the definition of $\alpha_{\mathfrak{p}}$, we see that for each $0 \leq i \leq n, v_{\mathfrak{p}}\left(b b_{i}\right) \geq 0$. Since this holds for all $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$, we have $b b_{i} \in \mathcal{O}_{K}$. This means that for any $b \in I_{K, \gamma}$, we have $b f_{K, \gamma}(x) \in \mathcal{O}_{K}[x]$ and hence $f_{K, \gamma}(x) I_{K, \gamma}[x] \subseteq \mathcal{O}_{K}[x]$.

Now consider the homomorphism $\phi$ from $\mathcal{O}_{K}[x]$ to $\mathcal{O}_{K}[\gamma]$ that sends $x$ to $\gamma$. It is clearly surjective. It is also clear that $f_{K, \gamma}(x) I_{K, \gamma}[x] \subseteq \operatorname{ker}(\phi)$. It only remains to show that $\operatorname{ker}(\phi) \subseteq f_{K, \gamma}(x) I_{K, \gamma}[x]$.

Pick some $g(x) \in \operatorname{ker}(\phi)$, so $g(x) \in \mathcal{O}_{K}[x]$. Since $g(\gamma)=0$, we know that $f_{K, \gamma} \mid g$ in $K[x]$. So we have $h(x) \in K[x]$, such that $g(x)=f_{K, \gamma}(x) h(x)$. Say $h(x)=d_{m} x^{m}+$ $\cdots+d_{0}$ and $g(x)=c_{m+n} x^{m+n}+\cdots+c_{0}$. So $d_{i} \in K$ and $c_{i} \in \mathcal{O}_{K}$. For $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$, denote $\beta_{\mathfrak{p}}=\min \left\{v_{\mathfrak{p}}\left(d_{j}\right) \mid 0 \leq j \leq m\right\}$.

Fix a prime $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$. Let $t$ be the largest integer for which $v_{\mathfrak{p}}\left(b_{t}\right)=-\alpha_{\mathfrak{p}}$. Also let $k$ be the largest integer for which $v_{\mathfrak{p}}\left(d_{k}\right)=\beta_{\mathfrak{p}}$. Then we have

$$
c_{t+k}=\sum_{i>0} b_{t+i} d_{k-i}+b_{t} d_{k}+\sum_{j>0} b_{t-j} d_{k+j} .
$$

Now, notice that $v_{\mathfrak{p}}\left(b_{t} d_{k}\right)=\beta_{\mathfrak{p}}-\alpha_{\mathfrak{p}}$. For $i>0$, we have $v_{\mathfrak{p}}\left(b_{t+i}\right)>-\alpha_{\mathfrak{p}}$ and $v_{\mathfrak{p}}\left(d_{k-i}\right) \geq$ $\beta_{\mathfrak{p}}$ meaning $v_{\mathfrak{p}}\left(b_{t+i} d_{k-i}\right)>\beta_{\mathfrak{p}}-\alpha_{\mathfrak{p}}$. Similarly for $j>0$ we have $v_{\mathfrak{p}}\left(b_{t-j} d_{k+j}\right)>\beta_{\mathfrak{p}}-\alpha_{\mathfrak{p}}$. We therefore see that $v_{\mathfrak{p}}\left(c_{t+k}\right)=\beta_{\mathfrak{p}}-\alpha_{\mathfrak{p}}$. Next since $c_{t+k} \in \mathcal{O}_{K}$, we conclude $\alpha_{\mathfrak{p}} \leq \beta_{\mathfrak{p}}$. This means that for each $0 \leq j \leq m$, we have $v_{\mathfrak{p}}\left(d_{j}\right) \geq \alpha_{\mathfrak{p}}=v_{\mathfrak{p}}\left(I_{K, \gamma}\right)$.

Since this holds for each prime $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$, we conclude that $I_{K, \gamma} \mid\left(d_{j}\right)$, that is $d_{j} \in$ $I_{K, \gamma}$. This implies that $h(x) \in I_{K, \gamma}[x]$ and $g(x) \in f_{K, \gamma}(x) I_{K, \gamma}[x]$. We have shown that $\operatorname{ker}(\phi)=f_{K, \gamma}(x) I[x]$ and hence we conclude that $\mathcal{O}_{K}[\gamma] \cong \mathcal{O}_{K}[x] /\left(f_{K, \gamma}(x) I_{K, \gamma}[x]\right)$.

Let $K, \gamma$ and $f_{K, \gamma}(x)=b_{n} x^{n}+\cdots+b_{0}$ be as above $\left(b_{n}=1\right)$. Denote

$$
S_{K, 1}(\gamma)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid \text { there exists } \alpha \in \mathfrak{p} \text { such that } 1 / \alpha \in \mathcal{O}_{K}[\gamma]\right\}
$$

$$
S_{K, 2}(\gamma)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid \text { for every } i \in[1, n], \text { we have } v_{\mathfrak{p}}\left(b_{i}\right)>v_{\mathfrak{p}}\left(b_{0}\right)\right\}
$$

$S_{K, 3}(\gamma)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid\right.$ for every $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{K(\gamma)}\right)$, if $\mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p}$ then $\left.v_{\mathfrak{q}}(\gamma)<0\right\}$. Recall that Theorem 1.4 asks us to show that $S_{K, 1}(\gamma)=S_{K, 2}(\gamma)=S_{K, 3}(\gamma)$. We will do this by showing that $S_{K, 1}(\gamma) \supseteq S_{K, 2}(\gamma), S_{K, 2}(\gamma) \supseteq S_{K, 3}(\gamma)$ and $S_{K, 3}(\gamma) \supseteq S_{K, 1}(\gamma)$.

Lemma 2.2. Given number field $K$ and $\gamma \in \overline{\mathbb{Q}}$, we have $S_{K, 2}(\gamma) \subseteq S_{K, 1}(\gamma)$.
Proof. Suppose $\mathfrak{p} \in S_{K, 2}(\gamma)$. Pick $a \in \mathcal{O}_{K}$ such that each $a b_{i} \in \mathcal{O}_{K}$. Denote $c_{i}=a b_{i} \in$ $\mathcal{O}_{K}$. Then we have $v_{\mathfrak{p}}\left(c_{n}\right), \ldots, v_{\mathfrak{p}}\left(c_{1}\right)>v_{\mathfrak{p}}\left(c_{0}\right)$ and

$$
c_{0}=-c_{n} \gamma^{n}-c_{n-1} \gamma^{n-1}-\cdots-c_{1} \gamma .
$$

Suppose $\left(c_{0}\right)=\mathfrak{p}^{e} J$, where $e=v_{\mathfrak{p}}\left(c_{0}\right)$ and $J+\mathfrak{p}=(1)$. Let $h$ be the class number of $K$. Suppose $\mathfrak{p}^{h}=(\beta)$ and $J^{h}=(\alpha)$. Therefore $c_{0}^{h}=\beta^{e} \alpha$ (possibly after replacing $\alpha$ by a unit multiple) and $(\alpha)+(\beta)=(1)$. Moreover, $\beta \in \mathfrak{p}, v_{\mathfrak{p}}(\beta)=h$ and $v_{\mathfrak{p}^{\prime}}(\beta)=0$ for any $\mathfrak{p}^{\prime} \neq \mathfrak{p}$. Now, we have

$$
\beta^{e} \alpha=c_{0}^{h}=\left(-c_{n} \gamma^{n}-c_{n-1} \gamma^{n-1}-\cdots-c_{1} \gamma\right)^{h}=(-1)^{h} \sum_{1 \leq j_{1} \leq \cdots \leq j_{h} \leq n} c_{j_{1}} \ldots c_{j_{h}} \gamma^{\sum_{i=1}^{h} j_{i}} .
$$

Notice that $v_{\mathfrak{p}}\left(c_{j_{1}} \ldots c_{j_{h}}\right) \geq h(e+1)=v_{\mathfrak{p}}\left(\beta^{e+1}\right)$. This means that $v_{\mathfrak{p}}\left(\frac{c_{j_{1}} \ldots c_{j_{h}}}{\beta^{e+1}}\right) \geq 0$.


$$
\frac{\alpha}{\beta}=(-1)^{h} \sum_{1 \leq j_{1} \leq \cdots \leq j_{h} \leq n} \frac{c_{j_{1}} \ldots c_{j_{h}}}{\beta^{e+1}} \gamma^{\sum_{i=1}^{h} j_{i}} \in \mathcal{O}_{K}[\gamma] .
$$

Now since $(\alpha)+(\beta)=(1)$, there are $x, y \in \mathcal{O}_{K}$ such that $x \alpha+y \beta=1$. Thus, $\frac{1}{\beta}=x \frac{\alpha}{\beta}+y \in \mathcal{O}_{K}[\gamma]$. So $\beta \in \mathfrak{p}$ and $\frac{1}{\beta} \in \mathcal{O}_{K}[\gamma]$. Thus $\mathfrak{p}$ in $S_{K, 1}(\gamma)$.

Lemma 2.3. Given a number field $K$ and $\gamma \in \overline{\mathbb{Q}}$, we have $S_{K, 1}(\gamma) \subseteq S_{K, 3}(\gamma)$.
Proof. Suppose we have a prime $\mathfrak{p}$ in $S_{K, 1}(\gamma)$. This means that we have $\alpha \in \mathfrak{p}$ and $c_{k} \in \mathcal{O}_{K}$ such that $\frac{1}{\alpha}=\sum_{k=0}^{m} c_{k} \gamma^{k}$. Let $\mathfrak{q}$ be a prime of $\mathcal{O}_{K[\gamma]}$ above $\mathfrak{p}$. Since $\alpha \in \mathfrak{p} \subseteq \mathfrak{q}$, we see that $v_{\mathfrak{q}}\left(\sum_{k=0}^{m} c_{k} \gamma^{k}\right)<0$. This implies there is some $k$ for which $v_{\mathfrak{q}}\left(c_{k} \gamma^{k}\right)<0$. Since $c_{k} \in \mathcal{O}_{K}$, we conclude that $v_{\mathfrak{q}}(\gamma)<0$.

Let $\mathcal{O}_{K \mathfrak{p}}$ be the completion of $\mathcal{O}_{K}$ at $\mathfrak{p}$. Let $\overline{\mathcal{O}_{K \mathfrak{p}}}$ be an algebraic closure of $\mathcal{O}_{K \mathfrak{p}}$. Let $\bar{v}$ be the unique valutaion on $\overline{\mathcal{O}_{K \mathfrak{p}}}$ that extends $v_{\mathfrak{p}}$. Say we have

$$
f_{K, \gamma}(x)=\left(x-\gamma_{1}\right) \ldots\left(x-\gamma_{n}\right)
$$

over $\overline{\mathcal{O}_{K \mathfrak{p}}}$. Suppose we have the following factorisation in $\mathcal{O}_{K(\gamma)}$

$$
\mathfrak{p} \mathcal{O}_{K(\gamma)}=\mathfrak{q}_{1}^{e_{1}} \ldots \mathfrak{q}_{r}^{e_{r}} .
$$

It is known that

$$
\left\{e_{i} v_{\mathfrak{q}_{i}}(\gamma) \mid i \in\{1, \ldots, r\}\right\}=\left\{\bar{v}\left(\gamma_{j}\right) \mid j \in\{1, \ldots, n\}\right\} .
$$

Lemma 2.4. Given a number field $K$ and $\gamma \in \overline{\mathbb{Q}}$, we have $S_{K, 3}(\gamma) \subseteq S_{K, 2}(\gamma)$.
Proof. Suppose we have $\mathfrak{p} \in S_{K, 3}(\gamma)$. This means that all $v_{\mathfrak{q}_{i}}(\gamma)<0$ and hence all $\bar{v}\left(\gamma_{j}\right)<0$. Now, we have

$$
\bar{v}\left(b_{0}\right)=\sum_{j=1}^{n} \bar{v}\left(\gamma_{j}\right)<0=\bar{v}\left(b_{n}\right)
$$

Also for $1 \leq t \leq n-1$ we have

$$
\bar{v}\left(b_{n-t}\right) \geq \min _{1 \leq j_{1}<\cdots<j_{t} \leq n} \sum_{k=1}^{t} \bar{v}\left(\gamma_{j_{k}}\right)>\sum_{j=1}^{n} \bar{v}\left(\gamma_{j}\right)=\bar{v}\left(b_{0}\right) .
$$

We conclude that $\mathfrak{p} \in S_{K, 2}(\gamma)$.
Theorem 1.4. Given a number ring $\mathcal{O}_{K}$, an algebraic number $\gamma$ and a prime $\mathfrak{p} \in$ $\operatorname{Spec}\left(\mathcal{O}_{K}\right)$, the following are equivalent:

- For every $i \in[1, n]: v_{\mathfrak{p}}\left(b_{i}\right)>v_{\mathfrak{p}}\left(b_{0}\right)$.
- There exists an $\alpha \in \mathfrak{p}$ for which $\frac{1}{\alpha} \in \mathcal{O}_{K}[\gamma]$.
- For every $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{K(\gamma)}\right)$ : if $\mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p}$ then $v_{\mathfrak{q}}(\gamma)<0$.

Proof. This follows from Lemma [2.2, Lemma 2.3 and Lemma 2.4,
Theorem 1.5. Given a number ring $\mathcal{O}_{K}$, an algebraic number $\gamma$ and a prime $\mathfrak{p} \in$ $\operatorname{Spec}\left(\mathcal{O}_{K}\right)$, the following are equivalent:

- There exists $i \in[0, n-1]$ for which $v_{\mathfrak{p}}\left(b_{i}\right)<0$.
- There exists $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{K(\gamma)}\right)$ for which $\mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p}$ and $v_{\mathfrak{q}}(\gamma)<0$.

Proof. Suppose $\mathfrak{p}$ does not satisfy the second condition, this means that each $v_{\mathfrak{q}_{i}}(\gamma) \geq 0$ and hence each $\bar{v}\left(\gamma_{j}\right) \geq 0$. We see that for $1 \leq t \leq n$,

$$
\bar{v}\left(b_{n-t}\right) \geq \min _{1 \leq j_{1}<\cdots<j_{t} \leq n} \sum_{k=1}^{t} \bar{v}\left(\gamma_{j_{k}}\right) \geq 0 .
$$

Therefore $\mathfrak{p}$ does not satisfy the first condition.
For the other direction, suppose $\mathfrak{p}$ satisfies the second condition. This means that at least one $v_{q_{i}}(\gamma)<0$ and hence at least one $\bar{v}\left(\gamma_{j}\right)<0$. Relabel the $\gamma_{j}$ such that $\bar{v}\left(\gamma_{1}\right), \ldots, \bar{v}\left(\gamma_{t}\right)$ are negative $(t \geq 1)$ and $\bar{v}\left(\gamma_{t+1}\right), \ldots, \bar{v}\left(\gamma_{n}\right)$ are not negative. Then

$$
\min \left\{\sum_{k=1}^{t} \bar{v}\left(\gamma_{j_{k}}\right) \mid 1 \leq j_{1}<\cdots<j_{t} \leq n\right\}=\sum_{k=1}^{t} \bar{v}\left(\gamma_{k}\right),
$$

and it is the unique minimum element in the set. Therefore

$$
\bar{v}\left(b_{n-t}\right)=\sum_{k=1}^{t} \bar{v}\left(\gamma_{k}\right)<0 .
$$

This shows that $\mathfrak{p}$ satisfies the first condition.

Proposition 1.7. For $a, b \in \mathcal{O}_{K}, b \neq 0$ : we have $\frac{a}{b} \in \mathcal{O}_{K}[\gamma]$ if and only if

$$
\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid v_{\mathfrak{p}}(a)<v_{\mathfrak{p}}(b)\right\} \subseteq X(K, \gamma)
$$

Proof. Suppose we have $a, b \in \mathcal{O}_{K}, b \neq 0$ with $\frac{a}{b} \in \mathcal{O}_{K}[\gamma]$. Consider some $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$ such that $v_{\mathfrak{p}}(a)<v_{\mathfrak{p}}(b)$. Suppose $(a)=\mathfrak{p}^{e} I$ and $(b)=\mathfrak{p}^{k} J$, where $e=v_{\mathfrak{p}}(a), k=v_{\mathfrak{p}}(b)$ and $I+\mathfrak{p}=(1)$. Let $h$ be the class number of $\mathcal{O}_{K}$, so $\mathfrak{p}^{h}, I^{h}$ and $J^{h}$ are all principal ideals. Say $\mathfrak{p}^{h}=(\beta), I^{h}=\left(\alpha_{1}\right)$ and $J^{h}=\left(\alpha_{2}\right)$. Therefore (after replacing $\alpha_{1}$ by a unit multiple) we have $\frac{a^{h}}{b^{h}}=\frac{\alpha_{1}}{\beta^{r} \alpha_{2}} \in \mathcal{O}_{K}[\gamma]$, where $r=k-e \geq 1$. Since $\alpha_{2} \in \mathcal{O}_{K}$, we have that $\frac{\alpha_{1}}{\beta^{r}} \in \mathcal{O}_{K}[\gamma]$. Next $I+\mathfrak{p}=(1)$ implies $\left(\alpha_{1}\right)+\left(\beta^{r}\right)=1$. This means there exist $x, y \in \mathcal{O}_{K}$ such that $x \beta^{r}+y \alpha_{1}=1$. So then $\frac{1}{\beta^{r}}=x+y \frac{\alpha_{1}}{\beta^{r}} \in \mathcal{O}_{K}[\gamma]$. Finally, $\beta^{r} \in \mathfrak{p}$ and $\frac{1}{\beta^{n}} \in \mathcal{O}_{K}[\gamma]$, therefore $\mathfrak{p} \in X(K, \gamma)$.

Conversely, suppose we have $a, b \in \mathcal{O}_{K}$ such that $b \neq 0$ and

$$
\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid v_{\mathfrak{p}}(a)<v_{\mathfrak{p}}(b)\right\} \subseteq X(K, \gamma) .
$$

Let $\mathfrak{p}_{1}, \mathfrak{p}_{2}, \ldots, \mathfrak{p}_{n}$ be the list of primes such that $v_{\mathfrak{p}_{i}}(b)>v_{\mathfrak{p}_{i}}(a)$. Then since $\mathfrak{p}_{i} \in$ $X(K, \gamma)$, there are $\alpha_{i} \in \mathfrak{p}_{i}$ such that $\frac{1}{\alpha_{i}} \in \mathcal{O}_{K}[\gamma]$. We can pick a sufficiently large $N$ such that $v_{\mathfrak{p}}\left(a \prod_{i} \alpha_{i}^{N}\right) \geq v_{\mathfrak{p}}(b)$ for all $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$. Then $\frac{a \prod_{i} \alpha_{i}^{N}}{b} \in \mathcal{O}_{K}$. Finally this implies

$$
\frac{a}{b}=\frac{a \prod_{i} \alpha_{i}^{N}}{b} \frac{1}{\alpha_{1}^{N}} \cdots \frac{1}{\alpha_{n}^{N}} \in \mathcal{O}_{K}[\gamma] .
$$

Theorem 1.6. Given a number ring $\mathcal{O}_{K}$ and an algebraic number $\gamma$ :
(1) $X(K, \gamma)=\emptyset$ if and only if $\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}$.
(2) $Y(K, \gamma)=\emptyset$ if and only if $\gamma \in \overline{\mathbb{Z}}$.

Proof. Note that $X(K, \gamma)=S_{K, 1}(\gamma)$. Let $h$ be the class number of $\mathcal{O}_{K}$.
First suppose $X(K, \gamma)=\emptyset$. Consider $\alpha \in \mathcal{O}_{K}[\gamma] \cap K$. By Proposition 1.7, we know that

$$
\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid v_{\mathfrak{p}}(\alpha)<0\right\} \subseteq X(K, \gamma)
$$

This implies that $v_{\mathfrak{p}}(\alpha) \geq 0$ for all primes $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$. Thus $\alpha \in \mathcal{O}_{K}$ and hence $\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}$.

Conversely, suppose $X(K, \gamma) \neq \emptyset$. Pick $\mathfrak{p} \in X(K, \gamma)=S_{K, 1}(\gamma)$. By the definition of $S_{K, 1}(\gamma)$, there exists $\alpha \in \mathfrak{p}$ such that $\frac{1}{\alpha} \in \mathcal{O}_{K}[\gamma]$. Then $\frac{1}{\alpha}$ is an element in $\mathcal{O}_{K}[\gamma] \cap K$ that is not in $\mathcal{O}_{K}$. We conclude that $\mathcal{O}_{K}[\gamma] \cap K \neq \mathcal{O}_{K}$.

Next, we prove the second part. Note that $\gamma \in \overline{\mathbb{Z}}$ if and only if $\gamma$ is integral over $\mathcal{O}_{K}$. Moreover, this happens if and only if $f_{K, \gamma}(x) \in \mathcal{O}_{K}[x]$. This is equivalent to the condition that for every $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$ and for every $i \in[0, n-1]: v_{\mathfrak{p}}\left(b_{i}\right) \geq 0$. This is clearly equivalent to $Y(K, \gamma)=\emptyset$.

Proposition 2.5. [10, Chapter 8, Section 3] Suppose $K$ is a number field and $X$ is a finite set of prime ideals of $\mathcal{O}_{K}$. Consider

$$
\mathcal{O}_{K, X}=\left\{\alpha \in K \mid \text { for all } \mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \text {, if } v_{\mathfrak{p}}(\alpha)<0, \text { then } \mathfrak{p} \in X\right\} .
$$

Then $\mathcal{O}_{K, X}$ is a Dedekind domain and its class group is

$$
C l\left(\mathcal{O}_{K, X}\right) \cong C l\left(\mathcal{O}_{K}\right) /\langle[\mathfrak{p}] \mid \mathfrak{p} \in X\rangle
$$

Proposition 1.8. If $K$ is a number field and $\gamma \in \overline{\mathbb{Q}}$, then $\mathcal{O}_{K}[\gamma] \cap K$ is a Dedekind domain and its class group is

$$
\mathrm{Cl}\left(\mathcal{O}_{K}[\gamma] \cap K\right) \cong \mathrm{Cl}\left(\mathcal{O}_{K}\right) /\langle[\mathfrak{p}] \mid \mathfrak{p} \in X(K, \gamma)\rangle
$$

Proof. This follows from Proposition 1.7 and Proposition 2.5.

## 3. VARYING THE NUMBER FIELD

In this Section we will study how $X(K, \gamma)$ and $Y(K, \gamma)$ change as we fix $\gamma$ and change $K$.

Lemma 3.1. If $K \subseteq L$ are number fields then

$$
\begin{gathered}
X(K, \gamma)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid \text { for every } \mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \text {, if } \mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p} \text { then } \mathfrak{q} \in X(L, \gamma)\right\}, \\
X(L, \gamma) \supseteq\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in X(K, \gamma)\right\} .
\end{gathered}
$$

Moreover if $L \cap K(\gamma)=K$, then we have

$$
X(L, \gamma)=\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in X(K, \gamma)\right\}
$$

Proof. First, suppose $\mathfrak{p}$ is a prime of $\mathcal{O}_{K}$, such that every prime of $\mathcal{O}_{L}$ above $\mathfrak{p}$ lies in $X(L, \gamma)$. We will show that $\mathfrak{p} \in X(K, \gamma)$.


Let $\mathfrak{p}^{\prime}$ be a prime of $\mathcal{O}_{K(\gamma)}$ that is above $\mathfrak{p}$. Let $\mathfrak{q}^{\prime}$ be a prime of $\mathcal{O}_{L(\gamma)}$ that is above $\mathfrak{p}^{\prime}$. Let $\mathfrak{q}=\mathfrak{q}^{\prime} \cap \mathcal{O}_{L}$. Then $\mathfrak{q}$ lies above $\mathfrak{p}$ and hence $\mathfrak{q} \in X(L, \gamma)$. This implies that $v_{\mathfrak{q}^{\prime}}(\gamma)<0$. Hence $v_{\mathfrak{p}^{\prime}}(\gamma)=\frac{1}{e\left(\mathfrak{q}^{\prime} \mid \mathfrak{p}^{\prime}\right)} v_{\mathfrak{q}^{\prime}}(\gamma)<0$. Since this holds for every prime $\mathfrak{p}^{\prime}$ of $\mathcal{O}_{K(\gamma)}$ that is above $\mathfrak{p}$, we see that $\mathfrak{p} \in X(K, \gamma)$. We have shown that
$X(K, \gamma) \supseteq\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid\right.$ for every $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$, if $\mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p}$ then $\left.\mathfrak{q} \in X(L, \gamma)\right\}$.
Next, consider a prime $\mathfrak{p} \in X(K, \gamma)$. Let $\mathfrak{q}$ be a prime of $\mathcal{O}_{L}$ above $\mathfrak{p}$. We will show that $\mathfrak{q} \in X(L, \gamma)$. Consider a prime $\mathfrak{q}^{\prime}$ of $\mathcal{O}_{L(\gamma)}$ above $\mathfrak{q}$. Let $\mathfrak{p}^{\prime}=\mathfrak{q}^{\prime} \cap \mathcal{O}_{K(\gamma)}$. Then $\mathfrak{p}$ is in $X(K, \gamma)$ and $\mathfrak{p}^{\prime}$ is a prime of $\mathcal{O}_{K(\gamma)}$ above $\mathfrak{p}$, therefore $v_{\mathfrak{p}^{\prime}}(\gamma)<0$. Next
$v_{\mathfrak{q}^{\prime}}(\gamma)=e\left(\mathfrak{q}^{\prime} \mid \mathfrak{p}^{\prime}\right) v_{\mathfrak{p}^{\prime}}(\gamma)<0$. Since this holds for every prime $\mathfrak{q}^{\prime}$ of $\mathcal{O}_{L(\gamma)}$ above $\mathfrak{q}$, we conclude that $\mathfrak{q} \in X(L, \gamma)$. This shows that
$X(K, \gamma) \subseteq\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid\right.$ for every $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$, if $\mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p}$ then $\left.\mathfrak{q} \in X(L, \gamma)\right\}$.
We can conclude that
$X(K, \gamma)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid\right.$ for every $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$, if $\mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p}$ then $\left.\mathfrak{q} \in X(L, \gamma)\right\}$.
Next, let $\mathfrak{q}$ be a prime of $\mathcal{O}_{L}$ for which $\mathfrak{q} \cap \mathcal{O}_{K} \in X(K, \gamma)$. Let $\mathfrak{p}=\mathfrak{q} \cap \mathcal{O}_{K}$. Then $\mathfrak{p}$ is in $X(K, \gamma)$ and $\mathfrak{q}$ is a prime of $\mathcal{O}_{L}$ above $\mathfrak{p}$. Therefore, from the previous part we see that $\mathfrak{q} \in X(L, \gamma)$. This shows that

$$
X(L, \gamma) \supseteq\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in X(K, \gamma)\right\}
$$

For the last part, suppose $L \cap K(\gamma)=K$. This means that

$$
f_{L, \gamma}(x)=f_{K, \gamma}(x)=b_{n} x^{n}+\cdots+b_{0} \in K(x)
$$

Consider $\mathfrak{q} \in X(L, \gamma)$. We know that for each $i \in[1, n]$, we have $v_{\mathfrak{q}}\left(b_{i}\right)>v_{\mathfrak{q}}\left(b_{0}\right)$. Let $\mathfrak{p}=\mathfrak{q} \cap \mathcal{O}_{K}$. Then

$$
v_{\mathfrak{p}}\left(b_{i}\right)=\frac{1}{e(\mathfrak{q} \mid \mathfrak{p})} v_{\mathfrak{q}}\left(b_{i}\right)>\frac{1}{e(\mathfrak{q} \mid \mathfrak{p})} v_{\mathfrak{q}}\left(b_{0}\right)=v_{\mathfrak{p}}\left(b_{0}\right)
$$

This implies that $\mathfrak{p}=\mathfrak{q} \cap \mathcal{O}_{K} \in X(K, \gamma)$. We conclude that

$$
X(L, \gamma)=\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in X(K, \gamma)\right\}
$$

Note that if $L \cap K(\gamma) \neq K$, then it is possible that

$$
X(L, \gamma) \supsetneq\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in X(K, \gamma)\right\}
$$

For example, consider $K=\mathbb{Q}, L=\mathbb{Q}[i]$ and $\gamma=\frac{1}{2+i}$. Then $X(L, \gamma)=\{(2+i)\}$, but $X(K, \gamma)=\emptyset$ so $\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in X(K, \gamma)\right\}=\emptyset$.

Lemma 3.2. If $K \subseteq L$ are number fields then
$Y(K, \gamma)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid\right.$ there exists $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ above $\mathfrak{p}$ such that $\left.\mathfrak{q} \in Y(L, \gamma)\right\}$,

$$
Y(L, \gamma) \subseteq\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in Y(K, \gamma)\right\}
$$

Moreover if $L \cap K(\gamma)=K$, then we have

$$
Y(L, \gamma)=\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in Y(K, \gamma)\right\}
$$

Proof. First, suppose $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$ for which there is a prime $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ above $\mathfrak{p}$ such that $\mathfrak{q} \in Y(L, \gamma)$. We will show that $\mathfrak{p} \in Y(K, \gamma)$.


Since $\mathfrak{q} \in Y(L, \gamma)$, there is a prime $\mathfrak{q}^{\prime}$ of $\mathcal{O}_{L(\gamma)}$ above $\mathfrak{q}$ for which $v_{\mathfrak{q}^{\prime}}(\gamma)<0$. Let $\mathfrak{p}^{\prime}=\mathfrak{q}^{\prime} \cap \mathcal{O}_{K(\gamma)}$. Then $\mathfrak{p}^{\prime}$ is a prime of $\mathcal{O}_{K(\gamma)}$ that is above $\mathfrak{p}$. Moreover, $v_{\mathfrak{p}^{\prime}}(\gamma)=$ $\frac{1}{e\left(\mathfrak{q}^{\prime} \mid \mathfrak{p}^{\prime}\right)} v_{\mathfrak{q}^{\prime}}(\gamma)<0$. We see that $\mathfrak{p} \in Y(K, \gamma)$. We have shown that
$Y(K, \gamma) \supseteq\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid\right.$ there exists $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ above $\mathfrak{p}$ such that $\left.\mathfrak{q} \in Y(L, \gamma)\right\}$.
Next, consider a prime $\mathfrak{p} \in Y(K, \gamma)$. This means there is a prime $\mathfrak{p}^{\prime}$ of $\mathcal{O}_{K(\gamma)}$ above $\mathfrak{p}$ for which $v_{\mathfrak{p}^{\prime}}(\gamma)<0$. Let $\mathfrak{q}^{\prime}$ be a prime of $\mathcal{O}_{L(\gamma)}$ above $\mathfrak{p}^{\prime}$. Then $v_{\mathfrak{q}^{\prime}}(\gamma)=e\left(\mathfrak{q}^{\prime} \mid \mathfrak{p}^{\prime}\right) v_{\mathfrak{p}^{\prime}}(\gamma)<$ 0 . Let $\mathfrak{q}=\mathfrak{q}^{\prime} \cap \mathcal{O}_{L}$. Now $\mathfrak{q}^{\prime}$ is a prime of $\mathcal{O}_{L(\gamma)}$ above $\mathfrak{q}$ for which $v_{\mathfrak{q}^{\prime}}(\gamma)<0$. This means that $\mathfrak{q} \in Y(L, \gamma)$. Moreover, $\mathfrak{q}$ is a prime of $\mathcal{O}_{L}$ above $\mathfrak{p}$. We have shown that $Y(K, \gamma) \subseteq\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid\right.$ there exists $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ above $\mathfrak{p}$ such that $\left.\mathfrak{q} \in Y(L, \gamma)\right\}$.

Next, consider a prime $\mathfrak{q} \in Y(L, \gamma)$. Let $\mathfrak{p}=\mathfrak{q} \cap \mathcal{O}_{K}$. Then $\mathfrak{q}$ is a prime of $\mathcal{O}_{L}$ above $\mathfrak{p}$ and $\mathfrak{q}$ is in $Y(K, \gamma)$. Therefore from the previous part $\mathfrak{p} \in Y(K, \gamma)$. This shows that

$$
Y(L, \gamma) \subseteq\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in Y(K, \gamma)\right\}
$$

For the last part, suppose $L \cap K(\gamma)=K$. This means that

$$
f_{L, \gamma}(x)=f_{K, \gamma}(x)=x^{n}+b_{n-1} x^{n-1}+\cdots+b_{0} \in K(x) .
$$

Consider $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ for which $\mathfrak{p}=\mathfrak{q} \cap \mathcal{O}_{K} \in Y(K, \gamma)$. We know that there is some $i \in[0, n-1]$, for which $v_{\mathfrak{p}}\left(b_{i}\right)<0$. Then $v_{\mathfrak{q}}\left(b_{i}\right)=e(\mathfrak{q} \mid \mathfrak{p}) v_{\mathfrak{p}}\left(b_{i}\right)<0$. This implies that $\mathfrak{q} \in Y(K, \gamma)$. We conclude that

$$
Y(L, \gamma)=\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in Y(K, \gamma)\right\}
$$

Note that if $L \cap K(\gamma) \neq K$, then it is possible that

$$
Y(L, \gamma) \subsetneq\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in Y(K, \gamma)\right\}
$$

For example, consider $K=\mathbb{Q}, L=\mathbb{Q}[i]$ and $\gamma=\frac{1}{2+i}$. Then $Y(L, \gamma)=\{(2+i)\}$, but $Y(K, \gamma)=\{(5)\}$ so $\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in Y(K, \gamma)\right\}=\{(2+i),(2-i)\}$.

Proposition 3.3. If $K \subseteq L$ are number fields, then

$$
\mathcal{O}_{L}[\gamma] \cap K=\mathcal{O}_{K}[\gamma] \cap K
$$

Proof. Clearly $\mathcal{O}_{K}[\gamma] \cap K \subseteq \mathcal{O}_{L}[\gamma] \cap K$. Suppose we have $\frac{a}{b} \in \mathcal{O}_{L}[\gamma] \cap K, a, b \in \mathcal{O}_{K}$. Since $\frac{a}{b} \in \mathcal{O}_{L}[\gamma]$, by Proposition 1.7 we know that whenever $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ satisfies $v_{\mathfrak{q}}(b)>v_{\mathfrak{q}}(a)$, then $\mathfrak{q} \in X(L, \gamma)$. Now suppose we have $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$ such that $v_{\mathfrak{p}}(b)>v_{\mathfrak{p}}(a)$. Then for any $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ that is above $\mathfrak{p}$, we also have $v_{\mathfrak{q}}(b)>v_{\mathfrak{q}}(a)$, which implies that $\mathfrak{q} \in X(L, \gamma)$. Then by Lemma 3.1, we see that $\mathfrak{p} \in X(K, \gamma)$. Therefore, $\frac{a}{b} \in \mathcal{O}_{K}[\gamma]$ by Proposition 1.7.

If two algebraic numbers $\gamma_{1}, \gamma_{2}$ satisfy $\mathcal{O}_{K}\left[\gamma_{1}\right] \cap K=\mathcal{O}_{K}$ and $\mathcal{O}_{K}\left[\gamma_{2}\right] \cap K=\mathcal{O}_{K}$, then we cannot always conclude that $\mathcal{O}_{K}\left[\gamma_{1}, \gamma_{2}\right] \cap K=\mathcal{O}_{K}$. For example, take $\gamma_{1}=\frac{1}{2+i}$, $\gamma_{2}=\frac{1}{2-i}$ and $K=\mathbb{Q}$. However, we will show that if $K\left(\gamma_{1}\right) \cap K\left(\gamma_{2}\right)=K$, then we can conclude that $\mathcal{O}_{K}\left[\gamma_{1}, \gamma_{2}\right] \cap K=\mathcal{O}_{K}$.

Proposition 3.4. Suppose we are given $\gamma_{1}, \ldots, \gamma_{n} \in \overline{\mathbb{Q}}$ such that for every $1 \leq m \leq$ $n-1$ and for every $m+1 \leq j \leq n$ :

$$
K\left(\gamma_{1}, \ldots, \gamma_{m-1}, \gamma_{m}\right) \cap K\left(\gamma_{1}, \ldots, \gamma_{m-1}, \gamma_{j}\right)=K\left(\gamma_{1}, \ldots, \gamma_{m-1}\right)
$$

Suppose moreover that for each $1 \leq i \leq n$ we have $\mathcal{O}_{K}\left[\gamma_{i}\right] \cap K=\mathcal{O}_{K}$, then we have

$$
\mathcal{O}_{K}\left[\gamma_{1}, \ldots, \gamma_{n}\right] \cap K=\mathcal{O}_{K}
$$

Proof. We start by showing that $X\left(K\left(\gamma_{1}, \ldots, \gamma_{k-1}\right), \gamma_{i}\right)=\emptyset$ for all $1 \leq k \leq n$ and $i \geq k$. We will induct on $k$. The base case $k=1$ follows from Theorem 1.6 and the assumption that each $\mathcal{O}_{K}\left[\gamma_{i}\right] \cap K=\mathcal{O}_{K}$. Now assume that this is true for $k-1$, that is, for each $i \geq k-1$, we have $X\left(K\left(\gamma_{1}, \ldots, \gamma_{k-2}\right), \gamma_{i}\right)=\emptyset$. Since we have

$$
K\left(\gamma_{1}, \ldots, \gamma_{k-2}, \gamma_{k-1}\right) \cap K\left(\gamma_{1}, \ldots, \gamma_{k-2}, \gamma_{i}\right)=K\left(\gamma_{1}, \ldots, \gamma_{k-2}\right)
$$

it follows from Lemma 3.1 that

$$
X\left(K\left(\gamma_{1}, \ldots, \gamma_{k-1}\right), \gamma_{i}\right)
$$

$=\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{K\left(\gamma_{1}, \ldots, \gamma_{k-1}\right)}\right) \mid \mathfrak{q} \cap K\left(\gamma_{1}, \ldots, \gamma_{k-2}\right) \in X\left(K\left(\gamma_{1}, \ldots, \gamma_{k-2}\right), \gamma_{i}\right)\right\}$.
Therefore, $X\left(K\left(\gamma_{1}, \ldots, \gamma_{k-1}\right), \gamma_{i}\right)=\emptyset$. This finishes the inductive step. In particular, we have shown that $X\left(K\left(\gamma_{1}, \ldots, \gamma_{k-1}\right), \gamma_{k}\right)=\emptyset$ for each $1 \leq k \leq n$.

Now we will show that $\mathcal{O}_{K}\left[\gamma_{1}, \ldots, \gamma_{n}\right] \cap K \neq \mathcal{O}_{K}$. Assume for the sake of contradiction that $\mathcal{O}_{K}\left[\gamma_{1}, \ldots, \gamma_{n}\right] \cap K \neq \mathcal{O}_{K}$. This means there is some $\beta \in \mathcal{O}_{K}\left[\gamma_{1}, \ldots, \gamma_{n}\right] \cap K$ for which $\beta \notin \mathcal{O}_{K}$. Then there must be a prime $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$ for which $v_{\mathfrak{p}}(\beta)<0$. Since $K(\beta)=K$, Theorem 1.4 implies that $\mathfrak{p} \in X(K, \beta)$ and hence there is $\alpha \in \mathfrak{p}$ for which $\frac{1}{\alpha} \in \mathcal{O}_{K}[\beta] \subseteq \mathcal{O}_{K}\left[\gamma_{1}, \ldots, \gamma_{n}\right] \cap K$.

Next, we will show by induction on $k$ that there exist $\mathfrak{p}_{k} \in \operatorname{Spec}\left(\mathcal{O}_{K\left(\gamma_{1}, \ldots, \gamma_{k}\right)}\right)$, such that $\mathfrak{p}_{k} \cap K=\mathfrak{p}$ and $v_{\mathfrak{p}_{k}}\left(\gamma_{1}\right), \ldots, v_{\mathfrak{p}_{k}}\left(\gamma_{k}\right)$ are all non-negative. We start with the base case $k=1$. Since $X\left(K, \gamma_{1}\right)=\emptyset, \mathfrak{p} \notin X\left(K, \gamma_{1}\right)$. Therefore, there exists $\mathfrak{p}_{1} \in \operatorname{Spec}\left(\mathcal{O}_{K\left(\gamma_{1}\right)}\right)$ such that $\mathfrak{p}_{1} \cap K=\mathfrak{p}$ and $v_{\mathfrak{p}_{1}}\left(\gamma_{1}\right) \geq 0$. Now suppose we have constructed $\mathfrak{p}_{k-1}$. Since $X\left(K\left(\gamma_{1}, \ldots, \gamma_{k-1}\right), \gamma_{k}\right)=\emptyset, \mathfrak{p}_{k-1} \notin X\left(K\left(\gamma_{1}, \ldots, \gamma_{k-1}\right), \gamma_{k}\right)$. Therefore, there exists $\mathfrak{p}_{k} \in \operatorname{Spec}\left(\mathcal{O}_{K\left(\gamma_{1}, \ldots, \gamma_{k}\right)}\right)$ such that $\mathfrak{p}_{k} \cap K\left(\gamma_{1}, \ldots, \gamma_{k-1}\right)=\mathfrak{p}_{k-1}$, and $v_{\mathfrak{p}_{k}}\left(\gamma_{k}\right) \geq 0$. But since $\mathfrak{p}_{k}$ is above $\mathfrak{p}_{k-1}$ and $v_{\mathfrak{p}_{k-1}}\left(\gamma_{1}\right), \ldots, v_{\mathfrak{p}_{k-1}}\left(\gamma_{k-1}\right) \geq 0$, we have that $v_{\mathfrak{p}_{k}}\left(\gamma_{1}\right), \ldots, v_{\mathfrak{p}_{k}}\left(\gamma_{k-1}\right) \geq 0$. This finishes the inductive step.

In particular, if we set $k=n$, this shows that there exists $\mathfrak{p}_{n} \in \operatorname{Spec}\left(\mathcal{O}_{K\left(\gamma_{1}, \ldots, \gamma_{n}\right)}\right)$ such that $\mathfrak{p}_{n}$ is above $\mathfrak{p}$ and $v_{\mathfrak{p}_{n}}\left(\gamma_{i}\right) \geq 0$ for $1 \leq i \leq n$. Since $\frac{1}{\alpha} \in \mathcal{O}_{K}\left[\gamma_{1}, \ldots, \gamma_{n}\right]$, we must have that $v_{\mathfrak{p}_{n}}\left(\frac{1}{\alpha}\right) \geq 0$, so $v_{\mathfrak{p}_{n}}(\alpha) \leq 0$. This contradicts the fact that $\alpha \in \mathfrak{p}$ and $\mathfrak{p}=\mathfrak{p}_{n} \cap K$. Therefore, $\mathcal{O}_{K}\left[\gamma_{1}, \ldots, \gamma_{n}\right] \cap K=\mathcal{O}_{K}$.

Corollary 3.4.1. If $\mathcal{O}_{K}\left[\gamma_{1}\right] \cap K=\mathcal{O}_{K}\left[\gamma_{2}\right] \cap K=\mathcal{O}_{K}$ and $K\left(\gamma_{1}\right) \cap K\left(\gamma_{2}\right)=K$ then

$$
\mathcal{O}_{K}\left[\gamma_{1}, \gamma_{2}\right] \cap K=\mathcal{O}_{K}
$$

## 4. The Generating Set of an Algebraic Number

In this section we will start by constructing a generating set of $\gamma$. After this we will study the properties of generating sets of $\gamma$. We will prove Proposition 1.10, Proposition 1.11 and Theorem 1.12 .

Given an algebraic number $\gamma \in \overline{\mathbb{Q}}$, and number field $K$, denote

$$
\mathcal{L}(\gamma, K)=\left\{\mathfrak{q} \in X(K, \gamma) \mid \text { for every } K_{1} \subsetneq K \text { we have } \mathfrak{q} \cap K_{1} \notin X\left(K_{1}, \gamma\right)\right\}
$$

Further, we define

$$
\mathcal{L}(\gamma)=\{K \mid \mathcal{L}(\gamma, K) \neq \emptyset\}
$$

Lemma 4.1. If $K \in \mathcal{L}(\gamma)$, then we have $K \subseteq \mathbb{Q}(\gamma)$.
Proof. Pick a prime $\mathfrak{q} \in \mathcal{L}(\gamma, K)$. Let $K_{1}=K \cap \mathbb{Q}(\gamma)$. Now we have $K_{1}(\gamma) \cap K=K_{1}$ and $\mathfrak{q} \in X(K, \gamma)$, so by Lemma 3.1 we get $\mathfrak{q} \cap K_{1} \in X\left(K_{1}, \gamma\right)$. Since $\mathfrak{q} \in \mathcal{L}(\gamma, K)$ and $K_{1} \subseteq K$, we conclude that $K_{1}=K$. This shows that $K \subseteq \mathbb{Q}(\gamma)$.
Corollary 4.1.1. For any algebraic number $\gamma, \# \mathcal{L}(\gamma)<\infty$.
We will use $\mathcal{L}(\gamma)$ to construct a generating set of $\gamma$. Denote $J_{K, \gamma}=\prod_{\mathfrak{q} \in \mathcal{L}(\gamma, K)} \mathfrak{q}$, it is an ideal of $\mathcal{O}_{K}$. For each $K \in \mathcal{L}(\gamma)$, denote the class number of $K$ as $h_{K}$. Then $J_{K, \gamma}^{h_{K}}$ is a principal ideal, let $\alpha_{K} \in \mathcal{O}_{K}$ be one of its generators ( $\alpha_{K}$ is not uniquely determined, but pick one).
Lemma 4.2. Let $K \in \mathcal{L}(\gamma)$ and $\alpha_{K}$ be as above. Then $\mathbb{Q}\left(\alpha_{K}\right)=K$.
Proof. Say $\mathbb{Q}\left(\alpha_{K}\right)=K_{1}$, so $K_{1} \subseteq K$. Pick a prime $\mathfrak{q}_{1} \in \mathcal{L}(\gamma, K)$. Let $\mathfrak{p}=\mathfrak{q}_{1} \cap K_{1} \in$ $\operatorname{Spec}\left(\mathcal{O}_{K_{1}}\right)$. Note that if we show that $\mathfrak{p} \in X(K, \gamma)$, then the definition of $\mathcal{L}(\gamma, K)$ will imply that $K_{1}=K$. Now

$$
\alpha_{K} \mathcal{O}_{K}=J_{K, \gamma}^{h_{K}}=\prod_{\mathfrak{q} \in \mathcal{L}(\gamma, K)} \mathfrak{q}^{h_{K}},
$$

so $\alpha_{K} \in \mathfrak{q}_{1}$ and hence $\alpha_{K} \in \mathfrak{p}$. Next let $\mathfrak{q}_{2}$ be a prime of $\mathcal{O}_{K}$ above $\mathfrak{p}$, then $\alpha_{K} \in \mathfrak{p} \mathcal{O}_{K} \subseteq$ $\mathfrak{q}_{2}$. This implies that $\mathfrak{q}_{2}$ divides $\alpha_{K} \mathcal{O}_{K}$ and hence $\mathfrak{q}_{2} \in \mathcal{L}(\gamma, K) \subseteq X(K, \gamma)$. We have shown that every prime of $\mathcal{O}_{K}$ above $\mathfrak{p}$ is in $X(K, \gamma)$, hence Lemma 3.1 implies that $\mathfrak{p} \in X\left(K_{1}, \gamma\right)$. But $\mathfrak{p}=\mathfrak{q}_{1} \cap K_{1}$ and $\mathfrak{q}_{1} \in \mathcal{L}(\gamma, K)$, so we can conclude that $K_{1}=K$, meaning $\mathbb{Q}\left(\alpha_{K}\right)=K$.

Let $S=\left\{\alpha_{K} \mid K \in \mathcal{L}(\gamma)\right\}$. Note that $|S|=|\mathcal{L}(\gamma)|<\infty$.
Corollary 4.2.1. Let $S$ be as above, then $\mathbb{Q}(S)$ is the composite of the fields in $\mathcal{L}(\gamma)$, that is,

$$
\prod_{K \in \mathcal{L}(\gamma)} K=\mathbb{Q}(S) \subseteq \mathbb{Q}(\gamma)
$$

Proposition 4.3. Let $S=\left\{\alpha_{K} \mid K \in \mathcal{L}(\gamma)\right\}$ as above. Then $S$ is a generating set of $\gamma$ with $|S|=\# \mathcal{L}(\gamma)$.

Proof. We know that $|S|=\# \mathcal{L}(\gamma)$, so we only need to show that for every number field $L$ we have

$$
X(L, \gamma)=\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap S \neq \emptyset\right\}
$$

Fix a number field $L$. Consider a prime $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ for which $\mathfrak{q} \cap S \neq \emptyset$. Say $\alpha_{K} \in \mathfrak{q}$, $K \in \mathcal{L}(\gamma)$. Now $\alpha_{K} \in \mathfrak{q} \subseteq L$, so $K=\mathbb{Q}\left(\alpha_{K}\right) \subseteq L$. Let $\mathfrak{q}^{\prime \prime}=\mathfrak{q} \cap K$, so $\alpha_{K} \in \mathfrak{q}^{\prime \prime}$. Since

$$
\alpha_{K} \mathcal{O}_{K}=J_{K, \gamma}^{h_{K}}=\prod_{\mathfrak{p} \in \mathcal{L}(\gamma, K)} \mathfrak{p}^{h_{K}}
$$

we see that $\mathfrak{q}^{\prime \prime} \in \mathcal{L}(\gamma, K) \subseteq X(K, \gamma)$. Then by Lemma 3.1 we see that $\mathfrak{q} \in X(L, \gamma)$.
For the other direction, consider a prime $\mathfrak{q} \in X(L, \gamma)$. Let $K_{1}=L \cap \mathbb{Q}\left(\gamma_{1}\right)$ and $\mathfrak{q}^{\prime}=\mathfrak{q} \cap K_{1}$. Then $K_{1}(\gamma) \cap L=K_{1}$, so by Lemma 3.1 we see that $\mathfrak{q}^{\prime} \in X\left(K_{1}, \gamma\right)$.


Now, consider the set

$$
\left\{E \mid E \subseteq K_{1}, \mathfrak{q}^{\prime} \cap E \in X(E, \gamma)\right\}
$$

This is a finite collection of fields, so let $K$ be a minimal field in this collection. Let $\mathfrak{q}^{\prime \prime}=\mathfrak{q}^{\prime} \cap K=\mathfrak{q} \cap K$. It follows from minimality of $K$ that $\mathfrak{q}^{\prime \prime} \in \mathcal{L}(\gamma, K)$ and hence $K \in \mathcal{L}(\gamma)$. From the definition of $\alpha_{K}$, we see that $\alpha_{K} \in \mathfrak{q}^{\prime \prime}$. We conclude that $\alpha_{K} \in \mathfrak{q}$ and hence $\mathfrak{q} \cap S \neq \emptyset$.
Example 4.4. Consider $\gamma=\frac{1}{60+15 i}$. Then $X(\mathbb{Q}, \gamma)=\{3,5\}$ and $X(\mathbb{Q}(i), \gamma)=\{3,2+$ $i, 2-i, 4+i\}$. Therefore $\mathcal{L}(\gamma, \mathbb{Q})=\{3,5\}, \mathcal{L}(\gamma, \mathbb{Q}(i))=\{4+i\}$ and $\mathcal{L}(\gamma)=\{\mathbb{Q}, \mathbb{Q}(i)\}$. We have $\alpha_{\mathbb{Q}}=15$ and $\alpha_{\mathbb{Q}(i)}=4+i$. Therefore for every number field $L$,

$$
X(L, \gamma)=\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid\{15,4+i\} \cap S \neq \emptyset\right\}
$$

Proposition 4.5. Suppose $S^{\prime}$ is a generating set of $\gamma$. Then we have $\# \mathcal{L}(\gamma) \leq\left|S^{\prime}\right|$ and the composite of the fields in $\mathcal{L}(\gamma)$ is contained in $\mathbb{Q}\left(S^{\prime}\right)$. Moreover, if $\left|S^{\prime}\right|=\# \mathcal{L}(\gamma)$, then we have

$$
\prod_{K \in \mathcal{L}(\gamma)} K=\mathbb{Q}\left(S^{\prime}\right) \subseteq \mathbb{Q}(\gamma)
$$

Proof. Consider $K \in \mathcal{L}(\gamma)$ and $\mathfrak{p} \in \mathcal{L}(\gamma, K)$. Then $\mathfrak{p} \in X(K, \gamma)$, so $\mathfrak{p} \cap S^{\prime} \neq \emptyset$. Say $\beta_{K} \in \mathfrak{p} \cap S^{\prime}$. Now let $K_{1}=\mathbb{Q}\left(\beta_{K}\right)$ and $\mathfrak{p}^{\prime}=\mathfrak{p} \cap K_{1}$. Then $\beta_{K} \in \mathfrak{p}^{\prime} \cap S^{\prime}$, so $\mathfrak{p}^{\prime} \in X\left(K_{1}, \gamma\right)$. But then the definition of $\mathcal{L}(\gamma, K)$ implies that $K_{1}=K$, meaning that $\mathbb{Q}\left(\beta_{K}\right)=K$. This shows that for distinct $K \in \mathcal{L}(\gamma)$, we have distinct $\beta_{K} \in S^{\prime}$. So we conclude that $|\mathcal{L}(\gamma)| \leq\left|S^{\prime}\right|$. Moreover, the fact that $\beta_{K} \in S^{\prime}$ and $\mathbb{Q}\left(\beta_{K}\right)=K$ implies that the
composite $\prod_{K \in \mathcal{L}(\gamma)} K \subseteq \mathbb{Q}\left(S^{\prime}\right)$. Finally if $\left|S^{\prime}\right|=|\mathcal{L}(\gamma)|$, then $S^{\prime}=\left\{\beta_{K} \mid K \in \mathcal{L}(\gamma)\right\}$ and hence $\mathbb{Q}\left(S^{\prime}\right)=\prod_{K \in \mathcal{L}(\gamma)} K$.
Corollary 4.5.1. Suppose $S_{1}$ and $S_{2}$ are generating sets of $\gamma_{1}$ and $\gamma_{2}$ respectively with $\left|S_{1}\right|=\# \mathcal{L}\left(\gamma_{1}\right)$ and $\left|S_{2}\right|=\# \mathcal{L}\left(\gamma_{2}\right)$. Suppose further that $\gamma_{1}, \gamma_{2}$ have the property that for every number field $L, X\left(L, \gamma_{1}\right)=X\left(L, \gamma_{2}\right)$. Then $\mathbb{Q}\left(S_{1}\right)=\mathbb{Q}\left(S_{2}\right)$.
Proof. The property that for every number field $L, X\left(L, \gamma_{1}\right)=X\left(L, \gamma_{2}\right)$, implies that $\mathcal{L}\left(\gamma_{1}\right)=\mathcal{L}\left(\gamma_{2}\right)$. Now we see that

$$
\mathbb{Q}\left(S_{1}\right)=\prod_{K \in \mathcal{L}\left(\gamma_{1}\right)} K=\mathbb{Q}\left(S_{2}\right) .
$$

Proposition 1.10. For a subset $S \subseteq \overline{\mathbb{Z}}, S$ is a generating set of $\gamma$ if and only if for every number field $K$, we have

$$
\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}[1 / \alpha \mid \alpha \in S \cap K] .
$$

Proof. First suppose that $S$ is a generating set of $\gamma$. Fix a number field $K$. Consider $\beta \in \mathcal{O}_{K}[\gamma] \cap K$. Then by proposition 1.7,

$$
\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid v_{\mathfrak{p}}(\beta)<0\right\} \subseteq X(K, \gamma)
$$

But by the definition of generating set, $X(K, \gamma)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid \mathfrak{p} \cap S \neq \emptyset\right\}$. Let $\mathfrak{p}_{1}, \ldots, \mathfrak{p}_{n}$ be the primes in $\operatorname{Spec}\left(\mathcal{O}_{K}\right)$ such that $v_{\mathfrak{p}_{i}}(\beta)<0$. Then for each $\mathfrak{p}_{i}$, $\mathfrak{p}_{i} \cap S \neq \emptyset$. Consider $\alpha_{i} \in \mathfrak{p}_{i} \cap S$, so $\alpha_{i} \in S \cap K$. Then for larger enough $N$, we have $\alpha_{1}^{N} \ldots \alpha_{n}^{N} \beta \in \mathcal{O}_{K}$, so $\beta \in \mathcal{O}_{K}\left[\left.\frac{1}{\alpha} \right\rvert\, \alpha \in S \cap K\right]$.

Now consider $\alpha \in S \cap K$. Then for every $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$ such that $v_{\mathfrak{p}}(\alpha)>v_{\mathfrak{p}}(1)$, we have $\alpha \in S \cap \mathfrak{p}$, so $S \cap \mathfrak{p} \neq \emptyset$ and $\mathfrak{p} \in X(K, \gamma)$. Then by proposition 1.7, we see that $\frac{1}{\alpha} \in \mathcal{O}_{K}[\gamma]$. Therefore, we have $\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}\left[\left.\frac{1}{\alpha} \right\rvert\, \alpha \in S \cap K\right]$.

Conversely, suppose for every number field $K$, we have

$$
\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}[1 / \alpha \mid \alpha \in S \cap K] .
$$

We want to show that $S$ is a generating set, that is, we want to show that for every number field $K, X(K, \gamma)=\left\{\mathfrak{p} \in \operatorname{Spec} \mathcal{O}_{K} \mid \mathfrak{p} \cap S \neq \emptyset\right\}$.

Suppose we have $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right)$ with $\mathfrak{p} \cap S \neq \emptyset$. Say $\alpha \in \mathfrak{p} \cap S$. Then $\alpha \in S \cap K$. Since $\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}\left[\left.\frac{1}{\alpha} \right\rvert\, \alpha \in S \cap K\right]$, we have $\frac{1}{\alpha} \in \mathcal{O}_{K}[\gamma] \cap K$, and $v_{\mathfrak{p}}(1)<v_{\mathfrak{p}}(\alpha)$. Then by proposition 1.7, $\mathfrak{p} \in X(K, \gamma)$.

On the other hand, suppose $\mathfrak{p} \in X(K, \gamma)$. By Theorem 1.4, there exists $\beta \in \mathfrak{p}$ such that $\frac{1}{\beta} \in \mathcal{O}_{K}[\gamma]$. Then $\frac{1}{\beta} \in \mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}\left[\left.\frac{1}{\alpha} \right\rvert\, \alpha \in S \cap K\right]$. Therefore, $\frac{1}{\beta}=f\left(\frac{1}{\alpha_{1}}, \ldots, \frac{1}{\alpha_{m}}\right)$, where $f\left(x_{1}, \ldots, x_{m}\right) \in \mathcal{O}_{K}\left[x_{1}, \ldots, x_{m}\right]$ and $\alpha_{i} \in S \cap K$. We can clear denominators by multiply both sides by high enough power of $\alpha_{1} \ldots \alpha_{m}$. We get that

$$
\left(\alpha_{1} \ldots \alpha_{m}\right)^{N}=\beta g\left(\alpha_{1}, \ldots, \alpha_{m}\right),
$$

and $g\left(\alpha_{1}, \ldots, \alpha_{m}\right)$ is in $\mathcal{O}_{K}$. We see that $\left(\alpha_{1} \ldots \alpha_{m}\right)^{N} \in \mathfrak{p}$. So there exists $i$ such that $\alpha_{i} \in \mathfrak{p}$. Therefore $\alpha_{i} \in \mathfrak{p} \cap S$, and hence $\mathfrak{p} \cap S \neq \emptyset$.

Proposition 1.11. Suppose $S$ is a generating set of $\gamma$. Then we have

$$
\overline{\mathbb{Z}}[\gamma]=\overline{\mathbb{Z}}[1 / \alpha \mid \alpha \in S]
$$

Proof. Pick $\alpha \in S$. Let $K=\mathbb{Q}(\alpha)$. Then by Proposition 1.10, we know that $\frac{1}{\alpha} \in$ $\mathcal{O}_{K}[\gamma] \cap K$ and hence $\frac{1}{\alpha} \in \overline{\mathbb{Z}}[\gamma]$. This shows that $\overline{\mathbb{Z}}\left[\left.\frac{1}{\alpha} \right\rvert\, \alpha \in S\right] \subseteq \overline{\mathbb{Z}}[\gamma]$.

For the other direction suppose $\beta \in \overline{\mathbb{Z}}[\gamma]$. Say $\beta=\sum_{i=0}^{m} c_{i} \gamma^{i}$ for $c_{i} \in \overline{\mathbb{Z}}$. Let $K=\mathbb{Q}\left(c_{0}, \ldots, c_{m}, \beta\right)$. Therefore $\beta \in \mathcal{O}_{K}[\gamma] \cap K$. Now Proposition 1.10 implies that $\beta \in \mathcal{O}_{K}\left[\left.\frac{1}{\alpha} \right\rvert\, \alpha \in S \cap K\right]$ and hence $\beta \in \overline{\mathbb{Z}}\left[\left.\frac{1}{\alpha} \right\rvert\, \alpha \in S\right]$. This shows that $\overline{\mathbb{Z}}[\gamma] \subseteq$ $\overline{\mathbb{Z}}\left[\left.\frac{1}{\alpha} \right\rvert\, \alpha \in S\right]$.
Lemma 4.6. Let $S$ be a finite generating set of $\gamma$, then as ideals of $\overline{\mathbb{Z}}$, we have

$$
\sqrt{\mathfrak{D}_{\gamma}}=\sqrt{\left(\prod_{\alpha \in S} \alpha\right)^{\overline{\mathbb{Z}}}}
$$

Proof. First consider $\beta \in \mathfrak{D}_{\gamma}$, say $\beta^{m} \in \mathfrak{D}_{\gamma}$. Therefore $\beta^{m} \gamma \in \overline{\mathbb{Z}}$. Consider $L=$ $\mathbb{Q}(\beta, \gamma, S)$. We want to show that there is some $N$ for which $\beta^{N} \in\left(\prod_{\alpha \in S} \alpha\right) \overline{\mathbb{Z}}$. This is equivalent to showing that $\frac{\beta^{N}}{\prod_{\alpha \in S}} \in \mathcal{O}_{L}$. Now for a prime $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$, if $v_{\mathfrak{p}}\left(\prod_{\alpha \in S} \alpha\right)>0$, then there is some $\alpha \in S$ such that $\alpha \in \mathfrak{p}$. By definition of generating set of $\gamma$, this implies that $\mathfrak{p} \in X(L, \gamma)$. Now since $L(\gamma)=L$, we see that $v_{\mathfrak{p}}(\gamma)<0$. Moreover $\beta^{m} \gamma \in \overline{\mathbb{Z}}$ implies $v_{\mathfrak{p}}(\beta)>0$. We have shown that $v_{\mathfrak{p}}\left(\prod_{\alpha \in S} \alpha\right)>0$ implies $v_{\mathfrak{p}}(\beta)>0$. Therefore for a sufficiently large $N$, we will have $\frac{\beta^{N}}{\prod_{\alpha \in S} \alpha} \in \mathcal{O}_{L}$. This shows that $\beta \in \sqrt{\left(\prod_{\alpha \in S} \alpha\right) \overline{\mathbb{Z}}}$.

For the other direction consider $\beta \in \sqrt{\left(\prod_{\alpha \in S} \alpha\right) \overline{\mathbb{Z}}}$. This means that for some $m$, $\frac{\beta^{m}}{\prod_{\alpha \in S}{ }^{\alpha}} \in \overline{\mathbb{Z}}$. Again consider $L=\mathbb{Q}(\beta, \gamma, S)$. Therefore, we have $\frac{\beta^{m}}{\Pi_{\alpha \in S} \alpha} \in \mathcal{O}_{L}$. Consider $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ for which $v_{\mathfrak{p}}(\gamma)<0$. Then $\mathfrak{p} \in X(L, \gamma)$ and hence by definition of generating set, $S \cap \mathfrak{p} \neq \emptyset$. This implies $v_{\mathfrak{p}}\left(\prod_{\alpha \in S} \alpha\right)>0$. Since $\frac{\beta^{m}}{\prod_{\alpha \in S^{\alpha}}} \in \mathcal{O}_{L}$, we see that $v_{\mathfrak{p}}(\beta)>0$. We have shown that whenever a prime $\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right)$ satisfies $v_{\mathfrak{p}}(\gamma)<0$, then it also satisfies $v_{\mathfrak{p}}(\beta)>0$. Therefore for sufficiently large $N$, we will have $\beta^{N} \gamma \in \mathcal{O}_{L}$. This means that $\beta \in \sqrt{\mathfrak{D}_{\gamma}}$.
Lemma 4.7. Given a number field $K$, as ideals of $\mathcal{O}_{K}$ we have

$$
\sqrt{\mathfrak{D}_{\gamma} \cap \mathcal{O}_{K}}=\prod_{\mathfrak{p} \in Y(K, \gamma)} \mathfrak{p}
$$

Proof. First suppose $\beta \in \sqrt{\mathfrak{D}_{\gamma} \cap \mathcal{O}_{K}}$, say $\beta^{N} \in \mathfrak{D}_{\gamma} \cap \mathcal{O}_{K}$ so $\beta^{N} \gamma \in \overline{\mathbb{Z}}$. Consider $\mathfrak{p} \in Y(K, \gamma)$, so there is a prime $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{K(\gamma)}\right)$ such that $\mathfrak{q} \cap K=\mathfrak{p}$ and $v_{\mathfrak{q}}(\gamma)<0$. This implies $v_{\mathfrak{q}}(\beta)>0$. Since $\beta \in K$, we see that $v_{\mathfrak{p}}(\beta)>0$. We have shown that $v_{\mathfrak{p}}(\beta)>0$ for all $\mathfrak{p} \in Y(K, \gamma)$. This shows that $\beta \in \prod_{\mathfrak{p} \in Y(K, \gamma)} \mathfrak{p}$.

For the other direction, suppose $\beta \in \prod_{\mathfrak{p} \in Y(K, \gamma)} \mathfrak{p}$. Let $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{K(\gamma)}\right)$ be a prime for which $v_{\mathfrak{q}}(\gamma)<0$. Then $\mathfrak{p}=\mathfrak{q} \cap K \in Y(K, \gamma)$. Therefore, $v_{\mathfrak{p}}(\beta)>0$ and hence $v_{\mathfrak{q}}(\beta)>0$. We have shown that for every prime $\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{K(\gamma)}\right)$ if $v_{\mathfrak{q}}(\gamma)<0$ then $v_{\mathfrak{q}}(\beta)>0$. Therefore for sufficiently large $N$, we have $\beta^{N} \gamma \in \mathcal{O}_{K(\gamma)}$. This shows that $\beta^{N} \in \mathfrak{D}_{\gamma}$ and hence $\beta \in \sqrt{\mathfrak{D}_{\gamma} \cap \mathcal{O}_{K}}$.
Lemma 4.8. Let $S$ be a finite generating set of $\gamma$. Then for any number field $K$, as ideals of $\mathcal{O}_{K}$ we have

$$
\sqrt{\left(\prod_{\alpha \in S \cap K} \alpha\right) \mathcal{O}_{K}}=\prod_{\mathfrak{p} \in X(K, \gamma)} \mathfrak{p}
$$

Proof. We know that

$$
\sqrt{\left(\prod_{\alpha \in S \cap K} \alpha\right) \mathcal{O}_{K}}=\bigcap_{\left(\prod_{\alpha \in S \cap K} \alpha\right) \in \mathfrak{p}} \mathfrak{p}
$$

Now the primes that contain $\left(\prod_{\alpha \in S \cap K} \alpha\right)$ are precisely those that contain at least one $\alpha \in S \cap K$. By the definition of generating set of $\gamma$, these are the primes in $X(K, \gamma)$. This is a finite set of primes and hence

$$
\bigcap_{\mathfrak{p} \in X(K, \gamma)} \mathfrak{p}=\prod_{\mathfrak{p} \in X(K, \gamma)} \mathfrak{p}
$$

Proof of Theorem 1.12. Follows from Lemma 4.6, Lemma 4.7 and Lemma 4.8,
Theorem 4.9. For $\gamma_{1}, \gamma_{2} \in \overline{\mathbb{Q}}$, the following are equivalent:
(1) $X\left(\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right), \gamma_{1}\right)=X\left(\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right), \gamma_{2}\right)$.
(2) For every number field $L$, we have $X\left(L, \gamma_{1}\right)=X\left(L, \gamma_{2}\right)$.
(3) $\sqrt{\mathfrak{D}_{\gamma_{1}}}=\sqrt{\mathfrak{D}_{\gamma_{2}}}$.
(4) For every number field $L$, we have $Y\left(L, \gamma_{1}\right)=Y\left(L, \gamma_{2}\right)$.
(5) $Y\left(\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right), \gamma_{1}\right)=Y\left(\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right), \gamma_{2}\right)$.

Proof. Suppose $\gamma_{1}, \gamma_{2}$ satisfy the condition (1). Consider a number field $L$ and let $K=L \cap \mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right)$. Then by Lemma 3.1 we have

$$
\begin{aligned}
X\left(K, \gamma_{1}\right) & =\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid \forall \mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right)}\right), \text { if } \mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p} \text { then } \mathfrak{q} \in X\left(\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right), \gamma_{1}\right)\right\} \\
& =\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid \forall \mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right)}\right), \text { if } \mathfrak{q} \cap \mathcal{O}_{K}=\mathfrak{p} \text { then } \mathfrak{q} \in X\left(\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right), \gamma_{2}\right)\right\} \\
& =X\left(K, \gamma_{2}\right) .
\end{aligned}
$$

Moreover we have $K\left(\gamma_{1}\right) \cap L=K, K\left(\gamma_{2}\right) \cap L=K$ and hence by Lemma 3.1 we have

$$
\begin{aligned}
X\left(L, \gamma_{1}\right) & =\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in X\left(K, \gamma_{1}\right)\right\} \\
& =\left\{\mathfrak{q} \in \operatorname{Spec}\left(\mathcal{O}_{L}\right) \mid \mathfrak{q} \cap \mathcal{O}_{K} \in X\left(K, \gamma_{2}\right)\right\} \\
& =X\left(L, \gamma_{2}\right) .
\end{aligned}
$$

Therefore $\gamma_{1}, \gamma_{2}$ satisfy condition (2).

Next suppose $\gamma_{1}, \gamma_{2}$ satisfy condition (2). Let $S$ be a finite generating set of $\gamma_{1}$. Then $S$ is a finite generating set of $\gamma_{2}$ as well. We conclude from Lemma 4.6 that $\sqrt{\mathfrak{D}_{\gamma_{1}}}=\sqrt{\mathfrak{D}_{\gamma_{2}}}$. Therefore $\gamma_{1}, \gamma_{2}$ satisfy condition (3).

Next suppose $\gamma_{1}, \gamma_{2}$ satisfy condition (3). Then for any number field $L$, we have

$$
\sqrt{\mathfrak{D}_{\gamma_{1}} \cap \mathcal{O}_{L}}=\sqrt{\mathfrak{D}_{\gamma_{1}}} \cap \mathcal{O}_{L}=\sqrt{\mathfrak{D}_{\gamma_{2}}} \cap \mathcal{O}_{L}=\sqrt{\mathfrak{D}_{\gamma_{2}} \cap \mathcal{O}_{L}}
$$

Now Lemma 4.7 implies $Y\left(L, \gamma_{1}\right)=Y\left(L, \gamma_{2}\right)$. Therefore $\gamma_{1}, \gamma_{2}$ satisfy condition (4).
Condition (4) clearly implies condition (5).
Finally suppose $\gamma_{1}, \gamma_{2}$ satisfy condition (5). Let $K=\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right)$. Then $K\left(\gamma_{1}\right)=K$, so we have

$$
X\left(K, \gamma_{1}\right)=\left\{\mathfrak{p} \in \operatorname{Spec}\left(\mathcal{O}_{K}\right) \mid v_{\mathfrak{p}}\left(\gamma_{1}\right)<0\right\}=Y\left(K, \gamma_{1}\right)
$$

Similarly we see that $X\left(K, \gamma_{2}\right)=Y\left(K, \gamma_{2}\right)$. Therefore $X\left(\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right), \gamma_{1}\right)=X\left(\mathbb{Q}\left(\gamma_{1}, \gamma_{2}\right), \gamma_{2}\right)$ and $\gamma_{1}, \gamma_{2}$ satisfy condition (1).

## 5. Local case

Proposition 5.1. Let $K$ be a finite extension of $\mathbb{Q}_{p}$ and $\gamma \in \overline{\mathbb{Q}_{p}}$. Let $v$ be the unique valuation on $\overline{\mathbb{Q}_{p}}$ that extends $v_{p}$. Then

- If $v(\gamma) \geq 0$, then $\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}$.
- If $v(\gamma)<0$, then $\mathcal{O}_{K}[\gamma] \cap K=K$.

Proof. If $v(\gamma) \geq 0$, let $\tilde{v}$ be the restriction of $v$ to $K(\gamma)$ and $v_{K}$ be the restriction of $v$ to $K$. Then for $\frac{a}{b} \in K \cap \mathcal{O}_{K}[\gamma]$, we have that $\tilde{v}\left(\frac{a}{b}\right) \geq 0$. Then $v_{K}\left(\frac{a}{b}\right) \geq 0$, so $\frac{a}{b} \in \mathcal{O}_{K}$. So for $v(\gamma) \geq 0$, we have $\mathcal{O}_{K}[\gamma] \cap K=\mathcal{O}_{K}$.

Now suppose $v(\gamma)<0$. First we will show that $\mathcal{O}_{K} \subsetneq \mathcal{O}_{K}[\gamma] \cap K$. Consider $a=\operatorname{Nm}_{K}^{K(\gamma)}(\gamma)$. Notice that

$$
v(\gamma)=\tilde{v}(\gamma)=\frac{1}{n} v_{K}\left(\operatorname{Nm}_{K}^{K(\gamma)}(\gamma)\right)=\frac{1}{n} v(a) .
$$

Thus $n v(\gamma)=v(a)$. If $\gamma_{i}$ is a conjugate of $\gamma$ over $K$, then we similarly see that $n v\left(\gamma_{i}\right)=v(a)$. Now let $x^{n}+a_{n-1} x^{n-1}+\cdots+a_{0}=0$ be the minimal polynomial of $\gamma$ over $K$. So $a_{0}= \pm a$. Then we have that $v\left(a_{i}\right) \geq(n-i) v(\gamma)$ and $v(a)=n v(\gamma)$, so $v\left(a_{i}\right)>v(a)$. Say $a_{i_{0}}=\min _{1 \leq i \leq n}\left(v\left(a_{i}\right)\right)$ and $u=a_{i_{0}}^{-1}$. Now,

$$
u a= \pm\left(u a_{n} \gamma^{n}+u a_{n-1} \gamma^{n-1} \cdots+u a_{1} \gamma\right)
$$

For $1 \leq i \leq n$, we have $v\left(a_{i_{0}}\right) \leq v\left(a_{i}\right)$, so $v\left(u a_{i}\right) \geq 0$ and hence $u a_{i} \in \mathcal{O}_{K}$. This shows that $u a \in \mathcal{O}_{K}[\gamma] \cap K$. Moreover $v(a)<v\left(a_{i_{0}}\right)$, so $v(u a)<0$ and $u a \notin \mathcal{O}_{K}$. Let $b=u a$.

Finally we will show that $\mathcal{O}_{K}[\gamma] \cap K=K$. Say $v_{K}(b)=\tilde{v}(b)=-m$. Let $t$ be a uniformizer of $\mathcal{O}_{K}$, then $\alpha=t^{m-1} b \in \mathcal{O}_{K}[\gamma] \cap K$ and $v_{K}(\alpha)=-1$. Then for any $\beta \in K$, suppose $v_{K}(\beta)=-s$. Then $v_{K}\left(\frac{\beta}{\alpha^{s}}\right)=0$, so $\frac{\beta}{\alpha^{s}} \in \mathcal{O}_{K}^{*}$. Then $\beta=\frac{\beta}{\alpha^{s}} \alpha^{s} \in \mathcal{O}_{K}[\gamma] \cap K$. Since $\beta$ is an arbitrary element in $K$, we have that $K=\mathcal{O}_{K}[\gamma] \cap K$.

## 6. Relationships Among $c(\gamma), d(\gamma), e(\gamma)$ And $\operatorname{deg}(\gamma)$

Proposition 6.1. Suppose $\gamma$ is an algebraic number of degree $n$. Then $c(\gamma)$ divides $d(\gamma)^{n-1} e(\gamma)$. Moreover, all rational primes $p$ satisfy at least one of the following:
(1) $v_{p}(d(\gamma))+v_{p}(e(\gamma)) \leq v_{p}(c(\gamma))$.
(2) $\frac{n-1}{n} v_{p}(c(\gamma))<v_{p}(e(\gamma)) \leq v_{p}(c(\gamma))$ and $v_{p}(c(\gamma))=n v_{p}(d(\gamma))$.

Proof. We know that there is some $1 \leq j \leq n-1$ such that $v_{p}\left(a_{j}\right)=v_{p}(e(\gamma))$. We know that $\left\lceil\frac{v_{p}\left(a_{n}\right)-v_{p}\left(a_{j}\right)}{n-j}\right\rceil \leq v_{p}(d(\gamma))$, and hence

$$
\frac{v_{p}(c(\gamma))-v_{p}(e(\gamma))}{n-j}=\frac{v_{p}\left(a_{n}\right)-v_{p}\left(a_{j}\right)}{n-j} \leq v_{p}(d(\gamma))
$$

This means that $v_{p}(c(\gamma)) \leq(n-1) v_{p}(d(\gamma))+v_{p}(e(\gamma))$. Therefore $c(\gamma) \mid d(\gamma)^{n-1} e(\gamma)$.
First consider a rational prime $p$ that does not divide $e(\gamma)$. Since $d(\gamma) \mid c(\gamma)$, we have $v_{p}(d(\gamma)) \leq v_{p}(c(\gamma))$. Therefore $v_{p}(d(\gamma))+v_{p}(e(\gamma)) \leq v_{p}(c(\gamma))$.

Next consider a rational prime $p$ that divides $e(\gamma)$. In this case, $p$ also divides $c(\gamma)=a_{n}$ and $d(\gamma)$ (since $\left.c(\gamma) \mid d(\gamma)^{n}\right)$. Moreover $p$ divides $a_{i}$ for $1 \leq i \leq n$ and hence $p \nmid a_{0}$. We know that that

$$
v_{p}(d(\gamma))=\max \left(0, \max _{0 \leq j \leq n-1}\left\lceil\frac{v_{p}\left(a_{n}\right)-v_{p}\left(a_{j}\right)}{n-j}\right\rceil\right) .
$$

Now $v_{p}\left(a_{0}\right)=0$, so $\left\lceil\frac{v_{p}\left(a_{n}\right)-v_{p}\left(a_{0}\right)}{n-0}\right\rceil=\left\lceil\frac{v_{p}(c(\gamma))}{n}\right\rceil$. Moreover for $1 \leq j \leq n-1$,

$$
\frac{v_{p}\left(a_{n}\right)-v_{p}\left(a_{j}\right)}{n-j} \leq \frac{v_{p}\left(a_{n}\right)-v_{p}(e(\gamma))}{n-j} \leq v_{p}\left(a_{n}\right)-v_{p}(e(\gamma)) .
$$

Since $v_{p}\left(a_{n}\right)-v_{p}(e(\gamma))$ is an integer, we conclude that $\left\lceil\frac{v_{p}\left(a_{n}\right)-v_{p}\left(a_{j}\right)}{n-j}\right\rceil \leq v_{p}(c(\gamma))-$ $v_{p}(e(\gamma))$. We also know that $v_{p}(d(\gamma)) \neq 0$. Therefore
$v_{p}(d(\gamma))=\max \left(0, \max _{0 \leq j \leq n-1}\left\lceil\frac{v_{p}\left(a_{n}\right)-v_{p}\left(a_{j}\right)}{n-j}\right\rceil\right) \leq \max \left(\left\lceil\frac{v_{p}(c(\gamma))}{n}\right\rceil, v_{p}(c(\gamma))-v_{p}(e(\gamma))\right)$.

- Case 1: $v_{p}(c(\gamma))-v_{p}(e(\gamma)) \geq\left\lceil\frac{v_{p}(c(\gamma))}{n}\right\rceil$. We see that $v_{p}(d(\gamma)) \leq v_{p}(c(\gamma))-$ $v_{p}(e(\gamma))$.
- Case 2: $v_{p}(c(\gamma))-v_{p}(e(\gamma))<\left\lceil\frac{v_{p}(c(\gamma))}{n}\right\rceil$. It follows that $v_{p}(d(\gamma))=\left\lceil\frac{v_{p}(c(\gamma))}{n}\right\rceil$ and hence $n v_{p}(d(\gamma)) \geq v_{p}(c(\gamma))$. Moreover since $c(\gamma) \mid d(\gamma)^{n}$, we always have $v_{p}(c(\gamma)) \leq n v_{p}(d(\gamma))$. Therefore $v_{p}(c(\gamma))=n v_{p}(d(\gamma))$.
Since $e(\gamma) \mid c(\gamma)$, we have $v_{p}(e(\gamma)) \leq v_{p}(c(\gamma))$. Finally $v_{p}(c(\gamma))-v_{p}(e(\gamma))<$ $\left\lceil\frac{v_{p}(c(\gamma))}{n}\right\rceil$ implies $v_{p}(c(\gamma))-v_{p}(e(\gamma))<\frac{v_{p}(c(\gamma))}{n}$, which means $\frac{n-1}{n} v_{p}(c(\gamma))<$ $v_{p}(e(\gamma))$.

Proposition 6.2. Suppose we are give positive integers $c, d, e, n$ such that $d|c, c| d^{n}$, $e|c, c| d^{n-1} e$ and $n \geq 2$. Suppose further that all rational primes $p$ satisfy at least one of the following:
(1) $v_{p}(d)+v_{p}(e) \leq v_{p}(c)$.
(2) $v_{p}(c)=n v_{p}(d)$.

Then there is an algebraic number $\gamma$ for which $\operatorname{deg}(\gamma)=n, c(\gamma)=c, d(\gamma)=d$ and $e(\gamma)=e$.

Proof. Let $Y$ be the collection of primes factors of $c$. Pick a prime $q$ that is not in $Y$. We will construct integers $a_{0}, a_{1}, \ldots, a_{n}$. Firstly set $a_{n}=c$. For primes $p$ that are not in $Y \cup\{q\}$, set $v_{p}\left(a_{i}\right)=0$ for each $0 \leq i \leq n-1$. Set $v_{q}\left(a_{i}\right)=1$ for $0 \leq i \leq n-1$. Finally for primes $p \in Y$, set $v_{p}\left(a_{0}\right)=0$ and for $1 \leq i \leq n-1$ set $v_{p}\left(a_{i}\right)=\max \left(v_{p}(c)-(n-i) v_{p}(d), v_{p}(e)\right)$

Consider the polynomial $F(x)=a_{n} x^{n}+\cdots+a_{0}$. By applying the Eisenstein criterion with prime $q$, we see that $F$ is irreducible. Let $\gamma$ be a root of $F$, then $\operatorname{deg}(\gamma)=n$, $c(\gamma)=a_{n}=c$.

For primes $p \in Y$, we know that $v_{p}(c) \leq(n-1) v_{p}(d)+v_{p}(e)$. This implies that $v_{p}\left(a_{1}\right)=v_{p}(e)$. We also know that for $1 \leq i \leq n-1, v_{p}\left(a_{i}\right) \geq v_{p}(e)$. Finally since $e \mid c$, we have $v_{p}\left(a_{n}\right) \geq v_{p}(e)$. This shows that $v_{p}(e(\gamma))=v_{p}(e)$. Moreover, for primes $p \notin Y$, $p$ does not divide $a_{n}$. Therefore $e(\gamma)=e$.

For a prime $p \in Y$ and $1 \leq j \leq n-1$, we know that $v_{p}\left(a_{i}\right) \geq v_{p}(c)-(n-i) v_{p}(d)$. This means that $\frac{v_{p}(c)-v_{p}\left(a_{i}\right)}{n-i} \leq v_{p}(d)$ and hence $\left\lceil\frac{v_{p}(c)-v_{p}\left(a_{i}\right)}{n-i}\right\rceil \leq v_{p}(d)$. Since $c \mid d^{n}$ and $v_{p}\left(a_{0}\right)=0$, we know that $\frac{v_{p}(c)-v_{p}\left(a_{0}\right)}{n} \leq v_{p}(d)$ and hence $\left\lceil\frac{v_{p}(c)-v_{p}\left(a_{0}\right)}{n}\right\rceil \leq v_{p}(d)$. Since

$$
v_{p}(d(\gamma))=\max \left(0, \max _{0 \leq j \leq n-1}\left\lceil\frac{v_{p}\left(a_{n}\right)-v_{p}\left(a_{j}\right)}{n-j}\right\rceil\right),
$$

and $v_{p}(d(\gamma)) \neq 0$, this shows that $v_{p}(d(\gamma)) \leq v_{p}(d)$.
Next if $p \in Y$ satisfies $v_{p}(d)+v_{p}(e) \leq v_{p}(c)$, then $v_{p}\left(a_{n-1}\right)=v_{p}(c)-v_{p}(d)$. In this case $\left\lceil\frac{v_{p}(c)-v_{p}\left(a_{n-1}\right)}{n-(n-1)}\right\rceil=v_{p}(d)$ and hence $v_{p}(d) \leq v_{p}(d(\gamma))$.

Finally suppose $p \in Y$ satisfies $n v_{p}(d)=v_{p}(c)$. Since $v_{p}\left(a_{0}\right)=0$, this means that $\left\lceil\frac{v_{p}(c)-v_{p}\left(a_{0}\right)}{n}\right\rceil=v_{p}(d)$. Therefore $v_{p}(d) \leq v_{p}(d(\gamma))$.
Proof of Theorem 1.3. Follows from Proposition 6.1 and Proposition 6.2,
