# Integer group determinants for abelian groups of order 16

#### Abstract

For any positive integer $n$, let $\mathrm{C}_{n}$ be the cyclic group of order $n$. We determine all possible values of the integer group determinant of $\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}$, which is the only unsolved abelian group of order 16 .


## 1 Introduction

A circulant determinant is the determinant of a square matrix in which each row is obtained by a cyclic shift of the previous row one step to the right. At the meeting of the American Mathematical Society in Hayward, California, in April 1977, Olga Taussky-Todd [10] suggested a problem that is to determine the all possible integers of an $n \times n$ circulant determinant when the all entries are integers (see e.g., [4, 6]). The solution for the case $n=2$ is well known. In the cases of $n=p$ and $2 p$, where $p$ is an odd prime, the problem was solved [3, 6]. Also, the problem was solved for the cases $n=9$ [5, Theorem 4], $n=4$ and 8 [2, Theorem 1.1], $n=12$ [9, Theorem 5.3], $n=15$ [7, Theorem 1.3] and $n=16$ [13]. For a finite group $G$, let $x_{g}$ be a variable for each $g \in G$. The group determinant of $G$ is defined as $\operatorname{det}\left(x_{g h^{-1}}\right)_{g, h \in G}$. Let $\mathrm{C}_{n}$ be the cyclic group of order $n$. Note that the group determinant of $\mathrm{C}_{n}$ becomes an $n \times n$ circulant determinant. The group determinant of $G$ is called an integer group determinant of $G$ when the variables $x_{g}$ are all integers. Let $S(G)$ denote the set of all possible values of the integer group determinant of $G$ :

$$
S(G):=\left\{\operatorname{det}\left(x_{g h^{-1}}\right)_{g, h \in G} \mid x_{g} \in \mathbb{Z}\right\} .
$$

The problem suggested by Olga Taussky-Todd is extended to the problem that is to determine $S(G)$ for any finite group $G$. For some groups, the problem was solved in [1, 2, 3, 5, 7, 8, 9, 11, 13, 14, 15]. As a result, for every group $G$ of order at most $15, S(G)$ was determined. Also, $\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}$ is left as the only unsolved abelian group of order 16 .

In this paper, we determine $S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)$. For any $r \in \mathbb{Z}$, let
$P_{r}:=\{p \mid p \equiv r(\bmod 8)$ is a prime number $\}$,
$P^{\prime}:=\left\{p \mid p=a^{2}+b^{2} \equiv 1(\bmod 8)\right.$ is a prime number satisfying $\left.a+b \equiv \pm 3(\bmod 8)\right\}$, $A:=\{(8 k-3)(8 l+3) \mid k, l \in \mathbb{Z}\} \subsetneq\{8 m-1 \mid m \in \mathbb{Z}\}$,
$B:=\left\{p(8 m-1) \mid p \in P^{\prime}, m \in \mathbb{Z}\right\} \subsetneq\{8 m-1 \mid m \in \mathbb{Z}\}$.
Theorem 1.1. We have

S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)=\{ & \left.16 m+1,2^{16}(4 m+1), 2^{16}(8 m+3), 2^{17} p(2 m+1), 2^{18} m \mid m \in \mathbb{Z}, p \in P_{5}\right\} \\
& \cup\left\{2^{16} m \mid m \in A \cup B\right\}
\end{aligned}
$$

Let $\mathrm{D}_{n}$ denote the dihedral group of order $n$ and let

$$
\begin{aligned}
C:= & \left\{(8 k-3)(8 l-3)(8 m-3)(8 n-3) \mid k \in \mathbb{Z}, 8 l-3,8 m-3,8 n-3 \in P_{5},\right. \\
& k+l \not \equiv m+n(\bmod 2)\} \subsetneq\{16 m-7 \mid m \in \mathbb{Z}\} \\
D:= & \{(8 k-3)(8 l-3) \mid k, l \in \mathbb{Z}, k \equiv l(\bmod 2)\} \subsetneq\{16 m-7 \mid m \in \mathbb{Z}\} .
\end{aligned}
$$

Remark that $C \subset D$ holds. In [14, [15], [11, Theorem 1.5], [1, Theorem 5.3] and [13], the following are obtained respectively:

S\left(\mathrm{C}_{2}^{4}\right)= & \left\{16 m+1,2^{16}(4 m+1), 2^{24}(4 m+1), 2^{24}(8 m+3), 2^{24} m^{\prime}, 2^{26} m \mid\right. \\
& \left.m \in \mathbb{Z}, m^{\prime} \in A\right\}, \\
S\left(\mathrm{C}_{4}^{2}\right)= & \left\{16 m+1, m^{\prime}, 2^{15} p(2 m+1), 2^{16} m \mid m \in \mathbb{Z}, m^{\prime} \in C, p \in P_{5}\right\}, \\
S\left(\mathrm{C}_{8} \times \mathrm{C}_{2}\right)= & \left\{16 m+1, m^{\prime}, 2^{10}(2 m+1), 2^{11} p(2 m+1), 2^{11} q^{2}(2 m+1), 2^{12} m \mid\right. \\
& \left.m \in \mathbb{Z}, m^{\prime} \in D, p \in P^{\prime} \cup P_{5}, q \in P_{3}\right\}, \\
S\left(\mathrm{D}_{16}\right)= & \left\{4 m+1,2^{10} m \mid m \in \mathbb{Z}\right\}, \\
S\left(\mathrm{C}_{16}\right)= & \left\{2 m+1,2^{6} p(2 m+1), 2^{6} q^{2}(2 m+1), 2^{7} m \mid m \in \mathbb{Z}, p \in P^{\prime} \cup P_{5}, q \in P_{3}\right\} .
\end{aligned}
$$

Pinner and Smyth [9, p.427] noted the following inclusion relations for every groups of order 8: $S\left(\mathrm{C}_{2}^{3}\right) \subsetneq S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}\right) \subsetneq S\left(\mathrm{Q}_{8}\right) \subsetneq S\left(\mathrm{D}_{8}\right) \subsetneq S\left(\mathrm{C}_{8}\right)$, where $\mathrm{Q}_{8}$ denotes the generalized quaternion group of order 8. From the above results, we have

S\left(\mathrm{C}_{2}^{4}\right) \subsetneq S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right) \subsetneq S\left(\mathrm{C}_{4}^{2}\right) \subsetneq S\left(\mathrm{C}_{8} \times \mathrm{C}_{2}\right) \subsetneq S\left(\mathrm{D}_{16}\right) \subsetneq S\left(\mathrm{C}_{16}\right)
$$

## 2 Preliminaries

For any $\bar{r} \in \mathrm{C}_{n}$ with $r \in\{0,1, \ldots, n-1\}$, we denote the variable $x_{\bar{r}}$ by $x_{r}$, and let $D_{n}\left(x_{0}, x_{1}, \ldots, x_{n-1}\right):=\operatorname{det}\left(x_{g h^{-1}}\right)_{g, h \in \mathrm{C}_{n}}$. For any $(\bar{r}, \bar{s}) \in \mathrm{C}_{4} \times \mathrm{C}_{2}$ with $r \in\{0,1,2,3\}$ and $s \in\{0,1\}$, we denote the variable $y_{(\bar{r}, \bar{s})}$ by $y_{j}$, where $j:=r+4 s$, and let $D_{4 \times 2}\left(y_{0}, y_{1}, \ldots, y_{7}\right):=$ $\operatorname{det}\left(y_{g h^{-1}}\right)_{g, h \in \mathrm{C}_{4} \times \mathrm{C}_{2}}$. For any $(\bar{r}, \bar{s}, \bar{t}) \in \mathrm{C}_{4} \times \mathrm{C}_{2}^{2}$ with $r \in\{0,1,2,3\}$ and $s, t \in\{0,1\}$, we denote the variable $z_{(\bar{r}, \bar{s}, \bar{t})}$ by $z_{j}$, where $j:=r+4 s+8 t$, and let $D_{4 \times 2 \times 2}\left(z_{0}, z_{1}, \ldots, z_{15}\right):=$ $\operatorname{det}\left(z_{g h^{-1}}\right)_{g, h \in \mathrm{C}_{4} \times \mathrm{C}_{2}^{2}}$. From the $G=\mathrm{C}_{4}$ and $H=\{\overline{0}, \overline{2}\}$ case of [11, Theorem 1.1], we have the following corollary.

Corollary 2.1. We have

$$
\begin{aligned}
D_{4}\left(x_{0}, x_{1}, x_{2}, x_{3}\right) & =D_{2}\left(x_{0}+x_{2}, x_{1}+x_{3}\right) D_{2}\left(x_{0}-x_{2}, \sqrt{-1}\left(x_{1}-x_{3}\right)\right) \\
& =\left\{\left(x_{0}+x_{2}\right)^{2}-\left(x_{1}+x_{3}\right)^{2}\right\}\left\{\left(x_{0}-x_{2}\right)^{2}+\left(x_{1}-x_{3}\right)^{2}\right\} .
\end{aligned}
$$

Remark 2.2. From Corollary 2.1, we have $D_{4}\left(x_{0}, x_{1}, x_{2}, x_{3}\right)=-D_{4}\left(x_{1}, x_{2}, x_{3}, x_{0}\right)$.
From [12, Theorem 1.1], we have the following corollary.
Corollary 2.3. The following hold:
(1) Let $H=\mathrm{C}_{4}$ and $K=\mathrm{C}_{2}$. Then we have

D_{4 \times 2}\left(y_{0}, y_{1}, \ldots, y_{7}\right)=D_{4}\left(y_{0}+y_{4}, y_{1}+y_{5}, y_{2}+y_{6}, y_{3}+y_{7}\right) D_{4}\left(y_{0}-y_{4}, y_{1}-y_{5}, y_{2}-y_{6}, y_{3}-y_{7}\right) ;
$$

(2) Let $H=\mathrm{C}_{4} \times \mathrm{C}_{2}$ and $K=\mathrm{C}_{2}$. Then we have

$$
D_{4 \times 2 \times 2}\left(z_{0}, z_{1}, \ldots, z_{15}\right)=D_{4 \times 2}\left(z_{0}+z_{8}, z_{1}+z_{9}, \ldots, z_{7}+z_{15}\right) D_{4 \times 2}\left(z_{0}-z_{8}, z_{1}-z_{9}, \ldots, z_{7}-z_{15}\right)
$$

Throughout this paper, we assume that $a_{0}, a_{1}, \ldots, a_{15} \in \mathbb{Z}$, and for any $0 \leq i \leq 3$, let

$$
\begin{array}{rlrl}
b_{i}:=\left(a_{i}+a_{i+8}\right)+\left(a_{i+4}+a_{i+12}\right), & c_{i}:=\left(a_{i}+a_{i+8}\right)-\left(a_{i+4}+a_{i+12}\right), \\
d_{i}:=\left(a_{i}-a_{i+8}\right)+\left(a_{i+4}-a_{i+12}\right), & & e_{i}:=\left(a_{i}-a_{i+8}\right)-\left(a_{i+4}-a_{i+12}\right) .
\end{array}
$$

Also, let $\boldsymbol{a}:=\left(a_{0}, a_{1}, \ldots, a_{15}\right)$ and let

$$
\boldsymbol{b}:=\left(b_{0}, b_{1}, b_{2}, b_{3}\right), \quad \boldsymbol{c}:=\left(c_{0}, c_{1}, c_{2}, c_{3}\right), \quad \boldsymbol{d}:=\left(d_{0}, d_{1}, d_{2}, d_{3}\right), \quad \boldsymbol{e}:=\left(e_{0}, e_{1}, e_{2}, e_{3}\right)
$$

Then, from Corollary 2.3, we have

$$
D_{4 \times 2 \times 2}(\boldsymbol{a})=D_{4}(\boldsymbol{b}) D_{4}(\boldsymbol{c}) D_{4}(\boldsymbol{d}) D_{4}(\boldsymbol{e}) .
$$

Remark 2.4. For any $0 \leq i \leq 3$, the following hold:
(1) $b_{i} \equiv c_{i} \equiv d_{i} \equiv e_{i}(\bmod 2)$;
(2) $b_{i}+c_{i}+d_{i}+e_{i} \equiv 0(\bmod 4)$.

Lemma 2.5. We have $D_{4 \times 2 \times 2}(\boldsymbol{a}) \equiv D_{4}(\boldsymbol{b}) \equiv D_{4}(\boldsymbol{c}) \equiv D_{4}(\boldsymbol{d}) \equiv D_{4}(\boldsymbol{e})(\bmod 2)$.
Proof. From Corollary 2.1, for any $x_{0}, x_{1}, x_{2}, x_{3} \in \mathbb{Z}$,

$$
D_{4}\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \equiv x_{0}+x_{1}+x_{2}+x_{3} \quad(\bmod 2)
$$

Therefore, from Remark $\mathbf{2 . 4}(1)$, we have $D_{4}(\boldsymbol{b}) \equiv D_{4}(\boldsymbol{c}) \equiv D_{4}(\boldsymbol{d}) \equiv D_{4}(\boldsymbol{e})(\bmod 2)$.

## 3 Impossible odd numbers

In this section, we consider impossible odd numbers. Let $\mathbb{Z}_{\text {odd }}$ be the set of all odd numbers.
Lemma 3.1. We have $S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right) \cap \mathbb{Z}_{\text {odd }} \subset\{16 m+1 \mid m \in \mathbb{Z}\}$.
To prove Lemma 3.1, we use the following lemma.
Lemma 3.2 ([11, Lemmas 4.6 and 4.7]). For any $k, l, m, n \in \mathbb{Z}$, the following hold:
(1) $D_{4}(2 k+1,2 l, 2 m, 2 n) \equiv 8 m+1(\bmod 16)$;
(2) $D_{4}(2 k, 2 l+1,2 m+1,2 n+1) \equiv 8(k+l+n)-3(\bmod 16)$.

Proof of Lemma 3.1. Let $D_{4 \times 2 \times 2}(\boldsymbol{a})=D_{4}(\boldsymbol{b}) D_{4}(\boldsymbol{c}) D_{4}(\boldsymbol{d}) D_{4}(\boldsymbol{e}) \in \mathbb{Z}_{\text {odd }}$. Then $D_{4}(\boldsymbol{b}) \in \mathbb{Z}_{\text {odd }}$. From this and Corollary [2.1, we have $b_{0}+b_{2} \not \equiv b_{1}+b_{3}(\bmod 2)$. Therefore, either one of the following cases holds:
(i) exactly three of $b_{0}, b_{1}, b_{2}, b_{3}$ are even;
(ii) exactly one of $b_{0}, b_{1}, b_{2}, b_{3}$ is even.

First, we consider the case (i). From Remarks 2.2 and 2.4 (1), we may assume without loss of generality that $\boldsymbol{b} \equiv \boldsymbol{c} \equiv \boldsymbol{d} \equiv \boldsymbol{e} \equiv(1,0,0,0)(\bmod 2)$. From Remark $\mathbf{2 . 4}$, there exist $m_{i} \in \mathbb{Z}$ satisfying $b_{2}=2 m_{0}, c_{2}=2 m_{1}, d_{2}=2 m_{2}, e_{2}=2 m_{3}$ and $\sum_{i=0}^{3} m_{i} \equiv 0(\bmod 2)$. Therefore, from Lemma 3.2 (1),

$$
D_{4 \times 2 \times 2}(\boldsymbol{a}) \equiv \prod_{i=0}^{3}\left(8 m_{i}+1\right) \equiv 8 \sum_{i=0}^{3} m_{i}+1 \equiv 1 \quad(\bmod 16)
$$

Next, we consider the case (ii). From Remarks 2.2 and 2.4 (1), we may assume without loss of generality that $\boldsymbol{b} \equiv \boldsymbol{c} \equiv \boldsymbol{d} \equiv \boldsymbol{e} \equiv(0,1,1,1)(\bmod 2)$. From Remark [2.4, there exist $k_{i}, l_{i}, n_{i} \in \mathbb{Z}$ satisfying

$$
\begin{aligned}
\left(b_{0}, b_{1}, b_{2}\right) & =\left(2 k_{0}, 2 l_{0}+1,2 n_{0}+1\right), & & \left(c_{0}, c_{1}, c_{3}\right)=\left(2 k_{1}, 2 l_{1}+1,2 n_{1}+1\right), \\
\left(d_{0}, d_{1}, d_{3}\right) & =\left(2 k_{2}, 2 l_{2}+1,2 n_{2}+1\right), & & \left(e_{0}, e_{1}, e_{3}\right)=\left(2 k_{3}, 2 l_{3}+1,2 n_{3}+1\right)
\end{aligned}
$$

and $\sum_{i=0}^{3} k_{i} \equiv \sum_{i=0}^{3} l_{i} \equiv \sum_{i=0}^{3} n_{i} \equiv 0(\bmod 2)$. Therefore, from Lemma 3.2 (2), we have

$$
D_{4 \times 2 \times 2}(\boldsymbol{a}) \equiv \prod_{i=0}^{3}\left\{8\left(k_{i}+l_{i}+n_{i}\right)-3\right\} \equiv 8 \sum_{i=0}^{3}\left(k_{i}+l_{i}+n_{i}\right)+1 \equiv 1 \quad(\bmod 16) .
$$

## 4 Impossible even numbers

In this section, we consider impossible even numbers. Let

$$
\begin{aligned}
P & :=\{p \mid p \equiv-3(\bmod 8) \text { is a prime number }\} \\
P^{\prime} & :=\left\{p \mid p=a^{2}+b^{2} \equiv 1(\bmod 8) \text { is a prime number satisfying } a+b \equiv \pm 3(\bmod 8)\right\}, \\
A & :=\{(8 k-3)(8 l+3) \mid k, l \in \mathbb{Z}\} \\
B & :=\left\{p(8 m-1) \mid p \in P^{\prime}, m \in \mathbb{Z}\right\}
\end{aligned}
$$

Lemma 4.1. We have $S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right) \cap 2 \mathbb{Z} \subset 2^{16} \mathbb{Z}$.
Lemma 4.2. We have

$$
S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right) \cap 2^{16} \mathbb{Z}_{\mathrm{odd}} \subset\left\{2^{16}(4 m+1), 2^{16}(8 m+3), 2^{16} m^{\prime} \mid m \in \mathbb{Z}, m^{\prime} \in A \cup B\right\}
$$

Lemma 4.3. We have $S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right) \cap 2^{17} \mathbb{Z}_{\text {odd }} \subset\left\{2^{17} p(2 m+1) \mid p \in P, m \in \mathbb{Z}\right\}$.
Lemma 4.1 is immediately obtained from Lemma 2.5 and Kaiblinger's [2, Theorem 1.1] result $S\left(\mathrm{C}_{4}\right)=\mathbb{Z}_{\text {odd }} \cup 2^{4} \mathbb{Z}$. To prove Lemma 4.2, we use the following six lemmas.

Lemma 4.4 ([15, Lemma 3.2]). For any $k, l, m, n \in \mathbb{Z}$, the following hold:
(1) $D_{4}(2 k, 2 l, 2 m, 2 n) \in \begin{cases}2^{4} \mathbb{Z}_{\text {odd }}, & k+m \neq l+n(\bmod 2), \\ 2^{8} \mathbb{Z}, & k+m \equiv l+n(\bmod 2) ;\end{cases}$
(2) $D_{4}(2 k+1,2 l+1,2 m+1,2 n+1) \in \begin{cases}2^{4} \mathbb{Z}_{\text {odd }}, & k+m \not \equiv l+n(\bmod 2), \\ 2^{7} \mathbb{Z}_{\text {odd }}, & (k+m)(l+n) \equiv-1(\bmod 4), \\ 2^{9} \mathbb{Z}, & \text { otherwise; }\end{cases}$
(3) $D_{4}(2 k, 2 l+1,2 m, 2 n+1)$

$$
\in \begin{cases}2^{5} \mathbb{Z}_{\mathrm{odd}}, & k-m \equiv l-n \equiv 1(\bmod 2) \\ 2^{6} \mathbb{Z}_{\mathrm{odd}}, & k \equiv m(\bmod 2) \text { and }(2 k+2 l+1)(2 m+2 n+1) \equiv \pm 3(\bmod 8) \\ 2^{7} \mathbb{Z}, & \text { otherwise }\end{cases}
$$

(4) $D_{4}(2 k, 2 l, 2 m+1,2 n+1) \in \begin{cases}2^{4} \mathbb{Z}_{\text {odd }}, & (2 k+2 m+1)(2 l+2 n+1) \equiv \pm 3(\bmod 8), \\ 2^{5} \mathbb{Z}, & (2 k+2 m+1)(2 l+2 n+1) \equiv \pm 1(\bmod 8) .\end{cases}$

Lemma 4.5. Suppose that $\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \equiv(0,0,1,1)(\bmod 2)$ and $\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right) \equiv \pm 3$ $(\bmod 8)$ hold. Then the following hold:
(1) If $x_{0} \equiv x_{1}(\bmod 4)$, then $\left(x_{0}-x_{2}\right)^{2}+\left(x_{1}-x_{3}\right)^{2} \in\{2(8 k-3) \mid k \in \mathbb{Z}\}$;
(2) If $x_{0} \not \equiv x_{1}(\bmod 4)$, then $\left(x_{0}-x_{2}\right)^{2}+\left(x_{1}-x_{3}\right)^{2} \in\{2(8 k+1) \mid k \in \mathbb{Z}\}$.

Proof. We prove (1). If $x_{0} \equiv x_{1}(\bmod 4)$, then

$$
\begin{aligned}
\left(x_{0}-x_{2}\right)\left(x_{1}-x_{3}\right) & =\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right)-2 x_{0} x_{3}-2 x_{2} x_{1} \\
& \equiv\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right)-2 x_{0}\left(x_{3}+x_{2}\right) \\
& \equiv \pm 3 \quad(\bmod 8) .
\end{aligned}
$$

Thus, $\left(x_{0}-x_{2}\right)^{2}+\left(x_{1}-x_{3}\right)^{2} \equiv-6(\bmod 16)$ holds. We prove (2). If $x_{0} \not \equiv x_{1}(\bmod 4)$, then

$$
\begin{aligned}
\left(x_{0}-x_{2}\right)\left(x_{1}-x_{3}\right) & =\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right)-2 x_{0} x_{3}-2 x_{2} x_{1} \\
& \equiv\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right)-2 x_{0} x_{3}-2 x_{2}\left(x_{0}+2\right) \\
& \equiv\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right)-2 x_{0}\left(x_{3}+x_{2}\right)-4 x_{2} \\
& \equiv \pm 1 \quad(\bmod 8) .
\end{aligned}
$$

Thus, $\left(x_{0}-x_{2}\right)^{2}+\left(x_{1}-x_{3}\right)^{2} \equiv 2(\bmod 16)$ holds.
Lemma 4.6. Suppose that $\left(x_{0}+x_{2}\right)^{2}-\left(x_{1}+x_{3}\right)^{2}$ has no prime factor of the form $8 k \pm 3$. Then the following hold:
(1) If $x_{0}+x_{2} \equiv \pm 3, x_{1}+x_{3} \equiv \pm 1(\bmod 8)$, then $\left(x_{0}+x_{2}\right)^{2}-\left(x_{1}+x_{3}\right)^{2} \in\{8(8 k+1) \mid k \in \mathbb{Z}\}$;
(2) If $x_{0}+x_{2} \equiv \pm 1, x_{1}+x_{3} \equiv \pm 3(\bmod 8)$, then $\left(x_{0}+x_{2}\right)^{2}-\left(x_{1}+x_{3}\right)^{2} \in\{8(8 k-1) \mid k \in \mathbb{Z}\}$.

Proof. We prove (1). First, we consider the case of $\left(x_{0}+x_{2}, x_{1}+x_{3}\right) \equiv(3,1)(\bmod 8)$. Then $\left(x_{0}+x_{2}, x_{1}+x_{3}\right) \equiv(3,1),(3,-7),(-5,1)$ or $(-5,-7)(\bmod 16)$. From

\begin{aligned}
(16 l+3)^{2}-(16 m+1)^{2} & =(16 l+3+16 m+1)(16 l+3-16 m-1) \\
& =8(4 l+4 m+1)(8 l-8 m+1), \\
(16 l+3)^{2}-(16 m-7)^{2} & =(16 l+3+16 m-7)(16 l+3-16 m+7) \\
& =8(4 l+4 m-1)(8 l-8 m+5), \\
(16 l-5)^{2}-(16 m+1)^{2} & =(16 l-5+16 m+1)(16 l-5-16 m-1) \\
& =8(4 l+4 m-1)(8 l-8 m-3), \\
(16 l-5)^{2}-(16 m-7)^{2} & =(16 l-5+16 m-7)(16 l-5-16 m+7) \\
& =8(4 l+4 m-3)(8 l-8 m+1),
\end{aligned}
$$

we find that if $\left(x_{0}+x_{2}, x_{1}+x_{3}\right) \equiv(3,-7)$ or $(-5,1)(\bmod 16)$, then $\left(x_{0}+x_{2}\right)^{2}-\left(x_{1}+x_{3}\right)^{2}$ has at least one prime factor of the form $8 k \pm 3$. Also, if $\left(x_{0}+x_{2}, x_{1}+x_{3}\right) \equiv(3,1)$ or $(-5,-7)$ $(\bmod 16)$, then $\left(x_{0}+x_{2}\right)^{2}-\left(x_{1}+x_{3}\right)^{2}$ is of the form $8(8 k+1)$ or has at least one prime factor of the form $8 k \pm 3$. In the same way, we can prove for the cases $\left(x_{0}+x_{2}, x_{1}+x_{3}\right) \equiv(3,-1),(-3,1)$ and $(-3,-1)(\bmod 8)$. Replacing $\left(x_{0}, x_{1}, x_{2}, x_{3}\right)$ with $\left(x_{1}, x_{2}, x_{3}, x_{0}\right)$ in (1), we obtain (2).

Lemma 4.7. Suppose that $\left(x_{0}-x_{2}\right)^{2}+\left(x_{1}-x_{3}\right)^{2}$ has no prime factor of the form $8 k \pm 3$ and $x_{0}-x_{2} \equiv \pm 3, x_{1}-x_{3} \equiv \pm 3(\bmod 8)$ hold. Then $\left(x_{0}-x_{2}\right)^{2}+\left(x_{1}-x_{3}\right)^{2}$ has at least one prime factor of the form $p=a^{2}+b^{2} \equiv 1(\bmod 8)$ with $a+b \equiv \pm 3(\bmod 8)$.

Proof. From the assumption, there exist primes $p_{i} \equiv 1, q_{i} \equiv-1(\bmod 8)$ and integers $k_{i}, l_{i} \geq 0$ satisfying $\left(x_{0}-x_{2}\right)^{2}+\left(x_{1}-x_{3}\right)^{2}=2 p_{1}^{k_{1}} \cdots p_{r}^{k_{r}} q_{1}^{2 l_{1}} \cdots q_{s}^{2 l_{s}}$. We prove by contradiction. If $p_{i}=a_{i}^{2}+b_{i}^{2}$ with $a_{i}+b_{i} \equiv \pm 1(\bmod 8)$ for any $1 \leq i \leq r$, then $x_{0}-x_{2}, x_{1}-x_{3} \in$ $\{8 k \pm 1 \mid k \in \mathbb{Z}\}$ hold from [13, Lemma 4.8]. This is a contradiction.

Lemma 4.8. Suppose that $b_{0}+b_{2} \equiv b_{1}+b_{3} \equiv 0(\bmod 2)$ and $D_{4 \times 2 \times 2}(\boldsymbol{a}) \in 2^{16} \mathbb{Z}_{\text {odd }}$. Then we have $D_{4 \times 2 \times 2}(\boldsymbol{a}) \in\left\{2^{16}(4 m+1) \mid m \in \mathbb{Z}\right\}$.

Proof. From Remarks 2.2 and 2.4 (1) and Lemma 4.4 either one of the following cases holds:
(i) $b_{0} \equiv b_{1} \equiv b_{2} \equiv b_{3} \equiv 0(\bmod 2)$ and $D_{4}(\boldsymbol{b}), D_{4}(\boldsymbol{c}), D_{4}(\boldsymbol{d}), D_{4}(\boldsymbol{e}) \in 2^{4} \mathbb{Z}_{\text {odd }}$;
(ii) $b_{0} \equiv b_{1} \equiv b_{2} \equiv b_{3} \equiv 1(\bmod 2)$ and $D_{4}(\boldsymbol{b}), D_{4}(\boldsymbol{c}), D_{4}(\boldsymbol{d}), D_{4}(\boldsymbol{e}) \in 2^{4} \mathbb{Z}_{\text {odd }}$.

First, we consider the case (i). From Remark [2.4, there exist $k_{i}, l_{i}, m_{i}, n_{i} \in \mathbb{Z}$ satisfying

\boldsymbol{b}=\left(2 k_{0}, 2 l_{0}, 2 m_{0}, 2 n_{0}\right), & \boldsymbol{c}=\left(2 k_{1}, 2 l_{1}, 2 m_{1}, 2 n_{1}\right), \\
\boldsymbol{d}=\left(2 k_{2}, 2 l_{2}, 2 m_{2}, 2 n_{2}\right), & \boldsymbol{e}=\left(2 k_{3}, 2 l_{3}, 2 m_{3}, 2 n_{3}\right)
\end{array}
$$

and $\sum_{i=0}^{3} k_{i} \equiv \sum_{i=0}^{3} l_{i} \equiv \sum_{i=0}^{3} m_{i} \equiv \sum_{i=0}^{3} n_{i} \equiv 0(\bmod 2)$. Here, from Lemma 4.4, $k_{i}+m_{i} \not \equiv$ $l_{i}+n_{i}(\bmod 2)$ holds for any $0 \leq i \leq 3$. Thus we have

2^{-4} D_{4}\left(2 k_{i}, 2 l_{i}, 2 m_{i}, 2 n_{i}\right) & =\left\{\left(k_{i}+m_{i}\right)^{2}-\left(l_{i}+n_{i}\right)^{2}\right\}\left\{\left(k_{i}-m_{i}\right)^{2}+\left(l_{i}-n_{i}\right)^{2}\right\} \\
& \equiv(-1)^{l_{i}+n_{i}}(\bmod 4)
\end{aligned}
$$

Therefore,

\begin{aligned}
2^{-16} D_{4 \times 2 \times 2}(\boldsymbol{a}) & =2^{-16} \prod_{i=0}^{3} D_{4}\left(2 k_{i}, 2 l_{i}, 2 m_{i}, 2 n_{i}\right) \\
& \equiv \prod_{i=0}^{3}(-1)^{l_{i}+n_{i}} \\
& \equiv(-1)^{l_{0}+l_{1}+l_{2}+l_{3}}(-1)^{n_{0}+n_{1}+n_{2}+n_{3}} \\
& \equiv 1 \quad(\bmod 4) .
\end{aligned}
$$

In the same way, we can prove for the case (ii).
Lemma 4.9. Let $b_{0}+b_{2} \equiv b_{1}+b_{3} \equiv 1(\bmod 2)$. If $D_{4 \times 2 \times 2}(\boldsymbol{a}) \in\left\{2^{16} m \mid m \equiv-1(\bmod 8)\right\}$, then $D_{4 \times 2 \times 2}(\boldsymbol{a}) \in\left\{2^{16} m \mid m \in A \cup B\right\}$.

Proof. Let $D_{4 \times 2 \times 2}(\boldsymbol{a})=D_{4}(\boldsymbol{b}) D_{4}(\boldsymbol{c}) D_{4}(\boldsymbol{d}) D_{4}(\boldsymbol{e})=2^{16} m$ with $m \equiv-1(\bmod 8)$. From Remarks 2.2 and $\mathbf{2 . 4}$ (1), we may assume without loss of generality that $\boldsymbol{b} \equiv \boldsymbol{c} \equiv \boldsymbol{d} \equiv \boldsymbol{e} \equiv$
$(0,0,1,1)(\bmod 2)$. We prove that if $m \notin A$, then $m \in B$. Suppose that $m \notin A$ and let

& Q:=\left\{\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in \mathbb{Z}^{4} \mid\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \equiv(0,0,1,1)(\bmod 2),\right. \\
&\left.\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right) \equiv \pm 3(\bmod 8), x_{0} \not \equiv x_{1}(\bmod 4)\right\}, \\
& Q_{1}:=\left\{\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in Q \mid x_{0}+x_{2} \equiv \pm 3, x_{1}+x_{3} \equiv \pm 1(\bmod 8)\right\}, \\
& Q_{2}:=\left\{\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in Q \mid x_{0}+x_{2} \equiv \pm 1, x_{1}+x_{3} \equiv \pm 3(\bmod 8)\right\}, \\
& Q_{1}^{\prime}:=\left\{\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in Q_{1} \mid x_{0} \equiv 0, x_{1} \equiv 2(\bmod 4)\right\}, \\
& Q_{2}^{\prime}:=\left\{\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in Q_{2} \mid x_{0} \equiv 2, x_{1} \equiv 0(\bmod 4)\right\} .
\end{aligned}
$$

Since $m \notin A, D_{4}(\boldsymbol{b}) D_{4}(\boldsymbol{c}) D_{4}(\boldsymbol{d}) D_{4}(\boldsymbol{e})$ has no prime factor of the form $8 k \pm 3$. Thus, from Lemmas 4.4 (4) and 4.5, we have $\boldsymbol{b}, \boldsymbol{c}, \boldsymbol{d}, \boldsymbol{e} \in Q$. Moreover, from $m \equiv-1(\bmod 8)$ and Lemmas 4.5 and 4.6, either one of the following cases holds:
(i) One of $\boldsymbol{b}, \boldsymbol{c}, \boldsymbol{d}, \boldsymbol{e}$ is an element of $Q_{1}$ and the other three are elements of $Q_{2}$;
(ii) One of $\boldsymbol{b}, \boldsymbol{c}, \boldsymbol{d}, \boldsymbol{e}$ is an element of $Q_{2}$ and the other three are elements of $Q_{1}$.

Since $b_{0}+c_{0}+d_{0}+e_{0} \equiv 0(\bmod 4)$ from Remark 2.4 (2), we find that in both cases (i) and (ii), at least one of $\boldsymbol{b}, \boldsymbol{c}, \boldsymbol{d}, \boldsymbol{e}$ is an element of $Q_{1}^{\prime} \cup Q_{2}^{\prime}$. On the other hand, for any $\boldsymbol{x}=$ $\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in Q_{1}^{\prime}$, we have $-x_{0}+x_{2} \equiv x_{0}+x_{2} \equiv \pm 3,-x_{1}+x_{3} \equiv x_{1}+x_{3}-4 \equiv \pm 3(\bmod 8)$. Thus, it follows from Lemma 4.7 that for any $\boldsymbol{x} \in Q_{1}^{\prime}$, if $D_{4}(\boldsymbol{x})$ has no prime factor of the form $8 k \pm 3$, then $D_{4}(\boldsymbol{x})$ has at least one prime factor of the form $p=a^{2}+b^{2} \equiv 1(\bmod 8)$ with $a+b \equiv \pm 3(\bmod 8)$. In the same way, we can obtain the same conclusion for any $\boldsymbol{x} \in Q_{2}^{\prime}$. From the above, we have $m \in B$.

Proof of Lemma 4.2. Suppose that $D_{4 \times 2 \times 2}(\boldsymbol{a})=D_{4}(\boldsymbol{b}) D_{4}(\boldsymbol{c}) D_{4}(\boldsymbol{d}) D_{4}(\boldsymbol{e}) \in 2^{16} \mathbb{Z}_{\text {odd }}$. From Corollary 2.1 and Lemma 2.5, we have $b_{0}+b_{2} \equiv b_{1}+b_{3}(\bmod 2)$. Therefore, from Lemmas 4.8 and 4.9, we have

D_{4 \times 2 \times 2}(\boldsymbol{a}) \in\left\{2^{16}(4 m+1), 2^{16}(8 m+3), 2^{16} m^{\prime} \mid m \in \mathbb{Z}, m^{\prime} \in A \cup B\right\}
$$

To prove Lemma 4.3, we use the following lemma.
Lemma 4.10. Suppose that $\boldsymbol{x}=\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \equiv(0,0,1,1)(\bmod 2),\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right) \equiv \pm 1$ $(\bmod 8)$ and $x_{0} \not \equiv x_{1}(\bmod 4)$. Then $D_{4}(\boldsymbol{x})$ has at least one prime factor of the form $8 k-3$.

Proof. From

$$
\begin{aligned}
\left(x_{0}-x_{2}\right)\left(x_{1}-x_{3}\right) & =\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right)-2 x_{0} x_{3}-2 x_{2} x_{1} \\
& \equiv\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right)-2 x_{0} x_{3}-2 x_{2}\left(x_{0}+2\right) \\
& \equiv\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right)-2 x_{0}\left(x_{3}+x_{2}\right)-4 x_{2} \\
& \equiv \pm 3 \quad(\bmod 8),
\end{aligned}
$$

we have $\left(x_{0}-x_{2}\right)^{2}+\left(x_{1}-x_{3}\right)^{2} \equiv-6(\bmod 16)$. This completes the proof.

Proof of Lemma 4.3. Suppose that $D_{4 \times 2 \times 2}(\boldsymbol{a})=D_{4}(\boldsymbol{b}) D_{4}(\boldsymbol{c}) D_{4}(\boldsymbol{d}) D_{4}(\boldsymbol{e}) \in 2^{17} \mathbb{Z}_{\text {odd }}$. Then, from Corollary 2.1 and Lemma 2.5, we have $b_{0}+b_{2} \equiv b_{1}+b_{3}(\bmod 2)$. Therefore, from Remarks 2.2 and 2.4 (1) and Lemma 4.4, we have $b_{0}+b_{2} \equiv b_{1}+b_{3} \equiv 1(\bmod 2)$. We may assume without loss of generality that $\boldsymbol{b} \equiv \boldsymbol{c} \equiv \boldsymbol{d} \equiv \boldsymbol{e} \equiv(0,0,1,1)(\bmod 2)$. Let

Q_{3}:=\{ & \left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in \mathbb{Z}^{4} \mid\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \equiv(0,0,1,1)(\bmod 2), \\
& \left.\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right) \equiv \pm 3(\bmod 8)\right\}, \\
Q_{4}:=\{ & \left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in \mathbb{Z}^{4} \mid\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \equiv(0,0,1,1)(\bmod 2), \\
& \left.\left(x_{0}+x_{2}\right)\left(x_{1}+x_{3}\right) \equiv \pm 1(\bmod 8)\right\}, \\
Q_{3}^{\prime}:=\{ & \left.\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in Q_{3} \mid x_{0} \equiv x_{1}(\bmod 4)\right\}, \\
Q_{4}^{\prime}:=\{ & \left\{\left(x_{0}, x_{1}, x_{2}, x_{3}\right) \in Q_{4} \mid x_{0} \not \equiv x_{1}(\bmod 4)\right\} .
\end{aligned}
$$

From Lemma 4.4, three of $\boldsymbol{b}, \boldsymbol{c}, \boldsymbol{d}, \boldsymbol{e}$ are elements of $Q_{3}$ and the other one is an element of $Q_{4}$. Moreover, since $\left(b_{0}-b_{1}\right)+\left(c_{0}-c_{1}\right)+\left(d_{0}-d_{1}\right)+\left(e_{0}-e_{1}\right) \equiv 0(\bmod 4)$ from Remark $2.4(2)$, we find that at least one of $\boldsymbol{b}, \boldsymbol{c}, \boldsymbol{d}, \boldsymbol{e}$ is an element of $Q_{3}^{\prime} \cup Q_{4}^{\prime}$. On the other hand, it follows from Lemmas 4.5 and 4.10 that for any $\boldsymbol{x} \in Q_{3}^{\prime} \cup Q_{4}^{\prime}, D_{4}(\boldsymbol{x})$ has at least one prime factor of the form $8 k-3$. From the above, there exist $p \in P$ and $m \in \mathbb{Z}$ satisfying $D_{4 \times 2 \times 2}(\boldsymbol{a})=2^{17} p(2 m+1)$.

## 5 Possible numbers

In this section, we determine all possible numbers. Lemmas 3.1 and 4.14 .3 imply that $S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)$ does not include every integer that is not mentioned in the following Lemmas 5.1 5.3 .

Lemma 5.1. For any $m \in \mathbb{Z}$, the following are elements of $S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)$ :
(1) $16 m+1$;
(2) $2^{16}(4 m+1)$;
(3) $2^{16}(4 m+1)(8 n+3)$;
(4) $2^{18}(2 m+1)$;
(5) $2^{18}(2 m)$.

Lemma 5.2. For any $p \in P^{\prime}$ and $m \in \mathbb{Z}$, we have $2^{16} p(4 m-1) \in S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)$.
Lemma 5.3. For any $p \in P$ and $m \in \mathbb{Z}$, we have $2^{17} p(2 m+1) \in S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)$.
Remark 5.4. From Lemma 5.1 (3), we have $2^{16} m \in S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)$ for any $m \in$ A. Also, from Lemma 5.2, we have $2^{16} m \in S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)$ for any $m \in B$.

Proof of Lemma 5.1. We obtain (1) from

D_{4 \times 2 \times 2}(m+1, m, \ldots, m) & =D_{4}(4 m+1,4 m, 4 m, 4 m) D_{4}(1,0,0,0)^{3} \\
& =(8 m+1)^{2}-(8 m)^{2} \\

\end{aligned}

We obtain (2) from

D_{4 \times 2 \times 2}(m+1, m+1, m+2, m, \ldots, m) & =D_{4}(4 m+1,4 m+1,4 m+2,4 m) D_{4}(1,1,2,0)^{3} \\
& =2\left\{(8 m+3)^{2}-(8 m+1)^{2}\right\} \cdot\left(2^{4}\right)^{3} \\
& =2^{13}(32 m+8) \\
& =2^{16}(4 m+1) .
\end{aligned}
$$

We obtain (3) from

\begin{aligned}
& D_{4 \times 2 \times 2} \overbrace{m+n+1, \ldots, m+n+1}^{4}, \overbrace{m-n, \ldots, m-n}^{4}, \\
& \quad m+n+1, m+n, m+n+1, m+n-1, m-n-1, m-n, m-n, m-n) \\
& =D_{4}(4 m+1,4 m+1,4 m+2,4 m) D_{4}(4 n+3,4 n+1,4 n+2,4 n) D_{4}(1,1,0,2) D_{4}(-1,1,0,2) \\
& =2\left\{(8 m+3)^{2}-(8 m+1)^{2}\right\} \cdot 2\left\{(8 n+5)^{2}-(8 n+1)^{2}\right\} \cdot\left(-2^{4}\right) \cdot\left(-2^{4}\right) \\
& =2^{10}(32 m+8)(64 n+24) \\
& =2^{16}(4 m+1)(8 n+3) .
\end{aligned}
$$

We obtain (4) from

& D_{4 \times 2 \times 2}(m+2, m, m+2, m+1, m, m, m, m, m+1, m+1, m, m+1, m, m, m, m) \\
&=D_{4}(4 m+3,4 m+1,4 m+2,4 m+2) D_{4}(3,1,2,2) D_{4}(1,-1,2,0)^{2} \\
& \quad=2\left\{(8 m+5)^{2}-(8 m+3)^{2}\right\} \cdot 2^{5} \cdot\left(2^{4}\right)^{2} \\
& \quad=2^{14}(32 m+16) \\
& \quad=2^{18}(2 m+1) .
\end{aligned}
$$

We obtain (5) from

& D_{4 \times 2 \times 2}(m+1, m, m+1, m, m, m-1, m, m, m, m+1, m, m+1, m, m-1, m-1, m-1) \\
& \quad=D_{4}(4 m+1,4 m-1,4 m, 4 m) D_{4}(1,3,2,2) D_{4}(1,-1,2,0) D_{4}(1,-1,0,-2) \\
& \quad=2\left\{(8 m+1)^{2}-(8 m-1)^{2}\right\} \cdot\left(-2^{5}\right) \cdot 2^{4} \cdot\left(-2^{4}\right) \\
& \quad=2^{14}(32 m) \\
& \quad=2^{18}(2 m) .
\end{aligned}
$$

Proof of Lemma 5.2. For any $p \in P^{\prime}$, there exist $r, s \in \mathbb{Z}$ with $r \not \equiv s(\bmod 2)$ satisfying $p=(4 r)^{2}+(4 s+1)^{2}$. Let $k:=\frac{r+s+1}{2}$ and $l:=\frac{r-s-1}{2}$. Then we have

2 p=(4 r+4 s+1)^{2}+(4 r-4 s-1)^{2}=(8 k-3)^{2}+(8 l+3)^{2}
$$

Therefore, from

& D_{4 \times 2 \times 2}(k-m, l-m+1,-k-m+1,-l-m, k+m, l+m+1,-k+m+1,-l+m, \\
&k-m, l-m+1,-k-m+1,-l-m, k+m-1, l+m,-k+m-1,-l+m) \\
&= D_{4}(4 k-1,4 l+3,2-4 k,-4 l) D_{4}(1-4 m, 1-4 m, 2-4 m,-4 m) \\
& \times D_{4}(1,1,2,0) D_{4}(-1,-1,-2,0) \\
&=-2^{3}\left\{(8 k-3)^{2}+(8 l+3)^{2}\right\} \cdot 2\left\{(3-8 m)^{2}-(1-8 m)^{2}\right\} \cdot 2^{4} \cdot 2^{4} \\
&=-2^{12}\left\{(8 k-3)^{2}+(8 l+3)^{2}\right\}(-32 m+8) \\
&= 2^{15}\left\{(8 k-3)^{2}+(8 l+3)^{2}\right\}(4 m-1),
\end{aligned}

we have $2^{16} p(4 m-1) \in S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)$.
Proof of Lemma 5.3. For any $p \in P$, there exist $r, s \in \mathbb{Z}$ with $r \equiv s(\bmod 2)$ satisfying $p=(4 r+2)^{2}+(4 s+1)^{2}$. Let $k:=\frac{r+s}{2}$ and $l:=\frac{r-s}{2}$. Then we have

$$
2 p=(4 r+4 s+3)^{2}+(4 r-4 s+1)^{2}=(8 k+3)^{2}+(8 l+1)^{2}
$$

Therefore, from

$$
\begin{aligned}
& D_{4 \times 2 \times 2}(m+l+1, m+k+1, m-l+1, m-k, m+l+1, m+k+1, m-l+1, m-k, \\
&m+l+1, m+k+1, m-l+1, m-k, m+l, m+k, m-l-1, m-k) \\
&= D_{4}(4 m+4 l+3,4 m+4 k+3,4 m-4 l+2,4 m-4 k) D_{4}(1,1,2,0)^{2} D_{4}(-1,-1,-2,0) \\
&=\left\{(8 m+5)^{2}-(8 m+3)^{2}\right\}\left\{(8 l+1)^{2}+(8 k+3)^{2}\right\} \cdot\left(2^{4}\right)^{2} \cdot 2^{4} \\
&= 2^{12}(32 m+16)\left\{(8 k+3)^{2}+(8 l+1)^{2}\right\} \\
&= 2^{16}\left\{(8 k+3)^{2}+(8 l+1)^{2}\right\}(2 m+1),
\end{aligned}
$$

we have $2^{17} p(2 m+1) \in S\left(\mathrm{C}_{4} \times \mathrm{C}_{2}^{2}\right)$.
From Lemmas 3.1, 4.1 4.3 and 5.15 .3 , Theorem 1.1 is proved.
