# NON-FLAT CONFORMAL BLOW-UP PROFILES FOR THE 1D CRITICAL NONLINEAR SCHRÖDINGER EQUATION*

#### Abstract

For the critical one-dimensional nonlinear Schrödinger equation, we construct blow-up solutions that concentrate a soliton at the origin at the conformal blow-up rate, with a non-flat blow-up profile. More precisely, we obtain a blow-up profile that equals $|x|+i \kappa x^{2}$ near the origin, where $\kappa$ is a universal real constant. Such profile differs from the flat profiles obtained in the same context by Bourgain and Wang 1].


## 1. Introduction

We consider the mass critical Schrödinger equation in one dimension

$$
\begin{equation*}
i \partial_{t} u+\partial_{x}^{2} u+|u|^{4} u=0 \quad(t, x) \in \mathbb{R} \times \mathbb{R} \tag{1.1}
\end{equation*}
$$

Recall that the mass $M(u)$, the momentum $J(u)$ and the energy $E(u)$ of a solution $u$ of (1.1) are formally conserved

$$
\begin{aligned}
M(u) & =\int_{\mathbb{R}}|u|^{2} d x \\
J(u) & =\Im \int_{\mathbb{R}}\left(\partial_{x} u\right) \bar{u} d x \\
E(u) & =\frac{1}{2} \int_{\mathbb{R}}\left|\partial_{x} u\right|^{2} d x-\frac{1}{6} \int_{\mathbb{R}}|u|^{6} d x .
\end{aligned}
$$

The Cauchy problem for (1.1) is locally well-posed in $L^{2}(\mathbb{R})$ : for any $u_{0} \in L^{2}(\mathbb{R})$, there exists a unique maximal solution $u$ of (1.1) in $\mathcal{C}\left([0, T), L^{2}(\mathbb{R})\right)$ satisfying $u(0, \cdot)=u_{0}$ (see e.g. [2] for details). If in addition $u_{0} \in H^{1}(\mathbb{R})$, then the solution belongs to $\mathcal{C}\left([0, T), H^{1}(\mathbb{R})\right)$; moreover, if the maximal time of existence $T>0$ is finite then

\liminf _{t \uparrow T}(T-t)^{\frac{1}{2}}\left\|\partial_{x} u(t)\right\|_{L^{2}}>0
$$

Let $Q$ be the positive, even, $H^{1}$ solution of $-Q^{\prime \prime}+Q=Q^{5}$ on $\mathbb{R}$ given by

$$
\begin{equation*}
Q(x)=3^{\frac{1}{4}}(\cosh (2 x))^{-\frac{1}{2}} \tag{1.2}
\end{equation*}
$$

It is well-known 23] that if the $H^{1}$ solution $u$ satisfies $\|u(t)\|_{L^{2}}<\|Q\|_{L^{2}}$, then it is global and bounded in $H^{1}$.

The pseudo-conformal symmetry of the equation implies that if $u(t, x)$ is a solution of (1.1) then

v(t, x)=\frac{1}{|t|^{\frac{1}{2}}} u\left(-\frac{1}{t}, \frac{x}{|t|}\right) e^{i \frac{|x|^{2}}{4 t}}
$$

[^0]is also a solution of (1.1). By this symmetry, the solitary wave solution $u(t, x)=$ $e^{i t} Q(x)$ yields the explicit blow-up solution
\[

$$
\begin{equation*}
S(t, x)=\frac{1}{|t|^{\frac{1}{2}}} Q\left(\frac{x}{t}\right) e^{-\frac{i x^{2}}{4 t}} e^{\frac{i}{t}} \tag{1.3}
\end{equation*}
$$

\]

defined on $(-\infty, 0) \times \mathbb{R}$. This solution is called the minimal mass solution since

$$
\|S(t)\|_{L^{2}}=\|Q\|_{L^{2}}, \quad \lim _{t \uparrow 0}\left\|\partial_{x} S(t)\right\|_{L^{2}}=+\infty .
$$

Moreover, for $t<0$ close to 0 ,

$$
\left\|\partial_{x} S(t)\right\|_{L^{2}} \sim \frac{C}{|t|}
$$

and $|t|^{-1}$ is thus called the conformal blow-up rate. In addition, it was proved in [15] that $S$ is the unique (up to the invariances of (1.1)) blow-up solution with the minimal mass.

The general blow-up problem for (1.1) is still largely open, but a lot of information is known for blow-up solutions close to the ground state $Q$, more precisely under the following assumption on the mass of the initial data

\end{equation*}

where $\delta>0$ is small. We recapitulate the main known results, in the context of the one-dimensional space variable with even symmetry on the initial data. Suppose that $u_{0} \in H^{1}(\mathbb{R})$ is even, satisfies (1.4) and that the corresponding solution $u$ blows up in finite time $0<T<+\infty$, then the following properties hold.

Orbital stability [23: There exist $\gamma(t)$ and $\lambda(t)$ such that

\sup _{[0, T)}\left\|e^{-i \gamma(t)} \lambda^{\frac{1}{2}}(t) u(t, \lambda(t) x)-Q\right\|_{H^{1}} \quad \text { is small as } \delta \text { is small. }
$$

Asymptotic stability 16, 17: There exist sequences $\left(\gamma_{n}\right),\left(\lambda_{n}\right)$ and $\left(t_{n}\right)$
with $t_{n} \uparrow T$, such that

\lim _{n \rightarrow+\infty} e^{-i \gamma_{n}} \lambda_{n}^{\frac{1}{2}} u\left(t_{n}, \lambda_{n} x\right) \rightarrow Q \quad \text { in } \dot{H}^{1} \text { as } n \rightarrow+\infty .
$$

Dichotomy and gap for the blow-up rate [20: The solution $u$

- either blows up with the loglog rate

$$
\begin{equation*}
\lim _{t \uparrow T} \sqrt{\frac{T-t}{\log |\log (T-t)|}}\left\|\partial_{x} u(t)\right\|_{L^{2}}=\frac{\left\|Q^{\prime}\right\|_{L^{2}}}{\sqrt{2 \pi}}, \tag{1.5}
\end{equation*}
$$

- or blows up faster than the conformal rate

$$
\begin{equation*}
\liminf _{t \uparrow T}(T-t)\left\|\partial_{x} u(t)\right\|_{L^{2}}>0 . \tag{1.6}
\end{equation*}
$$

Blow-up profile [16: There exist $\gamma(t), \lambda(t)$ and $r_{*} \in L^{2}(\mathbb{R})$ such that

$$
u(t)-\frac{e^{i \gamma(t)}}{\lambda^{\frac{1}{2}}(t)} Q\left(\frac{x}{\lambda(t)}\right) \rightarrow r_{*} \quad \text { in } L^{2}(\mathbb{R}) \text { as } t \uparrow T .
$$

Moreover,

$$
\begin{equation*}
\left(r_{*} \in H^{1}(\mathbb{R}) \text { and } r_{*}(0)=0\right) \Longleftrightarrow \text { (1.6) holds } \tag{1.7}
\end{equation*}
$$

Generic log-log blow-up rate [17]: The set of initial data in $H^{1}$ satisfying (1.4) and such that the solution blows up with the loglog blow-up rate (1.5) is open in $H^{1}$. It contains all the initial data with negative energy such that (1.4) holds.
Existence of non-generic blow-up [1, 9, 18: For $A>0$ large, if $r_{*} \in$ $H^{A}(\mathbb{R})$ satisfies

\begin{equation*}
\left(1+|x|^{2}\right)^{\frac{1}{2}} r_{*} \in L^{2}(\mathbb{R}) \quad \text { and } \quad r_{*}^{(k)}(0)=0 \quad \text { for any } 0 \leq k \leq A \tag{1.8}
\end{equation*}
$$

then, there exist $\tau>0$ and a solution $u$ of (1.1) on $[-\tau, 0)$ such that

$$
\lim _{t \uparrow 0} u(t)-S(t)=r_{*} \quad \text { in } H^{1}(\mathbb{R})
$$

The minimal mass solution (1.3) and the non-generic blow-up solutions constructed in 1 have the conformal blow-up rate $\left\|\partial_{x} u(t)\right\|_{L^{2}} \sim C(T-t)^{-1}$ for $t \sim T$. The existence of solutions blowing up strictly faster than the conformal rate is an open problem, which is equivalent, by the pseudo-conformal symmetry, to the existence of global solutions blowing up in infinite time. The only known example [13] contains at least two bubbles, which means that (1.4) is not satisfied.

The $\log \log$ rate is physically more relevant than the conformal rate since it was proved to be stable under the assumption (1.4) (the set of blow-up solutions exhibited in 17 is open in $H^{1}$ ). However, it is interesting mathematically to further investigate the conformal blow-up case. For example, the conformal blow-up rate is seen as a frontier separating solutions with the loglog rate and scattering, as discussed in 11, 9, 18 .

In this paper, we focus on the blow-up profile $r_{*}$ as defined in [16], in the conformal blow-up case.

Theorem 1. There exist $\kappa \in \mathbb{R}, \delta_{0}>0$ and $C>0$ with the following property. For any $\delta \in\left(0, \delta_{0}\right)$, there exist $\tau>0$ and a solution $u \in \mathcal{C}\left([-\tau, 0), H^{1}(\mathbb{R})\right)$ of (1.1) which blows up at time 0 with the asymptotics

\begin{align*}
& \lim _{t \uparrow 0}|t|\left\|\partial_{x} u(t)\right\|_{L^{2}}=\left\|Q^{\prime}\right\|_{L^{2}},  \tag{1.9}\\
& \lim _{t \uparrow 0}\{u(t)-S(t)\}=\lim _{t \uparrow 0}\left\{u(t)-\frac{e^{\frac{i}{t}}}{|t|^{\frac{1}{2}}} Q\left(\frac{x}{t}\right)\right\}=r_{*} \quad \text { in } L^{2}(\mathbb{R}), \tag{1.10}
\end{align*}
$$

where the function $r_{*} \in H^{1}(\mathbb{R})$ satisfies $\left\|r_{*}\right\|_{L^{2}} \leq C \delta^{\frac{3}{2}}$ and

$$
\begin{equation*}
r_{*}(x)=|x|+i \kappa x^{2} \quad \text { for all } x \in(-\delta, \delta) \tag{1.11}
\end{equation*}
$$

Remark 1.1. This example illustrates the fact that a blow-up profile in the conformal case need not be flat at a blow-up point as one could have expected from previous constructions of conformal blow-up solutions in [1, 9, 18] see (1.8).

Remark 1.2. The constant $\kappa$ is defined in (2.8) ; see also Remark 2.1,
Remark 1.3. We expect that the proof of Theorem 1 can be extended to more general blow-up profiles of the form

$$
\begin{equation*}
r_{*}(x)=z_{1}\left(|x|+i \kappa x^{2}\right)+z_{2}|x|^{3}+w_{*}(x) \tag{1.12}
\end{equation*}
$$

in the neighborhood of 0 where $z_{1}, z_{2} \in \mathbb{C}$ and $w_{*}$ is a term of order $x^{4}$ at $x=0$, with suitable regularity properties. We do not pursue this issue here for the sake of simplicity.

It is an open problem to determine all possible blow-up profiles, in terms of regularity and behavior at the blow-up point. On the one hand, in the one-dimensional case, from [16] , the condition $r_{*}(0)=0$ is necessary for $r_{*}$ to be a blow-up profile (see (1.7)). On the other hand, we do not know whether the implicit relation $r_{*}^{\prime \prime}(0)=2 i \kappa r_{*}^{\prime}(0)$ in (1.12) is necessary or is only a technical assumption due to our approach.

Remark 1.4. The question of the blow-up rate and the blow-up profile has been studied for other nonlinear dispersive or wave PDEs ; see for example the following articles: [3, 4, 5, 6, 7, 8, 10, 11, 12, 21. Analogies between the present work and [12], devoted to the critical generalized Korteweg-de Vries equation, are discussed in the sketch of the proof.

Sketch of the proof. To analyse the blow-up phenomenon, we introduce the rescaled variable

u(t, x)=\lambda^{-\frac{1}{2}}(s) e^{i \gamma(s)} U(s, y), \quad y=\frac{x}{\lambda}, \quad d s=\frac{d t}{\lambda^{2}} \tag{1.13}
\end{equation*}
$$

where $y \in \mathbb{R}$ and $s \gg 1$ (which means that $t$ is close to the blow up time) and where the scaling and phase parameters $\lambda>0$ and $\gamma$ are functions to be determined. By direct computation,

$$
\begin{equation*}
i \partial_{t} u+\partial_{x}^{2} u+|u|^{4} u=\lambda^{-\frac{5}{2}} e^{i \gamma} \mathcal{E}(U) \tag{1.14}
\end{equation*}
$$

where

$$
\begin{equation*}
\mathcal{E}(U):=i \partial_{s} U+\partial_{y}^{2} U-U+|U|^{4} U-i \frac{\lambda_{s}}{\lambda} \Lambda U-\left(\gamma_{s}-1\right) U \tag{1.15}
\end{equation*}
$$

It is easily checked using $Q^{\prime \prime}+Q^{5}=Q$ that the function $U(s, y)=e^{-i b(s) \frac{y^{2}}{4}} Q(y)$ satisfies $\mathcal{E}(U)=0$ for the special choice of parameters

$$
\begin{equation*}
\gamma(s)=s, \quad \lambda(s)=\frac{1}{s}, \quad b(s)=\frac{1}{s} \tag{1.16}
\end{equation*}
$$

which corresponds to the minimal mass solution $S(t)$ defined in (1.3), and thus to $r_{*}=0$ in (1.10). Any residual profile $r_{*}$ satisfying a strong flatness condition such as (1.8) will decouple from the soliton and in such case it is enough to consider an approximate solution containing only a rescaled soliton, as in 11, 18. The main new ingredient of the proof of Theorem 1 consists in constructing a suitable approximate solution $V$ of $\mathcal{E}(V)=0$. In contrast with the flat case, to generate the specific asymptotic behavior (1.10) (1.11), where the residual profile is expected to interact strongly with the bubble, the approximate solution $V$ has to include additional terms. We set

$$
\begin{equation*}
V(s, y)=e^{-i b \frac{y^{2}}{4}} Q(y)+\theta(s, y) \lambda^{\frac{3}{2}}\left(\varphi_{1}(y) \cos \gamma+i \psi_{1}(y) \sin \gamma\right) \tag{1.17}
\end{equation*}
$$

with a suitable cut-off function $\theta(\theta \equiv 1$ close to the soliton) and where

$$
\gamma(s) \sim s, \quad \lambda(s) \sim \frac{1}{s}, \quad b(s) \sim \frac{1}{s}
$$

We now discuss the choice of the pair of functions $\left(\varphi_{1}, \psi_{1}\right)$; the form of $V$ in (1.17) and the choice of the cut-off function $\theta$ are justified later. By linearization, we obtain formally

$$
\mathcal{E}(V) \sim-\lambda^{\frac{3}{2}}\left[\left(\psi_{1}+L_{+} \varphi_{1}\right) \cos \gamma+i\left(\varphi_{1}+L_{-} \psi_{1}\right) \sin \gamma\right]
$$

where the operators $L_{ \pm}$are defined in (2.1) and where we have discarded higher order terms. It is thus natural to consider the system

$$
\left(\begin{array}{cc}
L_{+} & 1  \tag{1.18}\\
1 & L_{-}
\end{array}\right)\binom{\varphi}{\psi}=0
$$

From [19, Proposition 2.1.4], the system (1.18) does not have any non zero bounded solution $(\varphi, \psi)$. However, it follows from ODE arguments (see Appendix A) that this system has an even solution $\left(\varphi_{1}, \psi_{1}\right)$ with the following asymptotic behavior as $|y| \rightarrow+\infty$,

$$
\begin{equation*}
\varphi_{1}(y) \sim|y|, \quad \psi_{1}(y) \sim-|y| . \tag{1.19}
\end{equation*}
$$

(See Lemma 2.2 for a precise statement.) We now justify that the asymptotic behavior (1.19) of $\left(\varphi_{1}, \psi_{1}\right)$ as $|y| \rightarrow+\infty$, the multiplicative factor $\lambda^{\frac{3}{2}}$ in (1.17) and the choice of a suitable cut-off function $\theta$ generate the first term of the profile $r_{*}$ in the original variables $(t, x)$. Indeed, from (1.17), the asymptotic behavior of $V(s, y)$ for $|y|$ large corresponds to the function $R_{*}(s, y)=\lambda^{\frac{3}{2}} e^{-i \gamma}|y|$ and after the change of variable (1.13), we recognize the first term $|x|$ in the profile $r_{*}$ defined by (1.11). For a different multiplicative factor $\lambda^{\alpha}, \alpha \neq \frac{3}{2}$, the ansatz would be either too large (the approximate solution is not close to $Q$ in $L^{2}$ ) or too small (the solution is simply $S(t, x)$ ). The second term $i \kappa x^{2}$ in (1.11) is due to an additional correction term in the definition of $V$ (see Section(3.2) which is needed in our method to obtain manageable error terms.

Note that the idea of using a pair $\left(\varphi_{1}, \psi_{1}\right)$ solution of (1.18) and the choice of a cut-off function $\theta$ related to the original variable (see Section 3.2) was inspired by the construction technique introduced in 12 (see the definition of $A_{1}$ and formula (1.16) in [12), devoted to the existence of a new blow-up rate for the critical generalized KdV equation. We also refer to [10, 11] and references therein for more blow-up results concerning that equation.

Once the approximate solution $V$ is constructed in Section 3 (see Lemma 3.1 and Proposition 3.2 for its main properties), the proof scheme follows the ones in [14, 21, 13]. For a sequence of solutions of (1.1) constructed backwards in time close to the approximate solution, we establish uniform estimates for the parameters (by modulation and ODE techniques, see Sections 4 and 6) and for the error term (by energy arguments inspired by [21, see Section (5). In Section 7 passing to the strong limit in $L^{2}$, we obtain a solution of (1.1) as stated in Theorem 1 .

Compared to previous works on blowup for the nonlinear Schrödinger equation, a key difficulty comes from oscillations in time through the phase parameter $\gamma$, due to that fact that the solitonic bubble has a phase $\gamma \rightarrow+\infty$ at the blow-up time, while the profile $r_{*}(x)$ is time independent. Several time dependent oscillatory quantities (like (3.9) and (4.27)) are introduced to use cancellations in mean value in time while estimating the parameters.

Notation. Set

$$
f(u)=|u|^{4} u, \quad F(u)=\frac{1}{6}|u|^{6}
$$

We denote

$$
\langle g, h\rangle=\Re \int g \bar{h}
$$

Set

$$
\Sigma=\left\{g \in H^{1}(\mathbb{R}) ; x g \in L^{2}(\mathbb{R})\right\}
$$

Let $\Lambda$ be the generator of $L^{2}$-scaling in 1D:

\Lambda g=\frac{1}{2} g+x \partial_{x} g
$$

In particular,

\begin{equation*}
\left\langle g_{1}, \Lambda g_{2}\right\rangle+\left\langle g_{2}, \Lambda g_{1}\right\rangle=0 \tag{1.20}
\end{equation*}
$$

for all $g_{1}, g_{2} \in \Sigma$, hence

\begin{equation*}
\langle g, \Lambda g\rangle=0 \tag{1.21}
\end{equation*}
$$

for all $g \in \Sigma$. In addition,

$$
\begin{equation*}
\left\langle\partial_{x}^{2} g, \Lambda g\right\rangle=-\left\|\partial_{x} g\right\|_{L^{2}}^{2} \tag{1.22}
\end{equation*}
$$

for all $g \in H^{2}(\mathbb{R})$ with $\partial_{x} g \in \Sigma$. More generally, for $k \in \mathbb{Z}$, we let

$$
\begin{equation*}
\Lambda_{k} g=\frac{1-k}{2} g+x \partial_{x} g \tag{1.23}
\end{equation*}
$$

so that $\Lambda=\Lambda_{0}$.
We define the vector space
$\mathcal{Y}=\left\{g \in \mathcal{C}^{\infty}(\mathbb{R}, \mathbb{R}) ; g\right.$ is even and

$$
\left.\exists q \in \mathbb{N}, \forall p \in \mathbb{N}, \exists C>0, \forall x \in \mathbb{R},\left|g^{(p)}(x)\right| \leq C\langle x\rangle^{q} e^{-|x|}\right\}
$$

where $\langle x\rangle=\left(1+x^{2}\right)^{\frac{1}{2}}$.
Moreover, we fix an even function $\chi \in \mathcal{C}^{\infty}(\mathbb{R}, \mathbb{R})$ such that $\chi \geq 0, \chi(x)=0$ for $|x| \leq 1 / 2$ and $\chi(x)=1$ for $|x| \geq 1$, and we define the functions $\mu_{k}, k \geq 0$, by

\mu_{k}(x)=|x|^{k} \chi(x) \tag{1.24}
\end{equation*}

We let

\mathcal{Z}_{k}=\mathcal{Y}+\operatorname{span}\left\{\mu_{0}, \ldots, \mu_{k}\right\} \tag{1.25}
\end{equation*}

Using the operators $\Lambda_{j}$ defined by (1.23), it is not difficult to see that for any $j, k \in \mathbb{N}$,

\Lambda_{2 k+3} \mathcal{Z}_{k+1} & \subset \mathcal{Z}_{k}  \tag{1.27}\\
\Lambda_{1} \mathcal{Z}_{0} & \subset \mathcal{Y} \tag{1.28}
\end{align*}

## 2. Linearization around the soliton

2.1. Linearized operator. The linearization of (1.1) around the special solution $u(t, x)=e^{i t} Q(x)$ involves the following Schrödinger operators:

\begin{equation*}
L_{+}:=-\partial_{x}^{2}+1-5 Q^{4}, \quad L_{-}:=-\partial_{x}^{2}+1-Q^{4} \tag{2.1}
\end{equation*}
$$

Denote by $\rho \in \mathcal{Y}$ the unique radial $H^{1}$ solution of

$$
L_{+} \rho=\frac{x^{2}}{4} Q
$$

See [24, Appendix B]. We recall the generalized null space relations [24, Appendix B]

$$
\begin{equation*}
L_{-} Q=0, \quad L_{+}(\Lambda Q)=-2 Q, \quad L_{-}\left(x^{2} Q\right)=-4 \Lambda Q, \quad L_{+} \rho=\frac{x^{2}}{4} Q \tag{2.2}
\end{equation*}
$$

We check that

$$
\begin{equation*}
\langle\rho, Q\rangle=-\frac{1}{2}\left\langle L_{+} \rho, \Lambda Q\right\rangle=-\frac{1}{8}\left\langle x^{2} Q, \Lambda Q\right\rangle=\frac{1}{8} \int x^{2} Q^{2}>0 \tag{2.3}
\end{equation*}
$$

For any $a \in \mathbb{R}$, we set

Q_{a}=Q+a \rho
$$

so that

Q_{a}^{\prime \prime}-Q_{a}+Q_{a}^{5}+a \frac{x^{2}}{4} Q=Q_{a}^{5}-Q^{5}-5 a Q^{4} \rho \tag{2.4}
\end{equation*}

We will use the following well-known coercivity properties.
Lemma 2.1. There exists a constant $\zeta_{0}>0$ such that

\left\langle L_{+} g, g\right\rangle \geq \zeta_{0}\|g\|_{H^{1}}^{2}-\frac{1}{\zeta_{0}}\left(\langle g, Q\rangle^{2}+\left\langle g, y^{2} Q\right\rangle^{2}\right)

and

\left\langle L_{-} g, g\right\rangle \geq \zeta_{0}\|g\|_{H^{1}}^{2}-\frac{1}{\zeta_{0}}\left(\langle g, \rho\rangle^{2}+\langle g, \Lambda Q\rangle^{2}\right)
$$

for any real-valued function $g \in H^{1}(\mathbb{R})$.
Proof. The estimates are immediate consequences of Propositions 2.9 and 2.10 in [24.
2.2. Linearized system. For the construction of the approximate blow-up solution, we will use systems involving the operators $L_{+}$and $L_{-}$, as introduced below.

Lemma 2.2. The following properties hold.
(i) There exists a unique pair of even functions $\left(\varphi_{1}, \psi_{1}\right) \in \mathcal{Z}_{1}^{2}$ such that

where $c_{1} \in \mathbb{R}$ and $v_{1}, w_{1} \in \mathcal{Y}$.
(ii) Given a pair of even functions $(g, h) \in \mathcal{Y}^{2}$, there exists a unique pair of even functions $(\varphi, \psi) \in \mathcal{Z}_{0}^{2}$ solution of the system

and satisfying

The proof of Lemma 2.2 is given in Appendix A. The key ingredient is a result from [19] concerning the non existence of a resonance pair for (2.5), i.e. the non existence of a pair of non zero bounded functions satisfying (2.5).

We define $\alpha_{1} \in \mathbb{R}$ by

Remark 2.1. The constant $\kappa$ appears in the statement of Theorem [1. From the definition of $c_{1}$ in part (i) of Lemma [2.2] it does not seem clear how to determine $\kappa$ explicitly.

Now, we define another pair of functions that will be useful in the construction of the approximate rescaled blow-up solution.

Lemma 2.3. There exists a unique pair of even functions $\left(\varphi_{2}, \psi_{2}\right) \in \mathcal{Z}_{2}^{2}$ solution of the system

where $c_{2} \in \mathbb{R}$ and $v_{2}, w_{2} \in \mathcal{Y}$.
Proof. Note from (1.27) with $k=0$ that $\Lambda_{3} \varphi_{1}, \Lambda_{3} \psi_{1} \in \mathcal{Z}_{0}$. More precisely, from Lemma 2.2. we have

In particular, $\left(\varphi_{2}, \psi_{2}\right)$ solves (2.9) if and only if setting $\check{\varphi}_{2}=$ $\varphi_{2}+\frac{1}{2} c_{1} x^{2}, \check{\psi}_{2}=\psi_{2}-\frac{1}{2} c_{1} x^{2}$, the pair $\left(\check{\varphi}_{2}, \check{\psi}_{2}\right)$ satisfies

As $\check{g}_{2}, \check{h}_{2} \in \mathcal{Y}$, by (iii) of Lemma 2.2 there exists a unique pair of functions $\left(\check{\varphi}_{2}, \check{\psi}_{2}\right)$ solutions in $\mathcal{Z}_{0}^{2}$ of this system, satisfying for a constant $c_{2} \in \mathbb{R}$ and $v_{2}, w_{2} \in \mathcal{Y}$,

Let $\alpha_{2} \in \mathbb{R}$ be defined by (see (2.3))

## 3. Approximate blow-up solution in rescaled variables

In the rest of this paper, $\delta \in(0,1)$ is a constant. For the sake of clarity, we also introduce the bootstrap constant

This constant will be taken large to close some bootstrap estimates by a continuity argument in the proof of Proposition 6.1.

Let $s_{0}>1$ be a constant to be chosen sufficiently large, possibly depending on $K$. Let $n \geq s_{0}$ be an integer. Throughout this paper, except in Section 7 the notation $a \lesssim b$ means that $a \leq C b$, where the constant $C>0$ is independent of $K$ and $n$.
3.1. Rescaled variables. Define

where $(\gamma, \lambda, b, a)$ are $\mathcal{C}^{1}$ functions of $s \in\left[s_{0}, S_{n}\right]$ satisfying the following bootstrap estimates, for any $s \in\left[s_{0}, S_{n}\right]$

where $\alpha_{1}$ is given by (2.7). It follows from (3.4) that

and

\vec{m}=\left(\begin{array}{l}
m_{\gamma}  \tag{3.12}\\
m_{\lambda} \\
m_{b} \\
m_{a}
\end{array}\right)
$$

We impose the following bootstrap estimates

Remark 3.1. The relations $m_{\gamma}=0, m_{\lambda}=0$ and $m_{b}=0$ give the standard approximate equations for the parameters $\gamma, \lambda$ and $b$ for the conformal blow-up. For example, for the minimal mass blow-up solution (1.3), one has

The function $\Omega$ allows us to keep track of some oscillatory terms in the behavior of $a_{s}$ that cannot be estimated in absolute value, but that can be easily integrated in time. This leads to a refined estimate of $a$ (see the last line of (3.4), which we use in the equation of $b$ (see the definition of $m_{b}$ ).
3.2. Definition of an approximate rescaled blow-up solution. First, let $\Theta_{0}$ : $\mathbb{R} \rightarrow[0,1]$ be an even smooth function with compact support such that

When $\Gamma$ is a function of $s$, we will write by abuse of notation

Now, we introduce

& B[\Gamma](y)=B_{1}[\Gamma](y)+B_{2}[\Gamma](y)=\lambda^{\frac{3}{2}} \psi_{1}(y) \sin \gamma-\lambda^{\frac{5}{2}} \psi_{2}(y) \cos \gamma
\end{aligned}

Recall that the functions $\varphi_{1}, \psi_{1} \in \mathcal{Z}_{1}$ are defined in Lemma 2.2 and the functions $\varphi_{2}, \psi_{2} \in \mathcal{Z}_{2}$ are defined in Lemma 2.3.

When $\Gamma$ is a function of $s$, we write by abuse of notation

Remark 3.2. The function $W$ is the main part of the approximate solution. It contains the modified bubble $Q_{a}$, multiplied by the quadratic phase $M_{-b}$. It also contains the term $\theta(A+i B)$ which will generate the expected blow-up profile at $x=0$. That term is not multiplied by $M_{-b}$ which is consistent with the result of convergence of the residual profile in [16].

We also introduce

where the functions $\nu_{1}$ and $\nu_{2}$ are explicitly defined as

Again, when $\Gamma$ is a function of $s$, we write by abuse of notation

Remark 3.3. The function $Z$ is a correction term in the approximate solution, to take into account error terms generated by $W$, as the nonlinear term $\nu_{2}$ for example.

Note that the expression of this correction term is simpler in the variable $(t, x)$. Setting

|W|+(1+|y|)\left|\partial_{y} W\right| & \lesssim e^{-\frac{|y|}{2}}+\delta s^{-\frac{1}{2}} \mathbf{1}_{I(s)},  \tag{3.23}\\
|Z|+(1+|y|)\left|\partial_{y} Z\right| & \lesssim \delta^{-1} s^{-\frac{3}{2}} \mathbf{1}_{J(s)}+s^{-\frac{9}{2}}\left(|y|^{3}+1\right) \mathbf{1}_{I(s)},  \tag{3.24}\\
\left|V-M_{-b} Q\right|+|V-Q|+||V|-Q| & \lesssim \delta s^{-\frac{1}{2}},  \tag{3.25}\\
|V|+(1+|y|)\left|\partial_{y} V\right| & \lesssim e^{-\frac{|y|}{2}}+\delta s^{-\frac{1}{2}} \mathbf{1}_{I(s)}, \tag{3.26}
\end{align*}
$$

Assuming in addition (3.13), it holds

$\left|\partial_{y}(\theta A)\right|+\left|\partial_{y}(\theta B)\right| \lesssim\left[s^{-\frac{3}{2}}+\delta^{-1} s^{-\frac{5}{2}}(1+|y|)+\delta^{-1} s^{-\frac{7}{2}}\left(1+y^{2}\right)\right] \mathbf{1}_{I(s)} \lesssim s^{-\frac{3}{2}} \mathbf{1}_{I(s)}$, which is (3.22). Now, the pointwise estimate (3.23) for $W$ follows directly from the expression of $W$, the definition of $Q$ in (1.2) and (3.21). Besides, (3.22) implies the pointwise estimate (3.23) for $(1+|y|)\left|\partial_{y} W\right|$.

Using (3.28)-(3.29), it is not difficult to estimate from (3.17) and (3.4),

Remark 3.4. In the expression (3.40), errors terms designated by $\mathcal{R}_{k}$ will be estimated directly in 3.7 while errors terms designated by $\mathcal{S}_{k}$ will be corrected by some terms from the equation of $Z$, before being estimated.

Note also that the contribution of $i \Omega \rho$ from the definition of $m_{a}$ has been split between $\mathcal{S}_{2}$ and $\mathcal{R}_{3}$ (with an error term $\mathcal{R}_{5}$ due to the quadratic phase and the localization $\theta$ ).

\left\|\mathcal{R}_{4}\right\|_{H^{1}}+\left\|y \mathcal{R}_{4}\right\|_{L^{2}} \lesssim s^{-5}
$$

and

\left|\left\langle M_{b} \mathcal{R}_{4}, i Q\right\rangle\right| \lesssim s^{-5}
$$

Besides, it is immediate by its definition that $\mathcal{R}_{4}[\Gamma]$ is a locally Lipschitz function of $\Gamma$ with values in $L_{y}^{2}$ and $\left\|\mathcal{R}_{4}[\Gamma]\right\|_{L^{2}} \rightarrow 0$ as $a \rightarrow 0$.

Estimates of $\mathcal{R}_{5}$. Since $\rho \in \mathcal{Y}$, using $|\Omega| \lesssim s^{-\frac{5}{2}}$ and (3.4) we have

Also, it is immediate by its definition that $\mathcal{R}_{5}[\Gamma]$ is a locally Lipschitz function of $\Gamma$ with values in $L_{y}^{2}$ and $\left\|\mathcal{R}_{5}[\Gamma]\right\|_{L^{2}} \rightarrow 0$ as $(\lambda, b) \rightarrow 0$.

Estimates of $\mathcal{R}_{6}$. It follows by easy calculations that

Thus, it is immediate that $\mathcal{R}_{6}[\Gamma]$ is a locally Lipschitz function of $\Gamma$ with values in $L_{y}^{2}$ and $\left\|\mathcal{R}_{6}[\Gamma]\right\|_{L^{2}} \rightarrow 0$ as $\left(\lambda, j_{1}, j_{2}, j_{3}\right) \rightarrow 0$.

Estimates of $\mathcal{R}_{7}$. By change of variable, $x=\lambda y$, the error term $\mathcal{R}_{7}$ satisfies

Therefore, Proposition 3.2 is proved.

## 4. Modulation around the approximate blow-up solution

4.1. Decomposition by modulation of the parameters. We recall that given $T \in \mathbb{R}$ and an initial data $u_{T} \in H^{3} \cap \Sigma$ such that $\partial_{x} u_{T} \in \Sigma$, there exists a solution $u$ of (1.1) defined on some interval $I \ni T$ with $u(T)=u_{T}$, in the same regularity class, i.e. $u \in \mathcal{C}\left(I, H^{3} \cap \Sigma\right), \partial_{x} u \in \mathcal{C}(I, \Sigma), u \in \mathcal{C}^{1}\left(I, H^{1}\right)$. This follows from standard arguments, see e.g. [2] Proof of Lemma 5.6.2].

We look for a decomposition of $u$ on $I$ of the form

where $V$ is defined in (3.18), $S>0$ and $(\gamma, \lambda, b, a)$ are $\mathcal{C}^{1}$ parameters such that

Remark 4.1. The choice of orthogonality relations (4.2) is standard and corresponds to observations in [24] and 21].

Using (1.14) and (3.35) with $\vec{m}$ defined in (3.12), we see that $\varepsilon$ and $(\gamma, \lambda, b, a)$ satisfy

From its definition, it is easy to check that $V \in \mathcal{C}\left(H^{3} \cap \Sigma\right), \partial_{x} V \in \mathcal{C}(\Sigma), V \in \mathcal{C}^{1}\left(H^{1}\right)$. Thus, by formula (4.1), $\varepsilon \in \mathcal{C}\left(H^{3} \cap \Sigma\right)$, $\partial_{x} \varepsilon \in \mathcal{C}(\Sigma), \varepsilon \in \mathcal{C}^{1}\left(H^{1}\right)$, and the above equation makes sense in $L^{2}$ and in $H_{\text {loc }}^{1}$.
4.2. Bootstrap assumption. The estimates of Section 3 on the approximate solution $V$, given in Lemma 3.1 and Proposition 3.2 were established assuming the bootstrap estimates (3.4) and (3.13). Bootstrap estimates on the function $\varepsilon$ will also be necessary. Below, we recapitulate all the bootstrap estimates to be used later

Note that (4.4) implies (3.4) and (3.13) for $s$ large. The more refined estimates for $b$ and $a$ are needed to close the estimates of those parameters in Section 6.
4.3. Modulation equations. For $g \in H^{1}$, we will use the notation

First, we observe that since $u \in \mathcal{C}_{t}^{1}\left(H_{x}^{-1}\right)$, for any $\Phi \in H^{1}$, the map $j_{1} \mapsto$ $\int u\left[j_{1}\right](x) \Phi(x) d x$ is locally Lipschitz. Second, since $V$ and $\partial_{y} V$ are bounded (see (3.26)), for any $\Phi \in H^{1}$, the map $\lambda \mapsto \int \Phi(x) V_{1}[\Gamma]\left(\frac{x}{\lambda}\right) k\left(\frac{x}{\lambda}\right)$ is locally Lipschitz and similarly for $V_{2}$. It follows that $\mathcal{M}$ is locally Lipschitz. Since $p_{1}^{\prime}, p_{2}^{\prime}, q_{1}^{\prime}, q_{2}^{\prime}$ are arbitrary, the result follows by using (4.5).

Let $g, h \in \mathcal{Y}$ be time-independent functions and let

where $\vec{\rho}_{\mathcal{I}}(s)=\rho_{\mathcal{I}}[\Gamma(s)], \mathcal{R}_{\mathcal{I}}(s)=\mathcal{R}_{\mathcal{I}}[\Gamma(s)]$ are Lipschitz functions of $\Gamma$ converging to 0 as $\left(\lambda, b, a, j_{1}, j_{2}, j_{3}\right) \rightarrow 0$ and $d(u[\Gamma] ; \Gamma) \rightarrow 0$.

Moreover, assuming (4.4),

& -4 \lambda^{\frac{3}{2}}\left[\left\langle\varepsilon_{1}, Q^{3} \psi_{1} g\right\rangle \sin \gamma+\left\langle\varepsilon_{2}, Q^{3} \varphi_{1} g\right\rangle \cos \gamma\right]  \tag{4.8}\\
& -m_{\gamma}\langle Q, h\rangle+\frac{1}{4}\left(m_{b}-2 b m_{\lambda}\right)\left\langle y^{2} Q, h\right\rangle-m_{a}\langle\rho, g\rangle+m_{\lambda}\langle\Lambda Q, g\rangle \\

The estimates in Lemma 4.2 allow us to improve the estimates in (4.4) related to the equations satisfied by the parameters. Recall that $m_{\gamma}, m_{\lambda}, m_{b}$ and $m_{a}$ are defined in (3.11). We also prove a refined estimate on $m_{a}=a_{s}-\Omega$ (see Remarks 3.1 and (4.2).

Remark 4.2. The terms in $\varepsilon_{1}$ and $\varepsilon_{2}$ in the right-hand side of 4.20) are of size $O\left(K^{\frac{1}{4}} S^{-\frac{7}{2}}\right)$, in particular time integration does not improve the estimate of $a$ in (4.4). Therefore, we need to introduce another functional $\mathcal{J}$ in order to control these terms at this order of $s^{-1}$.

We introduce some notation. Since $Q^{4} \varphi_{1} \in \mathcal{Y}$ and $Q^{4} \psi_{1} \in \mathcal{Y}$, it follows from Lemma 2.2 (iii) that there exists a unique pair of even functions $\left(\varphi_{0}, \psi_{0}\right) \in \mathcal{Z}_{0}^{2}$ such that

& -\int \Im S_{0} \psi_{0} \widetilde{\Theta}_{1}-\int \Im \mathcal{R} \psi_{0} \widetilde{\Theta}_{1}+\frac{1}{2} \int \varepsilon_{1} \frac{\lambda_{s}}{\lambda} \psi_{0} \widetilde{\Theta}_{2}+\int \gamma_{s} \varepsilon_{2} \varphi_{0} \widetilde{\Theta}_{1}

## 5. Energy estimates

Consider a solution $u$ of (1.1) as in Section 4.1, with $T=T_{n}=-\frac{1}{n}$ as defined in (3.2) and $S=S_{n}=n$. Assume that $u$ can be decomposed as in Section 4 and that the bootstrap estimates (4.4) hold for $s \leq S_{n}$ close to $S_{n}$. In particular (3.4) and (3.13) also hold, hence the estimates deduced in Lemma 3.1 and Proposition 3.2 apply to the solution $u$. In this section, we derive energy estimates in the original variables $(t, x)$ rather than the rescaled variables $(s, y)$. The main reason is the simplicity of equation (5.4) below, compared to (4.3) which involves the operator $\Lambda$. However, we will sometimes reintroduce the notation $\varepsilon$ to take advantage of the spectral properties of the operators $L_{ \pm}$and of the related orthogonality conditions (4.2); see Lemma 2.1.

We let

\mathcal{K} & =\Im \int x\left(\partial_{x} \eta\right) \bar{\eta}
\end{aligned}
$$

and

\mathcal{G}=\lambda^{2} \mathcal{H}+b \mathcal{K}+\frac{1}{4} \frac{b^{2}}{\lambda^{2}} \mathcal{N}
$$

First, we provide direct upper bounds and coercivity estimates on the quantities $\mathcal{N}, \mathcal{H}$ and $\mathcal{K}$. Second, we give estimates on the time derivatives of these quantities using (5.4).

by (4.2), we deduce, following the proof of (5.11), that

-2 \Re \int x \partial_{x} \bar{\eta}[f(v+\eta) & -f(v)]=2 \Re \int[F(v+\eta)-F(v)-f(v) \bar{\eta}] \\
& +\Re \int[2 \Lambda \bar{v}-\bar{v}]\left[f(v+\eta)-f(v)-3|v|^{4} \eta-2|v|^{2} v^{2} \bar{\eta}\right]
\end{aligned}
$$

Thus we see that

$$
\begin{aligned}
-2 \Re \int \Lambda \bar{\eta}[f(v+\eta)-f(v)]= & -\Re \int \bar{\eta}[f(v+\eta)-f(v)] \\
& +2 \Re \int[F(v+\eta)-F(v)-f(v) \bar{\eta}] \\
& -\Re \int \bar{v}\left[f(v+\eta)-f(v)-3|v|^{4} \eta-2|v|^{2} v^{2} \bar{\eta}\right] \\
& +2 \Re \int \Lambda \bar{v}\left[f(v+\eta)-f(v)-3|v|^{4} \eta-2|v|^{2} v^{2} \bar{\eta}\right]
\end{aligned}
$$

which we rewrite in the form

$$
\begin{aligned}
-2 \Re \int \Lambda \bar{\eta}[f(v+\eta)-f(v)] & =-4 \Re \int[F(v+\eta)-F(v)-f(v) \bar{\eta}] \\
& +2 \Re \int \Lambda \bar{v}\left[f(v+\eta)-f(v)-3|v|^{4} \eta-2|v|^{2} v^{2} \bar{\eta}\right] .
\end{aligned}
$$

Thus we arrive at the expression

\begin{aligned}
\frac{d}{d t} \mathcal{K}= & 2 \int\left|\partial_{x} \eta\right|^{2}-4 \Re \int[F(v+\eta)-F(v)-f(v) \bar{\eta}] \\
& +2 \Re \int \Lambda \bar{v}\left[f(v+\eta)-f(v)-3|v|^{4} \eta-2|v|^{2} v^{2} \bar{\eta}\right] \\
& +2 \Re \int \bar{\eta} \Lambda \mathcal{Q}_{0}+2 \Re \int \bar{\eta} \Lambda \mathcal{P} .
\end{aligned}
$$

On the other hand, using (5.6), (5.7) and (5.8), we obtain by the Cauchy-Schwarz inequality

2 \Re \int \bar{\eta} \Lambda \mathcal{Q}_{0}+2 \Re \int \bar{\eta} \Lambda \mathcal{P}=O\left(K^{\frac{1}{4}}|t|^{2}\right)
$$

which completes the proof.
End of the proof of Proposition 5.2. The estimate (5.14) is a consequence of (5.17) and the estimate (5.15) is already proved in (5.19).

We finally prove (5.16). By the expression of $\mathcal{G}=\lambda^{2} \mathcal{H}+b \mathcal{K}+\frac{1}{4} \frac{b^{2}}{\lambda^{2}} \mathcal{N}, d t=\lambda^{2} d s$, and the definitions of $m_{\lambda}$ and $m_{b}$, we have

\frac{d \mathcal{G}}{d t}= & \lambda^{2} \frac{d \mathcal{H}}{d t}+b \frac{d \mathcal{K}}{d t}+\frac{1}{4} \frac{b^{2}}{\lambda^{2}} \frac{d \mathcal{N}}{d t}-2 b \mathcal{H}-\frac{b^{2}}{\lambda^{2}} \mathcal{K} \\
& +2 m_{\lambda} \mathcal{H}+\frac{m_{b}+a}{\lambda^{2}} \mathcal{K}+\frac{1}{2} \frac{1}{\lambda^{2}}\left(\frac{a}{\lambda}+\frac{m_{b}}{\lambda}-m_{\lambda} \frac{b}{\lambda}\right) \frac{b}{\lambda} \mathcal{N}
\end{aligned}
$$

where the last term comes from the identity

$$
\begin{equation*}
\frac{d}{d s}\left(\frac{b}{\lambda}\right)=\frac{b_{s}-\frac{\lambda_{s}}{\lambda} b}{\lambda}=\frac{a}{\lambda}+\frac{m_{b}}{\lambda}-m_{\lambda} \frac{b}{\lambda}, \tag{5.25}
\end{equation*}
$$

see (3.11). Combining (5.17), (5.18), (5.20) with the expressions of $\mathcal{H}$ and $\mathcal{K}$, the resulting cancellations imply that

\lambda^{2} \frac{d \mathcal{H}}{d t}+b \frac{d \mathcal{K}}{d t}+\frac{1}{4} \frac{b^{2}}{\lambda^{2}} \frac{d \mathcal{N}}{d t}-2 b \mathcal{H}-\frac{b^{2}}{\lambda^{2}} \mathcal{K}=0+O\left(K^{\frac{1}{4}}|t|^{3}\right) .
$$

By (5.10) and (4.18),

$$
\left|m_{\lambda}\right||\mathcal{H}|+\left|\frac{m_{b}}{\lambda^{2}}\right||\mathcal{K}| \lesssim K^{\frac{1}{2}}|t|^{4}
$$

and

$$
\left|\frac{a}{\lambda^{2}} \mathcal{K}\right|+\frac{1}{\lambda^{2}}\left|\frac{a}{\lambda}+\frac{m_{b}}{\lambda}-m_{\lambda} \frac{b}{\lambda}\right|\left|\frac{b}{\lambda}\right||\mathcal{N}| \lesssim K^{\frac{1}{2}}|t|^{\frac{7}{2}} .
$$

Thus, we obtain (5.16).

## 6. Proof of the uniform estimates

We consider $n \geq s_{0}$, where $s_{0}$ will be chosen sufficiently large later. Recall from (3.2) that $T_{n}=-\frac{1}{n}$ and $S_{n}=n$. For $\beta \in(-1,1)$, we set

& \lambda_{n}^{i n}=b_{n}^{i n}=n^{-1}-\alpha_{1} n^{-\frac{5}{2}} \cos n+\beta n^{-\frac{7}{4}}  \tag{6.1}\\
& \Gamma_{n}^{i n}=\left(\gamma_{n}^{i n}, \lambda_{n}^{i n}, b^{i n}, a_{n}^{i n}, 0,0,0\right),
\end{align*}
$$

and

$$
\begin{equation*}
u_{n}^{i n}(x)=\lambda_{n}^{-\frac{1}{2}} e^{i \gamma_{n}} V\left[\Gamma_{n}^{i n}\right](y), \quad y=\frac{x}{\lambda_{n}} \tag{6.2}
\end{equation*}
$$

where $V\left[\Gamma_{n}^{i n}\right]$ is the blow-up approximate solution defined in (3.18) with the parameter $\Gamma_{n}^{i n}$ defined in (6.1) (recall that $V$ depends on the constant $\delta=K^{-2}$ ). We consider the solution $u_{n}$ of (1.1) with initial data $u_{n}\left(T_{n}\right)=u_{n}^{i n}$. Using Lemma 4.3 with $u(t, x)=u_{n}\left(T_{n}+t, x\right)$ and $S=S_{n}$, there exist a time $\bar{s}_{n}<S_{n}$ and a $\mathcal{C}^{1}$ function $\Gamma$ such that $u_{n}$ decomposes as in (4.1) with (4.17). Since $\varepsilon_{n}\left(S_{n}\right)=\varepsilon_{n}^{i n}=0$, integrating the first four equations in (4.17), we obtain the orthogonality relations (4.2). Note that the bootstrap estimate (4.4) is satisfied with strict inequalities at $s=S_{n}$ (for $n$ large) and thus by continuity, it is also satisfied on $\left[\bar{s}_{n}, S_{n}\right]$ after possibly increasing $\bar{s}_{n}<S_{n}$. Note that there exists $\tau_{K}$ large depending only on $K$ such that if (4.4) is satisfied on a time interval $\left[\tau, S_{n}\right]$, for $\tau_{K}<\tau<S_{n}$, then the asssumption

\left|\left(\lambda(s), b(s), a(s), j_{1}(s), j_{2}(s), j_{3}(s)\right)\right|+\left|d\left(u_{n}[\Gamma(s)] ; \Gamma(s)\right)\right|<\omega
$$

of Lemma 4.3 is satisfied for all $s \in\left[\tau, S_{n}\right]$ so that the decomposition can be extended to $\left[\tau^{\prime}, S_{n}\right]$ for some $\tau_{K}<\tau^{\prime}<\tau$. Thus, assuming $s_{0} \geq \tau_{K}$, we may define

s_{*}=s_{*}(\beta, n)=\inf \left\{s \in\left[s_{0}, S_{n}\right]: \text { (4.4) holds for } u_{n} \text { on }\left[s, S_{n}\right]\right\}
$$

In particular, possibly taking $s_{0}$ larger, depending on $K$, we may apply the estimates proved in Sections 34 and 5 to the solution $u_{n}$ on the rescaled time interval $\left[s_{*}, S_{n}\right.$ ]

The next proposition, which is the main result of this section, shows that for $K$ large, there exists at least a value of $\beta=\beta_{n}$ such that (4.4) holds on $\left[s_{0}, S_{n}\right]$ where $s_{0}$ is independent of $n$.

Proposition 6.1. For all sufficiently large $K$, there exists $s_{0} \geq \tau_{K}$ such that for all $n>s_{0}$, it holds $s_{*}\left(\beta_{n}, n\right)=s_{0}$ for some $\beta_{n} \in(-1,1)$.

The rest of this section is devoted to the proof of Proposition6.1. Recall that the estimate of $\vec{m}$ in (4.4) was strictly improved for $K$ large by Lemma 4.4 In Section 6.1, we improve the bootstrap estimate of $\varepsilon$ in (4.4). In Section 6.2, we improve the bootstrap estimates of $\gamma, a$ and $\frac{b}{\lambda}$ in (4.4). Last, in Section 6.3, we prove by a contradiction argument that there exists at least one value of $\beta \in(-1,1)$ such that $s_{*}(\beta, n)=s_{0}$.
6.1. Closing the bootstrap estimates on the error term. In this subsection, we prove the following result.

Lemma 6.2. For all $s \in\left[s_{*}, S_{n}\right]$,

$$
\begin{align*}
\|\varepsilon(s)\|_{H^{1}} & \lesssim K^{\frac{1}{8}} s^{-2} \\
\|y \varepsilon(s)\|_{L^{2}} & \lesssim K^{\frac{3}{16}} s^{-1} \tag{6.3}
\end{align*}
$$

Proof. Define $t_{*}<0$ such that $T_{n}-t_{*}=\int_{s_{*}}^{S_{n}} \lambda^{2}$. Let $t \in\left[t_{*}, T_{n}\right]$. Integrating (5.16) on $\left[t, T_{n}\right]$, using $\mathcal{G}\left(T_{n}\right)=0$, we obtain

|\mathcal{G}(t)| \lesssim K^{\frac{1}{4}}|t|^{4}
$$

Thus, by (5.12),

$$
\|\eta(t)\|_{L^{2}}^{2} \lesssim \mathcal{G}(t) \lesssim K^{\frac{1}{4}}|t|^{4}
$$

Inserting this estimate in (5.15), we obtain

\left|\frac{d}{d t} \mathcal{H}(t)\right| \lesssim K^{\frac{1}{4}}|t|
$$

Integrating the latter estimate on $\left[t, T_{n}\right]$, using $\mathcal{H}\left(T_{n}\right)=0$, we obtain

$$
|\mathcal{H}(t)| \lesssim K^{\frac{1}{4}}|t|^{2} .
$$

By (5.11), this gives

$$
\left\|\partial_{x} \eta(t)\right\|_{L^{2}}^{2} \lesssim K^{\frac{1}{4}}|t|^{2}
$$

Thus, by change of variable $\|\varepsilon(s)\|_{H^{1}} \lesssim K^{\frac{1}{8}} s^{-2}$ on $\left[s_{*}, S_{n}\right]$. We continue using (5.14), the above estimate and (5.6) for $\|x \eta\|_{L^{2}}$,

$$
\left|\frac{d}{d t} \mathcal{N}\right| \lesssim\left\|\partial_{x} \eta\right\|_{L^{2}}\|x \eta\|_{L^{2}}+K^{\frac{1}{4}}|t|^{3} \lesssim K^{\frac{3}{8}}|t|^{3}
$$

Integrating this estimate on $\left[t, T_{n}\right]$, using $\mathcal{N}\left(T_{n}\right)=0$, we obtain

\mathcal{N}(t)=\|x \eta(t)\|_{L^{2}}^{2} \lesssim K^{\frac{3}{8}}|t|^{4} .
$$

The proof of the lemma is complete.

### 6.2. Closing the parameter estimates.

Lemma 6.3. For all $s \in\left[s_{*}, S_{n}\right]$,

\left\{\begin{align*}
|\gamma(s)-s| & \lesssim s^{-2}  \tag{6.4}\\
\left|a(s)-\alpha_{1} s^{-\frac{5}{2}} \sin \gamma(s)\right| & \lesssim K^{\frac{1}{2}} s^{-3} \\
\left|\frac{b(s)}{\lambda(s)}-1\right| & \lesssim K^{\frac{1}{2}} s^{-1}
\end{align*}\right.
$$

Proof. Integrating on $\left[s, S_{n}\right]$ the estimate $\left|\gamma_{s}-1\right| \lesssim s^{-3}$ in (4.18) and using $\gamma_{n}^{i n}=$ $n=S_{n}$, we obtain

|\gamma(s)-s| \lesssim s^{-2}
$$

which is the estimate for $\gamma$ in (6.4).
Now, by (4.31), we have

\frac{d}{d s}\left[a+\alpha_{5} \lambda^{\frac{3}{2}} \mathcal{J}\right]=\Omega+O\left(K^{\frac{1}{2}} s^{-4}\right)
$$

Integrating, using $\mathcal{J}\left(S_{n}\right)=0$, then (4.28),

$$
\begin{equation*}
\left|a\left(S_{n}\right)-a(s)-\int_{s}^{S_{n}} \Omega\right| \lesssim \lambda^{\frac{3}{2}}|\mathcal{J}(s)|+K^{\frac{1}{2}} s^{-3} \lesssim K^{\frac{1}{2}} s^{-3} \tag{6.5}
\end{equation*}
$$

We now calculate $\int \Omega$ using the definition of $\Omega$ in (3.9). First, by $1=\gamma_{s}-m_{\gamma}$

$$
\begin{aligned}
\int_{s}^{S_{n}} b \lambda^{\frac{3}{2}} \cos \gamma & =-\int_{s}^{S_{n}} m_{\gamma} b \lambda^{\frac{3}{2}} \cos \gamma+\int_{s}^{S_{n}} b \lambda^{\frac{3}{2}} \frac{d}{d s} \sin \gamma \\
& =O\left(s^{-\frac{9}{2}}\right)+\int_{s}^{S_{n}} b \lambda^{\frac{3}{2}} \frac{d}{d s} \sin \gamma
\end{aligned}
$$

Next,

$$
\int_{s}^{S_{n}} b \lambda^{\frac{3}{2}} \frac{d}{d s} \sin \gamma=\left[b \lambda^{\frac{3}{2}} \sin \gamma\right]\left(S_{n}\right)-\left[b \lambda^{\frac{3}{2}} \sin \gamma\right](s)-\int_{s}^{S_{n}} \frac{d}{d s}\left(b \lambda^{\frac{3}{2}}\right) \sin \gamma
$$

then, using (4.18) and (4.4) (in particular, $|a| \lesssim s^{-\frac{5}{2}}$ )

$$
\begin{aligned}
\int_{s}^{S_{n}} \frac{d}{d s}\left(b \lambda^{\frac{3}{2}}\right) \sin \gamma & =-\frac{5}{2} \int_{s}^{S_{n}} b^{2} \lambda^{\frac{3}{2}} \sin \gamma+\int_{s}^{S_{n}} \lambda^{\frac{3}{2}}\left(a+m_{b}+\frac{3}{2} b m_{\lambda}\right) \sin \gamma \\
& =-\frac{5}{2} \int_{s}^{S_{n}} b^{2} \lambda^{\frac{3}{2}} \sin \gamma+O\left(s^{-3}\right)
\end{aligned}
$$

We integrate by parts again

$$
\begin{aligned}
\int_{s}^{S_{n}} b^{2} \lambda^{\frac{3}{2}} \sin \gamma & =-\int_{s}^{S_{n}} m_{\gamma} b^{2} \lambda^{\frac{3}{2}} \sin \gamma-\int_{s}^{S_{n}} b^{2} \lambda^{\frac{3}{2}} \frac{d}{d s} \cos \gamma \\
& =O\left(s^{-\frac{11}{2}}\right)-\int_{s}^{S_{n}} b^{2} \lambda^{\frac{3}{2}} \frac{d}{d s} \cos \gamma
\end{aligned}
$$

Next,

$$
\begin{aligned}
\int_{s}^{S_{n}} b^{2} \lambda^{\frac{3}{2}} \frac{d}{d s} \cos \gamma & =\left[b^{2} \lambda^{\frac{3}{2}} \cos \gamma\right]\left(S_{n}\right)-\left[b^{2} \lambda^{\frac{3}{2}} \cos \gamma\right](s)-\int_{s}^{S_{n}} \frac{d}{d s}\left(b^{2} \lambda^{\frac{3}{2}}\right) \cos \gamma \\
& =O\left(s^{-\frac{7}{2}}\right)-\int_{s}^{S_{n}} \frac{d}{d s}\left(b^{2} \lambda^{\frac{3}{2}}\right) \cos \gamma
\end{aligned}
$$

then, using (4.4) and (4.18)

$$
\begin{aligned}
\int_{s}^{S_{n}} \frac{d}{d s}\left(b^{2} \lambda^{\frac{3}{2}}\right) \cos \gamma & =-\frac{7}{2} \int_{s}^{S_{n}} b^{3} \lambda^{\frac{3}{2}} \cos \gamma+\int_{s}^{S_{n}} b \lambda^{\frac{3}{2}}\left(2 a+2 m_{b}+\frac{3}{2} b m_{\lambda}\right) \cos \gamma \\
& =O\left(s^{-\frac{7}{2}}\right)
\end{aligned}
$$

Collecting the above identities, we obtain

$$
\int_{s}^{S_{n}} b \lambda^{\frac{3}{2}} \cos \gamma=\left[b \lambda^{\frac{3}{2}} \sin \gamma\right]\left(S_{n}\right)-\left[b \lambda^{\frac{3}{2}} \sin \gamma\right](s)+O\left(s^{-3}\right)
$$

The other three terms in (3.9) can also be calculated by integration by parts (once only) and they are all $O\left(s^{-3}\right)$. Hence, in the end we obtain

\begin{aligned}
\int_{s}^{S_{n}} \Omega & =\alpha_{1}\left[b \lambda^{\frac{3}{2}} \sin \gamma\right]\left(S_{n}\right)-\alpha_{1}\left[b \lambda^{\frac{3}{2}} \sin \gamma\right](s)+O\left(s^{-3}\right) \\
& =\alpha_{1} S_{n}^{-\frac{5}{2}} \sin \gamma\left(S_{n}\right)-\alpha_{1} s^{-\frac{5}{2}} \sin \gamma(s)+O\left(s^{-3}\right)
\end{aligned}
$$

where we used (4.4) in the last line. Using now

$$
a\left(S_{n}\right)=\alpha_{1} S_{n}^{-\frac{5}{2}} \sin \gamma\left(S_{n}\right)
$$

as specified in (6.1), we finally obtain from (6.5),

$$
\begin{equation*}
\left|a(s)-\alpha_{1} s^{-\frac{5}{2}} \sin \gamma(s)\right| \lesssim K^{\frac{1}{2}} s^{-3}, \tag{6.6}
\end{equation*}
$$

which is the desired estimate related to $a$ in (6.4).
Last, we observe that by the calculation (5.25) and (4.18)

\frac{d}{d s}\left(\frac{b}{\lambda}\right)=\frac{a}{\lambda}+O\left(s^{-2}\right)
$$

so that using (6.6)

\left|\frac{d}{d s}\left(\frac{b}{\lambda}\right)-\alpha_{1} s^{-\frac{3}{2}} \sin \gamma\right| \lesssim K^{\frac{1}{2}} s^{-2}
$$

Integrating on $\left[s, S_{n}\right]$ and using $\lambda\left(S_{n}\right)=b\left(S_{n}\right)$ from (6.1), we obtain

$$
\left|\frac{b(s)}{\lambda(s)}-1\right| \lesssim K^{\frac{1}{2}} s^{-1}+\left|\int_{s}^{S_{n}}\left(s^{\prime}\right)^{-\frac{3}{2}} \sin \gamma\left(s^{\prime}\right)\right|
$$

We observe that, using $1=\gamma_{s}-m_{\gamma}$ and then integrating by parts

$$
\begin{aligned}
\int_{s}^{S_{n}}\left(s^{\prime}\right)^{-\frac{3}{2}} \sin \gamma\left(s^{\prime}\right) d s^{\prime}= & -\int_{s}^{S_{n}} m_{\gamma}\left(s^{\prime}\right)^{-\frac{3}{2}} \sin \gamma\left(s^{\prime}\right) d s^{\prime} \\
& +\int_{s}^{S_{n}}\left(s^{\prime}\right)^{-\frac{3}{2}} \gamma_{s}\left(s^{\prime}\right) \sin \gamma\left(s^{\prime}\right) d s^{\prime} \\
= & -\int_{s}^{S_{n}} m_{\gamma}\left(s^{\prime}\right)^{-\frac{3}{2}} \sin \gamma\left(s^{\prime}\right) d s^{\prime}-\frac{3}{2} \int_{s}^{S_{n}}\left(s^{\prime}\right)^{-\frac{5}{2}} \cos \gamma\left(s^{\prime}\right) d s^{\prime} \\
& -S_{n}^{-\frac{3}{2}} \cos \gamma\left(S_{n}\right)+s^{-\frac{3}{2}} \cos \gamma(s)
\end{aligned}
$$

and so, applying (4.18)

$$
\begin{equation*}
\left|\int_{s}^{S_{n}}\left(s^{\prime}\right)^{-\frac{3}{2}} \sin \gamma\left(s^{\prime}\right) d s^{\prime}\right| \lesssim s^{-\frac{3}{2}} \tag{6.7}
\end{equation*}
$$

Thus, we have proved

$$
\left|\frac{b(s)}{\lambda(s)}-1\right| \lesssim K^{\frac{1}{2}} s^{-1}
$$

which is the estimate related to $\frac{b}{\lambda}$ in (6.4).
Using Lemmas 4.46 .2 and 6.3 , we see that if $K$ is sufficiently large (independent of $n$ ), then on $\left[s_{*}, S_{n}\right]$,

|\gamma(s)-s| & \leq \frac{1}{2} s^{-\frac{7}{4}}  \tag{6.8}\\
\left|\frac{b(s)}{\lambda(s)}-1\right| & \leq \frac{1}{2} K s^{-1} \\
\left|a(s)-\alpha_{1} s^{-\frac{5}{2}} \sin \gamma(s)\right| & \leq \frac{1}{2} K s^{-3} \\
|\vec{m}(s)| & \leq \frac{1}{2} K s^{-3} \\
\|\varepsilon(s)\|_{H^{1}} & \leq \frac{1}{2} K^{\frac{1}{4}} s^{-2} \\
\|y \varepsilon(s)\|_{L^{2}} & \leq \frac{1}{2} K^{\frac{1}{4}} s^{-1}
\end{align*}\right.
$$

which means that all the estimates in (4.4) are strictly improved except the estimate of $b$. We now consider a value of $K$ sufficiently large so that (6.8) holds on $\left[s_{*}, S_{n}\right]$.
6.3. Closing the bootstrap by a contradiction argument. Closing the estimate of $b$ in (4.4) requires a specific contradiction argument related to the choice of the free parameter $\beta \in(-1,1)$.

We set

$$
g(s)=g_{\beta}(s)=s^{\frac{7}{4}}\left(b(s)-s^{-1}+\alpha_{1} s^{-\frac{5}{2}} \cos \gamma(s)\right)
$$

so that

|g(s)| \leq 1 \Longleftrightarrow\left|b(s)-s^{-1}+\alpha_{1} s^{-\frac{5}{2}} \cos \gamma(s)\right| \leq s^{-\frac{7}{4}}
$$

Hence, by (6.1) and (4.4),

g\left(S_{n}\right)=\beta \quad \text { and } \quad|g(s)| \leq 1
$$

Using (4.18) and the estimate on $a$ in (4.4), we have

$$
b_{s}+b^{2}-\alpha_{1} s^{-\frac{5}{2}} \sin \gamma=m_{b}+a-\alpha_{1} s^{-\frac{5}{2}} \sin \gamma=O\left(K s^{-3}\right)
$$

Thus, by direct computation, and (4.4)

$$
\begin{aligned}
g_{s} & =\frac{7}{4} s^{-1} g+s^{\frac{7}{4}}\left(-b^{2}+s^{-2}-\alpha_{1} m_{\gamma} s^{-\frac{5}{2}} \sin \gamma-\frac{5}{2} \alpha_{1} s^{-\frac{7}{2}} \cos \gamma+O\left(K s^{-3}\right)\right) \\
& =-\frac{g}{4 s}+O\left(K s^{-\frac{5}{4}}\right)
\end{aligned}
$$

where we have used, by (4.4),

$$
s^{\frac{7}{4}}\left(-b^{2}+s^{-2}\right)=-s^{\frac{7}{4}}\left(b+s^{-1}\right)\left(b-s^{-1}\right)=-\frac{2}{s} g+O\left(s^{-\frac{7}{4}}\right) .
$$

This estimate implies the following properties, for $s$ large,

$$
\begin{equation*}
g(s)=1 \Longrightarrow g_{s}(s)<0 \quad \text { and } \quad g(s)=-1 \Longrightarrow g_{s}(s)>0 . \tag{6.9}
\end{equation*}
$$

Here, $s_{0}$ large is fixed so that all the previous estimates hold, and we work for any $n>s_{0}$. For the sake of contradiction, assume that for any $\beta \in(-1,1)$, $s_{*}(\beta, n)=s_{*}(\beta)>s_{0}$. We claim now that

$$
\left|g\left(s_{*}(\beta)\right)\right|=1
$$

Indeed, if $\left|g\left(s_{*}(\beta)\right)\right|<1$, then by (6.8), the bootstrap estimate (4.4) is satisfied with strict inequalities at $s=s_{*}$, which is a contradiction with the definition of $s_{*}$ by continuity. By (6.9), the map $s_{*}$ is continuous on $(-1,1)$. We deduce that the map

$$
g \circ s_{*}: \beta \in(-1,1) \mapsto g \circ s_{*}(\beta) \in\{-1,1\}
$$

is continuous. Moreover, from (6.9), for $\beta$ close to $1, g\left(s_{*}(\beta)\right)=1$ and for $\beta$ close to $-1, g\left(s_{*}(\beta)\right)=-1$. Thus,

$$
g \circ s_{*}((-1,1))=\{-1,1\},
$$

which is a contradiction since $(-1,1)$ is connected. Therefore, for any $n$ large, there exists $\beta_{n} \in(-1,1)$ such that for any $s \in\left[s_{0}, S_{n}\right],|g(s)|<1$, which completes the proof of Proposition 6.1.

## 7. Proof of the main result

Let

$$
\begin{equation*}
r_{*}(x)=\Theta(x)\left(|x|+i \kappa|x|^{2}\right) . \tag{7.1}
\end{equation*}
$$

It follows that $r_{*}(x)=|x|+i \kappa|x|^{2}$ on $(-\delta, \delta)$ and $\left\|r_{*}\right\|_{L^{2}} \leq C \delta^{\frac{3}{2}}$, for some constant independent of $\delta$. In this section, we consider $K$ sufficiently large to satisfy the assumptions of Proposition 6.1. This corresponds to choosing $\delta>0$ sufficiently small.

In the rest of this section, the implicit constants in inequalities may depend on $\delta$, but are independent of $n$.
7.1. Construction of a sequence of solutions. In the next proposition, we construct a sequence of solutions $\left(u_{n}\right)$ of (1.1), defined on $\left[t_{1}, T_{n}\right]$, where $t_{1}<0$ is independent of $n$, satisfying uniform estimates related to the blow-up behavior expected in Theorem 1
Proposition 7.1. There exists $t_{1}<0$ such that, for all $n>1$ large, there exists $\beta_{n} \in(-1,1)$ with the following property. If $u_{n}$ be the solution of (1.1) such that $u_{n}\left(T_{n}\right)=u_{n}^{i n}$, where $u_{n}^{i n}$ is defined in (6.1)-(6.2), then $u_{n}$ exists on $\left[t_{1}, T_{n}\right]$ and satisfies the following uniform estimates

$$
\begin{align*}
\left\|u_{n}(t)-\frac{e^{\frac{i}{t}}}{|t|^{\frac{1}{2}}} Q\left(\frac{\cdot}{t}\right)-r_{*}\right\|_{L^{2}} & \lesssim|t|^{\frac{3}{4}}  \tag{7.2}\\
\left\|u_{n}(t)\right\|_{H^{1}} & \lesssim|t|^{-1}  \tag{7.3}\\
\left\|x u_{n}(t)\right\|_{L^{2}} & \lesssim 1 . \tag{7.4}
\end{align*}
$$

Remark 7.1. We observe by change of variable that

$$
\lim _{t \uparrow 0}\left\{S(t)-\frac{e^{\frac{i}{t}}}{|t|^{\frac{1}{2}}} Q\left(\frac{x}{t}\right)\right\}=0 \quad \text { in } L^{2}(\mathbb{R})
$$

where $S$ is defined in (1.3), which justifies the equality of the limits in (1.10).
Proof. We use Proposition 6.1] passing from the variable $(s, y)$ to the variable $(t, x)$, and using (4.4). Let $t_{0}=t_{0}(n)$ be defined by $T_{n}-t_{0}=j_{1}\left(s_{0}\right)$. By (3.8), we have the estimate $\left|t_{0}\right| \gtrsim s_{0}^{-1}$, and so there exists $t_{1}$ independent of $n$ such that $t_{0}(n) \leq t_{1}<0$. We now consider any $t \in\left[t_{1}, T_{n}\right]$. For the sake of readability, we do not mention the $n$ dependence in the following formulas. Let

$$
\begin{aligned}
w(t, x) & =e^{i \gamma} \lambda^{-\frac{1}{2}} W(s, y) \\
z(t, x) & =e^{i \gamma} \lambda^{-\frac{1}{2}} Z(s, y)
\end{aligned}
$$

We recall from (5.3) and $V=W+Z$ that

$$
u=w+z+e^{i \gamma} \eta
$$

First, from (5.6), we know that

$$
\|\eta(t)\|_{L^{2}} \lesssim|t|^{2}, \quad\left\|\partial_{x} \eta(t)\right\|_{L^{2}} \lesssim|t|, \quad\|x \eta(t)\|_{L^{2}} \lesssim|t|^{2}
$$

Second, we estimate $z$. From (3.24), recall that

$$
|Z| \lesssim s^{-\frac{3}{2}} \mathbf{1}_{J(s)}+s^{-\frac{9}{2}}\left(|y|^{3}+1\right) \mathbf{1}_{I(s)} \lesssim s^{-\frac{3}{2}} \mathbf{1}_{I(s)}
$$

and

$$
\left|\partial_{y} Z\right| \lesssim(1+|y|)^{-1}\left[s^{-\frac{3}{2}} \mathbf{1}_{J(s)}+s^{-\frac{9}{2}}\left(|y|^{3}+1\right) \mathbf{1}_{I(s)}\right] \lesssim s^{-\frac{5}{2}} \mathbf{1}_{I(s)}
$$

Thus,

$$
\|Z(s)\|_{L^{2}} \lesssim s^{-1}, \quad\left\|\partial_{y} Z(s)\right\|_{L^{2}} \lesssim s^{-2}, \quad\|y Z(s)\|_{L^{2}} \lesssim 1
$$

By change of variable and (3.8), we obtain

$$
\|z(t)\|_{H^{1}} \lesssim|t|, \quad\|x z(t)\|_{L^{2}} \lesssim|t|
$$

Last, we decompose $w$ as

$$
w=q+r, \quad q(t, x)=e^{i \gamma} \lambda^{-\frac{1}{2}} M_{-b} Q_{a}(y), \quad r(t, x)=e^{i \gamma} \lambda^{-\frac{1}{2}} \theta(s, y)(A+i B)(y)
$$

By the change of variable $z=\frac{x}{t}$, we have

$$
\left\|q(t)-\frac{e^{\frac{i}{t}}}{|t|^{\frac{1}{2}}} Q\left(\frac{x}{t}\right)\right\|_{L^{2}}=\left\|e^{i \tilde{\gamma}} \tilde{\lambda}^{-\frac{1}{2}} e^{-i b \tilde{\lambda}^{-2} \frac{z^{2}}{4}} Q_{a}\left(\frac{z}{\tilde{\lambda}}\right)-Q(z)\right\|_{L^{2}}
$$

where

$$
\tilde{\gamma}=\gamma-\frac{1}{t}, \quad \tilde{\lambda}=\frac{\lambda}{|t|}
$$

By (4.4) and (3.8), we have

$$
|\tilde{\gamma}|+|\tilde{\lambda}-1|+|b|+|a| \lesssim|t|^{\frac{3}{4}}
$$

Writing

$$
\begin{aligned}
& +\left\|Q\left(\frac{z}{\tilde{\lambda}}\right)-Q(z)\right\|_{L^{2}},
\end{aligned}
$$

it follows from usual computations, using the decay properties of $Q$ for the second term on the right-hand side, that

$$
\left\|q(t)-\frac{e^{\frac{i}{t}}}{|t|^{\frac{1}{2}}} Q\left(\frac{x}{t}\right)\right\|_{L^{2}} \lesssim|t|^{\frac{3}{4}} .
$$

Let

$$
\begin{aligned}
& A_{*}(s, y)=\lambda^{\frac{3}{2}}|y| \cos \gamma+\kappa \lambda^{\frac{5}{2}}|y|^{2} \sin \gamma \\
& B_{*}(s, y)=-\lambda^{\frac{3}{2}}|y| \sin \gamma+\kappa \lambda^{\frac{5}{2}}|y|^{2} \cos \gamma
\end{aligned}
$$

so that

$$
r_{*}(t, x)=e^{i \gamma} \lambda^{-\frac{1}{2}} \theta(s, y)\left(A_{*}+i B_{*}\right)(y)
$$

Now, note that by change of variable $x=\lambda y$,

$$
\left\|r-r_{*}\right\|_{L^{2}}=\left\|\theta\left(\left(A-A_{*}\right)+i\left(B-B_{*}\right)\right)\right\|_{L^{2}}
$$

By the asymptotics of the functions $\left(\varphi_{1}, \psi_{1}\right)$ and $\left(\varphi_{2}, \psi_{2}\right)$ in Lemmas 2.2 and 2.3 we have

$$
\begin{aligned}
\left\|\theta\left(\left(A-A_{*}\right)+i\left(B-B_{*}\right)\right)\right\|_{L^{2}} \leq & \lambda^{\frac{3}{2}}\left\|\theta\left(\varphi_{1}-|y|\right)\right\|_{L^{2}}+\lambda^{\frac{3}{2}}\left\|\theta\left(\psi_{1}+|y|\right)\right\|_{L^{2}} \\
& +\lambda^{\frac{5}{2}}\left\|\theta\left(\varphi_{2}-\kappa|y|^{2}\right)\right\|_{L^{2}}+\lambda^{\frac{5}{2}}\left\|\theta\left(\psi_{2}+\kappa|y|^{2}\right)\right\|_{L^{2}} \\
& \lesssim \lambda^{\frac{3}{2}}\|\theta\|_{L^{2}} \lesssim \delta^{\frac{1}{2}}|t| .
\end{aligned}
$$

Thus

$$
\left\|r(t)-r_{*}\right\|_{L^{2}} \lesssim \delta^{\frac{1}{2}}|t| .
$$

This estimate completes the proof of (7.2).
Finally, by (3.21), for $s$ large,

$$
\|W(s)\|_{H^{1}} \lesssim 1, \quad\|y W(s)\|_{L^{2}} \lesssim \delta^{\frac{5}{2}} s
$$

and thus, by change of variable,

$$
\|w(t)\|_{H^{1}} \lesssim|t|^{-1}, \quad\|x w(t)\|_{L^{2}} \lesssim \delta^{\frac{5}{2}}
$$

which completes the proof of (7.3)-(7.4).
7.2. Compactness argument. Finally, passing to the limit as $n \rightarrow+\infty$ in the sequence of solutions construted in Proposition 7.1 we construct a solution $u$ of (1.1) satisfying the conclusions of Theorem 1 .

By the bound (7.3)-(7.4), there exists a subsequence $u_{n_{k}}\left(t_{1}\right)$ of $u_{n}\left(t_{1}\right)$ and $u_{0} \in \Sigma$ such that

$$
\begin{array}{ll}
u_{n_{k}}\left(t_{1}\right) \rightharpoonup u_{0} & \text { weakly in } H^{1} \text { as } k \rightarrow+\infty \\
u_{n_{k}}\left(t_{1}\right) \rightarrow u_{0} & \text { strongly in } L^{2} \text { as } k \rightarrow+\infty
\end{array}
$$

Let $u$ be the $H^{1}$ solution of (1.1) such that $u\left(t_{1}\right)=u_{0}$. By the local wellposedness of the Cauchy problem in $L^{2}$ for (1.1) (see e.g. [2, Theorem 4.7.1]), the solution $u(t)$ exists on $\left[t_{1}, 0\right)$ and for any $t \in\left[t_{1}, 0\right)$,

$$
u_{n_{k}}(t) \rightarrow u(t) \quad \text { strongly in } L^{2} \text { as } k \rightarrow+\infty
$$

Passing to the limit in (7.2), we obtain on $\left[t_{1}, 0\right)$,

$$
\begin{aligned}
\left\|u(t)-\frac{e^{\frac{i}{t}}}{|t|^{\frac{1}{2}}} Q\left(\frac{x}{t}\right)-r_{*}\right\|_{L^{2}} & \lesssim|t|^{\frac{3}{4}} \\
\|u(t)\|_{H^{1}} & \lesssim|t|^{-1}
\end{aligned}
$$

It follows from the first estimate above that $\left\{u(t) ; t \in\left[t_{1}, 0\right]\right\}$ is not compact in $L^{2}$. Therefore, the maximal time of existence of the $L^{2}$ solution $u(t)$ is 0 . By persistence of regularity (see e.g. [2, Theorem 4.7.1]), $u(t)$ blows up in $H^{1}$ at time $t=0$. Next, by the Gagliardo-Nirenberg inequality $\|g\|_{L^{6}}^{3} \lesssim\left\|\partial_{x} g\right\|_{L^{2}}\|g\|_{L^{2}}^{2}$, we obtain

$$
\left\|u(t)-\frac{e^{\frac{i}{t}}}{|t|^{\frac{1}{2}}} Q\left(\frac{x}{t}\right)-r_{*}\right\|_{L^{6}} \lesssim|t|^{\frac{1}{6}} .
$$

By $E(Q)=0$, we have for any $t \neq 0$,

$$
\left\|\frac{e^{\frac{i}{t}}}{|t|^{\frac{1}{2}}} Q\left(\frac{x}{t}\right)\right\|_{L^{6}}^{6}=\frac{\left\|Q^{\prime}\right\|_{L^{2}}^{2}}{t^{2}}
$$

and thus

$$
\lim _{t \uparrow 0} t^{2}\|u(t)\|_{L^{6}}^{6}=\left\|Q^{\prime}\right\|_{L^{2}}^{2}
$$

Therefore, by conservation of the energy $E(u(t))$, we obtain (1.9). This completes the proof of Theorem 1

## Appendix A.

In this appendix, we prove Lemma 2.2. First, we prove the following ODE result.
Lemma A.1. Let $m>0$. Let $\left(P_{j}\right)_{1 \leq j \leq 4} \subset C(\mathbb{R}, \mathbb{R})$ and suppose there exists $\delta>0$ such that

\left|P_{j}(x)\right| \leq C e^{-(2 m+\delta) x}, \quad x \geq 0 \tag{A.1}
\end{equation*}
$$

If $u, v \in \mathcal{C}^{2}(\mathbb{R}, \mathbb{R})$ satisfy

\left\{\begin{array}{l}
-u^{\prime \prime}+m^{2} u+P_{1} u+P_{2} v=0  \tag{A.2}\\
-v^{\prime \prime}+P_{3} u+P_{4} v=0
\end{array}\right.
$$

then there exist constants $c, d_{0}, d_{1} \in \mathbb{R}$ such that
(i) for $x \geq 0,\left|u(x)-c e^{m x}\right| \lesssim e^{-m x}$,
(ii) for $x \geq 0,\left|v(x)-d_{0}-d_{1} x\right| \lesssim e^{-m x}$.

Proof. Setting $u^{\prime}=m w$ and $v^{\prime}=m z$, we have
$\frac{d}{d x}\left(u^{2}+w^{2}+v^{2}+z^{2}\right)=4 m u w+2 m v z+2 \frac{P_{1}}{m} u w+2 \frac{P_{2}}{m} v w+2 \frac{P_{3}}{m} u z+2 \frac{P_{4}}{m} v z$.
It follows that for every $\nu>0$,

$$
\frac{d}{d x}\left(u^{2}+w^{2}+v^{2}+z^{2}\right) \leq 2(m+\nu)\left(u^{2}+w^{2}+v^{2}+z^{2}\right)
$$

for all sufficiently large $x$; and so

$$
u^{2}+w^{2}+v^{2}+z^{2} \lesssim e^{2(m+\nu) x}, \quad x \geq 0
$$

It follows that

$$
\begin{equation*}
\left|P_{j}\right|(|u|+|v|) \lesssim e^{-(m+\delta-\nu) x}, \quad x \geq 0 \tag{A.3}
\end{equation*}
$$

for $j=1,2,3,4$. Next, from the variation of the parameter formula, we see that there exist constants $u_{1}$ and $u_{2}$ such that

$$
\begin{equation*}
u(x)=u_{1} e^{m x}+u_{2} e^{-m x}+\frac{1}{2 m} \int_{0}^{x}\left(e^{m(x-s)}-e^{-m(x-s)}\right)\left(P_{1} u+P_{2} v\right)(s) d s \tag{A.4}
\end{equation*}
$$

Applying (A.3) with $\nu<\delta$ and setting

$$
\begin{equation*}
c=u_{1}+\frac{1}{2 m} \int_{0}^{\infty} e^{-m s}\left(P_{1} u+P_{2} v\right)(s) d s \tag{A.5}
\end{equation*}
$$

we deduce from (A.4) that

$$
\begin{align*}
u(x)-c e^{m x}= & u_{2} e^{-m x}-\frac{1}{2 m} \int_{0}^{x} e^{-m(x-s)}\left(P_{1} u+P_{2} v\right)(s) d s  \tag{A.6}\\
& -\frac{1}{2 m} \int_{x}^{\infty} e^{m(x-s)}\left(P_{1} u+P_{2} v\right)(s) d s
\end{align*}
$$

It follows easily from (A.3) (with $\nu<\delta$ ) and A.6) that

$$
\begin{equation*}
\left|u(x)-c e^{m x}\right| \lesssim e^{-m x}, \quad x \geq 0 \tag{A.7}
\end{equation*}
$$

This proves the first part of the statement.
Set now

$$
d_{1}=v^{\prime}(0)+\int_{0}^{\infty}\left(P_{3} u+P_{4} v\right)(\tau) d \tau
$$

which is well defined by (A.3) (with $\nu<\delta$ ). It follows from the second equation in (A.2) that

v^{\prime}(s)-d_{1}=-\int_{s}^{\infty}\left(P_{3} u+P_{4} v\right)(\tau) d \tau
$$

Using again (A.3), we see that

\left|\int_{s}^{\infty}\left(P_{3} u+P_{4} v\right)(\tau) d \tau\right| \lesssim e^{-m s}
$$

and we define

$$
d_{0}=v(0)-\int_{0}^{\infty} \int_{s}^{\infty}\left(P_{3} u+P_{4} v\right)(\tau) d \tau d s
$$

It follows that

$$
v(x)-d_{0}-d_{1} x=\int_{x}^{\infty} \int_{s}^{\infty}\left(P_{3} u+P_{4} v\right)(\tau) d \tau d s
$$

so that $\left|v(x)-d_{0}-d_{1} x\right| \lesssim e^{-m x}$. This completes the proof.

We turn to the proof of Lemma 2.2. Set

$$
\widetilde{\varphi}=\varphi+\psi, \quad \widetilde{\psi}=\varphi-\psi, \quad \widetilde{g}=g+h, \quad \widetilde{h}=g-h
$$

We see by the expressions of $L_{+}$and $L_{-}$and direct computations that the system (2.6) is equivalent to

\left\{\begin{array}{l}
-\widetilde{\varphi}^{\prime \prime}+2 \widetilde{\varphi}-3 Q^{4} \widetilde{\varphi}-2 Q^{4} \widetilde{\psi}=\widetilde{g}  \tag{A.8}\\
-\widetilde{\psi}^{\prime \prime}-3 Q^{4} \widetilde{\psi}-2 Q^{4} \widetilde{\varphi}=\widetilde{h}
\end{array}\right.
$$

Recall that we consider only even solutions.
Lemma A.2. The following properties hold.
(i) There exists a unique pair of even functions $\left(\widetilde{\varphi}_{1}, \widetilde{\psi}_{1}\right) \in \mathcal{Y} \times \mathcal{Z}_{1}$ such that

\left\{\begin{array}{l}
-\widetilde{\varphi}_{1}^{\prime \prime}+2 \widetilde{\varphi}_{1}-3 Q^{4} \widetilde{\varphi}_{1}-2 Q^{4} \widetilde{\psi}_{1}=0  \tag{A.9}\\
-\widetilde{\psi}_{1}^{\prime \prime}-3 Q^{4} \widetilde{\psi}_{1}-2 Q^{4} \widetilde{\varphi}_{1}=0
\end{array}\right.
$$

and satisfying

$$
\begin{equation*}
\widetilde{\psi}_{1}(x)=\mu_{1}(x)+c_{1}+\widetilde{w}_{1}(x) \tag{A.10}
\end{equation*}
$$

where $c_{1} \in \mathbb{R}$ and $\widetilde{w}_{1} \in \mathcal{Y}$.
(ii) Given $(\widetilde{g}, \widetilde{h}) \in \mathcal{Y} \times \mathcal{Y}$, there exists a unique even solution $(\widetilde{\varphi}, \widetilde{\psi}) \in \mathcal{Y} \times \mathcal{Z}_{0}$ of (A.8).

Proof. Proof of part (i). Define the solutions $\left(f_{1}, g_{1}\right)$ and $\left(f_{2}, g_{2}\right)$ of system (A.9) corresponding to the initial data $f_{1}(0)=1, f_{1}^{\prime}(0)=0, g_{1}(0)=0, g_{1}^{\prime}(0)=0$ and $f_{2}(0)=0, f_{2}^{\prime}(0)=0, g_{2}(0)=1, g_{2}^{\prime}(0)=0$. From (i) of Lemma A. 1 and standard ODE arguments for the regularity and the decay of the derivatives, it follows that there exist $a_{1}, a_{2} \in \mathbb{R}$ and $w_{1}, w_{2} \in \mathcal{Y}$ such that

$$
f_{1}(x)=a_{1} \mu_{0}(x) e^{|x| \sqrt{2}}+w_{1}(x) \quad \text { and } \quad f_{2}(x)=a_{2} \mu_{0}(x) e^{|x| \sqrt{2}}+w_{2}(x)
$$

Therefore, there exists a linear combination of the pairs $\left(f_{1}, g_{1}\right)$ and $\left(f_{2}, g_{2}\right)$, denoted by $(f, g)$, such that $f \in \mathcal{Y}$. Since the solutions $\left(f_{1}, g_{1}\right)$ and $\left(f_{2}, g_{2}\right)$ are independent, the pair $(f, g)$ is non zero and satisfies the system (A.9). By (i) of Lemma A. 1 there exist $b_{0}, b_{1} \in \mathbb{R}$ and $z \in \mathcal{Y}$ such that

$$
g(x)=b_{1} \mu_{1}(x)+b_{0}+z(x)
$$

Recall from [19, Proposition 2.1.4] that there exist no nonzero bounded solution of (A.9), which means exactly that $b_{1} \neq 0$. Thus, $\left(\widetilde{\varphi}_{1}, \widetilde{\psi}_{1}\right)=\frac{1}{b_{1}}(f, g)$ satisfies (A.9) and A.10).

The uniqueness part of (i) also follows from the result of non existence of a non zero bounded solution of (A.9) in [19, Proposition 2.1.4].

Proof of part (iii). Let $(\widetilde{g}, \widetilde{h}) \in \mathcal{Y} \times \mathcal{Y}$ be a pair of even functions. We first construct a solution of A.8) in $\mathcal{Y} \times \mathcal{Z}_{1}$, using a reformulation of the problem.

Indeed, integrating twice the second equation in (A.8), and using that $\widetilde{\psi}$ is even, we obtain

\widetilde{\psi}+3 \int_{0}^{x} \int_{0}^{y} Q^{4} \widetilde{\psi}=-\int_{0}^{x} \int_{0}^{y}\left(2 Q^{4} \widetilde{\varphi}+\widetilde{h}\right)+C
$$

for some constant $C$. Now, we will solve the system

where for simplicity the constant $C$ was chosen equal to 0 . We rewrite the second equation in (A.11) in the equivalent form

It is clear that $T \in \mathcal{L}\left(L^{2}(\mathbb{R})\right)$ and that $T$ is a compact operator $L^{2}(\mathbb{R}) \rightarrow L^{2}(\mathbb{R})$. We also observe that if the function $u$ is even, then $T u$ is also even. Moreover, the adjoint of $T$ is given by (use Fubini's theorem)

By the above estimate and $T^{\star} u=u$, we deduce that $u(x)=0$ for $x$ large. The same vanishing property holds for $v=Q^{-2} u$, which satisfies the ODE $v^{\prime \prime}=-3 Q^{4} v$. By uniqueness, $v \equiv 0$ and so $u \equiv 0$ on $\mathbb{R}$. By Fredholm's alternative, $I-T$ is invertible on $L^{2}(\mathbb{R})$. Therefore, we may write equation A.12) in the form

& =\frac{1}{3} Q^{2}\left[5+4(I-T)^{-1}\right]\left(Q^{2}\left(-\partial_{x x}+2\right)^{-1} v\right) .

From the above, it follows that $(\widetilde{\varphi}, \widetilde{\psi})$ satisfy (A.8). Integrating twice the second equation in (A.8), we deduce that $\widetilde{\psi}(x)=d_{1} \mu_{1}(x)+d_{0}+w(x)$ with $d_{1}, d_{0} \in \mathbb{R}$ and $w \in \mathcal{Y}$, and it follows easily that $\widetilde{\varphi} \in \mathcal{Y}$. Therefore, the pair
$\left(\widetilde{\varphi}-d_{1} \widetilde{\varphi}_{1}, \widetilde{\psi}-d_{1} \widetilde{\psi}_{1}\right)$ is a solution of (A.8) in $\mathcal{Y} \times \mathcal{Z}_{0}$. Finally, uniqueness follows again from [19, Proposition 2.1.4].

Let $\left(\widetilde{\varphi}_{1}, \widetilde{\psi}_{1}\right)$ given by part (i) of Lemma A.2 It follows that that the pair

& +i \theta\left(\alpha_{1} b \lambda^{\frac{3}{2}} \cos \gamma+\alpha_{2} b \lambda^{\frac{5}{2}} \sin \gamma\right) \rho
\end{aligned}
$$

Using the definition of $\mathcal{S}_{2}$ and $\Omega$, we deduce that

$$
\begin{align*}
\mathcal{S}_{2}+\mathcal{R}_{3}= & i \theta\left(\partial_{s} A+i \partial_{s} B\right)+\theta\left(A_{y y}+i B_{y y}\right) \\
& -i \frac{\lambda_{s}}{\lambda} \theta(\Lambda A+i \Lambda B)-\gamma_{s} \theta(A+i B)  \tag{B.3}\\
& +f(W)-f\left(M_{-b} Q_{a}\right)+i \theta \Omega \rho
\end{align*}
$$

Identities (B.2) and (B.3) immediately yield (3.40).
