POLYTOPES, POLYHEDRA, AND THE FARKAS LEMMA

MELVYN B. NATHANSON

ABSTRACT. The Farkas lemma is proved and then applied to obtain a structure theorem for polyhedra. These notes are based on a talk in the New York Number Theory Seminar on October, 20, 2022.

1. Notation

For vectors $\mathbf{u} = \begin{pmatrix} u_1 \\ \vdots \\ u_n \end{pmatrix}$ and $\mathbf{v} = \begin{pmatrix} v_1 \\ \vdots \\ v_n \end{pmatrix}$ in \mathbf{R}^n we write $\mathbf{u} \leq \mathbf{v}$ (and also $\mathbf{v} \geq \mathbf{u}$) if $u_i \leq v_i$ for all $i \in \{1, 2, \dots, n\}$. If $\mathbf{u} \leq \mathbf{v}$ and $t \geq 0$, then $t\mathbf{u} \leq t\mathbf{v}$. We denote both the zero vector in \mathbf{R}^n and the zero $m \times n$ matrix in $\mathbf{R}^{m,n}$ by $\mathbf{0}$. The vector \mathbf{v} is nonnegative if $\mathbf{v} \geq \mathbf{0}$ and nonpositive if $\mathbf{v} \leq \mathbf{0}$. The transpose of the column

vector $\mathbf{u} = \begin{pmatrix} u_1 \\ \vdots \\ u_n \end{pmatrix}$ is the row vector $\mathbf{u}^t = (u_1, \dots, u_n)$ and

$$\mathbf{u}^{t}\mathbf{v} = (u_{1}, \dots, u_{n}) \begin{pmatrix} v_{1} \\ \vdots \\ v_{n} \end{pmatrix} = \sum_{i=1}^{n} u_{i}v_{i}.$$

If $\mathbf{u} \leq \mathbf{0}$ and $\mathbf{v} \geq \mathbf{0}$, then $\mathbf{u}^t \mathbf{v} \leq 0$.

Let A^t denote the transpose of the matrix A. The matrix $A = (a_{i,j})$ is nonnegative, denoted $A \ge \mathbf{0}$, if $a_{i,j} \ge 0$ for all i and j, and nonpositive, denoted $A \le \mathbf{0}$, if $a_{i,j} \le 0$ for all i and j. The inequalities $A \le \mathbf{0}$ and $\mathbf{v} \ge \mathbf{0}$ imply $A\mathbf{v} \le \mathbf{0}$.

2. Convex sets and polyhedra

A subset X of a real vector space V is *convex* if $\lambda_1 \mathbf{x}_1 + \lambda_2 \mathbf{x}_2 \in X$ for all vectors $\mathbf{x}_1, \mathbf{x}_2 \in X$ and all nonnegative numbers λ_1, λ_2 such that $\lambda_1 + \lambda_2 = 1$. The intersection of convex subsets of V is a convex set in V. For example, for every positive integer k, the set

$$\Delta_k = \left\{ \lambda = \begin{pmatrix} \lambda_1 \\ \vdots \\ \lambda_k \end{pmatrix} \in \mathbf{R}^k : \lambda \ge \mathbf{0} \text{ and } \sum_{i=1}^k \lambda_i = 1 \right\}$$

is a convex subset of \mathbf{R}^k . The set X is convex if and only if $\sum_{i=1}^k \lambda_i \mathbf{x}_i \in X$ for all $k \geq 1$, $(\mathbf{x}_1, \dots, \mathbf{x}_k) \in X^k$, and $\begin{pmatrix} \lambda_1 \\ \vdots \\ \lambda_k \end{pmatrix} \in \Delta_k$. We call $\sum_{i=1}^k \lambda_i \mathbf{x}_i \in X$ a convex combination of the k-tuple $(\mathbf{x}_1, \dots, \mathbf{x}_k)$.

The intersection of convex subsets of a real vector space V is convex. The *convex hull* of a nonempty subset W of V is the intersection of all convex subsets of V that contain W. This is the set X = conv(W) of all convex combinations of k-tuples of elements of W for all $k \geq 1$. For $j \in \{1, 2, ..., k\}$, the standard basis vector $\mathbf{e}_j \in \mathbf{R}^k$ is the vector whose jth coordinate is 1 and whose ith coordinate is 0 for all $i \in \{1, 2, ..., k\} \setminus \{j\}$. The set Δ_k is the convex hull of the set $\{\mathbf{e}_1, ..., \mathbf{e}_k\}$. We define $\text{conv}(\emptyset) = \{\mathbf{0}\}$.

The closed half-space in \mathbf{R}^n defined by the vector $\mathbf{a} = \begin{pmatrix} a_1 \\ \vdots \\ a_n \end{pmatrix} \in \mathbf{R}^n$ and the scalar $b \in \mathbf{R}$ is the set

$$H(\mathbf{a},b) = \left\{ \mathbf{x} = \begin{pmatrix} x_1 \\ \vdots \\ x_n \end{pmatrix} \in \mathbf{R}^n : \mathbf{a}^t \mathbf{x} = \sum_{j=1}^n a_j x_j \le b \right\}.$$

If $\mathbf{x}, \mathbf{y} \in H(\mathbf{a}, b)$ and if $\lambda_1 + \lambda_2 = 1$, then

$$\mathbf{a}^{t} (\lambda_{1}\mathbf{x} + \lambda_{2}\mathbf{y}) = \lambda_{1}\mathbf{a}^{t}\mathbf{x} + \lambda_{2}\mathbf{a}^{t}\mathbf{y} \le \lambda_{1}b + \lambda_{2}b = b$$

and so $\lambda_1 \mathbf{x} + \lambda_2 \mathbf{y} \in H(\mathbf{a}, b)$. Thus, every closed half-space is convex.

If $\mathbf{a} \neq 0$, then $H(\mathbf{a}, b) \neq \{\mathbf{0}\}$ and $H(\mathbf{a}, b) \neq \mathbf{R}^n$. We have $H(\mathbf{0}, b) = \emptyset$ if b < 0 and $H(\mathbf{0}, b) = \mathbf{R}^n$ if $b \geq 0$.

A polyhedron in \mathbf{R}^n is the intersection of a finite number of closed half-spaces, that is, a set P of vectors $\mathbf{x} = \begin{pmatrix} x_1 \\ \vdots \\ x_n \end{pmatrix}$ whose coordinates satisfy a finite number m of linear inequalities of the form $\sum_{j=1}^n a_{i,j}x_j \leq b_i$. These inequalities define the $m \times n$ matrix $A = \begin{pmatrix} a_{i,j} \end{pmatrix}$ and the vector $\mathbf{b} = \begin{pmatrix} b_1 \\ \vdots \\ b_m \end{pmatrix} \in \mathbf{R}^m$, which generate the polyhedron P as follows:

$$P = {\mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \le \mathbf{b}} = \bigcap_{i=1}^m H(\mathbf{a}_i, b_i)$$

where \mathbf{a}_i^t is the *i*th row vector of A. If $\mathbf{x}_1, \mathbf{x}_2 \in P$ and if $\lambda_1 + \lambda_2 = 1$ with $\lambda_1, \lambda_2 \in \mathbf{R}_{>0}^2$, then

$$A(\lambda_1 \mathbf{x}_1 + \lambda_2 \mathbf{x}_2) = \lambda_1 A \mathbf{x}_1 + \lambda_2 A \mathbf{x}_2 \le \lambda_1 \mathbf{b} + \lambda_2 \mathbf{b} = \mathbf{b}$$

and so every polyhedron is convex.

The inequality $\sum_{j=1}^{n} a_j x_j \geq b$ is equivalent to the inequality $\sum_{j=1}^{n} (-a_j) x_j \leq -b$, and the equation $\sum_{j=1}^{n} a_j x_j = b$ is equivalent to the two inequalities $\sum_{j=1}^{n} a_j x_j \leq b$ and $\sum_{j=1}^{n} (-a_j) x_j \leq -b$. Thus, the set of vectors $\mathbf{x} \in \mathbf{R}^n$ that satisfy a finite number of inequalities of the form $\sum_{j=1}^{n} a_j x_j \leq b$, a finite number of inequalities of the form $\sum_{j=1}^{n} a_j x_j \geq b$, and a finite number of equations $\sum_{j=1}^{n} a_j x_j = b$ is a polyhedron.

3. Projections

For all $n \geq 2$ and $k \in \{1, ..., n-1\}$, the *projection* of \mathbf{R}^n onto \mathbf{R}^{n-k} is the llinear transformation $\pi_{n,k} : \mathbf{R}^n \to \mathbf{R}^{n-k}$ defined by

$$\pi_{n,k} \begin{pmatrix} x_1 \\ \vdots \\ x_k \\ x_{k+1} \\ \vdots \\ \vdots \\ x_n \end{pmatrix} = \begin{pmatrix} x_{k+1} \\ \vdots \\ x_n \end{pmatrix}.$$

We have

(1)
$$\pi_{n,k} = \pi_{n-k+1,1} \cdots \pi_{n-1,1} \pi_{n,1}.$$

For example,

$$\pi_{4,1}\pi_{5,1} \begin{pmatrix} x_1 \\ x_2 \\ x_3 \\ x_4 \\ x_5 \end{pmatrix} = \pi_{4,1} \begin{pmatrix} x_2 \\ x_3 \\ x_4 \\ x_5 \end{pmatrix} = \begin{pmatrix} x_3 \\ x_4 \\ x_5 \end{pmatrix} = \pi_{5,2} \begin{pmatrix} x_1 \\ x_2 \\ x_3 \\ x_4 \\ x_5 \end{pmatrix}$$

Lemma 1. Let V and V' be real vector spaces and let $T: V \to V'$ be a linear transformation. If X is a convex subset of V, then Y = T(X) is a convex subset of V'. In particular, the projection of a convex set in \mathbb{R}^n is a convex set.

Proof. Let $\mathbf{y}_1, \mathbf{y}_2 \in Y$ and $(\lambda_1, \lambda_2) \in \Delta_2$. There exist $\mathbf{x}_1, \mathbf{x}_2 \in X$ such that $T(\mathbf{x}_1) = \mathbf{y}_1$ and $T(\mathbf{x}_2) = \mathbf{y}_2$. If X is convex, then $\lambda_1 \mathbf{x}_1 + \lambda_2 \mathbf{x}_2 \in X$ and so

$$\lambda_1 \mathbf{y}_1 + \lambda_2 \mathbf{y}_2 = \lambda_1 T(\mathbf{x}_1) + \lambda_2 T(\mathbf{x}_2) = T(\lambda_1 \mathbf{x}_1 + \lambda_2 \mathbf{x}_2) \in T(X) = Y.$$

Thus, Y is convex.

Every projection $\pi_{n,k}: \mathbf{R}^n \to \mathbf{R}^{n-k}$ is a linear transformation and so the projection of a convex set is convex. This completes the proof.

Theorem 1. The projection of a polyhedron is a polyhedron.

Proof. Identity (1) implies that it suffices to prove the Theorem for $n \geq 2$ and k = 1. The projection $\pi_{n,1} : \mathbf{R}^n \to \mathbf{R}^{n-1}$ is defined by

$$\pi_{n,1} \begin{pmatrix} x_1 \\ x_2 \\ \vdots \\ x_n \end{pmatrix} = \begin{pmatrix} x_2 \\ \vdots \\ x_n \end{pmatrix}.$$

Let $P = \{ \mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \leq \mathbf{b} \}$ be the polyhedron in \mathbf{R}^n defined by the $m \times n$ matrix $A = (a_{i,j})$ and the vector $\mathbf{b} = \begin{pmatrix} b_1 \\ \vdots \\ b_m \end{pmatrix} \in \mathbf{R}^m$. We have $\mathbf{x} = \begin{pmatrix} x_1 \\ \vdots \\ x_n \end{pmatrix} \in P$ if and only if the following m inequalities are satisfied:

$$a_{1,1}x_1 + a_{1,2}x_2 + \dots + a_{1,n}x_n \le b_1$$

$$a_{2,1}x_1 + a_{2,2}x_2 + \dots + a_{2,n}x_n \le b_2$$

$$\vdots$$

$$a_{m,1}x_1 + a_{m,2}x_2 + \cdots + a_{m,n}x_n \le b_m$$

Partition the set $S = \{1, 2, ..., m\}$ as follows:

$$S_1 = \{ p \in S : a_{p,1} > 0 \}$$

$$S_{-1} = \{ q \in S : a_{q,1} < 0 \}$$

$$S_0 = \{ r \in S : a_{r,1} = 0 \}$$

Let
$$\mathbf{x} = \begin{pmatrix} x_1 \\ \vdots \\ x_n \end{pmatrix} \in P$$
. If $p \in S_1$, then

$$x_1 \le -\frac{a_{p,2}}{a_{p,1}}x_2 - \dots - \frac{a_{p,n}}{a_{p,1}}x_n + \frac{b_p}{a_{p,1}}$$

If $q \in S_{-1}$, then

$$-\frac{a_{q,2}}{a_{q,1}}x_2 - \dots - \frac{a_{q,n}}{a_{q,1}}x_n + \frac{b_q}{a_{q,1}} \le x_1.$$

For all $p \in S_1$ and $q \in S_{-1}$ we have

$$-\frac{a_{q,2}}{a_{q,1}}x_2 - \dots - \frac{a_{q,n}}{a_{q,1}}x_n + \frac{b_q}{a_{q,1}} \le x_1 \le -\frac{a_{p,2}}{a_{p,1}}x_2 - \dots - \frac{a_{p,n}}{a_{p,1}}x_n + \frac{b_p}{a_{p,1}}x_n + \frac{b_p}{a_{p,1}}x_n + \frac{b_p}{a_{p,2}}x_n +$$

and so

(2)
$$\left(\frac{a_{p,2}}{a_{p,1}} - \frac{a_{q,2}}{a_{q,1}}\right) x_2 + \dots + \left(\frac{a_{p,n}}{a_{p,1}} - \frac{a_{q,n}}{a_{q,1}}\right) x_n \le \frac{b_p}{a_{p,1}} - \frac{b_q}{a_{q,1}}.$$

For all $r \in S_0$ we have

$$(3) a_{r,2}x_2 + \dots + a_{r,n}x_n \le b_r.$$

Thus, if $\mathbf{x} \in P$, then the vector $\pi_{n,1}(\mathbf{x})$ is in the polyhedron defined by the linear inequalities (2) and (3) for all p, q, and r. There are $|S_1| |S_{-1}| + |S_0|$ such inequalities.

Conversely, if the vector $\begin{pmatrix} x_2 \\ \vdots \\ x_n \end{pmatrix} \in \mathbf{R}^{n-1}$ satisfies inequalities (2) and (3) for all p, q, and r, then

$$(4) \qquad -\frac{a_{q,2}}{a_{q,1}}x_2 - \dots - \frac{a_{q,n}}{a_{q,1}}x_n + \frac{b_q}{a_{q,1}} \le -\frac{a_{p,2}}{a_{p,1}}x_2 - \dots - \frac{a_{p,n}}{a_{p,1}}x_n + \frac{b_p}{a_{p,1}}$$

for all p and q, and so

$$\max_{q \in S_{-1}} \left(-\frac{a_{q,2}}{a_{q,1}} x_2 - \dots - \frac{a_{q,n}}{a_{q,1}} x_n + \frac{b_q}{a_{q,1}} \right) \le \min_{p \in S_1} \left(-\frac{a_{p,2}}{a_{p,1}} x_2 - \dots - \frac{a_{p,n}}{a_{p,1}} x_n + \frac{b_p}{a_{p,1}} \right).$$

The left side of this inequality is $-\infty$ if $S_{-1} = \emptyset$ and the right side of this inequality is ∞ if $S_1 = \emptyset$. If x_1 is any real number such that

$$\max_{q \in S_{-1}} \left(-\frac{a_{q,2}}{a_{q,1}} x_2 - \dots - \frac{a_{q,n}}{a_{q,1}} x_n + \frac{b_q}{a_{q,1}} \right)$$

$$\leq x_1 \leq \min_{p \in S_1} \left(-\frac{a_{p,2}}{a_{p,1}} x_2 - \dots - \frac{a_{p,n}}{a_{p,1}} x_n + \frac{b_p}{a_{p,1}} \right)$$

then the vector $\mathbf{x} = \begin{pmatrix} x_1 \\ \vdots \\ x_n \end{pmatrix} \in \mathbf{R}^n$ is in the polyhedron P, and $\pi_{n,1}(\mathbf{x}) = \begin{pmatrix} x_2 \\ \vdots \\ x_n \end{pmatrix}$.

Thus, the projection of the polyhedron P in \mathbf{R}^n is the polyhedron in \mathbf{R}^{n-1} defined by the inequalities (2) and (3). This completes the proof.

The method of proof of Theorem 1 is sometimes called *Fourier-Motzkin elimination*.

4. Convex cones

A cone in \mathbf{R}^n is a nonempty set C such that $\lambda \mathbf{w} \in C$ for all $\mathbf{w} \in C$ and $\lambda \geq 0$. If $\mathbf{w} \in C$, then $\mathbf{0} = 0\mathbf{w} \in C$ and so every cone contains the zero vector. The set $\{\mathbf{0}\}$ in \mathbf{R}^n is a cone. The cone C is bounded if and only if $C = \{\mathbf{0}\}$.

A convex cone in \mathbf{R}^n is a cone that is convex. The set $\{\mathbf{0}\}$ in \mathbf{R}^n is a convex cone. If the cone C is convex, then for all $\mathbf{w}, \mathbf{w}' \in C$ we have

$$\mathbf{w} + \mathbf{w}' = 2\left(\frac{1}{2}\mathbf{w} + \frac{1}{2}\mathbf{w}'\right) \in C.$$

Conversely, if C is a cone such that $\mathbf{w} + \mathbf{w}' \in C$ for all $\mathbf{w}, \mathbf{w}' \in C$, then for all $(\lambda_1, \lambda_2) \in \Delta_2$ we have $\lambda_1 \mathbf{w}, \lambda_2 \mathbf{w}' \in C$ and so $\lambda_1 \mathbf{w} + \lambda_2 \mathbf{w}' \in C$. Thus, the cone C is convex if and only if $\mathbf{w} + \mathbf{w}' \in C$ for all $\mathbf{w}, \mathbf{w}' \in C$.

The union of cones is a cone, but the union of convex cones is not necessarily convex. For example, the union of two distinct one-dimensional subspaces in \mathbb{R}^n (that is, two lines passing through the origin) is a cone that is not convex.

The vector space \mathbf{R}^{n^2} can be viewed as the set of $n \times n$ matrices. An $n \times n$ matrix A is positive semidefinite if $\mathbf{x}^t A \mathbf{x} \geq 0$ for all $\mathbf{x} \in \mathbf{R}^n$. The set of positive semidefinite matrices is a convex cone in \mathbf{R}^{n^2} .

A conic combination of a finite sequence of vectors $(\mathbf{w}_1, \dots, \mathbf{w}_n)$ in \mathbf{R}^n is a vector of the form $\lambda_1 \mathbf{w}_1 + \dots + \lambda_n \mathbf{w}_n$ for some $(\lambda_1, \dots, \lambda_n) \in \mathbf{R}^n_{\geq 0}$. A nonempty set \mathcal{W} of vectors in \mathbf{R}^n conically generates the cone C if C is the set of all conic combinations of finite sequences of elements of \mathcal{W} . We write $C = \text{cone}(\mathcal{W})$ if C is the cone generated by \mathcal{W} . A cone is *finitely generated* if it is the set of all conic combinations of a finite set of vectors. The zero cone $C = \{\mathbf{0}\}$ is the cone generated by the empty set of vectors in \mathbf{R}^n .

Theorem 2. The cone generated by a nonempty set of vectors is convex.

Proof. Let \mathcal{W} be a nonempty set of vectors in \mathbb{R}^n and let $C = \text{cone}(\mathcal{W})$. The set C is nonempty because \mathcal{W} is nonempty. A conic combination of conic combinations of finite sequences of vectors in \mathcal{W} is also a conic combination of a finite sequence of vectors in \mathcal{W} , and so C is a cone. In particular, if $\mathbf{w} \in C$ and $\mathbf{w}' \in C$, then $\mathbf{w} + \mathbf{w}' \in C$. Thus, C is convex. This completes the proof.

Theorem 3. Let W be an $n \times m$ matrix. The set

$$C(W) = \{W\mathbf{y} : \mathbf{y} \in \mathbf{R}^m \text{ and } \mathbf{y} \geq \mathbf{0}\}\$$

is a convex cone in \mathbb{R}^n .

Proof. For $j \in \{1, ..., m\}$, let $\mathbf{w}_j \in \mathbf{R}^n$ be the the jth column vector of the matrix W and let $W = \{\mathbf{w}_1, ..., \mathbf{w}_m\}$. We have

$$C(W) = \{W\mathbf{y} : \mathbf{y} \in \mathbf{R}^m \text{ and } \mathbf{y} \ge \mathbf{0}\}$$

= \{y_1\mathbf{w}_1 + \cdots + y_m\mathbf{w}_m : y_j \geq 0 \text{ for all } j = 1, \ldots, m\}

and so C(W) is the set of all conic combinations of the sequence of vectors $(\mathbf{w}_1, \dots, \mathbf{w}_m)$, that is, C(W) = cone(W). By Theorem 2, the cone C(W) is convex. This completes the proof.

A polyhedral cone in \mathbb{R}^n is a polyhedron that is a cone.

Lemma 2. For every positive integer m and every $m \times n$ matrix A, the polyhedron

$$P(A) = \{ \mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \le \mathbf{0} \}$$

is a polyhedral cone. Every polyhedral cone in \mathbb{R}^n is of this form for some matrix A.

Proof. If $A\mathbf{x} \leq \mathbf{0}$, then $A(\lambda \mathbf{x}) = \lambda A\mathbf{x} \leq \mathbf{0}$ for all $\lambda \geq 0$ and so the polyhedron $\{\mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \leq \mathbf{0}\}$ is a cone.

Let
$$A = (a_{i,j})$$
 and $\mathbf{b} = \begin{pmatrix} b_1 \\ \vdots \\ b_m \end{pmatrix}$. Suppose that the polyhedron $P = \{\mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \leq \mathbf{b}\}$

is a cone. We have $\mathbf{0} \in P$ and so $\mathbf{0} = A\mathbf{0} \leq \mathbf{b}$. Therefore, $A\mathbf{x} \leq \mathbf{0}$ implies $A\mathbf{x} \leq \mathbf{b}$ and P contains the set $\{\mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \leq \mathbf{0}\}$.

If P contains a vector \mathbf{x} such that $A\mathbf{x} \nleq \mathbf{0}$, then the ith coordinate of the vector $A\mathbf{x}$ is positive for some $i \in \{1, \dots, m\}$. This coordinate is $\sum_{j=1}^{n} a_{i,j} x_j$ and satisfies the inequality

$$0 < \sum_{j=1}^{n} a_{i,j} x_j \le b_i.$$

Because P is a cone, for all $\lambda > 0$ we have $\lambda \mathbf{x} \in P$ and so $\lambda A\mathbf{x} = A(\lambda \mathbf{x}) \leq \mathbf{b}$. The *i*th coordinate of the vector $\lambda A\mathbf{x}$ satisfies the inequality

$$0 < \lambda \sum_{j=1}^{n} a_{i,j} x_j \le b_i$$

for all $\lambda > 0$, which is absurd. Therefore, $P = \{ \mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \leq \mathbf{0} \}$. This completes the proof.

Lemma 3. Let V and V' be real vector spaces and let $T: V \to V'$ be a linear transformation. If X is a cone in V, then Y = T(X) is a cone in V'. In particular, the projection of a cone in \mathbb{R}^n is a cone.

Proof. Let C be a cone in V. If $\mathbf{w} \in T(C)$, then $\mathbf{w} = T(\mathbf{v})$ for some $\mathbf{v} \in V$. For all $\lambda \geq 0$ we have $\lambda \mathbf{v} \in C$ and so

$$\lambda \mathbf{w} = \lambda T(\mathbf{v}) = T(\lambda \mathbf{v}) \in T(C)$$

and so T(C) is a cone.

Every projection $\pi_{n,k}: \mathbf{R}^n \to \mathbf{R}^{n-k}$ is a linear transformation and so the projection of a cone is a cone. This completes the proof.

Notation. For
$$\mathbf{y} = \begin{pmatrix} y_1 \\ \vdots \\ y_p \end{pmatrix} \in \mathbf{R}^p$$
 and $\mathbf{x} \in \begin{pmatrix} x_1 \\ \vdots \\ x_n \end{pmatrix} \in \mathbf{R}^n$, let $\begin{pmatrix} \mathbf{y} \\ \mathbf{x} \end{pmatrix} = \begin{pmatrix} y_1 \\ \vdots \\ y_p \\ x_1 \\ \vdots \\ x_n \end{pmatrix} \in$

 \mathbf{R}^{p+n} . Let I_n be the $n \times n$ identity matrix and $\mathbf{0}_{p,n}$ the $p \times n$ zero matrix.

Theorem 4 (Weyl). Every finitely generated convex cone is a polyhedral cone.

Proof. Let C be the convex cone in \mathbf{R}^n generated by the finite set of vectors $\{\mathbf{w}_1, \dots, \mathbf{w}_p\}$. Let W be the $n \times p$ matrix whose column vectors are $(\mathbf{w}_1, \dots, \mathbf{w}_p)$. Then

$$C = \{W\mathbf{y} : \mathbf{y} \in \mathbf{R}^p \text{ and } \mathbf{y} \geq \mathbf{0}\}.$$

Consider the set

$$P = \left\{ \begin{pmatrix} \mathbf{y} \\ W \mathbf{y} \end{pmatrix} : \mathbf{y} \in \mathbf{R}^p, \mathbf{y} \ge \mathbf{0} \right\} \subseteq \mathbf{R}^{p+n}.$$

We have

$$\begin{split} P &= \left\{ \begin{pmatrix} \mathbf{y} \\ \mathbf{x} \end{pmatrix} : \mathbf{y} \in \mathbf{R}^p, \mathbf{y} \geq \mathbf{0}, \mathbf{x} = W \mathbf{y} \right\} \\ &= \left\{ \begin{pmatrix} \mathbf{y} \\ \mathbf{x} \end{pmatrix} : \mathbf{y} \in \mathbf{R}^p, \mathbf{x} \in \mathbf{R}^n, -\mathbf{y} \leq \mathbf{0}, W \mathbf{y} - \mathbf{x} \leq \mathbf{0}, -W \mathbf{y} + \mathbf{x} \leq \mathbf{0} \right\} \\ &= \left\{ \mathbf{z} \in \mathbf{R}^{p+n} : \tilde{W} \mathbf{z} \leq \mathbf{0} \right\} \end{split}$$

where \tilde{W} is the $(p+2n)\times(p+n)$ matrix written in block form as

$$\tilde{W} = \begin{pmatrix} -I_p & \mathbf{0}_{p,n} \\ W & -I_n \\ -W & I_n \end{pmatrix}.$$

It follows from Lemma 2 that P is a polyhedral cone.

Let $\mathbf{y} \in \mathbf{R}^p$ and $\mathbf{x} \in \mathbf{R}^n$. The projection $\pi_{p+n,p} : \mathbf{R}^{p+n} \to \mathbf{R}^n$ is defined by $\pi_{p+n,p} \begin{pmatrix} \mathbf{y} \\ \mathbf{x} \end{pmatrix} = \mathbf{x}$. We have the cone

$$\pi_{p+n,p}(P) = \{W\mathbf{y} : \mathbf{y} \in \mathbf{R}^p \text{ and } \mathbf{y} \ge \mathbf{0}\} = C.$$

By Theorem 1, the set $C = \pi_{p+n,p}(P)$ is a polyhedron, and so C is a polyhedral cone. This completes the proof.

The following result is an example of what is called a "theorem of the alternative."

Theorem 5 (Farkas lemma). Let W be an $n \times p$ matrix and let $\mathbf{b} \in \mathbf{R}^n$. Exactly one of the following two statements holds:

(a) There is a vector $\mathbf{y} \in \mathbf{R}^p$ such that

$$\mathbf{y} \geq \mathbf{0} \qquad and \qquad W\mathbf{y} = \mathbf{b}.$$

(b) There is a vector $\mathbf{v} \in \mathbf{R}^n$ such that

$$\mathbf{v}^t W \le \mathbf{0}^t$$
 and $\mathbf{v}^t \mathbf{b} > 0$.

Proof. Suppose that alternative (a) holds and that $\mathbf{y} \in \mathbf{R}^p$ satisfies $\mathbf{y} \geq \mathbf{0}$ and $W\mathbf{y} = \mathbf{b}$. If $\mathbf{v} \in \mathbf{R}^n$ and $\mathbf{v}^t W \leq \mathbf{0}^t$, then

$$\mathbf{v}^t \mathbf{b} = \mathbf{v}^t (W \mathbf{v}) = (\mathbf{v}^t W) \mathbf{v} < 0$$

and so alternative (b) does not hold.

Let $\mathbf{w}_1, \dots, \mathbf{w}_p$ be the column vectors of the matrix W and let

$$C(W) = \{W\mathbf{y} : \mathbf{y} \in \mathbf{R}^p \text{ and } \mathbf{y} \geq \mathbf{0}\}\$$

be the convex cone in \mathbf{R}^n generated by the finite sequence $(\mathbf{w}_1, \dots, \mathbf{w}_p)$. By Weyl's theorem (Theorem 4), the finitely generated convex cone C(W) is a polyhedral cone and so there is an $m \times n$ matrix A such that

$$C(W) = P(A) = \{ \mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \le \mathbf{0} \}.$$

If alternative (a) does not hold, then $\mathbf{b} \notin C(W)$ and so $A\mathbf{b} \not\leq \mathbf{0}$. This means that the *i*th coordinate of the vector $A\mathbf{b}$ is positive for some $i \in \{1, ..., n\}$. Let

 $(a_{i,1},\ldots,a_{i,n})$ be the *i*th row of the matrix A and let $\mathbf{v}=(a_{i,1},\ldots,a_{i,n})^t\in\mathbf{R}^n$. The *i*th coordinate of $A\mathbf{b}$ is $\mathbf{v}^t\mathbf{b}=\sum_{j=1}^n a_{i,j}b_j$ and so $\mathbf{v}^t\mathbf{b}>0$.

For all $j \in \{1, ..., p\}$, the jth column vector $\mathbf{w}_j = W\mathbf{e}_j$ belongs to the convex cone C(W), and so $A\mathbf{w}_j \leq \mathbf{0}$. The vector $A\mathbf{w}_j$ is the jth column vector of the matrix AW. Therefore, the $m \times h$ matrix AW is nonnegative. Because \mathbf{v}^t is the ith row of A, it follows that \mathbf{v}^tW is the ith row of AW and so $\mathbf{v}^tW \leq \mathbf{0}^t$. Thus, alternative (b) holds if alternative (a) does not hold. This completes the proof of the Farkas lemma.

5. A Duality

Associated to every $m \times n$ matrix A are two convex sets in \mathbf{R}^n : The polyhedral cone

$$P = P(A) = \{ \mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \le \mathbf{0} \}$$

and the finitely generated convex cone

$$C = C(A^t) = \{A^t \mathbf{y} : \mathbf{y} \in \mathbf{R}^m \text{ and } \mathbf{y} \ge \mathbf{0}\}.$$

Consider, for example, the matrices

$$A_1 = \begin{pmatrix} -1 & 0 \\ 0 & -1 \\ -1 & 1 \end{pmatrix}$$
 and $A_1^t = \begin{pmatrix} -1 & 0 & -1 \\ 0 & -1 & 1 \end{pmatrix}$.

We have the polyhedral cone

$$P(A_1) = \left\{ \mathbf{x} \in \mathbf{R}^2 : A\mathbf{x} \le \mathbf{0} \right\}$$

$$= \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \in \mathbf{R}^2 : \begin{pmatrix} -1 & 0 \\ 0 & -1 \\ -1 & 1 \end{pmatrix} \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \le \begin{pmatrix} 0 \\ 0 \\ 0 \end{pmatrix} \right\}$$

$$= \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \in \mathbf{R}^2 : \begin{pmatrix} -x_1 \\ -x_2 \\ x_2 - x_1 \end{pmatrix} \le \begin{pmatrix} 0 \\ 0 \\ 0 \end{pmatrix} \right\}$$

$$= \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \in \mathbf{R}^2 : 0 \le x_2 \le x_1 \right\}$$

and the convex cone

$$C(A_1^t) = \left\{ A^t \mathbf{y} : \mathbf{y} \in \mathbf{R}^3 \text{ and } \mathbf{y} \ge \mathbf{0} \right\}$$

$$= \left\{ \begin{pmatrix} -1 & 0 & -1 \\ 0 & -1 & 1 \end{pmatrix} \begin{pmatrix} y_1 \\ y_2 \\ y_3 \end{pmatrix} : y_1, y_2, y_3 \ge \mathbf{0} \right\}$$

$$= \left\{ \begin{pmatrix} -y_1 - y_3 \\ -y_2 + y_3 \end{pmatrix} : y_1, y_2, y_3 \ge \mathbf{0} \right\}.$$

Setting $x_1 = -y_1 - y_3 \le 0$ and $x_2 = -y_2 + y_3 = -x_1 - y_1 - y_2 \le -x_1$, we obtain

$$\left\{ \begin{pmatrix} -y_1 - y_3 \\ -y_2 + y_3 \end{pmatrix} : y_1, y_2, y_3 \ge \mathbf{0} \right\} \subseteq \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \in \mathbf{R}^2 : x_1 \le 0 \text{ and } x_2 \le -x_1 \right\}.$$

If $x_1 \leq 0$ and $x_2 \leq -x_1$, then choosing $y_1 = 0$, $y_2 = -x_1 - x_2 \geq 0$, and $y_3 = -x_1 \geq 0$ gives

$$\begin{pmatrix} x_1 \\ x_2 \end{pmatrix} = \begin{pmatrix} -y_1 - y_3 \\ -y_2 + y_3 \end{pmatrix} \in C(A_1^t)$$




FIGURE 1. The cone $C(A_1^t)$ (blue) and the polyhedron $P(A_1)$ (red)

and so

$$C(A_1^t) = \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \in \mathbf{R}^2 : x_1 \le 0 \text{ and } x_2 \le -x_1 \right\}.$$

By Weyl's theorem, the cone $C(A_1^t)$ is a polyhedral cone. Indeed, $C(A_1^t)$ is defined by the inequalities $x_1 \leq 0$ and $x_2 \leq -x_1$. Consider the 2×2 matrices

$$B_1 = \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix}$$
 and $B_1^t = \begin{pmatrix} 1 & 1 \\ 0 & 1 \end{pmatrix}$.

We have the polyhedral cone

$$P(B_1) = \left\{ \mathbf{x} \in \mathbf{R}^2 : B_1 \mathbf{x} \le \mathbf{0} \right\}$$

$$= \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \in \mathbf{R}^2 : \begin{pmatrix} 1 & 0 \\ 1 & 1 \end{pmatrix} \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \le \begin{pmatrix} 0 \\ 0 \end{pmatrix} \right\}$$

$$= \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \in \mathbf{R}^2 : x_1 \le 0 \text{ and } x_1 + x_2 \le 0 \right\}$$

$$= C(A_i^t).$$

Thus,

(5)
$$\left\{\mathbf{x} \in \mathbf{R}^2 : B_1 \mathbf{x} \le \mathbf{0}\right\} = \left\{A_1^t \mathbf{y} : \mathbf{y} \in \mathbf{R}^3 \text{ and } \mathbf{y} \ge \mathbf{0}\right\}.$$

The 2×2 matrix B_1^t defines the convex cone

$$C(B_1^t) = \left\{ B_1^t \mathbf{y} : \mathbf{y} \in \mathbf{R}^2 \text{ and } \mathbf{y} \ge \mathbf{0} \right\}$$

$$= \left\{ \begin{pmatrix} 1 & 1 \\ 0 & 1 \end{pmatrix} \begin{pmatrix} y_1 \\ y_2 \end{pmatrix} : y_1, y_2 \ge 0 \right\}$$

$$= \left\{ \begin{pmatrix} y_1 + y_2 \\ y_2 \end{pmatrix} \begin{pmatrix} y_1 \\ y_2 \end{pmatrix} : y_1, y_2 \ge 0 \right\}$$

$$= \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} \in \mathbf{R}^2 : 0 \le x_2 \le x_1 \right\}$$

$$= P(A_1)$$

and so

(6)
$$\left\{ \mathbf{x} \in \mathbf{R}^2 : A_1 \mathbf{x} \le \mathbf{0} \right\} = \left\{ B_1^t \mathbf{y} : \mathbf{y} \in \mathbf{R}^2 \text{ and } \mathbf{y} \ge \mathbf{0} \right\}.$$

Relations (5) and (6) illustrate the following result.

Theorem 6. Let A be an $m \times n$ matrix and let B be an $n \times p$ matrix. If

(7)
$$P(A) = \{ \mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \le \mathbf{0} \} = \{ B\mathbf{y} : \mathbf{y} \in \mathbf{R}^p \text{ and } \mathbf{y} \ge \mathbf{0} \} = C(B)$$
then

(8)
$$P(B^t) = {\mathbf{x} \in \mathbf{R}^n : B^t \mathbf{x} \le \mathbf{0}} = {A^t \mathbf{y} : \mathbf{y} \in \mathbf{R}^m \text{ and } \mathbf{y} \ge \mathbf{0}} = C(A^t).$$

Proof. For $j \in \{1, ..., h\}$, the jth column vector of B is

$$\mathbf{b}_j = B\mathbf{e}_j \in \{B\mathbf{y} : \mathbf{y} \in \mathbf{R}^p \text{ and } \mathbf{y} \ge \mathbf{0}\}\$$

and so

$$\mathbf{b}_i \in {\mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \le \mathbf{0}}$$

by equation (7). The vector inequalities $A\mathbf{b}_j \leq \mathbf{0}$ for all $j \in \{1, \dots, p\}$ imply the matrix inequality $AB \leq \mathbf{0}$. The transpose of the matrix AB is also nonpositive:

$$B^t A^t = (AB)^t < \mathbf{0}.$$

It follows that for all $y \geq 0$ we have

$$B^t\left(A^t\mathbf{y}\right) = \left(B^tA^t\right)\mathbf{y} \le \mathbf{0}$$

and so

$$C(A^t) = \{A^t \mathbf{y} : \mathbf{y} \in \mathbf{R}^m \text{ and } \mathbf{y} \ge \mathbf{0}\} \subseteq \{\mathbf{x} \in \mathbf{R}^n : B^t \mathbf{x} \le \mathbf{0}\} = P(B^t).$$

We must prove the reverse inclusion: $P(B^t) \subseteq C(A^t)$. Let $\mathbf{x} \in \mathbf{R}^n$ with $B^t \mathbf{x} \leq \mathbf{0}$. If $A^t \mathbf{y} \neq \mathbf{x}$ for all $\mathbf{y} \in \mathbf{R}^m$ with $\mathbf{y} \geq \mathbf{0}$, then the Farkas Lemma (Theorem 5) implies that there exists a vector $\mathbf{v} \in \mathbf{R}^n$ such that

(9)
$$(A\mathbf{v})^t = \mathbf{v}^t A^t < \mathbf{0}^t \quad \text{and} \quad \mathbf{v}^t \mathbf{x} > 0.$$

The inequalities $(A\mathbf{v})^t \leq \mathbf{0}^t$ and $A\mathbf{v} \leq \mathbf{0}$ are equivalent. Equation (7) implies $\mathbf{v} = B\mathbf{y}$ for some $\mathbf{y} \geq \mathbf{0}$. The inequalities $\mathbf{y} \geq \mathbf{0}$ and $\mathbf{y}^t \geq \mathbf{0}^t$ are equivalent. From $\mathbf{y}^t \geq \mathbf{0}^t$ and $B^t\mathbf{x} \leq \mathbf{0}$ we obtain

$$\mathbf{v}^t \mathbf{x} = (B\mathbf{y})^t \mathbf{x} = (\mathbf{y}^t B^t) \mathbf{x} = \mathbf{y}^t (B^t \mathbf{x}) \le 0$$

which contradicts (9). Therefore,

$$P(B^t) = {\mathbf{x} \in \mathbf{R}^n : B^t \mathbf{x} \le \mathbf{0}} \subseteq {A^t \mathbf{y} : \mathbf{y} \in \mathbf{R}^m \text{ and } \mathbf{y} \ge \mathbf{0}} = C(A^t).$$

This completes the proof.

We can now prove the converse of Weyl's Theorem.

Theorem 7 (Minkowski). Every polyhedral cone is a finitely generated convex cone.

Proof. Let A be an $m \times n$ matrix. Consider the polyhedral cone $P(A) = \{ \mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \leq \mathbf{0} \}$ and the finitely generated convex cone $C(A^t) = \{ A^t\mathbf{y} : \mathbf{y} \in \mathbf{R}^m \text{ and } \mathbf{y} \geq \mathbf{0} \}$. By Weyl's theorem, the cone $C(A^t)$ is polyhedral and so there is an $n \times p$ matrix B such that

$$C(A^t) = \{A^t \mathbf{y} : \mathbf{y} \in \mathbf{R}^m \text{ and } \mathbf{y} \ge \mathbf{0}\} = \{\mathbf{x} \in \mathbf{R}^n : B^t \mathbf{x} \le \mathbf{0}\} = P(B^t).$$

Theorem 6 implies that

$$P(A) = {\mathbf{x} \in \mathbf{R}^n : A\mathbf{x} < \mathbf{0}} = {B\mathbf{v} : \mathbf{v} \in \mathbf{R}^p \text{ and } \mathbf{v} > \mathbf{0}} = C(B)$$




FIGURE 2. The polyhedron $P_1 = Q_1 + C_1$

and so P(A) is a finitely generated convex cone. This completes the proof.

6. Structure of Polyhedra

A polytope in \mathbf{R}^k is the convex hull of a finite set of points in \mathbf{R}^k . For example, the set $\Delta_k = \text{conv}(\mathbf{e}_1, \dots, \mathbf{e}_k)$ is a polytope. A triangle in \mathbf{R}^k is a polytope that is the convex hull of three non-collinear points. The convex hull of the set $\{\begin{pmatrix} 0\\0 \end{pmatrix}, \begin{pmatrix} 2\\0 \end{pmatrix}, \begin{pmatrix} 0\\2 \end{pmatrix}\}$ is the triangle

$$T = \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} : 0 \le x_1 \le 2 \text{ and } 0 \le x_2 \le 2 - x_1 \right\}.$$

The triangle T is also convexly generated by the set $\left\{ \begin{pmatrix} 0 \\ 0 \end{pmatrix}, \begin{pmatrix} 2 \\ 0 \end{pmatrix}, \begin{pmatrix} 1 \\ 1 \end{pmatrix}, \begin{pmatrix} 1 \\ 1/2 \end{pmatrix}, \begin{pmatrix} 0 \\ 2 \end{pmatrix} \right\}$ and by the set $\left\{ (x,0) : 0 \le x \le 2 \right\} \cup \left\{ (0,2) \right\}$.

The sum (sometimes called the Minkowski sum) of subsets C and Q in \mathbf{R}^k is the set

$$C + Q = \{\mathbf{u} + \mathbf{v} : \mathbf{u} \in C \text{ and } \mathbf{v} \in Q\}.$$

We shall prove that every polyhedron is the sum of a finitely generated convex cone and a polytope, and that, conversely, every sum of a finitely generated convex cone and a polytope is a polyhedron.

Here are two examples. Let

$$A_1 = \begin{pmatrix} -1 & 0 \\ 0 & -1 \\ -1 & -1 \end{pmatrix} \in \mathbf{R}^{3,2} \quad \text{and} \quad \mathbf{b}_1 = \begin{pmatrix} 0 \\ 0 \\ -1 \end{pmatrix} \in \mathbf{R}^3.$$

The polyhedron

$$P_{1} = \left\{ \mathbf{x} \in \mathbf{R}^{2} : A_{1}\mathbf{x} \leq \mathbf{b}_{1} \right\}$$
$$= \left\{ \begin{pmatrix} x_{1} \\ x_{2} \end{pmatrix} : x_{1} \geq 0, \ x_{2} \geq 0, \ x_{1} + x_{2} \geq 1 \right\}.$$

is the sum of the convex cone

$$C_1 = \{I_2 \mathbf{x} : \mathbf{x} \ge \mathbf{0}\} = \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} : x_1 \ge 0, \ x_2 \ge 0 \right\}.$$

and the polytope $Q_1 = \Delta_2$.




FIGURE 3. The polyhedron $P_2 = Q_2 + C_2$ and the polytope Q_2

Let

$$A_2 = \begin{pmatrix} -1 & 1\\ 1 & -1\\ -1 & -1\\ -2 & -1\\ -1 & -2 \end{pmatrix} \in \mathbf{R}^{5,2} \quad \text{and} \quad \mathbf{b}_1 = \begin{pmatrix} 4\\ 4\\ -3\\ -4\\ -4 \end{pmatrix} \in \mathbf{R}^5.$$

The polyhedron

$$P_2 = \left\{ \mathbf{x} \in \mathbf{R}^2 : A_2 \mathbf{x} \le \mathbf{b}_2 \right\}$$

$$= \left\{ \begin{pmatrix} x_1 \\ x_2 \end{pmatrix} : -4 \le x_1 - x_2 \le 4, \ x_1 + x_2 \ge 3, \ 2x_1 + x_2 \ge 4, \ x_1 + 2x_2 \ge 4 \right\}.$$

is the sum of the convex cone

$$C_2 = \left\{ \begin{pmatrix} 1 \\ 1 \end{pmatrix} (x_1) : x_1 \ge 0 \right\} = \left\{ \begin{pmatrix} x_1 \\ x_1 \end{pmatrix} : x_1 \ge 0 \right\}.$$

and the polytope

$$Q_2 = \left\{ \lambda_1 \begin{pmatrix} 0 \\ 4 \end{pmatrix} + \lambda_2 \begin{pmatrix} 1 \\ 2 \end{pmatrix} + \lambda_3 \begin{pmatrix} 2 \\ 1 \end{pmatrix} + \lambda_4 \begin{pmatrix} 4 \\ 0 \end{pmatrix} : \begin{pmatrix} \lambda_1 \\ \lambda_2 \\ \lambda_3 \\ \lambda_4 \end{pmatrix} \in \Delta_4 \right\}.$$

Theorem 8. A subset P of \mathbb{R}^n is a polyhedron if and only if there is a polytope Q and a finitely generated convex cone C such that P = Q + C.

Proof. Every vector in \mathbf{R}^{n+1} can be written uniquely in the form $\begin{pmatrix} \mathbf{x} \\ t \end{pmatrix}$ for some $\mathbf{x} \in \mathbf{R}^n$ and $t \in \mathbf{R}$. For every $\ell \times n$ matrix $A = \begin{pmatrix} a_{i,j} \end{pmatrix}$ and vector $\mathbf{b} = \begin{pmatrix} b_1 \\ \vdots \\ b_\ell \end{pmatrix} \in \mathbf{R}^\ell$, let $(A|\mathbf{b})$ be the $\ell \times (n+1)$ matrix whose ith row is $(a_{i,1}, \dots, a_{i,n}, b_i)$ for all $i \in \{1, \dots, \ell\}$. Every $\ell \times (n+1)$ matrix \widehat{A} can be written uniquely in the form $\widehat{A} = (A|\mathbf{b})$ for some $\ell \times n$ matrix A and vector $\mathbf{b} \in \mathbf{R}^\ell$. For $\mathbf{x} = \begin{pmatrix} x_1 \\ \vdots \\ x_n \end{pmatrix} \in \mathbf{R}^n$ and $t \in \mathbf{R}$, the ith

coordinate of the vector $(A|\mathbf{b}) \begin{pmatrix} \mathbf{x} \\ t \end{pmatrix} \in \mathbf{R}^{\ell}$ is $\sum_{j=1}^{n} a_{i,j} x_j + b_i t$. Thus, the vector inequality $(A|\mathbf{b}) \begin{pmatrix} \mathbf{x} \\ t \end{pmatrix} \leq \mathbf{0}$ is equivalent to the ℓ inequalities

$$\sum_{j=1}^{n} a_{i,j} x_j \le -tb_i$$

for all $i \in \{1, \dots, \ell\}$ and so

(10)
$$(A|\mathbf{b}) \begin{pmatrix} \mathbf{x} \\ t \end{pmatrix} \leq \mathbf{0}$$
 if and only if $A\mathbf{x} \leq -t\mathbf{b}$.

More generally, let $A_k = \left(a_{i,j}^{(k)}\right)$ be an $m \times n_k$ matrix for all $k \in \{1, \dots, \ell\}$ and let $n = \sum_{k=1}^{\ell} n_k$. Let

$$A = (A_1 | \cdots | A_k | \cdots | A_\ell)$$

be the $m \times n$ matrix obtained by concatenating the matrices A_1, \ldots, A_ℓ . Thus, for $k \in \{1, \dots, \ell\}$ and $j \in \{1, \dots, n_k\}$, the $\left(\sum_{r=1}^{k-1} n_r + j\right)$ th column of A is

$$\operatorname{col}_{j}(A_{k}) = \begin{pmatrix} a_{1,j}^{(k)} \\ \vdots \\ a_{m,j}^{(k)} \end{pmatrix}.$$

The coordinate in row i and column $\sum_{r=1}^{k-1} n_r + j$ of the matrix A is $a_{i,j}^{(k)}$. Let Q be a polytope in \mathbf{R}^n and let C be a finitely generated convex cone in \mathbf{R}^n . We shall prove that the sumset P = Q + C is a polyhedron.

Let $h \geq 2$ and let $\mathbf{b}_1, \dots, \mathbf{b}_h$ be vectors in \mathbf{R}^n . For $k \in \{1, \dots, h-1\}$, let \widehat{P} be the convex cone in \mathbf{R}^{n+1} conically generated by the finite sequence of vectors

$$\left(\begin{pmatrix}\mathbf{b}_1\\1\end{pmatrix},\ldots,\begin{pmatrix}\mathbf{b}_k\\1\end{pmatrix},\begin{pmatrix}\mathbf{b}_{k+1}\\0\end{pmatrix},\ldots,\begin{pmatrix}\mathbf{b}_h\\0\end{pmatrix}\right).$$

Thus,

$$\widehat{P} = \left\{ \sum_{j=1}^{k} \lambda_j \begin{pmatrix} \mathbf{b}_j \\ 1 \end{pmatrix} + \sum_{j=k+1}^{h} \lambda_j \begin{pmatrix} \mathbf{b}_j \\ 0 \end{pmatrix} : \lambda_1, \dots, \lambda_k, \lambda_{k+1}, \dots, \lambda_h \ge 0 \right\}.$$

By Weyl's theorem (Theorem 4) and by relation (10), the finitely generated convex cone \widehat{P} is a polyhedral cone, and so there is an $\ell \times n$ matrix A and a vector $\mathbf{b} \in \mathbf{R}^{\ell}$ such that the $\ell \times (n+1)$ matrix $(A|\mathbf{b})$ satisfies

(11)
$$\widehat{P} = \left\{ \begin{pmatrix} \mathbf{x} \\ t \end{pmatrix} \in \mathbf{R}^{n+1} : (A|\mathbf{b}) \begin{pmatrix} \mathbf{x} \\ t \end{pmatrix} \le \mathbf{0} \right\} = \left\{ \begin{pmatrix} \mathbf{x} \\ t \end{pmatrix} \in \mathbf{R}^{n+1} : A\mathbf{x} \le -t\mathbf{b} \right\}.$$

Let $(\mathbf{w}_1, \dots, \mathbf{w}_k)$ be a finite sequence of vectors that convexly generates the polytope Q and let $(\mathbf{w}_{k+1}, \dots, \mathbf{w}_h)$ be a finite sequence of vectors that conically generates the cone C. If $\mathbf{x} \in Q + C$, then

$$\mathbf{x} = \mathbf{x}_Q + \mathbf{x}_C$$

with

$$\mathbf{x}_Q = \sum_{j=1}^k \lambda_j \mathbf{w}_j \in Q$$
 and $\mathbf{x}_C = \sum_{j=k+1}^h \lambda_j \mathbf{w}_j \in C$

and

$$\lambda_j \ge 0$$
 for all $j \in \{1, \dots, k, k+1, \dots, h\}$ and $\sum_{j=1}^k \lambda_j = 1$.

Thus,

$$\begin{pmatrix} \mathbf{x} \\ 1 \end{pmatrix} = \begin{pmatrix} \mathbf{x}_Q \\ 1 \end{pmatrix} + \begin{pmatrix} \mathbf{x}_C \\ 0 \end{pmatrix}$$

$$= \begin{pmatrix} \sum_{j=1}^k \lambda_j \mathbf{w}_j \\ \sum_{j=1}^k \lambda_j \end{pmatrix} + \begin{pmatrix} \sum_{j=k+1}^h \lambda_j \mathbf{w}_j \\ 0 \end{pmatrix}$$

$$= \sum_{j=1}^k \lambda_j \begin{pmatrix} \mathbf{w}_j \\ 1 \end{pmatrix} + \sum_{j=k+1}^h \lambda_j \begin{pmatrix} \mathbf{w}_j \\ 0 \end{pmatrix}$$

$$\in \hat{P}.$$

It follows from (11) that $A\mathbf{x} \leq -\mathbf{b}$ and so $C + Q \subseteq \{\mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \leq -\mathbf{b}\}.$

Similarly, if $\mathbf{x} \in \mathbf{R}^n$ and $A\mathbf{x} \leq -\mathbf{b}$, then $\begin{pmatrix} \mathbf{x} \\ 1 \end{pmatrix} \in \widehat{P}$ and there exist nonnegative numbers $\lambda_1, \ldots, \lambda_k, \lambda_{k+1}, \ldots, \lambda_h$ such that

$$\begin{pmatrix} \mathbf{x} \\ 1 \end{pmatrix} = \sum_{j=1}^{k} \lambda_j \begin{pmatrix} \mathbf{w}_j \\ 1 \end{pmatrix} + \sum_{j=k+1}^{h} \lambda_j \begin{pmatrix} \mathbf{w}_j \\ 0 \end{pmatrix}$$

$$= \begin{pmatrix} \sum_{j=1}^{k} \lambda_j \mathbf{w}_j \\ \sum_{j=1}^{k} \lambda_j \end{pmatrix} + \begin{pmatrix} \sum_{j=k+1}^{h} \lambda_j \mathbf{w}_j \\ 0 \end{pmatrix}.$$

It follows that $\sum_{j=1}^{k} \lambda_j = 1$ and so

$$\mathbf{x}_Q = \sum_{j=1}^k \lambda_j \mathbf{w}_j \in Q$$
 and $\mathbf{x}_C = \sum_{j=k+1}^h \lambda_j \mathbf{w}_j \in C$.

Thus, $\mathbf{x} = \mathbf{x}_Q + \mathbf{x}_C \in Q + C$ and $\{\mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \le -\mathbf{b}\} \subseteq Q + C$. This proves that

$$Q + C = \{ \mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \le -\mathbf{b} \}$$

and so the sum of a polytope and a finitely generated convex cone is a polyhedron. Conversely, we shall prove that every polyhedron is the sum of a finitely generated convex cone and a polytope. Let P be a polyhedron in \mathbb{R}^n . There is an $m \times n$ matrix $A = (a_{i,j})$ and a vector $\mathbf{b} \in \mathbf{R}^m$ such that

$$P = \{ \mathbf{x} \in \mathbf{R}^n : A\mathbf{x} \le \mathbf{b} \}.$$

Consider the $(m+1) \times (n+1)$ matrix

$$\widehat{A} = \begin{pmatrix} a_{1,1} & a_{1,1} & \cdots & a_{1,n} & -b_1 \\ a_{2,1} & a_{2,2} & \cdots & a_{2,n} & -b_2 \\ \vdots & & & \vdots \\ a_{m,1} & a_{m,2} & \cdots & a_{m,n} & -b_m \\ 0 & 0 & \cdots & 0 & -1 \end{pmatrix}$$

By Lemma 2, the set \widehat{P} in \mathbb{R}^{n+1} defined by

(12)
$$\widehat{P} = \left\{ \begin{pmatrix} \mathbf{x} \\ t \end{pmatrix} : \mathbf{x} \in \mathbf{R}^n, t \ge 0, A\mathbf{x} \le t\mathbf{b} \right\}$$
$$= \left\{ \begin{pmatrix} \mathbf{x} \\ t \end{pmatrix} \in \mathbf{R}^{n+1} : \widehat{A} \begin{pmatrix} \mathbf{x} \\ t \end{pmatrix} \le \mathbf{0} \right\}$$

is a polyhedral cone. We have $\mathbf{x} \in P$ if and only if $A\mathbf{x} \leq \mathbf{b}$ if and only if $\begin{pmatrix} \mathbf{x} \\ 1 \end{pmatrix} \in \widehat{P}$ and so

$$P = \left\{ \mathbf{x} \in \mathbf{R}^n : \begin{pmatrix} \mathbf{x} \\ 1 \end{pmatrix} \in \widehat{P} \right\}.$$

By Minkowski's theorem (Theorem 7), the polyhedral cone \widehat{P} is a finitely generated convex cone in \mathbb{R}^{n+1} , and so there is an $(n+1) \times h$ matrix W such that

$$\widehat{P} = \{ W\mathbf{y} : \mathbf{y} \in \mathbf{R}^h \text{ and } \mathbf{y} \ge 0 \}.$$

The set \widehat{P} is conically generated by the set of columns of W. For $j \in \{1, \ldots, h\}$, let $\begin{pmatrix} \mathbf{w}_j \\ t_j \end{pmatrix}$ be the jth column of W, where $\mathbf{w}_j \in \mathbf{R}^n$ and $t_j \in \mathbf{R}$. We have $t_j \geq 0$ because $\begin{pmatrix} \mathbf{w}_j \\ t_j \end{pmatrix} = W\mathbf{e}_j \in \widehat{P}$.

Modify the matrix W as follows: If $t_j > 0$, then multiply the jth column of W by $1/t_j > 0$. If $t_j = 0$, do not change the jth column of W. We obtain a new matrix, which we shall also denote by W, whose jth column is of the form $\begin{pmatrix} \mathbf{w}_j \\ \varepsilon_j \end{pmatrix}$ with $\varepsilon_j = 0$ or 1. Because the columns of the original matrix W have only been multiplied by positive numbers, the new matrix W still conically generates \widehat{P} . Renumber the vectors $\mathbf{w}_1, \ldots, \mathbf{w}_h$ so that

$$\{\mathbf{w}_j : \varepsilon_j = 1\} = \{\mathbf{w}_1, \dots, \mathbf{w}_k\}$$
 and $\{\mathbf{w}_j : \varepsilon_j = 0\} = \{\mathbf{w}_{k+1}, \dots, \mathbf{w}_h\}.$

Let Q be the polytope in \mathbf{R}^n convexly generated by the set $\{\mathbf{w}_1, \dots, \mathbf{w}_k\}$ and let C be the convex cone in \mathbf{R}^n conically generated by the set $\{\mathbf{w}_{k+1}, \dots, \mathbf{w}_h\}$. Let $Q = \{\mathbf{0}\}$ if k = 0, that is, $\{\mathbf{w}_j : \varepsilon_j = 1\} = \emptyset$, and let $C = \{\mathbf{0}\}$ if k = h.

We have $\mathbf{x} \in P$ if and only if $\begin{pmatrix} \mathbf{x} \\ 1 \end{pmatrix} \in \widehat{P}$ if and only if there is a nonnegative

vector
$$\lambda = \begin{pmatrix} \lambda_1 \\ \vdots \\ \dot{\lambda_h} \end{pmatrix}$$
 such that

$$\begin{pmatrix} \mathbf{x} \\ 1 \end{pmatrix} = W\lambda = \sum_{j=1}^{k} \lambda_j \begin{pmatrix} \mathbf{w}_j \\ 1 \end{pmatrix} + \sum_{j=k+1}^{h} \lambda_j \begin{pmatrix} \mathbf{w}_j \\ 0 \end{pmatrix}$$
$$= \begin{pmatrix} \sum_{j=1}^{k} \lambda_j \mathbf{w}_j \\ \sum_{j=1}^{k} \lambda_j \end{pmatrix} + \begin{pmatrix} \sum_{j=k+1}^{h} \lambda_j \mathbf{w}_j \\ 0 \end{pmatrix}.$$

It follows that $\sum_{j=1}^{k} \lambda_j = 1$ and so

$$\sum_{j=1}^{k} \lambda_j \mathbf{w}_j \in Q \quad \text{and} \quad \sum_{j=k+1}^{h} \lambda_j \mathbf{w}_j \in C.$$

We obtain

$$\mathbf{x} = \sum_{j=1}^{k} \lambda_j \mathbf{w}_j + \sum_{j=k+1}^{h} \lambda_j \mathbf{w}_j \in Q + C.$$

Thus, $P \subseteq Q + C$.

Now we prove that $Q + C \subseteq P$. If $\mathbf{x} \in Q + C$, then $\mathbf{x} = \mathbf{x}_Q + \mathbf{x}_C$, where

$$\mathbf{x}_Q = \sum_{j=1}^k \lambda_j \mathbf{w}_j \in Q$$
 and $\mathbf{x}_C = \sum_{j=k+1}^h \lambda_j \mathbf{w}_j \in C$

and $\lambda = \begin{pmatrix} \lambda_1 \\ \vdots \\ \lambda_h \end{pmatrix} \in \mathbf{R}^h$ is a nonnegative vector such that $\sum_{j=1}^k \lambda_j = 1$. Then

$$\begin{pmatrix} \mathbf{x} \\ 1 \end{pmatrix} = \begin{pmatrix} \mathbf{x}_Q \\ 1 \end{pmatrix} + \begin{pmatrix} \mathbf{x}_C \\ 0 \end{pmatrix}$$
$$= \sum_{j=1}^k \lambda_j \begin{pmatrix} \mathbf{w}_j \\ 1 \end{pmatrix} + \sum_{j=k+1}^h \lambda_j \begin{pmatrix} \mathbf{w}_j \\ 0 \end{pmatrix}$$
$$\in \widehat{P}$$

and so $\mathbf{x} \in P$. Thus, $C+Q \subseteq P$. It follows that P=C+Q and so every polyhedron is the sum of a finitely generated convex cone and a polytope. This completes the proof.

7. Notes

Much of the material in this paper derives from the classic paper of Weyl [3]. The English translation is Weyl [4]. Excellent introductions to convexity are the books by Eggleston [1] and Lauritzen [2].
