# On the essential algebra of the shifted Burnside biset functor

#### Abstract

We describe the essential algebra, $\widehat{k B_{T}}(G)$, of the Burnside biset functor shifted by a group $T$, at a group $G$, in two cases. First, when $G$ and $T$ are both finite abelian groups and $k$ is a field of characteristic 0 . In this case, $\widehat{k B_{T}}(G)$ is isomorphic to a quotient of the shifted star algebra, which is defined in terms of the subgroups of $G \times G \times T$. The second case is when $G$ and $T$ are any finite groups satisfying $(|G|,|T|)=1$ and $k$ is a commutative unitary ring. In this case, $\widehat{k B_{T}}(G)$ is isomorphic to a semidirect product of $\operatorname{Out}(G)$ and $k B^{Z(G)}(T)$, the monomial Burnside ring of $T$ with coefficients in $Z(G)$.

The aim of the article is to consider the natural set of generators of $\widehat{k B_{T}}(G)$ coming from the transitive elements in $k B_{T}(G \times G)$ and explore some cases in which it is possible to give a basis for $\widehat{k B_{T}}(G)$ in this set.

## Introduction

The notion of an essential algebra in the context of biset functors appeared first in the classification of simple biset functors (see, for example, [4] and [5]). Latter on, it showed to be a key element in the problem of classifying simple modules over an arbitrary Green biset functor (see [12] and [15]). More recently, the notion appeared in

[^0]other related context, such as the correspondence functors ( 8] and [9]) and the diagonal $p$-permutation functors ([6]). On the other hand, the shifted biset functors are now known to be a fundamental part of the theory of biset functors (see, for example, [7]).

The article is divided in four sections. In Section 1 we recall basic results regarding the shifted Burnside biset functor, $k B_{T}$, for $k$ a commutative ring with unity and $T$ a finite group. For further details on the theory of biset functors, please see [5]. In Section 2 we generalize some results by Boltje and Danz ([3]) regarding the star operation, obtaining shifted versions of them. In particular, if $k$ is a field of characteristic 0 , if $G$ is a finite group and if $\mathscr{S}_{G G T}$ denotes the set of subgroups of $G \times G \times T$, we show that there exists an injective ring homomorphism, non-unitary in general,

$$
\alpha_{G G T}: k B_{T}(G \times G) \rightarrow k \mathscr{S}_{G G T},
$$

where, of course, $k \mathscr{S}_{G G T}$ has a suitable star algebra structure. Furthermore, at the end of Section 2 we define an essential algebra $\overline{k \mathscr{S}}_{G G T}$ for $k \mathscr{S}_{G G T}$ and see that $\alpha_{G G T}$ extends to a (in general non-unitary) ring morphism $\widehat{\alpha}_{G G T}: \widehat{k B}_{T}(G) \rightarrow \widehat{k S}_{G G T}$. In Theorem 3.5 we show that if $G$ and $T$ are finite abelian groups, then $\widehat{\alpha}_{G G T}$ is a ring isomorphism.

The main result of the article is Theorem 3.11. Here we come back to the general case and show that for any groups $G$ and $T$ and $k$ a commutative unitary ring, if we consider the monomial Burnside ring $k B^{Z(G)}(T)$, then there is an injective algebra homomorphism

$$
\Phi: k B^{Z(G)}(T) \rtimes \operatorname{Out}(G) \rightarrow k B_{T}(G \times G)
$$

which actually extends injectively to $\widehat{k B_{T}}(G)$. As a consequence, in Corollary 3.12, we show that if $G$ and $T$ are groups such that $(|G|,|T|)=1$, then $\widehat{k B_{T}}(G)$ is isomorphic to $k B^{Z(G)}(T) \rtimes \operatorname{Out}(G)$. Furthermore, in this case we have an isomorphism of $k$-modules,

$$
k B_{T}(G \times G) \cong\left(k B^{Z(G)}(T) \rtimes \operatorname{Out}(G)\right) \oplus \mathcal{I}_{T}(G)
$$

where $\mathcal{I}_{T}(G)$ is the ideal of $k B_{T}(G \times G)$ generated by elements that factor through groups $K$ such that $|K|<|G|$. This generalizes the results of Bouc for the case $T=1$ (see Section 4 in [4]).

Along Section 3, we deal with some subsets of the set of generators of $\widehat{k B_{T}}(G)$ coming from the transitive elements in $k B_{T}(G \times G)$ that appear naturally in this context. So, in Section 4 we give examples, with $k$ being a field of characteristic 0 , to show that these sets may be properly contained in one another. The objective of this is to show that explicitly giving a basis for $\widehat{k B_{T}}(G)$ in this set of generators, in the general case, may not be an easy task. We also show that the morphism $\widehat{\alpha}_{G G T}$ is not injective in general.

A bit of the chronology of the article is worth mentioning. The first result to be conjectured by the author was a primitive version of Corollary 3.12. Then, Serge Bouc kindly provided wonderful help to confection a GAP program ([13]) to test this conjecture, which was rapidly confirmed in several examples. After observing other examples generated by the program at the same time, Theorem 3.5 was conjectured too. At this stage, the GAP program had became more sophisticated, the last version of it appears in subsection 4.3.

## 1 Preliminaries

We fix the following notation.
Throughout the article, $G, H$ and $K$ will be finite groups. The trivial group will be denoted by 1 and a cyclic group of order $n>1$ by $C_{n}$.

Whenever we have three or more finite groups, we will write $G H K$ for $G \times H \times K$.
If $a, g \in G$, we write ${ }^{a} g$ for $a g a^{-1}$ and $g^{a}$ for $a^{-1} g a$. Also, $c_{a}$ denotes the conjugation on $G$ by $a \in G$, sending $g \in G$ to $a g a^{-1}$.

If $\sigma: G \rightarrow G$ is an automorphism of $G$, then $\Delta_{\sigma}(G)$ is the subgroup of $G \times G$, $\{(\sigma(g), g) \mid g \in G\}$. If $\sigma$ is the identity, then we simply write $\Delta(G)$.

We write $\mathscr{S}_{G}$ for the set of subgroups of $G$ and $\left[\mathscr{S}_{G}\right]$ for a set of representatives of the conjugacy classes of $\mathscr{S}_{G}$.

In this section, $k$ will be a commutative unitary ring and $T$ will be a finite group.

### 1.1 The shifted Burnside functor

We recall some results from sections 2.3 and 8.2 of [5], and Section 4.2 of [14]. Lemma 2.3.25 in [5] will be called Goursat's lemma.

Recall that the biset functor $k B_{T}$ sends a finite group $G$ to the Burnside group $k B_{T}(G)=k B(G \times T)$. In a finite $(H, G)$-biset $X$, it defines a morphism of $k$-modules

$$
k B_{T}(X): k B_{T}(G) \rightarrow k B_{T}(H) ; \quad y \mapsto k B(X \times T)(y)
$$

It is straightforward to see that if $Y$ is a $(G \times T)$-set, then $k B(X \times T)(Y)$ is isomorphic, as $(H \times T)$-set, to $X \times_{G} Y$ with the action of $T$ given by $t[x, y]=[x, t y]$, for $[x, y]$ in $X \times_{G} Y$. We will denote this operation by $X \times_{G}^{d} Y$. The superscript $d$ stands for diagonal, we will see next why this notation makes sense.

The category $\mathcal{P}_{k B_{T}}$, associated to $k B_{T}$, has for objects the class of finite groups and as set of arrows from a group $G$ to a group $H$, the $k$-module $k B_{T}(H \times G)$. Composition in $\mathcal{P}_{k B_{T}}$ is given in the following way: if $X$ is a $H G T$-set and $Y$ is a $G K T$-set, then
$X \circ Y$ is the $H K T$-set $X \times{ }_{G}^{d} Y$, that is, it is the $H \times K$-set $X \times_{G} Y$ with diagonal action of $T, t[x, y]=[t x, t y]$. The operation of the previous paragraph can be seen as a particular case of this composition, with $K=1$ and the action of $T$ on $X$ being trivial.

For a group $G$, we have then the endomorphism algebra $k B_{T}(G \times G)$, with identity given by the isomorphism class of $(G G T) /(\Delta(G) T)$.

Notation 1.1. Let $D$ be a subgroup of $H K T$. We will write $p_{1}(D), p_{2}(D)$ and $p_{3}(D)$ for the projections of $D$ in $H, K$ and $T$ respectively, $p_{1,2}(D)$ will denote the projection over $H \times K$, and in the same way we define the other possible combinations of subscripts. We write $k_{1}(D)$ for $\{h \in H \mid(h, 1,1) \in D\}$, which is a normal subgroup of $p_{1}(D)$. Similarly, we define $k_{2}(D), k_{3}(D)$ and $k_{i, j}(D)$ for all possible combinations of $i$ and $j$.

If $E$ is a subgroup of $K G T$, we denote by $D * E$ the set

$$
\{(h, g, t) \in H G T \mid \exists x \in K \text { s.t. }(h, x, t) \in D \text { and }(x, g, t) \in E\}
$$

We have the following results.
Lemma 1.2. Let $G, H$ and $K$ be groups, $U$ be an HGT-set and $V$ be a KHT-set. Then if $u \in U$ and $v \in V$, the stabilizer of $[v, u] \in V \times_{H}^{d} U$ under the action of $K G T$ is

$$
\operatorname{Stab}_{K G T}([v, u])=\operatorname{Stab}_{K H T}(v) * \operatorname{Stab}_{H G T}(u)
$$

Proof. The proof is a straightforward generalization of that of Lemma 2.3.20 in [5].
The next two lemmas are proved in [14]. We include the statements here, since it will be useful to have them at hand in the next sections.

Lemma 1.3 (Lemma 4.5 in [14]). Let $G, L, K$ and $T$ be groups. If $E$ is a subgroup of $G L T$ and $D$ is a subgroup of $L K T$, then we have an isomorphism

$$
(G L T) / E \times_{L}^{d}(L K T) / D \cong \bigsqcup_{(l, t)}(G K T) /\left(E *^{(l, 1, t)} D\right)
$$

of GKT-sets. Here $(l, t)$ runs through a set of representatives of the double cosets $p_{2,3}(E) \backslash L \times T / p_{1,3}(D)$.

Lemma 1.4 (Lemma 4.8 in [14]). If $D$ is a subgroup of HKT, then the HKT-set $(H K T) / D$ is isomorphic to
i) $X \times{ }_{D_{1}}^{d} Y$, where $D_{1}=p_{1}(D) / k_{1}(D)$, for some $X \in k B_{T}\left(H \times D_{1}\right)$ and $Y \in$ $k B_{T}\left(D_{1} \times K\right)$.
ii) $W \times_{D_{2}}^{d} Z$ where $D_{2}=p_{2}(D) / k_{2}(D)$, for some $W \in k B_{T}\left(H \times D_{2}\right)$ and $Z \in$ $k B_{T}\left(D_{2} \times K\right)$.

The last basic result of this section is a straightforward generalization of point 2 of Lemma 2.3.22 in [5].

Lemma 1.5. Let $G, H$ and $K$ be groups. Let $L$ be a subgroup of $H G T$ and $M$ be a subgroup of KHT. There are inclusions of subgroups

$$
\begin{aligned}
& k_{1}(M) \subseteq k_{1}(M * L) \subseteq p_{1}(M * L) \\
& \subseteq p_{1}(M) \\
& k_{2}(L) \subseteq k_{2}(M * L) \subseteq p_{2}(M * L) \subseteq p_{2}(L), \\
& k_{3}(M) \cap k_{3}(L) \subseteq k_{3}(M * L) \subseteq p_{3}(M * L) \subseteq p_{3}(M) \cap p_{3}(L) .
\end{aligned}
$$

### 1.2 The essential algebra

The essential algebra of $k B_{T}$ at a group $G$ is defined as the quotient of the endomorphism algebra of $G$ in $\mathcal{P}_{k B_{T}}$, that is $k B_{T}(G \times G)$ with product $\times_{G}^{d}$, over the ideal $\mathcal{I}_{T}(G)$, generated by elements of the form $\alpha \times{ }_{K}^{d} \beta$, where $\alpha \in k B_{T}(G \times K)$, $\beta \in k B_{T}(K \times G)$ and $K$ is a group such that $|K|<|G|$. It is denoted by $\widehat{k B_{T}}(G)$.

Definition 1.6. We denote by $E_{T, G}$ the natural ring epimorphism

$$
E_{T, G}: k B_{T}(G \times G) \rightarrow \widehat{k B_{T}}(G)
$$

We will write $[x]$ for the image of an element $x \in k B_{T}(G \times G)$ under $E_{T, G}$.
The classes of the transitive $G G T$-sets, denoted by $[(G G T) / D]$, form a $k$-basis for $k B_{T}(G \times G)$. Hence, $[[(G G T) / D]]$, their images under $E_{T, G}$, form a generating set for $\widehat{k B_{T}}(G)$. The goal in Section 3 will be to find, in some cases, a $k$-basis of $\widehat{k B_{T}}(G)$ in this set.

Lemma 1.7. Suppose that the element $a_{1}\left[e_{1}\right]+\cdots+a_{n}\left[e_{n}\right]$, for some different transitive elements $\left[e_{1}\right], \ldots,\left[e_{n}\right]$ in $k B_{T}(G \times G)$, lies in the kernel of $E_{T, G}$. Then, if $a_{j} \neq 0$, for some $j$, and $e_{j}=G G T / D$, we have that $D$ can be written as $D=E * F$, with $E \leqslant G K T$ and $F \leqslant K G T$ for some group $K$ such that $|K|<|G|$.

Proof. Since

$$
a_{1}\left[\left[e_{1}\right]\right]+\cdots+a_{n}\left[\left[e_{n}\right]\right]=0
$$

in $\widehat{k B_{T}}(G)$, we have

$$
a_{1}\left[e_{1}\right]+\cdots+a_{n}\left[e_{n}\right]=\sum_{i=1}^{r} b_{i}\left(x_{i} \times{ }_{K_{i}}^{d} y_{i}\right) .
$$

for some $x_{i} \in k B_{T}\left(G \times K_{i}\right), y_{i} \in k B_{T}\left(K_{i} \times G\right), b_{i} \in k$ and $K_{i}$ groups such that $\left|K_{i}\right|<|G|$. If we write the elements in the right-hand side of the equation in terms of transitive $G G T$-sets, we obtain, by Lemma 1.3, that for some $i$ there exist $A_{i} \leqslant G K_{i} T$ and $B_{i} \leqslant K_{i} G T$ such that

$$
(G G T) / D \cong(G G T) /\left(A_{i} * B_{i}\right)
$$

as $G G T$-sets. Hence $D=\left(A_{i} * B_{i}\right)^{\left(g, g^{\prime}, t\right)}$ for some $\left(g, g^{\prime}, t\right) \in G G T$. But it is easy to see that the conjugate $\left(A_{i} * B_{i}\right)^{\left(g, g^{\prime}, t\right)}$ is equal to $A_{i}^{(g, 1, t)} * B_{i}^{\left(1, g^{\prime}, t\right)}$. So, taking $K=K_{i}$, $E=A_{i}^{(g, 1, t)}$ and $F=B_{i}^{\left(1, g^{\prime}, t\right)}$ we obtain the result.

### 1.3 The monomial Burnside ring

The monomial Burnside ring will appear at the end of the paper, so we recall its definition and the description of its basis given by transitive sets (see [11]). For further results about it see [1], [15] or [2].

Definition 1.8. Let $C$ be a finite abelian group and $G$ be a finite group. A finite $C$-free $(G \times C)$-set is called a $C$-fibred $G$-set. The monomial Burnside ring for $G$ with coefficients in $C$, denoted by $k B^{C}(G)$, is, as a $k$-module, the submodule of $k B(G \times C)$ generated by the the classes of the $C$-fibred $G$-sets.

The product in $k B^{C}(G)$ is given in the following way. Let $X$ and $Y$ be $C$-fibred $G$-sets and regard $X$ as having the action of $C$ on the right. Then consider $X \times_{C} Y$ with the $(G \times C)$-action

$$
(g, c)[x, y]=[(g, c) x,(g, 1) y]=[(g, 1) x,(g, c) y]
$$

for $(g, c) \in G \times C$ and $[x, y] \in X \times Y$. It is clear that this action is well defined and that $C$-acts freely in $X \times_{C} Y$. This product extends linearly to $k B^{C}(G)$ and is denoted simply by $u v$ for $u$ and $v$ in $k B^{C}(G)$. The identity element in $k B^{C}(G)$ is the class of the trivial $C$-fibred $G$-set $C$.

Notation 1.9. If $D$ is a subgroup of $G$ and $\varphi: D \rightarrow C$ is a group homomorphism, we write $D_{\varphi}$ for the group $\{(x, \varphi(x)) \mid x \in D\}$ and denote by $(D, \varphi)$ the transitive $C$-fibred $G$-set $(G \times C) / D_{\varphi}$. We write $[D, \varphi]$ for the class of $(D, \varphi)$ in $k B^{C}(G)$. Notice that if $(g, x) \in G \times C$, then the conjugate ${ }^{(g, x)} D_{\varphi}$ is equal to $\left({ }^{g} D\right)_{\varphi c_{g-1}}$, where $\varphi c_{g^{-1}}:{ }^{g} D \rightarrow C$. We write ${ }^{g} \varphi$ for the morphism $\varphi c_{g^{-1}}$, so that $[D, \varphi]=\left[{ }^{g} D,{ }^{g} \varphi\right]$.
Remark 1.10. Recall that the elements $[D, \varphi]$ for $D \leqslant G$ and $\varphi: D \rightarrow C$ a group homomorphism, form a basis of $k B^{C}(G)$. Moreover, if $[E, \psi]$ is another element of this type, their product in $k B^{C}(G)$ is given by

$$
[D, \varphi][E, \psi]=\sum_{g \in[D \backslash G / E]}\left[D \cap{ }^{g} E, \varphi \cdot{ }^{g} \psi\right]
$$

where $[D \backslash G / E]$ is a set of representatives of $D \backslash G / E$ and the dot in the morphism $\varphi \cdot{ }^{g} \psi: D \cap{ }^{g} E \rightarrow C$ stands for the product in $C$.

We finish this subsection by noticing that if $D \leqslant G$, then $N_{G}(D)$ acts on the right on the set of group homomorphisms, $\operatorname{Hom}(D, C)$. The action is given by sending $g \in G$ and $f \in \operatorname{Hom}(D, C)$ to $f c_{g}$, that is, $f c_{g}(x)=f\left({ }^{g} x\right)$ for $x \in D$. In this case,

$$
\left[D, f c_{g}\right]=\left[{ }^{g} D,{ }^{g}\left(f c_{g}\right)\right]=[D, f]
$$

In turn, this implies that the cardinality of the basis in Remark 1.10 is equal to $\sum_{D \in\left[\mathscr{S}_{G}\right]}|\overline{\operatorname{Hom}}(D, C)|$, where $\overline{\operatorname{Hom}}(D, C)$ denotes the set of orbits of $\operatorname{Hom}(D, C)$ under the action of $N_{G}(D)$.

## 2 The star operation

Throughout this section, $k$ is a field of characteristic 0 .
Following Boltje and Danz [3], we observe that for groups $G, H$ and $K$ we can define an operation

$$
\mathscr{S}_{G H T} \times \mathscr{S}_{H K T} \longrightarrow \mathscr{S}_{G K T}
$$

sending a couple of subgroups $(D, E)$ to $D * E$. This operation is easily seen to be associative. Also, taking $\Delta(H) \times T \in \mathscr{S}_{H H T}$, gives $(\Delta(H) \times T) * L=L$ for any $L \in \mathscr{S}_{H H T}$. Hence, we can define a category $\mathcal{C}$, having as objects the class of all finite groups and as morphisms from $H$ to $G$, the set $\mathscr{S}_{G H T}$ (or the vector space $k \mathscr{S}_{G H T}$ ), with composition given by the star operation.

We denote by $\alpha_{G T}$ the morphism of $k$-vector spaces, $\alpha_{G \times T}$, defined in [3] as

$$
\alpha_{G T}: k B_{T}(G) \rightarrow k \mathscr{S}_{G \times T} ;[X] \mapsto \sum_{x \in X} \operatorname{Stab}_{G \times T}(X),
$$

for a $G \times T$-set $X$. As it is pointed out in Proposition 3.2 of [3], this map is injective and $\alpha_{G T}([G \times T / U])=\left[N_{G \times T}(U): U\right] \sum_{U^{\prime}} U^{\prime}$, where $U^{\prime}$ runs over the conjugacy class of $U$. In order to make this morphism compatible with the composition in the category $\mathcal{P}_{k B_{T}}$,

$$
\times_{H}^{d}: k B_{T}(G \times H) \times k B_{T}(H \times K) \rightarrow k B_{T}(G \times K),
$$

it is necessary to adjust the star composition $D * E$. Surprisingly, the adjustment made in the case considered in [3 works also in this case. That is, for $D$, a subgroup of $G H T$, and $E$, a subgroup of $H K T$, consider

$$
\kappa(D, E)=\frac{\left|k_{2}(D) \cap k_{1}(E)\right|}{|H|}
$$

in $k$, and define a $k$-bilinear map

$$
k \mathscr{S}_{G H T} \times k \mathscr{S}_{H K T} \longrightarrow k \mathscr{S}_{G K T}
$$

by $D *_{H}^{\kappa} E=\kappa(D, E) D * E$.
We have the following generalization of Proposition 3.5 in [3].
Lemma 2.1. Let $G, H, K$, and I be finite groups. If $\kappa$ is defined as before, then for any $L \leqslant G H T, M \leqslant H K T$ and $N \leqslant K I T$, we have

$$
\kappa(L, M) \kappa(L * M, N)=\kappa(L, M * N) \kappa(M, N)
$$

Proof. To prove that we have the following group isomorphism

$$
\frac{k_{2}(L) \cap k_{1}(M * N)}{k_{2}(L) \cap k_{1}(M)} \cong \frac{k_{2}(L * M) \cap k_{1}(N)}{k_{2}(M) \cap k_{1}(N)}
$$

we follow exactly the same steps of the proof of Proposition 3.5 in [3].
Corollary 2.2. Let $D$ be a subgroup of $G H T, E$ be a subgroup of $H K T$ and $F$ be a subgroup of $K L T$, then

$$
\left(D *_{H}^{\kappa} E\right) *_{K}^{\kappa} F=D *_{H}^{\kappa}\left(E *_{K}^{\kappa} F\right) .
$$

In particular, the $k$-vector space $k \mathscr{S}_{G \times G}$, together with multiplication $*_{G}^{k}$ is a $k$-algebra with identity element $|G|(\Delta(G) \times T)$.

Finally, we prove the analogue of Proposition 3.6 in [3].

Lemma 2.3. Let $G, H$ and $K$ be finite groups. For $a$ in $k B_{T}(G \times H)$ and $b$ in $k B_{T}(H \times K)$ we have

$$
\alpha_{G K T}\left(a \times_{H}^{d} b\right)=\alpha_{G H T}(a) *_{H}^{\kappa} \alpha_{H K T}(b)
$$

Proof. Suppose that $a=[X]$ and $b=[Y]$, where $X$ is a finite $G H T$-set and $Y$ is a finite $H K T$-set. Then

$$
\begin{aligned}
\alpha_{G K T}\left(\left[X \times_{H}^{d} Y\right]\right) & =\sum_{[x, y] \in X \times{ }_{H}^{d} Y} \operatorname{Stab}_{G K T}([x, y]) \\
& =\sum_{[x, y] \in X \times{ }_{H}^{d} Y} \operatorname{Stab}_{G H T}(x) * \operatorname{Stab}_{H K T}(y) \quad \text { by Lemma 1.2, }
\end{aligned}
$$

But this is equal to

$$
\sum_{(x, y) \in X \times Y} \frac{\left|k_{2}\left(\operatorname{Stab}_{G H T}(x)\right) \cap k_{1}\left(\operatorname{Stab}_{H K T}(y)\right)\right|}{|H|} \operatorname{Stab}_{G H T}(x) * \operatorname{Stab}_{H K T}(y)
$$

since $X \times_{H}^{d} Y$, as a set, is equal to $X \times_{H} Y$, so the number of elements in the orbit of $(x, y) \in X \times Y$ under the action of $H$ is $\left[H: k_{2}\left(\operatorname{Stab}_{G H T}(x)\right) \cap k_{1}\left(\operatorname{Stab}_{H K T}(y)\right)\right]$. The sum above is clearly equal to $\alpha_{G H T}(a) *_{H}^{\kappa} \alpha_{H K T}(b)$.

Remark 2.4. Suppose $G$ and $T$ are abelian. Then $\alpha_{G G T}$ is surjective and hence it is an isomorphism of $k$-algebras between $\left(k B_{T}(G \times G), \times_{G}^{d}\right)$ and $\left(k \mathscr{S}_{G G T}, *_{G}^{\kappa}\right)$.

The following corollary is the analogue of Lemma 1.4 for the star operation.
Corollary 2.5. If $D$ is a subgroup of HKT, then
i) $D=X * Y$, for some $X \leqslant H D_{1} T$ and $Y \leqslant D_{1} K T$, with $D_{1}=p_{1}(D) / k_{1}(D)$.
ii) $D=W * Z$, for some $W \leqslant H D_{2} T$ and $Z \leqslant D_{2} K T$, with $D_{2}=p_{2}(D) / k_{2}(D)$.

Proof. The result follows from lemmas 1.4 and 2.3, since the subgroups of $H K T$ form a basis for $k \mathscr{S}_{H K T}$ and $D$ appears in $\alpha_{H K T}([H K T / D])$ with non-zero coefficient.

We will not go further on the generalization of [3], the rest of the paper goes in a different direction. Nevertheless, the author believes that such generalization should be possible and that a deeper study of the morphism $\alpha$ could lead to a complete description of the essential algebra for the shifted Burnside biset functor, since the star operation will be a key element in the descriptions we will give in the next section. In this sense, we begin by defining the essential algebra for the star algebra.

Definition 2.6. The essential algebra, $\widehat{k \mathscr{S}}_{G G T}$, for the algebra $\left(k \mathscr{S}_{G G T}, *_{G}^{\kappa}\right)$ is its quotient by the ideal $\mathcal{J}$ generated by elements of the form $\alpha *_{K}^{\kappa} \beta$, where $\alpha \in k \mathscr{S}_{G K T}$, $\beta \in k \mathscr{S}_{K G T}$ and $K$ is a group such that $|K|<|G|$.

Notice that if $E \leqslant G K T$ and $F \leqslant K G T$ with $|K|<|G|$, then $E * F$ and $E *_{K}^{\kappa} F$ differ by a non-zero element in $k$. Hence, $\mathcal{J}$ is equal to the ideal generated by elements of the form $\alpha * \beta$, where $\alpha \in k \mathscr{S}_{G K T}, \beta \in k \mathscr{S}_{K G T}$ and $K$ is a group such that $|K|<|G|$.

We have a (non unitary) ring homomorphism, extending $\alpha_{G G T}$,

$$
\widehat{\alpha}_{G G T}:{\widehat{k B_{T}}}^{(G)} \rightarrow \widehat{k S}_{G G T} .
$$

In Section 4 we will see that $\widehat{\alpha}_{G G T}$ is not injective in general. On the other hand, we will see in the next section that if $G$ and $T$ are abelian, then $\widehat{\alpha}_{G G T}$ is an isomorphism of $k$-algebras.

## 3 Description in two cases

Throughout this section $T$ is a finite group and, unless stated otherwise, $k$ is a commutative ring with unity.

The first observation is that, by Lemma 1.4, we know that if $[[(G G T) / D]]$ is not zero in $\widehat{k B_{T}}(G)$, then $p_{1}(D)=G, k_{1}(D)=1, p_{2}(D)=G$ and $k_{2}(D)=1$. These conditions are equivalent to saying that $D$ can be written as

$$
D=\{(f(g, t), g, t) \mid(g, t) \in A\}
$$

where $A \leqslant G \times T$ satisfies $p_{1}(A)=G$ and $f: A \rightarrow G$ is a surjective group homomorphism such that $\operatorname{Ker} f \cap\left(k_{1}(A) \times \mathbf{1}\right)=\mathbf{1}$.
Definition 3.1. The image under $E_{T, G}$ (see Definition (1.6) of the set of transitive elements $[G G T / D]$ in $k B_{T}(G \times G)$ for which $D$ is of the form just described will be denoted by $\mathcal{G}$.

Notice that there might be elements in $\mathcal{G}$ which are equal to zero, since Lemma 1.4 only gives a necessary condition for $[[(G G T) / D]]$ not to be zero in $\widehat{k B_{T}}(G)$. Nevertheless, the set $\mathcal{G}$ is a generating set for $\widehat{k B_{T}}(G)$.

The following lemma is an immediate consequence of Lemma 1.7.
Lemma 3.2. Let $\mathcal{S}^{\prime}$ be the set of elements $[G G T / D]$ in $k B_{T}(G \times G)$ for which $D$ cannot be written as $D=E * F$, with $E \leqslant G H T, F \leqslant H G T$ and $H$ a group such that $|H|<|G|$. Then, no non-trivial linear combination of the elements of $\mathcal{S}^{\prime}$ is in the kernel of $E_{T, G}$. In particular, $E_{T, G}$ is injective in $\mathcal{S}^{\prime}$ and $E_{T, G}\left(\mathcal{S}^{\prime}\right)$ is a linearly independent subset of $\widehat{k B_{T}}(G)$.

If $\mathcal{S}^{\prime}$ is as in the previous lemma, we have that for every $[G G T / D]$ in $\mathcal{S}^{\prime}$,

$$
E_{T, G}([G G T / D])=[[G G T / D]] \neq 0 \text { in } \widehat{k B_{T}}(G) .
$$

Hence, by Lemma 1.4, $E_{T, G}\left(\mathcal{S}^{\prime}\right)$ is contained in $\mathcal{G}$.
Definition 3.3. We will denote by $\mathcal{L}_{s^{\prime}}$ the set $E_{T, G}\left(\mathcal{S}^{\prime}\right)$. The $\mathcal{L}$ stands for linearly independent and the $s^{\prime}$ for not (decomposable in terms of the) star composition.

We will see next that if $G$ and $T$ are finite abelian groups and $k$ is a field of characteristic 0 , then $\mathcal{L}_{s^{\prime}}$ is a basis of $\widehat{k B_{T}}(G)$.

Lemma 3.4. Suppose that $D$ is a subgroup of $G G T$ such that $D$ can be written as $D=E * F$, with $E \leqslant G H T$ and $F \leqslant H G T$, for some group $H$. Then $D=E_{1} * F_{1}$, with $E_{1} \leqslant G H_{1} T, F_{1} \leqslant H_{1} G T$ and $H_{1}=p_{2}(E) / k_{2}(E)$.

Proof. Let $K=k_{2}(E)$ and $H_{0}=p_{2}(E)$. Consider $E$ as a subgroup of $G H_{0} T$ and define

$$
F_{0}=\left\{(h, g, t) \in F \mid h \in H_{0}\right\} .
$$

It is clear that $F_{0} \leqslant H_{0} G T$. Now we take

$$
\rho: G H_{0} T \rightarrow \frac{G H_{0} T}{\mathbf{1 K 1}} \cong G H_{1} T \quad \text { and } \quad \lambda: H_{0} G T \rightarrow \frac{H_{0} G T}{K \mathbf{1 1}} \cong H_{1} G T .
$$

Let $E_{1}$ be the image of $E$ under $\rho$ and $F_{1}$ be the image of $F_{0}$ under $\lambda$.
Let us show that $D=E_{1} * F_{1}$. Let $\left(g, g^{\prime}, t\right) \in D$. Since $D=E * F$, there exists $h \in H$ such that $(g, h, t) \in E$ and $\left(h, g^{\prime}, t\right) \in F$. Hence $h \in p_{2}(E)=H_{0}$ and $\left(h, g^{\prime}, t\right) \in F_{0}$. So $(g, h K, t) \in E_{1},\left(h K, g^{\prime}, t\right) \in F_{1}$ and $\left(g, g^{\prime}, t\right) \in E_{1} * F_{1}$. Now suppose that $\left(a, a^{\prime}, t\right) \in E_{1} * F_{1}$. Then there exists $f K \in H_{1}$ such that $(a, f K, t) \in E_{1}$ and $\left(f K, a^{\prime}, t\right) \in F_{1}$. This means that there exist $h$ and $h^{\prime}$ in $p_{2}(E)$ with $h K=f K=$ $h^{\prime} K$ and such that $(a, h, t) \in E$ and $\left(h^{\prime}, a^{\prime}, t\right) \in F_{0}$. Now, since $h^{-1} h^{\prime} \in K=k_{2}(E)$, we have $\left(1, h^{-1} h^{\prime}, 1\right) \in E$ and so $\left(a, h^{\prime}, t\right) \in E$. Also, $\left(h^{\prime}, a^{\prime}, t\right) \in F$. So we have $\left(a, a^{\prime}, t\right) \in E * F=D$.

Remark that the previous lemma also holds if we take $H_{1}=p_{1}(F) / k_{1}(F)$.
Theorem 3.5. Let $k$ be a field of characteristic 0 and $G$ and $T$ be finite abelian groups. Then $\mathcal{L}_{s^{\prime}}$ is a basis of $\widehat{k B_{T}}(G)$ and we have an isomorphism of $k$-algebras

$$
\left(\widehat{k B_{T}}(G), \times_{G}^{d}\right) \cong\left(\widehat{k S}_{G G T}, *_{G}^{\kappa}\right)
$$

Proof. Suppose that $D$ can be written as $D=E * F$, with $E \leqslant G H T$ and $F \leqslant H G T$ for some group $H$ such that $|H|<|G|$. By the previous lemma, $D=E_{1} * F_{1}$ with $E_{1} \leqslant G H_{1} T$ and $F_{1} \leqslant H_{1} G T$, where $H_{1}=p_{2}(E) / k_{2}(E)$. By Goursat's lemma, $H_{1}$ is isomorphic to a subquotient of $G \times T$, hence it is an abelian group. Also, since it is a subquotient of $H$, it satisfies $\left|H_{1}\right|<|G|$.

Consider the elements $\left[G H_{1} T / E_{1}\right] \in k B_{T}\left(G \times H_{1}\right)$ and $\left[H_{1} G T / F_{1}\right] \in k B_{T}\left(H_{1} \times G\right)$. Composing them gives

$$
\left(G H_{1} T\right) / E_{1} \times_{H_{1}}^{d}\left(H_{1} G T\right) / F_{1} \cong \bigsqcup_{(h, t)}(G G T) /\left(E_{1} *^{(h, 1, t)} F_{1}\right)
$$

where $(h, t)$ runs through a set of representatives of $p_{2,3}\left(E_{1}\right) \backslash H_{1} \times T / p_{1,3}\left(F_{1}\right)$. Since $H_{1}$ and $T$ are abelian, we have

$$
\left[\left(G H_{1} T\right) / E_{1}\right] \times_{H_{1}}^{d}\left[\left(H_{1} G T\right) / F_{1}\right]=m\left[(G G T) /\left(E_{1} * F_{1}\right)\right],
$$

in $k B_{T}(G \times G)$, where $m=\left[H_{1} \times T: p_{2,3}\left(E_{1}\right) p_{1,3}\left(F_{1}\right)\right]$.
This proves that $[[G G T / D]]$ is not zero in $\widehat{k B_{T}}(G)$ if and only if $[[G G T / D]]$ is in $\mathcal{L}_{s^{\prime}}$, and hence that $\mathcal{L}_{s^{\prime}}$ is a basis of $\widehat{k B_{T}}(G)$. It also proves that $\alpha_{G G T}\left(\mathcal{I}_{T}(G)\right)=\mathcal{J}$, the ideal introduced in Definition 2.6. Hence, by Remark [2.4, we have $\left(\widehat{k B_{T}}(G), \times_{G}^{d}\right) \cong$ $\left(\widehat{k S}_{G G T}, *_{G}^{\kappa}\right)$.

### 3.1 General setting

Now we come back to the general case and suppose that $k$ is a commutative unitary ring. We will describe some elements in $\mathcal{L}_{s^{\prime}}$.

Suppose that $[G G T / D]$ is as in Definition 3.1 and that $A$ is of the form $A=G \times T_{0}$ for some $T_{0} \leqslant T$. Then $f(g, t)=f(g, 1) f(1, t)$ and the restriction of $f$ to $G \times \mathbf{1}$ defines an automorphism $\sigma$ of $G$. This is because $k_{1}(A)=G$ and, as said at the beginning of the section, $\operatorname{Ker} f \cap\left(k_{1}(A) \times \mathbf{1}\right)=\mathbf{1}$. On the other hand, the restriction of $f$ to $T_{0}$ defines a group homomorphism $\alpha: T_{0} \rightarrow Z(G)$. In this case, we write $D$ as:

$$
D_{\sigma, \alpha, T_{0}}=\left\{(\alpha(t) \sigma(g), g, t) \mid(g, t) \in G \times T_{0}\right\} .
$$

Definition 3.6. The set of transitive elements $\left[\left[G G T / D_{\sigma, \alpha, T_{0}}\right]\right]$ in $\widehat{k B_{T}}(G)$ as above will be denoted by $\mathcal{L}_{p}$. The $p$ here stands for (decomposable as a) direct product.

Proposition 3.7. The set $\mathcal{L}_{p}$ is contained in $\mathcal{L}_{s^{\prime}}$.

Proof. A particular case of this proposition was proven in Lemma 4.10 of [14].
Let $\alpha$ and $\sigma$ be as before and suppose $D_{\sigma, \alpha, T_{0}}=E * F$ for some $E \leqslant G H T$, $F \leqslant H G T$ and $H$ a group such that $|H|<|G|$. We claim that in this case $\Delta_{\sigma}(G)=$ $k_{1,2}(E) * k_{1,2}(F)$. This will give a contradiction since, if we call $M$ the group on the right-hand side of this equality, then by Lemma 2.3.22 in [5], $p_{1}(M) / k_{1}(M)$ is isomorphic to a subquotient of $H$.

Let $(\sigma(g), g) \in \Delta_{\sigma}(G)$. Since $(\sigma(g), g, 1)$ is in $D_{\sigma, \alpha, T_{0}}$, there exists $h \in H$ such that $(\sigma(g), h, 1) \in E$ and $(h, g, 1) \in F$, thus $(\sigma(g), h) \in k_{1,2}(E)$ and $(h, g) \in k_{1,2}(F)$. Hence $(\sigma(g), g) \in k_{1,2}(E) * k_{1,2}(F)$. Now let $\left(g_{1}, g_{2}\right) \in k_{1,2}(E) * k_{1,2}(F)$. Then there exists $h \in H$ such that $\left(g_{1}, h\right) \in k_{1,2}(E)$ and $\left(h, g_{2}\right) \in k_{1,2}(F)$, thus $\left(g_{1}, h, 1\right) \in E$ and $\left(h, g_{2}, 1\right) \in F$. This means that $\left(g_{1}, g_{2}, 1\right)$ is in $D_{\sigma, \alpha, T_{0}}$. But given an element $(\sigma(g) \alpha(t), g, t)$ in $D_{\sigma, \alpha, T_{0}}$, the elements $g$ and $t$ are uniquely determined. This means that $g_{1}=\sigma\left(g_{2}\right)$ and $\left(g_{1}, g_{2}\right) \in \Delta_{\sigma}(G)$.

Next we prove some properties of the elements of $\mathcal{L}_{p}$.
Lemma 3.8. Let $D_{\sigma, \alpha, T_{0}}$ and $D_{\tau, \beta, T_{1}}$ be as before, with $\sigma$ and $\tau$ automorphisms of $G$ and $\alpha: T_{0} \rightarrow Z(G)$ and $\beta: T_{1} \rightarrow Z(G)$ group homomorphisms. Then $\left[G G T / D_{\sigma, \alpha, T_{0}}\right]=$ $\left[G G T / D_{\tau, \beta, T_{1}}\right]$ in $k B_{T}(G \times G)$ if and only if there exists $(g, t) \in G \times T$ such that $T_{0}={ }^{t} T_{1}, \sigma=\tau c_{g}$ and $\alpha=\beta c_{t^{-1}}$.

Proof. If $\left[G G T / D_{\sigma, \alpha, T_{0}}\right]=\left[G G T / D_{\left.\tau, \beta, T_{1}\right]}\right]$ in $k B_{T}(G \times G)$, then there exist $g_{1}, g_{2}$ in $G$ and $t$ in $T$ such that $D_{\sigma, \alpha, T_{0}}={ }^{\left(g_{1}, g_{2}, t\right)} D_{\tau, \beta, T_{1}}$. This easily implies that $T_{0}={ }^{t} T_{1}$, that $\alpha\left(t^{\prime}\right)=\beta\left(t^{-1} t^{\prime} t\right)$ and that

$$
\sigma\left(g^{\prime}\right)=g_{1} \tau\left(g_{2}^{-1} g^{\prime} g_{2}\right) g_{1}^{-1}=\tau\left(\tau^{-1}\left(g_{1}\right) g_{2}^{-1} g^{\prime} g_{2} \tau^{-1}\left(g_{1}^{-1}\right)\right)
$$

for $t^{\prime} \in T_{0}$ and $g^{\prime} \in G$. Taking $g=\tau^{-1}\left(g_{1}\right) g_{2}^{-1}$, we have $\sigma=\tau c_{g}$.
Now suppose that $T_{0}={ }^{t} T_{1}$ for some $t \in T, \sigma=\tau c_{g}$ for some $g \in G$ and $\alpha=\beta c_{t^{-1}}$. Then, it is straightforward to see that

$$
D_{\sigma, \alpha, T_{0}}={ }^{(\tau(g), 1, t)} D_{\tau, \beta, T_{1}}
$$

hence $\left[G G T / D_{\sigma, \alpha, T_{0}}\right]=\left[G G T / D_{\tau, \beta, T_{1}}\right]$ in $k B_{T}(G \times G)$.
Lemma 3.9. For $D_{\sigma, \alpha, T_{0}}$ and $D_{\tau, \beta, T_{1}}$ as before, we have

$$
\left(G G T / D_{\sigma, \alpha, T_{0}}\right) \times{ }_{G}^{d}\left(G G T / D_{\tau, \beta, T_{1}}\right) \cong \bigsqcup_{t \in\left[T_{0} \backslash T / T_{1}\right]} G G T / D_{\sigma \tau, \alpha \cdot\left(\sigma^{t} \beta\right), T_{0} \cap^{t} T_{1}}
$$

where, in the group morphism $\alpha \cdot\left(\sigma^{t} \beta\right): T_{0} \cap{ }^{t} T_{1} \rightarrow Z(G)$, the dot $\cdot$ represents the product in $Z(G)$.

Proof. By Lemma 1.3 we have

$$
\left(G G T / D_{\sigma, \alpha, T_{0}}\right) \times_{G}^{d}\left(G G T / D_{\tau, \beta, T_{1}}\right) \cong \bigsqcup_{(g, t)} G G T /\left(D_{\sigma, \alpha, T_{0}} *(g, 1, t) D_{\tau, \beta, T_{1}}\right)
$$

where $(g, t)$ runs through a set of representatives of $p_{2,3}\left(D_{\sigma, \alpha, T_{0}}\right) \backslash G \times T / p_{1,3}\left(D_{\tau, \beta, T_{1}}\right)$. Now, since $\alpha: T_{0} \rightarrow Z(G)$ and $\beta: T_{1} \rightarrow Z(G)$, then $p_{2,3}\left(D_{\sigma, \alpha, T_{0}}\right)=G \times T_{0}$ and $p_{1,3}\left(D_{\tau, \beta, T_{1}}\right)=G \times T_{1}$. So, $p_{2,3}\left(D_{\sigma, \alpha, T_{0}}\right) \backslash G \times T / p_{1,3}\left(D_{\tau, \beta, T_{1}}\right)$ is in one-to-one correspondence with $T_{0} \backslash T / T_{1}$. Also, as in Lemma 3.8, we see that ${ }^{(1,1, t)} D_{\tau, \beta, T_{1}}=D_{\tau,{ }^{t},{ }^{t} T_{1}}$. Hence,

$$
\left(G G T / D_{\sigma, \alpha, T_{0}}\right) \times_{G}^{d}\left(G G T / D_{\tau, \beta, T_{1}}\right) \cong \bigsqcup_{t \in\left[T_{0} \backslash T / T_{1}\right]} G G T /\left(D_{\sigma, \alpha, T_{0}} * D_{\tau, t \beta, t} T_{1}\right)
$$

In general, $D_{\sigma, \alpha, T_{0}} * D_{\tau, \gamma, T_{2}}$ is equal to

$$
\left\{\left(g_{1}, g_{2}, t^{\prime}\right) \in G G T \mid \exists g_{0} \in G \text { s. t. }\left(g_{1}, g_{0}, t^{\prime}\right) \in D_{\sigma, \alpha, T_{0}},\left(g_{0}, g_{2}, t^{\prime}\right) \in D_{\tau, \gamma, T_{2}}\right\}
$$

This implies that $t^{\prime}$ is in $T_{0} \cap T_{2}$, that $g_{0}=\tau\left(g_{2}\right) \gamma\left(t^{\prime}\right)$ and finally that $g_{1}$ is equal to $\sigma \tau\left(g_{2}\right) \sigma \gamma\left(t^{\prime}\right) \alpha\left(t^{\prime}\right)$. That is,

$$
D_{\sigma, \alpha, T_{0}} * D_{\tau, \gamma, T_{2}}=D_{\sigma \tau, \alpha \cdot(\sigma \gamma), T_{0} \cap T_{2}}
$$

with $\alpha \cdot(\sigma \gamma): T_{0} \cap T_{2} \rightarrow Z(G)$. So, we have

$$
\left(G G T / D_{\sigma, \alpha, T_{0}}\right) \times{ }_{G}^{d}\left(G G T / D_{\tau, \beta, T_{1}}\right) \cong \bigsqcup_{t \in\left[T_{0} \backslash T / T_{1}\right]} G G T / D_{\sigma \tau, \alpha \cdot(\sigma \neq \beta), T_{0} \cap T_{1}}
$$

where for each $t \in\left[T_{0} \backslash T / T_{1}\right], \alpha \cdot\left(\sigma^{t} \beta\right): T_{0} \cap^{t} T_{1} \rightarrow Z(G)$.
The previous lemma says that, given groups $G$ and $T$, the $k$-submodule of $\widehat{k B_{T}}(G)$ generated by $\mathcal{L}_{p}$ is actually a subalgebra, the identity element of $\widehat{k B_{T}}(G)$ corresponds to $\left[G G T / D_{i d, \mathbf{1}, T}\right]$, where $i d: G \rightarrow G$ is the identity morphism and $\mathbf{1}: T \rightarrow Z(G)$ is the trivial morphism. We will use the monomial Burnside ring, $k B^{Z(G)}(T)$, to describe this algebra.

Let us fix the notation $Z$ for $Z(G)$.
Let $U$ be a $Z$-fibred $T$-set. By considering $U$ as a left $Z$-set and $G$ as a right $Z$-set, we can make the composition $G \times{ }_{Z} U$. Next, given $\sigma$, an automorphism of $G$, we turn $G \times_{Z} U$ into a $G G T$-set in the following way. Let $[g, u]$ be the class in $G \times{ }_{Z} U$ of $(g, u) \in G \times U$ and let $\left(g_{1}, g_{2}, t\right) \in G G T$, then

$$
\left(g_{1}, g_{2}, t\right)[g, u]=\left[g_{1} g \sigma\left(g_{2}\right)^{-1},(t, 1) u\right]
$$

Since the elements of $Z$ commute with those of $T$ in $T \times Z$ and, of course, with those of $G$, this action is well defined. We denote the class of this $G G T$-set in $k B_{T}(G \times G)$ by $[U, \sigma]$.

Lemma 3.10. Let $\sigma$ be an automorphism of $G$, let $X$ be a subgroup of $T$ and let $\alpha: X \rightarrow Z$ be a group homomorphism. Recall that $X_{\alpha}=\{(x, \alpha(x)) \mid x \in X\}$ and that $(X, \alpha)$ denotes the $Z$-fibred $T$-set $(T \times Z) / X_{\alpha}$. Then $[(X, \alpha), \sigma]=\left[G G T / D_{\sigma, \alpha, X}\right]$ in $B_{T}(G \times G)$.

Proof. Notice first that $G \times{ }_{Z}(X, \alpha)$ is a transitive $G G T$-set. This is because for $g \in G$ and $(t, z) \in T \times Z$, we have

$$
\left[g,(t, z) X_{\alpha}\right]=\left[g z,(t, 1) X_{\alpha}\right]=(g z, 1, t)\left[1,(1,1) X_{\alpha}\right] .
$$

Now suppose that $\left(g_{1}, g_{2}, t\right) \in G G T$ is in the stabilizer of $\left[1,(1,1) X_{\alpha}\right]$. Then there exists $z \in Z$ such that

$$
\left(g_{1} \sigma\left(g_{2}\right)^{-1},(t, 1) X_{\alpha}\right)=\left(z,\left(1, z^{-1}\right) X_{\alpha}\right)
$$

Hence $g_{1} \sigma\left(g_{2}\right)^{-1}=z$ and $(t, 1) X_{\alpha}=\left(1, z^{-1}\right) X_{\alpha}$. This implies $(t, z) \in X_{\alpha}$ and $\left(g_{1}, g_{2}, t\right) \in D_{\sigma, \alpha, X}$. The other inclusion is clear.

The previous lemma prompt us to consider, first the ring $k B^{Z}(T)$, and then the following $k$-algebra, which we denote by $k B^{Z}(T) \rtimes \operatorname{Out}(G)$.

As a $k$-module

$$
k B^{Z}(T) \rtimes \operatorname{Out}(G):=\bigoplus_{\sigma \in \operatorname{Out}(G)} k B^{Z}(T)
$$

If the element $u \in k B^{Z}(T)$ is in the component of this direct sum indexed by $\sigma$, then we will write $u_{\sigma}$.

To define a product in $k B^{Z}(T) \rtimes \operatorname{Out}(G)$ we introduce the following notation. If $\tau$ is an automorphism of $G$ and $U$ is a $Z$-fibred $T$-set, the $(T \times Z)$-set $\tau(U)$ is the set $U$ with the action of $T \times Z$ given by

$$
(t, z) \cdot u=\left(t, \tau^{-1}(z)\right) u
$$

Notice that $\tau(U)$ is also a $Z$-fibred $T$-set, so, this twist defines an action of $\operatorname{Out}(G)$ on $k B^{Z}(T)$, which we continue to denote by $\tau(u)$, for $\tau \in O u t(G)$ and $u \in k B^{Z}(T)$. With this, the product in $k B^{Z}(T) \rtimes \operatorname{Out}(G)$ is defined as

$$
v_{\tau} \cdot u_{\sigma}:=(v \tau(u))_{\tau \sigma} .
$$

By Remark 1.10, a $k$-basis of $k B^{Z}(T) \rtimes \operatorname{Out}(G)$ is given by $[X, \alpha]_{\sigma}$, for $X \leqslant T$, a group homomorphism $\alpha: X \rightarrow Z$ and $\sigma \in \operatorname{Out}(G)$. With this notation, the identity element of $k B^{Z}(T) \rtimes \operatorname{Out}(G)$ is $[T, \mathbf{1}]_{i d}$, where $i d: G \rightarrow G$ is the identity element and $1: T \rightarrow Z$ is the trivial morphism.

Theorem 3.11. Let $G$ and $T$ be finite groups. There is an injective morphism of $k$-algebras from $k B^{Z(G)}(T) \rtimes \operatorname{Out}(G)$ to $k B_{T}(G \times G)$. Moreover, by composition with $E_{T, G}$, this morphism extends to an injective morphism $k B^{Z(G)}(T) \rtimes O u t(G) \rightarrow \widehat{k B_{T}}(G)$ and its image is the subalgebra generated by $\mathcal{L}_{p}$.

Proof. We define

$$
\Phi: k B^{Z(G)}(T) \rtimes \operatorname{Out}(G) \rightarrow k B_{T}(G \times G)
$$

by sending $[(X, \alpha)]_{\sigma}$ to $[(X, \alpha), \sigma]=\left[G G T / D_{\sigma, \alpha, X}\right]$ in $k B_{T}(G \times G)$. To see that this is well defined, suppose $[(Y, \beta)]_{\tau}=[(X, \alpha)]_{\sigma}$. By Notation 1.9, this means that there exists $t \in T$ such that $(X, \alpha)=\left({ }^{t} Y,{ }^{t} \beta\right)$ and that $\sigma=\tau$ in $O u t(G)$. Hence, there exists $(g, t) \in G \times T$ such that $X=^{t} Y, \sigma=\tau c_{g}$ and $\alpha=\beta c_{t^{-1}}$. Then, by Lemma 3.8, we have $\left[G G T / D_{\sigma, \alpha, X}\right]=\left[G G T / D_{\tau, \beta, Y}\right]$. Going backwards, Lemma 3.8 shows too that $\Phi$ is injective.

To see that $\Phi$ is a ring homomorphism, notice first that if $\tau$ is an automorphism of $G$, then $\tau((X, \alpha))=(X, \tau \alpha)$. Indeed, if $(t, z) \in T \times Z$ is such that $\left(t, \tau^{-1}(z)\right) X_{\alpha}=X_{\alpha}$, then, $t \in X$ and $z=\tau \alpha(t)$. Hence, by Remark 1.10 and Lemma 3.9, we have that $\Phi$ is a ring homomorphism. Also, $\Phi\left([T, \mathbf{1}]_{i d}\right)=\left[G G T / D_{i d, \mathbf{1}, T}\right]$.

The rest of the statement follows from lemmas 3.2 and 3.7 .
Corollary 3.12. Suppose $G$ and $T$ are groups such that $(|G|,|T|)=1$. Then $\mathcal{L}_{p}=$ $\mathcal{L}_{s^{\prime}}=\mathcal{G}$ is a basis for $\widehat{k B_{T}}(G)$ and $\widehat{k B_{T}}(G) \cong k B^{Z(G)}(T) \rtimes$ Out $(G)$. Furthermore, in this case we have an isomorphism of $k$-modules,

$$
k B_{T}(G \times G) \cong\left(k B^{Z(G)}(T) \rtimes \operatorname{Out}(G)\right) \oplus \mathcal{I}_{T}(G)
$$

Proof. We show first that $\mathcal{G}$ is contained in $\mathcal{L}_{p}$.
Let $D \leqslant G G T$ be a group such that $p_{1}(D)=G, k_{1}(D)=\mathbf{1}, p_{2}(D)=G$ and $k_{2}(D)=1$. Then,

$$
D=\{(f(g, t), g, t) \mid(g, t) \in A\}
$$

where $A \leqslant G \times T$ satisfies $p_{1}(A)=G$ and $f: A \rightarrow G$ is a surjective group homomorphism such that $\operatorname{Ker} f \cap\left(k_{1}(A) \times \mathbf{1}\right)=\mathbf{1}$. Since $(|G|,|T|)=1$, we have that $A=G \times T_{0}$ for some $T_{0} \leqslant T$. As in the paragraph before Definition [3.6, this gives $D=D_{\sigma, \alpha, T_{0}}$ for some $\sigma$ automorphism of $G$ and $\alpha: T_{0} \rightarrow Z(G)$ a group homomorphism.

With this we have the equality $\mathcal{L}_{p}=\mathcal{L}_{s^{\prime}}=\mathcal{G}$. Since $\mathcal{G}$ is a generating set for $\widehat{k B_{T}}(G)$ and in this case it is linearly independent, then it is a basis for $\widehat{k B_{T}}(G)$. Also, by Lemma 3.2, this implies that $E_{T, G}: k B_{T}(G \times G) \rightarrow \widehat{k B_{T}}(G)$ is a split epimorphism and $k B_{T}(G \times G) \cong \widehat{k B_{T}}(G) \oplus \mathcal{I}_{T}(G)$.

## 4 (Counter)examples

Throughout this section $k$ is a field of characteristic 0 and we consider the three sets we have been associating to $\widehat{k B_{T}}(G)$. That is, $\mathcal{G}$ (Definition 3.1), $\mathcal{L}_{s^{\prime}}$ (Definition 3.3) and $\mathcal{L}_{p}$ (Definition (3.6). In what follows we suppose that $\gamma$ is a basis of $\widehat{k B_{T}}(G)$, contained in $\mathcal{G}$ and which contains $\mathcal{L}_{s^{\prime}}$. Such a basis exists, for example, by Theorem 2 of Chapter II, Section 7-1, in [10].

By means of the GAP program below, we computed two examples. The first example provides groups $T$ and $G$ for which we have the proper inclusions

$$
\mathcal{L}_{p} \subset \mathcal{L}_{s^{\prime}} \subset \gamma \subset \mathcal{G}
$$

It also shows that the morphism $\widehat{\alpha}_{G G T}$ is not injective in general. We include too an example with abelian groups $G$ and $T$, to show that not even with this extra hypothesis, we obtain equality between all of the sets above (except for $\gamma$ and $\mathcal{L}_{s^{\prime}}$ in this case).

Given a finite group $T$, the program runs through a list of groups, and for each $G$ in this list it computes the following:

Gen: The cardinality of Gen, a set of representatives of the conjugacy classes of subgroups $D$ of $G G T$, that satisfy $p_{1}(D)=G, p_{2}(D)=G, k_{1}(D)=\mathbf{1}$ and $k_{2}(D)=\mathbf{1}$. The image under $E_{T, G}$ of their corresponding elements, $[G G T / D] \in k B_{T}(G \times G)$, is the set $\mathcal{G}$.

St' $^{\prime}$ : The number of subgroups $D$ in Gen that cannot be written as $D=E * F$ for some $E \leqslant G H T, F \leqslant H G T$ and $H$ a group with $|H|<|G|$. The image under $E_{T, G}$ of their corresponding elements, $[G G T / D] \in k B_{T}(G \times G)$, is the set $\mathcal{L}_{s^{\prime}}$ and, by Lemma 3.2, $\mathrm{St}^{\prime}$ is the cardinality of $\mathcal{L}_{s^{\prime}}$.

Dim: The dimension of the essential algebra $\widehat{k B_{T}}(G)$.
Prod: The sum

$$
\sum_{X \in\left[\mathscr{S}_{T}\right]}|\operatorname{Out}(G)||\overline{\operatorname{Hom}}(X, Z(G))|,
$$

where $\overline{\operatorname{Hom}}(X, Z(G))$ is the set of orbits of $\operatorname{Hom}(X, Z(G))$ under the right action of $N_{T}(X)$ described in Section 1.3. By Theorem 3.11. Prod is the cardinality of $\mathcal{L}_{p}$.

### 4.1 General case

This example provides groups $T$ and $G$ for which we have the proper inclusions

$$
\mathcal{L}_{p} \subset \mathcal{L}_{s^{\prime}} \subset \gamma \subset \mathcal{G}
$$

We also show that the morphism $\widehat{\alpha}_{G G T}$ is not injective in this case.
For $T=Q_{8}$, the quaternion group, and $G=C_{4}$ we have

$$
\text { Gen: 58, } \quad \text { St'}^{\prime}: 46, \quad \text { Dim: } 52, \quad \text { Prod: } 32 .
$$

The proper inclusions $\mathcal{L}_{p} \subset \mathcal{L}_{s^{\prime}} \subset \gamma$ are clear. In particular, there exists an element $v=[[G G T / D]] \in \gamma$ such that $D=E * F$ for some $E \leqslant G H T, F \leqslant H G T$ and $|H|<|G|$. Hence $0 \neq v \in \widehat{k B_{T}}(G)$ and clearly $\widehat{\alpha}_{G G T}(v)=0$, so $\widehat{\alpha}_{G G T}$ is not injective.

Notice that Gen being bigger than Dim does not imply that $\gamma$ is properly contained in $\mathcal{G}$, since we do not know, in general, exactly what happens to Gen in $\widehat{k B_{T}}(G)$. To show this proper inclusion, we consider the group $\Delta_{i}=\langle(a, a, i)\rangle \leqslant G G T$, where $a$ is a generator of $G$ and $i$ is an element of order four in $Q_{8}$. Observe that $p_{1}\left(\Delta_{i}\right)=G$, $k_{1}\left(\Delta_{i}\right)=1, p_{2}\left(\Delta_{i}\right)=G$ and $k_{1}\left(\Delta_{i}\right)=1$. Hence, $v_{i}=\left[\left[G G T / \Delta_{i}\right]\right] \in \mathcal{G}$. If $v_{i}=0$, we are done. Otherwise, we consider the groups

$$
E=\langle(a, 1, i)\rangle \leqslant G \mathbf{1} T \quad \text { and } \quad F=\langle(1, a, i)\rangle \leqslant \mathbf{1} G T .
$$

We easily have $E * F=\Delta_{i}$. So, the composition

$$
[G \mathbf{1} T / E] \times_{\mathbf{1}}^{d}[\mathbf{1} G T / F]=\sum_{t \in[T /\langle i\rangle]}\left[G G T / E * *^{(1,1, t)} F\right]
$$

is easily seen to be equal to

$$
\left[G G T / \Delta_{i}\right]+\left[G G T / \Delta_{i}^{\prime}\right]
$$

where $\Delta_{i}^{\prime}=\left\langle\left(a, a^{3}, i\right)\right\rangle$.
As before, $v_{i}^{\prime}=\left[\left[G G T / \Delta_{i}^{\prime}\right]\right] \in \mathcal{G}$. Hence, we have $v_{i}, v_{i}^{\prime}$ in $\mathcal{G}$ such that $v_{i}+v_{i}^{\prime}=0$ in $\widehat{k B_{T}}(G)$. So, $\gamma$ is properly contained in $\mathcal{G}$.

### 4.2 Abelian case

This example provides abelian groups $T$ and $G$ for which we have the proper inclusions

$$
\mathcal{L}_{p} \subset \mathcal{L}_{s^{\prime}} \subset \mathcal{G}
$$

Recall that in this case $\mathcal{L}_{s^{\prime}}$ is a basis of $\widehat{k B_{T}}(G)$.
For $T=C_{4}$ and $G=C_{4}$ we have

$$
\text { Gen: } 22, \quad \mathrm{St}^{\prime}: 16, \quad \text { Dim: } 16, \quad \text { Prod: } 14 .
$$

The proper inclusion $\mathcal{L}_{p} \subset \mathcal{L}_{s^{\prime}}$ is clear. Also, since Gen is bigger than Dim, we have that there are groups $D$ in Gen such that $D=E * F$ for some $E \leqslant G H T, F \leqslant H G T$ and $|H|<|G|$. In this case, the proof of Theorem 3.5 gives us that $[[G G T / D]]=0$ in $\widehat{k B_{T}}(G)$ and, hence, that the zero vector is in $\mathcal{G}$.
