# Simulation of linear non-Hermitian boundary-value problems with quantum singular value transformation

#### Abstract

We propose a quantum algorithm for simulating dissipative waves in inhomogeneous linear media as a boundaryvalue problem. Using the so-called quantum singular value transformation (QSVT), we construct a quantum circuit that models the propagation of electromagnetic waves in a one-dimensional system with outgoing boundary conditions. The corresponding measurement procedure is also discussed. Limitations of the QSVT algorithm are identified in connection with the large condition numbers that the dispersion matrices exhibit at weak dissipation.


## I. INTRODUCTION

First-principle ('full-wave') modeling of linear waves in inhomogeneous linear media is important for various applications, for example, plasma heating in fusion research. $\underline{1}^{1-3}$ However, it can be computationally expensive, especially for waves with wavelengths that are orders magnitude smaller than the characteristic inhomogeneity scales. Such simulations can be facilitated by quantum computing (QC).

Quantum algorithms have been proposed for initial-value problems that involve purely Hermitian interactions, such as the propagation of electromagnetic (EM) waves in cold magnetized plasma ${ }^{4}$ and also Landau damping of kinetic plasma waves. $\frac{5}{2}$ However, practical applications are usually concerned with dissipative waves and are set up as boundaryvalue problems, also called antenna problems. The corresponding codes (Refs. 6-8, to name a few) are often used to model EM waves in fusion plasmas. 9 - ${ }^{-11}$ After discretization, such problems can be represented as linear vector equations of the form

where $A$ of size $N \times N$ is generally a non-Hermitian invertible matrix, $b$ is a given vector, and the vector $\psi$ represents the field(s) of interest. ${ }^{12}$

The first quantum method to solve Eq. (1), the so-called HHL algorithm, was presented in Ref. 13. This method was developed further in Refs. 14 and 15, where its scaling with the condition number $\kappa$ of the matrix $A$ and the absolute error has been improved. A thorough analysis of the HHL algorithm in application to EM classical-wave problems was given in Ref. 16. It was demonstrated there that the time necessary for a single run of the corresponding HHL circuit to achieve quantum advantage is comparable with the age of the Universe (even without taking into account the costs of encoding the matrix $A$ into a quantum circuit). Hence, a concern has emerged to what extent quantum algorithms are actually applicable to boundary-value wave problems.

Here, we address this matter by developing a different approach to solving Eq. (1) on a quantum computer, namely, by using so-called quantum signal processing (QSP). Although originally developed ${ }^{17,18}$ for Hermitian matrices, the

QSP has been recently extended to general matrices using the quantum singular value transformation (QSVT) ${ }^{19,20}$ The QSVT provides a near-optimal dependence of the query complexity (the number of calls to the subcircuit encoding $A$ ) on both the condition number and the error, so it is considered as a promising algorithm for solving linear equations. We apply the QSVT to a boundary-value wave problem for the first time.

We consider an EM wave propagating in an inhomogeneous one-dimensional dielectric medium with a source and outgoing boundary conditions. In the first part of our work, we construct a quantum circuit for the corresponding matrix $A$ using the QSVT, emulate quantum simulations on a classical computer, and benchmark our results against those of conventional classical simulations. The second part of the work is concerned with extracting classical information from quantum circuits using measurements. In general, this step is computationally expensive, so including it is necessary when assessing the efficiency of quantum simulations ${ }^{21}$. We discuss how to perform relevant measurements in the wave problem and estimate the necessary resources. Our finding is that even with the measurement costs included, the overall quantum simulations of dissipative waves based on the QSVT scale favorably compared to classical simulations in multi-dimensional systems. We expect the gain to be particularly efficient in kinetic plasma problems, where the wave modeling is done in phase space with six or even more dimensions.

Our paper is organized as follows. In Sec. II we briefly describe the QSVT algorithm and the corresponding circuit. The QSVT scaling and its comparison with classical methods are discussed in Sec. IIII In Sec. IV we outline our onedimensional wave system and describe its discretization. The encoding of the system into a quantum circuit is discussed in detail in Sec. V . The classical modeling of the system and its quantum simulation on a digital emulator of quantum circuits are compared in Sec. VI There, we explore circuits for basic measurements of the wave-number spectrum and the wave energy. Besides, an algorithm is proposed to measure wave absorption power, where the QSVT is used for both EM field computations and emulation of the electrical conductivity. The efficiency of the QSVT algorithm for simulations
of classical waves and the related challenges that remain are discussed in Sec. VII Auxiliary information and technical details are also discussed in appendices A and B

## II. QUANTUM SINGULAR VALUE TRANSFORMATION

## A. General idea

One of the ways to solve Eq. (1) is by calculating the inverse of the matrix $A$. The polynomial approximation $P_{\text {inv }}(A)$ of this function with a Hermitian $A$ can be found on a quantum computer by using the QSP $\xlongequal{17,18}$ To compute $P_{\text {inv }}(A)$ of a non-Hermitian $A$, one can dilate the matrix to make it the Hermitian one and then use the QSP. Another possibility, which does not require the dilation, is to apply the QSVT, ${ }^{19,20}$ The idea of this approach is based on a generalization of the classical singular value transformation

where $S=\operatorname{diag}\left(s_{1}, \ldots, s_{N}\right)$ is a diagonal $N \times N$ matrix with real nonnegative (or strictly positive, if $A$ is invertible) diagonal elements $s_{i}$ called singular values of $A$; also, $U_{L}$ and $U_{R}$ are complex unitary matrices. The QSVT operates with a matrix polynomial

where $p(S)=\operatorname{diag}\left(p\left(s_{1}\right), \ldots, p\left(s_{N}\right)\right)$, and $p\left(s_{i}\right)$ is a complex polynomial of a scalar $s_{i}$. In particular, let us consider the case when $P_{f}$ is a polynomial approximation of some given function $f$. If $A$ is Hermitian, then $U_{L}=U_{R}$ and, clearly, $P_{\mathrm{q} \text { svt }}(A)=P_{f}(A)$. If $A$ is not Hermitian, then $P_{\mathrm{qsvt}}(A)$ generally does not coincide with $P_{f}(A)$, but it still can be used to approximate $P_{f}(A)$ if $f$ is the inverse function. This is seen as follows.

First, note that the QSVT allows one to find the MoorePenrose pseudoinverse $A^{+}$(which must not be confused with the Hermitian adjoint $A^{\dagger}$ ). From the definition of $A^{+}$, and assuming that $A^{\dagger} A$ is invertible, one has $A^{+}=\left(A^{\dagger} A\right)^{-1} A^{\dagger}$, so, by Eq. (2), one finds

Now, let us consider $P_{\text {qsvt }}$ specifically with $p(s) \simeq s^{-1}$, where the symbol $\simeq$ denotes a polynomial approximation. By Eq. (3), one has $P_{\mathrm{qsvt}}\left(A^{\dagger}\right)=U_{R} S^{-1} U_{L}^{\dagger}$, and by comparing this with Eq. (4), one finds that $A^{+}=P_{\text {qsvt }}\left(A^{\dagger}\right)$. If the matrix $A$ is invertible, then $A^{+}=A^{-1}$ and therefore one has

This shows that $A^{-1}$ can be approximated with a QSVT polynomial constructed for $p(s) \simeq s^{-1}$.

## B. Block encoding

Because a quantum circuit can implement only unitary operations, to decompose a matrix polynomial of a given nonunitary matrix $A$, one first needs to encode it as a subblock
of an auxiliary unitary $U_{A}$. This procedure is called block encoding and involves introducing additional ancilla qubits. Specifically, $U_{A}$ acts as $A$ when the ancillae are in the zero state, $|0\rangle_{a}$, so $U_{A}$ has a form

For this, $A$ must be normalized such that $\varsigma\|A\|_{\max } \leq 1$, where

and $\varsigma$ is related to the matrix sparsity as detailed in Sec. VC (We define the sparsity as the number of nonzero matrix elements in a row maximized over all rows.) Otherwise, $A$ should be renormalized as follows:

## C. Polynomials via matrix rotations

The sets of right and left singular vectors $u_{r}$ and $u_{l}$, which are columns of the matrices $U_{L}$ and $U_{R}$, correspondingly, form two orthogonal sets. Any other vector can be represented as a linear superposition of the vectors from one of these sets. Therefore, to construct $U_{A}$, it is sufficient to define the action of this operator on the vectors $u_{r}$ and $u_{l}$. Assuming that $u_{r}$ and $u_{l}$ are associated with a given singular value $s$, one obtains from Eq. (2) that

U_{A}^{\dagger}|0\rangle_{a}\left|u_{l}\right\rangle & =s|0\rangle_{a}\left|u_{r}\right\rangle+\sqrt{1-s^{2}}\left|\perp_{r}\right\rangle, \tag{9b}
\end{align*}

where $\left|\perp_{l}\right\rangle$ and $\left|\perp_{r}\right\rangle$ are vectors orthogonal to the subspace that corresponds to the ancillae $a$ being in the zero state. Using that $U_{A}^{\dagger} U_{A}=1$, one obtains

& U_{A}\left|\perp_{r}\right\rangle=\sqrt{1-s^{2}}|0\rangle_{a}\left|u_{l}\right\rangle-s\left|\perp_{l}\right\rangle  \tag{10a}\\
& U_{A}^{\dagger}\left|\perp_{l}\right\rangle=\sqrt{1-s^{2}}|0\rangle_{a}\left|u_{r}\right\rangle-s\left|\perp_{r}\right\rangle . \tag{10b}
\end{align*}

The above equations indicate that $U_{A}$ maps the Hilbert space spanned by $|0\rangle_{a}\left|u_{r}\right\rangle$ and $\left|\perp_{r}\right\rangle$ to the space spanned by $|0\rangle_{a}\left|u_{l}\right\rangle$ and $\left|\perp_{l}\right\rangle$. Likewise, $U_{A}^{\dagger}$ maps $|0\rangle_{a}\left|u_{l}\right\rangle$ and $\left|\perp_{l}\right\rangle$ back to $|0\rangle_{a}\left|u_{r}\right\rangle$ and $\left|\perp_{r}\right\rangle$. Note that all these spaces remain invariant under the action of the projector $\Pi$ :

This property also extends to any function of $\Pi$. In particular, the reflector $Z_{\Pi}=2 \Pi-1$ maps $|0\rangle_{a}\left|u_{r, l}\right\rangle$ to $|0\rangle_{a}\left|u_{r, l}\right\rangle$, and $\left|\perp_{r, l}\right\rangle$ to $-\left|\perp_{r, l}\right\rangle$. By using the reflector, one can compose an elementary block of the QSVT circuit:

where $\phi_{x}$ and $\phi_{y}$ are real scalars that can be understood as rotation angles. A sequence of copies of this operator creates

a complex polynomial $P_{\text {qsvt }}(A)$ of definite parity. An odd polynomial of $A$ with a degree not exceeding $N_{\text {pol }}$ can be calculated as ${ }^{19}$

where

G_{k}=U_{A}^{\dagger} e^{\mathrm{i} \phi_{2 k} Z_{\Pi}} U_{A} e^{\mathrm{i} \phi_{2 k+1} Z_{\Pi}} \tag{14}
\end{equation*}

The polynomial $P_{\text {qsvt }}$ is defined up to a global phase and requires $N_{\text {pol }}+1$ classically precalculated angles $\phi_{i}$ as explained in Sec. IID In the spaces defined by Eqs. (9a)- (10b) and spanned by $|0\rangle_{a}\left|u_{r}\right\rangle$ and $\left|\perp_{r}\right\rangle$, as well as $|0\rangle_{a}\left|u_{l}\right\rangle$ and $\left|\perp_{l}\right\rangle$, the matrix polynomial becomes the scalar polynomial $p(s)$ of a real argument $s$. We are interested only in real polynomials, Re $p(s)$, whose circuit representation is shown in Fig. 1 (Real polynomials have only real coefficients, but maps complex domains into complex images.) The ancilla register $a$ is used to construct the block-encoding oracle $U_{A}$, and the ancilla qubit $q$ is used to construct the controlled rotations $\exp \left(\mathrm{i} \phi_{k} Z_{\Pi}\right)$ (Fig. 2). The QSVT can be used to solve Eq. (1) in that it computes $\left|\psi_{\text {out }}\right\rangle=|0\rangle_{q, a}\left|\psi_{x}\right\rangle+|\ldots\rangle$ for given $|b\rangle$ as

The QSVT circuit returns $\left|\psi_{x}\right\rangle$ in the input register when the ancilla registers $a$ and $q$ are output in the zero state. The rescaling by the condition number $\kappa_{\mathrm{qsvt}}$ and the additional factor $\beta_{\mathrm{sc}}$ ensures that $\left\|\psi_{x}\right\| \leq 1$, and $\phi_{\mathrm{glob}}$ is an arbitrary global angle. Equation (15) indicates that measurements of the state $\left|\psi_{x}\right\rangle$ have the success probability $\mathscr{O}\left(1 / \kappa_{\text {qsvt }}^{2}\right)$.

Note that we distinguish the actual condition number $\kappa$ of the matrix $A$ and the condition number $\kappa_{\mathrm{qsvt}}$ that is used as a
parameter in the calculation of the QSVT angles as explained below. Throughout this paper, $\kappa$ is defined as the ratio of the maximum and minimum singular values. The QSVT algorithm properly approximates $A^{-1}$ if $\kappa_{\mathrm{qsvt}} \gtrsim \kappa$.

For more details about the QSVT, see, for example, the recent overview in Ref. 22.

## D. Computation of QSVT angles

To compute the angles $\phi_{k}$ necessary for the construction of the QSVT circuit, one compares the polynomials $P_{f}(s)$ and $p(s)$. The polynomial $P_{f}(s)$ can be taken as a sum of Chebyschev polynomials:

The choice is justified in that the Chebyshev approximation is close to the minimax polynomial, ${ }^{23}$ which is the best possible polynomial approximation but requires the application of the Remez algorithm ${ }^{24}$ that can be computationally expensive. The coefficients $c_{k}$, however, can be computed without involving the Remez algorithm, specifically, using the Fourier series

where the number of points $N_{q}$ should be not less than $N_{c}$. In our work, we used both algorithms, specifically, the numerical implementation of the Remez algorithm as presented in Ref. 25 and also our GPU-parallelized version of the Fourier approach. ${ }^{26}$

The polynomial $p(s)$ can also be represented as a linear combination of Chebyschev polynomials with coefficients depending on $\phi_{k}$. The general algorithm to compute $\phi_{k}$ involves comparing the polynomial coefficients in $p(s)$ and $P_{f}(s)$. Usually, this requires arbitrary-precision arithmetic. ${ }^{27,28}$ In this work, however, $\phi_{k}$ are computed by minimizing the difference between $p(s)$ and $P_{f}(s)$ as proposed in Refs. 25 and 29. This algorithm works with the standard double-precision arithmetic.

To compute the polynomial for the inverse function $s^{-1}$, one considers the interval $s \in\left[-1,-1 / \kappa_{\mathrm{qsvt}}\right] \cup\left[1 / \kappa_{\mathrm{qsvt}}, 1\right]$ and approximates the original function by an auxiliary one

that coincides with $s^{-1}$ at the chosen interval and is analytic within $\left[-1 / \kappa_{\mathrm{qsvt}}, 1 / \kappa_{\mathrm{qsvt}}\right]$. For instance, one can take ${ }^{30}$

f(s)=\frac{1-e^{-\left(5 s \kappa_{\mathrm{qsvt}}\right)^{2}}}{s} \tag{18}
\end{equation*}

Then, one can use an odd polynomial to approximate $f(s)$ with some absolute approximation error $\varepsilon_{\text {qsvt }}$ :

\end{equation*}

Our calculations show that the polynomial approximation of $s^{-1}$ using the Remez algorithm works efficiently for small condition numbers ( $\kappa_{\mathrm{qsvt}} \lesssim 200$ ) and, generally, results in a smaller number of terms in $P_{f}(s)$ than the Fourier approach. For larger $\kappa_{\text {qsvt }}$, we use the Fourier approach since the Remez algorithm fails to deliver the coefficients of higher-order polynomials within a reasonable time. (Further optimization of the Remez algorithm, including its parallelization, might be possible but is not considered in this work.) In both cases, though, the number of terms in $P_{f}(x)$ grows linearly with $\kappa_{\mathrm{qsvt}}$ and logarithmically with $\varepsilon_{\mathrm{qsvt}}^{-1}$.

## III. SCALING

## A. General scaling of the QSVT

Here, we consider the scaling of the QSVT algorithm and compare it with classical methods for the matrix inversion. Because it is difficult to thoroughly analyze how preconditioning scales with the system size,, 21 we consider only a conservative scaling of the problem without preconditioning. However, even in this case, a polynomial speedup of the quantum method is possible for high-dimensional problems.

According to Ref. 20, the query complexity of the QSVT algorithm scales as $\mathscr{O}\left(\kappa \ln \left(\kappa / \varepsilon_{\text {qsvt }}\right)\right)$, as also validated by numerical simulations (Fig. 3). Here, we assume that the QSVT angles are computed using the parameter $\kappa_{\mathrm{qsvt}}$ close to the
matrix condition number, $\kappa_{\mathrm{qsvt}} \approx \kappa$. During each query, the QSVT circuit addresses the block-encoding oracle, which scales as $\mathscr{O}(\varsigma \ln (N))$, where $N$ is the size of the encoded ma$\operatorname{trix} A$, and $\varsigma$ is the matrix sparsity. According to Eq. (15), the probability of the zero-ancilla state after inverting a given matrix using the QSVT is $\mathscr{O}\left(1 / \kappa^{2}\right)$. Therefore, subsequent amplitude estimation, which includes amplitude amplification as a subroutine, requires $\mathscr{O}(\kappa)$ repetitions of the original QSVT procedure to achieve the probability $\geq 0.5$. Thus, the algorithm complexity is

\mathscr{O}\left(\kappa^{2} \varsigma \ln (N) \ln \left(\frac{\kappa}{\varepsilon_{\mathrm{qsvt}}}\right)\right) \tag{20}
\end{equation*}

assuming that the initialization of the starting quantum state is trivial, which is true in our case as explained in Sec.VB

## B. Scaling of the algorithm for modeling classical waves

In this paper, we are focusing on modeling wave dynamics and consider measurements relevant to this problem. Usually, in such problems, the spatial distribution of the corresponding fields is discretized by a finite-difference scheme or a finite-element method (FEM) over a grid with $N_{x}^{D}$ points (assuming the resolution is the same along all axes), where $D$ is the number of spatial dimensions, and $N_{x}$ is the number of points in the spatial grid along a single axis. This distribution is then encoded into $N_{x}^{D} N_{\text {fields }}$ complex amplitudes of the state-vector elements (Sec. $\overline{\mathrm{V}]}$, where $N_{\text {fields }}$ is the number of simulated variables (we assume $N_{\text {fields }}=1$ ).

If one measures, for example, the wave-number spectrum in a spatial domain with $N_{x}$ points by applying the quantum Fourier transform, one first needs to obtain the state projection where this spatial domain is encoded. The probability of this state equals the probability to extract $N_{x}$ elements from the set with $N_{x}^{D}$ elements (assuming that the field amplitudes are comparable at all $N_{x}^{D}$ spatial points), so it scales as $1 / N_{x}^{D-1}$. To increase this probability, the amplitude-amplification technique should be used, which involves $\mathscr{O}\left(\sqrt{N_{x}^{D-1}}\right)$ repetitions of the whole QSVT circuit. Hence, the whole algorithm scales as

\mathscr{O}\left(\sqrt{N_{x}^{D-1}} \kappa^{2} \varsigma \ln \left(N_{x}^{D}\right) \ln \left(\frac{\kappa}{\varepsilon_{\mathrm{qsvt}}}\right)\right) . \tag{21}
\end{equation*}

To eliminate the factor $\sqrt{N_{x}^{D-1}}$ from the above equation, one can dilate the system by adding $\eta_{\text {copies }} \geq 1$ copies, denoted as $F_{j}$, of the field amplitudes $F_{j_{0}}$ at each position $j_{0}$ within the spatial domain of interest to the original state vector. Correspondingly, it is necessary to supplement the original system of equations (as the one presented in Eqs. (36) and (38)) by $\eta_{\text {copies }}$ copies of the equation $F_{j}-F_{j_{0}}=0$ for $N_{x}$ positions $j_{0}$. By adding $N_{\text {copies }}=\eta_{\text {copies }} N_{x}$ additional equations, one increases the desired probability up to $\left(1+\eta_{\text {copies }}\right) N_{x}^{1-D}$. If $\eta_{\text {copies }} \sim \mathscr{O}\left(N_{x}^{D-1}\right)$ (in other words, if one doubles the size of the original matrix $A, N_{x}^{D} \rightarrow 2 N_{x}^{D}$ ), then the probability becomes $\mathscr{O}(1)$ and the scaling (21) turns
into

However, by adding $\eta_{\text {copies }} N_{x}$ equations we also increase the number of operations in the block-encoding oracle as

Furthermore, the condition number of the dilated system increases as well. According to Theorem 3.1 in Ref. 31, the condition number of FEM matrices scales as $\mathscr{O}\left(N_{\text {full }}^{2 / D}\right)$ for $N_{\text {full }}=N_{x}^{D}$. For instance, the condition number of our onedimensional system described in Sec.IVBscales even better, as $\mathscr{O}\left(N_{x}\right)$, according to the numerical results shown in Fig. 3. Thus, by doubling the matrix size, we change the condition number scaling as $\mathscr{O}\left(N_{x}^{2}\right) \rightarrow \mathscr{O}\left(2^{2 / D} N_{x}^{2}\right)$. As a result, one obtains the following scaling of the QSVT for the dilated matrix:

## C. Comparison with classical iterative methods

The QSVT can be compared with the best-known conjugate-gradient-based classical iterative methods for the inversion of sparse matrices. These methods ${ }^{32}$, such as BiCGSTAB ${ }^{33}$, GMRES ${ }^{34}$ and TFQMR ${ }^{35}$, which work with non-symmetric matrices, generally require preconditioning to converge. Here, we assume that they scale at least as the conjugate gradient method (which works only with symmetric matrices). As shown in Ref. 36, the number of iterations in this algorithm scales as $\mathscr{O}\left(\kappa \ln \left(1 / \varepsilon_{\text {qsvt }}\right)\right)$, and each iteration, where the sparse matrix-vector multiplication is the main operation, scales as $\mathscr{O}\left(\varsigma N_{x}^{D}\right)$. Thus, the scaling of the classical iterative method is

Here, we take the resulting absolute error in the classically calculated signal to be $\varepsilon_{\text {qsvt }}$. Taking into account the dependence of the condition number on the matrix size, $\kappa \sim$ $\mathscr{O}\left(N_{x}^{2}\right)$, the classical scaling becomes

By comparing Eqs. (24) and (26), one can see that the QSVT becomes more efficient than the classical methods in highdimensional problems, namely, those with $D \geq 3$. Examples of such (linear) problems include modeling of the wave propagation in plasma that is described hydrodynamically in three spatial dimensions or kinetically in six phase-space dimensions.

The QSVT scaling may be improved by reducing the condition number by means of preconditioning like that described in Ref. 37. We also stress that the QSVT algorithm currently has a bottleneck in that there are no optimized methods for calculating the rotation angles $\phi_{k}$ (used
in Eq. (13)) for large condition numbers. The latter problem is solved for our one-dimensional system, where $\kappa \sim 500$, by using the GPU-parallelized Fourier approach described in Sec. IID. For more complex problems, one may have to consider the method for computing $\phi_{k}$ that was proposed in Ref. 30.

## IV. THEORETICAL MODEL

## A. Problem specification

We consider EM waves in a linear medium with a dielectric permittivity $\varepsilon$. For simplicity, we assume the magnetic permittivity equal to unity as is the case, for example, in classical plasmas. Then, Maxwell's equations governing the waves can be written as

assuming units such that the speed of light equals unity. We consider the simplest model that allows investigating various measurement techniques of the wave spectrum and wave energy. Specifically, $\varepsilon$ will be assumed a piecewise-constant function of the spatial coordinates, and we will be interested in modeling the wave propagation across discontinuities of this function. In the absence of surface current and charge densities, the following boundary conditions are satisfied on each discontinuity of $\varepsilon$ :

where $\boldsymbol{E}_{t}$ and $\boldsymbol{B}_{t}$ are the fields tangent to the interface, $\boldsymbol{E}_{n}$ and $\boldsymbol{B}_{n}$ are the fields normal to the interface.

We consider a one-dimensional problem where waves propagate along the $x$ axis. The magnetic and electric fields are polarized along the $z$ and $y$ axes, respectively. Hence, Eqs. (27) can be expressed in a simple form:

where we omit the subindices $y$ and $z$ in $E_{y}$ and $B_{z}$. Also, we introduce the spatial coordinate $r_{x}$ that changes from 0 to 1 and is defined as

We assume a discontinuity of $\varepsilon$ at $r_{x, \text { int }}=1 / 2$, so that we have $N_{\text {layers }}=2$ dielectric layers of different permittivities:

A monochromatic source $Q=Q_{0} \exp (i \omega t)$ of the frequency $\omega$ and amplitude $Q_{0}$ is placed at $r_{x}=1$. The corresponding boundary-value problem, where we take $E, B \sim$

$\exp (\mathrm{i} \omega t)$, results in the following equations:

with $L=[0,1]$. (Here, the square brackets $\left[i_{\text {left }}, i_{\text {right }}\right]$ indicate a set of all integers from $i_{\text {left }}$ to $i_{\text {right }}$, including $i_{\text {left }}$ and $i_{\text {right }}$. To denote the same set but excluding $i_{\text {right }}$, we use the parenthesis as in $\left[i_{\text {left }}, i_{\text {right }}\right)$. The same notation will also be used to indicate open, $\left(x_{\text {left }}, x_{\text {right }}\right)$, and closed, $\left[x_{\text {left }}, x_{\text {right }}\right]$, continuous intervals with some rational numbers $x_{\text {left }}$ and $x_{\text {right }}$.) Note that the system is not conservative in that the wave energy is lost through radiation on the left and right boundaries and replenished by the source $Q$. In the left half of the spatial domain, where $r_{x}<r_{x, \text { int }}$, the EM field is a left-propagating wave. In the right half, the reflection at the interface between the dielectric layers results in the interference of left- and right-propagating waves and in the formation of a standing wave. Also, the wave propagating within the layer with the permittivity $\varepsilon$ has a wave number equal to

Below, we show how to develop a QSVT algorithm for this boundary-value problem and perform quantum measurements in the corresponding circuit to infer information about the spatial spectrum and the wave energy.

## B. Discretization

We discretize Eqs. (32) using the central finite difference scheme as shown in Fig. 4 Separate staggered grids, each
having $N_{x}=2^{n_{x}}$ points, are used for $E$ and $B$, and each dielectric layer contains $M_{x}=2^{n_{x}-1}$ spatial points. At the bulk spatial points, the discretized Eq. 32a) is

where $j=\left(M_{x} L+k\right)$ with $k=\left[1, M_{x}\right)$ for $L=0$ and $k=$ $\left[0, M_{x}\right)$ for $L=1$. Also, $\sigma=(2 h)^{-1}$, where $2 h$ is the spatial cell size:

The EM fields satisfy the outgoing boundary conditions (33) expressed as

Equations (36) and (38) with the boundary conditions (39) can be represented as a set of linear equations (1) where the vector $\psi$ stores $N_{\text {vars }}=2$ variables, $E$ and $B$ :

with $j=\left[0, N_{x}\right)$. The right-hand-side vector $b$ in Eq. (1) has dimension $N_{\text {vars }} N_{x}$ and encodes the source with the amplitude $Q_{0}=1$ :

where $L=[0,1], l=[0,1]$, and $k$ is the row index. The matrix $A^{\text {bulk }}$ contains information about the system evolution in the bulk spatial points. The matrix $A^{\text {edge }}$ describes the boundary conditions.

## V. ENCODING OF THE CLASSICAL SYSTEM INTO A QUANTUM CIRCUIT

Various formulations suitable for the QC of Maxwell's equations were proposed in Refs. 37-41, which considered analytical descriptions and the algorithm complexity but not actual circuits. Below, we show for the first time how to construct quantum circuits for this problem explicitly.

## A. Input registers

To map the problem on a quantum circuit, we introduce two input registers. The first one, $r_{d}$, consists of one qubit and encodes the variable index: $|0\rangle_{r_{d}}$ for the electric field and $|1\rangle_{r_{d}}$ for the magnetic field. The second register, $r_{j}$, contains $n_{x}=\log _{2} N_{x}$ qubits and encodes the coordinate index on the spatial grid. The state amplitude corresponds to the field magnitude at a given spatial point. For instance, the amplitude of the state $|1\rangle_{r_{d}}|j\rangle_{r_{j}}$ stores the magnitude of the magnetic field at $x_{j}$, where $x_{j}$ is taken on the upper spatial grid in Fig. 4 All indices are numbered from 0.

## B. Initialization

To solve Eq. (11) with the matrix (42) and the source (41) using the QSVT, one needs to block-encode the matrix $A$ into the unitary $U_{A}$ (Eq. (6) and encode the vector $b$ as the initial state, denoted as $|b\rangle$. At the beginning, all qubits are initialized in the zero state. Using the registers $r_{j}$ and $r_{d}$, the right-hand-side vector can be encoded as

The coefficients $\alpha_{k}^{(E, B)}$ are determined from Eq. (41), whence $\alpha_{k}^{(E)}=0$ for all $k$ and $\alpha_{k}^{(B)}=\delta_{k, N_{x}-1}$. Because the bit string encoding the number $N_{x}-1$ consists only of units, the state $|b\rangle$ can be initialized by applying the $X$ gate to each qubit in the register $r_{j}$. Also, the $X$ gate is applied to the qubit $r_{d}$. Importantly, the depth of the corresponding initialization circuit, henceforth denoted 'INIT', does not depend on $N_{x}$.

## C. Block encoding of a non-Hermitian matrix

To block-encode the matrix $A$, one should normalize it first according to Eq. (8). Here, we normalize $A$ in the following way:

The origin of the factor $d_{H}=2$, where $d_{H}^{2}$ is close to the actual sparsity of $A$, is explained in Sec.VE

To block-encode a non-Hermitian matrix, one usually extends it first to a Hermitian one: ${ }^{13.37 .42}$

After that, one can use the standard state-preparation technique ${ }^{4.43}$ to block-encode $A_{\text {ext }}$, where the oracle $U_{A}$ is represented through unitary operators $O_{F}, O_{H}, O_{M}$ :

The circuit implementing $U_{A}$ operates with 'input' qubit registers (in our case, registers $r_{j}$ and $r_{d}$ ) that contain initial and final (output) data, and also ancilla registers that are initialized in the zero states and used for intermediate computations. The operator $O_{F}$ reads a row index from the input registers, calculates the column indices of all nonzero elements of $A_{\text {ext }}$ at the given row and writes the computed indices into the ancillae. The operator $O_{H}$ computes the values of these nonzero elements and encodes them into the amplitudes of the ancilla-qubits' states. The operator $O_{M}$ transfers the computed column indices to the input registers so that $U_{A}$ could return the indices as an output. After that, $O_{F}^{\dagger}$ uncomputes (sets back to zero) the used ancilla registers for the state encoding the matrix nonzero elements.

In our implementation, we amend the above technique. In order to shorten the circuit for $U_{A}$, we avoid extending $A$ to a Hermitian matrix. Instead, we split $O_{F}$ into two oracles $O_{\text {bulk }}$ and $O_{\text {edge }}^{\mathrm{F}}$, and the adjoint $O_{F}^{\dagger}$ is replaced with the product of $O_{\text {bulk }}^{\dagger}$ and $O_{\text {edge }}^{\mathrm{B}}$. The index F in $O_{\text {edge }}^{\mathrm{F}}$ stands for 'forward', and the index 'B' in $O_{\text {edge }}^{\mathrm{B}}$ stands for 'backward'. The pair of oracles $O_{\text {edge }}^{\mathrm{F}}$ and $O_{\text {edge }}^{\mathrm{B}}$ encodes the locations of the elements $\eta_{ \pm}$in Eq. (44). The oracles $O_{\text {bulk }}$ and $O_{\text {bulk }}^{\dagger}$ encode the positions of the matrix elements in Eq. (43). Hence, the decomposition (48) is replaced with

Note that for a Hermitian $A$, one has $O_{\text {edge }}^{\mathrm{B}}=\left(O_{\text {edge }}^{\mathrm{F}}\right)^{\dagger}$, but generally this is not the case (Sec. $\nabla \mathrm{E})$. The decomposition (49) eliminates the need for the supplemental ancilla used for the extension (47), and one can also avoid additional gates needed for the block-encoding of $A^{\dagger}$ in Eq. (47). The circuit for $U_{A}$ is shown in Fig. 5. To describe the action of each operator in the above product, we need to consider the ancilla qubits used in the intermediate computations.

## D. Ancilla qubits

The matrix $A$ of size $2 N_{x} \times 2 N_{x}$ can be separated into four blocks of size $N_{x} \times N_{x}$ each. We introduce the ancilla qubit $a_{d}$ to address the first $N_{x}$ columns of $A$ when this qubit is in the zero state and to the last $N_{x}$ columns when it is in the unit state. The input register $r_{d}$ described in Sec. VA is used to address the first $N_{x}$ matrix rows when it is in the state $|0\rangle_{r_{d}}$ and the last $N_{x}$ rows when it is in the state $|1\rangle_{r_{d}}$. Hence, any block can be addressed by using just the qubits $a_{d}$ and $r_{d}$.


FIG. 5: The circuit implementing the oracle $U_{A}$ described in Eq. (49). The circuit for the operator $O_{H}$ is shown in Fig. 6 The decrementor ( Dec ) and incrementor (Inc) are described in Eqs. (54), and their circuits can be found in Ref. 4. The ancillae $a_{d}, a_{j}$ and $a_{v}$ are initialized in the zero state and described in Sec.VD.

Another ancilla, denoted $a_{v}$, is used to store the values of the matrix nonzero elements as explained in Sec. VF

An additional qubit, $a_{j}$, encodes the relative positions of matrix elements with respect to the diagonal within each block. The zero state of the qubit $a_{j}$ indicates a matrix element on the diagonal of a given block. (The position of the block itself in the matrix $A$ is encoded by the qubits $a_{d}$ and $r_{d}$ as described above.) Having $a_{j}$ in the unit state encodes different information depending on the state of $a_{d}$. If $a_{d}$ is in the zero state, then $|1\rangle_{a_{j}}$ indicates the matrix element shifted by one cell to the right from the block diagonal. If $a_{d}$ is in the unit state, then $|1\rangle_{a_{j}}$ indicates the element shifted by one cell to the left:

where $i_{c}, i_{r}=\left[0, \ldots N_{x}\right)$ are the column and row indices, respectively, of a matrix element within a given block.
The dependence on $a_{d}$ is due to the fact that in the upper and lower left blocks (corresponding to $a_{d}$ 's being in the zero state), the matrix (42) has nonzero elements only on the block diagonals and in cells shifted by one cell to the right from the diagonals. In the upper and lower right blocks (corresponding to $a_{d}$ 's being in the unit state), we work only with block-diagonal elements and elements shifted by one cell to the left.


FIG. 6: The circuit implementing the operator $O_{H}$. The subcircuits are described in Fig. 7 The rotation angles $\theta_{ \pm \pi}$ are computed using Eqs. (A6).

## E. Matrix structure

To explain the action of $U_{A}$ given by Eq. (49), let us first ignore the effect of $O_{H}$ and consider an auxiliary operator

O_{S}=O_{\text {bulk }}^{\dagger} O_{\text {edge }}^{\mathrm{B}} O_{M} O_{\text {edge }}^{\mathrm{F}} O_{\text {bulk }} \tag{51}

The purpose of introducing this auxiliary operator is to explain the appearance of the factor $d_{H}^{2}$ in Eq. (46), which is determined by the matrices entering (51) but not $O_{H}$.

The operators $O_{\text {bulk }}$ and $O_{\text {edge }}^{\mathrm{F}}$ (Fig. 5) encode the column indices of nonzero elements to a linear superposition of states of the ancillae $a_{d}$ and $a_{j}$ using a given row index from the registers $r_{j}$ and $r_{d}$. For instance, for the matrix row with the index $k=1$ (the second top matrix row encoded as $|0\rangle_{r_{d}}|1\rangle_{r_{j}}$, one has

Here, the first term in parenthesis encodes the position of the element $\mathrm{i} \omega \varepsilon_{0}$ on the main matrix diagonal in Eq. (43) in the row with $k=1$. The second and third terms encode the positions of the elements $(-1)^{l} \sigma$ in Eq. (43) at $k=1$. Thus, the column indices are written to the states of the qubits $a_{d}$ and $a_{j}$. The various orders of the factor $d_{H}$ introduced in Eq. (46) appear here due to the action of Hadamard gates, because each Hadamard gate modifies the state probability by $2^{-1 / 2}$.

As mentioned in $\mathrm{Sec} . \mathrm{VC}$ the oracle $U_{A}$ returns the state encoding matrix column indices. To transfer the column indices saved in the ancillae $a_{d}$ and $a_{j}$ to the input registers $r_{d}$ and $r_{j}$, we use the operator $O_{M}$, where the decrementor and incrementor ('Dec' and 'Inc' gates in Fig. 5] map the relative positions (encoded into the ancilla $a_{j}$ ) to the absolute column indices and write them to the input register $r_{j}$. These operators act on a given state $|k\rangle$ in the following way:

and they are controlled by the ancillae $a_{j}$ and $a_{d}$ (as shown in Fig. 5) to correctly perform the mapping described in

Eq. (50). Apart from that, $O_{M}$ transfers the absolute column indices stored in the ancilla $a_{d}$ to the input qubit $r_{d}$ by swapping these qubits.

The oracle $O_{\text {edge }}^{\mathrm{B}}$ is close to $O_{\text {edge }}^{F \dagger}$, but the control nodes of the Hadamard gates in $O_{\text {edge }}^{\mathrm{B}}$ are adjusted in such a way that the operator $O_{S}$ returns the correct column indices of the element $\eta_{-}$in Eq. (44). The oracle $O_{\text {edge }}^{\mathrm{B}}$ is found ad hoc specifically to encode the non-Hermitian matrix (42).

To describe the oracle $O_{H}$, note first that $O_{S}$ does not only encode the column indices into $r_{d}$ and $r_{j}$ but also modifies the amplitudes of the corresponding quantum states as demonstrated in Eq. (52). Specifically,

where $l=d_{r} N_{x}+k_{r}=\left[0,2 N_{x}\right), d_{r}=[0,1], k_{r}=\left[0, N_{x}\right)$, and the ancillae $a_{d}$ and $a_{j}$ are assumed to be returned in the zero states. The oracle $O_{H}$ must take into account the values from Eq. (55) and output the correct amplitudes $A_{k j}$ from Eqs. (43) and (44).

## F. Operator $O_{H}$

The operator $O_{H}$ encodes the values $A_{k j}$ into the state amplitudes of the qubit $a_{v}$. This is done by applying the rotation gates described in Appendix A The corresponding rotation angles are computed by taking into account the target values from Eq. (42), denoted $v_{\text {des }}$, and the multiplication factors from Eq. [55], denoted $c_{d}$, that appear due to the action of the operator $O_{S}$. For instance, the value $v_{\text {des }}$ can be encoded in the state amplitude by using the standard gate $R_{x}(\theta)$ acting on the zero state of the qubit $a_{v}$ :

where $|\ldots\rangle$ denotes states of other ancillae. The target value $v_{\text {des }}$ can be encoded to the amplitude of either the zero state $|0\rangle_{a_{v}}$ or the unit state $|1\rangle_{a_{v}}$. Since some of the values from Eq. (42) are purely imaginary, we choose the unit state to store $v_{\text {des }}$, so $v_{\text {des }}=-\mathrm{i} c_{d} \sin (\theta / 2)$. This requires the following angle:

where $\boldsymbol{l}_{v}= \pm 1$ is the sign of $\operatorname{Im} v_{\text {des }}$. The above transformation works only for purely real or imaginary values. To encode a complex value, one can use the combined rotation $R_{c}(v)$ presented in Eq. (A4).

The circuit implementing $O_{H}$ is shown in Fig. 6 and its individual blocks are detailed in Fig. 7 The rotation gates of the oracle $O_{H}$ are controlled by the states of the ancillae $a_{d}$ and $a_{j}$ and the input registers $r_{d}$ and $r_{j}$ to compute the values of the matrix elements at the positions encoded in these states. The calculation of the rotation angles for the oracle $O_{H}$ is summarized in Appendix A .

Assuming availability of gates that can be controlled by multiple qubits, the circuit depth of the oracle $U_{A}$ scales as

$\mathscr{O}\left(n_{x}\right)$ due to the scaling of the decrementor and incrementor operators (54). The number of ancilla qubits is independent of $n_{x}$. The main reason for this is that the ancilla $a_{j}$ stores the relative positions of the matrix elements, but not the absolute column indices. (In the latter case, the number of ancillae would be proportional to $n_{x}$.) If multicontrolled gates are not available, though, they would have to be transformed into elementary gates. An $n$-controlled single-target gate can be transformed into $\mathscr{O}\left(n^{2}\right)$ elementary gates using $\mathscr{O}(n)$ ancillae ${ }^{44}$

## VI. COMPARISON WITH CLASSICAL SIMULATIONS

## A. Direct comparison without measurements

We solve the model equations (32) by computing the inverse of the corresponding matrix 42) classically (by applying the standard Gauss-Jordan elimination) and by using the QSVT, whose quantum circuit is emulated using

our open-source code. ${ }^{26}$ Two sets of parameters are considered: $L_{x} k_{x, 0}=20.0, \varepsilon_{0}=\varepsilon_{1}=1, n_{x}=6$ and $L_{x} k_{x, 0}=28.8$, $4 \varepsilon_{0}=\varepsilon_{1}=4, n_{x}=7$, where $L_{x}$ is the spatial size of the system. The comparison between the classical and QSVT simulations is shown in Figs. 8 where the QSVT angles are computed using the indicated parameter $\kappa_{\text {qsvt }}$ and the approximation error $\varepsilon_{\text {qsvt }}$.

The first case, with $\varepsilon_{0}=\varepsilon_{1}=1$ (Fig. 8), corresponds to the propagation of a vacuum EM wave to the left from the source, which is placed at the right boundary. The matrix $A$ corresponding to this case has a condition number $\kappa \approx 150$, which is estimated as the ratio of the maximum and minimum singular values. This value varies with the method chosen for the computation of $\kappa$ as discussed in Ref. 16. As seen from Fig. 8, if the QSVT parameter $\kappa_{\text {qsvt }}$ is not sufficiently large, the calculation of the electric field using the QSVT does not converge.

The second case (Fig. 9) has a dielectric-dielectric interface at the center of the spatial domain, where the permittivity changes (as shown in Eq. (31). When the leftpropagating wave (incident wave) excited by the source $Q$ hits this interface, the wave is partially reflected and partially transmitted to the left half of the spatial domain ( $r_{x}<r_{x, \text { int }}$ ). Hence, the right half of the spatial domain ( $r_{x}>r_{x, \text { int }}$ ) contains both incident and reflected waves. Their interference changes the field amplitude and the wave-number spectrum, as seen in Fig. 9 This will be analyzed in Secs. VIB and VIC. The increase of the wave number in the right domain explains why one needs a larger number of spatial points, which results in a larger number of qubits, $n_{x}=7$ instead of $n_{x}=6$. In turn, changing $n_{x}$ results in a larger condition number of $A$ (here, $\kappa \approx 400$ ), and that requires a higher value of $\kappa_{\text {qsvt }}$ to compute $A^{-1}$ by the QSVT.

As seen from the green and blue lines in Fig. 10 if $\kappa_{\text {qsvt }}$ is not large enough, then the decrease of $\varepsilon_{\text {qvt }}$ does not improve the precision of the modeled signal (i.e., the electric field $E)$. In other words, the parameter $\kappa_{\mathrm{qsvt}}$, which determines the number of the QSVT angles and their values, defines the maximum achievable precision of the simulated signals. If

$\kappa_{\mathrm{qsvt}}$ is sufficiently large (as mentioned in Sec. IIII) $\log _{2} \kappa_{\mathrm{qsvt}}$ scales as $\left.\mathscr{O}\left(n_{x}\right)\right)$, then the resulting error changes linearly with $\varepsilon_{\text {qsvt }}$.

## B. Estimation of the wave numbers

One can estimate the dominant wave number(s) of the electric field using the quantum Fourier transform (QFT). A possible circuit is shown in Fig. 11 If one needs to measure the spectrum only in the left (right) half of the spatial domain, then the $X$ gate should be controlled also by the zero (unit) state of the uppermost qubit in the register $r_{j}$. The zerocontrol node on the qubit $r_{d}$ entangles the unit state $|1\rangle_{m}$ in the qubit $m$ with the state returned by the QSVT subcircuit encoding the spatial distribution of the electric field. As seen from Eq. (15), the amplitude of this state scales as $\mathscr{O}(1 / \kappa)$. Thus, the state should be amplified by using the amplitude amplification (AA) procedure ('AAb') ${ }^{47}$ for an unknown amplitude that requires $\mathscr{O}(\kappa)$ repetitions of the circuit $U_{\text {prep }}$ presented in Fig. 11 After the 'AAb', the probability to measure $|1\rangle_{m}$ becomes not less than $1 / 2$.

If the unit state $|1\rangle_{m}$ is measured, then the QFT, which requires $\mathscr{O}\left(n_{x}^{2}\right)$ quantum gates, is performed in the register $r_{j}$. Specifically, the spatial distribution of the electric field over the grid

is transformed into its spectrum on the wave-number grid

$$
\begin{equation*}

where $k_{\max }=\pi / \Delta x, \Delta x=2 h, \Delta k=2 k_{\max } / N_{x}$, and $N_{x}$ is an even integer (Sec.IVB). More precisely, after the QFT, the bit strings in the register $r_{j}$ encode the wave number grid, and the state amplitudes encode the corresponding Fourier magnitudes. The measurement of the qubits in the register $r_{j}$ outputs a bit string encoding a single wave number $k_{x}$ of a Fourier component with some amplitude $F_{k_{x}}$. The probability to measure a certain $k_{x}$ equals $\left|F_{k_{x}}\right|^{2}$.

Since the circuit shown in Fig. 11 is computationally expensive to emulate classically, we compute it in parts by modeling the INIT+QSVT circuit first and then transferring the computed QSVT state directly to the QFT as an input. The comparison between the classical FFT and QFT is shown in Fig. 12, where both FFT and QFT are defined over the same wave-number grid (59). Specifically, shown in Fig. 12 is the distribution of the probability with which a measurement returns a given $k_{x}$. According to the figure, each measurement most likely returns the wave numbers $k_{x, 0}$ or $\sqrt{\varepsilon_{1}} k_{x, 0}$, which is in agreement with Eq. (35).

This QFT-based procedure is particularly useful when the wave spectrum consists mainly of just a few dominant modes, which can be identified with $\mathscr{O}(1)$ measurements. A relevant application could be to the modeling of radiofrequency modes in fusion plasmas ${ }^{48}$, where the local spectrum often consists of a mode launched by an antenna and, possibly, few other modes generated by reflection and (or) mode conversion ${ }^{49}$ The corresponding wave vectors vary in space, and the above procedure can be used to identify these wave vectors at a given location of interest.

## C. Amplitude estimation of the field energy

To measure the field energy summed over a chosen spatial domain, we can use the so-called amplitude estimation (AE) procedure. For example, it can be implemented using the standard algorithm described in Ref. 47. The corresponding circuit is shown in Fig. 13, where the register $r_{y}$ has $n_{y}$ qubits. There, the subcircuit $U_{\text {prep }}$ entangles the unit state $|1\rangle_{m}$ with the superposition of states encoding the spatial distribution of the electric field in the right domain ( $r_{x}>r_{x, \text { int }}$ ):

(Here, we omit the register $r_{y}$, which remains in the zero state. We also omit the multiplication factor from Eq. (15) and the QSVT ancillae.) The electric-field energy can be measured as the probability amplitude of the state $|1\rangle_{m}$ :

Instead of emulating the circuit from Fig. 13 directly, which is computationally expensive, we emulate a simplified circuit shown in Fig. 14, There, the operator $U_{\text {prep }}$ is reduced to the one-qubit rotation $R_{y}\left(\theta_{E}\right)$, so

where $\sin ^{2}\left(\theta_{E}\right)=p_{m, 1}$. (This defines $\theta_{E}$ up to a modulo $\pi$, which is not important since we are only interested in $\sin ^{2}\left(\theta_{E}\right)$.) More precisely, we emulate the actual circuit $U_{\text {prep }}$ to compute the state $\psi_{E}$, from which we calculate the probability $p_{m, 1}$ numerically. As a result, we can find the angle $\theta_{E}$. After that, we model the circuit shown in Fig. 14 using $U_{\operatorname{sim}}$ with the pre-computed $\theta_{E}$. To demonstrate the operation of the AE, we also report emulation of the nonsimplified AE circuit (as in Fig. 13) for a Gaussian field profile in Appendix B 2

The bit string measured after the AE encodes an integer $i_{y}$ from which one can estimate the desired probability amplitude: ${ }^{47}$

where $N_{\mathrm{AA}}=2^{n_{y}}$, and $\tilde{p}_{m, 1}$ is the estimated probability of the state $|1\rangle_{m}$. With a probability more than 0.81 , the measurement outcomes $\tilde{p}_{m, 1}$ with the following absolute error: ${ }^{47}$

Since $p_{m, 1}$ is unknown in advance, in practice one can estimate $\delta$ by replacing $p_{m, 1}$ with $\tilde{p}_{m, 1}$ (obtained from measurements) in the right-hand side of Eq. (64). Then, the field energy stored in a given domain spanning $N_{x, \text { area }}$ points can be estimated as

The AE circuit requires $\mathscr{O}\left(N_{\mathrm{AA}}\right)$ repetitions of the AA operator, which is described in Appendix B2 and includes two calls to the QSVT. Because $\delta$ scales as $\mathscr{O}\left(1 / N_{\mathrm{AA}}\right)$, to measure the energy with an absolute error not larger than $\delta$, one needs $\mathscr{O}(1 / \delta)$ queries to the QSVT circuit. Since the amplitude of the QSVT resulting state, where the system fields are encoded, is $\mathscr{O}(1 / \kappa), \delta$ should also be at least as small as $\mathscr{O}(1 / \kappa)$. Thus, the AE requires $\mathscr{O}(\kappa)$ queries to the QSVT circuit.

The results of our emulations of the above AE procedure are summarized in Fig. 15 By increasing the number of qubits in the register $r_{y}$, one can reduce the measurement error $\delta$ so that the QSVT approximation error dominates over $\delta$. In turn, the QSVT error itself can be reduced by increasing $\kappa_{\text {qsvt }}$ and (or) decreasing $\varepsilon_{\text {qsvt }}$ as described in Sec. VIA,

## D. Measurement of the absorbed wave power

Another important parameter to measure in simulations of stationary waves is the absorbed power. In a given region $\left(x_{\mathrm{B}}, x_{\mathrm{E}}\right)$, this power can be calculated as ${ }^{48}$

where $\sigma$ is the conductivity at a given frequency, and the symbol * denotes the complex conjugation. The integration

over $x^{\prime}$ can be replaced by integration over $\zeta=x^{\prime}-x$ :

where the domain in the second integral can be finite and arbitrary as long as it is much larger than the localization scale of $\sigma$ with respect to $\zeta$ at a given $x$. Let us also adopt, for simplicity, that the interval ( $x_{\mathrm{B}}, x_{\mathrm{E}}$ ) is small enough so the dependence of $\sigma$ on $x$ on this interval can be neglected. In other words, let us assume, say, $\sigma(x, x+\zeta) \approx \bar{\sigma}\left(x_{\mathrm{C}}, \zeta\right)$, where $x_{\mathrm{C}}=\left(x_{\mathrm{B}}+x_{\mathrm{E}}\right) / 2$ is the center of the interval. (Further, for simplicity, we omit $x_{\mathrm{C}}$ and the bar in $\bar{\sigma}\left(x_{\mathrm{C}}, \zeta\right)$.) Then, after discretization, Eq. (67) becomes

where the indices $k_{\mathrm{B}}$ and $k_{\mathrm{E}}$ correspond to the spatial points $x_{\mathrm{B}}, x_{\mathrm{E}}$, respectively. The spatial interval has $N_{\mathrm{EB}}=k_{\mathrm{E}}-$ $k_{\mathrm{B}}+1$ points, and the electric current $\sigma_{j} E_{k+j}$ at the point $x_{k}$ is induced by the electric field within the window of $N_{\mathrm{w}}=$ $2 N_{\mathrm{h}, \mathrm{w}}+1$ points centered at $x_{k}$. To encode $N_{\mathrm{EB}}$ and $N_{\mathrm{w}}$ spatial points, one needs $n_{\mathrm{EB}}=\left\lceil\log _{2} N_{\mathrm{EB}}\right\rceil$ and $n_{\mathrm{w}}=\left\lceil\log _{2} N_{\mathrm{w}}\right\rceil$ qubits, respectively. Positive $\mathscr{P}$ corresponds to the wave power absorbed by the environment e.g., plasma.

In practice, $\sigma_{j}$ depends on the given medium and is supposed to be calculated analytically or numerically in kinetic simulations $\underline{\underline{50}}$ Here, we assume that the conductivity is a Gaussian function, $\sigma_{j}=G_{j}$, and rewrite Eq. 68b) as follows:

and Heaviside functions $\Theta$. The sum (69) has the form of the inner product $\langle E| M|E\rangle$ and, therefore, its circuit representation can be computed by applying the Hadamard test, ${ }^{51.52}$ provided that the matrix $M$ is encoded into a unitary one. Yet, the block-encoding of $M$ into a unitary can be difficult. Therefore, we propose an alternative way based on the SWAP test $t^{53}$ and quantum arithmetic operators.

The idea is to keep the simple vector form $G_{j}$ of the conductivity (instead of its matrix form $G_{p-k}$ as in Eq. (69)). Hence, we rewrite $D$ in Eq. (68b) as

Here, the Gaussian $G_{j}$ depends on a single index and can be calculated by the QSVT as explained in Appendix B 1 However, now the electric fields are summed over different spatial intervals and should be encoded into states on two different registers, $I$ and $I I$. These intervals can be set by applying various arithmetic operators described in Appendix A3 The coupling of the electric fields in Eq. (71) through the index $k$ can be implemented by using a quantum subtractor that performs the transformation $|k\rangle|p\rangle \rightarrow|k\rangle|p-k\rangle$.

The SWAP test computes the product of the form $|\langle\psi \mid \lambda\rangle|^{2}$ of two quantum states $|\psi\rangle$ and $|\lambda\rangle$ calculated in two separate qubit registers. In other words, one finds the square of the sum $\sum_{j} \psi_{j}^{*} \lambda_{j}$. To find the double sum as (71), we introduce supplemental registers, $r_{\mathrm{EB}}$ and $r_{\mathrm{w}}$, and perform one SWAP test between the registers $I I$ and $r_{\mathrm{EB}}$, and another SWAP test between $I$ and $r_{\mathrm{w}}$. The circuit for the computation of the double sum (71) is shown in Fig. 16, where the electric fields are computed using the QSVT subcircuits denoted 'MI'. ('MI' is the same QSVT circuit as the one used in Figs. 11 and 13) Further, we consider the circuit shown in Fig. 16step by step.

First of all, we compute the spatial distribution of the electric fields and initialize the registers $r_{\mathrm{w}}$ and $r_{\mathrm{EB}}$ :

where all other qubits are in the zero state, and the state $\left|\xi_{1}\right\rangle$ is indicated in Fig. 16. The registers $r_{\text {EB }}$ and $r_{\mathrm{w}}$ encode the following superpositions:

In Eqs. 731, the subindices indicating the qubit registers are skipped, since the states $\left|\phi_{\{l\}}^{\mathrm{EB}}\right\rangle$ and $\left|\phi_{\{i\}}^{\mathrm{W}}\right\rangle$ will also appear in other registers.

The operators $S_{I-r_{l}}$ and $S_{k_{B}}$ are two types of subtractors described in Appendix A3 The adder $A_{i}$ and comparator $C_{i}$ (for some integer $i$ ) are also presented in Appendix A3. The qubit $\operatorname{com}_{I}$ is not used by the subtractor $S_{I-r_{l}}$. To compute $p_{0, r_{\text {swap }}}$, the rightmost Toffoli gate must be controlled by the zero state of the qubit $r_{\text {swap }}$.

After that, the subtractor $S_{I-r_{\mathrm{EB}}}$ couples the indices in the registers $I$ and $r_{\text {EB }}$ :

The expression in the rightmost sum can be recasted as $E_{l+j}|j\rangle_{I}$ by setting $j=p-l$, where $j=\left[-l, N_{x}-l\right)$. The subtractor $S_{I-r_{\mathrm{EB}}}$ uses the ancilla $a_{I, \text { sign }}$ as a flag (or as a sign bit) which is set into the unit state for negative values of the index $j$. For simplicity, this ancilla is skipped in Eq. 75). Later, the state of this ancilla will be taken into account to deal only with positive values of $j$.

The next step is to encode the electric field amplitudes at the spatial points with indices $\left[k_{\mathrm{B}}, k_{\mathrm{E}}\right]$ into the first $n_{\mathrm{EB}}$ leastsignificant qubits in the register $I I$. To do that, we apply the subtractor $S_{k_{\mathrm{B}}}$ to the register $I I$. This operator subtracts the (unsigned) integer $k_{\mathrm{B}}$ from the integers encoded within the register $I I$ and entangles all indices not less than $k_{\mathrm{B}}$ with the zero state of the qubit $a_{I I, \text { sign }}$. After that, the comparator $C_{N_{\text {EB }}}$ is applied to set the correct upper limit in the sum $\sum_{k}$ by entangling all indices $k$ less than $N_{\text {EB }}$ with the unit state $|1\rangle_{\operatorname{com}_{I!}}$.

Similar arithmetic operators are applied to the register $I$ to entangle the intervals $\left[x_{k_{\mathrm{B}}+l-N_{\mathrm{h}, \mathrm{w}}}, x_{k_{\mathrm{B}}+l+N_{\mathrm{h}, \mathrm{w}}}\right]$ for $l=\left[0, N_{\mathrm{EB}}\right)$ with the state $|1\rangle_{\mathrm{com}_{I}}|0\rangle_{a_{I, \text { sign }}}$.

After that, the QSVT circuit is applied to the first $n_{\mathrm{w}}$ least-significant qubits of the register $I$ to multiply the electric field by the Gaussian as described in Ap-
pendix B3 To center correctly the Gaussian within the window $\left[x_{k_{\mathrm{B}}+l-N_{\mathrm{h}, \mathrm{w}}}, x_{k_{\mathrm{B}}+l+N_{\mathrm{h}, \mathrm{w}}}\right]$, one can use Eqs. (B3). The resulting data are entangled with the unit state $|1\rangle_{r_{\text {sel }}}$ :

and we are not interested in the state $|0\rangle_{r_{\text {sel }}}$. Note that in Eq. (76), the double sum $\sum_{l}|l\rangle_{r_{\mathrm{EB}}} \sum_{j} G_{j} E_{k_{\mathrm{B}}+l+j-N_{\mathrm{h}, \mathrm{w}}}|j\rangle_{I}$ is written as $\left|\phi_{\{l\}}^{\mathrm{EB}}\right\rangle_{r_{\mathrm{EB}}}\left|\phi_{l}^{G}\right\rangle_{I}$, where the subindex $l$ in $\left|\phi_{l}^{G}\right\rangle$ indicates the coupling to the state $\left|\phi_{\{l\}}^{\mathrm{EB}}\right\rangle$.

To compute the absolute value of $D$ from Eq. 71), we perform the SWAP test:

By applying the corresponding Toffoli gate, one can entangle $\left\langle\left. 1\right|_{r_{\text {swap }}}\left\langle\left. 1\right|_{r_{\text {sel }}} \mid \xi_{4}\right\rangle \text { with the unit state } \mid 1\right\rangle_{m}$ and measure its
probability $p_{1, r_{\text {swap }}}$ by using the AE. The probability of the state (78) is

with an unknown $\left|c_{0}\right|^{2}$. The positive real value $S$ is computed as a product of the sum:

with the sum

&=\sum_{l=0}^{N_{\mathrm{EB}}-1} E_{k_{\mathrm{B}}+l}^{*} \sum_{i_{2}=0}^{N_{\mathrm{w}}-1} G_{i_{2}} E_{k_{\mathrm{B}}+l+i_{2}-N_{\mathrm{h}, \mathrm{w}}} \tag{81}

By comparing Eq. (71) with the Eqs. (80) and (81), one can see that $S \equiv|D|^{2}$.

The constant $\left|c_{0}\right|^{2}$ can be eliminated by measuring also $p_{0, r_{\text {swap }}}$, which is the probability of the state $\left\langle\left. 0\right|_{r_{\text {swap }}}\left\langle\left. 1\right|_{r_{\text {sel }}} \mid \xi_{4}\right\rangle\right.$. Because this state is the same as (78) but with the ' + ' sign in the brackets, its probability is

Thus, the absolute value of the double sum (71) can be calculated as

As mentioned before, the amplitude of the QSVT output state (returned by 'MI') is $\mathscr{O}(1 / \kappa)$. To compute the sum (71), one launches the 'MI' twice in parallel to compute the product $E^{*} E$, which is $\mathscr{O}\left(1 / \kappa^{2}\right)$. Thus, to estimate $p_{0, r_{\text {swap }}}$ or $p_{1, r_{\text {swap }}}$, one will need $\mathscr{O}\left(\kappa^{2}\right)$ queries to the QSVT circuit. However, if $N_{\mathrm{EB}}$ is comparable with the system size, then the number of the queries can be reduced at least to $\mathscr{O}(\kappa)$ for two- and three-dimensional spatial systems.

## VII. CONCLUSIONS

In this paper, we propose a quantum algorithm for simulating dissipative waves in inhomogeneous linear media as a boundary-value problem. Our algorithm is based on the QSVT, which is a state-of-the-art technique that was previously proposed for other problems but is applied here to a boundary-value wave problem for the first time. Specifically, we model an EM wave that is excited by a prescribed source and propagates in a dielectric medium with a piecewisecontinuous dielectric function. We show how to encode the corresponding non-Hermitian Hamiltonian in a quantum circuit, calculate the field distribution using this circuit, and perform measurements of the spatial spectrum, wave energy,
and power dissipation for this and similar wave problems. We emulate quantum simulations of this circuit on a classical computer and show that the numerical results are in agreement with theory and usual classical simulations. Most of the quantum circuits presented in this paper are constructed and computed using our computational framework. ${ }^{26}$

We also show that the overall quantum simulations of dissipative waves based on the QSVT scale favorably compared to classical simulations in multi-dimensional systems. We expect the gain to be particularly efficient in kinetic plasma problems, where the wave modeling is done in phase space with six or even more dimensions. Still, there are several potential problems for practical applications of the QSVT, which should be pointed out. First of all, the encoding of the considered wave classical system requires at least $4+n_{x}$ qubits and the resulting QSVT circuit involves hundreds of calls to the block-encoding oracle, even without taken into account the measurements. Quantum hardware with such specifications is unlikely to appear in the foreseeable future. Another issue is that typical classical wave systems are characterized by matrices with large condition numbers. Since the QSVT used for the inversion of such matrices returns a state whose amplitude scales as $\mathscr{O}(1 / \kappa)$, the measurement of the state requires $\mathscr{O}(\kappa)$ queries to the QSVT circuit. This can significantly reduce the quantum speedup. Apart from that, to invert a matrix with a large condition number, one needs to precompute classically a significant number of QSVT angles. This is difficult to do using the codes that are currently available for calculating such angles. In our case, the GPU parallelization of the code responsible for the polynomial approximation of the inverse function allowed us to compute the QSVT angles only for $\kappa_{\text {qsvt }} \lesssim 1000$ (Sec. IID). This means that quantum modeling of classical wave systems is limited and, in practice, will likely require efficient preconditioning of the dispersion matrices. (A similar problem is known for classical modeling of large wave systems. ${ }^{54}$ ) For instance, due to the sparsity of the matrices associated with the computation of EM waves (such as those in cold plasmas ${ }^{4}$ ), a quantum version of the sparse approximate inverse preconditioner proposed in Ref. 37 may be useful.

The rotations from Sec. A1 are used in the oracle $O_{H}$ (Figs. 6and7) with the following angles:

For instance, the angles $\theta_{\omega, \varepsilon_{0}}$ are used in the oracle $O_{H, \omega}$ shown in Fig. 7 to compute the elements $i \omega \varepsilon_{0}$ of the matrix (43) at the rows with $k \in\left[2,2 N_{x}-3\right]$. According to Eq. (55),
for these elements, the oracle $O_{S}$ returns the multiplication factor $d_{H}^{-1}$, which is taken into account in Eq. (A6a). The elements $i \omega \varepsilon_{0}$ also appear at $k=1$ and $k=N_{x}-2$ in the matrix (43). However, for these indices, the oracle $O_{S}$ returns $d_{H}^{-3 / 2}$ that is taken into account in the computation of the angle $\theta_{\omega, \varepsilon_{0}, \mathrm{e}}$, where the subindex 'e' stands for 'edge' (boundary). The same principle applies to the calculation of the angles $\theta_{\omega}$ and $\theta_{\omega, \mathrm{e}}$, also $\theta_{ \pm \sigma}$ and $\theta_{ \pm \sigma, \mathrm{e}}$.

## 3. Arithmetic operators

Apart from the incrementor and decrementor used in Fig. 5 and described in Ref. 4, we use also a subtractor $S_{k_{\text {sub }}}$ and a comparator $C_{k_{\text {com }}}$. The former operator (Fig. 17) subtracts the predefined unsigned integer $k_{\text {sub }}$ from the integer(s) encoded in the $n_{t}$ target qubits $t$. Its implementation is based on the circuit described in Ref. 55. In our realization, the most significant (the uppermost) qubit is used to store the sign of the resulting integer, and the absolute value of the output integer is written back to the target qubits.

By removing the $X$ gates from Fig. 17, one obtains the adder $A_{k_{\text {sub }}}$ that adds the integer $k_{\text {sub }}$ to the integer(s) encoded in the register $t$.

The subtractor is used to construct the comparator ${ }^{55} C_{k_{\mathrm{com}}}$ that inverts the 'com' ancilla qubit (Fig. 16) if the predefined unsigned integer $k_{\mathrm{com}}$ is strictly larger than the integer encoded in the target qubits. The comparator leaves the target qubits and the 'sign' qubit (used for the intermediate computations within the comparator) untouched. More details can be found in Ref. 55. (Keep in mind that the least significant qubit in all our circuits is the lowermost one.)

As shown in Ref. 56, the circuit presented in Fig. 17 can be modified to subtract the integer $k_{\text {sub }}$ which is not predefined but encoded as a bit string in another register $r_{\text {sub }}$. For that, the phase gates $P_{k}$ in the subtractor should be controlled by the corresponding qubits of the register $r_{\text {sub }}$. This operator acts then on two registers, $t$ and $r_{\text {sub }}$, and is denoted here as $S_{t-r_{\text {sub }}}$. The resulting difference is written back to the target register $t$.

The circuits for the subtractors and the comparator require $\mathscr{O}\left(n^{2}\right)$ quantum operations.

## Appendix B: QSVT computation of a Gaussian function

## 1. General algorithm

To calculate the absolute value of the absorption power given by (71), one needs to compute the Gaussian function $G$ in the quantum circuit. This function can be approximated by a polynomial by using the Fourier approach, Eq. (17). The circuit for the polynomial is constructed by using the QSVT (Fig. 11). The QSVT finds the polynomial as a function of singular values of some given matrix $M$. If the matrix is diagonal, and the spatial coordinate grid is placed at the diagonal, $M=\operatorname{diag}(x)$, then the QSVT computes the polynomial of the coordinate $x$. After that, $M$ is block-encoded

to the register $t$, and the 'sign' qubit is inverted if the result is negative. Here, $b_{j}^{\text {sub }} P_{k}$ applies the phase gate $P\left(2 \pi / 2^{k}\right)$ (Eq. (A3) if $b_{j}^{\text {sub }}=1$. The inner dashed box is the adder, $k_{\operatorname{targ}}+k_{\text {sub }}$, where the 'sign' qubit stores the carry bit of the sum.
into the unitary matrix $U_{A}$, which is used within the QSVT circuit as shown in Fig. However, since the $x$ grid, $x_{j}$, is a linear function of the index $j$, it is problematic to encode the $x$ points directly into $U_{A}$ by using quantum gates, which are more naturally suited to represent rotations. Instead, one can encode $\psi=\sin (x)$ and consider the Gaussian as a function of $\arcsin (\psi)$ :

$$
\begin{equation*}
G(\psi)=\beta_{\mathrm{sc}} \exp \left(-\frac{\arcsin ^{2}(\psi)}{2 \mu^{2}}\right) \tag{B1}
\end{equation*}
$$

where $\beta_{\mathrm{sc}}$ is a rescaling factor, $\mu$ is the Gaussian width. To block-encode $\psi_{j}=\sin \left(x_{j}\right)$, the circuit shown in Fig. 18 is used. This circuit generates the sine of $x_{j}$ :

$$
\begin{equation*}
x_{j}=\alpha_{0}+j \Delta x, \quad j=\left[0, N_{x}\right), \quad \Delta x=2 \alpha / N_{x} . \tag{B2}
\end{equation*}
$$

Similar to Sec.IVB, we have $N_{x}=2^{n_{x}}$, and the register $r_{x}$ in Fig. 18 has $n_{x}$ qubits. For the given integer $j$ encoded as a bit string in the register $r_{x}$, the circuit returns $\sin \left(x_{j}\right)$ as the amplitude of the zero state of the ancilla $a$. It can be shown using Eq. A1b that the $x$-grid from $-1.0-x_{c}$ to $1.0-x_{c}$ for some real $x_{c}$ is generated by the following parameters:

$$
\begin{equation*}
\alpha_{0}=-1.0-x_{c}, \quad \alpha=N_{x} /\left(N_{x}-1\right) . \tag{B3}
\end{equation*}
$$

The Gaussian generated on this grid is centered at $x_{c}$ (Fig. 19).

The Gaussian (B1) is approximated by a polynomial of definite parity by using the Fourier approach (17), and

the QSVT angles are computed by using the minimization procedure. ${ }^{29}$ (By setting $\beta_{\mathrm{sc}}<1$ in Eq. (B1), one can speed up the calculation of the QSVT angles.) Since the Gaussian is an even function, the resulting QSVT circuit does not include the last three operators indicated by the dashed box in Fig. [1] The QSVT circuit uses the oracle $U_{A}$ shown in Fig. 18 to encode $\psi(x)$. As shown in Fig. 19 the number of the QSVT angles depends logarithmically on $\varepsilon_{\text {qsvt }}$ for small $\mu$, and the dependence becomes polynomial for $\mu \gtrsim 0.25$ (Fig. 19). If the Gaussian peak is narrow $(\mu<0.05)$ or becomes comparable with the length of the spatial domain $x=[-1.0,1.0](\mu>0.25)$, the number of angles grows exponentially with $\mu$ for a fixed $\varepsilon_{\text {qsvt }}$.

## 2. Two Gaussians

To demonstrate this technique, we construct two Gaussians by using the QSVT and integrate them in space by using AE. This is an illustration of the 'parallel' computation in quantum circuits: by applying the QSVT circuit only once, we construct two Gauss functions at the same time. The corresponding circuit is shown in Fig. 20, where the $x$ grid is prepared by creating a uniform superposition of states in the register $r_{x}$ and using the parameters from Eqs. (B3). The QSVT circuit is applied only to the first $n_{x}-1$ qubits of the register $r_{x}$. Since the last qubit (the most significant one) is in the superposition $(|0\rangle+|1\rangle) / \sqrt{2}$, the QSVT entangles one Gaussian with the zero state of this qubit and another Gaussian with the unit state:

\begin{align*}
\left|\psi_{G}\right\rangle= & 2^{-n_{x} / 2}\left(|0\rangle_{r_{x}, n_{x}-1}|G(x)\rangle_{r_{x},\left[0, n_{x}-2\right]}\right. \\
& \left.+|1\rangle_{r_{x}, n_{x}-1}|G(x)\rangle_{r_{x},\left[0, n_{x}-2\right]}\right) \tag{B4}
\end{align*}
$$

where the state $\left|\psi_{G}\right\rangle$ is indicated in Fig. 20 The most significant qubit in $r_{x}$ encodes the left spatial domain, $x<0$, if the qubit is in the zero state, and the right spatial domain, $x>0$, if the qubit is in the unit state. Therefore, the superposition (B4) corresponds to one Gaussian in the domain $x=[-1.0,0.0)$ and another Gaussian in $x=(0.0,1.0]$

as shown in Fig. 21 Apart from that, if the original Gaussian is defined according to Eq. (B1), then the resulting Gaussians have widths $\mu / 2$. Also, due to the initialization circuit (green box in Fig. 20), the Gaussians are multiplied by the factor $\beta_{\text {init }}=2^{-n_{x} / 2}$.

The circuit shown in Fig. 20 integrates the Gaussians in the second and third quarters of the spatial domain:

S_{G}=p_{m, 1} / N_{x} \tag{B5a}

p_{m, 1}=\beta_{\text {init }}^{2} \sum_{x=(-0.5,0.5)}|G(x)|^{2} . \tag{B5b}
\end{equation*}

The quantum state encoding the desired spatial interval is entangled with $|1\rangle_{m}$, and then $p_{m, 1}$ is computed by using the AE. As explained in Sec. VIC, the AE consists of several queries to the AA operator. In our case, the latter is defined as

$$
\begin{equation*}
\mathrm{AA}=U_{\text {prep }} \mathrm{REF}_{0} U_{\text {prep }}^{\dagger} \mathrm{REF}_{G} \tag{B6}
\end{equation*}
$$

where $U_{\text {prep }}$ is marked in Fig. 20 with the black dashed box, $\mathrm{REF}_{0}$ is the reflector around the initial (in our case, zero) state, $\mathrm{REF}_{G}$ is the reflector around the state of interest produced by $U_{\text {prep }}$. Here, the state of interest is $|1\rangle_{m}$, thus, $\mathrm{REF}_{G}$ is represented by a single Pauli $Z$ gate at the qubit $m$. The reflector $\mathrm{REF}_{0}$ is constructed as the sequence $X Z X$ at the qubit $m$ controlled by the zero states of the registers $r_{x}, a, q$ and 'sum'.

The whole circuit shown in Fig. 20 is computed on an emulator of quantum computers. ${ }^{26}$ The AE of $S_{G}$ is shown in Fig. 21 and compared with the value computed classically.

## 3. Gaussian as a filter

The Gaussian constructed by the QSVT can be used as a filter in real or Fourier space. In particular, to calculate the product of the EM fields $F(x)$ with the Gaussian, $G(x) F(x)$, one can use the circuit shown in Fig. 22] Here, the main question is whether it is possible to use the same ancillae in the QSVT for the computation of $F(x)$ (the 'MI' subcircuit) and in the QSVT for the Gaussian calculation (the 'Gauss' subcircuit). The computation shows that one does not need to control the 'Gauss' by the zero states of the ancillae used in the 'MI' (i.e., ancilla registers $q, a_{v}, a_{j}$ ), and the same ancilla $a_{d}$ can be used in both QSVT subcircuits. However, for the Gaussian QSVT, it is necessary to introduce another ancilla $q_{G}$ equivalent to the ancilla $q$ in the 'MI'.

Since the 'Gauss' is not controlled by the qubit $r_{d}$, which is responsible for the choice between the electric and magnetic fields, the circuit constructs the product $G(x) F(x)$ for both fields in parallel. The circuit shown in Fig. 22 outputs the spatial distribution $G(x) E(x)$ (entangled with $|0\rangle_{r_{d}}$ ) and $G(x) B(x)$ (entangled with $|1\rangle_{r_{d}}$ ) if all ancillae are in the zero state. The signals $G(x) F(x)$ obtained from the emulation of this circuit are shown in Fig. 23 and compared with classical simulations.
