# The Exact Susceptibility of the Spin-S Transverse Ising Chain with Next-nearest-neighbor Interactions.

The zero-field susceptibility of the spin-S transverse Ising chain with next-nearest-neighbor interactions is obtained exactly. The susceptibility is given in an explicit form for $S=1 / 2$, and expressed in terms of the eigenvectors of the transfer matrix for general spin $S$. It is found that the low-temperature limit is independent of spin $S$, and is divergent at the transition point.

## 1. Introduction

The transverse Ising model is a simple and basic spin model with non-trivial quantum effects. Specifically the spin $1 / 2$ transverse Ising chain has been investigated by many authors. Fisher ${ }^{12)}$ derived the exact zero-field transverse susceptibility, Katsura ${ }^{3)}$ obtained the free energy, and Pfeuty ${ }^{4}$ also obtained the free energy through the Jordan-Wigner transformation. The one-dimensional spin $1 / 2$ transverse Ising model is known to be equivalent to the twodimensional rectangular Ising model. ${ }^{5)}$ The Jordan-Wigner transformation was generalized, ${ }^{6}$ and an infinite number of systems which can be regarded as kind of generalizations of the transverse Ising chain were solved exactly. ${ }^{677) 8)}$ Applications of the Jordan-Wigner transformation to higher dimensions have also been considered by many authors. ${ }^{9) 10) 11) 12(13) 14)}$

The Ising chain with general spin $S$ have also been investigated. ${ }^{15) 16) 17)}$ The zero-field susceptibility of spin $S$ transverse Ising chain was exactly derived. ${ }^{18) 19) 20)}$ The transverse susceptibility and the specific heat were shown up to $S=60$ and the crossover from the $S=$ $1 / 2$ case to the classical case was exactly observed in Ref.21. The transverse susceptibility with a non-zero longitudinal external field, and that of Ising models with alternate or random structures were also obtained. ${ }^{21) 22)}$ The continuous spin chain which can be regarded as the infinite spin limit of the Ising chain was also investigated. ${ }^{23 / 24) 25)}$

The Ising chain with next-nearest-neighbor interactions have also been investigated by many authors. The free energy and correlation functions were, with the use of a dual transformation, derived by Stephenson ${ }^{26)}$ and Hornreich et al. ${ }^{27)}$ The zero-field transverse susceptibil-
ity for the spin $1 / 2$ case was calculated by Harada. ${ }^{28)}$ Oguchi introduced ${ }^{29)}$ a transfer matrix for the Ising chain with nearest- and next-nearest-neighbor interactions, and the free energy was re-derived by Kassan-Ogly. ${ }^{30)}$

In this paper, the exact zero-field susceptibility of the transverse Ising chain with the next-nearest-neighbor interactions is derived for general spin $S$. In section 2.1, the transverse susceptibility is expressed as an infinite sum of correlation functions. In section 2.2, the transfer matrix $V$ is introduced for the Ising chain with the next-nearest-neighbor interactions. The transfer matrix for the $S=1 / 2$ case is explicitly considered in detail as an example. In section 2.3, the susceptibility is expressed as a finite sum using the eigenvectors of $V$ for general spin $S$, and written down explicitly specifically for $S=1 / 2$. In section 3 , the low-temperature limit is considered, and it is derived that the $T \rightarrow 0$ limit is independent of $S$, and is divergent at the point where the ground state shows phase transition.

## 2. Formulation

### 2.1 Model and Formulation

Let us consider the Hamiltonian

where

and the periodic boundary condition is assumed. Here $\mathcal{H}_{\text {Is }}=\mathcal{H}_{0}+\mathcal{H}_{1}$ is the Ising interactions, and $Q$ is the transverse term which does not commute with $\mathcal{H}_{\text {Is }}$.

The transverse susceptibility $\chi$ at zero-field is defined as

The expectation $\left\rangle\right.$ is taken by $\mathcal{H}$, and $\beta=1 / k_{\mathrm{B}} T$ where $k_{\mathrm{B}}$ is the Boltzmann constant and $T$ is the temperature. For the purpose to calculate (3), let us introduce the formula

which can be derived by multiplying $\exp (\beta \mathcal{H})$ from the left-hand side and differentiating in
terms of $\beta$. Using (4), $\langle Q\rangle$ can be expanded in terms of $H$, and we obtain

where $\left\rangle_{0}\right.$ is the expectation taken at zero external field $H=0$.
Next let us introduce inner derivatives $\delta_{0}$ and $\delta_{1}$ through the relations

and introduce $\delta=\delta_{0}+\delta_{1}$. The expectation in (5) can be expanded using

and (5) is expressed as

It can be seen that (8) is equal to

This formula was already derived in Ref.20. What we have to do next is to evaluate the correlation functions $\left\langle\delta^{p} Q Q\right\rangle_{0}$ with non-zero next-nearest-neighbor interaction, and to perform the infinite sum in (9).

Then let us consider $\left\langle\delta^{p} Q Q\right\rangle_{0}$. Because of the commutatibity $\mathcal{H}_{1} \mathcal{H}_{0}=\mathcal{H}_{0} \mathcal{H}_{1}$, we generally find $\delta_{1} \delta_{0}=\delta_{0} \delta_{1}$, and then $\delta^{p} Q$ is written as

It is straightforward to show inductively that

and $k(p)=x$ for even $p$, and $k(p)=y$ for odd $p$. Then from (10) and (12), we find

& \times \sum_{l_{0}=0}^{p_{0}}\binom{p_{0}}{l_{0}} \sum_{l_{1}=0}^{p_{1}}\binom{p_{1}}{l_{1}}\left\langle\left(s_{j-2}^{z}\right)^{p_{1}-l_{1}}\left(s_{j-1}^{z}\right)^{p_{0}-l_{0}}\left(\tau_{p} s_{j}^{k(p)} s_{j}^{x}\right)\left(s_{j+1}^{z}\right)^{l_{0}}\left(s_{j+2}^{z}\right)^{l_{1}}\right\rangle_{0}, \tag{14}

where $p_{0}=p-l, p_{1}=l$ and thus $p_{0}+p_{1}=p$. Here we used the fact that eigenstates of $\mathcal{H}_{\mathrm{Is}}$ are direct products of eigenstates of each $s_{j}^{z}$, and hence $\left\langle\left(s_{j-2}^{z}\right)^{p_{1}-l_{1}}\left(s_{j-1}^{z}\right)^{p_{0}-l_{0}} \tau_{p} s_{j}^{k(p)}\left(s_{j+1}^{z}\right)^{l_{0}}\left(s_{j+2}^{z}\right)^{l_{1}}\right.$. $\left.s_{j^{\prime}}^{x}\right\rangle_{0}=0$ when $j^{\prime} \neq j$. The correlation function in (14) can be obtained through the transfer matrix method.

### 2.2 Transfer Matrix

The transfer matrix is defined as the matrix composed of the Boltzmann factors between two sites as its elements:

Here we consider the state $\left|s_{j}\right\rangle_{j}$ at site $j$ with the eigenvalue $s_{j}\left(s_{j}=S, S-1, \ldots,-S\right)$ : $s_{j}^{z}\left|s_{j}\right\rangle_{j}=s_{j}\left|s_{j}\right\rangle_{j}$, and $\left|s_{j}\right\rangle_{j}$ is written $\left|s_{j}\right\rangle$ for abbreviation. If one operates $V$ from the left-hand
side, then one additional bond is introduced to the chain; for example $V\left|s_{j}=s\right\rangle$ provides all the $(j+1)$-th states $\left|s_{j+1}\right\rangle$ multiplied by the Boltzmann factor obtained under the condition that the site $j$ has fixed eigenvalue $s_{j}=s$. In our case, we consider the configurations of adjacent two sites to introduce the next-nearest-neighbor interactions. The transfer matrix, in our notation, is defined as

where $K_{0}=\beta J_{0}, K_{1}=\beta J_{1}$, and $s_{j-1}, s_{j}, s_{j}^{\prime}, s_{j+1}^{\prime}=S, S-1, \ldots,-S$.
For example in the case of $S=1 / 2$, we find

where $x=e^{\frac{1}{4} K_{0}}$ and $y=e^{\frac{1}{4} K_{1}}$. The configurations $\left\{\left|s_{j-1}\right\rangle\left|s_{j}\right\rangle\right\}$ and $\left\{\left|s_{j}^{\prime}\right\rangle\left|s_{j+1}^{\prime}\right\rangle\right\}$ are both arranged by binary rules as $\left|\frac{1}{2}\right\rangle\left|\frac{1}{2}\right\rangle,\left|\frac{1}{2}\right\rangle\left|\frac{-1}{2}\right\rangle,\left|\frac{-1}{2}\right\rangle\left|\frac{1}{2}\right\rangle,\left|\frac{-1}{2}\right\rangle\left|\frac{-1}{2}\right\rangle$, in which each configuration corresponds to the $\rho=1,2,3,4$-th element of the matrix, respectively. When one operate the transfer matrix from the left-hand side, then the Boltzmann weights coming from an additional site are introduced. Configurations with the inconsistency $s_{j} \neq s_{j}^{\prime}$ are eliminated multiplying 0 element. Then we find the matrix elements $V_{\rho \rho^{\prime}}$ for example $(V)_{11}=\left\langle\frac{1}{2}\right|\left\langle\frac{1}{2}\right| V\left|\frac{1}{2}\right\rangle\left|\frac{1}{2}\right\rangle=x y$, $(V)_{21}=\left\langle\frac{1}{2}\right|\left\langle\frac{-1}{2}\right| V\left|\frac{1}{2}\right\rangle\left|\frac{1}{2}\right\rangle=x / y$, and $(V)_{12}=\left\langle\frac{1}{2}\right|\left\langle\frac{1}{2}\right| V\left|\frac{1}{2}\right\rangle\left|\frac{-1}{2}\right\rangle=0$. The eigenequation is

The eigenvalues are obtained as

When $J_{1}=0$, then $y=1$, and we find $\lambda_{1}^{+}=x+\frac{1}{x}, \lambda_{1}^{-}=0, \lambda_{2}^{+}=x-\frac{1}{x}$, and $\lambda_{2}^{-}=0$. When $J_{0}=0$, then $x=1$, and we find $\lambda_{1}^{+}=y+\frac{1}{y}, \lambda_{1}^{-}=y-\frac{1}{y}$, and $\lambda_{2}^{ \pm}= \pm \sqrt{y^{2}-\frac{1}{y^{2}}}$. The eigenvector corresponding to $\lambda_{1}^{+}$is obtained as

The elements of $V$ are all non-negative, and $V$ is irreducible. Hence from the PerronFrobenius theorem, the maximum eigenvalue of $V$ is unique. Together with the fact that $\lambda_{1}^{+}$is the maximum eigenvalue for $J_{1}=0$ and for $J_{0}=0, \lambda_{1}^{+}$is also the maximum for all $J_{0}$ and $J_{1}$. Let $U$ be a matrix whose column vectors are the eigenvectors of $V$, the first column being the eigenvector $\mathbf{u}_{1}$. Then the first row vector $\overline{\mathbf{u}}_{1}$ of the matrix $U^{-1}$ is obtained as

It is easy to confirm that $\overline{\mathbf{u}}_{1} \cdot \mathbf{u}_{1}=1$.

### 2.3 The Transverse Susceptibility

Let us then consider the expectation value in (14) for general spin $S$. The quantum expectation of this type can be calculated using the transfer matrix method. ${ }^{20)}$ Let $\left\{\left|s_{1}, \ldots, s_{N}\right\rangle\right\}$ be a complete set of the eigenstates of $\mathcal{H}_{\text {Is }}$, in which each $\left|s_{1}, \ldots, s_{N}\right\rangle=\left|s_{1}\right\rangle\left|s_{2}\right\rangle \cdots\left|s_{N}\right\rangle$ is a direct product of eigenstates of $s_{j}^{z}(j=1, \ldots, N)$. Then, the expectation value $\left\langle s_{j}^{k} s_{j}^{x}\right\rangle_{0}$, for example, can be calculated using the transfer matrix $V$ as

where $D_{j}^{(p)}$ is an operator defined by

and represented by a diagonal matrix $D^{(p)}$ with the elements

and $\rho$ is the index which corresponds to the spin configuration $\left(s_{j}^{\prime}, s_{j+1}^{\prime}\right)$ of the adjacent two sites $j$ and $j+1$ (see for example below (19)), and $l$ is defined by $s_{j}^{\prime}=S-l+1$, i.e. $\rho$ denotes a configuration $\left(s_{j}^{\prime}, s_{j+1}^{\prime}\right)$, and $l$ is determined from $s_{j}^{\prime}$. In the case of $S=1 / 2$, for example, $D^{(p)}$ is a diagonal matrix $D^{(p)}=\operatorname{diag}(1 / 4,1 / 4,1 / 4,1 / 4)$ when $p$ is even, and $i D^{(p)}=$ $\operatorname{diag}(1 / 4,1 / 4,-1 / 4,-1 / 4)$ when $p$ is odd. Let us introduce a parameter $m_{\rho}=s_{j}^{\prime}=S-l+1$ which is the eigenvalue satisfying $s_{j}^{z}\left|s_{j}^{\prime}\right\rangle=m_{\rho}\left|s_{j}^{\prime}\right\rangle$. The parameter $m_{\rho}$ will be used below.

Similarly the correlation function in (14) for general spin $S$ is then expressed, using the transfer matrix (17) and the operator

Matrix $U^{-1} V U=\Lambda$ is a diagonal matrix whose diagonal elements are the eigenvalues of $V$. Here let us consider the thermodynamic limit $N \rightarrow \infty$, then we find $\left(\lambda_{\rho} / \lambda_{1}\right)^{N-4} \rightarrow 0$ for $\rho \neq 1$,

When the transfer matrix $V$ cannot be diagonalized, which occur for example when $y^{2}(x+1 / x) / 2=1$ with $x \neq 1$ in the case of spin $1 / 2$, we can consider the Jordan normal form, and obtain an identical result. The susceptibility in the thermodynamic limit is obtained, from (9), (14) and (31), as

Equation (35) provides the exact zero-field transverse susceptibility of the spin-S transverse Ising model (1). The result is written in terms of finite summations.

The first term in (36) corresponds to the case $m_{\mu}+m_{\nu}=0$ and $m_{\iota}+m_{\kappa}=0$ which yields $J(\iota, \mu, \nu, \kappa)=0$ for all $J_{0}$ and $J_{1}$. Other $m_{\rho}$ 's sometimes yield $J(\iota, \mu, v, \kappa)=0$ when $J_{0}$ and $J_{1}$ take some special values (for example, $J_{1}=-J_{0}, m_{\mu}+m_{v}=2 S, m_{\iota}+m_{\kappa}=2 S$ result in $J(\iota, \mu, \nu, \kappa)=0$ ). Contributions from these latter cases, if exist, can be obtained by taking limit $J(\iota, \mu, \nu, \kappa) \rightarrow 0$ in the remaining four terms (thus the susceptibility for $J_{1}=-J_{0}$, for example, is simply obtained by taking limit $J_{1} \rightarrow-J_{0}$ in (36)).

When $J_{1}=0$ or $J_{0}=0$, the system reduces to the nearest-neighbor transverse Ising chain. For example in (36), let $J_{1} \rightarrow 0$ then $y \rightarrow 1$ and we obtain

which is the transverse susceptibility of the nearest-neighbor Ising chain. ${ }^{112)}$ When $J_{0} \rightarrow 0$ then $x \rightarrow 1$ and we again obtain (38) in which $x$ is replaced by $y$, and $J_{0}$ is replaced by $J_{1}$.

The susceptibility is invariant under the change of sign $J_{0} \mapsto-J_{0}$. For example (36) and (37) is invariant under $x \mapsto 1 / x$. This invariance comes from the symmetry of the system under transformations $J_{0} \mapsto-J_{0}$ and $\left(\sigma_{j}^{x}, \sigma_{j}^{y}, \sigma_{j}^{z}\right) \mapsto\left(\sigma_{j}^{x},-\sigma_{j}^{y},-\sigma_{j}^{z}\right)$ for odd $j$.

The transverse susceptibility of the spin $S$ Ising chain is shown in Fig.1-Fig. 3 for various values of the nearest-neighbor interaction $J_{0}$ and the next-nearest-neighbor interaction $J_{1}$. The susceptibility is calculated using the analytic result (36) for $S=1 / 2$, and calculated from numerically obtained $\bar{u}_{1 ،}$ and $u_{\kappa 1}$ for $S \geq 1$.

## 3. Low-temperature Limit

Next we physically consider the low-temperature behavior of the susceptibility. Let us follow the ground-state property of the system. Because (35) is a finite sum, the leading terms in (35) dominate the susceptibility at $T \rightarrow 0$. The phase diagram was investigated in Refs.31-33, and we know the ground state configurations in each phase. Let us consider the case $J_{0}>0$, because the susceptibility is invariant under the change $J_{0} \mapsto-J_{0}$ and the result for $J_{0}<0$ and $J_{1}$ is identical with that for $\left|J_{0}\right|$ and $J_{1}$.

When $J_{1}>-J_{0} / 2$, the ground state is ferromagnetic: $s_{j}=S$ for all $j$, or $s_{j}=-S$ for all $j$. The leading terms in (32) are

all the $\bar{u}_{1 \iota} u_{\kappa 1}$ are finite when $\iota=\kappa$. The leading terms in (35) are found in $(1,1)$ and $(n, n)$ elements of $V^{2} \tau_{p} D^{(p)} V^{2}$, with the condition $m_{\iota}+m_{\kappa}=m_{\mu}+m_{v}=2 S$ and $m_{\iota}+m_{\kappa}=m_{\mu}+m_{v}=$ $-2 S$, respectively. They come from the ground-state configurations together with the first excitations:

Note that the nearest-neighbor interactions cancel with each other and $J_{0}$ does not appear in the ground state configurations.

When $J_{1}=-J_{0} / 2$, configurations obtained by arbitrary iterations of $|S\rangle|S\rangle$ and $|-S\rangle \mid-$ $S\rangle$ belong to the ground state, e.g. configurations $|S\rangle|S\rangle|S\rangle|S\rangle|S\rangle|S\rangle \cdots$, and $|S\rangle|S\rangle|-S\rangle \mid-$ $S\rangle|S\rangle|S\rangle \cdots$, and $|S\rangle|S\rangle|S\rangle|S\rangle|-S\rangle|-S\rangle \cdots$ provide the ground state energy. The ground state is therefore highly degenerate, and for example the configurations

$$
\begin{equation*}
|S\rangle_{j-2}|S\rangle_{j-1}|-S\rangle_{j}|-S\rangle_{j+1}|-S\rangle_{j+2}|-S\rangle_{j+3}, \quad|S\rangle_{j-2}|S\rangle_{j-1}|S\rangle_{j}|-S\rangle_{j+1}|-S\rangle_{j+2}|-S\rangle_{j+3}, \tag{46}
\end{equation*}
$$

generate some of the leading terms. They satisfy $m_{\iota}+m_{\kappa}=0$ and $m_{\mu}+m_{\nu}=0$, and hence the first term in (35) remains even when $T \rightarrow 0$, and we find the divergence coming from $\beta$ at low temperatures.
