# HOMOGENIZATION OF ACTIVE SUSPENSIONS AND REDUCTION OF EFFECTIVE VISCOSITY

#### Abstract

We consider a suspension of active rigid particles (swimmers) in a steady Stokes flow, where particles are distributed according to a stationary ergodic random process, and we study its homogenization in the macroscopic limit. A key point in the model is that swimmers are allowed to adapt their propulsion to the surrounding fluid deformation: swimming forces are not prescribed a priori, but are rather obtained through the retroaction of the fluid. Qualitative homogenization of this nonlinear model requires an unusual proof that crucially relies on a semi-quantitative two-scale analysis. After introducing new correctors that accurately capture spatial oscillations created by swimming forces, we identify the contribution of the activity to the effective viscosity. In agreement with the physics literature, an analysis in the dilute regime shows that the activity of the particles can either increase or decrease the effective viscosity (depending on the swimming mechanism), which differs from the well-known case of passive suspensions.

## 1. Introduction and main results

1.1. General overview. This work is devoted to the large-scale rheology of suspensions of active particles in viscous fluids, where active particles are devices that can propel themselves in the fluid (in a direction that can adapt to the surrounding fluid flow itself). Important examples include suspensions of bacteria [49], micro-algae [50], nanomotors [39], etc. Compared to passive systems, active suspensions exhibit a particularly rich phenomenology, with the experimental observation of pattern formations [2] and unsteady whirls and jets [37]. Due to this complexity, the response to an external forcing can defy intuition, with rheological measurements displaying in some settings a transition to a superfluid-like behavior [35]. We refer to [25, 48, 42, 41] for more physical context. In the present contribution, our main purpose is to establish rigorously, starting from a simple (yet realistic) microscopic fluid-particle model, that the presence of active particles in a fluid can indeed drastically reduce its effective viscosity.

Microscopic fluid-particle models are challenging to analyze as they involve collective fluid-structure interactions. More precisely, the fluid should be described by the NavierStokes equations outside the particles, while the latter are assumed to be rigid and thus described by their translational and angular velocities. As a first approximation, we naturally assume no-slip boundary conditions at the boundary of the particles, so that the velocity of the fluid coincides with that of the particles at their boundaries. The fluid flow thus depends on the whole set of particles via boundary conditions, and the propulsion mechanism of active particles further yields forces on the surrounding fluid. Reciprocally, both the fluid and the propulsion mechanism exert forces on the particles, the dynamics of which is given by the corresponding Newton equations. Due to the multibody and longrange nature of particle interactions via the fluid flow, this fluid-particle system is highly difficult to understand - let alone analyze rigorously - in the macroscopic limit with a large number of particles.

On large scales, fluid-particle systems are expected to be approximated by multiscale models: On the one hand, the fluid flow would satisfy a macroscopic fluid equation including an additional effective stress due to the presence of the particles and their selfpropulsion. On the other hand, this effective stress would depend on the local geometry of the set of particles on small scales, so the macroscopic fluid equation would be coupled to a microscopic evolution equation for the latter. This amounts to a scale separation in the description of the system: the macroscopic fluid equation is coupled to the local microstructure dynamics. We emphasize the nonlinear structure of such models: the fluid flow depends on the local microstructure, the evolution of which depends itself on the fluid flow. The resulting flow-induced microstructure leads to possibly nonlinear response to external forces, thus explaining the well-known non-Newtonian behavior of particle suspensions.

As models for the microstructure dynamics are difficult to formulate concretely, a first simplification popular in physics and in applied mathematics consists in considering the dilute regime. In that case, particles interact little and can be viewed as approximately isolated, which allows to reduce the multibody nature of the system. In the spirit of Einstein's formula, the effective stress in the macroscopic fluid equations then takes an explicit form that only depends on the local mean-field distribution of particle orientations, and the macroscopic fluid equation is simply coupled to a kinetic equation for the latter. We refer for instance to $[3,47,45]$ for a review of multiscale models in this vein. The mathematical justification from dilute fluid-particle systems has attracted considerable
interest in recent years and has been completed in a few settings [30, 27, 28, 5, 29]. In particular, the recent work [5] by the second author addresses the full particle dynamics in the (semi)dilute regime and derives rigorously some multiscale Doi-type model in the spirit of $[3,45,47]$. In the same spirit, let us also mention the FENE model for suspensions of free polymer chains in a fluid flow [38, 1, 34, 33]: this model further takes into account the extensibility of the polymers and has been analyzed in $[32,36]$, but its mathematical justification from a microscopic fluid-particle system is still an open problem. Yet, despite their success, those dilute multiscale models neglect the spatial correlations of the particles on the microscale, which become important for less dilute suspensions, cf. [28, 5].

In the present work, we take another route and consider a non-dilute regime that is beyond the reach of mean-field approaches. To simplify the analysis, we neglect the inertia of the fluid, thus considering the steady Stokes equations instead of Navier-Stokes (vanishing Reynolds number), and we further neglect the inertia of the particles. What remains is the following: given instantaneous positions and orientations of the particles (at microscale $\varepsilon \ll 1$ ), the fluid flow $u_{\varepsilon}$ is given by solving the steady Stokes equations outside the particles, while their positions and orientations are updated as above. Note that this simplified fluid-particle system keeps its fundamental difficulty, namely the multibody and long-range nature of particle interactions via the fluid flow. Rather than studying the full dynamics of this system, which seems out of reach beyond dilute regimes, we further assume that a scale separation holds in the following sense: the large-scale behavior of the fluid is described by an effective flow $(t, x) \mapsto \bar{u}(t, x)$, while the positions and orientations of the particles at time $t$ around a point $x$ are locally given by a realization of some stationary ergodic decorated point process depending on the previous history of the effective flow $\{\bar{u}(s, \cdot)\}_{s \leq t}$ around $x$. As non-Newtonian effects are mainly due to the collective orientation of the particles [3, 47, 45], we focus on the latter and we further neglect memory effects for simplicity, thus rather assuming the following: the positions of the particles at time $t$ around a point $x$ are locally given by a realization of some stationary ergodic point process $\mathcal{P}$ (independent of $t, x$ ), and their orientations are given by some probability distribution depending on the surrounding effective flow $\left.\bar{u}(t, \cdot)\right|_{B_{\delta}(x)}$ - say in some neighborhood of mesoscopic size $\delta>0$. This dependence is assumed to be given as a data, having in mind that it should be related to invariant measures of the particle dynamics under the surrounding effective flow. We are then left with the following fluid-structure interaction problem: at a given time $t$, the microscopic fluid flow $u_{\varepsilon}$ is described by the steady Stokes equations outside a random ensemble of particles with positions given by $\mathcal{P}$ and with orientations depending on the surrounding effective flow $\left.\bar{u}(t, \cdot)\right|_{B_{\delta}(x)}$. As the latter is a large-scale approximation of the microscopic solution $u_{\varepsilon}$ itself, we choose to explicitly close the problem by replacing $\bar{u}(t, x)$ with $\chi_{\delta} * u_{\varepsilon}(t, x)$ for some convolution kernel $\chi_{\delta}$ supported in $B_{\delta}$. Note that this dependence of particle orientations on the fluid flow makes the problem explicitly nonlinear. We refer to (1.10) below for a precise formulation.

The aim of the present contribution is to analyze this original nonlinear steady-state model in the macroscopic limit of a large number of small particles with fixed density. We prove a homogenization result in form of the convergence of the microscopic fluid flow to some effective flow $\bar{u}$, which is compatible with the closure assumption in the sense that $\lim _{\delta \downarrow 0} \lim _{\varepsilon \downarrow 0} \chi_{\delta} * u_{\varepsilon}=\bar{u}$, and we identify the effective fluid equation in terms of some nonlinear effective viscosity. This result can be seen as a building block for a multiscale modelling of the fluid-particle dynamics beyond the dilute regime, which should ultimately be combined with the study of the very challenging question of the nondilute
microstructure dynamics (that we do not address in this contribution). As a corollary, we justify the drastic reduction of the effective viscosity for so-called pusher particles. In addition, as a sanity check for the model, we justify in the dilute regime an Einstein-type approximation for our nonlinear effective viscosity, see formula (1.35) below for the active contribution, which coincides with the standard expression for the active elastic stress in dilute multiscale models $[23,24,43,41,45,47,5]$. In a similar spirit, let us also mention that Girodroux-Lavigne recently analyzed in [20] a steady Stokes model with a dilute suspension of active particles with orientations and swimming forces that are completely prescribed in advance (independently of the fluid flow): this constitutes a linear version of the model analyzed here.

The sequel of this introduction is organized as follows: In Section 1.2, we recall the steady-state model for a steady Stokes fluid with a suspension of passive rigid particles, and we state the associated homogenization result previously obtained by the last two authors in that setting $[4,12,8,9]$. In Section 1.3, we introduce our new nonlinear steady-state model for active suspensions in a steady Stokes flow, as inspired in particular by [45, 47]. In Section 1.4, we relate this model to the physics literature. Section 1.5 is dedicated to the main results of this paper: the rigorous homogenization of the nonlinear model, and the analysis of the effective rheology in the dilute regime. Last, in Section 1.6, based on these results, we investigate the contribution of active particles to the effective viscosity, and rigorously establish that a significant reduction can take place in the case of so-called pusher particles.
1.2. Reminder on passive suspensions. Given an underlying probability space $(\Omega, \mathbb{P})$ (with expectation $\mathbb{E}[\cdot]$ ), let $\left\{x_{n}\right\}_{n}$ be a random point process on the ambient space $\mathbb{R}^{d}$, consider an associated collection of random shapes $\left\{I_{n}^{\circ}\right\}_{n}$, where each $I_{n}^{\circ}$ is a connected random open subset of the unit ball $B$ centered at the origin (in the sense that $\int_{I_{n}^{\circ}} y d y=0$ ), and then define the corresponding inclusions

I_{n}:=x_{n}+I_{n}^{\circ} .

Note that random shapes are not required to be independent of the point process $\left\{x_{n}\right\}_{n}$. We then consider the random set

\mathcal{I}:=\bigcup_{n} I_{n},
$$

which we assume to satisfy the following for some $\vartheta>0$.
Hypothesis 1.1 (Particle suspension).
(a) Stationarity and ergodicity: The random set $\mathcal{I}$ is stationary and ergodic.
(b) Uniform $C^{2}$ regularity: The random shapes $\left\{I_{n}^{\circ}\right\}_{n}$ satisfy interior and exterior ball conditions with radius $\vartheta$ almost surely.
(c) Uniform hardcore condition: For some $\ell \geq \vartheta$, there holds $\left(I_{n}+\ell B\right) \cap\left(I_{m}+\ell B\right)=\varnothing$ almost surely for all $n \neq m$. We let $\ell$ be the largest such value, that is, half the interparticle distance

Now consider a tank, described as a bounded Lipschitz domain $U \subset \mathbb{R}^{d}$, and assume that it is filled with a steady Stokes fluid with a suspension of particles of size $\varepsilon$, described as the $\varepsilon$-rescaling of $\mathcal{I}$. More precisely, we only consider particles that are included in $U$
and remove those close to the boundary: define $\mathcal{N}_{\varepsilon}(U)$ as the set of indices $n$ such that $\varepsilon\left(I_{n}+\ell B\right) \subset U$, and set

We write $u_{\varepsilon}$ for the fluid velocity, $P_{\varepsilon}$ for the corresponding pressure. We assume Dirichlet conditions $u_{\varepsilon}=0$ on $\partial U$, and we extend the fluid velocity inside particles with the rigidity constraint

Recall the definition of the Cauchy stress tensor

where Id denotes the identity matrix. Given an internal force $h$, the fluid velocity $u_{\varepsilon} \in$ $H_{0}^{1}(U)^{d}$ and the associated pressure $P_{\varepsilon} \in \mathrm{L}^{2}\left(U \backslash \mathcal{I}_{\varepsilon}(U)\right)$ are then given as the solutions of the Stokes system

$$

where $\nu$ stands for the outward normal to $\partial I_{n}$, where $\mathbb{M}^{\text {skew }}$ is the set of skew-symmetric matrices, and where we assume the additional anchoring condition

$$
\int_{U \backslash I_{\varepsilon}(U)} P_{\varepsilon}=0,
$$

which we shall abbreviate as choosing $P_{\varepsilon} \in \mathrm{L}^{2}\left(U \backslash \mathcal{I}_{\varepsilon}(U)\right) / \mathbb{R}$. The homogenization of the Stokes system (1.2) was the object of $[4,12,8]$, where the last two authors proved that $\left(u_{\varepsilon}, P_{\varepsilon} \mathbb{1}_{U \backslash \mathcal{I}_{\varepsilon}(U)}\right)$ converges almost surely weakly in $H_{0}^{1}(U) \times \mathrm{L}^{2}(U) / \mathbb{R}$ to the unique solution $(\bar{u}, \bar{P})$ of the homogenized Stokes system

where $\lambda$ stands for the particle volume fraction

$$
\begin{equation*}
\lambda:=\mathbb{E}\left[\mathbb{1}_{\mathcal{I}}\right], \tag{1.4}
\end{equation*}

and where the effective viscosity $\overline{\boldsymbol{B}}_{\text {pas }}$ is a symmetric linear map on the set $\mathbb{M}_{0}^{\text {sym }}$ of symmetric trace-free matrices. We recall that the latter satisfies $E: \overline{\boldsymbol{B}}_{\text {pas }} E>|E|^{2}$ for all $E \in \mathbb{M}_{0}^{\text {sym }}$ as soon as $\lambda>0$, meaning that the presence of (passive) rigid particles always increases the effective viscosity. We refer to [9] for a review of the topic.

In view of the quantitative homogenization results that we shall need later, we occasionally make quantitative ergodicity assumptions in form of the validity of the following multiscale variance inequality introduced by the last two authors in [6, 7]. This assumption holds for instance for hardcore Poisson point process with exponentially decaying $\pi$.

Hypothesis 1.2 (Quantitative mixing assumption). There exists a non-increasing weight function $\pi: \mathbb{R}^{+} \rightarrow \mathbb{R}^{+}$with superalgebraic decay (that is, $\pi(t) \leq C_{p}\langle t\rangle^{-p}$ for all $p<\infty$ ) such that the random set $\mathcal{I}$ satisfies, for all $\sigma(\mathcal{I})$-measurable random variables $Y(\mathcal{I})$,

where the "oscillation" $\partial^{\text {osc }}$ of the random variable $Y(\mathcal{I})$ is defined by

1.3. Hydrodynamic model for active suspensions. As opposed to passive particles, active particles propel themselves by applying a force on the surrounding fluid. In a steadystate perspective, we assume that we are given a random ensemble of particle positions and swimming directions, and we aim to evaluate the associated large-scale rheology. Swimming directions should not be taken as uniformly distributed, but should depend on the surrounding fluid deformation, which leads to a nontrivial interaction between the fluid flow and particles' swimming forces. More precisely, our model is based on the following assumption: if the fluid is locally deformed, then the distribution of orientations depends on some local average of the symmetrized velocity gradient of the surrounding fluid around each particle. Although this steady-state perspective is certainly simplistic, our model does not prescribe the retroaction of the fluid on the particles a priori, but leaves it as part of the problem. We start by modeling the swimming mechanism for a single particle, before combining it with (1.2) into a model for the whole active suspension.
1.3.1. Single-particle swimming mechanism. Let us place ourselves at the scale of an isolated particle $I$, and denote by $u$ the fluid velocity outside $I$. Given a nonnegative smooth kernel $\chi$ with unit mass $\int_{\mathbb{R}^{d}} \chi=1$, the locally averaged fluid deformation felt by the particle is taken of the form

The precise choice of this operator does not matter in our analysis, provided that it is a compact operator applied to a restriction of $\mathrm{D}(u)$ around $I$. Given a value $E_{I}(u)=E$ of this averaged fluid deformation, the particle adapts its random swimming direction: we denote by $\bar{f}(E) \in \mathbb{R}^{d}$ the resulting propulsion force and by $\tilde{f}(E) \in \mathbb{M}^{\text {skew }}$ the resulting torque on the particle. By the action-reaction principle, this force and torque must result from an action of the particle on the surrounding fluid. The detail of this action depends on the details of the swimming mechanism (flagella, cilia, etc.). The force field exerted by the particle on the fluid is denoted by $f(E)=f(\cdot, E)$, depending on the deformation $E$, and is taken to be supported in the immediate neighborhood $(I+B) \backslash I$ of the particle. By the action-reaction principle for forces and torques, we must have

since the barycenter of particle $I$ is $\int_{I} y d y=0$. The relation (1.6) reads as a local neutrality condition that actually entails that swimming forces act as dipoles in the fluid equations.

We emphasize that this is fundamentally different from the sedimentation problem studied in [11], for which the force on particles originates from gravity and is not compensated locally by opposite forces in the surrounding fluid - the backflow is then uniform and leads to more important large-scale effects.

We further make the following assumptions on the regularity of the swimming force with respect to the fluid deformation.
Hypothesis 1.3 (Swimming mechanism). The random force field defines almost surely a smooth map $\mathbb{M}_{0}^{\text {sym }} \rightarrow \mathrm{L}^{\infty}((I+B) \backslash I)^{d}: E \mapsto f(E)$ such that, for all $k \geq 1$,

In view of quantitative homogenization results, we shall occasionally need to further assume that for large strain rates $E$ the swimming direction becomes a deterministic function of $E$. This technical assumption is physically reasonable.
Hypothesis 1.4 (Swimming in large strain rate). There exist a deterministic direction field $f^{\infty}: \mathbb{M}_{0}^{\text {sym }} \rightarrow \mathbb{R}^{d}$, a random strength field $\mathcal{S} \in \mathrm{L}^{\infty}((I+B) \backslash I)$, and an exponent $\gamma>0$, such that for all $E \in \mathbb{M}_{0}^{\text {sym }}$ and $k \geq 1$ we have almost surely

1.3.2. Resulting system for many particles. Before including the above single-particle swimming mechanism into the passive suspension model (1.2), we start by making an assumption on the joint law of particles' swimming forces.
Hypothesis 1.5 (Joint swimming forces). Let $\left\{f_{n}(E)\right\}_{n}$ be a sequence of random maps, such that $f_{n}$ satisfies Hypothesis 1.3 with $I=I_{n}$ for all $n$, and such that $\mathcal{I}$ and $\sum_{n} f_{n}(E)$ are jointly stationary for all E.
In order to include these swimming forces into the model (1.2) for a suspension of small particles $\left\{\varepsilon I_{n}\right\}_{n}$, they need to be properly rescaled. The natural scaling happens to be $O\left(\frac{1}{\varepsilon}\right)$, which is indeed the only scaling giving rise to a nontrivial and finite contribution in the macroscopic limit $\varepsilon \downarrow 0$. We add a coupling parameter $\kappa$, which stands for the activity strength and will need to be chosen small enough to perform the analysis. In this $\varepsilon$-rescaling, the kernel $\chi$ defining the local averaged fluid deformations felt by the particles (1.5) should naturally be replaced by $\chi_{\varepsilon}:=\varepsilon^{-d} \chi(\dot{\bar{\varepsilon}})$. This however leads to important difficulties due to the highly oscillatory local behavior of the fluid flow. Instead, we need to replace it by $\chi_{\delta}:=\delta^{-d} \chi(\dot{\bar{\delta}})$, for some intermediate averaging scale $\varepsilon \ll \delta \ll 1$. (This "meso-scale" is also present in [45, 47].) The resulting hydrodynamic model takes on the following guise,

In what follows, it will be convenient to use an equivalent formulation of swimming forces. While each force field $f_{n}$ is supported in the particle neighborhood $\left(I_{n}+B\right) \backslash I_{n}$ in the fluid domain, we may naturally extend $f_{n}$ inside the particle domain $I_{n}$ to match its propulsion force and torque. More precisely, we can uniquely define $f_{n}$ in $I_{n}$ as an affine function such that

1.4. Heuristics and relation to the physics literature. In this section, we relate the problem we consider to the building block used in [45, 47]. In the physics literature, rather than the full problem (1.7) (involving boundary conditions, and a general forcing term $h$ ), one usually considers a forcing term in form of an imposed strain rate $E \in \mathbb{M}_{0}^{\text {sym }}$ at infinity - in which case it is natural to replace (1.5) by $E$ itself (which renders the problem linear). The velocity field of the suspension on microscopic scale is then given by $u_{E}+E x$,
where $u_{E}$ is a suitable solution of the following infinite-volume problem,

In these terms, the effective viscosity $\overline{\boldsymbol{B}}_{\text {tot }}(E)$ of the suspension in direction $E$ is obtained as the associated ensemble-averaged stress. Splitting the contributions of the stress in the fluid domain and in the particles, and taking into account swimming forces, we get for all $E^{\prime} \in \mathbb{M}_{0}^{\text {sym }}$,

As one could have expected, the active contribution $E^{\prime}: \overline{\boldsymbol{B}}_{\text {act }}(E)$ coincides with the averaged swimming force along the passive corrector in direction $E^{\prime}$. Note in particular that the active corrector $\phi_{E}$ does not appear in that formulation. The first main contribution of the present article is to properly justify these effective viscosity formulas using homogenization theory, cf. Theorem 1.7.

While these general formulas are difficult to analyze in practice without resorting to numerical simulations, it is a classical problem in the physics community to derive simpler approximate formulas in the dilute regime, which are easier to interpret and provide a useful grasp at the physical behavior of suspensions. This is made possible by replacing correctors by explicit solutions of single-particle problems: we refer to Theorem 1.9 and Section 1.6 below for justification of such dilute approximations based on the methods introduced by the last two authors in [13].Note that the formula for the active contribution of the effective viscosity in the dilute approximation coincides with the active elastic stress first formally derived in [46, 24, 44, 47, 40], cf. (1.35) below; see also [20].
1.5. Main results: well-posedness, homogenization, and dilute regime. We turn to the statement of our main results and we start with the well-posedness of the hydrodynamic model (1.7). It requires either the coupling constant $\kappa$ to be small enough or the interparticle distance $\ell$ to be large enough. Note that condition (1.18) below is nearly almost optimal in general: the same condition with $\eta=0$ is required to ensure the perturbative well-posedness of the homogenized equation (1.20), see first paragraph of Section 3.2.

Proposition 1.6 (Well-posedness of the hydrodynamic model). Let Hypotheses 1.1, 1.3, and 1.5 hold, and assume $\varepsilon \ell \leq \delta$. Provided for some $\eta>0$ we have that

Next, we combine the above (nonlocal) homogenization limit with the (local) limit $\delta \downarrow 0$. In order to get beyond a purely diagonal regime, cf. (3.55) below, we need to appeal to the quantitative homogenization techniques developed in [10] by the last two authors in the context of the Stokes equation with rigid inclusions. This requires a quantitative mixing assumption such as Hypothesis 1.2 (which holds in particular for hardcore Poisson point processes). Although from the modeling viewpoint the choice $\delta \sim \varepsilon$ could be more natural, it is not accessible to our analysis, and we are restricted to (1.27) below.

Theorem 1.8 (Homogenization as $\delta \downarrow 0$ ). Let Hypotheses 1.1, 1.3, and 1.5 hold, as well as the smallness condition (1.18) to ensure well-posedness, and further let the quantitative mixing Hypothesis 1.2 and the technical Hypothesis 1.4 hold. Then, for any $h \in W^{1, \infty}(U)^{d}$, as $\varepsilon, \delta \downarrow 0$, in the regime

where we recall that $\lambda, \overline{\boldsymbol{B}}_{\mathrm{pas}}, \overline{\boldsymbol{B}}_{\mathrm{act}}, \overline{\boldsymbol{b}}, \overline{\boldsymbol{c}}$ are defined in Theorem 1.7 above.
The above shows that the effective stress-strain constitutive relation $E \mapsto 2 \overline{\boldsymbol{B}}_{\text {pas }} E$ is replaced by the nonlinear (non-Newtonian) relation $E \mapsto 2 \overline{\boldsymbol{B}}_{\mathrm{pas}} E+2 \overline{\boldsymbol{B}}_{\text {act }}(E)$ due to the effect of particle activity.

Our last result concerns the analysis of the latter in the dilute regime, and we establish the active counterpart to Einstein's effective viscosity formula. Before stating the result, we need to recall some notation from [13]: Denote by $Q_{r}(x)=x+\left[-\frac{r}{2}, \frac{r}{2}\right)^{d}$ the cube of sidelength $r$ centered at $x$, and set $Q(x)=Q_{1}(x), Q_{r}=Q_{r}(0)$, and $Q=Q_{1}(0)$. The intensity of the point process $\left\{x_{n}\right\}_{n}$ is

where we recall that $\ell$ stands for (half) the interparticle distance, cf. (1.1). Note that by definition the intensity can be compared to the particle volume fraction $\lambda$, cf. (1.4), and we have for $k=2,3$,

With this notation at hand, we may now state the following result on the first-order dilute expansion of the effective viscosity. The expansion of the passive contribution $\overline{\boldsymbol{B}}_{\text {pas }}$ was already established in [13], and we extend it here to the active setting.

Theorem 1.9 (Dilute expansion of the effective viscosity). Let Hypotheses 1.1, 1.3, and 1.5 hold, and further assume
(a) Independence condition: The random shapes and swimming forces $\left\{I_{n}^{\circ}, f_{n}\right\}_{n}$ are iid copies of a given random open subset $I^{\circ}$ and of a random map $f^{\circ}$, independently of the point process $\left\{x_{n}\right\}_{n}$.
(b) Decay of correlations: The point process $\left\{x_{n}\right\}_{n}$ is strongly mixing, and the two- and three-point correlation functions

Note that the error bound in (1.32) is $\ll \lambda_{1}$ provided that $\lambda_{2}\left|\log \lambda_{1}\right| \ll \lambda_{1}$, and is in particular bounded by $\ell^{-3 d / 2} \ll \ell^{-d}$ in the regime $\ell \gg 1$.

Alternatively, arguing similarly as for the reformulation (1.26) of (1.24) \& (1.25), the dilute active effective viscosity can be written as

In particular, if $f^{\circ}(E)$ is rotationally symmetric around the direction $\bar{f}^{\circ}(E)$, we find by symmetry,

for some random prefactor $\alpha(E) \in \mathbb{R}$, the sign of which is actually of critical interest and depends on the nature of the swimming mechanism. Note that formula (1.35) coincides with the active elastic stress first formally derived in [46, 24, 44, 47, 40]; see also [20].

Before we discuss the possible reduction of viscosity due to particle activity, let us comment on one assumption that we make throughout the paper: the distribution of the positions of particles is stationary and ergodic. This is physically way too stringent since the dynamics in a bounded domain would break this stationarity, and therefore allow the local density of particle positions to be non-constant (as indeed observed in experiments). From our homogenization point of view, stationarity is fortunately not essential and the difficulty of the analysis is not there: one could indeed easily weaken stationarity into a notion of "local stationarity" and allow the density of active particles to depend on the macroscopic space variable.
1.6. Viscosity reduction. The main motivation of this work is to introduce a nontrivial (and hopefully somewhat realistic) model for active suspensions and rigorously establish a reduction of the viscosity of the plain fluid due to the activity of the particles. In the dilute regime, the above formulas provide a rigorous contribution to this celebrated topic. Although the question can be reduced to understanding the sign of $\alpha(E)$ in (1.35), we take a shorter path here based on (1.34). To make computations explicit, we restrict ourselves to the following simplified model for the swimming mechanism, see e.g. [20, 23],

where the force exerted by the particle on the surrounding fluid is reduced to a Dirac force at a surrounding point $x(E) \in \mathbb{R}^{d} \backslash B$. Consider a shear deformation $E=\frac{s}{2}\left(e_{1} \otimes e_{2}+e_{2} \otimes e_{1}\right)$ for some $s \in \mathbb{R}$. In these terms, the formula (1.34) reads

For a spherical particle with its swimming device viewed as a rigid elongated particle, the motion in shear flow has been well-studied on the formal level: in the limit of a strong angular diffusion, a standard heuristic computation shows that the preferred orientation of the particle is $e:=\frac{1}{\sqrt{2}}\left(e_{1}+e_{2}\right)$ or its opposite; see e.g. [15, Section V.8]. This leads us to choosing

$$

where $\gamma=1$ in case when the Dirac swimming force is ahead of the particle ("puller" particle) and $\gamma=-1$ in case when it is behind the particle ("pusher" particle). Hence, we get

which is negative (resp. positive) in case of a pusher (resp. puller). This is in full agreement with well-known experiments and predictions of [48, 49, 35].

To conclude on the extent of the possible viscosity reduction, we come back to Theorem 1.9 in case $\ell \gg 1$. As stated, the error bound in the result is then of order $O\left(\ell^{-3 d / 2}\right)$,

If $\overline{\boldsymbol{B}}_{\text {act }}^{(1)}(E)<0$, we infer that the total effective viscosity is smaller than the viscosity of the plain fluid,

provided that the activity is strong enough $\kappa \gg 1$ in such a way that the active contribution exceeds the passive one. Moreover, as $\lambda_{1}=O\left(\ell^{-d}\right)$, we see that the viscosity reduction could become of order 1 if $\kappa=O\left(\ell^{d}\right)$. This drastic reduction of viscosity is however prohibited by the (only nearly optimal) condition (1.18), which is used to ensure the wellposedness of the microscopic model. In some sense, the above analysis can be compared to the enhancement of elastostriction by active charges analyzed in [14].

Outline of the article. The article is organized as follows. Section 2 is dedicated to the introduction of correctors, the key quantities in homogenization. The proofs of the homogenization results of Theorems 1.7 and 1.8 are the object of Section 3, while the dilute analysis and the proof of Theorem 1.9 are postponed to Section 4.

## Notation.

## 2. Corrector problems

We start by recalling the relevant correctors for the passive suspension problem as introduced in $[4,12,8,10]$, and then we define new correctors for the active problem.
2.1. Passive corrector problems. Correctors for passive suspensions were first defined in [8] and are key to the definition of the associated effective viscosity $\overline{\boldsymbol{B}}$, cf. (1.3).

Lemma 2.1 (Passive correctors [8]). Let Hypothesis 1.1 hold. For all $E \in \mathbb{M}_{0}^{\text {sym }}$, there exist a unique random field $\psi_{E} \in \mathrm{~L}^{2}\left(\Omega ; H_{\mathrm{loc}}^{1}\left(\mathbb{R}^{d}\right)^{d}\right)$ and a unique pressure field $\Sigma_{E} \in$ $\mathrm{L}^{2}\left(\Omega ; \mathrm{L}_{\mathrm{loc}}^{2}\left(\mathbb{R}^{d} \backslash \mathcal{I}\right)\right)$ such that:

- almost surely, realizations of $\psi_{E}$ and $\Sigma_{E}$ satisfy

It thus needs to be first suitably compensated and we are led to defining the following auxiliary corrector $\gamma_{E}$. The proof of the upcoming lemma (which is a simplified version of Lemma 2.3) is straightforward and skipped for brevity.

\begin{cases}-\triangle \phi_{E}^{n}+\nabla \Pi_{E}^{n}=f_{n}(E), & \text { in } I_{n},  \tag{2.16}\\ \operatorname{div}\left(\phi_{E}^{n}\right)=0, & \text { in } I_{n}, \\ \sigma\left(\phi_{E}^{n}, \Pi_{E}^{n}\right) \nu=\sigma\left(\phi_{E}, \Pi_{E}\right) \nu, & \text { on } \partial I_{n} .\end{cases}
$$

Note that this only defines $\phi_{E}^{n}$ up to a rigid motion, which is fixed by choosing $\phi_{E}^{n}$ with $f_{I_{n}} \phi_{E}^{n}=0$ and $f_{I_{n}} \nabla \phi_{E}^{n} \in \mathbb{M}_{0}^{\text {sym }}$. Assuming that this Neumann problem (2.16) is wellposed, and setting

\end{align*}

we easily deduce that the extended flux

satisfies the desired relations (2.11) (recall that $\left.\mathrm{D}\left(\phi_{E}\right)\right|_{\mathcal{I}}=0$ ). It remains to check the well-posedness of this Neumann problem and to establish the bound (2.10). Note that this well-posedness, together with the uniqueness in our construction of the pressures $\left\{\Pi_{E}^{n}\right\}_{n}$
below, ensures that $\tilde{q}_{E}$ and $\tilde{\Pi}_{E}$ are stationary. We split the proof into three further substeps.

Substep 1.1. Well-posedness of the Neumann problem (2.16) for $\phi_{E}^{n}$.
The weak formulation of (2.16) reads as follows: for all divergence-free fields $v \in H^{1}\left(I_{n}\right)^{d}$,

In order to deal with the Neumann condition, we consider an extension map

= & \int_{\left(I_{n}+B\right) \backslash I_{n}} T_{n}\left(v-\left(f_{I_{n}} v\right)-\left(f_{I_{n}}(\nabla v)^{\text {skew }}\right)\left(x-x_{n}\right)\right) \cdot f_{n}(E) \\
& -2 \int_{\left(I_{n}+B\right) \backslash I_{n}} \mathrm{D}\left(\phi_{E}\right): \mathrm{D}\left[T_{n}\left(v-\left(f_{I_{n}} v\right)-\left(f_{I_{n}}(\nabla v)^{\text {skew }}\right)\left(x-x_{n}\right)\right)\right] .
\end{aligned}
$$

Hence, in view of (2.21) and of Korn's inequality,

which proves the continuity of $\mathcal{L}_{E}$ on $\mathcal{T}$.

By the Lax-Milgram theorem, we deduce that there exists a unique solution $\phi_{E}^{n} \in \mathcal{T}$ of (2.19), and that it satisfies

Substep 1.2. Construction of the pressure.
As (2.17) reads $\tilde{q}_{E}=\mathrm{D}\left(\phi_{E}\right)+\mathrm{D}\left(\phi_{E}^{n}\right) \mathbb{1}_{I_{n}}$ in $I_{n}+B$, combining equation (2.4) for $\phi_{E}$ and equation (2.19) for $\phi_{E}^{n}$, we find for all $v \in C_{c}^{\infty}\left(I_{n}+B\right)^{d}$ with $\operatorname{div}(v)=0$,

Appealing e.g. to [31, Proposition 12.10], we deduce that there exists an associated pressure field $\Pi_{E}^{n} \in \mathrm{~L}_{\text {loc }}^{2}\left(I_{n}+B\right)$, which is unique up to an additive constant, such that for all test functions $v \in C_{c}^{\infty}\left(I_{n}+B\right)^{d}$,

It remains to estimate the above-constructed pressure. Using that $\Pi_{E}^{n}$ coincides with $\Pi_{E}$ in $\left(I_{n}+B\right) \backslash I_{n}$, we can split

& \lesssim\left\|\Pi_{E}^{n}-f_{I_{n}+B} \Pi_{E}^{n}\right\|_{\mathrm{L}^{2}\left(I_{n}+B\right)}+\left|f_{\left(I_{n}+B\right) \backslash I_{n}} \Pi_{E}\right|
\end{aligned}
$$

Starting from (2.23), a standard argument based on the Bogovskii operator yields

By definition (2.18), the bound (2.24) yields for all $n$,

\end{align*}

Hence, for all $R>0$,

and thus, by stationarity, letting $R \uparrow \infty$,

Combined with (2.5), this yields (2.10).
Step 2. Formula for $\mathbb{E}\left[K_{E}\right]$ and definition of $\overline{\boldsymbol{C}}(E)$ and $\overline{\boldsymbol{c}}(E)$.
We split the proof into two further substeps, separately proving formula (2.12) for $\mathbb{E}\left[K_{E}\right]$ and establishing the alternative formulas (1.26) for $\overline{\boldsymbol{C}}(E)$ and $\overline{\boldsymbol{c}}(E)$.
Substep 2.1. Proof of (2.12).
The hardcore assumption allows to construct almost surely for all $R>0$ a cut-off function $\eta_{R}$ such that

& +\sum_{n} \eta_{R}\left(x_{n}\right) \int_{I_{n}} f_{n}(E) \otimes\left(x-x_{n}\right)
\end{aligned}

By the boundary conditions for $\left(\phi_{E}^{n}, \Pi_{E}^{n}\right)$ and recalling the notation (1.8), we deduce

and thus, after reorganizing the terms, using that the skew-symmetry of $\tilde{f}_{n}(E)$ in (1.8) yields $\int_{I_{n}} E^{\prime}\left(x-x_{n}\right) \cdot f_{n}(E)=0$,

\sum_{n} \int_{\partial I_{n}} \eta_{R} E^{\prime}\left(x-x_{n}\right) \cdot \sigma\left(\phi_{E}, \Pi_{E}\right) \nu= & \int_{\mathbb{R}^{d}} \nabla\left(\eta_{R} \psi_{E^{\prime}}\right): \nabla \phi_{E} \\
& -\int_{\mathbb{R}^{d}} \nabla \eta_{R} \cdot \psi_{E^{\prime}} \Pi_{E}-\sum_{n} \int_{I_{n}+B} \eta_{R} \psi_{E^{\prime}} \cdot f_{n}(E)
\end{aligned}
$$

Alternatively, expanding the first right-hand side term,

& \quad+\int_{\mathbb{R}^{d}}\left(\psi_{E^{\prime}} \otimes \nabla \eta_{R}\right): \nabla \phi_{E}-\int_{\mathbb{R}^{d}}\left(\phi_{E} \otimes \nabla \eta_{R}\right): \nabla \psi_{E^{\prime}}-\sum_{n} \int_{I_{n}+B} \eta_{R} \psi_{E^{\prime}} \cdot f_{n}(E)
\end{aligned}

Now testing equation (2.1) for $\psi_{E^{\prime}}$ with $\eta_{R} \phi_{E}$, and using that $\eta_{R} \phi_{E}$ is rigid in $\mathcal{I}$, we find that the first right-hand side term only yields a term involving $\Sigma_{E}$

Using the sublinearity of $\psi_{E^{\prime}}$ and $\phi_{E}$ and the stationarity of $\nabla \psi_{E^{\prime}}, \nabla \phi_{E}, \Pi_{E} \mathbb{1}_{\mathbb{R}^{d} \backslash \mathcal{I}}$, cf. Lemmas 2.1 and 2.3, we can now pass to the limit $R \uparrow \infty$ in this identity, and we obtain

Inserting this into (2.27), the conclusion (1.26) follows. Finally, the formula for $\overline{\boldsymbol{c}}(E)$ simply follows by taking the trace in (1.24).
Step 3. Construction of $\theta$.
This construction is standard: as $L_{E}$ is stationary, it follows from stationary calculus, e.g. [31, Chapter 7], that there is a unique solution $\theta_{E}=\left(\theta_{E ; i j k}\right)_{i j k} \in \mathrm{~L}^{2}\left(\Omega ; H_{\text {loc }}^{1}\left(\mathbb{R}^{d}\right)\right)$ of

and satisfies the anchoring condition $f_{B} \theta_{E}=0$. By uniqueness, the skew-symmetry of $\theta_{E}$ follows from the skew-symmetry of the right-hand side of (2.29) with respect to indices $j, k$. The fact that $\theta_{E}$ is a vector potential for $L_{E}$ follows from this defining equation as e.g. in [21, Section 3.1]. Finally, the sublinearity of $\theta_{E}$ is a standard property for random fields with stationary gradient and vanishing expectation; see e.g. [31, Chapter 7].

In view of the internal contribution to the effective viscosity, cf. (1.25), we also define the following stationary field,

When considering two-scale expansions, since correctors $\phi_{E}, \Pi_{E}, \gamma_{E}, \theta_{E}$, fluxes $K_{E}, L_{E}$, and $F_{E}$ are nonlinear with respect to $E$, we shall need to consider derivatives of these objects with respect to $E$. We introduce a general notation for linearized quantities.
Definition 2.6. Given $E, E^{\prime}, E^{\prime \prime} \in \mathbb{M}_{0}^{\text {sym }}$, we use the following notation for directional derivatives of swimming forces $f_{n}(E)$ in directions $E^{\prime}, E^{\prime \prime}$,

- First linearized correctors: We define $\left(\mathfrak{d} \phi_{E, E^{\prime}}, \mathfrak{d} \Pi_{E, E^{\prime}}\right)$ as in Lemma 2.3 with the swimming forces $f_{n}(E)$ replaced by $\partial_{E^{\prime}} f_{n}(E)$ (and similarly for $\mathfrak{d} F_{E, E^{\prime}}$ ). We then define $\mathfrak{d} \gamma_{E, E^{\prime}}$ as in Lemma 2.4 and $\mathfrak{d} K_{E, E^{\prime}}, \mathfrak{d} L_{E, E^{\prime}}, \mathfrak{d} \theta_{E, E^{\prime}}$ as in Lemma 2.5 with $f_{n}(E)$ replaced by $\partial_{E^{\prime}} f_{n}(E)$ and with $\left(\phi_{E}, \Pi_{E}\right)$ replaced by ( $\left.\mathfrak{d} \phi_{E, E^{\prime}}, \mathfrak{d} \Pi_{E, E^{\prime}}\right)$.
- Second linearized correctors: We define ( $\mathfrak{d}^{2} \phi_{E, E^{\prime}, E^{\prime \prime}}, \mathfrak{d}^{2} \Pi_{E, E^{\prime}, E^{\prime \prime}}$ ) as in Lemma 2.3 with swimming forces $f_{n}(E)$ replaced by $\partial_{E^{\prime}, E^{\prime \prime}} f_{n}(E)$ (and similarly for $\mathfrak{d}^{2} F_{E, E^{\prime}, E^{\prime \prime}}$ ). We then define $\mathfrak{d}^{2} \gamma_{E, E^{\prime}, E^{\prime \prime}}$ as in Lemma 2.4 and $\mathfrak{d}^{2} K_{E, E^{\prime}, E^{\prime \prime}}, \mathfrak{d}^{2} L_{E, E^{\prime}, E^{\prime \prime}}, \mathfrak{d}^{2} \theta_{E, E^{\prime}, E^{\prime \prime}}$ as in Lemma 2.5 with $f_{n}(E)$ replaced by $\partial_{E^{\prime}, E^{\prime \prime}} f_{n}(E)$ and with $\left(\phi_{E}, \Pi_{E}\right)$ replaced by ( ${ }^{2} \phi_{E, E^{\prime}, E^{\prime \prime}}$, $\left.\mathfrak{d}^{2} \Pi_{E, E^{\prime}, E^{\prime \prime}}\right)$.

Finally, we state that the effective maps $\overline{\boldsymbol{C}}, \overline{\boldsymbol{c}}, \overline{\boldsymbol{F}}$ are smooth, with derivatives given in terms of linearized correctors. The proof, based on Hypothesis 1.3, is straightforward and left to the reader.

Lemma 2.7. The effective maps $\overline{\boldsymbol{C}}, \overline{\boldsymbol{c}}, \overline{\boldsymbol{F}}$ are smooth and

In particular, in view of (2.12), this yields $\partial_{F} \mathbb{E}\left[K_{E}\right]=\mathbb{E}\left[\mathfrak{d} K_{E, F}\right]$.

## 3. Proof of the homogenization result

This section is devoted to the proof of Theorem 1.7. We quickly establish the wellposedness result of Proposition 1.6 before turning to the analysis of the limit $\varepsilon \downarrow 0$. For any map $V$ and domain $D$, we henceforth use the short-hand notation $V_{\nmid D}:=f_{D} V$.
3.1. Well-posedness of hydrodynamic model. This section is devoted to the proof of Proposition 1.6. We start by recalling the following standard computation (see e.g. [8]), which we already partly encountered when proving existence of correctors.
Lemma 3.1 (e.g. [8]). If vector fields $u, h$ and a scalar field $P$ satisfy the following relations,

The same is true if $\mathbb{R}^{d}$ and $\mathcal{I}$ are replaced by $U$ and $\mathcal{I}_{\varepsilon}(U)$, respectively.
We turn to the proof of Proposition 1.6 and proceed by a fixed-point argument. Let $\varepsilon>0$ be fixed. Given $v \in W^{1,1}(U)^{d}$, define $T_{\varepsilon}(v) \in H_{0}^{1}(U)^{d}$ as the unique solution of the following linear problem, with associated pressure $P_{\varepsilon}(v) \in \mathrm{L}^{2}\left(U \backslash \mathcal{I}_{\varepsilon}(U)\right)$,

\begin{cases}-\Delta T_{\varepsilon}(v)+\nabla P_{\varepsilon}(v) & \text { in } U \backslash \mathcal{I}_{\varepsilon}(U),  \tag{3.2}\\ =h+\frac{\kappa}{\varepsilon} \sum_{n \in \mathcal{N}_{\varepsilon}(U)} f_{n, \varepsilon}\left(\chi_{\delta} * \mathrm{D}(v)_{\notin I_{n}}\right), & \text { in } U \backslash \mathcal{I}_{\varepsilon}(U), \\ \operatorname{div}\left(T_{\varepsilon}(v)\right)=0, & \text { in } \mathcal{I}_{\varepsilon}(U), \\ \mathrm{D}\left(T_{\varepsilon}(v)\right)=0, & \\ \int_{\varepsilon \partial I_{n}} \sigma\left(T_{\varepsilon}(v), P_{\varepsilon}(v)\right) \nu+\frac{\kappa}{\varepsilon} \bar{f}_{n, \varepsilon}\left(\chi_{\delta} * \mathrm{D}(v)_{\notin I_{n}}\right)=0, & \forall n \in \mathcal{N}_{\varepsilon}(U), \\ \int_{\varepsilon \delta I_{n}} \Theta\left(x-\varepsilon x_{n}\right) \cdot \sigma\left(T_{\varepsilon}(v), P_{\varepsilon}(v)\right) \nu \\ \quad+\kappa \Theta: \tilde{f}_{n}\left(\chi_{\delta} * \mathrm{D}(v)_{ধ \varepsilon I_{n}}\right)=0, & \forall \Theta \in \mathbb{M}^{\text {skew }}, \forall n \in \mathcal{N}_{\varepsilon}(U) .\end{cases}
$$

We split the proof into three steps. We start by proving the result under the stronger smallness condition $\kappa \ell^{-d / 2} \ll 1$, before relaxing it to (1.18).
Step 1. Suboptimal contraction estimate: for all $v, w \in H_{0}^{1}(U)^{d}$ we have

This proves that $T_{\varepsilon}$ is a contraction on $H_{0}^{1}(U)^{d}$ provided that $\kappa \ell^{-\frac{d}{2}} \ll 1$ is small enough. Under this condition, we deduce the well-posedness of the hydrodynamic model (1.7) in $H_{0}^{1}(U)^{d}$.
We turn to the proof of (3.3). For abbreviation, we set $T_{\varepsilon}(v, w):=T_{\varepsilon}(v)-T_{\varepsilon}(w)$ and $P_{\varepsilon}(v, w)=P_{\varepsilon}(v)-P_{\varepsilon}(w)$. Testing the equations for $T_{\varepsilon}(v)$ and $T_{\varepsilon}(w)$ with $T_{\varepsilon}(v, w)$ in form of (3.1), we find

& \quad+\frac{\kappa}{\varepsilon} \sum_{n \in \mathcal{N}_{\varepsilon}(U)} \int_{\varepsilon\left(I_{n}+B\right) \backslash \varepsilon I_{n}} T_{\varepsilon}(v, w) \cdot\left(f_{n, \varepsilon}\left(\chi_{\delta} * \mathrm{D}(v)_{\notin I_{n}}\right)-f_{n, \varepsilon}\left(\chi_{\delta} * \mathrm{D}(w)_{\notin I_{n}}\right)\right),
\end{aligned}
$$

and thus, using the rigidity of $T_{\varepsilon}(v, w)$ in $\varepsilon I_{n}$ and using boundary conditions, recalling the notation (1.8),
$\int_{U}\left|\nabla T_{\varepsilon}(v, w)\right|^{2}=\frac{\kappa}{\varepsilon} \sum_{n \in \mathcal{N}_{\varepsilon}(U)} \int_{\varepsilon\left(I_{n}+B\right)} T_{\varepsilon}(v, w) \cdot\left(f_{n, \varepsilon}\left(\chi_{\delta} * \mathrm{D}(v)_{\nmid \varepsilon I_{n}}\right)-f_{n, \varepsilon}\left(\chi_{\delta} * \mathrm{D}(w)_{\notin I_{n}}\right)\right)$.
By the neutrality condition (1.9), appealing to Poincare's inequality, using the hardcore assumption, and recalling that $f_{n, \varepsilon}$ is Lipschitz, we get

& \leq\left(\frac{\varepsilon}{\delta}\right)^{d} \sup _{y \in \mathbb{R}^{d}} \sum_{n} \sup _{\frac{\varepsilon}{\delta} B_{\ell}\left(y+x_{n}\right)} \chi \\
& \lesssim \ell^{-d} \sup _{y \in \mathbb{R}^{d}} \sum_{n} \int_{\frac{\varepsilon}{\delta} B_{\ell}\left(y+x_{n}\right)}\left(\sup _{B_{2 \ell \frac{\delta}{\delta}(z)}} \chi\right) d z
\end{aligned}
$$

and thus, by the hardcore assumption, provided $\varepsilon \ell \leq \delta$,

Step 2. Improved contraction estimate: given $1<p \leq 2$ and given $\ell>_{p} 1$ large enough, we have for all $v, w \in W_{0}^{1, p}(U)^{d}$,

This proves that $T_{\varepsilon}$ is a contraction on $W_{0}^{1, p}(U)^{d}$ provided that $\kappa \ell^{-\frac{d}{p}} \ll 1$ is small enough, which then implies the well-posedness of the hydrodynamic model (1.7) in $W_{0}^{1, p}(U)^{d}$.

We appeal to the dilute deterministic $\mathrm{L}^{p}$ regularity theory developed by Höfer in [26]. Given $1<p \leq 2$, provided that $\ell>_{p} 1$ is large enough (depending on $p$ and dimension $d$ ), it allows us to deduce almost surely,

$$

and thus, using properties of $\left\{f_{n, \varepsilon}\right\}_{n}$,

\begin{aligned}
& \left\|\nabla\left(T_{\varepsilon}(v)-T_{\varepsilon}(w)\right)\right\|_{\mathrm{L}^{p}(U)} \\
& \quad \lesssim_{p} \kappa\left(\sum_{n \in \mathcal{N}_{\varepsilon}(U)} \int_{\varepsilon\left(I_{n}+B\right)}\left|f_{n, \varepsilon}\left(\chi_{\delta} * \mathrm{D}(v)_{\nless I_{n}}\right)-f_{n, \varepsilon}\left(\chi_{\delta} * \mathrm{D}(w)_{\ell \varepsilon I_{n}}\right)\right|^{p}\right)^{\frac{1}{p}} \\
& \quad \lesssim \kappa\left(\sum_{n \in \mathcal{N}_{\varepsilon}(U)} \int_{\varepsilon I_{n}}\left|\chi_{\delta} * \mathrm{D}(v-w)\right|^{p}\right)^{\frac{1}{p}} .
\end{aligned}
$$

Repeating the argument in (3.4), this proves the claim.
Step 3. Conclusion.
Testing equation (3.2) with its solution $T_{\varepsilon}(v)$ itself, using boundary conditions and recalling the notation (1.8), we find

This proves that $T_{\varepsilon}$ embeds $W_{0}^{1, p}(U)^{d}$ into $H_{0}^{1}(U)^{d}$, so that the solution $u_{\varepsilon}=T_{\varepsilon}\left(u_{\varepsilon}\right)$ in $W_{0}^{1, p}(U)^{d}$ constructed in Step 2 actually belongs to $H_{0}^{1}(U)^{d}$, and the a priori estimate (1.19) follows by iteration.
3.2. Qualitative homogenization at fixed $\delta$. This section is devoted to the proof of Theorem 1.7. Before turning to the proof, we argue for the well-posedness of the homogenized equation (1.20). Using $|\overline{\boldsymbol{C}}(E)|,|\overline{\boldsymbol{F}}(E)| \lesssim \lambda\langle E\rangle$, cf. (2.32), a perturbative argument as in the proof of Proposition 1.6 yields the well-posedness of (1.20) with $\left(\bar{u}_{\delta}, \bar{P}_{\delta}\right) \in H_{0}^{1}(U)^{d} \times \mathrm{L}^{2}(U) / \mathbb{R}$ provided that $\kappa \lambda \ll 1$ is small enough. As $\lambda \lesssim \ell^{-d}$, this holds in particular under the smallness condition (1.18).

Interestingly, our proof of qualitative homogenization relies on a semi-quantitative twoscale analysis and we do not believe that there exists a simpler and purely qualitative proof. In terms of a suitable limiting profile $\bar{u}_{\varepsilon}$ (mildly depending on $\varepsilon$ and to be identified at the end of the proof), we consider the following two-scale expansions for the solution ( $u_{\varepsilon}, P_{\varepsilon}$ ) of the hydrodynamic model (1.7),

where $u_{\varepsilon}$ is implicitely extended by 0 on $\mathbb{R}^{d} \backslash U$ to ensure that $\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)$ is well-defined, and where we implicitly sum over $E$ in an orthonormal basis of $\mathbb{M}_{0}^{\text {sym }}$. We start with two comments on the form of these two-scale expansions:

- The most unusual feature is that correctors $\phi, \Pi$ are evaluated at a background fluid deformation $\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)$ depending on the microscopic solution $u_{\varepsilon}$. This non-standard choice is taken as an intermediate step and happens to be providential in our proof, where the limit of this background deformation $\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right) \sim \chi_{\delta} * \mathrm{D}\left(\bar{u}_{\varepsilon}\right)$ can only be identified at the very end. To our knowledge, the necessity of such a two-step homogenization argument is new to the literature and gives the present problem an interest of its own.
- The choice of the non-oscillating part $\bar{P}_{\varepsilon}+\overline{\boldsymbol{b}}: \mathrm{D}\left(\bar{u}_{\varepsilon}\right)+\kappa \overline{\boldsymbol{c}}\left(\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)\right)$ in the twoscale expansion of the pressure is dictated by the proof and is similar to the case of passive suspensions [8]: the pressure for (1.7) does not converge to the pressure of the homogenized problem in its naïve form.

As $\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)$ is smooth, the maps $(x, y) \mapsto\left(\phi_{\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)(x)}\right)(y),\left(\Pi_{\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)(x)} \mathbb{1}_{\mathbb{R}^{d} \backslash \mathcal{I}}\right)(y)$ are Carathéodory functions, which ensures that $x \mapsto \phi_{\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)(x)}\left(\frac{x}{\varepsilon}\right),\left(\Pi_{\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)(x)} \mathbb{1}_{\mathbb{R}^{d} \backslash \mathcal{I}}\right)\left(\frac{x}{\varepsilon}\right)$ in (3.5) are measurable. When differentiating such composed functions, some care is needed in the notation. Given a smooth field $V: \mathbb{R}^{d} \rightarrow \mathbb{M}_{0}^{\text {sym }}$, we denote by $\phi_{V}$ the function of two variables $(x, y) \mapsto \phi_{V(x)}(y)$, and we use the short-hand notation $\phi_{V}\left(\frac{x}{\varepsilon}\right):=\phi_{V(x)}\left(\frac{x}{\varepsilon}\right)$. We use the following notation for the derivative of $\phi_{V}$ with $V$ frozen,

As usual, correctors are not capturing the relevant behavior close to the boundary of the domain $U$ : in particular, the two-scale expansion in (3.5) does not vanish at the boundary. To circumvent this, we proceed by truncating correctors in a neighborhood of the boundary. We set for abbreviation

We split the proof into three main steps.
Step 1. Equation for the two-scale expansion error $\left(w_{\varepsilon}, Q_{\varepsilon}\right)$ : in the weak sense in $U$,

Some care is however needed to prove these convergence results as we take suprema in the notation (3.23)-(3.24): while the linear dependence of $\nabla \psi_{E}$ on $E$ makes the suprema $|\nabla \psi|=\sup _{E}|E|^{-1}\left|\nabla \psi_{E}\right|$ trivial, the same is not true for $\nabla \phi_{E}$. In that case, we use the Sobolev embedding in form of

Now, by definition of the two-scale expansion error $w_{\varepsilon}$, cf. (3.8), together with the sublinearity of correctors, cf. Lemmas 2.1 and 2.3 , the convergence $w_{\varepsilon} \rightarrow 0$ in $H_{0}^{1}(U)$ implies $u_{\varepsilon}-\bar{u}_{\varepsilon} \rightarrow 0$ in $\mathrm{L}^{2}(U)$, and thus $u_{0}=\bar{u}_{0}$. From (3.54), we deduce that $\bar{u}:=u_{0}=\bar{u}_{0}$ actually satisfies the homogenized equation (1.20). In view of the well-posedness for the latter, we conclude $u_{\varepsilon} \rightharpoonup \bar{u}$ in $H_{0}^{1}(U)$ independently of extractions.
We turn to the convergence of the pressure field. Recall that we have shown $Q_{\varepsilon} \rightarrow 0$ in $\mathrm{L}^{2}(U)$. The a priori estimate (3.49) ensures $\bar{P}_{\varepsilon} \rightharpoonup \bar{P}$ in $\mathrm{L}^{2}(U)$, where $\bar{P}$ is the unique pressure field in $\mathrm{L}^{2}(U) / \mathbb{R}$ for the homogenized equation (3.54). By definition of $Q_{\varepsilon}$, cf. (3.8), together with the ergodic theorem for corrector pressures, cf. Lemmas 2.1 and 2.3, and with the choice (3.44) of $P_{\varepsilon}^{\prime}$, the convergence of the pressure follows.
3.3. Quantitative homogenization and limit $\delta \downarrow 0$. This section is devoted to the proof of Theorem 1.8. As the above proof is semi-quantitative, one can infer convergence rates provided that quantitative mixing assumptions such as Hypothesis 1.2 are further made on the statistical ensemble of inclusions. Quantitative rates then allow in particular to let the parameter $\delta$ tend to 0 in a nontrivial regime. We split the proof into three steps.
Step 1. Convergence of the homogenized equation (1.20) as $\delta \downarrow 0$.
Writing equation (1.20) as

Passing to the limit in equation (1.20), we find that ( $\bar{u}_{0}, \bar{P}_{0}$ ) satisfies equation (1.28). Provided that $\kappa \lambda \ll 1$ is small enough, which is ensured by the smallness condition (1.18), the well-posedness of (1.28) follows from the same argument as for (1.20). We conclude that $\left(\bar{u}_{0}, \bar{P}_{0}\right)=(\bar{u}, \bar{P})$ is the unique solution of (1.28) and that $\bar{u}_{\delta} \rightarrow \bar{u}$ in $W^{1, \infty}(U)$ and $\bar{P}_{\delta} \rightarrow \bar{P}$ in $\mathrm{L}^{\infty}(U)$.

Combining this with Theorem 1.7, by a diagonalization argument, we deduce that there is a (random) sequence $\delta_{\varepsilon}^{\circ} \downarrow 0$ such that, for any sequence $0<\delta_{\varepsilon} \leq \delta_{\varepsilon}^{\circ}$, the solution ( $u_{\varepsilon}, P_{\varepsilon}$ ) of (1.10) with $\delta=\delta_{\varepsilon}$ satisfies, as $\varepsilon \downarrow 0$,

u_{\varepsilon} & \rightharpoonup \bar{u}, & \text { in } H_{0}^{1}(U)^{d}, \\
P_{\varepsilon} \mathbb{1}_{U \backslash I_{\varepsilon}(U)} & \rightharpoonup(1-\lambda) \bar{P}+(1-\lambda) \overline{\boldsymbol{b}}: \mathrm{D}(\bar{u}) &  \tag{3.55}\\
& & +(1-\lambda) \kappa\left(\overline{\boldsymbol{c}}(\mathrm{D}(\bar{u}))-f_{U} \overline{\boldsymbol{c}}(\mathrm{D}(\bar{u}))\right), \\
& \text { in } \mathrm{L}^{2}(U) .
\end{array}
$$

To improve on such a diagonal result, we need to prove a quantitative version of Theorem 1.7 and capture the precise dependence on $\delta$. This is the purpose of the next two steps.

Step 2. Corrector estimates.
As we proved in [10] for passive correctors, under a quantitative mixing assumption such as Hypothesis 1.2, we have for all $s<\infty$,

which optimally quantifies the sublinearity of passive correctors. The method in [10] applies mutadis mutandis to active correctors, and yields the following: for all $E, E^{\prime}, E^{\prime \prime} \in \mathbb{M}_{0}^{\text {sym }}$ and $s<\infty$, we get

& \mathbb{E}\left[\mid\left(\phi_{E}, \gamma_{E}, \theta_{E}, \mathfrak{d} \phi_{E, E^{\prime}}, \mathfrak{d} \gamma_{E, E^{\prime}}, \mathfrak{d} \theta_{E, E^{\prime}},\right.\right. \\
& \left.\left.\qquad \mathfrak{d}^{2} \phi_{E, E^{\prime}, E^{\prime \prime}}, \mathfrak{d}^{2} \gamma_{E, E^{\prime}, E^{\prime \prime}}, \mathfrak{d}^{2} \theta_{E, E^{\prime}, E^{\prime \prime}}\right)\left.(x)\right|^{s}\right]^{\frac{1}{s}} \lesssim_{s, E, E^{\prime}, E^{\prime \prime}} \mu_{d}(x) . \tag{3.57}
\end{align*}

Yet, for our purposes, we further need corresponding estimates on suprema such as

which is not trivial due to the nonlinear dependence on $E$. As we aim at capturing the best dependence on $\delta$, we cannot appeal to brutal Sobolev estimates as in (3.53). Instead, we
shall take advantage of the above moment estimates (3.57) together with Hypothesis 1.4. More precisely, we decompose

where we compare $\phi_{E}$ to the random field $\phi_{E}^{\infty}$ that is defined via the same corrector problem (2.4) \& (2.5) with the swimming forces $\left\{f_{n}(E)\right\}_{n}$ replaced by their large- $E$ approximations $\left\{f^{\infty}(E) \xi_{n}\right\}_{n}$, cf. Hypothesis 1.4. On the one hand, as $f^{\infty}(E)$ is a deterministic function of $E$, the supremum of $\nabla \phi_{E}^{\infty}$ over $E$ becomes trivial and moment estimates can be established in the following form, for all $s<\infty$,

and thus, using the proof of moment estimates (3.57) together with Hypothesis 1.4 in form of

we deduce for all $s<\infty$ with $s>\left(1 \vee \frac{1}{\gamma}\right) \operatorname{dim} \mathbb{M}_{0}^{\text {sym }}$,

Combining these bounds with (3.58), we deduce for all $s<\infty$,

uniformly with respect to $\delta>0$. This string of arguments allows us to post-process (3.57) into

\mathbb{E}\left[\left|\left(\phi, \gamma, \theta, \mathfrak{d} \phi, \mathfrak{d} \gamma, \mathfrak{d} \theta, \mathfrak{d}^{2} \phi, \mathfrak{d}^{2} \gamma, \mathfrak{d}^{2} \theta\right)(x)\right|^{s}\right]^{\frac{1}{s}} & \lesssim s \mu_{d}(x)
\end{aligned}
$$

Step 3. Conclusion.
In order to capture the best dependence on $\delta$, we need a version of (3.48) where the dependence on $\bar{u}_{\varepsilon}, \chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)$ does not deteriorate in terms of uniform norms. Rather combining (3.25) and (3.43), and choosing $K \geq 1$ large enough, we get

& \quad \quad+\varepsilon^{2} r_{\varepsilon}^{-2} \int_{\partial_{3 r_{\varepsilon} U}}|(\psi, \Upsilon, \phi, \theta, \gamma, \mathfrak{d} \phi, \mathfrak{d} \theta, \mathfrak{d} \gamma)(\dot{\bar{\varepsilon}})|^{2}\left(1+\left|\nabla \bar{u}_{\varepsilon}\right|^{2}+\left|\chi_{\delta} * \mathrm{D}\left(u_{\varepsilon}\right)\right|^{2}\right)
\end{aligned}
$$

$$
\begin{aligned}
& +\varepsilon^{2} \int_{U}\left|\left(1, \psi, \Upsilon, \phi, \mathfrak{d} \phi, \mathfrak{d} \theta, \mathfrak{d} \gamma, \mathfrak{d}^{2} \theta, \mathfrak{d}^{2} \gamma, \Delta^{-1} \nabla \mathbb{1}_{\mathcal{I}}, \Delta^{-1} \nabla \mathfrak{d} F, \Delta^{-1} \nabla \mathfrak{d}^{2} F\right)(\dot{\bar{\varepsilon}})\right|^{2} \\
& \quad \times\left(|\langle\nabla\rangle h|^{2}+\left|\nabla^{2} \bar{u}_{\varepsilon}\right|^{2}+\left|\nabla \bar{P}_{\varepsilon}\right|^{2}\right.

By Proposition 1.6, we have $\left\|\nabla u_{\varepsilon}\right\|_{\mathrm{L}^{2}(U)} \lesssim 1+\|h\|_{\mathrm{L}^{2}(U)}$ and thus, for all $k \geq 0$ and $s \geq 2$,

By the regularity theory for the Stokes equation, using (2.32), we then deduce that the solution $\left(\bar{u}_{\varepsilon}, \bar{P}_{\varepsilon}\right)$ of (3.10) satisfies for all $s \geq 2$ and $\eta>0$,

Inserting these estimates into the above, we get for all $s \geq 1$,

& \quad+\varepsilon^{2} r_{\varepsilon}^{-2}\left(r_{\varepsilon}+\left(r_{\varepsilon} \delta^{-d-\eta}\right) \wedge\left(r_{\varepsilon} \delta^{-d}\right)^{\frac{1}{s}}\right)\left(f_{\partial_{3 r_{\varepsilon}} U}|(\psi, \Upsilon, \phi, \theta, \gamma, \mathfrak{d} \phi, \mathfrak{d} \theta, \mathfrak{d} \gamma)(\dot{\bar{\varepsilon}})|^{2 s}\right)^{\frac{1}{s}} \\
& \quad+\varepsilon^{2} \delta^{-2-d\left(2+\frac{1}{s}\right)}\left(\int_{U} \mid\left(1, \psi, \Upsilon, \nabla \psi, \Sigma \mathbb{1}_{\mathbb{R}^{d} \backslash \mathcal{I}}, \phi, \mathfrak{d} \phi, \nabla \mathfrak{d} \phi, \mathfrak{d} \theta, \mathfrak{d} \Pi \mathbb{1}_{\mathbb{R}^{d} \backslash \mathcal{I}}, \mathfrak{d} \gamma\right.\right. \\
& \left.\left.\quad \mathfrak{d}^{2} \theta, \mathfrak{d}^{2} \gamma, \Delta^{-1} \nabla \mathbb{1}_{\mathcal{I}}, \triangle^{-1} \nabla \mathfrak{d} F, \triangle^{-1} \nabla \mathfrak{d}^{2} F\right)\left.(\dot{\bar{\varepsilon}})\right|^{2 s}\right)^{\frac{1}{s}}
\end{aligned}
$$

where the multiplicative constant depends on the $W^{1, \infty}(U)$ norm of $h$. Hence, taking the expectation and using the corrector estimates of Step 2, we get for all $s<\infty$,

\end{aligned}

Choosing $r_{\varepsilon}:=\varepsilon \mu_{d}\left(\frac{1}{\varepsilon}\right)$, this becomes

$$

As $\varepsilon, \delta \downarrow 0$ in the regime (1.27), we thus get $w_{\varepsilon} \rightarrow 0$ in $\mathrm{L}^{s}\left(\Omega ; H^{1}(U)\right)$ and $Q_{\varepsilon} \rightarrow 0$ in $L^{s}\left(\Omega ; \mathrm{L}^{2}(U)\right)$. Arguing as for Theorem 1.7, and further using the result of Step 1, the conclusion follows.

## 4. Dilute expansion of the effective viscosity

This section is devoted to the proof of Theorem 1.9, that is, the first-order dilute expansion of the effective viscosity $\overline{\boldsymbol{B}}_{\text {tot }}$. We recall that Einstein's formula for the passive contribution was already established in [13] (see also [17, 16, 19, 18]), in form of

We split the proof into four steps.
Step 1. Periodic approximation.
Define a periodized version $\mathcal{P}_{L}$ of the point process $\mathcal{P}=\left\{x_{n}\right\}_{n}$ on the cube $Q_{L}:=\left[-\frac{L}{2}, \frac{L}{2}\right)^{d}$,

For notational convenience, we choose an enumeration $\mathcal{P}_{L}:=\left\{x_{n, L}\right\}_{n}$ and we set $I_{n, L}:=$ $x_{n, L}+I_{n, L}^{\circ}$. By definition, under Hypothesis 1.1, for all $L$, the periodized random set $\mathcal{I}_{L}+L \mathbb{Z}^{d}$ satisfies the same regularity and hardcore conditions as in Hypothesis 1.1. Moreover, we emphasize the stabilization property $\left.\mathcal{P}_{L}\right|_{Q_{L-4}}=\left.\mathcal{P}\right|_{Q_{L-4}}$. Next, we define $\psi_{E ; L} \in \mathrm{~L}^{2}\left(\Omega ; H_{\mathrm{per}}^{1}\left(Q_{L}\right)^{d}\right)$ as the unique almost sure solution of the periodic version of (2.1),

It is easily checked that the map $\overline{\boldsymbol{B}}_{\text {act }}$ defined in (1.26) can be reformulated as

We start by decomposing

E^{\prime}: 2 \overline{\boldsymbol{B}}_{\mathrm{act} ; L}(E)=E^{\prime}: \overline{\boldsymbol{B}}_{\mathrm{act} ; L}^{(1)}(E)+E^{\prime}: R_{1 ; L}(E)+E^{\prime}: R_{2 ; L}(E) \tag{4.4}
\end{equation*}
$$

where we have set

$$
E^{\prime}: \overline{\boldsymbol{B}}_{\mathrm{act} ; L}^{(1)}(E):=-L^{-d} \mathbb{E}\left[\sum_{n} \int_{I_{n, L}+B}\left(\psi_{E^{\prime} ; L}^{n}+E^{\prime}\left(x-x_{n, L}\right)\right) \cdot f_{n, L}(E)\right],
$$

and where the remainders $R_{1 ; L}(E), R_{2 ; L}(E)$ are given by

$$
\begin{aligned}
& E^{\prime}: R_{1 ; L}(E):=-L^{-d} \mathbb{E}\left[\sum_{n \neq m} \int_{I_{n, L}+B} \psi_{E^{\prime} ; L}^{m} \cdot f_{n, L}(E)\right], \\
& E^{\prime}: R_{2 ; L}(E):=-L^{-d} \mathbb{E}\left[\sum_{n} \int_{I_{n, L}+B}\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right) \cdot f_{n, L}(E)\right],
\end{aligned}
$$

in terms of the solution $\psi_{E^{\prime} ; L}^{n}$ of the single-particle periodized problem

$$
\begin{cases}-\triangle \psi_{E ; L}^{n}+\nabla \Sigma_{E ; L}^{n}=0, & \text { in } Q_{L} \backslash I_{n, L},  \tag{4.5}\\ \operatorname{div}\left(\psi_{E ; L}^{n}\right)=0, & \text { in } Q_{L} \backslash I_{n, L}, \\ \mathrm{D}\left(\psi_{E ; L}^{n}+E x\right)=0, & \text { in } I_{n, L}, \\ f_{\partial I_{n, L}} \sigma\left(\psi_{E ; L}^{n}+E x, \Sigma_{E ; L}^{n}\right) \nu=0, & \forall n, \\ f_{\partial I_{n, L}} \Theta\left(x-\varepsilon x_{n, L}\right) \cdot \sigma\left(\psi_{E ; L}^{n}+E x, \Sigma_{E ; L}^{n}\right) \nu=0, & \forall n, \forall \Theta \in \mathbb{M}^{\text {skew }}\end{cases}
$$

Step 2. Proof that

$$
\begin{equation*}
\left|R_{1 ; L}\right| \lesssim \lambda_{2}\left(\left|\log \lambda_{1}\right|+\frac{\log L}{L}\right) . \tag{4.6}
\end{equation*}
$$

As by assumption the point process is independent of particles' shapes and swimming forces, we can write, in terms of the two-point intensity $g_{2}$, cf. (1.29),

$$
E^{\prime}: R_{1 ; L}(E)=-L^{-d} \iint_{Q_{L-4} \times Q_{L-4}} \mathbb{E}\left[\int_{Q_{L}} \psi_{E^{\prime} ; L}^{\circ}(\cdot+x-y) \cdot \tilde{f}^{\circ}(E)\right] g_{2}(x, y) d x d y
$$

where $\tilde{f}^{\circ}$ is an iid copy of $f^{\circ}$, hence independent of $\psi_{E^{\prime} ; L^{\prime}}^{\circ}$. Noting that the periodicity of $\psi_{E^{\prime} ; L}^{\circ}$ yields

$$
\begin{equation*}
\int_{Q_{L}}\left(\int_{Q_{L}} \psi_{E^{\prime} ; L}^{\circ}(\cdot+x-y) \cdot \tilde{f}^{\circ}(E)\right) d x=0 \tag{4.7}
\end{equation*}
$$

we can replace the two-point density $g_{2}$ by the correlation function $h_{2}=g_{2}-\lambda_{1}^{2}$, to the effect of

$$
\begin{aligned}
E^{\prime}: R_{1 ; L}(E)= & -L^{-d} \iint_{Q_{L \times Q_{L-4}}} \mathbb{E}\left[\int_{Q_{L}} \psi_{E^{\prime} ; L}^{\circ}(\cdot+x-y) \cdot \tilde{f}^{\circ}(E)\right] h_{2}(x, y) d x d y \\
& +L^{-d} \iint_{\left(Q_{L} \backslash Q_{L-4}\right) \times Q_{L-4}} \mathbb{E}\left[\int_{Q_{L}} \psi_{E^{\prime} ; L}^{\circ}(\cdot+x-y) \cdot \tilde{f}^{\circ}(E)\right] g_{2}(x, y) d x d y .
\end{aligned}
$$

The neutrality condition (1.9) entails

$$
\left|\int_{Q_{L}} \psi_{E^{\prime} ; L}^{\circ}(\cdot+x-y) \cdot \tilde{f}^{\circ}(E)\right| \lesssim\langle E\rangle\left(\int_{2 B}\left|\nabla \psi_{E^{\prime} ; L}^{\circ}(\cdot+x-y)\right|^{2}\right)^{\frac{1}{2}},
$$

and thus, using standard decay estimates, see e.g. [13, Lemma 4.2],

$$
\left|\int_{Q_{L}} \psi_{E^{\prime} ; L}^{\circ}(\cdot+x-y) \cdot \tilde{f}^{\circ}(E)\right| \lesssim\langle E\rangle\langle x-y\rangle^{-d}
$$

The above then becomes

$$
\begin{aligned}
&\left|R_{1 ; L}\right| \lesssim L^{-d} \iint_{Q_{L} \times Q_{L}}\langle x-y\rangle^{-d}\left|h_{2}(x, y)\right| d x d y \\
&+L^{-d} \iint_{\left(Q_{L} \backslash Q_{L-4}\right) \times Q_{L}}\langle x-y\rangle^{-d} g_{2}(x, y) d x d y
\end{aligned}
$$

The definition of two-point intensity (1.30) and the decay of correlations (1.31) yield

$$
\begin{gathered}
\left|h_{2}\left(x^{\prime}, y^{\prime}\right)\right| \lesssim\left(\lambda_{1}^{2}+g_{2}(x, y)\right) \wedge\langle x-y\rangle^{-\gamma} \\
g_{2}(x, y)=g_{2}(x, y) \mathbb{1}_{|x-y| \geq 2 \ell} \\
f_{B_{\ell}(x) \times B_{\ell}(y)} g_{2}\left(x^{\prime}, y^{\prime}\right) d x^{\prime} d y^{\prime} \lesssim \lambda_{2}
\end{gathered}
$$

and the claim (4.6) easily follows.
Step 3. Proof that

$$
\begin{equation*}
\left|R_{2 ; L}\right| \lesssim\left(\lambda_{1}\right)^{\frac{1}{2}}\left(\lambda_{2}+\lambda_{3}\left|\log \lambda_{1}\right|\right)^{\frac{1}{2}} . \tag{4.8}
\end{equation*}
$$

We start by decomposing

$$
\begin{align*}
E^{\prime}: R_{2 ; L}(E) & =-L^{-d} \mathbb{E}\left[\sum_{n} \int_{\left(I_{n, L}+B\right) \backslash I_{n, L}}\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right) \cdot f_{n, L}(E)\right]  \tag{4.9}\\
& +L^{-d} \mathbb{E}\left[\sum_{n} \int_{\partial I_{n, L}}\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right) \cdot \sigma\left(\phi_{E ; L}, \Pi_{E ; L}\right) \nu\right] \\
-L^{-d} \mathbb{E}[ & \left.\sum_{n} \int_{I_{n, L}+B}\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right) \cdot\left(f_{n, L}(E) \mathbb{1}_{I_{n, L}}+\delta_{\partial I_{n, L}} \sigma\left(\phi_{E ; L}, \Pi_{E ; L}\right) \nu\right)\right] .
\end{align*}
$$

The first two terms can be recovered in the weak formulation of the equation for $\phi_{E ; L}$ (periodized version of (2.4) as in (4.2)), when tested with $\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}$,

$$
\begin{aligned}
& -L^{-d} \mathbb{E}\left[\sum_{n} \int_{\left(I_{n, L}+B\right) \backslash I_{n, L}}\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right) \cdot f_{n, L}(E)\right] \\
& \quad+L^{-d} \mathbb{E}\left[\sum_{n} \int_{\partial I_{n, L}}\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right) \cdot \sigma\left(\phi_{E ; L}, \Pi_{E ; L}\right) \nu\right] \\
& =-\int_{Q_{L}} \nabla \phi_{E ; L}: \nabla\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right)
\end{aligned}
$$

and thus, similarly testing the equation for $\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}$ with $\phi_{E ; L}$, using boundary conditions and the rigidity condition for $\phi_{E ; L}$ in $\mathcal{I}_{L}$,

$$
\begin{aligned}
-L^{-d} \mathbb{E}\left[\sum_{n} \int_{\left(I_{n, L}+B\right) \backslash I_{n, L}}\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right) \cdot f_{n, L}(E)\right] \\
+L^{-d} \mathbb{E}\left[\sum_{n} \int_{\partial I_{n, L}}\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right) \cdot \sigma\left(\phi_{E ; L}, \Pi_{E ; L}\right) \nu\right]=0 .
\end{aligned}
$$

Next, using boundary conditions for $\phi_{E ; L}$, noting that $\psi_{E^{\prime} ; L}-\psi_{E^{\prime} ; L}^{n}$ is rigid in $I_{n, L}$, the last term in (4.9) can be rewritten as

$$
-L^{-d} \mathbb{E}\left[\sum_{n} \int_{I_{n, L}+B}\left(\psi_{E^{\prime} ; L}-\sum_{m} \psi_{E^{\prime} ; L}^{m}\right) \cdot\left(f_{n, L}(E) \mathbb{1}_{I_{n, L}}+\delta_{\partial I_{n, L}} \sigma\left(\phi_{E ; L}, \Pi_{E ; L}\right) \nu\right)\right]
$$

$$
=L^{-d} \mathbb{E}\left[\sum_{n \neq m} \int_{I_{n, L}+B} \psi_{E^{\prime} ; L}^{m} \cdot\left(f_{n, L}(E) \mathbb{1}_{I_{n, L}}+\delta_{\partial I_{n, L}} \sigma\left(\phi_{E ; L}, \Pi_{E ; L}\right) \nu\right)\right] .
$$

Inserting these identities into (4.9), we get

$$
E^{\prime}: R_{2 ; L}(E)=L^{-d} \mathbb{E}\left[\sum_{n \neq m} \int_{I_{n, L}+B} \psi_{E^{\prime} ; L}^{m} \cdot\left(f_{n, L}(E) \mathbb{1}_{I_{n, L}}+\delta_{\partial I_{n, L}} \sigma\left(\phi_{E ; L}, \Pi_{E ; L}\right) \nu\right)\right]
$$

Using boundary conditions for $\phi_{E ; L}$ to replace $\psi_{E^{\prime} ; L}^{m}$ by $\psi_{E^{\prime} ; L}^{m}-f_{I_{n, L}} \psi_{E^{\prime} ; L}^{m}$, using the Poincaré inequality, and a trace estimate, this can be estimated as

$$
\begin{aligned}
\left|E^{\prime}: R_{2 ; L}(E)\right| \lesssim \mathbb{E}\left[L^{-d}\right. & \left.\sum_{n} \int_{I_{n, L}+B}\left|\sum_{m: m \neq n} \nabla \psi_{E^{\prime} ; L}^{m}\right|^{2}\right]^{\frac{1}{2}} \\
& \times \mathbb{E}\left[L^{-d} \sum_{n} \int_{I_{n, L}+B}\left|f_{n, L}(E)\right|^{2}+L^{-d} \sum_{n} \int_{I_{n, L}+B}\left|\nabla \phi_{E ; L}\right|^{2}\right]^{\frac{1}{2}} .
\end{aligned}
$$

Taking advantage of explicit renormalizations as in [13, Section 4.4], the first factor can easily be estimated by

$$
\mathbb{E}\left[L^{-d} \sum_{n} \int_{I_{n, L}+B}\left|\sum_{m: m \neq n} \nabla \psi_{E^{\prime} ; L}^{m}\right|^{2}\right] \lesssim\left(\lambda_{2}+\lambda_{3}\left|\log \lambda_{1}\right|\right)\left|E^{\prime}\right|^{2}
$$

Further noting that

$$
\begin{equation*}
\mathbb{E}\left[L^{-d} \sum_{n} \int_{I_{n, L}+B}\left|f_{n, L}(E)\right|^{2}\right] \lesssim \lambda_{1} \int_{2 B}\left|f_{\circ}(E)\right|^{2} \lesssim \lambda_{1}\langle E\rangle^{2} \tag{4.10}
\end{equation*}
$$

and using the hardcore condition, we deduce

$$
\begin{equation*}
\left|R_{2 ; L}(E)\right| \lesssim\left(\lambda_{2}+\lambda_{3}\left|\log \lambda_{1}\right|\right)^{\frac{1}{2}}\left(\lambda_{1}\langle E\rangle^{2}+\mathbb{E}\left[f_{Q_{L}}\left|\nabla \phi_{E ; L}\right|^{2}\right]\right)^{\frac{1}{2}} \tag{4.11}
\end{equation*}
$$

It remains to estimate the last integral: starting from the energy identity for $\phi_{E ; L}$,

$$
\int_{Q_{L}}\left|\nabla \phi_{E ; L}\right|^{2}=\sum_{n} \int_{I_{n, L}+B} \phi_{E ; L} \cdot f_{n, L}(E)
$$

and using boundary conditions and the Poincaré inequality to estimate the right-hand side, we find

$$
\int_{Q_{L}}\left|\nabla \phi_{E ; L}\right|^{2} \lesssim\left(\sum_{n} \int_{I_{n, L}+B}\left|f_{n, L}(E)\right|^{2}\right)^{\frac{1}{2}}\left(\sum_{n} \int_{I_{n, L}+B}\left|\nabla \phi_{E ; L}\right|^{2}\right)^{\frac{1}{2}}
$$

Hence, using the hardcore condition, absorbing the last factor, taking the expectation, and combining with (4.10), we obtain

$$
\mathbb{E}\left[f_{Q_{L}}\left|\nabla \phi_{E ; L}\right|^{2}\right] \lesssim \mathbb{E}\left[L^{-d} \sum_{n} \int_{I_{n, L}+B}\left|f_{n, L}(E)\right|^{2}\right] \lesssim \lambda_{1}\langle E\rangle^{2}
$$

Inserting this into (4.11), the claim (4.8) follows.
Step 4. Conclusion.
In view of Steps 1,2 and 3 , it remains to examine the limit of the main term $\overline{\boldsymbol{B}}_{\text {act } ; L}^{(1)}$ in (4.4).

As by assumption the point process $\left\{x_{n}\right\}$ is independent of particles' shapes and swimming forces, we can write

$$
E^{\prime}: \overline{\boldsymbol{B}}_{\mathrm{act} ; L}^{(1)}(E)=-\lambda_{1} L^{-d}\left|Q_{L-4}\right| \mathbb{E}\left[\int_{2 B}\left(\psi_{E^{\prime} ; L}^{\circ}+E^{\prime} x\right) \cdot f^{\circ}(E)\right]
$$

and thus, as $L \uparrow \infty$,

$$
\lim _{L \uparrow \infty} E^{\prime}: \overline{\boldsymbol{B}}_{\mathrm{act} ; L}^{(1)}(E)=-\lambda_{1} \mathbb{E}\left[\int_{2 B}\left(\psi_{E^{\prime}}^{\circ}+E^{\prime} x\right) \cdot f^{\circ}(E)\right]
$$

in terms of the solution $\psi_{E^{\prime}}^{\circ}$ of the whole-space single-particle problem (1.33). In case of spherical particles, $I^{\circ}=B$, the latter is explicitly solvable, cf. [22, Section 2.1.3],

$$
\psi_{E^{\prime}}^{\circ}(x)= \begin{cases}-E^{\prime} x & :|x| \leq 1 \\ -\frac{d+2}{2} \frac{\left(x \cdot E^{\prime} x\right) x}{|x|^{d+2}}\left(1-\frac{1}{|x|^{2}}\right)-\frac{E^{\prime} x}{|x|^{d+2}} & :|x|>1\end{cases}
$$

and the conclusion follows.
