# NEAR-OPTIMAL RESTRICTION ESTIMATES FOR CANTOR SETS ON THE PARABOLA

#### Abstract

For any $0<\alpha<1$, we construct Cantor sets on the parabola of Hausdorff dimension $\alpha$ such that they are Salem sets and each associated measure $\nu$ satisfies the estimate $\|\widehat{f d \nu}\|_{L^{p}\left(\mathbb{R}^{2}\right)} \leq C_{p}\|f\|_{L^{2}(\nu)}$ for all $p>6 / \alpha$ and for some constant $C_{p}>0$ which may depend on $p$ and $\nu$. The range $p>6 / \alpha$ is optimal except for the endpoint. The proof is based on the work of Laba and Wang on restriction estimates for random Cantor sets and the work of Shmerkin and Suomala on Fourier decay of measures on random Cantor sets. They considered fractal subsets of $\mathbb{R}^{d}$, while we consider fractal subsets of the parabola.


## 1. Introduction

Given $f: \mathbb{R}^{d} \rightarrow \mathbb{C}$, the Fourier transform of $f$ is defined by

$$
\widehat{f}(\xi)=\int_{\mathbb{R}^{d}} f(x) e^{-2 \pi i x \cdot \xi} d x \quad \forall \xi \in \mathbb{R}^{d}
$$

Let $\mu$ be a compactly supported measure on $\mathbb{R}^{d}$. If $f$ is $\mu$-integrable, $\widehat{f d \mu}$ is defined by

$$
\widehat{f d \mu}(\xi)=\int f(x) e^{-2 \pi i x \cdot \xi} d \mu(x) \quad \forall \xi \in \mathbb{R}^{d}
$$

We consider a Borel probability measure $\mu$ in $\mathbb{R}^{d}$ and assume that it satisfies the estimate

$$
\begin{equation*}
\|\widehat{f d \mu}\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq C_{p}\|f\|_{L^{2}(\mu)} \quad \forall f \in L^{2}(\mu) \tag{1.1}
\end{equation*}
$$

for some constant $C_{p}$ which depends on $p$. It is easy to show that (1.1) holds when $p=\infty$. However, we can say more if we focus on more specific measures. One typical example is a surface carried measure on the sphere or on the paraboloid. Then, (1.1) holds when $p \geq 2(d+1) /(d-1)$ and the range of $p$ is sharp. This is the result of the Stein-Tomas theorem (see for example [24]).

Let $B(x, r)$ be a closed ball of radius $r$ centered at $x$. If we have assumptions on the Fourier decay of $\mu$ and the upper bound of $\mu(B(x, r))$, the following result generalizes the Stein-Tomas theorem.
Theorem 1.1. Let $\mu$ be a Borel probability measure on $\mathbb{R}^{d}$. Assume that there exist $\alpha, \beta \in$ $(0, d)$ and $C_{1}, C_{2} \geq 0$ such that

$$
\begin{gather*}
\mu(B(x, r)) \leq C_{1} r^{\alpha} \quad \forall x \in \mathbb{R}^{d}, r>0  \tag{1.2}\\
|\widehat{\mu}(\xi)| \leq C_{2}(1+|\xi|)^{-\beta / 2} \quad \forall \xi \in \mathbb{R}^{d} . \tag{1.3}
\end{gather*}
$$

Then, the estimate (1.1) holds when $p \geq(4 d-4 \alpha+2 \beta) / \beta$ for some constant $C_{p} \geq 0$ which depends on $p, C_{1}$ and $C_{2}$.

[^0]Mockenhaupt [21] and Mitsis [19] proved that (1.1) holds when $p>(4 d-4 \alpha+2 \beta) / \beta$ and the endpoint result was proved by Bak and Seeger [1]. If $\mu$ is a surface carried measure on the paraboloid, $\alpha=\beta=d-1$. Thus, Theorem 1.1 recovers the range $p \geq 2(d+1) /(d-1)$.

Define the critical exponent $p_{c}$ of the measure $\mu$ by

$$
p_{c}=\inf \{p:(1.1) \text { holds }\}
$$

Theorem 1.1 means $p_{c} \leq(4 d-4 \alpha+2 \beta) / \beta$. This upper bound of $p_{c}$ is known to be optimal when $d-1<\beta \leq \alpha<d$ in the sense that there exists a measure $\mu$ such that it satisfies the assumptions of Theorem 1.1 and $p_{c}=(4 d-4 \alpha+2 \beta) / \beta$. When $d=1$, Hambrook and Łaba [10] constructed a measure such that (1.3) holds for any $\beta$ arbitrarily close to but smaller than $\alpha$ and $p_{c}=(4-2 \alpha) / \alpha$. Chen [6] extended this result to general $\alpha$ and $\beta$ such that $0 \leq \beta \leq \alpha \leq 1$. In higher dimensions, it was done in 11 by Hambrook and Łaba.

However, there exist some measures $\mu$ such that $p_{c}<(4 d-4 \alpha+2 \beta) / \beta$. In [10], Hambrook and Łaba showed that $p_{c} \geq 2 d / \alpha_{0}$ if $\mu$ is supported on a set of Hausdorff dimension $\alpha_{0}$. Note that $0 \leq \alpha, \beta \leq \alpha_{0}$. If (1.2) and (1.3) hold for values arbitrarily close to $\alpha_{0}$, the support of $\mu$ is called a Salem set. If $0<\alpha_{0}<d$, we have

$$
\frac{2 d}{\alpha_{0}}<\frac{4 d-2 \alpha_{0}}{\alpha_{0}} \leq \frac{4 d-4 \alpha+2 \beta}{\beta}
$$

Thus, $2 d / \alpha_{0}$ is smaller than $(4 d-4 \alpha+2 \beta) / \beta$ even when $\mu$ is supported on a Salem set. Examples such that $p_{c}=2 d / \alpha_{0}$ were provided by Chen [5], Chen and Seeger [7], Shmerkin and Suomala [23] (see also [22]) and Laba and Wang [15]. Therefore, the lower bound of $p_{c}$ is optimal for all $0<\alpha_{0}<d$ in the sense that there exists a measure $\mu$ whose $p_{c}=2 d / \alpha_{0}$ for each $\alpha_{0}$.

In [5] and [7], Chen and Seeger constructed measures supported on a Salem set of Hausdorff dimension $\alpha_{0}$ such that $p_{c}=2 d / \alpha_{0}$ where $\alpha_{0}=d / k$ and $k$ is an integer. They considered $k$-fold self-convolution of $\mu$. Shmerkin and Suomala [23] constructed the example through random fractal measures. Their result covers when $d=1$ and $1 / 2<\alpha_{0}<1$. Łaba and Wang [15] constructed measures of Hausdorff dimension $\alpha_{0}$ such that (1.3) holds for $\beta<$ $\min \left(\alpha_{0} / 2,1\right)$ and $p_{c}=2 d / \alpha_{0}$. They used $\Lambda(p)$-set and decoupling. Their construction works for all $\alpha_{0}$ such that $0<\alpha_{0}<d$. However, in their result, the estimate (1.1) only holds when $p>2 d / \alpha_{0}$, while the results of Chen, Chen-Seeger, and Shmerkin-Suomala work even at the endpoint. Thus, it is still open whether, for any $0<\alpha_{0}<d$, there exists a measure $\mu$ such that its support has Hausdorff dimension $\alpha_{0}$ and (1.1) holds for $p=2 d / \alpha_{0}$.

We also mention that all the results are related to a question raised by Mitsis [20] (see also Mattila [17]). If $\alpha$ is not an integer such that $0<\alpha<d$, Mitsis asked if there is a compactly supported measure $\mu$ such that

$$
C_{1} r^{\alpha} \leq \mu(B(x, r)) \leq C_{2} r^{\alpha} \quad \forall x \in \operatorname{supp}(\mu), \forall r>0
$$

for some constants $C_{1}, C_{2}>0$ and

$$
|\widehat{\mu}(\xi)| \leq|\xi|^{-\alpha / 2} \quad \forall \xi \in \mathbb{R}^{d}
$$

A related result can also be found in [14. However, there is no known result yet, including this paper, since we have $|\widehat{\mu}(\xi)| \leq C_{\alpha, \epsilon}|\xi|^{-\alpha / 2+\epsilon}$ at best where $C_{\alpha, \epsilon}$ is a constant depends on $\alpha$ and $\epsilon$.

Throughout the paper, we denote by $X \lesssim Y$ when $X \leq C Y$ for some constant $C>0$ and we write $X \approx Y$ to denote that $X \lesssim Y$ and $Y \lesssim X$. If the constant $C$ depends on a parameter such as $\epsilon$, we write $X(\epsilon) \lesssim \epsilon Y(\epsilon)$ instead of $X(\epsilon) \leq C(\epsilon) Y(\epsilon)$ where the constant $C(\epsilon)$ depends on $\epsilon$. Depending on the context, $|\cdot|$ denotes the $\ell^{2}$ norm of a vector in $\mathbb{R}^{d}$,
the cardinality of a finite set or the $d$-dimensional Lebesgue measure of a subset in $\mathbb{R}^{d}$. We abbreviate $e^{2 \pi i x}$ to $e(x)$.

Now, let us turn to our setting. Earlier works constructed fractal measures on $\mathbb{R}^{d}$, but we consider fractal measures on the parabola $\mathbb{P}^{1}:=\left\{\left(x, x^{2}\right): 0 \leq x \leq 1\right\}$.
Theorem 1.2. Let $0<\alpha<1$. There exists a Borel probability measure $\nu$ supported on a subset of $\mathbb{P}^{1}$ which satisfies the following.
(1) The support of the measure $\nu$ has Hausdorff dimension $\alpha$.
(2) For any $0<\epsilon<\alpha$, we have

$$
\begin{equation*}
\nu(B(x, r)) \lesssim \lesssim_{\alpha, \epsilon} r^{\alpha-\epsilon} \quad \forall x \in \mathbb{R}^{2}, \forall r>0 . \tag{1.4}
\end{equation*}
$$

(3) For any $\epsilon>0$,

$$
\begin{equation*}
|\widehat{\nu}(\xi)| \lesssim_{\alpha, \epsilon}(1+|\xi|)^{-\alpha / 2+\epsilon} \quad \forall \xi \in \mathbb{R}^{2} . \tag{1.5}
\end{equation*}
$$

(4) For every $p>6 / \alpha$, we have the estimate

$$
\begin{equation*}
\|\widehat{f d \nu}\|_{L^{p}\left(\mathbb{R}^{2}\right)} \lesssim_{p}\|f\|_{L^{2}(\nu)} \quad \forall f \in L^{2}(\nu) \tag{1.6}
\end{equation*}
$$

Equivalently, for any $1 \leq q<6 /(6-\alpha)$ we have

$$
\|\widehat{f}\|_{L^{2}(\nu)} \lesssim_{q}\|f\|_{L^{q}\left(\mathbb{R}^{2}\right)} \quad \forall f \in L^{q}\left(\mathbb{R}^{2}\right) .
$$

Note that the support of $\nu$ is a Salem set and it is a subset of the parabola, which is also a Salem set. Theorem 1.2 is sharp except for the endpoint in the following sense.
Theorem 1.3. Let $\mathbb{P}^{d-1}:=\left\{\left(x,|x|^{2}: x \in[0,1]^{d-1}\right\}\right.$ and $0<\alpha<d-1$. Assume that $\nu$ is a Borel probability measure supported on a subset of $\mathbb{P}^{d-1}$ whose Hausdorff dimension is $\alpha$. Assume that

$$
\begin{equation*}
\nu(B(x, r)) \lesssim \alpha r^{\alpha} \quad \forall x \in \mathbb{P}^{d-1}, \forall r>0 . \tag{1.7}
\end{equation*}
$$

Then, the estimate

$$
\begin{equation*}
\|\widehat{f d \nu}\|_{L^{p}\left(\mathbb{R}^{2}\right)} \lesssim_{p, q}\|f\|_{L^{q}(\nu)} \quad \forall f \in L^{q}(\nu) \tag{1.8}
\end{equation*}
$$

cannot hold if $p<q^{\prime}(d+1) / \alpha$ where $1 / q+1 / q^{\prime}=1$.
When $d=2$ and $q=2$, Theorem 1.3 implies that $p_{c} \geq 6 / \alpha$. Since $\nu$ is on the parabola, the lower bound of $p_{c}$ increased from $4 / \alpha$ to $6 / \alpha$ compared with the result of Hambrook and Laba [10]. Also, since $0<\alpha<1$, we have $6 / \alpha<(8-2 \alpha) / \alpha$. Thus, it is smaller than the upper bound of $p_{c}$ obtained from Theorem 1.1.
1.1. Outline of the paper. The proof was inspired by the work of Laba and Wang [15], but we cannot apply it directly. The main obstacle is that we cannot make use of dual cubes as in [15]. For example, they considered a Cantor set which can be covered by $R^{\alpha+\epsilon}$ number of cubes $Q$ of side length $R^{-1}$ for any $R>0$. Let $\psi_{Q}=\psi\left(R\left(x-x_{Q}\right)\right)$ where $\psi$ is a compactly supported Schwartz function and $x_{Q}$ is the center of $Q$. For any $Q, \widehat{\psi_{Q}}$ is essentially supported on a cube of side length $O(R)$ centered at the origin.

Now, let us consider a subset of the parabola as follows. First, consider a Cantor set on $[0,1]$ which can be covered by $R^{\alpha+\epsilon}$ number of intervals $I$ of length $R^{-1 / 2}$. Then, we can consider a parallelogram $\Omega_{I}$ of sides $O\left(R^{-1 / 2}\right)$ and $O\left(R^{-1}\right)$ which contains the subset of the parabola above $I$, i.e. $\left\{\left(x, x^{2}\right): x \in I\right\} \subseteq \Omega_{I}$. Let $\psi_{\Omega_{I}}$ be a Schwartz function supported on $\Omega_{I}$. Specifically,

$$
\psi_{\Omega_{I}}=\psi\left(R^{1 / 2}\left(x_{1}-x_{I}\right), R\left(x_{2}-\left(2 x_{I}+R^{-1 / 2}\right)\left(x_{1}-x_{I}\right)-x_{I}^{2}\right)\right)
$$

where $x_{I}$ is the center of $I$. Then, $\widehat{\psi_{\Omega_{I}}}$ is essentially supported on a parallelogram of sides $O\left(R^{1 / 2}\right)$ and $O(R)$. However, the directions of long sides of them are all different, so that they overlap in a small cube of side $O\left(R^{1 / 2}\right)$, while the union of these parallelograms is a cube of side $O(R)$. Thus, we need new arguments in addition to the modifications of the proof in [15].

In Section 2, we construct a Cantor set on $[0,1]$ by using $\Lambda(p)$-sets and consider the associated measure which is supported on a subset of parabola above the Cantor set. Let $\nu$ be the measure constructed in Section 2. Then $\nu$ is supported on a set of Hausdorff dimension $\alpha$ and satisfies (1.4). In Section 3, we obtain the decoupling inequality for the support of $\nu$. We use $\Lambda(p)$-sets and the result of [4]. In Section[4, we obtain the local restriction estimate for $\nu$, which is an analogue of Corollary 2 in [15]. However, we use the mixed norm interpolation [2] in addition to the argument in [15]. In Section [5] we obtain the Fourier decay of $\nu$. We only need a negative exponent to derive (1.6), but it turned out that almost surely $\nu$ has the Fourier decay arbitrary close to the optimal one, as in (1.5). We use the arguments in [13] and [22] in our setting. The local restriction estimate and the Fourier decay lead to the global restriction estimate in Section 6, which is (1.6). Tao's epsilon removal lemma [27] is used as in [15], but we simplify the proof of Lemma 9 in [15] in order to avoid the problem we described above. Then, we prove that Theorem 1.2 happens almost surely if $\nu$ is a random measure constructed in Section 6. Lastly, we prove Theorem 1.3 in Section 7

## 2. The construction of a Cantor set

Let $\left\{n_{j}\right\}_{j \in \mathbb{N} \cup\{0\}}$ be a sequence of positive integers, and let $N_{j}=n_{0} \cdots n_{j}$. We assume the following conditions on $n_{j}$.

$$
\begin{gather*}
n_{0}=1 \quad \text { and } \quad 2 \leq n_{1} \leq n_{2} \leq \cdots \leq n_{j} \leq \cdots,  \tag{2.1}\\
\forall a>0, a^{j} \lesssim a N_{j},  \tag{2.2}\\
\forall \epsilon>0 \text { and } \forall j \in \mathbb{N}, n_{j+1} \lesssim_{\epsilon} N_{j}^{\epsilon},  \tag{2.3}\\
\exists B \text { such that } \forall j \in \mathbb{N}, N_{2 j}^{1 / 2} N_{j}^{-1} \leq B^{j} \tag{2.4}
\end{gather*}
$$

For example, if $n_{j} \approx j$, all conditions from (2.1) to (2.4) are satisfied by Stirling's formula (see [9, p. 98]). The condition (2.4) was not assumed in [15, but it is necessary in Sections 3 and 4. We need the following theorem in order to use $\Lambda(p)$-sets.

Theorem 2.1 (Existence of $\Lambda(p)$-sets). Let $p>2$. For every $N \in \mathbb{N}$, there exists a set $S \subset\{0,1,2, \cdots, N-1\}$ such that $N^{2 / p} \leq|S|<N^{2 / p}+1$ and

$$
\begin{equation*}
\left\|\sum_{a \in S} c_{a} e(a x)\right\|_{L^{p}([0,1])} \leq C_{p}\left(\sum_{a \in S}\left|c_{a}\right|^{2}\right)^{1 / 2} \quad \forall\left\{c_{a}\right\}_{a \in S} \in \ell^{2} \tag{2.5}
\end{equation*}
$$

for some constant $C_{p}>0$ which depends only on $p$, but not on $N$.

Theorem 2.1 was first proved by Bourgain [3 and another proof was given by Talagrand [25], see also [26, Section 19.3] for simpler proof.

Let $0<\alpha<1$ and for each $j \in \mathbb{N}$, let $\left\{t_{j}\right\}_{\mathbb{N}}$ be a sequence of integers such that

$$
n_{j}^{\alpha / 2} \leq t_{j}<n_{j}^{\alpha / 2}+1 .
$$

Define

$$
\Sigma_{j}:=\left\{S \subset\left[0, n_{j}^{1 / 2}\right) \cap \mathbb{Z}:|S|=t_{j} \text { and (2.5) holds for } p=2 / \alpha, N=n_{j}^{1 / 2}\right\}
$$

The set $\Sigma_{j}$ is non-empty because of Theorem 2.1.
Let $E_{0}=[0,1]$ and $A_{0}=\{0\}$. For each $a \in A_{j}$, choose a set $S_{j+1, a} \in \Sigma_{j+1}$ and let

$$
A_{j+1, a}=n_{j+1}^{1 / 2} a+S_{j+1, a} \quad A_{j+1}=\cup_{a \in A_{j}} A_{j+1, a} \quad E_{j+1}=N_{j+1}^{-1 / 2}\left(A_{j+1}+[0,1]\right)
$$

The set $A_{j}$ is a subset of $\left\{0,1,2, \cdots, N_{j}^{1 / 2}-1\right\}$ and $[0,1] \supseteq E_{1} \supseteq \cdots \supseteq E_{j} \supseteq E_{j+1}$. Let $E_{\infty}:=\cap_{j=1}^{\infty} E_{j}$. Similarly, let $P_{j}:=\left\{\left(x_{1}, x_{1}^{2}\right): x_{1} \in E_{j}\right\}$ and $P_{\infty}:=\cap_{j=1}^{\infty} P_{j}$.

For each $j \in \mathbb{N} \cup\{0\}$, we define

$$
\mu_{j}:=\frac{1}{\left|E_{j}\right|} \mathbf{1}_{E_{j}}\left(x_{1}\right), \quad x_{1} \in \mathbb{R}
$$

We identify the function $\mu_{j}$ with the absolutely continuous measure $\mu_{j} d x_{1}$ so that

$$
\int g d \mu_{j}:=\int g \mu_{j} d x_{1}
$$

From $\mu_{j}$, we define the measure $\nu_{j}$ as follows.

$$
\int f d \nu_{j}:=\int f\left(x_{1}, x_{1}^{2}\right) d \mu_{j} .
$$

For simplicity, define $\left\|\mu_{j}\right\|:=\mu_{j}(\mathbb{R})$ and $\left\|\nu_{j}\right\|:=\nu_{j}\left(\mathbb{R}^{2}\right)$. The measures $\mu_{j}$ and $\nu_{j}$ converge weakly as $j \rightarrow \infty$ to probability measures $\mu$ and $\nu$ supported on $E_{\infty}$ and $P_{\infty}$ respectively.

Lemma 2.2 (Lemma 6, [15). The measure $\mu$ and the set $E_{\infty}$ constructed above satisfy the following.
(1) The set $E_{\infty}$ has Hausdorff dimension $\alpha$.
(2) For any $0<\epsilon<\alpha$, we have

$$
\mu(B(x, r)) \lesssim_{\alpha, \epsilon} r^{\alpha-\epsilon} \quad \forall \xi \in \mathbb{R}, \forall r>0
$$

It is easy to show that the same is true for $\nu$.
Lemma 2.3. The measure $\nu$ and the set $P_{\infty}$ constructed above satisfy the following.
(1) The set $P_{\infty}$ has Hausdorff dimension $\alpha$.
(2) For any $0<\epsilon<\alpha$, we have

$$
\nu(B(x, r)) \lesssim_{\alpha, \epsilon} r^{\alpha-\epsilon} \quad \forall \xi \in \mathbb{R}^{2}, \forall r>0
$$

## 3. Decoupling inequalities

In this section, we will derive the decoupling estimates for $E_{\infty}$ and $P_{\infty}$. We will define decoupling constants and discrete restriction constants, and we will verify relations between them. Since we need to look into $E_{j}$ in different scales, we define the following.

For $0 \leq i \leq j$ and $a \in A_{i}$, we define $E_{j, i, a}=E_{j} \cap N_{i}^{-1 / 2}(a+[0,1])$, see Figure 1 . If $i=0$, since $A_{0}=\{0\}$, note that $E_{j, i, a}=E_{j, 0,0}=E_{j}$. Let $\mathcal{P}_{j}\left(E_{j, i, a}\right)$ be the partition of

$E_{j, i, a}$ into intervals of length $N_{j}^{-1 / 2}$ and $\widehat{f}_{I}\left(\xi_{1}\right):=\widehat{f}_{I}\left(\xi_{1}\right) \mathbf{1}_{I}\left(\xi_{1}\right)$ for $I \in \mathcal{P}_{j}\left(E_{j, i, a}\right)$ and $\xi_{1} \in \mathbb{R}$. Sometimes, we will write $I(b) \in \mathcal{P}_{j}\left(E_{j, i, a}\right)$ for $N_{j}^{-1 / 2}(b+[0,1]) \subseteq E_{j, i, a}$ for some $b \in A_{j}$.

For $p \geq 2$, let $D_{p}\left(E_{j, i, a}\right)$ denote the best constant such that

$$
\begin{equation*}
\left\|\sum_{I \in \mathcal{P}_{j}\left(E_{j, i, a}\right)} f_{I}\right\|_{L^{p}(\mathbb{R})} \leq D_{p}\left(E_{j, i, a}\right)\left(\sum_{I \in \mathcal{P}_{j}\left(E_{j, i, a}\right)}\left\|f_{I}\right\|_{L^{p}(\mathbb{R})}^{2}\right)^{1 / 2} \tag{3.1}
\end{equation*}
$$

for any function $f$ such that $\operatorname{supp} \widehat{f} \subseteq E_{j, i, a}$ and let $D_{p}\left(E_{j, i}\right)=\sup _{a \in A_{i}} D_{p}\left(E_{j, i, a}\right)$.
If $I \in \mathcal{P}_{j}\left(E_{j, i, a}\right)$, there exist an unique element $b \in A_{j}$ such that $I(b) \in \mathcal{P}_{j}\left(E_{j, i, a}\right)$. Thus, we define

$$
\begin{aligned}
& \Omega_{I}=\left\{\xi \in \mathbb{R}^{2}: b N_{j}^{-1 / 2} \leq \xi_{1} \leq(b+1) N_{j}^{-1 / 2}\right. \\
&\left.\left|\xi_{2}-(2 b+1) N_{j}^{-1 / 2}\left(\xi_{1}-b N_{j}^{-1 / 2}\right)-b^{2} N_{j}^{-1}\right| \leq N_{j}^{-1}\right\}
\end{aligned}

and $P_{j, i, a}=\cup_{I \in \mathcal{P}_{j}\left(E_{j, i, a}\right)} \Omega_{I}$ and $f_{\Omega_{I}}=\widehat{f}(\xi) \mathbf{1}_{\Omega_{I}}(\xi)$ for $\xi \in \mathbb{R}^{2}$. Let $D_{p}\left(P_{j, i, a}\right)$ be the best constant such that

\left\|\sum_{I \in \mathcal{P}_{j}\left(E_{j, i, a}\right)} f_{\Omega_{I}}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \leq D_{p}\left(P_{j, i, a}\right)\left(\sum_{I \in \mathcal{P}_{j}\left(E_{j, i, a}\right)}\left\|f_{\Omega_{I}}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)}^{2}\right)^{1 / 2} \tag{3.2}

for any function $f$ such that $\operatorname{supp} \widehat{f} \subseteq P_{j, i, a}$. Similarly, let $D_{p}\left(P_{j, i}\right)=\sup _{a \in A_{i}} D_{p}\left(P_{j, i, a}\right)$.
We also need discrete versions of $D_{p}\left(E_{j, i}\right)$ and $D_{p}\left(P_{j, i}\right)$. For $a \in A_{i}$, let us define

for any $\left\{c_{b}\right\}_{b \in A_{j, i, a}} \in \ell^{2}$ and $K_{p}\left(E_{j, i}\right):=\sup _{a \in A_{i}} K_{p}\left(E_{j, i, a}\right)$. Similarly, let $K_{p}\left(P_{j, i, a}\right)$ be the best constant such that

In short, $D_{p}\left(E_{j, i, a}\right)$ and $D_{p}\left(P_{j, i, a}\right)$ are decoupling constants for $E_{j, i, a}$ and $P_{j, i, a}$ respectively and $K_{p}\left(E_{j, i, a}\right)$ and $K_{p}\left(P_{j, i, a}\right)$ are discrete restriction constants for $E_{j, i, a}$ and $P_{j, i, a}$ respectively.

If $i=0$, we simply write $D_{p}\left(E_{j}\right):=D_{p}\left(E_{j, 0}\right), D_{p}\left(P_{j}\right):=D_{p}\left(P_{j, 0}\right), K_{p}\left(E_{j}\right):=K_{p}\left(E_{j, 0}\right)$ and $K_{p}\left(P_{j}\right):=K_{p}\left(P_{j, 0}\right)$.

We will show that $K_{6 / \alpha}\left(P_{j}\right) \lesssim_{\epsilon} N_{j}^{\epsilon}$ through the following inequalities:

3.1. From $\Lambda(p)$-sets to decoupling for $E_{j}$. We need the following lemmas to use $\Lambda(p)$-sets in multiscale.

Lemma 3.1. For $p \geq 2$, let $S_{1}$ be a subset of $\mathbb{Z}^{d}$. For $a \in S_{1}$ and $k \in \mathbb{N}$, let $S_{2, a}$ be subsets of $([0, k) \cap \mathbb{Z})^{d}$. Assume that the sets $S_{1}$ and $S_{2, a}$ satisfy

\end{equation*}

Then, we have

Lemma 3.2. For $p \geq 2$ and for any $a \in A_{i}, D_{p}\left(E_{j, i, a}\right) \approx_{p} K_{p}\left(E_{j, i, a}\right)$.
Lemma 3.1 and 3.2 follow from the proofs of Lemma 4 and Proposition 1 in [15] and the duality of $L^{p}$ played a key role. In Section 8, we provide alternative proofs of them which do not rely on duality.

Remark 3.3. Readers may want to compare Lemma 3.1] with Proposition 3.5 in [4]. They are similar but there is a trade-off. Lemma 3.1 can cover more general cases, because $p$ does not need to be an even integer and there is no assumption on carryover. However, the implicit constant of the inequality is larger than Proposition 3.5 in [4] because the constant in (3.5) is not exactly $C_{1} C_{2}$, but $C_{p}^{\prime} C_{1} C_{2}$ where $C_{p}^{\prime}>1$.

Lemma 3.4. For $0<\alpha<1, D_{2 / \alpha}\left(E_{j, i}\right) \lesssim \alpha \widetilde{C}_{2 / \alpha}^{j-i}$ where the $\widetilde{C}_{2 / \alpha}$ is a constant multiple of $C_{2 / \alpha}$ in (2.5).

Iterating Theorem 2.1 and Lemma 3.1, we get $K_{2 / \alpha}\left(E_{j, i, a}\right) \lesssim \widetilde{C}_{2 / \alpha}^{j-i}$. By Lemma 3.2, we obtain

3.2. From decoupling for $E_{j}$ to decoupling for $P_{j}$. In this section, we write $N_{j, i}=$ $N_{j} N_{i}^{-1}$. Also, note that $N_{j, 0}=N_{j}$. We will prove the following decoupling estimate for $P_{j}$.

Proposition 3.5. For $0<\alpha<1$, we have $D_{6 / \alpha}\left(P_{j}\right) \lesssim{ }_{\alpha, \epsilon} N_{j}^{\epsilon}$.
It is well known that $K_{p}\left(P_{j}\right) \lesssim_{p} D_{p}\left(P_{j}\right)$ (see for example [8, Theorem 13.1]). Thus, we have $K_{6 / \alpha}\left(P_{j}\right) \lesssim_{\alpha, \epsilon} N_{j}^{\epsilon}$. We will use it in the proof of Proposition 4.1.

In [4], they proved that the decoupling estimate for a Cantor set on the parabola can be derived from the decoupling estimate for a Cantor set on the line. We adapt their argument to our setting. The proofs of Lemma 3.6 and 3.7 are standard, but we included them for convenience.

& \leq D_{p}\left(P_{i, i_{0}, a}\right)\left(\sum_{I_{i}(b) \in \mathcal{P}_{i}\left(E_{i, i_{0}, a}\right)} D_{p}\left(P_{j+i, i, b}\right) \sum_{I \in \mathcal{P}_{j+i}\left(E_{j+i, i, b}\right)}\left\|f_{\Omega_{I}}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)}^{2}\right)^{1 / 2} \\
& \leq D_{p}\left(P_{j+i, i}\right) D_{p}\left(P_{i, i_{0}}\right)\left(\sum_{I_{i}(b) \in \mathcal{P}_{i}\left(E_{\left.i, i_{0}, a\right)}\right)} \sum_{I \in \mathcal{P}_{j+i}\left(E_{j+i, i, b}\right)}\left\|f_{\Omega_{I}}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)}^{2}\right)^{1 / 2}
\end{aligned}
$$

For $0 \leq k \leq i_{1}, i_{2} \leq j$ and $i_{0} \geq 0$, we define the bilinear constant $M_{p, i_{0}}\left(j, k, i_{1}, i_{2}, a\right)$ which is the smallest constant such that

& \left(\sum_{J_{1} \in \mathcal{P}_{j+i_{0}}\left(I_{1} \cap E_{j+i_{0}}\right)}\left\|f_{\Omega_{J_{1}}}\right\|_{L^{3 p\left(\mathbb{R}^{2}\right)}}^{2}\right)^{p / 2}\left(\sum_{J_{2} \in \mathcal{P}_{j+i_{0}}\left(I_{2} \cap E_{j+i_{0}}\right)}\left\|g_{\Omega_{J_{2}}}\right\|_{L^{3 p}\left(\mathbb{R}^{2}\right)}^{2}\right)^{p}
\end{aligned}
$$

for all $I_{1} \in \mathcal{P}_{i_{1}+i_{0}}\left(E_{i_{1}+i_{0}, i_{0}, a}\right)$ and $I_{2} \in \mathcal{P}_{i_{2}+i_{0}}\left(E_{i_{2}+i_{0}, i_{0}, a}\right)$ such that $d\left(I_{1}, I_{2}\right) \geq N_{k+i_{0}}^{-1 / 2}$ and for any $f$ and $g$ such that $\operatorname{supp} \widehat{f} \subseteq P_{j+i_{0}, i_{0}, a}$ and $\operatorname{supp} \widehat{g} \subseteq P_{j+i_{0}, i_{0}, a}$ respectively. Let $M_{p, i_{0}}\left(j, k, i_{1}, i_{2}\right)=\sup _{a \in A_{i_{0}}} M_{p, i_{0}}\left(j, k, i_{1}, i_{2}, a\right)$.

For any $a \in A_{i_{0}}$, note that

& \lesssim p N_{i+i_{0}, i_{0}}^{O(1)}\left(\widetilde{C}_{p} B\right)^{a i / 2} B^{i_{0} / 3} M_{p, i_{0}}(j, i, 4 a i, 2 a i)^{1 / 2} D_{3 p}\left(P_{j+i_{0}, a i+i_{0}}\right)^{1 / 2} .
\end{align*}
$$

First, we assume that $j=2^{k+1} i$ where $k$ is a sufficiently integer to be determined later. By iterating (3.22) and using (3.19) with $\epsilon$ replaced by $\epsilon / 2$, we have

## 4. Local Restriction estimate

We denote $B^{d}(R)$ by a cube of side length $R$ in $\mathbb{R}^{d}$ centered at the origin.
Proposition 4.1. Let $p=6 / \alpha$ where $0<\alpha<1$ and $\nu$ be the measure constructed in Section (2. Then, we have

Proof of Proposition 4.1. Let $\eta$ be a Schwartz function on $\mathbb{R}$ such that $|\eta| \geq 1$ on $[-1,1]$ and $\widehat{\eta}$ is supported on $[0,1]$. Let

& =K_{p}\left(P_{2 j}\right) N_{2 j}^{\epsilon+\frac{3}{2 p}-\frac{\alpha}{4}} N_{\ell}^{-3 / 4}\left|A_{\ell}\right|^{1 / 2}\|\widehat{F}\|_{L^{2}\left(\mathbb{R}^{2}\right)} .
\end{aligned}
$$

Since $\left|E_{\ell}\right|=\left|A_{\ell}\right| N_{\ell}^{-1 / 2}$, we get $\|\widehat{F}\|_{L^{2}\left(\mathbb{R}^{2}\right)} \lesssim N_{\ell}^{3 / 4}\left|A_{\ell}\right|^{-1 / 2}\|f\|_{L^{2}\left(\nu_{\ell}\right)}$.
Since $p=6 / \alpha$, it follows from Proposition 3.5 that

Now let us turn to the proof of Lemma 4.2,

The function $\widehat{f}_{\Omega_{a}}$ is supported on a rectangle of dimensions $O\left(N_{2 j}^{-1 / 2}\right) \times O\left(N_{2 j}^{-1}\right)$ centered at $\left((a+1 / 2) N_{2 j}^{-1 / 2},(a+1 / 2)^{2} N_{2 j}^{-1}\right)$ and the direction that it is pointing depends on $a$. The function $\widehat{\eta}_{2 j}$ is supported on a square with side length $O\left(N_{2 j}^{-1 / 2}\right)$ centered at the origin. Therefore, $\widehat{f}_{\Omega_{a}} * \widehat{\eta}_{2 j}(\xi)$ is supported on a square with side length $O\left(N_{2 j}^{-1 / 2}\right)$ centered at $\left(a N_{2 j}^{-1 / 2}, a^{2} N_{2 j}^{-1}\right)$.

For $a \in A_{2 j}$ and $c=\left(c_{1}, c_{2}\right) \in \mathbb{Z}^{2}$, let us consider characteristic functions

\widehat{g}\left(N_{2 j}^{-1 / 2}\left(z_{1}+a+c_{1}\right), N_{2 j}^{-1 / 2}\left(z_{2}+c_{2}\right)+a^{2} N_{2 j}^{-1}\right) d z N_{2 j}^{-1} \mid
\end{array}

Let $a^{\prime}=\left(a_{1}^{\prime}, a_{2}^{\prime}\right) \in \mathbb{Z}^{2}$ and $a^{\prime} \cdot u=a_{1}^{\prime} u_{1}+a_{2}^{\prime} u_{2}$. Then, we have

& \leq \sup _{\|g\|_{L^{q}\left(\mathbb{R}^{2}\right) \leq 1}} \sum_{|c| \lesssim 1}\left\|F_{c}(u, z)\right\|_{L_{u}^{p} L_{z}^{2}\left([0,1]^{2}\right)}\left\|G_{c}(u, z)\right\|_{L_{u}^{q} L_{z}^{2}\left([0,1]^{2}\right)} N_{2 j}^{-1}
\end{align*}
$$

Since $F_{c}(u, z)$ is a Fourier series with respect to $u$ variable, the definition of $K_{p}\left(P_{2 j}\right)$ and (4.4) implies that

$$
\begin{align*}
\left\|F_{c}\right\|_{L_{u}^{p} L_{z}^{2}\left([0,1]^{2}\right)} & \leq K_{p}\left(P_{2 j}\right)\left\|F_{c}\right\|_{L_{u}^{2} L_{z}^{2}\left([0,1]^{2}\right)} \\
& \leq K_{p}\left(P_{2 j}\right) N_{2 j}^{1 / 2}\left(\int \sum_{a \in A_{2 j}}\left|\widehat{f}_{\Omega_{a}} * \widehat{\eta}_{2 j}(\xi)\right|^{2} d \xi\right)^{1 / 2} \tag{4.7}
\end{align*}
$$

In order to obtain an estimate for $\left\|G_{c}\right\|_{\left.L_{u}^{q} L_{z}^{2}[0,1]^{2}\right)}$, we consider $G_{c}$ as a linear operator $T: L^{q}\left(\mathbb{R}^{2}\right) \rightarrow L_{u}^{q} L_{z}^{2}\left([0,1]^{2}\right)$ acting on $g$, which is defined by

$$
\begin{aligned}
T g(u, z)= & \sum_{\left|a_{1}^{\prime}\right| \lesssim N_{2 j}^{1 / 2},\left|a_{2}^{\prime}\right| \lesssim N_{2 j}} \int g(x) e\left(N_{2 j}^{-1 / 2} z_{1} x_{1}+N_{2 j}^{-1 / 2} z_{2} x_{2}\right) \\
& e\left(N_{2 j}^{-1 / 2}\left(a_{1}^{\prime}+c_{1}\right) x_{1}+\left(a_{2}^{\prime} N_{2 j}^{-1}+c_{2} N_{2 j}^{-1 / 2}\right) x_{2}\right) e\left(-a^{\prime} \cdot u\right) d x
\end{aligned}
$$

If we show that

$$
\begin{equation*}
\|T g\|_{L_{u}^{1} L_{z}^{2}\left([0,1]^{2}\right)} \lesssim N_{2 j}^{\epsilon}\|g\|_{L^{1}\left(\mathbb{R}^{2}\right)} \quad \forall g \in L^{1}\left(\mathbb{R}^{2}\right) \tag{4.8}
\end{equation*}
$$

and

$$
\begin{equation*}
\|T g\|_{L_{u}^{2} L_{z}^{2}\left([0,1]^{2}\right)} \lesssim N_{2 j}^{3 / 4}\|g\|_{L^{2}\left(\mathbb{R}^{2}\right)} \quad \forall g \in L^{2}\left(\mathbb{R}^{2}\right) \tag{4.9}
\end{equation*}
$$

then the mixed norm interpolation theorem (see [2, Theorem 2 in Section 7]) implies that

$$
\begin{equation*}
\left\|G_{c}(u, z)\right\|_{L_{u}^{q} L_{z}^{2}\left([0,1]^{2}\right)}=\|T g\|_{L_{u}^{q} L_{z}^{2}\left([0,1]^{2}\right)} \lesssim_{\epsilon} N_{2 j}^{\epsilon+\frac{3}{2}\left(1-\frac{1}{q}\right)}\|g\|_{L^{q}\left(\mathbb{R}^{2}\right)} \quad \forall g \in L^{q}\left(\mathbb{R}^{2}\right) \tag{4.10}
\end{equation*}
$$

When $q=1$, we only need to consider the case $c=0$, since the similar argument works for $c \neq 0$. We have

$$
T g(u, z)=\sum_{\left|a_{1}^{\prime}\right| \lesssim N_{2 j}^{1 / 2},\left|a_{2}^{\prime}\right| \lesssim N_{2 j}} \int_{\mathbb{R}^{2}} g\left(N_{2 j}^{1 / 2} x_{1}, N_{2 j} x_{2}\right) e\left(x_{1} z_{1}+N_{2 j}^{1 / 2} x_{2} z_{2}\right) N_{2 j}^{3 / 2} e\left(-a^{\prime} \cdot(u-x)\right) d x .
$$

Note that $\sum_{\left|a_{1}^{\prime}\right| \lesssim N_{2 j}^{1 / 2},\left|a_{2}^{\prime}\right| \lesssim N_{2 j}} e\left(-a^{\prime} \cdot u\right)$ is a product of Dirichlet kernels, since

$$
\sum_{\left|a_{1}^{\prime}\right| \lesssim N_{2 j}^{1 / 2},\left|a_{2}^{\prime}\right| \lesssim N_{2 j}} e\left(-a^{\prime} \cdot u\right)=\sum_{\left|a_{1}^{\prime}\right| \lesssim N_{2 j}^{1 / 2}} e\left(-a_{1}^{\prime} u_{1}\right) \sum_{\left|a_{2}^{\prime}\right| \lesssim N_{2 j}} e\left(-a_{2}^{\prime} u_{2}\right) .
$$

Uniformly in $x$, we have

$$
\left\|\sum_{\left|a_{1}^{\prime}\right| \lesssim N_{2 j}^{1 / 2},\left|a_{2}^{\prime}\right| \lesssim N_{2 j}} e\left(-a^{\prime} \cdot(u-x)\right)\right\|_{L^{1}\left([0,1]^{2}, d u\right)} \lesssim \log \left(N_{2 j}^{1 / 2}\right) \log \left(N_{2 j}\right)
$$

Therefore, we obtain that

$$
\begin{align*}
\|T g\|_{L^{1}\left([0,1]^{2}, d u\right)} & \lesssim \int_{\mathbb{R}^{2}} \int_{[0,1]^{2}}\left|g\left(N_{2 j}^{1 / 2} x_{1}, N_{2 j} x_{2}\right) N_{2 j}^{3 / 2}\right| \sum_{\left|a_{1}^{\prime}\right| \lesssim N_{2 j}^{1 / 2},\left|a_{2}^{\prime}\right| \lesssim N_{2 j}} e\left(-a^{\prime} \cdot(x-u)\right) \mid d u d x \\
& \lesssim \log \left(N_{2 j}\right)^{2} \int_{\mathbb{R}^{2}}\left|g\left(N_{2 j}^{1 / 2} x_{1}, N_{2 j} x_{2}\right) N_{2 j}^{3 / 2}\right| d x \\
& \lesssim \epsilon N_{2 j}^{\epsilon}\|g\|_{L^{1}\left(\mathbb{R}^{2}\right)} . \tag{4.11}
\end{align*}
$$

Since the estimate (4.11) holds uniformly in $z$, we established (4.8).
When $q=2$, since $T g(u, z)$ is a Fourier series with respect to $u$ variable, we use Plancherel's theorem and by (4.4), we have

$$
\begin{aligned}
& \|T g\|_{L_{u}^{2} L_{z}^{2}\left([0,1]^{2}\right)} \\
& =\left(\int_{[0,1]^{2}} \sum_{\left|a_{1}^{\prime}\right| \lesssim N_{2 j}^{1 / 2},\left|a_{2}^{\prime}\right| \lesssim N_{2 j}}\left|\widehat{g}\left(N_{2 j}^{-1 / 2}\left(z_{1}+a_{1}^{\prime}+c_{1}\right), N_{2 j}^{-1 / 2}\left(z_{2}+c_{2}\right)+a_{2}^{\prime} N_{2 j}^{-1}\right)\right|^{2} d z\right)^{1 / 2} \\
& =N_{2 j}^{1 / 2}\left(\int|\widehat{g}(\xi)|^{2} \sum_{\left|a_{1}^{\prime}\right| \lesssim N_{2 j}^{1 / 2},\left|a_{2}^{\prime}\right| \lesssim N_{2 j}} \mathbf{1}_{Q_{a^{\prime} c}}(\xi) d \xi\right)^{1 / 2}
\end{aligned}
$$

where

$$
\mathbf{1}_{Q_{a^{\prime}, c}}(\xi)=\mathbf{1}_{[0,1]^{2}}\left(N_{2 j}^{1 / 2} \xi_{1}-\left(a_{1}^{\prime}+c_{1}\right), N_{2 j}^{1 / 2} \xi_{2}-\left(a_{2}^{\prime} N_{2 j}^{-1 / 2}+c_{2}\right)\right)
$$

The function $\mathbf{1}_{Q_{a^{\prime}, c}}(\xi)$ is supported on a square with side length $O\left(N_{2 j}^{-1 / 2}\right)$ centered at ( $\left(a_{1}^{\prime}+\right.$ $\left.\left.c_{1}\right) N_{2 j}^{-1 / 2}, a_{2}^{\prime} N_{2 j}^{-1}+c_{2} N_{2 j}^{-1 / 2}\right)$. These squares overlap at most $O\left(N_{2 j}^{1 / 2}\right)$ times. Therefore, we have

$$
\|T g\|_{L_{u}^{2} L_{z}^{2}\left([0,1]^{2}\right)} \lesssim N_{2 j}^{3 / 4}\|\widehat{g}\|_{L^{2}\left(\mathbb{R}^{2}\right)} \leq N_{2 j}^{3 / 4}\|g\|_{L^{2}\left(\mathbb{R}^{2}\right)}
$$

Therefore, we established (4.9). Combining (4.6), (4.7) and (4.10), we obtain that

$$
\begin{equation*}
\left\|\sum_{a \in A_{2 j}} f_{\Omega_{a}}\right\|_{L^{p}\left(B^{2}\left(N_{j}\right)\right)} \lesssim_{\epsilon} K_{p}\left(P_{2 j}\right) N_{2 j}^{\epsilon+\frac{3}{2 p}-\frac{1}{2}}\left(\int \sum_{a \in A_{2 j}}\left|\widehat{f}_{\Omega_{a}} * \widehat{\eta}_{2 j}(\xi)\right|^{2} d \xi\right)^{1 / 2} \tag{4.12}
\end{equation*}
$$

We define

$$
\mathbf{1}_{\ell, 2 j, a}(\xi):=\sum_{b \in A_{\ell, 2 j, a}} \mathbf{1}_{[0,1] \times[-1,1]}\left(N_{\ell}^{1 / 2} \xi_{1}-b, N_{\ell} \xi_{2}-(2 b+1) N_{\ell}^{1 / 2} \xi_{1}+b^{2}+b\right)
$$

so that $\widehat{f}_{\Omega_{a}}(\xi)=\widehat{f}_{\Omega_{a}} \mathbf{1}_{\ell, 2 j, a}(\xi)$. By Hölder's inequality, we have

$$
\begin{aligned}
\left|\widehat{f}_{\Omega_{a}} * \widehat{\eta}_{2 j}(\xi)\right|^{2} & \leq\left(\left|{\widehat{f_{\Omega}}}^{\mathbf{1}_{\ell, 2 j, a}}\right| *\left|\widehat{\eta}_{2 j}\right|(\xi)\right)^{2} \\
& \leq\left(\left|\widehat{f}_{\Omega_{a}}\right|^{2} *\left|\widehat{\eta}_{2 j}\right|(\xi)\right)\left(\mathbf{1}_{\ell, 2 j, a} *\left|\widehat{\eta}_{2 j}\right|(\xi)\right) .
\end{aligned}
$$

Since $\left|\widehat{\eta}_{2 j}\right| \lesssim N_{2 j}$, for any fixed $\xi$, we have

$$
\left(\mathbf{1}_{\ell, 2 j, a} *\left|\widehat{\eta}_{2 j}\right|(\xi)\right) \leq\left\|\widehat{\eta}_{2 j}\right\|_{L^{\infty}\left(\mathbb{R}^{2}\right)}\left\|\mathbf{1}_{\ell, 2 j, a}\right\|_{L^{1}\left(\mathbb{R}^{2}\right)} \lesssim N_{2 j} N_{\ell}^{-3 / 2} \frac{\left|A_{\ell}\right|}{\left|A_{2 j}\right|}
$$

Since $N_{2 j}^{\alpha / 2} \leq\left|A_{2 j}\right|$ and $\left\|\widehat{\eta}_{2 j}\right\|_{L^{1}\left(\mathbb{R}^{2}\right)} \lesssim 1$, we get

$$
\begin{align*}
\int \sum_{a \in A_{2 j}}\left|\widehat{f}_{\Omega_{a}} * \widehat{\eta}_{2 j}(\xi)\right|^{2} d \xi & \lesssim N_{2 j}^{1-\alpha / 2} N_{\ell}^{-3 / 2}\left|A_{\ell}\right| \int \sum_{a \in A_{2 j}}\left|\widehat{f}_{\Omega_{a}}\right|^{2} *\left|\widehat{\eta}_{2 j}\right|(\xi) d \xi \\
& \lesssim N_{2 j}^{1-\alpha / 2} N_{\ell}^{-3 / 2}\left|A_{\ell}\right| \sum_{a \in A_{2 j}}\left\|\widehat{f}_{\Omega_{a}}\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}^{2}  \tag{4.13}\\
& \lesssim N_{2 j}^{1-\alpha / 2} N_{\ell}^{-3 / 2}\left|A_{\ell}\right|\left\|\sum_{a \in A_{2 j}} \widehat{f}_{\Omega_{a}}\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}^{2}
\end{align*}
$$

By (4.12) and (4.13), we obtain (4.3).

## 5. Fourier dechy

We abbreviate almost surely to a.s. When we say an inequality holds a.s., the corresponding implicit constant may depend on the measure $\nu$, but the probability that the constant exist is 1. Let us consider a nondecreasing sequence $\left\{m_{j}\right\}_{j \in \mathbb{N}}$ such that $2 \leq m_{j}$. Let $M_{j}:=m_{j} \cdots m_{1}$ and assume that for any $\epsilon>0$ and $j \in \mathbb{N}$,

$$
\begin{equation*}
m_{j+1} \lesssim_{\epsilon} M_{j}^{\epsilon} . \tag{5.1}
\end{equation*}
$$

Let $\mathcal{I}_{j}$ be the collection of $M_{j}^{-1}$-intervals such that

$$
\mathcal{I}_{j}=\left\{M_{j}^{-1}(k+[0,1]): 0 \leq k \leq M_{j}-1\right\} .
$$

We consider a sequence of random functions $\mu_{j}$ which satisfies the following conditions for some deterministic nondecreasing sequence $\left\{\beta_{j}\right\}_{j \in \mathbb{N}}$ :

- $\mu_{0}=\mathbf{1}_{[0,1]}$.
- $\mu_{j}=\beta_{j} \mathbf{1}_{E_{j}}$ where $E_{j}$ is a union of intervals in $\mathcal{I}_{j}$.
- $\mathbb{E}\left(\mu_{j+1}(x) \mid E_{j}\right)=\mu_{j}(x)$ for all $x \in[0,1]$.
- Conditioned on $E_{j}$, the sets $I_{j} \cap E_{j+1}$ are chosen independently for each $I_{j} \subseteq E_{j}$. We will identify the functions $\mu_{j}$ with the measures $\mu_{j} d x$ and write $\left\|\mu_{j}\right\|:=\mu_{j}([0,1])$.
Remark 5.1. First three conditions are same with (M1)-(M3) in [22] and the last condition is weaker than (M4) in [22]. Since we only prove Fourier decay, it suffices to assume the weaker condition.

Let $\alpha_{0}$ be a number such that

$$
\begin{equation*}
1-\alpha_{0}=\lim _{j \rightarrow \infty} \frac{\log \beta_{j}}{\log M_{j}} \tag{5.2}
\end{equation*}
$$

Note that (5.2) implies that there exist $j_{0}(\epsilon)$ for every $\epsilon>0$ such that if $j \geq j_{0}(\epsilon)$, then

$$
\begin{equation*}
M_{j}^{1-\alpha_{0}-\epsilon} \leq \beta_{j} \leq M_{j}^{1-\alpha_{0}+\epsilon} . \tag{5.3}
\end{equation*}
$$

Shmerkin and Suomala showed that $\mu_{j}$ converges weakly to a measure $\mu$ supported on $[0,1]$ and the support of the measure $\mu$ is a Salem set a.s. so that $|\widehat{\mu}(\xi)| \lesssim \sigma(1+|\xi|)^{-\sigma / 2}$ for any $\sigma<\alpha_{0}$, see [22, Theorem 4.2] and [23, Theorem 14.1].

Now, let $\nu_{j}$ be a measure defined as

$$
\int f\left(x_{1}, x_{2}\right) d \nu_{j}:=\int f\left(x_{1}, x_{1}^{2}\right) \mu_{j}\left(x_{1}\right) d x_{1}
$$

Similarly, $\nu_{j}$ converges weakly to a measure $\nu$ supported on $\mathbb{P}^{1}$.
Proposition 5.2. Suppose that $\mu_{j}$ is a sequence of random measures that satisfies the conditions above. For any $0<\sigma<\alpha_{0}$, the limit measure $\nu$ satisfies the following inequality a.s.

$$
\begin{equation*}
|\widehat{\nu}(\xi)| \lesssim \sigma(1+|\xi|)^{-\sigma / 2} \quad \forall \xi \in \mathbb{R}^{2} \tag{5.4}
\end{equation*}
$$

Remark 5.3. For each $0<\beta<1$, Kaufman [13] constructed a Salem set of dimension $\beta$ which is a subset of $\mathbb{P}^{1}$. The proof of Proposition 5.2 is similar to [13] in that we used probabilistic argument and Van der Corput lemma. However, we showed that (5.4) is satisfied a.s. in more general settings.

One of the main ingredients of the proof is Hoeffding's inequality.
Theorem 5.4 (Hoeffding's inequality [12]). Let $X_{1}, \cdots, X_{n}$ be independent real random variables such that $a_{i} \leq X_{i} \leq b_{i}$ and $S_{n}:=X_{1}+\cdots+X_{n}$. For $t>0$,

$$
\begin{equation*}
\mathbb{P}\left(\left|S_{n}-\mathbb{E}\left(S_{n}\right)\right|>t\right) \leq 2 \exp \left(\frac{-2 t^{2}}{\sum_{i=1}^{n}\left(b_{i}-a_{i}\right)^{2}}\right) \tag{5.5}
\end{equation*}
$$

According to the size of $|\xi|$, we will use different arguments to obtain estimates for $\mid \widehat{\nu}_{j+1}(\xi)-$ $\widehat{\nu}_{j}(\xi) \mid$. If $|\xi| \leq M_{j+1}$, we use (5.5). If $|\xi| \geq m_{j} M_{j+1}^{2}$, we use van der Corput lemma. Lastly, if $M_{j+1} \leq|\xi| \leq m_{j+1} M_{j}^{2}$, we use both of them.

Lemma 5.5. For fixed $\xi$ such that $|\xi| \leq M_{j+1}$, we have the following tail bound. There exists a constant $C_{1}>0$ such that

$$
\begin{equation*}
\mathbb{P}\left(\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right| \geq M_{j}^{-\sigma / 2}\left\|\mu_{j}\right\|^{1 / 2} \mid E_{j}\right) \lesssim \exp \left(-C_{1} M_{j}^{1-\sigma} \beta_{j} \beta_{j+1}^{-2}\right) \tag{5.6}
\end{equation*}
$$

Proof. The proof is similar to the proof of Theorem 4.2 in [22]. For $I_{j} \in \mathcal{I}_{j}$, we consider

$$
X_{I_{j}}=\int_{I_{j}} \beta_{j+1} \mathbf{1}_{E_{j+1}} e\left(-x \xi_{1}-x^{2} \xi_{2}\right) d x
$$

for $\xi=\left(\xi_{1}, \xi_{2}\right) \in \mathbb{R}^{2}$. Then, $\sum_{I_{j} \in \mathcal{I}_{j}} X_{I_{j}}=\widehat{\nu}_{j+1}(\xi)$ and $\mathbb{E}\left(\mu_{j+1}(x) \mid E_{j}\right)=\mu_{j}(x)$ implies that

$$
\begin{aligned}
\mathbb{E}\left(\sum_{I_{j} \in \mathcal{I}_{j}} X_{I_{j}} \mid E_{j}\right) & =\mathbb{E}\left(\widehat{\nu}_{j+1}(\xi) \mid E_{j}\right) \\
& =\int e\left(-x \xi_{1}-x^{2} \xi_{2}\right) \mathbb{E}\left(\mu_{j+1}(x) \mid E_{j}\right) d x \\
& =\int e\left(-x \xi_{1}-x^{2} \xi_{2}\right) \mu_{j}(x) d x=\widehat{\nu}_{j}(\xi)
\end{aligned}
$$

Let $S_{j}:=\sum_{I_{j} \in \mathcal{I}_{j}} X_{I_{j}}$, then

$$
\left|S_{j}-\mathbb{E}\left(S_{j}\right)\right|=\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right|
$$

conditioned on $E_{j}$. Also, note that $X_{I_{j}}$ are independent conditioned on $E_{j}$, since $I_{j} \cap E_{j+1}$ are chosen independently.

Next, we need to estimate $\left|X_{I_{j}}\right|$ for $I_{j} \subseteq E_{j}$. The random variables $X_{I_{j}}$ are not realvalued. But by considering real and imaginary parts of $X_{I_{j}}$ separately, we can use Hoeffding's inequality (5.5) with $\sum_{i=1}^{n}\left(b_{i}-a_{i}\right)^{2}$ replaced by the upper bound of $\sum_{I_{j}}\left|X_{I_{j}}\right|^{2}$.

We have

$$
\begin{equation*}
\left|X_{I_{j}}\right| \leq \beta_{j+1} M_{j}^{-1} \tag{5.7}
\end{equation*}
$$

and the number of $I_{j} \subseteq E_{j}$ is $M_{j} \beta_{j}^{-1}\left\|\mu_{j}\right\|$. Thus, we obtain

$$
\sum_{I_{j} \subseteq E_{j}}\left|X_{I_{j}}\right|^{2} \leq \frac{\beta_{j+1}^{2}}{\beta_{j} M_{j}}\left\|\mu_{j}\right\|
$$

For $t=M_{j}^{-\sigma / 2}\left\|\mu_{j}\right\|^{1 / 2}$, Hoeffding's inequality (5.5) implies (5.6).
Then, the unconditional version of Lemma 5.5 easily follows.
Corollary 5.6. For fixed $\xi$, if $|\xi| \leq M_{j+1}$, then there exists a constant $C_{1}>0$ such that

$$
\mathbb{P}\left(\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right| \geq M_{j}^{-\sigma / 2}\left\|\mu_{j}\right\|^{1 / 2}\right) \lesssim \exp \left(-C_{1} M_{j}^{1-\sigma} \beta_{j} \beta_{j+1}^{-2}\right)
$$

Proof. Note that Lemma 5.5 holds uniformly in $E_{j}$. Thus, the result can be immediately derived from the law of total probability.

For the rest of this section, we will use the following notations additionally. For fixed $\xi=\left(\xi_{1}, \xi_{2}\right) \in \mathbb{R}^{2}$ such that $\xi \neq 0$, consider $I_{j+1}(k):=M_{j+1}^{-1}(k+[0,1]) \in \mathcal{I}_{j+1}$ and let $m(k)$ be the minimum of $\left|\xi_{1}+2 x \xi_{2}\right|$ on $I_{j+1}(k)$. Also, if $\xi_{2} \neq 0$, let $m\left(k_{0}\right)$ be the smallest among $m(k)$ and $x_{0}$ be a point in $[0,1]$ such that $m\left(k_{0}\right)=\left|\xi_{1}+2 x_{0} \xi_{2}\right|$. If there are two $k$ 's such that $m(k)$ is the smallest, $k_{0}$ can be either of them.
Lemma 5.7. For any $|\xi| \geq m_{j+1} M_{j}^{2}$, we have

$$
\begin{equation*}
\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right| \lesssim_{\epsilon} M_{j+1}^{1-\alpha_{0}+\epsilon}|\xi|^{-1 / 2} \tag{5.8}
\end{equation*}
$$

Proof. By Van der Corput lemma (see for example [24, Proposition 2.2, Chapter 8]), we get

$$
\begin{equation*}
\left|\int_{I_{j+1}(k)} e\left(-x \xi_{1}-x^{2} \xi_{2}\right) d x\right| \lesssim m(k)^{-1} \quad \text { if } m(k) \neq 0 \tag{5.9}
\end{equation*}
$$

If $\left|\xi_{1}\right| \geq 10\left|\xi_{2}\right|$, then $\left|\xi_{1}+2 x \xi_{2}\right| \gtrsim|\xi|$. Therefore,

$$
\begin{align*}
\left|\widehat{\nu_{j+1}}(\xi)\right| & \leq \sum_{I_{j+1}(k) \subseteq E_{j+1}}\left|\int_{I_{j+1}(k)} \beta_{j+1} e\left(-x \xi_{1}-x^{2} \xi_{2}\right) d x\right| \\
& \lesssim \beta_{j+1} M_{j+1}|\xi|^{-1}  \tag{5.10}\\
& \leq \beta_{j+1} m_{j+1}^{1 / 2}|\xi|^{-1 / 2} .
\end{align*}
$$

In the last inequality, we used that $|\xi| \geq m_{j+1} M_{j}^{2}$.
If $\left|\xi_{1}\right| \leq 10\left|\xi_{2}\right|$, we consider $I_{j+1}\left(k_{0}+p\right)$ for $p=-1,0$ or 1 . The interval $I_{j+1}\left(k_{0}+p\right)$ can be divided into $I_{1}$ and $I_{2}$ where $I_{1}=\left\{x:\left|x-x_{0}\right| \leq|\xi|^{-1 / 2}\right\}$ and $I_{2}=\left\{x:\left|x-x_{0}\right| \geq|\xi|^{-1 / 2}\right\}$. For $x \in I_{2}$, since $\left|\xi_{1}+2 x \xi_{2}\right|$ attains its minimum at $x_{0}$,

\end{aligned}
$$

Therefore, (5.9) implies that

\left|\int_{I_{j+1}\left(k_{0}+p\right)} \beta_{j+1} e\left(-x \xi_{1}-x^{2} \xi_{2}\right) d x\right| & \lesssim \beta_{j+1}\left|I_{1}\right|+\beta_{j+1}|\xi|^{-1 / 2}  \tag{5.11}\\
& \lesssim \beta_{j+1}|\xi|^{-1 / 2}
\end{align*}
$$

If $p \neq-1,0,1$, then $m\left(k_{0}+p\right) \geq 2\left|x-x_{0}\right||\xi| \gtrsim p M_{j+1}^{-1}|\xi|$. Using (5.9), we obtain

\left|\int_{I_{j+1}\left(k_{0}+p\right)} \beta_{j+1} e\left(-x \xi_{1}-x^{2} \xi_{2}\right) d x\right| \lesssim \frac{\beta_{j+1} M_{j+1}}{p|\xi|} . \tag{5.12}
\end{equation*}
$$

Combining (5.11) and (5.12), we get

\left|\widehat{\nu_{j+1}}(\xi)\right| & \leq \sum_{I_{j+1}(k) \subseteq E_{j+1}}\left|\int_{I_{j+1}(k)} \beta_{j+1} e\left(-x \xi_{1}-x^{2} \xi_{2}\right) d x\right| \\
& \lesssim \beta_{j+1}|\xi|^{-1 / 2}+\sum_{p=1}^{M_{j+1}} \frac{\beta_{j+1} M_{j+1}}{p|\xi|} \\
& \lesssim \beta_{j+1} m_{j+1}^{1 / 2} \log \left(M_{j+1}\right)|\xi|^{-1 / 2} .
\end{aligned}
$$

We considered when $\left|\xi_{1}\right| \geq 10\left|\xi_{2}\right|$ and $\left|\xi_{1}\right| \leq 10\left|\xi_{2}\right|$. In either cases, (5.1) and (5.3) imply that

for any $\xi$. The same argument works for $\widehat{\nu}_{j}$ with $j+1$ replaced by $j$. Thus, we have $\left|\widehat{\nu}_{j}(\xi)\right| \lesssim{ }_{\epsilon} M_{j}^{1-\alpha_{0}+\epsilon}|\xi|^{-1 / 2}$. Since $M_{j} \leq M_{j+1}$, we get (5.8).
Lemma 5.8. For fixed $\xi$, if $M_{j+1} \leq|\xi| \leq m_{j+1} M_{j}^{2}$, let $k$ be an integer such that $0 \leq k \leq j-1$ and

\end{equation*}
$$

If $\left|\xi_{1}\right| \leq 10\left|\xi_{2}\right|$, there exists a constant $C_{3}>0$ such that

\begin{array}{r}
\mathbb{P}\left(\left.\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right| \geq M_{j}^{-\left(\alpha_{0}-\epsilon\right) / 2}\left[\sum_{i=0}^{k}\left(\frac{M_{i+1}}{M_{k}}\right)^{2} \mu_{j}\left(I_{i}\left(x_{0}\right)\right)\right]^{1 / 2} \right\rvert\, E_{j}\right)  \tag{5.14}\\
\\
\lesssim \exp \left(-C_{3} M_{j}^{1-\alpha_{0}+\epsilon} \beta_{j} \beta_{j+1}^{-2}\right)
\end{array}
$$

where $I_{i}\left(x_{0}\right)$ is an interval of length $M_{i}^{-1}$ centered at $x_{0}$.
Proof. If $\left|\xi_{1}\right| \geq 10\left|\xi_{2}\right|$, by the argument similar to (5.10), we have $\left|X_{I_{j}}\right| \lesssim \beta_{j+1} m_{j+1}|\xi|^{-1}$ and the number of interval $I_{j}$ in $E_{j}$ is $\beta_{j}^{-1} M_{j}\left\|\mu_{j}\right\|$. Since $M_{j+1} \leq|\xi|$, we have

For $t=M_{j}^{\left(1-\alpha_{0}+\epsilon\right) / 2}|\xi|^{-1 / 2}\left\|\mu_{j}\right\|^{1 / 2}$, Hoeffding's inequality (5.5) implies (5.13).

If $\left|\xi_{1}\right| \leq 10\left|\xi_{2}\right|$, we consider $I_{k}\left(x_{0}\right)$ first. If $I_{j} \subseteq I_{k}\left(x_{0}\right)$, we use (5.7). Since the number of $I_{j}$ in $I_{k}\left(x_{0}\right)$ is $\beta_{j}^{-1} M_{j} \mu_{j}\left(I_{k}\left(x_{0}\right)\right)$, we obtain that

\sum_{I_{j} \subseteq I_{k}\left(x_{0}\right)}\left|X_{I_{j}}\right|^{2} \leq \beta_{j+1}^{2} \beta_{j}^{-1} M_{j}^{-1} \mu_{j}\left(I_{k}\left(x_{0}\right)\right) . \tag{5.15}
\end{equation*}
$$

If $I \subseteq I_{i}\left(x_{0}\right)$ but $I \nsubseteq I_{i+1}\left(x_{0}\right)$ for $0 \leq i \leq k-1$, then $\left|x-x_{0}\right| \geq M_{i+1}^{-1}-M_{j}^{-1} \gtrsim M_{i+1}^{-1}$ for any $x \in I$. Therefore,

\left|\xi_{1}+2 x \xi_{2}\right| \gtrsim\left|x-x_{0}\right||\xi| \gtrsim M_{i+1}^{-1}|\xi| .

We use (5.9) again and obtain that $\left|X_{I_{j}}\right| \lesssim \beta_{j+1} m_{j+1} M_{i+1}|\xi|^{-1}$. Since the number of $I_{j}$ in $I_{i}\left(x_{0}\right)$ is $\lesssim \beta_{j}^{-1} M_{j} \mu_{j}\left(I_{i}\left(x_{0}\right)\right)$ and $M_{j+1}|\xi|^{-1} \leq M_{k}^{-1}$, we get

& \leq \frac{\beta_{j+1}^{2}}{\beta_{j} M_{j}}\left(\frac{M_{i+1}}{M_{k}}\right)^{2} \mu_{j}\left(I_{i}\left(x_{0}\right)\right) .
\end{align*}
$$

Combining (5.15) and (5.16), we get

For

t=M_{j}^{-\left(\alpha_{0}-\epsilon\right) / 2}\left(\sum_{i=0}^{k}\left(\frac{M_{i+1}}{M_{k}}\right)^{2} \mu_{j}\left(I_{i}\left(x_{0}\right)\right)\right)^{1 / 2}
$$

Hoeffding's inequality (5.5) implies (5.14).
We also have the following unconditional version of Lemma 5.8,
Corollary 5.9. For fixed $\xi$, if $M_{j+1} \leq|\xi| \leq m_{j+1} M_{j}^{2}$, for $k$ defined in Lemma 5.8, we have the following tail bounds.
If $\left|\xi_{1}\right| \geq 10\left|\xi_{2}\right|$, there exists a constant $C_{2}>0$ such that

\mathbb{P}\left(\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right| \geq M_{j}^{-\left(\alpha_{0}-\epsilon\right) / 2}\left(\frac{M_{j}}{|\xi|}\right)^{1 / 2}\left\|\mu_{j}\right\|^{1 / 2}\right) \lesssim \exp \left(-C_{2} M_{j}^{1-\alpha_{0}+\epsilon} \beta_{j} \beta_{j+1}^{-2} m_{j+1}^{-1}\right)
$$

If $\left|\xi_{1}\right| \leq 10\left|\xi_{2}\right|$, there exists a constant $C_{3}>0$ such that

\begin{aligned}
\mathbb{P}\left(\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right| \geq M_{j}^{-\left(\alpha_{0}-\epsilon\right) / 2}[ \right. & \left.\left.\sum_{i=0}^{k}\left(\frac{M_{i+1}}{M_{k}}\right)^{2} \mu_{j}\left(I_{i}\left(x_{0}\right)\right)\right]^{1 / 2}\right) \\
& \lesssim \exp \left(-C_{3} M_{j}^{1-\alpha_{0}+\epsilon} \beta_{j} \beta_{j+1}^{-2}\right)
\end{aligned}
$$

where $I_{i}\left(x_{0}\right)$ is an interval of length $M_{i}^{-1}$ centered at $x_{0}$.
Proof. Note that Lemma 5.8 holds uniformly in $E_{j}$. Thus, the result immediately follows from the law of total probability.

In order to prove Proposition 5.2, we also need an estimate for $\mu_{j}\left(I_{i}\left(x_{0}\right)\right)$.

Lemma 5.10. We have the following estimate a.s.

\mathbb{E}\left(\sum_{I_{j} \in \mathcal{I}_{j}} X_{I_{j}} \mid E_{j}\right)=\sum_{I_{j} \in \mathcal{I}_{j}} \mathbb{E}\left(\mu_{j+1}\left(I_{j} \cap I_{i}\right) \mid E_{j}\right)=\sum_{I_{j} \in \mathcal{I}_{j}} \mu_{j}\left(I_{j} \cap I_{i}\right)=\mu_{j}\left(I_{i}\right) .
$$

Also, $X_{I_{j}}$ are independent conditioned on $E_{j}$, since $I_{j} \cap E_{j+1}$ are chosen independently.
We have $\left|X_{I_{j}}\right| \leq \beta_{j+1} M_{j}^{-1}$ and the number of $I_{j}$ such that $I_{j} \subseteq I_{i}$ is $\beta_{j}^{-1} M_{j} \mu_{j}\left(I_{i}\right)$. Note that $I_{j} \subseteq I_{i}$ if and only if $X_{I_{j}}>0$. Therefore, we have

For $t=M_{j}^{\epsilon / 4} M_{j}^{-1 / 2} \beta_{j}^{1 / 2} \mu_{j}\left(I_{i}\right)^{1 / 2}$, Hoeffding's inequality (5.5) implies that there exist a constant $C>0$ such that

Borel-Cantelli lemma and (5.18) imply that there exist $i_{0}$ a.s. such that if $j \geq i \geq i_{0}$, then for any $I_{i} \in \mathcal{I}_{i}$,

\end{equation*}

Using (5.3) again, we can choose $i_{1}(\epsilon)$ such that if $i \geq i_{1}(\epsilon)$, then

Now, we claim that if $i \geq \max \left(i_{0}, i_{1}(\epsilon)\right)$, then there exists a constant $C^{\prime} \geq 1$ such that for any $j \geq i$ and $I_{i} \in \mathcal{I}_{i}$

\mu_{j}\left(I_{i}\right) \leq C^{\prime} j^{2} \beta_{i} M_{i}^{-1} M_{j}^{\epsilon\left(1-2^{-j}\right)} \tag{5.20}
\end{equation*}
$$

If $j=i$, then $\mu_{j}\left(I_{i}\right) \lesssim \beta_{i} M_{i}^{-1}$ uniformly in $i$ and $I_{i} \in \mathcal{I}_{i}$. If (5.20) holds for $j=k$, (5.19) implies that

\mu_{k+1}\left(I_{i}\right) \leq C^{\prime} k^{2} \beta_{i} M_{i}^{-1} M_{k}^{\epsilon\left(1-2^{-k}\right)}+\left(C^{\prime}\right)^{1 / 2} k \beta_{i} M_{i}^{-1} M_{k}^{\frac{\epsilon}{\epsilon}\left(1-2^{-k}\right)} M_{k}^{\epsilon / 4}\left(\frac{\beta_{k} M_{k}^{-1}}{\beta_{i} M_{i}^{-1}}\right)^{1 / 2}
$$

By the choice of $\epsilon_{1}(\epsilon)$,

$$
\frac{\beta_{k} M_{k}^{-1}}{\beta_{i} M_{i}^{-1}} \leq \frac{M_{k}^{-\alpha_{0}+\epsilon / 4}}{M_{i}^{-\alpha_{0}-\epsilon / 4}} \leq\left(M_{k} M_{i}\right)^{\epsilon / 4} \leq M_{k}^{\epsilon / 2}
$$

Thus, we obtain that for any $I_{i} \in \mathcal{I}_{i}$,

\mu_{k+1}\left(I_{i}\right) \leq C^{\prime}\left(k^{2}+k\right) \beta_{i} M_{i}^{-1} M_{k}^{\epsilon\left(1-2^{-k-1}\right)} \leq C^{\prime}(k+1)^{2} \beta_{i} M_{i}^{-1} M_{k+1}^{\epsilon\left(1-2^{-k-1}\right)} .
$$

Hence, we proved (5.20). The estimate (5.17) follows when $j \geq i \geq \max \left(i_{0}, i_{1}(\epsilon)\right)$.
To consider the case $i \leq \max \left(i_{0}, i_{1}(\epsilon)\right)$, we first show that $\left\|\mu_{j}\right\|$ is a.s. bounded. We have $\mathbb{E}\left(\left\|\mu_{j+1}\right\| \mid E_{j}\right)=\left\|\mu_{j}\right\|$ for all $E_{j}$ and the law of total probability implies that $\mathbb{E}\left(\left\|\mu_{j+1}\right\|\right)=$ $\mathbb{E}\left(\left\|\mu_{j}\right\|\right)$. By iterating the equality, we get $\mathbb{E}\left(\left\|\mu_{j}\right\|\right)=\mathbb{E}\left(\left\|\mu_{0}\right\|\right)=1$ for all $j \in \mathbb{N} \cup\{0\}$. By Martingale convergence theorem (see for example [9, Theorem 4.2.11]), as $j \rightarrow \infty,\left\|\mu_{j}\right\|$ converges to $\|\mu\|$ a.s. with $\mathbb{E}(\|\mu\|)=1$. Therefore, $\left\|\mu_{j}\right\|$ is a.s. bounded.

Therefore, if $i \leq \max \left(i_{0}, i_{1}(\epsilon)\right)$, for any $j \geq i$ and $I_{i} \in \mathcal{I}_{i}$ we have

\mu_{j}\left(I_{i}\right) \leq\left\|\mu_{j}\right\| \lesssim_{\epsilon} \min _{i \leq \max \left(i_{0}, i_{1}(\epsilon)\right)}\left(\beta_{i} M_{i}^{-1}\right) \leq M_{j}^{\epsilon} \beta_{i} M_{i}^{-1} \quad \text { a.s. }
$$

Thus, we get (5.17).
Proof of Proposition [5.2. As in [22] and [23], we use Lemma 9A4 in [28]. Then, it suffices to consider only $\xi \in \mathbb{Z}^{2}$. Let $\Omega_{j}$ be the event that there exists $\xi \in \mathbb{Z}^{2}$ such that one of the following happens.
(1) If $|\xi| \leq M_{j+1}$, then

\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right| \geq M_{j}^{-\left(\alpha_{0}-\epsilon\right) / 2}\left(\frac{M_{j}}{|\xi|}\right)^{1 / 2}\left\|\mu_{j}\right\|^{1 / 2}
$$

(3) If $M_{j+1} \leq|\xi| \leq m_{j+1} M_{j}^{2}$ and $\left|\xi_{1}\right| \leq 10\left|\xi_{2}\right|$, then

\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right| \geq M_{j}^{-\left(\alpha_{0}-\epsilon\right) / 2}\left[\sum_{i=0}^{k}\left(\frac{M_{i+1}}{M_{k}}\right)^{2} \mu_{j}\left(I_{i}\left(x_{0}\right)\right)\right]^{1 / 2}
$$

for $k$ such that $0 \leq k \leq j-1$ and $M_{j+1} M_{k} \leq|\xi| \leq M_{j+1} M_{k+1}$.
Since we only consider $\xi \in \mathbb{Z}^{2}$ such that $|\xi| \leq m_{j+1} M_{j}^{2}$, Corollary 5.6 and 5.9 imply that

\mathbb{P}\left(\Omega_{j}\right) \lesssim m_{j+1}^{2} M_{j}^{4} \exp \left(-C M_{j}^{1-\alpha_{0}+\epsilon} \beta_{j} \beta_{j+1}^{-2} m_{j+1}^{-1}\right) \tag{5.21}
\end{equation*}
$$

for some constant $C>0$. For sufficiently large $j$ and sufficiently small $\epsilon>0$, it follows from (5.1) and (5.3) that

$$
M_{j}^{1-\alpha_{0}+\epsilon} \beta_{j} \beta_{j+1}^{-2} m_{j+1}^{-1} \gtrsim \epsilon M_{j}^{\epsilon / 2}
$$

Therefore, $\sum_{j=1}^{\infty} \mathbb{P}\left(\Omega_{j}\right)<\infty$.

Using Lemma 5.10, (5.3) and that $M_{j+1} M_{k} \leq|\xi| \leq M_{j+1} M_{k}$, a.s. we have

$$
\begin{align*}
\sum_{i=0}^{k}\left(\frac{M_{i+1}}{M_{k}}\right)^{2} \mu_{j}\left(I_{i}\left(x_{0}\right)\right) & \lesssim \epsilon \sum_{i=0}^{k} M_{j}^{\epsilon} \beta_{i} M_{i} m_{i+1}^{2} M_{k}^{-2} \\
& \lesssim \epsilon M_{j}^{\epsilon} \beta_{k} m_{k+1}^{2} M_{k}^{-1} \lesssim_{\epsilon} M_{j}^{\epsilon} M_{k}^{\epsilon}\left(\frac{M_{j+1}}{|\xi|}\right)^{\alpha_{0}-\epsilon}  \tag{5.22}\\
& \lesssim M_{j}^{2 \epsilon}\left(\frac{M_{j}}{|\xi|}\right)^{\alpha_{0}-\epsilon}
\end{align*}
$$

We apply Borel-Cantelli lemma to $\Omega_{j}$, Since $\left\|\mu_{j}\right\|$ is a.s. bounded, Lemma 5.7] and (5.22) imply that a.s. there exists $j_{0}$ such that for $j \geq j_{0}$,

$$
\begin{aligned}
\left|\widehat{\nu}_{j+1}(\xi)-\widehat{\nu}_{j}(\xi)\right| & \lesssim M_{j}^{-\sigma / 2} & & \text { if }|\xi| \leq M_{j+1} \\
& \lesssim \epsilon M_{j}^{2 \epsilon}|\xi|^{\left(-\alpha_{0}+\epsilon\right) / 2} & & \text { if } M_{j+1} \leq|\xi| \leq m_{j+1} M_{j}^{2} \\
& \lesssim \epsilon M_{j+1}^{1-\alpha_{0}+\epsilon}|\xi|^{-1 / 2} & & \text { if }|\xi| \geq m_{j+1} M_{j}^{2}
\end{aligned}
$$

When $M_{j+1} \leq|\xi| \leq m_{j+1} M_{j}^{2}$ and $\left|\xi_{1}\right| \geq 10\left|\xi_{2}\right|$, we used that $M_{j} /|\xi| \leq\left(M_{j} /|\xi|\right)^{\alpha_{0}-\epsilon}$ for $\epsilon<\alpha_{0}$.

Let $j_{1}, j_{2}$ be numbers such that $M_{j_{2}} \leq|\xi| \leq M_{j_{2}+1}$ and $m_{j_{1}+1} M_{j_{1}}^{2} \leq|\xi| \leq m_{j_{1}+2} M_{j_{1}+1}^{2}$. By telescoping, we obtain for $k \geq j_{0}$,

\begin{aligned}
\left|\widehat{\nu}_{k}(\xi)-\widehat{\nu}_{j_{0}}(\xi)\right| \lesssim \epsilon & \sum_{j_{0} \leq j \leq j_{1}} M_{j+1}^{1-\alpha_{0}+\epsilon}|\xi|^{-1 / 2}+\sum_{\max \left(j_{0}, j_{1}\right)<j<j_{2}} M_{j}^{2 \epsilon}|\xi|^{\left(-\alpha_{0}+\epsilon\right) / 2} \\
& +\sum_{\max \left(j_{0}, j_{2}\right) \leq j \leq k} M_{j}^{-\sigma / 2} .
\end{aligned}
$$

We drop the first sum if $j_{1}<j_{0}$ and we drop the first and the second sum if $j_{1}, j_{2} \leq j_{0}$. Since $\sigma<\alpha_{0}$, for sufficiently small $\epsilon>0$, we get

\begin{aligned}
\left|\widehat{\nu}_{k}(\xi)-\widehat{\nu}_{j_{0}}(\xi)\right| & \lesssim_{\epsilon} M_{j_{1}+1}^{1-\alpha_{0}+\epsilon}|\xi|^{-1 / 2}+M_{j_{2}-1}^{2 \epsilon}|\xi|^{\left(-\alpha_{0}+\epsilon\right) / 2}+M_{j_{2}}^{-\sigma / 2} \\
& \lesssim \epsilon|\xi|^{-\sigma / 2+\epsilon} .
\end{aligned}
$$

Since $\left|\widehat{\nu}_{j_{0}}(\xi)\right| \lesssim_{j_{0}}|\xi|^{-1 / 2}$, by letting $k \rightarrow \infty$, we obtain (5.4).

## 6. Global Restriction estimate

We need to randomize the choice of $S_{j, a}$ in order to get the global restriction estimate.
Proposition 6.1. Let $\left\{n_{j}\right\}_{j \in \mathbb{N}}$ be a sequence of positive numbers which satisfies (2.1), (2.2), (2.3) and (2.4). Let $\left\{\mu_{j}\right\}_{j \in \mathbb{N} \cup\{0\}}$ be a sequence of random measures on $[0,1]$ which satisfies the following.
(1) $\mu_{0}, \mu_{1}, \cdots$ are constructed through the process in Section 园.
(2) For each $j \in \mathbb{N}$ and for each $a \in A_{j}$, the set $S_{j, a}$ are chosen randomly and independently from $\Sigma_{j}$ with probability distribution such that

$$
\mathbb{E}\left(\mu_{j}(x) \mid E_{j-1}\right)=\mu_{j-1}(x)
$$

For the corresponding sequence of random measures $\left\{\nu_{j}\right\}_{j \in \mathbb{N} \cap\{0\}}$, its limiting measure $\nu$ satisfies all conclusions of Theorem 1.2 a.s.

To prove Proposition 6.1, we need the next lemma to combine it with Tao's epsilon removal argument.

Lemma 6.2. Let $p=6 / \alpha$ where $0<\alpha<1$ and assume that $\nu$ is the measure constructed in Section 2 and satisfies (1.5). For sufficiently large $R>0$, suppose that $\left\{Q_{i}\right\}_{i=1}^{M}$ is a sparse collection of $R$-cubes in $\mathbb{R}^{2}$, which means that their centers $x_{1}, \cdots, x_{M}$ are $R^{B} M^{B}$-separated from each other for some sufficiently large constant $B$ which will be determined later. For any function $f$ supported on $\cup_{i=1}^{M} Q_{i}$, we have

$$
\begin{equation*}
\|\widehat{f}\|_{L^{2}(d \nu)} \lesssim_{q, \epsilon} R^{\epsilon}\|f\|_{L^{q}\left(\mathbb{R}^{2}\right)} \tag{6.1}
\end{equation*}
$$

where $1 / p+1 / q=1$.
Proof. Let $f=\sum_{i=1}^{M} f \mathbf{1}_{Q_{i}}$ where $\mathbf{1}_{Q_{i}}$ is a characteristic function on $Q_{i}$.

$$
\begin{aligned}
\|\widehat{f}\|_{L^{2}(d \nu)}^{2} & =\int\left|\sum_{i=1}^{M} \widehat{f \mathbf{1}_{Q_{i}}}\right|^{2} d \nu \\
& =\int \sum_{i=1}^{M}\left|\widehat{f \mathbf{1}_{Q_{i}}}\right|^{2} d \nu+\int \sum_{i \neq j} \widehat{f \mathbf{1}_{Q_{i}}} \widehat{\widehat{f 1_{Q_{j}}}} d \nu
\end{aligned}
$$

It follows from Proposition 4.1 that

$$
\begin{align*}
& \sum_{i=1}^{M} \int\left|\widehat{f \mathbf{1}_{Q_{i}}}\right|^{2} d \nu \lesssim q, \epsilon \\
& R^{\epsilon} \sum_{i=1}^{M}\left\|f \mathbf{1}_{Q_{i}}\right\|_{L^{q}\left(\mathbb{R}^{2}\right)}^{2}  \tag{6.2}\\
& \leq R^{\epsilon}\left(\sum_{i=1}^{M}\left\|f \mathbf{1}_{Q_{i}}\right\|_{L^{q}\left(\mathbb{R}^{2}\right)}^{q}\right)^{2 / q}=R^{\epsilon}\|f\|_{L^{q}\left(\mathbb{R}^{2}\right)}^{2}
\end{align*}
$$

In the last inequality, we used that $1 \leq q \leq 2$.
For the second term, Young's convolution inequality implies that

$$
\begin{align*}
\int \sum_{i \neq j} \widehat{f \mathbf{1}_{Q_{i}}} \overline{\widehat{f 1_{Q_{j}}}} d \nu & =\sum_{i \neq j} \iint f \mathbf{1}_{Q_{i}}(x) \overline{f \mathbf{1}_{Q_{j}}(y) \widehat{d \nu}}(y-x) d x d y \\
& \leq \sum_{i \neq j}\left\|f \mathbf{1}_{Q_{i}}\right\|_{L^{q}\left(\mathbb{R}^{2}\right)}\left\|f \mathbf{1}_{Q_{i}}\right\|_{L^{q}\left(\mathbb{R}^{2}\right)}\left\|\widehat{d \nu} \mathbf{1}_{i, j}\right\|_{L^{r}\left(\mathbb{R}^{2}\right)} \tag{6.3}
\end{align*}
$$

where $\frac{2}{q}+\frac{1}{r}=2$, so that $r=\frac{p}{2} \geq 1$ and

$$
\mathbf{1}_{i, j}=\mathbf{1}_{B^{2}(2 R)}\left(x-\left(x_{j}-x_{i}\right)\right)
$$

where $B^{2}(2 R)$ is a ball of radius $2 R$ centered at the origin. Since $x_{i}$ and $x_{j}$ are separated at least by $R^{B} M^{B}$, (1.5) implies that

$$
\begin{equation*}
\left\|\widehat{d \nu} \mathbf{1}_{i, j}\right\|_{L^{r}\left(\mathbb{R}^{2}\right)} \lesssim \epsilon\left(R^{B} M^{B}\right)^{-\alpha / 2+\epsilon} R^{2 / r} \tag{6.4}
\end{equation*}
$$

We choose $B$ such that

$$
B \geq \frac{8}{\alpha}
$$

and let $\epsilon=\alpha / 4$ in (6.4). Since $r \geq 1$ we have,

$$
\begin{equation*}
\left\|\widehat{d \nu} \mathbf{1}_{i, j}\right\|_{L^{r}\left(\mathbb{R}^{2}\right)} \lesssim(R M)^{-B \alpha / 4} R^{2} \leq M^{-2} \tag{6.5}
\end{equation*}
$$

By (6.3) and (6.5), we obtain that

$$
\begin{align*}
\int \sum_{i \neq j} \widehat{f \mathbf{1}_{Q_{i}}} \overline{\widehat{f \mathbf{1}_{Q_{j}}}} d \nu & \lesssim M^{-2} \sum_{i \neq j}\left\|f \mathbf{1}_{Q_{i}}\right\|_{L^{q}\left(\mathbb{R}^{2}\right)}\left\|f \mathbf{1}_{Q_{j}}\right\|_{L^{q}\left(\mathbb{R}^{2}\right)} \\
& \leq M^{-1}\left(\sum_{i=1}^{M}\left\|f \mathbf{1}_{Q_{i}}\right\|_{L^{q}\left(\mathbb{R}^{2}\right)}^{2}\right)^{1 / 2}\left(\sum_{j=1}^{M}\left\|f \mathbf{1}_{Q_{j}}\right\|_{L^{q}\left(\mathbb{R}^{2}\right)}^{2}\right)^{1 / 2}  \tag{6.6}\\
& \leq M^{-1}\|f\|_{L^{q}\left(\mathbb{R}^{2}\right)}^{2} .
\end{align*}
$$

In the last inequality, we used again that $1 \leq q \leq 2$. Combining (6.2) and (6.6), we obtain (6.1).

Let us turn to the proof of Proposition 6.1.
Proof of Proposition 6.1. The inequality (1.4) follows from Lemma 2.3. If we let $n_{k}^{1 / 2}=m_{k}$, $N_{k}^{1 / 2}=M_{k}, \beta_{k}=\left|E_{k}\right|^{-1}$ and $\alpha_{0}=\alpha$, then $\left\{\mu_{k}\right\}_{k \in \mathbb{N} \cup\{0\}}$ satisfies all conditions of Proposition 5.2. Thus, $\widehat{\nu}$ satisfies (1.5) a.s. Now, we can use Tao's epsilon removal argument to prove (1.6). Lemma 6.2 replaces Lemma 3.2 in [27] and rest of the proof (1.6) is same as in [27, Theorem 1.2].

## 7. Proof of Theorem 1.3

The proof is based on Knapp-type example.
Proof. Since $\nu$ is supported on $\mathbb{P}^{d-1}$, there exists a measure $\mu$ on $[0,1]^{d-1}$ such that

\int f(x) d \nu=\int f\left(x^{\prime},\left|x^{\prime}\right|^{2}\right) d \mu
$$

for all $\nu$-measurable function $f$ on $\mathbb{R}^{d}$ where $x^{\prime} \in \mathbb{R}^{d-1}$. The assumption (1.7) implies that

\mu\left(B\left(x^{\prime}, r\right)\right) \lesssim_{\alpha} r^{\alpha} \tag{7.1}
\end{equation*}
$$

for all $x^{\prime} \in \mathbb{R}^{d-1}$ and $\forall r>0$.
We claim that for any $\epsilon>0$, there exist sequences $\left\{a_{i}\right\}_{i \in \mathbb{N}}$ and $\left\{r_{i}\right\}_{i \in \mathbb{N}}$ such that $\lim _{i \rightarrow \infty} r_{i}=$ 0 and

$$
\begin{equation*}
r_{i}^{\alpha+\epsilon}<\mu\left(B\left(a_{i}, r_{i}\right)\right) \tag{7.2}
\end{equation*}
$$

The measure $\mu$ is supported on a set of Hausdorff dimension $\alpha$ in $\mathbb{R}^{d-1}$. By Frostman's lemma (see for example [18, Theorem 2.7]), $\alpha$ is the supremum of $s$ such that $\mu\left(B\left(x^{\prime}, r\right)\right) \leq r^{s}$ holds for all $x \in \mathbb{R}^{d-1}$ and $r>0$. Towards a contradiction, for given $\epsilon>0$, we assume that $r_{0}>0$ is the smallest such that $\mu\left(B\left(x^{\prime}, r_{0}\right)\right)>r^{\alpha+\epsilon}$ for some $x^{\prime} \in \mathbb{R}^{d-1}$. Let $\mu^{\prime}=r_{0}^{\alpha+\epsilon} \mu$. Since $\nu$ is a probability measure, $\mu([0,1])^{d-1}=1$. If $r \geq r_{0}$, then $\mu^{\prime}(B(x, r)) \leq r_{0}^{\alpha+\epsilon} \mu\left([0,1]^{d-1}\right) \leq r^{\alpha+\epsilon}$. If $r<r_{0}$, then $\mu^{\prime}(B(x, r)) \leq \mu(B(x, r)) \leq r^{\alpha+\epsilon}$. Since $\mu^{\prime}$ is also supported on a set of Hausdorff dimension $\alpha$, it contradicts Frostman's lemma. Therefore, such $r_{0}$ does not exists and we established the claim (7.2).

Assume that the estimate (1.8) holds for some $p$ and $q$ and let $h_{i}\left(x^{\prime}\right)=\mathbf{1}_{[0,1]^{d-1}}\left(r_{i}^{-1}\left(x^{\prime}-a_{i}\right)\right)$. Then, we have

$$
\begin{equation*}
\left(\int\left|\int h_{i}\left(x^{\prime}\right) e\left(-x^{\prime} \cdot \xi^{\prime}-\left|x^{\prime}\right|^{2} \xi_{d}\right) d \mu\left(x^{\prime}\right)\right|^{p} d \xi\right)^{1 / p} \lesssim_{p, q}\left(\int\left|h_{i}\left(x^{\prime}\right)\right|^{q} d \mu\right)^{1 / q} \tag{7.3}
\end{equation*}
$$

where $\xi^{\prime} \in \mathbb{R}^{d-1}$ and $\xi_{d} \in \mathbb{R}$. By (7.1), we obtain that

$$
\begin{equation*}
\left(\int\left|h_{i}\left(x^{\prime}\right)\right|^{q} d \mu\right)^{1 / q} \lesssim \alpha r_{i}^{\alpha / q} . \tag{7.4}
\end{equation*}
$$

By change of variables $\xi^{\prime}=r_{i}^{-1} \zeta^{\prime}$ and $\xi_{d}=r_{i}^{-2} \zeta_{d}$, left-hand side of (7.3) becomes

$$
\begin{equation*}
r_{i}^{-(d+1) / p}\left(\int\left|\int h_{i}\left(x^{\prime}\right) e\left(-r_{i}^{-1}\left(x^{\prime}-a_{i}\right) \cdot\left(\zeta^{\prime}+2 \zeta_{d} r_{i}^{-1} a_{i}\right)-r_{i}^{-2} \zeta_{d}\left|x^{\prime}-a_{i}\right|^{2}\right) d \mu\left(x^{\prime}\right)\right|^{p} d \zeta\right)^{1 / p} \tag{7.5}
\end{equation*}
$$

By considering when $\left|\zeta^{\prime}+2 \zeta_{d} r_{i}^{-1} a_{i}\right| \leq 1 / 100$ and $\left|\zeta_{d}\right| \leq 1 / 100$, (7.2) and (7.5) implies that

$$
\begin{align*}
& \left(\int\left|\int h_{i}\left(x^{\prime}\right) e\left(-x^{\prime} \cdot \xi^{\prime}-\left|x^{\prime}\right|^{2} \xi_{d}\right) d \mu\left(x^{\prime}\right)\right|^{p} d \xi\right)^{1 / p}  \tag{7.6}\\
& \gtrsim r_{i}^{-(d+1) / p}\left|\int \mathbf{1}_{[0,1]^{d-1}}\left(r_{i}^{-1}\left(x^{\prime}-a_{i}\right)\right) d \mu\left(x^{\prime}\right)\right| \gtrsim \alpha, \epsilon r_{i}^{-(d+1) / p+\alpha+\epsilon} .
\end{align*}
$$

We combine (7.3), (7.4) and (7.6), then for any $r_{i}$, we get

$$
r_{i}^{-(d+1) / p+\alpha+\epsilon} \lesssim_{\alpha, \epsilon, p, q} r_{i}^{\alpha / q} .
$$

Therefore,

$$
\frac{\alpha}{q} \leq-\frac{d+1}{p}+\alpha+\epsilon .
$$

Since $\epsilon$ is arbitrary, $p \geq q^{\prime}(d+1) / \alpha$ if the estimate (1.8) holds.

## 8. Appendix

Proof of Lemma 3.1. First, assume that $S_{1}$ is a subset of $\left[-k_{0}, k_{0}\right]^{d} \cap \mathbb{Z}^{d}$. Let $\psi$ be a nonnegative smooth function supported on $[0,1]^{d}$ such that $\psi \geq 1$ on $[1 / 4,3 / 4]^{d}$. For $x \in[-k, k]^{d}$,

1 \leq \sum_{|n| \lesssim k}|\psi(x-n)|^{p}+\sum_{\left|n^{\prime}\right| \lesssim 1} \sum_{|n| \lesssim k}\left|\psi\left(x-n-n^{\prime} / 2\right)\right|^{p}
$$

where $n, n^{\prime} \in \mathbb{Z}^{d}$, but $n^{\prime} \neq 0$. Thus, we have

$$
\begin{aligned}
& \left\|\sum_{a \in S_{1}} \sum_{b \in S_{2, a}} c_{a, b} e((k a+b) \cdot x)\right\|_{L^{p}\left([0,1]^{d}\right)}^{p}=\int_{[0, k]^{d}}\left|\sum_{a \in S_{1}} \sum_{b \in S_{2, a}} c_{a, b} e\left(\left(a+\frac{b}{k}\right) \cdot x\right)\right|^{p} k^{-d} d x \\
& \leq \sum_{|n| \lesssim k} k^{-d} \int_{[0,1]^{d}}\left|\sum_{a \in S_{1}} \sum_{b \in S_{2, a}} c_{a, b} e(a \cdot x) e\left(\frac{b}{k} \cdot(x+n)\right) \psi(x)\right|^{p} d x \\
& +\sum_{\left|n^{\prime}\right| \lesssim 1} \sum_{|n| \lesssim k} k^{-d} \int_{[0,1]^{d}}\left|\sum_{a \in S_{1}} \sum_{b \in S_{2, a}} c_{a, b} e\left(a \cdot\left(x+n^{\prime} / 2\right)\right) e\left(\frac{b}{k} \cdot\left(x+n+n^{\prime} / 2\right)\right) \psi(x)\right|^{p} d x .
\end{aligned}
$$

We will show that the first term is bounded by a constant multiple of

$$
\begin{equation*}
C_{1} C_{2}\left(\sum_{a \in S_{1}} \sum_{b \in S_{2, a}}\left|c_{a, b}\right|^{2}\right)^{p / 2} \tag{8.1}
\end{equation*}
$$

By the same argument, the second term will be also bounded by a constant multiple of (8.1).

Since $\psi$ is supported on $[0,1]^{d}$, we have

\psi(x) e(b \cdot x / k)=\sum_{m \in \mathbb{Z}^{d}} \widehat{\psi}_{b}(m) e(m \cdot x)
$$

where $\widehat{\psi}_{b}(m)$ is the $m$-th Fourier coefficient of $\psi(x) e(b \cdot x / k)$. Since $\sum_{m}\left|\widehat{\psi}_{b}(m)\right| \lesssim 1$ and $S_{1}$ is a subset of $\left[-k_{0}, k_{0}\right]^{d}$, we obtain

\begin{align*}
& \left(\sum_{|n| \lesssim k} k^{-d} \int_{[0,1]^{d}}\left|\sum_{a \in S_{1}} \sum_{b \in S_{2, a}} c_{a, b} e(a \cdot x) e\left(\frac{b}{k} \cdot(x+n)\right) \psi(x)\right|^{p} d x\right)^{1 / p} \\
& \leq \sum_{m \in \mathbb{Z}^{d}}\left(\sum_{|n| \lesssim k} k^{-d} \int_{[0,1]^{d}}\left|\sum_{a \in S_{1}} \sum_{b \in S_{2, a}} c_{a, b} e\left(\frac{b \cdot n}{k}\right) \widehat{\psi}_{b}(m) e((a+m) \cdot x)\right|^{p} d x\right)^{1 / p} \\
& \leq \sum_{m \in \mathbb{Z}^{d}}\left(\sum_{|n| \lesssim k} k^{-d} \int_{[0,1]^{d}}\left|\sum_{a \in S_{1}}\left(\sum_{b \in S_{2, a}} c_{a, b} e\left(\frac{b \cdot n}{k}\right) \widehat{\psi}_{b}(m)\right) e(a \cdot x)\right|^{p} d x\right)^{1 / p}  \tag{8.2}\\
& \leq C_{1} \sum_{m \in \mathbb{Z}^{d}}\left(\sum_{|n| \lesssim k} k^{-d}\left(\sum_{a \in S_{1}}\left|\sum_{b \in S_{2, a}} c_{a, b} e\left(\frac{b \cdot n}{k}\right) \widehat{\psi}_{b}(m)\right|^{2}\right)^{p / 2}\right)^{1 / p}
\end{align*}
$$

In the last inequality, we used (3.3).
First, we consider when $|m| \leq 10$. Since $p \geq 2$ and $|\psi| \lesssim 1$, we get

\begin{align*}
& \left(\sum_{|n| \lesssim k} k^{-d}\left(\sum_{a \in S_{1}}\left|\sum_{b \in S_{2, a}} c_{a, b} e\left(\frac{b \cdot n}{k}\right) \widehat{\psi}_{b}(m)\right|^{2}\right)^{p / 2}\right)^{1 / p} \\
& \leq\left(\sum_{a \in S_{1}}\left(\sum_{|n| \lesssim k} k^{-d}\left|\sum_{b \in S_{2, a}} c_{a, b} e\left(\frac{b \cdot n}{k}\right) \int_{[0,1]^{d}} \psi(x) e\left(\left(\frac{b}{k}-m\right) \cdot x\right) d x\right|^{p}\right)^{2 / p}\right)^{1 / 2}  \tag{8.3}\\
& \lesssim\left(\sum_{a \in S_{1}}\left(k^{-d} \sum_{|n| \lesssim k} \int_{[0,1]^{d}}\left|\sum_{b \in S_{2, a}} c_{a, b} e\left(\frac{b}{k} \cdot(x+n)\right)\right|^{p} d x\right)^{2 / p}\right)^{1 / 2} \\
& \lesssim\left(\sum_{a \in S_{1}}\left\|\sum_{b \in S_{2, a}} c_{a, b} e(b \cdot x)\right\|_{L^{p}\left([0,1]^{d}\right)}^{2}\right)^{1 / 2} \leq C_{2}\left(\sum_{a \in S_{1}} \sum_{b \in S_{2, a}}\left|c_{a, b}\right|^{2}\right)^{1 / 2} .
\end{align*}
$$

In the case when $|m| \geq 10$, since $\psi$ is supported on $[0,1]^{d}$ and decreases rapidly, we can use the principle of stationary phase. Let $(b / k-m)_{i}$ denote the $i$-th coordinate of $(b / k-m)$ and denote $\nabla_{b, k, m}$ by

$$
\nabla_{b, k, m}=\sum_{i=1}^{d}\left|\frac{b}{k}-m\right|^{-2}\left(\frac{b}{k}-m\right)_{i} \frac{\partial}{\partial x_{i}}
$$

Note that

$$
\widehat{\psi}_{b}(m)=\int_{[0,1] d}\left(\nabla_{b, k, m}^{2} \psi(x)\right) e\left(\left(\frac{b}{k}-m\right) x\right) d x
$$

If we let

$$
\tilde{c}_{a, b, i, j, m}=c_{a, b}\left|\frac{b}{k}-m\right|^{-4}\left(\frac{b}{k}-m\right)_{i}\left(\frac{b}{k}-m\right)_{j}
$$

it is well defined since $|b| \leq k$ and $|m| \geq 10$. Then we obtain

$$
\left|\sum_{b \in S_{2, a}} c_{a, b} e\left(\frac{b \cdot n}{k}\right) \widehat{\psi}_{b}(m)\right| \leq \sum_{i, j=1}^{d} \int_{[0,1] d}\left|\sum_{b \in S_{2, a}} \tilde{c}_{a, b, i, j, m} e\left(\frac{b}{k} \cdot(x+n)\right) \partial_{i j} \psi(x)\right| d x
$$

Since $\left|\partial_{i, j} \psi\right| \lesssim 1$ uniformly in $i$ and $j$, we obtain that

$$
\begin{aligned}
& \left(\sum_{|n| \lesssim k} k^{-d}\left(\sum_{a \in S_{1}}\left|\sum_{b \in S_{2, a}} c_{a, b}\left(\frac{b \cdot n}{k}\right) \widehat{\psi}_{b}(m)\right|^{2}\right)^{p / 2}\right)^{1 / p} \\
& \lesssim \sum_{i, j=1}^{d}\left(\sum_{a \in S_{1}}\left(k^{-d} \sum_{|n| \lesssim k} \int_{[0,1]^{d}}\left|\sum_{b \in S_{2, a}} \tilde{c}_{a, b, i, j, m} e\left(\frac{b}{k} \cdot(x+n)\right)\right|^{p} d x\right)^{2 / p}\right)^{1 / 2} \\
& \lesssim \sum_{i, j=1}^{d}\left(\sum_{a \in S_{1}}\left\|\sum_{b \in S_{2, a}} \tilde{c}_{a, b, i, j, m} e(b \cdot x)\right\|_{L^{p}\left([0,1]^{d}\right)}^{2}\right)^{1 / 2} \\
& \leq C_{2} \sum_{i, j=1}^{d}\left(\sum_{a \in S_{1}} \sum_{b \in S_{2, a}}\left|\tilde{c}_{a, b, i, j, m}\right|^{2}\right)^{1 / 2} \lesssim_{d} C_{2}|m|^{-2}\left(\sum_{a \in S_{1}} \sum_{b \in S_{2, a}}\left|c_{a b}\right|^{2}\right)^{1 / 2}
\end{aligned}
$$

In the last inequality, we used that $|b / k-m| \approx|m|$ since $|m| \geq 10$. Therefore,

$$
\begin{align*}
& \sum_{|m| \geq 10}\left(\sum_{|n| \lesssim k} k^{-d}\left(\sum_{a \in S_{1}}\left|\sum_{b \in S_{2, a}} c_{a, b} e\left(\frac{b \cdot n}{k}\right) \widehat{\psi}_{b}(m)\right|^{2}\right)^{p / 2}\right)^{1 / p} \\
& \lesssim C_{2} \sum_{|m| \geq 10}|m|^{-2}\left(\sum_{a \in S_{1}} \sum_{b \in S_{2, a}}\left|c_{a, b}\right|^{2}\right)^{1 / 2}  \tag{8.4}\\
& \lesssim C_{2}\left(\sum_{a \in S_{1}} \sum_{b \in S_{2, a}}\left|c_{a, b}\right|^{2}\right)^{1 / 2}
\end{align*}
$$

By (8.2), (8.3) and (8.4), it follows that

$$
\begin{aligned}
& \left(\sum_{|n| \lesssim k} k^{-d} \int_{[0,1]^{d}}\left|\sum_{a \in S_{1}} \sum_{b \in S_{2, a}} c_{a, b} e(a \cdot x) e\left(\frac{b}{k} \cdot(x+n)\right) \psi(x)\right|^{p} d x\right)^{1 / p} \\
& \lesssim C_{1} C_{2}\left(\sum_{a \in S_{1}} \sum_{b \in S_{2, a}}\left|c_{a, b}\right|^{2}\right)^{1 / 2}
\end{aligned}
$$

We proved Lemma 3.1 when $S_{1}$ is a subset of $\left[-k_{0}, k_{0}\right]^{d} \cap \mathbb{Z}^{d}$. The estimate holds for arbitrary $k_{0}$. Thus, letting $k_{0} \rightarrow \infty$ finishes the proof.

Proof of Lemma 3.2. The inequality $K_{p}\left(E_{j}\right) \lesssim p D_{p}\left(E_{j}\right)$ is well known (see for example [8, Theorem 13.1]). Thus, it suffices to prove the converse. Let $R$ be a positive large number and $S$ be a subset of $[-R, R]^{d} \cap \mathbb{Z}^{d}$ such that

$$
\begin{equation*}
\left\|\sum_{a \in S} c_{a} e(a \cdot x)\right\|_{L^{p}\left([0,1]^{d}\right)} \leq C\left(\sum_{a \in S}\left|c_{a}\right|^{2}\right)^{1 / 2} \tag{8.5}
\end{equation*}
$$

and let

$$
\widehat{f}_{a}(\xi)=\widehat{f}(\xi) \mathbf{1}_{[0,1]^{d}}(R \xi-a)
$$

Let us consider a Schwartz function $\eta$ such that $|\eta| \geq 1$ on $[-1,1]^{d}$ and $\widehat{\eta}$ is supported on $[0,1]^{d}$. Recall that $B^{d}(R)$ is a cube of side length $R$ in $\mathbb{R}^{d}$ centered at the origin. We will show that for any $f$ such that $f=\sum_{a \in S} f_{a}$,

$$
\begin{equation*}
\|f\|_{L^{p}\left(B^{d}(R)\right)} \lesssim C\left(\sum_{a \in S}\left\|f_{a}\right\|_{L^{p}\left(\eta_{R}\right)}^{2}\right)^{1 / 2} \tag{8.6}
\end{equation*}
$$

where $\eta_{R}(x)=\eta(x / R)$ and $C$ is the constant in (8.5). Then (8.6) implies that

$$
\begin{equation*}
\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)} \lesssim C\left(\sum_{a \in S}\left\|f_{a}\right\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{2}\right)^{1 / 2} \tag{8.7}
\end{equation*}
$$

For the proof of (8.7) from (8.6), see [8, Proposition 9.15] and [16, Chapter 4.1]. Thus, Lemma 3.2 easily follows.

Now we prove (8.6). We have

$$
\begin{align*}
\|f\|_{L^{p}\left(B^{d}(R)\right)} & \leq\left\|f \eta_{R}\right\|_{L^{p}\left(B^{d}(R)\right)} \\
& =\left\|\sum_{a \in S} \int \widehat{f}_{a} * \widehat{\eta}_{R}(\xi) e(-x \cdot \xi) d \xi\right\|_{L^{p}\left(B^{d}(R)\right)} \tag{8.8}
\end{align*}
$$

The function $\widehat{f}_{a} * \widehat{\eta}_{R}$ is supported on a cube of side length $O\left(R^{-1}\right)$ centered at $a / R$. Therefore, by change of variables $\xi=R^{-1} \zeta$ and $R^{-1} x=z$, (8.8) is

$$
\begin{aligned}
& \leq R^{-d+d / p} \sum_{|c| \lesssim 1} \int_{[0,1]^{d}}\left\|\sum_{a \in S} \widehat{f}_{a} * \widehat{\eta}_{R}\left(R^{-1}(\zeta+a+c)\right) e(-z \cdot(\zeta+a+c))\right\|_{L^{p}\left(B^{d}(1)\right)} d \zeta \\
& \lesssim R^{-d+d / p} \sum_{|c| \lesssim 1} \int_{[0,1]^{d}}\left\|\sum_{a \in S} \widehat{f}_{a} * \widehat{\eta}_{R}\left(R^{-1}(\zeta+a+c)\right) e(-z \cdot a)\right\|_{L^{p}\left(B^{d}(1)\right)} d \zeta .
\end{aligned}
$$

By (8.5), we obtain that

$$
\begin{aligned}
\|f\|_{L^{p}\left(B^{d}(R)\right)} & \lesssim C R^{-d+d / p} \sum_{|c| \lesssim 1} \int_{[0,1]^{d}}\left(\sum_{a \in S}\left|\widehat{f}_{a} * \widehat{\eta}_{R}\left(R^{-1}(\zeta+a+c)\right)\right|^{2}\right)^{1 / 2} d \zeta \\
& \lesssim C R^{-d+d / p} \sum_{|c| \lesssim 1}\left(\sum_{a \in S} \int_{[0,1]^{d}}\left|\widehat{f}_{a} * \widehat{\eta}_{R}\left(R^{-1}(\zeta+a+c)\right)\right|^{2} d \zeta\right)^{1 / 2} \\
& \lesssim C R^{-d / 2+d / p}\left(\sum_{a \in S}\left\|\widehat{f}_{a} * \widehat{\eta}_{R}(\xi)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}\right)^{1 / 2} \\
& \leq C R^{-d / 2+d / p}\left(\sum_{a \in S}\left\|f_{a} \eta_{R}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}\right)^{1 / 2} \\
& \leq C R^{-d / 2+d / p}\left(\sum_{a \in S}\left\|f_{a}\right\|_{L^{p}\left(\eta_{R}\right)}^{2}\left\|\eta_{R}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}^{1-2 / p}\right)^{1 / 2} .
\end{aligned}
$$

Since $\left\|\eta_{R}\right\|_{L^{1}} \approx R^{d}$, this completes the proof of (8.6).
