# Error analysis for a Crouzeix-Raviart approximation of the obstacle problem

#### Abstract

In the present paper, we study a Crouzeix-Raviart approximation of the obstacle problem, which imposes the obstacle constraint in the midpoints (i.e., barycenters) of the elements of a triangulation. We establish a priori error estimates imposing natural regularity assumptions, which are optimal, and the reliability and efficiency of a primal-dual type a posteriori error estimator for general obstacles and involving data oscillation terms stemming only from the right-hand side. Numerical experiments are carried out to support the theoretical findings.


Keywords: Obstacle problem; Crouzeix-Raviart element; a priori error analysis; a posteriori error analysis.

## 1. Introduction

The obstacle problem is a prototypical example of a non-smooth convex minimization problem with an inequality constraint that leads to a variational inequality. It has countless applications, e.g., in the contexts of fluid filtration in porous media, constrained heating, elasto-plasticity, optimal control, and financial mathematics, cf. [14, 29]. It is deeply related to models in free boundary value problems, the study of minimal surfaces, and the capactity of a set in potential theory, cf. [14]. The problem is to find the equilibrium position of an elastic membrane whose boundary is held fixed and which is constrained to lie above a given obstacle.

More precisely, given an external force $f \in L^{2}(\Omega)$ and an obstacle $\chi \in W^{1,2}(\Omega)$ with $\operatorname{tr} \chi \leq 0$ on $\Gamma_{D}$, where $\Gamma_{D} \subseteq \partial \Omega$ denotes the Dirichlet part of the topological boundary $\partial \Omega$, the obstacle problem seeks for a minimizer $u \in W_{D}^{1,2}(\Omega):=\left\{v \in W^{1,2}(\Omega) \mid \operatorname{tr} v=0\right.$ in $\left.\Gamma_{D}\right\}$ of the energy functional $I: W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R} \cup\{+\infty\}$, for every $v \in W_{D}^{1,2}(\Omega)$ defined by

where

and $I_{K}: W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R} \cup\{+\infty\}$ is defined by $I_{K}(v):=0$ if $v \in K$ and $I_{K}(v):=+\infty$ else.

### 1.1 Related contributions

The numerical approximation of (1.1) has already been the subject of numerous contributions: Early contributions examing the a priori and a posteriori error analysis of approximations of (1.1) using the conforming Lagrange finite element can be found in $[26,1,32,37,38,13,43,17,42,10,11$, $9,48,27]$, imposing the obstacle constraint in the nodes of a triangulation, and in [34, 28], enforcing the obstacle constraint in the limit via a penalization approach. We refer to [17] for a short review. Contributions addressing the a priori and a posteriori error analysis of an approximation of (1.1) deploying Discontinuous Galerkin (DG) type methods can be found in [30, 18, 5], equally imposing the obstacle constraint in the nodes of a triangulation. The first contribution addressing the a priori error analysis of an approximation of (1.1) in two dimensions deploying the Crouzeix-Raviart element can be found in [47] and imposes the obstacle constraint in the midpoints (i.e., barycenters) of elements of a triangulation. In [6], for homogeneous Dirichlet boundary data and zero obstacle, this result was extended to arbitrary dimensions. In [15], an a priori and a posterior error analysis of an approximation of (1.1) deploying the Crouzeix-Raviart element which imposes the obstacle constraint in the integral mean values of element sides of a triangulation was carried out.

### 1.2 New contributions

Inspired by [47] as well as recent contributions [5, 6, 7], different from the contribution [15], we treat an approximation of the obstacle problem (1.1) deploying the Crouzeix-Raviart element that imposes the obstacle constraint in the midpoints (i.e., barycenters) of elements of a triangulation. More precisely, given a family of regular triangulations $\mathcal{T}_{h}, h>0$, setting $f_{h}:=\Pi_{h} f \in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$ and for $\chi_{h} \in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$ approximating $\chi \in W^{1,2}(\Omega)$, our discrete obstacle problem seeks for a minimizer $u_{h}^{c r} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$ of the functional $I_{h}^{c r}: \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right) \rightarrow \mathbb{R} \cup\{+\infty\}$, for every $v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$ defined by

where

K_{h}^{c r}:=\left\{v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right) \mid \Pi_{h} v_{h} \geq \chi_{h} \text { a.e. in } \Omega\right\}

and $I_{K_{h}^{c r}}: \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right) \rightarrow \mathbb{R} \cup\{+\infty\}$ is defined by $I_{K_{h}^{c r}}\left(v_{h}\right):=0$ if $v_{h} \in K_{h}^{c r}$ and $I_{K_{h}^{c r}}\left(v_{h}\right):=+\infty$ else. Here, $\mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$ denotes the space of element-wise constant functions, $\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$ the Crouzeix-Raviart finite element space, i.e., the space of element-wise affine functions that are continuous in the midpoints (i.e., barycenters) of inner element sides and that vanish in the midpoints of element sides that belong to $\Gamma_{D}, \nabla_{h}: \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right) \rightarrow \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$ the element-wise gradient and $\Pi_{h}: L^{2}(\Omega) \rightarrow \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$ the (local) $L^{2}$-projection operator onto element-wise constant functions. Imposing the obstacle constraint in the midpoints of elements follows a systematic approximation procedure for general convex minimization problems deploying the Crouzeix-Raviart element introduced in [6, 7] and has the advantage that the resulting discrete convex minimization problem generates discrete convex duality relations that are analogous to those in the continuous setting -up to non-conforming modifications- and that enable a systematic a priori error analysis and a posteriori error analysis:

- In [6], a systematic procedure for the derivation of a priori error estimates for convex minimization problems deploying the Crouzeix-Raviart element based on (discrete) convex duality relations was proposed. Following this systematic procedure, with comparably little effort, we derive a priori error estimates, which are optimal for natural regularity assumptions and also apply in arbitrary dimensions. More precisely, our a priori error estimates exploit that the discrete primal-dual gap controls the convexity measure of (1.2) and the concavity measure of its dual functional, i.e., that for every $v_{h} \in K_{h}^{c r}$ and $y_{h} \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right)$, it holds

where $\mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right)$ denotes the Raviart-Thomas finite element space, i.e., the space of elementwise affine vector fields that have continuous constant normal components on element sides that vanish on $\Gamma_{N}, z_{h}^{r t} \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right)$ the unique discrete dual solution, i.e., the maximizer of
the discrete dual energy functional $D_{h}^{c r}: \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right) \rightarrow \mathbb{R} \cup\{-\infty\}$, and $\bar{\lambda}_{h}^{c r} \in \Pi_{h}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)\right)$ the unique discrete Lagrange multiplier satisfying $\bar{\lambda}_{h}^{c r} \leq 0$ a.e. in $\Omega$ and for all $v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$

\left(\bar{\lambda}_{h}^{c r}, \Pi_{h} v_{h}\right)_{\Omega}=\left(f_{h}, \Pi_{h} v_{h}\right)_{\Omega}-\left(\nabla_{h} u_{h}^{c r}, \nabla_{h} v_{h}\right)_{\Omega}

If $\chi_{h}:=\Pi_{h} I_{c r} \chi \in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$, where $I_{c r}: W^{1,2}(\Omega) \rightarrow \mathcal{S}^{1, c r}(\Omega)$ denotes the Crouzeix-Raviart quasi-interpolation operator, then $I_{c r} u \in K_{h}^{c r}$. Thus, under natural regularity assumptions, i.e., $u, \chi \in W^{2,2}(\Omega)$, the choices $v_{h}=I_{c r} u \in K_{h}^{c r}$ and $y_{h}=I_{r t} z \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right)$, where $z=$ $\nabla u \in W^{1,2}\left(\Omega ; \mathbb{R}^{d}\right) \cap W_{N}^{2}(\operatorname{div} ; \Omega)$ denotes the dual solution, i.e., the maximizer of the dual energy functional $D: L^{2}\left(\Omega ; \mathbb{R}^{d}\right) \rightarrow \mathbb{R} \cup\{-\infty\}$, and $I_{r t}: W^{1,2}\left(\Omega ; \mathbb{R}^{d}\right) \cap W_{N}^{2}(\operatorname{div} ; \Omega) \rightarrow \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right)$ the Raviart-Thomas quasi-interpolation operator, are admissible in (1.3) and lead to quasioptimal a priori error estimates.

- In [7], a systematic procedure for the derivation of reliable, quasi-constant-free a posteriori error estimates for convex minimization problems deploying the Crouzeix-Raviart element based on (discrete) convex duality relations was proposed. Following this systematic procedure, we derive a posteriori error estimates, which, by definition, are reliable and constant-free. Apart from that, we establish the efficiency of these a posteriori error estimates for general obstacles $\chi \in W^{1,2}(\Omega)$. More precisely, our a posteriori error estimates exploit that the primal-dual gap controls the convexity measure of (1.1) and the concavity measure of its dual functional, i.e., that for every $v \in K$ and $y \in L^{2}\left(\Omega ; \mathbb{R}^{d}\right)$, it holds

where $\Lambda \in\left(W_{D}^{1,2}(\Omega)\right)^{*}$ is the unique Lagrange multiplier satisfying $\Lambda \leq 0$ in $\left(W_{D}^{1,2}(\Omega)\right)^{*}$ and for all $v \in W_{D}^{1,2}(\Omega)$

\langle\Lambda, v\rangle_{\Omega}=(f, v)_{\Omega}-(\nabla u, \nabla v)_{\Omega}

For the a posteriori error estimate (1.4) being practicable it is necessary to have a sufficiently accurate and computationally cheap procedure to obtain an approximation $y \in L^{2}\left(\Omega ; \mathbb{R}^{d}\right)$ of the dual solution $z=\nabla u \in L^{2}\left(\Omega ; \mathbb{R}^{d}\right)$ at hand. In the case $f=f_{h} \in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$, the discrete dual solution $z_{h}^{r t} \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right)$ is admissible in (1.4) and leads to a constant-free reliable and efficient a posteriori error estimator $\eta_{h}^{2}:=I-D\left(z_{h}^{r t}\right): W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R}$, which has similarities to the residual type a posteriori estimator derived in [42] but is simper and avoids jump terms of the obstacle that arise in the efficiency analysis in [42]. In particular, note that the discrete dual solution can cheaply be computed via the generalized Marini formula

A typical choice of $v \in K$ is obtained via nodal averaging $u_{h}^{c r} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$ and truncating to enforce the continuous obstacle constraint. Moreover, any conforming approximation $u_{h} \in K$ can be used such as a continuous Lagrange approximation $u_{h}^{c} \in K_{h}^{c}:=K \cap \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$, so that our analysis also implies the full reliability and efficiency error analysis for continuous Lagrange approximations, even for general obstacles and oscillation terms only stemming from the right-hand side since lumping is not needed in our analysis.
As a whole, our approach brings together and extends ideas and concepts from [13, 43, 42, 10, 11, 15], and leads to a full error analysis.

### 1.3 Outline

This article is organized as follows: In Section 2, we introduce the notation, the relevant function spaces and finite element spaces. In Section 3, we give a brief review of the continuous and the discrete obstacle problem. In Section 4, we prove a priori error estimates for the Crouzeix-Raviart approximation (1.2) of (1.1), which are optimal for natural regularity assumptions. In Section 5, we introduce a primal-dual a posteriori error estimator and establish its reliability and efficiency. In Section 6, numerical experiments are carried out to confirm the theoretical findings. In the Appendix A, we derive local efficiency estimates for the Crouzeix-Raviart approximation (1.2) of (1.1).

## 2. Preliminaries

Throughout the article, let $\Omega \subseteq \mathbb{R}^{d}, d \in \mathbb{N}$, be a bounded polyhedral Lipschitz domain whose boundary $\partial \Omega$ is disjointly divided into a closed Dirichlet part $\Gamma_{D}$, for which we assume that $\left|\Gamma_{D}\right|>0^{1}$, and a Neumann part $\Gamma_{N}$. For (Lebesgue) measurable functions $u, v: \Omega \rightarrow \mathbb{R}$ and a (Lebesgue) measurable set $M \subseteq \Omega$, we employ the product

whenever the right-hand side is well-defined. Analogously, for (Lebesgue) measurable vector fields $z, y: \Omega \rightarrow \mathbb{R}^{d}$ and a (Lebesgue) measurable set $M \subseteq \Omega$, we write $(z, y)_{M}:=\int_{M} z \cdot y \mathrm{~d} x$.

### 2.1 Standard function spaces

For $l \in \mathbb{N}$, we let

$W^{1,2}\left(\Omega ; \mathbb{R}^{l}\right):=W_{D}^{1,2}\left(\Omega ; \mathbb{R}^{l}\right)$ in the case $\Gamma_{D}=\emptyset$, and $W^{2}(\operatorname{div} ; \Omega):=W_{N}^{2}(\operatorname{div} ; \Omega)$ in the case $\Gamma_{N}=\emptyset$. Here, $\operatorname{tr}: W^{1,2}\left(\Omega ; \mathbb{R}^{l}\right) \rightarrow L^{2}\left(\partial \Omega ; \mathbb{R}^{l}\right)$ and $\operatorname{tr}_{n}: W^{2}(\operatorname{div} ; \Omega) \rightarrow W^{-\frac{1}{2}, 2}(\partial \Omega)$ denote the trace and normal trace operator, respectively. More precisely, $\operatorname{tr}_{n} y=y \cdot n$ on $\partial \Omega$ for all $y \in C^{0}\left(\bar{\Omega} ; \mathbb{R}^{d}\right)$, where $n: \partial \Omega \rightarrow \mathbb{S}^{d-1}$ denotes the outer unit normal vector field to $\Omega$. We always omit $\operatorname{tr}(\cdot)$ and $\operatorname{tr}_{n}(\cdot)$. For a compact notation, we abbreviate $L^{2}(\Omega):=L^{2}\left(\Omega ; \mathbb{R}^{1}\right), W^{1,2}(\Omega):=W^{1,2}\left(\Omega ; \mathbb{R}^{1}\right), W_{D}^{1,2}(\Omega):=$ $W_{D}^{1,2}\left(\Omega ; \mathbb{R}^{1}\right),\|\cdot\|_{\Omega}:=\|\cdot\|_{L^{2}\left(\Omega ; \mathbb{R}^{l}\right)},\|\cdot\|_{*, \Omega}:=\|\cdot\|_{\left(W_{D}^{1,2}\left(\Omega ; \mathbb{R}^{l}\right)\right)^{*}}$, and $\langle\cdot, \cdot\rangle_{\Omega}:=\langle\cdot, \cdot\rangle_{W_{D}^{1,2}\left(\Omega ; \mathbb{R}^{l}\right)}, l \in \mathbb{N}$.

### 2.2 Triangulations and standard finite element spaces

Throughout the article, let $\mathcal{T}_{h}, h>0$, be a family of uniformly shape regular and conforming, triangulations of $\Omega \subseteq \mathbb{R}^{d}, d \in \mathbb{N}$, cf. [25]. Here, the parameter $h>0$ denotes the average mesh-size, i.e., $h:=\frac{1}{\operatorname{card}\left(\mathcal{T}_{h}\right)} \sum_{T \in \mathcal{T}_{h}} h_{T}$, where $h_{T}:=\operatorname{diam}(T)>0$ for all $T \in \mathcal{T}_{h}$. We assume there exists $\omega_{0}>0$, independent of $h>0$, such that $\max _{T \in \mathcal{T}_{h}} h_{T} \rho_{T}^{-1} \leq \omega_{0}$, where $\rho_{T}:=\sup \left\{r>0 \mid \exists x \in T: B_{r}^{d}(x) \subseteq T\right\}$ for all $T \in \mathcal{T}_{h}$. The smallest such constant is called the chunkiness of $\left(\mathcal{T}_{h}\right)_{h>0}$. For every $T \in \mathcal{T}_{h}$, let $\omega_{T}:=\bigcup\left\{T^{\prime} \in \mathcal{T}_{h} \mid T^{\prime} \cap T \neq \emptyset\right\}$ denote the element patch of $T$. Then, we assume that int $\left(\omega_{T}\right)$ is connected for all $T \in \mathcal{T}_{h}$, so that $\operatorname{card}\left(\bigcup\left\{T^{\prime} \in \mathcal{T}_{h} \mid T^{\prime} \subseteq \omega_{T}\right\}\right)+\operatorname{card}\left(\bigcup\left\{T^{\prime} \in \mathcal{T}_{h} \mid T \subseteq \omega_{T^{\prime}}\right\}\right) \leq c$, where $c>0$ depends only on the chunkiness $\omega_{0}>0$, and $|T| \sim\left|\omega_{T}\right|$ for all $T \in \mathcal{T}_{h}$. Eventually, we define the maximum mesh-size by $h_{\max }:=\max _{T \in \mathcal{T}_{h}} h_{T}>0$.

We define interior and boundary sides of $\mathcal{T}_{h}$ in the following way: an interior side is the closure of the non-empty relative interior of $\partial T \cap \partial T^{\prime}$, where $T, T^{\prime} \in \mathcal{T}_{h}$ are two adjacent elements. For an interior side $S:=\partial T \cap \partial T^{\prime} \in \mathcal{S}_{h}$, where $T, T^{\prime} \in \mathcal{T}_{h}$, the side patch is defined by $\omega_{S}:=T \cup T^{\prime}$. A boundary side is the closure of the non-empty relative interior of $\partial T \cap \partial \Omega$, where $T \in \mathcal{T}_{h}$ denotes a boundary element of $\mathcal{T}_{h}$. For a boundary side $S:=\partial T \cap \partial \Omega$, the side patch is defined by $\omega_{S}:=T$. Eventually, by $\mathcal{S}_{h}^{i}$, we denote the set of interior sides, and by $\mathcal{S}_{h}$, we denote the set of all sides.

For (Lebesgue) measurable functions $u, v: \mathcal{S}_{h} \rightarrow \mathbb{R}$ and $\mathcal{M}_{h} \subseteq \mathcal{S}_{h}$, we employ the product

whenever all integrals are well-defined. Analogously, for (Lebesgue) measurable vector fields $z, y: \mathcal{S}_{h} \rightarrow \mathbb{R}^{d}$ and $\mathcal{M}_{h} \subseteq \mathcal{S}_{h}$, we write $(z, y)_{\mathcal{M}_{h}}:=\sum_{S \in \mathcal{M}_{h}}(z, y)_{S}$, where $(z, y)_{S}:=\int_{S} z \cdot y \mathrm{~d} s$

[^1]For $k \in \mathbb{N} \cup\{0\}$ and $T \in \mathcal{T}_{h}$, let $\mathcal{P}_{k}(T)$ denote the set of polynomials of maximal degree $k$ on $T$. Then, for $k \in \mathbb{N} \cup\{0\}$ and $l \in \mathbb{N}$, the sets of continuous and element-wise polynomial functions or vector fields, respectively, are defined by

The side-wise constant mesh-size function $h_{\mathcal{S}} \in \mathcal{L}^{0}\left(\mathcal{S}_{h}\right)$ is defined by $\left.h_{\mathcal{S}}\right|_{S}:=h_{S}$ for all $S \in \mathcal{S}_{h}$, where $h_{S}:=\operatorname{diam}(S)$ for all $S \in \mathcal{S}_{h}$. If $\mathcal{N}_{h}$ contains the vertices of $\mathcal{T}_{h}$, for every $T \in \mathcal{T}_{h}$ and $S \in \mathcal{S}_{h}$, we denote by $x_{T}:=\frac{1}{d+1} \sum_{z \in \mathcal{N}_{h} \cap T} z \in T$ and $x_{S}:=\frac{1}{d} \sum_{z \in \mathcal{N}_{h} \cap S z} \in S$, the barycenters of $T$ and $S$, respectively. Then, the functions $\varphi_{S} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right), S \in \mathcal{S}_{h} \backslash \Gamma_{D}$, form a basis of $\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$. There exists a constant $c_{P}^{c r}>0$, depending only on the chunkiness $\omega_{0}>0$, such that for every $v_{h} \in \mathcal{S}^{1, c r}\left(\mathcal{T}_{h}\right)$, it holds the discrete Poincaré inequality

Then, the vector fields $\psi_{S} \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right), S \in \mathcal{S}_{h} \backslash \Gamma_{N}$ form a basis of $\mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right)$. The quasi-interpolation operator $I_{r t}: W^{1,2}\left(\Omega ; \mathbb{R}^{d}\right) \cap W_{N}^{2}(\operatorname{div} ; \Omega) \rightarrow$ $\mathcal{R} T_{N}^{0}\left(\mathcal{T}_{h}\right)$, for every $y \in W^{1,2}\left(\Omega ; \mathbb{R}^{d}\right) \cap W_{N}^{2}(\operatorname{div} ; \Omega)$ defined by

There exists a constant $c_{r t}>0$, depending only on the chunkiness $\omega_{0}>0$, such that for every $y \in W^{1,2}\left(\Omega ; \mathbb{R}^{d}\right) \cap W_{N}^{2}($ div; $\Omega)$ and $T \in \mathcal{T}_{h}$, cf. [25, Theorem 16.4], it holds
(RT.1) $\left\|I_{r t} y\right\|_{T} \leq c_{r t}\left(\left\|I_{r t} y\right\|_{T}+h_{T}\|\nabla y\|_{T}\right)$,

In $[16,5,6,7]$, the discrete integration-by-parts formula (2.5) formed a cornerstone in the derivation of a discrete convex duality theory and, as such, also plays a central role in the hereinafter analysis. For instance, cf. [6, Lemma 2.1], for every $v \in W_{D}^{1,2}(\Omega)$ and $y \in W^{1,2}\left(\Omega ; \mathbb{R}^{d}\right) \cap W_{N}^{2}($ div; $\Omega),(2.5)$ enables to exchange quasi-interpolation operators via

## 3. Obstacle Problem

In this section, we discuss the continuous and the discrete obstacle problem.

### 3.1 Continuous obstacle problem

Primal problem. Given a force $f \in L^{2}(\Omega)$ and an obstacle $\chi \in W^{1,2}(\Omega)$ with $\chi \leq 0$ on $\Gamma_{D}$, the (continuous) obstacle problem is defined via the minimization of $I: W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R} \cup\{+\infty\}$, for every $v \in W_{D}^{1,2}(\Omega)$ defined by

\begin{equation*}
I(v):=\frac{1}{2}\|\nabla v\|_{\Omega}^{2}-(f, v)_{\Omega}+I_{K}(v) \tag{3.1}
\end{equation*}
$$

where

$$
K:=\left\{v \in W_{D}^{1,2}(\Omega) \mid v \geq \chi \text { a.e. in } \Omega\right\}
$$

and $I_{K}: W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R} \cup\{+\infty\}$ is given via $I_{K}(v):=0$ if $v \in K$ and $I_{K}(v):=+\infty$ else. In what follows, we refer to the minimization of the functional (3.1) as the primal problem. Since the functional (3.1) is proper, strictly convex, weakly coercive, and lower semi-continuous, cf. [3, Theorem 5.1], the direct method in the calculus of variations, cf. [20], yields the existence of a unique minimizer $u \in K$, called the primal solution. In what follows, we reserve the notation $u \in K$ for the primal solution. Since the functional (3.1) is not Fréchet differentiable, the optimality conditions associated with the primal problem are not given via a variational equality. Instead, they are given via a variational inequality. In fact, cf. [3, Theorem 5.2], $u \in K$ is minimal for (3.1) if and only if for every $v \in K$

Dual problem. Appealing to [24, Section 2.4, p. 84 ff .], the dual problem to the obstacle problem is defined via the maximization of $D: L^{2}\left(\Omega ; \mathbb{R}^{d}\right) \rightarrow \mathbb{R} \cup\{-\infty\}$, for every $y \in L^{2}\left(\Omega ; \mathbb{R}^{d}\right)$ defined by

D(y):=-\frac{1}{2}\|y\|_{\Omega}^{2}-I_{K}^{*}(\operatorname{Div}(y)+F) \tag{3.3}
\end{equation*}
$$

where $I_{K}^{*}:\left(W_{D}^{1,2}(\Omega)\right)^{*} \rightarrow \mathbb{R} \cup\{+\infty\}$ is defined by $I_{K}^{*}\left(v^{*}\right):=0$ if $\left\langle v^{*}, v\right\rangle_{W_{D}^{1,2}(\Omega)} \leq 0$ for all $v \in K$ and $I_{K}^{*}\left(v^{*}\right):=+\infty$ else, Div: $L^{2}\left(\Omega ; \mathbb{R}^{d}\right) \rightarrow\left(W_{D}^{1,2}(\Omega)\right)^{*}$ is defined by $\langle\operatorname{Div} y, v\rangle_{\Omega}:=-(y, \nabla v)_{\Omega}$ for all $y \in$ $L^{2}\left(\Omega ; \mathbb{R}^{d}\right)$ and $v \in W_{D}^{1,2}(\Omega)$, and $F \in\left(W_{D}^{1,2}(\Omega)\right)^{*}$ is defined by $\langle F, v\rangle_{\Omega}:=(f, v)_{\Omega}$ for all $v \in W_{D}^{1,2}(\Omega)$. For every $y \in W_{N}^{2}(\operatorname{div} ; \Omega)$, there holds the representation

where $I_{-}: L^{2}(\Omega) \rightarrow \mathbb{R} \cup\{+\infty\}$ is defined by $I_{-}(g):=0$ if $g \in L^{2}(\Omega)$ with $g \leq 0$ a.e. in $\Omega$ and $I_{-}(g):=+\infty$ else. Moreover, in [24, Section 2.4, p. 84 ff.$\left.\right]$, it is shown that there exists a unique maximizer $z \in L^{2}\left(\Omega ; \mathbb{R}^{d}\right)$ of (3.3), called the dual solution, and a strong duality relation, i.e.,

Due to [3, Theorem 5.2], there exists a Lagrange multiplier $\Lambda \in\left(W_{D}^{1,2}(\Omega)\right)^{*}$ with $\Lambda \leq 0$ in $\left(W_{D}^{1,2}(\Omega)\right)^{*}$, i.e., $\langle\Lambda, v\rangle_{\Omega} \leq 0$ for all $v \in W_{D}^{1,2}(\Omega)$ with $v \geq 0$ for a.e. $\Omega$, such that for every $v \in W_{D}^{1,2}(\Omega)$, it holds the augmented problem

(\nabla u, \nabla v)_{\Omega}+\langle\Lambda, v\rangle_{\Omega}=(f, v)_{\Omega} \tag{3.8}

i.e., $\Lambda=\operatorname{Div} z+f$ in $\left(W_{D}^{1,2}(\Omega)\right)^{*}$. Then, cf. [3, Theorem 5.2], there holds the complementary condition

### 3.2 Discrete obstacle problem

Discrete primal problem. Given a force $f \in L^{2}(\Omega)$ and an obstacle $\chi \in W^{1,2}(\Omega)$ such that $\chi \leq 0$ on $\Gamma_{D}$, with $f_{h}:=\Pi_{h} f \in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$ and $\chi_{h} \in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$ approximating $\chi$, the discrete obstacle problem is defined via the minimization of $I_{h}^{c r}: \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right) \rightarrow \mathbb{R} \cup\{+\infty\}$, for every $v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$ defined by

I_{h}^{c r}\left(v_{h}\right):=\frac{1}{2}\left\|\nabla_{h} v_{h}\right\|_{\Omega}^{2}-\left(f_{h}, \Pi_{h} v_{h}\right)_{\Omega}+I_{K_{h}^{c r}}\left(v_{h}\right) \tag{3.11}
\end{equation*}

where

In what follows, we refer to the minimization of the functional (3.11) as the discrete primal problem. Since the functional (3.11) is proper, strictly convex, weakly coercive, and lower semi-continuous, the direct method in the calculus of variations, cf. [20], yields the existence of a unique minimizer $u_{h}^{c r} \in K_{h}^{c r}$, called the discrete primal solution. In what follows, we reserve the notation $u_{h}^{c r} \in K_{h}^{c r}$ for the discrete primal solution. In addition, $u_{h}^{c r} \in K_{h}^{c r}$ is the unique minimizer of (3.11) if and only if for every $v_{h} \in K_{h}^{c r}$, it holds

Discrete dual problem. Discrete augmented problem. The discrete augmented problem, similar to the augmented problem (3.8), seeks for a discrete Lagrange multiplier $\bar{\lambda}_{h}^{c r} \in \Pi_{h}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)\right)$ such that $\bar{\lambda}_{h}^{c r} \leq 0$ a.e. in $\Omega$ and for every $v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$, it holds

Next, let $\alpha_{T} \in \mathbb{R}$ be such that $\Pi_{h} u_{h}^{c r}+\alpha_{T} \Pi_{h} v_{h}^{T}$ $=\Pi_{h} u_{h}^{c r}+\alpha_{T} \chi_{T} \geq \chi_{h}$ a.e. in $\Omega$. ## 4. A priori error analysis

In this section, we establish a priori error estimates for the discrete primal problem.
Theorem 4.1. If $u, \chi \in W^{2,2}(\Omega)$, i.e., $z \in W^{1,2}\left(\Omega ; \mathbb{R}^{d}\right)$ and $\lambda:=f+\operatorname{div} z \in L^{2}(\Omega)$, and $\chi_{h}:=\Pi_{h} I_{c r} \chi$ $\in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$, then there exists a constant $c>0$, depending only on the chunkiness $\omega_{0}>0$, such that

## 5. A POSTERIORI ERROR ANALYSIS

In this section, we examine the primal-dual a posteriori error estimator $\eta_{h}^{2}: W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R}$, for every $v \in W_{D}^{1,2}(\Omega)$ defined by

for reliability and efficiency.
Remark 5.1. (i) The estimator $\eta_{h}^{2}$ appeared in a similar form in [15] in a Crouzeix-Raviart approximation of the obstacle problems, imposing the obstacle constraint at the barycenters of element sides. However, imposing the obstacle constraint at the barycenters of elements leads to a simplified form compared to the estimator in [15].
(ii) The estimator $\eta_{A, h}^{2}$ provides control over the flux relation (3.6).
(iii) The estimator $\eta_{B, h}^{2}$ measures the discrepancy in the complementary condition (3.9), cf. [11].
(iv) The estimator $\eta_{C, h}^{2}$ measures the irregularity of the dual solution, i.e., $\operatorname{div} z \notin L^{2}(\Omega)$.

### 5.1 Reliability

In this subsection, we identify error quantities that are controlled by the a posteriori error estimator $\eta_{h}^{2}: W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R}$, cf. (5.1). In doing so, we combine two different but related approaches: first, we resort to first-order relations based on (discrete) convex duality, leading to constant-free estimates; second, we resort to second-order relations based on the (discrete) augmented problems, leading to estimates for further error quantities that are not covered be the first approach.

### 5.1.1 Reliability based on (discrete) convex duality

In this subsection, we follow the procedure for the derivation of, by definition, reliable and con-stant-free a posteriori error estimates based on (discrete) convex duality outlined in the introduction.
Lemma 5.2. For every $v \in K$, we have that

(5.1), furthermore, controls the error between the continuous Lagrange multiplier $\Lambda \in\left(W_{D}^{1,2}(\Omega)\right)^{*}$, defined by (3.8), and the discrete Lagrange multiplier $\bar{\lambda}_{h}^{c r} \in \Pi_{h}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)\right)$, defined by (3.14), measured in the Sobolev dual norm. To this end, we introduce the $\left(W_{D}^{1,2}(\Omega)\right)^{*}$-representation $\bar{\Lambda}_{h}^{c r} \in\left(W_{D}^{1,2}(\Omega)\right)^{*}$ of $\bar{\lambda}_{h}^{c r} \in \Pi_{h}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)\right)$, for every $v \in W_{D}^{1,2}(\Omega)$ defined by

& +\left(f_{h}-f, v-\Pi_{h} v\right)_{\Omega} \\
\leq & \left\|\nabla_{h} u_{h}^{c r}-\nabla u\right\|_{\Omega}+\eta_{C, h}+c_{\Pi}\left(\operatorname{osc}_{h}(f)\right)^{\frac{1}{2}}
\end{align*}
$$

Taking the supremum with respect to every $v \in W_{D}^{1,2}(\Omega)$ satisfying $\|v\|_{\Omega}+\|\nabla v\|_{\Omega} \leq 1$ in (5.6), we conclude the assertion.
ad (ii). Due to (i) and $f=f_{h} \in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$, for every $v \in W_{D}^{1,2}(\Omega)$, it holds

Following an approach which resorts to the (discrete) augmented problems, i.e., (3.8) and (3.14), it is possible to establish the following reliability result, which identifies additional quantities that are controlled by the a posteriori error estimator $\eta_{h}^{2}: W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R}$, cf. (5.1).

\end{aligned}

\end{aligned}

which is the claimed reliability estimate.
Proof (of Lemma 5.9). Resorting to (3.8), for every $v \in W_{D}^{1,2}(\Omega)$, since $f-f_{h} \perp \Pi_{h}(u-v)$ in $L^{2}(\Omega)$, we find that

& +\left(f_{h}, u-v\right)_{\Omega}
\end{align*}

i.e., owing to $\nabla_{h} I_{c r}(u-v)=\Pi_{h} \nabla(u-v)$ in $\mathcal{L}^{0}\left(\mathcal{T}_{h}\right)^{d}$ and $\nabla_{h} u_{h}^{c r} \in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)^{d}$, for every $v \in W_{D}^{1,2}(\Omega)$

Theorem 5.12 (Reliability). There exist constants $c_{\text {rel }}, c_{o s c}>0$, depending only on the chunkiness $\omega_{0}>0$, such that for every $v \in K$, we have that

\end{aligned}

If $f=f_{h} \in \mathcal{L}^{0}\left(\mathcal{T}_{h}\right)$, then Lemma 5.2 yields that for every $v \in K$, we have that

### 5.2 Efficiency

In this subsection, we show the efficiency of the a posteriori error estimator $\eta_{h}^{2}: W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R}$, cf. (5.1), with respect to the error measure $\rho_{h}^{2}: W_{D}^{1,2}(\Omega) \rightarrow \mathbb{R}$, cf. (5.16).
Theorem 5.14 (Efficiency). There exist constants $c_{\text {eff }}, c_{o s c}>0$, depending on the chunkiness $\omega_{0}>0$, such that for every $v \in W_{D}^{1,2}(\Omega)$, we have that

\eta_{h}^{2}(v) \leq c_{e f f} \rho_{h}^{2}(v)+c_{o s c} \operatorname{osc}_{h}(f)
$$

Proof. Apparently, for every $v \in W_{D}^{1,2}(\Omega)$, we have that

\eta_{A, h}^{2}(v) \leq 2\left[\|\nabla v-\nabla u\|_{\Omega}^{2}+\left\|\nabla u-\nabla_{h} u_{h}^{c r}\right\|_{\Omega}^{2}\right]
$$

In addition, appealing to Lemma A. 3 (A.7), there exists a constant $c>0$, depending only on the chunkiness $\omega_{0}>0$, such that

\eta_{C, h}^{2} \leq c\left[\left\|\nabla_{h} u_{h}^{c r}-\nabla u\right\|_{\Omega}^{2}+\left\|\bar{\Lambda}_{h}^{c r}-\Lambda\right\|_{*, \Omega}^{2}+\operatorname{osc}_{h}(f)\right]
$$

Eventually, for every $v \in W_{D}^{1,2}(\Omega)$, using Young's and Poincaré's inequality, we find that

& +\frac{1}{2}\left\|\bar{\Lambda}_{h}^{c r}-\Lambda\right\|_{*, \Omega}^{2}+\frac{1+c_{P}^{2}}{2}\|\nabla v-\nabla u\|_{\Omega}^{2}
\end{aligned}
$$

where $c_{P}>0$ denotes the Poincaré constant.
Remark 5.15. Since the discrete primal solution $u_{h}^{c r} \in K_{h}^{c r}$ is neither an admissible approximation of the primal solution $u \in K$ in Theorem 5.12 nor in Theorem 5.14, since, in general,

u_{h}^{c r} \notin W_{D}^{1,2}(\Omega) \quad \text { and } \quad u_{h}^{c r} \nsupseteq \chi \text { a.e. in } \Omega,
$$

it is necessary to post-process $u_{h}^{c r} \in K_{h}^{c r}$. In the numerical experiments, cf. Section 6, we employ the post-processed function $v_{h}=\max \left\{I_{h}^{a v} u_{h}^{c r}, \chi\right\}$, where $I_{h}^{a v}: \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right) \rightarrow \mathcal{S}_{D}^{1}\left(\mathcal{T}_{h}\right)$ is a node-averaging quasi-interpolation operator, cf. Subsection A.1, which, by the Sobolev chain rule, satisfies

i.e., $v_{h} \in K$. Note that $\operatorname{tr} v_{h}=0$ in $\Gamma_{D}$ due to $I_{h}^{a v} u_{h}^{c r}=0$ on $\Gamma_{D}$ and $\chi \leq 0$ in $\Gamma_{D}$. In addition, using the best-approximation property of $I_{h}^{a v}: \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right) \rightarrow \mathcal{S}_{D}^{1}\left(\mathcal{T}_{h}\right)$, cf. Proposition A.4, we have that

& \leq 2\left\|\nabla I_{h}^{a v} u_{h}^{c r}-\nabla u_{h}^{c r}\right\|_{\Omega}+\left\|\nabla u_{h}^{c r}-\nabla \chi\right\|_{\left\{I_{h}^{a v} u_{h}^{c r}<\chi\right\}} \\
& \leq c\left\|\nabla u_{h}^{c r}-\nabla u\right\|_{\Omega}+\|\nabla u-\nabla \chi\|_{\left\{I_{h}^{a v} u_{h}^{c r}<\chi\right\}}
\end{aligned}
$$

and, thus,

$$
\left\|\nabla v_{h}-\nabla u\right\|_{\Omega} \leq c\left\|\nabla u_{h}^{c r}-\nabla u\right\|_{\Omega}+\|\nabla u-\nabla \chi\|_{\left\{I_{h}^{a v} u_{h}^{c r}<\chi\right\}}

In other words, the error between $v_{h} \in K$ and $u_{h}^{c r} \in K_{h}^{c r}$ (and $u \in K$, respectively) is controlled by the error between $u_{h}^{c r} \in K_{h}^{c r}$ and $u \in K$ plus a contribution capturing the violation of the continuous obstacle constraint by $u_{h}^{c r} \in K_{h}^{c r}$.
Remark 5.16. Appealing to Theorem A. 1 and Lemma A.3 (A.7), there exists a constant $c>0$, depending only on the chunkiness $\omega_{0}>0$, such that for every $v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$, we have that

\left\|\nabla_{h} v_{h}-\nabla_{h} u_{h}^{c r}\right\|_{\Omega}^{2}+\left\|h_{\mathcal{T}}\left(f_{h}-\bar{\lambda}_{h}^{c r}\right)\right\|_{\Omega}^{2} \leq c\left[\left\|\nabla_{h} v_{h}-\nabla u\right\|_{\Omega}^{2}+\left\|\bar{\Lambda}_{h}^{c r}-\Lambda\right\|_{*, \Omega}^{2}+\operatorname{osc}_{h}(f)\right]
$$

Thus, it is possible to establish efficiency estimates for parts of the primal-dual a posteriori error estimator, which also apply for non-conforming functions, cf. Appendix A.

## 6. Numerical experiments

In this section, we review the theoretical findings of Section 4 and Section 5 via numerical experiments. All experiments were carried out using the finite element software package FEniCS (version 2019.1.0), cf. [39]. All graphics are created using the Matplotlib (version 3.5.1) library, cf. [33].

### 6.1 Implementation details

We approximate the discrete primal solution $u_{h}^{c r} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$ and the associated discrete Lagrange multiplier $\bar{\lambda}_{h}^{c r} \in \Pi_{h}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)\right)$ jointly satisfying the discrete augmented problem (3.14) via the primal-dual active set strategy interpreted as a super-linear converging semi-smooth Newton method, cf. [3, Subsection 5.3.1] or [31]. For sake of completeness, we will briefly outline important implementation details related with this strategy.

We fix an ordering of the element sides $\left(S_{i}\right)_{i=1, \ldots, N_{h}^{c r}}$ and an ordering of the elements $\left(T_{i}\right)_{i=1, \ldots, N_{h}^{0}}$, where $N_{h}^{c r}:=\operatorname{card}\left(\mathcal{S}_{h}\right)$ and $N_{h}^{0}:=\operatorname{card}\left(\mathcal{T}_{h}\right)$, such that ${ }^{4}$

where $N_{h}^{c r, 0}=\operatorname{dim}\left(\Pi_{h}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)\right)\right) \in\left\{N_{h}^{0}, N_{h}^{0}-1\right\}$ because of $\operatorname{codim}_{\mathcal{L}^{0}\left(\mathcal{T}_{h}\right)}\left(\Pi_{h}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)\right)\right)=1$, cf. [8, Corollary 3.2]. Then, if we define the matrices

the same argumentation as in [3, Lemma 5.3] shows that the discrete augmented problem (3.14) is equivalent to finding vectors $\left(\mathrm{U}_{h}^{c r}, \mathrm{~L}_{h}^{c r}\right)^{\top} \in \mathbb{R}^{N_{h}^{c r}} \times \mathbb{R}^{N_{h}^{c r, 0}}$ such that

More precisely, the discrete primal solution $u_{h}^{c r} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$ and the associated discrete Lagrange multiplier $\bar{\lambda}_{h}^{c r} \in \Pi_{h}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)\right)$ jointly satisfying the discrete augmented problem (3.14) as well as $\left(\mathrm{U}_{h}^{c r}, \mathrm{~L}_{h}^{c r}\right)^{\top} \in \mathbb{R}^{N_{h}^{c r}} \times \mathbb{R}^{N_{h}^{c r, 0}}$, respectively, are related by ${ }^{5}$

where $I_{\mathscr{A}_{h}}, I_{\mathscr{A}_{h}^{c}}:=I_{N_{h}^{c r, 0}} \times N_{h}^{c r, 0}-I_{\mathscr{A}_{h}} \in \mathbb{R}^{N_{h}^{c r, 0}} \times \mathbb{R}^{N_{h}^{c r, 0}}$ for every $i, j \in\left\{1, \ldots, N_{h}^{c r, 0}\right\}$ are defined by $\left(I_{\mathscr{A}_{h}}\right)_{i j}=1$ if $i=j \in \mathscr{A}_{h}$ and $\left(I_{\mathscr{A}_{h}}\right)_{i j}=0$ else.

For a given iterate $\left(\mathrm{U}_{h}^{k-1}, \mathrm{~L}_{h}^{k-1}\right)^{\top} \in \mathbb{R}^{N_{h}^{c r}} \times \mathbb{R}^{N_{h}^{c r, 0}}$, one step of the semi-smooth Newton method, cf. [3, Subsection 5.3.1] or [31], determines a direction $\left(\delta \mathrm{U}_{h}^{k-1}, \delta \mathrm{~L}_{h}^{k-1}\right)^{\top} \in \mathbb{R}^{N_{h}^{c r}} \times \mathbb{R}^{N_{h}^{c r, 0}}$ such that

The semi-smooth Newton method can, thus, equivalently be formulated in the following form, which is a version of a primal-dual active set strategy.

Algorithm 6.1 (Primal-dual active set strategy). Choose parameters $\alpha>0$ and $\varepsilon_{\text {STOP }}>0$. Moreover, let $\left(\mathrm{U}_{h}^{0}, \mathrm{~L}_{h}^{0}\right)^{\top} \in \mathbb{R}^{N_{h}^{c r}} \times \mathbb{R}_{h}^{N_{h}^{c r, 0}}$ and set $k=1$. Then, for every $k \in \mathbb{N}$ :
(i) Define the most recent active set

(ii) Compute the iterate $\left(\mathrm{U}_{h}^{k}, \mathrm{~L}_{h}^{k}\right)^{\top} \in \mathbb{R}^{N_{h}^{c r}} \times \mathbb{R}^{N_{h}^{c r, 0}}$ such that

(iii) Stop if $\left|\mathrm{U}_{h}^{k}-\mathrm{U}_{h}^{k-1}\right| \leq \varepsilon_{\text {STOP }}$; otherwise, increase $k \rightarrow k+1$ and continue with step (i).

Remark 6.2 (Important implementation details). (i) Algorithm 6.1 converges super-linearly if $\left(U_{h}^{0}, L_{h}^{0}\right)^{\top} \in \mathbb{R}^{N_{h}^{c r}} \times \mathbb{R}^{N_{h}^{c r, 0}}$ is sufficiently close to the solution $\left(U_{h}^{c r}, L_{h}^{c r}\right)^{\top} \in \mathbb{R}^{N_{h}^{c r}} \times \mathbb{R}^{N_{h}^{c r, 0}}$, cf. [31, Theorem 3.1]. Since the Newton-differentiability only holds in finite-dimensional situations and deteriorates as the dimension increases, the condition on the initial guess becomes more critical for increasing dimensions.
(ii) The degrees of freedom related to the entries $\left.L_{h}^{k}\right|_{\left(\mathscr{A}_{h}^{k-1}\right)^{c}}$ can be eliminated from the linear system of equations in Algorithm 6.1, step (ii) (see also (6.3)).
(iii) Since only a finite number of active sets are possible, the algorithm terminates within a finite number of iterations at the exact solution $\left(\mathrm{U}_{h}^{c r}, \mathrm{~L}_{h}^{c r}\right)^{\top} \in \mathbb{R}^{N_{h}^{c r}} \times \mathbb{R}^{N_{h}^{c r, 0}}$. For this reason, in practice, the stopping criterion in step (iii) is reached with $\left|\mathrm{U}_{h}^{k^{*}}-\mathrm{U}_{h}^{k^{*}-1}\right|=0$ for some $k^{*} \in \mathbb{N}$, in which case, one has that $\mathrm{U}_{h}^{k^{*}}=\mathrm{U}_{h}^{c r}$, provided $\varepsilon_{\mathrm{STOP}}>0$ is sufficiently small.
(iv) The linear system emerging in each semi-smooth Newton step (cf. Algorithm 6.1, step (ii)) is solved using a sparse direct solver from SciPy (version 1.8.1), cf. [46].
(v) Global convergence of the algorithm and monotonicity, i.e., $\mathrm{U}_{h}^{k} \geq \mathrm{U}_{h}^{k-1} \geq \mathrm{X}_{h}^{c r}$ for $k \geq 3$ can be proved if $\mathrm{S}_{h}^{c r} \in \mathbb{R}^{N_{h}^{c r} \times N_{h}^{c r}}$ is an M-Matrix, cf. [31, Theorem 3.2].
(vi) Classical active set strategies define $\mathscr{A}_{h}^{k-1}:=\left\{i \in\left\{1, \ldots, N_{h}^{c r, 0}\right\} \mid \mathrm{L}_{h}^{k-1} \cdot \mathrm{e}_{i}<0\right\}$, which corresponds to the formal limit $\alpha \rightarrow \infty$.

### 6.2 Numerical experiments concerning the a priori error analysis

In this subsection, we review the theoretical findings of Section 4.
For our numerical experiments, we choose $\Omega:=\left(-\frac{3}{2}, \frac{3}{2}\right)^{2}, \Gamma_{D}:=\partial \Omega, f:=-2 \in L^{2}(\Omega), \chi:=0 \in$ $W^{2,2}(\Omega)$, so that the exact solution $u \in K$, for every $x \in \Omega$ defined by

u(x):= \begin{cases}\frac{|x|^{2}}{2}-\ln (|x|)-\frac{1}{2} & \text { if } x \in \Omega \backslash B_{1}^{2}(0) \\ 0 & \text { else }\end{cases}
$$

satisfies $u \in W^{2,2}(\Omega)$. Therefore, Theorem 4.1 let us expect a convergence rate of about 1 .
An initial triangulation $\mathcal{T}_{h_{0}}, h_{0}=\frac{3}{2 \sqrt{2}}$, is constructed by subdividing a rectangular Cartesian grid into regular triangles with different orientations. Refined triangulations $\mathcal{T}_{h_{k}}, k=1, \ldots, 7$, where $h_{k+1}=\frac{h_{k}}{2}$ for all $k=1, \ldots, 7$, are obtained by applying the red-refinement rule, cf. [45].

For the resulting series of triangulations $\mathcal{T}_{k}:=\mathcal{T}_{h_{k}}, k=1, \ldots, 7$, we apply the primal-dual active set strategy (cf. Algorithm 6.1) to compute the discrete primal solution $u_{k}^{c r}:=u_{h_{k}}^{c r} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{k}\right)$, $k=1, \ldots, 7$, the discrete Lagrange multiplier $\bar{\lambda}_{k}^{c r}:=\bar{\lambda}_{h_{k}}^{c r} \in \Pi_{h_{k}}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{k}\right)\right)$, and, subsequently, resorting to (3.27), the discrete dual solution $z_{k}^{r t}:=z_{h_{k}}^{r t} \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{k}\right), k=1, \ldots, 7$. Afterwards, we compute the error quantities

For the determination of the convergence rates, the experimental order of convergence (EOC)

\operatorname{EOC}_{k}\left(e_{k}\right):=\frac{\log \left(e_{k} / e_{k-1}\right)}{\log \left(h_{k} / h_{k-1}\right)}, \quad k=2, \ldots, 7
$$

where for every $k=1, \ldots, 7$, we denote by $e_{k}$, either $e_{u}^{k}, e_{I_{c r} u}^{k}, e_{z}^{k}, e_{I_{r t} z}^{k}, e_{\lambda, u}^{k}, e_{\lambda, I_{c r} u}^{k}, e_{\lambda, u}^{t o t, k}:=$ $e_{\lambda, u}^{k}+e_{u}^{k}$, or $e_{\lambda, I_{c r} u}^{t o t, k}:=e_{\lambda, I_{c r} u}^{k}+e_{I_{c r} u}^{k}$, respectively, is recorded.

For a series of triangulations $\mathcal{T}_{k}, k=1, \ldots, 7$, obtained by uniform mesh refinement as described above, the EOC is computed and presented in Table 1 and Table 2. In each case, except for $e_{k} \in\left\{e_{\lambda, u, k}, e_{\lambda, I_{c r} u, k}\right\}$, we record a convergence ratio of about $\operatorname{EOC}_{k}\left(e_{k}\right) \approx 1, k=2, \ldots, 7$, confirming the optimality of the a priori error estimates established in Theorem 4.1 and Corollary 4.2. For $e_{k} \in\left\{e_{\lambda, u, k}, e_{\lambda, I_{c r} u, k}\right\}$, we record a convergence ratio of about $\operatorname{EOC}_{k}\left(e_{k}\right) \approx 1.5, k=2, \ldots, 7$.

### 6.3 Numerical experiments concerning a posteriori error analysis

In this subsection, we review the theoretical findings of Section 5. More precisely, we apply the $\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$-approximation (3.11) of the obstacle problem (3.1) in an adaptive mesh refinement algorithm based on local refinement indicators $\left(\eta_{h, T}^{2}\right)_{T \in \mathcal{T}_{h}}$ associated with the a posteriori error estimator $\eta_{h}^{2}$, cf. (5.1). More precisely, for every $v \in W_{D}^{1,2}(\Omega)$ and $T \in \mathcal{T}_{h}$, we define

Before we present numerical experiments, we briefly outline the details of the implementations. In general, we follow the adaptive algorithm, cf. [21]:
Algorithm 6.3 (AFEM). Let $\varepsilon_{\mathrm{STOP}}>0, \theta \in(0,1)$ and $\mathcal{T}_{0}$ a conforming initial triangulation of $\Omega$. Then, for every $k \in \mathbb{N} \cup\{0\}$ :
('Solve') Compute the discrete primal solution $u_{k}^{c r}:=u_{h_{k}}^{c r} \in K_{k}^{c r}:=K_{h_{k}}^{c r}$ and the discrete Lagrange multiplier $\bar{\lambda}_{k}^{c r}:=\bar{\lambda}_{h_{k}}^{c r} \in \Pi_{h_{k}}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{k}\right)\right)$ jointly solving the discrete augmented problem (3.14). Post-process $u_{k}^{c r} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{k}\right)$ to obtain a conforming approximation $v_{k} \in K$ of the primal solution $u \in K$ and a discrete dual solution $z_{k}^{r t}:=z_{h_{k}}^{r t} \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{k}\right)$.
('Estimate') Compute the local refinement indicators $\left(\eta_{k, T}^{2}\left(v_{k}\right)\right)_{T \in \mathcal{T}_{k}}:=\left(\eta_{h_{k}, T}^{2}\left(v_{k}\right)\right)_{T \in \mathcal{T}_{k}}$. If $\eta_{k}^{2}\left(v_{k}\right):=\eta_{h_{k}}^{2}\left(v_{k}\right) \leq \varepsilon_{\text {STOP }}$, then STOP; otherwise, continue with step ('Mark').
('Mark') Choose a minimal (in terms of cardinality) subset $\mathcal{M}_{k} \subseteq \mathcal{T}_{k}$ such that

('Refine') Perform a conforming refinement of $\mathcal{T}_{k}$ to obtain $\mathcal{T}_{k+1}$ such that each $T \in \mathcal{M}_{k}$ is refined in $\mathcal{T}_{k+1}$. Increase $k \mapsto k+1$ and continue with step ('Solve').
Remark 6.4. (i) The discrete primal solution $u_{k}^{c r} \in K_{k}^{c r}$ and the discrete Lagrange multiplier $\bar{\lambda}_{k}^{c r} \in \Pi_{h_{k}}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{k}\right)\right)$ in step ('Solve') are computed using the primal-dual active set strategy (cf. Algorithm 6.1) for the parameter $\alpha=1$.
(ii) The reconstruction of the discrete dual solution $z_{k}^{r t} \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{k}\right)$ in step ('Solve') is based on the generalized Marini formula (3.27).
(iii) In accordance with Remark 5.15, as a conforming approximation $v_{k} \in K$ of the primal solution $u \in K$ in step ('Solve'), we employ $v_{k}=\max \left\{I_{h_{k}}^{a v} u_{k}^{c r}, \chi\right\} \in K$.
(iv) We always employ the parameter $\theta=\frac{1}{2}$ in ('Mark').
(v) To find the set $\mathcal{M}_{k} \subseteq \mathcal{T}_{k}$ in step ('Mark'), we deploy the Dörfler marking strategy, cf. [23].
(vi) The (minimal) conforming refinement of $\mathcal{T}_{k}$ with respect to $\mathcal{M}_{k}$ in step ('Refine') is obtained by deploying the red-green-blue-refinement algorithm, cf. [45].

### 6.3.1 Example with corner singularity

We examine an example from [9]. In this example, we let $\Omega:=(-2,2)^{2} \backslash([0,2] \times[-2,0])$, $\Gamma_{D}:=\partial \Omega, \Gamma_{N}:=\emptyset, f \in L^{2}(\Omega)$, in polar coordinates, for every $(r, \varphi)^{\top} \in \mathbb{R}_{>0} \times(0,2 \pi)$ defined by

f(r, \varphi):=-r^{\frac{2}{3}} \sin \left(\frac{2 \varphi}{3}\right)\left(\frac{\gamma_{1}^{\prime}(r)}{r}+\gamma_{1}^{\prime \prime}(r)\right)-\frac{4}{3} r^{-\frac{1}{3}} \gamma_{1}^{\prime}(r) \sin \left(\frac{2 \varphi}{3}\right)-\gamma_{2}(r)
$$

where $\gamma_{1}, \gamma_{2}: \mathbb{R}_{>0} \rightarrow \mathbb{R}$ for every $r \in \mathbb{R}_{>0}$, abbreviating $\bar{r}:=2\left(r-\frac{1}{4}\right)$, are defined by

\end{array} \quad \gamma_{2}(r):= \begin{cases}0 & \text { if } \bar{r} \leq \frac{5}{4} \\
1 & \text { if } \bar{r}>\frac{5}{4}\end{cases}\right.
$$

and $\chi:=0 \in W_{D}^{1,2}(\Omega)$. Then, the primal solution $u \in K$, in polar coordinates, for every $(r, \varphi)^{\top} \in$ $\mathbb{R}_{>0} \times(0,2 \pi)$ defined by $u(r, \varphi):=r^{\frac{2}{3}} \gamma_{1}(r) \sin \left(\frac{2 \varphi}{3}\right)$, has a singularity at the origin and, therefore, satisfies $u \notin W^{2,2}(\Omega)$, so that we cannot expect uniform mesh refinement to yield the quasioptimal linear convergence rate.

The coarsest triangulation $\mathcal{T}_{0}$ of Figure 2 (and starting triagulation of Algorithm 6.3) consists of 48 halved squares. More precisely, Figure 2 displays the triangulations $\mathcal{T}_{k}, k \in\{0,4,8,12,16,20\}$, generated by the adaptive Algorithm 6.3. The approximate contact zones $\mathcal{C}_{k}^{c r}:=\left\{\Pi_{h_{k}} u_{k}^{c r}=0\right\}=$ $\left\{\bar{\lambda}_{k}^{c r}<0\right\}, k \in\{0,4,8,12,16,20\}$, are plotted in white Figure 2 while its complement is shaded ${ }^{6}$. Algorithm 6.3 refines in the complement of the contact zone $\mathcal{C}:=\Omega \cap\left\{|\cdot|>\frac{3}{4}\right\}$. A refinement towards the origin, where the solution has a singularity in the gradient, and in $\left\{\frac{1}{4} \leq|\cdot| \leq \frac{3}{4}\right\}$, where the solution has large gradients, is reported. This behavior can also be seen in Figure 3, where the discrete primal solution $u_{10}^{c r} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{10}\right)$, the node-averaged discrete primal solution $I_{h_{10}}^{a v} u_{10}^{c r} \in \mathcal{S}_{D}^{1}\left(\mathcal{T}_{10}\right)$, the discrete Lagrange multiplier $\bar{\lambda}_{10}^{c r} \in \Pi_{h_{10}}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{10}\right)\right)$, and the discrete dual solution $z_{10}^{r t} \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{10}\right)$ are plotted on the triangulation $\mathcal{T}_{10}$, which has 1858 degrees of freedom. Figure 1 demonstrates that the adaptive Algorithm 6.3 improves the experimental convergence rate of about $\frac{3}{4}$ for uniform mesh-refinement to the optimal value 1 . For uniform mesh-refinement, we expect an asymptotic convergence rate $\frac{3}{4}$ due to the corner singularity. Since not all quantities in the error measure $\rho_{h_{k}}^{2}\left(v_{k}\right)$ are computable, in Figure 1, we employ the reduced error measure

\tilde{\rho}_{k}^{2}\left(v_{k}\right):=\frac{1}{2}\left\|\nabla v_{k}-\nabla u\right\|_{\Omega}^{2}+\left\langle-\Lambda, v_{k}-u\right\rangle_{\Omega}+\left\|\nabla u-\nabla_{h_{k}} u_{k}^{c r}\right\|_{\Omega}^{2}+\left(-\bar{\lambda}_{k}^{c r}, \Pi_{h_{k}}(u-\chi)\right)_{\Omega}
$$

where we exploit for the computation of the first two terms the identity (5.2).

### 6.3.2 Example with unknown exact solution

We examine an example from [9]. In this example, we let $\Omega:=(-1,1)^{2}, \Gamma_{D}:=\partial \Omega, \Gamma_{N}:=\emptyset$, $f=1 \in L^{2}(\Omega)$, and $\chi=\operatorname{dist}(\cdot, \partial \Omega) \in W_{D}^{1,2}(\Omega)$. The primal solution $u \in K$ is not known and cannot be expected to satisfy $u \in W^{2,2}(\Omega)$ inasmuch as $\chi \notin W^{2,2}(\Omega)$, so that uniform mesh refinement is expected to yield a reduced error decay rate compared to the optimal linear error decay rate.

The coarsest triangulation $\mathcal{T}_{0}$ in Figure 5 (and starting triangulation in Algorithm 6.3) consists of 64 elements. More precisely, Figure 5 displays the triangulations $\mathcal{T}_{k}, k \in\{0,5,10,15,20,25\}$, generated by the adaptive Algorithm 6.3. The approximate contact zones $\mathcal{C}_{k}^{c r}:=\left\{\Pi_{h_{k}} u_{k}^{c r}=\chi_{k}\right\}=$ $\left\{\bar{\lambda}_{k}^{c r}<0\right\}, k \in\{0,5,10,15,20,25\}$, where $\chi_{k}:=\Pi_{h_{k}} \chi \in \mathcal{L}^{0}\left(\mathcal{T}_{k}\right)$ for every $k \in\{0,5,10,15,20,25\}$, are plotted in white in Figure 5 while their complements are shaded. Note that for every $k \in \mathbb{N}$, we have that $\chi=I_{c r} \chi \in \mathcal{S}_{D}^{1}\left(\mathcal{T}_{k}\right)$ and $f=f_{h_{k}} \in \mathcal{L}^{0}\left(\mathcal{T}_{k}\right)$.

This example is different from the previous examples; in the sense that the solution and the obstacle are non-smooth along the lines $\mathcal{C}:=\left\{(x, y)^{\top} \in \Omega \mid x=y\right.$ or $\left.x=1-y\right\}$. Algorithm 6.3 refines the mesh towards these lines as can be seen in Figure 5. In addition, the approximate contact zones $\mathcal{C}_{k}^{c r}, k \in\{0, \ldots, 25\}$, reduces to $\mathcal{C}$. This behavior can also be observed in Figure 3, where the discrete primal solution $u_{15}^{c r} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{15}\right)$, the node-averaged discrete primal solution $I_{h}^{a v} u_{15}^{c r} \in \mathcal{S}_{D}^{1}\left(\mathcal{T}_{15}\right)$, the discrete Lagrange multiplier $\bar{\lambda}_{15}^{c r} \in \Pi_{h_{15}}\left(\mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{15}\right)\right)$, and the discrete dual solution $z_{15}^{r t} \in \mathcal{R} T_{N}^{0}\left(\mathcal{T}_{15}\right)$ are plotted on the triangulation $\mathcal{T}_{15}$, which has 3769 degrees of freedom. Algorithm 6.3 improves the experimental convergence rate of about $\frac{1}{2}$ for uniform mesh-refinement to the quasi-optimal value 1 . Since not all quantities in the error measure $\rho_{h_{k}}^{2}\left(v_{k}\right)$ are computable, in Figure 4, we employ the reduced error measure

$$
\tilde{\rho}_{k}^{2}\left(v_{k}\right):=\frac{1}{2}\left\|\nabla v_{k}-\nabla u\right\|_{\Omega}^{2}+\left\langle-\Lambda, v_{k}-u\right\rangle_{\Omega},
$$

where we exploit for the computation of $\tilde{\rho}_{k}^{2}\left(v_{k}\right)$ the identity (5.2) and approximate the value $I(u)$ via Aitken's $\delta^{2}$-process, cf. [2]. More precisely, we always employ the approximation $I(u) \approx \epsilon_{27}$, where the sequence $\left(\epsilon_{k}\right)_{k \in \mathbb{N} ; k \geq 2}$, for every $k \in \mathbb{N}$ with $k \geq 2$, is defined by

\epsilon_{k}:=\frac{I\left(v_{k}\right) I\left(v_{k-2}\right)-I\left(v_{k-1}\right)^{2}}{I\left(v_{k}\right)-2 I\left(v_{k-1}\right)+I\left(v_{k-2}\right)} \in \mathbb{R}
$$

However, it remains unclear whether this is a sufficiently accurate approximation of the exact errors $\rho_{h_{k}}^{2}\left(v_{k}\right), k=0, \ldots, 25$.

Using the $\varepsilon$-Young inequality, the $W^{1,2^{2}}$-stability of $I_{h}^{a v}: \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right) \rightarrow \mathcal{S}_{D}^{1}\left(\mathcal{T}_{h}\right)$, cf. (AV.1) \& (AV.2), and the discrete Poincare inequality (2.1), for every $\varepsilon>0$, we obtain

$$
\begin{align*}
I_{h}^{5} & \leq \frac{1}{4 \varepsilon}\left\|\bar{\Lambda}_{h}^{c r}-\Lambda\right\|_{*, \Omega}^{2}+\varepsilon\left(\left\|I_{h}^{a v} e_{h}\right\|_{\Omega}^{2}+\left\|\nabla I_{h}^{a v} e_{h}\right\|_{\Omega}^{2}\right) \\
& \leq \frac{1}{4 \varepsilon}\left\|\bar{\Lambda}_{h}^{c r}-\Lambda\right\|_{*, \Omega}^{2}+\varepsilon\left(1+\left(c_{P}^{c r}\right)^{2}\right)\left\|\nabla_{h} e_{h}\right\|_{\Omega}^{2} \tag{A.14}
\end{align*}
$$

Combining (A.10), (A.11), (A.12), (A.13), and (A.14) in (A.9), for every $\varepsilon>0$, we conclude that

$$
\begin{align*}
\left\|\nabla_{h} v_{h}-\nabla_{h} u_{h}^{c r}\right\|_{\Omega}^{2} \leq & \frac{3+c_{e f f}\left(1+c_{t r}^{2}\right)}{4 \varepsilon}\left[\left\|\nabla_{h} v_{h}-\nabla u\right\|_{\Omega}^{2}+\operatorname{osc}_{h}(f)+\left\|\bar{\Lambda}_{h}^{c r}-\Lambda\right\|_{*, \Omega}^{2}\right]  \tag{A.15}\\
& +\varepsilon\left(3 c_{a v}+c_{\Pi}^{2}+1+\left(c_{P}^{c r}\right)^{2}\right)\left\|\nabla_{h} e_{h}\right\|_{\Omega}^{2}
\end{align*}
$$

For $\varepsilon:=\frac{1}{2\left(3 c_{a v}+c_{\Pi}^{2}+1+\left(c_{P}^{c r}\right)^{2}\right)}>0$ and $c:=\left(3 c_{a v}+c_{\Pi}^{2}+1+\left(c_{P}^{c r}\right)^{2}\right)\left(3+c_{e f f}\left(1+c_{t r}^{2}\right)\right)>0$ in (A.15), for every $v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$, we arrive at

$$
\begin{equation*}
\left\|\nabla_{h} v_{h}-\nabla_{h} u_{h}^{c r}\right\|_{\Omega}^{2} \leq c\left[\left\|\nabla_{h} v_{h}-\nabla u\right\|_{\Omega}^{2}+\operatorname{osc}_{h}(f)+\left\|\bar{\Lambda}_{h}^{c r}-\Lambda\right\|_{*, \Omega}^{2}\right] \tag{A.16}
\end{equation*}
$$

which is the claimed non-conforming efficiency estimate.
Eventually, the node-averaging quasi-interpolation operator $I_{h}^{a v}: \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right) \rightarrow \mathcal{S}_{D}^{1}\left(\mathcal{T}_{h}\right)$ satisfies the following best-approximation result with respect to Sobolev functions.

Proposition A.4. There exists a constant $c>0$, depending only on the chunkiness $\omega_{0}>0$, such that for every $v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$ and $T \in \mathcal{T}_{h}$, it holds

$$
\left\|\nabla_{h} v_{h}-\nabla I_{h}^{a v} v_{h}\right\|_{T}^{2} \leq c \inf _{v \in W_{D}^{1,2}(\Omega)}\left\|\nabla_{h} v_{h}-\nabla v\right\|_{\omega_{T}}^{2}
$$

In particular, for every $v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right), v \in W_{D}^{1,2}(\Omega)$, and $T \in \mathcal{T}_{h}$, it holds

$$
\left\|\nabla I_{h}^{a v} v_{h}-\nabla v\right\|_{T}^{2} \leq c\left\|\nabla_{h} v_{h}-\nabla v\right\|_{\omega_{T}}^{2}
$$

Essential tool in the verification of Proposition A. 4 is the following lemma.

Lemma A.5. There exists a constant $c>0$, depending only on the chunkiness $\omega_{0}>0$, such that for every $v_{h} \in \mathcal{S}_{D}^{1, c r}\left(\mathcal{T}_{h}\right)$ and $T \in \mathcal{T}_{h}$, it holds

$$
\left\|\nabla_{h} v_{h}-\nabla I_{h}^{a v} v_{h}\right\|_{T}^{2} \leq c \sum_{S \in \mathcal{S}_{h}(T) \backslash \Gamma_{N}} h_{T}\left\|h_{T}^{-1} \llbracket v_{h} \rrbracket_{S}\right\|_{S}^{2},
$$

where $\mathcal{S}_{h}(T):=\left\{S \in \mathcal{S}_{h} \mid S \cap T \neq \emptyset\right\}$.
Proof. Appealing to the inverse inequality [25, Lemma 12.1] and the node-based norm equivalence [25, Proposition 12.5], there exists a constant $c>0$, depending only on the chunkiness $\omega_{0}>0$, such that

$$
\begin{align*}
\left\|\nabla_{h} v_{h}-\nabla I_{h}^{a v} v_{h}\right\|_{T}^{2} & \leq c h_{T}^{-1}\left\|v_{h}-I_{h}^{a v} v_{h}\right\|_{T}^{2} \\
& \leq c h_{T}^{d-2} \sum_{z \in \mathcal{N}_{h} \cap T}\left|\left(\left.v_{h}\right|_{T}\right)(z)-\left(I_{h}^{a v} v_{h}\right)(z)\right|^{2} \tag{A.17}
\end{align*}
$$

Next, for every $z \in \mathcal{N}_{h} \cap T$, we need to distinguish the cases $z \notin \Gamma_{D}$ and $z \in \Gamma_{D}$ :
Case $z \notin \Gamma_{D}$. If $z \notin \Gamma_{D}$, then since each $T^{\prime} \in \mathcal{T}_{h}(z)$ can be reached from $T$ via passing through a finite number ${ }^{7}$ of interior sides in $\mathcal{S}_{h}^{i}(T):=\mathcal{S}_{h}(T) \cap \mathcal{S}_{h}^{i}$, using [25, (22.6)], we find that

$$
\begin{align*}
\left|\left(\left.v_{h}\right|_{T}\right)(z)-\left(I_{h}^{a v} v_{h}\right)(z)\right|^{2} & \leq c \frac{1}{\operatorname{card}\left(\mathcal{T}_{h}(z)\right)} \sum_{T^{\prime} \in \mathcal{T}_{h}(z)}\left|\left(\left.v_{h}\right|_{T}\right)(z)-\left(\left.v_{h}\right|_{T^{\prime}}\right)(z)\right|^{2} \\
& \leq c \sum_{S \in \mathcal{S}_{h}^{i}(T)}\left|\llbracket v_{h} \rrbracket_{S}(z)\right|^{2}  \tag{A.18}\\
& \leq c \sum_{S \in \mathcal{S}_{h}^{i}(T)} h_{T}^{1-d}\left\|\llbracket v_{h} \rrbracket_{S}\right\|_{S}^{2}
\end{align*}
$$

Case $z \in \Gamma_{D}$. If $z \in \Gamma_{D}$, then we need to distinguish the case that $z \in \operatorname{int} \Gamma_{D}$, i.e., $z$ lies in the relative interior of $\Gamma_{D}$, and $z \in \partial \Gamma_{D}$, i.e., $z$ lies in the relative boundary of $\Gamma_{D}$ :

Subcase $z \in \operatorname{int} \Gamma_{D}$. If $z \in \operatorname{int} \Gamma_{D}$, then there exists a boundary side $S \in \mathcal{S}_{h}(T) \backslash \Gamma_{N}$ with $z \in S$ and $S \subseteq \partial T$. Thus, resorting to [25, (22.6)], we find that

$$
\begin{align*}
\left|\left(\left.v_{h}\right|_{T}\right)(z)-\left(I_{h}^{a v} v_{h}\right)(z)\right|^{2} & =\left|\left(\left.v_{h}\right|_{T}\right)(z)\right|^{2} \\
& =\left|\llbracket v_{h} \rrbracket_{S}(z)\right|^{2}  \tag{A.19}\\
& \leq c h_{T}^{1-d}\left\|\llbracket v_{h} \rrbracket_{S}\right\|_{S}^{2}
\end{align*}
$$

Subcase $z \in \partial \Gamma_{D}$. If $z \in \partial \Gamma_{D}$, then there exists a boundary side $S \in \mathcal{S}_{h}(T)$ with $z \in S, S \subseteq \partial T$, and either $S \subseteq \Gamma_{D}$ or $S \subseteq \Gamma_{N}$. If $S \subseteq \Gamma_{D}$, then we argue as in (A.19). If $S \subseteq \Gamma_{N}$, then there exists boundary side $S^{\prime} \in \mathcal{S}_{h}(T) \backslash \Gamma_{N}$ with $z \in S^{\prime}$ and an element $T^{\prime} \in \mathcal{T}_{h}$ with $z \in T^{\prime}$ and $S^{\prime} \subseteq T^{\prime}$. If $T^{\prime}=T$, then we argue as in (A.19). If $T^{\prime} \neq T$, then since $T^{\prime}$ can be reached from $T$ via passing through a finite number of interior sides in $\mathcal{S}_{h}^{i}(T)$, resorting to [25, (22.6)], we find that

$$
\begin{align*}
\left|\left(\left.v_{h}\right|_{T}\right)(z)-\left(I_{h}^{a v} v_{h}\right)(z)\right|^{2} & =\left|\left(\left.v_{h}\right|_{T}\right)(z)\right|^{2} \\
& \leq\left|\left(\left.v_{h}\right|_{T^{\prime}}\right)(z)\right|^{2}+c \sum_{S \in \mathcal{S}_{h}^{i}(T)}\left|\llbracket v_{h} \rrbracket_{S}(z)\right|^{2} \\
& \leq c\left|\llbracket v_{h} \rrbracket_{S^{\prime}}(z)\right|^{2}+c \sum_{S \in \mathcal{S}_{h}^{i}(T)}\left|\llbracket v_{h} \rrbracket_{S}(z)\right|^{2}  \tag{A.20}\\
& \leq c \sum_{S \in \mathcal{S}_{h}(T) \backslash \Gamma_{N}} h_{T}^{1-d}\left\|\llbracket v_{h} \rrbracket_{S}\right\|_{S}^{2} .
\end{align*}
$$

Eventually, combining (A.18)-(A.20) in (A.17), we conclude the claimed estimate.

[^6]Proof (of Proposition A.4). Using that $\left\|\llbracket v_{h} \rrbracket_{S}\right\|_{L^{\infty}(S)} \leq c f_{S}\left|\llbracket v_{h} \rrbracket_{S}\right| \mathrm{d} x$ (cf. [25, Lemma 12.1]) as well as $|T| \sim h_{T}|S|$ for all $T \in \mathcal{T}_{h}$ and $S \in \mathcal{S}_{h}(T)$, where the constant $c>0$ depends only on the chunkiness $\omega_{0}>0$, for every $T \in \mathcal{T}_{h}$, we infer from Lemma A. 5 that

$$
\begin{align*}
\left\|\nabla I_{h}^{a v} v_{h}-\nabla_{h} v_{h}\right\|_{T}^{2} & \leq c \sum_{S \in \mathcal{S}_{h}(T) \backslash \Gamma_{N}} h_{T}\left\|h_{T}^{-1} \llbracket v_{h} \rrbracket_{S}\right\|_{S}^{2}  \tag{A.21}\\
& \leq c \sum_{S \in \mathcal{S}_{h}(T) \backslash \Gamma_{N}}|T|\left(|T|^{-1}\left\|\llbracket v_{h} \rrbracket_{S}\right\|_{L^{1}(S)}\right)^{2} .
\end{align*}
$$

For every $S \in \mathcal{S}_{h}$, we denote by $\pi_{h}^{S}: L^{1}(S) \rightarrow \mathbb{R}$, the side-wise (local) $L^{2}$-projection operator onto constant functions, for every $w \in L^{1}(S)$ defined by $\pi_{h}^{S} w:=f_{S} w \mathrm{~d} s$. Since for every $w \in W^{1,1}(T)$, where $T \in \mathcal{T}_{h}$ with $T \subseteq \omega_{S}$, due to the $L^{1}(S)$-stability of $\pi_{h}^{S}: L^{1}(S) \rightarrow \mathbb{R}$ and [35, Corollary A.19], it holds

$$
\begin{align*}
\left\|w-\pi_{h}^{S} w\right\|_{L^{1}(S)} & =\left\|w-\Pi_{h} w-\pi_{h}^{S}\left(w-\Pi_{h} w\right)\right\|_{L^{1}(S)} \\
& \leq 2\left\|w-\Pi_{h} w\right\|_{L^{1}(S)}  \tag{A.22}\\
& \leq c\|\nabla w\|_{L^{1}\left(T ; \mathbb{R}^{d}\right)}
\end{align*}
$$

where $c>0$ depends only on the chunkiness $\omega_{0}>0$. Next, let $v \in W_{D}^{1,2}(\Omega)$ be fixed, but arbitrary. Using that $\pi_{h}^{S} \llbracket v_{h} \rrbracket_{S}=\llbracket v \rrbracket_{S}=0$ in $L^{1}(S)$ for all $S \in \mathcal{S}_{h}(T) \backslash \Gamma_{N}$ and $T \in \mathcal{T}_{h}$ and (A.22), we find that

$$
\begin{align*}
\left\|\llbracket v_{h} \rrbracket_{S}\right\|_{L^{1}(S)} & =\left\|\llbracket v_{h}-v \rrbracket_{S}-\pi_{h}^{S} \llbracket v_{h}-v \rrbracket_{S}\right\|_{L^{1}(S)}  \tag{A.23}\\
& \leq\left\|\nabla v_{h}-\nabla v\right\|_{L^{1}\left(\omega_{S} ; \mathbb{R}^{d}\right)} .
\end{align*}
$$

Then, using in (A.21), (A.23), $|T| \sim\left|\omega_{T}\right| \sim\left|\omega_{S}\right|$ for all $T \in \mathcal{T}_{h}$ and $S \in \mathcal{S}_{h}(T)$, where $c>0$ depends only on the chunkiness $\omega_{0}>0$, and Jensen's inequality, for every $T \in \mathcal{T}_{h}$, we deduce that

$$
\begin{align*}
\left\|\nabla I_{h}^{a v} v_{h}-\nabla_{h} v_{h}\right\|_{T}^{2} & \leq c \sum_{S \in \mathcal{S}_{h}(T) \backslash \Gamma_{N}}\left|\omega_{S}\right|\left(\left|\omega_{S}\right|^{-1}\left\|\nabla v_{h}-\nabla v\right\|_{L^{1}\left(\omega_{S} ; \mathbb{R}^{d}\right)}\right)^{2} \\
& \leq c \sum_{S \in \mathcal{S}_{h}(T) \backslash \Gamma_{N}}\left\|\nabla v_{h}-\nabla v\right\|_{\omega_{S}}^{2}  \tag{A.24}\\
& \leq c\left\|\nabla v_{h}-\nabla v\right\|_{\omega_{T}}^{2}
\end{align*}
$$

Eventually, taking in (A.24) the infimum with respect to $v \in W_{D}^{1,2}(\Omega)$, we conclude the claimed estimate.
