# The Scholz conjecture on addition chains is true for $n=2^{m}(23)+7, m \in \mathbb{N}^{*}$

#### Abstract

The Scholz conjecture on addition chains states that $\ell\left(2^{n}-1\right) \leq \ell(n)+n-1$ for all integers $n$ where $\ell(n)$ stands for the minimal length of all addition chains for $n$. It is proven to hold for infinite sets of integers. In this paper, we will prove that the conjecture still holds for $n=2^{m}(23)+7$. It is the first set of integers given by Thurber 8 to prove that there are an infinity of integers satisfying $\ell(2 n)=\ell(n)$. Later on, Thurber 4] give a second set of integers with the same properties $\left(n=2^{2 m+k+7}+2^{2 m+k+5}+2^{m+k+4}+2^{m+k+3}+2^{m+2}+2^{m+1}+1\right)$. We will prove that the conjecture holds for them as well.


Keywords: Addition chain, Scholz-Bauer conjecture, minimal length, factor method

## Introduction

Exponentiation is a key operation in mathematics. It is often seen as a number of multiplications. Let $x$ be an integer, finding $x^{n}$ for a given $n$ seems to be easy. We need to do $n$ multiplications. But what if $n$ is getting very large. It is a very important operation in many areas like cryptography. The best tool know to do fast exponentiation is addition chain.

Definition 1. An addition chain for an integer $n$ is a set $\mathcal{C}=\left\{a_{0}=1, a_{1}, a_{2}, \ldots, a_{r}\right\}$ such that the last element $a_{r}$ is $n$ and every element $a_{k}$ is the sum of two previous elements $a_{i}$ and $a_{j}$. The integer $r$ is the length of the chain and is denoted $\ell(c)$.

One can easily see that there can be many addition chains of different length for the same integer $n$ and finding the minimal length for all addition chains of $n$ (denoted $\ell(n)$ ) is a NP-complete problem. Just to give an example, on can think that the fastest way to reach $2 n$ is by reaching $n$ and then doubling it, which means that $\ell(2 n)=\ell(n)+1$. It has been proven that there are infinitely many integers which don't follow that rule. We have $\ell(382)=\ell(191)=11$. The most famous conjecture on addition chain is giving an upper bound on the length of addition chains for integers with only " 1 "s in their binary expansion $\left(n=2^{a}-1\right.$ for some $\left.a\right)$.

Conjecture 2. The Scholz conjecture on addition chains states that

$$
\ell\left(2^{n}-1\right) \leq \ell(n)+n-1, \forall n \in \mathbb{N}
$$

Several decades of research and the conjecture has been proved to hold for $n<5784689$. It has been proven to hold for several sets of integers. We know that if it is true for $n$ and that $\ell(2 n)=\ell(n)+1$, then it is also true for $2 n$. We would like to know if it holds when $\ell(2 n)=\ell(n)$. An answer for the general case doesn't exist yet.

In this paper, we will investigate the two cases.

1. We will give a very simple proof that the conjecture holds for $2 n$ if it is for $n$ and $\ell(2 n)=\ell(n)+1$.
2. We will also prove that it holds for integers $n=2^{m}(23)+7$ which are known to be among the first infinite sets of integers verifying $\ell(2 n)=\ell(n)$.
The main result from Thurber [8] is
Theorem 3. Let $m$ be an integer greater than 5. Then

$$
\ell\left(2^{m}(23)+7\right)=m+8=\ell\left(2 \times\left(2^{m}(23)+7\right)\right)
$$

Let us remind the factor method, which is a method to construct a chain for the product $n m$ based on chains for $n$ and $m$.

Definition 4. Let $c_{1}$ and $c_{2}$ be addition chains respectively for $n_{1}$ and $n_{2}$. Then $c_{1} \times c_{2}$ is an addition chain for $n_{1} \times n_{2}$ of length $\ell\left(c_{1}\right)+\ell\left(c_{2}\right)$ where $\times$ is defined as follows:
if $c_{1}=\left\{a_{0}, a_{1}, \ldots, a_{r}\right\}$ and $c_{2}=\left\{b_{0}, b_{1}, \ldots, b_{l}\right\}$, then

$$
c_{1} \times c_{2}=\left\{a_{0}, a_{1}, \ldots, a_{r}, a_{r} \times b_{1}, a_{r} \times b_{2}, \times, a_{r} \times b_{l}\right\}
$$

The length of the new chain is the sum of the length of the chains, meaning that $\ell(m n) \leq \ell(n)+\ell(m)$.

## 1 Our contribution

Theorem 5. Let $n$ be a positive integer satisfying $\ell(2 n)=\ell(n)+1$. If the Scholz conjecture holds for $n$, then it also holds for $2 n$.

Proof. Let $n$ be a positive integer which satisfies $\ell(2 n)=\ell(n)+1$ and $\ell\left(2^{n}-1\right) \leq \ell(n)+n-1$. Let $n_{0}=2 n$ be another positive integer, we have

$$
2^{n_{0}}-1=\left(2^{n}-1\right)\left(2^{n}+1\right)
$$

using the factor method, we can deduce a chain for $2^{n_{0}}-1$ of length

$$
\ell(n)+n-1+n+1=\ell(n)+2 n=\ell\left(n_{0}\right)+n_{0}-1 .
$$

Theorem 6. The Scholz conjecture holds for all integers of the form $U_{m}=2^{m}(23)+7$.
It will be proven by induction on $m$
Proof. 1. Thanks to the computational results, the Scholz conjecture holds for $U_{m}, m \in\{1,2,3,4,5\}$
2. A chain for $X_{m}+3$ (with $X_{m}=2^{m}(23)$ ) of length $m+7$ can be obtain as follows

$$
\mathcal{C}_{\mathcal{X}_{\Downarrow}}=\left\{1,2,3,5,10,20,23,2 \times 23, \cdots, 2^{m} \times 23,2^{m} \times 23+3\right\}
$$

3. We know that

$$
U_{m+1}=2^{m+1}(23)+7
$$

so,

$$
X_{m}=U_{m}-7=\frac{U_{m+1}-1}{2}-3
$$

which leads to

$$
\begin{aligned}
2^{U_{m+1}}-1 & =2^{2\left(X_{m}+3\right)+1}-1 \\
& =2\left(2^{2\left(X_{m}+3\right)}-1\right)+1 \\
& =2\left(2^{X_{m}+3}-1\right)\left(2^{X_{m}+3}+1\right)+1
\end{aligned}
$$

From the chain of $\left(2^{X_{m}+3}-1\right)$ and using the factor method, we can then deduce a chain for $2^{U_{m+1}}-1$ of length

$$
\begin{aligned}
X_{m}+3+1+1+1+\ell\left(2^{X_{m}+3}-1\right) & =X_{m}+6+\ell\left(X_{m}+3\right)+X_{m}+3-1 \\
& =2 X_{m}+8+m \\
& =\left(2 x_{m}+7\right)+(m+9)-1 \\
& =U_{m+1}+\ell\left(U_{m+1}\right)-1
\end{aligned}
$$

Two years later, Thurber has also stated that
Theorem 7. For each $m \geq 1$, the set of integers with $v(n)=7$ and $n$ of the binary form $n=$ $101 \cdots m \cdots 11 \cdots k \cdots 11 \cdots m \cdots 1$ (where $k \geq 3$ ) is an infinite class of integers which $\ell(2 n)=\ell(n)$.
He prove that $\ell(n)=\lambda(n)+4$. We will also prove that the Scholz conjecture holds for such $n$.

Theorem 8. The Scholz conjecture on addition chain holds for $n=2^{2 m+k+7}+2^{2 m+k+5}+2^{m+k+4}+$ $2^{m+k+3}+2^{m+2}+2^{m+1}+1$.

Proof. Let us rewrite

$$
\begin{aligned}
n & =2^{2 m+k+7}+2^{2 m+k+5}+2^{m+k+4}+2^{m+k+3}+2^{m+2}+2^{m+1}+1 \\
& =2^{m+k+3}\left(2^{m+4}+2+2^{m+2}+1\right)+\left(2^{m+2}+1+2^{m+1}\right) \\
& =2^{m+k+3}\left(2\left(2^{m+3}+1\right)+\left(2^{m+2}+1\right)\right)+\left(2^{m+2}+1\right)+2^{m+1}
\end{aligned}
$$

A minimal chain for $n$ is

$$
\begin{gathered}
\rfloor=\left\{1,2, \ldots, 2^{m+1}, 2^{m+2}, 2^{m+2}+1,2^{m+3}+1,2^{m+1}+\left(2^{m+2}+1\right)=\beta\right. \\
2\left(2^{m+3}+1\right), 2\left(2^{m+3}+1\right)+\left(2^{m+2}+1\right)=\alpha \\
\left.2 \alpha, 2^{2} \alpha, \ldots, 2^{m+k+3} \alpha, n=2^{m+k+3} \alpha+\beta\right\}
\end{gathered}
$$

which is of length

$$
m+2+1+1+1+1+1+m+k+3+1=2 m+k+11=\lambda(n)+4
$$

Using the following rules:

1. If $A=2 B$, then we will get a chain for $2^{A}-1=\left(2^{B}-1\right)\left(2^{B}+1\right)$ by adding $B+1$ steps to a chain for $2^{B}-1$
2. If $A=B+1$, then we will add two steps $\left(2^{A}-1=2\left(2^{B}-1\right)+1\right)$
3. $2^{m+3}+1=2^{m+2}+2^{m+2}+1$, so

$$
2^{2^{m+3}+1}-1=2^{2^{m+2}}\left(2^{2^{m+2}+1}-1\right)+\left(2^{2^{m+2}}+1\right)
$$

4. $2^{m+2}+2^{m+1}+1=\left(2^{m+2}+1\right)+2^{m+1}$, so

$$
2^{2^{m+2}+2^{m+1}+1}-1=2^{2^{m+1}}\left(2^{2^{m+2}+1}-1\right)+\left(2^{2^{m+1}}-1\right)
$$

We can then construct a chain $\mathcal{C}$ for $2^{n}-1$ of length

$$
\begin{aligned}
\ell & =2^{m+2}+m+2-1+2+2^{m+2}+1+2+2^{m+3}+ \\
& +1+1+2^{m+2}+1+1+(m+k+3)+\alpha\left(2^{m+k+3}-1\right)+\beta \\
& =2 m+k+13+2^{m+4}+2^{m+2}+\left(2^{m+4}+2^{m+2}+2+1\right)\left(2^{m+k+3}-1\right)+2^{m+2}+2^{m+1}+1 \\
& =2 m+k+14+2^{m+4}+2^{m+3}+2^{m+1}+2^{2 m+k+7}+2^{2 m+k+5} 2^{m+k+4}+2^{m+k+3}-2^{m+4}-2^{m+2}-2-1 \\
& =(2 m+k+11)+\left(2^{2 m+k+7}+2^{2 m+k+5} 2^{m+k+4}+2^{m+k+3}+2^{m+2}+2^{m+1}\right)=\ell(n)+n-1 .
\end{aligned}
$$

## Conclusion

We don't know if the Scholz conjecture holds for all integers with $\ell(2 n)=\ell(n)$. It must be more difficult to investigate the case where $\ell(2 n)<\ell(n)$.
