# Cluster Toroidal Multipoles Formed by Electric-Quadrupole and Magnetic-Octupole Trimers: A Possible Scenario for Hidden Orders in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$

#### Abstract

Cluster multipole orderings composed of atomic high-rank multipole moments are theoretically investigated with a $5 d$-electron compound $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$ in mind. $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$ exhibits two hidden orders: One is an intermediate-temperature phase with time-reversal symmetry and the other is a low-temperature phase without time-reversal symmetry. By performing the symmetry and augmented multipole analyses for a $d$-orbital model under the hexagonal point group $D_{3 \mathrm{~h}}$, we find that the $120^{\circ}$-type ordering of the electric quadrupole corresponds to cluster electric toroidal dipole ordering with the electric ferroaxial moment, which can become the microscopic origin of the intermediate-temperature phase in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$. Furthermore, based on ${ }^{193}$ Ir synchrotron-radiation-based Mössbauer spectroscopy, we propose that the low-temperature phase in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$ is regarded as a coexisting state with cluster electric toroidal dipole and cluster magnetic toroidal quadrupole, the latter of which is formed by the $120^{\circ}$-type ordering of the magnetic octupole and accompanies a small uniform magnetization as a secondary effect. Our results provide a clue to two hidden phases in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$.


A toroidal multipole moment, which is characterized by different spatial and time-reversal parities from conventional electric and magnetic multipole moments, has drawn considerable interest owing to its fascinating electronic structures, cross-correlation response, and transport. ${ }^{1-7)}$ There are two types of toroidal multipoles: magnetic toroidal (MT) multipoles with the same symmetry property as time-reversal-odd polar tensors and electric toroidal (ET) multipoles with the same symmetry as time-reversal-even axial tensors. Among them, the odd-parity toroidal multipoles, i.e., the odd-rank MT and even-rank ET multipoles, have been extensively studied, since they give rise to physical phenomena related to the spatial-parity breaking, such as the magnetoelectric effect under the MT dipole, ${ }^{8-17)}$ nonlinear (spin) transport ${ }^{18-25)}$ and nonreciprocal magnon excitations under the MT dipole and octupole, ${ }^{26-31)}$ and Edelstein effect and rotation-field induced electric polarization under the ET monopole and quadrupole. ${ }^{32-37)}$ These unconventional electronic orderings have been proposed and identified in metallic materials, such as the MT dipole orderings in $\mathrm{UNi}_{4} \mathrm{~B},{ }^{12,38-44)} \mathrm{Ce}_{3} \mathrm{TiBi}_{5},{ }^{45-48)}$ and $\mathrm{CeCoSi}^{36,49-55)}$ and ET quadrupole orderings in $\mathrm{Cd}_{2} \mathrm{Re}_{2} \mathrm{O}_{7} \cdot{ }^{56-64)}$

Meanwhile, the even-parity toroidal multipoles, i.e., the even-rank MT and odd-rank ET multipoles, have also been recognized to exhibit various off-diagonal responses and transports in spite of the presence of spatial inversion symmetry. For example, the MT quadrupole (MTQ) gives rise to a symmetric spin splitting in the electronic band structure to generate the spin current even without
relativistic spin-orbit coupling (SOC). ${ }^{65-68)}$ In addition, the ET dipole (ETD) and octupole induce unconventional transverse responses, ${ }^{69-71)}$ such as the antisymmetric thermopolarization. ${ }^{72)}$ However, candidate materials with even-parity toroidal multipoles have been rare compared to those with odd-parity ones; $\mathrm{CaMn}_{7} \mathrm{O}_{12},{ }^{73}$ ) $\mathrm{RbFe}\left(\mathrm{MoO}_{4}\right)_{2},{ }^{74,75)}$ and $\mathrm{NiTiO}_{3}{ }^{75-77)}$ are a few examples to possess the ETD in bulk and no materials with the MTQ have been recognized. ${ }^{68)}$ Thus, searching for compounds with even-parity toroidal orderings is highly desired.
$\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$ has a hexagonal structure $(P \overline{6} 2 m)$, which might be a prototype to possess both ETD and MTQ, as will be discussed. This material undergoes two phase transitions at 105 K and $7.8 \mathrm{~K}:^{78,79)}$ The former transition was identified as the onset of the ETD ordering with the $\sqrt{3} a \times \sqrt{3} a \times 3 c$ superstructure in the hexagonal coordinate, ${ }^{80-82)}$ although relevant electronic degrees of freedom for the ETD ordering have been still lacking. The latter was identified as the antiferromagnetic ordering, ${ }^{83-85)}$ where a detailed structure has not been revealed; no magnetic reflections have been observed by powder neutron diffraction experiments ${ }^{86)}$ and a possibility of multipole magnetic ordering was implied, ${ }^{85)}$ which is similar to the hidden order in $\mathrm{URu}_{2} \mathrm{Si}_{2} .{ }^{87,88)}$ The emergence of such peculiar orderings might be attributed to a comparable energy scale among the SOC, exchange interaction, and transfer arising from the Ir $5 d$ electrons, as demonstrated by the density functional theory calculations. ${ }^{89)}$

In the present study, we investigate the possi-
bility of even-parity ETD and MTQ orderings in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$. Based on symmetry analysis, cluster multipole theory, and experimental observations including ${ }^{193} \mathrm{Ir}$ synchrotron-radiation-based Mössbauer spectroscopy (SRMS), we propose that the intermediatetemperature (IT) phase corresponds to a cluster ETD and the low-temperature (LT) phase corresponds to a cluster MTQ; the former is characterized by an electric-quadrupole (EQ) trimer, while the latter is by a magnetic-octupole (MO) trimer. We show that the system under both the ETD and MTQ exhibits a spontaneous magnetization along the $z$ direction. We also discuss possible superlattice structures for two ordered phases in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$.

Let us start by considering a three-sublattice triangular cluster with five $d$ orbitals, $\left(d_{u}, d_{v}, d_{y z}, d_{z x}, d_{x y}\right)$ for $u=3 z^{2}-r^{2}$ and $v=x^{2}-y^{2}$, under the point group $D_{3 \mathrm{~h}}$. We denote the sublattice index as $i=1-3$. In the spinless Hilbert space, the irreducible representations (IRs) of the five $d$ orbitals are $d_{u} \in \mathrm{~A}_{1}^{\prime},\left(d_{v}, d_{x y}\right) \in \mathrm{E}^{\prime}$, and $\left(d_{y z}, d_{z x}\right) \in \mathrm{E}^{\prime \prime}$. Then, active atomic multipoles with time-reversal even are rank-0 electric monopole, rank2 EQ , and rank-4 electric hexadecapole, which belong to the IR $\mathrm{A}_{1}^{\prime+}, \mathrm{A}_{1}^{\prime \prime+}, \mathrm{A}_{2}^{\prime \prime+}, \mathrm{E}^{\prime+}$, and $\mathrm{E}^{\prime \prime+}$ according to the type of multipoles; the superscript $\pm$ represents the timereversal parity. ${ }^{90,91)}$ Among them, the atomic multipoles belonging to the $\mathrm{E}^{\prime+}$ representation can construct the $\mathrm{A}_{2}^{\prime+}$ representation corresponding to the ETD within a triangular cluster. Thus, the Hilbert space should include such multipole degrees of freedom belonging to the $\mathrm{E}^{\prime+}$ representation to describe the ETD ordering observed in

$\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12},{ }^{82)}$ where each triangle unit of the Ir ions is supposed to have the ETD based on the Raman scattering experiments. ${ }^{80)}$

Based on this symmetry analysis, we consider an effective model to include the multipoles under the $\mathrm{E}^{\prime+}$ representation. Specifically, we adopt a minimal twoorbital basis consisting of $d_{z x}$ and $d_{y z}$, which forms $| \pm 1 \sigma\rangle=\left(\mp\left|d_{z x} \sigma\right\rangle-i\left|d_{y z} \sigma\right\rangle\right) / \sqrt{2}$ for $\sigma=\uparrow, \downarrow ; \pm 1$ represents the magnetic quantum number. ${ }^{92)}$ For this atomic basis, there are 4 spinless and 12 spinful multipole degrees of freedom. By introducing the Pauli matrices $\tau_{\mu}$ and $\sigma_{\nu}$ for $\mu, \nu=0, x, y, z$ in the orbital and spin space for the basis $\left\{\left|d_{z x} \uparrow\right\rangle,\left|d_{y z} \uparrow\right\rangle,\left|d_{z x} \downarrow\right\rangle,\left|d_{y z} \downarrow\right\rangle\right\}$, respectively ( $\tau_{0}$ and $\sigma_{0}$ denote the $2 \times 2$ identity matrices), each multipole is described by a linear combination of $\tau_{\mu} \sigma_{\nu}$, as shown in Table I. ${ }^{93,94)}$ The prime symbol in the multipole in Table I means the spinful multipoles. The multipoles belonging to the $\mathrm{E}^{\prime+}$ representation are two EQs: $Q_{v}$ and $Q_{x y} \cdot{ }^{95)}$

Next, let us consider the three-sublattice structure of $Q_{v}$ and $Q_{x y}$. We show possible three-sublattice structures in Fig. 1(a) based on cluster multipole theory, ${ }^{96,97)}$ where the superscript (c) of the multipole represents the cluster multipole. When superposing $\left(Q_{v}, Q_{x y}\right)=$ $(\sqrt{3} / 2,-1 / 2)$ for site $1,(-\sqrt{3} / 2,-1 / 2)$ for site 2 , and $(0,1)$ for site 3 , we obtain the cluster ETD $G_{z}^{(\mathrm{c})}$ belonging to the $\mathrm{A}_{2}^{\prime+}$ representation, which reduces the symmetry to $C_{3 \mathrm{~h}}$. Since the other three-sublattice structures are incompatible with the $\mathrm{A}_{2}^{\prime+}$ representation, the orbital trimer consisting of the EQs is a natural candidate of the IT phase in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$.

The Kramers degeneracy remains in the $G_{z}^{(\mathrm{c})}$ order owing to the presence of time-reversal symmetry. Then, the further phase transition breaking time-reversal symmetry is expected, which corresponds to the LT phase in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$. To narrow down possible order parameters,

we perform ${ }^{193}$ Ir SRMS at BL35XU of SPring-8. The experimental details were reported in Ref. 98. ${ }^{99 \text { ) }}$ Figure 2 shows ${ }^{193} \mathrm{Ir}$ SRMS in the IT phase at 12 K and the LT phase at 4 K measured with 4 bunch $\times 84$ train mode in SPring- $8,{ }^{100)}$ where the data for $T \geq 30 \mathrm{~K}$ were presented in Ref. 101. The spectra do not qualitatively change in the phase transition, which demonstrates that hyperfine magnetic field is absent at ${ }^{193}$ Ir below the magnetic transition temperature of 7.8 K . The resolution limit of the magnetic moment for $\mathrm{Ir}^{4+}$ is evaluated around $0.01 \mu_{\mathrm{B}}$ by using its hyperfine coupling constant as $85 \mathrm{~T} / \mu_{\mathrm{B}}{ }^{102-104)}$ and the magnetic splitting $1 \mathrm{~mm} / \mathrm{s}$ in ${ }^{193}$ Ir SRMS spectra corresponding to 0.85 T , which is comparable to the magnitude of the magnetic moments observed by previous $\mu \mathrm{SR}$ studies with the dipole approximation. ${ }^{84)}$ Since such a situation is similar to $\mathrm{NpO}_{2},{ }^{105-107)}$ the higherrank magnetic multipole ordering is expected.

In addition, we take into account two conditions: (i) tiny uniform magnetization ${ }^{108)}$ and (ii) threefold symmetric cluster structure. ${ }^{80)}$ Based on these conditions, it is natural to consider that the primary magnetic order parameter is described by the three-sublattice ordering of MOs rather than the magnetic dipoles. Among the MOs $\left(M_{x y z}^{\prime}, M_{z}^{\prime \beta}, M_{3 a}^{\prime}, M_{3 b}^{\prime}, M_{3 u}^{\prime}, M_{3 v}^{\prime}\right)$ in Table I, only $M_{x y z}^{\prime}$ and $M_{z}^{\prime \beta}$ belonging to $\mathrm{E}^{\prime-}$ satisfy the above conditions. We present six three-sublattice structures of $M_{x y z}^{\prime}$ and $M_{z}^{\prime \beta}$ in Fig. 1(b), where the cluster MTQ $T_{u}^{(\mathrm{c})}$ and the cluster MO $M_{z}^{\alpha(\mathrm{c})}$ are allowed to have a uniform magnetization along the $z$ direction ( $M_{z}$ and $\left.M_{z}^{\prime}\right) ; T_{u}^{(\mathrm{c})}\left(M_{z}^{\alpha(\mathrm{c})}\right)$ is constituted of $\left(M_{z}^{\prime \beta}, M_{x y z}^{\prime}\right)=$ $(\sqrt{3} / 2,-1 / 2)[(-1 / 2,-\sqrt{3} / 2)]$ for site $1,(-\sqrt{3} / 2,-1 / 2)$ $[(-1 / 2, \sqrt{3} / 2)]$ for site 2 , and $(0,1)[(1,0)]$ for site 3 . In this case, $M_{z}$ and $M_{z}^{\prime}$ correspond to the secondary order parameters. Although the resultant magnetic point group is the same between $T_{u}^{(\mathrm{c})}$ and $M_{z}^{\alpha(\mathrm{c})}$, their origin of spontaneous magnetization is different from each other, as detailed below.

We model the above situation in the triangular cluster for the basis $\left\{\left|d_{z x} \uparrow\right\rangle,\left|d_{y z} \uparrow\right\rangle,\left|d_{z x} \downarrow\right\rangle,\left|d_{y z} \downarrow\right\rangle\right\}$. The

where $c_{i \alpha \sigma}^{\dagger}$ and $c_{i \alpha \sigma}$ are creation and annihilation operators of electrons at site $i=1-3$, orbital $\alpha=v, x y$, and spin $\sigma=\uparrow, \downarrow$. The total Hamiltonian $\mathcal{H}$ consists of four terms. The first term $\mathcal{H}_{\text {SOC }}$ in Eq. (1) represents the SOC, where $\boldsymbol{l}_{i}=\left(l_{i}^{x}, l_{i}^{y}, l_{i}^{z}\right)$ and $\boldsymbol{s}_{i}=\left(s_{i}^{x}, s_{i}^{y}, s_{i}^{z}\right)$ are orbital and spin angular momentum operators, respectively. The second term $\mathcal{H}_{t}$ in Eq. (1) represents the hopping to satisfy the Slater-Koster parameters: $t_{d d \pi}=1$. The third term $\mathcal{H}_{\mathrm{MF}}^{\mathrm{Q}}$ in Eq. (1) stands for the mean field corresponding to $G_{z}^{(\mathrm{c})}$, where we introduce $\tilde{\boldsymbol{\tau}}=\left(-\tau_{z}, \tau_{x}\right)$ and the unit vectors for $i$ th site $\boldsymbol{e}_{i} ; \boldsymbol{e}_{1}=(-\sqrt{3} / 2,-1 / 2)$, $\boldsymbol{e}_{2}=(\sqrt{3} / 2,-1 / 2)$, and $\boldsymbol{e}_{3}=(0,1)$. The fourth term $\mathcal{H}_{\mathrm{MF}}^{\mathrm{M}}$ in Eq. (1) stands for the mean fields corresponding to $T_{u}^{(\mathrm{c})}$ in the first term and $M_{z}^{\alpha(\mathrm{c})}$ in the second term; $p(\sigma)=+1(-1)$ for $\sigma=\uparrow(\downarrow)$. It is noted that $h_{\mathrm{Q}} \neq 0$ in the IT phase, while $h_{\mathrm{M}} \neq 0$ and/or $h_{\mathrm{M}}^{\prime} \neq 0$ in addition to $h_{\mathrm{Q}} \neq 0$ in the LT phase. The amplitudes of the mean fields are set as $h_{\mathrm{Q}}$ in Eq. (4) and $h_{\mathrm{M}}^{\left({ }_{\mathrm{M}}\right)}$ in Eq. (5).

For the model in Eq. (1), we investigate the behavior of the uniform magnetization $\left\langle M_{z}^{\text {tot }}\right\rangle=\left\langle l^{z}+2 s^{z}\right\rangle=$ $\left\langle\sum_{i}\left(l_{i}^{z}+2 s_{i}^{z}\right)\right\rangle$ with $\left\langle l_{1}^{z}+2 s_{1}^{z}\right\rangle=\left\langle l_{2}^{z}+2 s_{2}^{z}\right\rangle=\left\langle l_{3}^{z}+2 s_{3}^{z}\right\rangle$ in the LT phase by setting the temperature $T=0.1$, where $\left\langle M_{z}^{\text {tot }}\right\rangle=\operatorname{Tr}\left[e^{-E_{k} / T} M_{z}^{\text {tot }}\right] / Z(Z$ is the partition function, $T$ is the temperature, and $E_{k}$ is the $k$ th eigenenergies). Figure 3(a) shows the $h_{\mathrm{M}}$ dependence of $\left\langle M_{z}^{\text {tot }}\right\rangle$ as well as $\left\langle G_{z}^{(\mathrm{c})}\right\rangle$ and $\left\langle T_{u}^{(\mathrm{c})}\right\rangle$ in the $T_{u}^{(\mathrm{c})}$ order at $h_{\mathrm{M}}^{\prime}=0, \lambda=5$, and $h_{\mathrm{Q}}=0.3 ;\left\langle G_{z}^{(\mathrm{c})}\right\rangle$ and $\left\langle T_{u}^{(\mathrm{c})}\right\rangle$ correspond to the $120^{\circ}$ distributions of the atomic $\left(Q_{v}, Q_{x y}\right)$ and $\left(M_{x y z}^{\prime}, M_{z}^{\prime \beta}\right)$, respectively, as shown in Fig. 1. The result clearly indicates that $\left\langle M_{z}^{\text {tot }}\right\rangle$ increases while $\left\langle T_{u}^{(\mathrm{c})}\right\rangle$ is developed. The similar result is also obtained in the $M_{z}^{\alpha(\mathrm{c})}$ order by setting $h_{\mathrm{M}}=0$ but $h_{\mathrm{M}}^{\prime} \neq 0 ;\left\langle M_{z}^{\text {tot }}\right\rangle$ becomes nonzero for $\left\langle M_{z}^{\alpha(\mathrm{c})}\right\rangle \neq 0$, as shown in Fig. 3(b).

The different behavior of $\left\langle M_{z}^{\text {tot }}\right\rangle$ between the $T_{u}^{(\mathrm{c})}$ and $M_{z}^{\alpha(\mathrm{c})}$ orders is found when $\left\langle G_{z}^{(\mathrm{c})}\right\rangle \rightarrow-\left\langle G_{z}^{(\mathrm{c})}\right\rangle ;\left\langle M_{z}^{\text {tot }}\right\rangle \rightarrow$ $-\left\langle M_{z}^{\mathrm{tot}}\right\rangle$ in the $T_{u}^{(\mathrm{c})}$ order, whereas $\left\langle M_{z}^{\mathrm{tot}}\right\rangle \rightarrow\left\langle M_{z}^{\mathrm{tot}}\right\rangle$ in the $M_{z}^{\alpha(\mathrm{c})}$ order. In other words, the uniform magnetization is canceled out for different domains of $\left\langle G_{z}^{(\mathrm{c})}\right\rangle$ in the $T_{u}^{(\mathrm{c})}$ order, while it is not in the $M_{z}^{\alpha(\mathrm{c})}$ order.

The magnitude of $\left\langle M_{z}^{\text {tot }}\right\rangle$ is dependent on the model parameters $t_{d d \pi}, \lambda$, and $h_{\mathrm{Q}}$. We present the cases of small $\left\langle M_{z}^{\text {tot }}\right\rangle$ by taking $h_{\mathrm{Q}}=0.01$ and $\lambda=1$ in the $T_{u}^{(\mathrm{c})}$ order in Fig. 3(c) and taking $\lambda=20$ in the $M_{z}^{\alpha(\mathrm{c})}$ order in Fig. 3(d) as examples. In both ordered cases, the crystal Hall effect is expected even for negligibly small $\left\langle M_{z}^{\text {tot }}\right\rangle$, which might be a signature of the $T_{u}^{(\mathrm{c})}$ and/or $M_{z}^{\alpha(\mathrm{c})}$ orders. ${ }^{109-112)}$

Let us discuss the model parameter dependence of $\left\langle M_{z}^{\text {tot }}\right\rangle$ for both ordered states. By analytically expanding the trace, one can obtain the essential model parameters for inducing $\left\langle M_{z}^{\text {tot }}\right\rangle .{ }^{113-115)}$ In the $T_{u}^{(\mathrm{c})}$ order, we find that $\left\langle s^{z}\right\rangle\left(\left\langle l^{z}\right\rangle\right)$ is proportional to $h_{\mathrm{Q}} h_{\mathrm{M}}\left(\lambda h_{\mathrm{Q}} h_{\mathrm{M}}\right)$. Thus, nonzero $\left\langle G_{z}^{(\mathrm{c})}\right\rangle$ is essentially important but the hopping is not for inducing $\left\langle M_{z}^{\text {tot }}\right\rangle$. This is understood from the atomic limit by taking $t_{d d \pi} \rightarrow 0$. When considering site 3 , one finds that a superposition of $\tau_{x} \sigma_{0}$ corresponding to $Q_{x y}$ and $\tau_{x} \sigma_{z}$ corresponding to $M_{x y z}^{\prime}$ naturally leads to $\tau_{0} \sigma_{z}$ in their coupling. This is also consistent with the symmetry argument; $\left\langle M_{z}^{\text {tot }}\right\rangle$ must vanish for $\left\langle G_{z}^{(\mathrm{c})}\right\rangle=0$, since the representation of $T_{u}^{(c)}$ is different from that of $M_{z}^{\text {tot }}$. This is why the sign of $\left\langle M_{z}^{\text {tot }}\right\rangle$ depends on that of $\left\langle G_{z}^{(\mathrm{c})}\right\rangle$.

On the other hand, the different essential model parameters for $\left\langle M_{z}^{\text {tot }}\right\rangle$ are obtained in the $M_{z}^{\alpha(\mathrm{c})}$ order; $\left\langle s^{z}\right\rangle$ $\left(\left\langle l^{z}\right\rangle\right)$ is proportional to $h_{\mathrm{M}}^{\prime} t_{d d \pi}^{2}\left(\lambda h_{\mathrm{M}}^{\prime} t_{d d \pi}^{2}\right)$. Thus, the precursor $\left\langle G_{z}^{(\mathrm{c})}\right\rangle$ is not necessarily for nonzero $\left\langle M_{z}^{\text {tot }}\right\rangle$ in this case. Moreover, one finds that the cluster structure connected by the hopping is important in this case; $\left\langle M_{z}^{\text {tot }}\right\rangle$ vanishes for $t_{d d \pi}=0$.

We apply the above results to the crystal system with $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$ in mind. In the present scenario, the IT phase in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$ is described by the density waves of the cluster ETD (EQ trimer) $\left\langle G_{z}^{(\mathrm{c})}\right\rangle$ at $\boldsymbol{q}=$ ( $1 / 3,1 / 3,1 / 3$ ), as shown in Fig. 4(a). The periodic alignment of $\left(+\left\langle G_{z}^{(\mathrm{c})}\right\rangle,-\left\langle G_{z}^{(\mathrm{c})}\right\rangle, 0\right)$ leads to a charge dispropor-

tionation of the Ir ion to satisfy $\mathrm{Ir}^{4+}: \operatorname{Ir}^{5+}=1: 2$, which is consistent with SRMS. ${ }^{101)}$ When the temperature is lowered, the remaining triangle occupied by $\mathrm{Ir}^{4+}$ is expected to show the $T_{u}^{(\mathrm{c})}$ (or $M_{z}^{\alpha(\mathrm{c})}$ ) order, as shown in Fig. 4(b). Thus, a coexisting state with $G_{z}^{(\mathrm{c})}$ and $T_{u}^{(\mathrm{c})}$ (or $M_{z}^{\alpha(\mathrm{c})}$ ) corresponds to the LT phase in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$. It is noted that the triangles with $\pm\left\langle G_{z}^{(\mathrm{c})}\right\rangle$ also have nonzero $\left\langle T_{u}^{(\mathrm{c})}\right\rangle$ via the interplaquette coupling, and hence, the induced magnetization should be small.

Finally, let us comment on how to distinguish $T_{u}^{(\mathrm{c})}$ and $M_{z}^{\alpha(\mathrm{c})}$, either of which can be the primary order parameter in the LT phase. Since there is correspondence as $T_{u} \leftrightarrow x z s_{y}-y z s_{x}$ and $M_{z}^{\alpha} \leftrightarrow\left(3 z^{2}-r^{2}\right) s_{z}-z\left(x s_{x}+y s_{y}\right)$ based on the augmented multipole description, ${ }^{90,116)}$ the quantitative difference between them appears when an external magnetic field is applied; $y z(z x)$-type distortion is dominantly observed under the $x$-directional magnetic field in the $T_{u}^{(\mathrm{c})}\left(M_{z}^{\alpha(\mathrm{c})}\right)$ order.

To summarize, we have proposed a possible scenario for two hidden phases in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$ on the basis of the augmented multipole description and the SRMS measurement. By considering the trimer structures consisting of EQ and MO in a multi-orbital $d$-electron model, we showed that the IT and LT phases correspond to the cluster ETD and the coexistence of the cluster ETD and MTQ (or MO), respectively. In the LT phase, the uniform magnetization is spontaneously induced as the secondary order parameter. The present results will be useful to identify hidden order parameters in $\mathrm{Ca}_{5} \mathrm{Ir}_{3} \mathrm{O}_{12}$ by not only macroscopic physical responses but also local probes.
