# Diffusion Maps for Group-Invariant Manifolds

#### Abstract

In this article, we consider the manifold learning problem when the data set is invariant under the action of a compact Lie group $K$. Our approach consists in augmenting the data-induced graph Laplacian by integrating over the $K$-orbits of the existing data points, which yields a $K$-invariant graph Laplacian $L$. We prove that $L$ can be diagonalized by using the unitary irreducible representation matrices of $K$, and we provide an explicit formula for computing its eigenvalues and eigenfunctions. In addition, we show that the normalized Laplacian operator $L_{N}$ converges to the Laplace-Beltrami operator of the data manifold with an improved convergence rate, where the improvement grows with the dimension of the symmetry group $K$. This work extends the steerable graph Laplacian framework of Landa and Shkolnisky from the case of $\mathrm{SO}(2)$ to arbitrary compact Lie groups.


## 1 Introduction

In manifold learning, a given data set $\mathcal{X}=\left\{x_{1}, \ldots, x_{N}\right\} \subseteq \mathbb{R}^{\mathcal{D}}$ is assumed to lie on or near a low-dimensional manifold $\mathcal{M}$ of dimension $d \ll \mathcal{D}$. Tools in this field have important applications in data analysis, including dimensionality reduction [1, 19, 21, semi-supervised learning [8, 13], function approximation [5, 17] and denoising [10. A prevalent approach to manifold learning is based on constructing a weighted graph whose vertices are the elements of $\mathcal{X}$ and where edges are assigned weights according to the affinity of the pairs of points in question. More precisely, edge $\left\{x_{i}, x_{j}\right\}$ is assigned the weight $W_{i j}=K_{\varepsilon}\left(\left\|x_{i}-x_{j}\right\|\right)$, where $K_{\varepsilon}$ is a kernel function, commonly chosen to be the Gaussian kernel $W_{i j}=\exp \left(-\left\|x_{i}-x_{j}\right\| / \varepsilon\right)$. The graph Laplacian $L$ is then defined to act on functions $f: \mathcal{X} \rightarrow \mathbb{R}$ by

$$
L f\left(x_{i}\right)=D_{i i} f\left(x_{i}\right)-\sum_{j=1}^{N} W_{i j} f\left(x_{j}\right),
$$

where $D_{i i}=\sum_{j=1}^{N} W_{i j}$. After suitable normalization, as $N \rightarrow \infty$ the graph Laplacian $L$ approximates the Laplace-Beltrami operator $\Delta_{\mathcal{M}}$ [19] of the data manifold $\mathcal{M}$ and its eigenvectors converge to the eigenfunctions of $\Delta_{\mathcal{M}}$ 2. Methods that use the graph Laplacian include the spectral embedding techniques of diffusion maps [7] and Laplacian eigenmaps [2].

There are important applications where the data points are each subject to an unknown rotation or reflection, or more generally the action of an unknown group element [9]. For example, consider 2D tomographic images in cryo-electron microscopy [16], which are subject to 2D rigid transformations, or 3D subtomograms in cryo-electron tomography [12], which are subject to spatial rotations. For data sets like these, it is most natural to assume that the underlying data manifold is closed under the group action. The question arises: how should we incorporate symmetries into the graph Laplacian framework?

This paper gives a principled answer to this question. In practice data augmentation is common 4, however adding in random points from each observation's orbits runs the risk of becoming too computationally expensive. Instead, we extend a framework of Landa and Shkolnisky 10 to arbitrary compact Lie groups. This achieves infinite data augmentation efficiently, through analytic integration over the group orbits. We

[^0]construct the $K$-invariant graph Laplacian $L$ where $K$ is the underlying symmetry group in Section 3 The main result is Theorem 3.4, where we characterize the eigenvalues and eigenfunctions of $L$ and show how to compute them. Then in Section 4 we prove Theorem 4.2 which states that the normalized graph Laplacian $L_{N}=D^{-1} L$ converges pointwise to the Laplace-Beltrami operator on $\mathcal{M}$. Moreover, we prove that the variance term of the convergence scales with $d-\operatorname{dim}(K)$ rather than $d$ in the case of symmetry-unaware diffusion maps. This implies an improved sample complexity rate for computations with the graph Laplacian.

## 2 Setting

Let $\mathcal{M}$ be a compact $d$-dimensional smooth manifold without boundary embedded in $\mathbb{R}^{\mathcal{D}}$. Consider data points $\left\{x_{1}, x_{2}, \ldots, x_{N}\right\} \subseteq \mathbb{R}^{\mathcal{D}}$ sampled independently from the uniform probability distribution $p(x)$ on $\mathcal{M}$.

To encode the symmetries of $\mathcal{M}$, we let $K$ be a compact Lie group acting linearly and by isometries on $\mathbb{R}^{\mathcal{D}}$, and we assume $\mathcal{M}$ is $K$-invariant: for every $x \in \mathcal{M}$ and $\kappa \in K$, it holds that $\kappa \cdot x \in \mathcal{M}$. Moreover, we assume that the action of $K$ on $\mathcal{M}$ is generically free, meaning that the set of points in $\mathcal{M}$ whose stabilizer is nontrivial has measure zero. In other words, if $\mathcal{M}^{\prime}$ is the subset of $\mathcal{M}$ where $K$ acts freely, then $\mathcal{M} \backslash \mathcal{M}^{\prime}$ has measure zero. In particular, integrating over $\mathcal{M}^{\prime}$ is the same as integrating over $\mathcal{M}$, and we will use this fact without further mention in Section 4.

## 3 The $K$-invariant graph Laplacian and its spectrum

Take $\Gamma:=\{1,2, \ldots, N\} \times K$, and consider the space $\mathcal{H}=\mathcal{L}^{2}(\Gamma)$ of square integrable functions $f: \Gamma \rightarrow \mathbb{R}$ equipped with the inner product

$$
\langle g, f\rangle:=\sum_{i=1}^{N} \int_{K} g^{*}(i, \kappa) f(i, \kappa) d \kappa
$$

where $d \kappa$ is the normalized Haar measure on $K$. This is an infinite-dimensional complex Hilbert space. Note that, for any $f \in \mathcal{H}$, we can write $f(i, \kappa)=f_{i}(\kappa)$ with $\left\{f_{i}\right\}_{i=1}^{N} \in \mathcal{L}^{2}(K)$. Hence, we can view a function in $\mathcal{H}$ as an $N$-dimensional vector where each entry is a square-integrable function on $K$.

For any pair of data points $x_{i}, x_{j}$ and any pair of elements $\kappa, \lambda$ in $K$, we define the affinity between the elements $\kappa \cdot x_{i}$ and $\lambda \cdot x_{j}$ in $\mathbb{R}^{\mathcal{D}}$ as

$$
\begin{equation*}
W_{i j}(\kappa, \lambda):=\exp \left(-\left\|\kappa \cdot x_{i}-\lambda \cdot x_{j}\right\|^{2} / \varepsilon\right) \tag{3.1}
\end{equation*}
$$

Then we define the affinity operator $W: \mathcal{H} \rightarrow \mathcal{H}$ by

$$
W f(i, \kappa)=\sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) f(j, \lambda) d \lambda
$$

for any function $f \in \mathcal{H}$, and any $(i, \kappa) \in \Gamma$. This operator defines a weighted graph $G=(V, E, W)$ whose vertices $V$ are the data points $\left\{x_{1}, \ldots, x_{n}\right\}$ together with all the points $\kappa \cdot x_{i}, 1 \leq i \leq N$ and $\kappa \in K$, in their orbits under the action of $K$; and the set of edges $E$ consists of all the pairs $\left\{\kappa \cdot x_{i}, \lambda \cdot x_{j}\right\}$ for which $W_{i, j}(\kappa, \lambda)>0$.
Lemma 3.1. For any group elements $\kappa, \lambda \in K$, it holds that

$$
W_{i j}(\kappa, \lambda)=W_{i j}\left(\operatorname{Id}, \kappa^{-1} \lambda\right)
$$

where Id is the identity element of $K$.
Proof. This follows from the fact that $K$ acts by isometries on $\mathbb{R}^{\mathcal{D}}$, since acting by $k^{-1}$ gives

$$
\left\|\kappa \cdot x_{i}-\lambda \cdot x_{j}\right\|^{2}=\left\|x_{i}-\kappa^{-1} \lambda \cdot x_{j}\right\|^{2}
$$

Let $D$ be the diagonal matrix with diagonal entries given by

$$
D_{i i}=\sum_{j=1}^{N} \int_{K} W_{i j}(\mathrm{Id}, \lambda) d \lambda
$$

Note that the entries $D_{i i}$ are constant. In addition, as $d \lambda$ is the Haar measure on $K$, it is invariant under left translations, so we have that

$$
D_{i i}=\sum_{j=1}^{N} \int_{K} W_{i j}(\operatorname{Id}, \lambda) d \lambda=\sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) d \lambda .
$$

That is, $D_{i i}$ is independent of the group element $\kappa$ in the first argument of $W_{i j}$.
Define the graph Laplacian $L: \mathcal{H} \rightarrow \mathcal{H}$ by $L f=D f-W f$. More explicitly, it acts on a function $f \in \mathcal{H}$ as

$$
L f(i, \kappa)=f(i, \kappa) \sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) d \lambda-\sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) f(j, \lambda) d \lambda
$$

Lemma 3.2. The graph Laplacian $L$ admits the quadratic form

$$
\langle f, L f\rangle=\frac{1}{2} \sum_{i=1}^{N} \sum_{j=1}^{N} \int_{K} \int_{K} W_{i j}(\kappa, \lambda)\left|f_{i}(\kappa)-f_{j}(\lambda)\right|^{2} d \kappa d \lambda
$$

Proof.

$$
\begin{aligned}
\langle f, L f\rangle & =\sum_{i=1}^{N} \int_{K} f^{*}(i, \kappa) L f(i, \kappa) d \kappa \\
& =\sum_{i=1}^{N} \int_{K} f^{*}(i, \kappa)\left[f(i, \kappa) \sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) d \lambda-\sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) f(j, \lambda) d \lambda\right] \\
& =\sum_{i=1}^{N} \sum_{j=1}^{N} \int_{K} \int_{K} W_{i j}(\kappa, \lambda)\left[f^{*}(i, \kappa) f(i, \kappa)-f^{*}(i, \kappa) f(j, \lambda)\right] d \kappa d \lambda \\
& =\frac{1}{2} \sum_{i=1}^{N} \sum_{j=1}^{N} \int_{K} \int_{K} W_{i j}(\kappa, \lambda)\left[f^{*}(i, \kappa) f(i, \kappa)-2 f^{*}(i, \kappa) f(j, \lambda)+f^{*}(j, \lambda) f(j, \lambda)\right] d \kappa d \lambda \\
& =\frac{1}{2} \sum_{i=1}^{N} \sum_{j=1}^{N} \int_{K} \int_{K} W_{i j}(\kappa, \lambda)|f(i, \kappa)-f(j, \lambda)|^{2} d \kappa d \lambda
\end{aligned}
$$

From here we conclude that $L$ is positive semidefinite, since $\langle f, L f\rangle \geq 0$ for all $f \in \mathcal{H}$.
We are interested in finding the eigenvalues and eigenvectors of the graph Laplacian $L$. In doing so, we need to take the Fourier transform of each $W_{i j}(\kappa, \lambda)$, which involves the representation theory of $K$ [18, 6. For each $i, j \in\{1, \ldots, N\}$, consider the Fourier transform

$$
\widehat{W}_{i j}^{(\ell)}=\int_{K} W_{i j}\left(\mathrm{Id}, \kappa^{-1} \lambda\right) U_{\ell}\left(\kappa^{-1} \lambda\right) d\left(\kappa^{-1} \lambda\right)=\int_{K} W_{i j}(\mathrm{Id}, \kappa) U_{\ell}(\kappa) d \kappa
$$

where $U_{\ell}\left(\kappa^{-1} \lambda\right)$ is the $\ell$-th irreducible unitary representation matrix for $K$. Note that $\widehat{W}_{i j}^{(\ell)}$ is an $\operatorname{dim} E_{\ell} \times$ $\operatorname{dim} E_{\ell}$ matrix which does not depend on $K$. More explicitly, the entries $\left[\widehat{W}_{i j}^{(\ell)}\right]_{m n}$ of $\widehat{W}_{i j}^{(\ell)}$ are given by

$$
\left[\widehat{W}_{i j}^{(\ell)}\right]_{m n}=\int_{K} W_{i j}(\mathrm{Id}, \kappa) U_{\ell}(\kappa)_{m n} d \kappa
$$

where $U_{\ell}(\kappa)_{m n}$ is the $(m, n)$-entry of the matrix $U_{\ell}(\kappa)$. Using the Fourier transform, we can expand $W_{i j}(\kappa, \lambda)$ in a Fourier series as

$$
W_{i j}(\kappa, \lambda)=W_{i j}\left(\operatorname{Id}, \kappa^{-1} \lambda\right)=\sum_{\ell \in \mathcal{I}} \operatorname{dim} E_{\ell} \sum_{m=1}^{\operatorname{dim} E_{\ell}} \sum_{n=1}^{\operatorname{dim} E_{\ell}}\left[\widehat{W}_{i j}^{(\ell)}\right]_{m n} U_{\ell}\left(\left(\kappa^{-1} \lambda\right)^{-1}\right)_{m n}
$$

Next, form the block matrix $\widehat{W}^{(\ell)}$ by putting $\widehat{W}_{i j}^{(\ell)}$ in the $(i, j)$-th block. This is a matrix of size $N\left(\operatorname{dim} E_{\ell}\right) \times$ $N\left(\operatorname{dim} E_{\ell}\right)$.

Lemma 3.3. The block matrix $\widehat{W}^{(\ell)}$ is Hermitian.
Proof. This follows from a direct computation, using the fact that $U_{l}(\kappa)$ is a unitary matrix.

$$
\begin{aligned}
{\left[\widehat{W}_{i j}^{(\ell)}\right]_{m n}^{*} } & =\int_{K} W_{i j}(I d, \kappa) U_{\ell}(\kappa)_{m n}^{*} d \kappa \\
& =\int_{K} W_{j i}\left(I d, \kappa^{-1}\right) U_{\ell}\left(\kappa^{-1}\right)_{n m} d \kappa \\
& =\int_{K} W_{j i}(I d, \kappa) U_{\ell}(\kappa)_{n m} d \kappa \\
& =\left[\widehat{W}_{j i}^{(\ell)}\right]_{n m}
\end{aligned}
$$

Form the matrix $S_{\ell}=D \otimes I_{\operatorname{dim} E_{\ell}}-\widehat{W}^{(\ell)}$, where $D \otimes I_{\operatorname{dim} E_{\ell}}$ denotes the Kronecker product of the matrices $D$ and $I_{\operatorname{dim} E_{\ell}}$. As the following theorem proves, we can compute the eigenvalues and eigenvectors of the graph Laplacian $L$ from those of $S_{\ell}$.

Theorem 3.4. The graph Laplacian $L$ admits a sequence of nonnegative eigenvalues $\left\{\lambda_{\ell, 1}, \ldots, \lambda_{\ell, N\left(d i m E_{\ell}\right)}\right\}_{\ell \in \mathcal{I}}$ and a sequence of corresponding eigenfunctions $\left\{\Phi_{m}^{(\ell, 1)}, \ldots, \Phi_{m}^{\left(\ell, N \operatorname{dim} E_{\ell}\right)}\right\}_{\ell \in \mathcal{I}, 1 \leq m \leq \operatorname{dim} E_{\ell}}$ which are orthogonal and complete over $\mathcal{L}^{2}(\mathcal{H})$ and are given by

$$
\Phi_{m}^{(\ell, s)}(i, \kappa)=\sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n} v_{(i-1) \operatorname{dim} E_{\ell}+n}^{(\ell, s)}
$$

where $\left(\lambda_{\ell, s}, v^{(\ell, s)}\right)$ is the $s$-th eigenvalue-eigenvector pair of the matrix $S_{\ell}=D \otimes I_{\text {dim } E_{\ell}}-\widehat{W}^{(\ell)}$, for $1 \leq s \leq$ $N \operatorname{dim} E_{\ell}$.
Proof. We begin by noting that the matrix $S_{\ell}=D \otimes I_{\mathrm{dim} E_{\ell}}-\widehat{W}^{(\ell)}$ is diagonalizable since, as proved in Lemma 3.3, $\widehat{W}^{(\ell)}$ is a Hermitian matrix. For $1 \leq s \leq N \operatorname{dim} E_{\ell}$, let $\left(\lambda_{\ell, s}, v^{(\ell, s)}\right)$ be the $s$-th eigenvalueeigenvector pair of $S_{\ell}$, chosen so that the vectors $\left\{v^{(\ell, s)}\right\}_{1 \leq s \leq N \operatorname{dim} E_{\ell}}$ are orthonormal. By Lemma 3.5 below, $\Phi_{m}^{(\ell, s)}$ is an eigenfunction of $L$ with eigenvalue $\lambda_{\ell, s}$, where $1 \leq s \leq N \operatorname{dim} E_{\ell}$ and $1 \leq m \leq \operatorname{dim} E_{\ell}$. Moreover, the eigenvalues $\lambda_{\ell, s}$ are nonnegative since $L$ is a positive semi-definite operator, as it is immediate from Claim 3.2.

Now let us prove the completeness of the eigenfunctions $\left\{\Phi_{m}^{(\ell, 1)}, \ldots, \Phi_{m}^{\left(\ell, N \operatorname{dim} E_{\ell}\right)}\right\}_{\ell, 1 \leq m \leq \operatorname{dim} E_{\ell}}$. Note that

$$
\mathcal{L}^{2}(\Gamma)=\mathcal{L}^{2}(K) \otimes \mathbb{R}^{N}=\bigoplus_{\ell \in \mathcal{I}}\left(E_{\ell}^{\oplus \operatorname{dim} E_{\ell}} \otimes \mathbb{R}^{N}\right)
$$

where the second equality comes from the Peter-Weyl Theorem. For each $\ell$, let us see that the set $\left\{\Phi_{m}^{(\ell, 1)}, \ldots, \Phi_{m}^{\left(\ell, N \operatorname{dim} E_{\ell}\right)}\right\}_{1 \leq m \leq \operatorname{dim} E_{\ell}}$ is an orthogonal basis for the subspace $E_{\ell}^{\oplus \operatorname{dim} E_{\ell}} \otimes \mathbb{R}^{N}$ of $\mathcal{L}^{2}(\Gamma)$. We have $N\left(\operatorname{dim} E_{\ell}\right)^{2}=\operatorname{dim}\left(E_{\ell}^{\oplus \operatorname{dim} E_{\ell}} \otimes \mathbb{R}^{N}\right)$ eigenfunctions, and the following computation proves they are orthogonal.

$$
\left\langle\Phi_{m}^{(\ell, s)}, \Phi_{m^{\prime}}^{\left(\ell, s^{\prime}\right)}\right\rangle=\sum_{i=1}^{N} \int_{K}\left(\Phi_{m}^{(\ell, s)}(i, \kappa)\right)^{*} \Phi_{m^{\prime}}^{\left(\ell, s^{\prime}\right)}(i, \kappa) d \kappa
$$

$$
\begin{aligned}
& =\sum_{i=1}^{N} \int_{K} \sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n}^{*}\left(v_{(i-1) \operatorname{dim} E_{\ell}+n}^{(\ell, s)}\right)^{*} \sum_{n^{\prime}=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m^{\prime} n^{\prime}} v_{(i-1) \operatorname{dim} E_{\ell}+n^{\prime}}^{\left(\ell, s^{\prime}\right)} d \kappa \\
& =\sum_{i=1}^{N} \sum_{n=1}^{\operatorname{dim} E_{\ell}} \sum_{n^{\prime}=1}^{\operatorname{dim} E_{\ell}}\left(v_{(i-1) \operatorname{dim} E_{\ell}+n}^{(\ell, s)}\right)^{*} v_{(i-1) \operatorname{dim} E_{\ell}+n^{\prime}}^{\left(\ell, s^{\prime}\right)} \int_{K} U_{\ell}\left(\kappa^{-1}\right)_{m n} U_{\ell}(\kappa)_{m^{\prime} n^{\prime}} d \kappa \\
& =\sum_{i=1}^{N} \sum_{n=1}^{\operatorname{dim} E_{\ell}} \sum_{n^{\prime}=1}^{\operatorname{dim} E_{\ell}}\left(v_{(i-1) \operatorname{dim} E_{\ell}+n}^{(\ell, s)}\right)^{*} v_{(i-1) \operatorname{dim} E_{\ell}+n^{\prime}}^{\left(\ell, s^{\prime}\right)} \frac{1}{\operatorname{dim} E_{\ell}} \delta_{m m^{\prime}} \delta_{n n^{\prime}} \\
& =\frac{1}{\operatorname{dim} E_{\ell}} \delta_{m m^{\prime}} \sum_{i=1}^{N} \sum_{n=1}^{\operatorname{dim} E_{\ell}}\left(v_{(i-1) \operatorname{dim} E_{\ell}+n}^{(\ell, s)}\right)^{*} v_{(i-1) \operatorname{dim} E_{\ell}+n^{\prime}}^{\left(\ell, s^{\prime}\right)} \\
& =\frac{1}{\operatorname{dim} E_{\ell}} \delta_{m m^{\prime}}\left\langle v^{(\ell, s)}, v^{\left(\ell, s^{\prime}\right)}\right\rangle_{\mathbb{R}^{N \operatorname{dim} E_{\ell}}} \\
& =\frac{1}{\operatorname{dim} E_{\ell}} \delta_{m m^{\prime}} \delta_{s s^{\prime}} .
\end{aligned}
$$

Lemma 3.5. If $v$ is an eigenvector of $S_{\ell}=D \otimes I_{d i m E_{\ell}}-\widehat{W}^{(\ell)}$ with eigenvalue $\lambda$, then for all $1 \leq m \leq \operatorname{dim} E_{\ell}$ the function $\Phi_{m} \in \mathcal{L}^{2}(\mathcal{H})$ given by

$$
\Phi_{m}(i, \kappa)=\sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n} v_{(i-1) \operatorname{dim} E_{\ell}+n}
$$

is an eigenfunction of $L$ with eigenvalue $\lambda$.
Proof. This follows from a direct computation.

$$
\begin{equation*}
D \Phi_{m}(i, \kappa)=D_{i i} \sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n} v_{(i-1) \operatorname{dim} E_{\ell}+n}=\sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n} D_{i i} v_{(i-1) \operatorname{dim} E_{\ell}+n} \tag{3.2}
\end{equation*}
$$

On the other hand,

$$
\begin{align*}
W \Phi_{m}(i, \kappa) & =\sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) \Phi(j, \lambda) d \lambda \\
& =\sum_{j=1}^{N} \int_{K} W_{i j}\left(I d, \kappa^{-1} \lambda\right) \sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n} v_{(j-1) \operatorname{dim} E_{\ell}+n} d \lambda \\
& =\sum_{j=1}^{N} \int_{K} \sum_{\ell \in \mathcal{I}^{\prime}} \operatorname{dim} E_{\ell} \sum_{m^{\prime}=1}^{\operatorname{dim} E_{\ell} \operatorname{dim} E_{\ell}} \sum_{n^{\prime}=1}\left[\widehat{W}_{i j}^{(\ell)}\right]_{m^{\prime} n^{\prime}} U_{\ell^{\prime}}\left(\left(\kappa^{-1} \lambda\right)^{-1}\right)_{m^{\prime} n^{\prime}} \sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\lambda)_{m n} v_{(j-1) \operatorname{dim} E_{\ell}+n} d \lambda \\
& =\sum_{j=1}^{N} \sum_{\ell \in \mathcal{I}^{\prime}} \sum_{m^{\prime}=1}^{\operatorname{dim} E_{\ell}} \sum_{n^{\prime}=1}^{\operatorname{dim} E_{\ell}} \sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell^{\prime}}(\kappa)_{m^{\prime} n^{\prime}} \int_{K} \frac{\operatorname{dim} E_{\ell}}{\operatorname{Vol}}(K)\left[\widehat{W}_{i j}^{(\ell)}\right]_{m^{\prime} n^{\prime}} U_{\ell^{\prime}}\left(\lambda^{-1}\right)_{m^{\prime} n^{\prime}} U_{\ell}(\lambda)_{m n} v v_{(j-1) \operatorname{dim} E_{\ell}+n} d \lambda \\
& =\sum_{j=1}^{N} \sum_{\ell \in \mathcal{I}^{\prime}} \sum_{m^{\prime}=1}^{\operatorname{dim} E_{\ell}} \sum_{n^{\prime}=1}^{\operatorname{dim} E_{\ell}} \sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell^{\prime}}(\kappa)_{m^{\prime} n^{\prime}}\left[\widehat{W}_{i j}^{(\ell)}\right]_{m^{\prime} n^{\prime}} v_{(j-1) \operatorname{dim} E_{\ell}+n} \delta_{\ell, \ell^{\prime}} \delta_{m, m^{\prime}} \delta_{n, n^{\prime}} \\
& =\sum_{j=1}^{N} \sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n}\left[\widehat{W}_{i j}^{(\ell)}\right]_{m n} v_{(j-1) \operatorname{dim} E_{\ell}+n} \\
& =\sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n} \sum_{j=1}^{N}\left[\widehat{W}_{i j}^{(\ell)}\right]_{m n} v_{(j-1) \operatorname{dim} E_{\ell}+n .} \tag{3.3}
\end{align*}
$$

Combining Equations (3.2) and (3.3) gives

$$
\begin{aligned}
L \Phi_{m}(i, \kappa) & =(D-W) \Phi_{m}(i, \kappa) \\
& =\sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n}\left[D_{i i} v_{(i-1) \operatorname{dim} E_{\ell}+n}-\sum_{j=1}^{N}\left[\widehat{W}_{i j}^{(\ell)}\right]_{m n} v_{(j-1) \operatorname{dim} E_{\ell}+n}\right] \\
& =\sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n} \lambda v_{(i-1) \operatorname{dim} E_{\ell}+n} \\
& =\lambda \sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n} v_{(i-1) \operatorname{dim} E_{\ell}+n} \\
& =\lambda \Phi_{m}(i, \kappa)
\end{aligned}
$$

as we wanted to see.

## 4 Convergence of the normalized $K$-invariant graph Laplacian to the Laplace-Beltrami operator

The normalized graph Laplacian $L_{N}: \mathcal{H} \rightarrow \mathcal{H}$ is defined as

$$
L_{N}=D^{-1} L
$$

The operator $L_{N}$ is generally not hermitian, but it is similar to the symmetric Laplacian $L_{\text {sym }}=D^{-1 / 2} L D^{-1 / 2}$, a hermitian matrix, and hence $L_{N}$ is diagonalizable. More precisely,

$$
L_{N}=I-D^{-1 / 2}\left(I-L_{\mathrm{sym}}\right) D^{1 / 2}
$$

It follows that $L_{N}$ can be diagonalized with real eigenvalues; however, its eigenvectors will not generally be orthogonal. This is stated precisely in the following theorem.

Theorem 4.1. The normalized graph Laplacian $L_{N}$ admits a sequence of real eigenvalues $\left\{\mu_{\ell, 1}, \ldots, \mu_{\ell, N\left(\operatorname{dim} E_{\ell}\right)}\right\}_{\ell \in \mathcal{I}}$ and a sequence of corresponding eigenfunctions $\left\{\Psi_{m}^{(\ell, 1)}, \ldots, \Psi_{m}^{\left(\ell, N \operatorname{dim} E_{\ell}\right)}\right\}_{\ell \in \mathcal{I}, 1 \leq m \leq \operatorname{dim} E_{\ell}}$ which are complete over $\mathcal{L}^{2}(\mathcal{H})$ and are given by

$$
\Psi_{m}^{(\ell, s)}(i, \kappa)=\sum_{n=1}^{\operatorname{dim} E_{\ell}} U_{\ell}(\kappa)_{m n} w_{(i-1) \operatorname{dim} E_{\ell}+n}^{(\ell, s)}
$$

where $\left(\mu_{\ell, s}, w^{(\ell, s)}\right)$ is the s-th eigenvalue-eigenvector pair of the matrix $S_{N, \ell}=I_{N} \otimes I_{d i m E_{\ell}}-\left(D^{-1} \otimes I_{d i m E_{\ell}}\right) \widehat{W}^{(\ell)}$, for $1 \leq s \leq N \operatorname{dim} E_{\ell}$.
Proof. This proof is identical to that of Theorem 3.4 except that we work with the matrix $\left(D^{-1} \otimes I_{\operatorname{dim} E_{\ell}}\right) \widehat{W}^{(\ell)}$ instead of $\widehat{W}^{(\ell)}$. Just as in the case of $L_{N}$, the matrix $\left(D^{-1} \otimes I_{\operatorname{dim} E_{\ell}}\right) \widehat{W}^{(\ell)}$ is similar to a Hermitian matrix. Thus it has a complete set of (not-necessarily orthogonal) eigenvectors $\left\{w^{(\ell, s)}\right\}_{1 \leq s \leq N \operatorname{dim} E_{\ell}}$ with corresponding real eigenvalues $\left\{\mu_{\ell, s}\right\}_{1 \leq s \leq N \operatorname{dim} E_{\ell}}$.

Next, we show how the normalized graph Laplacian $L_{N}$ approximates the Laplace-Beltrami operator $\Delta_{\mathcal{M}}$ of the manifold $\mathcal{M}$ as the number of data points $N$ goes to infinity and the parameter $\varepsilon$ (used in Equation (3.1) to define the affinity operator) goes to zero.

Theorem 4.2. Let $\left\{x_{1}, \ldots, x_{N}\right\} \subseteq \mathcal{M}$ be independent and identically distributed with uniform probability distribution $p(x)=1 / \operatorname{Vol}(\mathcal{M})$. If $f: \mathcal{M} \rightarrow \mathbb{R}$ is a smooth function, and if we define $g \in \mathcal{H}$ such that $g(i, \kappa)=f\left(\kappa \cdot x_{i}\right)$, then with high probability we have that

$$
\frac{4}{\epsilon}\left(L_{N} g\right)(i, \kappa)=\Delta_{\mathcal{M}} f\left(\kappa \cdot x_{i}\right)+O(\varepsilon)+O\left(\frac{1}{N^{1 / 2} \varepsilon^{(d-\operatorname{dim}(K)) / 4+1 / 2}}\right)
$$

Proof. We divide the proof of the theorem into two steps. The first step consists of taking the limit as $N \rightarrow \infty$, which yields the $O(\varepsilon)$ term, called the bias term. The second step is concerned with computing the remaining error term, also known as the variance term.

Step 1: We have that

$$
\begin{align*}
\frac{4}{\varepsilon}\left(L_{N} g\right)(i, \kappa) & =\frac{4}{\varepsilon}\left[g(i, \kappa)-D_{i i}^{-1} \sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) g(j, \lambda) d \lambda\right] \\
& =\frac{4}{\varepsilon}\left[f\left(\kappa \cdot x_{i}\right)-\frac{\frac{1}{N} \sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) f\left(\lambda \cdot x_{j}\right) d \lambda}{\frac{1}{N} \sum_{j=1}^{N} \int_{K} W_{i j}(\kappa, \lambda) d \lambda}\right] \\
& =\frac{4}{\varepsilon}\left[f\left(\kappa \cdot x_{i}\right)-\frac{\frac{1}{N} \sum_{j=1}^{N} F_{i, \kappa}\left(x_{j}\right)}{\frac{1}{N} \sum_{j=1}^{N} G_{i, \kappa}\left(x_{j}\right)}\right] \tag{4.1}
\end{align*}
$$

where we have defined

$$
F_{i, \kappa}(x)=\int_{K} \exp \left(-\left\|\kappa \cdot x_{i}-\lambda \cdot x\right\|^{2} / \varepsilon\right) f(\lambda \cdot x) d \lambda
$$

and similarly

$$
G_{i, \kappa}(x)=\int_{K} \exp \left(-\left\|\kappa \cdot x_{i}-\lambda \cdot x\right\|^{2} / \varepsilon\right) d \lambda
$$

Now let us take the limit as $N \rightarrow \infty$ of the numerator of the second term in Equation (4.1). By the law of large numbers, we get

$$
\begin{align*}
\lim _{N \rightarrow \infty} \frac{1}{N} \sum_{j=1}^{N} F_{i, \kappa}\left(x_{j}\right) & =\mathbb{E}\left[F_{i, \kappa}\right] \\
& =\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}} F_{i, \kappa}(x) d x \\
& =\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}} \int_{K} \exp \left(-\left\|\kappa \cdot x_{i}-\lambda \cdot x\right\|^{2} / \varepsilon\right) f(\lambda \cdot x) d \lambda d x \\
& =\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}} \int_{K} \exp \left(-\left\|\kappa \cdot x_{i}-x^{\prime}\right\|^{2} / \varepsilon\right) f\left(x^{\prime}\right) d \lambda d x^{\prime} \\
& =\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}} \exp \left(-\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) f(x) d x . \tag{4.2}
\end{align*}
$$

Here we made the change of variables $x^{\prime}=\lambda \cdot x$. Note that $d x^{\prime}=d x$ since the Jacobian determinant of the change of coordinates induced by the map $\varphi_{\lambda}: \mathcal{M} \rightarrow \mathcal{M}$ with $\varphi_{\lambda}(x)=\lambda \cdot x$ is equal to 1 , as $K$ acts by isometries on $\mathbb{R}^{\mathcal{D}}$, and thus on $\mathcal{M}$.

The calculation for $G_{i, \kappa}$ is the same as above, taking $f=1$. Hence, we have

$$
\begin{equation*}
\lim _{N \rightarrow \infty} \frac{1}{N} \sum_{j=1}^{N} G_{i, \kappa}\left(x_{j}\right)=\mathbb{E}\left[G_{i, \kappa}\right]=\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}} \exp \left(-\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) d x \tag{4.3}
\end{equation*}
$$

Putting Equations (4.2) and (4.3) together gives

$$
\begin{aligned}
\lim _{N \rightarrow \infty} \frac{4}{\varepsilon}\left(L_{N} g\right)(i, \kappa) & =\frac{4}{\varepsilon}\left[f\left(\kappa \cdot x_{i}\right)-\frac{\lim _{N \rightarrow \infty} \frac{1}{N} \sum_{j=1}^{N} F_{i, \kappa}\left(x_{j}\right)}{\lim _{N \rightarrow \infty} \frac{1}{N} \sum_{j=1}^{N} G_{i, \kappa}\left(x_{j}\right)}\right] \\
& =\frac{4}{\varepsilon}\left[f\left(\kappa \cdot x_{i}\right)-\frac{\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}} \exp \left(-\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) f(x) d x}{\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}} \exp \left(-\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) d x}\right] \\
& =\Delta_{\mathcal{M}} f\left(\kappa \cdot x_{i}\right)+O(\varepsilon),
\end{aligned}
$$

where the last simplification is justified in [15]. This concludes the proof of the first step.
Step 2: Now we evaluate the variance term. To this end, we use Chernoff's inequality to estimate the probabilities

p_{+}(N, \alpha)=\mathbb{P}\left[\frac{\frac{1}{N} \sum_{\substack{j=1 \\ j \neq i}}^{N} F_{i, \kappa}\left(x_{j}\right)}{\frac{1}{N} \sum_{\substack{j=1 \\ j \neq i}}^{N} G_{i, \kappa}\left(x_{j}\right)}-\frac{\mathbb{E}\left[F_{i, \kappa}\right]}{\mathbb{E}\left[G_{i, \kappa}\right]}>\alpha\right], \tag{4.4}
\end{equation*}
$$

and

$$
\begin{equation*}
p_{-}(N, \alpha)=\mathbb{P}\left[\frac{\frac{1}{N} \sum_{\substack{j=1 \\ j \neq i}}^{N} F_{i, \kappa}\left(x_{j}\right)}{\frac{1}{N} \sum_{\substack{j=1 \\ j \neq i}}^{N} G_{i, \kappa}\left(x_{j}\right)}-\frac{\mathbb{E}\left[F_{i, \kappa}\right]}{\mathbb{E}\left[G_{i, \kappa}\right]}<-\alpha\right] . \tag{4.5}
\end{equation*}
$$

Let us start with $p_{+}(N, \alpha)$. We can rewrite Equation (4.4) as

$$
\begin{equation*}
p_{+}(N, \alpha)=\mathbb{P}\left[\sum_{j \neq i}^{N} Y_{j}>(N-1) \alpha\left(\mathbb{E}\left[G_{i, \kappa}\right]\right)^{2}\right] \tag{4.6}
\end{equation*}
$$

where we have defined

$$
\begin{equation*}
Y_{j}=\mathbb{E}\left[G_{i, \kappa}\right] F_{i, \kappa}\left(x_{j}\right)-\mathbb{E}\left[F_{i, \kappa}\right] G_{i, \kappa}\left(x_{j}\right)+\alpha \mathbb{E}\left[G_{i, \kappa}\right]\left(\mathbb{E}\left[G_{i, \kappa}\right]-G_{i, \kappa}\left(x_{j}\right)\right) \tag{4.7}
\end{equation*}
$$

The first and second moments of $Y_{j}$ are $\mathbb{E}\left[Y_{j}\right]=0$ and

$$
\begin{equation*}
\mathbb{E}\left[Y_{j}^{2}\right]=\left(\mathbb{E}\left[G_{i, \kappa}\right]\right)^{2} \mathbb{E}\left[F_{i, \kappa}^{2}\left(x_{j}\right)\right]-2 \mathbb{E}\left[F_{i, \kappa}\left(x_{j}\right)\right] \mathbb{E}\left[G_{i, \kappa}\left(x_{j}\right)\right] \mathbb{E}\left[F_{i, \kappa}\left(x_{j}\right) G_{i, \kappa}\left(x_{j}\right)\right]+\left(\mathbb{E}\left[F_{i, \kappa}\left(x_{j}\right)\right]\right)^{2} \mathbb{E}\left[G_{i, \kappa}^{2}\left(x_{j}\right)\right]+O(\alpha) \tag{4.8}
\end{equation*}
$$

We are interested in finding an approximation to $\mathbb{E}\left[Y_{j}^{2}\right]$ in terms of $\varepsilon$ besides the current $O(\alpha)$ term. To do this, we need to approximate the different first and second moments involving $F_{i, \kappa}$ and $G_{i, \kappa}$. From [15], the first moments are given by

& \mathbb{E}\left[F_{i, \kappa}\right]=\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}} \exp \left(-\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) f(x) d x=\frac{1}{\operatorname{Vol}(\mathcal{M})}(\pi \varepsilon)^{d / 2}\left[f\left(\kappa \cdot x_{i}\right)+O(\varepsilon)\right]  \tag{4.9}\\
& \mathbb{E}\left[G_{i, \kappa}\right]=\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}} \exp \left(-\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) d x=\frac{1}{\operatorname{Vol}(\mathcal{M})}(\pi \varepsilon)^{d / 2}[1+O(\varepsilon)] \tag{4.10}
\end{align*}
$$

And from Lemma 4.3 below, the second moments are

$$
\begin{align*}
\mathbb{E}\left[F_{i, \kappa}^{2}\right] & =\frac{1}{\operatorname{Vol}(\mathcal{M})} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f^{2}\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right],  \tag{4.11}\\
\mathbb{E}\left[G_{i, \kappa}^{2}\right] & =\frac{1}{\operatorname{Vol}(\mathcal{M})} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right],  \tag{4.12}\\
\mathbb{E}\left[F_{i, \kappa} G_{i, \kappa}\right] & =\frac{1}{\operatorname{Vol}(\mathcal{M})} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right] . \tag{4.13}
\end{align*}
$$

Substituting Equations (4.9) through (4.13) into Equation (4.8) gives

\mathbb{E}\left[Y_{j}^{2}\right]= & \frac{1}{\operatorname{Vol}(\mathcal{M})^{3}}(\pi \varepsilon)^{d} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right] \\
& -2 \frac{1}{\operatorname{Vol}(\mathcal{M})^{3}}(\pi \varepsilon)^{d} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right] \\
& +\frac{1}{\operatorname{Vol}(\mathcal{M})^{3}}(\pi \varepsilon)^{d} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right]+O(\alpha)
\end{aligned}
$$

$$
\begin{align*}
& =\frac{1}{\operatorname{Vol}(\mathcal{M})^{3}}(\pi \varepsilon)^{d} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}} O(\varepsilon)+O(\alpha) \\
& =O\left(\varepsilon^{(3 d+\operatorname{dim}(K)+2) / 2}\right)+O(\alpha) \tag{4.14}
\end{align*}
$$

Next, we apply Chernoff's inequality to obtain an exponential bound on $p_{+}(N, \alpha)$ involving $\mathbb{E}\left[G_{i, \kappa}\right]$ and $\mathbb{E}\left[Y_{j}^{2}\right]$. This together with Equations (4.10) and (4.14) gives

p_{+}(N, \alpha) & \leq \exp \left(-\frac{\alpha^{2}(N-1)^{2}\left(\mathbb{E}\left[G_{i, \kappa}\right]\right)^{4}}{2(N-1) \mathbb{E}\left[Y_{j}^{2}\right]+O(\alpha)}\right) \\
& \leq \exp \left(-\frac{\alpha^{2} O\left(\varepsilon^{2 d}\right)}{O\left(\varepsilon^{(3 d+\operatorname{dim}(K)+2) / 2} / N\right)+O(\alpha)}\right) \\
& \leq \exp \left(-\frac{\alpha^{2}}{O\left(\varepsilon^{(-d+\operatorname{dim}(K)+2) / 2} / N\right)+O(\alpha)}\right) . \tag{4.15}
\end{align*}
$$

To obtain a bound for $p_{-}(N, \alpha)$ we apply the same analysis, changing $\alpha$ by $-\alpha$ in the definition of $Y_{j}$ when we rewrite Equation (4.5) as we did for $p_{+}(N, \alpha)$. This and Chernoff's inequality for lower tails gives

p_{-}(N, \alpha)=\mathbb{P}\left[\sum_{j \neq i}^{N} Y_{j}<-(N-1) \alpha\left(\mathbb{E}\left[G_{i, \kappa}\right]\right)^{2}\right] \leq \exp \left(-\frac{\alpha^{2}}{O\left(\varepsilon^{(-d+\operatorname{dim}(K)+2) / 2} / N\right)+O(\alpha)}\right) \tag{4.16}
\end{equation*}
$$

Inequalities (4.15) and (4.16) imply that by taking $\alpha=O\left(\varepsilon^{(-d+\operatorname{dim}(K)+2) / 4} / \sqrt{N}\right)$ we can make both $p_{+}(N, \alpha)$ and $p_{-}(N, \alpha)$ arbitrarily small with exponential decay. It follows that

\left|\frac{\frac{1}{N} \sum_{\substack{j=1 \\ j \neq i}}^{N} F_{i, \kappa}\left(x_{j}\right)}{\frac{1}{N} \sum_{\substack{j=1 \\ j \neq i}}^{N} G_{i, \kappa}\left(x_{j}\right)}-\frac{\mathbb{E}\left[F_{i, \kappa}\right]}{\mathbb{E}\left[G_{i, \kappa}\right]}\right|=|\alpha|=O\left(\frac{1}{N^{1 / 2} \varepsilon^{(d-\operatorname{dim}(K)) / 4-1 / 2}}\right)
$$

To obtain the variance term we multiply the error above by $4 / \varepsilon$. More precisely, we have

$$
\begin{aligned}
\left\lvert\, \frac{4}{\varepsilon}\left[f\left(\kappa \cdot x_{i}\right)-\frac{\frac{1}{N} \sum_{\substack{j=1 \\
j \neq i}}^{N} F_{i, \kappa}\left(x_{j}\right)}{\frac{1}{N} \sum_{\substack{j=1 \\
j \neq i}}^{N} G_{i, \kappa}\left(x_{j}\right)}\right]\right. & -\left[\Delta_{\mathcal{M}} f\left(\kappa \cdot x_{i}\right)+O(\varepsilon)\right] \mid \\
& =\left|\frac{4}{\varepsilon}\left[f\left(\kappa \cdot x_{i}\right)-\frac{\frac{1}{N} \sum_{\substack{j=1 \\
j \neq i}}^{N} F_{i, \kappa}\left(x_{j}\right)}{\frac{1}{N} \sum_{\substack{j=1 \\
j \neq i}}^{N} G_{i, \kappa}\left(x_{j}\right)}\right]-\frac{4}{\varepsilon}\left[f\left(\kappa \cdot x_{i}\right)-\frac{\mathbb{E}\left[F_{i, \kappa}\right]}{\mathbb{E}\left[G_{i, \kappa}\right]}\right]\right| \\
& =\frac{4}{\varepsilon}\left|\frac{\frac{1}{N} \sum_{\substack{j=1 \\
j \neq i}}^{N} F_{i, \kappa}\left(x_{j}\right)}{\frac{1}{N} \sum_{\substack{j=1 \\
j \neq i}}^{N} G_{i, \kappa}\left(x_{j}\right)}-\frac{\mathbb{E}\left[F_{i, \kappa}\right]}{\mathbb{E}\left[G_{i, \kappa}\right]}\right| \\
& =O\left(\frac{1}{N^{1 / 2} \varepsilon^{(d-\operatorname{dim}(K)) / 4+1 / 2}}\right) .
\end{aligned}
$$

Finally, we prove that removing the diagonal terms (the case $j=i$ ) in the sums does not affect the convergence rate. Note that

$$
\begin{aligned}
\frac{\sum_{j=1}^{N} F_{i, \kappa}\left(x_{j}\right)}{\sum_{j=1}^{N} G_{i, \kappa}\left(x_{j}\right)}-\frac{\sum_{\substack{j=1 \\
j \neq i}}^{N} F_{i, \kappa}\left(x_{j}\right)}{\sum_{\substack{j=1 \\
j \neq i}}^{N} G_{i, \kappa}\left(x_{j}\right)} & =\frac{F_{i, \kappa}\left(x_{i}\right)}{\sum_{j=1}^{N} G_{i, \kappa}\left(x_{j}\right)}-\frac{G_{i, \kappa}\left(x_{i}\right)}{\sum_{j=1}^{N} G_{i, \kappa}\left(x_{j}\right)} \frac{\sum_{\substack{j=1 \\
j \neq i}}^{N} F_{i, \kappa}\left(x_{j}\right)}{\sum_{\substack{j=1 \\
j \neq i}}^{N} G_{i, \kappa}\left(x_{j}\right)} \\
& =O\left(\frac{\frac{1}{N} G_{i, \kappa}\left(x_{i}\right)}{\frac{1}{N} \sum_{j=1}^{N} G_{i, \kappa}\left(x_{j}\right)}\right)
\end{aligned}
$$

$$
\begin{aligned}
& =O\left(\frac{\varepsilon^{(\operatorname{dim}(K) / 2)} / N}{\varepsilon^{d / 2}}\right) \\
& =O\left(\frac{1}{N \varepsilon^{(d-\operatorname{dim}(K)) / 2}}\right)
\end{aligned}
$$

where we used the fact that $f$ is a smooth function on $\mathcal{M}$ and thus uniformly bounded: $|f(x)| \leq c$ for some constant $c$, implying that $\left|F_{i, \kappa}\left(x_{i}\right)\right| \leq c\left|G_{i, \kappa}\left(x_{i}\right)\right|$. The error term we get is negligible compared to the variance term, so we ignore it. Therefore, we obtain

$$
\frac{4}{\varepsilon}\left(L_{N} g\right)(i, \kappa)=\frac{4}{\varepsilon}\left[f\left(\kappa \cdot x_{i}\right)-\frac{\frac{1}{N} \sum_{\substack{j=1 \\ j \neq i}}^{N} F_{i, \kappa}\left(x_{j}\right)}{\frac{1}{N} \sum_{\substack{j=1 \\ j \neq i}}^{N} G_{i, \kappa}\left(x_{j}\right)}\right]=\Delta_{\mathcal{M}} f\left(\kappa \cdot x_{i}\right)+O(\varepsilon)+O\left(\frac{1}{N^{1 / 2} \varepsilon^{(d-\operatorname{dim}(K)) / 4+1 / 2}}\right),
$$

as we wanted to see.
We conclude this section by proving Lemma 4.3
Lemma 4.3. There exist smooth function $\mu$ and $\nu$ on $\mathcal{M}$ such that

$$
\begin{aligned}
\mathbb{E}\left[F_{i, \kappa}^{2}\right] & =\frac{1}{\operatorname{Vol}(\mathcal{M})} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f^{2}\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right], \\
\mathbb{E}\left[G_{i, \kappa}^{2}\right] & =\frac{1}{\operatorname{Vol}(\mathcal{M})} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right], \\
\mathbb{E}\left[F_{i, \kappa} G_{i, \kappa}\right] & =\frac{1}{\operatorname{Vol}(\mathcal{M})} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right] .
\end{aligned}
$$

Proof. We will prove the lemma for $\mathbb{E}\left[F_{i, \kappa}^{2}\right]$. The same proof holds for $\mathbb{E}\left[G_{i, \kappa}^{2}\right]$ and $\mathbb{E}\left[F_{i, \kappa} G_{i, \kappa}\right]$ by replacing $f$ by 1 where necessary. We start by deriving an asymptotic expansion for

$$
\begin{equation*}
F_{i, \kappa}(x)=\int_{K} \exp \left(-\left\|\kappa \cdot x_{i}-\lambda \cdot x\right\|^{2} / \varepsilon\right) f(\lambda \cdot x) d \lambda \tag{4.17}
\end{equation*}
$$

To this end, we write

$$
\begin{align*}
\left\|\kappa \cdot x_{i}-\lambda \cdot x\right\|^{2} & =\left\|\left(\kappa \cdot x_{i}-x\right)+(x-\lambda \cdot x)\right\|^{2} \\
& =\left\|\kappa \cdot x_{i}-z\right\|^{2}+2 \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-\lambda \cdot x\right\rangle+\|x-\lambda \cdot x\|^{2} \tag{4.18}
\end{align*}
$$

and apply the Taylor expansion

$$
\begin{equation*}
\exp \left(2 \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-\lambda \cdot x\right\rangle / \varepsilon\right)=1-O\left(\frac{2 \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-\lambda \cdot x\right\rangle}{\varepsilon}\right) \tag{4.19}
\end{equation*}
$$

Plugging Equations (4.18) and (4.19) into (4.17) gives

$$
\begin{align*}
F_{i, \kappa}(x)=\exp \left(-\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) & {\left[\int_{K} \exp \left(-\|x-\lambda \cdot x\|^{2} / \varepsilon\right) f(\lambda \cdot x) d \lambda\right.} \\
& \left.-O\left(\frac{1}{\varepsilon} \int_{K} 2 \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-\lambda \cdot x\right\rangle \exp \left(-\|x-\lambda \cdot x\|^{2} / \varepsilon\right) f(\lambda \cdot x) d \lambda\right)\right] \tag{4.20}
\end{align*}
$$

Hence, we need to find asymptotic expansions for each of the two terms in Equation (4.20). Let us denote by $\mathcal{O}(x)=\{\lambda \cdot x \mid \lambda \in K\}$ the orbit of $x \in \mathcal{M}^{\prime}$ under the action of $K$, which is a smooth manifold of dimension equal to $\operatorname{dim}(K)$. Using this, we can rewrite the integrals over $K$ in Equation (4.20) as integrals over $\mathcal{O}(x)$. For the first integral, we obtain

$$
\begin{equation*}
\int_{K} \exp \left(-\|x-\lambda \cdot x\|^{2} / \varepsilon\right) f(\lambda \cdot x) d \lambda=\frac{1}{\mu(x)} \int_{\mathcal{O}(x)} \exp \left(-\|x-y\|^{2} / \varepsilon\right) f(y) d y \tag{4.21}
\end{equation*}
$$

where $\mu(x)=\left|D \varphi_{x}\right|$ is the Jacobian determinant of the map $\varphi_{x}: K \rightarrow \mathcal{O}(x)$ defined by $\varphi_{x}(\lambda)=\lambda \cdot x$, which is a diffeomorphism [11, Proposition 21.7]. Next, applying Proposition 9 in [10] allows us to approximate the left-hand-side integral in Equation (4.21) as

$$
\begin{equation*}
\int_{K} \exp \left(-\|x-\lambda \cdot x\|^{2} / \varepsilon\right) f(\lambda \cdot x) d \lambda=\frac{(\pi \varepsilon)^{\operatorname{dim}(K) / 2}}{\mu(x)}[f(x)+O(\varepsilon)] \tag{4.22}
\end{equation*}
$$

We do the same for the second integral in (4.20), which gives

$$
\begin{align*}
O & \left(\frac{1}{\varepsilon} \int_{K} 2 \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-\lambda \cdot x\right\rangle \exp \left(-\|x-\lambda \cdot x\|^{2} / \varepsilon\right) f(\lambda \cdot x) d \lambda\right) \\
& =O\left(\frac{1}{\varepsilon \mu(x)} \int_{\mathcal{O}(x)} 2 \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-y\right\rangle \exp \left(-\|x-y\|^{2} / \varepsilon\right) f(y) d y\right)  \tag{4.23}\\
& =O\left(\frac{(\pi \varepsilon)^{\operatorname{dim}(K) / 2}}{\mu(x)}\left[\left.\frac{1}{2} \Delta_{\mathcal{O}(x)}\left(\operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-y\right\rangle f(y)\right)\right|_{y=x}+\varepsilon\right]\right)
\end{align*}
$$

Note that

$$
\begin{align*}
\left.\Delta_{\mathcal{O}(x)}\left(\operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-y\right\rangle f(y)\right)\right|_{y=x}= & \left.\Delta_{\mathcal{O}(x)} f(y)\right|_{y=x} \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-x\right\rangle \\
& -2\left\langle\left.\nabla_{\mathcal{O}(x)} \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-y\right\rangle\right|_{y=x}, \nabla_{\mathcal{O}(x)} f(z)\right\rangle \\
& +\left.f(x) \Delta_{\mathcal{O}(x)} \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-y\right\rangle\right|_{y=x}  \tag{4.24}\\
= & 2\left\langle\operatorname{Re}\left\langle\kappa \cdot x_{i}-x,\left.\nabla_{\mathcal{O}(x)} y\right|_{y=x}\right\rangle, \nabla_{\mathcal{O}(x)} f(z)\right\rangle \\
& -f(x) \operatorname{Re}\left\langle\kappa \cdot x_{i}-x,\left.\Delta_{\mathcal{O}(x)} y\right|_{y=x}\right\rangle .
\end{align*}
$$

To simplify the notation, let us define

$$
q(x)=\left\langle\operatorname{Re}\left\langle\kappa \cdot x_{i}-x,\left.\nabla_{\mathcal{O}(x)} y\right|_{y=x}\right\rangle, \nabla_{\mathcal{O}(x)} f(z)\right\rangle-\frac{f(x)}{2} \operatorname{Re}\left\langle\kappa \cdot x_{i}-x,\left.\Delta_{\mathcal{O}(x)} y\right|_{y=x}\right\rangle
$$

This function satisfies $q\left(\kappa \cdot x_{i}\right)=0$. Therefore, Equation (4.23) can be written as

$$
\begin{equation*}
O\left(\frac{1}{\varepsilon} \int_{K} 2 \operatorname{Re}\left\langle\kappa \cdot x_{i}-x, x-\lambda \cdot x\right\rangle \exp \left(-\|x-\lambda \cdot x\|^{2} / \varepsilon\right) f(\lambda \cdot x) d \lambda\right)=O\left(\frac{(\pi \varepsilon)^{\operatorname{dim}(K) / 2}}{\mu(x)}[q(x)+\varepsilon]\right) \tag{4.25}
\end{equation*}
$$

Plugging in Equations (4.25) and (4.22) into (4.20) yields the asymptotic expansion

$$
F_{i, \kappa}(x)=\exp \left(-\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) \frac{(\pi \varepsilon)^{\operatorname{dim}(K) / 2}}{\mu(x)}[f(x)+O(q(x))+O(\varepsilon)]
$$

From here we directly obtain an approximation for $\left(F_{i, \kappa}(x)\right)^{2}$, namely

$$
\begin{equation*}
\left(F_{i, \kappa}(x)\right)^{2}=\exp \left(-2\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) \frac{(\pi \varepsilon)^{\operatorname{dim}(K)}}{\mu^{2}(x)}\left[f^{2}(x)+O(q(x))+O(\varepsilon)\right] \tag{4.26}
\end{equation*}
$$

The final step is to use Formula (4.26) to estimate the expected value of $F_{i, \kappa}^{2}$. To integrate this function over $\mathcal{M}$, consider the quotient map $\pi: \mathcal{M}^{\prime} \rightarrow \mathcal{M}^{\prime} / K$, which is a smooth submersion by the quotient manifold theorem [11; moreover, $\mathcal{M}^{\prime} / K$ is a smooth manifold of dimension equal to $d-\operatorname{dim}(K)$. It inherits a natural Riemannian metric such that if $g$ is an integrable function on $\mathcal{M}^{\prime} / K$, then it holds that

$$
\int_{\mathcal{M}^{\prime}} \pi^{*} g \mu_{\mathcal{M}^{\prime}}=\int_{\mathcal{M}^{\prime} / K} g \pi_{*} \mu_{\mathcal{M}^{\prime}}
$$

where $\mu_{\mathcal{M}^{\prime}}$ is the induced measure on $\mathcal{M}^{\prime}$ and $\pi^{*}, \pi_{*}$ denote pullback and pushforward respectively. To apply this identity, note that the function $F_{i, \kappa}$ is invariant under the action of $K$. Indeed, for any $x \in \mathcal{M}$ and $\eta \in K$ we have that

$$
F_{i, \kappa}(\eta \cdot x)=\int_{K} \exp \left(-\left\|\kappa \cdot x_{i}-\lambda \cdot \eta \cdot x\right\|^{2} / \varepsilon\right) f(\lambda \cdot \eta \cdot x) d \lambda
$$

$$
\begin{aligned}
& =\int_{K} \exp \left(-\left\|\kappa \cdot x_{i}-\lambda^{\prime} \cdot x\right\|^{2} / \varepsilon\right) f\left(\lambda^{\prime} \cdot x\right) d\left(\eta^{-1} \lambda^{\prime}\right) \\
& =\int_{K} \exp \left(-\left\|\kappa \cdot x_{i}-\lambda^{\prime} \cdot x\right\|^{2} / \varepsilon\right) f\left(\lambda^{\prime} \cdot x\right) d\left(\lambda^{\prime}\right) \\
& =F_{i, k}(x) .
\end{aligned}
$$

It follows that $F_{i, \kappa}=\pi^{*} g$ for some function $g$ on $\mathcal{M}^{\prime} / K$. Let $\nu$ be the function on $\mathcal{M}^{\prime}$ given by $\nu(x):=$ $\sqrt{\left|\operatorname{det}\left(g_{\mathcal{M}}^{\prime}\right)(x)\right|}$, where $g_{\mathcal{M}}^{\prime}$ is the metric on $\mathcal{M}^{\prime}$, comes from the volume form of the manifold $\mathcal{M}^{\prime}$. This and Formula (4.26) yield

$$
\begin{align*}
\mathbb{E}\left[\left(F_{i, \kappa}(x)\right)^{2}\right] & =\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}}\left(F_{i, \kappa}(x)\right)^{2} d x \\
& =\frac{1}{\operatorname{Vol}(\mathcal{M})} \int_{\mathcal{M}^{\prime} / K}\left(F_{i, \kappa}(x)\right)^{2} \nu(x) d x \\
& =\frac{1}{\operatorname{Vol}(\mathcal{M})}(\pi \varepsilon)^{\operatorname{dim}(K)} \int_{\mathcal{M}^{\prime} / K} \exp \left(-2\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) \frac{\nu(x)}{\mu^{2}(x)}\left[f^{2}(x)+O(q(x)+\varepsilon)\right] d x . \tag{4.27}
\end{align*}
$$

Again, we evaluate all terms in the integral (4.27) using Proposition 9 in 10. We obtain

$$
\begin{equation*}
\int_{\mathcal{M} / K} \exp \left(-2\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) \frac{\nu(x) f^{2}(x)}{\mu^{2}(x)} d x=(\pi \varepsilon / 2)^{(d-\operatorname{dim}(K)) / 2}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f^{2}\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right], \tag{4.28}
\end{equation*}
$$

and

$$
\begin{align*}
O\left(\int_{\mathcal{M} / K} \exp \left(-2\left\|\kappa \cdot x_{i}-x\right\|^{2} / \varepsilon\right) \frac{\nu(x) q(x)}{\mu^{2}(x)} d x\right) & =O\left((\pi \varepsilon)^{(d-\operatorname{dim}(K)) / 2}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) q\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+\varepsilon\right]\right)  \tag{4.29}\\
& =(\pi \varepsilon / 2)^{(d-\operatorname{dim}(K)) / 2} O(\varepsilon) \tag{4.30}
\end{align*}
$$

since $q\left(\kappa \cdot x_{i}\right)=0$. By plugging Equations (4.28) and (4.29) into (4.27), it follows that

$$
\begin{align*}
\mathbb{E}\left[\left(F_{i, \kappa}(x)\right)^{2}\right] & =\frac{1}{\operatorname{Vol}(\mathcal{M})}(\pi \varepsilon)^{\operatorname{dim}(K)}(\pi \varepsilon / 2)^{(d-\operatorname{dim}(K)) / 2}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f^{2}\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right] \\
& =\frac{1}{\operatorname{Vol}(\mathcal{M})} \frac{(\pi \varepsilon)^{(d+\operatorname{dim}(K)) / 2}}{2^{(d-\operatorname{dim}(K)) / 2}}\left[\frac{\nu\left(\kappa \cdot x_{i}\right) f^{2}\left(\kappa \cdot x_{i}\right)}{\mu^{2}\left(\kappa \cdot x_{i}\right)}+O(\varepsilon)\right], \tag{4.31}
\end{align*}
$$

concluding the proof.

## 5 Concluding remarks

In this paper, we developed the framework of $K$-invariant graph Laplacian operators $L$ for manifold learning under group actions. Our work extends a method of Landa and Shkolnisky from the 2D rotation group to the case of an arbitrary compact Lie group $K$. The $K$-invariant graph Laplacian provides a principled approach to manifold learning when the data manifold is invariant under the action of the group $K$. The method achieves this by carrying out infinite data augmentation, through analytic integration over the orbits of the data points. In Theorem4.1 we provided an explicit formula for computing the eigenvalues and eigenfunctions of $L$ using the representation theory of $K$. Moreover, in Theorem 4.2 we proved that the normalized $K$-invariant graph Laplacian operator $L_{N}$ converges to the Laplace-Beltrami operator $\Delta_{\mathcal{M}}$ of the data manifold $\mathcal{M}$, at a faster rate than the symmetry-unaware graph Laplacian. In particular, the variance term involves the dimension of $K$. In practice, this result will yield an improvement in sample complexity.

There are several directions worthy of future work. First and foremost, we wish to use the theoretical apparatus of this paper in a real-life application. To this end, mapping out low-dimensional models for molecular conformation spaces in cryo-electron tomography [20 is a target application. In this case, data points are naturally subject to an $\mathrm{SO}(3)$-action. Secondly, a computational challenge in implementing the
approach will come from implementing the Fourier transform of each $W_{i j}(\kappa, \lambda)$ from the block matrices $\widehat{W}^{\ell}$ since, depending on the group, the $\operatorname{dim} E_{\ell}$ could grow faster than desired 6. Thirdly, it is natural to ask about spectral convergence [3] rather than the pointwise convergence established here. That is, we would like to show the convergence of the eigenfunctions of the $K$-invariant graph Laplacian operator to the eigenfunctions of the Laplace-Beltrami operator on $\mathcal{M}$.
