The Pseudoinverse of A = CR is $A^+ = R^+C^+$ (?)

Abstract

This paper gives three formulas for the pseudoinverse of a matrix product A = CR. The first is sometimes correct, the second is always correct, and the third is almost never correct. But that third randomized pseudoinverse A_r^+ may be very useful when A is a very large matrix.

- 1. $A^+ = R^+C^+$ when A = CR and C has independent columns and R has independent rows.
- 2. $A^+ = (C^+CR)^+(CRR^+)^+$ is always correct.
- 3. $A_r^+ = (P^T C R)^+ P^T C R Q (C R Q)^+ = A^+$ only when rank $(P^T A) =$ rank(AQ) =rank(A) with A = C R.

The statement in the title is not generally true, as the following example shows:

$$C = \begin{bmatrix} 1 & 0 \end{bmatrix} R = \begin{bmatrix} 1 \\ 1 \end{bmatrix} (CR)^{+} = \begin{bmatrix} 1 \end{bmatrix} R^{+}C^{+} = \begin{bmatrix} \frac{1}{2} & \frac{1}{2} \end{bmatrix} \begin{bmatrix} 1 \\ 0 \end{bmatrix} = \begin{bmatrix} \frac{1}{2} \end{bmatrix}.$$

Here, C has a full row rank and R has a full column rank. We need to have it the other way around in Theorem 1. Then Theorem 2 will give a formula for the pseudoinverse of A = CR that applies in every case.

When the *m* by *r* matrix *C* has *r* independent columns (full column rank *r*), and the *r* by *n* matrix *R* has *r* independent rows (full row rank *r*), the pseudoinverse C^+ is the left inverse of *C*, and the pseudoinverse R^+ is the right inverse of *R*:

$$C^+ = (C^{\mathrm{T}}C)^{-1}C^{\mathrm{T}}$$
 has $C^+C = I_r$ and $R^+ = R^{\mathrm{T}}(RR^{\mathrm{T}})^{-1}$ has $RR^+ = I_r$.

In this case, the *m* by *n* matrix A = CR will also have rank *r* and the statement correctly claims that its *n* by *m* pseudoinverse is $A^+ = R^+C^+$.

Theorem 1. The pseudoinverse A^+ of a product A = CR is the product of the pseudoinverses R^+C^+ (as for inverses) when C has full column rank and R has full row rank r.

The simplest proof verifies the four Penrose identities [4] that determine the pseudoinverse A^+ of any matrix A:

$$AA^{+}A = A$$
 $A^{+}AA^{+} = A^{+}$ $(A^{+}A)^{\mathrm{T}} = A^{+}A$ $(AA^{+})^{\mathrm{T}} = AA^{+}$ (1)

Our goal is a different proof of $A^+ = R^+C^+$, starting from first principles. We begin with the "four fundamental subspaces" associated with any m by n matrix A of rank r. Those are the column space \mathbf{C} and nullspace \mathbf{N} of A and A^{T} .




Figure 1: $Ax_r = b$ is in the column space of A and $Ax_n = 0$. The complete solution to Ax = b is x = one $x_r +$ any x_n .

Note that every matrix A gives an invertible map (Figure 1) from its row space $\mathbf{C}(A^{\mathrm{T}})$ to its column space $\mathbf{C}(A)$. If \boldsymbol{x} and \boldsymbol{y} are in the row space and $A\boldsymbol{x} = A\boldsymbol{y}$, then $A(\boldsymbol{x} - \boldsymbol{y}) = \boldsymbol{0}$. Therefore $\boldsymbol{x} - \boldsymbol{y}$ is in the nullspace $\mathbf{N}(A)$ as well as the row space. So $\boldsymbol{x} - \boldsymbol{y}$ is orthogonal to itself and $\boldsymbol{x} = \boldsymbol{y}$.




Figure 2: The four subspaces for A^+ are the four subspaces for A^{T} .

The pseudoinverse A^+ in Figure 2 inverts the row space to column space map in Figure 1 when $\mathbf{N}(A^T) = \mathbf{N}(A^+)$. If \mathbf{b}_c and \mathbf{d}_c are in the column space $\mathbf{C}(A)$ and $\mathbf{x} = A^+\mathbf{b}_c = A^+\mathbf{d}_c$, then $A^+(\mathbf{b}_c - \mathbf{d}_c) = \mathbf{0}$ and $\mathbf{b}_c - \mathbf{d}_c$ is in the nullspace $\mathbf{N}(A^+)$. Therefore, if $\mathbf{N}(A^+) = \mathbf{N}(A^T)$, then $\mathbf{b}_c - \mathbf{d}_c$ is in the nullspace of A^T and the column space of A, it is orthogonal to itself and $(\mathbf{b}_c - \mathbf{d}_c)^T(\mathbf{b}_c - \mathbf{d}_c) = 0$ with $\mathbf{b}_c = \mathbf{d}_c$. For all vectors \mathbf{b}_n in the orthogonal complement of $\mathbf{C}(A)$, we have $A^T\mathbf{b}_n = \mathbf{0}$ and $A^+\mathbf{b}_n = \mathbf{0}$. Theorem 1 shows why $\mathbf{N}(A^T) = \mathbf{N}(A^+)$ and A^+ is the inverse map.

That upper map from the row space $\mathbf{C}(A^{\mathrm{T}})$ to the column space $\mathbf{C}(A)$ is inverted by the pseudoinverse A^+ in Figure 2. And the nullspace of A^+ is the same as the nullspace of A^{T} —the orthogonal complement of $\mathbf{C}(A)$. Thus 1/0 = 0 for A^+ . In the extreme case, the pseudoinverse of A = zero matrix (m by n) is $A^+ =$ zero matrix (n by m).

The proof of Theorem 1 begins with a simple Lemma.

Lemma 1. We have $\mathbf{C}(A) = \mathbf{C}(AB)$ if and only if rank(A) = rank(AB), and $\mathbf{N}(B) = \mathbf{N}(AB)$ if and only if rank(B) = rank(AB).

Proof: Always $\mathbf{C}(A) \supset \mathbf{C}(AB)$ and $\mathbf{N}(AB) \supset \mathbf{N}(B)$. In each pair, equality of dimensions guarantees equality of spaces. The column space can only become smaller, and the nullspace larger.

Proof of Theorem 1: We will show that $\mathbf{N}(A^{\mathrm{T}}) \subset \mathbf{N}(A^{+})$ and $\mathbf{N}(A^{\mathrm{T}}) \supset \mathbf{N}(A^{+})$, and that $\mathbf{C}(A^{\mathrm{T}}) \subset \mathbf{C}(A^{+})$ and $\mathbf{C}(A^{\mathrm{T}}) \supset \mathbf{C}(A^{+})$ when $A^{+} = R^{+}C^{+}$.

Step 1: $\mathbf{N}(A^{\mathrm{T}}) \subset \mathbf{N}(A^{+})$. Every vector $\boldsymbol{b_n}$ in the nullspace of A^{T} is also in the nullspace of A^{+} .

If $A^{\mathrm{T}}\boldsymbol{b_n} = 0$, then $R^{\mathrm{T}}C^{\mathrm{T}}\boldsymbol{b_n} = 0$. Since C^{T} has full column rank, we conclude that $C^{\mathrm{T}}\boldsymbol{b_n} = (C^{\mathrm{T}}C)^{-1}C^{\mathrm{T}}\boldsymbol{b_n} = C^+\boldsymbol{b_n} = 0$ and $\boldsymbol{b_n}$ is in the nullspace of C^+ . However, by Lemma 1, we also have $\mathbf{N}(C^+) = \mathbf{N}(R^+C^+) = \mathbf{N}(A^+)$. Every $\boldsymbol{b_n}$ in the nullspace of A^{T} is also in the nullspace of A^+ .

Step 2: $\mathbf{N}(A^{\mathrm{T}}) \supset \mathbf{N}(A^{+})$. Every vector $\boldsymbol{b_n}$ in the nullspace of A^{+} is also in the nullspace of A^{T} .

Suppose that $A^+ \boldsymbol{b_n} = R^+ C^+ \boldsymbol{b_n} = \boldsymbol{0}$. Since $RR^+ = I_r$, we have $AA^+ \boldsymbol{b_n} = CRR^+C^+\boldsymbol{b_n} = C(C^{\mathrm{T}}C)^{-1}C^{\mathrm{T}}\boldsymbol{b_n} = \boldsymbol{0}$. Since $C(C^{\mathrm{T}}C)^{-1}$ has full column rank, we see that $C^{\mathrm{T}}\boldsymbol{b_n} = \boldsymbol{0}$, so $\boldsymbol{b_n}$ is orthogonal to every column of C. Therefore $\boldsymbol{b_n} \in \mathbf{N}(A^{\mathrm{T}})$.

Step 3: $\mathbf{C}(A^{\mathrm{T}}) \subset \mathbf{C}(A^{+})$. Every vector \boldsymbol{x} in the row space of A is also in the column space of A^{+} .

We have $\boldsymbol{x} = A^{\mathrm{T}}\boldsymbol{y} = R^{\mathrm{T}}C^{\mathrm{T}}\boldsymbol{y} = R^{\mathrm{T}}[(RR^{\mathrm{T}})^{-1}RR^{\mathrm{T}}]C^{\mathrm{T}}\boldsymbol{y} = R^{+}R(R^{\mathrm{T}}C^{\mathrm{T}}\boldsymbol{y}) = R^{+}R\boldsymbol{x}$. So by Lemma 1, we conclude that $\boldsymbol{x} \in \mathbf{C}(R^{+}) = \mathbf{C}(R^{+}C^{+}) = \mathbf{C}(A^{+})$.

Step 4: $\mathbf{C}(A^{\mathrm{T}}) \supset \mathbf{C}(A^{+})$. Every vector \boldsymbol{x} in the column space of A^{+} is also in the row space of A.

Given $\boldsymbol{b} = A\boldsymbol{x} = CR\boldsymbol{x}$, we have

$$\boldsymbol{x} = A^{+}\boldsymbol{b} = R^{+}C^{+}CR\boldsymbol{x} = R^{\mathrm{T}}(RR^{\mathrm{T}})^{-1}(C^{\mathrm{T}}C)^{-1}C^{\mathrm{T}}CR\boldsymbol{x} = R^{\mathrm{T}}(RR^{\mathrm{T}})^{-1}R\boldsymbol{x}$$

So again by Lemma 1, we conclude that $\boldsymbol{x} \in \mathbf{C}(R^{\mathrm{T}}) = \mathbf{C}(R^{\mathrm{T}}C^{\mathrm{T}}) = \mathbf{C}(A^{\mathrm{T}}).$

An *m* by *n* matrix of rank *r* has many factorizations. The simplest form of A = CR fills *C* with the first *r* independent columns of *A*. Those columns are a basis for the column space of *A*. Then column *j* of *R* specifies the combination of columns of *C* that produces column *j* of *A*. This example has column 3 = column 1 + column 2:

$$A = \begin{bmatrix} 1 & 4 & 5 \\ 2 & 3 & 5 \end{bmatrix} = \begin{bmatrix} 1 & 4 \\ 2 & 3 \end{bmatrix} \begin{bmatrix} 1 & 0 & 1 \\ 0 & 1 & 1 \end{bmatrix} = CR.$$

That matrix R contains the nonzero rows of the **reduced row echelon form** of A. It also reveals nullspace $\mathbf{N}(A) = \mathbf{N}(R)$.

A = CR expresses this classical "elimination by row operations" as a matrix factorization [5, 6]. It is slower and less stable numerically than the SVD, but rational A produces rational C and R and C^+ and R^+ . The following useful formula shows that explicitly:

$$A^{+} = R^{+}C^{+} = R^{\mathrm{T}}(RR^{\mathrm{T}})^{-1}(C^{\mathrm{T}}C)^{-1}C^{\mathrm{T}} = R^{\mathrm{T}}(C^{\mathrm{T}}AR^{\mathrm{T}})^{-1}C^{\mathrm{T}}.$$
 (2)

The inverses of square rational matrices RR^T and C^TC are formed by elementary operations and division by a rational determinant. Therefore, the pseudoinverse of A is rational when A is rational.

The ranks of A^+ and A are equal when A^+ is the inverse map. Then,

$$\boldsymbol{b} = A\boldsymbol{x} + (I_m - AA^+)\boldsymbol{w}$$

is a solution of $A^+ \boldsymbol{b} = \boldsymbol{x}$ for arbitrary \boldsymbol{w} . We have $A^+ \boldsymbol{b} = A^+ A \boldsymbol{x} = \boldsymbol{x}$, since $A^+ A A^+ = A^+$ when A^+ and A have equal ranks.

That is not always the case and not always necessary. Consider the rankdeficient

$$A = \begin{bmatrix} 1 & 0 \\ 0 & 0 \\ 0 & 0 \end{bmatrix} = \begin{bmatrix} 1 \\ 0 \\ 0 \end{bmatrix} \begin{bmatrix} 1 & 0 \end{bmatrix} = C_0 R_0.$$

When we complete C_0 and R_0 to get square invertible $[C_0, C_1]$ and $[R_0, R_1]^T$, then the generalized A = CR becomes

$$A = \begin{bmatrix} C_0 & C_1 \end{bmatrix} \begin{bmatrix} I_r & 0 \\ 0 & 0 \end{bmatrix} \begin{bmatrix} R_0 \\ R_1 \end{bmatrix} = \bar{C}\bar{R}$$

and its generalized inverse is

$$G = \begin{bmatrix} R_0 \\ R_1 \end{bmatrix}^{-1} \begin{bmatrix} I_r & Z_{11} \\ Z_{21} & Z_{22} \end{bmatrix} \begin{bmatrix} C_0 & C_1 \end{bmatrix}^{-1}$$

for arbitrary Z_{ij} of proper size [8]. The first Penrose identity holds, AGA = A, but the second one gives

$$GAG = \begin{bmatrix} R_0 \\ R_1 \end{bmatrix}^{-1} \begin{bmatrix} I_r & Z_{12} \\ Z_{21} & Z_{21}Z_{12} \end{bmatrix} \begin{bmatrix} C_0 & C_1 \end{bmatrix}^{-1}.$$

We have GAG = G only if $Z_{22} = Z_{21}Z_{12}$. Then A and G have equal ranks and G is the inverse map. Otherwise, the nullspaces $\mathbf{N}(A^T)$ and $\mathbf{N}(G)$ are different. For

$$A^{T} = \begin{bmatrix} 1 & 0 & 0 \\ 0 & 0 & 0 \end{bmatrix} = \begin{bmatrix} 1 \\ 0 \end{bmatrix} \begin{bmatrix} 1 & 0 & 0 \end{bmatrix} = C_{2}R_{2}$$

the nullspace $\mathbf{N}(A^T) = \mathbf{N}(R_2)$ is spanned by $(0, 1, 0)^T$ and $(0, 0, 1)^T$. For:

$$G = \begin{bmatrix} 1 & 3 & 2 \\ 3 & 3 & 2 \end{bmatrix} = \begin{bmatrix} 1 & 3 \\ 3 & 3 \end{bmatrix} \begin{bmatrix} 1 & 0 & 0 \\ 0 & 1 & 2/3 \end{bmatrix} = C_3 R_3,$$

we see that $\mathbf{N}(G) = \mathbf{N}(R_3)$ is spanned by $(0, -2/3, 0)^T$. Here AGA = A, but GAG is not equal to G with $1 = \operatorname{rank}(A) < \operatorname{rank}(G) = 2$. Also, neither AG nor GA gives an identity matrix. Still,

$$\boldsymbol{x} = G\boldsymbol{b} + (I_n - GA)\boldsymbol{z}$$

solves $A\boldsymbol{x} = AG\boldsymbol{b} + (A - AGA)\boldsymbol{z} = AG\boldsymbol{b} = \boldsymbol{b}$ for arbitrary \boldsymbol{z} .

The necessary and sufficient conditions for $A^+ = (CR)^+ = R^+C^+$ are surprisingly complex. Greville formulated them in [7]. The reverse order law for pseudoinverse, $(CR)^+ = R^+C^+$, holds if and only if

$$\mathbf{C}(RR^TC^T) \subset \mathbf{C}(C^T)$$
 and $\mathbf{C}(C^TCR) \subset \mathbf{C}(R)$. (3)

Matrix R maps $\boldsymbol{x}_r = R^T C^T \boldsymbol{y}$ from the row space $\mathbf{C}(A^T)$ into the row space $\mathbf{C}(C^T)$. Then matrix C takes $R\boldsymbol{x}_r$ to the column space $\mathbf{C}(A)$, so we have $CR\boldsymbol{x}_r = A\boldsymbol{x}_r = \boldsymbol{b}_c$. Matrix C^T maps \boldsymbol{b}_c into the column space $\mathbf{C}(R)$. Then $R^T C^T \boldsymbol{b}_c$ is also in the row space $\mathbf{C}(A^T)$. The inverse map C^+ identifies $R\boldsymbol{x}_r$ in the column space $\mathbf{C}(R)$ and then R^+ gives $\boldsymbol{x}_r = R^+ C^+ \boldsymbol{b}_c$ in Figure 3. The reverse order law demands that


$$C^{+}C(RA^{T}) = RA^{T} \quad \text{and} \quad RR^{+}(C^{T}A) = C^{T}A.$$
(4)

It follows that C and R solve the two-sided projection equation:

$$C^+C(RR^TC^TC)RR^+ = RR^TC^TC.$$
(5)

For the full-rank factorization of Theorem 1 the equation holds with $C^+C = I_r = RR^+$.

$$R\mathbf{C}(A^T) = \mathbf{C}(RR^TC^T) \subset \mathbf{C}(C^T)$$



 $C^T \mathbf{C}(A) = \mathbf{C}(C^T C R) \subset \mathbf{C}(R)$

Figure 3: Given a full rank decomposition A = CR, matrix R maps $\mathbf{C}(A^T)$ into $\mathbf{C}(C^T)$ and matrix C^T maps $\mathbf{C}(A)$ into $\mathbf{C}(R)$ when $(CR)^+ = R^+C^+$.

$$\mathbf{C}((CRR^{+})^{+}) = RR^{+}\mathbf{C}(C^{T})$$

$$[10pt]\mathbf{x}_{r} \in \mathbf{C}(R^{T}C^{T})$$

$$\mathbf{C}(R) \cap \mathbf{C}(C^{T})$$

$$\mathbf{C}(CR) \ni \mathbf{b}_{c}$$

$$\mathbf{C}(A^T) = \mathbf{C}((C^+ CR)^+)$$

Figure 4: The pseudoinverse $A^+ = (CR)^+ = (C^+CR)^+(CRR^+)^+$ decomposes into the product of the pseudoinverse of R projected on the row space of C^T and the pseudoinverse of C^T projected on the column space of R.

In general, the inverse map $A^+ = (CR)^+$ takes \boldsymbol{b}_c in the column space $\mathbf{C}(C)$ and projects it into $R\boldsymbol{x}_r$ in the part of the column space $\mathbf{C}(R)$ intersecting with $\mathbf{C}(C^T)$. That is ensured by $(C^+RR^+)^+$, since by the first principles

$$\mathbf{C}((CRR^+)^+) = \mathbf{C}((CRR^+)^T) = RR^+\mathbf{C}(C^T) = RR^+\mathbf{C}(C^+).$$

Then $(C^+CR)^+$ maps $R\boldsymbol{x}_r$ into the row space $\mathbf{C}(R^TC^T)$. We have

$$\mathbf{C}((C^+CR)^+) = \mathbf{C}((C^+CR)^T) = R^T \mathbf{C}(C^+C) = R^T \mathbf{C}(C^T) = \mathbf{C}(R^TC^T).$$

Therefore, $\mathbf{C}(R^T C^T) = \mathbf{C}(A^+)$ in Figure 4. Also, for any \boldsymbol{b}_n in the nullspace of $R^T C^T$ we have $RR^+ C^T \boldsymbol{b}_n = \mathbf{0}$, which shows that \boldsymbol{b}_n is in the nullspace

$$\mathbf{N}(RR^+C^T) = \mathbf{N}((CRR^+)^+) \subset \mathbf{N}((C^+CR)^+(CRR^+)^+) = \mathbf{N}(A^+).$$

Conversely, any \boldsymbol{b}_n in the nullspace $\mathbf{N}((CRR^+)^+) = RR^+\mathbf{N}(C^T)$ is also in the nullspace of $\mathbf{N}(C^T)$. It is orthogonal to the columns of C spanning $\mathbf{C}(A)$. Therefore, it is also in the nullspace $\mathbf{N}(A^T)$. That proves the following formula for A^+ :

Theorem 2. The pseudoinverse A^+ of a product A = CR is given by the product

$$A^{+} = (CR)^{+} = (C^{+}CR)^{+}(CRR^{+})^{+}.$$
(6)

The statement in the title of this paper is not generally true. But the statement of Theorem 2 corrects the mistake as the following example shows:

$$C = \begin{bmatrix} 1 & 0 \end{bmatrix} \quad R = \begin{bmatrix} 1 \\ 1 \end{bmatrix} \quad C^{+}C = \begin{bmatrix} 1 & 0 \\ 0 & 0 \end{bmatrix} \quad RR^{+} = \frac{1}{2} \begin{bmatrix} 1 & 1 \\ 1 & 1 \end{bmatrix}$$
$$(C^{+}CR)^{+}(CRR^{+})^{+} = \begin{bmatrix} 1 & 0 \end{bmatrix} \begin{bmatrix} 1 \\ 1 \end{bmatrix} = (CR)^{+}.$$

Theorem 3 gives an even more general statement (following from [3]).

Theorem 3. The pseudoinverse A^+ of a product A = CR is given by the product $A^+ = \left((P^T CR)^+ P^T C \right) \left(RQ(CRQ)^+ \right), \tag{7}$

for any P and Q satisfying

$$\operatorname{rank}(P^T A) = \operatorname{rank}(AQ) = \operatorname{rank}(A).$$
(8)

Proof: When $\operatorname{rank}(P^T A) = \operatorname{rank}(AQ) = \operatorname{rank}(A)$ for P and Q of proper size, then $\mathbf{C}((P^T A)^T) = \mathbf{C}((A)^T) = \mathbf{L} \cdot \mathbf{C}(AQ) = \mathbf{C}(A)$

$$C((P^T A)^T) = C((A)^T)$$
 and $C(AQ) = C(A)$.
In that case, $(P^T A)^+ (P^T A) = A^+ A$ and $(AQ)(AQ)^+ = AA^+$ and (7) is true:
 $A^+ = (P^T A)^+ P^T AQ(AQ)^+.$

Matrices P and Q must be rank-preserving to reconstruct A^+ . But apart from that requirement, P and Q can be random matrices. The pseudoinverse of

$$A = \begin{bmatrix} 1 & 4 & 5 \\ 2 & 3 & 5 \end{bmatrix} \text{ is equal to } A^+ = \frac{1}{15} \begin{bmatrix} -8 & 9 \\ 7 & -6 \\ -1 & 3 \end{bmatrix}$$

Randomly selected matrices

$$P = \begin{bmatrix} 2 & 2 & 2 \\ 1 & 2 & 2 \end{bmatrix} \quad \text{and} \quad Q = \begin{bmatrix} 1 & 1 \\ 0 & 2 \\ 0 & 0 \end{bmatrix}$$




Figure 5: Computation time and relative approximation error of the randomized $A_r^+ = \operatorname{rpinv}(A)$, randomized SVD-based $A_s^+ = \operatorname{rsvdi}(A)$ and direct $A^+ = \operatorname{pinv}(A)$ method of calculating the pseudoinverse of A. In the experiment, we generate a random test matrix $A = \operatorname{gallery}('\operatorname{randsvd}', n, 1e100)$ with n ranging from 100 to 1000. Then, we calculate the approximation A_r^+ taking random m by p matrix P and n by q matrix Q (in Theorem 3) with $p = q = \lceil \alpha \cdot n \rceil$ for $\alpha = 0.4$ (top) and $\alpha = 0.1$ (bottom). Randomized SVD-based pseudoinverse is calculated based on rank $s = \operatorname{rank}(A)$ approximation $A_s = QU_s \Sigma_s V_s^T$ for $[Q, \sim] = \operatorname{qr}(A * \operatorname{randn}(n, s))$.

preserve $\operatorname{rank}(A) = \operatorname{rank}(P^T A) = \operatorname{rank}(AQ) = 2$. Therefore,

$$(P^T CR)^+ P^T C = \frac{1}{3} \begin{bmatrix} 2 & -1 \\ -1 & 2 \\ 1 & 1 \end{bmatrix}$$
 and $RQ(CRQ)^+ = \frac{1}{5} \begin{bmatrix} -3 & 4 \\ 2 & -1 \end{bmatrix}$

reconstruct

$$A^{+} = \frac{1}{3} \begin{bmatrix} 2 & -1 \\ -1 & 2 \\ 1 & 1 \end{bmatrix} \cdot \frac{1}{5} \begin{bmatrix} -3 & 4 \\ 2 & -1 \end{bmatrix} = \frac{1}{15} \begin{bmatrix} -8 & 9 \\ 7 & -6 \\ -1 & 3 \end{bmatrix}.$$

Random sampling matrices P and Q that are not rank-preserving produce a low-rank approximation of A^+ from the samples of bases for the column space and row space of A. Therefore, the formula in Theorem 3 describes a randomized algorithm approximating A^+ :

P = randn(m,p);
Q = randn(n,q);
PTA = P'*A;
AQ = A*Q;
Arplus = pinv(PTA)*PTA*Q*pinv(AQ);

```

When P and Q are small (m by p and n by q matrices), it is more time-efficient to compute A_r^+ using two pseudoinverses, $(P^TA)^+$ and $(AQ)^+$, than to calculate A^+ directly. Also, that approach may lead to smaller relative errors (under the circumstances to be investigated) than the randomized SVD method while maintaining similar time efficiency. Figure 5 demonstrates these points by comparing each method.

We have given three formulas for the pseudoinverse of a matrix product A = CR and derived them from the four fundamental subspaces of A. Every matrix A gives an invertible map from its row space to its column space. The pseudoinverse A^+ inverts the row space to the column space map when the nullspace of A^T and A^+ match. The first formula in Theorem 1 is correct if C has independent columns and R has independent rows or when Greville's conditions hold. The second in Theorem 2 is always correct. The third in Theorem 3 is correct when the sampling matrices P and Q preserve rank. Otherwise, it is not correct but potentially very useful, especially for large A.
