# From sparse to dense functional data in high dimensions: Revisiting phase transitions from a non-asymptotic perspective

#### Abstract

Nonparametric estimation of the mean and covariance functions is ubiquitous in functional data analysis and local linear smoothing techniques are most frequently used. Zhang and Wang (2016) explored different types of asymptotic properties of the estimation, which reveal interesting phase transition phenomena based on the relative order of the average sampling frequency per subject $T$ to the number of subjects $n$, partitioning the data into three categories: "sparse", "semi-dense" and "ultra-dense". In an increasingly available high-dimensional scenario, where the number of functional variables $p$ is large in relation to $n$, we revisit this open problem from a non-asymptotic perspective by deriving comprehensive concentration inequalities for the local linear smoothers. Besides being of interest by themselves, our non-asymptotic results lead to elementwise maximum rates of $L_{2}$ convergence and uniform convergence serving as a fundamentally important tool for further convergence analysis when $p$ grows exponentially with $n$ and possibly $T$. With the presence of extra $\log p$ terms to account for the high-dimensional effect, we then investigate the scaled phase transitions and the corresponding elementwise maximum rates from sparse to semi-dense to ultradense functional data in high dimensions. Finally, numerical studies are carried out to confirm our established theoretical properties.

## 1 Introduction

A fundamental issue in functional data analysis is the nonparametric estimation of the mean and covariance functions based on discretely sampled and noisy curves. The estimated quantities are not only of interest by themselves, but also serve as building blocks for dimension reduction and subsequent modelling of functional data, such as functional principal component analysis (Yao et al., 2005a; Li and Hsing, 2010) and functional linear regression (Yao et al., 2005b). Among candidate nonparametric smoothers, we focus on the most commonly-adopted local linear smoothing method due to its simplicity and attractive local and boundary correction properties.

In a typical functional data setting, we have $n$ random curves, representing $n$ subjects, observed with errors, at $T_{i}$ randomly sampled time points for the $i$ th subject. The sampling frequency $T_{i}$ plays a pivotal role in the estimation, as it may affect the choice of the estimation procedure. The literature can be loosely divided into two categories. The first category corresponds to dense functional data, where $T_{i}$ 's are larger than some order of $n$. A conventional approach to handle such data implements nonparametric smoothing to the observations from each subject to eliminate the noise, thus reconstructing each individual curve before subsequent analysis (Zhang and Chen, 2007). The second category, referred to as sparse functional data, accords with bounded $T_{i}$ 's. Under such a scenario, the pre-smoothing step is no longer applicable, an alternative post-smoothing type approach considers pooling the data from all subjects to build strength across all observations (Yao et al., 2005a; Li and Hsing, 2010). More recently, Zhang and Wang (2016) provided a comprehensive analysis of phase transitions and the associated rates of convergence for three types of asymptotic properties: local asymptotic normality, $L_{2}$ convergence, and uniform convergence. They proposed to further partition dense functional data into new categories: "semi-dense" and "ultra-dense", depending on whether the root- $n$ rate is achieved with negligible asymptotic bias or not. However, these aforementioned asymptotic results are only suitable to handle univariate or low-dimensional multivariate functional data.

With recent advances in data collection technology, high-dimensional functional datasets become increasingly available. Examples include time-course gene expression data, and electroencephalography and functional magnetic resonance imaging data, where signals are
measured over time at a large number of regions of interest (Zhu et al., 2016; Li and Solea, 2018; Zapata et al., 2022; Fang et al., 2023). Those data can be represented as a $p$-vector of random functions $\mathbf{X}_{i}(\cdot)=\left\{X_{i 1}(\cdot), \ldots, X_{i p}(\cdot)\right\}^{\mathrm{T}}$ for $i=1, \ldots, n$ defined on a compact set $\mathcal{U}$, where the dimension $p$ can be diverging with, or even larger than, the number of subjects $n$. In practice, each $X_{i j}(\cdot)$ is observed subject to error contamination at $T_{i j}$ random time points; see (1) below. In this paper, we propose a unified local linear smoothing approach to estimate the mean and covariance functions for both sparsely and densely sampled high-dimensional functional data.

Within the framework of high-dimensional statistics, it is essential to conduct nonasymptotic analysis of the estimators by developing concentration inequalities under given performance metric, which can lead to probabilistic error bounds in elementwise maximum norm as a function of $n, p$ and possibly $T_{i j}$ 's under our setup. The literature has mainly focused on fully observed functional data, based on which concentration inequalities for the estimated covariance functions were established in Qiao et al. (2019) and Zapata et al. (2022). For the practical scenario where the curves are partially observed with errors, one has to deal with the second order $U$-statistics with complex dependence structure, posing a technically challenging task. Qiao et al. (2020) made the first attempt to derive some sub-optimal concentration results for the estimated covariance functions only under a restrictive finite-dimensional setting. Lee et al. (2022) and Fang et al. (2023) developed their methodologies by simply assuming that the elementwise maximum rates of the covariance estimators are not faster than the parametric counterpart without specifying the exact forms. Therefore, it remains an important open problem to investigate the non-asymptotic proprieties of both the mean and covariance estimators when handling partially observed functional data.

We present in this paper a systematic and unified non-asymptotic analysis of the local linear smoothers for the mean and covariance functions to accommodate both sparsely and densely sampled functional data in high dimensions. The new contribution of this paper is threefold.

- First, we develop generalized sub-Gaussian type concentration inequalities in both $L_{2}$ norm and supremum norm for each functional element of the mean and covariance estimators. Compare to the asymptotic results in Zhang and Wang (2016), our
non-asymptotic error bounds lead to the same rates of $L_{2}$ convergence and uniform convergence, and reveal the same phase transition phenomena depending on the relative order of the average sampling frequency per subject to $n^{1 / 4}$ for dense functional data.
- Second, we derive elementwise maximum rates of both $L_{2}$ and uniform convergence for the mean and covariance estimators, serving as a fundamental tool to provide theoretical guarantees for a set of high-dimensional functional data models, such as functional graphical models (Li and Solea, 2018; Qiao et al., 2019, 2020; Solea and Li, 2022; Zapata et al., 2022; Lee et al., 2022), functional covariance estimation (Fang et al., 2023), and functional additive regressions (Fan et al., 2014, 2015; Kong et al., 2016; Luo and Qi, 2017).
- Third, with the presence of additional $\log p$ terms to account for the high-dimensional effect in our established elementwise maximum rates, the scaled phase transitions for high-dimensional dense functional data occur based on the ratios of the average sampling frequency per subject to $n^{1 / 4}(\log p)^{-1 / 4}$. This leads to a further partition of dense functional data into categories of "semi-dense" and "ultra-dense", depending on whether the parametric rate $(\log p)^{1 / 2} n^{-1 / 2}$ can be attained or not. With suitable choices of optimal bandwidths, we also present the optimal elementwise maximum rates from sparse to semi-dense to ultra-dense functional data, which correspondingly extend the optimal rates in Zhang and Wang (2016) to the high-dimensional setting.

Outline of the paper. In Section 2, we present the nonparametric smoothing approach to estimate the mean and covariance functions. In Section 3, we investigate the non-asymptotic and convergence properties of the proposed local linear smoothers and discuss the associated phase transition phenomena. The established theoretical results are validated through simulations in Section 4. All technical proofs are relegated to the Appendix.

Notation. We summarize here some notation to be used throughout the paper. For a positive integer $q$, we write $[q]=\{1, \ldots, q\}$. For $x, y \in \mathbb{R}$, we write $x \vee y=\max (x, y)$ and $x \wedge y=\min (x, y)$. We use $I(\cdot)$ to denote an indicator function. Let $L_{2}(\mathcal{U})$ be a Hilbert space of square-integrable functions on a compact interval $\mathcal{U}$ equipped with the inner product
$\langle f, g\rangle=\int f(u) g(u) \mathrm{d} u$ for $f(\cdot), g(\cdot) \in L_{2}(\mathcal{U})$ and the induced $L_{2}$ norm $\|\cdot\|=\langle\cdot, \cdot\rangle^{1 / 2}$. For any bivariate function $\Phi(\cdot, \cdot)$ in the tensor product space $L_{2}(\mathcal{U}) \otimes L_{2}(\mathcal{U})$, we also use $\Phi$ to denote the linear operator induced from the kernel function $\Phi(\cdot, \cdot)$, that is, for any $f(\cdot) \in L_{2}(\mathcal{U}), \Phi(f)(\cdot)=\int \Phi(\cdot, v) f(v) \mathrm{d} v \in L_{2}(\mathcal{U})$, and denote its Hilbert-Schmidt norm by $\left\{\iint \Phi(u, v)^{2} \mathrm{~d} u \mathrm{~d} v\right\}^{1 / 2}$. For two positive sequences $\left\{a_{n}\right\}$ and $\left\{b_{n}\right\}$, we write $a_{n} \lesssim b_{n}$ or $b_{n} \gtrsim a_{n}$ if there exist a positive constant $c$ such that $\limsup _{n \rightarrow \infty} a_{n} / b_{n} \leqslant c$. We write $a_{n}=b_{n}$ if and only if $a_{n} \lesssim b_{n}$ and $b_{n} \lesssim a_{n}$ hold simultaneously.

## 2 Methodology

Let $\mathbf{X}_{i}(\cdot)=\left\{X_{i 1}(\cdot), \ldots, X_{i p}(\cdot)\right\}^{\mathrm{T}}$ for $i \in[n]$ be independently and identically distributed copies of $\mathbf{X}(\cdot)$ defined on $\mathcal{U}$ with $p$-vector of mean functions $\boldsymbol{\mu}(\cdot)=\left\{\mu_{1}(\cdot), \ldots, \mu_{p}(\cdot)\right\}^{\mathrm{T}}=$ $E\{\mathbf{X}(\cdot)\}$ and $(p \times p)$-matrix of marginal- and cross-covariance functions $\boldsymbol{\Sigma}(u, v)=\left\{\Sigma_{j k}(u, v)\right\}_{p \times p}$ whose $(j, k)$-th entry $\Sigma_{j k}(u, v)=\operatorname{cov}\left\{X_{i j}(u), X_{i k}(v)\right\}$. For any $i \in[n]$ and $j \in[p], X_{i j}(\cdot)$ is not directly observable in practice. Instead it is observed, with random errors, at $T_{i j}$ random time points, $U_{i 1}, \ldots, U_{i T_{i j}} \in \mathcal{U}$. Let $Y_{i j t}$ be the observed value of $X_{i j}\left(U_{i j t}\right)$ satisfying

\end{equation*}

where the errors $\varepsilon_{i j t}$ 's, independent of $X_{i j}$ 's, are independently and identically distributed copies of $\varepsilon_{j}$ with $E\left(\varepsilon_{j}\right)=0$ and $\operatorname{var}\left(\varepsilon_{j}\right)=\sigma_{j}^{2}<\infty$.

Based on the observed data $\left\{\left(U_{i j t}, Y_{i j t}\right): i \in[n], j \in[p], t \in\left[T_{i j}\right]\right\}$, we present a unified procedure to estimate the mean functions $\mu_{j}(\cdot)$ 's and the marginal- and cross-covariance functions $\Sigma_{j k}(\cdot, \cdot)$ 's for both sparsely and densely sampled functional data. In what follows, denote $K_{h}(\cdot)=h^{-1} K(\cdot / h)$ for a univariate kernel $K$ with bandwidth $h>0$. For each $j$, a local linear smoother is firstly applied to $\left\{\left(U_{i j t}, Y_{i j t}\right): i \in[n], t \in\left[T_{i j}\right]\right\}$, and hence the estimated mean function is attained via $\hat{\mu}_{j}(u)=\hat{b}_{0}$, where

\left(\hat{b}_{0}, \hat{b}_{1}\right)=\arg \min _{b_{0}, b_{1}} \sum_{i=1}^{n} v_{i j} \sum_{t=1}^{T_{i j}}\left\{Y_{i j t}-b_{0}-b_{1}\left(U_{i j t}-u\right)\right\}^{2} K_{h_{\mu, j}}\left(U_{i j t}-u\right) . \tag{2}

The weight $v_{i j}$ is attached to each observation for the $i$ th subject and the $j$ th functional variable such that $\sum_{i=1}^{n} T_{i j} v_{i j}=1$ (Zhang and Wang, 2016).

For each $i \in[n], j, k \in[p], t \in\left[T_{i j}\right]$ and $s \in\left[T_{i k}\right]$, once the mean functions are estimated, let $\Theta_{i j k t s}=\left\{Y_{i j t}-\hat{\mu}_{j}\left(U_{i j t}\right)\right\}\left\{Y_{i k s}-\hat{\mu}_{k}\left(U_{i k s}\right)\right\}$ be the "raw covariance" between $Y_{i j t}$ and
$Y_{i k s}$. Observe that $\operatorname{cov}\left(Y_{i j t}, Y_{i k s}\right)=\Sigma_{j k}\left(U_{i j t}, U_{i k s}\right)+\sigma_{j}^{2} I(j=k) I(t=s)$. To estimate the marginal-covariance function $\Sigma_{j j}(\cdot, \cdot)$ for each $j$ or the cross-covariance function $\Sigma_{j k}(\cdot, \cdot)$ for each $j \neq k$, we next employ local linear surface smoothers to the off-diagonals of the raw marginal-covariances $\left(\Theta_{i j j t s}\right)_{1 \leqslant t \neq s \leqslant T_{i j}}$ or to the raw cross-covariances $\left(\Theta_{i j k t s}\right)_{t \in\left[T_{i j}\right], s \in\left[T_{i k}\right]}$. Specifically, we minimize

\sum_{i=1}^{n} w_{i j k} \sum_{(t, s) \in \mathcal{T}}\left\{\Theta_{i j k t s}-\beta_{0}-\beta_{1}\left(U_{i j t}-u\right)-\beta_{2}\left(U_{i k s}-v\right)\right\}^{2} K_{h_{\Sigma, j k}}\left(U_{i j t}-u\right) K_{h_{\Sigma, j k}}\left(U_{i k s}-v\right) \tag{3}
\end{equation*}

with respect to $\left(\beta_{0}, \beta_{1}, \beta_{2}\right)$, where the set $\mathcal{T}$ equals to $\left\{(t, s): t \in\left[T_{i j}\right], s \in\left[T_{i j}\right], t \neq s\right\}$ if $j=k$ or $\left\{(t, s): t \in\left[T_{i j}\right], s \in\left[T_{i k}\right]\right\}$ if $j \neq k$, and the weight $w_{i j k}$ is assigned to each triplet $(i, j, k)$ such that $\sum_{i=1}^{n} T_{i j}\left\{T_{i k}-I(j=k)\right\} w_{i j k}=1$. See the weights to estimate marginal-covariance functions in Zhang and Wang (2016). The resulting marginal- or crosscovariance estimator is $\hat{\Sigma}_{j k}(u, v)=\hat{\beta}_{0}$. For ease of presentation, we assume that the mean functions $\mu_{j}(\cdot)$ 's are known in advance when discussing the concentration and convergence results related to the covariance estimators $\hat{\Sigma}_{j k}(u, v)$ 's in Section 3 below. However, it is noteworthy that all our discussions remain valid even when $\mu_{j}(\cdot)$ 's are unknown as long as a few additional technical assumptions are imposed.

Our estimation procedure allows general weighting schemes for $\left\{v_{i}\right\}_{i \in[n]},\left\{w_{i j k}\right\}_{i \in[n], j, k \in[p]}$ such that two types of frequently-used schemes in existing literature are special cases of them. One type assigns the same weights to each observation (Yao et al., 2005a) with $v_{i j}=\left(\sum_{i=1}^{n} T_{i j}\right)^{-1}$ and $w_{i j k}=\left[\sum_{i=1}^{n} T_{i j}\left\{T_{i k}-I(j=k)\right\}\right]^{-1}$, so a subject with a larger number of observations receives more weights in total. The other type assigns the same weights to each subject (Li and Hsing, 2010), thus leading to $v_{i j}=\left(n T_{i j}\right)^{-1}$ and $w_{i j k}=$ $\left[n T_{i j}\left\{T_{i k}-I(j=k)\right\}\right]^{-1}$.

Suppose that the estimated mean and covariance functions are evaluated at a grid of $R \times R$ locations over $\mathcal{U}^{2}$. Under the high-dimensional setting, it is apparent that our proposed nonparametric smoothing approach suffers from high computational cost in kernel evaluations, particularly when estimating $p(p+1) / 2$ marginal- and cross-covariance functions. In a common practical scenario, where each $X_{i j}(\cdot)$ is observed at the same set of time points $U_{1}, \ldots, U_{T_{i}} \in \mathcal{U}$ across $j \in[p]$, the number of kernel evaluations is reduced from $O\left(\sum_{i=1}^{n} \sum_{j=1}^{p} T_{i j} R\right)$ to $O\left(\sum_{i=1}^{n} T_{i} R\right)$. To further speed up the computation, we can adopt the linear binning technique (Fan and Marron, 1994) to approximate the mean and co-
variance estimation. This would largely reduced the number of kernel evaluations to $O(R)$ while requiring only $O\left(\sum_{i=1}^{n} T_{i}\right)$ additional operations. See the detailed implementation of binning in Fang et al. (2023). Our conducted numerical experiments show that such binned implementation offers substantially improved computational efficiency without sacrificing any estimation accuracy.

## 3 Theory

Before presenting the concentration and convergence results, we impose the following regularity assumptions.

Assumption 1 For each $i \in[n]$ and $j \in[p], X_{i j}(\cdot)$ is a sub-Gaussian random process and $\varepsilon_{i j}$ is a sub-Gaussian random variable, that is, there exists some positive constant $c$ such that $E\left\{\exp \left(\left\langle x, X_{i j}-\mu_{j}\right\rangle\right)\right\} \leqslant \exp \left\{2^{-1} c^{2}\left\langle x, \Sigma_{j j}(x)\right\rangle\right\}$ for all $x(\cdot) \in L^{2}(\mathcal{U})$ and $E\left\{\exp \left(\varepsilon_{i j} z\right)\right\} \leqslant$ $\exp \left(2^{-1} c^{2} \sigma_{j}^{2} z^{2}\right)$ for all $z \in \mathbb{R}$.

Assumption 2 For each $i \in[n]$ and $j \in[p]$, under the sparse design, $T_{i j} \leqslant T_{0}<\infty$, and, under the dense design, $T_{i j} \rightarrow \infty$ and there exists some positive constant $\bar{c}$ such that $\max _{i, j} T_{i j}\left(\min _{i, j} T_{i j}\right)^{-1} \leqslant \bar{c}$.

Assumption 3 Under the dense design, there exists some positive constant $c_{0}$ such that $\max _{i, j} v_{i j}\left(\min _{i, j} v_{i j}\right)^{-1} \leqslant c_{0}$ and $\max _{i, j, k} w_{i j k}\left(\min _{i, j, k} w_{i j k}\right)^{-1} \leqslant c_{0}$.

Assumption 4 (i) Let $\left\{U_{i j t}: i \in[n], t \in\left[T_{i j}\right]\right\}$ be independently and identically distributed copies of a random variable $U$ defined on $\mathcal{U}$. The density $f_{U}(\cdot)$ of $U$ satisfies $0<m_{f} \leqslant$ $\inf _{\mathcal{U}} f_{U}(u) \leqslant \sup _{\mathcal{U}} f_{U}(u) \leqslant M_{f}<\infty$ for some positive constants $m_{f}$ and $M_{f} ;$ (ii) $\mathbf{X}(\cdot), U$ and $\left\{\varepsilon_{j}\right\}_{j \in[p]}$ are mutually independent.

Assumption 5 Let $B_{j k}=\left[(k-1) \widetilde{T}_{j}^{-1}, k \widetilde{T}_{j}^{-1}\right]$ for $k \in\left[\widetilde{T}_{j}\right]$ with $\widetilde{T}_{j}=\max _{i} T_{i j}$, there exists some constant $C>0$ such that the cardinality $\#\left\{U_{i j t}: U_{i j t} \in B_{j k}, t \in\left[T_{i j}\right]\right\} \leqslant C$ for each $i \in[n], j \in[p]$ and $k \in\left[\widetilde{T}_{j}\right]$.

Assumption 6 (i) $K(\cdot)$ is symmetric probability density function on $[-1,1]$ with $\int u^{2} K(u)<$ $\infty$ and $\int K(u)^{2} d u<\infty$. (ii) $K(\cdot)$ is Lipschitz continuous: there exists some positive constant $L$ such that $|K(u)-K(v)| \leqslant L|u-v|$ for any $u, v \in[-1,1]$.

Assumption 7 (i) $\partial^{2} \mu_{j}(u) / \partial u^{2}$ is uniformly bounded over $u \in \mathcal{U}$ and $j \in[p] ;$ (ii) $\partial^{2} \Sigma_{j k}(u, v) / \partial u^{2}$, $\partial^{2} \Sigma_{j k}(u, v) / \partial u \partial v$, and $\partial^{2} \Sigma_{j k}(u, v) / \partial v^{2}$ are uniformly bounded over $(u, v) \in \mathcal{U}^{2}$ and $(j, k) \in$ $[p]^{2}$.

The sub-Gaussianities in Assumption 1 for both Hilbert space-valued random elements $X_{i j}(\cdot)$ 's and random errors $\varepsilon_{j}$ 's together imply that the observations $Y_{i j t}$ 's in (1) are subGaussian, which plays a crucial role in deriving our subsequent concentration inequalities. The dense case in Assumption 2 corresponds to a common practical scenario, where the sampling frequencies $T_{i j}$ 's are of the same order across $i \in[n]$ and $j \in[p]$. Under such a scenario, Assumption 3 is automatically satisfied by two frequently-used weighting schemes including "equal weight per observation" and "equal weight per subject". Assumption 5 means that all observational time points are distributed in the sense of "uniformly on $\mathcal{U}^{\prime \prime}$. This circumvents the possibility of an extreme case where a large number of time points are concentrated in some small areas, while leaving too few points in other regions. Assumptions 4, 6 and 7 are standard in the literature of local linear smoothing for functional data (Yao et al., 2005a; Zhang and Wang, 2016) adaptable to the multivariate setting.

Theorem 1 Suppose that Assumptions 1-6 hold. For each $j \in[p]$, let $\gamma_{n, T, h, j}=n(1 \wedge$ $\left.\bar{T}_{\mu, j} h_{\mu, j}\right)$ with the corresponding average sampling frequency per subject $\bar{T}_{\mu, j}=n^{-1} \sum_{i=1}^{n} T_{i j}$, then there exist some positive constants $c_{1}, c_{2}$ (independent of $n, p, \bar{T}_{\mu, j}$ 's) and arbitrarily small $\epsilon_{1}>0$ such that for any $\delta \in(0,1]$,

\operatorname{pr}\left\{\sup _{u \in \mathcal{U}}\left|\hat{\mu}_{j}(u)-\tilde{\mu}_{j}(u)\right| \geqslant \delta\right\} \leqslant \frac{c_{2}\left(n^{\epsilon_{1}} \gamma_{n, T, h, j}\right)^{1 / 2}}{h_{\mu, j}} \exp \left(-c_{1} \gamma_{n, T, h, j} \delta^{2}\right) \tag{5}

where $\tilde{\mu}_{j}(u)$ is a deterministic univariate function that converges to $\mu_{j}(u)$ as $h_{\mu, j} \rightarrow 0$. See (A.1) in Appendix A for the exact form of $\tilde{\mu}_{j}(u)$.

Theorem 2 Suppose that Assumptions 1-6 hold. For each $j, k \in[p]$, let $\nu_{n, T, h, j k}=$ $n\left(1 \wedge \bar{T}_{\Sigma, j k}^{2} h_{\Sigma, j k}^{2}\right)$ with the corresponding average sampling frequency per subject $\bar{T}_{\Sigma, j k}=$ $\left[n^{-1} \sum_{i=1}^{n} T_{i j}\left\{T_{i k}-I(j=k)\right\}\right]^{1 / 2}$, then there exist some positive constants $c_{3}, c_{4}$ (independent of $n, p, \bar{T}_{\Sigma, j k}$ 's) and arbitrarily small $\epsilon_{2}>0$ such that for any $\delta \in(0,1]$,

\operatorname{pr}\left\{\sup _{(u, v) \in \mathcal{U}^{2}}\left|\widehat{\Sigma}_{j k}(u, v)-\widetilde{\Sigma}_{j k}(u, v)\right| \geqslant \delta\right\} \leqslant \frac{c_{4} n^{\epsilon_{2}} \nu_{n, T, h, j k}}{h_{\Sigma, j k}^{2}} \exp \left(-c_{3} \nu_{n, T, h, j k} \delta^{2}\right), \tag{7}
\end{gather*}

where $\widetilde{\Sigma}_{j k}(u, v)$ is a deterministic bivariate function that converges to $\Sigma_{j k}(u, v)$ as $h_{\Sigma, j k} \rightarrow 0$. See (A.17) in Appendix $A$ for the exact form of $\widetilde{\Sigma}_{j k}(u, v)$.

The concentration inequalities in Theorems 1 and 2 imply that $\hat{\mu}_{j}$ and $\hat{\Sigma}_{j k}$ are nicely concentrated around $\tilde{\mu}_{j}$ and $\widetilde{\Sigma}_{j k}$, respectively, in both $L_{2}$ norm and supremum norm with generalized sub-Gaussian type tail behaviors. It is worth mentioning that such $L_{2}$ and uniform concentration results are derived based on the local concentration inequalities of $\hat{\mu}_{j}(u)$ and $\widehat{\Sigma}_{j, k}(u, v)$ for fixed interior points $u, v \in \mathcal{U}$, which enjoy the same tail behaviors as (4) and (6). Besides being fundamental to derive elementwise maximum error bounds that are essential for further convergence analysis under high-dimensional scaling, these non-asymptotic results lead to the same rates of $L_{2}$ convergence and uniform convergence compared to those in Zhang and Wang (2016). Specifically, under extra Assumption 7, it holds that

&\left\|\widehat{\Sigma}_{j k}-\Sigma_{j k}\right\|_{\mathcal{S}}=O_{P}\left\{n^{-1 / 2}+\left(n \bar{T}_{\Sigma, j k}^{2} h_{\Sigma, j k}^{2}\right)^{-1 / 2}+h_{\Sigma, j k}^{2}\right\}, \\
& \sup _{(u, v) \in \mathcal{U}^{2}}\left|\widehat{\Sigma}_{j k}(u, v)-\Sigma_{j k}(u, v)\right|=O_{P}\left[(\log n)^{1 / 2} n^{-1 / 2}\left\{1+\left(\bar{T}_{\Sigma, j k}^{2} h_{\Sigma, j k}^{2}\right)^{-1 / 2}\right\}+h_{\Sigma, j k}^{2}\right] .

The above rates of convergence reveal interesting phase transition phenomena depending on the ratio of the average sampling frequency per subject $\bar{T}_{\mu, j}$ (or $\bar{T}_{\Sigma, j k}$ ) to $n^{1 / 4}$. In the following, we use different rates of $L_{2}$ convergence for $\hat{\mu}_{j}$ and $\widehat{\Sigma}_{j k}$ to illustrate a systematic partition of functional data into three categories:

1. Under the sparse design, when $h_{\mu, j}=n^{-1 / 5}$,

3. Under the dense design, when $\bar{T}_{\mu, j} n^{-1 / 4} \rightarrow \tilde{c}$ (some positive constant) with $h_{\mu, j}=$ $n^{-1 / 4}$ or $\bar{T}_{\mu, j} n^{-1 / 4} \rightarrow \infty$ with $h_{\mu, j}=o\left(n^{-1 / 4}\right)$ and $\bar{T}_{\mu, j} h_{\mu, j} \rightarrow \infty$,

As $\bar{T}_{\mu, j}$ and $\bar{T}_{\Sigma, j k}$ grow very fast, case 3 results in the root- $n$ rate complying with the parametric rate for fully observed functional data. As $\bar{T}_{\mu, j}$ and $\bar{T}_{\Sigma, j k}$ grow moderately fast, case 2 corresponds to the optimal minimax rates (Zhang and Wang, 2016), which are slower than root- $n$ but faster than the counterparts for sparsely sampled functional data. Our established convergence rates in cases 1,2 and 3 allow free choices of $(j, k)$, and are respectively consistent to those of the mean and covariance estimators under categories of "sparse", "semi-dense" and "ultra-dense" functional data introduced in Zhang and Wang (2016).

Theorem 3 Suppose that the assumptions in Theorem 1 and Assumption 7(i) hold, and $\log p\left(\min _{j} \gamma_{n, T, h, j}\right)^{-1} \rightarrow 0, \max _{j} h_{\mu, j} \rightarrow 0$ as $n, p \rightarrow \infty$. It then holds that

Theorem 4 Suppose that the assumptions in Theorem 2 and Assumption 7(ii) hold and $\log p\left(\min _{j, k} \nu_{n, T, h, j k}\right)^{-1} \rightarrow 0, \max _{j, k} h_{\Sigma, j k} \rightarrow 0$ as $n, p \rightarrow \infty$. It then holds that

We observe that the elementwise maximum rates of $L_{2}$ convergence and uniform convergence are governed by both dimensionality parameters ( $n, p,\left\{\bar{T}_{\mu, j}\right\}_{j \in[p]},\left\{\bar{T}_{\Sigma, j k}\right\}_{j, k \in[p]}$ ) and internal parameters $\left(\left\{h_{\mu, j}\right\}_{j \in[p]},\left\{h_{\Sigma, j k}\right\}_{j, k \in[p]}\right)$. Each convergence rate is composed of two terms reflecting our familiar variance-bias tradeoff in nonparametric statistics. It is easy to see that the variance terms are determined by the least frequently sampled and smoothed components, that is the smallest $\bar{T}_{\mu, j}$ (or $\bar{T}_{\Sigma, j k}$ ) and $h_{\mu, j}$ (or $h_{\Sigma, j k}$ ) across $j, k$, whereas the highest level of smoothness with the largest $h_{\mu, j}$ (or $h_{\Sigma, j k}$ ) controls the bias terms.

To facilitate further discussion, we consider the simplified setting where $\bar{T}_{\mu, j}=\bar{T}_{\mu}, h_{\mu, j}=$ $h_{\mu}$ and $\bar{T}_{\Sigma, j k}=\bar{T}_{\Sigma}, h_{\Sigma, j k}=h_{\Sigma}$ for each $j$ and $k$. Compared to cases 1-3 above, the corresponding elementwise maximum rates of convergence for $\left\{\hat{\mu}_{j}\right\}_{j \in[p]}$ (or $\left\{\widehat{\Sigma}_{j k}\right\}_{j, k \in[p]}$ ) in Theorem 3 (or Theorem 4) reveal scaled phase transitions for dense functional data depending on the relative order of $\bar{T}_{\mu}$ (or $\bar{T}_{\Sigma}$ ) to $n^{1 / 4}(\log p)^{-1 / 4}$ instead of $n^{1 / 4}$. In the following, we use elementwise maximum rates of $L_{2}$ convergence to illustrate the phase transition phenomena and the optimal estimation from sparse to dense functional data in high dimensions. In terms of the uniform convergence, the same phenomena occur as long as $p \gtrsim n$.
i. Under the sparse design, when $h_{\mu}=(\log p)^{1 / 5} n^{-1 / 5}$,

ii. Under the dense design, when $\bar{T}_{\mu}(\log p)^{1 / 4} n^{-1 / 4} \rightarrow 0$ with $h_{\mu}=(\log p)^{1 / 5}\left(n \bar{T}_{\mu}\right)^{-1 / 5}$,

iii. Under the dense design, when $\bar{T}_{\mu}(\log p)^{1 / 4} n^{-1 / 4} \rightarrow \tilde{c}$ with $h_{\mu}=(\log p)^{1 / 4} n^{-1 / 4}$ or $\bar{T}_{\mu}(\log p)^{1 / 4} n^{-1 / 4} \rightarrow \infty$ with $h_{\mu}=o\left\{(\log p)^{1 / 4} n^{-1 / 4}\right\}$ and $\bar{T}_{\mu} h_{\mu} \rightarrow \infty$,

when $\bar{T}_{\Sigma}(\log p)^{1 / 4} n^{-1 / 4} \rightarrow \tilde{c}$ with $h_{\Sigma}=(\log p)^{1 / 4} n^{-1 / 4}$ or $\bar{T}_{\Sigma}(\log p)^{1 / 4} n^{-1 / 4} \rightarrow \infty$ with $h_{\Sigma}=o\left\{(\log p)^{1 / 4} n^{-1 / 4}\right\}$ and $\bar{T}_{\Sigma} h_{\Sigma} \rightarrow \infty$,

In a similar spirit to the partitioned three categories for univariate functional data (see cases 1, 2 and 3 above), we can also term the high-dimensional functional data in cases i, ii, and iii as "sparse", "semi-dense" and "ultra-dense", respectively. The main difference lies in the presence of additional $\log p$ terms to account for the high-dimensional effect. As $\bar{T}_{\mu}$ and $\bar{T}_{\Sigma}$ grow at least in the order of $n^{1 / 4}(\log p)^{-1 / 4}$, the attained optimal rate $(\log p)^{1 / 2} n^{-1 / 2}$ is identical to that for the fully observed functional data (Zapata et al., 2022), presenting that the theory for high-dimensional ultra-dense functional data falls in the parametric paradigm. As $\bar{T}_{\mu}$ and $\bar{T}_{\Sigma}$ diverge slower than $n^{1 / 4}(\log p)^{-1 / 4}$, if we let $h_{\mu}=(\log p)^{1 / 5}\left(n \bar{T}_{\mu}\right)^{-1 / 5}$ and $h_{\Sigma}=(\log p)^{1 / 6}\left(n \bar{T}_{\Sigma}^{2}\right)^{-1 / 6}$ to balance the corresponding variance and bias terms, the optimal rates for high-dimensional semi-dense functional data are respectively achieved in (12) and (13). These rates degenerate to the minimax rates in case 2 when $p$ is fixed. With the choice of elementwise optimal bandwidths $h_{\mu}=\left(n \bar{T}_{\mu}\right)^{-1 / 5}$ and $h_{\Sigma}=\left(n \bar{T}_{\Sigma}^{2}\right)^{-1 / 6}$, we obtain $\max _{j}\left\|\hat{\mu}_{j}-\mu_{j}\right\|=O_{P}\left\{(\log p)^{1 / 2}\left(n \bar{T}_{\mu}\right)^{-2 / 5}\right\}$ and $\max _{j, k} \| \widehat{\Sigma}_{j k}-$ $\Sigma_{j k} \|=O_{P}\left\{(\log p)^{1 / 2}\left(n \bar{T}_{\Sigma}\right)^{-1 / 3}\right\}$, which are respectively slower than the optimal rates in (12) and (13). Such discussion applies analogously to the sparse functional setting; see cases 1 and i. Compared to the asymptotic results for cases 1,2 and 3 under a fixed $p$ scenario,
the high-dimensionality in cases i, ii and iii leads to the scaled phase transitions, optimal selected bandwidths and corresponding optimal rates, each of which is up to a factor of $\log p$ at some polynomial order. It is worth mentioning that Lee et al. (2022) simply assumed the elementwise maximum rate $\max _{j, k}\left\|\widehat{\Sigma}_{j k}-\Sigma_{j k}\right\|_{\mathcal{S}}=O_{P}\left(\log p n^{-\tau}\right)$, which was further reduced to $O_{P}\left\{(\log p)^{1 / 2} n^{-\tau}\right\}$ in Fang et al. (2023). The involved quantity $\tau \in(0,1 / 2]$ reflects the average sampling frequency with larger values yielding denser observational points. We fundamentally improve their rates in the sense of precisely specifying the largest values of $\tau$ under cases with different sampling frequencies.

## 4 Simulations

In this section, we examine the finite-sample performance of the local linear smoothers for the mean and covariance function estimation in high dimensions.

We generalize the simulated example for univariate functional data in Zhang and Wang (2016) to the multivariate setting by generating

where the true mean function $\mu_{j}(u)=1.5 \sin \{3 \pi(u+0.5)\}+2 u^{3}$, the basis function $\boldsymbol{\phi}(u)=$ $\{\sqrt{2} \cos (2 \pi u), \sqrt{2} \sin (2 \pi u), \sqrt{2} \cos (4 \pi u), \sqrt{2} \sin (4 \pi u)\}^{\mathrm{T}}$ and the basis coefficient vector $\boldsymbol{\theta}_{i}=$ $\left(\boldsymbol{\theta}_{i 1}^{\mathrm{T}}, \ldots, \boldsymbol{\theta}_{i p}^{\mathrm{T}}\right)^{\mathrm{T}} \in \mathbb{R}^{4 p}$ is sampled independently from a mean zero multivariate Gaussian distribution with block covariance matrix $\Lambda \in \mathbb{R}^{4 p \times 4 p}$ whose $(j, k)$ th block is given by $\boldsymbol{\Lambda}_{j k}=\rho^{|j-k|} \operatorname{diag}\left\{2^{-2}, \ldots, 5^{-2}\right\} \in \mathbb{R}^{4 \times 4}$ for $j, k \in[p]$. Hence the $(j, k)$ th entry of the true covariance functions $\boldsymbol{\Sigma}(\cdot, \cdot)=\left\{\Sigma_{j k}(\cdot, \cdot)\right\}_{p \times p}$ is $\Sigma_{j k}(u, v)=\boldsymbol{\phi}(u)^{\mathrm{T}} \boldsymbol{\Lambda}_{j k} \boldsymbol{\phi}(v)$. We then generate the observed values $Y_{i j t}=X_{i j}\left(U_{i j t}\right)+\varepsilon_{i j t}$ for $t=1, \ldots, T_{i j}=T$, where the time points $U_{i j t}$ 's and errors $\varepsilon_{i j t}$ 's are sampled independently from Uniform $[0,1]$ and $\mathcal{N}\left(0,0.5^{2}\right)$, respectively.

We use the Epanechnikov kernel with bandwidth values varying on a dense grid. To evaluate the performance of $\widehat{\mu}_{j}(\cdot)$ for $j \in[p]$ and $\widehat{\Sigma}_{j k}(\cdot, \cdot)$ for $(j, k) \in[p]^{2}$ given specific bandwidth $h_{\mu, j}$ and $h_{\Sigma, j k}$, we define the corresponding mean integrated squared errors (MISE) as $\operatorname{MISE}\left(\widehat{\mu}_{j}, h_{\mu, j}\right)=\int_{\mathcal{U}}\left\{\widehat{\mu}_{j}(u)-\mu_{j}(u)\right\}^{2} \mathrm{~d} u$ and $\operatorname{MISE}\left(\widehat{\Sigma}_{j k}, h_{\Sigma, j k}\right)=\int_{\mathcal{U}} \int_{\mathcal{U}}\left\{\widehat{\Sigma}_{j k}(u, v)-\right.$ $\left.\Sigma_{j k}(u, v)\right\}^{2} \mathrm{~d} u \mathrm{~d} v$. We first calculate the elementwise minimal MISEs for the mean and covariance estimators over the grids of candidate bandwidths in prespecified sets $\mathcal{H}_{\mu}$ and $\mathcal{H}_{\Sigma}$,
respectively. We then compute their averages and maximums over $j \in[p]$ for the mean functions, that is,

and over $(j, k) \in[p]^{2}$ for the covariance functions, that is,
$\operatorname{AveMISE}(\Sigma)=p^{-2} \sum_{j} \sum_{k} \min _{h_{\Sigma, j k}} \operatorname{MISE}\left(\widehat{\Sigma}_{j k}, h_{\Sigma, j k}\right), \quad \operatorname{MaxMISE}(\Sigma)=\max _{j, k} \min _{h_{\Sigma, j k}} \operatorname{MISE}\left(\widehat{\Sigma}_{j k}, h_{\Sigma, j k}\right)$.
We next use the example of estimating the mean functions to illustrate the rationale of the above measures. While AveMISE ( $\mu$ ) presents the averaged elementwise minimal MISEs across $j \in[p]$, some simple calculations in Appendix B show that the attainable quantity of the minimal elementwise maximum of MISEs, $\min _{\left(h_{\mu, 1}, \ldots, h_{\mu, p}\right) \in \mathcal{H}_{\mu}^{p}} \max _{j \in[p]} \operatorname{MISE}\left(\widehat{\mu}_{j}, h_{\mu, j}\right)$, is equal to $\operatorname{MaxMISE}(\mu)$.



Figure 1: Plots of the average MaxMISEs (black) and AveMISEs (red) against $T$ with $p=50$ (solid), 100 (dashed) and 150 (dotted) for the mean estimators (left) and the covariance estimators (right).

We consider settings of $n=100, p=50,100,150$, and $T=5,10,20,40,60,80,100$, $120,140,160$, varying from sparse to semi-dense to ultra-dense measurement schedules. We ran each simulation 100 times. Figure 1 plots the average AveMISEs and MaxMISEs as functions of the sampling frequency $T$ for the estimated mean and covariance functions. A few apparent patterns are observable from Figure 1. First, both MaxMISEs and AveMISEs display a similar trend as $T$ increases from 5 to 160, with a steep decline followed by a slight
decrease and then a period of stability. Such trend roughly corresponds to the three categories of "sparse", "semi-dense" and "ultra-dense", respectively. Second, while AveMISEs reflect the performance for univariate functional data, MaxMISEs gradually enlarges as $p$ increases from 50 to 150 , providing empirical evidence to support that the associated rates in high-dimensional settings all depend on $\log p$-based multiplicative factors. Additionally, it is observable that the high-dimensionlity causes the transition phase between semi-dense and ultra-dense functional data to slightly shift to the left. Third, compared to the results for the estimated mean functions, an increase in $T$ for sparse and semi-dense functional data leads to an enhanced reduction in relative MISEs for the covariance estimators. These observations further validate our established theoretical results in Section 3.

## A Technical proofs

The appendix contains proofs of all theorems. Throughout, we use $c, c_{1}, c_{2}, \ldots$ to denote generic positive finite constants that may be different in different uses.

## A. 1 Proof of Theorem 1

We organize the proof in four steps. First, we will define $\widehat{\mu}(\cdot), \widetilde{\mu}(\cdot)$ and obtain the decomposition of $\widehat{\mu}(\cdot)-\widetilde{\mu}(\cdot)$. Second, we will prove the local concentration inequality for fixed interior point $u \in \mathcal{U}$. Third, we will prove the concentration inequality in $L_{2}$ norm. Finally, we will prove the concentration inequality in supremum norm.

## A.1.1 Definition and decomposition

Without loss of generality, we let $h_{\mu, j}=h$ for $j \in[p]$ and denote $\mathbf{e}_{0}=(1,0)^{\mathrm{T}}, \tilde{\mathbf{U}}_{i j t}=$ $\left\{1,\left(U_{i j t}-u\right) / h\right\}^{\mathrm{T}}$,

& +\left\|\widehat{\mathbf{S}}_{j}(u)\right\|_{\min }^{-1}\left\|E\left\{\widehat{\mathbf{S}}_{j}(u)\right\}\right\|_{\min }^{-1}\left\|\widehat{\mathbf{R}}_{j}(u)\right\|\left\|\widehat{\mathbf{S}}_{j}(u)-E\left\{\widehat{\mathbf{S}}_{j}(u)\right\}\right\|_{\mathbf{F}}
\end{align*}
$$

where, for any vector $\mathbf{b}=\left(b_{1}, \ldots, b_{p}\right)^{\mathrm{T}}$, we write $\|\mathbf{b}\|=\left(\sum_{i} b_{i}^{2}\right)^{1 / 2}$ and, for any matrix $\mathbf{B}=\left(B_{i j}\right)_{p \times q}$, we write $\|\mathbf{B}\|_{\min }=\left\{\lambda_{\min }\left(\mathbf{B}^{\mathrm{T}} \mathbf{B}\right)\right\}^{1 / 2}$ and $\|\mathbf{B}\|_{\mathrm{F}}=\left(\sum_{i, j} B_{i j}^{2}\right)^{1 / 2}$ to denote its Frobenius norm.

For any $\delta>0$, define the event $\Omega_{j, 1}(\delta)=\left\{\sum_{i=1}^{n} \sum_{t=1}^{T_{i j}} K_{h}\left(U_{i j t}-u\right) \leqslant c(1+\delta) n \bar{T}_{\mu, j}\right\}$. We have

$\left|\left(U_{i j t}-u\right)^{a} h^{-a} K_{h}\left(U_{i j t}-u\right)\right|-E\left\{\left|\left(U_{i j t}-u\right)^{a} h^{-a} K_{h}\left(U_{i j t}-u\right)\right|\right\}=0, E\left[\left(n \bar{T}_{j}\right)^{-2}\left\{\left(U_{i j t}-\right.\right.\right.$ $\left.\left.u)^{a} h^{-a} K_{h}\left(U_{i j t}-u\right)\right\}^{2}\right] \leqslant c\left(n \bar{T}_{j}\right)^{-2} h^{-1} \leqslant 1$ for $a=0,1,2$, and Theorem 11.10 of Boucheron et al. (2014) that the variance of $W$ is bounded by $c\left(n \bar{T}_{j} h\right)^{-1}$. Applying Theorem 12.5 of Boucheron et al. (2014) yields that there exists some positive constant $c$ such that, for any $\delta>0$,

By (A.14), we obtain that there exists some constant $c>0$ such that, for any $\delta \in(0,1]$,

On the event $\Omega_{j, 4}=\Omega_{j, 4}\left(\delta_{1}\right)$ with $c\left(n \bar{T}_{j} h\right)^{-1 / 2}<\delta_{1} \leqslant 1,\left\|\widehat{\mathbf{S}}_{j}(u)\right\|_{\text {min }} \geqslant c\left\|\widetilde{\mathbf{S}}_{j}(u)\right\|_{\min } \geqslant$ $c\left(1-\delta_{1} / 2\right) \geqslant c / 2$. Note that $E\left\{\widehat{\mathbf{S}}_{j}(u)\right\}$ is positive definite and $\left\|E\left\{\widehat{\mathbf{R}}_{j}(u)\right\}\right\|$ is uniformly bounded over $\mathcal{U}$. On the event $\Omega_{j, 4}$, it thus follows from (A.2) and $\left\|\hat{\mathbf{R}}_{j}(u)\right\| \leqslant \| \widehat{\mathbf{R}}_{j}(u)-$ $E\left\{\widehat{\mathbf{R}}_{j}(u)\right\}\|+\| E\left\{\widehat{\mathbf{R}}_{j}(u)\right\} \|$ that

Combining (A.15) with (A.3), (A.5) and applying the first part of Lemma 6 in Guo and Qiao (2023) yields that, for any $u \in \mathcal{U}$ and integer $q \geqslant 1$,

Applying the second part of Lemma 6 in Guo and Qiao (2023), we can show that, for each $\delta \in(0,1],(4)$ in Theorem 1 holds, which completes the proof of concentration inequality for the mean estimator in $L_{2}$ norm.

## A.1.4 Concentration inequality in supremum norm

We will derive the uniform concentration bound of $\sup _{u \in \mathcal{U}}\left|\widehat{\mu}_{j}(u)-\widetilde{\mu}_{j}(u)\right|$. We partition the interval $\mathcal{U}=[0,1]$ into $N$ subintervals $I_{s}$ for $s \in[N]$ of equal length. Let $u_{s}$ be the center of $I_{s}$, then we have

We need to bound the second term. By some calculations, it suffices to bound $\mid\left\{\widehat{R}_{j k}(u)-\right.$ $\left.\widehat{R}_{j k}\left(u_{s}\right)\right\}-\left[E\left\{\widehat{R}_{j k}(u)\right\}-E\left\{\widehat{R}_{j k}\left(u_{s}\right)\right\}\right] \mid$ and $\left|\left\{\widehat{S}_{j k l}(u)-\widehat{S}_{j k l}\left(u_{s}\right)\right\}-\left[E\left\{\widehat{S}_{j k l}(u)\right\}-E\left\{\widehat{S}_{j k l}\left(u_{s}\right)\right\}\right]\right|$ for $k, l=1,2$, which means that we need to bound $\left|\widehat{R}_{j k}(u)-\widehat{R}_{j k}\left(u_{s}\right)\right|$ and $\mid \widehat{S}_{j k l}(u)-$ $\widehat{S}_{j k l}\left(u_{s}\right) \mid$. Let $u \in I_{s}$ and consider $\left|\widehat{R}_{j 1}(u)-\widehat{R}_{j 1}\left(u_{s}\right)\right|$ first. Define the event $\Omega_{R, j 1}=$ $\left\{\left|\sum_{i=1}^{n} v_{i j} \sum_{t=1}^{T_{i j}} Y_{i j t}\right| \leqslant E\left(\left|\sum_{i=1}^{n} v_{i j} \sum_{t=1}^{T_{i j}} Y_{i j t}\right|\right)+1\right\}$. On this event, it follows from Assumption 6(ii) that

& \leqslant \frac{c\left|u-u_{s}\right|}{h}\left|\sum_{i=1}^{n} v_{i j} \sum_{t=1}^{T_{i j}} Y_{i j t}\right| \leqslant \frac{c}{N h}\left\{E\left(\left|\sum_{i=1}^{n} v_{i j} \sum_{t=1}^{T_{i j}} Y_{i j t}\right|\right)+1\right\} \leqslant \frac{c}{N h} .
\end{aligned}

Applying similar techniques as above, we can define events $\Omega_{R, j k}$ and $\Omega_{S, j k l}$ for $k, l=1,2$. On the intersection of these events, we can obtain that $\left|\widehat{R}_{j k}(u)-\widehat{R}_{j k}\left(u_{s}\right)\right| \leqslant c(N h)^{-1}$ and $\left|\widehat{S}_{j k l}(u)-\widehat{S}_{j k l}\left(u_{s}\right)\right| \leqslant c(N h)^{-1}$. Combing the above results, we have

By the Bernstein inequality, we have $\operatorname{pr}\left(\Omega_{R, j k}^{\mathrm{c}}\right) \leqslant c \exp (-c n) \leqslant c \exp \left(-c \gamma_{n, T, h, j}\right)$ and $\operatorname{pr}\left(\Omega_{S, j k l}^{\mathrm{c}}\right) \leqslant c \exp (-c n) \leqslant c \exp \left(-c \gamma_{n, T, h, j}\right)$ for $k, l=1,2$. It follows from the above results and the union bound of probability with the choice of $N=c(h \delta)^{-1}$ that there exist some positive constants $c_{1}$ and $c_{2}$ such that, for any $\delta \in(0,1]$,

Take arbitrarily small $\epsilon_{1}>0$. If $n^{\epsilon_{1}} \gamma_{n, T, h, j} \delta^{2} \geqslant 1$, then the right side of (A.16) reduces to $c_{2}\left\{n^{\epsilon_{1}} \gamma_{n, T, h, j}\right\}^{1 / 2} h^{-1} \exp \left(-c_{1} \gamma_{n, T, h, j} \delta^{2}\right)$. If $n^{\epsilon_{1}} \gamma_{n, T, h, j} \delta^{2} \leqslant 1$, we can choose $c_{2}$ and $n^{\epsilon_{1}}>c$ such that $c_{2} \exp \left(-c_{1} c^{-1}\right) \geqslant 1$ and the same bound $c_{1}\left\{n^{\epsilon_{1}} \gamma_{n, T, h, j}\right\}^{1 / 2} h^{-1} \exp \left(-c_{1} \gamma_{n, T, h, j} \delta^{2}\right)$ can therefore still be used. Hence (5) in Theorem 1 holds, which completes the proof of concentration inequality for the mean estimator in supremum norm.

## A. 2 Proofs of Theorem 2

We organize the proof in four steps. First, we will define $\hat{\Sigma}(\cdot, \cdot), \widetilde{\Sigma}(\cdot, \cdot)$ and obtain the decomposition of $\hat{\Sigma}(\cdot, \cdot)-\widetilde{\Sigma}(\cdot, \cdot)$. Second, we will prove the local concentration inequality
for fixed $(u, v) \in \mathcal{U}^{2}$. Third, we will prove the concentration inequality in Hilbert-Schmidt norm. Finally, we will prove the concentration inequality in supremum norm.

& \widehat{\mathbf{Z}}_{j k}(u, v)=\sum_{i=1}^{n} w_{i j k} \sum_{t=1}^{T_{i j}} \sum_{s=1}^{T_{i k}} \tilde{\mathbf{U}}_{i j k t s}(u, v) \Theta_{i j k t s} K_{h}\left(U_{i j t}-u\right) K_{h}\left(U_{i k s}-v\right)

& +\left\|E\left\{\hat{\boldsymbol{\Xi}}_{j k}(u, v)\right\}\right\|_{\min }^{-1}\left\|\hat{\boldsymbol{\Xi}}_{j k}(u, v)\right\|_{\min }^{-1}\| \| \widehat{\mathbf{Z}}_{j k}(u, v)\| \| \hat{\boldsymbol{\Xi}}_{j k}(u, v)-E\left\{\hat{\boldsymbol{\Xi}}_{j k}(u, v)\right\} \|_{\mathrm{F}}
\end{align*}

Note that for each $i$ Assumption 3 implies that $w_{i j k}=\left(n \bar{T}_{j k}^{2}\right)^{-1}$. & \left.\times E\left[\exp \left\{\lambda w_{i j k} \zeta_{i j k t s} \sum_{t=1}^{T_{i j}} \sum_{s=1}^{T_{i k}} K_{h}\left(U_{i j t}-u\right) K_{h}\left(U_{i k s}-v\right) \mid \tilde{V}_{j k}\right\}\right]\right) \\
\leqslant & \exp \left[\frac{c \lambda^{2}\left(n \bar{T}_{j k}^{2}\right)^{-2}\left\{\sum_{t, s} K_{h}\left(U_{i j t}-u\right) K_{h}\left(U_{i k s}-v\right)\right\}^{2}}{1-c \lambda\left(n \bar{T}_{j k}^{2}\right)^{-1} \sum_{t, s} K_{h}\left(U_{i j t}-u\right) K_{h}\left(U_{i k s}-v\right)}\right]
\end{aligned}
$$

where $0<\lambda\left(n \bar{T}_{j k}^{2}\right)^{-1} \sum_{t=1}^{T_{i j}} \sum_{s=1}^{T_{i k}} K_{h}\left(U_{i j t}-u\right) K_{h}\left(U_{i k s}-v\right)<c^{-1}$. It is obvious that the above inequality still holds even if $\sum_{t=1}^{T_{i j}} \sum_{s=1}^{T_{i k}} K_{h}\left(U_{i j t}-u\right) K_{h}\left(U_{i k s}-v\right)=0$. \leqslant & \frac{c\left(\left|u-u_{s}\right| \vee\left|v-v_{s^{\prime}}\right|\right)}{h}\left|\sum_{i=1}^{n} w_{i j k} \sum_{t=1}^{T_{i j}} \sum_{t^{\prime}=1}^{T_{i k}} \Theta_{i j k t t^{\prime}}\left\{K_{h}\left(U_{i k t^{\prime}}-v\right)+K_{h}\left(U_{i j t}-u_{s}\right)\right\}\right| \\
\leqslant & \frac{c}{N h}\left\{E\left(\left|\sum_{i=1}^{n} w_{i j k} \sum_{t=1}^{T_{i j}} \sum_{t^{\prime}=1}^{T_{i k}} \Theta_{i j k t t^{\prime}}\right|\right)+1\right\} \leqslant \frac{c}{N h} .
\end{aligned}
$$

Applying similar techniques as above, we can define events $\Lambda_{Z, j k m}$ and $\Lambda_{\Xi, j k m l}$ for $m, l=$ $1,2,3$. On the intersection of these events, we can obtain that $\left|\hat{Z}_{j k m}(u, v)-\widehat{Z}_{j k m}\left(u_{s}, v_{s^{\prime}}\right)\right| \leqslant$ $c(N h)^{-1}$ and $\left|\hat{\Xi}_{j k m l}(u, v)-\hat{\Xi}_{j k m l}\left(u_{s}, v_{s^{\prime}}\right)\right| \leqslant c(N h)^{-1}$. Combing the above results, we have

It follows from the above results and the union bound of probability with the choice of $N=c(h \delta)^{-1}$ that there exists some positive constants $c_{3}$ and $c_{4}$ such that, for any $\delta \in(0,1]$,

If $n^{\epsilon_{2}} \nu_{n, T, h, j k} \delta^{2} \geqslant 1$, the right side of (A.32) reduces to $c_{4} n^{\epsilon_{2}} \nu_{n, T, h, j k} h^{-2} \exp \left(-c_{3} \nu_{n, T, h, j k} \delta^{2}\right)$. If $n^{\epsilon_{2}} \nu_{n, T, h, j k} \delta^{2} \leqslant 1$, we can choose $c_{4}$ and $n^{\epsilon_{2}}>c$ such that $c_{4} \exp \left(-c_{3} c^{-1}\right) \geqslant 1$ and hence the same bound $c_{4} n^{\epsilon_{2}} \nu_{n, T, h, j k} h^{-2} \exp \left(-c_{3} \nu_{n, T, h, j k} \delta^{2}\right)$ can still be used. We complete the proof of (7) in Theorem 2, the concentration inequality for the covariance estimator in supremum norm.

Under the dense design with $\bar{T}_{\mu}\{\log (p \vee n) / n\}^{1 / 4} \rightarrow 0$, the rate is at least $\{\log (p \vee n) / n\}^{1 / 4} \bar{T}_{\mu}^{-1 / 2}$, which is slower than $\{\log (p \vee n) / n\}^{2 / 5} \bar{T}_{\mu}^{-2 / 5}$ with $\kappa_{1} \in(1 / 5,1 / 4)$. Under the dense design with $\bar{T}_{\mu}\{\log (p \vee n) / n\}^{1 / 4} \rightarrow \tilde{c}$ or $\infty$, the rate is at least $\{\log (p \vee n) / n\}^{1 / 4} \bar{T}_{\mu}^{-1 / 2}$, which is slower than $\{\log (p \vee n) / n\}^{1 / 2}$ with $\kappa_{1} \in(1 / 4,1 / 2)$. Based on the above three cases, if $\kappa_{1}>1 / 2$, the corresponding rate is slower than that with some $\kappa_{1} \in(0,1 / 2]$ and hence the $\kappa_{1}$ that corresponds with the optimal bandwidth under sparse or dense design is in $(0,1 / 2]$. For $M>0$ with the choice of $\delta=\{\log (p \vee n)\}^{1 / 2}\left(\min _{j} \gamma_{n, T, h, j}\right)^{-1 / 2} M \leqslant 1$, by the union bound

For $M>0$ with the choice of $\delta=(\log p)^{1 / 2}\left(\min _{j, k} \nu_{n, T, h, j k}\right)^{-1 / 2} M \leqslant 1$, it follows from the union bound of probability and (6) in Theorem 2 that

$$
\begin{align*}
& \operatorname{pr}\left\{\frac{\max _{j, k \in[p]}\left\|\widehat{\Sigma}_{j k}-\widetilde{\Sigma}_{j k}\right\|_{\mathcal{S}}}{(\log p)^{1 / 2}\left(\min _{j, k} \nu_{n, T, h, j k}\right)^{-1 / 2}} \geqslant M\right\} \\
\leqslant & \sum_{j=1}^{p} \sum_{k=1}^{p} \operatorname{pr}\left\{\left\|\widehat{\Sigma}_{j k}-\widetilde{\Sigma}_{j k}\right\|_{\mathcal{S}} \geqslant M(\log p)^{1 / 2}\left(\min _{j, k} \nu_{n, T, h, j k}\right)^{-1 / 2}\right\}  \tag{A.37}\\
\leqslant & \sum_{j=1}^{p} \sum_{k=1}^{p} c \exp \left(-c \nu_{n, T, h, j k} M^{2} \frac{\log p}{\min _{j, k} \nu_{n, T, h, j k}}\right) \leqslant c \exp \left\{\left(2-c M^{2}\right) \log p\right\} .
\end{align*}
$$

We can choose a large $M$ such that $2-c M^{2}<0$, the right-side of (A.37) tends to 0 . Hence $\max _{j, k \in[p]}\left\|\widehat{\Sigma}_{j k}-\widetilde{\Sigma}_{j k}\right\|_{\mathcal{S}}=O_{P}\left\{(\log p)^{1 / 2}\left(\min _{j, k} \nu_{n, T, h, j k}\right)^{-1 / 2}\right\}$. Combing this with (A.36) yields that

$$
\max _{j, k \in[p]}\left\|\widehat{\Sigma}_{j k}-\Sigma_{j k}\right\|_{\mathcal{S}}=O_{P}\left\{\left(\frac{\log p}{\min _{j, k} \nu_{n, T, h, j k}}\right)^{1 / 2}+\max _{j, k} h_{\Sigma, j k}^{2}\right\} .
$$

which completes the proof of (10).
The rate of convergence in (11) can be proved following the similar procedure. Let $h_{\Sigma, \min }=\min _{j, k} h_{\Sigma, j k}$, we can assume that $h_{\Sigma, \text { min }}=\{\log (p \vee n) / n\}^{\kappa_{2}}$ where $\kappa_{2} \in(0,1 / 2]$. Consider $h_{\Sigma, \text { min }}$ with $\kappa_{2}>1 / 2$, the corresponding rate is slower than that with some $\kappa_{2} \in(0,1 / 2]$. Specifically, under the sparse design, the rate of $\max _{j, k \in[p]} \sup _{(u, v) \in \mathcal{U}^{2}}\left|\widehat{\Sigma}_{j k}(u, v)-\Sigma_{j k}(u, v)\right|$ is at least 1 , which is slower than $\{\log (p \vee n) / n\}^{1 / 3}$ with $\kappa_{2}=1 / 6$. Under the dense design with $\bar{T}_{\Sigma}\{\log (p \vee n) / n\}^{1 / 4} \rightarrow 0$, the rate is at least $\bar{T}_{\Sigma}^{-1}$, which is slower than $\{\log (p \vee n) / n\}^{1 / 3} \bar{T}_{\Sigma}^{-1 / 3}$ with $\kappa_{2} \in(1 / 6,1 / 4)$. Under the dense design with $\bar{T}_{\Sigma}\{\log (p \vee n) / n\}^{1 / 4} \rightarrow \widetilde{c}$ or $\infty$, the rate is at least $\bar{T}_{\Sigma}^{-1}$, which is slower than $\{\log (p \vee n) / n\}^{1 / 2}$ with $\kappa_{2} \in(1 / 4,1 / 2)$. Based on the above three cases, if $\kappa_{2}>1 / 2$, the corresponding rate is slower than that with some $\kappa_{2} \in(0,1 / 2]$ and hence $\kappa_{2}$ that corresponds with the optimal bandwidth under sparse or dense design is in $(0,1 / 2]$. For $M>0$ with the choice of $\delta=\{\log (p \vee n)\}^{1 / 2}\left(\min _{j} \gamma_{n, T, h, j}\right)^{-1 / 2} M \leqslant 1$, by
the union bound of probability and (7) in Theorem 2, we have

$$
\begin{aligned}
& \operatorname{pr}\left\{\frac{\max _{j, k \in[p]} \sup _{(u, v) \in \mathcal{U}^{2}}\left|\hat{\Sigma}_{j k}(u, v)-\widetilde{\Sigma}_{j k}(u, v)\right|}{\log (p \vee n)^{1 / 2}\left(\min _{j, k} \nu_{n, T, h, j k}\right)^{-1 / 2}} \geqslant M\right\} \\
\leqslant & \sum_{j=1}^{p} \sum_{k=1}^{p} \operatorname{pr}^{p}\left\{\sup _{(u, v) \in \mathcal{U}^{2}}\left|\widehat{\Sigma}_{j k}(u, v)-\widetilde{\Sigma}_{j k}(u, v)\right| \geqslant M\{\log (p \vee n)\}^{1 / 2}\left(\min _{j, k} \nu_{n, T, h, j k}\right)^{-1 / 2}\right\} \\
\leqslant & \sum_{j=1}^{p} \sum_{k=1}^{p} \frac{c n^{\epsilon} \nu_{2} \nu_{n, T, h, j k}}{h_{\Sigma, \min }^{2}} \exp \left\{-c \nu_{n, T, h, j k} M^{2} \frac{\log (p \vee n)}{\min _{j, k} \nu_{n, T, h, j k}}\right\} \\
\leqslant & c \exp \left\{\left(3+\epsilon_{2}+2 \kappa_{2}-c M^{2}\right) \log (p \vee n)\right\} .
\end{aligned}
$$

We can choose a large $M$ such that $3+\epsilon_{2}+2 \kappa_{2}-c M^{2}<0$, the right-side of the above inequality tends to 0 . Hence

$$
\max _{j, k \in[p]} \sup _{(u, v) \in \mathcal{U}^{2}}\left|\widehat{\Sigma}_{j k}(u, v)-\widetilde{\Sigma}_{j k}(u, v)\right|=O_{P}\left\{\log (p \vee n)^{1 / 2}\left(\min _{j, k} \nu_{n, T, h, j k}\right)^{-1 / 2}\right\} .
$$

Combing this with (A.36) yields that

$$
\max _{j, k \in[p]} \sup _{(u, v) \in \mathcal{U}^{2}}\left|\widehat{\Sigma}_{j k}(u, v)-\Sigma_{j k}(u, v)\right|=O_{P}\left[\left\{\frac{\log (p \vee n)}{\min _{j, k} \nu_{n, T, h, j k}}\right\}^{1 / 2}+\max _{j, k} h_{\Sigma, j k}^{2}\right] .
$$

which completes the proof of (11).

## B Verification of the claim in Section 4

For the mean estimator, define the set of $r$ candidate bandwidths $\mathcal{H}_{\mu}=\left\{h_{\mu}^{(1)}, \ldots, h_{\mu}^{(r)}\right\}$. In our simulations, the bandwidth for each dimension can be chosen from $\mathcal{H}_{\mu}$ freely and hence there are $r^{p}$ possible outcomes. The targeted evaluation metric is global ${ }_{\mathrm{opt}}=$ $\min _{\left(m_{1}, \ldots, m_{p}\right) \in[r]^{p}} \max _{j \in[p]} \operatorname{MISE}\left(\widehat{\mu}_{j}, h_{\mu}^{\left(m_{j}\right)}\right)$. We will show that $\operatorname{global}_{\text {opt }}=\operatorname{MaxMISE}(\mu)$, the right side of which is much easier to calculate as it only takes into account pr cases. On one hand, it is obvious that global ${ }_{\text {opt }} \leqslant \operatorname{Max} \operatorname{MISE}(\mu)$. On the other hand, for fixed $\left(j, m_{j}\right) \in[p] \times[r], \operatorname{MISE}\left(\widehat{\mu}_{j}, h_{\mu}^{\left(m_{j}\right)}\right) \geqslant \min _{m \in[r]} \operatorname{MISE}\left(\widehat{\mu}_{j}, h_{\mu}^{(m)}\right)$, and hence global ${ }_{\text {opt }} \geqslant$

$$
\min _{\left(m_{1}, \ldots, m_{p}\right) \in[r]^{p}} \max _{j \in[p]} \min _{m \in[r]} \operatorname{MISE}\left(\widehat{\mu}_{j}, h_{\mu}^{(m)}\right)=\max _{j \in[p]} \min _{m \in[r]} \operatorname{MISE}\left(\hat{\mu}_{j}, h_{\mu}^{(m)}\right)=\operatorname{MaxMISE}(\mu)
$$

Combining the above results yields global ${ }_{\text {opt }}=\operatorname{MaxMISE}(\mu)$. The corresponding claim for the covariance estimator can be verified in the same way.
