# Global existence and uniqueness of strong solutions to the 2D nonhomogeneous primitive equations with density-dependent viscosity

**Abstract:** This paper is concerned with an initial-boundary value problem of the twodimensional inhomogeneous primitive equations with density-dependent viscosity. The global well-posedness of strong solutions is established, provided the initial horizontal velocity is suitably small, that is,  $\|\nabla u_0\|_{L^2} \leq \eta_0$  for suitably small  $\eta_0 > 0$ . The initial data may contain vacuum. The proof is based on the local well-posedness and the blow-up criterion proved in [15], which states that if  $T^*$  is the maximal existence time of the local strong solutions  $(\rho, u, w, P)$ and  $T^* < \infty$ , then

$$\sup_{0 \le t < T^*} (\|\nabla \rho(t)\|_{L^{\infty}} + \|\nabla^2 \rho(t)\|_{L^2} + \|\nabla u(t)\|_{L^2}) = \infty.$$

To complete the proof, it is required to make an estimate on a key term  $\|\nabla u_t\|_{L^1_t L^2_\Omega}$ . We prove that it is bounded and could be as small as desired under certain smallness conditions, by making use of the regularity result of hydrostatic Stokes equations and some careful time weighted estimates.

**Key Words:** Nonhomogeneous primitive equations; Global well-posedness; Density-dependent viscosity

## 1 Introduction

In this paper, we consider the global existence and uniqueness of strong solutions to the

nonhomogeneous primitive equations in  $\mathbb{R}^2$ , which read as

$$\begin{cases}
\rho_t + \partial_x(\rho u) + \partial_y(\rho w) = 0, \\
\partial_t(\rho u) + \partial_x(\rho u^2) + \partial_y(\rho u w) + \partial_x P - \partial_x(\mu(\rho)\partial_x u) - \partial_y(\mu(\rho)\partial_y u) = 0, \\
\partial_x u + \partial_y w = 0, \\
\partial_y P = 0,
\end{cases} (1.1)$$

where the density  $\rho$ , the horizontal velocity u, the vertical velocity w and the pressure P are the unknown functions. The viscosity coefficient  $\mu = \mu(\rho)$  is a function of the density  $\rho$  and assumed to satisfy

$$\mu(\rho) \in C^2[0,\infty) \quad \text{and} \quad \mu(\rho) \ge \mu > 0 \quad \text{on} \quad [0,\infty).$$
 (1.2)

The primitive equations are based on the so called hydrostatic approximation, and they form a fundamental block in models for planetary oceanic and atmospheric dynamics (see, for example, Pedlosky [29] and Vallis [34]). As far as we know, it was essentially introduced by Richardson in [30], to study the complicated atmospheric phenomena and for predicting the weather and possible climate changes. Until 1990s, the mathematical studies of primitive equations were initiated by Lions, Temam and Wang in [21]-[23], and they established the global existence of weak solutions to the system for the initial data  $a \in L^2$ ; The uniqueness of weak solutions for the two-dimensional case was later proved by Bresch, Kazhikjov and Lemoine [1] for initial data a with  $\partial_z a \in L^2$  and by Kukavica, Pei, Rusin and Ziane [18] for the initial data which is only continuous on the space variables. However, the uniqueness of these weak solutions for the threedimensional case is still unclear. Concerning the strong solutions, the local existence results to the 2D primitive equations were proved by Guill-Gonzez, Masmoudi and Rodruez-Bellido in [12], while the global existence and uniqueness of strong solutions for the 2D primitive equations was achieved by Bresch, Kazhikhov and Lemoine in [1] and Temam and Ziane in [32]. The global existence of strong solutions for the 3D incompressible primitive equations has been known since the breakthrough work by Cao and Titi [6], see also Kobelkov [17] and Kukavica and Ziane [19]-[20]. In the partial viscosities and partial diffusivity case, one can see the works by Cao and Titi in [7] and by Cao, Li and Titi in [2]-[5]. However, the above-mentioned results are phrased within the  $L^2$ -setting. Based on the maximal regularity technique, Hieber and kashiwabara [13] and Giga, Gries, Hieber, Hussein and kashiwabara [10]-[11] gave the existing results in the  $L^p$ type spaces.

In recent years, the mathematical analysis of compressible primitive equations has been attracting the attention of many mathematicians. Gatapov and Kazhikhov firstly studied in [9] and they proved the global existence of weak solutions to the 2D compressible primitive equations. The uniqueness of such weak solutions was proved by Jiu, Li and Wang in [14]. Ersoy, Ngom and Sy [8] derived the 3D compressible primitive equations and obtained the stability of weak solutions to the 3D compressible primitive equations with degenerate viscosity (see also Tang and Gao [33] for 2D case). Recently, Wang, Dou and Jiu [36] established the global existence of weak solutions to 3D compressible primitive equations with gravity field. The similar result is referred to Liu and Titi [26]. However, the uniqueness of these weak solutions for 3D case is still an open problem. Moreover, Liu and Titi [25] established local well-posedness results in the three-dimensional case. Meanwhile, they also considered the zero Mach number limit of compressible primitive equations in [24] and [27]. From the point of view of physics, the viscosity may depend on the density. Wang [35] established the local existence and uniqueness of strong solutions to the 2D compressible primitive equations with density-dependent viscosity.

Very recently, Wang and Jiu [38] proved the global existence and uniqueness of strong solutions to the 2D compressible primitive equations with density-dependent viscosity.

In this paper, we consider the nonhomogeneous primitive equations (1.1) in the domain  $\Omega = M \times (0,1)$ , with M = (0,L), where L > 0. We complement the system (1.1) with boundary conditions and initial conditions as follows.

and

$$u|_{t=0} = u_0(x, y),$$

Throughout this paper, we define the following function spaces:

$$V = \{v \in H^1(\Omega); \partial_y v = 0\},$$
  
$$H^1_{0,per}(\Omega) = \{v \in H^1(\Omega); \partial_x \int_0^1 v(x,y) dy = 0, \ v|_{y=0,1} = 0, \ v(0,y) = v(L,y)\}.$$

The nonhomogeneous primitive equations, as the intermediate equations between incompressible primitive equations and compressible primitive equations, were firstly studied by Jiu and Wang in [16], and they proposed the following compatibility condition:

$$\mu \Delta u_0 - \partial_x P_0 = \rho_0^{\frac{1}{2}} g(x, z)$$
 in  $\Omega$  and  $\partial_x \int_0^1 u_0 dz = 0$ , for some  $(P_0, g) \in V \times L^2$ 

and established the local existence and uniqueness of strong solutions to the 2D nonhomogeneous primitive equations with large data. Furthermore, Wang, Jiu and Xu [37] obtained an global existence result on strong solutions to the 2D nonhomogeneous primitive equations for initial data with small  $H^{\frac{1}{2}}$ -norm. Recently, for the case that the viscosity coefficient depends on the density, Jiu, Ma and Wang [15] established the local-in-time well-posedness of strong solutions to the 2D nonhomogeneous primitive equations (1.1), which is listed as follows.

**Theorem 1.1** Suppose that the initial data  $(\rho_0, u_0)$  satisfies the regularity conditions

$$0 \le \rho_0 \in W^{2,2}(\Omega), \ \nabla \rho_0 \in L^{\infty}, \ u_0 \in H^1_{0,ner}(\Omega) \cap H^2(\Omega)$$
 (1.5)

and the compatibility condition

$$-\rho_0 u_0 \partial_x u_0 + \rho_0 \int_0^y \partial_x u_0(s) ds \partial_y u_0 - \partial_x P_0 + \partial_x (\mu(\rho_0) \partial_x u_0) + \partial_y (\mu(\rho_0) \partial_y u_0) := \rho_0 V_1,$$

$$\partial_x \int_0^1 u_0(x, y) dy = 0,$$
(1.6)

for some  $(P_0, V_1) \in V \times L^2$ . Then there exists a small time  $T_* \in (0, T)$ , such that the initial boundary value problem (1.1)-(1.4) has a unique strong solution  $(\rho, u, w, P)$  satisfying

$$\rho \geq 0, \ \rho \in C([0, T_*]; W^{1, \infty}) \cap C([0, T_*]; W^{2, 2}), \ \rho_t \in C([0, T_*]; L^q), \ \sqrt{\rho} u_t \in L^{\infty}(0, T_*; L^2), 
P \in C([0, T_*]; H^1) \cap L^2(0, T_*; H^2), \ \nabla u \in C([0, T_*]; H^1) \cap L^2(0, T_*; H^2), 
u_t \in L^2(0, T_*; H^1_{0, per}), \ w \in C([0, T_*]; H^1) \cap L^2(0, T_*; H^2),$$
(1.7)

where  $1 \leq q < \infty$ . Furthermore, if  $T^*$  is the maximal existence time of the local strong solutions  $(\rho, u, w, P)$ , then

$$\sup_{t \in [0, T^*]} (\|\nabla \rho(t)\|_{L^{\infty}} + \|\nabla^2 \rho(t)\|_{L^2} + \|\nabla u(t)\|_{L^2}) = \infty.$$
(1.8)

However, up to now, the global existence and uniqueness of strong solutions to the 2D nonhomogeneous primitive equations is open. The main purpose of this paper is to establish the global well-posedness of strong solutions to the problem (1.1)-(1.4) with small initial data in some sense. Our main result can be stated as

**Theorem 1.2** Suppose that the initial data  $(\rho_0, u_0, P_0)$  satisfies the conditions in Theorem1.1. Then there exists a small positive constant  $\eta_0$ , depending on  $\Omega$ ,  $\sup_{\Omega} \rho_0 = \bar{\rho}$ ,  $\|\mu(\rho)\|_{C^2}$ ,  $\|\nabla \rho_0\|_{L^{\infty}}$  and  $\|\nabla^2 \rho_0\|_{L^2}$ , such that if

$$\|\nabla u_0\|_{L^2} \le \eta_0,$$

then the initial boundary value problem (1.1)-(1.4) admits a unique global strong solution  $(\rho, u, w, P)$  with

$$\rho \ge 0, \ \rho \in C(0,\infty; W^{1,\infty}) \cap C(0,\infty; W^{2,2}), \ \rho_t \in C(0,\infty; L^q), \ \sqrt{\rho}u_t \in L^{\infty}(0,\infty; L^2), 
P \in C(0,\infty; H^1) \cap L^2(0,\infty; H^2), \ \nabla u \in C(0,\infty; H^1) \cap L^2(0,\infty; H^2) 
u_t \in L^2(0,\infty; H_0^1_{ner}), \ w \in C(0,\infty; H^1) \cap L^2(0,\infty; H^2).$$
(1.9)

Moveover, the following decay property holds

$$\|\sqrt{\rho}u_t\|_{L^2}^2 \le C(\Omega, \|\mu\|_{C^1}, \bar{\rho}, \|\nabla\rho_0\|_{L^\infty}, \|\nabla^2\rho_0\|_{L^2})\|\nabla u_0\|_{L^2}^2 t^{-2}, \tag{1.10}$$

and

$$\|\nabla u\|_{L^2}^2 \le C(\Omega, \|\mu\|_{C^1})(1 + \frac{\overline{\rho}}{\|\rho_0\|_{L^p}})e^{-\sigma t},\tag{1.11}$$

where  $\sigma = \frac{\mu}{\|\rho_0\|_{L^p}}$  for any p > 1.

Based on the result in [15], we apply the continuity method to establish the global well-posedeness of strong solutions to (1.1)-(1.4). It was shown in [15] that if  $T^*$  is the maximal existence time of the local strong solutions  $(\rho, u, w, P)$  and  $T^* < T$ , then

$$\sup_{0 \le t \le T^*} (\|\nabla \rho(t)\|_{L^{\infty}} + \|\nabla^2 \rho(t)\|_{L^2} + \|\nabla u(t)\|_{L^2}) = \infty,$$

which implies that the proof of global existence relies on the estimates on the gradient of horizontal velocity and the one-order and two-order derivative of the density. We start with the a priori hypothesises  $\|\nabla\rho\|_{L^{\infty}} + \|\nabla^2\rho\|_{L^2} \le 8(\|\nabla\rho_0\|_{L^{\infty}} + \|\nabla^2\rho_0\|_{L^2})$  and  $\|\nabla u\|_{L^2}^2 \le 4\frac{\bar{\mu}}{\mu}\|\nabla u_0\|_{L^2}^2$ , where  $\bar{\mu} = \sup_{[0,\bar{\rho}]} \mu(\rho)$ . Then we prove that  $\|\nabla\rho\|_{L^{\infty}} + \|\nabla^2\rho\|_{L^2}$  is less than  $4(\|\nabla\rho_0\|_{L^{\infty}} + \|\nabla^2\rho_0\|_{L^2})$  and  $\|\nabla u\|_{L^2}^2$  is less than  $(2\ln 2 + 1)\frac{\bar{\mu}}{\mu}\|\nabla u_0\|_{L^2}^2$  on [0,T] with the assumption  $\|\nabla u_0\|_{L^2}$  is suitably small. In fact, by making use of the regularity result of hydrostatic Stokes equations (see Lemma 3.3), it is easy to obtain the desired bound of  $\|\nabla u\|_{L^2}$  under the assumption that  $\|\nabla u_0\|_{L^2}$  is suitably small (see Lemma 3.2). Then, the next key step is to show that  $\|\nabla\rho\|_{L^{\infty}} + \|\nabla^2\rho\|_{L^2}$  is less than  $4(\|\nabla\rho_0\|_{L^{\infty}} + \|\nabla^2\rho_0\|_{L^2})$ . To do this, it suffices to deal with a trouble term  $\|\nabla u_t\|_{L_t^1 L_\Omega^2}$  which appears when estimating the term  $\|u\|_{L_t^1 H_\Omega^3}$  (see Lemma 3.8). Indeed, based on the regularity result of hydrostatic Stokes equations and some careful time weighted estimates, we find

that the norm of  $\|\nabla u_t\|_{L_t^1 L_\Omega^2}$  is bounded and could be as small as desired under certain smallness conditions. More precisely, we split it into two terms

$$\int_{0}^{T_{*}} \|\nabla u_{t}\|_{L^{2}} dt \leq \left(\int_{0}^{T^{0}} \|\nabla u_{t}\|_{L^{2}}^{2} dt\right)^{\frac{1}{2}} \sqrt{T^{0}} + \left(\int_{T^{0}}^{T_{*}} t^{2} \|\nabla u_{t}\|_{L^{2}}^{2} dt\right)^{\frac{1}{2}} \left(\int_{T^{0}}^{T_{*}} t^{-2} dt\right)^{\frac{1}{2}}, \tag{1.12}$$

where  $T^0$  is a small enough number independent on the norm of  $\|\nabla u_0\|_{L^2}$ . We remark that the local time  $T_*$  might depend on  $\|\nabla u_0\|_{L^2}$  (see [15]). We can consider the local existence of the strong solutions under the additional assumption of  $\|\nabla u_0\|_{L^2} \leq 1$  such that the local time  $T_*$  we obtain is independent on the norm of  $\|\nabla u_0\|_{L^2}$  (see Lemma 2.4). Therefore, we can choose some small  $T_0$  independent on the norm of  $\|\nabla u_0\|_{L^2}$  such that the first term of (1.12) is small enough. Meanwhile, the second term of (1.12) can be controlled by the time weighted estimates (see (3.26) for more details). Then, it follows that  $\int_0^T \|u\|_{H^3} dt \leq \ln 2$  under the assumption that  $\|\nabla u_0\|_{L^2}$  is suitably small. As a result, the control of  $\|\nabla \rho\|_{L^\infty} + \|\nabla^2 \rho\|_{L^2}$  and  $\|\nabla u\|_{L^2}$  lead to uniform estimates for other higher order quantities, which guarantees the extension of local strong solutions.

The rest of this paper is organized as follows. In Section 2, we recall some lemmas and give an auxiliary lemma which is used later. In Section 3, we give an outline of the proof of the main Theorem.

The following notations will be used:

- (1)  $||f||_{L^2_y} = (\int_0^1 |f|^2 dy)^{\frac{1}{2}},$
- (2)  $||f||_{L_y^2 L_x^{\infty}} = (\int_0^1 ||f||_{L_x^{\infty}}^2 dy)^{\frac{1}{2}}, ||f||_{L_y^{\infty} L_x^{\infty}} = \operatorname{esssup}_{(x,y) \in \Omega} |f|,$
- (3) For  $1 , <math>||f||_{L^p} = ||f||_{L^p_y L^p_x} = ||f||_{L^p_x L^p_y} = \left(\int_0^1 \int_0^L |f|^p dx dy\right)^{\frac{1}{p}}$ ,
- $(4) \int_{\Omega} = \int_{\Omega} dx dy.$

## 2 Preliminaries

In this section, we recall some basic facts and elementary inequalities which will be used later. First of all, we present the well-known Gagliardo-Nirenberg interpolation inequality.

**Lemma 2.1** (see [28])(Gagliardo-Nirenberg interpolation inequality). For a function  $u: \Omega \to \mathbb{R}$  defined on a bounded Lipschitz domain  $\Omega \subset \mathbb{R}^n, \forall \ 1 \leq q,r \leq \infty$ , and a natural number m. Suppose also that a real number  $\theta$  and a natural number j are such that

$$\frac{1}{p} = \frac{j}{n} + \left(\frac{1}{r} - \frac{m}{n}\right)\theta + \frac{1-\theta}{q},$$

and

$$\frac{j}{m} \le \theta \le 1.$$

Then, we have

$$||D^{j}u||_{L^{p}} \leq C_{1} ||D^{m}u||_{L^{r}}^{\theta} ||u||_{L^{q}}^{1-\theta} + C_{2}||u||_{L^{s}},$$

where s is a positive constant. The constants  $C_1$  and  $C_2$  depend on the domain  $\Omega$  and  $m, n, j, r, q, \theta$ .

The derivations of high-order estimates on the horizontal velocity u rely on the following regularity results for the density-dependent hydrostatic Stokes equations.

**Lemma 2.2** Assume that  $\rho \in W^{2,2}$ ,  $\nabla \rho \in L^{\infty}$  and  $0 \leq \rho \leq \bar{\rho}$ , let  $(u, P) \in H^1_{0,per} \times L^2$  be the unique weak solution to the problem

$$-\partial_x(\mu(\rho)\partial_x u) - \partial_y(\mu(\rho)\partial_y u) + \partial_x P = f, \quad \partial_x \int_0^1 u(x,y)dy = 0, \quad \int_\Omega P dx dy = 0.$$
 (2.1)

Then we have the following regularity results:

(1) If  $f \in L^2$ , then  $(u, P) \in H^2 \times H^1$  and

$$||u||_{H^2} + ||P||_{H^1} \le C (1 + ||\nabla \rho||_{L^{\infty}}) ||f||_{L^2}.$$

(2) If  $f \in L^r$ , then  $(u, P) \in W^{2,r} \times W^{1,r}$  and

$$||u||_{W^{2,r}} + ||P||_{W^{1,r}} \le C(1 + ||\nabla \rho||_{L^{\infty}})^2 ||f||_{L^r}, \tag{2.2}$$

where r > 2.

(3) If  $f \in H^1$ , then  $(u, P) \in H^3 \times H^2$  and

$$||u||_{H^3} + ||P||_{H^2} \le \widetilde{C}(1 + ||\nabla \rho||_{L^{\infty}} + ||\nabla^2 \rho||_{L^2})^3 ||f||_{H^1}, \tag{2.3}$$

the constant  $\widetilde{C}$  depend also on  $\|\partial^2 \mu/\partial x^2\|_C$ .

**Lemma 2.3** Assume that  $u \in L^1([0,T],H^3(\Omega))$ , let  $\rho$  be the unique solution to the problem

$$\partial_t \rho + \partial_x \rho u - \partial_y \rho \int_0^y \partial_x u(s) ds, \ \rho|_{t=0} = \rho_0.$$

If  $\nabla \rho_0 \in L^{\infty}(\Omega)$  and  $\rho_0 \in W^{2,2}(\Omega)$ , then we have the following regularity results:

$$\|\nabla \rho(t)\|_{L^{\infty}(\Omega)} \le \|\nabla \rho_0\|_{L^{\infty}(\Omega)} \exp(\int_0^t \|u(s)\|_{H^3(\Omega)} ds),$$
 (2.4)

and

$$\|\nabla^{2}\rho(t)\|_{L^{2}(\Omega)} \leq (\|\nabla\rho_{0}\|_{L^{\infty}(\Omega)} + \|\nabla^{2}\rho_{0}\|_{L^{2}(\Omega)}) \exp \int_{0}^{t} \|u(s)\|_{H^{3}(\Omega)} ds. \tag{2.5}$$

The proof of (2.4) and (2.5) is referred to [15] and we omit it here.

As aforementioned, the global existence and uniqueness of strong solutions will be proved by combining the global a priori estimates in section 3 with the following local-in-time existence results which can follow as a corollary of Theorem 1.1 in [15].

**Lemma 2.4** Suppose that the initial data  $(\rho_0, u_0, P_0)$  satisfies the regularity conditions in Theorem 1.1 and the additional condition  $\|\nabla u_0\|_{L^2}^2 \leq 1$ . Then there exists a small time  $T_* \in (0,T)$  such that the initial boundary value problem (1.1)-(1.4) has a unique strong solution  $(\rho, u, w, P)$  satisfying

$$\begin{split} \rho &\in C([0,T_*];W^{1,\infty}) \cap C([0,T_*];W^{2,2}), \ \rho_t \in C([0,T_*];L^q), \ \sqrt{\rho}u_t \in L^\infty(0,T_*;L^2), \\ P &\in C([0,T_*];H^1) \cap L^2(0,T_*;H^2), \ \nabla u \in C([0,T_*];H^1) \cap L^2(0,T_*;H^2), \\ u_t &\in L^2(0,T_*;H^1_{0,per}), \ w \in C([0,T_*];H^1) \cap L^2(0,T_*;H^2), \end{split}$$

where  $1 \leq q < \infty$  and  $T_*$  is independent on the norm of  $\|\nabla u_0\|_{L^2}$ .

#### 3 Proof of Theorem 1.2

This section is devoted to the proof of Theorem 1.2. Indeed, we follow the idea in [15] and first prove the estimates for the case of a positive initial density and obtain the uniform bounds which are independent of the lower bounds of the initial density. Then the vacuum case can be proved by applying standard regularizing techniques and compactness arguments.

#### 3.1 A priori estimates

In this subsection, we establish several a priori estimates for strong solutions to the system (1.1)-(1.4), which will play a key role in extending local strong solutions to the global ones. For simplicity, throughout this subsection, a constant C will denote some positive one which may be dependent on  $\Omega$  and  $\|\mu\|_{C_1}$ , but is independent of  $\rho_0$  and  $u_0$ , and  $\tilde{C}$  depends on C and  $\|\partial^2\mu/\partial x^2\|_{C}$ . We remark that the value of the constant C will be different from line to line.

We begin with the boundedness of density and the basic energy estimates, which can be easily derived from the system (1.1).

**Lemma 3.1** Assume that  $(\rho, u, w, P)$  is the unique strong solution to the system (1.1)-(1.4) on  $\Omega \times (0,T)$  with the initial data satisfying the assumptions in Theorem 1.1. Then, for every  $(x,y,t) \in \Omega \times (0,T)$ , it holds that

$$\|\rho\|_{L^{\infty}} = \|\rho_0\|_{L^{\infty}},$$

and

$$\int_{\Omega} \rho \frac{1}{2} u^2(t) + \int_0^t \int_{\Omega} \mu(\rho) |\nabla u|^2 ds \le \frac{1}{2} \bar{\rho} ||u_0||_{L^2}^2, \tag{3.1}$$

which yields

$$\frac{1}{2} \int_{\Omega} \rho u^{2}(t) + \underline{\mu} \int_{0}^{t} \int_{\Omega} |\nabla u|^{2} ds \le \frac{1}{2} \bar{\rho} ||u_{0}||_{L^{2}}^{2}. \tag{3.2}$$

The next lemma is concerned with the  $L^2$ -norm of the gradient of horizontal velocity. Before sate and prove it, we denote

$$M_0 := \|\nabla \rho_0\|_{L^{\infty}} + \|\nabla^2 \rho_0\|_{L^2}.$$

**Lemma 3.2** Assume that  $(\rho, u, w, P)$  is the unique strong solution to the system (1.1)-(1.4) on  $\Omega \times (0,T)$  with the initial data satisfying the assumptions in Theorem 1.1, satisfying

$$\sup_{t \in [0,T]} \|\nabla \rho(t)\|_{L^{\infty}} + \sup_{t \in [0,T]} \|\nabla^2 \rho(t)\|_{L^2} \le 8M_0, \tag{3.3}$$

and

$$\sup_{t \in [0,T]} \|\nabla u(t)\|_{L^2}^2 \le 4\frac{\bar{\mu}}{\mu} \|\nabla u_0\|_{L^2}^2 \le 1. \tag{3.4}$$

There exists a positive number  $\gamma_0$ , depending on  $\Omega$ ,  $\sup_{\Omega} \rho_0 = \overline{\rho}$ ,  $\|\mu\|_{C^2}$ ,  $\|\nabla \rho_0\|_{L^{\infty}}$  and  $\|\nabla^2 \rho_0\|_{L^2}$ , such that, if

$$\|\nabla u_0\|_{L^2} \le \gamma_0,\tag{3.5}$$

then

$$\frac{2}{\mu} \int_0^T \int_{\Omega} \rho u_t^2 dt + \sup_{t \in [0,T]} \int_{\Omega} |\nabla u|^2 \le (2ln^2 + 1) \frac{\bar{\mu}}{\mu} ||\nabla u_0||_{L^2}^2.$$
 (3.6)

Before proving Lemma 3.2, we need the following lemma.

**Lemma 3.3** Assume that  $(\rho, u, w, P)$  is the unique strong solution to the system (1.1)-(1.4) on  $\Omega \times (0,T)$  with the initial data satisfying the assumptions in Theorem 1.1,, and satisfies

$$\sup_{t \in [0,T]} \|\nabla \rho(t)\|_{L^{\infty}} + \sup_{t \in [0,T]} \|\nabla^2 \rho(t)\|_{L^2} \le 8M_0.$$

Then it holds that

$$\|\nabla u\|_{H^{1}} \le C(\bar{\rho}^{1/2}M\|\sqrt{\rho}u_{t}\|_{L^{2}} + \bar{\rho}M\|\nabla u\|_{L^{2}}^{2} + \bar{\rho}^{\frac{3}{2}}M^{\frac{3}{2}}\|\nabla u\|_{L^{2}}^{\frac{5}{2}} + \bar{\rho}^{2}M^{2}\|\nabla u\|_{L^{2}}^{3}), \tag{3.7}$$

where  $M = 1 + 8M_0$ .

$$\leq CM[\bar{\rho}^{1/2}\|\sqrt{\bar{\rho}}u_{t}\|_{L^{2}} + \bar{\rho}\|\nabla u\|_{L^{2}}(C_{1}\|\nabla^{2}u\|_{L^{2}}^{\frac{1}{3}}\|\nabla u\|_{L^{2}}^{\frac{2}{3}} + C_{2}\|\nabla u\|_{L^{2}})$$

$$+ \bar{\rho}\|\nabla u\|_{L^{2}}(C_{1}\|\nabla^{2}u\|_{L^{2}}^{\frac{1}{2}}\|\nabla u\|_{L^{2}}^{\frac{1}{2}} + C_{2}\|\nabla u\|_{L^{2}})]$$

$$\leq C(\bar{\rho}^{1/2}M\|\sqrt{\bar{\rho}}u_{t}\|_{L^{2}} + \bar{\rho}M\|\nabla u\|_{L^{2}}^{2} + \bar{\rho}M\|\nabla^{2}u\|_{L^{2}}^{\frac{1}{3}}\|\nabla u\|_{L^{2}}^{\frac{5}{3}}$$

$$+ M\bar{\rho}\|\nabla^{2}u\|_{L^{2}}^{\frac{1}{2}}\|\nabla u\|_{L^{2}}^{\frac{3}{2}}).$$

$$(3.9)$$

Applying Young's inequality, we deduce that

$$\|\nabla u\|_{H^{1}} \le C(\bar{\rho}^{1/2}M\|\sqrt{\rho}u_{t}\|_{L^{2}} + \bar{\rho}M\|\nabla u\|_{L^{2}}^{2} + \bar{\rho}^{\frac{3}{2}}M^{\frac{3}{2}}\|\nabla u\|_{L^{2}}^{\frac{5}{2}} + \bar{\rho}^{2}M^{2}\|\nabla u\|_{L^{2}}^{3}). \tag{3.10}$$

Now we give the proof of Lemma 3.2.

\leq \epsilon \|\sqrt{\rho} u_{t}\|_{L^{2}}^{2} + \bar{\rho} \|\nabla u\|_{L^{2}}^{2} (C_{1} \|\nabla^{2} u\|_{L^{2}}^{\frac{2}{3}} \|\nabla u\|_{L^{2}}^{\frac{4}{3}} + C_{2} \|\nabla u\|_{L^{2}}^{2}) 
\leq \epsilon \|\sqrt{\rho} u_{t}\|_{L^{2}}^{2} + C(\bar{\rho} \|\nabla u\|_{L^{2}}^{\frac{10}{3}} \|\nabla^{2} u\|_{L^{2}}^{\frac{2}{3}} + \bar{\rho} \|\nabla u\|_{L^{2}}^{4}) 
\leq \epsilon \|\sqrt{\rho} u_{t}\|_{L^{2}}^{2} + C(\bar{\rho}^{\frac{4}{3}} M^{\frac{2}{3}} \|\sqrt{\rho} u_{t}\|_{L^{2}}^{\frac{2}{3}} \|\nabla u\|_{L^{2}}^{\frac{10}{3}} + M^{\frac{2}{3}} \bar{\rho}^{\frac{5}{3}} \|\nabla u\|_{L^{2}}^{\frac{14}{3}}

\leq \epsilon \| \sqrt{\rho} u_{t} \|_{L^{2}}^{2} + C(\bar{\rho}^{3/2} M \| \sqrt{\rho} u_{t} \|_{L^{2}} \| \nabla u \|_{L^{2}}^{3} + \bar{\rho}^{2} M \| \nabla u \|_{L^{2}}^{5} 
+ \bar{\rho}^{\frac{5}{2}} M^{\frac{3}{2}} \| \nabla u \|_{L^{2}}^{\frac{11}{2}} + \bar{\rho}^{3} M^{2} \| \nabla u \|_{L^{2}}^{6} + \bar{\rho} \| \nabla u \|_{L^{2}}^{4}) 
\leq \epsilon \| \sqrt{\rho} u_{t} \|_{L^{2}}^{2} + C(\bar{\rho}^{2} M \| \nabla u \|_{L^{2}}^{5} + \bar{\rho}^{\frac{5}{2}} M^{\frac{3}{2}} \| \nabla u \|_{L^{2}}^{\frac{11}{2}} 
+ \bar{\rho}^{3} M^{2} \| \nabla u \|_{L^{2}}^{6} + \bar{\rho} \| \nabla u \|_{L^{2}}^{4}).$$

For the last term, by direct estimates, we get

$$\int_{\Omega} \left[ \int_{0}^{y} \partial_{x} u(s) ds \partial_{y} \mu(\rho) |\nabla u| |\nabla u| - u(x) \partial_{x} \mu(\rho) |\nabla u| |\nabla u| \right] \\
\leq \| \int_{0}^{y} \partial_{x} u(s) ds \|_{L^{\infty}} \| \partial_{y} \mu(\rho) \|_{L^{\infty}} \| \nabla u \|_{L^{2}} \| \nabla u \|_{L^{2}} - \| u \|_{L^{\infty}} \| \partial_{x} \mu(\rho) \|_{L^{\infty}} \| \nabla u \|_{L^{2}} \| \nabla u \|_{L^{2}} \\
\leq \| u \|_{H^{2}} \| \partial_{y} \mu(\rho) \|_{L^{\infty}} \| \nabla u \|_{L^{2}}^{2} \\
\leq C(\bar{\rho}^{1/2} M \| \sqrt{\rho} u_{t} \|_{L^{2}} \| \nabla u \|_{L^{2}}^{2} + \bar{\rho} M \| \nabla u \|_{L^{2}}^{4} + \bar{\rho}^{\frac{3}{2}} M^{\frac{3}{2}} \| \nabla u \|_{L^{2}}^{\frac{9}{2}} + \bar{\rho}^{2} M^{2} \| \nabla u \|_{L^{2}}^{5}) M_{0} \\
\leq \epsilon \| \sqrt{\rho} u_{t} \|_{L^{2}}^{2} + C(\bar{\rho} M^{2} M_{0}^{2} \| \nabla u \|_{L^{2}}^{4} + \bar{\rho} M M_{0} \| \nabla u \|_{L^{2}}^{4} + \bar{\rho}^{\frac{3}{2}} M^{\frac{3}{2}} M_{0} \| \nabla u \|_{L^{2}}^{\frac{9}{2}} + \bar{\rho}^{2} M^{2} M_{0} \| \nabla u \|_{L^{2}}^{5}). \tag{3.14}$$

Substituting (3.12)-(3.14) into (3.11), we obtain

$$\int_{\Omega} \rho u_t^2 + \frac{1}{2} \frac{d}{dt} \int_{\Omega} \mu(\rho) |\nabla u|^2 \le C \mathcal{Q} ||\nabla u||_{L^2}^2, \tag{3.15}$$

where

$$\mathcal{Q} := \bar{\rho} \|\nabla u\|_{L^{2}}^{2} + \bar{\rho} M^{2} M_{0}^{2} \|\nabla u\|_{L^{2}}^{2} + \bar{\rho} M M_{0} \|\nabla u\|_{L^{2}}^{2} + M^{\frac{2}{3}} \bar{\rho}^{\frac{5}{3}} \|\nabla u\|_{L^{2}}^{\frac{8}{3}} 
+ M^{\frac{4}{3}} \bar{\rho}^{\frac{7}{3}} \|\nabla u\|_{L^{2}}^{\frac{10}{3}} + \bar{\rho}^{2} M \|\nabla u\|_{L^{2}}^{3} + \bar{\rho}^{2} M^{2} M_{0} \|\nabla u\|_{L^{2}}^{3} + \bar{\rho}^{\frac{5}{2}} M^{\frac{3}{2}} \|\nabla u\|_{L^{2}}^{\frac{7}{2}}

$$\frac{2}{\underline{\mu}} \int_{0}^{t} \int_{\Omega} \rho u_{t}^{2} ds + \int_{\Omega} |\nabla u|^{2} \leq \int_{0}^{t} \frac{CQ}{\underline{\mu}} ||\nabla u(s)||_{L^{2}}^{2} ds + \int_{\Omega} \frac{\mu(\rho_{0})}{\underline{\mu}} |\nabla u_{0}|^{2} \\
\leq \int_{0}^{t} \frac{CQ}{\underline{\mu}} (||\nabla u(s)||_{L^{2}}^{2} + \frac{2}{\underline{\mu}} \int_{0}^{s} \int_{\Omega} \rho u_{t}^{2}(\tau) d\tau) ds + \int_{\Omega} \frac{\mu(\rho_{0})}{\underline{\mu}} |\nabla u_{0}|^{2} \tag{3.17}$$

$$\frac{2}{\underline{\mu}} \int_{0}^{T} \int_{\Omega} \rho u_{t}^{2} dt + \sup_{t \in [0,T]} \int_{\Omega} |\nabla u|^{2}$$

$$\leq \frac{1}{\underline{\mu}} \int_{\Omega} \mu(\rho_{0}) |\nabla u_{0}|^{2} + \frac{1}{\underline{\mu}} \int_{\Omega} \mu(\rho_{0}) |\nabla u_{0}|^{2} \cdot \int_{0}^{T} \frac{CQ}{\underline{\mu}} dt \cdot \exp(\int_{0}^{T} \frac{CQ}{\underline{\mu}} dt). \tag{3.18}$$

According to Lemmas 3.1, (3.4) and Poincaré inequality, one has

$$\int_{0}^{T} \frac{CQ}{\underline{\mu}} dt \leq C \left\{ \bar{\rho} + \bar{\rho} M^{2} M_{0}^{2} + \bar{\rho} M M_{0} + M^{\frac{2}{3}} \bar{\rho}^{\frac{5}{3}} + M^{\frac{4}{3}} \bar{\rho}^{\frac{7}{3}} + \bar{\rho}^{2} M + \bar{\rho}^{2} M^{2} M_{0} \right. \\
\left. + \bar{\rho}^{\frac{5}{2}} M^{\frac{3}{2}} + \bar{\rho}^{3} M^{2} + \bar{\rho}^{\frac{3}{2}} M^{\frac{3}{2}} M_{0} \right\} \frac{\bar{\rho}}{\mu^{2}} \|\nabla u_{0}\|_{L^{2}}^{2}. \tag{3.19}$$

Now we choose  $\gamma_0$  small enough such that

$$C(\bar{\rho} + \bar{\rho}M^4 + \bar{\rho}M^2 + M^{\frac{2}{3}}\bar{\rho}^{\frac{5}{3}} + M^{\frac{4}{3}}\bar{\rho}^{\frac{7}{3}} + \bar{\rho}^2M + \bar{\rho}^2M^3 + \bar{\rho}^{\frac{5}{2}}M^{\frac{3}{2}} + \bar{\rho}^3M^2 + \bar{\rho}^{\frac{3}{2}}M^{\frac{5}{2}})\frac{\bar{\rho}}{\mu^2}\gamma_0^2 \leq \ln 2.$$

It follows from (3.18), (3.19) and (3.5) that

$$\frac{2}{\underline{\mu}} \int_{0}^{T} \int_{\Omega} \rho u_{t}^{2} dt + \sup_{t \in [0,T]} \int_{\Omega} |\nabla u|^{2} \leq \frac{\bar{\mu}}{\underline{\mu}} ||\nabla u_{0}||_{L^{2}}^{2} + \frac{\bar{\mu}}{\underline{\mu}} ||\nabla u_{0}||^{2} \cdot \ln 2 \cdot 2$$

$$= (2 \ln 2 + 1) \frac{\bar{\mu}}{\underline{\mu}} ||\nabla u_{0}||_{L^{2}}.$$

Recall that  $\|\nabla\rho\|_{L^{\infty}} + \|\nabla^2\rho(t)\|_{L^2(\Omega)} \leq (\|\nabla\rho_0\|_{L^{\infty}(\Omega)} + \|\nabla^2\rho_0\|_{L^2(\Omega)}) \exp \int_0^t \|u(s)\|_{H^3(\Omega)} ds$ . To prove that  $\|\nabla\rho(t)\|_{L^{\infty}} + \|\nabla^2\rho(t)\|_{L^2} \leq 4M_0$ , we still need the  $H^3$ -regularity of the velocity u. In fact, we need the following several lemmas to deal with  $\|u\|_{H^3}$ . First, we estiblish some time weighted estimates.

**Lemma 3.4** Assume that  $(\rho, u, w, P)$  is the unique strong solution to the system (1.1)-(1.4) on  $\Omega \times (0,T)$  with the initial data satisfying the assumptions in Theorem 1.1 and (3.3)-(3.5). Then it holds that

$$\frac{2}{\mu} \int_0^T (t \int_{\Omega} \rho u_t^2) dt + \sup_{t \in [0,T]} (t \int_{\Omega} |\nabla u|^2) \le (2 \ln 2 + 1) \frac{\bar{\mu} \bar{\rho}}{2\mu^2} ||\nabla u_0||_{L^2}^2. \tag{3.21}$$

**Proof.** Multiplying (3.15) by t and adding the term  $\frac{1}{2} \int_{\Omega} \mu(\rho) |\nabla u|^2$ , we have

$$t \int_{\Omega} \rho u_t^2 + \frac{1}{2} \frac{d}{dt} (t \int_{\Omega} \mu(\rho) |\nabla u|^2) \le t C \mathcal{Q} ||\nabla u||_{L^2}^2 + \frac{1}{2} \int_{\Omega} \mu(\rho) |\nabla u|^2.$$
 (3.22)

Integrating with respect to time on [0,t] and using the fact that  $\mu \geq \underline{\mu} > 0$ , we get

$$\frac{2}{\underline{\mu}} \int_{0}^{t} (s \int_{\Omega} \rho u_{t}^{2}) ds + \sup_{t \in [0,T]} (t \int_{\Omega} |\nabla u|^{2})$$

$$\leq \int_{0}^{t} (\frac{CQ}{\underline{\mu}} s ||\nabla u||_{L^{2}}^{2}) ds + \frac{1}{\underline{\mu}} \int_{0}^{t} (\int_{\Omega} \mu(\rho) |\nabla u|^{2}) ds$$

$$\leq \int_{0}^{t} \frac{CQ}{\underline{\mu}} (s ||\nabla u(s)||_{L^{2}}^{2} + \frac{2}{\underline{\mu}} \int_{0}^{s} \tau \int_{\Omega} \rho u_{t}^{2}(\tau) d\tau) ds + \frac{1}{\underline{\mu}} \int_{0}^{t} (\int_{\Omega} \mu(\rho) |\nabla u|^{2}) ds. \tag{3.23}$$

By Gronwall inequality, assumption (3.5), Poincaré inequality and Lemma 3.1, we deduce

$$\frac{2}{\underline{\mu}} \int_{0}^{T} (t \int_{\Omega} \rho u_{t}^{2}) dt + \sup_{t \in [0,T]} (t \int_{\Omega} |\nabla u|^{2}) 
\leq \frac{1}{\underline{\mu}} \int_{0}^{T} (\int_{\Omega} \mu(\rho) |\nabla u|^{2}) dt + \frac{1}{\underline{\mu}} \int_{0}^{T} (\int_{\Omega} \mu(\rho) |\nabla u|^{2}) dt \cdot \int_{0}^{T} \frac{CQ}{\underline{\mu}} dt \cdot \exp(\int_{0}^{T} \frac{CQ}{\underline{\mu}} dt) 
\leq (2 \ln 2 + 1) \frac{\overline{\mu} \overline{\rho}}{2\underline{\mu}^{2}} ||\nabla u_{0}||_{L^{2}}^{2}.$$

**Lemma 3.5** Assume that  $(\rho, u, w, P)$  is the unique strong solution to the system (1.1)-(1.4) on  $\Omega \times (0,T)$  with the initial data satisfying the assumptions in Theorem 1.1 and (3.3)-(3.5). Then it holds that

$$\sup_{t \in [0,T]} t \int_{\Omega} \rho u_t^2 + 2\underline{\mu} \int_0^T (t \int_{\Omega} |\nabla u_t|^2) dt \le C\Theta_1 \|\nabla u_0\|_{L^2}^2 \cdot \exp\left[C\Theta_2\right], \tag{3.25}$$

and

$$\sup_{t \in [0,T]} t^2 \int_{\Omega} \rho u_t^2 + 2\underline{\mu} \int_0^T (t^2 \int |\nabla u_t|^2) dt \le C \bar{\rho} \Theta_1 ||\nabla u_0||_{L^2}^2 \cdot \exp\left[C\Theta_2\right], \tag{3.26}$$

where  $\Theta_1 = 1 + M^4 \bar{\rho}^4 + \bar{\rho}^5 M^5 + M^6 \bar{\rho}^6$  and  $\Theta_2 = C(M^4 \bar{\rho}^2 + \bar{\rho}^2 + \bar{\rho}^4)$ .

**Proof.** Taking t-derivative of the horizontal momentum equations  $(1.1)_2$ , we deduce that

\leq (\sup_{t \in [0,T]} t ||\nabla u||_{L^{2}}^{2} \int_{0}^{T} C \mathcal{Q}_{1} dt + \int_{0}^{T} ||\sqrt{\rho} u_{t}||_{L^{2}}^{2} dt) \cdot \int_{0}^{T} C \mathcal{Q}_{2} dt \cdot exp(\int_{0}^{T} C \mathcal{Q}_{2} dt), 
\leq (\sup_{t \in [0,T]} t ||\nabla u||_{L^{2}}^{2} \int_{0}^{T} C \mathcal{Q}_{1} dt + \int_{0}^{T} ||\sqrt{\rho} u_{t}||_{L^{2}}^{2} dt) \cdot exp(\int_{0}^{T} C \mathcal{Q}_{2} dt)$$
(3.39)

By using Lemma 3.1 and (3.4), one obtains

$$\int_{0}^{T} C \mathcal{Q}_{1} dt \leq \int_{0}^{T} C (M_{0}^{2} M^{2} \bar{\rho}^{2} \|\nabla u\|_{L^{2}}^{4} + M_{0}^{2} M^{3} \bar{\rho}^{3} \|\nabla u\|_{L^{2}}^{5} + M_{0}^{2} M^{4} \bar{\rho}^{4} \|\nabla u\|_{L^{2}}^{6}

$$\int_{0}^{T} C \mathcal{Q}_{2} dt \leq \int_{0}^{T} C(\bar{\rho} M_{0}^{4} \|\nabla u\|^{4} + \bar{\rho}^{3} \|\nabla u\|^{4} + \bar{\rho} \|\nabla u\|^{2} + M_{0}^{2} \bar{\rho} M^{2} \|\nabla u\|^{2} + M_{0}^{2} \bar{\rho} M^{2} \|\nabla u\|^{4}) dt 
\leq C (M^{4} \bar{\rho}^{2} + \bar{\rho}^{2} + \bar{\rho}^{4}) \|u_{0}\|_{L^{2}}^{2}.$$

Taking (3.21) and (3.6) into account and using Poincaré inequality, we obtain

\leq C (M^{4} \bar{\rho}^{4} + M^{5} \bar{\rho}^{5} + M^{6} \bar{\rho}^{6} + 1) \|\nabla u_{0}\|_{L^{2}}^{2} \cdot \exp \left[ C (M^{4} \bar{\rho}^{2} + \bar{\rho}^{2} + \bar{\rho}^{4}) \right].$$

Next we turn to the  $t^2$ -weighted estimates. To do this, multiplying (3.38) by t, one has

Integrating with respect to time on [0,t] and using the fact that  $\mu \geq \underline{\mu} > 0$ , we get

$$\begin{split} & t^2 \int_{\Omega} \rho u_t^2 + 2\underline{\mu} \int_0^t s^2 \int_{\Omega} |\nabla u_t|^2 ds \\ & \leq \int_0^t C s^2 \|\sqrt{\rho} u_t\|_{L^2}^2 \mathcal{Q}_2 ds + \int_0^t C s^2 \|\nabla u\|_{L^2}^4 \mathcal{Q}_3 ds + \int_0^t 2s \|\sqrt{\rho} u_t\|_{L^2}^2 ds \\ & \leq \int_0^t C \mathcal{Q}_2(s^2 \|\sqrt{\rho} u_t\|_{L^2}^2 + 2\underline{\mu} \int_0^s \tau^2 \int_{\Omega} |\nabla u_t|^2 d\tau) ds + \int_0^t C s^2 \|\nabla u\|_{L^2}^4 \mathcal{Q}_3 ds + \int_0^t 2s \|\sqrt{\rho} u_t\|_{L^2}^2 ds, \end{split}$$

$$\begin{aligned} \mathcal{Q}_{3} &= M_{0}^{2} M^{2} \bar{\rho}^{2} \|\nabla u\|_{L^{2}}^{2} + M_{0}^{2} M^{3} \bar{\rho}^{3} \|\nabla u\|_{L^{2}}^{3} + M_{0}^{2} M^{4} \bar{\rho}^{4} \|\nabla u\|_{L^{2}}^{4} \\ &+ M_{0}^{2} M^{2} \bar{\rho}^{2} \|\nabla u\|_{L^{2}}^{4} + M_{0}^{2} M^{3} \bar{\rho}^{3} \|\nabla u\|_{L^{2}}^{5} + M_{0}^{2} M^{4} \bar{\rho}^{4} \|\nabla u\|_{L^{2}}^{6}. \end{aligned}$$

Applying Gronwall's inequality, Lemma 3.1, (3.4) and Lemma 3.4, we obtain that

Thus, we complete the proof of this lemma.

$$\sup_{t \in [0,T]} e^{\sigma t} \int_{\Omega} \rho u^{2}(t) + \underline{\mu} \int_{0}^{T} (e^{\sigma t} \int_{\Omega} |\nabla u|^{2}) dt \le \bar{\rho} ||u_{0}||_{L^{2}}^{2}, \tag{3.46}$$

and

$$\leq C \|\rho_{0}\|_{L^{p}} \|\nabla u\|_{L^{2}}^{2} \leq \sigma^{-1} \int_{\Omega} \mu(\rho) |\nabla u|^{2},$$
(3.49)

where  $\sigma = \frac{\underline{\mu}}{C\|\rho_0\|_{L^p}}$  for p > 1.

Multiplying both sides of (3.48) and (3.49) by the term  $e^{\sigma t}$ , respectively, and collecting them, we have

$$\frac{d}{dt}[e^{\sigma t}\|\sqrt{\rho}u\|_{L^2}^2] + e^{\sigma t} \int_{\Omega} \mu(\rho)|\nabla u|^2 \le 0.$$

Recall that

$$2\int_{\Omega} \rho u_t^2 + \frac{d}{dt} \int_{\Omega} \mu(\rho) |\nabla u|^2 \le C \mathcal{Q} ||\nabla u||_{L^2}^2.$$

Multiplying both sides of (3.51) by the term  $e^{\sigma t}$  and adding the term  $e^{\sigma t}\sigma \int_{\Omega} \mu(\rho) |\nabla u|_{L^2}^2$  to both sides, we get

By Gronwall inequality in integral form

$$\sup_{t \in [0,T]} e^{\sigma t} \int_{\Omega} |\nabla u|^2 + \int_{0}^{T} (e^{\sigma t} \frac{2}{\underline{\mu}} \int_{\Omega} \rho u_t^2) dt 
\leq \int_{0}^{T} (e^{\sigma t} \frac{\sigma}{\underline{\mu}} \int_{\Omega} \mu(\rho) |\nabla u|^2) dt + \int_{\Omega} \mu(\rho_0) \frac{|\nabla u_0|^2}{\underline{\mu}} 
+ \left[ \int_{0}^{T} (e^{\sigma t} \frac{\sigma}{\underline{\mu}} \int_{\Omega} \mu(\rho) |\nabla u|^2) + \int_{\Omega} \mu(\rho_0) \frac{|\nabla u_0|^2}{\underline{\mu}} dt \right] \cdot \int_{0}^{T} \frac{CQ}{\underline{\mu}} dt \cdot \exp(\int_{0}^{T} \frac{CQ}{\underline{\mu}} dt)

$$+ \int_{\Omega} [\rho \int_{0}^{y} \partial_{x} u_{t}(s) ds \partial_{y} u u_{t}] - \int_{\Omega} \mu_{t}(\rho) \nabla u \nabla u_{t} = \sum_{i=1}^{6} J_{i}.$$
(3.56)

By direct estimates and Young inequality, we have

$$\leq C \|\nabla \rho\|_{L^{\infty}}^{2} \|u\|_{H^{2}}^{2} \|\nabla u\|_{L^{2}}^{4} + \frac{\mu}{2} \|\nabla u_{t}\|_{L^{2}}^{2}.$$

Remark 3.1 When we deal with the term of  $\|\sqrt{\rho}u_t(0)\|_{L^2}$ , we first need to regularize the initial data  $(\rho_0, u_0, P_0)$ . That is, for each  $\delta \in (0, 1)$ , that we choose  $\rho_0^{\delta} \in C^{2+\alpha}$  such that  $0 < \delta \le \rho_0^{\delta} \le \rho_0 + 1$ ,  $\rho_0^{\delta} \to \rho_0$  in  $W^{2,2}$  as  $\delta \to 0$ , and denote by  $(u_0^{\delta}, P_0^{\delta}) \in H^1(\Omega) \times L^2(\Omega)$  a solution to the problem

In fact, with such regularized initial data and the compatibility condition (3.65), we can get corresponding solutions ( $\rho^{\delta}$ ,  $u^{\delta}$ ,  $P^{\delta}$ ) satisfying the estimates in Lemma 3.1-3.9 and these estimates are independent of  $\delta$ . Then we use the standard compactness arguments to get the desired result.

With the help of Lemmas 3.4-3.7, we can now estimate  $||u||_{L^1(0,T;H^3(\Omega))}$ .

Moreover, suppose that there exists a positive number  $\epsilon_0$ , depending on  $\Omega$ ,  $\sup_{\Omega} \rho_0 = \overline{\rho}$ ,  $\|\mu\|_{C^2}$ ,  $\|\nabla \rho_0\|_{L^{\infty}}$ ,  $\|\nabla^2 \rho_0\|_{L^2}$ , such that

$$\|\nabla \rho\|_{L^{\infty}} + \|\nabla^2 \rho\|_{L^2} \le 2(2\|\rho_0\|_{L^{\infty}} + \|\nabla^2 \rho_0\|_{L^2}) \le 4(\|\nabla \rho_0\|_{L^{\infty}} + \|\nabla^2 \rho_0\|_{L^2}) = 4M_0.$$

Here we complete the proof of Lemma 3.9.

#### 3.2 Proof of Theorem 1.2

With the above uniform estimates in hand, we are ready to prove Theorem 1.2.

**Proof of Theorem 1.2.** According to Lemma 2.4, there exists a  $T_* > 0$  such that the primitive equations have a unique local strong solution  $(\rho, u, w, P)$  on  $[0, T_*]$ . Next, we apply the above a priori estimates in Section 3.1 to extend the local solution to a global one.

Since  $\|\nabla \rho_0\|_{L^{\infty}} + \|\nabla^2 \rho_0\|_{L^2} = M_0 < 8M_0$ , and thanks to the continuity of  $\|\nabla \rho(t)\|_{L^{\infty}} + \|\nabla^2 \rho(t)\|_{L^2}$  and  $\|\nabla u(t)\|_{L^2}$ , there exists a  $T_1 \in (0, T_*)$  such that

$$\sup_{0 \le t \le T_1} \|\nabla \rho(t)\|_{L^{\infty}} + \|\nabla^2 \rho(t)\|_{L^2} \le 8M_0,$$

and

$$\sup_{0 \le t \le T_1} \|\nabla u(t)\|_{L^2}^2 \le 4 \frac{\mu}{\underline{\mu}} \|\nabla u_0\|_{L^2}^2.$$

Let

$$T^* = \sup \Big\{ T | (\rho, u, w, P) \text{ is a strong solution to (1.1) on } [0, T] \Big\},$$

and

$$T_1^* = \sup \left\{ T \middle| \begin{matrix} (\rho, u, w, P) \text{ is a strong solution to } (1.1) \text{ on } [0, T], \sup_{0 \le t \le T} (\|\nabla \rho(t)\|_{L^{\infty}}) \\ + \|\nabla^2 \rho(t)\|_{L^2}) \le 8M_0, \text{ and } \sup_{0 \le t \le T} \|\nabla u(t)\|_{L^2}^2 \le (2ln2 + 1) \frac{\bar{\mu}}{\underline{\mu}} \|\nabla u_0\|_{L^2}^2 \end{matrix} \right\}.$$

Then  $T_1^* \geq T_1 > 0$ . Recalling Lemma 3.2 and Lemma 3.9, it is easy to verify that

$$T^* = T_1^*$$

provided that  $\|\nabla u_0\|_{L^2} \leq \eta_0 = \min\{\gamma_0, \epsilon_0\}$  as assumed.

We claim that  $T^* = \infty$ . Otherwise assume that  $T^* < \infty$ . By virtue of Lemma 3.2 and Lemma 3.9, for every  $t \in [0, T^*)$ , it holds that

$$\|\nabla \rho(t)\|_{L^{\infty}} + \|\nabla^2 \rho\|_{L^2} \le 4M_0 \text{ and } \|\nabla u(t)\|_{L^2}^2 \le (2ln^2 + 1)\frac{\bar{\mu}}{\underline{\mu}} \|\nabla u_0\|_{L^2}^2,$$

which contradicts the blow-up criterion (1.8) in Theorem 1.1. Hence we complete the proof of Theorem 1.2.
