Tensor-force effects on nuclear matter in relativistic *ab initio* theory

Within the relativistic Brueckner-Hartree-Fock theory in the full Dirac space, the tensor-force effects on infinite nuclear matter are elucidated by subtracting the matrix elements of tensor forces from the realistic nucleon-nucleon interaction. The tensor-force effects for the binding energy per particle of symmetric nuclear matter (SNM) as well as the symmetry energy are attractive and are more pronounced around the empirical saturation density, while the tensor forces have little impact on the pure neutron matter. By tuning the tensor-force strength, an infinite (negative) scattering length in the spin-triplet channel is found. This locates the dilute SNM with only the ${}^{3}S_{1}$ - ${}^{3}D_{1}$ channel interaction at the unitary limit. Its ground-state energy is found proportional to the energy of a free Fermi gas with a scaling factor 0.38, revealing good universal properties. This work paves the way to study the tensor-force effects in neutron stars as well as finite nuclei from realistic nucleon-nucleon interactions and highlights the role of the tensor force on the deviation of the nuclear physics to the unitary limit.

As a crucial ingredient of the nucleon-nucleon (NN)interaction, the tensor force has an important impact on the structural and dynamical properties of the nuclear many-body systems, particularly the properties of exotic nuclei far away from the stability, which are crucial for understanding the nucleonsynthesis in nuclear astrophysics. Many efforts have been devoted to studying the influence of the tensor force in effective NN interaction in nuclear medium within the configuration interaction shell model [1] and the density functional theories (DFTs) [2]. Due to the difference of modeling the effective NN interaction and the difficulty of determining the tensor-force strengths in finite nuclei, the tensor force effects in nuclear physics are not fully settled.

Starting from the realistic NN interactions that are well calibrated in free space, the microscopic *ab initio* studies provide a more promising way to study the tensor-force effects, since no free parameters are introduced throughout the solution of the many-body methods. Progress has been made on the role of tensor force in the binding of light nuclei [3] and the symmetry energy of nuclear matter [4]. Still, insufficient attention has been paid on the studies of tensor-force effects from microscopic *ab initio* calculations.

The relativistic Brueckner-Hartree-Fock (RBHF) theory plays a key role in addressing the challenge of *ab initio* methods rooted in a relativistic framework [6]. The strong correlation in many-body wave function induced by the realistic NN interaction V is absorbed into the effective G matrix, which is obtained as the solution of the Thompson equation in medium [7]. In addition to the advantages by solving nuclear many-body systems within a relativistic framework [8], the main strength of the RBHF theory lies in its inherent ability to account for a class of three-body forces which are important for satisfactorily reproducing the empirical saturation properties of nuclear matter [7, 9]. The RBHF theory has been successfully applied to describe the properties of nuclear matter and finite nuclei [10, 11].

In the light of the remarkable reliability of the relativistic *ab initio* theory, the many-body predictions from RBHF theory have been utilized as pseudo-data to constrain the parameters in both non-relativistic and relativistic DFTs. By applying the RBHF theory in neutron drops, a systematic and specific pattern in the evolution of spin-orbit (SO) splittings is observed [12, 13], which is found to have strong tensor-force effects. This provides a novel scheme for the determination of the tensor-force strengths and forms an important guide for the microscopic derivations of nuclear DFTs [14, 15].

In this work, we aim to directly study the tensor-force effects in nuclear many-body systems from relativistic *ab initio* theory. As a first step we focus on the infinite nuclear matter, which provides an ideal laboratory accessible to different methods that allows detailed benchmark. The RBHF theory in the full Dirac space

is adopted, which considers simultaneously the positiveand negative-energy solutions (NESs) of the Dirac equation, thus avoids the uncertainties suffered from the RBHF calculations without NESs. Details can be found in Refs. [10, 16]. To identify the effects of tensor forces, we perform the RBHF calculations, in which the tensor forces in different meson-nucleon couplings are removed from the realistic NN interaction by using the non-relativistic reduced operators [17]

$$\hat{\mathcal{V}}_{\phi}^{t} = \frac{1}{m_{\phi}^{2} + q^{2}} \mathcal{F}_{\phi} S_{12}.$$

Here ϕ denotes the exchanged meson with mass m_{ϕ} , q is the momentum transfer, and S_{12} is the tensor force operator

$$S_{12} \equiv (\boldsymbol{\sigma}_1 \cdot \boldsymbol{q})(\boldsymbol{\sigma}_2 \cdot \boldsymbol{q}) - \frac{1}{3}(\boldsymbol{\sigma}_1 \cdot \boldsymbol{\sigma}_2)q^2.$$

The factor \mathcal{F}_{ϕ} in each meson-nucleon coupling can be found in Table 1 of Ref. [17]. This scheme has been initially applied in analyzing the tensor-force effects on the neutron-proton effective mass splitting in neutronrich matter [18]. To study the tensor-force effects more precisely, a quenching factor λ is introduced in Eq. (1) for each coupling channel \mathcal{F}_{ϕ} to control the strength of the tensor force. The factor $\lambda = 0$ means no tensor force, while $\lambda = 1$ means the tensor forces are considered fully as original.

Figure 1(a) shows the binding energies per particle as a function of the density ρ for symmetric nuclear matter (SNM) calculated within the RBHF theory with and without tensor forces. Clearly the tensor-force effects lead to attraction over a wide range of densities and are more significant at lower densities. The characteristics of attraction can be understood from the Thompson equation, which can be written simply in the operator form

 $G = V + V(Q/e)V + \cdots$. Here Q and e denote the Pauli operator and the energy denominator, respectively. The tensor force in the realistic interaction V makes no contribution to the binding energy of nuclear matter due to the spin saturation. For the second term V(Q/e)V, due to the positive definiteness of quadratic terms of V and the negative energy denominator in the presence of the Pauli operator, the contributions of the tensor force in the second term are always attractive. This implies that the contribution of tensor forces in realistic NN interaction to the nuclear matter binding is reflected through higherorder effects. In addition, among the three parameterizations of the Bonn potential [7], the tensor-force effects of Bonn C are the most pronounced. This is consistent with the well known fact that Bonn C has the strongest tensor force [7], as indicated by the largest D-state probability of the deuteron.

In Fig. 1(b), we illustrate the tensor-force effects on the binding energies per particle in pure neutron matter (PNM) where the total isospin T for two-nucleon state must equal to 1. For the Bonn A potential, the calculations with and without tensor force lead to nearly the same results. This indicates that the total tensorforce effects for Bonn A in isospin triplet with T = 1 are marginal. Similar conclusions can be drawn for Bonn B and Bonn C potentials. This can be understood by the fact that the PNM is dominated by ${}^{1}S_{0}$ partial wave, while the tensor-force contribution appears in P and higher waves.

The results in SNM and PNM allow us to derive the nuclear symmetry energy $E_{\rm sym}(\rho)$, which is one of the cutting-edge topics in nuclear physics and astrophysics. We depict the differences between the symmetry energies obtained with and without tensor forces in Fig. 1(c). The tensor force plays an essential role around the empirical saturation density $\rho_0 = 0.16 \pm 0.01$ fm⁻³, beyond which

the tensor-force effects become weaker. In comparison to our results, the symmetry energy difference obtained in Ref. [5] is very similar, where the tensor-force effects are analyzed by performing the RBHF calculations without the off-diagonal NN matrix elements in the coupled spin triplet channels. By using the Hellmann-Feynman theorem from non-relativistic *ab initio* method [4], the estimation of the tensor-force contribution to symmetry energy is qualitatively consistent (36 MeV at $\rho =$ 0.187 fm^{-3}), despite the quantitative discrepancy which may result from relativistic effects in NN interaction and many-body method.

It should be noted that, starting from the effective NN interaction within the DFTs, where only the tree-level interactions are considered, tensor force plays no role in nuclear matter due to the spin saturation. This clearly reveals the advantages from *ab initio* studies that the higher-order effects of the tensor force on nuclear matter can be explored.

The nuclear physics is naturally in proximity to the unitary limit where the two-body scattering length is infinite. This can be recognized by the fact that the scattering lengths in ${}^{1}S_{0}$ (spin singlet) and ${}^{3}S_{1}$ (spin triplet) are appreciably large compared to the effective range of the interaction. The system at the unitary limit exhibits universal properties regardless of the nature of the constituent particles and their mutual interactions. In particular, the ground state energy of any fermionic system at the unitary limit is expected to be proportional to the corresponding ones of a non-interacting Fermi gas with the scaling factor called Bertsch parameter [19].

Many efforts have been devoted to studying the relation of the dilute PNM properties with the unitary limit. At low densities, the neutron-neutron (nn) interaction is dominated by the ${}^{1}S_{0}$ partial wave with the scattering length $a_s^{nn} = -18.9$ fm. Therefore, the dilute PNM is similar to a unitary Fermi gas, which is an idealized system of spin-1/2 fermions at the unitary limit. It is found that the Bertsch parameter is around 0.3-0.7 [20].

Different to the PNM, the SNM incorporates additionally the spin triplet ${}^{3}S_{1}$ partial wave, where the scattering length $a_t = 5.4$ fm implying the existence of a bound state for the neutron-proton (np) system, i.e., the deuteron. It is well known that the tensor force plays an important role in the binding energy of the deuteron and leads to the coupling between ${}^{3}S_{1}$ and ${}^{3}D_{1}$ partial waves. In Fig. 2(a) we present the ratio of the effective range r_t and the scattering length a_t as a function of the strength of the tensor force. With the continuously decreasing of the quenching factor λ of the tensor force, the ratio r_t/a_t also decreases. Note that the running of r_t/a_t is dominated by the scattering length a_t , while r_t retains in the range of 1.8-5.1 fm. At a certain λ , the scattering length a_t goes to infinity, locating the np system at the unitary limit, which is denoted by the upper horizontal dashed line. This also illustrates that the strong tensor force in the np interaction makes the np system, to some extent, deviate from the unitary limit.

We also show the influence of the tensor force on the binding energy of deuteron in Fig. 2(a). With the decrease of the factor λ , the binding energy of the deuteron B_d also decreases from 2.2246 MeV to zero until meeting the unitary limit. The rapidest case is found for Bonn C, since this potential has the strongest tensor force. The deuteron is not bound any more after the dimensionless ratio r_t/a_t crosses the locale of the unitary limit and the bound limit is denoted by the lower horizontal dashed line.

It is interesting to study how the dilute SNM with only the coupled spin triplet ${}^{3}S_{1}$ - ${}^{3}D_{1}$ partial waves behaves at the unitary limit. By tuning the quenching factor of the tensor force $\lambda = 0.4029, 0.5624$, and 0.6278 for Bonn A, B, C, respectively, we obtain the scattering length $a_t \approx -100$ fm, which is large enough compared to the effective range r_t and the average distance between nucleons in the dilute SNM. From the modified Bonn potentials near the unitary limit, we calculate the ground-state energies per particle for SNM by only considering the NN matrix elements in the ${}^{3}S_{1}$ - ${}^{3}D_{1}$ channel. To avoid the numerical instabilities at extreme low densities, the Thompson equations are solved only once with initial vanishing single-particle potentials. This should be reasonable since the hypothetically converged singleparticle potentials are very close to zero at extreme low densities.

In Fig. 2(b), we present the ground-state energy per particle of SNM within the scheme discussed above. The results from Bonn A, B, and C show very good consistency, not sensitive to the details of the interaction. Furthermore, it is found that the results from our calculations can be well simulated with $\xi(E/A)_{\text{free gas}}$, where $(E/A)_{\text{free gas}} = (3k_F^2)/(10M)$ is the energy per particle of the free Fermi gas and the $\xi = 0.38$ is the aforementioned Bertsch parameter. We also calculate the parameter ξ for dilute PNM and SNM in the ${}^{1}S_{0}$ channel, where the scattering lengths are $a_s^{nn} = -18.9$ fm and $a_s^{np} = -23.7$ fm. The corresponding results are $\xi = 0.60$ and 0.42, implying the convergence of the Bertsch parameter towards the unitary limit. Besides, the value 0.38 is close to the result 0.372 from quantum Monte Carlo calculations [21] for unitary Fermi gas, and 0.376 measured in ultra cold atoms [22]. With increasing density, the differences among the three potentials and the deviations with respect to the $0.38(E/A)_{\text{free gas}}$ become evident, which means that the universal properties of SNM are getting deteriorated.

In summary, the tensor-force effects on the equation of state of nuclear matter and the symmetry energy have been studied from the realistic Bonn potentials, by invoking the relativistic Brueckner-Hartree-Fock theory with the tensor force matrix elements subtracted. For the binding energies per particle of symmetric nuclear matter (SNM) and the symmetry energy, the tensor-force effects are attractive and are more pronounced around the empirical saturation density. For pure neutron matter, the tensor-force effects are marginal. The impact of the tensor force on the deviation of the np system to the unitary limit has also been studied. By tuning the tensor-force strength, an infinite (negative) scattering length in the spin triplet can be obtained and the dilute SNM is located at the unitary limit. With only the interaction in ${}^{3}S_{1}$ - ${}^{3}D_{1}$ channel considered, the ground-state energy of dilute SNM is found proportional to that of a free Fermi gas with a scaling factor 0.38, which reveals very good universal properties. This work paves the way to study the tensor-force effects in neutron stars as well as

finite nuclei from realistic nucleon-nucleon interactions and highlights the role of the tensor force on the deviation of the nuclear physics to the unitary limit.
