# IMPROVED BOUNDS FOR INTEGRAL POINTS ON MODULAR CURVES USING RUNGE'S METHOD

#### Abstract

Consider a modular curve $X_{G}$ defined over a number field $K$, where $G$ is a subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ with $N>2$. The curve $X_{G}$ comes with a morphism $j: X_{G} \rightarrow \mathbb{P}_{K}^{1}=\mathbb{A}_{K}^{1} \cup\{\infty\}$ to the $j$ line. For a finite set of places $S$ of $K$ that satisfies a certain condition, Runge's method shows that there are only finitely many points $P \in X_{G}(K)$ for which $j(P)$ lies in the ring $\mathcal{O}_{K, S}$ of $S$-units of $K$. We prove an explicit version which shows that if $j(P) \in \mathcal{O}_{K, S}$ for some $P \in X_{G}(K)$, then the absolute logarithmic height of $j(P)$ is bounded above by $N^{12} \log N$. Explicits upper bounds have already been obtained by Bilu and Parent though they are not polynomial in $N$. The modular functions needed to apply Runge's method are constructing using Eisenstein series of weight 1.


## 1. Introduction

Fix an integer $N>2$ and consider a subgroup $G$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ that contains $-I$. Associated to the group $G$ is a modular curve $X_{G}$ that is defined over the number field $K_{G}:=\mathbb{Q}\left(\zeta_{N}\right)^{\operatorname{det}(G)}$ and is smooth, projective and geometrically irreducible; see $\S 2$ for details. In particular, the curve $X_{G}$ is defined over $\mathbb{Q}$ when $\operatorname{det}(G)=(\mathbb{Z} / N \mathbb{Z})^{\times}$. The curve $X_{G}$ comes with a nonconstant morphism

$$
j: X_{G} \rightarrow \mathbb{P}_{K_{G}}^{1}=\mathbb{A}_{K_{G}}^{1} \cup\{\infty\}
$$

to the $j$-line. The cusps of $X_{G}$ are the points lying over $\infty$. We define $Y_{G}$ to be the open subvariety of $X_{G}$ that is the complement of its cusps.

Fix a number field $K \supseteq K_{G}$. Let $S$ be a finite set of places of $K$ that contains all the infinite places and let $\mathcal{O}_{K, S}$ be the ring of $S$-integers in $K$. Let $\mathfrak{c}_{G, K}$ be the number of orbits of the action of the Galois group $\operatorname{Gal}(\bar{K} / K)$ on the set of cusps $X_{G}(\bar{K})-Y_{G}(\bar{K})$. We say that the pair $(K, S)$ satisfies Runge's condition for $X_{G}$ if $|S|<\mathfrak{c}_{G, K}$.

Assume that $(K, S)$ satisfies Runge's condition for $X_{G}$. Runge's method shows that there only finitely many points $P \in Y_{G}(K)$ with $j(P) \in \mathcal{O}_{K, S}$. For background on Runge's method see [Sch08, Chapter 5], [BG06, §9.6.5] or [LF19, §4]. An effective version for modular curves was given by Bilu and Parent [BP11] where they showed that for all points $P \in Y_{G}(K)$ with $j(P) \in \mathcal{O}_{K, S}$, we have

$$
\begin{equation*}
h(j(P)) \leq 36|S|^{|S| / 2+1}\left(N^{2}|G| / 2\right)^{|S|} \log (2 N), \tag{1.1}
\end{equation*}
$$

where $h$ denotes the logarithmic absolute height.
Our main result gives a bound for $h(j(P))$ which is polynomial in $N$ and independent of $|S|$; the bound in (1.1) is polynomial in $N$ only when we bound $|S|$.

Theorem 1.1. Fix an integer $N>2$ and a subgroup $G$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ containing $-I$. Let $\mu$ be the degree of the morphism $j: X_{G} \rightarrow \mathbb{P}_{K_{G}}^{1}$. Assume that ( $K, S$ ) satisfies Runge's condition for $X_{G}$, where $K \supseteq K_{G}$ is a number field and $S$ is a finite set of places of $K$ that contains all the infinite places. Then for any point $P \in Y_{G}(K)$ with $j(P) \in \mathcal{O}_{K, S}$, we have $h(j(P)) \leq 4(\mu+4)^{4} \log N$ and hence

$$
h(j(P)) \leq N^{12} \log N .
$$

Remark 1.2.
(i) Since $G$ contains $-I$, we have $\mu=\left[\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z}): G \cap \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})\right]$. In particular, we have $\mu \leq$ $\left|\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z}) /\{ \pm I\}\right| \leq N^{3} / 2$. Using that $N>2$, we find that $4(\mu+4)^{4} \leq 4\left(N^{3} / 2+4\right)^{4} \leq N^{12}$. This explains how the first inequality of Theorem 1.1 implies the second one.
(ii) Since $h$ is the logarithmic absolute height, Theorem 1.1 implies that there are only finitely many points $P \in Y_{G}(K)$ with $j(P) \in \mathcal{O}_{K, S}$ as we vary over all pairs $(K, S)$ satisfying Runge's condition for $X_{G}$, where $K$ is a subfield of a fixed algebraic closure of $K_{G}$.
(iii) Consider a subgroup $G$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $X_{G}$ has at least 3 distinct cusps. Take any number field $K \supseteq K_{G}$ and any finite set of places $S$ of $K$. From a classical theorem of Siegel, there are only finitely many points $P \in X_{G}(K)$ for which $j(P) \in \mathcal{O}_{K, S}$. Unfortunately, Siegel's theorem gives no way to bound the height of the $j$-invariants $j(P)$ that arise. Bilu [Bil95, §5] showed that the heights could actually be effectively bounded by making use of Baker's method. A quantitative version was given by Sha [Sha14] and see also [Cai22]. We will not state the explicit bound of Sha, but simply remark that it implies that $\log (h(j(P))+1) \leq C_{K, S} N \log N$ holds for all $P \in Y_{G}(K)$ with $j(P) \in \mathcal{O}_{K, S}$, where $C_{K, S}$ is a positive constant depending only on the pair $(K, S)$. Note that when Runge's condition holds, the bounds in Theorem 1.1 will be stronger and will have no dependency on $(K, S)$.
(iv) The condition $N>2$ is used several times during the proof; for such $N$, the classical modular curve $X(N)$ over $\mathbb{Q}\left(\zeta_{N}\right)$ is a fine moduli space. For the excluded case $N=2$, one can simply lift $G$ to a subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / 4 \mathbb{Z})$ to obtain bounds.
(v) Let $g$ be the genus of $X_{G}$. We have $\mu<101(g+1)$, see the comments after [CP03, Proposition 2.3]. For a pair $(K, S)$ that satisfies Runge's condition for $X_{G}$, Theorem 1.1 implies that

$$
h(j(P)) \leq 4\left((101(g+1)+4)^{4} \cdot \log N\right.
$$

holds for all $P \in Y_{G}(K)$ with $j(P) \in \mathcal{O}_{K, S}$.
(vi) The points of our modular curves give important arithmetic information about elliptic curves which we now recall; this will not be used elsewhere. Fix a number field $K \supseteq K_{G}$. Let $E$ be an elliptic curve over $K$ with $j$-invariant $j(E) \notin\{0,1728\}$. The $N$-torsion subgroup $E[N]$ of $E(\bar{K})$ is a free $\mathbb{Z} / N \mathbb{Z}$-module of rank 2 . The natural Galois action on $E[N]$ and a choice of basis gives a Galois representation $\rho_{E, N}: \operatorname{Gal}(\bar{K} / K) \rightarrow \operatorname{Aut}_{\mathbb{Z} / N \mathbb{Z}}(E[N]) \cong \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. One can show that $\rho_{E, N}(\operatorname{Gal}(\bar{K} / K))$ is conjugate in $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ to a subgroup of $G^{t}$ if and only if $j(E)=j(P)$ for some $P \in Y_{G}(K)$. Here $G^{t}$ is the group obtained by taking the transpose of the elements of $G$. As a warning, we note that in the literature, our modular curve $X_{G}$ is sometimes denoted $X_{G^{t}}$.
1.1. Overview. Fix an integer $N>2$ and a subgroup $G$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. Fix a number field $K \supseteq K_{G}$ and a finite set $S$ of places of $K$ containing all the infinite places. The set $\mathcal{C}_{G}:=X_{G}(\bar{K})-Y_{G}(\bar{K})$ of cusps has a natural action by $\operatorname{Gal}_{K}:=\operatorname{Gal}(\bar{K} / K)$. Assume that Runge's condition for $X_{G}$ holds for the pair $(K, S)$, i.e., the number of $\mathrm{Gal}_{K}$-orbits on $\mathcal{C}_{G}$ is strictly greater than $|S|$.

Consider any nonempty and proper subset $\Sigma \subseteq \mathcal{C}_{G}$ that is $\mathrm{Gal}_{K}$-stable. To apply Runge's method, we need a nonconstant function $\varphi \in K\left(X_{G}\right)$ that satisfies the following properties:

- The poles of $\varphi$ occur only at cusps of $X_{G}$.
- The function $\varphi$ is regular at each cusp in $\Sigma$.
- The function $\varphi$ is a root of a monic polynomial with coefficients in $\mathbb{Z}[j]$.

The existence of a nonconstant function $\varphi \in K\left(X_{G}\right)$ that satisfies the first two properties is an easy consequence of the Riemann-Roch theorem. Since such a function $\varphi$ is integral over $\mathbb{Q}[j]$, we obtain the third property after scaling $\varphi$ by an appropriate positive integer. However, this existence is not enough for our application since we also need good estimates on the function $\varphi$; especially near the cusps.

The functions $\varphi$ used by Bilu and Parent in [BP11] are modular units, i.e., their zeros and poles only occur at cusps. The existence of suitable modular units is not a consequence of the Riemann-Roch theorem but follows from the Manin-Drinfeld theorem. Modular units can be explicitly constructed by taking products and quotients of Siegel functions; these have many nice properties and have an explicit $q$-expansion at each cusp. One downside to dealing with modular units is that they can have poles of high order and their $q$-expansion can have relatively large coefficients. For example in the proof of Bilu and Parent, modular units on $X_{G}$ arise for which the order of the poles might not be uniformly bounded by a polynomial in $N$.

Let $\Delta$ be the modular discriminant function; it is a cusp form of weight 12 for $\mathrm{SL}_{2}(\mathbb{Z})$ that is everywhere nonzero when viewed as a function of the complex upper half-plane. For a function $\varphi \in K\left(X_{G}\right)$ whose poles only occur at cusps, $\varphi \cdot \Delta^{m}$ will be a modular form of weight $12 m$ on $\Gamma(N)$ for all sufficiently large $m$.

Now fix a positive integer $m$. Consider the finite dimensional $K_{G}$-vector space $M_{12 m, G}$ consisting of those modular forms $f$ of weight $12 m$ on $\Gamma(N)$ for which $f / \Delta^{m}$ lies in $K_{G}\left(X_{G}\right)$. For each $f \in M_{12 m, G}$, the function $f / \Delta^{m} \in K_{G}\left(X_{G}\right)$ has no poles away from the cusps. One advantage of such functions is that they have a uniformly bounded number of poles; in fact, they have fewer than $m N^{3} / 2$ total poles when counted with multiplicity.

Let $W_{m}$ be the $K_{G}$-subspace of $M_{12 m, G}$ consisting of modular forms $f$ for which $f / \Delta^{m} \in K_{G}\left(X_{G}\right)$ is regular at each cusp $c \in \Sigma$. For a fixed $f \in W_{m}, \varphi:=f / \Delta^{m} \in K_{G}\left(X_{G}\right)$ will have all its poles at cusps and will be regular at all $c \in \Sigma$. Since we want $\varphi$ to be nonconstant, we will also want to choose $f$ so that so that it does not lie in the 1-dimensional subspace $K_{G} \Delta^{m}$. By taking $m$ sufficiently large, we will see from the Riemann-Roch theorem that $\operatorname{dim}_{K_{G}} W_{m} \geq 2$ and hence we can find a suitable $f$. This is the source of our functions $\varphi$ in this paper.

However, to understand the growth of $\varphi$ near the cusps of $X_{G}$, we need to have suitable explicit bounds on the coefficients of the $q$-expansion of $f$ at each cusp. As a first step, we will find a basis of the vector space $M_{12 m, G}$ for which the $q$-expansions at each cusp have coefficients in $\mathbb{Z}\left[\zeta_{N}\right]$ which can be explicitly bounded with respect to any absolute value of $\mathbb{Q}\left(\zeta_{N}\right)$. Our basis will be expressed in terms of Eisenstein series of weight 1 on $\Gamma(N)$. We then use a version of Siegel's lemma to show the existence of a modular form $f \in W_{m}-K_{G} \Delta^{m}$ with explicit bounds on the coefficients of the $q$-expansion at each cusp.

Let us give a brief overview of the sections of the paper. In §2, we give background on modular curves. In $\S 3$, we will show how around each cusp of $X_{G}$ we can express rational functions analytically with respect to different places $v$. In $\S 4$, we state a theorem about the existence of a function $\varphi \in K\left(X_{G}\right)$ with the required properties. Assuming the existence of such a function $\varphi$, we then prove Theorem $1.1 \mathrm{in} \S 5$. The existence of the desired $\varphi$ is proved in $\S 10$ after several sections on modular forms.

In $\S 6$, we give some background on modular forms. In particular, we define the vector spaces $M_{k, G}$ of modular forms in $\S 6.3$ and we give an explicit generating set for $M_{k, G}$ in terms of Eisenstein series in $\S 6.5$. Using this generating set, we prove in $\S 7$ the existence of a basis of $M_{k, G}$ whose $q$-expansions at each cusp have integral coefficients that can be bounded explicitly. In $\S 8$, we define the subspace $W_{m}$ of $M_{12 m, G}$ for each positive integer $m$ and use the Riemann-Roch to show that $\operatorname{dim}_{K_{G}} W_{m} \geq 2$ for $m$ large enough. For $m$ large enough, we prove in $\S 9$ the existence of a modular form $f \in W_{m}-K_{G} \Delta^{m}$ so that its $q$-expansions at the cusps have integral coefficients that can be bounded explicitly.
1.2. Notation. Let $\zeta_{N}$ be the primitive $N$-th root of unity $e^{2 \pi i / N}$ in $\mathbb{C}$. For each positive integer $N$, we define $q_{N}:=e^{2 \pi i \tau / N}$ which we view as a function in $\tau$ of the complex upper half-plane. When used with $q$-expansions, we will often view $q_{N}$ as an indeterminate variable. For a positive divisor $w$ of $N$, we have $q_{N}^{N / w}=q_{w}$. We set $q:=q_{1}$.

For a field $K$, we define $\operatorname{Gal}_{K}:=\operatorname{Gal}(\bar{K} / K)$, where $\bar{K}$ is a fixed algebraic closure of $K$. When $K \subseteq \mathbb{C}$, we will always take $\bar{K}$ to be the algebraic closure in $\mathbb{C}$.

Consider a number field $L$. We let $M_{L}$ be the set of places of $L$. We let $M_{L, \infty} \subseteq M_{L}$ be the set of infinite places. Take any place $v$ of $L$. We let $L_{v}$ be the completion of $L$ with respect to $v$. We let $|\cdot|_{v}$ be the corresponding absolute value on $L_{v}$ normalized so that $|2|_{v}=2$ if $v$ is infinite and $|p|_{v}=p^{-1}$ if $v$ induces the $p$-adic topology on $\mathbb{Q}$. For an algebraic closure $\bar{L}_{v}$ of $L_{v}$, the absolute value $|\cdot|_{v}$ uniquely extends to it. Define the integer $d_{v}=\left[L_{v}: \mathbb{Q}_{v}\right]$, where $\mathbb{Q}_{v}$ is the completion of $\mathbb{Q}$ in $L_{v}$. For any nonzero $a \in L$, we have the product formula $\prod_{v \in M_{L}}|a|_{v}^{d_{v}}=1$.

Let $C$ be a smooth projective and geometrically irreducible curve defined over a field $K$. For any point $c \in C(K)$, let $\operatorname{ord}_{c}: K(C) \rightarrow \mathbb{Z} \cup\{+\infty\}$ be the discrete valuation whose valuation ring consists of the rational functions that are regular at $c$.

## 2. Background: modular curves

Fix a positive integer $N$ and a group $G \subseteq \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. The goal of this section is to give a quick definition of the modular curve $X_{G}$. While we could define $X_{G}$ as a coarse moduli space, we will instead define it by explicitly giving its function field.

Let $(\mathbb{Z} / N \mathbb{Z})^{\times} \xrightarrow{\sim} \operatorname{Gal}\left(\mathbb{Q}\left(\zeta_{N}\right) / \mathbb{Q}\right), d \mapsto \sigma_{d}$ be the group isomorphism for which $\sigma_{d}\left(\zeta_{N}\right)=\zeta_{N}^{d}$. We define $K_{G}=\mathbb{Q}\left(\zeta_{N}\right)^{\operatorname{det}(G)}$ to be the subfield of $\mathbb{Q}\left(\zeta_{N}\right)$ fixed by $\sigma_{d}$ for all $d \in \operatorname{det}(G)$.
2.1. Modular functions. The group $\mathrm{SL}_{2}(\mathbb{Z})$ acts by linear fractional transformations on the complex upper half-plane $\mathcal{H}$ and the extended upper half-plane $\mathcal{H}^{*}=\mathcal{H} \cup \mathbb{Q} \cup\{\infty\}$. Let $\Gamma$ be a congruence subgroup of $\mathrm{SL}_{2}(\mathbb{Z})$. The quotient $\mathcal{X}_{\Gamma}:=\Gamma \backslash \mathcal{H}^{*}$ is a smooth compact Riemann surface (away from the cusps and elliptic points, use the analytic structure coming from $\mathcal{H}$ and extend to the full quotient). Denote the field of meromorphic functions on $\mathcal{X}_{\Gamma}$ by $\mathbb{C}\left(\mathcal{X}_{\Gamma}\right)$.

Fix a positive integer $N$ and let $\Gamma(N)$ be the congruence subgroup of $\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ consisting of matrices that are congruent to the identity modulo $N$. Every $f \in \mathbb{C}\left(\mathcal{X}_{\Gamma(N)}\right)$ gives rise to a meromorphic function on $\mathcal{H}$ that satisfies

$$
f(\tau)=\sum_{n \in \mathbb{Z}} a_{n}(f) q_{N}^{n}
$$

for all $\tau \in \mathcal{H}$ with sufficiently large imaginary component, where $q_{N}:=e^{2 \pi i \tau / N}$ and the $a_{n}(f)$ are unique complex numbers which are nonzero for only finitely many $n<0$. This Laurent series in $q_{N}$ is called the $q$-expansion of $f$ (at the cusp at infinity) and it determines $f$ uniquely. Let $\mathcal{F}_{N}$ be the subfield of $\mathbb{C}\left(\mathcal{X}_{\Gamma(N)}\right)$ consisting of all meromorphic functions $f$ for which $a_{n}(f)$ lies in $\mathbb{Q}\left(\zeta_{N}\right)$ for all $n \in \mathbb{Z}$. For example, $\mathcal{F}_{1}=\mathbb{Q}(j)$, where $j$ is the modular $j$-invariant.

We now describe a right action $*$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ on $\mathcal{F}_{N}$. Note that the following two lemmas are both consequences of Theorem 6.6 and Proposition 6.9 of [Shi94].

Lemma 2.1. There is a unique right action $*$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ on the field $\mathcal{F}_{N}$ such that the following hold for all $f \in \mathcal{F}_{N}$ :

- For $A \in \operatorname{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$, we have $(f * A)(\tau)=f(\gamma \tau)$, where $\gamma \in \mathrm{SL}_{2}(\mathbb{Z})$ is any matrix congruent to $A$ modulo $N$.
- For $A=\left(\begin{array}{ll}1 & 0 \\ 0 & d\end{array}\right) \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$, the $q$-expansion of $f * A$ is $\sum_{n \in \mathbb{Z}} \sigma_{d}\left(a_{n}(f)\right) q_{N}^{n}$.

For each subgroup $G$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$, let $\mathcal{F}_{N}^{G}$ be the subfield of $\mathcal{F}_{N}$ fixed by $G$ under the action $*$ of Lemma 2.1.

## Lemma 2.2.

(i) The matrix $-I$ acts trivially on $\mathcal{F}_{N}$ and the right action of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z}) /\{ \pm I\}$ on $\mathcal{F}_{N}$ is faithful.
(ii) We have $\mathcal{F}_{N}^{\mathrm{GL}(\mathbb{Z} / N \mathbb{Z})}=\mathcal{F}_{1}=\mathbb{Q}(j)$ and $\mathcal{F}_{N}^{\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})}=\mathbb{Q}\left(\zeta_{N}\right)(j)$.
(iii) The field $\mathbb{Q}\left(\zeta_{N}\right)$ is algebraically closed in $\mathcal{F}_{N}$.
2.2. Modular curves. Take any subgroup $G$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. From Lemma 2.2, we find that the field $\mathcal{F}_{N}^{G}$ has transcendence degree 1 and that $K_{G}$ is the algebraic closure of $\mathbb{Q}$ in $\mathcal{F}_{N}^{G}$. We define the modular curve $X_{G}$ to be the smooth, projective and geometrically irreducible curve over $K_{G}$ that has function field $\mathcal{F}_{N}^{G}$. We have $j \in \mathcal{F}_{N}^{G}=K_{G}\left(X_{G}\right)$ which gives a nonconstant morphism

$$
j: X_{G} \rightarrow \mathbb{P}_{K_{G}}^{1}
$$

whose degree we denote by $\mu$.
Let $\bar{G}$ be the subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ generated by $G$ and $-I$. Observe that $\mathcal{F}_{N}^{G}=\mathcal{F}_{N}^{\bar{G}}$ and hence $X_{G}=X_{\bar{G}}$. We have $\mu=\left[\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z}): \bar{G} \cap \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})\right]$.

Let $\Gamma_{G}$ be the congruence subgroup of $\mathrm{SL}_{2}(\mathbb{Z})$ consisting of those matrices whose image modulo $N$ lies in $\bar{G} \cap \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$; it contains $-I$. We have an inclusion $\mathbb{C} \cdot K_{G}\left(X_{G}\right) \subseteq \mathbb{C}\left(\mathcal{X}_{\Gamma_{G}}\right)$ of fields that both have degree $\mu=\left[\mathrm{SL}_{2}(\mathbb{Z}): \Gamma_{G}\right]$ over $\mathbb{C}(j)$. Therefore, $\mathbb{C}\left(\mathcal{X}_{\Gamma_{G}}\right)=\mathbb{C}\left(X_{G}\right)$. Using this equality of function fields, we shall identify $X_{G}(\mathbb{C})$ with the Riemann surface $\mathcal{X}_{\Gamma_{G}}$.
2.3. Cusps. Fix notation as in $\S 2.2$. Let $\mathcal{C}_{G}$ be the set of cusps of $\mathcal{X}_{\Gamma_{G}}=X_{G}(\mathbb{C})$. i.e., the set of orbits of $\Gamma_{G}$ on $\mathbb{Q} \cup\{\infty\}$ or equivalently the points above $\infty$ under the morphism $j$. We have $\mathcal{C}_{G} \subseteq X_{G}\left(\mathbb{Q}\left(\zeta_{N}\right)\right)$, see Lemma 2.3(ii).

Let $c_{\infty}$ be the cusp at infinity, i.e., the orbit containing $\infty$. We have a bijection

$$
\Gamma_{G} \backslash \mathrm{SL}_{2}(\mathbb{Z}) / U \xrightarrow{\sim} \mathcal{C}_{G}, \quad \Gamma_{G} A U \mapsto A \cdot c_{\infty}
$$

where $U$ is the group of upper triangular matrices in $\mathrm{SL}_{2}(\mathbb{Z})$ generated by $-I$ and $\left(\begin{array}{ll}1 & 1 \\ 0 & 1\end{array}\right)$. Since the level of $\Gamma_{G}$ divides $N$, we find that the cusp $A \cdot c_{\infty}$ of $X_{G}$ depends only on $A$ modulo $N$. In particular, it makes sense to talk about the cusp $A \cdot c_{\infty}$ for any $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$.

Now take any cusp $c \in \mathcal{C}_{G}$. We define $w_{c}$ to be the ramification index of $c$ over $\infty$ with respect to the morphism $j: X_{G} \rightarrow \mathbb{P}_{K_{G}}^{1}$. Equivalently, $w_{c}$ is the width of the cusp $c$ for the congruence subgroup $\Gamma_{G}$. The integer $w_{c}$ divides $N$. Since $\mu$ is the degree of $j: X_{G} \rightarrow \mathbb{P}_{K_{G}}^{1}$, we have

$$
\begin{equation*}
\sum_{c \in \mathcal{C}_{G}} w_{c}=\mu \tag{2.1}
\end{equation*}
$$

Take any $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $A \cdot c_{\infty}=c$. Then for any $f \in \mathbb{C}\left(X_{G}\right)$, the $q$-expansion of $f * A \in \mathcal{F}_{N}$ is a Laurent series in the variable $q_{w_{c}}$.
2.4. The modular curve $X(N)$. Let $X(N)$ be the modular curve corresponding to the subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ consisting of matrices of the form $\left(\begin{array}{cc}1 & 0 \\ 0 & *\end{array}\right)$; it is a curve defined over $\mathbb{Q}$. The group $\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ has a left action on the curve $X(N)_{\mathbb{Q}\left(\zeta_{N}\right)}$ corresponding to the right action on the function field $\mathbb{Q}\left(\zeta_{N}\right)(X(N))=\mathcal{F}_{N}$ given in Lemma 2.1.

## Lemma 2.3.

(i) The cusp $c_{\infty}$ of $X(N)$ is defined over $\mathbb{Q}$.
(ii) For any subgroup $G$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$, we have $\mathcal{C}_{G} \subseteq X_{G}\left(\mathbb{Q}\left(\zeta_{N}\right)\right)$. The set $\mathcal{C}_{G}$ is stable under the action of $\operatorname{Gal}\left(\mathbb{Q}\left(\zeta_{N}\right) / K_{G}\right)$.
Proof. Let $\mathcal{C}$ be the set of cusps of in $X(N)(\mathbb{C})$. From [Zyw24, Lemma 5.2], we find that $\mathcal{C} \subseteq X(N)\left(\mathbb{Q}\left(\zeta_{N}\right)\right)$ and that $c_{\infty}$ is defined over $\mathbb{Q}$. Take any subgroup $G \subseteq \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ and let $\pi: X(N)_{\mathbb{Q}\left(\zeta_{N}\right)} \rightarrow\left(X_{G}\right)_{\mathbb{Q}\left(\zeta_{N}\right)}$ be the morphism corresponding to the inclusion $\mathbb{Q}\left(\zeta_{N}\right)\left(X_{G}\right) \subseteq \mathcal{F}_{N}=\mathbb{Q}\left(\zeta_{N}\right)(X(N))$ of function fields. We have $\pi(\mathcal{C})=\mathcal{C}_{G}$. Therefore, $\mathcal{C}_{G} \subseteq \pi\left(X(N)\left(\mathbb{Q}\left(\zeta_{N}\right)\right) \subseteq X_{G}\left(\mathbb{Q}\left(\zeta_{N}\right)\right)\right.$, where the last equality uses that $\pi$ is defined over $\mathbb{Q}\left(\zeta_{N}\right)$. Since $j: X_{G} \rightarrow \mathbb{P}_{K_{G}}^{1}$ is defined over $K_{G}$, the set $j^{-1}(\infty)=\mathcal{C}_{G} \subseteq X_{G}\left(\mathbb{Q}\left(\zeta_{N}\right)\right)$ is stable under the action of $\operatorname{Gal}\left(\mathbb{Q}\left(\zeta_{N}\right) / K_{G}\right)$.
Remark 2.4. Suppose that $N>2$. The modular curve $X(N)_{\mathbb{Q}\left(\zeta_{N}\right)}$ has an alternate description as a fine moduli space. We refer to Deligne and Rapoport [DR73] where this theory is fully developed. They define a smooth projective curve $M_{N}$ over $\mathbb{Q}\left(\zeta_{N}\right)$ that is the moduli space for generalized elliptic curves with a level $N$ structure (we use $N>2$ to ensure the moduli problem is represented by a scheme and we have also base extended to $\mathbb{Q}\left(\zeta_{N}\right)$ from the ring $\left.\mathbb{Z}\left[1 / N, \zeta_{N}\right]\right)$. The curve $M_{N}$ has $\phi(N)$ irreducible components. Our curve $X(N)_{\mathbb{Q}\left(\zeta_{N}\right)}$ can be identified with an irreducible $C$ component of $M_{N}$ (in particular, the irreducible component consisting of generalized elliptic curves with a level $N$ structure so that the Weil pairing of the basis is $\zeta_{N}$ ). To prove this identification one need only identify the function field of $C$ with $\mathcal{F}_{N}=$ $\mathbb{Q}\left(\zeta_{N}\right)(X(N))$; thus can be done using the material in [DR73, Chapter VII, §4] which compares modular forms with the classical theory.

For every $f \in \mathbb{Q}(X(N))$, its $q$-expansion (at $\left.c_{\infty}\right)$ lies in $\mathbb{Q}\left(\left(q_{N}\right)\right)$ and it lies in $\mathbb{Q} \llbracket q_{N} \rrbracket$ when $f$ is regular at $c_{\infty}$. So with $\mathcal{O}$ the local ring of rational functions on $X(N)$ that are regular at $c_{\infty}, q$-expansions induces an isomorphism between the completion of $\mathcal{O}$ with $\mathbb{Q} \llbracket q_{N} \rrbracket$. Equivalently, $q$-expansions induces an isomorphism between the formal completion of the curve $X(N)$ along $c_{\infty}$ with the formal spectrum of $\mathbb{Q} \llbracket q_{N} \rrbracket$.

Now consider any field $F \supseteq \mathbb{Q}$. If $\mathcal{O}$ is the local ring of rational functions on $X(N)_{F}$ that are regular at $c_{\infty}$, then we obtain an isomorphism between the completion of $\mathcal{O}$ with $F \llbracket q_{N} \rrbracket$. So for any $f \in F\left(X(N)_{F}\right)=$ $F(X(N))$, we obtain a $q$-expansion in $F\left(\left(q_{N}\right)\right)$ that lies in $F \llbracket q_{N} \rrbracket$ when $f$ is regular at $c_{\infty}$.

Consider any field $F \supseteq \mathbb{Q}\left(\zeta_{N}\right)$. The group $\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ acts on $X(N)_{F}$ and hence acts on $F(X(N))$. The field $F(X(N))$ is the compositum of $F$ and $\mathcal{F}_{N}$. The group $\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ acts on the field $F(X(N))$ as the identity on $F$ and as our action $*$ on $\mathcal{F}_{N}$; we also denote this action by $*$.

## 3. Analytic expansions at the cusps

Fix an integer $N>2$. Fix a number field $L \supseteq \mathbb{Q}\left(\zeta_{N}\right)$ and a place $v$ of $L$.
Take any cusp $c$ of $X(N)$ and choose an $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $A \cdot c_{\infty}=c$. Consider a rational function $f$ in $\bar{L}_{v}(X(N))$. As noted in $\S 2.4, f * A$ has a $q$-expansion in $\bar{L}_{v}\left(\left(q_{N}\right)\right)$ that we denote by $\sum_{n \in \mathbb{Z}} a_{n}(f * A) q_{N}^{n}$. We will show that for all points in $X(N)\left(\bar{L}_{v}\right)$ near $c$, but maybe not equal to $c$, the function $f$ can be expressed analytically in terms of the Laurent series of the the $q$-expansion of $f * A$. In order to make this precise, we will define a subset $\Omega_{c, v} \subseteq X(N)\left(\bar{L}_{v}\right)$ that only contains the one cusp $c$ and whose interior is an open neighborhood of $c$.

For a subgroup $G$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$, we will also define similar subsets $\Omega_{c, v}$ of $X_{G}\left(\bar{L}_{v}\right)$ in $\S 3.2$.
3.1. The modular curve $X(N)$. As noted in §2.4, the group $\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ acts on $X(N)_{F}$ and $F(X(N))$ for any field $F \supseteq \mathbb{Q}\left(\zeta_{N}\right)$. For each $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$, let $\iota_{A}$ be the corresponding automorphism of $X(N)_{\mathbb{Q}\left(\zeta_{N}\right)}$. For any place $v$ of $L, \iota_{A}$ gives a homeomorphism $X(N)\left(\bar{L}_{v}\right) \xrightarrow{\sim} X(N)\left(\bar{L}_{v}\right)$. Define the open ball $B_{v}:=\{a \in$ $\left.\bar{L}_{v}:|a|_{v}<1\right\}$ of $\bar{L}_{v}$.
Proposition 3.1. Fix a place $v$ of $L$. Take a matrix $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ and define the cusp $c:=A \cdot c_{\infty}$ of $X(N)$. Then there is a unique continuous map

$$
\psi_{A, v}: B_{v} \rightarrow X(N)\left(\bar{L}_{v}\right)
$$

such that the following hold:
(a) Take any rational function $f \in \bar{L}_{v}(X(N))$ and let $r$ be the radius of convergence of the power series $\sum_{n=0}^{\infty} a_{n}(f * A) x^{n}$ in $\bar{L}_{v} \llbracket x \rrbracket$. Then for all nonzero $t \in B_{v}$ with $|t|_{v}<r$, we have

$$
f\left(\psi_{A, v}(t)\right)=\sum_{n \in \mathbb{Z}} a_{n}(f * A) t^{n}
$$

in $\bar{L}_{v}$.
(b) We have $\psi_{A, v}(0)=c$. For any nonzero $t \in B_{v}, \psi_{A, v}(t)$ is not a cusp and

$$
j\left(\psi_{A, v}(t)\right)=J\left(t^{N}\right)
$$

in $\bar{L}_{v}$, where $J(q)=q^{-1}+744+196884 q+21493760 q^{2}+\cdots \in \mathbb{Z}((q))$ is the $q$-expansion of $j$. When $v$ is finite, we have $\left|j\left(\psi_{A, v}(t)\right)\right|_{v}=|t|_{v}^{-N}>1$ for all nonzero $t \in B_{v}$.
We have $\psi_{A, v}=\iota_{A} \circ \psi_{I, v}$.
Proof. We first assume that there is a unique continuous map $\psi_{I, v}: B_{v} \rightarrow X(N)\left(\bar{L}_{v}\right)$ satisfying (a) and (b). Define the continuous map $\psi_{A, v}:=\iota_{A} \circ \psi_{I, v}: B_{v} \rightarrow X(N)\left(\bar{L}_{v}\right)$. We have $\psi_{A, v}(0)=\iota_{A}\left(\psi_{I, v}(0)\right)=\iota_{A}\left(c_{\infty}\right)=$ $A \cdot c_{\infty}=c$. Take any $f \in \bar{L}_{v}(X(N))$. We have $f * A \in \bar{L}_{v}(X(N))$. Let $r$ be the radius of convergence of $\sum_{n=0}^{\infty} a_{n}(f * A) x^{n} \in \bar{L}_{v} \llbracket x \rrbracket$. For any nonzero $t \in B_{v}$ with $|t|_{v}<r$, we have

$$
f\left(\psi_{A, v}(t)\right)=f\left(\iota_{A}\left(\psi_{I, v}(t)\right)=(f * A)\left(\psi_{I, v}(t)\right)=\sum_{n \in \mathbb{Z}} a_{n}(f * A) t^{n} \in \bar{L}_{v},\right.
$$

where the last equality uses our assumption that $\psi_{I, v}$ exists with the expected properties. For any nonzero $t \in B_{v}$, we also have $j\left(\psi_{A, v}(t)\right)=j\left(\iota_{A}\left(\psi_{I, v}(t)\right)\right)=(j * A)\left(\psi_{I, v}(t)\right)=j\left(\psi_{I, v}(t)\right)$. So (b) holds for $\psi_{A, v}$ by the corresponding property that we have assumed holds for $\psi_{I, v}$. Therefore, $\psi_{A, v}$ satisfies (a) and (b).

We now show that $\psi_{A, v}$ is unique. A similar argument as above shows that for any continuous $\psi_{A, v}$ satisfying (a) and (b), the map $\iota_{A}^{-1} \circ \psi_{A, v}: B_{v} \rightarrow X(N)\left(\bar{L}_{v}\right)$ is continuous and satisfies the same properties (a) and (b) as $\psi_{I, v}$. By our assumption that $\psi_{I, v}$ is unique, we deduce that $\psi_{I, v}=\iota_{A}^{-1} \circ \psi_{A, v}$. This proves the uniqueness of $\psi_{A, v}$ and that $\psi_{A, v}=\iota_{A} \circ \psi_{I, v}$.

So without loss of generality, we may assume that $A=I$ and hence $c=c_{\infty}$.
Before starting the case where $v$ is infinite, let us recall the classic situation over $\mathbb{C}$. Define $B:=\{t \in \mathbb{C}$ : $|t|<1\}$. Let

$$
\pi: \mathcal{H} \cup\{\infty\} \rightarrow \Gamma(N) \backslash \mathcal{H}^{*}=\mathcal{X}_{\Gamma(N)}=X(N)(\mathbb{C})
$$

be the natural quotient map with the last equality being the identification from $\S 2.2$. The map $\pi$ can be expressed as the composition of $\mathcal{H} \cup\{\infty\} \rightarrow B, \tau \mapsto e^{2 \pi i \tau / N}$ (where $\infty \mapsto 0$ ) with a unique function
$\psi: B \rightarrow X(N)(\mathbb{C})$. The map $\psi$ is continuous and its image is all of $X(N)(\mathbb{C})$ except for those cusps that are not $c_{\infty}$. We have $\psi(0)=c_{\infty}$ and $\psi(t)$ is not a cusp for all nonzero $t \in B$. Take any $f \in \mathbb{C}(X(N))=\mathbb{C}\left(\mathcal{X}_{\Gamma(N)}\right)$ that is regular at $c_{\infty}$. Let $\sum_{n \in \mathbb{Z}} a_{n}(f) q_{N}^{n} \in \mathbb{C}\left(\left(q_{N}\right)\right)$ be the $q$-expansion of $f$ and let $r$ be its radius of convergence of $\sum_{n=0}^{\infty} a_{n}(f) x^{n} \in \mathbb{C} \llbracket x \rrbracket$. Take any nonzero $t \in B$ with $|t|<r$ and choose a $\tau \in \mathcal{H}$ for which $t=e^{2 \pi i \tau / N}$. We have

$$
f(\psi(t))=(f \circ \pi)(\tau)=\sum_{n \in \mathbb{Z}} a_{n}(f) e^{2 \pi i \tau n / N}=\sum_{n \in \mathbb{Z}} a_{n}(f) t^{n}
$$

In the special case $f=j$, we have a $q$-expansion $J(q)=q^{-1}+744+\cdots \in \mathbb{Z} \llbracket q \rrbracket$ and hence $j(\psi(t))=J\left(t^{N}\right)$ for all nonzero $t \in B_{v}$.

We now consider the case where $v$ is infinite. Fix an embedding $\sigma: L \hookrightarrow \mathbb{C}$ that satisfies $|a|_{v}=|\sigma(a)|$ for all $a \in L$. By continuity, $\sigma$ extends uniquely to an isomorphism $\bar{\sigma}: \bar{L}_{v}=L_{v} \xrightarrow{\sim} \mathbb{C}$ of fields that respects absolute values (the field $L_{v}$ is not real since it contains $\zeta_{N}$ with $\left.N>2\right)$. Since $X(N)$ and the cusp $c_{\infty}$ are defined over $\mathbb{Q}, \bar{\sigma}$ induces a homeomorphism $\bar{\sigma}_{*}: X(N)\left(\bar{L}_{v}\right) \xrightarrow{\sim} X(N)(\mathbb{C})$ that maps $c_{\infty}$ to itself. Define the continuous function

$$
\psi_{I, v}: B_{v} \xrightarrow{\sim} B \xrightarrow{\psi} X(N)(\mathbb{C}) \xrightarrow{\sim} X(N)\left(\bar{L}_{v}\right),
$$

where the first map is given by $\bar{\sigma}$ and the third map is the inverse of $\bar{\sigma}_{*}$. The image of $\psi_{I, v}$ is equal to $X(N)\left(\bar{L}_{v}\right)$ with all the cusps except $c_{\infty}$ removed since $\psi$ has this property. The desired properties for $\psi_{I, v}$ are now immediate consequences of the analogous properties of $\psi$.

The process of $q$-expansions induces an isomorphism between the formal completion of the curve $X(N)_{\mathbb{Q}\left(\zeta_{N}\right)}$ along $c_{\infty}$ with the formal spectrum of $\mathbb{Q}\left(\zeta_{N}\right) \llbracket q_{N} \rrbracket$. We will require a stronger version of Deligne and Rapoport that we now recall. Define the ring $R:=\left(\mathbb{Z}\left[\zeta_{N}\right] \llbracket q_{N} \rrbracket\right) \otimes_{\mathbb{Z}\left[\zeta_{N}\right]} \mathbb{Q}\left(\zeta_{N}\right)$; we can view it as a subring of $\mathbb{Q}\left(\zeta_{N}\right) \llbracket q_{N} \rrbracket$. From Deligne and Rapoport [DR73, Chapter VII, Corollary 2.4] with Remark 2.4, the Tate curve produces a morphism

$$
\begin{equation*}
\operatorname{Spec} R \rightarrow X(N)_{\mathbb{Q}\left(\zeta_{N}\right)} \tag{3.1}
\end{equation*}
$$

that induces an isomorphism between the formal completion of $X(N)_{\mathbb{Q}\left(\zeta_{N}\right)}$ along $c_{\infty}$ and the formal spectrum of $\mathbb{Q}\left(\zeta_{N}\right) \llbracket q_{N} \rrbracket$.

We now consider a finite place $v$ of $L$. Define the $\bar{L}_{v}$-algebra $R^{\prime}:=R \otimes_{\mathbb{Q}\left(\zeta_{N}\right)} \bar{L}_{v}$. Take any $t \in B_{v}$. Evaluating the power series in $R^{\prime} \subseteq \bar{L}_{v} \llbracket q_{n} \rrbracket$ at $t$ gives a homomorphism $\phi_{t}: R^{\prime} \rightarrow \bar{L}_{v}$ of $\bar{L}_{v^{\prime}}$ algebras. Composing $\phi_{t}^{*}: \operatorname{Spec} \bar{L}_{v} \rightarrow \operatorname{Spec} R^{\prime}$ with the morphism $\operatorname{Spec} R^{\prime} \rightarrow X(N)_{\bar{L}_{v}}$ obtained from base changing (3.1) produces a point $\psi_{I, v}(t)$ in $X(N)\left(\bar{L}_{v}\right)$. We thus have defined a map

$$
\psi_{I, v}: B_{v} \rightarrow X(N)\left(\bar{L}_{v}\right)
$$

and it is continuous. Note that $\psi_{I, v}(0)=c$.
Take any $t \in B_{v}$ and let $R_{t}$ be the subring of $\bar{L}_{v} \llbracket q_{N} \rrbracket$ consisting of those series whose radius of convergence is strictly greater than $|t|_{v}$. By base changing (3.1) by $\bar{L}_{v}$ and using the inclusion $R^{\prime} \subseteq R_{t}$, we obtain a morphism Spec $R_{t} \rightarrow X(N)_{\bar{L}_{v}}$ that induces an isomorphism between the formal completion of $X(N)_{\bar{L}_{v}}$ at $c_{\infty}$ and the formal spectrum of the power series ring $\bar{L}_{v} \llbracket q_{N} \rrbracket$. Evaluating power series in $R_{t}$ at $t$ induces a morphism $\operatorname{Spec} \bar{L}_{v} \rightarrow \operatorname{Spec} R_{t}$ which after composing with $\operatorname{Spec} R_{t} \rightarrow X(N)_{\bar{L}_{v}}$ gives the $\bar{L}_{v}$-point $\psi_{I, v}(t)$. So for any rational function $f \in \bar{L}_{v}(X(N))$ regular at $c_{\infty}$ for which $\sum_{n=0}^{\infty} a_{n}(f) q_{N}^{n} \in \bar{L}_{v} \llbracket x \rrbracket$ lies in $R_{t}$, we have $f\left(\psi_{I, v}(t)\right)=\sum_{n=0}^{\infty} a_{n}(f) t^{n}$.

The function $j^{-1}$ is regular at $c_{\infty}$ and its $q$-expansion is $h(q):=J(q)^{-1}=q-744 q^{2}+\cdots \in \mathbb{Z} \llbracket q \rrbracket \subseteq R$. Take any nonzero $t \in B_{v}$. We have $j^{-1}\left(\psi_{I, v}(t)\right)=t^{N}-744 t^{2 N}+\cdots=h\left(t^{N}\right)$ in $\bar{L}_{v}$. Since $|t|_{v}<1$, this series implies that $\left|j^{-1}\left(\psi_{I, v}(t)\right)\right|_{v}=|t|_{v}^{N}$. In particular, $j^{-1}\left(\psi_{I, v}(t)\right)$ is nonzero since $t$ is nonzero. Therefore, $\psi_{I, v}(t)$ is not a cusp and $j\left(\psi_{I, v}(t)\right)=h\left(t^{N}\right)^{-1}=J\left(t^{N}\right)$. We have also shown that $\left|j\left(\psi_{I, v}(t)\right)\right|_{v}=|t|_{v}^{-N}>1$.

We have now shown that $\psi_{I, v}: B_{v} \rightarrow X(N)\left(\bar{L}_{v}\right)$ satisfies (b). It also satisfies (a) since we have shown that (a) holds for $f \in \bar{L}_{v}(x(N))$ regular at $c_{\infty}$ and for $j$ (for any $f \in \bar{L}_{v}(X(N)$ ), there is an integer $m$ for which $f \cdot j^{m}$ is regular at $c$ ).

Finally, it remains to prove the uniqueness of $\psi_{I, v}$; we have already proved the existence. For $\tau \in \mathcal{H}$, let $\wp(z ; \tau)$ be the Weierstrass elliptic function for the lattice $\mathbb{Z} \tau+\mathbb{Z} \subseteq \mathbb{C}$. For integers $0 \leq r, s<N$ that are not
both zero, define the function $x_{(r, s)}(\tau):=36 E_{4}(\tau) E_{6}(\tau) \Delta(\tau)^{-1} \cdot(2 \pi i)^{-2} \wp\left(\frac{r}{N} \cdot \tau+\frac{s}{N} ; \tau\right)$, where $E_{4}$ and $E_{6}$ are the usual Eisenstein series of weight 4 and 6 , respectively, on $\mathrm{SL}_{2}(\mathbb{Z})$. The function $x_{(r, s)}$ lies in $\mathcal{F}_{N}$ with cusps only at the poles, see [Zyw24, Lemma 6.1]. The $q$-expansion of $12 \cdot(2 \pi i)^{-2} \wp\left(\frac{r}{N} \cdot \tau+\frac{s}{N} ; \tau\right)$ is of the form $\sum_{n=0}^{\infty} a_{n} q_{N}^{n}$ with $a_{n} \in \mathbb{Z}\left[\zeta_{N}\right]$ and $\left|a_{n}\right|_{v} \ll n$ for $n \geq 1$, see the proof of [Zyw24, Lemma 6.1] for the explicit $q$-expansion. From this, we deduce that the $q$-expansion of each $x_{(r, s)}$ will have coefficients in $\mathbb{Q}\left(\zeta_{N}\right) \subseteq L$ and will have radius of convergence at least 1 when viewed as having coefficients in $\bar{L}_{v}$. In particular, the value $x_{(r, s)}\left(\psi_{I, v}(t)\right)$ depends only on $t$ by (a) (and not the choice of $\left.\psi_{I, v}\right)$. By (b), $j\left(\psi_{I, v}(t)\right)$ also depends only on $t$. However, the functions $x_{(r, s)}$ along with $j$ generate the field $\mathcal{F}_{N}$, cf. [Zyw24, Lemma 6.1], and hence also generate $\bar{L}_{v}(X(N))$ over $\bar{L}_{v}$. This implies that $\psi_{I, v}(t)$ does not depend on the choice of $\psi_{I, v}$.

Let $\mathcal{C}$ be the set of cusps of $X(N)$; it is a subset of $X(N)(L)$ by Lemma 2.3(ii). Take any cusp $c \in \mathcal{C}$ and any place $v$ of $L$. Choose an $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $A \cdot c_{\infty}=c$. With $\psi_{A, v}$ as in Proposition 3.1, define the following subset of $X(N)\left(\bar{L}_{v}\right)$ :

$$
\Omega_{c, v}:= \begin{cases}\psi_{A, v}\left(B_{v}\right) & \text { if } v \text { is finite } \\ \psi_{A, v}\left(\left\{t \in \bar{L}_{v}:|t|_{v} \leq e^{-\pi \sqrt{3} / N}\right\}\right) & \text { if } v \text { is infinite }\end{cases}
$$

The only cusp in the set $\Omega_{c, v}$ is $c$.
Lemma 3.2. Take any place $v$ of $L$.
(i) For each cusp $c \in \mathcal{C}, \Omega_{c, v}$ does not depend on the choice of $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $A \cdot c_{\infty}=c$.
(ii) If $v$ is finite, then $\bigcup_{c \in \mathcal{C}} \Omega_{c, v}=\left\{P \in X(N)\left(\bar{L}_{v}\right): P\right.$ a cusp or $\left.|j(P)|_{v}>1\right\}$.
(iii) If $v$ is infinite, then $\bigcup_{c \in \mathcal{C}} \Omega_{c, v}=X(N)\left(\bar{L}_{v}\right)$.

Proof. Consider any integer $b$. We have $e^{2 \pi i(\tau+b) / N}=\zeta_{N}^{b} q_{N}$. So for a matrix $U= \pm\left(\begin{array}{ll}1 & b \\ 0 & 1\end{array}\right) \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ and a function $f \in \mathcal{F}_{N}$, the $q$-expansion of $f * U$ is $\sum_{n \in \mathbb{Z}} a_{n}(f * U) q_{N}^{n}=\sum_{n \in \mathbb{Z}} a_{n}(f) \zeta_{N}^{b n} q_{N}^{n}$. The same thing thus holds for the $q$-expansion of $f * U$ for any $f \in \bar{L}_{v}(X(N))$.

Take any matrices $A, A^{\prime} \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $A \cdot c_{\infty}=A^{\prime} \cdot c_{\infty}$. We have $A=A^{\prime} \cdot U$ for some matrix $U$ of the form $\pm\left(\begin{array}{ll}1 & b \\ 0 & 1\end{array}\right)$. For any $f \in \bar{L}_{v}(X(N))$, the $q$-expansion of $f * A$ is $\sum_{n \in \mathbb{Z}} a_{n}(f * A) q_{N}^{n}=$ $\sum_{n \in \mathbb{Z}} a_{n}\left(\left(f * A^{\prime}\right) * U\right) q_{N}^{n}=\sum_{n \in \mathbb{Z}} a_{n}\left(f * A^{\prime}\right) \zeta_{N}^{b n} q_{N}^{n}$. From the uniqueness of $\psi_{A, v}$ in Proposition 3.1, we deduce that $\psi_{A, v}(t)=\psi_{A^{\prime}, v}\left(\zeta_{N}^{b} t\right)$ for all $t \in B_{v}$. Part (i) follows immediately since $\left|\zeta_{N}^{b}\right|_{v}=1$.

Since $\psi_{A, v}=\iota_{A} \circ \psi_{I, v}$ by Proposition 3.1, we find that $\mathcal{S}:=\bigcup_{c \in \mathcal{C}} \Omega_{c, v}$ is equal to the set

$$
\bigcup_{\operatorname{SL}_{2}(\mathbb{Z} / N \mathbb{Z})} \iota_{A}\left(\Omega_{c_{\infty}, v}\right) .
$$

In particular, $\mathcal{S} \subseteq X(N)\left(\bar{L}_{v}\right)$ is stable under the action of $\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$. Since $\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ acts transitively on the fibers of $j: X(N)\left(\bar{L}_{v}\right) \rightarrow \mathbb{P}^{1}\left(\bar{L}_{v}\right)$, we have

$$
\begin{equation*}
\mathcal{S}=\left\{P \in X(N)\left(\bar{L}_{v}\right): j(P) \in j(\mathcal{S})\right\} \tag{3.2}
\end{equation*}
$$

Since $\mathcal{S}$ contains all the cusps $\mathcal{C}$, we need only compute the set $j(\mathcal{S}-\mathcal{C}) \subseteq \bar{L}_{v}$ to prove (ii) and (iii).
First suppose that $v$ is finite. We have $j(\mathcal{S}-\mathcal{C}) \subseteq\left\{a \in \bar{L}_{v}:|a|_{v}>1\right\}$ by Proposition 3.1(b). Now take any $a \in \bar{L}_{v}$ with $|a|_{v}>1$. By [Sil94, Chapter V Lemma 5.1], there is a nonzero $t \in \bar{L}_{v}$ with $|t|_{v}<1$ such that $a=J\left(t^{N}\right)$ with $J$ as in Proposition 3.1(b). By Proposition 3.1(b), we have $a=J\left(t^{N}\right)=j\left(\psi_{I, v}(t)\right) \in j(\mathcal{S}-\mathcal{C})$. Therefore, $j(\mathcal{S}-\mathcal{C})=\left\{a \in \bar{L}_{v}:|a|_{v}>1\right\}$ and hence we obtain (ii) from (3.2).

Finally suppose that $v$ is infinite. Using (3.2), we need only verify that $j(\mathcal{S}-\mathcal{C})=\bar{L}_{v}$ to prove part (iii). We have

$$
j(\mathcal{S}-\mathcal{C})=\bigcup_{c \in \mathcal{C}} j\left(\Omega_{c, v}-\{c\}\right)=\left\{J\left(t^{N}\right): t \in \bar{L}_{v}-\{0\},|t|_{v} \leq e^{-\pi \sqrt{3} / N}\right\}
$$

where the last equality uses the definition of $\Omega_{c, v}$ and Proposition 3.1(b). So after choosing an isomorphism $\bar{L}_{v} \cong \mathbb{C}$ that respects absolute values, we need only show that every $a \in \mathbb{C}$ is of the form $J\left(t^{N}\right)$ for some nonzero $t \in \mathbb{C}$ with $|t| \leq e^{-\pi \sqrt{3} / N}$. Take any $a \in \mathbb{C}$. There is a $\tau \in \mathcal{H}$ for which $j(\tau)=a$, where we are viewing $j$ as a holomorphic function of the upper half-plane. Using the action of $\mathrm{SL}_{2}(\mathbb{Z})$ on $\mathcal{H}$, we may further assume that $|\tau| \geq 1$ and $-1 / 2 \leq \operatorname{Re}(\tau) \leq 1 / 2$. In particular, $\operatorname{Im}(\tau) \geq \sqrt{3} / 2$. Define
$u=e^{2 \pi i \tau} \in \mathbb{C}$. We have $0<|u| \leq e^{-\pi \sqrt{3}}$. Choose a $t \in \mathbb{C}$ for which $u=t^{N}$. We have $0<|t| \leq e^{-\pi \sqrt{3} / N}$ and $J\left(t^{N}\right)=J(u)=j(\tau)=a$.

Remark 3.3. Consider the cusp $c:=c_{\infty}$. The approach in $\S 3$ of [BP11] is to view $t_{c}:=q_{N}$ as a parameter on $X(N)$ that defines a $v$-analytic function on a neighborhood of $c$ in $X(N)\left(\bar{L}_{v}\right)$ that maps $c$ to 0 . They describe an open neighborhood of $c$ for which their function is defined and analytic; locally it is a homeomorphism whose inverse will agree with the restriction of our function $\psi_{I, v}$. Bilu and Parent take a similar approach for any cusp of a general modular curve $X_{G}$. In the setting of this section, our set $\Omega_{c, v}$ will agree with that in $\S 3$ of [BP11] when $v$ is finite (our sets are larger when $v$ is infinite).
3.2. The sets $\Omega_{c, v}$ for a general modular curve. Take any subgroup $G$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. The modular curve $X_{G}$ is defined over $K_{G} \subseteq \mathbb{Q}\left(\zeta_{N}\right) \subseteq L$. Let $\pi: X(N)_{\mathbb{Q}\left(\zeta_{N}\right)} \rightarrow\left(X_{G}\right)_{\mathbb{Q}\left(\zeta_{N}\right)}$ be the natural morphism corresponding to the inclusion of function fields $\mathbb{Q}\left(\zeta_{N}\right)\left(X_{G}\right) \subseteq \mathcal{F}_{N}$. Let $\mathcal{C}$ be the set of cusps in $X(N)\left(\mathbb{Q}\left(\zeta_{N}\right)\right)$.

Fix a place $v$ of $L$. For each cusp $c \in \mathcal{C}_{G}$, we define the subset

$$
\Omega_{c, v}:=\pi\left(\bigcup_{c^{\prime} \in \mathcal{C}} \bigcup_{\pi\left(c^{\prime}\right)=c} \Omega_{c^{\prime}, v}\right)
$$

of $X_{G}\left(\bar{L}_{v}\right)$, where the sets $\Omega_{c^{\prime}, v} \subseteq X(N)\left(\bar{L}_{v}\right)$ are from $\S 3.1$. The set $\Omega_{c, v}$ contains $c$ and no other cusps.
Lemma 3.4. For any place $v$ of $L$, we have

$$
\bigcup_{c \in \mathcal{C}_{G}} \Omega_{c, v}= \begin{cases}\left\{P \in X_{G}\left(\bar{L}_{v}\right): P \text { is a cusp or }|j(P)|_{v}>1\right\} & \text { if } v \text { is finite } \\ X_{G}\left(\bar{L}_{v}\right) & \text { if } v \text { is infinite } .\end{cases}
$$

Proof. We have $\bigcup_{c \in \mathcal{C}_{G}} \Omega_{c, v}=\pi\left(\bigcup_{c^{\prime} \in \mathcal{C}} \Omega_{c^{\prime}, v}\right)$. The lemma now follows from Lemma 3.2.

## 4. Properties of $\varphi$

Fix an integer $N>2$ and let $G$ be a subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ containing $-I$. Let $\mu$ be the degree of the morphism $j: X_{G} \rightarrow \mathbb{P}_{K_{G}}^{1}$. The group $\mathrm{Gal}_{K_{G}}$ acts on the set of cusps $\mathcal{C}_{G}$ of $X_{G}$ by Lemma 2.3(ii).

Let $\Sigma$ be a proper subset of $\mathcal{C}_{G}$ that is stable under the $\mathrm{Gal}_{K_{G}}$-action. Let $m$ be the smallest positive integer for which $m \sum_{c \in \mathcal{C}_{G}-\Sigma} w_{c}>g$, where $g$ is the genus of $X_{G}$. Fix a number field $L \supseteq \mathbb{Q}\left(\zeta_{N}\right)$. Define the real numbers

$$
\beta:=2\left(2^{3} 4.5^{36 m} N^{108 m+15} m^{72 m+1}\right)^{m \mu+1} 4.5^{12 m} N^{36 m+4}
$$

$C:=96.6 \cdot 0.1^{24 m} N^{90 m+4}$ and $C^{\prime}:=22.16 N^{144 m+7} 0.024^{24 m}$.
The following theorem gives the existence of a rational function $\varphi \in K_{G}\left(X_{G}\right)$ suitable for our application of Runge's method; it makes use of the sets $\Omega_{c, v} \subseteq X_{G}\left(\bar{L}_{v}\right)$ from $\S 3.2$. The proof will given in $\S 10$ after several sections discussing modular forms.

Theorem 4.1. Fix notation and assumptions as above. There is a nonconstant function $\varphi \in K_{G}\left(X_{G}\right)$ that satisfies the following properties:
(a) The function $\varphi$ is integral over $\mathbb{Z}[j]$, i.e., $\varphi$ is the root of a monic polynomial with coefficients in $\mathbb{Z}[j]$.
(b) The function $\varphi$ has no poles away from the cusps of $X_{G}$.
(c) Take any cusp $c \in \Sigma$. The function $\varphi$ is regular at $c$. Moreover, $\varphi(c)$ lies in $\mathbb{Z}\left[\zeta_{N}\right]$ and satisfies $|\varphi(c)|_{v} \leq \beta m^{24 m}$ for all infinite places $v$ of $L$.
(d) For any cusp $c \in \Sigma$, place $v$ of $L$ and point $P \in \Omega_{c, v}-\{c\}$, we have

$$
|\varphi(P)-\varphi(c)|_{v} \leq \begin{cases}|j(P)|_{v}^{-1 / w_{c}} & \text { if } v \text { is finite, } \\ |j(P)|_{v}^{-1 / w_{c}} \cdot \beta C & \text { if } v \text { is infinite and }|j(P)|_{v}>3500 \\ \beta C / 2 & \text { if } v \text { is infinite }\end{cases}
$$

(e) Let $K$ be any number field with $K_{G} \subseteq K \subseteq L$ and let $\Sigma^{\prime}$ be $a \mathrm{Gal}_{K}$-orbit of $\Sigma$. Let $w$ be the integer for which $w_{c}=w$ for all $c \in \Sigma^{\prime}$. Then there is a nonzero $\xi \in \mathcal{O}_{K}$ such that the following hold:

- We have $|\xi|_{v} \leq\left(\beta C^{\prime}\right)^{w\left|\Sigma^{\prime}\right|}$ for all infinite place $v$ of $L$.
- Consider any point $P \in Y_{G}(K)$ for which $\varphi(P)=\varphi(c)$ and $P \in \Omega_{c, v}$ for some cusp $c \in \Sigma^{\prime}$ and place $v$ of $L$. Then

$$
|\xi|_{v} \leq \begin{cases}|j(P)|_{v}^{-w} & \text { if } v \text { is finite, } \\ |j(P)|_{v}^{-w} \cdot\left(\beta C^{\prime}\right)^{w\left|\Sigma^{\prime}\right|} & \text { if } v \text { is infinite and }|j(P)|_{v}>3500 .\end{cases}
$$

For later use, we now gives some simple bounds on $m$ and $\mu$ in terms of $N$.
Lemma 4.2. Fix notation as above.
(i) We have $\mu \leq \frac{1}{2} N^{3}, \mu+1 \leq \frac{29}{54} N^{3}$ and $\mu+2 \leq \frac{31}{54} N^{3}$.
(ii) We have $m \leq \frac{1}{24} N^{3}$.

Proof. Since $G$ contains $-I$, we have $\mu=\left[\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z}): \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z}) \cap G\right]$. In particular, $\mu$ is a divisor of $\left|\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z}) /\{ \pm I\}\right|$ and thus $\mu \leq N^{3} / 2$. Take any nonnegative real numbers $b$. From our bound on $\mu$ and $N \geq 3$, we have $\mu+b \leq(1 / 2+b / 27) N^{3}$. Part (i) is obtained by taking specific values of $b$.

We now bound $m$. We have $m \leq g+1$ since $\sum_{c \in \mathcal{C}_{G}-\Sigma} w_{c} \geq 1$. For every congruence subgroup $\Gamma \subseteq \operatorname{SL}_{2}(\mathbb{Z})$ of level at most $5, \mathcal{X}_{\Gamma}$ has genus 0 , see [CP03]. So if $N \leq 5$, then $g=0$ and hence $m=1$; the bound $m \leq \frac{1}{24} N^{3}$ is immediate since $N \geq 3$. We can now assume that $N \geq 6$. By [Shi94, Proposition 1.40], we have $g+1 \leq \mu / 12+3 / 2$, where we have used that $X_{G}$ has at least one cusp. If $\mu$ is a proper divisor of $\left|\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z}) /\{ \pm I\}\right|$, then $\mu \leq N^{3} / 4$ and hence

$$
m \leq g+1 \leq \frac{1}{48} N^{3}+\frac{3}{2} \leq \frac{1}{48} N^{3}+\frac{3}{2 \cdot 6^{3}} N^{3} \leq \frac{1}{24} N^{3} .
$$

Finally assume that $\mu=\left|\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z}) /\{ \pm I\}\right|$ and hence $G \cap \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})=\mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$. In this case, we have $g=1+\mu(N-6) /(12 N)$, cf. [Shi94, Equation (1.6.4)]. Therefore,

$$
m \leq g+1 \leq 2+\frac{1}{2} N^{3} \frac{N-6}{12 N} \leq \frac{1}{24} N^{3}-\frac{1}{4} N^{2}+2 \leq \frac{1}{24} N^{3} .
$$

## 5. Proof of Theorem 1.1

Take any point $P$ in $Y_{G}(K)$ with $j(P) \in \mathcal{O}_{K, S}$. Let $S^{\prime}$ be the set of places $v$ of $K$ for which $v$ is infinite or $|j(P)|_{v}>1$. We have $j(P) \in \mathcal{O}_{K, S^{\prime}}$ and $\left|S^{\prime}\right| \leq|S|<\mathfrak{c}_{G, K}$. So without loss of generality, we may assume that $S=S^{\prime}$, i.e., a finite place $v$ of $K$ lies in $S$ if and only if $|j(P)|_{v}>1$.

We have $K_{G} \subseteq \mathbb{Q}\left(\zeta_{N}\right) \subseteq \mathbb{C}$. Without loss of generality, we may assume that $K_{G} \subseteq K \subseteq \mathbb{C}$. Let $\bar{K}$ be the algebraic closure of $K$ in $\mathbb{C}$ and define $\mathrm{Gal}_{K}:=\operatorname{Gal}(\bar{K} / K)$. Define the field $L:=K\left(\zeta_{N}\right)$. Let $\mathcal{C}_{G}$ be the set of cusps in $X_{G}(\mathbb{C})$; we have $\mathcal{C}_{G} \subseteq X_{G}(L)$ by Lemma 2.3(ii).

Take any $v \in S$; it is a place of $K$. We choose a place of $L$ that extends $v$ which, by abuse of notation, we also denote by $v$. This choice of place of $L$ will ultimately not matter since we are interested in $|j(P)|_{v}$ which does not depend on the choice of extension since $j(P) \in K$. As in $\S 3$, we define a subset $\Omega_{c, v} \subseteq X_{G}\left(\bar{L}_{v}\right)$ for each cusp $c \in \mathcal{C}_{G}$. By Lemma 3.4, there is a cusp $c_{v} \in \mathcal{C}_{G}$ for which $P$ lies in $\Omega_{c_{v}, v}$. Intuitively, $c_{v}$ is a cusp that is "nearby" $P$ in $X_{G}\left(\bar{L}_{v}\right)$.

Let $\Sigma$ be the minimal subset of $\mathcal{C}_{G}$ that contains $\left\{c_{v}: v \in S\right\}$ and is stable under the $\mathrm{Gal}_{K}$-action. The action of $\mathrm{Gal}_{K}$ on $\Sigma$ clearly has at most $|S|$ orbits. We have $|S|<\mathfrak{c}_{G, K}$ by assumption and hence $\Sigma$ is a proper subset of $\mathcal{C}_{G}$. The set $\Sigma$ is nonempty since $S$ is nonempty.

Let $m$ be the smallest positive integer for which $m \sum_{c \in \mathcal{C}_{G}-\Sigma} w_{c}>g$, where $g$ is the genus of $X_{G}$. Let $\varphi \in K_{G}\left(X_{G}\right) \subseteq K\left(X_{G}\right)$ be a nonconstant function satisfying all the properties of Theorem 4.1 with respect to the set $\Sigma$ and the field $L$.

Let $\Sigma_{1}, \ldots, \Sigma_{h}$ be the $\mathrm{Gal}_{K}$-orbits of $\Sigma$. For each $1 \leq i \leq h$, the values $w_{c}$ agree as we vary over all $c \in \Sigma_{i}$; we denote this common integer by $w_{i}$.

We now fix an integer $1 \leq i \leq h$. Let $S_{i}$ be the set of places $v \in S$ such that $c_{v} \in \Sigma_{i}$ and such that $|j(P)|_{v}>3500$ if $v$ is infinite. Our goal is to find an upper bound for $\sum_{v \in S_{i}} d_{v} \log |j(P)|_{v}$, where the integers $d_{v}$ are defined in $\S 1.2$. Once this is done we will combine these bounds for all $i$ to obtain an upper bound for $h(j(P))$.

The function $\varphi$ is regular at all $c \in \Sigma_{i}$ by Theorem 4.1(c). Define the function

$$
g_{i}:=\prod_{c \in \Sigma_{i}}(\varphi-\varphi(c)) .
$$

We now give some basic properties of $g_{i}$.

## Lemma 5.1.

(i) The rational function $g_{i}$ lies in $K\left(X_{G}\right)$ and any pole of $g_{i}$ is a cusp of $X_{G}$ that does not lie in the set $\Sigma$.
(ii) We have $g_{i}(c)=0$ for all $c \in \Sigma_{i}$.
(iii) We have $\varphi(P) \in \mathcal{O}_{K, S}$ and $g_{i}(P) \in \mathcal{O}_{K, S}$.

Proof. For any $\sigma \in \operatorname{Gal}_{K}$ and $c \in \Sigma_{i}$, we have $\sigma(\varphi(c))=\varphi(\sigma(c))$ since $\varphi \in K\left(X_{G}\right)$. Since $\Sigma_{i}$ is stable under the $\operatorname{Gal}_{K^{-}}$action, the polynomial $Q_{i}(x):=\prod_{c \in \Sigma_{i}}(x-\varphi(c))$ lies in $K[x]$. Moreover, $Q_{i}(x) \in \mathcal{O}_{K}[x]$ since $\varphi(c)$ is algebraic for all $c \in \Sigma$ by Theorem 4.1(c). Therefore, $g_{i}=Q_{i}(\varphi)$ is an element of $K\left(X_{G}\right)$. Since $g_{i}=Q_{i}(\varphi)$, any pole of $g_{i}$ will also be a pole of $\varphi$. Part (i) thus follows from Theorem 4.1(b) and (c). Part (ii) is immediate from the definition of $g_{i}$.

We have $g_{i}=Q_{i}(\varphi)$ and hence $g_{i}(P)=Q_{i}(\varphi(P))$; the functions are regular at $P$ since $P$ is not a cusp. Since $Q_{i}(x)$ is a polynomial in $\mathcal{O}_{K}[x]$, to prove (iii) it suffices to show that $\varphi(P)$ lies in $\mathcal{O}_{K, S}$. Since $\varphi$ and $P$ are defined over $K$, we have $\varphi(P) \in K$. By property (a) of Theorem 4.1, $\varphi$ is the root of a monic polynomial with coefficients in $\mathbb{Z}[j]$. Therefore, $\varphi(P)$ is the root of a monic polynomial with coefficients in $\mathbb{Z}[j(P)] \subseteq \mathcal{O}_{K, S}$. We thus have $\varphi(P) \in \mathcal{O}_{K, S}$ since $\mathcal{O}_{K, S}$ is integrally closed.

Define the numbers

$$
\beta:=2\left(2^{3} 4.5^{36 m} N^{108 m+15} m^{72 m+1}\right)^{m \mu+1} 4.5^{12 m} N^{36 m+4}
$$

and $C:=96.6 \cdot 0.1^{24 m} N^{90 m+4}$. We now bound the absolute value of $g_{i}(P)$ at infinite places.
Lemma 5.2. For any infinite place $v$ of $K$, we have

$$
\left|g_{i}(P)\right|_{v} \leq \begin{cases}(\beta C)^{\left|\Sigma_{i}\right|} \cdot|j(P)|_{v}^{-1 / w_{i}} & \text { if } v \in S_{i} \\ (\beta C)^{\left|\Sigma_{i}\right|} & \text { otherwise }\end{cases}
$$

Proof. Recall we have chosen a place of $L$ extending $v$ that we also denoted by $v$. We have also chosen a cusp $c_{v} \in \Sigma$ such that $P \in \Omega_{c_{v}, v}$. Since $P$ is not a cusp, Theorem 4.1(d) implies that $\left|\varphi(P)-\varphi\left(c_{v}\right)\right|_{v} \leq \beta C / 2$. Take any cusp $c \in \Sigma$. By Theorem 4.1(c), we have $|\varphi(c)|_{v} \leq \beta m^{24 m}$. By using the bound on $m$ from Lemma 4.2, one can show that $|\varphi(c)|_{v} \leq \beta C / 4$.

Take any $c \in \Sigma_{i}$. We have $|\varphi(P)-\varphi(c)|_{v} \leq\left|\varphi(P)-\varphi\left(c_{v}\right)\right|_{v}+\left|\varphi\left(c_{v}\right)\right|_{v}+|\varphi(c)|_{v}$ and hence $|\varphi(P)-\varphi(c)|_{v} \leq$ $\beta C / 2+\beta C / 4+\beta C / 4=\beta C$. Therefore,

$$
\left|g_{i}(P)\right|_{v}=\prod_{c \in \Sigma_{i}}|\varphi(P)-\varphi(c)|_{v} \leq(\beta C)^{\left|\Sigma_{i}\right|}
$$

Finally suppose that $v \in S_{i}$, i.e., $c_{v} \in \Sigma_{i}$ and $|j(P)|_{v}>3500$. Note that $w_{c_{v}}=w_{i}$. We get the other inequality of the lemma in the same manner except also using the bound $\left|\varphi(P)-\varphi\left(c_{v}\right)\right|_{v} \leq|j(P)|_{v}^{-1 / w_{i}} \cdot \beta C$ from Theorem 4.1(d).

We now bound the absolute value of $g_{i}(P)$ at finite places.
Lemma 5.3. For any finite place $v$ of $K$, we have

$$
\left|g_{i}(P)\right|_{v} \leq \begin{cases}|j(P)|_{v}^{-1 / w_{i}} & \text { if } v \in S_{i} \\ 1 & \text { otherwise }\end{cases}
$$

Proof. Take any finite place $v$ of $K$. First suppose that $v \notin S$. We have $g_{i}(P) \in \mathcal{O}_{K, S}$ by Lemma 5.1(iii) and hence $\left|g_{i}(P)\right|_{v} \leq 1$.

We can now assume that $v \in S$ and hence $|j(P)|_{v}>1$. Recall we have chosen a place of $L$ extending $v$ that we also denoted by $v$. We have also chosen a cusp $c_{v} \in \Sigma$ such that $P \in \Omega_{c_{v}, v}$. Since $P$ is not a cusp, Theorem 4.1(d) implies that $\left|\varphi(P)-\varphi\left(c_{v}\right)\right|_{v} \leq|j(P)|_{v}^{-1 / w_{c_{v}}}$. In particular, $\left|\varphi(P)-\varphi\left(c_{v}\right)\right|_{v} \leq 1$.

Take any cusp $c \in \Sigma$. Since $\varphi(c)$ and $\varphi\left(c_{v}\right)$ are integral by Theorem 4.1(c), we find that

$$
|\varphi(P)-\varphi(c)|_{v} \leq \max \left\{\left|\varphi(P)-\varphi\left(c_{v}\right)\right|_{v},\left|\varphi\left(c_{v}\right)-\varphi(c)\right|_{v}\right\} \leq 1
$$

Therefore, $\left|g_{i}(P)\right|=\prod_{c \in \Sigma_{i}}|\varphi(P)-\varphi(c)|_{v} \leq 1$. Now assume that $v \in S_{i}$ and hence $c_{v} \in \Sigma_{i}$. Using $w_{c_{v}}=w_{i}$, we have $\left|g_{i}(P)\right|=\prod_{c \in \Sigma_{i}}|\varphi(P)-\varphi(c)|_{v} \leq\left|\varphi(P)-\varphi\left(c_{v}\right)\right|_{v} \leq|j(P)|_{v}^{-1 / w_{i}}$.

Define $C^{\prime}:=22.16 N^{144 m+7} 0.024^{24 m}$.
Lemma 5.4. We have

$$
[K: \mathbb{Q}]^{-1} \sum_{v \in S_{i}} d_{v} \log |j(P)|_{v} \leq w_{i}\left|\Sigma_{i}\right| \log \left(\beta C^{\prime}\right)
$$

Proof. We first assume that $g_{i}(P) \in K$ is nonzero. We have $\prod_{v \in M_{K}}\left|g_{i}(P)\right|_{v}^{d_{v}}=1$ by the product formula. Using the upper bounds on $\left|g_{i}(P)\right|_{v}$ from Lemmas 5.2 and 5.3, we have

$$
1 \leq \prod_{v \in M_{K, \infty}}(\beta C)^{d_{v}\left|\Sigma_{i}\right|} \cdot \prod_{v \in S_{i}}|j(P)|_{v}^{-d_{v} / w_{i}}
$$

Taking logarithms and using that $\sum_{v \in M_{K, \infty}} d_{v}=[K: \mathbb{Q}]$ gives

$$
[K: \mathbb{Q}]^{-1} \sum_{v \in S_{i}} d_{v} \log |j(P)|_{v} \leq w_{i}\left|\Sigma_{i}\right| \log (\beta C)
$$

To prove the lemma in this case, it thus suffices to show that $C \leq C^{\prime}$. We have

$$
C^{\prime} / C=\frac{22.16}{96.6} N^{54 m+3}\left(\frac{0.024}{0.1}\right)^{24 m} \geq \frac{22.16 \cdot 3^{3}}{96.6}\left(3^{54} \cdot \frac{0.024^{24}}{0.1^{24}}\right)^{m}>6 \cdot 10^{10 m}>1
$$

where we have used that $N \geq 3$.
We may now assume that $g_{i}(P)=0$. We have $\varphi(P)=\varphi(c)$ for some $c \in \Sigma_{i}$. Since $\varphi(c)=\varphi(P)$ is in $K$, $\varphi$ is defined over $K$ and $\Sigma_{i}$ has a transitive $\operatorname{Gal}_{K^{-}}$-action, we find that $\varphi(P)=\varphi\left(c^{\prime}\right)$ for all $c^{\prime} \in \Sigma_{i}$. With our fields $K_{G} \subseteq K \subseteq L$ and $\Sigma^{\prime}:=\Sigma_{i}$, let $\xi$ be a nonzero element of $\mathcal{O}_{K}$ as in Theorem 4.1(e).

Take any place $v \in S_{i}$. We have $P \in \Omega_{c_{v}, v}-\left\{c_{v}\right\}$ with $c_{v} \in \Sigma_{i}$. Moreover, $|j(P)|_{v}>3500$ if $v$ is infinite. By Theorem 4.1(e), we have $|\xi|_{v} \leq|j(P)|_{v}^{-w_{i}}$ if $v$ is finite and $|\xi|_{v} \leq|j(P)|_{v}^{-w_{i}} \cdot\left(\beta C^{\prime}\right)^{w_{i}\left|\Sigma_{i}\right|}$ if $v$ is infinite.

For any infinite place $v \notin S_{i}$ of $K$, we have $|\xi|_{v} \leq\left(\beta C^{\prime}\right)^{w_{i}\left|\Sigma_{i}\right|}$ by Theorem 4.1(e). Since $\xi$ is integral, we have $|\xi|_{v} \leq 1$ for all finite places $v \notin S_{i}$ of $K$. The product formula and the above inequalities give

$$
1=\prod_{v \in M_{K}}|\xi|_{v}^{d_{v}} \leq \prod_{v \in S_{i}}|j(P)|_{v}^{-w_{i} d_{v}} \cdot \prod_{v \in M_{K, \infty}}\left(\beta C^{\prime}\right)^{w_{i}\left|\Sigma_{i}\right| d_{v}} .
$$

By taking logarithms and using $\sum_{v \in M_{K, \infty}} d_{v}=[K: \mathbb{Q}]$, we obtain

$$
[K: \mathbb{Q}]^{-1} \sum_{v \in S_{i}} d_{v} \log |j(P)|_{v} \leq\left|\Sigma_{i}\right| \log \left(\beta C^{\prime}\right) \leq w_{i}\left|\Sigma_{i}\right| \log \left(\beta C^{\prime}\right)
$$

Recall that a finite place $v$ of $K$ lies in $S$ if and only if $|j(P)|_{v}>1$. A place $v \in S$ lies in $S_{i}$ for some $1 \leq i \leq h$ if $v$ is finite or $|j(P)|_{v}>3500$. Therefore,

$$
\begin{aligned}
h(j(P)) & =[K: \mathbb{Q}]^{-1} \sum_{v \in M_{K}} d_{v} \log \max \left\{1,|j(P)|_{v}\right\} \\
& \leq[K: \mathbb{Q}]^{-1} \sum_{i=1}^{h} \sum_{v \in S_{i}} d_{v} \log |j(P)|_{v}+[K: \mathbb{Q}]^{-1} \sum_{v \in M_{K, \infty}} d_{v} \log 3500 .
\end{aligned}
$$

By Lemma 5.4 and $\sum_{v \in M_{K, \infty}} d_{v}=[K: \mathbb{Q}]$, we obtain

$$
h(j(P)) \leq \sum_{i=1}^{h} w_{i}\left|\Sigma_{i}\right| \log \left(\beta C^{\prime}\right)+\log 3500
$$

Observe that $\sum_{i=1}^{h} w_{i}\left|\Sigma_{i}\right| \leq \sum_{c \in \Sigma} w_{c} \leq \mu$, where the last inequality follows from (2.1). Therefore,

$$
\begin{equation*}
h(j(P)) \leq \mu \log \left(\beta C^{\prime}\right)+\log 3500 \tag{5.1}
\end{equation*}
$$

This is our explicit upper bound for $h(j(P))$; note that the numbers $\beta$ and $C^{\prime}$ are both expressed solely in terms of $\mu, m$ and $N$.

We finish by making some estimates to produce worse, though more aesthetically pleasing, bounds for $h(j(P))$.

Lemma 5.5. We have $h(j(P)) \leq 4(\mu+4)^{4} \log N$.
Proof. Using $m \leq \frac{1}{24} N^{3}$ from Lemma 4.2, we find that

$$
\begin{aligned}
\beta & \leq 2\left(2^{3} 4.5^{36 m}\left(\frac{1}{24}\right)^{72 m+1}\right)^{m \mu+1} 4.5^{12 m} \cdot N^{(324 m+18)(m \mu+1)+(36 m+4)} \\
& =2\left(\frac{1}{3}\right)^{m \mu+1}\left(\frac{4.5}{24^{2}}\right)^{36 m(m \mu+1)} 4.5^{12 m} N^{(324 m+18)(m \mu+1)+(36 m+4)}
\end{aligned}
$$

and hence

$$
\beta C^{\prime} \leq 44.32\left(\frac{1}{3}\right)^{m \mu+1}\left(\frac{4.5}{24^{2}}\right)^{36 m(m \mu+1)}\left(4.5 \cdot 0.024^{2}\right)^{12 m} \cdot N^{d}
$$

where $d:=(324 m+18)(m \mu+1)+(36 m+4)+(144 m+7)$. We have $\mu \geq 2$ (since otherwise $X_{G}$ has only one cusp and hence $1 \leq|S|<\mathfrak{c}_{G, K}=1$ ). Using that $m \geq 1$ and $m \mu+1 \geq 3$, we deduce that $\beta C^{\prime} \leq 44.32\left(\frac{1}{3}\right)^{3}\left(\frac{4.5}{24^{2}}\right)^{108}\left(4.5 \cdot 0.024^{2}\right)^{12} N^{d}$. Taking logarithms, we find that $\log \left(\beta C^{\prime}\right) \leq d \log N-594.98$. Since $\mu \geq 2$, we have

$$
\mu \log \left(\beta C^{\prime}\right)+\log 3500 \leq \mu d \log N-2 \cdot 594.98+\log 3500 \leq \mu d \log N-1181
$$

In particular, $\mu \log \left(\beta C^{\prime}\right)+\log 3500 \leq \mu d \log N$ and hence $h(j(P)) \leq \mu d \log N$ by (5.1).
By [Shi94, Proposition 1.40], we have $g+1 \leq \mu / 12+1$, where we have used that $X_{G}$ has at least two cusps due to the Runge condition on $X_{G}$. Using $m \leq g+1 \leq \mu / 12+1$, we obtain an upper bound for $\mu d$ that is a polynomial in $\mu$. In particular, $\mu d \leq f(\mu)$, where $f(x)=\left(9 x^{4}+222 x^{3}+1536 x^{2}+2132 x\right) / 4$. One can readily check that $f(x) \leq 4(x+4)^{4}$ holds for all $x \geq 0$. Therefore, $\mu d \leq 4(\mu+4)^{4}$ and hence $h(j(P)) \leq \mu d \log N \leq 4(\mu+4)^{4} \log N$.

By Lemma 4.2, we have $\mu \leq N^{3} / 2$ and hence $h(j(P)) \leq 4\left(N^{3} / 2+4\right)^{4} \log N$ by Lemma 5.5. Using that $N \geq 3$, one can check that $4\left(N^{3} / 2+4\right)^{4} \leq N^{12}$ and hence $h(j(P)) \leq N^{12} \log N$.

## 6. BACKGROUND: MODULAR FORMS

In this section, we recall some facts about modular forms. For the basics on modular forms see [Shi94].
6.1. Notation. Recall that the group $\mathrm{SL}_{2}(\mathbb{Z})$ acts by linear fractional transformations on the complex upper half-plane $\mathcal{H}$ and the extended upper half-plane $\mathcal{H}^{*}=\mathcal{H} \cup \mathbb{Q} \cup\{\infty\}$. Consider an integer $k \geq 0$. For a meromorphic function $f$ on $\mathcal{H}$ and a matrix $\gamma=\left(\begin{array}{cc}a & b \\ c & d\end{array}\right) \in \mathrm{SL}_{2}(\mathbb{Z})$, define the meromorphic function $\left.f\right|_{k} \gamma$ on $\mathcal{H}$ by $\left(\left.f\right|_{k} \gamma\right)(\tau):=(c \tau+d)^{-k} f(\gamma \tau)$; we call this the slash operator of weight $k$.

For a congruence subgroup $\Gamma$ of $\mathrm{SL}_{2}(\mathbb{Z})$, we denote by $M_{k}(\Gamma)$ the set of modular forms of weight $k$ on $\Gamma$; it is a finite dimensional complex vector space. Recall that each $f \in M_{k}(\Gamma)$ is a holomorphic function of the upper half-plane $\mathcal{H}$ that satisfies $\left.f\right|_{k} \gamma=f$ for all $\gamma \in \Gamma$ along with the familiar growth condition at the cusps. For each modular form $f \in M_{k}(\Gamma)$, we have

$$
f(\tau)=\sum_{n=0}^{\infty} a_{n}(f) q_{w}^{n}
$$

for unique $a_{n}(f) \in \mathbb{C}$, where $w$ is the width of the cusp $\infty$ of $\Gamma$ and $q_{w}:=e^{2 \pi i \tau / w}$. We call this power series in $q_{w}$, the $q$-expansion of $f$ (at the cusp $\infty$ ). Note that $f$ is uniquely determined by its $q$-expansion and hence we can identify $f$ with its $q$-expansion. For a subring $R$ of $\mathbb{C}$, we denote by $M_{k}(\Gamma, R)$ the $R$-submodule of $M_{k}(\Gamma)$ consisting of modular forms whose $q$-expansion has coefficients in $R$.
6.2. Actions on $M_{k}(\Gamma(N))$. Fix positive integers $N$ and $k$. Since $\Gamma(N)$ is normal in $\mathrm{SL}_{2}(\mathbb{Z})$, the slash operator of weight $k$ defines a right action of $\mathrm{SL}_{2}(\mathbb{Z})$ on $M_{k}(\Gamma(N))$. Take any modular form $f=\sum_{n=0}^{\infty} a_{n}(f) q_{N}^{n}$ in $M_{k}(\Gamma(N))$. For every field automorphism $\sigma$ of $\mathbb{C}$, there is a unique modular form $\sigma(f) \in M_{k}(\Gamma(N))$ whose $q$-expansion is $\sum_{n=0}^{\infty} \sigma\left(a_{n}(f)\right) q_{N}^{n}$. This defines an action of Aut( $\left.\mathbb{C}\right)$ on $M_{k}(\Gamma)$.

The following lemma says that the above actions of $\mathrm{SL}_{2}(\mathbb{Z})$ and $\operatorname{Aut}(\mathbb{C})$ induce a right action of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ on $M_{k}(\Gamma(N))$. For each $d \in(\mathbb{Z} / N \mathbb{Z})^{\times}$, let $\sigma_{d}$ be any automorphism of $\mathbb{C}$ for which $\sigma_{d}\left(\zeta_{N}\right)=\zeta_{N}^{d}$.
Lemma 6.1. There is a unique right action $*$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ on $M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)$ such that the following hold:

- if $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$, then $f * A=\left.f\right|_{k} \gamma$, where $\gamma$ is any matrix in $\mathrm{SL}_{2}(\mathbb{Z})$ that is congruent to $A$ modulo $N$,
- if $A=\left(\begin{array}{ll}1 & 0 \\ 0 & d\end{array}\right)$, then $f * A=\sigma_{d}(f)$.

Proof. See [BN19, §3].
6.3. The spaces $M_{k, G}$. Fix a positive integer $N$ and let $G$ be a subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. For each integer $k \geq 0$, define

$$
M_{k, G}:=M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)^{G}
$$

i.e., the subgroup fixed by the $G$-action $*$ from Lemma 6.1. Note that $M_{k, G}$ is a vector space over $K_{G}=$ $\mathbb{Q}\left(\zeta_{N}\right)^{\operatorname{det} G}$. The following lemma explains how we will use modular forms to produce regular functions on $X_{G}$.

Lemma 6.2. Fix an integer $k \geq 0$ and take any modular forms $f$ and $g$ in $M_{k, G}$ with $g \neq 0$. Then $f / g$ is an element of $K_{G}\left(X_{G}\right)=\mathcal{F}_{N}^{G}$.

Proof. For any $\gamma \in \Gamma(N)$, we have $(f / g)(\gamma \tau)=f(\gamma \tau) / g(\gamma \tau)=\left(\left.f\right|_{k} \gamma\right)(\tau) /\left(\left.g\right|_{k} \gamma\right)(\tau)=f(\tau) / g(\tau)$. Therefore, $f / g$ is a modular function of level $N$. We have $f / g \in \mathcal{F}_{N}$ since the $q$-expansions of $f$ and $g$ both have coefficients in $\mathbb{Q}\left(\zeta_{N}\right)$.

For any $A \in G$, we have $(f / g) * A=(f * A) /(g * A)=f / g$, where the first $*$-action is the one from Lemma 2.1. Therefore, $f / g$ is an element of $\mathcal{F}_{N}^{G}=K_{G}\left(X_{G}\right)$.

Take any cusp $c \in \mathcal{C}_{G}$ of $X_{G}$. Choose an $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $A \cdot c_{\infty}=c$, where $c_{\infty}$ is the cusp at infinity. Set $w=w_{c}$. For any $f \in M_{k, G}$, the $q$-expansion of $f * A$ lies in $\mathbb{Q}\left(\zeta_{N}\right) \llbracket q_{w} \rrbracket$. When $f$ is nonzero, we define $\nu_{c}(f)$ to be the minimal integer $n$ for which the coefficient of $q_{w}^{n}$ in the $q$-expansion of $f * A$ is nonzero. When $f$ is zero, we define $\nu_{c}(f)=+\infty$. Note that $\nu_{c}(f)$ does not depend on the choice of $A$. Now consider any $f, g \in M_{k, G}$ with $g$ nonzero. We have $f / g \in K_{G}\left(X_{G}\right) \subseteq \mathbb{Q}\left(\zeta_{N}\right)\left(X_{G}\right)$ by Lemma 6.2. Moreover,

$$
\begin{equation*}
\operatorname{ord}_{c}(f / g)=\nu_{c}(f)-\nu_{c}(g) \tag{6.1}
\end{equation*}
$$

6.4. Eisenstein series of weight 1. See $[\mathrm{Kat} 04, \S 3]$ for the basics on Eisenstein series. For further information, we refer to $\S \S 2-3$ of [BN19] where all the results below are summarized and referenced (except for the explicit constant $c_{0}$ in Lemma 6.3, see [Bru17, Lemma 3.1] instead). We will restrict our attention to weight 1 modular forms; our functions $E_{\alpha}$ are denoted $E_{\alpha}^{(1)}$ in [BN19].

Fix a positive integer $N$. Consider any pair $\alpha \in(\mathbb{Z} / N \mathbb{Z})^{2}$ and choose $a, b \in \mathbb{Z}$ with $\alpha \equiv(a, b)(\bmod N)$. With $\tau \in \mathcal{H}$, consider the series

$$
\begin{equation*}
E_{\alpha}(\tau, s)=\frac{1}{-2 \pi i} \sum_{\substack{\omega \in \mathbb{Z}+\mathbb{Z} \tau \\ \omega \neq-(a \tau+b) / N}}\left(\frac{a \tau+b}{N}+\omega\right)^{-1} \cdot\left|\frac{a \tau+b}{N}+\omega\right|^{-2 s} \tag{6.2}
\end{equation*}
$$

The series (6.2) converges when the real part of $s \in \mathbb{C}$ is large enough. Hecke proved that $E_{\alpha}(\tau, s)$ can be analytically continued to all $s \in \mathbb{C}$. Using this analytic continuation, we define the Eisenstein series

$$
E_{\alpha}(\tau):=E_{\alpha}(\tau, 0)
$$

For $\gamma \in \mathrm{SL}_{2}(\mathbb{Z})$, we have $\left.E_{\alpha}\right|_{1} \gamma=E_{\alpha \gamma}$, where $\alpha \gamma \in(\mathbb{Z} / N \mathbb{Z})^{2}$ denotes matrix multiplication. In particular, $E_{\alpha}$ is fixed by $\Gamma(N)$ under the slash operator of weight 1.
Lemma 6.3. Take any $a, b \in \mathbb{Z}$ and let $\alpha \in(\mathbb{Z} / N \mathbb{Z})^{2}$ be the image of $(a, b)$ modulo $N$. The function $E_{\alpha}$ is a modular form of weight 1 on $\Gamma(N)$ with $q$-expansion

$$
c_{0}+\sum_{\substack{m, n \geq 1 \\ m \equiv a \bmod N}} \zeta_{N}^{b n} q_{N}^{m n}-\sum_{\substack{m, n \geq 1 \\ m \equiv-a \bmod N}} \zeta_{N}^{-b n} q_{N}^{m n}
$$

and $c_{0} \in \mathbb{Q}\left(\zeta_{N}\right)$. Moreover,

$$
c_{0}= \begin{cases}0 & \text { if } a \equiv b \equiv 0 \quad(\bmod N), \\ \frac{1}{2} \frac{1+\zeta_{N}^{b}}{1-\zeta_{N}^{b}} & \text { if } a \equiv 0 \quad(\bmod N) \text { and } b \not \equiv 0 \quad(\bmod N), \\ \frac{1}{2}-\frac{a_{0}}{N} & \text { if } a \not \equiv 0 \quad(\bmod N),\end{cases}
$$

where $0 \leq a_{0}<N$ is the integer congruent to a modulo $N$.
The right action $*$ of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ on $M_{1}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)$, described in $\S 6.2$, acts on the Eisenstein series $E_{\alpha}$ in a pleasant manner.
Lemma 6.4. We have $E_{\alpha} * A=E_{\alpha A}$ for all $\alpha \in(\mathbb{Z} / N \mathbb{Z})^{2}$ and $A \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$.
6.5. Expressing modular forms in terms of Eisenstein series. Using the Eisenstein series of weight 1 from $\S 6.4$, we can generate higher weight modular forms.

Theorem 6.5 (Khuri-Makdisi). Suppose $N>2$. The $\mathbb{C}$-subalgebra of $\bigoplus_{k \geq 0} M_{k}(\Gamma(N))$ generated by the Eisenstein series $E_{\alpha}$ with $\alpha \in(\mathbb{Z} / N \mathbb{Z})^{2}$ contains all modular forms of weight $k$ on $\Gamma(N)$ for all $k \geq 2$.

Proof. This particular formulation of results of Khuri-Makdisi [KM12] is Theorem 3.1 of [BN19].
The following is a direct consequence of the above theorem. It describes an explicit finite set of generators for $M_{k, G}$ as a vector space over $\mathbb{Q}$.
Lemma 6.6. Fix integers $N>2$ and $k \geq 2$. Let $G$ be a subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. Then $M_{k, G}$, as a $\mathbb{Q}$-vector space, is spanned by the set of modular forms of the form

$$
\begin{equation*}
\sum_{A \in G} \zeta_{N}^{j \operatorname{det} A} E_{\alpha_{1} A} \cdots E_{\alpha_{k} A} \tag{6.3}
\end{equation*}
$$

with $\alpha_{i} \in(\mathbb{Z} / N \mathbb{Z})^{2}-\{0\}$ and $0 \leq j<\left[\mathbb{Q}\left(\zeta_{N}\right): \mathbb{Q}\right]$.
Proof. Let $S$ be the set of modular forms of the form $\zeta_{N}^{j} E_{\alpha_{1}} \cdots E_{\alpha_{k}}$ with pairs $\alpha_{1}, \ldots, \alpha_{k} \in(\mathbb{Z} / N \mathbb{Z})^{2}-\{(0,0)\}$ and an integer $0 \leq j<\phi(N):=\left[\mathbb{Q}\left(\zeta_{N}\right): \mathbb{Q}\right]$. Since $E_{(0,0)}=0$, Theorem 6.5 implies that $S$ spans the complex vector space $M_{k}(\Gamma(N))$. We have $S \subseteq M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)$ by Lemma 6.3 . Since $k \geq 2$ and $N>2$, the natural map $M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right) \otimes_{\mathbb{Q}\left(\zeta_{N}\right)} \mathbb{C} \rightarrow M_{k}(\Gamma(N))$ is an isomorphism of complex vector spaces, cf. [Kat73, §1.7]. Since $S \subseteq M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)$ spans $M_{k}(\Gamma(N))$, we deduce that $S$ also spans the $\mathbb{Q}\left(\zeta_{N}\right)$ vector space $M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)$. Since $1, \zeta_{N}, \ldots, \zeta_{N}^{\phi(N)-1}$ is a basis of $\mathbb{Q}\left(\zeta_{N}\right)$ as a vector space over $\mathbb{Q}$, we find $S$ further spans $M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)$ as a vector space over $\mathbb{Q}$.

Define the $\mathbb{Q}$-linear map $T: M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right) \rightarrow M_{k, G}, f \mapsto \sum_{A \in G} f * A$. The map $T$ is surjective since we have $T(f)=|G| f$ for all $f \in M_{k, G}$. Therefore, $M_{k, G}$ as a $\mathbb{Q}$-vector space is spanned by the set of $T(f)$ with $f \in S$. It remains to compute $T(f)$ for $f \in S$. Take any $f=\zeta_{N}^{j} E_{\alpha_{1}} \cdots E_{\alpha_{k}} \in S$. We have

$$
T(f)=\sum_{A \in G}\left(\zeta_{N}^{j} E_{\alpha_{1}} \cdots E_{\alpha_{k}}\right) * A=\sum_{A \in G} \zeta_{N}^{j \operatorname{det} A}\left(E_{\alpha_{1}} * A\right) \cdots\left(E_{\alpha_{k}} * A\right)
$$

Finally note that $T(f)$ equals (6.3) by Lemma 6.4.
Remark 6.7. In [Zyw24], under the extra assumption $\operatorname{det}(G)=(\mathbb{Z} / N \mathbb{Z})^{\times}$, a version of Lemma 6.6 is required for an algorithm which finds an explicit basis of $M_{k, G}$ for any given even integer $k \geq 2$. Using a suitable weight $k \in\{2,4,6\}$, this basis can then used to compute an explicit model of the curve $X_{G}$ over $K_{G}=\mathbb{Q}$.

## 7. A Basis of modular forms with relatively small coefficients

Fix an integer $N>2$ and let $G$ be a subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ that satisfies $-I \in G$. In $\S 6.3$, we defined a finite dimensional $K_{G}$-vector space $M_{k, G}$ of modular forms of level $N$ and weight $k$. Since $-I \in G$, we find that $M_{k, G}=0$ for $k$ odd.

In this section, we prove the following result which shows that there is basis of $M_{k, G}$, viewed as a vector over $\mathbb{Q}$, consisting of modular forms whose $q$-expansion at each cusp has integral and relatively small coefficients.
Theorem 7.1. Fix an even integer $k \geq 2$. Then there is a basis $f_{1}, \ldots, f_{d}$ of the $\mathbb{Q}$-vector space $M_{k, G}$ such that for every $1 \leq i \leq d$ and every $A \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$, we have

$$
f_{i} * A=\sum_{n=0}^{\infty} a_{n} q_{N}^{n}
$$

where each coefficient $a_{n}$ lies in $\mathbb{Z}\left[\zeta_{N}\right]$ and satisfies

$$
\left|a_{n}\right|_{v} \leq 2|G| 4.5^{k} N^{k} \max \left\{N^{k}, n^{2 k}\right\}
$$

for all infinite places $v$ of $\mathbb{Q}\left(\zeta_{N}\right)$.
7.1. Bounding coefficients. Fix an even integer $k \geq 2$. Lemma 6.6 shows that there is a basis of $M_{k, G}$ obtained from Eisenstein series of weight 1. We will want to bound the size of the Fourier coefficients that arise in such a basis. We first prove a simple lemma that will be needed for these bounds. For each positive integer $n$, let $d(n)$ be the number of positive divisors of $n$.

Lemma 7.2. Take any positive integers $j$ and $n$, and define the sum

$$
S_{j, n}:=\sum_{a_{1}+\cdots+a_{j}=n} \prod_{i=1}^{j} d\left(a_{i}\right)
$$

where $a_{1}, \ldots, a_{j}$ vary over all positive integers. Then $S_{j, n} \leq 2 n^{j-1 / 2}(\log n+1)^{j-1}$.
Proof. We proceed by induction on $j \geq 1$. We have $d(n) \leq 2 n^{1 / 2}$ since for every positive divisor $e$ of $n$ at least one of $e$ or $n / e$ is bounded above $n^{1 / 2}$. The case $j=1$ is now clear since $S_{1, n}=d(n)$.

Now consider any $j \geq 1$ for which the lemma holds. We have $S_{j+1, n}=\sum_{a=1}^{n} d(a) S_{j, n-a}$. Thus by our inductive hypothesis, we have $S_{j+1, n} \leq 2 n^{j-1 / 2}(\log n+1)^{j-1} \sum_{a=1}^{n} d(a)$. So to prove the lemma, it suffices to show that $\sum_{a=1}^{n} d(a) \leq n(\log n+1)$.

We have inequalities $\sum_{a=1}^{n} d(a)=\#\{(b, c) \in \mathbb{N}: b c \leq n\} \leq \sum_{b=1}^{n}\lfloor n / b\rfloor \leq n \sum_{b=1}^{n} 1 / b$. Therefore, $\sum_{a=1}^{n} d(a) \leq n\left(1+\sum_{b=2}^{n} 1 / b\right) \leq n\left(1+\int_{1}^{n} 1 / x d x\right)=n(\log n+1)$ as desired.

Lemma 7.3. Fix positive integers $k$ and $N$. For any $\alpha_{1}, \ldots, \alpha_{k} \in(\mathbb{Z} / N \mathbb{Z})^{2}$, the $q$-expansion of $E_{\alpha_{1}} \cdots E_{\alpha_{k}}$ is of form $\sum_{n=0}^{\infty} a_{n} q_{N}^{n}$ with $a_{n} \in \mathbb{Q}\left(\zeta_{N}\right)$ that satisfy $\left|a_{0}\right| \leq(N / 4)^{k}$ and

$$
\left|a_{n}\right| \leq 2 n^{-1 / 2}(N / 4+2 n(\log n+1))^{k}
$$

for all $n \geq 1$.
Proof. First take any $\alpha \in(\mathbb{Z} / N \mathbb{Z})^{2}$ and fix $a, b \in \mathbb{Z}$ so that $\alpha \equiv(a, b)(\bmod N)$ with $0 \leq a<N$ and $|b| \leq N / 2$. Let $\sum_{n=0}^{\infty} c_{n}(\alpha) q_{N}^{n}$ be the $q$-expansion of $E_{\alpha}$. We have $c_{n}(\alpha) \in \mathbb{Q}\left(\zeta_{N}\right)$ by Lemma 6.3. Moreover, the explicit $q$-expansion given in Lemma 6.3 implies that $\left|c_{n}(\alpha)\right| \leq 2 d(n)$ for all $n \geq 1$.

We claim that $\left|c_{0}(\alpha)\right| \leq N / 4$. From Lemma 6.3, we have $\left|c_{0}(\alpha)\right| \leq 1 / 2$ if $a \not \equiv 0(\bmod N)$ or $b \equiv 0$ $(\bmod N)$. So to prove the claim, we may assume from Lemma 6.3 that $b \not \equiv 0(\bmod N)$ and $c_{0}(\alpha)=$ $1 / 2 \cdot\left(1+\zeta_{N}^{b}\right) /\left(1-\zeta_{N}^{b}\right)$. We have $\left|c_{0}(\alpha)\right|^{2} \leq\left|1-\zeta_{N}^{b}\right|^{-2}=(2-2 \cos (\theta))^{-1}$, where $\theta:=2 \pi b / N \in[-\pi, \pi]$. Since $2-2 \cos (x) \geq 4 / \pi^{2} \cdot x^{2}$ for all real $x \in[-\pi, \pi]$ and $\theta \neq 0$, we deduce that $\left|c_{0}(\alpha)\right|^{2} \leq \pi^{2} / 4 \cdot \theta^{-2}=$ $N^{2} /\left(16 b^{2}\right) \leq N^{2} / 16$. Therefore, $\left|c_{0}(\alpha)\right| \leq N / 4$ as claimed.

Multiplying the $q$-expansions of $E_{\alpha_{1}}, \ldots, E_{\alpha_{k}}$ together, we have

$$
\begin{equation*}
a_{n}=\sum_{n_{1}+\cdots+n_{k}=n, n_{i} \geq 0} \prod_{i=1}^{k} c_{n_{i}}\left(\alpha_{i}\right) . \tag{7.1}
\end{equation*}
$$

For $n=0$, we have $\left|a_{0}\right|=\prod_{i=1}^{k}\left|c_{0}\left(\alpha_{i}\right)\right| \leq(N / 4)^{k}$ which proves the lemma in this case.
Now take any integer $n \geq 1$. For each subset $I \subseteq\{1, \ldots, k\}$, we can consider those terms in the sum (7.1) for which we have $n_{i}=0$ exactly when $i \in I$. Using our bounds for the coefficients $c_{n}(\alpha)$, we deduce that

$$
\left|a_{n}\right| \leq \sum_{j=1}^{k}\binom{k}{j} \cdot(N / 4)^{k-j} \sum_{a_{1}+\cdots+a_{j}=n, a_{i} \geq 1} \prod_{i=1}^{j} 2 d\left(a_{i}\right) .
$$

Equivalently, $\left|a_{n}\right| \leq \sum_{j=1}^{k}\binom{k}{j} \cdot(N / 4)^{k-j} \cdot 2^{j} S_{j, n}$ with $S_{j, n}$ as in Lemma 7.2. By Lemma 7.2, we obtain the upper bounds

$$
\left|a_{n}\right| \leq 2 \sum_{j=1}^{k}\binom{k}{j} \cdot(N / 4)^{k-j} \cdot 2^{j} n^{j-1 / 2}(\log n+1)^{j} \leq 2 n^{-1 / 2} \sum_{j=1}^{k}\binom{k}{j}(N / 4)^{k-j}(2 n(\log n+1))^{j} .
$$

So by the binomial theorem, we have $\left|a_{n}\right| \leq 2 n^{-1 / 2}(N / 4+2 n(\log n+1))^{k}$.

Lemma 7.4. Fix positive integers $k$ and $N$ and take any $\alpha_{1}, \ldots, \alpha_{k} \in(\mathbb{Z} / N \mathbb{Z})^{2}$. Define the modular form $h:=(2 N)^{k} E_{\alpha_{1}} \cdots E_{\alpha_{k}} \in M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)$. For any $A \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$, the $q$-expansion of $h * A$ is of form $\sum_{n=0}^{\infty} a_{n} q_{N}^{n}$ so that each coefficient $a_{n}$ is an element of $\mathbb{Z}\left[\zeta_{N}\right]$ that satisfy $\left|a_{0}\right| \leq N^{2 k} / 2^{k}$ and

$$
\left|a_{n}\right| \leq 2 n^{-1 / 2} N^{k}(N / 2+4 n(\log n+1))^{k}
$$

for all $n \geq 1$.
Proof. By Lemma 6.3, we find that $h$, and hence also $h * A$, are modular forms in $M_{k}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)$. Using Lemma 6.4, we have $h * A=(2 N)^{k}\left(E_{\alpha_{1}} * A\right) \cdots\left(E_{\alpha_{k}} * A\right)=(2 N)^{k} E_{\beta_{1}} \cdots E_{\beta_{k}}$, where $\beta_{i}:=\alpha_{i} A$. Therefore, the desired bounds on the $\left|a_{n}\right|$ follow from those of Lemma 7.3 after multiplying by $(2 N)^{k}$.

Finally, to prove that each $a_{n}$ lies in $\mathbb{Z}\left[\zeta_{N}\right]$, it suffices to show that the $q$-expansion of $2 N \cdot E_{\beta_{i}}$ has coefficients in $\mathcal{O}_{\mathbb{Q}\left(\zeta_{N}\right)}=\mathbb{Z}\left[\zeta_{N}\right]$ for all $1 \leq i \leq k$. From the explicit $q$-expansions given in Lemma 6.3, it suffices to show that $N /\left(1-\zeta_{N}^{b}\right)$ lies in $\mathbb{Z}\left[\zeta_{N}\right]$ for any integer $b \not \equiv 0(\bmod N)$. We have $N /\left(1-\zeta_{N}^{b}\right) \in \mathbb{Z}\left[\zeta_{N}\right]$ since $\zeta_{N}^{b}-1$ is a root of $\left((x+1)^{N}-1\right) / x=x^{N-1}+\cdots+N \in \mathbb{Z}[x]$.
7.2. Proof of Theorem 7.1. By Lemma 6.6 , there is a basis $f_{1}, \ldots, f_{d}$ of the $\mathbb{Q}$-vector space $M_{k, G}$ such every $f_{i}$ has a $q$-expansion of the form

$$
\begin{equation*}
(2 N)^{k} \sum_{g \in G} \zeta_{N}^{j \operatorname{det} g} E_{\alpha_{1} g} \cdots E_{\alpha_{k} g} \tag{7.2}
\end{equation*}
$$

for some $\alpha_{1}, \ldots, \alpha_{k} \in(\mathbb{Z} / N \mathbb{Z})^{2}$ and integer $j$.
Take any $1 \leq i \leq d$ and $A \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. Let $\sum_{n=0}^{\infty} a_{n} q_{N}^{n}$ be the $q$-expansion of $f_{i} * A$. Take any infinite place $v$ of $\mathbb{Q}\left(\zeta_{N}\right)$. Since $\mathbb{Q}\left(\zeta_{N}\right) \subseteq \mathbb{C}$, there is a $\sigma \in \operatorname{Gal}\left(\mathbb{Q}\left(\zeta_{N}\right) / \mathbb{Q}\right)$ such that $|a|_{v}=|\sigma(a)|$ for all $a \in \mathbb{Q}\left(\zeta_{N}\right)$. There is a unique $d^{\prime} \in(\mathbb{Z} / N \mathbb{Z})^{\times}$for which $\sigma\left(\zeta_{N}\right)=\zeta_{N}^{d^{\prime}}$. Define $B:=A\left(\begin{array}{cc}1 & 0 \\ 0 & d^{\prime}\end{array}\right) \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. By Lemma 6.1, we have $f_{i} * B=\sum_{n=0}^{\infty} \sigma\left(a_{n}\right) q_{N}^{n}$. Since the $q$-expansion of $f_{i}$ is of the form (7.2), Lemma 7.4 implies that all of the $\sigma\left(a_{n}\right)$ are in $\mathbb{Z}\left[\zeta_{N}\right]$ and

$$
\left|a_{n}\right|_{v}=\left|\sigma\left(a_{n}\right)\right| \leq \begin{cases}|G| \cdot N^{2 k} / 2^{k} & \text { if } n=0 \\ |G| \cdot 2 n^{-1 / 2} N^{k}(N / 2+4 n(\log n+1))^{k} & \text { if } n \geq 1\end{cases}
$$

It remains to prove that $\left|a_{n}\right|_{v} \leq 2|G| 4.5^{k} N^{k} \max \left\{N^{k}, n^{2 k}\right\}$. This is immediate for $n=0$ from the above bound, so assume that $n \geq 1$. We have $\log n+1 \leq n$, so $\left|a_{n}\right|_{v} \leq 2|G| N^{k}\left(N / 2+4 n^{2}\right)^{k}$. When $N \leq n^{2}$, we have $\left|a_{n}\right|_{v} \leq 2|G| N^{k}\left(4.5 n^{2}\right)^{k}$. When $N \geq n^{2}$, we have $\left|a_{n}\right|_{v} \leq 2|G| N^{k}(4.5 N)^{k}$. The theorem is now immediate.

## 8. Riemann-Roch

Fix an integer $N>2$ and let $G$ be a subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ with $-I \in G$. Let $g$ be the genus of the curve $X_{G}$ and let $\mu$ be the degree of the morphism $j: X_{G} \rightarrow \mathbb{P}_{K_{G}}^{1}$. The group Gal ${ }_{K_{G}}$ acts on the set of cusps $\mathcal{C}_{G}$ of $X_{G}$ by Lemma 2.3(ii).

Consider a proper subset of $\Sigma \subseteq \mathcal{C}_{G}$ that is stable under the $\mathrm{Gal}_{K_{G}}$-action. For our application, we will require a nonconstant function $\varphi \in K_{G}\left(X_{G}\right)$ whose poles are all at cusps and has no pole at any cusp $c \in \Sigma$. In this section, we use the Riemann-Roch theorem to find spaces of modular forms from which we can construct such $\varphi$.

Consider a divisor $D=\sum_{c \in \mathcal{C}_{G}} n_{c} \cdot c$ of $X_{G}$ that is defined over $K_{G}$, i.e., $n_{c}=n_{\sigma(c)}$ for all $c \in \mathcal{C}_{G}$ and $\sigma \in \operatorname{Gal}_{K_{G}}$. Define the $K_{G}$-vector space $\mathscr{L}(D):=\left\{\varphi \in K_{G}\left(X_{G}\right): \operatorname{div}(\varphi)+D \geq 0\right\}$; equivalently, $\mathscr{L}(D)$ consists of those functions $\varphi \in K_{G}\left(X_{G}\right)$ whose poles all occur at cusps and $\operatorname{ord}_{c}(\varphi)+n_{c} \geq 0$ for all $c \in \mathcal{C}_{G}$. By the Riemann-Roch theorem, we have $\operatorname{dim}_{K_{G}} \mathscr{L}(D) \geq \operatorname{deg}(D)-g+1$ with equality holding when $\operatorname{deg}(D)>2 g-2$.

For a fixed positive integer $m$, define the divisors $D_{0}:=\sum_{c \in \mathcal{C}_{G}} m w_{c} \cdot c$ and $D_{1}:=\sum_{c \in \mathcal{C}_{G}-\Sigma} m w_{c} \cdot c$. The divisors $D_{0}$ and $D_{1}$ are defined over $K_{G}$ since $\mathcal{C}_{G}$ and $\Sigma$ are both stable under the Gal ${ }_{K_{G}}$-action (also $w_{\sigma(c)}=w_{c}$ for all $c \in \mathcal{C}_{G}$ and $\left.\sigma \in \operatorname{Gal}_{K_{G}}\right)$. The functions in $\mathscr{L}\left(D_{0}\right)$ have no poles away from the cusps. The functions in the subspace $\mathscr{L}\left(D_{1}\right) \subseteq \mathscr{L}\left(D_{0}\right)$ are regular at all $c \in \Sigma$.

By Lemma 6.2, we have an injective $K_{G}$-linear map

$$
T: M_{12 m, G} \hookrightarrow K_{G}\left(X_{G}\right), \quad f \mapsto f / \Delta^{m}
$$

Let $W_{m}$ be the $K_{G}$-subspace of $M_{12 m, G}$ consisting of those modular forms $f$ for which $\nu_{c}(f) \geq m w_{c}$ for all $c \in \Sigma$, where $\nu_{c}$ is defined in $\S 6.3$.

## Lemma 8.1.

(i) We have $T\left(M_{12 m, G}\right)=\mathscr{L}\left(D_{0}\right)$ and $T\left(W_{m}\right)=\mathscr{L}\left(D_{1}\right)$.
(ii) We have $\operatorname{dim}_{K_{G}} M_{12 m, G}=m \mu-g+1$ and

$$
\operatorname{dim}_{K_{G}} W_{m} \geq m \sum_{c \in \mathcal{C}_{G}-\Sigma} w_{c}-g+1
$$

Proof. We first prove that $T\left(M_{12 m, G}\right)=\mathscr{L}\left(D_{0}\right)$. Take any $f \in M_{12 m, G}$ and define $\varphi:=T(f)=f / \Delta^{m} \in$ $K_{G}\left(X_{G}\right)$. Every pole of $\varphi$ is a cusp since $\Delta$, when viewed as a function of the upper half-plane, is holomorphic and everywhere nonzero. Take any cusp $c \in \mathcal{C}_{G}$. By (6.1), we have $\operatorname{ord}_{c} \varphi=\nu_{c}(f)-\nu_{c}\left(\Delta^{m}\right)=\nu_{c}(f)-m w_{c} \geq$ $-m w_{c}$. Therefore, $T(f)=\varphi \in \mathscr{L}\left(D_{0}\right)$. We have $T\left(M_{12 m, G}\right) \subseteq \mathscr{L}\left(D_{0}\right)$ since $f$ was an arbitrary element of $M_{12 m, G}$.

Now take any $\varphi \in \mathscr{L}\left(D_{0}\right)$. Define $f:=\varphi \Delta^{m}$; it is a weakly modular form of weight $12 m$. For each $c \in \mathcal{C}_{G}$, we have $\operatorname{ord}_{c}(\varphi)+\nu_{c}\left(\Delta^{m}\right)=\operatorname{ord}_{c}(\varphi)+m w_{c} \geq 0$, where the inequality use our choice of $\varphi$. Therefore, $f$ is a modular form of weight $12 m$ on $\Gamma(N)$. We have $f \in M_{12 m}\left(\Gamma(N), \mathbb{Q}\left(\zeta_{N}\right)\right)$ since the $q$-expansions of $\varphi$ and $\Delta$ have coefficients in $\mathbb{Q}\left(\zeta_{N}\right)$. For any $A \in G$, we have $f * A=\left(\varphi \Delta^{m}\right) * A=(\varphi * A)\left(\Delta^{m} * A\right)=\varphi \Delta^{m}$. Therefore, $f \in M_{12 m, G}$ and hence $\varphi=T(f)$ lies in $T\left(M_{12 m, G}\right)$. We have $T\left(M_{12 m, G}\right) \supseteq \mathscr{L}\left(D_{0}\right)$ since $\varphi$ was an arbitrary element of $\mathscr{L}\left(D_{0}\right)$. This completes the proof that $T\left(M_{12 m, G}\right)=\mathscr{L}\left(D_{0}\right)$.

For any $f \in M_{12 m, G}$, we have $\operatorname{ord}_{c}(T(f))=\nu_{c}(f)-m w_{c}$ for each $c \in \mathcal{C}_{G}$. So $T(f) \in \mathscr{L}\left(D_{1}\right)$ if and only if $\nu_{c}(f) \geq m w_{c}$ for each $c \in \Sigma$. Since $T\left(M_{12 m, G}\right)=\mathscr{L}\left(D_{0}\right)$, we deduce that $T\left(W_{m}\right)=\mathscr{L}\left(D_{1}\right)$.

By the Riemann-Roch theorem, we have

$$
\operatorname{dim}_{K_{G}} W_{m}=\operatorname{dim}_{K_{G}} \mathscr{L}\left(D_{1}\right) \geq \operatorname{deg}\left(D_{1}\right)-g+1=m \sum_{c \in \mathcal{C}-\Sigma} w_{c}-g+1
$$

We have $\operatorname{deg}\left(D_{0}\right)=\sum_{c \in \mathcal{C}_{G}} m w_{c}=m \mu$ by (2.1) and $2 g-2<\mu / 6$ by [Shi94, Proposition 1.40]. Therefore, $\operatorname{deg}\left(D_{0}\right)>2 g-2$. By the Riemann-Roch theorem, we have $\operatorname{dim}_{K_{G}} M_{12 m, G}=\operatorname{dim}_{K_{G}} \mathscr{L}\left(D_{0}\right)=\operatorname{deg}\left(D_{1}\right)-$ $g+1=m \mu-g+1$.

Take any $f \in W_{m}$ and define $\varphi:=T(f)=f / \Delta^{m}$. By Lemma 8.1, $\varphi \in K_{G}\left(X_{G}\right)$ is a function that is regular at all $c \in \Sigma$ and all of its poles are at cusps. In order for $\varphi$ to be nonconstant, we need $f$ not to lie in the subspace $K_{G} \Delta^{m} \subseteq W_{m}$. Thus to construct a nonconstant $\varphi$ in this manner, we need $\operatorname{dim}_{K_{G}} W_{m} \geq 2$; by Lemma 8.1 this holds for all sufficiently large $m$.

## 9. Existence of a certain modular form

Fix an integer $N>2$ and let $G$ be a subgroup of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ with $-I \in G$. Let $g$ be the genus of the curve $X_{G}$ and let $\mu$ be the degree of the morphism $j: X_{G} \rightarrow \mathbb{P}_{K_{G}}^{1}$.

Let $\Sigma$ be a proper subset of $\mathcal{C}_{G}$ that is stable under the $\operatorname{Gal}_{K_{G}}$-action. Let $m$ be the smallest positive integer for which $m \sum_{c \in \mathcal{C}_{G}-\Sigma} w_{c}>g$. Define the real number

$$
\beta:=2\left(2^{3} 4.5^{36 m} N^{108 m+15} m^{72 m+1}\right)^{m \mu+1} 4.5^{12 m} N^{36 m+4} .
$$

Theorem 9.1. There is a nonzero modular form $f \in M_{12 m, G}$ that satisfies the following properties:
(a) We have $\nu_{c}(f) \geq m w_{c}$ for all $c \in \Sigma$.
(b) The modular form $f$ does not lie in $K_{G} \Delta^{m}$.
(c) Take any $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$. Define the cusp $c:=A \cdot c_{\infty}$ of $X_{G}$, where $c_{\infty}$ is the cusp at infinity, and set $w=w_{c}$. Then we have $f * A=\sum_{n=0}^{\infty} b_{n} q_{w}^{n}$, where each coefficient $b_{n}$ lies in $\mathbb{Z}\left[\zeta_{N}\right]$ and satisfies

$$
\left|b_{n}\right|_{v} \leq \beta \max \left\{1,(n / w)^{24 m}\right\}
$$

for each infinite place $v$ of $\mathbb{Q}\left(\zeta_{N}\right)$.
9.1. Proof of Theorem 9.1. Set $k=12 m$ and define $d:=\operatorname{dim}_{\mathbb{Q}} M_{k, G}$. Fix a basis $f_{1}, \ldots, f_{d}$ of the $\mathbb{Q}$-vector space $M_{k, G}$ satisfying the conclusion of Theorem 7.1. Using Lemma 8.1, we find that

$$
d=\left[K_{G}: \mathbb{Q}\right] \operatorname{dim}_{K_{G}} M_{k, G}=\left[K_{G}: \mathbb{Q}\right](m \mu-g+1)
$$

Let $W$ be the $K_{G}$-subspace of $M_{k, G}$ consisting of those modular forms $f$ for which $\nu_{c}(f) \geq m w_{c}$ for all $c \in \Sigma$. By Lemma 8.1 and our choice of $m$, we have $\operatorname{dim}_{K_{G}} W \geq 2$. We will now describe $W$ as the kernel of a linear map on $M_{k, G}$.

Define $L:=\mathbb{Q}\left(\zeta_{N}\right)$. For each cusp $c \in \Sigma$, we choose a matrix $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $A \cdot c_{\infty}=c$. For any $f \in M_{k, G}$, we have $f * A=\sum_{n=0}^{\infty} a_{c, n}(f) q_{w_{c}}^{n}$ with $a_{c, n}(f) \in L$. Define the $\mathbb{Q}$-linear map

$$
\psi_{c}: M_{k, G} \rightarrow L^{m w_{c}}, \quad f \mapsto\left(a_{c, 0}(f), \ldots, a_{c, m w_{c}-1}(f)\right)
$$

Combining the maps $\psi_{c}$ with $c \in \Sigma$, we obtain a $\mathbb{Q}$-linear map

$$
\psi: M_{k, G} \rightarrow \prod_{c \in \Sigma} L^{m w_{c}}
$$

Note that the kernel of $\psi$ is $W$. Let

$$
\alpha_{0}: \mathbb{Q}^{d} \rightarrow \prod_{c \in \Sigma} L^{m w_{c}}
$$

be the $\mathbb{Q}$-linear map obtained by composing the isomorphism $\mathbb{Q}^{d} \xrightarrow{\sim} M_{k, G}$ coming from the basis $f_{1}, \ldots, f_{d}$ with $\psi$. We have $\operatorname{dim}_{\mathbb{Q}} \operatorname{ker}\left(\alpha_{0}\right)=\operatorname{dim}_{\mathbb{Q}} W$.

We have an isomorphism $L \otimes_{\mathbb{Q}} \mathbb{R} \xrightarrow{\sim} \prod_{v \in M_{L, \infty}} L_{v}$ of real vector spaces induced by the inclusions $L \subseteq L_{v}$. Tensoring $\alpha_{0}$ with $\mathbb{R}$ gives a $\mathbb{R}$-linear map

$$
\alpha: V_{1} \rightarrow V_{2}
$$

where $V_{1}=\mathbb{R}^{d}$ and $V_{2}=\prod_{c \in \Sigma} \prod_{v \in M_{L, \infty}} L_{v}^{m w_{c}}$. We have $\operatorname{dim}_{\mathbb{R}} \operatorname{ker}(\alpha)=\operatorname{dim}_{\mathbb{Q}} W$.
We define norms on $V_{1}$ and $V_{2}$ by $\|b\|_{1}:=\sum_{i=1}^{d}\left|b_{i}\right|$ and $\left\|\left(b_{c, v}\right)\right\|_{2}:=\max _{c \in \Sigma, v \in M_{L, \infty}}\left|b_{c, v}\right|_{v}$, respectively. The group $M_{1}:=\mathbb{Z}^{d}$ is a lattice in $V_{1}$; it is generated by elements of norm 1 . Let $M_{2}$ be the lattice in $V_{2}$ corresponding to the subgroup $\prod_{c \in \Sigma} \mathcal{O}_{L}^{m w_{c}}$ of $\prod_{c \in \Sigma} L^{m w_{c}}$. For each $i \in\{1,2\}$ and nonzero $b \in M_{i}$, we have $\|b\|_{i} \geq 1$. For each $1 \leq i \leq d$, we have $\psi_{c}\left(f_{i}\right) \in \mathcal{O}_{L}^{m w_{c}}$ for all $c \in \Sigma$ by our choice of basis $f_{1}, \ldots, f_{d}$. Therefore, $\alpha\left(M_{1}\right) \subseteq M_{2}$.

The norm $\|\alpha\|$ of $\alpha$ is the minimal real number for which $\|\alpha(v)\|_{2} \leq\|\alpha\|\|v\|_{1}$ holds for all $v \in V_{1}$. We now find an upper bound for $\|\alpha\|$.
Lemma 9.2. We have $\|\alpha\| \leq 2|G| 4.5^{k} N^{3 k} m^{2 k}$.
Proof. Take any $b \in \mathbb{R}^{d}$. We have $\alpha(b)=\sum_{i=1}^{d} b_{i} \alpha\left(e_{i}\right)$, where $e_{1}, \ldots, e_{d}$ is the standard basis of $\mathbb{R}^{d}$. Taking the norm gives $\|\alpha(b)\|_{2} \leq \sum_{i=1}^{d}\left|b_{i}\right|\left\|\alpha\left(e_{i}\right)\right\|_{2} \leq \max _{1 \leq i \leq d}\left\|\alpha\left(e_{i}\right)\right\|_{2} \cdot\|b\|_{1}$. Therefore, $\|\alpha\| \leq \max _{1 \leq i \leq d}\left\|\alpha\left(e_{i}\right)\right\|_{2}$ and hence

$$
\|\alpha\| \leq \max \left\{\left|a_{c, n}\left(f_{i}\right)\right|_{v}: i \in\{1, \ldots, d\}, n \in\left\{0, \ldots, m w_{c}-1\right\}, c \in \Sigma, v \in M_{L, \infty}\right\}
$$

Take any $1 \leq i \leq d, c \in \Sigma$ and $v \in M_{L, \infty}$. Recall that $f * A=\sum_{n=0}^{\infty} a_{c, n}(f) q_{w_{c}}^{n}$ for some $A \in \operatorname{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$. In particular, $f * A=\sum_{n=0}^{\infty} a_{c, n}(f) q_{N}^{n N / w_{c}}$. By Theorem 7.1, we have $\left|a_{c, 0}\left(f_{i}\right)\right|_{v} \leq|G| N^{2 k} / 2^{k}$. Now take any $1 \leq n<m w_{c}$ and define the integer $n_{0}:=n N / w_{c}$. We have $1 \leq n_{0}<m N$. By Theorem 7.1, we have

$$
\left|a_{c, n}\left(f_{i}\right)\right|_{v} \leq 2|G| 4.5^{k} N^{k} \max \left\{N^{k}, n_{0}^{2 k}\right\} \leq 2|G| 4.5^{k} N^{3 k} m^{2 k}
$$

Combining everything together, we have now shown that $\|\alpha\| \leq 2|G| 4.5^{k} N^{3 k} m^{2 k}$.
Before proceeding, we recall the following version of Siegel's lemma due to Faltings.
Lemma 9.3. Let $V_{1}$ and $V_{2}$ be finite dimensional real vector spaces with norms $|\cdot|_{1}$ and $|\cdot|_{2}$, respectively. Let $M_{1}$ and $M_{2}$ be $\mathbb{Z}$-lattices of $V_{1}$ and $V_{2}$, respectively. Let $\alpha: V_{1} \rightarrow V_{2}$ be a linear map that satisfies $\alpha\left(M_{1}\right) \subseteq M_{2}$. Let $C \geq 2$ be a real number such that $\alpha$ has norm at most $C$ (i.e., $|\alpha(v)|_{2} \leq C \cdot|v|_{1}$ for all $\left.v \in V_{1}\right), M_{1}$ is generated by elements of norm at most $C$, and every nonzero element of $M_{1}$ and $M_{2}$ has norm at least $C^{-1}$. Define $a=\operatorname{dim} \operatorname{ker}(\alpha)$ and $b=\operatorname{dim} V_{1}$. Then for each $0 \leq i \leq a-1$, $\operatorname{ker}(\alpha)$ contains linearly independent elements $m_{1}, \ldots, m_{i+1}$ of $M_{1}$ satisfying

$$
\max _{1 \leq j \leq i+1}\left|m_{j}\right|_{1} \leq\left(C^{3} \cdot b\right)^{b /(a-i)}
$$

Proof. See [Fal91, Proposition 2.18] or [Koo93, Lemma 4]; they give the upper bound $\left(C^{3 b} \cdot b!\right)^{1 /(a-i)}$ from which our follows by using that $b!\leq b^{b}$.

We now apply Siegel's lemma in our setting. Define $\mathcal{B}:=\left(2^{3} 4.5^{3 k} N^{9 k+15} m^{6 k+1}\right)^{m \mu+1}$.
Lemma 9.4. There is a $u \in \mathbb{Z}^{d}$ with $\|u\|_{1} \leq \mathcal{B}$ such that $\sum_{i=1}^{d} u_{i} f_{i}$ lies in $W$ but does not lie in the subspace $K_{G} \Delta^{m}$.

Proof. Define $a:=\operatorname{dim}_{\mathbb{R}} \operatorname{ker}(\alpha)=\operatorname{dim}_{\mathbb{Q}} W=\left[K_{G}: \mathbb{Q}\right] \operatorname{dim}_{K_{G}} W \geq 2\left[K_{G}: \mathbb{Q}\right]$ and $b:=\operatorname{dim} V_{1}=d=\left[K_{G}\right.$ : $\mathbb{Q}](m \mu-g+1)$. Using Lemma 9.2, we find that the conditions of Lemma 9.3 hold in our setting with $C:=2|G| 4.5^{k} N^{3 k} m^{2 k}$.

Now take $i:=\left[K_{G}: \mathbb{Q}\right]$; we have $i<a$. By Lemma 9.3, there are linearly independent vectors $m_{1}, \ldots, m_{i+1} \in \mathbb{Z}^{d}$ in $\operatorname{ker}(\alpha)$ satisfying $\left\|m_{j}\right\|_{1} \leq\left(C^{3} b\right)^{b /(a-i)}$ for all $1 \leq j \leq i+1$. Since $i+1>\left[K_{G}\right.$ : $\mathbb{Q}]=\operatorname{dim}_{\mathbb{Q}}\left(K_{G} \Delta^{m}\right)$, there is a vector $u \in\left\{m_{1}, \ldots, m_{i+1}\right\} \subseteq \mathbb{Z}^{d}$ so that

$$
f:=\sum_{i=1}^{d} u_{i} f_{i}
$$

is a modular form in $M_{k, G}$ for which $f$ does not lie in $K_{G} \Delta^{m}$. Since $u$ is in the kernel of $\alpha$, and hence also the kernel of $\alpha_{0}$, we find that $f$ lies in $W$. We have $\|u\|_{1} \leq\left(C^{3} b\right)^{b /(a-i)}$ since $u=m_{j}$ for some $j$.

It remains to bound $\left(C^{3} b\right)^{b /(a-i)}$ from above. We have $a-i \geq 2\left[K_{G}: \mathbb{Q}\right]-\left[K_{G}: \mathbb{Q}\right]=\left[K_{G}: \mathbb{Q}\right]$ and $b=\left[K_{G}: \mathbb{Q}\right](m \mu-g+1)$, so $b /(a-i) \leq m \mu-g+1 \leq m \mu+1$. We have

$$
C^{3} b=2^{3} 4.5^{3 k} N^{9 k} m^{6 k} \cdot|G|^{3}\left[K_{G}: \mathbb{Q}\right] \cdot(m \mu-g+1)
$$

We have $\left[K_{G}: \mathbb{Q}\right] \leq\left[\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z}): G\right]$, so $|G|^{3}\left[K_{G}: \mathbb{Q}\right] \leq\left|\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})\right|^{3} \leq N^{12}$. We have $m \mu-g+1 \leq m \mu+$ $1 \leq 2 m \mu \leq m N^{3}$ by Lemma 4.2. Therefore, $C^{3} b \leq 2^{3} 4.5^{3 k} N^{9 k+15} m^{6 k+1}$ and hence $\left(C^{3} b\right)^{b /(a-i)} \leq \mathcal{B}$.

Fix a $u \in \mathbb{Z}^{d}$ as in Lemma 9.4. Define $f:=\sum_{i=1}^{d} u_{i} f_{i}$; it is an element of $W$ that does not lie in $K_{G} \Delta^{m}$.
Take any matrix $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ and take any infinite place $v$ of $\mathbb{Q}\left(\zeta_{N}\right)$ Define the cusp $c:=A \cdot c_{\infty}$ and set $w=w_{c}$. We now consider the $q$-expansions $f * A=\sum_{n=0}^{\infty} a_{n} q_{N}^{n}$ and $f_{i} * A=\sum_{n=0}^{\infty} a_{i, n} q_{N}^{n}$ with $1 \leq i \leq d$. Since $f=\sum_{i=1}^{d} u_{i} f_{i}$, we have $a_{n}=\sum_{i=1}^{d} u_{i} a_{i, n}$ for all $n \geq 0$. So for $n \geq 0$, we have $\left|a_{n}\right|_{v} \leq\|u\|_{1} \max _{1 \leq i \leq d}\left|a_{i, n}\right|_{v} \leq \mathcal{B} \max _{1 \leq i \leq d}\left|a_{i, n}\right|_{v}$.

Since $f_{1}, \ldots, f_{d}$ is a basis of $M_{k, G}$ satisfying the conclusion of Theorem 7.1, we find that

$$
\left|a_{n}\right|_{v} \leq \mathcal{B} \cdot 2 \cdot 4.5^{k} N^{k+4} \max \left\{N^{k}, n^{2 k}\right\}
$$

where we have used the bound $|G| \leq N^{4}$. However, recall that we are interested in the coefficients of the $q$-expansion $\sum_{n=0}^{\infty} b_{n} q_{w}^{n}$ of $f * A$. We must have $b_{n}=a_{n N / w}$ for all $n \geq 0$. So for $n \geq 0$, we have

$$
\begin{aligned}
\left|b_{n}\right|_{v}=\left|a_{n N / w}\right|_{v} & \leq \mathcal{B} \cdot 2 \cdot 4.5^{k} N^{k+4} \max \left\{N^{k},(n N / w)^{2 k}\right\} \\
& \leq \mathcal{B} \cdot 2 \cdot 4.5^{k} N^{2 k+4} \max \left\{1, N^{k}(n / w)^{2 k}\right\} \\
& \leq \mathcal{B} \cdot 2 \cdot 4.5^{k} N^{3 k+4} \max \left\{1,(n / w)^{2 k}\right\}
\end{aligned}
$$

The theorem follows since $k=12 m$ and hence $\beta=\mathcal{B} \cdot 2 \cdot 4.5^{k} N^{3 k+4}$.
9.2. Some bounds. We now prove some technical lemmas that we will later use to bound functions near cusps. Note that the bound on $c_{n}$ in the following lemma is, up to a constant factor, that of $\left|b_{n}\right|_{v}$ from Theorem 9.1.

Lemma 9.5. Take any real number $0 \leq u \leq e^{-\pi \sqrt{3}}$ and positive integer $m$. Fix a positive divisor $w$ of $N$ and let $\left\{c_{n}\right\}_{n \geq 1}$ be a sequence of nonnegative real numbers that satisfy $c_{n} \leq \max \left\{1,(n / w)^{24 m}\right\}$.
(i) For any integer $B \geq 5 \mathrm{mw}$, we have $\sum_{n=B}^{\infty} c_{n} u^{n / w} \leq 230.8 w u^{B / w}(B / w)^{24 m+1}$.
(ii) For any integer $m w \leq B \leq 5 m w$, we have $\sum_{n=B}^{\infty} c_{n} u^{n / w} \leq 231.6 w u^{B / w}(5 m)^{24 m+1}$.

Proof. Set $u_{0}:=e^{-\pi \sqrt{3}}$ and $a:=-24 / \log \left(u_{0}\right) \cdot m=m \cdot 4.410 \ldots$ Define the function $g(x)=x^{24 m} u_{0}^{x}$. One can check that $g(x)$ is increasing for $0 \leq x \leq a$ and decreasing for $x \geq a$.

We first assume that $B \geq 5 \mathrm{mw}$. We have

$$
\sum_{n=B}^{\infty} c_{n} u^{n / w}=u^{B / w} \sum_{n=0}^{\infty} c_{n+B} u^{n / w}=u^{B / w} \sum_{e=0}^{\infty}\left(\sum_{r=0}^{w-1} c_{e w+r+B} u^{r / w}\right) u^{e}
$$

For all integers $e \geq 0$ and $0 \leq r<w$, we have

$$
c_{e w+r+B} \leq((e w+r+B) / w)^{24 m} \leq(e+1+B / w)^{24 m}
$$

where the first bound uses that $(e w+r+B) / w \geq B / w \geq 1$. Using that $u^{r / w} \leq 1$ for all $0 \leq r<w$ and that $u \leq u_{0}$, we obtain

$$
\begin{equation*}
\sum_{n=B}^{\infty} c_{n} u^{n / w} \leq u^{B / w} w \sum_{e=0}^{\infty}(e+1+B / w)^{24 m} u_{0}^{e}=u^{B / w} w u_{0}^{-1-B / w} C \tag{9.1}
\end{equation*}
$$

where $C:=\sum_{e=0}^{\infty} g(e+1+B / w)$. Since $g(x)$ is decreasing for $x \geq 5 m$ and $B / w \geq 5 m$, we have

$$
C \leq \int_{0}^{\infty} g(x+B / w) d x=\int_{B / w}^{\infty} g(x) d x=\sum_{i=0}^{\infty} s_{i}
$$

where $s_{i}:=\int_{2^{i} B / w}^{2^{i+1} B / w} g(x) d x$. For $x \geq 5 m$, we have $g(2 x) / g(x)=2^{24 m} u_{0}^{x} \leq\left(2^{24} u_{0}^{5}\right)^{m} \leq 0.000026$. For each $i \geq 1$, we have

$$
s_{i}=2 \int_{2^{i-1} B / w}^{2^{i} B / w} g(2 x) d x \leq 0.000026 \int_{2^{i-1} B / w}^{2^{i} B / w} g(x) d x=0.000026 s_{i-1} .
$$

Therefore, $s_{i} \leq(0.000026)^{i} s_{0}$ for all $i \geq 0$ and hence $C \leq \sum_{i=0}^{\infty} s_{i} \leq(1-0.000026)^{-1} s_{0} \leq 1.00003 s_{0}$. Since $g(x)$ is decreasing for $x \geq 5 m$ and $B / w \geq 5 m$, we have $s_{0} \leq g(B / w) B / w$ and hence $C \leq 1.00003(B / w)^{24 m+1} u_{0}^{B / w}$. By (9.1), we deduce that

$$
\sum_{n=B}^{\infty} c_{n} u^{n / w} \leq 1.00003 u_{0}^{-1} w u^{B / w}(B / w)^{24 m+1} \leq 230.8 w u^{B / w}(B / w)^{24 m+1}
$$

which proves (i).
We now assume that $m w \leq B<5 m w$. From part (i), in the special case $B=5 m w$, we have

$$
\begin{equation*}
\sum_{n=5 m w}^{\infty} c_{n} u^{n / w} \leq 230.8 w u^{5 m}(5 m)^{24 m+1} \leq 230.8 w u^{B / w}(5 m)^{24 m+1} \tag{9.2}
\end{equation*}
$$

We have

$$
\sum_{n=B}^{5 m w-1} c_{n} u^{n / w} \leq u^{B / w} \sum_{n=B}^{5 m w-1}(n / w)^{24 m} u^{(n-B) / w} \leq u^{B / w}(5 m)^{24 m}(5 m w-m w)
$$

So $\sum_{n=B}^{5 m w} c_{n} u^{n / w} \leq 0.8 w u^{B / w}(5 m)^{24 m+1}$ and by combining with (9.2) we deduce (ii).
Lemma 9.6. Take any positive integer $m$ and let $\sum_{n=m}^{\infty} a_{n} q^{n}$ be the $q$-expansion of $\Delta^{m}$. Take any real number $0 \leq u \leq e^{-\pi \sqrt{3}}$.
(i) We have $\left|a_{n}\right| \leq 2 n^{6 m}$ for all $n \geq 2$.
(ii) For any integer $B>2 m$, we have $\sum_{n=B}^{\infty}\left|a_{n}\right| u^{n} \leq 463 u^{B}(B-1)^{6 m+1}$.
(iii) For any integer $m<B \leq 2 m$, we have $\sum_{n=B}^{\infty}\left|a_{n}\right| u^{n} \leq 465 u^{B}(2 m)^{6 m+1}$.

Proof. In [Rou08], Rouse describes a constant $C_{m}$ for which $\left|a_{n}\right| \leq C_{m} d(n) n^{(12 m-1) / 2}$ holds for all $n \geq m$; this follows from expressing $\Delta^{m}$ as a linear combination of Hecke eigenforms and using bounds of Deligne. When $m>1$, an explicit upper bound for $C_{m}$ is given in the proof of Theorem 1 in [Rou08] from which we find that $C_{m} \leq 1$. When $m=1$, we have $C_{m}=1$ as noted in the appendix of [Rou08]. Therefore, $\left|a_{n}\right| \leq d(n) n^{(12 m-1) / 2}$. We obtain $\left|a_{n}\right| \leq 2 n^{6 m}$ by using the easy bound $d(n) \leq 2 \sqrt{n}$. This proves (i).

Define $u_{0}:=e^{-\pi \sqrt{3}}$. Define the function $g(x)=x^{6 m} u_{0}^{x}$; it is decreasing for all $x \geq a:=-6 / \log \left(u_{0}\right) \cdot m=$ $m \cdot 1.102 \ldots$

We first assume that $B \geq 2 m$. Using (i) and $u \leq u_{0}$, we have

$$
\begin{equation*}
\sum_{n=B+1}^{\infty}\left|a_{n}\right| u^{n} \leq 2 u^{B+1} \sum_{n=B+1}^{\infty} n^{6 m} u_{0}^{n-B-1}=2 u^{B+1} u_{0}^{-B-1} C \tag{9.3}
\end{equation*}
$$

where $C:=\sum_{n=B+1}^{\infty} g(n)$. Since $g(x)$ is decreasing for $x \geq B \geq 2 m$, we have $C \leq \int_{B}^{\infty} g(x) d x=\sum_{i=0}^{\infty} s_{i}$, where $s_{i}:=\int_{2^{i} B}^{2^{i+1} B} g(x) d x$. For $x \geq 2 m$, we have $g(2 x) / g(x)=2^{6 m} u_{0}^{x} \leq\left(2^{6} u_{0}^{2}\right)^{m} \leq 0.0013$. For each $i \geq 1$, we have

$$
s_{i}=2 \int_{2^{i-1} B}^{2^{i} B} g(2 x) d x \leq 0.0013 \int_{2^{i-1} B}^{2^{i} B} g(x) d x=0.0013 s_{i-1}
$$

Therefore, $s_{i} \leq(0.0013)^{i} s_{0}$ for all $i \geq 0$ and hence $C \leq \sum_{i=0}^{\infty} s_{i} \leq(1-0.0013)^{-1} s_{0} \leq 1.0014 s_{0}$. Since $g(x)$ is decreasing for $x \geq B \geq 2 m$, we have $s_{0} \leq g(B) B$ and hence $C \leq 1.0014 B^{6 m+1} u_{0}^{B}$. By (9.3), we deduce that

$$
\sum_{n=B+1}^{\infty}\left|a_{n}\right| u^{n} \leq 2 \cdot 1.0014 u_{0}^{-1} u^{B+1} B^{6 m+1} \leq 463 u^{B+1} B^{6 m+1}
$$

This implies (ii) after replacing $B$ by $B-1$.
Now take any $m<B \leq 2 m$. We have

$$
\sum_{n=B}^{2 m}\left|a_{n}\right| u^{n} \leq u^{B} \sum_{n=B}^{2 m}\left|a_{n}\right| \leq u^{B} \cdot 2(2 m)^{6 m} \cdot(2 m-B+1) \leq u^{B}(2 m)^{6 m+1}
$$

From (ii), we have $\sum_{n=2 m+1}^{\infty}\left|a_{n}\right| u^{n} \leq 463 u^{2 m+1}(2 m)^{6 m+1}$. By adding these sums, we obtain $\sum_{n=B}^{\infty}\left|a_{n}\right| u^{n} \leq$ $464 u^{B}(2 m)^{6 m+1}$.

## 10. Proof of Theorem 4.1

With $k:=12 m$, fix a modular form $f \in M_{k, G}=M_{12 m, G}$ as in Theorem 9.1. Define $\varphi:=f / \Delta^{m}$. We have $\varphi \in K_{G}\left(X_{G}\right)$ by Lemma 6.2. We now state some basic properties of $\varphi$.

## Lemma 10.1.

(i) The function $\varphi \in K_{G}\left(X_{G}\right)$ is nonconstant and has no poles away from the cusps of $X_{G}$.
(ii) The $q$-expansion of $\varphi * A$ has coefficients in $\mathbb{Z}\left[\zeta_{N}\right]$ for each $A \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$.
(iii) For any cusp $c$ of $X_{G}$, we have $\operatorname{ord}_{c}(\varphi) \geq-m w_{c}$.
(iv) For any cusp $c \in \Sigma, \varphi$ is regular at $c$. Moreover, $\varphi(c)$ lies in $\mathbb{Z}\left[\zeta_{N}\right]$ and satisfies $|\varphi(c)|_{v} \leq \beta m^{24 m}$ for any infinite places $v$ of $L$.
(v) The rational function $\varphi$ of $X_{G}$ has at most $m \mu$ poles counted with multiplicity.

Proof. With notation as in $\S 8$, we have $f \in W_{m}$ by our choice of $f$ and hence $\varphi \in \mathscr{L}\left(D_{1}\right)$ by Lemma 8.1, where $D_{1}:=\sum_{c \in \mathcal{C}_{G}-\Sigma} m w_{c} \cdot c$. Since $\varphi \in \mathscr{L}\left(D_{1}\right)$, the function $\varphi$ has no poles away from the cusps, $\operatorname{ord}_{c} \varphi \geq 0$ for all $c \in \Sigma$, and $\operatorname{ord}_{c} \varphi \geq-m w_{c}$ for all $c \in \mathcal{C}_{G}$. The function $\varphi$ is nonconstant since $f \notin K_{G} \Delta^{m}$ by our choice of $f$. We have proved (i) and (iii). By (i) and (iii), the number of poles of $\varphi$ is bounded above by $\sum_{c \in \mathcal{C}_{G}} m w_{c}=m \mu$, where the equality uses (2.1). This proves (v).

We now prove (ii). Since $\Delta^{m}$ lies in $q^{m} \cdot(1+q \mathbb{Z} \llbracket q \rrbracket)$ and $\varphi * A=(f * A) /\left(\Delta^{m} * A\right)=(f * A) / \Delta^{m}$, it suffices to show that the $q$-expansion of $f * A$ has coefficients in $\mathbb{Z}\left[\zeta_{N}\right]$ for any $A \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. Take any $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$. Define the cusp $c:=A \cdot c_{\infty}$ of $X_{G}$, where $c_{\infty}$ is the cusp at infinity, and set $w=w_{c}$. By property (c) of Theorem 9.1, we have $f * A=\sum_{n=0}^{\infty} b_{n} q_{w}^{n}$ with $b_{n} \in \mathbb{Z}\left[\zeta_{N}\right]$. For any $B=\left(\begin{array}{ll}1 & 0 \\ 0 & d\end{array}\right) \in \mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$, we have $f *(A B)=(f * A) * B=\sum_{n=0}^{\infty} \sigma_{d}\left(b_{n}\right) q_{w}^{n} \in \mathbb{Z}\left[\zeta_{N}\right] \llbracket q_{w} \rrbracket$ by Lemma 6.1. This completes the proof of (ii) since any matrix in $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$ is of the form $A B$ for some $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ and $B=\left(\begin{array}{ll}1 & 0 \\ 0 & d\end{array}\right)$.

We finally prove (iv). Take any $c \in \Sigma$; we have already shown that $\varphi$ is regular at $c$. Fix $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $A \cdot c_{\infty}=c$ and set $w=w_{c}$. We have $\nu_{c}(f) \geq m w$, so $f * A=\sum_{n=m w}^{\infty} b_{n} q_{w}^{n}$ with $b_{n} \in \mathbb{Z}\left[\zeta_{N}\right]$. We have $\Delta^{m} \in q^{m} \cdot(1+q \mathbb{Z} \llbracket q \rrbracket)=q_{w}^{m w} \cdot(1+q \mathbb{Z} \llbracket q \rrbracket)$, so the constant term of the $q$-expansion of $\varphi=f * A / \Delta^{m}$ is $b_{m w}$. Therefore, $\varphi(c)=b_{m w}$ and in particular $\varphi(c) \in \mathbb{Z}\left[\zeta_{N}\right]$. For any infinite place $v$ of $L$, we have $|\varphi(c)|=\left|b_{m w}\right| \leq \beta m^{2 k}=\beta m^{24 m}$ by Theorem 9.1(c).

From the previous lemma, we have proved (b) and (c). The following lemma proves (a).

Lemma 10.2. The function $\varphi$ is the root of a monic polynomial with coefficients in $\mathbb{Z}[j]$.
Proof. Define the polynomial $Q(x)=\prod_{A \in R}(x-\varphi * A)$, where $R$ is a set of representatives of the right $G$ cosets of $\mathrm{GL}_{2}(\mathbb{Z} / N \mathbb{Z})$. Since $\varphi$ is fixed by the right action of $G$ on $\mathcal{F}_{N}$, we deduce that $Q(x)$ is independent of the choice of $R$ and its coefficients lie in $\mathcal{F}_{N}^{\mathrm{GL}}(\mathbb{Z} / N \mathbb{Z})=\mathbb{Q}(j)$.

By Lemma 10.1(i), the function $\varphi$ has all of its poles at cusps. So for each $A \in R, \varphi * A$ has all of its poles at cusps. The coefficients of $Q(x)$ lie in $\mathbb{Q}(j)$ and have all of their poles at cusps as well. Therefore, the coefficients of $Q(x)$ lie in $\mathbb{Q}[j]$. The coefficients of $Q(x)$ all have $q$-expansions with integral coefficients by Lemma 10.1(ii). The lemma follows by noting that an element of $\mathbb{Q}[j]$ lies in $\mathbb{Z}[j]$ if and only if its $q$-expansion has integral coefficients (to see this use that $\left.j=q^{-1}+744+196884 q+\cdots \in \mathbb{Z}((q))\right)$.

Now take any cusp $c \in \mathcal{C}_{G}$ and set $w=w_{c}$. Choose an $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$ for which $A \cdot c_{\infty}=c$. By property (c) of Theorem 9.1, we have $f * A=\sum_{n=0}^{\infty} b_{n} q_{w}^{n}$ with $b_{n} \in \mathbb{Z}\left[\zeta_{N}\right]$. We also have a $q$-expansion $\Delta^{m}=q^{m} \prod_{i=1}^{\infty}\left(1-q^{n}\right)^{24 m}=\sum_{n=m}^{\infty} a_{n} q^{n}$ with $a_{n} \in \mathbb{Z}$.

Note that $\Delta^{-1}=q^{-1} h(q)$ with $h(x):=\prod_{n=1}^{\infty}\left(1-x^{n}\right)^{-24} \in \mathbb{Z} \llbracket x \rrbracket$. For later, we remark that a numerical computation shows that

$$
\begin{equation*}
\left|h\left(t^{N}\right)\right|_{v} \leq \prod_{n=1}^{\infty}\left(1-e^{-\pi \sqrt{3} n}\right)^{-24}<1.1104 \tag{10.1}
\end{equation*}
$$

holds for any infinite place $v$ of $L$ and any $t \in \bar{L}_{v}$ with $|t|_{v} \leq e^{-\pi \sqrt{3} / N}$. We now show that with respect to a place $v$ of $L, \varphi$ can be given by an explicit $v$-analytic expression on a neighborhood of $c$.

Lemma 10.3. Take any place $v$ of $L$ and point $P \in \Omega_{c, v}-\{c\}$. Then there is a nonzero $t \in \bar{L}_{v}$ such that all the following hold:

- We have $|t|_{v}<1$. If $v$ is infinite, then $|t|_{v} \leq e^{-\pi \sqrt{3} / N}$.
- We have

$$
\begin{equation*}
\varphi(P)=t^{-m N} h\left(t^{N}\right)^{m} \sum_{n=0}^{\infty} b_{n} t^{n N / w} \tag{10.2}
\end{equation*}
$$

in $\bar{L}_{v}$.

- If $v$ is finite, we have $|j(P)|_{v}=|t|_{v}^{-N}$.
- If $v$ is infinite and $|j(P)|_{v}>3500$, we have $|t|_{v}^{N} \leq 2|j(P)|_{v}^{-1}$.

Proof. Denote by $\pi: X(N)_{\mathbb{Q}\left(\zeta_{N}\right)} \rightarrow\left(X_{G}\right)_{\mathbb{Q}\left(\zeta_{N}\right)}$ the natural morphism corresponding to the inclusion $\mathbb{Q}\left(\zeta_{N}\right)\left(X_{G}\right) \subseteq$ $\mathcal{F}_{N}$ of function fields. By our definition of $\Omega_{c, v}$, there is a cusp $c^{\prime}$ of $X(N)$ and a point $P^{\prime} \in \Omega_{c^{\prime}, v}$ such that $\pi\left(c^{\prime}\right)=c$ and $\pi\left(P^{\prime}\right)=P$. We have $P \neq c^{\prime}$ since otherwise $P=c$. Since $\varphi \in K_{G}\left(X_{G}\right) \subseteq \mathbb{Q}\left(\zeta_{N}\right)(X(N))$, we can view $\varphi$ as a rational function on $X(N)$ (equivalently, we denote $\varphi \circ \pi$ by $\varphi$ as well). We have $\varphi(P)=\varphi\left(P^{\prime}\right)$ and $j(P)=j\left(P^{\prime}\right)$. So without loss of generality, we may assume that $c$ is a cusp of $X(N)$, $P \in \Omega_{c, v}-\{c\} \subseteq X(N)\left(\bar{L}_{v}\right)$ and we may view $\varphi$ as a function in $\mathbb{Q}\left(\zeta_{N}\right)(X(N))=\mathcal{F}_{N}$.

We have

$$
\begin{equation*}
\varphi * A=\Delta^{-m}(f * A)=q^{-m} h(q)^{m} \sum_{n=0}^{\infty} b_{n} q_{w}^{n}=q_{N}^{-m N} h\left(q^{N}\right)^{m} \sum_{n=0}^{\infty} b_{n} q_{N}^{n N / w} \tag{10.3}
\end{equation*}
$$

which when expanded is the $q$-expansion of $\varphi$. We claim that the radius of convergence of (10.2), viewed as a power series in $\bar{L}_{v} \llbracket q_{N} \rrbracket$, is at least 1 . Since the coefficients of $h$ and all the $b_{n}$ are integral, the claim is immediate when $v$ is finite. When $v$ is infinite, the claim follows from the bounds on $\left|b_{n}\right|_{v}$ given by property (c) of Theorem 9.1.

For our fixed $A$, let $\psi_{A, v}: B_{v} \rightarrow X(N)\left(\bar{L}_{v}\right)$ be the continuous map from Proposition 3.1. By the definition of $\Omega_{c, v}$, we have $P=\psi_{A, v}(t)$ for some nonzero $t \in B_{v}$ that also satisfies $|t|_{v} \leq e^{-\pi \sqrt{3} / N}$ when $v$ is infinite. The $v$-analytic expression (10.2) thus holds by (10.3) and Proposition 3.1. By Proposition 3.1, we also have $j(P)=t^{-N}+744+196884 t^{N}+21493760 t^{2 N}+\cdots$ in $\bar{L}_{v}$, where the coefficients are from the familiar $q$-expansion of $j$. When $v$ is finite this implies that $|j(P)|_{v}=|t|_{v}^{-N}$. When $v$ is infinite and $|j(P)|_{v}>3500$, we have $|t|_{v}^{N} \leq 2|j(P)|_{v}^{-1}$, cf. [BP11, Corollary 2.2].

We now assume that the cusp $c=A \cdot c_{\infty}$ lies in $\Sigma$. By Lemma 10.1(iv), $\varphi$ is regular at $c$ and $\varphi(c) \in \mathbb{Z}\left[\zeta_{N}\right]$. The function $\varphi-\varphi(c)$ lies in $\mathbb{Q}\left(\zeta_{N}\right)\left(X_{G}\right)$ and has a zero at $c$.

Fix an integer $1 \leq r \leq \operatorname{ord}_{c}(\varphi-\varphi(c))$. Since $A \in \mathrm{SL}_{2}(\mathbb{Z} / N \mathbb{Z})$, we have $(\varphi-\varphi(c)) * A=\varphi * A-\varphi(c)=$ $(f * A) / \Delta^{m}-\varphi(c)$. Since $r \leq \operatorname{ord}_{c}(\varphi-\varphi(c))$, the $q$-expansion of $(f * A) / \Delta^{m}-\varphi(c)$ lies in $q_{w}^{r} \cdot \mathbb{Q}\left(\zeta_{N}\right) \llbracket q_{w} \rrbracket$ and hence the $q$-expansion of $f * A-\varphi(c) \Delta^{m}$ lies in $q_{w}^{m w+r} \cdot \mathbb{Q}\left(\zeta_{N}\right) \llbracket q_{w} \rrbracket$. Therefore,

$$
\begin{equation*}
f * A-\varphi(c) \Delta^{m}=\sum_{n=m w+r}^{\infty} b_{n} q_{w}^{n}-\varphi(c) \sum_{n \geq m+r / w} a_{n} q^{n} \tag{10.4}
\end{equation*}
$$

Take any place $v$ of $L$ and take any point $P \in \Omega_{c, v}-\{c\}$ that satisfies $|j(P)|_{v}>3500$ when $v$ is infinite. Let $t \in \bar{L}_{v}$ be an nonzero element satisfying the conclusions of Lemma 10.3. We have

$$
\begin{align*}
\varphi(P)-\varphi(c) & =t^{-m N} h\left(t^{N}\right)^{m} \sum_{n=0}^{\infty} b_{n} t^{n N / w}-\varphi(c)  \tag{10.5}\\
& =t^{-m N} h\left(t^{N}\right)^{m}\left(\sum_{n=m w+r}^{\infty} b_{n} t^{n N / w}-\varphi(c) \sum_{n \geq m+r / w} a_{n} t^{n N}\right)
\end{align*}
$$

where we have used $\Delta^{-m}=q^{-m} h(q)^{m}$ along with (10.4) which ensures early terms of our sums will cancel. Therefore,

$$
\begin{equation*}
\varphi(P)-\varphi(c)=t^{r N / w} h\left(t^{N}\right)^{m}\left(\sum_{n=m w+r}^{\infty} b_{n} t^{(n-m w-r) N / w}-\varphi(c) \sum_{n \geq m+r / w} a_{n} t^{(n-m-r / w) N}\right) \tag{10.6}
\end{equation*}
$$

Consider the case where $v$ is finite. From (10.6), we have $\varphi(P)-\varphi(c)=t^{r N / w} g(t)$, where $g$ is a power series with coefficients in $\mathbb{Z}\left[\zeta_{N}\right]$. Therefore, $|\varphi(P)-\varphi(c)|_{v} \leq|t|_{v}^{r N / w}=|j(P)|_{v}^{-r / w}$. We obtain $|\varphi(P)-\varphi(c)|_{v} \leq$ $|j(P)|_{v}^{-1 / w}$ by taking $r=1$. This proves (d) in the case that $v$ is finite.

Now suppose that $v$ is infinite and take $r=1$. Starting with (10.5) and taking absolute values gives

$$
\begin{equation*}
|\varphi(P)-\varphi(c)|_{v} \leq u^{-m}\left|h\left(t^{N}\right)\right|_{v}^{m}\left(\sum_{n=m w+1}^{\infty}\left|b_{n}\right|_{v} u^{n / w}+|\varphi(c)|_{v} \sum_{n=m+1}^{\infty}\left|a_{n}\right| u^{n}\right) \tag{10.7}
\end{equation*}
$$

where $u:=|t|_{v}^{N} \leq e^{-\pi \sqrt{3}}$. Using our bound $\left|b_{n}\right|_{v} \leq \beta(n / w)^{24 m}$ for $n \geq m w$, Lemma 9.5(ii) with $B=m w+1$ implies that

$$
u^{-m} \sum_{n=m w+1}^{\infty}\left|b_{n}\right|_{v} u^{n / w} \leq \beta \cdot u^{1 / w} \cdot 231.6 w(5 m)^{24 m+1}
$$

By Lemma 9.6(iii) with $B=m+1$, we have $u^{-m} \sum_{n=m+1}^{\infty}\left|a_{n}\right| u^{n} \leq 465 u(2 m)^{6 m+1}$ and hence

$$
u^{-m}|\varphi(c)|_{v} \sum_{n=m+1}^{\infty}\left|a_{n}\right| u^{n} \leq \beta \cdot u \cdot 465 \cdot 2^{6 m+1} m^{30 m+1}
$$

by Lemma 10.1 (iv). We have $\left|h\left(t^{N}\right)\right|_{v}<1.1104$ by (10.1). Combining the above bounds with (10.7) gives

$$
\begin{aligned}
|\varphi(P)-\varphi(c)|_{v} & \leq \beta \cdot 1.1104^{m}\left(u^{1 / w} \cdot 231.6 w(5 m)^{24 m+1}+u \cdot 465 \cdot 2^{6 m+1} m^{30 m+1}\right) \\
& \leq u^{1 / w} \beta w \cdot 1.1104^{m}\left(231.6(5 m)^{24 m+1}+465 \cdot 2^{6 m+1} m^{30 m+1}\right) \\
& \leq u^{1 / w} \beta w \cdot 1.1104^{m}\left(231.6 \cdot 5^{24 m+1}+465 \cdot 2^{6 m+1}\right) m^{30 m+1} \\
& =u^{1 / w} \beta w \cdot 1.1104^{m} 1158 \cdot 5^{24 m}\left(1+\frac{465}{231.6} \cdot \frac{2}{5} \cdot\left(\frac{2^{6}}{5^{24}}\right)^{m}\right) m^{30 m+1} \\
& \leq u^{1 / w} \beta C_{0} / 2
\end{aligned}
$$

where $C_{0}:=N \cdot 2 \cdot 1159 \cdot 5.022^{24 m} m^{30 m+1}$. Since $u^{1 / w} \leq 1$, we deduce that $|\varphi(P)-\varphi(c)|_{v} \leq \beta C_{0} / 2$. Now assume further that $|j(P)|_{v}>3500$. We have $u=|t|_{v}^{N} \leq 2|j(P)|_{v}^{-1}$ by Lemma 10.3 and our of choice of $t$. So $u^{1 / w} \leq\left(2|j(P)|_{v}^{-1}\right)^{1 / w} \leq 2|j(P)|_{v}^{-1 / w}$ and hence $|\varphi(P)-\varphi(c)|_{v} \leq|j(P)|_{v}^{-1 / w} \cdot \beta C_{0}$.

To complete the proof of (d) in the case that $v$ is infinite, it suffices to show that $C_{0} \leq C$. Since $m \leq \frac{1}{24} N^{3}$ by Lemma 4.2, we have

$$
C_{0} \leq 2 \cdot 1159 \cdot 5.022^{24 m}\left(\frac{1}{24}\right)^{30 m+1} N^{90 m+4} \leq 96.6 \cdot 0.1^{24 m} N^{90 m+4}=C
$$

It remains to prove (e). Let $K$ be any number field with $K_{G} \subseteq K \subseteq L$ and let $\Sigma^{\prime}$ be a Gal $K^{\text {-orbit }}$ of $\Sigma$. We keep notation as above with a fixed cusp $c \in \Sigma^{\prime} \subseteq \Sigma$ and we take $r=\operatorname{ord}_{c}(\varphi-\varphi(c))$. We further assume that $\varphi(c) \in K$; if no such $c$ exists then (e) holds trivially with $\xi=1$. Since the divisor of $\varphi-\varphi(c)$ has degree 0 , we have $r \leq m \mu$ by Lemma 10.1(v).

We have $f * A-\varphi(c) \Delta^{2}=\gamma q_{w}^{m w+r}+\cdots$ with $\gamma \in \mathbb{Z}\left[\zeta_{N}\right]$ nonzero. From (10.4), we find that

$$
\gamma= \begin{cases}b_{m w+r}-\varphi(c) a_{m+r / w} & \text { if } w \mid r  \tag{10.8}\\ b_{m w+r} & \text { if } w \nmid r\end{cases}
$$

The rational function $h:=(\varphi-\varphi(c))^{w} j^{r}$ lies in $K\left(X_{G}\right)$ and we have $\operatorname{ord}_{c} h=w r-r w=0$. Moreover, $h(c)=\gamma^{w}$. Since $h$ is defined over $K$, we have $\gamma^{w}=h(c) \in K(c)$. Define

$$
\xi:=N_{K(c) / K}\left(\gamma^{w}\right) \in K
$$

We have $\xi \in \mathcal{O}_{K}$ since $\gamma$ is integral. We have $\xi \neq 0$ since $\gamma \neq 0$.
We will prove that (e) holds with this particular $\xi$. Since $\varphi(c)$ lies in $K$, by assumption, and $\varphi$ is defined over $K$, we deduce that $\varphi\left(c^{\prime}\right)=\varphi(c) \in K$ for all $c^{\prime} \in \Sigma^{\prime}$. We also have $K\left(c^{\prime}\right)=K(c)$ and $w_{c^{\prime}}=w_{c}$ for all $c \in \Sigma^{\prime}$ since $\Sigma^{\prime}$ has a transitive $\operatorname{Gal}(L / K)$-action and $K(c) / K$ is abelian. Therefore, $h(c)=\gamma^{w}$ and $\xi=N_{K(c) / K}\left(\gamma^{w}\right)$ are independent of the choice of $c \in \Sigma^{\prime}$. So for the rest of the proof we can work with our fixed cusp $c$.

We now find upper bounds for $|\gamma|_{v}$ for some places $v$ of $L$. Define $C^{\prime}:=22.16 N^{144 m+7} 0.024^{24 m}$.
Lemma 10.4. For any infinite place $v$ of $L$, we have $|\gamma|_{v} \leq \beta C^{\prime}$.
Proof. Take any infinite place $v$ of $L$. By Theorem 9.1(c) and $r \leq m \mu$, we have

$$
\left|b_{m w+r}\right|_{v} \leq \beta(m+r / w)^{24 m} \leq \beta m^{24 m}(1+\mu)^{24 m}
$$

If $w$ divides $r$, Lemma 9.6(i) and $r \leq m \mu$ implies that $\left|a_{m+r / w}\right| \leq 2(m+r / w)^{6 m} \leq 2 m^{6 m}(1+\mu)^{6 m}$ and hence

$$
\left|\varphi(c) a_{m+r / w}\right|_{v} \leq \beta \cdot 2 m^{30 m}(1+\mu)^{6 m}
$$

by Lemma 10.1(iv). Using these bounds with (10.8), we obtain

$$
|\gamma|_{v} \leq \beta m^{24 m}(1+\mu)^{24 m}+\beta \cdot 2 m^{30 m}(1+\mu)^{6 m}
$$

Using the bounds on $m$ and $\mu+1$ from Lemma 4.2, we obtain

$$
\begin{aligned}
|\gamma|_{v} & \leq \beta\left(\left(\frac{1}{24} \cdot \frac{29}{54}\right)^{24 m} N^{144 m}+2\left(\frac{1}{24}\right)^{30 m}\left(\frac{29}{54}\right)^{6 m} N^{108 m}\right) \\
& =\beta N^{144 m}\left(\frac{1}{24} \cdot \frac{29}{54}\right)^{24 m}\left(1+2\left(\frac{1}{24}\right)^{6 m}\left(\frac{54}{29}\right)^{18 m} N^{-36 m}\right) \\
& \leq \beta N^{144 m}\left(\frac{1}{24} \cdot \frac{29}{54}\right)^{24 m}\left(1+2\left(\frac{1}{24}\left(\frac{54}{29}\right)^{3} 3^{-6}\right)^{6 m}\right),
\end{aligned}
$$

where in the last inequality we have used that $N \geq 3$. Since $\frac{1}{24}\left(\frac{54}{29}\right)^{3} 3^{-6} \leq 1$, we have $|\gamma|_{v} \leq \beta N^{144 m}\left(\frac{1}{24}\right.$. $\left.\frac{29}{54}\right)^{24 m}\left(1+2\left(\frac{1}{24}\left(\frac{54}{29}\right)^{3} 3^{-6}\right)^{6}\right)$. It is now easy to verify that $|\gamma|_{v} \leq \beta C^{\prime}$.

Lemma 10.5. Consider any point $P \in Y_{G}(K)$ that satisfies $\varphi(P)=\varphi(c)$ and $P \in \Omega_{c, v}$ for some place $v$ of L. Further suppose that $|j(P)|_{v}>3500$ when $v$ is infinite. Then

$$
|\gamma|_{v} \leq \begin{cases}|j(P)|_{v}^{-1} & \text { if } v \text { is finite, } \\ |j(P)|_{v}^{-1} \cdot \beta C^{\prime} & \text { if } v \text { is infinite and }|j(P)|_{v}>3500\end{cases}
$$

Proof. Using equation (10.5) and $\varphi(P)-\varphi(c)=0$, we obtain

$$
\begin{equation*}
0=\gamma+t^{-(m w+r) N / w} \sum_{n=m w+r+1}^{\infty} b_{n} t^{n N / w}-\varphi(c) t^{-(m w+r) N / w} \sum_{n>m+r / w} a_{n} t^{n N} \tag{10.9}
\end{equation*}
$$

with $t \in \bar{L}_{v}$ satisfying $|t|_{v}<1$. If $v$ is finite, we also have $|j(P)|_{v}=|t|_{v}^{-N}$. If $v$ is infinite, we also have $|t|_{v} \leq e^{-\pi \sqrt{3} / N}$ and $|t|_{v}^{N} \leq 2|j(P)|_{v}^{-1}$. In particular, $\gamma=t^{N / w} g(t)$ in $\bar{L}_{v}$ for some power series $g(x)$ with coefficients in $\mathbb{Z}\left[\zeta_{N}\right]$. So when $v$ is finite, we have $|\gamma|_{v}=|t|_{v}^{N / w}|g(t)|_{v} \leq|t|_{v}^{N / w}=|j(P)|_{v}^{-1 / w}$.

We can now assume that $v$ is infinite. Define $u=|t|_{v}^{N}$; we have $u \leq e^{-\pi \sqrt{3}}$. Solving for $\gamma$ in (10.9) and taking absolute values, we obtain

$$
\begin{equation*}
|\gamma|_{v} \leq u^{-(m w+r) / w} s_{1}+|\varphi(c)|_{v} u^{-(m w+r) / w} s_{2}, \tag{10.10}
\end{equation*}
$$

where $s_{1}:=\sum_{n=m w+r+1}^{\infty}\left|b_{n}\right|{ }_{v} u^{n / w}$ and $s_{2}:=\sum_{n>m+r / w}\left|a_{n}\right| u^{n}$. Using Lemma 9.5 with $B=m w+r+1$ and our bound $\left|b_{n}\right| \leq \beta \max \left\{1,(n / w)^{24 m}\right\}$, we have

$$
\begin{aligned}
u^{-(m w+r) / w} s_{1} & \leq \beta \cdot 231.6 w u^{1 / w} \max \{(m w+r+1) / w, 5 m\}^{24 m+1} \\
& \leq u^{1 / w} \beta \cdot 231.6 N m^{24 m+1} \max \{\mu+2,5\}^{24 m+1}
\end{aligned}
$$

where the last inequality uses $1 \leq w \leq N$ and $r \leq m \mu$. Using the bounds on $m$ and $\mu+2$ from Lemma 4.2, we obtain

$$
u^{-(m w+r) / w} s_{1} \leq u^{1 / w} \beta \cdot 231.6 N^{144 m+7}\left(\frac{1}{24} \cdot \frac{31}{54}\right)^{24 m+1} \leq u^{1 / w} \beta \cdot 5.54 N^{144 m+7} 0.024^{24 m}
$$

Let $B$ be the smallest integer for which $B>m+r / w$. By Lemma 9.6, we have

$$
\begin{aligned}
s_{2} & \leq 465 u^{B} \max \{m+r / w, 2 m\}^{6 m+1} \\
& \leq 465 u^{m+r / w+1 / w} m^{6 m+1} \max \{1+\mu, 2\}^{6 m+1}
\end{aligned}
$$

where in the last inequality we have used that $u<1, B \geq m+r / w+1 / w$, and $r / w \leq r \leq m \mu$. So by Lemma 10.1(iv),

$$
|\varphi(c)|_{v} u^{-(m w+r) / w} s_{2} \leq u^{1 / w} \beta \cdot 465 m^{30 m+1} \max \{1+\mu, 2\}^{6 m+1}
$$

Using the bounds on $m$ and $\mu+1$ from Lemma 4.2, we obtain

$$
\begin{aligned}
|\varphi(c)|_{v} u^{-(m w+r) / w} s_{2} & \leq u^{1 / w} \beta \cdot 465 N^{108 m+6}\left(\frac{1}{24}\right)^{30 m+1}\left(\frac{29}{54}\right)^{6 m+1} \\
& \leq u^{1 / w} \beta \cdot 10.41 N^{108 m+6} 0.0162^{24 m} .
\end{aligned}
$$

In particular, $|\varphi(c)|_{v} u^{-(m w+r) / w} s_{2} \leq u^{1 / w} \beta \cdot 5.54 N^{144 m+7} 0.024^{24 m}$ since $N \geq 3$.
Thus from (10.10) and the above bounds, we have

$$
|\gamma|_{v} \leq 2 \cdot u^{1 / w} \beta \cdot 5.54 N^{144 m+7} 0.024^{24 m}=u^{1 / w} \beta C^{\prime} / 2 .
$$

Since $u^{1 / w}=|t|_{v}^{N / w} \leq\left(2|j(P)|_{v}^{-1}\right)^{1 / w} \leq 2|j(P)|_{v}^{1 / w}$, we conclude that $|\gamma|_{v} \leq|j(P)|_{v}^{1 / w} \beta C^{\prime}$.
We have $\gamma^{w} \in K(c)$. For any place $v$ of $L$, we have

$$
|\xi|_{v}=\prod_{\sigma \in \operatorname{Gal}(K(c) / K)}\left|\sigma\left(\gamma^{w}\right)\right|_{v}
$$

Since the action of $\operatorname{Gal}(K(c) / K)$ on $\Sigma^{\prime}$ is transitive and $c \in \Sigma^{\prime}$, we have $|\operatorname{Gal}(K(c) / K)|=\left|\Sigma^{\prime}\right|$.
Suppose that $v$ is infinite. We have $\left|\sigma\left(\gamma^{w}\right)\right|_{v} \leq\left(\beta C^{\prime}\right)^{w}$ for all $\sigma \in \operatorname{Gal}(K(c) / K)$ by Lemma 10.4; note that the lemma holds for an arbitrary infinite place. Therefore,

$$
|\xi|_{v} \leq\left(\beta C^{\prime}\right)^{w|\operatorname{Gal}(K(c) / K)|}=\left(\beta C^{\prime}\right)^{w\left|\Sigma^{\prime}\right|} .
$$

Now suppose further that $|j(P)|_{v}>3500$ and that there is a point $P \in Y_{G}(K)$ for which $\varphi(P)=\varphi(c)$ and $P \in \Omega_{c, v}$. By Lemma 10.5, we have $\left|\gamma^{w}\right|_{v} \leq|j(P)|_{v}^{-w}\left(\beta C^{\prime}\right)^{w}$. Therefore,

$$
|\xi|_{v} \leq\left(\beta C^{\prime}\right)^{w(|\operatorname{Gal}(K(c) / K)|-1)}\left|\gamma^{w}\right|_{v} \leq|j(P)|_{v}^{-w}\left(\beta C^{\prime}\right)^{w|\operatorname{Gal}(K(c) / K)|}=|j(P)|_{v}^{-w}\left(\beta C^{\prime}\right)^{w\left|\Sigma^{\prime}\right|}
$$

Finally suppose that $v$ is finite and that there is a point $P \in Y_{G}(K)$ for which $\varphi(P)=\varphi(c)$ and $P \in \Omega_{c, v}$. Since $\gamma$ is integral, we have $\left|\sigma\left(\gamma^{w}\right)\right|_{v} \leq 1$ for all $\sigma \in \operatorname{Gal}(K(c) / K)$. Therefore, $|\xi|_{v} \leq\left|\gamma^{w}\right|_{v}$. By Lemma 10.5, we conclude that $|\xi|_{v} \leq|j(P)|_{v}^{-w}$.
