# Key varieties for prime $\mathbb{Q}$-Fano threefolds defined by Jordan algebras of cubic forms. Part I

#### Abstract

The first aim of this paper is to construct a 13 -dimensional affine variety $\mathcal{H}_{\mathbb{A}}^{13}$ related with $\mathbb{P}^{2} \times \mathbb{P}^{2}$-fibration. It is well-known that the affine cone of the Segre embedded $\mathbb{P}^{2} \times \mathbb{P}^{2}$ is defined as the null loci of the so called $\sharp$-mapping of a 9 -dimensional nondegenerate quadratic Jordan algebra $J$ of a cubic form. Inspired with this fact, we construct $\mathcal{H}_{\mathbb{A}}^{13}$ in the same way coordinatizing $J$ with 8 parameters. We derive such a coordinatization of $J$ using fixed three complementary primitive idempotents and the associated Peirce decomposition of $J$.

The second aim of this paper is to construct complex prime $\mathbb{Q}$-Fano 3 -folds of anti-canonical codimension 4 as weighted complete intersections of appropriate weighted projectivizations of $\mathcal{H}_{\mathbb{A}}^{13}$ or its subvarieties (possibly allowing some coordinates with weight 0 ). The affine variety $\mathcal{H}_{\mathbb{A}}^{13}$ and such weighted projectivizations of $\mathcal{H}_{\mathbb{A}}^{13}$ are called key varieties for prime $\mathbb{Q}$-Fano 3-folds. We show that a prime $\mathbb{Q}$ Fano 3 -fold of genus 3 with three $\frac{1}{2}(1,1,1)$-singularities belonging to the class of No.5.4 as in [Tak1] is constructed from one weighted projectivization of $\mathcal{H}_{\mathbb{A}}^{13}$ such that all the coordinates have positive weights. Conversely, we also show that any such a prime $\mathbb{Q}$-Fano 3-fold is obtained in this way. Moreover, relating $\mathcal{H}_{\mathbb{A}}^{13}$ with the $C_{2}$-cluster variety constructed by Coughlan and Ducat [CD1], we show that weighted projectivizations of $\mathcal{H}_{\mathbb{A}}^{13}$ or its subvarieties are key varieties for prime $\mathbb{Q}$-Fano 3-folds belonging to 108 classes in the online database GRDB].

## 1. Introduction

1.1. Background for classification of $\mathbb{Q}$-Fano 3-folds. A complex projective variety is called a $\mathbb{Q}$-Fano variety if it is a normal variety with only terminal singularities, and its anti-canonical divisor is ample. The classification of $\mathbb{Q}$-Fano 3-folds is one of the central problems in Mori theory for projective 3-folds. Although the classification is far from completion, several systematic classification results have been obtained so far. In the online database [GRDB], a huge table of candidates of $\mathbb{Q}$ Fano 3-folds are given. One kind of the classification results is that with respect to the codimension $\mathrm{ac}_{\mathrm{X}}$ of a $\mathbb{Q}$-Fano 3-fold $X$ in the weighted projective space of the minimal dimension determined by the anti-canonical graded ring of $X$. We call $\mathrm{ac}_{\mathrm{x}}$ the anti-canonical codimension, which can be considered as a generalization of the genus of a $\mathbb{Q}$-Fano 3-fold. The invariant acx is expected not to be unreasonably big for prime $\mathbb{Q}$-Fano 3-folds, namely, $\mathbb{Q}$-Fano 3-folds whose anti-canonical divisors generate the groups of numerical equivalence classes of $\mathbb{Q}$-Cartier divisors. Hereafter, we focus on prime $\mathbb{Q}$-Fano 3-folds. For prime $\mathbb{Q}$-Fano 3-folds $X$ with acx $\leq 3$, the classification was completed if $X$ are quasi-smooth, namely, the affine cones of $X$ in the affine spaces associated to the anti-canonical graded rings are smooth outside the vertices; Fletcher [Fl] and Chen-Chen-Chen [CCC] did in the case of $\mathrm{ac}_{\mathrm{X}} \leq 2$, and Altınok [Al] did in the case of $\mathrm{ac}_{\mathrm{X}}=3$.
1.2. The case of anti-canonical codimension 4 . Now let us consider prime $\mathbb{Q}$ Fano 3 -folds $X$ with acx $=4$. In this case, the classification is not completed mainly because there is no suitable general structure theorem for Gorenstein graded rings of codimension 4 while there are such structure theorems in the case of codimension less than or equal to 3 , which are foundations for the classification results mentioned as above; see $[\mathrm{Se}]$ in the case of codimension $\leq 2$ and $[\overline{\mathrm{BE}}]$ in the case of codimension 3.
1.3. Key varieties for prime $\mathbb{Q}$-Fano 3-folds. Under this circumstance, it is meaningful to construct examples of prime $\mathbb{Q}$-Fano 3 -folds $X$ with $\mathrm{ac}_{\mathrm{X}}=4$ systematically. In [CD1, CD2], Coughlan and Ducat do this as weighted complete intersections in weighted projectivizations of the cluster varieties of types $C_{2}$ and $G_{2}^{(4)}$, which are related with $\mathbb{P}^{2} \times \mathbb{P}^{2}$ - and $\mathbb{P}^{1} \times \mathbb{P}^{1} \times \mathbb{P}^{1}$-fibrations, respectively. This type of construction is modeled after the classification of smooth prime Fano 3-folds by Gushel' [Gu1, Gu2] and Mukai [Mu2]. The idea of them is describing $\mathbb{Q}$-Fano 3-folds $X$ in appropriate projective varieties $\Sigma$ of larger dimensions and usually with larger symmetries; in the case of [Mu2], $\Sigma$ are rational homogeneous spaces, and in the case of [CD1, CD2], $\Sigma$ are several weighted projectivizations of the cluster varieties. Such $\Sigma$ or the affine cone of $\Sigma$ are informally called key variety as in the title of this paper.

The purpose of this paper is to construct a new key variety $\mathcal{H}_{\mathbb{A}}^{13}$ for prime $\mathbb{Q}$-Fano 3 -folds $X$ with $\mathrm{ac}_{\mathrm{X}}=4$ related with $\mathbb{P}^{2} \times \mathbb{P}^{2}$-fibration. The variety $\mathcal{H}_{\mathbb{A}}^{13}$ naturally grows out of the theory of the quadratic Jordan algebra of a cubic form.
1.4. Quadratic Jordan algebra of a cubic form and its coordinatization. In this subsection, we work over an algebraically closed field k. Let $J$ be a 9-dimensional nondegenerate quadratic Jordan algebra of a cubic form over k with reasonable assumptions (for details, we refer to Assumption (a)-(c) in Section 2). The quadratic Jordan algebra $J$ is endowed with a quadratic mapping called $\sharp$-mapping, and a bi-linear product called $\sharp$-product defined by the $\sharp$-mapping (Section 2). By general theory of quadratic Jordan algebra of cubic form, $J$ has three complementary primitive idempotents $v_{1}, v_{2}, v_{3}$, which give the so called Peirce decomposition of $J$ :

$$
J=J_{11} \oplus J_{22} \oplus J_{33} \oplus J_{12} \oplus J_{13} \oplus J_{23}
$$

where $J_{i i}=\mathrm{k} v_{i}(1 \leq i \leq 3)$ and $J_{i j} \simeq \mathrm{k}^{2}(1 \leq i<j \leq 3)$. Taking a suitable basis of each of the subspaces $J_{i j}$, we show that the $\sharp$-products between elements of these bases can be described by introducing 8 parameters indexed as $p_{i j k}(i, j, k=1,2)$ (Proposition 3.2).

Hereafter in Section we assume for simplicity that $k=\mathbb{C}$, the complex number field.
1.5. Affine variety $\mathcal{H}_{\mathbb{A}}^{13}$. It is well-known that the affine cone $C\left(\mathbb{P}^{2} \times \mathbb{P}^{2}\right)$ of (the Segre embedded) $\mathbb{P}^{2} \times \mathbb{P}^{2}$ is defined as the null loci of the $\sharp$-mapping of $J$. Inspired with this fact, we construct the affine variety $\mathcal{H}_{\mathbb{A}}^{13}$ in the same way as $C\left(\mathbb{P}^{2} \times \mathbb{P}^{2}\right)$ of $\mathbb{P}^{2} \times \mathbb{P}^{2}$ coordinatizing $J$ with 8 parameters $p_{i j k}(i, j, k=1,2)$.

Let $\mathbb{A}_{\mathcal{H}}$ be the 17 -dimensional affine space containing $J \simeq \mathbb{A}^{9}$ with $p_{i j k}$ as additional 8 coordinates. Then we define $\mathcal{H}_{\mathbb{A}}^{13} \subset \mathbb{A}_{\mathcal{H}}^{17}$ as the null loci of the $\sharp$-mapping; we refer to Corollary 3.4 and Definition 4.1 for the explicit equations of $\mathcal{H}_{\mathbb{A}}^{13}$. Here we summarize properties of $\mathcal{H}_{\mathbb{A}}^{13}$ as follows:

Theorem 1.1. The affine variety $\mathcal{H}_{\mathbb{A}}^{13}$ has the following properties:
(1) There exists a $\left(\mathrm{GL}_{2}\right)^{3} \rtimes S_{3}$-action on $\mathcal{H}_{\mathbb{A}}^{13}$ (Proposition 4.2).
(2) Let $\mathbb{A}_{p}$ be the affine space with coordinates $p_{i j k}(i, j, k=1,2)$, and $\widehat{\mathcal{H}}$ the variety in $\mathbb{P}(J) \times \mathbb{A}_{p}$ with the same equations as $\mathcal{H}_{\mathbb{A}}^{13}$. The natural projection $\rho_{\mathcal{H}}: \widehat{\mathcal{H}} \rightarrow \mathbb{A}_{p}$ is equidimensional outside the origin of $\mathbb{A}_{p}$, and a general $\rho_{\mathcal{H}}$-fiber is isomorphic to $\mathbb{P}^{2} \times \mathbb{P}^{2}$ (Proposition 4.5).
(3) The variety $\mathcal{H}_{\mathbb{A}}^{13}$ is a 13-dimensional irreducible normal variety with only factorial Gorenstein terminal singularities (Propositions 4.7 4.8, 4.9 and 4.11).
(4) The ideal of $\mathcal{H}_{\mathbb{A}}^{13}$ is generated by 9 elements with 16 relations (Proposition 4.8).

In Section6, we also introduce two subvarieties $\mathcal{M}_{\mathbb{A}}^{8}$ and $\mathcal{S}_{\mathbb{A}}^{6}$ of $\mathcal{H}_{\mathbb{A}}^{13}$ with $\left(\mathrm{GL}_{2}\right)^{2}$ and $\mathrm{GL}_{3}$-action respectively, which turn out to be key varieties of many prime $\mathbb{Q}$ Fano 3-folds (Section7).
1.6. $\mathbb{Q}$-Fano 3 -fold of genus 3 with three $1 / 2(1,1,1)$-singularities. Let $\mathcal{H}_{\mathbb{P}}^{12} \subset$ $\mathbb{P}\left(1^{14}, 2^{3}\right)$ be the weighted projectivization of $\mathcal{H}_{\mathbb{A}}^{13}$ such that the 3 weights of the coordinates corresponding to $v_{i}(1 \leq i \leq 3)$ are 2 , and the other weights of coordinates are 1 . We show that $\mathcal{H}_{\mathbb{P}}^{12}$ is the key variety for a prime $\mathbb{Q}$-Fano 3-fold of No.5.4 as in [Tak1] of genus 3 with three $1 / 2(1,1,1)$-singularities, which corresponds to the numerical data No. 20652 as in [GRDB]. Actually, we prove the following stronger result in Section 5 ,

Theorem 1.2. The following assertions hold:
(1) Let $L_{1}, \ldots, L_{9}$ be general forms of weight 1 in $\mathbb{P}\left(1^{14}, 2^{3}\right)$. The subscheme

$$
X:=\mathcal{H}_{\mathbb{P}}^{12} \cap L_{1} \cap \cdots \cap L_{9}
$$

is a prime $\mathbb{Q}$-Fano 3 -fold of No.5.4 as in [Tak1] for any choice of the $1 / 2(1,1,1)$ singularities of $X$, and is of anticanonical codimension 4.
(2) Conversely, any prime $\mathbb{Q}$-Fano 3 -fold with only $1 / 2(1,1,1)$-singularities of No.5.4 is a codimension 9 linear section of $\mathcal{H}_{\mathbb{P}}^{12}$.

We will see in the course of the proof of Theorem 1.2 (2) that the affine variety $\mathcal{H}_{\mathbb{A}}^{13}$ is obtained naturally from birational geometry of the $\mathbb{Q}$-Fano 3 -fold. We mention that we obtain similar results for other prime $\mathbb{Q}$-Fano 3-folds in [Tak5].
1.7. Relation with the $\mathrm{C}_{2}$-cluster variety. As is mentioned in Subsection 1.3 several weighted projectivizations of the $\mathrm{C}_{2}$-cluster variety are key varieties for prime Fano 3-folds by [CD1, CD2]. We show that the $\mathrm{C}_{2}$-cluster variety is a subvariety of $\mathcal{H}_{\mathbb{A}}^{13}$ (Proposition 7.2). This implies that, corresponding to each of the 108 classes of prime $\mathbb{Q}$-Fano 3-folds constructed by ibid., we can construct $\mathbb{Q}$-Fano 3-folds from weighted projectivizations of 4 subvarieties $\mathcal{H}_{\mathbb{A}}^{12}, \mathcal{H}_{\mathbb{A}}^{11}, \mathcal{M}_{\mathbb{A}}^{8}, \mathcal{S}_{\mathbb{A}}^{6}$ of $\mathcal{H}_{\mathbb{A}}^{13}$, which are more general than the ones constructed by ibid (Corollary 7.6).
1.8. Relation with our previous works and our future plan. We have constructed key varieties for prime $\mathbb{Q}$-Fano 3-folds in our previous papers [Tak3, Tak4, Tak6]. Here we clarify the relations of them and our future plan with the present paper.

In the papers [Tak3, Tak4], we construct key varieties related with $\mathbb{P}^{2} \times \mathbb{P}^{2}$ fibration; the varieties $\Sigma_{\mathbb{A}}^{14}$ and $\Upsilon_{\mathbb{A}}^{14}$ are constructed in [Tak3] (see also [Tay] as for $\Upsilon_{\mathbb{A}}^{14}$ ), and the variety $\Pi_{\mathbb{A}}^{15}$ is constructed in [Tak4] inspired by [Tay]. The method of the constructions is the theory of unprojection developed by Papadakis and Reid.

The variety $\mathcal{H}_{\mathbb{A}}^{13}$ also appears in [Tak4] only to describe $\Pi_{\mathbb{A}}^{15}$. In this paper, we introduce $\mathcal{H}_{\mathbb{A}}^{13}$ using a Jordan algebra of a cubic form, and treat it as a key variety for the first time. In our forthcoming paper [Tak7], we will reintroduce $\Upsilon_{\mathbb{A}}^{14}$ and $\Pi_{\mathbb{A}}^{15}$ via other coordinatizations of the Jordan algebra $J$.

In the paper [Tak6], we construct key varieties for prime $\mathbb{Q}$-Fano 3 -folds related with $\mathbb{P}^{1} \times \mathbb{P}^{1} \times \mathbb{P}^{1}$-fibration, and study the relation of them with the $G_{2}^{(4)}$-cluster variety. Our constructions of them are based on the theory of Freudenthal triple system.
1.9. Structure of the paper. Sections 2 and 3 and Subsection 4.5 are devoted to studying the quadratic Jordan algebra of a cubic form, and, in the remaining part, we are concerned with the classification of prime $\mathbb{Q}$-Fano 3 -folds.

After we review general facts about quadratic Jordan algebra of cubic form in Section 2 and Subsection 3.1 we obtain a coordinatization with 8 parameters of the 9-dimensional nondegenerate quadratic Jordan algebra $J$ of a cubic form with some reasonable assumptions (Proposition 3.2). In Subsection 3.3 we write down the $\sharp$-mapping and the cubic form of $J$ using 8 parameters (Corollary 3.4). This leads us to our definition of the affine variety $\mathscr{H}_{\mathbb{A}}^{13}$ (Definition 4.11. It turns out that $\mathcal{H}_{\mathbb{A}}^{13}$ is naturally related with $2 \times 2 \times 2$ hypermatrix (Subsection 4.3). In the remaining part of Section 4, we show Theorem [1.1. Section 5 is occupied with the proof of Theorem [1.2, In Section 6 we introduce two subvarieties $\mathcal{M}_{\mathbb{A}}^{8}$ and $\oint_{\mathbb{A}}^{6}$ of $\mathcal{H}_{\mathbb{A}}^{13}$ with good group actions. In the final section Z we show that the $C_{2}$ cluster variety $X_{\mathrm{C}_{2}}$ is a subvariety of $\mathcal{H}_{\mathbb{A}}^{13}$. We also clarify relations of $X_{\mathrm{C}_{2}}$ with 4 subvarieties $\mathcal{H}_{\mathbb{A}}^{12}, \mathcal{H}_{\mathbb{A}}^{11}, \mathcal{M}_{\mathbb{A}}^{8}, \mathcal{S}_{\mathbb{A}}^{6}$ of $\mathcal{H}_{\mathbb{A}}^{13}$. Then we show that these 4 varieties are key varieties of prime $\mathbb{Q}$-Fano 3 -folds belonging to 108 classes (Corollary 7.6).

This paper contains several assertions which can be proved by straightforward computations; we often omit such computation processes. Some computations are difficult by hand but are easy within a software package. In our computations, we use intensively the software systems Mathematica [W] and Singular [DGPS].

## 2. Quadratic Jordan algebra $J$ of cubic forms

In this section, we review the construction of the Jordan algebra of a cubic form and collect some basic facts following [R, Mc2].

Let k be a field and $J$ a finite dimensional k -vector space and $N(x)(x \in J)$ a cubic form on $J$. We fix an element $1 \in J$ such that

$$
N(\mathbf{1})=1 .
$$

We denote by $\partial_{y} N(x)$ the directional derivative of $N$ in the direction $y \in J$, evaluated at $x \in J$.

For the cubic form $N(x)$, the following several forms are introduced:

$$
\begin{cases}\text { Bilinear Trace Form } & : T(x, y):=-\partial_{x} \partial_{y} N(1)+\left(\partial_{x} N(1)\right)\left(\partial_{y} N(1)\right) \\ \text { Linear Trace Form } & : T(x):=T(x, 1)=\partial_{x} N(1),\end{cases}
$$

where the last equality of the second line follows from the assumptions that $N(x)$ is a cubic form and $N(1)=1$. It follows that

$$
T(\mathbf{1})=\partial_{\mathbf{1}} N(\mathbf{1})=3
$$

since $N(x)$ is a cubic form.
Now $\sharp$-mapping and $\sharp$-product are introduced as follows, which will guarantee that $J$ has the structure of quadratic Jordan algebra defined from the cubic form $N(x)$ :

$$
\begin{cases}\sharp \text {-mapping } & : x \mapsto x^{\sharp}, \\ \sharp \text {-product } & : x \sharp y:=(x+y)^{\sharp}-x^{\sharp}-y^{\sharp}\end{cases}
$$

satisfying the following three conditions:

## Sharp Condition:

(\#1) $\quad T\left(x^{\sharp}, y\right)=\partial_{y} N(x)$,
(\#2) $x^{\sharp \sharp}=N(x) x$,
( $\sharp 3) \quad ı \sharp y=T(y) \_-y$.
In this paper, the $\#$-product plays important roles.
The following fundamental theorem is due to McCrimmon ([Mc2, Const. 4.2.2]):
Theorem 2.1. Assume that the cubic form $N(x)$ and $1 \in J$ are endowed with the $\sharp-$ mapping and the $\sharp-$-product satisfying the conditions $(\sharp 1)-(\sharp 3)$. Then $J$ has the structure of quadratic Jordan algebra with 1 as the unit element and with the following $U$ operator:

$$
U_{x} y:=T(x, y) x-x^{\sharp} \sharp y .
$$

We refer to [Mc2] Sect.4.3] and [R] the definition of quadratic Jordan algebra.
Definition 2.2. We call the quadratic Jordan algebra defined as in Theorem[2.1] the quadratic Jordan algebra of the cubic form $N(x)$.

Remark 2.3. In the situation of Theorem[2.1] if the characteristic of k is not 2 , then the usual Jordan product $\bullet$ is defined as follows ([Mc2, Const. 4.2.2]):

$$
x \bullet y:=\frac{1}{2}(x \sharp y+T(x) y+T(y) x-S(x, y) \mathbf{1}) .
$$

The product $x \bullet x$ can be defined for any k as follows:

$$
\begin{equation*}
x \bullet x:=x^{\sharp}+T(x) x-S(x) ı . \tag{2.1}
\end{equation*}
$$

The introduction of the forms for $J$ continues:

$$
\begin{cases}\text { Quadratic Spur form } & : S(x):=T\left(x^{\sharp}\right) \\ \text { Bilinear Spur form } & : S(x, y):=T(x \sharp y)=T(x, y)-T(x) T(y),\end{cases}
$$

where the last equality of the second line holds by [Mc1, p.497, (16)]
Now the following nondegeneracy condition for a Jordan algebra $J$ of a cubic form is introduced, which will guarantee a good structure theorem of $J$ :

Definition 2.4. We set

$$
\begin{equation*}
R_{J}:=\left\{\sigma \in J \mid \forall_{y \in J}, U_{\sigma} y=0\right\} \tag{2.2}
\end{equation*}
$$

The quadratic Jordan algebra $J$ of the cubic form $N(x)$ is said to be nondegenerate if $R_{J}=\{0\}$.

We note that a nonzero element of $R_{J}$ is called in [R] an absolute zero divisor.
In Pe , Cor.4.1.58], the following effective paraphrase of nondegeneracy is obtained:

Theorem 2.5. The quadratic Jordan algebra $J$ of the cubic form $N(x)$ is nondegenerate if and only if it holds that

$$
\left\{\sigma \in J \mid N(\sigma)=T(\sigma, J)=T\left(\sigma^{\sharp}, J\right)=0\right\}=\{0\} .
$$

Hereafter in this paper, we consider the quadratic Jordan algebra $J$ of the cubic form $N(x)$ with the following assumptions:

## Assumptions.

(a) $J$ is nondegenerate.
(b) $N(x) \neq 0$ for some $x \neq 0$.
(c) $J \not \approx \mathrm{k} \oplus J\left(Q, \mathrm{I}^{\prime}\right)$, where $J\left(Q, \mathrm{I}^{\prime}\right)$ is the Jordan algebra of a quadratic form $Q$ with the identity $\mathbf{1}^{\prime}$.
In the paper [R], Racine obtains a coordinatization of the quadratic Jordan algebra $J$ of a cubic form with the assumptions (a)-(c) ([ibid., Thm. 1.1]); he describe $J$ using a $3 \times 3$ matrix over a composition algebra. We do not state his result in detail since we do not need the result itself in this paper. We, however, heavily use his arguments and several formulas contained in the proof of [ibid., Thm. 1.1], which we will recall in Subsection 3.1.

## 3. Coordinatization of $J$ WITH 8 Parameters

3.1. Facts about three complementary primitive idempotents. Let k be a field and $J$ be the quadratic Jordan algebra of a cubic form with the assumptions (a)(c) as in Section 2, A nonzero element $e \in J$ is called an idempotent if it satisfies $e \bullet e=e$ (cf. Remark2.3), and an idempotent is called primitive if it also satisfies $e^{\sharp}=0$. For $x_{1}, x_{2}, y \in J$, we define $U_{x_{1}, x_{2}}(y):=U_{1}(y)-U_{x_{1}}(y)-U_{x_{2}}(y)$.

By [R], there exist three primitive idempotents $v_{1}, v_{2}, v_{3}$ such that $v_{1}+v_{2}+$ $v_{3}=1$. Such three primitive idempotents are called complementary. They give the following decomposition of $J$, which is called the Peirce decomposition (associated to $v_{1}, v_{2}, v_{3}$ ):

$$
J=J_{11} \oplus J_{22} \oplus J_{33} \oplus J_{12} \oplus J_{13} \oplus J_{23}
$$

where

$$
J_{i i}=\mathrm{k} v_{i}, J_{i j}=U_{v_{i}, v_{j}}(J)(1 \leq i<j \leq 3)
$$

If the characteristic of $k$ is not 2 , then it holds that

$$
J_{i j}=\left\{\sigma \in J \mid v_{i} \bullet \sigma=v_{j} \bullet \sigma=1 / 2 \sigma\right\}(1 \leq i<j \leq 3)
$$

We define for convenience that $J_{12}=J_{21}, J_{13}=J_{31}$ and $J_{23}=J_{32}$. The subspace $J_{i j}$ are called the Peirce subspaces. In [R] p.99], it is proved that

$$
\begin{equation*}
\operatorname{dim} J_{12}=\operatorname{dim} J_{13}=\operatorname{dim} J_{23} \tag{3.1}
\end{equation*}
$$

The following facts are obtained in $[\mathrm{R}]$ in the course of the proof of [ibid., Thm.1]:

Theorem 3.1. Let $i, j, k$ be three integers such that $\{i, j, k\}=\{1,2,3\}$. The Peirce spaces have the following properties:
(i) For $\sigma \in J_{j k}$, it holds that $T(\sigma)=0([\mathbb{R},(28)])$.
(ii) $J_{i j}$ and $J_{i k}$ are orthogonal with respect to the bilinear trace form $T([\boxed{R}$, (33)]).
(iii) For $v_{1}, v_{2}, v_{3}$, and $\sigma \in J_{j k}$, it holds that

$$
\begin{aligned}
\sigma^{\sharp} & =S(\sigma) v_{i}, \\
v_{i} \sharp v_{j} & =v_{k}, \\
v_{j} \sharp \sigma & =v_{k} \sharp \sigma=0, \\
v_{i} \sharp \sigma & =-\sigma .
\end{aligned}
$$

([], (33)]).
(iv) $J_{j k} \neq\{0\}$ and the quadratic form $S(\sigma)\left(\sigma \in J_{j k}\right)$ is not identically zero on $J_{j k}([\mathrm{R}, \mathrm{p} .98$, 5th line from the bottom]).
(v) For $\sigma_{a} \in J_{i j}$ and $\sigma_{b} \in J_{j k}$, it holds that $\sigma_{a} \sharp \sigma_{b} \in J_{i k}([\mathbb{R}, ~(34)])$.
(vi) For $\sigma_{a} \in J_{i j}$ and $\sigma_{b} \in J_{j k}$, it holds that

$$
\begin{equation*}
\sigma_{a} \sharp\left(\sigma_{a} \sharp \sigma_{b}\right)=-S\left(\sigma_{a}\right) \sigma_{b} \tag{3.2}
\end{equation*}
$$

([], (36)]).

Hereafter in this section, we keep considering the quadratic Jordan algebra $J$ of a cubic form as in Subsection 3.1, and fixing the three complementary primitive idempotents $v_{1}, v_{2}, v_{3}$. Moreover, we assume that

$$
\operatorname{dim} J=9
$$

Then, by (3.1), it holds that

$$
\operatorname{dim} J_{12}=\operatorname{dim} J_{13}=\operatorname{dim} J_{23}=2
$$

3.2. Coordinatization of $J$ using 3 complementary primitive idempotents. We consider how to describe the cubic form $N$ from the Peirce decomposition. For this, it suffices to compute $x^{\sharp}$ for any $x$ since $x^{\sharp \sharp}=N(x) x$. We can compute $x^{\sharp}$ for any $x$ if we know all the $\sharp$ products between the elements of the bases of the Peirce spaces since the $\sharp$ product is bilinear. By (iii), we already know the $\sharp$ products among $v_{1}, v_{2}, v_{3}$, and an element $x$ of a Peirce space. Hence it remains to know the $\sharp$ products $x \sharp y$ when $x \in J_{i j}$ and $y \in J_{j k}$, or $x, y \in J_{i j}$. In the following proposition, assuming that k is algebraically closed, we show that everything is determined by taking an appropriate bases for $J_{12}, J_{13}, J_{23}$ and giving 8 parameters that define the $\sharp$ products between the bases of $J_{23}$ and $J_{13}$ as in (3.3).

Proposition 3.2. Assume that k is algebraically closed. Then there exist bases $\chi_{1 i}$, $\chi_{2 i}$ of $J_{j k}$ for each $i, j, k$ with $\{i, j, k\}=\{1,2,3\}$ and $p_{a b c} \in \mathrm{k}(a, b, c=1,2)$ such that
the following hold:

$$
\left\{\begin{array}{l}
\chi_{11} \sharp \chi_{11}=2\left(-p_{212} p_{221}+p_{211} p_{222}\right) v_{1},  \tag{3.6}\\
\chi_{11} \sharp \chi_{21}=\left(-p_{122} p_{211}+p_{121} p_{212}+p_{112} p_{221}-p_{111} p_{222}\right) v_{1}, \\
\chi_{21} \sharp \chi_{21}=2\left(-p_{112} p_{121}+p_{111} p_{122}\right) v_{1}, \\
\chi_{12} \sharp \chi_{12}=2\left(-p_{122} p_{221}+p_{121} p_{222}\right) v_{2}, \\
\chi_{12} \sharp \chi_{22}=\left(p_{122} p_{211}-p_{121} p_{212}+p_{112} p_{221}-p_{111} p_{222}\right) v_{2} \\
\chi_{22 \sharp \chi_{22}=2\left(-p_{112} p_{211}+p_{111} p_{212}\right) v_{2},}^{\chi_{13} \sharp \chi_{13}=2\left(-p_{122} p_{212}+p_{112} p_{222}\right) v_{3},} \\
\chi_{13} \sharp \chi_{23}=\left(p_{122} p_{211}+p_{121} p_{212}-p_{112} p_{221}-p_{111} p_{222}\right) v_{3}, \\
\chi_{23} \sharp \chi_{23}=2\left(-p_{121} p_{211}+p_{111} p_{221}\right) v_{3} .
\end{array}\right.
$$

Remark 3.3. It is convenient to put $p_{a b c} \in \mathrm{k}(a, b, c=1,2)$ on the vertices of the cube as follows and we regard it as a hypermatrix P :


Proof of Proposition 3.2 For $\sigma \in J_{i j}$, we denote by

$$
f_{i j}^{\sigma}: J_{i k} \rightarrow J_{j k} \text { and } f_{j i}^{\sigma}: J_{j k} \rightarrow J_{i k}
$$

the linear maps defined by $\sigma \sharp$. We choose a basis $\chi_{1 i}, \chi_{2 i}$ of $J_{j k}$ for any mutually distinct $i, j, k$. Let $P_{i j}^{\sigma}$ be the representation matrix of $f_{i j}^{\sigma}$ with respect to these bases. By (3.2), we have

$$
\begin{equation*}
P_{i j}^{\sigma} P_{j i}^{\sigma}=-S(\sigma) E \tag{3.7}
\end{equation*}
$$

where $E$ is the identity matrix. Let $\left(P_{i j}^{\sigma}\right)^{\dagger}$ be the adjoint matrix of $P_{i j}^{\sigma}$. Multiplying the equality (3.7) with $\left(P_{i j}^{\sigma}\right)^{\dagger}$, we have

$$
\begin{equation*}
\left(\operatorname{det} P_{i j}^{\sigma}\right) P_{j i}^{\sigma}=-S(\sigma)\left(P_{i j}^{\sigma}\right)^{\dagger} . \tag{3.8}
\end{equation*}
$$

Note that entries of $P_{i j}^{\sigma}$ are linear forms and then $\operatorname{det} P_{i j}^{\sigma}$ is a quadratic form with respect to the coordinates of $J_{i j}$ since the $\sharp$-product is bi-linear and dim $J_{j k}=2$.

By Theorem 3.1 (iv), $S(\sigma) \neq 0$ for some $\sigma \in J_{i j}$, and then, by (3.7), $\operatorname{det} P_{i j}^{\sigma} \neq 0$ for such a $\sigma$. Now we show that, for some $\alpha_{i j} \in \mathrm{k}$, $\operatorname{det} P_{i j}^{\sigma}=\alpha_{i j} S(\sigma)$ for any $\sigma \in J_{i j}$ using (3.8). Assume the contrary. Then, for a reason of degree, the highest common factor of $S(\sigma)$ and $\operatorname{det} P_{i j}^{\sigma}$ is a linear form, say, $m(\sigma)$. We may write $S(\sigma)=m(\sigma) l(\sigma)$ with a linear form $l(\sigma)$ (note that $l(\sigma)$ does not $\left.\operatorname{divide} \operatorname{det} P_{i j}^{\sigma}\right)$. Then, by (3.8), there is a constant $2 \times 2$ matrix $M$ such that $P_{j i}^{\sigma}=l(\sigma) M$. Therefore, for a nonzero $\sigma_{0} \in J_{i j}$ such that $l\left(\sigma_{0}\right)=0$, we have $P_{j i}^{\sigma_{0}}=0$. This means $\sigma_{0} \sharp \tau=\mathbf{0}$ for any $\tau \in J_{j k}$. For a $\tau_{0} \in J_{j k}$ with $S\left(\tau_{0}\right) \neq 0$ (cf. Theorem 3.1 (iv)), however, the linear map $f_{j k}^{\tau_{0}}$ is an isomorphism, thus $\sigma_{0} \sharp \tau_{0}$ cannot be zero since $\sigma_{0} \neq \mathbf{0}$, a contradiction. Therefore, for some $\alpha_{i j} \in \mathrm{k}$, $\operatorname{det} P_{i j}^{\sigma}=\alpha_{i j} S(\sigma)$ as desired.

Note that, by replacing the basis $\chi_{1 i}, \chi_{2 i}$ of $J_{j k}$ with $\beta_{j k} \chi_{1 i}, \beta_{j k} \chi_{2 i}$ for some $\beta_{j k} \in \mathrm{k}^{*}$ and the basis $\chi_{1 j}, \chi_{2 j}$ of $J_{i k}$ with $\beta_{i k} \chi_{1 j}, \beta_{i k} \chi_{2 j}$ for some $\beta_{i k} \in \mathrm{k}^{*}$, the matrix $P_{i j}^{\sigma}$ is multiplied with $\frac{B_{i k}}{\beta_{j k}}$. Choosing $\beta_{12}, \beta_{13}, \beta_{23}$ such that $\frac{\beta_{12}}{\beta_{23}}=\sqrt{\alpha_{13}}$ and $\frac{\beta_{12}}{\beta_{13}}=\sqrt{\alpha_{23}}$ (here we use the assumption that k is algebraically closed), and taking the corresponding base changes for $J_{12}, J_{13}, J_{23}$, we may assume that

$$
\begin{equation*}
\operatorname{det} P_{13}^{\sigma}=S(\sigma) \text { and } \operatorname{det} P_{23}^{\tau}=S(\tau) \tag{3.9}
\end{equation*}
$$

for $\sigma \in J_{13}$ and $\tau \in J_{23}$. Then, by (3.8), we have

$$
\begin{equation*}
P_{31}^{\sigma}=-\left(P_{13}^{\sigma}\right)^{\dagger} \text { and } P_{32}^{\tau}=-\left(P_{23}^{\tau}\right)^{\dagger} \tag{3.10}
\end{equation*}
$$

for $\sigma \in J_{13}$ and $\tau \in J_{23}$. Now, setting

$$
P_{32}^{\chi_{11}}=\left(\begin{array}{ll}
p_{221} & -p_{211} \\
p_{222} & -p_{212}
\end{array}\right) \text { and } P_{32}^{\chi_{21}}=\left(\begin{array}{ll}
-p_{121} & p_{111} \\
-p_{122} & p_{112}
\end{array}\right)
$$

the equality (3.3) holds. We have also the first three equalities of (3.6) by the first equality of Theorem 3.1 (iii), (3.9), (3.10), and the definition of $\#$ product. Since $P_{23}^{\tau}=-\left(P_{32}^{\tau}\right)^{\dagger}$ for $\tau \in J_{23}$ by (3.10), we have (3.4). By the commutativity of $\sharp$ product, (3.3) implies

$$
\begin{aligned}
& \chi_{12} \sharp \chi_{11}=p_{221} \chi_{13}+p_{222} \chi_{23}, \\
& \chi_{12} \sharp \chi_{21}=-p_{121} \chi_{13}-p_{122} \chi_{23}, \\
& \chi_{22 \sharp \chi_{11}}=-p_{211} \chi_{13}-p_{212} \chi_{23}, \\
& \chi_{22 \sharp \chi_{21}}=p_{111} \chi_{13}+p_{112} \chi_{23} .
\end{aligned}
$$

Thus we have $P_{31}^{\chi_{12}}=\left(\begin{array}{ll}p_{221} & -p_{121} \\ p_{222} & -p_{122}\end{array}\right)$ and $P_{31}^{\chi_{22}}=\left(\begin{array}{ll}-p_{211} & p_{111} \\ -p_{212} & p_{112}\end{array}\right)$. Then, since $P_{13}^{\sigma}=-\left(P_{31}^{\sigma}\right)^{\dagger}$ for $\sigma \in J_{13}$, we obtain (3.5). Finally we obtain the last six equalities of (3.6) in a similar way to obtain the first three equalities of (3.6).
3.3. $\#$-mapping and cubic form. By Proposition 3.2 and direct computations, we obtain the formulas of $\sigma^{\sharp}$ for any $\sigma \in J$ and the explicit presentation of the cubic form of $J$ as follows:

Corollary 3.4. Under the same assumptions and notation as in Proposition 3.2. we also fix the bases $\chi_{1 i}, \chi_{2 i}$ of $J_{j k}$ for each $i, j, k$ with $\{i, j, k\}=\{1,2,3\}$ and $p_{a b c} \in$ $\mathrm{k}(a, b, c=1,2)$. Let $\sigma \in J$ be any element. We write

$$
\begin{aligned}
& \sigma=\sum_{i=1}^{3}\left(x_{1 i} \chi_{1 i}+x_{2 i} \chi_{2 i}\right)+\sum_{j=1}^{3} u_{j} v_{j}, \\
& \sigma^{\sharp}=\sum_{i=1}^{3}\left(x_{1 i}^{\sharp} \chi_{1 i}+x_{2 i}^{\sharp} \chi_{2 i}\right)+\sum_{j=1}^{3} u_{j}^{\sharp} v_{j},
\end{aligned}
$$

and set

$$
\boldsymbol{x}_{i}:=\binom{x_{1 i}}{x_{2 i}}, \boldsymbol{x}_{i}^{\sharp}:=\binom{x_{1 i}^{\sharp}}{x_{2 i}^{\sharp}}(1 \leq i \leq 3) .
$$

For $i, j=1,2$ and $k=1,2,3$, we define

$$
\begin{aligned}
D_{i j}^{(1)}(x) & :=\left|\begin{array}{ll}
p_{1 i j} & x_{11} \\
p_{2 i j} & x_{21}
\end{array}\right|, D_{i j}^{(2)}(x):=\left|\begin{array}{ll}
p_{i 1 j} & x_{12} \\
p_{i 2 j} & x_{22}
\end{array}\right|, D_{i j}^{(3)}(x):=\left|\begin{array}{ll}
p_{i j 1} & x_{13} \\
p_{i j 2} & x_{23}
\end{array}\right|, \\
D_{i j}^{(1)}\left(x^{\sharp}\right) & :=\left|\begin{array}{ll}
p_{1 i j} & x_{11}^{\sharp} \\

The coordinates of $\sigma^{\sharp}$ and the cubic form defining the quadratic Jordan structure of $J$ are written as follows:

\boldsymbol{x}_{2}^{\#}=-u_{2} \boldsymbol{x}_{2}+D^{(1)}(x) \boldsymbol{x}_{3}, \\
\boldsymbol{x}_{3}^{\#}=-u_{3} \boldsymbol{x}_{3}-\left(D^{(2)}(x)\right)^{\dagger} \boldsymbol{x}_{1}, \\
u_{1}^{\#}=u_{2} u_{3}+\left|D^{(1)}(x)\right|, \\
u_{2}^{\#}=u_{3} u_{1}+\left|D^{(2)}(x)\right|, \\
u_{3}^{\#}=u_{1} u_{2}+\left|D^{(3)}(x)\right|,
\end{array}\right.
$$

where $\left(D^{(2)}(x)\right)^{\dagger}$ is the adjoint matrix of $D^{(2)}(x)$.

N_{\mathcal{H}, \mathrm{P}}:= & 1 / 3\left\{u_{1}\left(u_{1}^{\sharp}\right)-\left|D^{(1)}\left(x, x^{\sharp}\right)\right|-\left|D^{(1)}\left(x^{\sharp}, x\right)\right|\right.  \tag{3.12}\\
& +u_{2}\left(u_{2}^{\sharp}\right)-\left|D^{(2)}\left(x, x^{\sharp}\right)\right|-\left|D^{(2)}\left(x^{\sharp}, x\right)\right| \\
& \left.+u_{3}\left(u_{3}^{\sharp}\right)-\left|D^{(3)}\left(x, x^{\sharp}\right)\right|-\left|D^{(3)}\left(x^{\sharp}, x\right)\right|\right\},

where the coefficient $1 / 3$ in (3.12) only appears in the expression and is canceled such that r.h.s. of (3.12) has only integer coefficients (thus, it works also when the characteristic of k is 3 ).

Notation. We denote the r.h.s. of (3.11) in order from the top by $G_{1}, \ldots, G_{6}$, where $\mathrm{G}_{1}, \mathrm{G}_{2}, \mathrm{G}_{3}$ are 2-dimensional vectors with polynomial entries, and $\mathrm{G}_{4}, \mathrm{G}_{5}, \mathrm{G}_{6}$ are polynomials.

We also have the following converse statement, for which we do not need to assume that k is algebraically closed:

Proposition 3.5. Let $J$ be a 9-dimensional k-vector space with coordinates $u_{1}, u_{2}$, $u_{3}, x_{i j}(i=1,2,3, j=1,2)$. Let $N_{\mathcal{H}, \mathrm{P}}$ be the cubic form (3.12) on $J$ with some hypermatrix P. We also define $\sigma^{\sharp}$ for $\sigma \in J$ as in (3.11). The vector space $J$ has the structure of the quadratic Jordan algebra of the cubic form $N_{\mathcal{H}, \mathrm{P}}$ with the $\sharp$-mapping $J \ni \sigma \mapsto \sigma^{\sharp} \in J$.

Proof. It is straightforward to check the sharp condition ( $\sharp 1)-(\sharp 3)$ for the cubic form $N_{\mathcal{H}, \mathrm{P}}$ and the map $J \ni \sigma \mapsto \sigma^{\sharp} \in J$. Then the assertion follows from Theorem 2.1 .

Definition 3.6. We denote by $J_{\mathrm{P}}$ the quadratic Jordan algebra of the cubic form $N_{\mathcal{H}, \mathrm{P}}$ constructed in Proposition 3.5 .
$J_{\mathrm{P}}$ is not necessarily nondegenerate. We will revisit the problem to determine nondegeneracy of $J_{\mathrm{P}}$ in Subsection 4.5 .

## 4. Affine variety $\mathcal{H}_{\mathbb{A}}^{13}$

Let k be a field.

### 4.1. Definition of $\mathcal{H}_{\mathbb{A}}^{13}$.

Definition 4.1. Let $\mathbb{A}_{\mathcal{H}}$ be the k-affine 17 -space with coordinates $u, u_{2}, u_{3}, x_{i j}(i=$ $1,2,3, j=1,2)$ and $p_{i j k}(i, j, k=1,2,3)$. We define a morphism $\mathbb{A}_{\mathcal{H}} \rightarrow \mathbb{A}_{\mathcal{H}}$ by $\mathbb{A}_{\mathcal{H}} \ni \sigma \mapsto \sigma^{\sharp} \in \mathbb{A}_{\mathcal{H}}$ as in Corollary 3.4. In $\mathbb{A}_{\mathcal{H}}$, we define $\mathcal{H}_{\mathbb{A}}^{13}$ to be the affine scheme defined by the condition

$$
\sigma^{\sharp}=0,
$$

namely, the vanishing of the r.h.s. of (3.11).
Finally, we show that $\mathcal{H}_{\mathbb{A}}^{13}$ is a variety, i.e., it is irreducible.
4.2. $\left(\mathrm{GL}_{2}\right)^{3} \rtimes S_{3}$-action on $\mathcal{H}_{\mathbb{A}}^{13}$. In this subsection, we show the following:

Proposition 4.2. $\mathcal{H}_{\mathbb{A}}^{13}$ has a $\left(\mathrm{GL}_{2}\right)^{3} \rtimes S_{3}$-action.
Proof. There exist three $\mathrm{GL}_{2}$-actions on $\mathcal{H}_{\mathbb{A}}^{13}$ defined by the following rules (1)-(3):
(1) For an element $g_{1} \in \mathrm{GL}_{2}$, we define the $\mathrm{GL}_{2}$-action on the affine space $\mathbb{A}_{\mathcal{H}}$ by the rule

& \boldsymbol{x}_{1} \mapsto g_{1} \boldsymbol{x}_{1}, u_{2} \mapsto\left(\operatorname{det} g_{1}\right) u_{2}, u_{3} \mapsto\left(\operatorname{det} g_{1}\right) u_{3} \\
& \left(\begin{array}{cccc}
p_{111} & p_{112} & p_{121} & p_{122} \\
p_{211} & p_{212} & p_{221} & p_{222}
\end{array}\right) \mapsto g_{1}\left(\begin{array}{cccc}
p_{111} & p_{112} & p_{121} & p_{122} \\
p_{211} & p_{212} & p_{221} & p_{222}
\end{array}\right),
\end{aligned}
$$

with the other coordinates being unchanged. We can check that $\mathrm{G}_{1}, \ldots, \mathrm{G}_{6}$ are changed as follows:

& \mathrm{G}_{1} \mapsto g_{1} \mathrm{G}_{1}, \mathrm{G}_{2} \mapsto\left(\operatorname{det} g_{1}\right) \mathrm{G}_{2}, \mathrm{G}_{3} \mapsto\left(\operatorname{det} g_{1}\right) \mathrm{G}_{3}, \\
& G_{4} \mapsto\left(\operatorname{det} g_{1}\right)^{2} G_{4}, G_{5} \mapsto\left(\operatorname{det} g_{1}\right) G_{5}, G_{6} \mapsto\left(\operatorname{det} g_{1}\right) G_{6} .
\end{aligned}
$$

Therefore this $\mathrm{GL}_{2}$-action on the affine space $\mathbb{A}_{\mathcal{H}}$ induces the action on $\mathcal{H}_{\mathbb{A}}^{13}$.
(2) For an element $g_{2} \in \mathrm{GL}_{2}$, we set

\begin{aligned}
& \boldsymbol{x}_{2} \mapsto g_{2} \boldsymbol{x}_{2}, u_{1} \mapsto\left(\operatorname{det} g_{2}\right) u_{1}, u_{3} \mapsto\left(\operatorname{det} g_{2}\right) u_{3} \\
& \left(\begin{array}{cccc}
p_{111} & p_{112} & p_{211} & p_{212} \\
p_{121} & p_{122} & p_{221} & p_{222}
\end{array}\right) \mapsto g_{2}\left(\begin{array}{cccc}
p_{111} & p_{112} & p_{211} & p_{212} \\
p_{121} & p_{122} & p_{221} & p_{222}
\end{array}\right),
\end{aligned}
$$

and other coordinates being unchanged. The changes of the equations of $\mathcal{H}_{\mathbb{A}}^{13}$ are similar to the case (1), so we omit them. We can check that this $\mathrm{GL}_{2}$-action on the affine space $\mathbb{A}_{\mathcal{H}}$ induces the action on $\mathcal{H}_{\mathbb{A}}^{13}$.
(3) For and element $g_{3} \in \mathrm{GL}_{2}$, we set $\boldsymbol{x}_{3} \mapsto g_{3} \boldsymbol{x}_{3}, u_{1} \mapsto\left(\operatorname{det} g_{3}\right) u_{1}, u_{2} \mapsto$ $\left(\operatorname{det} g_{3}\right) u_{2}$,

$$
\left(\begin{array}{llll}
p_{111} & p_{121} & p_{211} & p_{221} \\
p_{112} & p_{122} & p_{212} & p_{222}
\end{array}\right) \mapsto g_{3}\left(\begin{array}{llll}
p_{111} & p_{121} & p_{211} & p_{221} \\
p_{112} & p_{122} & p_{212} & p_{222}
\end{array}\right)
$$

and other coordinates being unchanged. The changes of the equations of $\mathcal{H}_{\mathbb{A}}^{13}$ are also similar to the case (1), so we omit them. We can check that this $\mathrm{GL}_{2}{ }^{-}$ action on the affine space $\mathbb{A}_{\mathcal{H}}$ induces the action on $\mathcal{H}_{\mathbb{A}}^{13}$.
We can also check that these three $\mathrm{GL}_{2}$-actions on $\mathcal{H}_{\mathbb{A}}^{13}$ mutually commute. Thus these actions induce a $\left(\mathrm{GL}_{2}\right)^{3}$-action on $\mathcal{H}_{\mathbb{A}}^{13}$.

We may define a natural $S_{3}$-action by associating the three numbers $1,2,3$ to the three coordinates $u_{1}, u_{2}, u_{3}$, the three vectors $\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}$, and the three subscripts $i, j, k$ for $p_{i j k}$. For example, by (12) $\in S_{3}, u_{1}$ and $u_{2}, \boldsymbol{x}_{1}$ and $\boldsymbol{x}_{2}, p_{i j k}$ and $p_{j i k}$ are interchanged respectively. Also, by $(123) \in S_{3}, u_{1}, u_{2}, u_{3}$, and $\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}$, and the indices of $p_{i j k}$, respectively are transformed cyclically.

We may check that the $\left(\mathrm{GL}_{2}\right)^{3}$-action and the $S_{3}$-action are not commutative, and $\left(\mathrm{GL}_{2}\right)^{3}$ is invariant by the conjugate of the $S_{3}$-action. Therefore we have a $\left(\mathrm{GL}_{2}\right)^{3} \rtimes S_{3}$-action on $\mathcal{H}_{\mathbb{A}}^{13}$.
4.3. Cayley's hyperdeterminant. Let $\mathbb{A}_{p}$ be the $k$-affine 8 -space with coordinates $p_{i j k}(i, j, k=1,2)$. Note that the $\left(\mathrm{GL}_{2}\right)^{3} \rtimes S_{3}$-action on $\mathbb{A}_{\mathcal{H}}$ induces the one on $\mathbb{A}_{\mathrm{p}}$ by the rules as in the proof of Proposition 4.2. Now we refer to the hypermatrix $P$ as in Remark 3.3.

The induced $\left(\mathrm{SL}_{2}\right)^{3}$-action on $\mathbb{A}_{p}$ is studied in [GKZ, Chap.14, Ex.4.5]; Ap has seven orbits. By this result and by considering the induced $S_{3}$-action on $\mathbb{A}_{p}$ together, we see that $\mathbb{A}_{P}$ has five $\left(\mathrm{GL}_{2}\right)^{3} \rtimes \mathrm{~S}_{3}$-orbits when k is algebraically closed. To state the result, we set
$\mathrm{p}_{1}:=$ the $p_{111}$-point,
$\mathrm{p}_{2}:=$ the point with $p_{111}=p_{221}=1$ and the other coordinates being zero,
$\mathrm{p}_{3}:=$ the point with $p_{111}=p_{122}=p_{212}=1$ and the other coordinates being zero,
$\mathrm{p}_{4}:=$ the point with $p_{111}=p_{222}=1$ and the other coordinates being zero.
Moreover, we set

$$
\begin{align*}
D_{\mathcal{H}}(\mathrm{P}) & :=p_{111}^{2} p_{222}^{2}+p_{112}^{2} p_{221}^{2}+p_{121}^{2} p_{212}^{2}+p_{122}^{2} p_{211}^{2}  \tag{4.1}\\
& -2\left(p_{111} p_{122} p_{211} p_{222}+p_{111} p_{121} p_{212} p_{222}+p_{111} p_{112} p_{221} p_{222}\right. \\
& \left.+p_{121} p_{122} p_{211} p_{212}+p_{112} p_{122} p_{211} p_{221}+p_{112} p_{121} p_{212} p_{221}\right) \\
& +4\left(p_{111} p_{122} p_{212} p_{221}+p_{112} p_{121} p_{211} p_{222}\right)
\end{align*}
$$

which is the hyperdeterminant of the hypermatrix $P$, classically known as the Cayley hyperdeterminant. It is known that $\left\{D_{\mathscr{H}}=0\right\}$ is stable under the $\left(\mathrm{GL}_{2}\right)^{3} \rtimes S_{3^{-}}$ action on $\mathbb{A}_{p}$.

Proposition 4.3. Assume that k is algebraically closed. Then the affine space $\mathbb{A}_{\mathrm{p}}$ has the following five $\left(\mathrm{GL}_{2}\right)^{3} \rtimes \mathrm{~S}_{3}$-orbits:
(1) The origin of $\mathbb{A}_{p}$.
(2) The 4 -dimensional orbit of $\mathrm{p}_{1}$, which is the complement $O_{1}$ of the origin in the affine cone over the Segre variety $\mathbb{P}^{1} \times \mathbb{P}^{1} \times \mathbb{P}^{1}$.
(3) The 5 -dimensional orbit of $\mathrm{p}_{2}$, which is the complement $O_{2}$ of the affine cone over the Segre variety $\mathbb{P}^{1} \times \mathbb{P}^{1} \times \mathbb{P}^{1}$ in the union of three copies of the affine cone over the Segre variety $\mathbb{P}^{1} \times \mathbb{P}^{3}$.
(4) The 7 -dimensional orbit of $\mathrm{p}_{3}$, which is the complement $O_{3}$ of the union of three copies of the affine cone over the Segre variety $\mathbb{P}^{1} \times \mathbb{P}^{3}$ in $\left\{D_{\mathcal{H}}=0\right\}$.
(5) The open orbit of $\mathrm{p}_{4}$, which is the complement $O_{4}$ of $\left\{D_{\mathcal{H}}=0\right\}$ in $\mathbb{A}_{p}$.

Proof. In |GKZ, Chap.14, Ex.4.5], the result is stated without proof for $k=\mathbb{C}$ (see [Pa] for a proof). We give a quick proof for convenience.

We may identify $\mathbb{A}_{p}$ with the affine space associated to the vector space $V_{1} \otimes$ $V_{2} \otimes V_{3}$ with $V_{i} \simeq \mathrm{k}^{2}(1 \leq i \leq 3)$, where $\mathrm{GL}_{2}$ acts on $V_{i}$ in a standard way. We may identify $V_{2} \otimes V_{3}$ with the space of $2 \times 2$ k-matrices as $\mathrm{GL}_{2} \times \mathrm{GL}_{2}$-representation, where $\left(G_{1}, G_{2}\right) \in \mathrm{GL}_{2} \times \mathrm{GL}_{2}$ acts on a $2 \times 2$ k-matrix $A$ as $A \mapsto G_{1} A G_{2}^{-1}$. Having this, we write an element p of $V_{1} \otimes V_{2} \otimes V_{3}$ as $\boldsymbol{e}_{1} \otimes A_{1}+\boldsymbol{e}_{2} \otimes A_{2}$, where $\boldsymbol{e}_{1}, \boldsymbol{e}_{2}$ form a basis of $V_{1}$, and $A_{1}, A_{2}$ are $2 \times 2$ k-matrices. We also take bases $\boldsymbol{g}_{1}, \boldsymbol{g}_{2}$ of $V_{2}$ and $\boldsymbol{h}_{1}, \boldsymbol{h}_{2}$ of $V_{3}$. We determine the orbit of p . We may assume that $\boldsymbol{e}_{1} \otimes A_{1}+\boldsymbol{e}_{2} \otimes A_{2} \neq 0$, i.e., $A_{1} \neq O$ or $A_{2} \neq O$. By the $S_{3}$-action, we may assume that $A_{1} \neq O$.

Assume that rank $A_{1}=2$. Then, by the $\mathrm{GL}_{2} \times \mathrm{GL}_{2}$-action, we may assume that $A_{1}$ is the identity matrix $I$. By a further transformation of the form $\left(I, A_{2}\right) \mapsto$ $\left(I, G A_{2} G^{-1}\right)$, we may assume that $A_{2}=\left(\begin{array}{cc}\alpha & 0 \\ 0 & \beta\end{array}\right)$ or $\left(\begin{array}{cc}\alpha & 1 \\ 0 & \alpha\end{array}\right)(\alpha, \beta \in \mathrm{k})$ (here we use the assumption k is algebraically closed).

In the former case, the element $\mathrm{p}=e_{1} \otimes I+e_{2} \otimes A_{2}$ is identified with $\left(e_{1}+\right.$ $\left.\alpha \boldsymbol{e}_{2}\right) \otimes \boldsymbol{g}_{1} \otimes \boldsymbol{h}_{1}+\left(\boldsymbol{e}_{1}+\beta \boldsymbol{e}_{2}\right) \otimes \boldsymbol{g}_{2} \otimes \boldsymbol{h}_{2}$. If $\alpha \neq \beta$, then, by the $\mathrm{GL}_{2}$-action on $V_{1}$, we may assume that $\mathrm{p}=\boldsymbol{e}_{1} \otimes \boldsymbol{g}_{1} \otimes \boldsymbol{h}_{1}+\boldsymbol{e}_{2} \otimes \boldsymbol{g}_{2} \otimes \boldsymbol{h}_{2}$, which is nothing but the point $\mathrm{p}_{4}$. If $\alpha=\beta$, then, by the $\mathrm{GL}_{2}$-action on $V_{1}$, we may assume that $\mathrm{p}=$ $\boldsymbol{e}_{1} \otimes\left(\boldsymbol{g}_{1} \otimes \boldsymbol{h}_{1}+\boldsymbol{g}_{2} \otimes \boldsymbol{h}_{2}\right)$, which belongs to the orbit of the point $\mathrm{p}_{2}$.

In the latter case, the element $\mathrm{p}=\boldsymbol{e}_{1} \otimes I+\boldsymbol{e}_{2} \otimes A_{2}$ is identified with $\left(\boldsymbol{e}_{1}+\alpha \boldsymbol{e}_{2}\right) \otimes$ $\left(\boldsymbol{g}_{1} \otimes \boldsymbol{h}_{1}+\boldsymbol{g}_{2} \otimes \boldsymbol{h}_{2}\right)+\boldsymbol{e}_{2} \otimes \boldsymbol{g}_{1} \otimes \boldsymbol{h}_{2}$. By the $\mathrm{GL}_{2}$-action on $V_{1}$, we may assume that $\mathrm{p}=\boldsymbol{e}_{1} \otimes\left(\boldsymbol{g}_{1} \otimes \boldsymbol{h}_{1}+\boldsymbol{g}_{2} \otimes \boldsymbol{h}_{2}\right)+\boldsymbol{e}_{2} \otimes \boldsymbol{g}_{1} \otimes \boldsymbol{h}_{2}$, which is nothing but the point $\mathrm{p}_{3}$.

Assume that rank $A_{1}=1$. By the $S_{3}$-action, we may assume that $A_{2}=O$ or $\operatorname{rank} A_{2}=1$. If $A_{2}=O$, then, by the $\mathrm{GL}_{2} \times \mathrm{GL}_{2}$-action on $V_{2} \otimes V_{3}$, we may assume that $\mathrm{p}=\boldsymbol{e}_{1} \otimes \boldsymbol{g}_{1} \otimes \boldsymbol{h}_{1}$, which is nothing but the point $\mathrm{p}_{1}$. Assume that $\operatorname{rank} A_{2}=1$. Then by the $\mathrm{GL}_{2} \times \mathrm{GL}_{2}$-action on $V_{2} \otimes V_{3}$, we may assume that $\mathrm{p}=\boldsymbol{e}_{1} \otimes \boldsymbol{g}_{1} \otimes \boldsymbol{h}_{1}+\boldsymbol{e}_{2} \otimes \boldsymbol{v}_{2} \otimes \boldsymbol{v}_{3}$,where $\boldsymbol{v}_{i}$ is a nonzero vector of $V_{i}(i=2,3)$. Now it is easy to see the following: If $\boldsymbol{v}_{2}$ is parallel to $\boldsymbol{g}_{1}$ and $\boldsymbol{v}_{3}$ is parallel to $\boldsymbol{g}_{2}$, then p belongs to the orbit of $\mathrm{p}_{1}$. If $\boldsymbol{v}_{2}$ is parallel to $\boldsymbol{g}_{1}$ and $\boldsymbol{v}_{3}$ is not parallel to $\boldsymbol{g}_{2}$, then p belongs to the orbit of $\mathrm{p}_{2}$. If $\boldsymbol{v}_{2}$ is not parallel to $\boldsymbol{g}_{1}$ and $\boldsymbol{v}_{3}$ is not parallel to $\boldsymbol{g}_{2}$, then p belongs to the orbit of $\mathrm{p}_{4}$.

Now we have shown that all the orbits are those of $o$ and $\mathrm{p}_{i}(1 \leq i \leq 4)$. It is easy to check that $\mathrm{p}_{i} \in O_{i}(1 \leq i \leq 4)$, and $O_{i}$ are $\left(\mathrm{GL}_{2}\right)^{3} \rtimes S_{3}$-stable (note that the three copies of the Segre variety $\overline{\mathbb{P}^{1}} \times \mathbb{P}^{3}$ as in the statement of (3) are nothing but $\left.\mathbb{P}\left(V_{1}\right) \times \mathbb{P}\left(V_{2} \otimes V_{3}\right), \mathbb{P}\left(V_{1} \otimes V_{2}\right) \times \mathbb{P}\left(V_{3}\right), \mathbb{P}\left(V_{2}\right) \times \mathbb{P}\left(V_{1} \otimes V_{3}\right)\right)$. Since $O_{i}$ are mutually disjoint, we conclude that $O_{i}(1 \leq i \leq 4)$ coincide with the orbit of $\mathrm{p}_{i}$.
4.4. $\mathbb{P}^{2} \times \mathbb{P}^{2}$-fibration associated to $\mathcal{H}_{\mathbb{A}}^{13}$. Note that any equation of $\mathcal{H}_{\mathbb{A}}^{13}$ is of degree two if we regard the coordinates of $\mathbb{A}_{p}$ as constants. Therefore, considering the coordinates $u_{j}, x_{i j}(i=1,2, j=1,2,3)$ as projective coordinates, we obtain a quasi-projective variety with the same equations as $\mathcal{H}_{\mathbb{A}}^{13}$, which we denote by $\widehat{\mathcal{H}}$. We also denote by $\rho_{\mathcal{H}}: \widehat{\mathcal{H}} \rightarrow \mathbb{A}_{p}$ the natural projection.
Definition 4.4. We set

$$
\mathrm{S}:=\left(\begin{array}{lll}
s_{11} & s_{12} & s_{13} \\
s_{12} & s_{22} & s_{23} \\
s_{13} & s_{23} & s_{33}
\end{array}\right), \boldsymbol{\sigma}:=\left(\begin{array}{c}
\sigma_{1} \\
\sigma_{2} \\
\sigma_{3}
\end{array}\right)
$$

and denote by $\mathrm{S}^{\dagger}$ the adjoint matrix of S . We define

$$
\mathbb{P}^{2,2}:=\left\{(\mathrm{S}, \boldsymbol{\sigma}) \mid \mathrm{S}^{\dagger}=O, \mathrm{~S} \boldsymbol{\sigma}=\mathbf{0}\right\} \subset \mathbb{P}^{8}
$$

which is introduced in Mu3] as a degeneration of $\mathbb{P}^{2} \times \mathbb{P}^{2}$ and is shown to be a singular del Pezzo 4-fold of degree six (see also [Fu]).
Proposition 4.5. Assume that k is algebraically closed. The $\rho_{\mathcal{H}}$-fibers over points of the open subset $\left\{D_{\mathcal{H}} \neq 0\right\}$ are isomorphic to $\mathbb{P}^{2} \times \mathbb{P}^{2}$, and the $\rho_{\mathcal{H}}$-fibers over points of the unique nonempty $\left(\mathrm{GL}_{2}\right)^{3} \rtimes \mathrm{~S}_{3}$-stable open subset of $\left\{D_{\mathscr{H}}=0\right\}$ are isomorphic to $\mathbb{P}^{2,2}$. Any $\rho_{\mathcal{H}}$-fibers except the fiber over the origin are 4-dimensional while the fiber over the origin is 5 -dimensional. In particular, $\mathcal{H}_{\mathbb{A}}^{13}$ is 13-dimensional.
Proof. The assertions immediately follows by giving descriptions of all the $\rho_{\mathcal{H}^{-}}$ fibers. Note that the $\left(\mathrm{GL}_{2}\right)^{3} \rtimes \mathrm{~S}_{3}$-action on $\mathcal{H}_{\mathbb{A}}^{13}$ induces that on $\widehat{\mathcal{H}}$. Then $\rho_{\mathcal{H}}$-fibers are isomorphic to the fibers over the origin or the $\mathrm{p}_{i}$-points for some $i=1,2,3,4$, which are easily described by the equations of $\mathcal{H}_{\mathbb{A}}^{13}$ as follows:
(1) The fiber over the origin is the union of $\left\{u_{1}=u_{2}=u_{3}=0\right\} \simeq \mathbb{P}^{5}$, and three $\mathbb{P}^{3}$ 's $\left\{u_{1}=u_{2}=x_{13}=x_{23}=0\right\},\left\{u_{1}=u_{3}=x_{12}=x_{22}=0\right\}$, and $\left\{u_{2}=u_{3}=x_{11}=\right.$ $\left.x_{21}=0\right\}$.
(2) The fiber over the point $\mathrm{p}_{1}$ is the union of three quadric 4 -folds of rank 4 ;

& \left\{u_{1}=u_{2}=x_{23}=u_{3} x_{13}-x_{21} x_{22}=0\right\} \cup\left\{u_{1}=u_{3}=x_{22}=u_{2} x_{12}-x_{21} x_{23}=0\right\} \\
& \cup\left\{u_{2}=u_{3}=x_{21}=u_{1} x_{11}-x_{22} x_{23}=0\right\}
\end{aligned}
$$

(3) The fiber over the point $\mathrm{p}_{2}$ is the union of a quadric 4 -fold of rank 6 and the 4-dimensional cone over a hyperplane section of $\mathbb{P}^{1} \times \mathbb{P}^{3}$;

\begin{aligned}
& \left\{u_{1}=u_{2}=x_{23}=u_{3} x_{13}-x_{11} x_{12}-x_{21} x_{22}=0\right\} \\
& \cup\left\{u_{3}=0, \operatorname{rank}\left(\begin{array}{cccc}
x_{23} & u_{2} & x_{11} & x_{21} \\
u_{1} & -x_{23} & x_{22} & -x_{12}
\end{array}\right) \leq 1\right\}
\end{aligned}
$$

(4) The fiber over the point $p_{3}$ :

\left\{\operatorname{rank}\left(\begin{array}{ccc}
u_{1} & x_{13} & x_{22} \\
x_{13} & u_{2} & -x_{21} \\
x_{22} & -x_{21} & -u_{3}
\end{array}\right) \leq 1,\left(\begin{array}{ccc}
u_{1} & x_{13} & x_{22} \\

Therefore we have shown the assertions.
4.5. Nondegeneracy of $J_{\mathrm{P}}$. Assume that k is algebraically closed. Now we revisit the quadratic Jordan algebra $J_{\mathrm{P}}$ of the cubic form $N_{\mathcal{H}, \mathrm{P}}$ for each value of $\mathrm{P} \in \mathbb{A}_{\mathrm{P}}$ as in Proposition 3.5, we study nondegeneracy of $J_{\mathrm{P}}$. We may regard $\mathbb{A}_{\mathcal{H}} \rightarrow \mathbb{A}_{\mathrm{P}}$ as a family of $J_{\mathrm{P}}$. By the group action of $\mathcal{H}_{\mathbb{A}}^{13}$ as in Subsection 4.2 , we have only to consider nondegeneracy over the origin, the $\mathrm{p}_{1^{-}}, \mathrm{p}_{2^{-}}, \mathrm{p}_{3^{-}}$, and $\mathrm{p}_{4}$-point. For these points, we calculate the subvarieties $R_{J_{P}}$ defined as (2.2), which measure how degenerate the quadratic Jordan algebras $J_{\mathrm{P}}$ are. The results as presented below follow from direct calculations:

Consequently, we have the following:
Corollary 4.6. $J_{\mathrm{P}}$ is nondegenerate if and only if P belongs to the open $\left(\mathrm{GL}_{2}\right)^{3} \rtimes \mathrm{~S}_{3}$ orbit, namely, $D_{\mathcal{H}}(\mathrm{P}) \neq 0$.

In the remaining part of Section 4, we obtain several properties of $\mathcal{H}_{\mathbb{A}}^{13}$ which are needed to construct prime $\mathbb{Q}$-Fano 3-folds from weighted projectivizations of $\mathcal{H}_{\mathbb{A}}^{13}$.
4.6. Charts of $\mathcal{H}_{\mathbb{A}}^{13}$. For a coordinate $*$, we call the open subset of $\mathcal{H}_{\mathbb{A}}^{13}$ with $* \neq$ 0 the $*$-chart. We describe the $*$-chart such that $*$ is an entry of $\boldsymbol{x}_{i}$, or $u_{i}(i=$ $1,2,3)$. By the $S_{3}$-action on $\mathcal{H}_{\mathbb{A}}^{13}$ as in Proposition4.2, we may swap $u_{1}, u_{2}, u_{3}$, and $\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}$. We can also check that, by the action of

 $\overline{\operatorname{map}}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}, u_{1}, u_{2}, u_{3}, p_{i j k}\right) \mapsto\left(\left(u_{1}^{-1} \boldsymbol{x}_{1}, u_{1}^{-1} \boldsymbol{x}_{2}, u_{1}^{-1} \boldsymbol{x}_{3}, u_{1}^{-1} u_{2}, u_{1}^{-1} u_{3}, p_{i j k}\right), u_{1}\right)$. This is because all the equations of $\mathcal{H}_{\mathbb{A}}^{13}$ are quadratic when we consider $p_{i j k}$ are constants. Therefore it suffices to describe $\mathcal{H}_{\mathbb{A}}^{13} \cap\left\{u_{1}=1\right\}$. Solving regularly the 9 equations of $\mathcal{H}_{\mathbb{A}}^{13}$ setting $u_{1}=1$, we see that the 9 equations are reduced to the following 4 equations:

This description of the $u_{1}$-charts shows that the $u_{1^{-}}, u_{2^{-}}$, and $u_{3}$-charts of $\mathcal{H}_{\mathbb{A}}^{13}$ are isomorphic to $\mathbb{A}^{12} \times \mathbb{A}^{1 *}$.
 $x_{11}=1$, we may eliminate the coordinate $u_{1}$ by $u_{1} \boldsymbol{x}_{1}-D^{(3)} \boldsymbol{x}_{2}=0$ with $x_{11}=1$. Then we may verify that $\mathcal{H}_{\mathbb{A}}^{14} \cap\left\{x_{11}=1\right\}$ is defined by the five $4 \times 4$ Pfaffians of the following skew-symmetric matrix:

We have $\Delta \cap\left\{x_{i j} \neq 0\right\}=\Delta_{j} \cap\left\{x_{i j} \neq 0\right\}(i=1,2, j=1,2,3)$. Considering $\mathbb{A}_{\mathrm{P}}$ as the subspace of $\mathbb{A}_{\mathcal{H}}$, we see that $\mathbb{A}_{p} \subset \mathcal{H}_{\mathbb{A}}^{13}$.

By the above descriptions of the charts and the $\left(\mathrm{GL}_{2}\right)^{3} \rtimes \mathrm{~S}_{3}$-action on $\mathcal{H}_{\mathbb{A}}^{13}$, we have the following:

Proposition 4.7. The open subset $\mathcal{H}_{\mathbb{A}}^{13} \backslash \mathbb{A}_{p}$ of $\mathcal{H}_{\mathbb{A}}^{13}$ is 13 -dimensional and irreducible. Its singular locus is equal to $\Delta$, and it has $c(G(2,5))$-singularities along $\Delta$, where we call a singularity isomorphic to the vertex of the cone over $\mathrm{G}(2,5)$ a $c(\mathrm{G}(2,5))$ singularity.

We will show that $\mathcal{H}_{\mathbb{A}}^{13}$ itself is 13 -dimensional and irreducible (Proposition 4.9), and describe the singularities of $\mathcal{H}_{\mathbb{A}}^{13}$ along $\left\{\boldsymbol{x}_{i}=0, u_{j}=0(i, j=1,2,3)\right\}$ in Subsection 4.9 when $\mathrm{k}=\mathbb{C}$.

Hereafter till the end of the paper, we assume for simplicity that $\mathrm{k}=\mathbb{C}$.

### 4.7. Gorensteinness and $9 \times 16$ graded minimal free resolution of the ideal of $\mathcal{H}_{\mathbb{A}}^{13}$.

Proposition 4.8. Let $S_{\mathcal{H}}$ be the polynomial ring over $\mathbb{C}$ whose variables are $u_{1}, u_{2}, u_{3}$, $p_{i j k}(i, j, k=1,2)$ and the entries of $\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}$. Let $I_{\mathcal{H}}$ be the ideal of the polynomial ring $S_{\mathcal{H}}$ generated by the 9 equations (3.11) of $\mathcal{H}_{\mathbb{A}}^{13}$.
(1) We give nonnegative weights for coordinates of $S_{\mathcal{H}}$ such that all the equations of $\mathcal{H}_{\mathbb{A}}^{13}$ are weighted homogeneous, and we denote by $w(*)$ the weight of the monomial $*$. We denote by $\mathbb{P}$ the corresponding weighted projective space, and by $\mathcal{H}_{\mathbb{P}} \subset \mathbb{P}$ the weighted projectivization of $\mathcal{H}_{\mathbb{A}}^{13}$, where we allow some coordinates being nonzero constants (thus $\operatorname{dim} \mathcal{H}_{\mathbb{P}}$ could be less than 12). We set

(2) $I_{\mathcal{H}}$ is a Gorenstein ideal of codimension 4.
(3) $\mathscr{H}_{\mathbb{A}}^{13}$ is irreducible and reduced, thus $I_{\mathcal{H}}$ is a prime ideal.
(4) $\mathcal{H}_{\mathbb{A}}^{13}$ is normal.

Proof. (1). We may compute the $S_{\mathcal{H}}$-free resolution (4.2) of $R_{\mathcal{H}}$ by Singular [DGPS]. Since $\mathcal{H}_{\mathbb{A}}^{13}$ is codimension 4 in $\mathbb{A}_{\mathcal{H}}$ by Proposition 4.5, the length of an $S_{\mathcal{H}}$-free resolution of $I_{\mathcal{H}}$ is at least 4. Therefore the minimality of (4.2) follows. We have (1-1) by the conditions of weights of coordinates, and (1-3) follows from (1-1) and (1-2).
(2). By (1), $I_{\mathcal{H}}$ is Cohen-Macaulay. Moreover, since the last term of the minimal free resolution is $S_{\mathcal{H}}(-\delta)$, which is of rank $1, I_{\mathcal{H}}$ is Gorenstein.
(3). By Proposition 4.5, the $\rho_{\mathcal{H}}$-inverse image $U$ of the open $\left(\mathrm{GL}_{2}\right)^{3} \rtimes \mathrm{~S}_{3}$-orbit is irreducible since any fiber in the open subset is isomorphic to $\mathbb{P}^{2} \times \mathbb{P}^{2}$. Moreover, by ibid., we can verify that $\widehat{\mathcal{H}} \backslash U$ is 11 -dimensional. Therefore, $\mathcal{H}_{\mathbb{A}}^{13}$ has 13 -dimensional irreducible open subset, and its complement is 12 -dimensional. Since $\mathcal{H}_{\mathbb{A}}^{13}$ is Gorenstein by (2), this implies that $\mathcal{H}_{\mathbb{A}}^{13}$ is irreducible and reduced by unmixedness of a Gorenstein variety. We note that we can show (3) similarly using Proposition 4.7 . (4). By Proposition 4.7 $\mathcal{H}_{\mathbb{A}}^{13}$ is regular in codimension 1. By (2), $\mathcal{H}_{\mathbb{A}}^{13}$ satisfies $S_{2}$ condition. Therefore, $\mathcal{H}_{\mathbb{A}}^{13}$ is normal.

### 4.8. Factoriality of $\mathcal{H}_{\mathbb{A}}^{13}$.

Proposition 4.9. Let $S_{\mathcal{H}}, I_{\mathcal{H}}$ be as in Proposition 4.8. The ring $R_{\mathcal{H}}:=S_{\mathcal{H}} / I_{\mathcal{H}}$ is a UFD.

Proof. Note that $R_{\mathcal{H}}$ is a domain by Proposition 4.8 (3). Therefore, by Nagata's theorem [Ma, Thm. 20.2], it suffices to show that the ring $\left(R_{\mathcal{H}}\right)_{u_{1}}$ is a UFD and $u_{1}$ is a prime element of $R_{\mathcal{H}}$.

By the description of the $u_{1}$-chart as in Subsection 4.6, we see that $\left(R_{\mathcal{H}}\right)_{u_{1}}$ is a localization of a polynomial ring, thus is a UFD.

We can show that $\mathcal{H}_{\mathbb{A}}^{13} \cap\left\{u_{1}=0\right\}$ is irreducible by a similar argument as in the proof of Proposition 4.8 (3) using the fibration $\rho_{\mathcal{H}}$; note that $\mathcal{H}_{\mathbb{A}}^{13} \cap\left\{u_{1}=0\right\}$ is also Gorenstein, and any fiber of $\left.\rho_{\mathcal{H}}\right|_{\left\{u_{1}=0\right\}}$ contained in the open subset $U$ is irreducible since it is a hyperplane section of $\mathbb{P}^{2} \times \mathbb{P}^{2}$. Therefore $u_{1}$ is a prime element of $R_{\mathcal{H}}$.

Corollary 4.10. Let $\mathcal{H}_{\mathbb{P}}^{12}$ be the weighted projectivization of $\mathcal{H}_{\mathbb{A}}^{13}$ with some positive weights of coordinates. The following assertions hold:
(1) Any prime Weil divisor on $\mathcal{H}_{\mathbb{P}}^{12}$ is the intersection between $\mathcal{H}_{\mathbb{P}}^{12}$ and a weighted hypersurface. In particular, $\mathcal{H}_{\mathbb{P}}^{12}$ is $\mathbb{Q}$-factorial and has Picard number one.
(2) Let $X$ be a quasi-smooth threefold such that $X$ is a codimension 9 weighted complete intersection in $\mathcal{H}_{\mathbb{P}}^{12}$, i.e., there exist 9 weighted homogeneous polynomials $G_{1}, \ldots, G_{9}$ such that $X=\mathcal{H}_{\mathbb{P}}^{12} \cap\left\{G_{1}=0\right\} \cap \cdots \cap\left\{G_{9}=0\right\}$. Assume moreover that $\left\{u_{1}=0\right\} \cap X$ is a prime divisor. Then any prime Weil divisor on $X$ is the intersection between $X$ and a weighted hypersurface. In particular, $X$ is $\mathbb{Q}$-factorial and has Picard number one.

Proof. (1) Let $\mathfrak{p} \subset R_{\mathcal{H}}$ be the homogeneous ideal defining a prime divisor $D$. Then $\mathfrak{p}$ is an ideal of height one. Since $R_{\mathcal{H}}$ is a UFD by Proposition 4.9, its ideal of height one is principal by [Ma, Thm. 20.1]. Thus the assertion follows.
(2) Once we check that $R_{X}:=R_{\mathcal{H}} /\left(F_{1}, \ldots, F_{9}\right)$ is a UFD, the proof of (1) works verbatim here. Let $R_{X, o}$ be the localization of $R_{X}$ by the maximal irrelevant ideal. Note that, by [Sa, Prop. 7.4], $R_{X}$ is a UFD if and only if so is $R_{X, o}$. Thus we have only to check the latter. To check $R_{X, o}$ is a UFD, we apply Nagata's theorem as in the proof of Proposition 4.9. For this, we need to check that $u_{1}$ is a prime element of $R_{X, o}$, which follows from our assumption, and $\left(R_{X, o}\right)_{u_{1}}$ is a UFD, which we will check below. We denote by $R_{\mathcal{H}, o}$ the localization of $R_{\mathcal{H}}$ by the maximal irrelevant ideal. Since $\left(R_{\mathcal{H}, o}\right)_{u_{1}}$ is a localization of a polynomial ring by the description of the $u_{1}$-chart as in Subsection 4.6, we see that $\left(R_{X, o}\right)_{u_{1}}$ is a localization of a complete
intersection ring. Therefore $\left(R_{X, o}\right)_{u_{1}}$ is a complete intersection local ring of dimension 4. Since $X$ is quasi-smooth, we see that $\left(R_{X, o}\right)_{u_{1}}$ is a UFD by [SGA2, Cor. 3.10 and Thm. 3.13].

### 4.9. Singularities of $\mathcal{H}_{\mathbb{A}}^{13}$.

Proposition 4.11. The variety $\mathcal{H}_{\mathbb{A}}^{13}$ has only terminal singularities with the following descriptions:
(1) The singular locus of $\mathcal{H}_{\mathbb{A}}^{13}$ coincides with $\Delta \cup \mathbb{A}_{p}$.
(2) The singularities along the 6-dimensional locus $\Delta$ are $c(G(2,5))$-singularities.
(3) There exists a primitive $K$-negative divisorial extraction $f: \widetilde{\mathcal{H}} \rightarrow \mathcal{H}_{\mathbb{A}}^{13}$ such that
(a) singularities of $\widetilde{\mathcal{H}}$ are only $c(G(2,5))$-singularities along the strict transforms of $\bar{\Delta}$, and
(b) for the $f$-exceptional divisor $E_{\mathcal{H}}$, the morphism $\left.f\right|_{E_{\mathcal{H}}}$ can be identified with $\rho_{\mathcal{H}}: \widehat{\mathcal{H}} \rightarrow \mathbb{A}_{p}$ as in Subsection 4.4

Proof. By Proposition 4.7, the singular locus of $\mathcal{H}_{\mathbb{A}}^{13}$ is contained in $\Delta \cup \mathbb{A}_{p}$ and the singularities of $\mathcal{H}_{\mathbb{A}}^{13}$ along $\Delta$ are $c(G(2,5))$-singularities. It remain to check the singularities of $\mathcal{H}_{\mathbb{A}}^{13}$ along $\mathbb{A}_{p}$.
Step 1. Let $\widetilde{\mathcal{H}}$ be the variety obtained by blowing up $\mathcal{H}_{\mathbb{A}}^{13}$ along $\mathbb{A}_{p}$ and taking the reduced structure of the blow-up. We denote by $f: \widetilde{\mathcal{H}} \rightarrow \mathcal{H}_{\mathbb{A}}^{13}$ the natural induced morphism. We show that $\widetilde{\mathcal{H}}$ has only $c(G(2,5))$-singularities.

A crucial fact is that any equation of $\mathcal{H}_{\mathbb{A}}^{13}$ is of degree two if we regard $p_{i j k}$ as constants. Therefore, $\widetilde{\mathcal{H}}$ has the same singularities as the $x_{i j}$ - and $u_{j}$-charts $(i=1,2, j=1,2,3)$ of $\mathcal{H}_{\mathbb{A}}^{13}$, and then, by Subsection4.6, $\widetilde{\mathcal{H}}$ has also only $c(G(2,5))$ singularities, which are known to be Gorenstein terminal singularities. Since $\widetilde{\mathcal{H}}$ has only $c(G(2,5))$-singularities, the singular locus of $\widetilde{\mathcal{H}}$ is a smooth 6 -dimensional closed subset. Moreover, it contains the strict transform of $\bar{\Delta}$ and, by the descriptions of the charts of $\widetilde{\mathcal{H}}$, the restriction of the singular locus of $\widetilde{\mathcal{H}}$ to the $f$ exceptional divisor is 5 -dimensional. Therefore, the singular locus of $\widetilde{\Sigma}$ coincides with the strict transform of $\bar{\Delta}$.
Step 2. We show that $\mathcal{H}_{\mathbb{A}}^{13}$ has only Gorenstein terminal singularities also along $\mathbb{A}_{p}$.
Let $E$ be the exceptional divisor of the blow-up $\widetilde{\mathbb{A}} \rightarrow \mathbb{A}_{\mathcal{H}}^{17}$ along $\mathbb{A}_{\mathrm{p}}$. Let $X_{i j}, U_{j}$ be the projective coordinates of $\widetilde{\mathbb{A}}$ corresponding to $x_{i j}, u_{j}$. We see that the $f$ exceptional divisor $E_{\mathcal{H}}=E \cap \widetilde{\mathcal{H}}$ is defined with the equation of $\mathcal{H}_{\mathbb{A}}^{13}$ by replacing $x_{i j}, u_{j}$ with $X_{i j}, U_{j}$. Hence $E_{\mathcal{H}} \rightarrow \mathbb{A}_{p}$ can be identified with $\rho_{\mathcal{H}}: \widehat{\mathcal{H}} \rightarrow \mathbb{A}_{p}$. Therefore $E_{\mathscr{H}}$ is irreducible and reduced since so is $\mathcal{H}_{\mathbb{A}}^{13}$ by Proposition 4.8 (3). By Proposition 4.8 (2) and (4), the variety $\mathcal{H}_{\mathbb{A}}^{13}$ is normal and Gorenstein, and by Step 1 , so is $\widetilde{\mathcal{H}}$. Thus we may write

$$
\begin{equation*}
K_{\tilde{\mathcal{H}}}=f^{*} K_{\mathcal{H}_{\mathbb{A}}^{13}}+a E_{\mathcal{H}} \tag{4.4}
\end{equation*}
$$

with some integer $a$. Note that a general fiber of $E_{\mathcal{H}} \rightarrow \mathbb{A}_{P}$ is $\mathbb{P}^{2} \times \mathbb{P}^{2}$ by Proposition 4.5. Therefore we see that $a=2$ restricting (4.4) to a general fiber. This implies that $\mathcal{H}_{\mathbb{A}}^{13}$ has only Gorenstein terminal singularities also along $\mathbb{A}_{p}$ since so does $\widetilde{\mathcal{H}}$ by Step 1 .

Step 3. Finally we show that $f$ is a $K$-negative primitive divisorial extraction.
Note that $-E_{\mathcal{H}}$ is $f$-ample by a general property of blow-up. Thus $f$ is $K$ negative by (4.4) with $a=2$. Since $\mathcal{H}_{\mathbb{A}}^{13}$ is affine and $-E_{\mathcal{H}}$ is $f$-ample, we may find an effective divisor $D$ such that $D$ is linearly equivalent to $n\left(-E_{\mathcal{H}}\right)$ for sufficiently $\operatorname{big} n \in \mathbb{N}$ and $(\widetilde{\mathcal{H}}, 1 / n D)$ is a klt pair since $\widetilde{\mathcal{H}}$ has only terminal singularities. Note that $\widetilde{\mathcal{H}}$ is locally factorial since so is a $c(G(2,5))$-singularity. Therefore, by [BCHM] Cor. 1.4.1 and 1.4.2], we may run the $K$-MMP over $\mathcal{H}_{\mathbb{A}}^{13}$ with scale $1 / n D$. By the choice of the scale, the strict transforms of $E_{\mathcal{H}}$ are always negative for the contractions when we run the $K$-MMP. Therefore the final contraction of the $K$-MMP is the contraction of the strict transforms of $E_{\mathcal{H}}$. We denote by $f^{\prime}$ this contraction, by $\mathcal{H}^{\prime}$ the source of $f^{\prime}$ and by $E_{\mathcal{H}}^{\prime}$ the strict transforms of $E_{\mathcal{H}}$ on $\mathcal{H}^{\prime}$. Since $R_{\mathcal{H}}$ is a UFD by Proposition 4.9 we see that the target of $f^{\prime}$ is equal to $\mathcal{H}_{\mathbb{A}}^{13}$ and $f^{\prime}\left(E_{\mathcal{H}}^{\prime}\right)=\mathbb{A}_{\mathrm{P}}$. Since the $K$-MMP induces a birational map $\widetilde{\mathcal{H}} \rightarrow \mathcal{H}^{\prime}$ which is isomorphism in codimension one, $f$ and $f^{\prime}$ have the common target $\mathcal{H}_{\mathbb{A}}^{13}$, and both $f$ and $f^{\prime}$ are $K$-negative contractions, we conclude that the induced map $\widetilde{\mathcal{H}} \rightarrow \mathcal{H}^{\prime}$ is actually an isomorphism by [Tak2, Lem. 5.5] for example.

## 5. $\mathbb{Q}$-Fano 3 -fold of No.5.4

5.1. Proof of Theorem 1.2 (1) . We may verify that $\mathcal{H}_{\mathbb{A}}^{13}$ is positively graded by the following weights of coordinates:

& w\left(\boldsymbol{x}_{i}\right)=\binom{1}{1}(i=1,2,3) \\
& w\left(p_{i j k}\right)=1(i, j, k=1,2), w\left(u_{i}\right)=2(i=1,2,3)
\end{aligned}
$$

Let

$$
\mathcal{H}_{\mathbb{P}}^{12} \subset \mathbb{P}\left(1^{14}, 2^{3}\right)
$$

be the weighted projectivization of $\mathcal{H}_{\mathbb{A}}^{13}$ by these weights of coordinates.
Proof of Theorem 1.2 (1). In this proof, we denote $\mathbb{P}\left(1^{14}, 2^{3}\right)$ by $\mathbb{P}$ for simplicity. Using the equations of $\mathcal{H}_{\mathbb{P}}^{12}$, we may easily verify that $\mathrm{Bs}\left|\mathcal{O}_{\mathbb{P}}(1)\right| \cap \mathcal{H}_{\mathbb{P}}^{12}$ consists of the $u_{i}$-points $(i=1,2,3)$, where the $*$-point for a coordinate $*$ of $\mathbb{P}$ means the point of $\mathbb{P}$ such that all the coordinates except $*$ are zero. Note that, by Proposition 4.7 $\operatorname{dim} \operatorname{Sing} \mathcal{H}_{\mathbb{A}}^{13}$ is less than the codimension of $X$ in $\mathcal{H}_{\mathbb{P}}^{12}$. Therefore, by the Bertini theorem, we see that $X$ is a smooth 3 -fold outside the $u_{i}$-points. Computing the linear parts of the equations of $X$ at each of the $u_{i}$-points (cf. LPC in TTak3, Subsec. 5.1]), we see that $X$ has a $1 / 2(1,1,1)$-singularity at each of the $u_{i}$-points. By [BH] Lem.4.1.13], we can read off the Hilbert numerator of $X$ from (4.2). Then we have $\left(-K_{X}\right)^{3}=11 / 2$. By (4.3), we have $-K_{X}=\mathcal{O}_{X}(1)$. Therefore, by the RiemannRoch theorem, we have $g(X):=h^{0}\left(X, \mathcal{O}_{X}\left(-K_{X}\right)\right)-2=3$. We show that $\rho(X)=1$. By Corollary4.10(2), it suffices to check that $X \cap\left\{u_{1}=0\right\}$ is a prime divisor. This follows by the Bertini theorem since $\mathcal{H}_{\mathbb{P}}^{12} \cap\left\{u_{1}=0\right\}$ is irreducible by Proposition 4.8 (3), and the fact that $\mathrm{Bs}\left|\mathcal{O}_{\mathbb{P}}(1)\right| \cap \mathcal{H}_{\mathbb{P}}^{12}$ consists of the $u_{i}$-points. Hence $X$ is a prime $\mathbb{Q}$-Fano 3-fold of No.20652. Note that $\mathcal{H}_{\mathbb{P}}^{12}$ is of codimension 4 in the ambient weighted projective space $\mathbb{P}\left(1^{14}, 2^{3}\right)$. Therefore so is $X$ in the ambient weighted projective space $\mathbb{P}\left(1^{5}, 2^{3}\right)$. By the classification of prime $\mathbb{Q}$-Fano 3 -folds with anti-canonical codimension $\leq 3$, the numerical data of $X$ does not coincide with the data of those. This implies that $\mathrm{ac}_{X}=4$ as desired.

Finally, we show that $X$ belongs to the class of No.5.4 as in [Tak1]. We choose a $1 / 2(1,1,1)$-singularity p and construct the Sarkisov link starting from the blowup at p. By [Tak1, Tables 4 and 5], we can distinguish between prime $\mathbb{Q}$-Fano threefolds of No.4.1 and No.5.4 by the dimension of forms of weight 2 vanishing at p with weighted multiplicity $\geq 3$; the dimension is 3 for No.4.1, and is 4 for No.5.4, which can be verified by looking at the rational map $X \rightarrow X^{\prime}$ in the Sarkisov link (note that this map is defined by the linear system $\left|-2 K_{X}-3 \mathrm{p}\right|$ ). By the group action on $\mathcal{H}_{\mathbb{A}}^{13}$ described in Subsection4.2, we may assume that p is the $u_{1}$ point. Then, by the equation of $\mathcal{H}_{\mathbb{P}}^{12}$, we see that the space of the forms of weight 2 vanishing at p with weighted multiplicity $\geq 3$ on $\mathcal{H}_{\mathbb{P}}^{12}$ is generated by $x_{11}^{2}, x_{11} x_{21}, x_{21}^{2}$ and they are linearly independent on $\mathcal{H}_{\mathbb{P}}^{12}$. They are still linearly independent on $X$ and $H^{0}\left(\mathcal{O}_{\mathscr{H}^{13}}(2)\right) \simeq H^{0}\left(\mathcal{O}_{X}(2)\right)$ since $X$ is cut out from $\mathcal{H}_{\mathbb{P}}^{12}$ by linear forms. Therefore $X$ belongs to that class of No.5.4 as in [Tak1, Tak2].

Remark 5.1. In [Tak6], we will construct a prime $\mathbb{Q}$-Fano threefold of No.4.1 via another key variety $\mathfrak{S}_{\mathbb{A}}^{8}$ obtained in ibid.
5.2. Proof of Theorem $\mathbf{1 . 2}(2)$. This section is occupied with the proof of Theorem 1.2 (2). The proof uses results of [Tak1] freely.

Proof of Theorem 1.2 (2). Let $X$ be a prime $\mathbb{Q}$-Fano 3-fold of No.5.4 as in [Tak1] and assume that $X$ has only $1 / 2(1,1,1)$-singularities. We denote by $\mathrm{p}_{1}, \mathrm{p}_{2}, \mathrm{p}_{3}$ the $1 / 2(1,1,1)$-singularities of $X$. Let $g: Z \rightarrow X$ be the blow-up at (any) two of $1 / 2(1,1,1)$-singularities, say, $\mathrm{p}_{1}, \mathrm{p}_{2}$. By [Tak1, II, Thm.1.0 (2)] and $\left(-K_{Z}\right)^{3}=$ $\left(-K_{X}\right)^{3}-2 \times 1 / 2=9 / 2>0$, we see that $Z$ is a weak $\mathbb{Q}$-Fano 3-fold. Let $h: Z \rightarrow W$ be the morphism defined by $\left|-m K_{Z}\right|$ with $m \gg 0$ ( $W$ is so-called the anti-canonical model of $Z$ ). Note that $W$ is a $\mathbb{Q}$-Fano 3-fold with only canonical singularities.

In the sequel, Steps 1 to 5 consists of lengthy preparation, and the variety $\mathcal{H}_{\mathbb{A}}^{13}$ will appear in Step 6, and we finish the proof in Step 7.
Step 1. We show that $W$ is anticanonically embedded in $\mathbb{P}\left(1^{5}, 2\right)$ as a weighted compelete intersection of two weight 3 hypersurfaces.

We will show this applying [Tak1, II, Thm.3.0] (see the last part of the proof of ibid.). It suffices to check the conditions (1)-(5) of ibid.
(4) We show that $h^{0}\left(\mathcal{O}\left(-K_{W}\right)\right) \geq 4$. By the equality $\left(-K_{Z}\right)=h^{*}\left(-K_{W}\right)$, we have $h^{0}\left(\mathcal{O}\left(-K_{W}\right)\right)=h^{0}\left(\mathcal{O}\left(-K_{Z}\right)\right)$. Since $g$ has the minimal discrepancies at the centers $\mathrm{p}_{1}, \mathrm{p}_{2}$ and the discrepancies are positive, we have $h^{0}\left(\mathcal{O}\left(-K_{Z}\right)\right)=h^{0}\left(\mathcal{O}\left(-K_{X}\right)\right)$. Therefore, since $h^{0}\left(\mathcal{O}\left(-K_{X}\right)\right)=5$, we have $h^{0}\left(\mathcal{O}\left(-K_{W}\right)\right)=h^{0}\left(\mathcal{O}\left(-K_{X}\right)\right) \geq 4$.

It is convenient below to keep in mind that there are bijections among the linear systems $\left|-K_{W}\right|,\left|-K_{Z}\right|$ and $\left|-K_{X}\right|$ by the proof of (4).
(3) We show that $\left|-K_{W}\right|$ has a member with only canonical singularities. By [Tak1, II, Cor.1.2], there is a member $D_{X}$ of $\left|-K_{X}\right|$ with only canonical singularities. Then, since $K_{D_{Z}} \leq\left(\left.g\right|_{D_{Z}}\right)^{*} K_{D_{X}}$, we see that the strict transform $D_{Z}$ belongs to $\left|-K_{Z}\right|$ and $D_{Z}$ has also only canonical singularities. The image $D_{W}$ of $D_{Z}$ belongs to $\left|-K_{W}\right|$. Moreover, $D_{W}$ has also only canonical singularities since so is $D_{Z}$ and $K_{D_{Z}} \sim 0$.
(5) We check that $W$ has only one index two point and it is a $1 / 2(1,1,1)$-singularity. It suffices to show that there are no $h$-exceptional curves through the unique singularity q of $Z$ ( q is the point with $g(\mathrm{q})=\mathrm{p}_{3}$ ). If there is such an $h$-exceptional curve
$l$, then $l \subset \mathrm{Bs}\left|-K_{Z}\right|$ since $-K_{Z} \cdot l=0$ and $\mathrm{q} \in \mathrm{Bs}\left|-K_{Z}\right|$. Then it holds that $g(l) \subset \mathrm{Bs}\left|-K_{X}\right|$ and $g(l)$ contains the $1 / 2(1,1,1)$-singularity $g(\mathrm{q})$, a contradiction to [Tak1, Thm.1.0 (2)].
(2) We show that $\left|-K_{W}\right|$ has no base curve passing through its unique index two point. Assume the contrary. Then $\left|-K_{Z}\right|$ has also a base curve passing through its unique index two point q since $h$ is isomorphic near the unique index two point of $W$ by the proof of (5). Since $g$-exceptional divisors do not contain q, $\left|-K_{X}\right|$ has also a base curve passing through $\mathrm{p}_{3}$, a contradiction to [Tak1, Thm.1.0 (2)].
(1) We check that $W$ is indecomposable, i.e., there are no effective Weil divisors $A, B$ with $h^{0}(A) \geq 2$ and $h^{0}(B) \geq 2$ such that $-K_{W} \sim A+B$. Assume by contradiction that there are such $A$ and $B$. By the check of (5), $h$ is isomorphic near the unique index two point of $W$. Therefore $-K_{W}$ is a Cartier divisor near the images of $h$-exceptional divisors if exist. Hence $h^{*}(A+B)$ is an integral divisor. Then we have $h^{*}(A+B)=A^{\prime}+B^{\prime}+\sum E_{i}$, where $A^{\prime}, B^{\prime}$ are integral Weil Divisors such that $h_{*}^{\prime}\left(A^{\prime}\right)=A, h^{0}\left(A^{\prime}\right) \geq h^{0}(A) \geq 2$, and $h_{*}^{\prime}\left(B^{\prime}\right)=B, h^{0}\left(B^{\prime}\right) \geq h^{0}(B) \geq 2$, and $E_{i}$ are $h$-exceptional divisors ( $E_{i}=E_{j}$ could happen even if $i \neq j$ ). Thus we have $-K_{X} \sim g_{*}\left(A^{\prime}\right)+g_{*}\left(B^{\prime}\right)+\sum g_{*}\left(E_{i}\right)$. Since $h^{0}\left(g_{*}\left(A^{\prime}\right)\right), h^{0}\left(g_{*}\left(B^{\prime}\right)\right) \geq 2$, we have $g_{*}\left(A^{\prime}\right) \neq 0$ and $g_{*}\left(B^{\prime}\right) \neq 0$. This contradicts the assumption that $X$ is prime.

Now, applying [Tak1, II, Thm.3.0] to $W$, we see that $W$ is anticanonically embedded in $\mathbb{P}\left(1^{5}, 2\right)$ as a weighted compelete intersection of two weight 3 hypersurfaces.

Before going to the next step, let $E_{1}$ and $E_{2}$ be the $g$-exceptional divisors and $\Pi_{1}$ and $\Pi_{2}$ the images on $W$ of $E_{1}$ and $E_{2}$ respectively. We see that $\Pi_{1}$ and $\Pi_{2}$ do not contain the $1 / 2(1,1,1)$-singularity of $W$ since $E_{1}$ and $E_{2}$ do not contain the $1 / 2(1,1,1)$-singularity q of $Z$ and there are no $h$-exceptional curves through $z$ as we see in the check of (5) in Step 1. Therefore, by the projection $\mathbb{P}\left(1^{5}, 2\right) \rightarrow \mathbb{P}^{4}$ from the unique $1 / 2\left(1^{5}\right)$-point, $\Pi_{1}$ and $\Pi_{2}$ are mapped to planes, say, $\Pi_{1}^{\prime}$ and $\Pi_{2}^{\prime}$ in $\mathbb{P}^{4}$ since $\left(-K_{Z}\right)^{2} E_{1}=\left(-K_{Z}\right)^{2} E_{2}=1$. Therefore $E_{1}$ and $E_{2}$ are mapped to planes in $\mathbb{P}^{4}$ isomorphically and hence $E_{1}$ and $E_{2}$ are mapped to $\Pi_{1}$ and $\Pi_{2}$ isomorphically.
Step 2. We show that $h$ has no exceptional divisors. In particular, $W$ has only terminal singularities. Moreover the singular locus of $W$ consists of the $u_{3}$-point and the locus contained in $\Pi_{1} \cup \Pi_{2}$.

Since an $h$-exceptional curve is numerically trivial for $-K_{Z}$ while $-K_{X}$ is ample, we see that an $h$-exceptional curve intersects with $E_{1}$ or $E_{2}$. Therefore the singular locus of $W$ is contained in $\Pi_{1} \cup \Pi_{2}$ outside of the $u_{3}$-point.

Assume by contradiction that there exists an $h$-exceptional divisor $F$. Therefore, by the discussion in the above paragraph, $h(F)$ is contained in $\Pi_{1}$ or $\Pi_{2}$, say, $\Pi_{1}$. Since $\Pi_{1}$ is mapped to the plane $\Pi_{1}^{\prime}$ in $\mathbb{P}^{4}$ isomorphically, there exists a member $D_{W}$ of $\left|-K_{W}\right|$ containing $\Pi_{1}$ since $\mathcal{O}\left(-K_{W}\right)=\mathcal{O}(1)$. Since there are two independent linear forms to define a plane in $\mathbb{P}^{4}$, we can write $D_{W}=D_{W}^{\prime}+\Pi_{1}$ with $h^{0}\left(D_{W}^{\prime}\right)=2$. Let $D_{Z}$ be the total transform of $D_{W}$ on $Z$ and $D_{X}:=g_{*} D_{Z}$. Then, by a similar argument to the check of (1) in Step 1 , we see that $D_{X} \in\left|-K_{X}\right|$ and $D_{X}$ contains at least the strict transform of some irreducible component of $D_{W}^{\prime}$ and the image of $F$. This contradicts the assumption that $X$ is prime.

In the following steps, we also consider the blow-up $g^{\prime}: Z^{\prime} \rightarrow X$ at the three $1 / 2(1,1,1)$-singularities $\mathrm{p}_{1}, \mathrm{p}_{2}, \mathrm{p}_{3}$. By a similar argument to Step 1 , we can prove that $Z^{\prime}$ is a weak Fano 3-fold. Let $h^{\prime}: Z^{\prime} \rightarrow W^{\prime}$ be the morphism defined by $\mid-$
$m K_{Z^{\prime}} \mid$ with $m \gg 0$. By a similar argument to Step 2, we can prove that $h^{\prime}$ has no exceptional divisor.
Step 3. We show that $W^{\prime}$ is a quartic 3-fold in $\mathbb{P}^{4}$ with only terminal singularities.
By a similar argument to the one before Step 1, we can check that $W^{\prime}$ satisfies the conditions (1)-(5) of [Tak1, II, Thm.3.0], and applying [Tak1, II, Thm.3.0] to $W^{\prime}$, we see that $W^{\prime}$ is a quartic 3-fold in $\mathbb{P}^{4}$ or a double cover of a quadric 3-fold in $\mathbb{P}^{4}$ branched along the intersection with a quartic 3 -fold. Assume by contradiction that the latter case occurs, i.e., $W^{\prime}$ is the double cover of a quadric 3-fold $Q$. Similarly to the discussion just before Step 2, we see that the images on $\mathbb{P}^{4}$ of $g^{\prime}$-exceptional divisors are planes. Therefore $Q$ contains a plane, and then $Q$ is singular. By the geometry of a singular quadric 3-fold, there is a hyperplane section $H_{Q}$ which is the union of two planes $P_{1}$ and $P_{2}$, and we may choose $P_{1}$ and $P_{2}$ such that their strict transforms are not $g^{\prime}$-exceptional divisors. Then, pulling back $H_{Q}$ to $Z^{\prime}$ and pushing down to $X$, we obtain a reducible anticanonical divisor of $X$, which contradicts the assumption that $X$ is prime (cf. the argument in Step 2). Therefore $W^{\prime}$ is a quartic in $\mathbb{P}^{4}$. The assertion as for the singularities of $W^{\prime}$ follows similarly to Step 2.
Step 4. We show that $\Pi_{1}^{\prime} \cap \Pi_{2}^{\prime}$ consists of one point.
First we show that $\Pi_{1}^{\prime} \cap \Pi_{2}^{\prime} \neq \emptyset$. To see this, let $f: Y \rightarrow X$ be the blow-up at $\mathrm{p}_{1}$ and $E$ the $f$-exceptional divisor. Then, since X is of No.5.4, there is a flop $Y \rightarrow Y_{1}$ and a flip $Y_{1} \rightarrow Y^{\prime}$ by [Tak1, I, Table 5]. Let $E_{Y_{1}}$ be the strict transform of $E$ on $Y_{1}$. By ibid., there is a flipping curve $m$ on $Y_{1}$ with $-K_{Y_{1}} \cdot m=1 / 2$ and $E_{Y_{1}} \cdot m>0$ through the $1 / 2(1,1,1)$-singularity corresponding to $\mathrm{p}_{2}$. Since the flop $Y \rightarrow Y_{1}$ is crepant, we see that $m$ is the strict transform of a curve $m_{Y}$ on $Y$ with $-K_{Y} \cdot m_{Y}=1 / 2$ passing through the $1 / 2(1,1,1)$-singularity corresponding to $\mathrm{p}_{2}$. Moreover, since a flopping curve is positive for $E$, we have $E \cdot m_{Y}>0$, or there exists a connected chain of flopping curves intersecting both $E$ and $m_{Y}$. Regarding $Z$ as the blow-up of $Y$ at the $1 / 2(1,1,1)$-singularity corresponding to $\mathrm{p}_{2}$ (then $E_{1}$ is the strict transform of the $f$-exceptional divisor $E$ ), we see that the strict transform $m_{Z}$ of $m_{Y}$ on $Z$ satisfies $-K_{Z} \cdot m_{Z}=0$. Therefore $m_{Z}$ is contracted to a point on $\mathbb{P}^{4}$. Moreover $m_{Z}$ intersects both with $E_{1}$ and $E_{2}$, or $m_{Z}$ intersects with $E_{2}$ and there exists a connected chain of flopping curves intersecting $E_{1}$ and $m_{Z}$. In any case, we conclude that $\Pi_{1}^{\prime} \cap \Pi_{2}^{\prime}$ contains at least the image of $m_{Z}$.

Assume by contradiction that $\Pi_{1}^{\prime} \cap \Pi_{2}^{\prime}$ does not consists of one point. Then $\Pi_{1}^{\prime} \cap \Pi_{2}^{\prime}$ contains at least a line. We may easily check that the closure of the image of $W$ by the projection $\mathbb{P}\left(1^{5}, 2\right) \rightarrow \mathbb{P}^{4}$ is nothing but $W^{\prime}$, which is shown to be a quartic 3 -fold in $\mathbb{P}^{4}$ in Step 3. Then, since $\Pi_{1}^{\prime} \cap \Pi_{2}^{\prime}$ contains at least a line and $h^{\prime}$ is birational, there exists an $h^{\prime}$-exceptional divisor, which contradicts the argument just above Step 3. Thus we have shown that $\Pi_{1}^{\prime} \cap \Pi_{2}^{\prime}$ consists of one point.

Let $x_{11}, x_{21}, x_{12}, x_{22}, x_{13}, u_{3}$ be the coordinates of $\mathbb{P}\left(1^{5}, 2\right)$ such that the weight of $u_{3}$ is 2 and the weights of the other coordinates are 1 (this strange choice of notation for coordinates will convenient for relating the construction below with the equation of $\mathcal{H}_{\mathbb{A}}^{13}$ as in Corollary 3.4).
Step 5. We prove that we may assume $\Pi_{1}=\left\{x_{11}=x_{21}=u_{3}=0\right\}$ and $\Pi_{2}=\left\{x_{12}=\right.$ $\left.x_{22}=u_{3}=0\right\}$ by coordinate changes.

Since $\Pi_{1}^{\prime} \cap \Pi_{2}^{\prime}$ consists of one point by Step 4, we may assume that $\Pi_{1}^{\prime}=\left\{x_{11}=\right.$ $\left.x_{21}=0\right\}$ and $\Pi_{2}^{\prime}=\left\{x_{12}=x_{22}=0\right\}$. Therefore, since the degrees of $\Pi_{1}$ and $\Pi_{2}$ are one with respect to $\mathcal{O}(1)$, we have $\Pi_{1}=\left\{x_{11}=x_{21}=f_{1}\left(x_{12}, x_{22}, x_{13}, u_{3}\right)=0\right\}$
and $\Pi_{2}=\left\{x_{12}=x_{22}=f_{2}\left(x_{11}, x_{21}, x_{13}, u_{3}\right)=0\right\}$, where $f_{1}\left(x_{12}, x_{22}, x_{13}, u_{3}\right)$ and $f_{2}\left(x_{11}, x_{21}, x_{13}, u_{3}\right)$ are of weight two. Since $\Pi_{1}, \Pi_{2}$ do not contain the $1 / 2\left(1^{5}\right)$ singularity of $\mathbb{P}\left(1^{5}, 2\right)$, we see that the polynomials $f_{1}, f_{2}$ contains $u_{3}$. By a coordinate change, we may assume that $f_{1}=u_{3}$ and $f_{2}=u_{3}+g_{2}\left(x_{11}, x_{21}, x_{13}\right)$. Note that $g_{2}$ does not contain $x_{13}^{2}$ since otherwise $\Pi_{1} \cap \Pi_{2}$ must be empty. Now we set $u_{3}^{\prime}=u_{3}+g_{2}\left(x_{11}, x_{21}, x_{13}\right)$. Then $\Pi_{2}=\left\{x_{12}=x_{22}=u_{3}^{\prime}=0\right\}$ and $\Pi_{1}=\left\{x_{11}=x_{21}=u_{3}^{\prime}-g_{2}\left(x_{11}, x_{21}, x_{13}\right)=0\right\}=\left\{x_{11}=x_{21}=u_{3}^{\prime}=0\right\}$. Denoting $u_{3}^{\prime}$ by $u_{3}$, we obtain the desired expression of $\Pi_{1}$ and $\Pi_{2}$.
Step 6. We extend $W$ to a 12-dimensional weighted compelete intersection $\overline{\mathcal{H}}$ of two weight 3 hypersurfaces in $\mathbb{P}\left(1^{14}, 2\right)$.

We may write equations of $W$ as follows since it contains $\Pi_{1}$ and $\Pi_{2}$ :

where $l_{i j k}$ 's, $l_{s t}$ are linear forms.
We show that $l_{13}$ or $l_{23}$ contains $x_{13}$. Assume by contradiction that neither $l_{13}$ nor $l_{23}$ contains $x_{13}$. Then both equations of (5.1) are singular at the $x_{13}$-point. Therefore $W$ has a canonical but non-terminal singularity at the $x_{13}$-point. This contradicts Step 2.

By changing the order of the two equations of (5.1), we may assume that $l_{13}$ contains $x_{13}$. Moreover, changing the coordinates, we may also assume that $l_{13}=$ $x_{13}$. Now (5.1) can be written as follows:

where we set $\boldsymbol{x}_{1}:=\binom{x_{11}}{x_{21}}$. We also set $\boldsymbol{x}_{2}:=\binom{x_{12}}{x_{22}}, \boldsymbol{x}_{3}:=\binom{x_{13}}{x_{23}}$, and denote by $\mathbb{P}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}, p_{i j k}, u_{3}\right)(i, j, k=1,2)$ the weighted projective space with the entries of $\boldsymbol{x}_{i}(i=1,2,3)$ and $p_{i j k}$ being weight one coordinates, and $u_{3}$ being a weight two coordinate. Then $W$ is equal to

where $D^{(2)}$ is defined as in Corollary 3.4,
Finally, we set

Let $\mathcal{H}_{\mathbb{P}}^{12}$ be the weighted projectivization of $\mathcal{H}_{\mathbb{A}}^{13}$ such that the weights of $u_{1}, u_{2}, u_{3}$ is 2 and the weights of the other coordinates are 1 . We set

X^{\prime}:=\mathcal{H}_{\mathbb{P}}^{12} \cap\left\{p_{i j k}=l_{i j k}, x_{23}=l_{23}\right\}
$$

Note that the projection $\mathbb{P}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}, p_{i j k}, u_{1}, u_{2}, u_{3}\right) \rightarrow \mathbb{P}\left(\boldsymbol{x}_{1}, \boldsymbol{x}_{2}, \boldsymbol{x}_{3}, p_{i j k}, u_{3}\right)$ induces rational maps $\mathcal{H}_{\mathbb{P}}^{12} \rightarrow \overline{\mathcal{H}}$ and $X^{\prime} \rightarrow W$.
Step 7. We show that $X$ is isomorphic to $X^{\prime}$, which finish the proof of Theorem 1.2 (2).

By [Tak2, Lem.5.5], it suffices to show that
(i) $X^{\prime}$ is a normal 3-fold,
(ii) $-K_{X^{\prime}}$ is $\mathbb{Q}$-Cartier and ample, and
(iii) the rational map $X \rightarrow X^{\prime}$ induced by $X \rightarrow W$ and the inverse of $X^{\prime} \rightarrow W$ is isomorphic in codimension 1.

Note that (ii) follows from (i) and the proof of Theorem 1.2 (1). Thus it suffices to show (i) and (iii). For this, we give preparatory argument.

It is easy to check that the rational map $\mathcal{H}_{\mathbb{P}}^{12} \rightarrow \overline{\mathcal{H}}$ is defined outside the $u_{1}$ - and the $u_{2}$-points. Moreover, using the equations (3.11), we see that, outside $\left\{\boldsymbol{x}_{1}=\right.$ $\left.\boldsymbol{o}, u_{3}=0\right\} \cup\left\{\boldsymbol{x}_{2}=\boldsymbol{o}, u_{3}=0\right\}$, the coordinates $u_{1}$ and $u_{2}$ are recovered by this rational map with the equations $\mathrm{G}_{1}=\boldsymbol{o}, \mathrm{G}_{2}=\boldsymbol{o}, \mathrm{G}_{3}=\boldsymbol{o}, \mathrm{G}_{4}=0, \mathrm{G}_{5}=0$. Therefore it holds that

where we set

This implies that

By direct computations, we can verify that

& \cup\left\{\boldsymbol{x}_{1}=\boldsymbol{x}_{2}=\boldsymbol{o}, u_{3}=0, u_{1} u_{2}+\operatorname{det} D^{(3)}=0\right\},
\end{aligned}
$$

and it is mapped by $\mathcal{H}_{\mathbb{P}}^{12} \longrightarrow \overline{\mathcal{H}}$ to the locus

with 1-dimensional fibers. We note that $D^{(1)} \boldsymbol{x}_{3}=-D^{(3) \dagger} \boldsymbol{x}_{1}$, where $D^{(3) \dagger}$ is the adjoint of $D^{(3)}$. Then, setting

we can similarly check that $\left\{\boldsymbol{x}_{2}=\boldsymbol{o}, u_{3}=0\right\} \cap \mathcal{H}_{\mathbb{P}}^{12}$ is mapped by $\mathcal{H}_{\mathbb{P}}^{12} \rightarrow \overline{\mathcal{H}}$ to $S_{2}$ with 1-dimensional fibers. Therefore, $\Gamma \cap X^{\prime}$ is mapped to the image $\left.\left.S_{1}\right|_{W} \cup S_{2}\right|_{W}$ with 1-dimensional fibers. On the other hand, using (5.2), we can directly check that Sing $W=\left\{\right.$ the $u_{3}$-point $\} \cup\left(\left.\left.S_{1}\right|_{W} \cup S_{2}\right|_{W}\right)$. Therefore, by Step 2, $\operatorname{dim}\left(\left.S_{1}\right|_{W} \cup\right.$ $\left.\left.S_{2}\right|_{W}\right)=0$, and then $\operatorname{dim} \Gamma \cap X^{\prime}=1$.

Now we show (i). By the above discussion, $X^{\prime}$ is 3-dimentional since $X^{\prime}$ is the union of a 1-dimensional closed subset $\Gamma \cap X^{\prime}$ and a 3-dimensional open subset isomorphic to $W \backslash\left(\Pi_{1} \cup \Pi_{2}\right)$. Since then the affine cone $X_{\mathbb{A}}^{\prime}$ of $X^{\prime}$ is of codimension 9 in $\mathcal{H}_{\mathbb{A}}^{13}$ and the ideal of $X_{\mathbb{A}}^{\prime}$ in $\mathcal{H}_{\mathbb{A}}^{13}$ is generated by 9 elements, $X_{\mathbb{A}}^{\prime}$ is Gorenstein and is of pure dimension 4 by unmixedness of the Gorenstein variety $\mathcal{H}_{\mathbb{A}}^{13}$. Thus $X^{\prime}$ is an irreducible 3-fold and satisfies $S_{2}$-condition. Since $W \backslash\left(\Pi_{1} \cup \Pi_{2}\right)$ has only one $1 / 2(1,1,1)$-singularity by Step $2, X^{\prime}$ satisfies the $R_{1}$-condition. Consequently, $X^{\prime}$ is a normal 3-fold as desired.

It remains to show (iii). Since $W$ has only terminal singularities by Step 2, the morphism $h$ is a small contraction and the images of $h$-exceptional curves are contained in $\Pi_{1} \cup \Pi_{2}$. Thus $W \backslash\left(\Pi_{1} \cup \Pi_{2}\right)$ is isomorphic to an open subset of $X$
obtained by removing a closed subset of codimension 2. Therefore, $X$ and $X^{\prime}$ are isomorphic in codimension 1 as desired by (5.3) and the fact $\operatorname{dim} \Gamma \cap X^{\prime}=1$.

## 6. Relatives of $\mathcal{H}_{\mathbb{A}}^{13}$-AFFine varieties $\mathcal{M}_{\mathbb{A}}^{8}$ and $\mathcal{S}_{\mathbb{A}}^{6}$ -

We define two special subvarieties $\mathcal{N}_{\mathbb{A}}^{8}$ and $\mathcal{S}_{\mathbb{A}}^{6}$ of $\mathcal{H}_{\mathbb{A}}^{13}$ with good group actions. In Section 7, it turns out that their several weighted projectivizations are key varieties of prime $\mathbb{Q}$-Fano 3-folds.

### 6.1. Definition of $\mathcal{M}_{\mathbb{A}}^{8}$.

Definition 6.1. We define $\mathcal{M}_{\mathbb{A}}^{8}$ to be the affine scheme in the 12 -dimensional affine space $\mathbb{A}_{\mathcal{M}}$ with the coordinates implemented in

where $X_{2}^{\dagger}$ is the adjoint matrix of $X_{2}$.
Proposition 6.2. The affine scheme $\mathcal{H}_{\mathbb{A}}^{13} \cap\left\{p_{221}=-1, p_{222}=0, p_{211}=0, p_{212}=\right.$ $\left.1, p_{121}=p_{112}\right\}$ coincides with $\mathcal{M}_{\mathbb{A}}^{8}$ by changing the notation of the coordinates as follows:

where the l.h.s. are the coordinates of $\mathcal{M}_{\mathbb{A}}^{8}$, and the r.h.s. are those of $\mathcal{H}_{\mathbb{A}}^{13}$.
6.2. $\left(\mathrm{GL}_{2}\right)^{2}$-action on $\mathcal{M}_{\mathbb{A}}^{8}$. By the equations (6.1) of $\mathcal{M}_{\mathbb{A}}^{8}$, we can directly check the following:

Proposition 6.3. The group $\left(\mathrm{GL}_{2}\right)^{2}$ acts on $\mathcal{M}_{\mathbb{A}}^{8}$ by the following rules: for any $\left(g_{1}, g_{2}\right) \in\left(\mathrm{GL}_{2}\right)^{2}$, we set

where $g_{1}^{\dagger}, g_{2}^{\dagger}$ are the adjoint matrices of $g_{1}, g_{2}$ respectively.
6.3. $\mathbb{P}^{2} \times \mathbb{P}^{2}$-fibration related with $\mathcal{M}_{\mathbb{A}}^{8}$. Let $\mathbb{A}_{x_{1}}$ be the affine 3 -space with the coordinates $x_{1}, x_{2}, x_{3}$. As in the case of $\mathcal{H}_{\mathbb{A}}^{13}$, considering the coordinates in the equations of $\mathcal{M}_{\mathbb{A}}^{8}$ except those of $\mathbb{A}_{X_{1}}$ as projective coordinates, we obtain a quasiprojective variety with the same equations as $\mathcal{M}_{\mathbb{A}}^{8}$, which we denote by $\widehat{\mathcal{M}}$. We also denote by $\rho_{\mathcal{M}}: \widehat{\mathcal{M}} \rightarrow \mathbb{A}_{X_{1}}$ the natural projection. Using the group action on $\mathcal{M}_{\mathbb{A}}^{8}$, we can show the following in a similar way to Proposition4.5.

Proposition 6.4. The $\rho_{\mathcal{M}}$-fibers over points of the complement of $\left\{\operatorname{det} \mathrm{X}_{1}=0\right\}$ are isomorphic to $\mathbb{P}^{2} \times \mathbb{P}^{2}$, and the $\rho_{\mathcal{M}}$-fibers over points of are $\left\{\operatorname{det} \mathrm{X}_{1}=0\right\} \backslash\{o\}$ isomorphic to $\mathbb{P}^{2,2}$. Any $\rho_{\mathcal{M}}$-fibers are 4 -dimensional. In particular, $\mathcal{N}_{\mathbb{A}}^{8}$ is irreducible and 8-dimensional.

### 6.4. Definition of $\mathcal{S}_{\mathbb{A}}^{6}$.

Definition 6.5. We define $\mathcal{S}_{\mathbb{A}}^{6}$ to be the affine scheme in the 10 -dimensional affine space $\mathbb{A}_{\mathcal{S}}$ with the coordinates implemented in

Remark 6.6. The equations (6.2) appears in [GN, Ex.5.4].
Proposition 6.7. The affine scheme $\mathcal{H}_{\mathbb{A}}^{13} \cap\left\{p_{221}=p_{212}=p_{122}=1, p_{222}=p_{211}=\right.$ $\left.p_{121}=p_{112}=0\right\}$ coincides with $\mathcal{S}_{\mathbb{A}}^{6}$ by changing the notation of the coordinates as follows:

where the l.h.s. are the coordinates of $\mathcal{S}_{\mathbb{A}}^{6}$, and the r.h.s. are those of $\mathcal{H}_{\mathbb{A}}^{13}$.
6.5. $\mathrm{GL}_{3}$-action on $\mathfrak{S}_{\mathbb{A}}^{6}$. By the equations (6.2) of $\mathcal{S}_{\mathbb{A}}^{6}$, we can directly check the following:

Proposition 6.8. The group $\mathrm{GL}_{3}$ acts on $\mathcal{S}_{\mathbb{A}}^{6}$ by the following rules: for any $g \in \mathrm{GL}_{3}$, we set

$$
\mathrm{S} \mapsto g \mathrm{~S}\left({ }^{\mathrm{t}} g\right), \boldsymbol{\sigma} \mapsto\left({ }^{\mathrm{t}} g\right)^{\dagger} \boldsymbol{\sigma}, t \mapsto t
$$

where $g^{\dagger}$ is the adjoint matrix of $g$ respectively.
6.6. $\mathbb{P}^{2} \times \mathbb{P}^{2}$-fibration related with $\mathcal{S}_{\mathbb{A}}^{6}$. Let $\mathbb{A}_{t}$ be the affine line with the coordinates $t$. As in the case of $\mathcal{H}_{\mathbb{A}}^{13}$, considering the coordinates in the equations of $\mathcal{S}_{\mathbb{A}}^{6}$ except $t$ as projective coordinates, we obtain a quasi-projective variety with the same equations as $\mathcal{S}_{\mathbb{A}}^{6}$, which we denote by $\widehat{\mathcal{S}}$. We also denote by $\rho_{\mathcal{S}}: \widehat{\mathcal{S}} \rightarrow \mathbb{A}_{t}$ the natural projection. Using the group action on $\mathcal{S}_{\mathbb{A}}^{6}$, we can show the following in a similar way to Proposition 4.5:
Proposition 6.9. The $\rho_{\mathcal{M}}$-fibers except the one over the origin are isomorphic to $\mathbb{P}^{2} \times \mathbb{P}^{2}$, and the $\rho_{\mathcal{M}}$-fiber over the origin is isomorphic to $\mathbb{P}^{2,2}$. In particular, $\mathcal{S}_{\mathbb{A}}^{6}$ is irreducible and 6-dimensional.

As for $\mathcal{M}_{\mathbb{A}}^{8}$ and $\mathfrak{S}_{\mathbb{A}}^{6}$, we obtain similar properties to those of $\mathcal{H}_{\mathbb{A}}^{13}$ as in Subsections 4.6-4.9. We omit deriving these since the method is similar to that in the case of $\mathcal{H}_{\mathbb{A}}^{13}$. Actually, we need those properties of $\mathcal{M}_{\mathbb{A}}^{8}$ and $\mathcal{S}_{\mathbb{A}}^{6}$ if we directly construct prime $\mathbb{Q}$-Fano 3-folds from their weighted projectivizations. We can, however, take a shortcut using the result of [CD1] in Section 7.

## 7. THE $C_{2}$-CLUSTER VARIETY AS A SPECIALIZATION OF $\mathcal{H}_{\mathbb{A}}^{13}$

7.1. The cluster variety $X_{C_{2}}$ of type $C_{2}$. In the paper (CD1], inspired by mirror symmetry of log Calabi-Yau surfaces after Gross, Hacking and Keel [GHK], Coughlan and Ducat define the cluster variety of type $C_{2}$ as follows and produces, as weighted complete intersections of their weighted projectivizations, several examples of prime $\mathbb{Q}$-Fano 3-folds $X$ with $\mathrm{ac}_{X}=4$.
Definition 7.1. The cluster variety of type $C_{2}$, denoted by $X_{C_{2}}$, is the affine variety in the 13 -affine space $\mathbb{A}_{C_{2}}$ with coordinates implemented as in

$$
\left(\begin{array}{cccccc}
\theta_{12} & \theta_{23} & \theta_{31} & \theta_{1} & \theta_{2} & \theta_{3} \\
A_{12} & A_{23} & A_{31} & A_{1} & A_{2} & A_{3}
\end{array}\right), \lambda
$$

defined by the following 9 equations:

$$
\left\{\begin{array}{l}
\theta_{i} \theta_{j}=A_{i j} \theta_{i j}+A_{j k} A_{k} A_{k i}  \tag{7.1}\\
\theta_{k i} \theta_{i j}=A_{i} \theta_{i}^{2}+\lambda A_{j k} \theta_{i}+A_{j} A_{j k}^{2} A_{k} \\
\theta_{i} \theta_{j k}=A_{i j} A_{j} \theta_{j}+\lambda A_{k i} A_{i j}+A_{k} A_{k i} \theta_{k}
\end{array}\right.
$$

where $(i, j, k)=(1,2,3),(2,3,1),(3,1,2)$.
7.2. $X_{\mathrm{C}_{2}}$ as a subvariety of $\mathcal{H}_{\mathbb{A}}^{13}$. By direct computations, we may check the following:

Proposition 7.2. The affine variety $\mathcal{H}_{\mathbb{A}}^{13} \cap\left\{p_{121}=p_{112}=p_{211}=0, p_{111}=1\right\}$ coincides with $X_{C_{2}}$ by changing the notation of coordinates as follows:

$$
\begin{aligned}
u_{1} & =\theta_{12}, u_{2}=\theta_{23}, u_{3}=\theta_{31}, \\
\boldsymbol{x}_{1} & =\binom{A_{12}}{\theta_{3}}, \boldsymbol{x}_{2}=\binom{A_{23}}{\theta_{1}}, \boldsymbol{x}_{3}=\binom{A_{31}}{\theta_{2}}, \\
p_{212} & =-A_{1}, p_{221}=-A_{2}, p_{122}=-A_{3}, p_{222}=\lambda,
\end{aligned}
$$

where the l.h.s. are the coordinates of $\mathcal{H}_{\mathbb{A}}^{13}$ and the r.h.s. are those of $X_{C_{2}}$.
By this proposition, we often consider $X_{\mathrm{C}_{2}}$ as a subvariety of $\mathcal{H}_{\mathbb{A}}^{13}$.
7.3. Subvarieties $\mathcal{H}_{\mathbb{A}}^{11}$ and $\mathcal{H}_{\mathbb{A}}^{12}$ of $\mathcal{H}_{\mathbb{A}}^{13}$ related with $X_{C_{2}}$.

Definition 7.3. We set

$$
\begin{aligned}
& \mathcal{H}_{\mathbb{A}}^{12}:=\mathcal{H}_{\mathbb{A}}^{13} \cap\left\{p_{111}=1\right\}, \\
& \mathcal{H}_{\mathbb{A}}^{11}:=\mathcal{H}_{\mathbb{A}}^{12} \cap\left\{p_{121}=1\right\} .
\end{aligned}
$$

Actually, $\mathcal{H}_{\mathbb{A}}^{12} \cap\left\{p_{121}=1\right\}, \mathcal{H}_{\mathbb{A}}^{12} \cap\left\{p_{112}=1\right\}, \mathcal{H}_{\mathbb{A}}^{12} \cap\left\{p_{221}=1\right\}$ are transformed each other by permuting the coordinates $p_{121}, p_{112}, p_{211}$ by the $S_{3}$-action. Therefore, abusing notation, we also denote $\mathcal{H}_{\mathbb{A}}^{12} \cap\left\{p_{112}=1\right\}, \mathcal{H}_{\mathbb{A}}^{12} \cap\left\{p_{221}=1\right\}$ by $\mathcal{H}_{\mathbb{A}}^{11}$.

Note that $X_{\mathrm{C}_{2}}$ is a subvariety of $\mathcal{H}_{\mathbb{A}}^{12}$. Moreover, we can regard $X_{\mathrm{C}_{2}}$ as a specialization of a subvariety of $\mathcal{H}_{\mathbb{A}}^{11}$. Indeed, we can verify $\mathcal{H}_{\mathbb{A}}^{12} \cap\left\{p_{121}=1\right\}$ is isomorphic to $\mathcal{H}_{\mathbb{A}}^{12} \cap\left\{p_{121}=\alpha\right\}(\alpha \neq 0)$. Then $X_{\mathrm{C}_{2}}$ is a specialization of $\mathcal{H}_{\mathbb{A}}^{12} \cap\left\{p_{121}=\alpha, p_{112}=\right.$ $\left.p_{211}=0\right\}$ by $\alpha \rightarrow 0$.

The reason why we consider $\mathcal{H}_{\mathbb{A}}^{11}$ and $\mathcal{H}_{\mathbb{A}}^{12}$ is that, using these, we can generalize some examples of prime $\mathbb{Q}$-Fano 3 -folds obtained from $X_{\mathrm{C}_{2}}$; let us consider the following classes of prime $\mathbb{Q}$-Fano 3-folds of [GRDB]:
(A) No.1397,1405,2427,2511,5052,5305,5410,5516,5963,11222 (10 classes).
(B) No.5530,5970,11437,11455,16339 (5 classes).

We can show directly that positive weights of coordinates are associated to $\mathcal{H}_{\AA}^{12}$ (resp. $\mathcal{H}_{\mathbb{A}}^{11}$ ) by

- the data of [CD2] for the classes in the group (A) (resp. (B)),
- the transformations of the coordinates as in Proposition7.2, and
- the set-up

$$
\left\{\begin{array}{l}
w\left(p_{121}\right):=w\left(p_{122}\right)+w\left(p_{221}\right)-w\left(p_{222}\right),  \tag{7.2}\\
w\left(p_{112}\right):=w\left(p_{122}\right)+w\left(p_{212}\right)-w\left(p_{222}\right), \\
w\left(p_{211}\right):=w\left(p_{212}\right)+w\left(p_{221}\right)-w\left(p_{222}\right) .
\end{array}\right.
$$

(we note that one of $w\left(p_{121}\right), w\left(p_{112}\right)$ or $w\left(p_{211}\right)$ is zero for the group (B), so (7.2) gives suitable weights of coordinates of $\mathcal{H}_{\mathbb{A}}^{11}$ ). We may also directly verify that all the equations of $\mathcal{H}_{\mathbb{P}}^{11}$ and $\mathcal{H}_{\mathbb{P}}^{10}$ in each case are homogeneous with these weights of coordinates. Therefore, by [CD1], we can construct examples of prime $\mathbb{Q}$-Fano threefolds $X$ for the classes in the group (A) (resp. (B)) as weighted complete intersection of $\mathcal{H}_{\mathbb{P}}^{11}$ (resp. $\mathcal{H}_{\mathbb{P}}^{10}$ ). Actually, more general examples are obtained since $X_{C_{2}}$ is a specialization of a subvariety of $\mathcal{H}_{\mathbb{A}}^{11}$ or $\mathcal{H}_{\mathbb{A}}^{12}$ as we see above.

We describe an example of a prime $\mathbb{Q}$-Fano threefold obtained from $\mathcal{H}_{\mathbb{P}}^{11}$.
Example 7.4. Let $X$ be a prime $\mathbb{Q}$-Fano threefold $X \subset \mathbb{P}\left(1^{2}, 3,4^{2}, 5^{3}\right)$ of No. 5052 with three $1 / 5(1,1,4)$-singularities. Based on the data of weights of coordinates of $X_{\mathrm{C}_{2}}$ as in [CD2] and (7.2), we put the following weights of coordinates for $\mathcal{H}_{\mathbb{A}}^{12}$ :

$$
\begin{aligned}
w\left(\boldsymbol{x}_{1}\right) & =w\left(\boldsymbol{x}_{2}\right)=w\left(\boldsymbol{x}_{3}\right)=\binom{3}{4}, \\
w\left(u_{1}\right) & =w\left(u_{2}\right)=w\left(u_{3}\right)=5 \\
w\left(p_{112}\right) & =w\left(p_{121}\right)=w\left(p_{211}\right)=1 \\
w\left(p_{122}\right) & =w\left(p_{212}\right)=w\left(p_{221}\right)=2 \\
w\left(p_{222}\right) & =3
\end{aligned}
$$

Then we obtain a weighted projectivization $\mathcal{H}_{\mathbb{P}}^{11}$ of $\mathcal{H}_{\mathbb{A}}^{12}$ in $\mathbb{P}^{15}\left(1^{3}, 2^{3}, 3^{4}, 4^{3}, 5^{3}\right)$. A general

$$
X:=\mathcal{H}_{\mathbb{P}}^{11} \cap(1) \cap(2)^{3} \cap(3)^{3} \cap(4)
$$

is an example of a prime $\mathbb{Q}$-Fano threefold $X$ of No. 5052 .
By [CD1], an example of such an $X$ is obtained from $X_{\mathrm{C}_{2}}$ but two weight 1 coordinates are missing for $X_{\mathrm{C}_{2}}$, thus it is necessary to take the cone over $X_{\mathrm{C}_{2}}$ with two weight 1 coordinates added. Therefore the example obtained here is more general than one in [CD1].

## 7.4. $\mathcal{M}_{\mathbb{A}}^{8}$ and $\mathcal{S}_{\mathbb{A}}^{6}$ as subvarieties of $X_{\mathrm{C}_{2}}$.

Proposition 7.5. (1) By the isomorphism $\mathbb{A}_{C_{2}} \cap\left\{A_{3}=1\right\} \rightarrow \mathbb{A}_{\mathcal{M}}$ defined by

$$
\begin{align*}
\mathrm{X}_{1} & =\left(\begin{array}{cc}
1 / 2 \lambda & A_{2} \\
-A_{1} & -1 / 2 \lambda
\end{array}\right), \mathrm{X}_{2}=\left(\begin{array}{cc}
\theta_{1} & A_{31} \\
A_{23} & \theta_{2}
\end{array}\right), \\
\mathrm{W} & =\left(\begin{array}{cc}
\theta_{3}+1 / 2 \lambda A_{12} & \theta_{23} \\
-\theta_{31} & -\theta_{3}-1 / 2 \lambda A_{12}
\end{array}\right),  \tag{7.3}\\
y & =\theta_{12}, z=A_{12},
\end{align*}
$$

the affine variety $\mathcal{M}_{\mathbb{A}}^{8}$ is the image of $X_{\mathrm{C}_{2}}^{I}:=X_{\mathrm{C}_{2}} \cap\left\{A_{3}=1\right\}$.
If we put the positive weights to the coordinates of $\mathbb{A}_{C_{2}} \cap\left\{A_{3}=1\right\}$ such that all the equations of $X_{\mathrm{C}_{2}}^{I}$ are homogeneous, then we can define the positive weights to the coordinates of $\mathbb{A}_{\mathcal{M}}$ by the equalities (7.3) and the isomorphism $X_{\mathrm{C}_{2}}^{I} \rightarrow \mathcal{M}_{\mathbb{A}}^{8}$ becomes homogeneous.
(2) Let $\mathbb{A}_{\mathbb{S}}^{\prime}$ be the affine space obtained from $\mathbb{A}_{\mathcal{S}}$ by adding one coordinate $\sigma_{0}$. By the isomorphism $\mathbb{A}_{\mathbb{C}_{2}} \cap\left\{A_{3}=1, A_{1}=-1\right\} \rightarrow \mathbb{A}_{\mathcal{S}}$ defined by

$$
\begin{align*}
\mathrm{S} & =\left(\begin{array}{ccc}
\theta_{12} & -\theta_{1}+1 / 2 \lambda A_{23} & A_{31}-1 / 2 \lambda \theta_{2} \\
& -\theta_{31} & \theta_{3}+1 / 2 \lambda A_{12} \\
& & -\theta_{23}
\end{array}\right), \boldsymbol{\sigma}=\left(\begin{array}{c}
A_{12} \\
\theta_{2} \\
A_{23}
\end{array}\right),  \tag{7.4}\\
t & =-1 / 4 \lambda^{2}-A_{2}, \sigma_{0}=\lambda,
\end{align*}
$$

the cone $\mathcal{S}_{\mathbb{A}}^{7}$ over $\mathcal{S}_{\mathbb{A}}^{6}$ with the coordinate $\sigma_{0}$ added is the image of $X_{\mathrm{C}_{2}}^{I I}:=X_{\mathrm{C}_{2}} \cap$ $\left\{A_{3}=1, A_{1}=-1\right\}$.

If we put the positive weights to the coordinates of $\mathbb{A}_{C_{2}} \cap\left\{A_{3}=1, A_{1}=\right.$ $-1\}$ such that all the equations of $X_{\mathrm{C}_{2}}^{I I}$ are homogeneous, then we can define the positive weights to the coordinates of $\mathbb{A}_{s}$ by the equality (7.4) and the isomorphism $X_{\mathrm{C}_{2}}^{I I} \rightarrow \mathcal{S}_{\mathbb{A}}^{7}$ becomes homogeneous.

Proof. By direct calculations, we see that the conditions of the weights of coordinates so that the equations (7.1) are homogeneous are reduced to the following if all the coordinates are nonzero:

$$
\begin{aligned}
w\left(\theta_{1}\right) & =w\left(A_{23}\right)+w\left(A_{3}\right)+w\left(A_{31}\right)-w\left(t_{2}\right), w\left(\theta_{3}\right)=w\left(A_{1}\right)+w\left(A_{12}\right)+w\left(A_{31}\right)-w\left(t_{2}\right), \\
w\left(A_{2}\right) & =w\left(A_{1}\right)+w\left(A_{3}\right)+2 w\left(A_{31}\right)-2 w\left(t_{2}\right) \\
w\left(\theta_{12}\right) & =-w\left(A_{12}\right)+w\left(A_{23}\right)+w\left(A_{3}\right)+w\left(A_{31}\right) \\
w\left(\theta_{23}\right) & =w\left(A_{1}\right)+w\left(A_{12}\right)-w\left(A_{23}\right)+w\left(A_{31}\right) \\
w\left(\theta_{31}\right) & =w\left(A_{1}\right)+w\left(A_{12}\right)+w\left(A_{23}\right)+w\left(A_{3}\right)+w\left(A_{31}\right)-2 w\left(t_{2}\right), \\
w(\lambda) & =w\left(A_{1}\right)+w\left(A_{3}\right)+w\left(A_{31}\right)-w\left(t_{2}\right)
\end{aligned}
$$

For the assertion (1), we have only to check that $\theta_{3}+1 / 2 \lambda A_{12}$ is weighted homogeneous, namely, it holds that $w\left(\theta_{3}\right)=w(\lambda)+w\left(A_{12}\right)$. This is easily seen by the above conditions of the weights since $w\left(A_{3}\right)=0$.

For the assertion (2), we have only to check that $-\theta_{1}+1 / 2 \lambda A_{23}, A_{31}-1 / 2 \lambda \theta_{2}$, $\theta_{3}+1 / 2 \lambda A_{12}$ and $-1 / 4 \lambda^{2}-A_{2}$ are weighted homogeneous, namely, it holds that $w\left(\theta_{1}\right)=w(\lambda)+w\left(A_{23}\right), w(\lambda)+w\left(\theta_{2}\right)=w\left(A_{31}\right), w\left(\theta_{3}\right)=w(\lambda)+w\left(A_{12}\right)$, and $2 w(\lambda)=w\left(A_{2}\right)$. These are again easily seen by the above conditions of the weights since $w\left(A_{1}\right)=w\left(A_{3}\right)=0$.
7.5. $\mathcal{H}_{\mathbb{A}}^{12}, \mathcal{H}_{\mathbb{A}}^{11}, \mathcal{M}_{\mathbb{A}}^{8}$ or $\mathcal{S}_{\mathbb{A}}^{6}$ as key varieties. By the above considerations in Section 7 and the result of [CD1, CD2], we have the following:
Corollary 7.6. There exist quasi-smooth prime $\mathbb{Q}$-Fano 3 -folds $X$ with ac ${ }_{X}=4$ for the 109 numerical data of [GRDB] such that they are obtained as weighted complete intersections of weighted projectivizations $\mathcal{H}_{\mathbb{P}}^{12}, \mathcal{H}_{\mathbb{P}}^{11}, \mathcal{H}_{\mathbb{P}}^{10}, \mathcal{M}_{\mathbb{P}}^{7}$ or $\mathcal{S}_{\mathbb{P}}^{5}$ of $\mathcal{H}_{\mathbb{A}}^{13}, \mathcal{H}_{\mathbb{A}}^{12}, \mathcal{H}_{\mathbb{A}}^{11}, \mathcal{M}_{\mathbb{A}}^{8}$ or $\mathcal{S}_{\mathbb{A}}^{6}$ respectively or suitable weighted cones of them. Precise information about which $X$ can be constructed from which key varieties is as in the following table 1

| key variety | \# of classes |
| :---: | :---: |
| $\mathcal{H}_{\mathbb{P}}^{12}$ | 1 |
| $\mathcal{H}_{\mathbb{P}}^{11}$ | 10 |
| $\mathcal{H}_{\mathbb{P}}^{10}$ | 5 |
| $\mathcal{M}_{\mathbb{P}}^{8}$ | 32 |
| $\mathcal{S}_{\mathbb{P}}^{5}$ or $\mathfrak{S}_{\mathbb{P}}^{6}$ | 61 |

TABLE 1. prime $\mathbb{Q}$-Fano 3-folds obtained from $\mathcal{H}_{\mathbb{A}}^{13}$
