

# ON THE MAPPING CLASS GROUP ACTION ON THE HOMOLOGY OF SURFACE COVERS

**ABSTRACT.** Let  $\phi \in \text{Mod}(\Sigma)$  be an arbitrary element of the mapping class group of a closed orientable surface  $\Sigma$  of genus at least 2. For any characteristic cover  $\tilde{\Sigma} \rightarrow \Sigma$  one can consider the linear subspace  $H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \subseteq H_1(\tilde{\Sigma}, \mathbb{Q})$  consisting of all homology classes with finite  $\phi$ -orbit. We prove that  $\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi$  can be arbitrary large for any fixed  $\phi \in \text{Mod}(\Sigma)$ .

## 1. INTRODUCTION

**1.1. Result.** Let  $\Sigma$  be a compact orientable surface of genus at least 2 without boundary. Let  $\text{Mod}(\Sigma)$  be the *mapping class group* of  $\Sigma$ , defined by  $\text{Mod}(\Sigma) = \pi_0(\text{Homeo}^+(\Sigma))$ , where  $\text{Homeo}^+(\Sigma)$  is the group of orientation-preserving homeomorphisms of  $\Sigma$ . Let  $p : \tilde{\Sigma} \rightarrow \Sigma$  be a finite characteristic cover, i.e.  $p_*(\pi_1(\tilde{\Sigma})) \triangleleft \pi_1(\Sigma)$  is a finite index characteristic subgroup. Then the action of  $\text{Mod}(\Sigma)$  on  $H_1(\tilde{\Sigma}, \mathbb{Q})$  is well-defined up to the action of the finite deck group  $\pi_1(\Sigma)/p_*(\pi_1(\tilde{\Sigma}))$ . Therefore, for each  $v \in H_1(\tilde{\Sigma}, \mathbb{Q})$  one can ask about finiteness of its orbit with respect to the action of  $\text{Mod}(\Sigma)$  and its subgroups.

For each  $\phi \in \text{Mod}(\Sigma)$  we consider the linear subspace  $H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \subseteq H_1(\tilde{\Sigma}, \mathbb{Q})$  consisting of all homology classes with finite  $\phi$ -orbit. The main result of this paper is as follows.

**Theorem 1.1.** *Let  $\phi \in \text{Mod}(\Sigma)$  be any element. Then there exist finite characteristic covers  $\tilde{\Sigma} \rightarrow \Sigma$  with arbitrary large  $\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi$ .*

In view of Theorem 1.1, it is natural to ask the following question, to which the author does not know the answer.

**Question 1.2.** Let  $\phi \in \text{Mod}(\Sigma)$  be any element and let

$$\cdots \rightarrow \tilde{\Sigma}_k \rightarrow \tilde{\Sigma}_{k-1} \rightarrow \cdots \rightarrow \tilde{\Sigma}_1 \rightarrow \Sigma$$

be any infinite tower of finite characteristic covers of  $\Sigma$  such that  $\cap_{k=1}^\infty \pi_1(\tilde{\Sigma}_k) = \{1\}$ . Is it true that  $\lim_{k \rightarrow \infty} \dim H_1^{f.o.}(\tilde{\Sigma}_k, \mathbb{Q})^\phi = \infty$ ?

Note that the usual space of  $\phi$ -invariants  $H_1(\tilde{\Sigma}, \mathbb{Q})^\phi \subseteq H_1(\tilde{\Sigma}, \mathbb{Q})$  is well-defined after fixing a base point  $x_0 \in \tilde{\Sigma}$ . Indeed, there is a well-defined action of  $\text{Mod}(\Sigma) \cong \text{Out}^+(\pi_1(\Sigma, p(x_0)))$  on the characteristic subgroup  $p(\pi_1(\tilde{\Sigma}, x_0)) \triangleleft \pi_1(\Sigma, p(x_0))$ , and we

have a canonical isomorphism  $H_1(\pi_1(\tilde{\Sigma}, x_0), \mathbb{Q}) \cong H_1(\tilde{\Sigma}, \mathbb{Q})$ . The author does not know if the statement of Theorem 1.1 remains true after replacing  $\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi$  by  $\dim H_1(\tilde{\Sigma}, \mathbb{Q})^\phi$  in the above setting.

**1.2. History.** The (virtual) representations of the group  $\text{Mod}(\Sigma)$  in the symplectic group  $\text{Sp}(H_1(\tilde{\Sigma}, \mathbb{Q}))$  for regular covers  $\tilde{\Sigma} \rightarrow \Sigma$  are called *Prym representations*. This notion is a natural generalisation of the standard symplectic representation of  $\text{Mod}(\Sigma)$  in  $\text{Sp}(H_1(\Sigma, \mathbb{Q}))$  and was initially introduced by Looijenga [20] for the case of abelian covers. In [8], Grunewald, Larsen, Lubotzky, and Malestein constructed a lot of arithmetic quotients of the mapping class group using Prym representations.

In 2013, Putman and Wieland [23] stated the following conjecture, which is one of the central open questions about Prym representations (the similar question for graph covers was studied by Farb and Hensel [6]).

**Conjecture 1.3.** [23, Conjecture 1.2] *Let  $\tilde{\Sigma} \rightarrow \Sigma$  be a finite characteristic cover. Then for each nonzero homology class  $v \in H_1(\tilde{\Sigma}, \mathbb{Q})$  the  $\text{Mod}(\Sigma)$ -orbit of  $v$  is infinite.*

It turns out [23, Theorem C] that Conjecture 1.3 is essentially equivalent to the classical Ivanov's conjecture [11] on vanishing of the first virtual Betti number of the mapping class group (see also [15, Problem 2.11.A]). It is also important to note that it is an open question whether  $\text{Mod}(\Sigma)$  has Kazhdan's property (T), which is a stronger condition than vanishing of the first virtual Betti number. In this context, Theorem 1.1 in particular claims that it is not possible to provide a counterexample to Conjecture 1.3 using the action of only one element  $\phi \in \text{Mod}(\Sigma)$ .

Besides general questions on Prym representations, it is natural to study  $\phi$ -action on  $H_1(\tilde{\Sigma}, \mathbb{Q})$  for a fixed element  $\phi \in \text{Mod}(\Sigma)$ . Koberda [16, 17] showed that for every nontrivial  $\phi \in \text{Mod}(\Sigma)$  there exists a finite characteristic cover  $\tilde{\Sigma} \rightarrow \Sigma$  such that each lift of  $\phi$  acts nontrivially on  $H_1(\tilde{\Sigma}, \mathbb{Q})$ . Liu [21] proved the well-known McMullen's conjecture claiming that every pseudo-Anosov  $\phi \in \text{Mod}(\Sigma)$  lifts to some finite cover  $\tilde{\Sigma} \rightarrow \Sigma$  with the spectral radius of the induced action on  $H_1(\tilde{\Sigma}, \mathbb{Q})$  strictly greater than one (see also [13]). Using a completely different approach, Hadari [14] proved the similar result for the surfaces with at least one boundary component. These results imply that for any infinite order element  $\phi \in \text{Mod}(\Sigma)$  there exists a finite cover  $\tilde{\Sigma} \rightarrow \Sigma$  such that  $\phi$  lifts to a mapping class acting on  $H_1(\tilde{\Sigma}, \mathbb{Q})$  with infinite order. In some sense, Theorem 1.1 answers the opposite question to this.

One more important aspect of Prym representations is *simple closed curve homology*  $H_1^{scc}(\tilde{\Sigma}, \mathbb{Q}) \subseteq H_1(\tilde{\Sigma}, \mathbb{Q})$  defined as the span of the homology classes of all loops on  $\tilde{\Sigma}$  projecting to multiples of simple curves on  $\Sigma$ ; this definition was initially mentioned by Farb and Hensel [5]. There exist branched (Malestein and Putman, [22]) and unbranched (Klukowski, [18]) covers  $\tilde{\Sigma} \rightarrow \Sigma$  with  $H_1^{scc}(\tilde{\Sigma}, \mathbb{Q}) \neq H_1(\tilde{\Sigma}, \mathbb{Q})$ . Recently, Boggi, Putman and Salter [3] proved that  $H_1^{scc}(\tilde{\Sigma}, \mathbb{Q})$  is a symplectic subspace of  $H_1(\tilde{\Sigma}, \mathbb{Q})$ . Moreover, they showed that the analogue of Conjecture 1.3 is true for  $H_1^{scc}(\tilde{\Sigma}, \mathbb{Q})$ . Namely, for any characteristic cover  $\tilde{\Sigma} \rightarrow \Sigma$  and for each nonzero homology class  $v \in H_1^{scc}(\tilde{\Sigma}, \mathbb{Q})$  the  $\text{Mod}(\Sigma)$ -orbit of  $v$  is infinite.

In view of [3] and Theorem 1.1, it is natural to ask if  $\dim(H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \cap H_1^{sc}(\tilde{\Sigma}, \mathbb{Q}))$  can be arbitrary large for a fixed  $\phi \in \text{Mod}(\Sigma)$ . For periodic  $\phi$  this claim is straightforward, and for reducible  $\phi$  this more or less immediately follows from our proof (see Lemmas 3.2 and 3.3). However, the author does not know if it is true for pseudo-Anosov elements  $\phi \in \text{Mod}(\Sigma)$ .

**1.3. Outline of the paper.** Our proof of Theorem 1.1 uses the Nielsen-Thurston classification. We consider periodic, reducible and pseudo-Anosov elements  $\phi$  separately. If  $\phi$  is periodic then  $H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi = H_1(\tilde{\Sigma}, \mathbb{Q})$  and there is nothing to prove. Reducible and pseudo-Anosov classes are considered in Sections 3 and 4, respectively, after some preliminaries given in Section 2. For reducible  $\phi$  we explicitly construct covers  $\tilde{\Sigma} \rightarrow \Sigma$  with large  $\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi$ . The proof in the pseudo-Anosov case is based on the deep theorem of Agol [2] on virtual Betti numbers of hyperbolic 3-manifolds.

## 2. PRELIMINARIES

First let us recall the Nielsen-Thurston classification [24] (see also [7, Theorem 13.2]) of the mapping class group elements. Let  $\phi \in \text{Mod}(\Sigma)$  be an arbitrary element. Then precisely one of the following statements holds.

- (1)  $\phi$  is periodic, i.e.  $\phi^n = \text{id}$  for some integer  $n \geq 1$ .
- (2)  $\phi$  is reducible, i.e.  $\phi$  has infinite order and  $\phi^n(\alpha) = \alpha$  for some integer  $n \geq 1$  and some essential simple closed curve  $\alpha$  on  $\Sigma$ .
- (3)  $\phi$  is pseudo-Anosov, see [7, Section 13.2.3] for the standard definition.

For any  $\phi \in \text{Mod}(\Sigma)$  we can define the mapping torus  $M_\phi$  of  $\phi$ , which is a closed orientable 3-manifold. Then we have the following classical result of Thurston [24], which we will use instead of the standard definition of pseudo-Anosov elements.

**Theorem 2.1.** [7, Theorem 13.4] *Let  $\phi \in \text{Mod}(\Sigma)$  be any element. Then  $M_\phi$  admits a hyperbolic metric if and only if  $\phi$  is pseudo-Anosov.*

In this section we also prove some facts about the action of the mapping class group on surface covers. A first step is to define  $H_1^{f.o.}(\Sigma, \mathbb{Q})^\phi$  for all finite regular covers, not only for characteristic ones.

Let  $\tilde{\Sigma} \rightarrow \Sigma$  be a finite regular cover and let  $K = \pi_1(\tilde{\Sigma}) \triangleleft \pi_1(\Sigma)$  be its fundamental group. Then an element  $\phi \in \text{Mod}(\Sigma)$  lifts to  $\text{Mod}(\tilde{\Sigma})$  if and only if  $K$  is invariant under the action of  $\phi \in \text{Mod}(\Sigma) \cong \text{Out}(\pi_1(\Sigma))$ . However, for every  $\phi \in \text{Mod}(\Sigma)$  there exists  $k > 0$  such that  $K$  is  $\phi^k$ -invariant, so the action of  $\phi^k$  on  $H_1(K, \mathbb{Q})$  is well defined. Therefore, one can consider the linear subspace  $H_1^{f.o.}(K, \mathbb{Q})^\phi \subseteq H_1(K, \mathbb{Q})$  consisting of all homology classes with finite  $\phi^k$ -orbit.

In this case  $\phi^k$  also has a lift to  $\text{Mod}(\tilde{\Sigma})$  defined up to the action of the deck group  $\pi_1(\Sigma)/K$ . Therefore, the action of  $\phi^k$  on  $H_1(\tilde{\Sigma}, \mathbb{Q})$  is also defined up to the action of the

finite deck group, and we similarly define the linear subspace  $H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \subseteq H_1(\tilde{\Sigma}, \mathbb{Q})$  consisting of all homology classes with finite  $\phi^k$ -orbit. This definition of  $H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi$  agrees with the one for characteristic covers. We have  $H_1^{f.o.}(K, \mathbb{Q})^\phi \cong H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi$  (not canonically).

Note that these definitions do not depend on the choice of  $k$  since the property of orbit (in)finiteness is preserved under passing to finite index subgroups. By the same reason we have  $H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi = H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^{\phi^n}$  for any finite regular cover  $\tilde{\Sigma} \rightarrow \Sigma$  and any integer  $n \neq 0$ .

The next lemma claims that the dimension of  $H_1^{f.o.}(K, \mathbb{Q})^\phi$  can not be decreased via passing to finite index subgroups. A related statement in a different setting appears in [19, Lemma 2.3].

**Lemma 2.2.** *Let  $K', K \triangleleft \pi_1(\Sigma)$  be finite index normal subgroups such that  $K' \triangleleft K$ . Then  $\dim H_1^{f.o.}(K', \mathbb{Q})^\phi \geq \dim H_1^{f.o.}(K, \mathbb{Q})^\phi$ .*

For a group  $G$  acting on a vector space  $V$ , we denote by  $V^G$  and  $V_G$  the spaces of invariants and coinvariants, respectively. Lemma 2.2 follows from the following general algebraic fact.

**Fact 2.3.** Let  $G$  be a discrete group and let  $V, W$  be finite dimensional vector spaces over  $\mathbb{Q}$  equipped with a  $G$ -action. Then for any surjective  $G$ -equivariant map  $f : V \rightarrow W$  its restriction to  $G$ -invariants  $f|_{V^G} : V^G \rightarrow W^G$  is also surjective.

*Proof.* We have the canonical isomorphisms  $V^G \cong V_G$  and  $W^G \cong W_G$  induced by the inclusions  $V^G \hookrightarrow V$  and  $W^G \hookrightarrow W$ . The induced map on coinvariants  $f' : V_G \rightarrow W_G$  is surjective since  $f$  is surjective. Therefore,  $f|_{V^G}$  can be considered as a composite map

$$f|_{V^G} : V^G \cong V_G \rightarrow W_G \cong W^G,$$

which is surjective. □

*Proof of Lemma 2.2.* First let us choose an integer  $k > 0$  such that both  $K$  and  $K'$  are  $\phi^k$ -invariant. Then the action of  $\phi^k$  on  $H_1(K, \mathbb{Q})$  is well-defined, so one can consider the subspaces  $H_1(K, \mathbb{Q})^{\phi^{kn}} \subseteq H_1(K, \mathbb{Q})$  of  $\phi^{kn}$ -invariants for  $n \in \mathbb{Z}$ . Since  $H_1^{f.o.}(K, \mathbb{Q})^\phi$  is finite dimensional, it follows that there exists an integer  $n > 1$  such that  $H_1^{f.o.}(K, \mathbb{Q})^\phi = H_1(K, \mathbb{Q})^{\phi^{kn}}$ . Indeed, it suffices to take  $n$  equal to the least common multiple of the  $\phi^k$ -orbit cardinalities of basis elements of  $H_1^{f.o.}(K, \mathbb{Q})^\phi$  (for some basis).

Let  $\iota : K' \hookrightarrow K$  be the inclusion map. Since  $\iota$  comes from a finite covering of surfaces, then the induced map  $\iota_* : H_1(K', \mathbb{Q}) \rightarrow H_1(K, \mathbb{Q})$  is surjective. Hence Fact 2.3 applied to the map  $\iota_*$  and the group  $\mathbb{Z}$  acting by powers of  $\phi^{kn}$  implies that we have the surjection  $H_1(K', \mathbb{Q})^{\phi^{kn}} \rightarrow H_1(K, \mathbb{Q})^{\phi^{kn}}$ . Since

$$H_1(K', \mathbb{Q})^{\phi^{kn}} \subseteq H_1^{f.o.}(K', \mathbb{Q})^\phi,$$

we obtain

$$\dim H_1^{f.o.}(K', \mathbb{Q})^\phi \geq \dim H_1(K', \mathbb{Q})^{\phi^{kn}} \geq \dim H_1(K, \mathbb{Q})^{\phi^{kn}} = \dim H_1^{f.o.}(K, \mathbb{Q})^\phi.$$

This concludes the proof. □

We obtain the following corollary, which allows us to replace characteristic covers in the statement of Theorem 1.1 by regular ones.

**Corollary 2.4.** *Let  $K \triangleleft \pi_1(\Sigma)$  be a finite index normal subgroup. Then there exists a finite index characteristic subgroup  $K' \triangleleft \pi_1(\Sigma)$  such that  $K' \triangleleft K$  and  $\dim H_1^{f.o.}(K', \mathbb{Q})^\phi \geq \dim H_1^{f.o.}(K, \mathbb{Q})^\phi$ .*

*Proof.* Since  $K$  has finite index in  $\pi_1(\Sigma)$ , then there exists a finite index characteristic subgroup  $K' \triangleleft \pi_1(\Sigma)$  such that  $K' \triangleleft K$ . Then by Lemma 2.2 we have  $\dim H_1^{f.o.}(K', \mathbb{Q})^\phi \geq \dim H_1^{f.o.}(K, \mathbb{Q})^\phi$ .  $\square$

### 3. REDUCIBLE CASE

In this section we prove Theorem 1.1 for a reducible  $\phi$ . In this case we have  $\phi^k(\alpha) = \alpha$  for some integer  $k > 1$  and some essential simple closed curve  $\alpha$  on  $\Sigma$ . We consider the cases of nonseparating and separating curves  $\alpha$  separately. In both cases we explicitly construct regular covers  $\tilde{\Sigma} \rightarrow \Sigma$  with  $\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi$  bounded from below.

By a simple closed curve we mean a curve without orientation unless explicitly stated otherwise. For an oriented simple closed curve  $\alpha$  on  $\Sigma$  we denote by  $[\alpha] \in H_1(\Sigma, \mathbb{Q})$  its homology class. First we need the following result.

**Lemma 3.1.** *Let  $\phi \in \text{Mod}(\Sigma)$  and let  $\alpha$  be a simple closed curve such that  $\phi(\alpha) = \alpha$ . Let  $p : \tilde{\Sigma} \rightarrow \Sigma$  be a finite regular cover. Denote by  $\tilde{\alpha}_1, \dots, \tilde{\alpha}_d$  all lifts of (multiples of)  $\alpha$  to simple closed curves on  $\tilde{\Sigma}$ . Then*

$$\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \geq \dim \text{span}\langle [\tilde{\alpha}_1], \dots, [\tilde{\alpha}_d] \rangle_{\mathbb{Q}}$$

*after choosing arbitrary orientations on  $\tilde{\alpha}_1, \dots, \tilde{\alpha}_d$ , where the span on the right hand side is taken inside  $H_1(\tilde{\Sigma}, \mathbb{Q})$ .*

*Proof.* Let us show that

$$\text{span}\langle [\tilde{\alpha}_1], \dots, [\tilde{\alpha}_d] \rangle_{\mathbb{Q}} \subseteq H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi. \quad (1)$$

Take an integer  $k$  such that  $\phi^k$  lifts to  $\text{Mod}(\tilde{\Sigma})$ . For each  $i = 1, \dots, d$  we have

$$p(\phi^k(\tilde{\alpha}_i)) = \phi^k(p(\tilde{\alpha}_i)) = \phi^k(\alpha) = \alpha,$$

so we obtain  $\phi^k(\tilde{\alpha}_i) \in \{\tilde{\alpha}_1, \dots, \tilde{\alpha}_d\}$  and hence  $\phi^k([\tilde{\alpha}_i]) \in \{\pm[\tilde{\alpha}_1], \dots, \pm[\tilde{\alpha}_d]\}$ . Therefore, the  $\phi^k$ -orbit of  $[\tilde{\alpha}_i]$  is finite. Since the space  $\text{span}\langle [\tilde{\alpha}_1], \dots, [\tilde{\alpha}_d] \rangle_{\mathbb{Q}}$  has a basis consisting of the the homology classes  $[\tilde{\alpha}_i]$  with finite  $\phi$ -orbits, then (1) follows. This immediately implies the claim of the lemma.  $\square$

Let us consider the case where some nonzero power of  $\phi \in \text{Mod}(\Sigma)$  stabilizes a nonseparating curve  $\alpha$  on  $\Sigma$ . Since  $H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi = H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^{\phi^k}$  for any integer  $k \neq 0$ , we can replace  $\phi$  by  $\phi^k$  and assume that  $\phi(\alpha) = \alpha$ .

**Lemma 3.2.** *Let  $\phi \in \text{Mod}(\Sigma)$  be such that there exists a nonseparating simple closed curve  $\alpha$  with  $\phi(\alpha) = \alpha$  and let  $N > 0$  be an integer. Then there exists a regular finite cover  $\tilde{\Sigma} \rightarrow \Sigma$  with  $\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \geq N$ .*

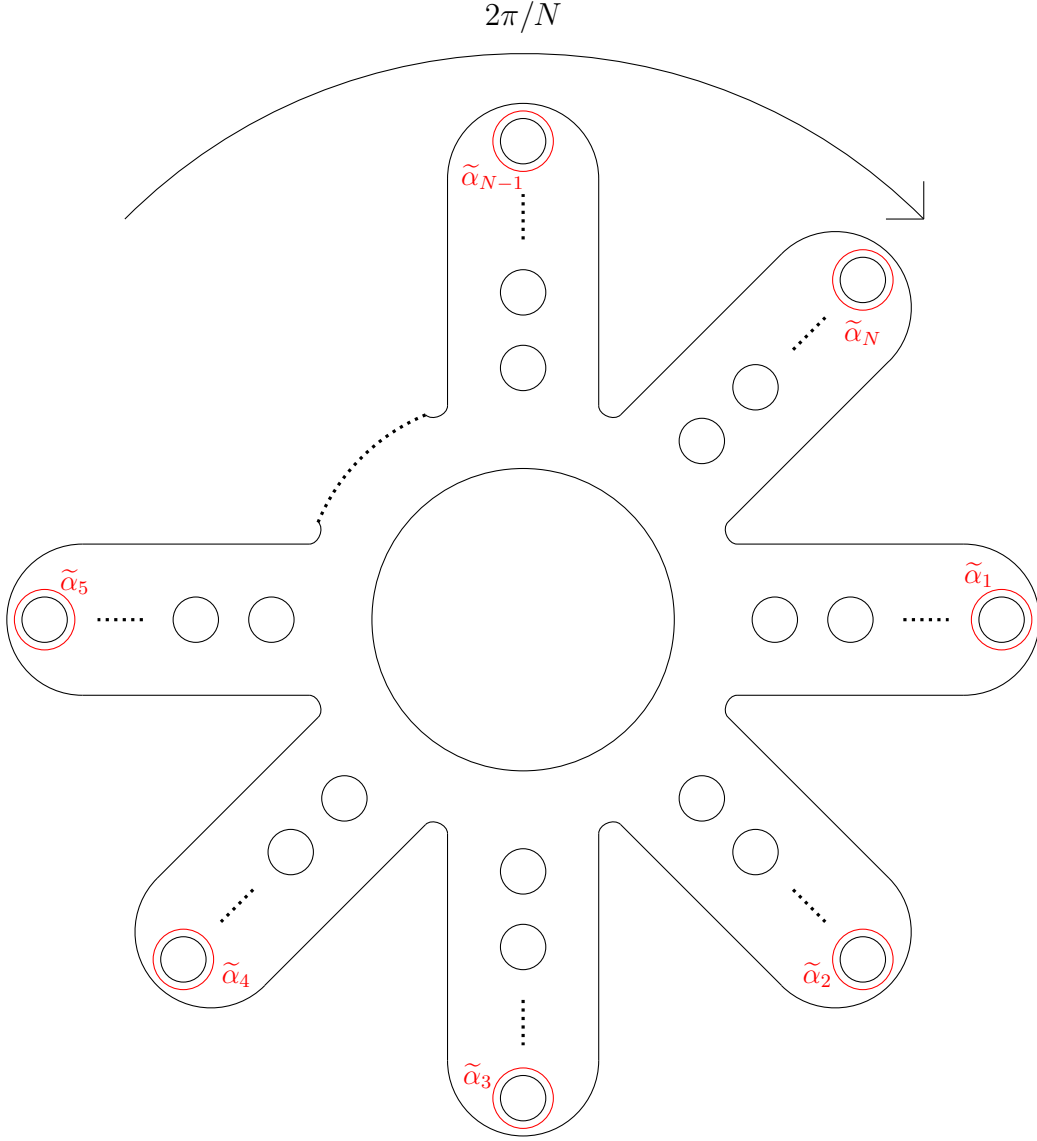


FIGURE 1. The  $(\mathbb{Z}/N\mathbb{Z})$ -action on  $\tilde{\Sigma}$  and the curves  $\tilde{\alpha}_1, \dots, \tilde{\alpha}_N$ .

*Proof.* Let  $g \geq 2$  be the genus of  $\Sigma$ . Consider the surface  $\tilde{\Sigma}$  of genus  $1 + N(g - 1)$  shown in Fig. 1, consisting of the connected sum of  $N$  subsurfaces of genus  $g - 1$  and the torus. The group  $\mathbb{Z}/N\mathbb{Z}$  acts on  $\tilde{\Sigma}$  by rotations and we obtain a finite regular covering  $p : \tilde{\Sigma} \rightarrow \Sigma' = \tilde{\Sigma}/(\mathbb{Z}/N\mathbb{Z})$ .

Let us fix  $N$  curves  $\tilde{\alpha}_1, \dots, \tilde{\alpha}_N$  on  $\tilde{\Sigma}$  as shown in Fig. 1. Note that all these curves belong to the same  $(\mathbb{Z}/N\mathbb{Z})$ -orbit, let us choose orientations on these curves agreed with this action. Since the surface  $\tilde{\Sigma} \setminus \cup\{\tilde{\alpha}_1, \dots, \tilde{\alpha}_N\}$  is connected, it follows that the homology classes  $[\tilde{\alpha}_1], \dots, [\tilde{\alpha}_N] \in H_1(\Sigma, \mathbb{Q})$  are linearly independent. Hence we obtain

$$\dim \text{span}\langle [\tilde{\alpha}_1], \dots, [\tilde{\alpha}_N] \rangle_{\mathbb{Q}} = N.$$

Denote  $\alpha' = p(\tilde{\alpha}_1)$ . Note that  $\alpha'$  is a nonseparating simple closed curve on  $\Sigma'$  and  $p(\tilde{\alpha}_i) = \alpha'$  for all  $i = 1, \dots, N$ . Since all nonseparating simple closed curves on  $\Sigma$  are  $\text{Mod}(\Sigma)$ -equivalent, one can choose a homeomorphism  $\eta : \Sigma' \cong \Sigma$  such that  $\eta(\alpha') = \alpha$ . We obtain the covering  $\eta \circ p : \tilde{\Sigma} \rightarrow \Sigma$  such that  $\tilde{\alpha}_1, \dots, \tilde{\alpha}_N$  are the lifts of  $\alpha$ . By Lemma 3.1 we have

$$\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \geq \dim \text{span}\langle [\tilde{\alpha}_1], \dots, [\tilde{\alpha}_N] \rangle_{\mathbb{Q}} = N,$$

which concludes the proof.  $\square$

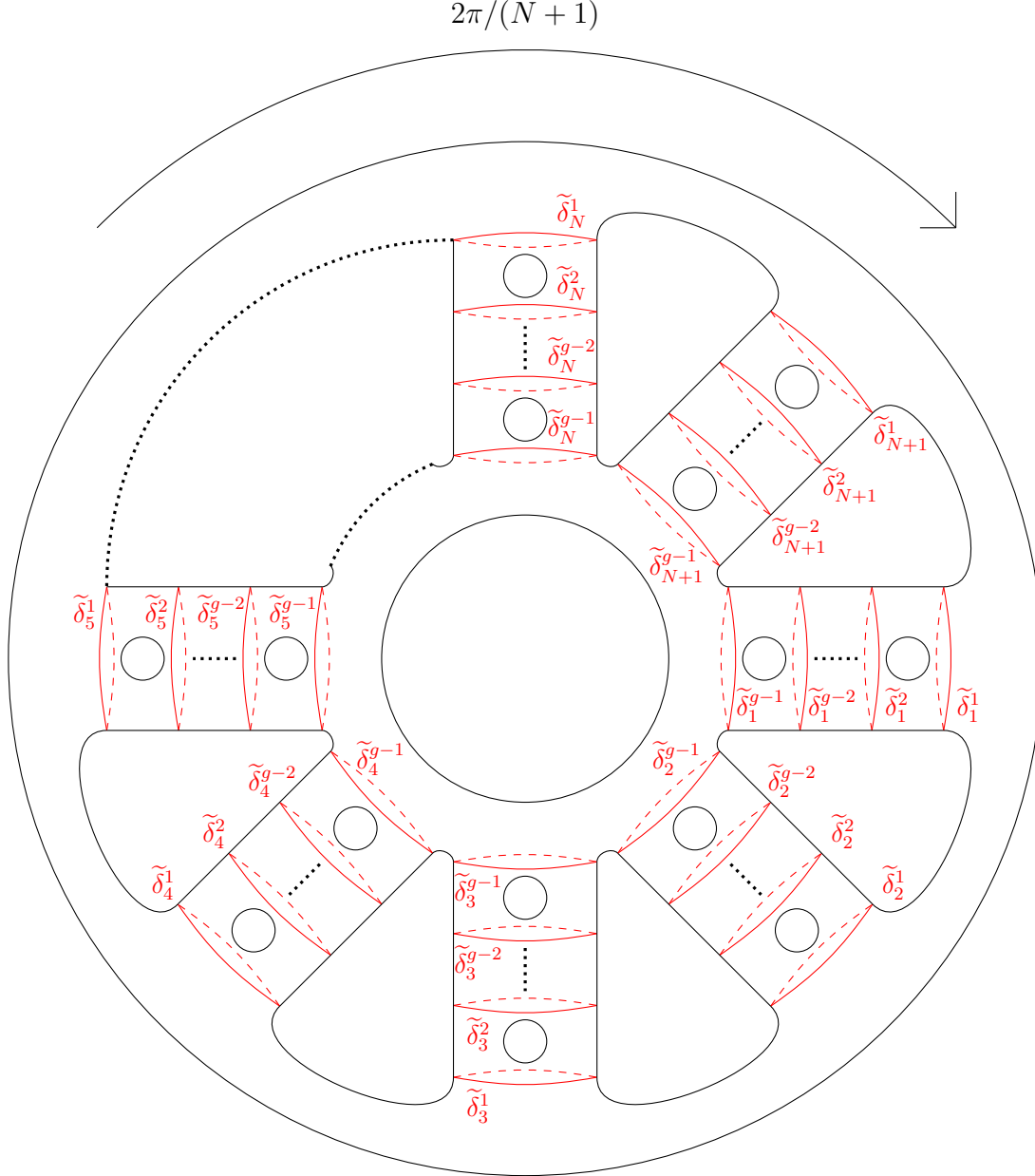


FIGURE 2. The  $(\mathbb{Z}/(N+1)\mathbb{Z})$ -action on  $\tilde{\Sigma}$  and the curves  $\tilde{\delta}_i^j$ .

Now we consider the case where some nonzero power of  $\phi \in \text{Mod}(\Sigma)$  stabilizes a separating curve  $\delta$  on  $\Sigma$ . Similarly, we can replace  $\phi$  by its power and assume that  $\phi(\delta) = \delta$ .

**Lemma 3.3.** *Let  $\phi \in \text{Mod}(\Sigma)$  be such that there exists a separating simple closed curve  $\delta$  with  $\phi(\delta) = \delta$  and let  $N > 0$  be an integer. Then there exists a regular finite cover  $\tilde{\Sigma} \rightarrow \Sigma$  with  $\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \geq N$ .*

*Proof.* Let  $g \geq 2$  be the genus of  $\Sigma$ . Consider the surface  $\tilde{\Sigma}$  of genus  $1 + (N+1)(g-1)$  shown in Fig. 2, consisting two tori connected by  $N+1$  subsurfaces of genus  $g-2$ . The group  $\mathbb{Z}/(N+1)\mathbb{Z}$  acts on  $\tilde{\Sigma}$  by rotations and we obtain a finite regular covering  $p: \tilde{\Sigma} \rightarrow \Sigma' = \tilde{\Sigma}/(\mathbb{Z}/(N+1)\mathbb{Z})$ .

For each  $j = 1, \dots, g-1$  let us fix  $N+1$  curves  $\tilde{\delta}_1^j, \dots, \tilde{\delta}_{N+1}^j$  on  $\tilde{\Sigma}$  as shown in Fig. 2. Note that for a fixed  $j$  all these curves belong to the same  $(\mathbb{Z}/(N+1)\mathbb{Z})$ -orbit, let us choose orientations on these curves agreed with this action. Since the surface  $\tilde{\Sigma} \setminus \cup\{\tilde{\delta}_1^j, \dots, \tilde{\delta}_N^j\}$  is connected, it follows that the homology classes  $[\tilde{\delta}_1^j], \dots, [\tilde{\delta}_N^j] \in H_1(\tilde{\Sigma}, \mathbb{Q})$  are linearly independent for each  $j$ . One can easily check that  $\tilde{\Sigma} \setminus \cup\{\tilde{\delta}_1^j, \dots, \tilde{\delta}_{N+1}^j\}$  is not connected, so

$$\dim \text{span}\langle [\tilde{\delta}_1^j], \dots, [\tilde{\delta}_{N+1}^j] \rangle_{\mathbb{Q}} = N$$

for any  $j = 1, \dots, g-1$ .

For each  $j$  denote  $\delta^j = p(\tilde{\delta}_1^j)$ . One can check that  $\delta$  is a separating simple closed curve on  $\Sigma'$  bounding a subsurface of genus  $j$ . Moreover, we have  $p(\tilde{\delta}_i^j) = \delta^j$  for all  $i = 1, \dots, N+1$ . Denote by  $h$  the genus of one of the subsurfaces bounded by  $\delta$ . Since the  $\text{Mod}(\Sigma)$ -orbit of  $\delta$  is uniquely determined by  $h$ , one can choose a homeomorphism  $\eta: \Sigma' \cong \Sigma$  such that  $\eta(\delta^h) = \delta$ . We obtain the covering  $\eta \circ p: \tilde{\Sigma} \rightarrow \Sigma$  such that  $\tilde{\delta}_1^h, \dots, \tilde{\delta}_{N+1}^h$  are the lifts of  $\delta$ . By Lemma 3.1 we have

$$\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \geq \dim \text{span}\langle [\tilde{\delta}_1^h], \dots, [\tilde{\delta}_{N+1}^h] \rangle_{\mathbb{Q}} = N,$$

which concludes the proof.  $\square$

**Proposition 3.4.** *Let  $\phi \in \text{Mod}(\Sigma)$  be a reducible element and let  $N > 0$  be an integer. Then there exists a regular finite cover  $\tilde{\Sigma} \rightarrow \Sigma$  with  $\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi \geq N$ .*

*Proof.* Since  $\phi \in \text{Mod}(\Sigma)$  is reducible, it follows that there exists an integer  $n > 0$  and a simple closed curve  $\alpha$  on  $\Sigma$  such that  $\phi^n(\alpha) = \alpha$ . Since any curve is either nonseparating or separating, Lemmas 3.2 and 3.3 imply that in both cases there exists a regular finite cover  $\tilde{\Sigma} \rightarrow \Sigma$  with  $\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^{\phi^n} \geq N$ . We obtain

$$\dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^\phi = \dim H_1^{f.o.}(\tilde{\Sigma}, \mathbb{Q})^{\phi^n} \geq N.$$

This concludes the proof.  $\square$

#### 4. PSEUDO-ANOSOV CASE

In this section we prove Theorem 1.1 for a pseudo-Anosov  $\phi$ . First let us recall the following classical fact.

**Fact 4.1** (Five-term exact sequence). [4, Corollary 6.4] Let

$$1 \longrightarrow P \longrightarrow G \longrightarrow Q \longrightarrow 1.$$

be a short exact sequence of groups. Then the following sequence is exact.

$$H_2(G, \mathbb{Q}) \longrightarrow H_2(Q, \mathbb{Q}) \longrightarrow H_1(P, \mathbb{Q})_Q \longrightarrow H_1(G, \mathbb{Q}) \longrightarrow H_1(Q, \mathbb{Q}) \longrightarrow 0.$$

Note that if  $P$  is finitely generated, then  $\dim H_1(P, \mathbb{Q}) < \infty$ . In this case, since  $\mathbb{Q}$  is a field, it follows that we have a canonical isomorphism  $H_1(P, \mathbb{Q})_Q \cong H_1(P, \mathbb{Q})^Q$ . Therefore Fact 4.1 immediately implies the following.

**Corollary 4.2.** *Let*

$$1 \longrightarrow P \longrightarrow G \longrightarrow \mathbb{Z} \longrightarrow 1.$$

*be a short exact sequence of groups. Assume that  $P$  is finitely generated. Then the sequence*

$$0 \longrightarrow H_1(P, \mathbb{Q})^{\mathbb{Z}} \longrightarrow H_1(G, \mathbb{Q}) \longrightarrow \mathbb{Q} \longrightarrow 0,$$

*is exact. In particular, we have*

$$H_1(G, \mathbb{Q}) \cong \mathbb{Q} \oplus H_1(P, \mathbb{Q})^{\mathbb{Z}}.$$

The key tool for our proof is the following deep theorem, which is a consequence of results of Haglund [9], Haglund-Wise [10], and Agol [1, 2].

**Theorem 4.3.** [12, Corollary 4.2.3 (3)] *Let  $M$  be a closed hyperbolic 3-manifold. Then  $vb_1(M) = \infty$ , i.e. there exist finite regular covers  $\widetilde{M} \rightarrow M$  with arbitrary large  $\dim H_1(\widetilde{M}, \mathbb{Q})$ .*

Now we can prove Theorem 1.1 for the pseudo-Anosov case.

**Proposition 4.4.** *Let  $\phi \in \text{Mod}(\Sigma)$  be a pseudo-Anosov element and let  $N > 0$  be an integer. Then there exists a regular finite cover  $\widetilde{\Sigma} \rightarrow \Sigma$  with  $\dim H_1^{f.o.}(\widetilde{\Sigma}, \mathbb{Q})^{\phi} \geq N$ .*

*Proof.* Let  $M_{\phi}$  be the mapping torus of  $\phi$ . Since there is a fiber bundle  $\Sigma \rightarrow M_{\phi} \rightarrow S^1$  with aspherical  $S^1$  and  $\Sigma$ , we obtain the short exact sequence of groups

$$1 \longrightarrow \pi_1(\Sigma) \longrightarrow \pi_1(M_{\phi}) \longrightarrow \mathbb{Z} \longrightarrow 1. \quad (2)$$

By Theorem 2.1 the 3-manifold  $M_{\phi}$  admits a hyperbolic metric. Theorem 4.3 implies that there exists a regular cover  $q : \widetilde{M} \rightarrow M_{\phi}$  such that  $b_1(\widetilde{M}) = \dim H_1(\widetilde{M}, \mathbb{Q}) \geq N + 1$ . We have the normal subgroup  $\pi_1(\widetilde{M}) \triangleleft \pi_1(M_{\phi})$  is of finite index. Denote  $\Gamma = \pi_1(\widetilde{M}) \cap \pi_1(\Sigma)$ . Since  $\pi_1(\widetilde{M})$  and  $\pi_1(\Sigma)$  are normal subgroups in  $\pi_1(M_{\phi})$ , then so is  $\Gamma$ .

Since  $[\pi_1(M_{\phi}) : \pi_1(\widetilde{M})] < \infty$ , then  $[\pi_1(\Sigma) : \Gamma] < \infty$ . Therefore, there exists a finite regular cover  $p : \widetilde{\Sigma} \rightarrow \Sigma$ , such that  $p_*(\pi_1(\widetilde{\Sigma})) = \Gamma$ . Therefore, (2) implies that we

obtain the following commutative diagram

$$\begin{array}{ccccccc}
 1 & \longrightarrow & \pi_1(\widetilde{\Sigma}) & \longrightarrow & \pi_1(\widetilde{M}) & \longrightarrow & \mathbb{Z} \longrightarrow 1 \\
 & & \downarrow p_* & & \downarrow q_* & & \downarrow n \\
 1 & \longrightarrow & \pi_1(\Sigma) & \longrightarrow & \pi_1(M_\phi) & \longrightarrow & \mathbb{Z} \longrightarrow 1
 \end{array} \tag{3}$$

where the right vertical arrow is the multiplication by some integer  $n$ . Since  $[\pi_1(M_\phi) : \pi_1(\widetilde{M})] < \infty$ , it follows that  $p_*(\pi_1(\widetilde{\Sigma})) = \Gamma \neq \pi_1(\widetilde{M})$ . Therefore, we obtain that  $n \neq 0$ .

Note that the group  $\mathbb{Z}$  in the bottom line of (3) acts on  $\pi_1(\Sigma)$  by  $\phi$ . Hence the group  $\mathbb{Z}$  in the top line of (3) acts on  $\pi_1(\widetilde{\Sigma})$  by  $\phi^n$ . In particular,  $\pi_1(\widetilde{\Sigma})$  is  $\phi^n$ -invariant. Then Corollary 4.2 applied to the top line of (3) implies

$$H_1(\pi_1(\widetilde{M}), \mathbb{Q}) \cong \mathbb{Q} \oplus H_1(\widetilde{\Sigma}, \mathbb{Q})^{\phi^n},$$

and since  $\widetilde{M}$  is also hyperbolic, we obtain  $H_1(\widetilde{M}, \mathbb{Q}) \cong H_1(\pi_1(\widetilde{M}), \mathbb{Q})$ .

Hence we have

$$\dim H_1(\widetilde{\Sigma}, \mathbb{Q})^{\phi^n} = \dim H_1(\pi_1(\widetilde{M}), \mathbb{Q}) - 1 = \dim H_1(\widetilde{M}, \mathbb{Q}) - 1 = b_1(\widetilde{M}) - 1 \geq N.$$

Since

$$H_1(\widetilde{\Sigma}, \mathbb{Q})^{\phi^n} \subseteq H_1^{f.o.}(\widetilde{\Sigma}, \mathbb{Q})^\phi,$$

it follows that

$$\dim H_1^{f.o.}(\widetilde{\Sigma}, \mathbb{Q})^\phi \geq \dim H_1(\widetilde{\Sigma}, \mathbb{Q})^{\phi^n} \geq N.$$

This concludes the proof of Theorem 1.1.  $\square$

Now we can finish the proof of the main result.

*Proof of Theorem 1.1.* By the Nielsen-Thurston classification we have that  $\phi$  is periodic, reducible, or pseudo-Anosov. If  $\phi$  is periodic, then  $\phi^n = \text{id}$  for some integer  $n > 0$ . In this case for any characteristic cover  $\widetilde{\Sigma} \rightarrow \Sigma$  we obtain

$$H_1^{f.o.}(\widetilde{\Sigma}, \mathbb{Q})^\phi = H_1^{f.o.}(\widetilde{\Sigma}, \mathbb{Q})^{\phi^n} = H_1^{f.o.}(\widetilde{\Sigma}, \mathbb{Q})^{\text{id}} = H_1(\widetilde{\Sigma}, \mathbb{Q}).$$

Hence the result follows from the fact that there exist finite characteristic covers of an arbitrary large degree.

For reducible and pseudo-Anosov cases, by Propositions 3.4 and 4.4, we obtain that there exists a finite regular cover  $\widetilde{\Sigma} \rightarrow \Sigma$  such that  $\dim H_1^{f.o.}(\widetilde{\Sigma}, \mathbb{Q})^\phi \geq N$ . Note that  $H_1^{f.o.}(\widetilde{\Sigma}, \mathbb{Q})^\phi \cong H_1^{f.o.}(K, \mathbb{Q})^\phi$ , where  $K = \pi_1(\widetilde{\Sigma}) \triangleleft \pi_1(\Sigma)$ . Corollary 2.4 implies that there exists a finite index characteristic subgroup  $K' \triangleleft \pi_1(\Sigma)$  such that  $\dim H_1^{f.o.}(K', \mathbb{Q})^\phi \geq \dim H_1^{f.o.}(K, \mathbb{Q})^\phi$ . Denote by  $\widetilde{\Sigma}' \rightarrow \Sigma$  the characteristic cover corresponding to  $K'$ . Then we obtain

$$\dim H_1^{f.o.}(\widetilde{\Sigma}', \mathbb{Q})^\phi = \dim H_1^{f.o.}(K', \mathbb{Q})^\phi \geq \dim H_1^{f.o.}(K, \mathbb{Q})^\phi = H_1^{f.o.}(\widetilde{\Sigma}, \mathbb{Q})^\phi \geq N.$$

This concludes the proof.  $\square$
