# REGULARITY FOR NONLOCAL EQUATIONS WITH LOCAL NEUMANN BOUNDARY CONDITIONS

#### Abstract

In this article we establish fine results on the boundary behavior of solutions to nonlocal equations in $C^{k, \gamma}$ domains which satisfy local Neumann conditions on the boundary. Such solutions typically blow up at the boundary like $v \asymp$ dist $^{s-1}$ and are sometimes called large solutions. In this setup we prove optimal regularity results for the quotients $v /$ dist $^{s-1}$, depending on the regularity of the domain and on the data of the problem. The results of this article will be important in a forthcoming work on nonlocal free boundary problems.


## 1. Introduction

The study of nonlocal operators of the form

L v(x)=\text { p.v. } \int_{\mathbb{R}^{n}}(v(x)-v(x+h)) K(h) \mathrm{d} h \tag{1.1}
\end{equation*}

where $K: \mathbb{R}^{n} \rightarrow[0, \infty]$ is a kernel satisfying for some $s \in(0,1)$

\begin{equation*}
K(h)=\frac{K(h /|h|)}{|h|^{n+2 s}}, \quad 0<\lambda \leq K(\theta) \leq \Lambda \quad \forall \theta \in \mathbb{S}^{n-1}, \quad K(h)=K(-h) \tag{1.2}
\end{equation*}
$$

has been an important area of research in analysis and probability for the past 30 years. Operators $L$ of the type (1.1)-(1.2) arise naturally as generators of $2 s$-stable Lévy processes, and are used to model different kinds of real-world phenomena involving long range interactions, e.g. in mathematical finance and in physics. From a PDE perspective, it is of particular interest to study the effect of the nonlocality of $L$ on the regularity of solutions to nonlocal equations. By now, the question of interior regularity of solutions is fairly well-understood, and there are several important works in this context, such as [CaSi09, CaSi11b, CaSi11a, [Sil06], BaLe02, [Kas09], DKP14, DKP16], BFV14], RoSe16b].
A much more delicate question is the one of boundary regularity of solutions to nonlocal problems. Previous works have mostly focused on nonlocal Poisson problems, given as follows

The nonlocal Poisson problem (1.3) arises naturally as the Euler-Lagrange equation of a nonlocal energy minimization problem and can therefore be studied via variational methods, but also via non-variational methods. For (1.3) it was proved (see RoSe14, Gru15) that weak solutions satisfy $v \in C^{s}(\bar{\Omega})$, once $\partial \Omega \in C^{1, \gamma}$ and $f \in L^{\infty}(\Omega)$. The $C^{s}$ regularity of solutions is optimal, as one can see from the following explicit example (see Get61, [Lan72], Dyd12):

\end{equation*}

[^0]However, it turns out that once the domain, the kernel, and the data are regular enough, also the quotient $v / d^{s}$ will be regular, yielding a fine description of the behavior of the solution $v$ at the boundary. The best known result in the literature, establishing optimal boundary regularity of weak solutions of (1.3) in terms of the regularity of the domain and the data was shown in RoSe17, AbRo20, Gru15) (see also RoSe16a, RoSe16b, AbGr23]) and reads as follows:

\partial \Omega \in C^{k+1, \gamma}, \quad f \in C^{k+\gamma-s}(\bar{\Omega}) \quad \Rightarrow \quad \frac{v}{d^{s}} \in C^{k, \gamma}(\bar{\Omega}) \quad \forall k \in \mathbb{N} \cup\{0\}, \quad \gamma \in(0,1) \tag{1.5}
\end{equation*}
$$

All the previously mentioned results on the nonlocal Poisson problem (1.3) address weak solutions for which one can prove that they must remain bounded in $\bar{\Omega}$ (see [SeVa14, KKP16]). However, explicit computations reveal that there also exist pointwise solutions of (1.3), which explode at the boundary of the domain behaving asymptotically like $d^{s-1}$. The following most prominent example goes back to a work by Hmissi [Hmi94 (see also Bog99, Example 1, p.239], [BBKRSV09, Example 3.3], Dyd12):

\end{equation*}

The example (1.6) has initiated the conceptual study of boundary blow-up for solutions to nonlocal equations (see [Gru14, Gru15, Gru18, Gru23, Aba15, Aba17, AGV23], CGV21). In this theory, solutions such as (1.6) are sometimes called "large solutions". Note that due to the explosion at the boundary, the above function cannot be a weak solution, and clearly violates (1.5).

In order to have a unified framework which also allows for singular behavior at the boundary, it is necessary to keep track of the boundary behavior of the solution, or more precisely to prescribe somehow the behavior of the quotient $v / d^{s-1}$. In this spirit, the following Neumann problem, which was introduced in Gru14 (see also Gru18, [Gru23), can be seen as a generalization of (1.3)

& L v=f \text { in } \Omega,  \tag{1.7}\\
& v=0 \\
& \text { in } \mathbb{R}^{n} \backslash \Omega, \\
& \partial_{\nu}\left(\frac{v}{d^{s-1}}\right)=g \text { on } \partial \Omega,
\end{align*}\right.
$$

where $\nu\left(x_{0}\right) \in \mathbb{S}^{n-1}$ denotes the unit normal at $x_{0} \in \partial \Omega$. The problem (1.7) is a natural nonlocal Neumann problem with inhomogeneous Neumann data $g$, and one can show that the problem is wellposed in suitable function spaces, at least if the domain is $C^{\infty}$ (see [Gru14]). Moreover, the solutions blow up at every boundary point where $v / d^{s-1}$ does not vanish.

Remark 1.1. The functions in (1.4) and (1.6), are both solutions to (1.7), with $g \equiv 1$ and $f=c_{n, s}$ and with $g \equiv s-1$ and $f=0$, respectively, in case $\Omega=B_{1}$.

Note that the Neumann condition in (1.7) is purely local in nature in the sense that it is imposed only on the topological boundary $\partial \Omega$. Therefore, (1.7) is conceptually completely different from the nonlocal Neumann problem introduced in DGLZ12, DRV17] (see also [AlTo20, Don21, [AFR23, [FoKa24], [GrHe24]). It is also of entirely different nature than [BCGJ14, BGJ14], and [BBC03, ChKi02], where local boundary conditions are imposed, but instead the operator is changed, depending on the domain.
1.1. Main result. The aforementioned regularity results (1.5) from RoSe17, AbRo20 do not apply to (1.7) since solutions are in general not continuous and might even explode at the boundary. However, it is natural to expect fine regularity results for the quotients $v / d^{s-1}$ depending on the regularity of the domain and the data.
When $\Omega$ is $C^{\infty}$ and $\left.K\right|_{\mathbb{S}^{n-1}}$ is $C^{\infty}$, the regularity theory for (1.7) was developed by Grubb in Gru14) using an approach via pseudodifferential operators.

Our goal in this work is twofold: to establish sharp boundary regularity estimates for (1.7) in $C^{k, \gamma}$ domains, and at the same time to prove them for the first time as localized estimates in $\Omega \cap B_{2}$. This is new even for $C^{\infty}$ domains, and it is crucial for our application to free boundary problems.
Our main result is the following:
Theorem 1.2. Let $L, K, s, \lambda, \Lambda$ be as in (1.1)-(1.2). Let $k \in \mathbb{N}, \gamma \in(0,1)$ with $\gamma \neq s$, and $\Omega \subset \mathbb{R}^{n}$ be a $C^{k+1, \gamma}$ domain, and $K \in C^{2 k+2 \gamma+3}\left(\mathbb{S}^{n-1}\right)$.
Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to

L v & =f \quad \text { in } \Omega \cap B_{2}, \\
v & =0 \quad \text { in } B_{2} \backslash \Omega, \\
\partial_{\nu}\left(\frac{v}{d^{s-1}}\right) & =g \quad \text { on } \partial \Omega \cap B_{2},
\end{aligned}\right.
$$

where $\nu: \partial \Omega \rightarrow \mathbb{S}^{n-1}$ is the normal vector of $\Omega$, and $f \in C(\Omega) \cap \mathcal{X}\left(\Omega \cap B_{2}\right), g \in C^{k-1+\gamma}\left(\partial \Omega \cap B_{2}\right)$,

\mathcal{X}\left(\Omega \cap B_{2}\right)= \begin{cases}d^{s-\gamma} L^{\infty}\left(\Omega \cap B_{2}\right), & \text { if } k+\gamma \leq 2 s  \tag{1.8}\\ C^{k-2 s+\gamma}\left(\Omega \cap B_{2}\right), & \text { if } k+\gamma>2 s\end{cases}
$$

Then, it holds $v / d^{s-1} \in C_{l o c}^{k+\gamma}\left(\bar{\Omega} \cap B_{2}\right)$ and

$$
\left\|\frac{v}{d^{s-1}}\right\|_{C^{k, \gamma}\left(\bar{\Omega} \cap B_{1}\right)} \leq c\left(\left\|\frac{v}{d^{s-1}}\right\|_{L^{\infty}\left(\Omega \cap B_{2}\right)}+\|v\|_{L_{2 s}^{1}\left(\mathbb{R}^{n} \backslash B_{2}\right)}+\|f\|_{\mathcal{X}\left(\Omega \cap B_{2}\right)}+\|g\|_{C^{k-1+\gamma}\left(\partial \Omega \cap B_{2}\right)}\right),
$$

for some $c>0$, which only depends on $n, s, \lambda, \Lambda, k, \gamma, \Omega$, and $\|K\|_{C^{2 k+2 \gamma+3}\left(\mathbb{S}^{n-1}\right)}$.
For the definition of $L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ and the notion of viscosity solutions, we refer to Section 2,
Note that the regularity we obtain for $v / d^{s-1}$ depending on the regularity of the domain $\Omega$ and the data $f, g$ is optimal. For $f$ and $g$, this is an immediate consequence of interior Schauder theory (see [RoSe16b]), and the order of the equation. For the regularity of the domain, we observe that our results are in align with the ones in AbRo20 once $v \in C\left(\bar{\Omega} \cap B_{2}\right)$. What concerns the regularity of $K$, we obtain optimal results in case $\Omega$ is a half-space (see Theorem 1.7).
Another key advantage of our approach is that it allows for localized results in $\Omega \cap B_{2}$. Nonetheless, if $\Omega \subset B_{2}$, and $v$ is a solution to (1.7), by application of the maximum principle (see Lemma 3.4) to the estimate in Theorem 1.2 we can obtain a bound that is purely in terms of $f$ and $g$. Thus, we have the following generalization of (1.5) to solutions of (1.7):

\partial \Omega \in C^{k+1, \gamma}, f \in C^{k+\gamma-2 s}(\bar{\Omega}), g \in C^{k-1+\gamma}(\partial \Omega) \quad \Rightarrow \quad \frac{v}{d^{s-1}} \in C^{k, \gamma}(\bar{\Omega}) \quad \forall k \in \mathbb{N}, \gamma \in(0,1) \tag{1.9}
\end{equation*}
$$

1.2. A weak maximum principle and nonlocal problems with local Dirichlet conditions. The example (1.6) of a non-trivial harmonic function that vanishes outside $B_{1}$ implies that the Poisson problem (1.3) for the fractional Laplacian is ill-posed even in the homogeneous case. Therefore, maximum principles are usually established under an additional assumption on the boundary behavior of the solution, ruling out "large" solutions such as (1.6) (see Sil07, SeVa14], FKV15], JaWe19], [FeJa23], FeRo24a]). Note that a similar phenomenon occurs for local equations, where any constant function is a pointwise solution inside the solution domain.
In this paper, we prove the following nonlocal weak maximum principle, which allows for solutions that blow up at the boundary.

Proposition 1.3. Let $L, K, s, \lambda, \Lambda$ be as in (1.1)-(1.2). Let $\gamma>0$ and $\Omega \subset \mathbb{R}^{n}$ be a $C^{1, \gamma}$ domain. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to

$$
\left\{\begin{aligned}
L v & \geq 0 \text { in } \Omega, \\
v & \geq 0 \text { in } \mathbb{R}^{n} \backslash \Omega, \\
\frac{v}{d^{s-1}} & \geq 0 \text { on } \partial \Omega .
\end{aligned}\right.
$$

Then, $v \geq 0$.
The condition $v / d^{s-1} \geq 0$ in Proposition 1.3 includes solutions that blow up at the boundary, such as (1.6). Previously, maximum principles including large solutions have been established in Aba15, and [GrHe23], LiZh22, LiLi23. Proposition 1.3 extends these results to general $2 s$-stable integrodifferential operators, and to $C^{1, \gamma}$ domains, respectively.
Recall, that a natural way to make the nonlocal Poisson problem (1.3) well-posed is to impose Neumann boundary conditions as in (1.7). Another way would be to prescribe the limit of the quotient $v / d^{s-1}$ directly, which leads to the following nonlocal problem with local Dirichlet data, which was introduced independently in Gru14, Aba15:

\left\{\begin{array}{rll}
L v & =f & \text { in } \Omega  \tag{1.10}\\
v & =0 & \text { in } \mathbb{R}^{n} \backslash \Omega \\
\frac{v}{d^{s-1}} & =h & \text { on } \partial \Omega
\end{array}\right.
$$

The weak maximum principle in Proposition 1.3 implies that the problems (1.10) and (1.3) are equivalent, when $h \equiv 0$. Thus, (1.10) can be seen as an inhomogeneous nonlocal Dirichlet problem.
Another contribution of this article is the following Schauder-type boundary regularity estimate for solutions to nonlocal equations with local Dirichlet data:

Theorem 1.4. Let $L, K, s, \lambda, \Lambda$ be as in (1.1)-(1.2). Let $k \in \mathbb{N}, \gamma \in(0,1)$ with $\gamma \neq s$, and $\Omega \subset \mathbb{R}^{n}$ be a $C^{k+1, \gamma}$ domain, and $K \in C^{2 k+2 \gamma+3}\left(\mathbb{S}^{n-1}\right)$.
Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to (1.10) with $f \in C(\Omega) \cap \mathcal{X}(\Omega)$ and $h \in C^{k+\gamma}(\partial \Omega)$, where $\mathcal{X}$ is as in (1.8). Then, it holds $v / d^{s-1} \in C_{l o c}^{1+\gamma}(\bar{\Omega})$, and

$$
\left\|\frac{v}{d^{s-1}}\right\|_{C^{k, \gamma}(\bar{\Omega})} \leq c\left(\|f\|_{\mathcal{X}(\Omega)}+\|h\|_{C^{k+\gamma}(\partial \Omega)}\right)
$$

for some $c>0$, which only depends on $n, s, \lambda, \Lambda, k, \gamma, \Omega$, and $\|K\|_{C^{2 k+2 \gamma+3\left(\mathbb{S}^{n-1}\right)}}$.
We refer to Gru15, Gru23 for similar results in the framework of pseudodifferential operators.
Note that (1.10) can always be reduced to the homogeneous problem (1.3). In fact, if $\Omega$ and $h$ are regular enough, one can extend $h$ to a smooth function in $\bar{\Omega}$ and consider $w:=v-d^{s-1} h$. Then, $w$ solves the homogeneous problem (1.3) with a new right hand side $\tilde{f}=f-L\left(d^{s-1} h\right)$. Since $L\left(d^{s-1} h\right)$ has good regularity properties (see Corollary 2.5), we can prove Theorem 1.4 by application of the results in RoSe17, AbRo20.
1.3. Strategy of the proof: regularity for nonlocal problems with local Neumann data. Since the nonlocal problem with inhomogeneous local Dirichlet data (1.10) can always be reduced to the homogeneous problem (1.3) for which the boundary regularity theory was already established (see [RoSe17], AbRo20]), the proof of Theorem 1.4 is rather simple.

In sharp contrast to that, for the Neumann problem (1.7) there is no cheap way to obtain the boundary regularity results in Theorem 1.6 from the existing theory. In fact, it is already highly non-trivial to establish Hölder continuity of the quotient $v / d^{s-1}$ up to the boundary.
Our proof of Theorem 1.6 goes in three main steps.
First, we establish a weak maximum principle for solutions to the Neumann problem (1.7).
Proposition 1.5. Let $L, K, s, \lambda, \Lambda$ be as in (1.1)-(1.2). Let $\gamma>0$ and $\Omega \subset \mathbb{R}^{n}$ be a $C^{1, \gamma}$ domain. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to

\left\{\begin{aligned}
& L v \geq 0 \\
& v \text { in } \Omega, \\
& 0 \\
& \text { in } \mathbb{R}^{n} \backslash \Omega, \\
& \partial_{\nu}\left(\frac{v}{d^{s-1}}\right) \leq 0
\end{aligned} \text { on } \partial \Omega . ~ \$\right.
$$

Then, $v \geq 0$.
Note that this result seems to be the first maximum principle for nonlocal problems with local Neumann boundary conditions in the literature. We believe it to be of independent interest and refer to Lemma 3.4 for a corresponding $L^{\infty}$ bound in the case of inhomogeneous data.
The proof of Proposition 1.5 follows from a nonlocal Hopf-type lemma for solutions to the inhomogeneous Dirichlet problem (1.10) (see Lemma 3.3), which in turn follows from the weak maximum principle in Proposition 1.3. All of these results rely heavily on explicit barriers for (1.10) in $C^{1, \gamma}$ domains that are adapted to the geometry of the domain and blow up at the boundary like $d^{s-1}$. These barriers can be seen as perturbations of (1.6), or rather of 1D solutions such as

\begin{equation*}
L\left(x_{n}\right)_{+}^{s-1}=0 \quad \text { in }\left\{x_{n}>0\right\} . \tag{1.11}
\end{equation*}
$$

Note that (1.11) follows simply by differentiating the equation

$$
L\left(x_{n}\right)_{+}^{s}=0 \quad \text { in }\left\{x_{n}>0\right\} .
$$

The previous identity is a classical fact for nonlocal operators (1.1)-(1.2) (see [FeRo24a, Lemma 2.6.2]). The second main step in the proof of Theorem 1.6 is to establish Hölder continuity of order $\alpha$, for $\alpha \in(0,1)$ small enough, up to the boundary of $v / d^{s-1}$ for solutions to (1.7) in $C^{1, \gamma}$ domains.
Theorem 1.6. Let $L, K, s, \lambda, \Lambda$ be as in (1.1) -(1.2). Let $\gamma \in(0,1)$, and $\Omega \subset \mathbb{R}^{n}$ be a $C^{1, \gamma}$ domain. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to

$$
\left\{\begin{aligned}
& L v=f \quad \text { in } \Omega \cap B_{2} \\
& v=0 \\
& \text { in } B_{2} \backslash \Omega, \\
& \partial_{\nu}\left(\frac{v}{d^{s-1}}\right)=g \quad \text { on } \partial \Omega \cap B_{2},
\end{aligned}\right.
$$

with $f \in C\left(\Omega \cap B_{2}\right)$ and $g \in C\left(\partial \Omega \cap B_{2}\right)$. Then, there exists $\alpha_{0}>0$, such that when $d^{s+1-\alpha} f \in$ $L^{\infty}\left(\Omega \cap B_{2}\right)$ for some $\alpha \in\left(0, \alpha_{0}\right]$, then it holds $v / d^{s-1} \in C_{\text {loc }}^{\alpha}\left(\bar{\Omega} \cap B_{2}\right)$, and

$$
\left\|\frac{v}{d^{s-1}}\right\|_{C^{\alpha}\left(\bar{\Omega} \cap B_{1}\right)} \leq c\left(\left\|\frac{v}{d^{s-1}}\right\|_{L^{\infty}\left(\Omega \cap B_{2}\right)}+\|v\|_{L_{2 s}^{1}\left(\mathbb{R}^{n} \backslash B_{2}\right)}+\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{2}\right)}+\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{2}\right)}\right)
$$

where $c>0$ and $\alpha_{0}$ depend only on $n, s, \lambda, \Lambda, \gamma$, and the $C^{1, \gamma}$ radius of $\Omega$.
The proof of Theorem 1.6 uses the weak maximum principle in Proposition 1.5 and the interior weak Harnack inequality, to establish a weak Harnack inequality for $v / d^{s-1}$ at the boundary (see Lemma 4.11. This allows us to deduce a so called "growth lemma" for $v / d^{s-1}$, stating that $v / d^{s-1}$ must be large pointwise in a ball centered at the boundary, if $v / d^{s-1}$ was large in a measure-theoretic
sense in a ball away from the boundary. Such growth lemma allows to establish oscillation decay for $v / d^{s-1}$ at the boundary, and to deduce the Hölder estimate in Theorem 1.6, A similar proof for the classical Laplacian can be found in [LiZh23].
Once the boundary Hölder estimate is shown, we can establish the higher order boundary regularity in Theorem 1.2 via a blow-up argument. This is the third, and last step of the proof. Theorem 1.6 is crucial in order to deduce uniform convergence of the blow-up sequence.
The blow-up argument follows the scheme in [AbRo20] and relies on a Liouville theorem in the halfspace with local Neumann data (see Theorem 5.1). However, major modifications have to be made in most of the steps due to the boundary blow-up of solutions. For instance, we need to show the following new result (see Corollary 2.5):

\partial \Omega \in C^{k+1, \gamma} \quad \Rightarrow \quad L\left(d^{s-1}\right) \in C^{k-1+\gamma-s}(\bar{\Omega}) \quad \text { if } k+\gamma>1+s
$$

Moreover, the presence of a Neumann boundary condition complicates some of the arguments, such as the proof of a stability result for viscosity solutions (see Lemma 2.13). Finally, as in AbRo20] we need to make use of a suitable notion of nonlocal equations up to a polynomial (see [DSV19], [DDV22]) in order to account for solutions that grow too fast at infinity (see Definition 2.8).
1.4. Applications to free-boundary problems. We end the discussion of the main results of this article by shedding some light on a, perhaps unexpected, connection between nonlocal problems with local Neumann boundary data and free boundary problems. This connection is a main motivation for us to study (1.7). Let us explain this phenomenon in the particular case of the fractional Laplacian.
The nonlocal one-phase free boundary problem, which was introduced in CRS10 (see also RoWe24a), deals with the minimization of the following functional

\mathcal{I}(w):=\iint_{\left(B_{1}^{c} \times B_{1}^{c}\right)^{c}}(w(x)-w(y))^{2} \frac{\mathrm{~d} y \mathrm{~d} x}{|x-y|^{n+2 s}}+M\left|\{w>0\} \cap B_{1}\right| \tag{1.12}
\end{equation*}
$$

for some $M>0$ and with prescribed values of $w$ in $\mathbb{R}^{n} \backslash B_{1}$. One can show (see [CRS10, FeRo24b]) that local minimizers of (1.12) are $C^{s}\left(B_{1}\right)$ and that they are viscosity solutions to

$$
\left\{\begin{align*}
(-\Delta)^{s} w & =0 & & \text { in } \Omega \cap B_{1}  \tag{1.13}\\
w & =0 & & \text { in } B_{1} \backslash \Omega \\
\frac{w}{d^{s}} & =c_{n, s} M & & \text { on } \partial \Omega \cap B_{1}
\end{align*}\right.
$$

where $c_{n, s}>0$ is a constant and $\Omega:=\{w>0\}$. An important question in the theory is to determine the regularity of the free boundary $\partial \Omega$ near so called "regular points". These are the points $x_{0} \in \partial \Omega \cap B_{1}$ for which blow-ups of $w$ are half-space solutions, i.e., (up to rotations and multiplicative constants)

$$
\frac{w\left(x_{0}+r x\right)}{r^{s}} \rightarrow w_{0}(x):=\left(x_{n}\right)_{+}^{s} \quad \text { locally uniformly. }
$$

One can show using the extension for $(-\Delta)^{s}$ (see DeRo12, DeSa12, DSS14]) that once a sequence $\left(w_{\varepsilon}\right)$ of viscosity solutions (1.13) is " $\varepsilon$-close" to the half-space solution $w_{0}$ in the sense that

$$
\left(x_{n}-\varepsilon\right)_{+}^{s} \leq w_{\varepsilon}(x) \leq\left(x_{n}+\varepsilon\right)_{+}^{s},
$$

then it holds, as $\varepsilon \searrow 0$ :

$$
\frac{w_{\varepsilon}(x)-\left(x_{n}\right)_{+}^{s}}{\varepsilon} \rightarrow\left(x_{n}\right)_{+}^{s-1} u(x)
$$

where $u$ solves the so called "linearized problem"

$$
\left\{\begin{align*}
(-\Delta)^{s}\left(\left(x_{n}\right)_{+}^{s-1} u\right) & =0 \quad \text { in }\left\{x_{n}>0\right\} \cap B_{1},  \tag{1.14}\\
\partial_{n} u & =0 \quad \text { on }\left\{x_{n}=0\right\} \cap B_{1} .
\end{align*}\right.
$$

Hence, $\left(x_{n}\right)_{+}^{s-1} u$ is a solution to a nonlocal problem with local Neumann data (1.7) in the half-space, and it explodes at the boundary $\left\{x_{n}=0\right\} \cap B_{1}$.
In order to establish regularity results for the free boundary $\Omega=\{w>0\}$ near regular points, it is an important step to establish boundary regularity results for the solution to the linearized problem. For (1.14) this was done in DeRo12, DeSa12, DSS14, using the Caffarelli-Silvestre extension.
In the light of this connection, our main result Theorem 1.2 also makes a contribution to the theory of the nonlocal one-phase problem (1.12), and provides a completely new proof of the regularity for (1.14), even in the case of the fractional Laplacian.

We end this discussion by stating a variant of Theorem 1.2 in the special case $\Omega=\left\{x_{n}>0\right\}$. This result holds true under optimal assumptions on $K$, and it will be helpful in the study of the nonlocal one-phase free boundary problem (1.13) with respect to general nonlocal operators (1.1)-(1.2), which we plan to investigate in a future work (see RoWe24b]).
Theorem 1.7. Let $L, K, s, \lambda, \Lambda$ be as in (1.1) -(1.2). Let $k \in \mathbb{N}, \gamma \in(0,1)$ with $\gamma \neq s$. Let $u \in C\left(\left\{x_{n} \geq 0\right\} \cap B_{2}\right)$ with $\left(x_{n}\right)_{+}^{s-1} u \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ be a viscosity solution to

$$
\left\{\begin{aligned}
L\left(\left(x_{n}\right)_{+}^{s-1} u\right) & =f \text { in }\left\{x_{n}>0\right\} \cap B_{2}, \\
\partial_{n} u & =g \text { on } \partial\left\{x_{n}=0\right\} \cap B_{2} .
\end{aligned}\right.
$$

with $f \in C\left(\left\{x_{n}>0\right\} \cap B_{2}\right) \cap \mathcal{X}\left(\left\{x_{n}>0\right\} \cap B_{2}\right), g \in C^{k-1+\gamma}\left(\left\{x_{n}=0\right\} \cap B_{2}\right)$, and $K \in C^{k-2 s+\gamma}\left(\mathbb{S}^{n-1}\right)$ if $k+\gamma>2 s$, where $\mathcal{X}$ is as in (1.8). Then, it holds

$$
\begin{aligned}
\|u\|_{C^{k, \gamma}\left(\left\{x_{n} \geq 0\right\} \cap B_{1}\right)} \leq c\left(\|u\|_{L^{\infty}\left(\left\{x_{n}>0\right\} \cap B_{2}\right)}\right. & +\left\|\left(x_{n}\right)_{+}^{s-1} u\right\|_{L_{2 s}^{1}\left(\mathbb{R}^{n} \backslash B_{2}\right)} \\
& \left.+\|f\|_{\mathcal{X}\left(\left\{x_{n}>0\right\} \cap B_{2}\right)}+\|g\|_{C^{k-1+\gamma}\left(\left\{x_{n}=0\right\} \cap B_{2}\right)}\right)
\end{aligned}
$$

for some $c>0$, which only depends on $n, s, \lambda, \Lambda, k, \gamma$, and (if $k+\gamma>2 s$ ) also on $\|K\|_{C^{k-2 s+\gamma\left(S^{n-1}\right)}}$.
Finally, we make the following remark.
Remark 1.8. Note that the following two problems are equivalent if $v \in C\left(\bar{\Omega} \cap B_{2}\right)$, i.e., if solutions do not blow up on $\partial \Omega \cap B_{2}$ :

$$
\left\{\begin{array} { r l } 
{ L v } & { = f \text { in } \Omega \cap B _ { 2 } , } \\
{ v } & { = 0 } \\
{ \text { in } B _ { 2 } \backslash \Omega , } \\
{ \partial _ { \nu } ( \frac { v } { d ^ { s - 1 } } ) } & { = g \text { on } \partial \Omega \cap B _ { 2 } , }
\end{array} \quad \leftrightarrow \quad \left\{\begin{array}{rll}
L v & =f \text { in } \Omega \cap B_{2}, \\
v & =0 & \text { in } B_{2} \backslash \Omega, \\
\frac{v}{d^{s}} & =g & \text { on } \partial \Omega \cap B_{2} .
\end{array}\right.\right.
$$

Indeed, since $v \equiv 0$ in $B_{2} \backslash \Omega$, it holds for any $x_{0} \in \partial \Omega \cap B_{2}$ :

$$
\partial_{\nu}\left(\frac{v}{d^{s-1}}\right)=\lim _{x \rightarrow x_{0}} \frac{\frac{v}{d^{s-1}}(x)-\lim _{z \rightarrow x_{0}} \frac{v}{d^{s-1}}(z)}{d(x)}=\lim _{x \rightarrow x_{0}} \frac{v}{d^{s}}(x) .
$$

Recall that the second problem is satisfied by minimizers to the nonlocal one-phase problem (1.13). Moreover, the above problem is the nonlocal counterpart of the over-determined Serrin's problem whenever $\Omega \subset B_{2}$ (see for instance [FaJa15, SoVa19, BiJa20, DPTV23]).

1.6. Organization of the paper. This paper is organized as follows. In Section 2 we introduce the notion of viscosity solutions to (1.7) and give some preliminary lemmas. Among them are already several new results of independent interest, such as the construction of explicit barriers exploding at the boundary (see Subsection [2.3), an analysis of the regularity of $L\left(d^{s-1}\right)$ in terms of the regularity of the domain (see Corollary 2.5), and a stability result for viscosity solutions (see Lemma 2.13). In Section 3 we prove maximum principles for solutions to nonlocal problems with local Dirichlet- and Neumann data (see Proposition 1.3 and Proposition 1.5). Section 4 is devoted to the proof of the Hölder estimate up to the boundary (see Theorem 1.6). In Section 5 we prove a Liouville theorem in the half-space (see Theorem 5.1), and in Section 6 we carry out a blow-up argument to prove our main result, Theorem 1.2. Finally, Section 7 contains the proof of the regularity for the inhomogeneous Dirichlet problem (see Theorem 1.4).

## 2. Preliminaries

In this section, we give several important definitions, such as the definitions of viscosity solutions to (1.7). In Subsection 2.2 we establish the regularity of $L\left(d^{s-1}\right)$ depending on the regularity of the domain and in Subsection 2.3 we use these results to construct barrier functions. In Subsection 2.4, we introduce the notion of nonlocal equations satisfied up to a polynomial, and in Subsection 2.5 we establish stability of viscosity solutions and prove that the sum of two viscosity solutions is again a viscosity solution.
From now on, we denote by $\mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$ the class of operators (1.1) with kernels satisfying (1.2). Moreover, whenever we say $K \in C^{\alpha}\left(\mathbb{S}^{n-1}\right)$ for some $\alpha>0$, we mean that $\|K\|_{C^{\alpha}\left(\mathbb{S}^{n-1}\right)} \leq \Lambda$. Sometimes, we denote the class of operators (1.1) satisfying (1.2) and $K \in C^{\alpha}\left(\mathbb{S}^{n-1}\right)$ by $\mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda, \alpha)$.
Moreover, given an open, bounded domain $\Omega \subset \mathbb{R}^{n}$ with $\partial \Omega \in C^{\beta}$ for some $\beta>1, d:=d_{\Omega}: \mathbb{R}^{n} \rightarrow$ $[0, \infty)$ will denote the regularized distance which satisfies $d \in C^{\infty}(\Omega) \cap C^{\beta}(\bar{\Omega})$ and $d \equiv 0$ in $\mathbb{R}^{n} \backslash \Omega$. Crucially, we have $\operatorname{dist}(\cdot, \Omega) \leq d \leq C \operatorname{dist}(\cdot, \Omega)$ in $\mathbb{R}^{n}$, i.e., the topological distance and the regularized distance are pointwise comparable. We will often use the fact that $\left|D^{k} d\right| \leq c d^{\beta-k}$ (see FeRo24a, Definition 2.7.5]). Throughout this article, we will define $d^{s-1} \equiv 0$ in $\mathbb{R}^{n} \backslash \Omega$.
In the following, whenever $x_{0} \in \partial \Omega$, we write $v / d^{s-1}\left(x_{0}\right):=\lim _{\Omega \ni x \rightarrow x_{0}} v / d_{\Omega}^{s-1}(x)$.
2.1. Function spaces and solution concepts. Let us introduce the following function space

$$
L_{\alpha}^{1}\left(\mathbb{R}^{n}\right):=\left\{u:\|u\|_{L_{\alpha}^{1}\left(\mathbb{R}^{n}\right)}:=\int_{\mathbb{R}^{n}}|u(y)|(1+|y|)^{-n-\alpha} \mathrm{d} y<\infty\right\}, \quad \alpha>0 .
$$

Typically, we will use the previous definition with $\alpha=2 s$. We are now in a position to give the notion of viscosity solution to (1.7).

Definition 2.1 (Viscosity solution). Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$.
(i) We say that $v \in C(\Omega) \cap L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ is a viscosity subsolution to

$$
\begin{equation*}
L v=f \quad \text { in } \Omega \cap B_{1}, \tag{2.1}
\end{equation*}
$$

where $f \in C\left(\Omega \cap B_{1}\right)$, if for any $x \in \Omega \cap B_{1}$ and any neighborhood $N_{x} \subset \Omega$ of $x$ it holds

$$
\begin{equation*}
L \phi(x) \leq f(x) \quad \forall \phi \in C^{2}\left(N_{x}\right) \cap L_{2 s}^{1}\left(\mathbb{R}^{n}\right) \quad \text { s.t. } v(x)=\phi(x), \quad \phi \geq v . \tag{2.2}
\end{equation*}
$$

We say that $v$ is a viscosity supersolution to (2.2) if (2.2) holds true for $-v$ and $-f$ instead of $v$ and $f$. Moreover, $v$ is a viscosity solution to (2.2), if it is a viscosity subsolution and a viscosity supersolution.
(ii) We say that $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ is a viscosity subsolution to

$$
\partial_{\nu}\left(v / d^{s-1}\right)=g \quad \text { on } \partial \Omega \cap B_{1},
$$

where $g \in C\left(\partial \Omega \cap B_{1}\right)$, if for any $x \in \partial \Omega \cap B_{1}$ and any neighborhood $N_{x} \subset \bar{\Omega} \cap B_{1}$ of $x$ it holds

$$
\begin{equation*}
\partial_{\nu} \phi(x) \leq g(x) \quad \forall \phi \in C^{2}\left(N_{x}\right) \cap L^{\infty}(\bar{\Omega}) \quad \text { s.t. } v / d^{s-1}(x)=\phi(x), \quad \phi \leq v / d^{s-1} . \tag{2.3}
\end{equation*}
$$

We say that $v$ is a viscosity supersolution to (2.3) if (2.3) holds true for $-v$ and $-g$ instead of $v$ and $g$. Moreover, $v$ is a viscosity solution to (2.3), if it is a viscosity subsolution and a viscosity supersolution.

Note that clearly, if in (i) $L v(x)$, or if in (ii) $\partial_{\nu}\left(v / d^{s-1}\right)(x)=\lim _{\Omega \ni y \rightarrow x}\left(v / d^{s-1}\right)(y)$ exists in the strong sense, then the notions of viscosity solutions coincide with the ones for strong solutions (see FeRo24a, Lemma 3.4.13]).
2.2. Nonlocal operators and the distance function. The goal of this subsection is to establish several lemmas on the regularity of $L\left(d^{s-1}\right)$ depending on the regularity of $\Omega$. Lemma 2.3 will help us to establish barriers in $C^{1, \gamma}$ domains and Corollary 2.5 is crucial for domains that are more regular.
The following lemma is a slight modification of FeRo24a, Lemma B.2.4].
Lemma 2.2. Let $L \in \mathcal{L}_{s}^{h o m}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be a bounded Lipschitz domain with Lipschitz constant $L$ and $C^{0,1}$ radius $\rho_{0}>0$. Let $x_{0} \in \Omega$ with $\rho:=d_{\Omega}\left(x_{0}\right), \gamma>-1$ and $\gamma<\beta$. Then,

$$
\int_{\Omega \backslash B_{\rho / 2}} d_{\Omega}^{\gamma}\left(x_{0}+y\right)|y|^{-n-\beta} \mathrm{d} y \leq C\left(1+\rho^{\gamma-\beta}\right)
$$

for some constant $C>0$, depending only on $n, \gamma, \beta, \rho_{0}, L$, and, if $\gamma>0$ or $\beta \leq 0$ also on $\operatorname{diam}(\Omega)$.
Proof. We assume that $x_{0}=0$. There exists $\kappa>0$ such that for any $t \in(0, \kappa)$ :

$$
\begin{equation*}
\mathcal{H}^{n-1}\left(\{d=t\} \cap\left(B_{2^{j+1} \rho} \backslash B_{2^{j} \rho}\right)\right) \leq C\left(2^{j} \rho\right)^{n-1} \tag{2.4}
\end{equation*}
$$

(we refer to FeRo24a, Lemma B.2.4] for a reference of this fact). Note that

$$
\int_{\left(\Omega \backslash B_{\rho / 2}\right) \cap\{d \geq \kappa\}} d^{\gamma}(y)|y|^{-n-\beta} \mathrm{d} y \leq\left(\operatorname{diam}(\Omega)^{\gamma} \mathbb{1}_{\{\gamma>0\}}+\kappa^{\gamma} \mathbb{1}_{\{\gamma \leq 0\}}\right) \int_{\left(\Omega \backslash B_{\rho / 2}\right) \cap\{d \geq \kappa\}}|y|^{-n-\beta} \mathrm{d} y \leq c
$$

for some constant $c>0$ depending on $\kappa$ and, if $\gamma>0$ or $\beta \leq 0$ also on diam $(\Omega)$, but independent of $\rho$. The independence of $\rho$ is trivial if $\kappa \leq 2 \rho$ since then $\Omega \backslash B_{\rho / 2} \subset \Omega \backslash B_{\kappa / 4}$, and otherwise, it follows from the fact that $B_{r} \cap\{d \geq \kappa\}=\emptyset$ once $r \leq \kappa / 2 \leq \kappa-\rho$ (recall that $d(0)=\rho$ ), so also in this case, we can replace the domain of integration by $\Omega \backslash B_{\kappa / 2}$. Moreover, using (2.4) and the co-area formula:

$$
\begin{aligned}
\int_{\left(\Omega \backslash B_{\rho / 2}\right) \cap\{d \leq \kappa\}} d^{\gamma}(y)|y|^{-n-\beta} \mathrm{d} y & \leq c \sum_{j \geq 1}\left(\left(2^{j} \rho\right)^{-n-\beta} \int_{\left(B_{2^{j+1} \rho} \backslash B_{3^{j} \rho}\right) \cap\{d \leq \kappa\}} d^{\gamma}(y)|\nabla d(y)| \mathrm{d} y\right) \\
& \leq c \sum_{j \geq 1}\left(\left(2^{j} \rho\right)^{-n-\beta} \int_{0}^{\min \left\{2^{j} \rho, \kappa\right\}} t^{\gamma}\left[\int_{\left(B_{2^{j+1} \rho} \rho B_{2^{j} \rho}\right) \cap\{d=t\}} \mathrm{d} \mathcal{H}^{n-1}(y)\right] \mathrm{d} t\right) \\
& \leq c \sum_{j \geq 1}\left(\left(2^{j} \rho\right)^{-\beta+\gamma}\right) \leq c \rho^{\gamma-\beta}
\end{aligned}
$$

for some $c>0$, where we used that $\gamma-\beta<0$.
The following lemma will be of central importance for the proof of Lemma 2.6 and Lemma 2.7

Lemma 2.3. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Then, for any $\delta \in(0, s)$, there exists $c_{1}>0$, depending only on $n, s, \lambda, \Lambda, \Omega, \gamma, \delta$, and the $C^{1, \gamma}$ radius of $\Omega$, such that

$$
\left|L\left(d^{s-1}\right)\right| \leq c_{1} d^{\delta \gamma-s-1} \quad \text { in } \Omega
$$

Moreover, for any $\varepsilon \in(0, s)$, there exist $c_{2}, c_{3}>0$ depending only on $n, s, \lambda, \Lambda, \gamma, \varepsilon$, and the $C^{1, \gamma}$ radius of $\Omega$, such that

$$
L\left(d^{s-1+\varepsilon}\right) \leq-c_{2} d^{\varepsilon-s-1}+c_{3} \quad \text { in } \Omega .
$$

Proof. The first part follows as in the proof of [FeRo24a, Proposition B.2.1]. Indeed, we let $x_{0} \in \Omega$ and denote $\rho=d\left(x_{0}\right)$. Then, we denote

$$
l(x)=\left(d\left(x_{0}\right)+\nabla d\left(x_{0}\right) \cdot\left(x-x_{0}\right)\right)_{+}
$$

and observe that

$$
L\left(l^{s-1}\right)=0 \quad \text { in }\{l>0\}
$$

as a consequence of $L\left(l^{s}\right)=0$ and $\nabla l^{s}=s l^{s-1} \nabla l=s \nabla d\left(x_{0}\right) l^{s-1}$. Next, we claim that

$$
\left|d^{s-1}-l^{s-1}\right|\left(x_{0}+y\right) \leq\left\{\begin{array}{l}
C \rho^{s+\gamma-3}|y|^{2} \quad \text { in } B_{\rho / 2},  \tag{2.5}\\
C|y|^{(1+\gamma) \delta}\left|d^{s-1-\delta}\left(x_{0}+y\right)+l^{s-1-\delta}\left(x_{0}+y\right)\right| \quad \text { in } \mathbb{R}^{n} \backslash B_{\rho / 2}
\end{array}\right.
$$

Note that from here, we can compute

$$
\begin{aligned}
\left|L\left(d^{s-1}\right)\left(x_{0}\right)\right|= & \left|L\left(d^{s-1}-l^{s-1}\right)\left(x_{0}\right)\right| \\
\leq & C \rho^{s+\gamma-3} \int_{B_{\rho / 2}}|y|^{2-n-2 s} \mathrm{~d} y \\
& +C \int_{\left(x_{0}+\Omega\right) \backslash B_{\rho / 2}}|y|^{-n-2 s+(1+\gamma) \delta}\left|d^{s-1-\delta}\left(x_{0}+y\right)+l^{s-1-\delta}\left(x_{0}+y\right)\right| \mathrm{d} y \\
\leq & C\left(1+\rho^{\gamma-s-1}+\rho^{\gamma \delta-s-1}\right)
\end{aligned}
$$

where we applied Lemma 2.2 to $d$ and to $l$ with $s-1-\delta=: \gamma<\beta:=2 s-(1+\gamma) \delta($ choosing $\gamma \in(0, s)$ so small that $\beta>0$ ), in order to estimate the third integral. Since this estimate implies the first result, it remain to verify the claim (2.5). In case $x \in B_{\rho / 2}\left(x_{0}\right)$, we estimate

$$
\begin{aligned}
\left|d^{s-1}-l^{s-1}\right|(x) & \leq|d-l|(x)\left\|d^{s-2}+l^{s-2}\right\|_{L^{\infty}\left(B_{\rho / 2}\left(x_{0}\right)\right)} \leq c\left\|D^{2} d\right\|_{L^{\infty}\left(B_{\rho / 2}\left(x_{0}\right)\right)}\left|x_{0}-x\right|^{2} \rho^{s-2} \\
& \leq C \rho^{s+\gamma-3}|y|^{2},
\end{aligned}
$$

where we used that $l \geq c \rho$ in $B_{\rho / 2}\left(x_{0}\right)$, which follows by the same argument as in FeRo24a, the estimates for $D^{2} d$ from [FeRo24a, Lemma B.0.1], and the fact that $d\left(x_{0}\right)=l\left(x_{0}\right)$ and $\nabla d\left(x_{0}\right)=\nabla l\left(x_{0}\right)$ by construction.
Moreover, for $x \in \mathbb{R}^{n} \backslash B_{\rho / 2}\left(x_{0}\right)$, we make use of the following algebraic inequality

$$
\left|a^{s-1}-b^{s-1}\right| \leq|a-b|^{\delta}\left|a^{s-1-\delta}+b^{s-1-\delta}\right|,
$$

for $\delta \in(0, s)$, which allows us to estimate

$$
\begin{aligned}
\left|d^{s-1}(x)-l^{s-1}(x)\right| & \leq|d(x)-l(x)|^{\delta}\left|d^{s-1-\delta}(x)+l^{s-1-\delta}(x)\right| \\
& \leq c\left|x_{0}-x\right|^{(1+\gamma) \delta}| | d^{s-1-\delta}(x)+l^{s-1-\delta}(x) \mid,
\end{aligned}
$$

where we used

$$
|d(x)-l(x)| \leq C\left|x_{0}-x\right|^{1+\gamma}
$$

by FeRo24a, Lemma B.2.2]. This proves the first claim.
Now, we turn to to proof of the second result. First, we observe that by similar arguments as in the first part of the proof, we obtain

$$
\left|d^{\varepsilon+s-1}-l^{\varepsilon+s-1}\right|\left(x_{0}+y\right) \leq\left\{\begin{array}{l}
C \rho^{\varepsilon+s+\gamma-3}|y|^{2} \quad \text { in } B_{\rho / 2}, \\
C|y|^{(1+\gamma) \delta}| | d^{\varepsilon+s-1-\delta}\left(x_{0}+y\right)+l^{\varepsilon+s-1-\delta}\left(x_{0}+y\right) \mid \quad \text { in } \mathbb{R}^{n} \backslash B_{\rho / 2} .
\end{array}\right.
$$

and therefore

$$
\left|L\left(d^{\varepsilon+s-1}-l^{\varepsilon+s-1}\right)\left(x_{0}\right)\right| \leq C\left(1+\rho^{\varepsilon+\gamma-s-1}+\rho^{\varepsilon+\gamma \delta-s-1}\right) .
$$

We claim that for any $e \in \mathbb{S}^{n-1}$ it holds

$$
\left\{\begin{array}{lll}
L\left((x \cdot e)_{+}^{\varepsilon+s-1}\right) & =-c_{e}(x \cdot e)_{+}^{\varepsilon-s-1} & \text { in }\{x \cdot e>0\}  \tag{2.6}\\
(x \cdot e)_{+}^{s-1+\varepsilon} & =0 & \text { in }\{x \cdot e \leq 0\}
\end{array}\right.
$$

for some $c_{e} \in\left[c_{-}, c_{+}\right]$, for some $c_{+}>c_{-}>0$, depending only on $n, s, \lambda, \Lambda$. Note that once we have shown the claim (2.6), we can conclude the proof, since it implies

$$
\begin{aligned}
L\left(d^{\varepsilon+s-1}\right)\left(x_{0}\right) & \leq L\left(l^{\varepsilon+s-1}\right)\left(x_{0}\right)+\left|L\left(d^{\varepsilon+s-1}-l^{\varepsilon+s-1}\right)\left(x_{0}\right)\right| \\
& \leq-c \rho^{\varepsilon-s-1}+C\left(1+\rho^{\varepsilon+\gamma-s-1}+\rho^{\varepsilon+\gamma \delta-s-1}\right) \leq-c \rho^{\varepsilon-s-1}+C
\end{aligned}
$$

Hence, it remains to prove (2.6). By the $2 s$-homogeneity of $L$, we have

$$
L\left((x \cdot e)_{+}^{\varepsilon+s-1}\right)=c_{1}(-\Delta)_{\mathbb{R}}^{s}(x \cdot e)_{+}^{\varepsilon+s-1}=c_{1} c_{2}(x \cdot e)_{+}^{\varepsilon-s-1}
$$

for some constant $c_{1}>0$ and $c_{2} \in \mathbb{R}$, so it remains to prove that $-c_{1} c_{2} \in\left[c_{-}, c_{+}\right]$for some $c_{+}>c_{-}>0$. This will follow immediately, once we show $c_{2}<0$. To see this, we slide the function $t_{+}^{s-1}$ from the left until we touch $t_{+}^{\varepsilon+s-1}$. Indeed, note that for $h>0$ large enough, it holds $(t+h)_{+}^{s-1}<t_{+}^{\varepsilon+s-1}$ for any $t>0$. Then, let us take $h_{0}>0$ to be the smallest positive number such that there exists some $t_{0}>0$ at which the two functions touch, i.e. $\left(t_{0}+h_{0}\right)_{+}^{s-1}=\left(t_{0}\right)_{+}^{\varepsilon+s-1}$. Then, it holds

$$
c_{2}\left(t_{0}\right)_{+}^{\varepsilon+s-1}=(-\Delta)_{\mathbb{R}}^{s}\left(t_{+}^{\varepsilon+s-1}\right)\left(t_{0}\right)<(-\Delta)_{\mathbb{R}}^{s}\left(\left(t+h_{0}\right)_{+}^{s-1}\right)\left(t_{0}\right)=0,
$$

which implies $c_{2}<0$, as desired. This concludes the proof.
The following lemma is crucial in the proofs of Lemma 2.13, and in Section 6, It follows by differentiating the corresponding results in AbRo20.

Lemma 2.4. Let $L \in \mathcal{L}_{s}^{h o m}(\lambda, \Lambda)$. Let $k \in \mathbb{N}$, and $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{k+1, \gamma}$ for some $\gamma \in(0,1)$ with $\gamma \neq s$, and $0 \in \partial \Omega$. Assume that $K \in C^{2 k+2 \gamma+3}\left(\mathbb{S}^{n-1}\right)$. Let $\eta \in C^{k, \gamma}\left(\overline{\Omega \cap B_{1}}\right) \cap C^{\infty}\left(\Omega \cap B_{1}\right)$. Then, there exists $c>0$, depending only on $n, s, \lambda, \Lambda, \Omega, \gamma, k$, such that the following holds true:
(i) If $k=1$ and $\gamma<s$, then

$$
\left|L\left(d^{s-1}(\nabla d) \eta\right)\right| \leq c(|\cdot|+|\eta(0)|+|\nabla \eta(0)|) d^{\gamma-s} \quad \text { in } \bar{\Omega} \cap B_{1 / 2} .
$$

(ii) If $k \geq 2$ or $\gamma>s$, then

$$
\left[L\left(d^{s-1}(\nabla d) \eta\right)\right]_{C^{k-1-s+\gamma}\left(\bar{\Omega} \cap B_{1 / 2}\right)} \leq c(|\cdot|+|\eta(0)|+|\nabla \eta(0)|)
$$

(iii) If $k+\gamma>2 s$, then we have for any $x_{0} \in \Omega \cap B_{1 / 2}$

$$
\left[L\left(d^{s-1}(\nabla d) \eta\right)\right]_{C^{k+\gamma-2 s}\left(B_{d\left(x_{0}\right) / 2}\left(x_{0}\right)\right)} \leq c(|\cdot|+|\eta(0)|+|\nabla \eta(0)|) d^{s-1}\left(x_{0}\right) .
$$

Proof. By AbRo20, Corollary 2.3] (see also Kuk21, Corollary 3.9] for $i>k+1$ ), we deduce that

$$
\begin{equation*}
\left|D^{i} L\left(d^{s} \eta\right)\right| \leq c(|\cdot|+|\eta(0)|) d^{k+\gamma-s-i} \quad \text { in } \bar{\Omega} \cap B_{1 / 2} \forall i \in \mathbb{N} \tag{2.7}
\end{equation*}
$$

Note that by [AbRo20, Theorem 2.2] and the choice of $\psi$ in the proof of AbRo20, Corollary 2.3], it can be seen that the assumption $\eta \in C^{k, \gamma}\left(\overline{\Omega \cap B_{1}}\right) \cap C^{\infty}\left(\Omega \cap B_{1}\right)$ is sufficient for (2.7) to hold true. Let us now prove (i) and assume that $k=1$ and $\gamma<s$. Then, since $D^{i} \eta \in C^{\infty}\left(\mathbb{R}^{n}\right)$, another application of AbRo20, Corollary 2.3] yields

$$
\left\|L\left(d^{s} D^{i} \eta\right)\right\|_{C^{1+\gamma-s}\left(\bar{\Omega} \cap B_{1 / 2}\right)} \leq C \quad \text { for } i \in\{1,2\}
$$

Since $\nabla\left(d^{s} \eta\right)=s d^{s-1}(\nabla d) \eta+d^{s} \nabla \eta$, a combination of the previous two estimates with $i=1$ implies

$$
\left|L\left(d^{s-1}(\nabla d) \eta\right)\right| \leq s^{-1}\left|\nabla L\left(d^{s} \eta\right)\right|+s^{-1}\left|L\left(d^{s} \nabla \eta\right)\right| \leq c(|\cdot|+|\eta(0)|+|\nabla \eta(0)|) d^{\gamma-s} \quad \text { in } \bar{\Omega} \cap B_{1 / 2}
$$

which yields the result in (i).
To see (ii) and (iii), we observe first that by application of (2.7), we have for any $i \in \mathbb{N}$

$$
\left|D^{i} L\left(d^{s}(\nabla \eta)\right)\right| \leq c(|\cdot|+|\nabla \eta(0)|) d^{k+\gamma-s-i} \quad \text { in } \bar{\Omega} \cap B_{1 / 2}
$$

Next, by differentiation, we obtain

$$
D^{i+1}\left(d^{s} \eta\right)=s D^{i}\left(d^{s-1}(\nabla d) \eta\right)+D^{i}\left(d^{s} \nabla \eta\right) .
$$

Thus, altogether for every $i \in \mathbb{N}$

$$
\begin{align*}
\left|D^{i}\left(L\left(d^{s-1}(\nabla d) \eta\right)\right)\right| & \leq s^{-1}\left|D^{i+1} L\left(d^{s} \eta\right)\right|+s^{-1}\left|D^{i} L\left(d^{s}(\nabla \eta)\right)\right| \\
& \leq c(|\cdot|+|\eta(0)|) d^{k+\gamma-s-(i+1)}+c(|\cdot|+|\nabla \eta(0)|) d^{k+\gamma-s-i}  \tag{2.8}\\
& \leq c(|\cdot|+|\eta(0)|+|\nabla \eta(0)|) d^{k+\gamma-s-i-1} \quad \text { in } \bar{\Omega} \cap B_{1 / 2}
\end{align*}
$$

To conclude the proof of (ii) let $x_{0} \in \Omega \cap B_{1 / 2}$, and note that if $k \geq 2$ or $\gamma>s$, then (2.8) applied with $i=k-1+\lceil\gamma-s\rceil$ implies

$$
\begin{aligned}
{\left[L\left(d^{s-1}(\nabla d) \eta\right)\right]_{C^{k-1-s+\gamma}\left(B_{d\left(x_{0}\right) / 2}\left(x_{0}\right)\right)} } & \leq \sup _{x, y \in B_{d_{x_{0}} / 2}\left(x_{0}\right)} \frac{\left\|D^{k-1+\lceil\gamma-s\rceil}\left(L\left(d^{s-1}(\nabla d) \eta\right)\right)\right\|_{L^{\infty}\left(B_{d\left(x_{0}\right) / 2}\left(x_{0}\right)\right)}}{|x-y|^{\gamma-s-\lceil\gamma-s\rceil}} \\
& \leq c(|\cdot|+|\eta(0)|+|\nabla \eta(0)|) d^{\gamma-s-\lceil\gamma-s\rceil}\left(x_{0}\right) d^{s-\gamma+\lceil\gamma-s\rceil}\left(x_{0}\right) \\
& \leq c(|\cdot|+|\eta(0)|+|\nabla \eta(0)|),
\end{aligned}
$$

where we used that $\gamma<1$. From here, a standard covering argument (see [FeRo24a, Lemma A.1.4]) yields the desired regularity estimate in $\bar{\Omega} \cap B_{1 / 2}$.
To prove (iii), note that if $k+\gamma>2 s$, then (2.8) applied with $i=k+\lceil\gamma-s\rceil$ implies

$$
\begin{aligned}
{\left[L\left(d^{s-1}(\nabla d) \eta\right)\right]_{C^{k+\gamma-2 s}\left(B_{d\left(x_{0}\right) / 2}\left(x_{0}\right)\right)} } & \leq \sup _{\left.x, y \in B_{d\left(x_{0}\right) / 2}\left(x_{0}\right)\right)} \frac{\left\|D^{k+\lceil\gamma-s\rceil}\left(L\left(d^{s-1}(\nabla d) \eta\right)\right)\right\|_{L^{\infty}\left(B_{d\left(x_{0}\right) / 2}\left(x_{0}\right)\right)}}{|x-y|^{\gamma-2 s-\lceil\gamma-s\rceil}} \\
& \leq c(|\cdot|+|\eta(0)|+|\nabla \eta(0)|) d^{\gamma-s-1-\lceil\gamma-s\rceil}\left(x_{0}\right) d^{2 s-\gamma+\lceil\gamma-s\rceil}\left(x_{0}\right) \\
& \leq c(|\cdot|+|\eta(0)|+|\nabla \eta(0)|) d^{s-1}\left(x_{0}\right),
\end{aligned}
$$

where we used that $\gamma<1$. This implies (iii), and we conclude the proof.
As a corollary, we obtain the following result:

Corollary 2.5. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $k \in \mathbb{N}$, and $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{k+1, \gamma}$ for some $\gamma \in(0,1)$ with $\gamma \neq s$, and $0 \in \partial \Omega$. Assume that $K \in C^{2 k+2 \gamma+3}\left(\mathbb{S}^{n-1}\right)$. Let $\eta \in C^{k, \gamma}\left(\overline{\Omega \cap B_{1}}\right) \cap C^{\infty}\left(\Omega \cap B_{1}\right)$. Then, there exists $c>0$, depending only on $n, s, \lambda, \Lambda, \Omega, \gamma, k$, such that the following holds true:
(i) If $k=1$ and $\gamma<s$, then

$$
\left|L\left(d^{s-1} \eta\right)\right| \leq c\|\eta\|_{C^{1}\left(\overline{\left.\Omega \cap B_{1 / 2}\right)}\right.} d^{\gamma-s} \quad \text { in } \bar{\Omega} \cap B_{1 / 2} .
$$

(ii) If $k \geq 2$ or $\gamma>s$, then

$$
\left[L\left(d^{s-1} \eta\right)\right]_{C^{k-1-s+\gamma}\left(\bar{\Omega} \cap B_{1 / 2}\right)} \leq c\left(\|\eta\|_{C^{1}\left(\overline{\Omega \cap B_{1 / 2}}\right)}+\|\eta\|_{C^{k-1+s+\gamma}\left(\Omega \cap B_{1}\right)}\right) .
$$

(iii) If $k+\gamma>2 s$, then we have for any $x_{0} \in \Omega \cap B_{1 / 2}$

$$
\left[L\left(d^{s-1} \eta\right)\right]_{C^{k+\gamma-2 s}\left(B_{d\left(x_{0}\right) / 2}\left(x_{0}\right)\right)} \leq c\left(\|\eta\|_{C^{1}\left(\overline{\left.\Omega \cap B_{1 / 2}\right)}\right.}+\|\eta\|_{C^{k+\gamma}\left(\Omega \cap B_{1}\right)}\right) d^{s-1}\left(x_{0}\right) .
$$

Proof. Note that there exist $N \in \mathbb{N}$ and $\delta>0, \nu_{i} \in \mathbb{S}^{n-1}, x_{i} \in \partial \Omega \cap B_{1}$, depending only on $\Omega$, such that $\partial_{\nu_{i}} d \geq 1 / 2$ in $\overline{\Omega \cap B_{\delta}\left(x_{i}\right)}$, for $i \in\{1, \ldots, N\}$, and such that

$$
\left\{x \in \bar{\Omega} \cap B_{1 / 2}: d(x) \leq \delta / 2\right\} \subset \bigcup_{i=1}^{N} B_{\delta}\left(x_{i}\right) .
$$

Then, by application of Lemma 2.4(i) to $\left.\eta:=\left(\partial_{\nu_{i}} d\right)^{-1} \eta \in C^{k, \gamma} \overline{\left(\Omega \cap B_{\delta}\left(x_{i}\right)\right.}\right) \cap C^{\infty}\left(\Omega \cap B_{\delta}\left(x_{i}\right)\right)$, we deduce that for any $i \in\{1, \ldots, N\}$

$$
\left|L\left(d^{s-1} \eta\right)\right| \leq c\left(|\cdot|+\left|\eta\left(x_{i}\right)\right|+\left|\nabla \eta\left(x_{i}\right)\right|\right) d^{\gamma-s} \quad \text { in } \bar{\Omega} \cap B_{\delta / 2}\left(x_{i}\right) .
$$

Thus, we have proved (i) in $\bar{\Omega} \cap B_{1 / 2} \cap\{d(x) \leq \delta / 2\}$. The result in $\bar{\Omega} \cap B_{1 / 2} \cap\{d(x)>\delta / 2\}$ is immediate from the regularity of $K$ (see [FeRo24a, Lemma 2.2.6]).
The proofs of (ii) and (iii) follow from Lemma 2.4 is an analogous way.
2.3. Barriers with boundary blow-up. Let us construct barrier functions that are suitable for establishing maximum principles for solutions that blow up at the boundary. We establish a subsolution and a supersolution in the following two lemmas.
Lemma 2.6. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Then, for any $l \in \mathbb{R}, \varepsilon \in(0, \min \{s, 1-s\})$, and $M>0$ there exists $\phi_{l} \in C^{\infty}(\Omega)$ such that

$$
\left\{\begin{aligned}
L \phi_{l} & \leq-d^{\varepsilon-s-1}-M & & \text { in } \Omega, \\
\phi_{l} & =0 & & \text { in } \mathbb{R}^{n} \backslash \Omega, \\
\phi_{l} / d^{s-1} & =l & & \text { on } \partial \Omega, \\
\partial_{\nu}\left(\phi_{l} / d^{s-1}\right) & =+\infty & & \text { on } \partial \Omega
\end{aligned}\right.
$$

Moreover, if $l \geq 0$, then there exists $\delta \in(0,1)$, depending only on $n, s, \lambda, \Lambda, \operatorname{diam}(\Omega), \varepsilon, M$, such that $\phi_{l} \geq 0$ in $\Omega \cap\{d \leq \delta\}$. And if $l<0$, then for $M$ large enough, depending on $n, s, \lambda, \Lambda, \operatorname{diam}(\Omega), \varepsilon$, it holds $\phi_{l} \leq 0$ in $\Omega$.

Proof. Let $\varepsilon \in(0, s)$ and $N>1$ to be chosen small and large, respectively, later. We set

$$
\phi_{l}(x):=l d^{s-1}(x)+d^{s-1+\varepsilon}(x)-N \mathbb{1}_{\Omega}(x) .
$$

Then, by Lemma 2.3,

$$
L \phi_{l} \leq c_{1} l d^{\delta \gamma-s-1}-c_{2} d^{\varepsilon-s-1}+c_{3}-N L \mathbb{1}_{\Omega} .
$$

Note that since $L \mathbb{1}_{\Omega} \geq 0$, by taking any $\delta \in(0, s)$ and then $\varepsilon<\delta \gamma$, we see that there exists $\eta>0$, depending on $s, l, \varepsilon, M, \delta, \gamma$, such that

$$
L \phi_{l} \leq-d^{\varepsilon-s-1}-M \quad \text { in } \Omega \cap\{d<\eta\} .
$$

Moreover, note that there exists $c_{4}>0$, depending on $\operatorname{diam}(\Omega)$, such that $L \mathbb{1}_{\Omega} \geq c_{4}$ in $\Omega \cap\{d \geq \eta\}$. Thus, choosing $N=M c_{4}^{-1}$, we deduce that

$$
L \phi_{l} \leq-d^{\varepsilon-s-1}-M \quad \text { in } \Omega,
$$

as desired. Next, we observe that since $\left(\phi_{l} / d^{s-1}\right)\left(x_{0}\right)=l$ for any $x_{0} \in \partial \Omega \cap B_{1}$ :

$$
\partial_{\nu}\left(\phi_{l} / d^{s-1}\right)\left(x_{0}\right)=\lim _{x \rightarrow x_{0}} \frac{\frac{\phi_{l}(x)}{d^{s-1}(x)}-l}{d(x)}=\lim _{x \rightarrow x_{0}} \frac{d^{\varepsilon}-N d^{1-s}}{d(x)}=\lim _{x \rightarrow x_{0}}\left(d^{\varepsilon-1}-N d^{-s}\right)=\infty,
$$

if we choose $\varepsilon<1-s$. The remaining properties of $\phi_{l}$ follow immediately from its construction.
Lemma 2.7. Let $L \in \mathcal{L}_{s}^{h o m}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Then, there is $c_{1}>0$, depending only on $n, s, \lambda, \Lambda$, such that for any $l \in \mathbb{R}, \varepsilon \in$ $(0, \min \{s \gamma, 1-s\})$, and $M>0$ there exists $\psi_{l} \in C^{\infty}(\Omega)$ such that

$$
\left\{\begin{aligned}
L \psi_{l} & \geq c_{1} d^{\varepsilon-s-1}+M & & \text { in } \Omega, \\
\psi_{l} & =0 & & \text { in } \mathbb{R}^{n} \backslash \Omega, \\
\psi_{l} / d^{s-1} & =l & & \text { on } \partial \Omega, \\
\partial_{\nu}\left(\psi_{l} / d^{s-1}\right) & =-\infty & & \text { on } \partial \Omega .
\end{aligned}\right.
$$

Moreover, for any $M>0$, if $l>0$ is large enough, depending only on $n, s, \lambda, \Lambda, \operatorname{diam}(\Omega), \varepsilon$, it holds $\psi_{l} \geq 0$ in $\Omega$.

Proof. The proof is similar to the one of Lemma 2.6. We set

$$
\psi_{l}(x)=l d^{s-1}(x)-d^{s-1+\varepsilon}(x)+C_{2} \mathbb{1}_{\bar{\Omega}}(x)
$$

for some $\varepsilon<\delta \gamma$ and $l, C_{2}>0$ to be chosen later. Note that by Lemma 2.3:

$$
L \psi_{l} \geq-c_{1} l d^{\delta \gamma-s-1}+c_{2} d^{\varepsilon-s-1}-c_{3}+c_{4} C_{2} \quad \text { in } \Omega
$$

for some constants $c_{1}, c_{2}, c_{3}, c_{4}>0$, depending only on $n, s, \lambda, \Lambda$, and the $C^{1, \gamma}$ radius of $\Omega$. Thus, if we choose $C_{2}>0$ large enough, depending on $M, l, c_{1}, c_{2}, c_{3}, c_{4}, \varepsilon, \operatorname{diam}(\Omega)$, then we deduce

$$
L \psi_{l} \geq c d^{\varepsilon-s-1}+M \quad \text { in } \Omega .
$$

Moreover, note that for any $x_{0} \in \partial \Omega$ it holds since $\psi / d^{s-1}=l$ on $\partial \Omega$ :

$$
\begin{aligned}
\partial_{\nu}\left(\psi_{l} / d^{s-1}\right)\left(x_{0}\right) & =\lim _{x \rightarrow x_{0}} \frac{\frac{\psi_{l}(x)}{d^{s-1}(x)}-l}{d(x)}=\lim _{x \rightarrow x_{0}} \frac{l-d^{\varepsilon}(x)+C_{2} d^{1-s}(x)-l}{d(x)} \\
& =\lim _{x \rightarrow x_{0}}\left(-d^{\varepsilon-1}(x)+C_{2} d^{-s}(x)\right)=-\infty,
\end{aligned}
$$

if we choose $\varepsilon<1-s$. Finally, we observe that upon choosing $l>0$ large enough, depending only on $\varepsilon$, $\operatorname{diam}(\Omega)$, we have

$$
\psi_{l} \geq l d^{s-1}-d^{s-1+\varepsilon} \geq 0 \quad \text { in } \Omega
$$

2.4. Nonlocal equations up to a polynomial. We will need the following definition of nonlocal equations that hold true up to a polynomial. It was introduced in DSV19 for the fractional Laplacian and the theory was extended in [DDV22] to general nonlocal operators (see also [AbRo20]).
Definition 2.8. For $k \in \mathbb{N}$, a bounded domain $\Omega \subset \mathbb{R}^{n}, f \in C(\Omega)$, and $K \in C^{k-1+\delta}\left(\mathbb{S}^{n-1}\right)$ for some $\delta>0$, we say that a function $u \in C(\Omega) \cap L_{2 s+k}^{1}\left(\mathbb{R}^{n}\right)$ solves in the viscosity sense

$$
L u \stackrel{k}{=} f \text { in } \Omega,
$$

if there exist polynomials $\left(p_{R}\right)_{R>1} \in \mathcal{P}_{k-1}$ of degree $k-1$, and functions $\left(f_{R}\right)_{R>1}$ such that

$$
\begin{aligned}
L\left(u \mathbb{1}_{B_{R}}\right)= & f_{R}+p_{R} \quad \text { in } \Omega, \quad \forall R>\operatorname{diam}(\Omega), \\
& \left\|f_{R}-f\right\|_{L^{\infty}(\Omega)} \rightarrow 0 \quad \text { as } R \rightarrow \infty .
\end{aligned}
$$

Remark 2.9. - $L u={ }^{0} f$ is equivalent to $L u=f$ (see [DDV22, Corollary 2.13]).

- Instead of $K \in C^{k}\left(\mathbb{S}^{n-1}\right)$, here we only assume $K \in C^{k-1+\delta}\left(\mathbb{S}^{n-1}\right)$ for some $\delta>0$. It is easy to see that all the arguments in DDV22 remain valid under this weaker assumption. We decided to make this change in order to have optimal assumptions on $K$ in Theorem 1.7.
- As in AbRo20, we assume uniform convergence $f_{R} \rightarrow f$. This is slightly different from [DSV19, where pointwise convergence was assumed.

The following lemma is a slight improvement of AbRo20, Lemma 3.6] (see also [RTW23, Lemma 8.1]) in the sense that the estimate involves a weighted $L^{1}$ norm instead of a weighted $L^{\infty}$ norm.
Lemma 2.10. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $u \in C\left(B_{1}\right)$ be a viscosity solution to

$$
L u=f \quad \text { in } B_{1} .
$$

Then, the following holds true:
(i) Let $\beta \in(0,2 s]$ if $s \neq 1 / 2$ and $\beta \in(0,1)$ if $s=1 / 2$. If $f \in C\left(B_{1}\right)$ and $u \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$, then it holds $u \in C_{l o c}^{\beta}\left(B_{1}\right)$ and

$$
\|u\|_{C^{\beta}\left(B_{1 / 2}\right)} \leq c\left(\|u\|_{L^{\infty}\left(B_{1}\right)}+\int_{\mathbb{R}^{n} \backslash B_{1}} \frac{|u(y)|}{|y|^{n+2 s}} \mathrm{~d} y+\|f\|_{L^{\infty}\left(B_{1}\right)}\right)
$$

for some $c>0$, depending only on $n, s, \lambda, \Lambda, \beta$.
(ii) If $f \in C^{\alpha}\left(B_{1}\right)$ for some $\alpha>0$ such that $2 s+\alpha \notin \mathbb{N}, K \in C^{\alpha}\left(\mathbb{S}^{n-1}\right)$, and $u \in L_{2 s+\alpha}^{1}\left(\mathbb{R}^{n}\right)$ then $u \in C_{l o c}^{2 s+\alpha}\left(B_{1}\right)$ and

$$
\|u\|_{C^{2 s+\alpha}\left(B_{1 / 2}\right)} \leq c\left(\|u\|_{L^{\infty}\left(B_{1}\right)}+\int_{\mathbb{R}^{n} \backslash B_{1}} \frac{|u(y)|}{|y|^{n+2 s+\alpha}} \mathrm{d} y+[f]_{C^{\alpha}\left(B_{1}\right)}\right)
$$

for some $c>0$, depending only on $n, s, \lambda, \Lambda, \alpha$.
Remark 2.11. From the proof it is apparent, that Lemma 2.10(ii) remains true if $L u \stackrel{k}{=} f$ for $k<\alpha$.
Proof. Statement (i) was proved in [FeRo24a, Theorem 2.4.3]. The $L^{\infty}$ norm can be replaced by the $L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ norm by a standard truncation argument. Let us now show (ii). We restrict ourselves to proving the result in case $\alpha<1$. The case $\alpha>1$ goes in the same way by considering higher order incremental quotients in the arguments below. Let us define $v=u \mathbb{1}_{B_{1}}$. We claim that $v$ solves $L v=\tilde{f}$ in $B_{3 / 4}$ for some $\tilde{f} \in C^{2 s+\alpha}\left(B_{3 / 4}\right)$ with

$$
\begin{equation*}
\|\tilde{f}\|_{C^{\alpha}\left(B_{3 / 4}\right)} \leq C\left(\|u\|_{L^{\infty}\left(B_{1}\right)}+\int_{\mathbb{R}^{n} \backslash B_{1}} \frac{|u(y)|}{|y|^{n+2 s+\alpha}} \mathrm{d} y+[f]_{C^{\alpha}\left(B_{3 / 4}\right)}\right) \tag{2.9}
\end{equation*}
$$

Note that this claim is a slight improvement of [AbRo20, Lemma 3.6] (see also [RTW23, Lemma 8.1]) in the sense that the second term in the estimate is an $L^{1}$ norm instead of an $L^{\infty}$ norm. This can be achieved a follows. First, observe that for any $h \in B_{3 / 4}$ and $x \in B_{\frac{3}{4}-|h|}$, using that $K \in C^{\alpha}\left(\mathbb{S}^{n-1}\right)$ :

$$
\begin{aligned}
\left|L\left(u \mathbb{1}_{\mathbb{R}^{n} \backslash B_{1}}\right)(x)-L\left(u \mathbb{1}_{\mathbb{R}^{n} \backslash B_{1}}\right)(x+h)\right| & \leq|h|^{\alpha} \int_{\mathbb{R}^{n} \backslash B_{1}}|u(y)| \frac{|K(x-y)-K(x+h-y)|}{|h|^{\alpha}} \mathrm{d} y \\
& \leq c|h|^{\alpha} \int_{\mathbb{R}^{n} \backslash B_{1}} \frac{|u(y)|}{|y|^{n+2 s+\alpha}} \mathrm{d} y .
\end{aligned}
$$

Therefore, since we can add and subtract constants to $\tilde{f}$ without affecting the left hand side of the next estimate, for any $h \in B_{3 / 4}$ it holds:

$$
\begin{equation*}
\|\tilde{f}-\tilde{f}(\cdot+h)\|_{L^{\infty}\left(B_{\frac{3}{4}-|h|}\right)} \leq C\left(\underset{B_{3 / 4}}{\operatorname{osc}} f+|h|^{\alpha} \int_{\mathbb{R}^{n} \backslash B_{1}} \frac{|u(y)|}{|y|^{n+2 s+\alpha}} \mathrm{d} y\right) . \tag{2.10}
\end{equation*}
$$

From here, proceeding as in the proof of [AbRo20, Lemma 3.6] (see also [RTW23, Lemma 8.1]), we deduce that we can write $\tilde{f}=g+p$ for some $g \in L^{\infty}\left(B_{3 / 4}\right)$ and a polynomial $p$. By the same arguments as in AbRo20, Lemma 3.6], RTW23, Lemma 8.1] we deduce suitable estimates for $p$ yielding after combination with (2.10):

$$
\|\tilde{f}\|_{L^{\infty}\left(B_{3 / 4}\right)} \leq C\left(\|u\|_{L^{\infty}\left(B_{1}\right)}+\int_{\mathbb{R}^{n} \backslash B_{1}} \frac{|u(y)|}{|y|^{n+2 s+\alpha}} \mathrm{d} y+\underset{B_{3 / 4}}{\operatorname{osc}} f\right) .
$$

Finally, as a direct consequence of (2.10), we deduce

$$
[\tilde{f}]_{C^{\alpha}\left(B_{3 / 4}\right)} \leq C\left(\|u\|_{L^{\infty}\left(B_{1}\right)}+\int_{\mathbb{R}^{n} \backslash B_{1}} \frac{|u(y)|}{|y|^{n+2 s+\alpha}} \mathrm{d} y+[f]_{C^{\alpha}\left(B_{3 / 4}\right)}\right)
$$

which yields the claim (2.9).
Thus, by application of the interior regularity estimate [FeRo24a, Theorem 2.4.1] to $v$, we obtain

$$
\begin{aligned}
\|u\|_{C^{2 s+\alpha}\left(B_{1 / 2}\right)} & =\|v\|_{C^{2 s+\alpha}\left(B_{1 / 2}\right)} \leq c\left(\|v\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}+\|\tilde{f}\|_{C^{\alpha}\left(B_{3 / 4}\right)}\right) \\
& \leq c\left(\|u\|_{L^{\infty}\left(B_{1}\right)}+\int_{\mathbb{R}^{n} \backslash B_{1}} \frac{|u(y)|}{|y|^{n+2 s+\alpha}} \mathrm{d} y+[f]_{C^{\alpha}\left(B_{3 / 4}\right)}\right),
\end{aligned}
$$

as desired.

Next, we provide a lemma stating that equations up to a polynomial can be differentiated in the same way as classical nonlocal equations. This lemma will be used in the proof of Lemma 5.3,

Lemma 2.12. Let $L \in \mathcal{L}_{s}^{h o m}(\lambda, \Lambda)$. Let $k \in \mathbb{N}, f \in C^{1}\left(B_{1}\right)$, and $K \in C^{k+\delta}\left(\mathbb{S}^{n-1}\right)$ for some $\delta>0$. Let $u \in C\left(B_{1}\right) \cap L_{2 s+k+\delta}^{1}\left(\mathbb{R}^{n}\right)$ with $\partial_{i} u \in L_{2 s+k-1+\delta}^{1}\left(\mathbb{R}^{n}\right)$. Then, it holds

$$
L u \stackrel{k+1}{=} f \quad \text { in } B_{1}
$$

and $\partial_{i} f_{R} \rightarrow \partial_{i} f$, if and only if

$$
L\left(\partial_{i} u\right) \stackrel{k}{=} \partial_{i} f \quad \text { in } B_{1} .
$$

Proof. Let us assume first that $\partial_{i} u \in L_{2 s+k-1+\delta}^{1}\left(\mathbb{R}^{n}\right)$, and assume that $L u \stackrel{k+1}{=} f$ in $B_{1}$. Then, there exist polynomials $p_{R} \in \mathcal{P}_{k}$ and functions $f_{R} \in L^{\infty}\left(B_{1}\right)$ with $f_{R} \rightarrow f$ such that

$$
L\left(u \mathbb{1}_{B_{R}}\right)=f_{R}+p_{R} \quad \text { in } B_{1} .
$$

Let us now consider difference quotients $D_{i}^{h} u(x)=\frac{u\left(x+e_{i} h\right)-u(x)}{|h|}$ and compute

L\left(D_{i}^{h} u \mathbb{1}_{B_{R}}\right)=L\left(D_{i}^{h}\left(u \mathbb{1}_{B_{R}}\right)\right)-L\left(u D_{i}^{h} \mathbb{1}_{B_{R}}\right)=D_{i}^{h} f_{R}+D_{i}^{h} p_{R}-L\left(u D_{i}^{h} \mathbb{1}_{B_{R}}\right),
$$

where, by carefully following the proof of DDV22, Theorem 2.1], we can decompose

$$
-L\left(u D_{i}^{h} \mathbb{1}_{B_{R}}\right)(x)=\int_{\mathbb{R}^{n} \backslash B_{3}} u D_{i}^{h} \mathbb{1}_{B_{R}}(y) K(x-y) \mathrm{d} y=d_{R, h}(x)+g_{R, h}(x)
$$

for functions $g_{R, h}$ such that

$$
g_{R, h}(x)=\int_{\mathbb{R}^{n}} D_{i}^{h}\left(\mathbb{1}_{B_{R}}\right)(y) u(y) \psi(x, y) \mathrm{d} y=-\int_{B_{R}}\left(D_{-h}^{i} u(y) \psi(x, y)+u(y) D_{-h}^{i} \psi(x, y)\right) \mathrm{d} y
$$

for some function $\psi: B_{1} \times\left(\mathbb{R}^{n} \backslash B_{3}\right) \rightarrow \mathbb{R}$ such that

$$
\sup _{x \in B_{1}} \psi(x, y) \leq C \sup _{x \in B_{1}}(1+|x-y|)^{-(n+2 s+k-1+\delta)}, \quad \sup _{x \in B_{1}}\left|\nabla_{y} \psi(x, y)\right| \leq C \sup _{x \in B_{1}}(1+|x-y|)^{-(n+2 s+k+\delta)},
$$ and polynomials $d_{R, h} \in \mathcal{P}_{k-1}$ with

$$
d_{R, h}(x)=\sum_{|\alpha| \leq k-1} \kappa_{\alpha, h} x^{\alpha}, \quad \kappa_{\alpha, h}=c_{\alpha} \int_{B_{R}} D_{-h}^{i}\left[u(y) \partial_{x}^{\alpha} K(x-y)\right] \mathrm{d} y, \quad c_{\alpha} \in \mathbb{R} .
$$

Clearly, it holds $g_{R, h} \rightarrow g_{R}$, and $d_{R, h} \rightarrow d_{R}$, as $R \rightarrow \infty$, where

$$
g_{R}(x)=\int_{B_{R}} \partial_{i}[u(y) \psi(x, y)] \mathrm{d} y, \quad d_{R}(x)=\sum_{|\alpha| \leq k-1} \kappa_{\alpha} x^{\alpha}, \quad \kappa_{\alpha}=c_{\alpha} \int_{B_{R}} \partial_{i}\left[u(y) \partial_{x}^{\alpha} K(x-y)\right] \mathrm{d} y .
$$

Note that for the convergence $g_{R, h} \rightarrow g_{R}$ we are using that for any $x \in B_{1}$

$$
\begin{aligned}
\mid \mathbb{1}_{B_{R}}(y) & \left(D_{-h}^{i} u(y) \psi(x, y)+\mathbb{1}_{B_{R}}(y) u(y) D_{-h}^{i} \psi(x, y)\right) \mid \\
\quad \leq & C\left|\partial_{i} u(y)\right| \sup _{x \in B_{1}}(1+|x-y|)^{-(n+2 s+k-1+\delta)}+C|u(y)| \sup _{x \in B_{1}}(1+|x-y|)^{-(n+2 s+k+\delta)} \in L^{1}\left(\mathbb{R}^{n}\right)
\end{aligned}
$$

and dominated convergence. Moreover, from integrating by parts, we see that it holds for any $x \in B_{1}$
$\int_{2}^{\infty} R^{-1}\left|g_{R}^{(2)}(x)\right| \mathrm{d} R \leq \int_{2}^{\infty} R^{-1} \int_{\partial B_{R}}\left|u(y)\left\|x-\left.y\right|^{-(n+2 s+k-1+\delta)} \mathrm{d} y \mathrm{~d} R \leq c \int_{B_{2}^{c}}|u(y) \| y|^{-(n+2 s+k+\delta)} \mathrm{d} y<\infty\right.\right.$,
which implies that $g_{R}(x) \rightarrow 0$, as $R \rightarrow \infty$, uniformly in $x$.
Altogether, we have shown

$$
L\left(\partial_{i} u \mathbb{1}_{B_{R}}\right)=\lim _{h \rightarrow 0} D_{i}^{h} f_{R}+\lim _{h \rightarrow 0} D_{i}^{h} p_{R}+\lim _{h \rightarrow 0} d_{R, h}+\lim _{h \rightarrow 0} g_{R, h}=\partial_{i} f_{R}+\partial_{i} p_{R}+d_{R}+g_{R},
$$

which implies that

$$
L\left(\partial_{i} u \mathbb{1}_{B_{R}}\right) \stackrel{k}{=} f \quad \text { in } B_{1},
$$

as desired.
Let us now show the other implication, i.e., assume that $L\left(\partial_{i} u\right) \stackrel{k}{=} \partial_{i} f$ in $B_{1}$. Then, by DDV22 we observe that there are $F_{R}: \mathbb{R}^{n} \rightarrow \mathbb{R}$, and $P_{R} \in \mathcal{P}_{k}$ such that

$$
L\left(u \mathbb{1}_{B_{R}}\right)=F_{R}+P_{R} \quad \text { in } B_{1} .
$$

Clearly, by the same arguments as above, we have

$$
L\left(\left(D_{i}^{h} u\right) \mathbb{1}_{B_{R}}\right)=D_{i}^{h} L\left(u \mathbb{1}_{B_{R}}\right)-L\left(u D_{i}^{h} \mathbb{1}_{B_{R}}\right)=D_{i}^{h} F_{R}+D_{i}^{h} P_{R}+d_{R, h}+g_{R, h}
$$

with $D_{i}^{h} P_{R}+d_{R, h} \in \mathcal{P}_{k-1}$ and $g_{R, h} \rightarrow g_{R}$, as $h \rightarrow 0$ with $g_{R} \rightarrow 0$, as $R \rightarrow \infty$. Thus, by the stability for viscosity solutions up to a polynomial (see [AbRo20]), we have that

$$
f_{R}+p_{R}=L\left(\partial_{i} u \mathbb{1}_{B_{R}}\right)=\partial_{i} F_{R}+\partial_{i} P_{R}+d_{R}+g_{R}
$$

where $d_{R}, p_{R}, \partial_{i} P_{R} \in \mathcal{P}_{k-1}$. Hence, after integrating the previous identity in $x_{i}$ and denoting $\tilde{F}_{R}(x)=$ $\int_{-\infty}^{x_{i}}\left(f_{R}-g_{R}\right)\left(x^{\prime}, y_{i}\right) \mathrm{d} y$, we can deduce:

$$
F_{R}=\tilde{F}_{R}+\tilde{P}_{R} \quad \text { in } B_{1}
$$

where $\tilde{P}_{R} \in \mathcal{P}_{k}$ is such that $\partial_{i} \tilde{P}_{R}=p_{R}-d_{R}-\partial_{i} P_{R}$. Then, since $f_{R} \rightarrow f$ and $g_{R} \rightarrow 0$, as $R \rightarrow \infty$, we deduce that $\tilde{F}_{R} \rightarrow F$, where $\partial_{i} F=f$, and the proof is complete.
2.5. Two lemmas on viscosity solutions. In this section, we prove two auxiliary lemmas for viscosity solutions to nonlocal equations with local Neumann boundary data, namely a stability result, and that sums of viscosity subsolutions are again viscosity subsolutions. Both results are standard for nonlocal equations in the interior of the solution domain (see [FeRo24a]). However, since we consider equations at the boundary, where solutions satisfy a Neumann condition in the viscosity sense, both results require a proof. Both proofs heavily rely on the interaction of nonlocal operators with the distance function and the results in Subsection 2.2.

First, we prove a stability result, which will be crucial in the blow-up argument of our proof of the higher boundary regularity.

Lemma 2.13. Let $k \in \mathbb{N} \cup\{0\}$, $\gamma \in(0,1)$ with $\gamma \neq s$, and $\Omega_{j} \subset \mathbb{R}^{n}$ be open, bounded domains with $\partial \Omega_{j} \in C^{2, \gamma}$ such that $0 \in \partial \Omega_{j}, \nu_{0}=e_{n}$ for any $j \in \mathbb{N}$, and such that the $C^{2, \gamma}$ radii of $\Omega_{j}$ and $\operatorname{diam}\left(\Omega_{j}\right)$ are uniformly bounded. Given a sequence $r_{j} \searrow 0$, we set $\tilde{\Omega}_{j}=r_{j}^{-1} \Omega_{j}$ and $\tilde{d}_{j}:=d_{\Omega_{j}}$. Let $v_{j} \in L_{2 s+k}^{1}\left(\mathbb{R}^{n}\right)$ with $v_{j} / \tilde{d}_{j}^{s-1} \in C\left(\overline{\tilde{\Omega}_{j}}\right)$ be viscosity solutions to

$$
\left\{\begin{array}{rll}
L_{j} v_{j} & \stackrel{k}{=} f_{j} & \text { in } \tilde{\Omega}_{j} \cap B_{1}, \\
v_{j} & =0 & \text { in } \mathbb{R}^{n} \backslash \tilde{\Omega}_{j}, \\
\partial_{\nu}\left(v_{j} / \tilde{d}_{j}^{s-1}\right) & =g_{j} & \text { on } \partial \tilde{\Omega}_{j} \cap B_{1},
\end{array}\right.
$$

where $f_{j} \in C\left(\tilde{\Omega}_{j} \cap B_{1}\right)$, $g_{j} \in C\left(\partial \tilde{\Omega}_{j} \cap B_{1}\right)$, and $\left(L_{j}\right)_{j} \subset \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda, k-1+\alpha)$ for some $\alpha>0$. Moreover, assume that there are $v \in L_{2 s+k}^{1}\left(\mathbb{R}^{n}\right)$ with $v /\left(x_{n}\right)_{+}^{s-1} \in C\left(\left\{x_{n} \geq 0\right\}\right), f \in C\left(\left\{x_{n}>0\right\} \cap B_{1}\right)$, $g \in C\left(\left\{x_{n}=0\right\} \cap B_{1}\right), L \in \mathcal{L}_{s}^{h o m}(\lambda, \Lambda, k-1+\alpha)$, and $\varepsilon_{j} \searrow 0, q_{j} \in \mathcal{P}_{k}$ such that

$$
\begin{aligned}
v_{j} / \tilde{d}_{j}^{s-1} & \rightarrow v /\left(x_{n}\right)_{+}^{s-1} & & \text { in } L_{l o c}^{\infty}\left(B_{1}\right), \\
v_{j} & \rightarrow v & & \text { in } L_{2 s+k}^{1}\left(\mathbb{R}^{n}\right), \\
\left|f_{j}-p_{j}-f\right| & \rightarrow 0 & & \text { in } L_{l o c}^{\infty}\left(B_{1} \cap\left\{x_{n}>0\right\}\right), \\
\left|g_{j}-q_{j}-g\right|(x) \leq c \varepsilon_{j} & \rightarrow 0 & & \forall x \in \partial \tilde{\Omega}_{j} \cap B_{1}, \\
K_{j} & \rightarrow K & & \text { in } C^{k-1+\alpha}\left(\mathbb{S}^{n-1}\right) .
\end{aligned}
$$

Then, there exists $q \in \mathcal{P}_{k}$ such that $v$ is a viscosity solution to

$$
\left\{\begin{aligned}
L v & \stackrel{k}{=} f & & \text { in } B_{1} \cap\left\{x_{n}>0\right\} \\
v & =0 & & \text { in } \mathbb{R}^{n} \backslash\left\{x_{n}>0\right\} \\
\partial_{n}\left(v /\left(x_{n}\right)_{+}^{s-1}\right) & =g+q & & \text { on } B_{1} \cap\left\{x_{n}=0\right\}
\end{aligned}\right.
$$

If $k=0$, the same result holds with $\tilde{d}_{j}^{s-\gamma} f_{j} \in L^{\infty}\left(\tilde{\Omega}_{j} \cap B_{1}\right)$ and $\left(x_{n}\right)_{+}^{s-\gamma} f \in L^{\infty}\left(\left\{x_{n}>0\right\} \cap B_{1}\right)$.
Proof. Let us define $u_{j}:=v_{j} / \tilde{d}_{j}^{s-1}$ and $u:=v /\left(x_{n}\right)_{+}^{s-1}$. Note that since $u_{j} \rightarrow u$ in $L_{l o c}^{\infty}\left(B_{1}\right)$ it follows that $v_{j}=\tilde{d}_{j}^{s-1} u_{j} \rightarrow\left(x_{n}\right)_{+}^{s-1} u=v$ in $L_{\text {loc }}^{\infty}\left(B_{1} \cap\left\{x_{n}>0\right\}\right)$. This property is enough to apply the proof of the stability of viscosity solutions in [FeRo24a, Proposition 3.2.12] to $v_{j}$ and $v$. The higher order version which we require here follows in the same way as in AbRo20, Lemma 3.5]. Since $v_{j} \rightarrow v$ in $L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$, we also have that $v=0$ in $B_{1} \backslash\left\{x_{n}>0\right\}$. Consequently, it only remains to prove the convergence of the Neumann boundary condition.
To do so, let $x_{0} \in B_{1} \cap\left\{x_{n}=0\right\}$. In case $k \geq 1$, we first truncate $v$ and $v_{j}$ in $B_{2}\left(x_{0}\right)$ and apply [AbRo20, Lemma 3.6] to obtain the equations satisfied by $v \mathbb{1}_{B_{2}}\left(x_{0}\right)$ and $v_{j} \mathbb{1}_{B_{2}}\left(x_{0}\right)$. In order not to over-complicate the notation, let us denote the truncations still by $v$ and $v_{j}$ and the corresponding source terms by $f$ and $f_{j}$. Then, let $\phi \in C^{2}\left(B_{r}\left(x_{0}\right)\right)$ for some $r \in(0,1)$ with $\phi \leq u$ in $B_{r}\left(x_{0}\right)$, $\phi\left(x_{0}\right)=u\left(x_{0}\right)$, and $\phi \equiv u$ in $\mathbb{R}^{n} \backslash \overline{B_{r}\left(x_{0}\right)}$ be a test function. Given $\delta \in(0,1), \eta \in(0, \gamma)$, we define now

$$
\psi^{(\delta)}(x)=-\delta \mathbb{1}_{B_{r}\left(x_{0}\right)}(x)\left[\left(x_{n}\right)_{+}-\left(x_{n}\right)_{+}^{1+\eta}\right], \quad \psi_{j}^{(\delta)}(x)=-\delta \mathbb{1}_{B_{r}\left(x_{0}\right)}(x)\left[\tilde{d}_{j}(x)-\tilde{d}_{j}^{1+\eta}(x)\right] .
$$

Note that there exist $C>0$ and $\varepsilon \in(0, r / 2)$, independent of $\delta, j$, such that

$$
\begin{equation*}
L_{j}\left(\tilde{d}_{j}^{s-1} \psi_{j}^{(\delta)}\right) \leq-C \delta \tilde{d}_{j}^{\eta-s} \quad \text { in } \tilde{\Omega}_{j} \cap B_{\varepsilon}\left(x_{0}\right) . \tag{2.11}
\end{equation*}
$$

This is due to [FeRo24a, Proposition B.2.1, Lemma B.2.6, Corollary B.2.8], and since $\tilde{\Omega}_{j} \cap B_{R}\left(x_{0}\right)$ and the respective $C^{2, \gamma}$-radii of $\tilde{\Omega}_{j}$ are uniformly bounded. Indeed, the aforementioned results yield the existence of $\varepsilon_{0}>0$ such that

$$
-\delta L_{j}\left(\tilde{d}_{j}^{s-1}\left[\tilde{d}_{j}-\tilde{d}_{j}^{1+\eta}\right]\right) \leq-c_{1} \delta \tilde{d}_{j}^{\eta-s} \quad \text { in } \tilde{\Omega}_{j} \cap B_{\varepsilon_{0}}\left(x_{0}\right) .
$$

Moreover, one computes by scaling from $\tilde{\Omega}_{j}$ to $\Omega_{j}$, denoting $d_{j}=d_{\Omega_{j}}$, and applying Lemma 2.2

$$
\begin{align*}
-\delta L_{j}\left(\tilde{d}_{j}^{s-1}\left[\tilde{d}_{j}-\tilde{d}_{j}^{1+\eta}\right] \mathbb{1}_{\mathbb{R}^{n} \backslash B_{r}\left(x_{0}\right)}\right) & \leq c \int_{\tilde{\Omega}_{j} \backslash B_{r}\left(x_{0}\right)}\left(\tilde{d}_{j}^{s}(y)+\tilde{d}_{j}^{s+\eta}(y)\right)|y|^{-n-2 s} \mathrm{~d} y \\
& \leq c \delta \int_{\Omega_{j} \backslash B_{r r_{j}}\left(x_{0}\right)}\left(r_{j}^{s} d_{j}^{s}(y)+r_{j}^{s-\eta} d_{j}^{s+\eta}(y)\right)|y|^{-n-2 s} \mathrm{~d} y  \tag{2.12}\\
& \leq c_{2} \delta\left(1+r^{-s}+r^{\eta-s}\right) \quad \text { in } \tilde{\Omega}_{j} \cap B_{r / 2}\left(x_{0}\right),
\end{align*}
$$

where $c_{2}>0$ might depend on $\operatorname{diam}\left(\Omega_{j}\right)$, which we assumed to be bounded, but not on $j$. Thus, by combination of the previous two computations, we deduce (2.11) upon choosing $\varepsilon<\varepsilon_{0}$ if necessary. Moreover, it is immediate by construction that

$$
\begin{equation*}
\psi^{(\delta)} \leq 0 \quad \text { in } \mathbb{R}^{n} \tag{2.13}
\end{equation*}
$$

Next, we set $\phi^{(\delta)}:=\phi+\psi^{(\delta)}$. Note that for any $\delta>0$, it still holds $\phi^{(\delta)} \leq u$ by (2.13), and $\phi^{(\delta)}\left(x_{0}\right)=u\left(x_{0}\right)$, however $u-\phi^{(\delta)}$ has a strict minimum at $x_{0}$ in $\overline{B_{r}\left(x_{0}\right)}$.
It suffices to prove for any $\delta>0$ small enough

$$
\begin{equation*}
\partial_{n} \phi^{(\delta)}\left(x_{0}\right) \leq g\left(x_{0}\right)+q\left(x_{0}\right), \tag{2.14}
\end{equation*}
$$

since then it follows that $\partial_{n} \phi\left(x_{0}\right)=\partial_{n} \phi^{(\delta)}\left(x_{0}\right)+\delta \leq g\left(x_{0}\right)+q\left(x_{0}\right)+\delta$, and we obtain the desired result upon taking the limit $\delta \searrow 0$.
Let us now construct test functions $\phi_{j}^{(\delta)}$ for any $j \in \mathbb{N}$ as follows

$$
\begin{cases}\phi_{j}^{(\delta)}=u_{j}=u_{j}+\psi_{j}^{(\delta)} & \text { in } \mathbb{R}^{n} \backslash \overline{B_{r}\left(x_{0}\right)}, \\ \phi_{j}^{(\delta)}=\phi+c_{j}+\psi_{j}^{(\delta)} & \text { in } \overline{B_{r}\left(x_{0}\right)},\end{cases}
$$

where

$$
c_{j}=\min \left\{c \in \mathbb{R}: \phi+c+\psi_{j}^{(\delta)} \leq u_{j} \quad \text { in } \overline{B_{r}\left(x_{0}\right)}\right\} .
$$

Since $\psi_{j}^{(\delta)} \rightarrow \psi^{(\delta)}$ (lower half-relaxed limits) in $\overline{B_{r}\left(x_{0}\right)}$, we obtain that $c_{j} \rightarrow 0$, and that there exist $x_{j} \in \overline{B_{r}\left(x_{0}\right)}$ with $x_{j} \rightarrow x_{0}$ such that $\phi_{j}^{(\delta)}\left(x_{j}\right)=u_{j}\left(x_{j}\right)$ and $\phi_{j}^{(\delta)} \leq u_{j}$ by FeRo24a, Lemma 3.2.10 and Proof of Proposition 3.2.12].
Next, we argue that $x_{j} \in \partial \tilde{\Omega}_{j} \cap B_{1}$. Without loss of generality, we can assume that $x_{j} \in B_{\varepsilon}\left(x_{0}\right)$ upon taking $j \in \mathbb{N}$ large enough. In fact, if $x_{j} \in \tilde{\Omega}_{j} \cap B_{\varepsilon}\left(x_{0}\right)$, then we can compute using Corollary 2.5(i), and (2.11)

$$
\begin{align*}
L_{j}\left(\tilde{d}_{j}^{s-1} \phi_{j}^{(\delta)}\right)\left(x_{j}\right)= & L_{j}\left(\tilde{d}_{j}^{s-1} \phi \mathbb{1}_{B_{r}\left(x_{0}\right)}\right)\left(x_{j}\right)+c_{j} L_{j}\left(\tilde{d}_{j}^{s-1} \mathbb{1}_{B_{r}\left(x_{0}\right)}\right)\left(x_{j}\right) \\
& +L_{j}\left(v_{j} \mathbb{1}_{\mathbb{R}^{n} \backslash B_{r}\left(x_{0}\right)}\right)\left(x_{j}\right)+L_{j}\left(\tilde{d}_{j}^{s-1} \psi_{j}^{(\delta)}\right)\left(x_{j}\right) \\
\leq & L_{j}\left(\tilde{d}_{j}^{s-1} \phi\right)+c_{j} L_{j}\left(\tilde{d}_{j}^{s-1}\right)  \tag{2.15}\\
& +L_{j}\left(\tilde{d}_{j}^{s-1} u \mathbb{1}_{\mathbb{R}^{n} \backslash B_{r}\left(x_{0}\right)}\right)+c_{j} L_{j}\left(\tilde{d}_{j}^{s-1} \mathbb{1}_{\mathbb{R}^{n} \backslash B_{r}\left(x_{0}\right)}\right) \\
& \left.+c\left\|v_{j}\right\|_{L_{2 s}} \mathbb{R}^{n}\right)-C \delta \tilde{d}_{j}^{\eta-s}\left(x_{j}\right) \\
\leq & C_{r} \tilde{d}_{j}^{\gamma-s}\left(x_{j}\right)-C \delta \tilde{d}_{j}^{\eta-s}\left(x_{j}\right)
\end{align*}
$$

for some constant $C_{r}>0$, depending also on $\left\|v_{j}\right\|_{L_{2 s}^{1}\left(\mathbb{R}^{n}\right)}$ and $\|v\|_{L_{s s}^{1}\left(\mathbb{R}^{n}\right)}$. Note that to estimate the fourth term in the last estimate, we used an argument similar to (2.12).
Let us now recall that $\eta<\gamma$. Hence, upon making $\varepsilon>0$ even smaller, we can have in $\tilde{\Omega}_{j} \cap B_{\varepsilon}\left(x_{0}\right)$ :

$$
C \delta \tilde{d}_{j}^{\eta-\gamma}>\left(C_{r}+\mathbb{1}_{\{k=0\}}\left\|\tilde{d}_{j}^{s-\gamma} f_{j}\right\|_{L^{\infty}\left(\tilde{\Omega}_{j} \cap B_{1}\right)}+\mathbb{1}_{\{k \geq 1\}}\left\|f_{j}\right\|_{L^{\infty}\left(\tilde{\Omega}_{j} \cap B_{1}\right)}\right)
$$

Then it holds

$$
\begin{equation*}
L_{j}\left(\tilde{d}_{j}^{s-1} \phi_{j}^{(\delta)}\right)\left(x_{j}\right)<-\mathbb{1}_{\{k=0\}} \tilde{d}_{j}^{\gamma-s}\left(x_{j}\right)\left\|\tilde{d}_{j}^{s-\gamma} f_{j}\right\|_{L^{\infty}\left(\tilde{\Omega}_{j} \cap B_{1}\right)}-\mathbb{1}_{\{k \geq 1\}}\left\|f_{j}\right\|_{L^{\infty}\left(\tilde{\Omega}_{j} \cap B_{1}\right)}<f_{j}\left(x_{j}\right) \tag{2.16}
\end{equation*}
$$

However, note that by construction, $\tilde{d}_{j}^{s-1} \phi_{j}^{(\delta)}$ is a valid test function for the equation that is satisfied for $\tilde{d}_{j}^{s-1} u_{j}=v_{j}$ at $x_{j}$. Since we assumed that $x_{j} \in \tilde{\Omega}_{j} \cap B_{1}$, it must hold $L_{j}\left(\tilde{d}_{j}^{s-1} \phi_{j}^{(\delta)}\right)\left(x_{j}\right) \geq f_{j}\left(x_{j}\right)$, which contradicts (2.16).
Therefore, it must be $x_{j} \in \partial \tilde{\Omega}_{j} \cap B_{1}$, as we claimed before. Thus, by the boundary condition

$$
\partial_{\nu_{x_{j}}} \phi_{j}^{(\delta)}\left(x_{j}\right) \leq g_{j}\left(x_{j}\right) .
$$

Passing this inequality to the limit, and using the uniform convergence $\left|g_{j}-q_{j}-g\right| \rightarrow 0, \nu_{x_{j}} \rightarrow \nu_{0}=e_{n}$, and $\tilde{\Omega}_{j} \rightarrow\left\{x_{n}>0\right\}$, we obtain

$$
\partial_{n}\left(\phi^{(\delta)}\left(x_{0}\right)-q\left(x_{0}\right)\right) \leq g\left(x_{0}\right)
$$

where $q \in \mathcal{P}_{k}$ is the limit of the sequence of polynomials $\left(q_{j}\right)_{j}$. Thus, we have $\partial_{n} \phi^{(\delta)}\left(x_{0}\right) \leq g\left(x_{0}\right)+$ $q\left(x_{0}\right)$, i.e., (2.14), as desired. This concludes the proof.

Second, we prove that the difference of two viscosity solutions is again a viscosity subsolution.
Lemma 2.14. Let $k \in \mathbb{N} \cup\{0\}, \Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{2, \gamma}$ for some $\gamma>0$. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda, k-1+\alpha)$ for some $\alpha>0$. Let $v, w \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1}, w / d^{s-1} \in C(\bar{\Omega})$ be
viscosity solutions to

$$
\left\{\begin{array} { r l l l } 
{ L v } & { \stackrel { k } { = } f _ { 1 } } & { \text { in } \Omega , } \\
{ v } & { = } & { 0 } & { \text { in } \mathbb { R } ^ { n } \backslash \Omega , } \\
{ v / d ^ { s - 1 } } & { = } & { g _ { 1 } } & { \text { on } \partial \Omega , }
\end{array} \quad \left\{\begin{array}{rlll}
L w & \stackrel{k}{=} & f_{2} & \text { in } \Omega \\
w & = & 0 & \text { in } \mathbb{R}^{n} \backslash \Omega \\
w / d^{s-1} & = & g_{2} & \text { on } \partial \Omega
\end{array}\right.\right.
$$

for some $f_{1}, f_{2} \in C(\Omega)$ and $g_{1}, g_{2} \in C(\partial \Omega)$. Then, $v-w$ is a viscosity solution to

$$
\left\{\begin{array}{rll}
L(v-w) & \stackrel{k}{=} f_{1}-f_{2} & \\
\text { in } \Omega \\
v-w & =0 & \text { in } \mathbb{R}^{n} \backslash \Omega \\
(v-w) / d^{s-1} & =g_{1}-f_{2} & \text { on } \partial \Omega
\end{array}\right.
$$

Proof. We will only demonstrate the proof in case $k=0$. The general case follows immediately by combining the arguments with the definition Definition 2.8. For the nonlocal equation, the result follows for instance from FeRo24a, Lemma 3.4.14]. For the boundary condition, one can proceed as follows. First, we define the sup- and inf-convolutions $\left(v / d^{s-1}\right)_{\varepsilon}$ and $\left(w / d^{s-1}\right)^{\varepsilon}$ (see [FeRo24a, Lemma 3.2.16]) with $D \subset \Omega$ open, bounded such that $\bar{D} \cap \partial \Omega \neq \emptyset$. Then, by adapting the arguments in [FeRo24a, Proposition 3.2.17], one can show that for any $x \in \partial \Omega \cap \bar{D}$ it holds in the viscosity sense

$$
\begin{equation*}
\partial_{\nu}\left(v / d^{s-1}\right)_{\varepsilon}(x) \leq g_{1}(x)+\delta_{\varepsilon}, \quad \partial_{\nu}\left(w / d^{s-1}\right)^{\varepsilon} \geq g_{2}(x)+\delta^{\varepsilon} \tag{2.17}
\end{equation*}
$$

where $\delta_{\varepsilon}, \delta^{\varepsilon} \rightarrow 0$, as $\varepsilon \rightarrow 0$. Note that once (2.17) is proven, since $\left(v / d^{s-1}\right)_{\varepsilon}$ and $-\left(w / d^{s-1}\right)^{\varepsilon}$ are both semi-concave, we have that at any point $x \in \partial \Omega \cap \bar{D}$, where $\left(v / d^{s-1}\right)_{\varepsilon}-\left(w / d^{s-1}\right)^{\varepsilon}$ can be touched by a paraboloid from below, the functions $\left(v / d^{s-1}\right)_{\varepsilon}$ and $-\left(w / d^{s-1}\right)^{\varepsilon}$ must be in $C^{1,1}$. Hence, by the linearity of $\partial_{\nu}$, and due to (2.17) it must hold $\partial_{\nu}\left(\left(v / d^{s-1}\right)_{\varepsilon}-\left(w / d^{s-1}\right)^{\varepsilon}\right)(x) \leq g_{1}(x)-g_{2}(x)+\delta_{\varepsilon}-\delta^{\varepsilon} \rightarrow 0$, as $\varepsilon \rightarrow 0$. Thus, by the stability for viscosity solutions (which was provided in a significantly more general framework in Lemma 2.13), we deduce that $\partial_{\nu}\left((v-w) / d^{s-1}\right) \leq\left(g_{1}-g_{2}\right)$ in the viscosity sense. In a similar way, one can prove $\partial_{\nu}\left((v-w) / d^{s-1}\right) \geq\left(g_{1}-g_{2}\right)$, and thus, we obtain the desired result. Thus, it remains to give a proof of (2.17). To see it, for any test function $\phi \in C^{2}\left(B_{r}\left(x_{0}\right)\right)$ touching $\left(v / d^{s-1}\right)_{\varepsilon}$ from below at $x_{0} \in \partial \Omega \cap \bar{D}$, we define

$$
\psi^{(\delta)}(x)=-\delta \mathbb{1}_{B_{1}\left(x_{0}\right)}(x)\left[d(x)-d^{1+\eta}(x)\right]
$$

for some $\eta \in(0, \gamma)$ and observe that $\phi^{(\delta)}=\phi+\psi^{(\delta)}$ is still a valid test function, touching $\left(v / d^{s-1}\right)_{\varepsilon}$ (strictly) from below, at $x_{0}$. Then, by the same arguments as in [FeRo24a, Proposition 3.2.17], there exists $x_{\varepsilon} \in \bar{D}$ with $x_{\varepsilon} \in B_{c \varepsilon}\left(x_{0}\right)$ for some $c>0$, depending only on the oscillation of $v / d^{s-1}$, such that $\phi^{(\delta)}\left(\cdot+x_{0}-c+\varepsilon\right)-\varepsilon^{-1}\left|x_{0}-x_{\varepsilon}\right|^{2}$ touches $v / d^{s-1}$ from below at $x_{\varepsilon}$. We observe that $x_{\varepsilon} \notin \Omega$ since otherwise one would get a contradiction with the nonlocal equation satisfied by $v$, in the exact same way as in the proof of (2.16), if $\varepsilon>0$ is small enough. Thus, $x_{\varepsilon} \in \partial \Omega \cap \bar{D}$, and from the boundary condition satisfied by $v$, it follows $\partial_{\nu} \phi^{(\delta)}\left(x_{0}\right) \leq g_{1}\left(x_{\varepsilon}\right)$. Thus, by the definition of $\phi^{(\delta)}$, we have $\partial_{\nu} \phi\left(x_{0}\right)=\partial_{\nu} \phi^{(\delta)}\left(x_{0}\right)+\delta \leq g_{1}\left(x_{\varepsilon}\right)+\delta$ for any $\delta>0$. Thus, sending $\delta \rightarrow 0$ and recalling that $x_{\varepsilon} \rightarrow x_{0}$, as $\varepsilon \rightarrow 0$, this proves the first statement in (2.17) with $\delta_{\varepsilon}=g_{1}\left(x_{\varepsilon}\right)-g_{1}\left(x_{0}\right)$. Analogously, one proves the second claim in (2.17).

## 3. Nonlocal maximum principles with local Dirichlet- and Neumann conditions

In this section, we establish weak maximum principles for nonlocal equations with local Dirichlet- and Neumann data (see Proposition 1.3 and Proposition 1.5).
First, we establish a weak maximum principle for solutions to the inhomogeneous Dirichlet problem in (1.10) (see Proposition 1.3). Its proof goes by sliding the barrier subsolution $\phi$ from Lemma 2.6 underneath $v$ from below.

Proof of Proposition 1.3. By assumption on $v$, we have that $v / d^{s-1} \in C(\bar{\Omega})$ with $v / d^{s-1} \geq 0$ on $\partial \Omega$. Let $z \in \partial \Omega$ be such that $\min _{\partial \Omega} v / d^{s-1}=v / d^{s-1}(z)=: l \geq 0$. Let $\varepsilon \in(0, s)$ and $M>1$ to be chosen later, and recall the subsolution $\phi_{l} \in C(\Omega)$ from Lemma 2.6. We define

$$
c_{0}:=\inf \left\{c \in \mathbb{R}: \phi_{l} / d^{s-1}-c \leq v / d^{s-1} \text { in } \bar{\Omega}\right\} .
$$

Since also $\phi_{l} / d^{s-1} \in C(\bar{\Omega})$, the above set is nonempty and $c_{0}<\infty$. In fact, recalling the definition of $\phi_{l}$, it must be

$$
\begin{equation*}
c_{0} \leq\left\|v / d^{s-1}\right\|_{L^{\infty}(\bar{\Omega})}+\left\|\left(\phi_{l}\right)_{+} / d^{s-1}\right\|_{L^{\infty}(\bar{\Omega})} \leq\left\|v / d^{s-1}\right\|_{L^{\infty}(\bar{\Omega})}+l+c|\operatorname{diam}(\Omega)|^{\varepsilon} \tag{3.1}
\end{equation*}
$$

which is independent of $M$. Moreover, since $\phi_{l} / d^{s-1}(z)=l=v / d^{s-1}(z)$, we have that $c_{0} \geq 0$. Then, in particular, we have

$$
\phi_{l} / d^{s-1}-c_{0} \leq v / d^{s-1} \quad \text { in } \mathbb{R}^{n}, \quad \text { and } \quad \phi_{l} / d^{s-1}\left(x_{0}\right)-c_{0}=v / d^{s-1}\left(x_{0}\right) \quad \text { for some } x_{0} \in \bar{\Omega} .
$$

In case $x_{0} \in \Omega$, we have

$$
\phi_{l}-c_{0} d^{s-1}-v \leq 0 \quad \text { in } \mathbb{R}^{n} \quad \text { and } \quad\left(\phi_{l}-c_{0} d^{s-1}-v\right)\left(x_{0}\right)=0
$$

so it must be

$$
0 \leq L\left(\phi_{l}-c_{0} d^{s-1}-v\right)\left(x_{0}\right) \leq L \phi_{l}\left(x_{0}\right)-c_{0} L\left(d^{s-1}\right)\left(x_{0}\right) \leq-d^{\varepsilon-s-1}\left(x_{0}\right)-M+\left(l+c_{0}\right) c d^{\delta \gamma-s-1}\left(x_{0}\right)
$$

where we used Lemma 2.6 and that $\left|L\left(d^{s-1}\right)\right| \leq c d^{\delta \gamma-s-1}$ for any $\delta \in(0, s)$ by Lemma 2.3. Next, we fix any $\delta \in(0, s)$, and take $\varepsilon<\delta \gamma$ and $M$ so large, depending only on $c_{0}, l$, $\operatorname{diam}(\Omega)$ (but not on $x_{0}$ ), such that

$$
-d^{\varepsilon-s-1}\left(x_{0}\right)-M+\left(l+c_{0}\right) c d^{\delta \gamma-s-1}\left(x_{0}\right)<0
$$

Since $c_{0}$ is independent of $M$ (see (3.1)), we obtain a contradiction. Thus, it must be $x_{0} \in \partial \Omega$, which by construction yields that $c_{0}=0$, and therefore $\phi_{l} \leq v$ in $\Omega$. Since $l \geq 0$, by Lemma 2.6, there exists $\delta>0$ such that $\phi_{l} \geq 0$ in $\Omega \cap\{d \leq \delta\}$. Therefore, $v$ is a viscosity solution to

$$
\begin{cases}L v & \geq 0 \quad \text { in } \Omega \cap\{d>\delta\}, \\ v & \geq 0 \quad \text { in } \mathbb{R}^{n} \backslash(\Omega \cap\{d>\delta\})\end{cases}
$$

Since $v \in C(\overline{\Omega \cap\{d>\delta\}})$, we can apply the standard maximum principle for viscosity solutions to $v$ (see [FeRo24a, Lemma 3.2.19]) and deduce that $v \geq 0$ in $\mathbb{R}^{n}$, as desired.

In particular, we have the following comparison principle:
Lemma 3.1. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Let $v, b \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1}, b / d^{s-1} \in C(\bar{\Omega})$ be viscosity solutions to

$$
\left\{\begin{array} { l l l } 
{ L v } & { \geq f } & { \text { in } \Omega , } \\
{ v / d ^ { s - 1 } } & { \geq 0 } & { \text { on } \partial \Omega , }
\end{array} \quad \left\{\begin{array}{lll}
L b & \leq f & \text { in } \Omega \\
b & \leq v & \text { in } \mathbb{R}^{n} \backslash \Omega \\
b / d^{s-1} & \leq 0 & \text { on } \partial \Omega
\end{array}\right.\right.
$$

for some $f \in C(\Omega)$. Then, $v \geq b$ in $\mathbb{R}^{n}$.
Proof. Since by FeRo24a, Lemma 3.4.13] $w=v-b$ is a viscosity solution to $L w \geq 0$ in $\Omega$ such that $w / d^{s-1} \geq 0$ on $\partial \Omega$, and $w \geq 0$ in $\mathbb{R}^{n} \backslash \Omega$, it satisfies the assumptions of Proposition 1.3. An application of this result concludes the proof.

As an application, we have the following version of a nonlocal Hopf lemma for viscosity solutions:

Lemma 3.2. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ satisfy in the viscosity sense:

$$
\begin{cases}L v=f & \geq 0 \quad \text { in } \Omega \\ v & \geq 0 \quad \text { in } \mathbb{R}^{n} \backslash \Omega, \\ v / d^{s-1} & \geq 0 \quad \text { on } \partial \Omega\end{cases}
$$

for some $f \in C(\Omega)$. Then, either $v \equiv 0$ in $\Omega$, or

$$
v(x) \geq C\left(\inf _{\{x \in \Omega: \operatorname{dist}(x, \partial \Omega) \geq \delta\}} v\right) d_{\Omega}^{s}(x) \quad \text { in } \Omega
$$

for some $C, \delta>0$, which depend only on $n, s, \lambda, \Lambda, \gamma, \operatorname{diam}(\Omega)$, and the $C^{1, \gamma}$ radius of $\Omega$.
Proof. The proof follows in the same way as FeRo24a, Proposition 2.6.6]. First, by the weak maximum principle for viscosity solutions with boundary blow-up (see Proposition 1.3), we have $v \geq 0$ in $\mathbb{R}^{n}$. In order to deduce $v>0$ in case $v \not \equiv 0$, one uses the nonlocal weak Harnack inequality (see FeRo24a, Theorem 3.3.1]). An appropriate comparison principle for our framework is stated in Lemma 3.1. Apart from these observations, the proof follows precisely along the lines of [FeRo24a, Proposition 2.6.6].

As a corollary of the previous results, we obtain the following pointwise formulation of a nonlocal Hopf lemma for solutions with boundary blow-up.

Lemma 3.3. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ satisfy in the viscosity sense:

$$
\begin{cases}L v & \geq 0 \quad \text { in } \Omega, \\ v & \geq 0 \quad \text { in } \mathbb{R}^{n} \backslash \Omega, \\ v / d^{s-1} & =g \quad \text { on } \partial \Omega\end{cases}
$$

for some $g \in C(\partial \Omega)$. Let $x_{0} \in \partial \Omega$ be such that $\min _{\overline{\partial \Omega}} g=g\left(x_{0}\right) \leq 0$. Then, either $v \equiv 0$, or we have that in the viscosity sense

$$
\partial_{\nu}\left(v / d^{s-1}\right)\left(x_{0}\right)>0 .
$$

Proof. Let $\phi=\phi_{-1}$ be the barrier function from Lemma 2.6 with respect to $\Omega$ for some $\varepsilon \in(0, s)$ and $M>0$ so large that $\phi \leq 0$ in $\Omega$. Note that since $g\left(x_{0}\right) \leq 0$ we have

$$
\begin{aligned}
L\left(v+g\left(x_{0}\right) \phi\right) \geq-g\left(x_{0}\right)\left(d^{\varepsilon-s-1}+M\right) & \geq 0
\end{aligned} \begin{aligned}
v+g\left(x_{0}\right) \phi & \geq 0 \\
& \text { in } \mathbb{R}^{n} \backslash \Omega, \\
\left(v+g\left(x_{0}\right) \phi\right) / d^{s-1}=g-g\left(x_{0}\right) & \geq 0
\end{aligned} \quad \text { on } \partial \Omega ., ~
$$

Thus, an application of Lemma 3.2 to $v+g\left(x_{0}\right) \phi$ yields that either $v+g\left(x_{0}\right) \phi \equiv 0$ in $\Omega$, or

$$
\begin{equation*}
v+g\left(x_{0}\right) \phi \geq c d^{s} \quad \text { near } x_{0} . \tag{3.2}
\end{equation*}
$$

Note that we cannot have $v+g\left(x_{0}\right) \phi \equiv 0$, unless $g\left(x_{0}\right)=0$ (in which case $v \equiv v+g\left(x_{0}\right) \phi \equiv 0$ ), since then

$$
L v=-g\left(x_{0}\right) L \phi \leq g\left(x_{0}\right)\left(d^{\varepsilon-s-1}+M\right)<0 \quad \text { near } \partial \Omega,
$$

a contradiction. Thus, unless $v \equiv 0$, we have (3.2), and we compute, using that $\phi / d^{s-1}\left(x_{0}\right)=-1$

$$
\partial_{\nu}\left(v / d^{s-1}\right)\left(x_{0}\right)=\lim _{x \rightarrow x_{0}} \frac{\frac{v(x)}{d^{s-1}(x)}-g\left(x_{0}\right)}{d(x)}=\lim _{x \rightarrow x_{0}} \frac{\frac{v(x)}{d^{s-1}}+\frac{g\left(x_{0}\right) \phi(x)}{d^{-1}(x)}}{d(x)}=\lim _{x \rightarrow x_{0}} \frac{v(x)+g\left(x_{0}\right) \phi(x)}{d^{s}(x)} \geq c>0,
$$

which concludes the proof. Note that if the limit in the previous estimate does not exist, we need to interpret the boundary condition in the viscosity sense, i.e., take any smooth $\psi$ with $\psi\left(x_{0}\right)=$ $\left(v / d^{s-1}\right)\left(x_{0}\right)=g\left(x_{0}\right)$ and $\psi \geq v / d^{s-1}$. Then, the limit $\partial_{\nu} \psi\left(x_{0}\right)$ exists, and an analogous computation as above yields $\partial_{\nu} \psi\left(x_{0}\right) \geq c>0$, i.e., $\partial_{\nu}\left(v / d^{s-1}\right)\left(x_{0}\right)>0$ in the viscosity sense.

Finally, we are in a position to prove the main result of this section, a maximum principle for nonlocal equations with local Neumann conditions.
Lemma 3.4. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ satisfy in the viscosity sense:

$$
\begin{cases}L v & \geq f \\ v & \text { in } \Omega \\ v 0 & \text { in } \mathbb{R}^{n} \backslash \Omega, \\ \partial_{\nu}\left(v / d^{s-1}\right) & \leq g \quad \text { on } \partial \Omega\end{cases}
$$

for some $f \in C(\Omega)$ with $d^{s+1-\varepsilon} f \in L^{\infty}(\Omega)$ for some $\varepsilon \in(0,1+s]$, and $g \in C(\partial \Omega)$. Then, there exists $c>0$, depending only on $n, s, \lambda, \Lambda, \gamma, \varepsilon$, and the $C^{1, \gamma}$ radius of $\Omega$ and $\operatorname{diam}(\Omega)$, such that

$$
v / d^{s-1} \geq-c\left\|d^{s+1-\varepsilon} f\right\|_{L^{\infty}(\Omega)}-c\|g\|_{L^{\infty}(\partial \Omega)} \quad \text { in } \Omega
$$

Proof. The case $f \geq 0$ and $g \leq 0$ follows from the Hopf lemma (see Lemma 3.3). In fact, by Lemma 3.3 we deduce that either $v \equiv 0$, in which case we are done, or that $v / d^{s-1}>0$ on $\partial \Omega$. However, by the weak maximum principle (see Proposition 1.3), this implies $v \geq 0$, as desired.
Now, we explain how to get the result with general $f, g$. To do so, we apply the previous argument with $v$ replaced by

$$
w=v+\left(\left\|d^{s+1-\varepsilon} f\right\|_{L^{\infty}(\Omega)}+\|g\|_{L^{\infty}(\partial \Omega)}\right) \psi, \quad \text { where } \quad \psi(x)=l d^{s-1}(x)-d^{s-1+\varepsilon_{0}}(x)+C_{2} \mathbb{1}_{\bar{\Omega}}(x)
$$

for some $\varepsilon_{0}<\min \{\gamma, 1-s, \varepsilon\}$, and $l, C_{2}>0$ to be chosen later, as in Lemma 2.7. Note that $\psi \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ and $\psi / d^{s-1} \in C(\bar{\Omega})$, and from the proof of Lemma 2.7 we deduce that for any $M>0$

$$
\left\{\begin{array}{lll}
L \psi & \geq c_{0} d^{\varepsilon_{0}-s-1}+M & \text { in } \Omega \\
\partial_{\nu}\left(\psi / d^{s-1}\right) & =-\infty \leq 1, & \text { on } \partial \Omega \\
\psi & \geq 0 & \text { in } \mathbb{R}^{n}
\end{array}\right.
$$

for some $c_{0}>0$, if we choose $l>0$ large enough, depending on $\varepsilon_{0}$, and $\operatorname{diam}(\Omega)$, and then $C_{2}>0$, large enough, depending on $l, \varepsilon_{0}, M$. Let us choose $M$ so large that

$$
c_{0} d^{\varepsilon_{0}-s-1}+M \geq d^{\varepsilon-s-1} \quad \text { in } \Omega
$$

Then, altogether, we have that in the viscosity sense:

$$
\begin{cases}L w \geq f+\left(c_{0} d^{\varepsilon_{0}-s-1}+M\right)\left(\left\|d^{s+1-\varepsilon} f\right\|_{L^{\infty}(\Omega)}+\|g\|_{L^{\infty}(\partial \Omega)}\right) & \geq 0 \quad \text { in } \Omega \\ w \geq v & \geq 0 \quad \text { in } \mathbb{R}^{n} \backslash \Omega \\ \partial_{\nu}\left(w / d^{s-1}\right) \leq g-\left(\left\|d^{s+1-\varepsilon} f\right\|_{L^{\infty}(\Omega)}+\|g\|_{L^{\infty}(\partial \Omega)}\right) & \leq 0 \text { on } \partial \Omega\end{cases}
$$

Altogether, by the same argument as at the beginning of the proof, we have $w \geq 0$ in $\Omega$. Let us now observe that by construction

$$
\psi \leq l d^{s-1}+C_{2} \leq\left(l+C_{2}\right) d^{s-1} \quad \text { in } \Omega .
$$

Therefore, we obtain

$$
v \geq-\psi\left(\left\|d^{s+1-\varepsilon} f\right\|_{L^{\infty}(\Omega)}+\|g\|_{L^{\infty}(\partial \Omega)}\right) \geq-\left(l+C_{2}\right) d^{s-1}\left(\left\|d^{s+1-\varepsilon} f\right\|_{L^{\infty}(\Omega)}+\|g\|_{L^{\infty}(\partial \Omega)}\right) \quad \text { in } \Omega,
$$

as desired.
Proof of Proposition 1.5. Proposition 1.5 is a special case of Lemma 3.4,

## 4. HÖlder estimates up to the boundary

The previous maximum principle for nonlocal equations with local Neumann conditions (see Lemma 3.4) puts us in a position to establish a Harnack inequality for solutions to (1.7) at the boundary, which will eventually lead to the Hölder regularity estimate in Theorem 1.6.
To prove it, we adapt some of the ideas in [LiZh23] to the framework of solutions to nonlocal problems which blow up at the boundary.
For $\delta>0$, let us define $\Omega_{\delta}=\{x \in \Omega: \operatorname{dist}(x, \partial \Omega) \geq \delta\}$.
Lemma 4.1. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to

$$
\begin{cases}L v & \geq f \quad \text { in } \Omega \cap B_{1}, \\ v & \geq 0 \quad \text { in } \mathbb{R}^{n} \\ \partial_{\nu}\left(v / d^{s-1}\right) & \leq g \quad \text { on } \partial \Omega \cap B_{1}\end{cases}
$$

for some $f \in C\left(\Omega \cap B_{1}\right)$ with $d^{s+1-\alpha} f \in L^{\infty}\left(\Omega \cap B_{1}\right)$ for some $\alpha \in(0,1+s]$, and $g \in C\left(\overline{\partial \Omega \cap B_{1}}\right)$. Assume that $0 \in \partial \Omega$. Then, there exist $\eta>1$ and $c>0$, depending only on $n, s, \lambda, \Lambda$, and the $C^{1, \gamma}$ radius of $\Omega$, such that

$$
f_{\Omega_{1 / 2} \cap B_{1}}\left(v / d^{s-1}\right) \mathrm{d} x \leq c \inf _{\Omega \cap B_{\eta^{-1}}}\left(v / d^{s-1}\right)+c\left(\left\|d^{s+1-\alpha} f_{-}\right\|_{L^{\infty}\left(\Omega \cap B_{1}\right)}+\left\|g_{+}\right\|_{L^{\infty}\left(\partial \Omega \cap B_{1}\right)}\right)
$$

where $c>0$ depends only on $n, s, \lambda, \Lambda, \gamma, \alpha$.
Proof. The interior weak Harnack inequality for viscosity supersolutions (see FeRo24a, Theorem 3.3.1]) applied with $v$ implies

$$
f_{\Omega_{1 / 2} \cap B_{1}} v(x) \mathrm{d} x \leq c \inf _{x \in \Omega_{1 / 2} \cap B_{1}} v(x)+c\|f\|_{L^{\infty}\left(\Omega_{1 / 2} \cap B_{1}\right)},
$$

where $c>0$ depends on $n, s, \lambda, \Lambda, \eta, \alpha$. Moreover, since $1 / 2 \leq d \leq 1$ in $\Omega_{1 / 2} \cap B_{1}$, it follows for $u:=v / d^{s-1}$ :

$$
f_{\Omega_{1 / 2} \cap B_{1}} u(x) \mathrm{d} x \leq c \inf _{x \in \Omega_{1 / 2} \cap B_{1}} u(x)+c\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega_{1 / 2} \cap B_{1}\right)} .
$$

Thus, it remains to show

$$
\begin{equation*}
\inf _{x \in \Omega_{1 / 2} \cap B_{1}} u(x) \leq c \inf _{x \in \Omega \cap B_{\eta^{-1}}} u(x)+c\left(\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{1}\right)}+\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{1}\right)}\right) . \tag{4.1}
\end{equation*}
$$

Note that since $v \geq 0$, by the weak Harnack inequality, either $v \equiv 0$, or $\inf _{\Omega \cap B_{1}} v>0$. Therefore, without loss of generality, we can assume that $\inf _{\Omega_{1 / 2} \cap B_{1}} u=1$.
To prove (4.1), let us take a set $D \subset \mathbb{R}^{n}$ with $\partial D \in C^{1, \gamma}$ such that

$$
\Omega \cap B_{1 / 2} \subset D \subset \Omega \cap B_{1},
$$

and take $w=\phi_{1}=d_{D}^{s-1}+d_{D}^{s-1+\alpha}-N \mathbb{1}_{D}$ from Lemma 2.6, where $\alpha<1-s$ is chosen small enough and $N>0$ is chosen large enough. Then, we have

$$
\begin{align*}
L w \leq 0 \quad \text { in } D \cap B_{1},  \tag{4.2}\\
w \leq 0 \quad \text { in } \mathbb{R}^{n} \backslash\left(D \cap B_{1}\right),  \tag{4.3}\\
\partial_{\nu}\left(w / d_{D}^{s-1}\right) \geq 0 \quad \text { on } \partial D \cap B_{1},  \tag{4.4}\\
w / d_{D}^{s-1} \geq c_{1} \quad \text { in }\left(\Omega \backslash \Omega_{\eta^{-1}}\right) \cap B_{1 / 4} \tag{4.5}
\end{align*}
$$

for some constants $\eta>4$, and $c_{1}>0$, depending only on $n, s, \lambda, \Lambda, \gamma$, and the $C^{1, \gamma}$ radius of $\Omega$ (but not on $\operatorname{diam}(\Omega)$, since we can assume without loss of generality that $\Omega \cap B_{\eta^{-1}} \neq \emptyset$ ). Note that (4.5) relies on the fact that $\partial D \cap B_{1 / 2}=\partial \Omega \cap B_{1 / 2}$.
Moreover, note that for any $x_{0} \in(\partial D \backslash \partial \Omega) \cap B_{1}$ it holds $\left(v / d_{D}^{s-1}\right)\left(x_{0}\right)=0$ on (recall that $v \in C(\Omega)$ and therefore $\left.\left|v\left(x_{0}\right)\right|<\infty\right)$. Thus, and using also that $w / d^{s-1}=1$ on $\partial D$ by construction:

$$
\begin{align*}
\partial_{\nu}\left((v-w) / d_{D}^{s-1}\right)\left(x_{0}\right) & =\lim _{x \rightarrow x_{0}} \frac{\frac{v(x)-w(x)}{d_{D}^{s-1}(x)}-(-1)}{d_{D}(x)} \\
& =\lim _{x \rightarrow x_{0}} \frac{\frac{v(x)}{d_{D}^{s-1}(x)}-\left(1+d_{D}^{\alpha}(x)-N d_{D}^{1-s}(x)\right)+1}{d_{D}(x)}  \tag{4.6}\\
& =\lim _{x \rightarrow x_{0}}\left(-d_{D}^{\alpha-1}(x)+(N+v(x)) d_{D}^{-s}(x)\right)=-\infty \leq 0,
\end{align*}
$$

since $\alpha<1-s$. Thus, altogether, extending $g$ by zero on $(\partial D \backslash \partial \Omega) \cap B_{1}$, we have that $v-w$ satisfies

$$
\begin{cases}L(v-w) & \geq f \quad \text { in } D \cap B_{1}, \\ v-w & \geq 0 \quad \text { in } \mathbb{R}^{n} \backslash\left(D \cap B_{1}\right), \\ \partial_{\nu}\left((v-w) / d_{D}^{s-1}\right) & \leq g \quad \text { in } \partial D \cap B_{1} .\end{cases}
$$

While the first property is an easy consequence of $D \cap B_{1} \subset \Omega \cap B_{1}$ and (4.2), for the second one we used (4.3) and the fact that $v \geq 0$ in $\mathbb{R}^{n}$ by assumption. The third property is immediate from the assumption on $v$ combined with (4.4) and (4.6).
Thus, we are in a position to apply the maximum principle for the Neumann problem (see Lemma 3.4):

$$
(v-w) / d_{D}^{s-1} \geq-c\left\|d^{s+1-\alpha} f_{-}\right\|_{L^{\infty}\left(D \cap B_{1}\right)}-c\left\|g_{+}\right\|_{L^{\infty}\left(\partial D \cap B_{1}\right)} \quad \text { in } D \cap B_{1} .
$$

Since by (4.5) we also have that $w / d_{D}^{s-1} \geq c_{1}=c_{1} \inf _{\Omega_{1 / 2} \cap B_{1}} u$ in $\left(\Omega \backslash \Omega_{\eta^{-1}}\right) \cap B_{1 / 4}$, we deduce

$$
\begin{aligned}
v / d_{D}^{s-1} & =(w+v-w) / d_{D}^{s-1} \\
& \geq c_{1} \inf _{\Omega_{1 / 2} \cap B_{1}} u-c\left\|d_{D}^{s+1-\alpha} f_{-}\right\|_{L^{\infty}\left(D \cap B_{1}\right)}-c\left\|g_{+}\right\|_{L^{\infty}\left(\partial D \cap B_{1}\right)} \\
& \geq c_{1} \inf _{\Omega_{1 / 2} \cap B_{1}} u-c\left\|d^{s+1-\alpha} f_{-}\right\|_{L^{\infty}\left(\Omega \cap B_{1}\right)}-c\left\|g_{+}\right\|_{L^{\infty}\left(\partial \Omega \cap B_{1}\right)} \quad \text { in }\left(\Omega \backslash \Omega_{\eta^{-1}}\right) \cap B_{1 / 4},
\end{aligned}
$$

where we used $D \cap B_{1} \subset \Omega \cap B_{1}$. Since $\Omega \cap B_{\eta^{-1}} \subset\left(\Omega \backslash \Omega_{\eta^{-1}}\right) \cap B_{1 / 4}$, and moreover in this set $d_{D}=d_{\Omega}$ by construction, we obtain (4.1), as desired.

As a corollary of the previous weak Harnack inequality at the boundary, we obtain a growth lemma.
Lemma 4.2. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Let $\eta>1$ be as in Lemma 4.1. Assume that $x_{0} \in \partial \Omega$ and let $0<R \leq 1$. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with
$v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to

$$
\left\{\begin{array}{rlrl}
L v & \geq f & & \text { in } \Omega \cap B_{R}\left(x_{0}\right), \\
\partial_{\nu}\left(v / d^{s-1}\right) & \leq g & & \text { on } \partial \Omega \cap B_{R}\left(x_{0}\right), \\
v & \geq 0 & & \text { in } B_{R}\left(x_{0}\right), \\
v & \geq d^{s-1}\left(1-\eta^{j \beta}\right) & & \text { in } B_{\eta^{j} R}\left(x_{0}\right) \cap \Omega \forall j \geq 1, \\
v & \geq\left(1-\eta^{j \beta}\right) & & \text { in } B_{\eta^{j} R}\left(x_{0}\right) \backslash \Omega \forall j \geq 1, \\
\left|\Omega_{R / 4} \cap B_{R / 2}\left(x_{0}\right) \cap\left\{v / d^{s-1} \geq \frac{1}{4}\right\}\right| & \geq \frac{1}{2}\left|\Omega_{R / 4} \cap B_{R / 2}\left(x_{0}\right)\right| &
\end{array}\right.
$$

for some $f \in C\left(\Omega \cap B_{R}\left(x_{0}\right)\right)$ with $d^{s+1-\alpha} f \in L^{\infty}\left(\Omega \cap B_{R}\left(x_{0}\right)\right)$ for some $\alpha \in(0,1+s]$, and $g \in$ $C\left(\overline{\partial \Omega \cap B_{R}\left(x_{0}\right)}\right)$. Then, there exist $\delta>0$, and $\beta \in(0,1)$, depending only on $n, s, \lambda, \Lambda, \gamma, \alpha$, and the $C^{1, \gamma}$ radius of $\Omega$, such that

$$
\inf _{\Omega \cap B_{\eta^{-1} R}\left(x_{0}\right)}\left(v / d^{s-1}\right)+R^{\alpha}\left\|d^{s+1-\alpha} f_{-}\right\|_{L^{\infty}\left(\Omega \cap B_{R}\left(x_{0}\right)\right)}+R\left\|g_{+}\right\|_{L^{\infty}\left(\partial \Omega \cap B_{R}\left(x_{0}\right)\right)} \geq \delta .
$$

Proof. Let us assume without loss of generality that $x_{0}=0$. The proof follows from a standard application of the weak Harnack inequality (see Lemma 4.1) to $v_{+}$. The only deviation of this proof from standard arguments comes from the more involved argument to estimate the tail term.
Indeed, we have

$$
L v_{+}(x) \geq f(x)-\int_{\mathbb{R}^{n} \backslash B_{R}} v_{-}(y) K(x-y) \mathrm{d} y=: \tilde{f}(x),
$$

where we used that by assumption, $v \geq 0$ in $B_{R}$. Then, we obtain from Lemma 4.1 (after scaling), using the last assumption and setting $u:=v / d^{s-1}$

$$
\begin{equation*}
\inf _{\Omega \cap B_{\eta^{-1} R}} u+R^{\alpha}\left\|d^{s+1-\alpha} \tilde{f}_{-}\right\|_{L^{\infty}\left(\Omega \cap B_{R / 2}\right)}+R\left\|g_{+}\right\|_{L^{\infty}\left(\partial \Omega \cap B_{R / 2}\right)} \geq c_{0} f_{\Omega_{R / 4} \cap B_{R / 2}} u \mathrm{~d} x \geq \frac{c_{0}}{8}, \tag{4.7}
\end{equation*}
$$

where $c_{0}>0$ is the constant from the weak Harnack inequality.
Next, we estimate $\left\|d^{s+1-\alpha} \tilde{f}\right\|_{L^{\infty}\left(\Omega \cap B_{R}\right)}$. To do so, we apply a similar reasoning as in the proof of Lemma 2.2. First, we recall that for any $x \in B_{R / 2}$, there exists $\kappa>0$ such that for any $t \in(0, \kappa)$ :

$$
\mathcal{H}^{n-1}\left(\{d=t\} \cap B_{\eta^{j} R} \backslash B_{\eta^{j-1} R}\right) \leq C\left(\eta^{j} R\right)^{n-1},
$$

where $C>0$ depends only on $n$ and the $C^{1, \gamma}$ radius of $\Omega$ (we refer to [FeRo24a, Lemma B.2.4] for a reference of this fact). Next, we observe that by the co-area formula:

$$
\begin{aligned}
& R^{1+s} \int_{\Omega \backslash B_{R}} v_{-}(y) K(x-y) \mathrm{d} y \leq c \sum_{j \geq 1}\left(1-\eta^{j \beta}\right) R^{1+s} \int_{\Omega \cap\left(B_{\eta^{j} R} \backslash B_{\eta^{j-1} R_{R}}\right)} d^{s-1}(y)|y|^{-n-2 s} \mathrm{~d} y \\
& \quad \leq c \sum_{j \geq 1}\left(1-\eta^{j \beta}\right) R^{1+s}\left(\left(\eta^{j} R\right)^{-n-2 s} \int_{\left(B_{\eta^{j} R} \backslash B_{\eta^{j-1}}\right) \cap\{d \leq \kappa\}} d^{s-1}(y)|\nabla d(y)| \mathrm{d} y+\kappa^{s-1}\left(\eta^{j} R\right)^{-2 s}\right) \\
& \quad \leq c \sum_{j \geq 1}\left(1-\eta^{j \beta}\right) R^{1+s}\left(\left(\eta^{j} R\right)^{-n-2 s} \int_{0}^{\min \left\{\eta^{j} R, \kappa\right\}} t^{s-1}\left(\int_{\left(B_{\eta^{j} R} \backslash B_{\eta^{j-1} R}\right) \cap\{d=t\}} \mathrm{d}^{n-1}(y)\right) \mathrm{d} t+\left(\eta^{j} R\right)^{-2 s}\right) \\
& \quad \leq c \sum_{j \geq 1}\left(1-\eta^{j \beta}\right) R^{1+s}\left(\left(\eta^{j} R\right)^{-1-s}+\left(\eta^{j} R\right)^{-2 s}\right) \leq c \sum_{j \geq 1}\left(1-\eta^{j \beta}\right) \eta^{-2 s j}
\end{aligned}
$$

for some $c>0$, depending only on $n, s, \lambda, \Lambda, \kappa, C, \eta$, where we also used that $R \leq 1$. Similarly,

$$
R^{1+s} \int_{\left(\mathbb{R}^{n} \backslash \Omega\right) \backslash B_{R}} v_{-}(y) K(x-y) \mathrm{d} y \leq c \sum_{j \geq 1}\left(1-\eta^{j \beta}\right) R^{1+s} \int_{\mathbb{R}^{n} \cap\left(B_{\eta^{j} R} \backslash B_{\eta^{j-1} R}\right)}|y|^{-n-2 s} \mathrm{~d} y
$$

$$
\leq c \sum_{j \geq 1}\left(1-\eta^{j \beta}\right) R^{1+s}\left(\eta^{j} R\right)^{-2 s} \leq c \sum_{j \geq 1}\left(1-\eta^{j \beta}\right) \eta^{-2 j s},
$$

where we used that $R^{1-s} \leq 1$, and $c>0$ depends only on $n, s, \Lambda$. Therefore, we obtain

$$
R^{1+s} \int_{\mathbb{R}^{n} \backslash B_{R}} d^{s-1}(y) v_{-}(y) K(x-y) \mathrm{d} y \leq c \sum_{j \geq 1}\left(1-\eta^{j \beta}\right) \eta^{-2 j s} .
$$

Since this quantity vanishes as $\beta>0$ goes to zero, we can make the whole expression smaller than $c_{0} / 16$, which implies by recalling the definition of $\tilde{f}$

$$
\begin{aligned}
R^{\alpha}\left\|d^{s+1-\alpha} \tilde{f}_{-}\right\|_{L^{\infty}\left(\Omega \cap B_{R / 2}\right)} & \leq R^{\alpha}\left\|d^{s+1-\alpha} f_{-}\right\|_{L^{\infty}\left(\Omega \cap B_{R / 2}\right)}+R^{1+s}\left\|\int_{\Omega \backslash B_{R}} v_{-}(y) K(\cdot-y) \mathrm{d} y\right\|_{L^{\infty}\left(B_{R / 2}\right)} \\
& \leq R^{\alpha}\left\|d^{s+1-\alpha} f_{-}\right\|_{L^{\infty}\left(\Omega \cap B_{R}\right)}+\frac{c_{0}}{16}
\end{aligned}
$$

and therefore by the estimate (4.7)

$$
\inf _{\Omega \cap B_{\eta^{-1} R}} u+R^{\alpha}\left\|d^{s+1-\alpha} f_{-}\right\|_{L^{\infty}\left(\Omega \cap B_{R}\right)}+R\left\|g_{+}\right\|_{L^{\infty}\left(\partial \Omega \cap B_{R}\right)} \geq \frac{c_{0}}{8}-\frac{c_{0}}{16}=\frac{c_{0}}{16},
$$

as desired.
We are now in a position to prove the boundary Hölder regularity.
Lemma 4.3. Let $L \in \mathcal{L}_{s}^{h o m}(\lambda, \Lambda)$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Assume that $x_{0} \in \partial \Omega$ and let $0<R \leq 1$. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to

$$
\left\{\begin{array}{lll}
L v & =f \quad \text { in } \Omega \cap B_{R}\left(x_{0}\right), \\
v & =0 \quad \text { in } B_{R}\left(x_{0}\right) \backslash \Omega \\
\partial_{\nu}\left(v / d^{s-1}\right) & =g \quad \text { on } \partial \Omega \cap B_{R}\left(x_{0}\right)
\end{array}\right.
$$

for some $f \in C\left(\Omega \cap B_{R}\left(x_{0}\right)\right)$ and $g \in C\left(\overline{\partial \Omega \cap B_{R}\left(x_{0}\right)}\right)$. Then, there exist $c>0$, and $\alpha_{0} \in(0,1)$, depending only on $n, s, \lambda, \Lambda, \gamma$, and the $C^{1, \gamma}$ radius of $\Omega$, such that if $d^{s+1-\alpha} f \in L^{\infty}\left(\Omega \cap B_{R}\left(x_{0}\right)\right)$ for some $\alpha \in\left(0, \alpha_{0}\right]$, then it holds:

$$
\begin{aligned}
{\left[v / d^{s-1}\right]_{C^{\alpha}\left(B_{R / 2}\left(x_{0}\right)\right)} \leq c R^{-\alpha}\left(\left\|v / d^{s-1}\right\|_{L^{\infty}(\Omega)}\right.} & +\|v\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \Omega\right)} \\
& \left.+R^{\alpha}\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{R}\left(x_{0}\right)\right)}+R\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{R}\left(x_{0}\right)\right)}\right)
\end{aligned}
$$

Proof. Let us assume without loss of generality that $x_{0}=0$. We will prove the desired result in two steps. Let us denote by $\eta>1$ the constant from Lemma 4.2,
Step 1: We claim that for any $k \in \mathbb{N}$ :

for some constant $c>0$, depending only on $n, s, \lambda, \Lambda, \gamma$, and the $C^{1, \gamma}$ radius of $\Omega$. To prove it, we set $\alpha_{0}:=\min \left\{\beta, \gamma s, 1-s\left[-\log _{\eta}\left(1-\frac{\delta^{\prime}}{2}\right)\right]\right\}$, and $\delta:=1-\eta^{-\alpha_{0}}$, where $\delta^{\prime}, \beta, \eta$ are the constants from Lemma 4.2. This yields

$$
\begin{equation*}
(1-\delta)=\eta^{-\alpha_{0}}, \quad \alpha_{0} \leq \min \{\beta, \gamma s, 1-s\}, \quad \delta \leq \delta^{\prime} / 2 \tag{4.8}
\end{equation*}
$$

Let us set $u=v / d^{s-1}$, take $\alpha \in\left(0, \alpha_{0}\right]$, and
$M:=4 \delta^{-1} c_{1}\left(\left\|v / d^{s-1}\right\|_{L^{\infty}(\Omega)}+\|v\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \Omega\right)}+R^{\alpha}\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{R}\left(x_{0}\right)\right)}+R^{\alpha}+R\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{R}\left(x_{0}\right)\right)}\right)$,
where $c_{1}>0$ denotes the constant $c_{1}$ from Lemma 2.3.
The claim of Step 1 will follow immediately, once we construct an increasing sequence $\left(m_{k}\right)_{k}$ and a decreasing sequence $\left(M_{k}\right)_{k}$ such that for any $k \in \mathbb{N}$ :

$$
\begin{align*}
m_{k} & \leq u \leq M_{k} \quad \text { in } B_{\eta^{-k} R},  \tag{4.9}\\
M_{k}-m_{k} & =M \eta^{-\alpha k} . \tag{4.10}
\end{align*}
$$

We prove (4.9) and (4.10) by induction. Setting $m_{0}=-\frac{\delta}{2 c_{1}} M, M_{0}=\frac{\delta}{2 c_{1}} M$, we obtain the desired results for $k=0$. Let us now assume that (4.9) and (4.10) hold true for any $j \leq k-1$.
We will now prove it for $k$. Clearly, one of the following two options always holds true:

$$
\begin{aligned}
& \left|\Omega_{\eta^{-(k-1)} R / 4} \cap B_{\eta^{-(k-1)} R / 2} \cap\left\{u \geq \frac{M_{k-1}+m_{k-1}}{2}\right\}\right| \geq \frac{\left|\Omega_{\eta^{-(k-1)} R / 4} \cap B_{\eta^{-(k-1)} R / 2}\right|}{2}, \\
& \left|\Omega_{\eta^{-(k-1)} R / 4} \cap B_{\eta^{-(k-1)} R / 2} \cap\left\{u \geq \frac{M_{k-1}+m_{k-1}}{2}\right\}\right| \leq \frac{\left|\Omega_{\eta^{-(k-1)} R / 4} \cap B_{\eta^{-(k-1)} R / 2}\right|}{2} .
\end{aligned}
$$

In the first case, and in the second case, we define

$$
w=\frac{v-\left(d^{s-1}+\mathbb{1}_{\mathbb{R}^{n} \backslash \Omega} \mathbb{1}_{\left\{m_{k-1}<0\right\}}\right) m_{k-1}}{M_{k-1}-m_{k-1}}, \quad w=\frac{\left(d^{s-1}+\mathbb{1}_{\mathbb{R}^{n} \backslash \Omega} \mathbb{1}_{\left\{M_{k-1}>0\right\}}\right) M_{k-1}-v}{M_{k-1}-m_{k-1}}, \quad \text { respectively }
$$

Let us assume that we are in the first case. The proof of the second case goes via the same arguments, and we will skip it. Let us verify that $w$ satisfies the assumptions of Lemma 4.2. First, note that if $u(x) \geq \frac{M_{k-1}+m_{k-1}}{2}$ for some $x \in \Omega$, it follows that

$$
\frac{w}{d^{s-1}}(x)=\frac{u(x)-m_{k-1}}{M_{k-1}-m_{k-1}} \geq \frac{u(x)-m_{k-1}}{M_{k-1}-m_{k-1}} \geq \frac{\frac{M_{k-1}+m_{k-1}}{2}-m_{k-1}}{M_{k-1}-m_{k-1}}=\frac{1}{2}
$$

Thus, as an immediate consequence of being in the first case, we get

$$
\left|\Omega_{\eta^{-(k-1)} R / 4} \cap B_{\eta^{-(k-1)} R / 2} \cap\left\{\frac{w}{d^{s-1}} \geq \frac{1}{2}\right\}\right| \geq \frac{\left|\Omega_{\eta^{-(k-1)} R / 4} \cap B_{\eta^{-(k-1)} R / 2}\right|}{2}
$$

Moreover, by (4.9) (for $k-1$ ), we have

$$
w=\frac{v-d^{s-1} m_{k-1}}{M_{k-1}-m_{k-1}} \geq 0 \quad \text { in } B_{\eta^{-(k-1)} R} \cap \Omega .
$$

Non-negativity of $w$ in $B_{\eta^{-(k-1)} R} \backslash \Omega$ follows by assumption and construction. Note that by Lemma 2.3 (applied with $\delta \in(0, s)$ such that $\delta \gamma=\alpha$, which is possible by the choice of $\alpha_{0}$ ), we obtain

$$
\left|L\left(d^{s-1}+\mathbb{1}_{\mathbb{R}^{n} \backslash \Omega}\right)\right| \leq c_{1}\left(d^{\alpha-s-1}+d^{-2 s}\right) \leq c_{1} d^{\alpha-s-1} \quad \text { in } \Omega,
$$

and therefore $d^{s+1-\alpha} L\left(d^{s-1}+\mathbb{1}_{\mathbb{R}^{n} \backslash \Omega}\right) \in L^{\infty}\left(\Omega \cap B_{R}\right)$. Then, by (4.10) (for $k-1$ ) we have

$$
\begin{equation*}
L w=\frac{f-L\left(d^{s-1}+\mathbb{1}_{\mathbb{R}^{n} \backslash \Omega} \mathbb{1}_{\left\{m_{k-1}<0\right\}}\right) m_{k-1}}{M_{k-1}-m_{k-1}} \geq \frac{f-c_{1} d^{\alpha-s-1} m_{k-1}}{M_{k-1}-m_{k-1}} \quad \text { in } \Omega \cap B_{R} \tag{4.11}
\end{equation*}
$$

Moreover, clearly

$$
\partial_{\nu}\left(w / d^{s-1}\right)=\frac{g-\partial_{\nu}\left(d^{s-1} / d^{s-1}\right) m_{k-1}}{M_{k-1}-m_{k-1}}=\frac{g}{M_{k-1}-m_{k-1}} \quad \text { on } \partial \Omega \cap B_{R}
$$

It remains to verify the fourth and fifth assumption of Lemma 4.2. Let us first consider $j \leq k-1$. In that case, for any $x \in B_{\eta^{-(k-1)+j} R} \cap \Omega$ it holds by (4.9) and (4.10):

$$
\frac{w}{d^{s-1}}(x)=\frac{u(x)-m_{k-1}}{M_{k-1}-m_{k-1}} \geq \frac{m_{k-j-1}-m_{k-1}}{M_{k-1}-m_{k-1}}
$$

$$
\geq \frac{M_{k-1}-M_{k-j-1}+m_{k-j-1}-m_{k-1}}{M_{k-1}-m_{k-1}}=1-\frac{M_{k-j-1}-m_{k-j-1}}{M_{k-1}-m_{k-1}}=1-\eta^{\alpha j} .
$$

Clearly, for any $x \in B_{\eta^{-(k-1)+j} R} \backslash \Omega$ and in case $m_{k-1}<0$, by the same arguments as above, using (4.9), we have

$$
w(x)=\frac{v(x)-m_{k-1}}{M_{k-1}-m_{k-1}} \geq \frac{m_{k-j-1}-m_{k-1}}{M_{k-1}-m_{k-1}} \geq 1-\eta^{\alpha j} .
$$

If however $m_{k-1} \geq 0$, then we can use that $v=0$ in $B_{R} \backslash \Omega$. Moreover, if $j>k-1$ we compute for $x \in B_{\eta^{-(k-1)+j} R} \cap \Omega$ :

$$
\begin{aligned}
\frac{w}{d^{s-1}}(x) & =\frac{u(x)-m_{k-1}}{M_{k-1}-m_{k-1}} \geq \frac{m_{0}-m_{k-1}}{M_{k-1}-m_{k-1}} \\
& \geq \frac{\left(M_{k-1}-m_{k-1}\right)-\left(M_{0}-m_{0}\right)}{M_{k-1}-m_{k-1}}=1-\eta^{\alpha(k-1)} \geq 1-\eta^{\alpha j} .
\end{aligned}
$$

Finally, for $x \in B_{\eta^{-(k-1)+j} R} \backslash \Omega$, again by the same arguments as above, and using that $v \geq m_{0}$ by construction, we have

$$
w(x)=\frac{v(x)-m_{k-1} \mathbb{1}_{\left\{m_{k-1}<0\right\}}}{M_{k-1}-m_{k-1}} \geq \frac{m_{0}-m_{k-1}}{M_{k-1}-m_{k-1}} \geq 1-\eta^{\alpha j} .
$$

Consequently, all assumptions of Lemma 4.2 are satisfied for $w$ with $R:=\eta^{-(k-1)} R$. Thus, we deduce from Lemma 4.2 and the choice of $\delta$ :

$$
\begin{array}{rlr}
u-m_{k-1} & =\left(M_{k-1}-m_{k-1}\right) \frac{w}{d^{s-1}} & \\
\geq 2 \delta\left(M_{k-1}-m_{k-1}\right)-\left(\eta^{-(k-1)} R\right)^{\alpha}\left(\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{\eta^{-(k-1)} R}\right)}+c_{1}\right) & \\
& -\left(\eta^{-(k-1)} R\right)\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{\eta^{-(k-1)} R_{R}}\right)} \quad \text { in } \Omega \cap B_{\eta^{-k} R} .
\end{array}
$$

Moreover, by (4.8), the choice of $M$, (4.10), and the estimate $\left|m_{k-1}\right| \leq M_{0}=\frac{\delta}{2 c_{1}} M$ we estimate

$$
\begin{aligned}
\left(\eta^{-(k-1)} R\right)^{\alpha} & \left(\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{\eta^{-(k-1)_{R}}}\right)}+c_{1}\left|m_{k-1}\right|\right)+\left(\eta^{-(k-1)} R\right)\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{\eta^{-(k-1)_{R}}}\right)} \\
& \leq \eta^{-\alpha(k-1)} \delta M=\delta\left(M_{k-1}-m_{k-1}\right) .
\end{aligned}
$$

Therefore, we deduce

$$
m_{k}:=\delta\left(M_{k-1}-m_{k-1}\right)+m_{k-1} \leq u \leq M_{k-1}=: M_{k} \quad \text { in } \Omega \cap B_{\eta^{-k} R},
$$

which proves (4.9) for $k$. (4.10) for $k$ follows from (4.8). The proof of Step 1 is complete.
Step 2: Now that we have established the claim of Step 1, let us show how to conclude the proof. Let us take $x, y \in B_{R / 2}$. We define $k \in \mathbb{N}$ as

$$
\inf \left\{k \in \mathbb{N}:|x-y| \geq \eta^{-k}(R / 2)\right\}
$$

Then, $|x-y| \leq \eta^{-k+1}(R / 2)$ and by Step 1, it holds

$$
\begin{aligned}
\frac{|u(x)-u(y)|}{|x-y|^{\alpha}} & \leq \eta^{k \alpha}(R / 2)^{-\alpha} \underset{B_{\eta^{-k+1}(R / 2)}^{\text {osc }}}{ } u \\
& \leq c R^{-\alpha}\left(\|u\|_{L^{\infty}(\Omega)}+\|v\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \Omega\right)}+R^{\alpha}\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{R}\right)}+R^{\alpha}+R\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{R}\right)}\right) .
\end{aligned}
$$

Note that we can omit the additional summand $+R^{\alpha}$ by an additional scaling and normalization argument, i.e., by assuming that $R=1$ and $\|u\|_{L^{\infty}(\Omega)}+\|v\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \Omega\right)}+\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{1}\right)}+\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{1}\right)}=$ 1 , applying the previous estimate, and rescaling to general $R$. This concludes the proof.

We are now in a position to deduce the boundary Hölder regularity estimate in $C^{1, \gamma}$ domains.
Proof of Theorem 1.6. The proof follows immediately by combination of Lemma 4.3 (with $R=1 / 2$ and varying $x_{0} \in \partial \Omega$ ), the interior regularity results from FeRo24a, Theorem 2.4.3], and a covering argument. In order to produce the tail-term in the estimate, we employ a standard truncation argument (see also the proof of Corollary 4.4).

We end this section with a boundary Hölder regularity estimate for solutions that are defined up to a polynomial and might grow fast at infinity.

Corollary 4.4. Let $L \in \mathcal{L}_{s}^{h o m}(\lambda, \Lambda)$. Let $k \in \mathbb{N} \cup\{0\}$. Let $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in C^{1, \gamma}$ for some $\gamma>0$. Let $f \in C\left(\Omega \cap B_{4}\right), g \in C\left(\overline{\partial \Omega \cap B_{4}}\right)$, and $v$ with $v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to

$$
\left\{\begin{array}{lll}
L v & \stackrel{k}{=} f & \text { in } \Omega \cap B_{4} \\
v & =0 & \text { in } B_{4} \backslash \Omega \\
\partial_{\nu}\left(v / d^{s-1}\right) & =g & \text { on } \partial \Omega \cap B_{4}
\end{array}\right.
$$

Then, there exists $\alpha_{0}>0$ such that if for some $\alpha \in\left(0, \alpha_{0}\right]$ we have $d^{s+1-\alpha} f \in L^{\infty}\left(\Omega \cap B_{4}\right)$, then the following holds true: If $k=0$, and $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$, it holds $v / d^{s-1} \in C_{\text {loc }}^{\alpha}\left(\bar{\Omega} \cap B_{4}\right)$, and

$$
\left\|\frac{v}{d^{s-1}}\right\|_{C^{\alpha}\left(\bar{\Omega} \cap B_{1}\right)} \leq c\left(\left\|\frac{v}{d^{s-1}}\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}+\|v\|_{L_{2 s}^{1}\left(\mathbb{R}^{n} \backslash B_{4}\right)}+\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}+\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{4}\right)}\right) .
$$

If $k \in \mathbb{N}, K \in C^{k-1+\delta}\left(\mathbb{S}^{n-1}\right), v \in L_{2 s+k-1+\delta}^{1}\left(\mathbb{R}^{n}\right)$ for some $\delta>0$, it holds $v / d^{s-1} \in C_{\text {loc }}^{\alpha}\left(\bar{\Omega} \cap B_{4}\right)$, and $\left\|\frac{v}{d^{s-1}}\right\|_{C^{\alpha}\left(\bar{\Omega} \cap B_{1}\right)} \leq c\left(\left\|\frac{v}{d^{s-1}}\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}+\|v\|_{L_{2 s+k-1+\delta}^{1}\left(\mathbb{R}^{n} \backslash B_{4}\right)}+\left\|d^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}+\|g\|_{L^{\infty}\left(\partial \Omega \cap B_{4}\right)}\right)$, where $c>0$ and $\alpha_{0}$, depend only on $n, s, \lambda, \Lambda, \gamma, k, \delta$, and the $C^{1, \gamma}$ radius of $\Omega$.

Proof. In case $k=0$, the proof follows by a standard truncation argument. Indeed, let us define $w=v \mathbb{1}_{B_{4}}$ and observe that

$$
L w=f-L\left(v \mathbb{1}_{\mathbb{R}^{n} \backslash B_{4}}\right)=: \tilde{f} \quad \text { in } \Omega \cap B_{2} .
$$

Moreover, we can estimate

$$
\left\|d^{s+1-\alpha} \tilde{f}\right\|_{L^{\infty}\left(\Omega \cap B_{2}\right)} \leq c\left\|d^{s-1+\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{2}\right)}+c\|v\|_{L_{2 s}^{1}\left(\mathbb{R}^{n} \backslash B_{4}\right)}
$$

Thus, the desired result follows immediately by application of Theorem 1.6 to $w$, using that $v=0$ in $B_{4} \backslash \Omega$, by assumption.
Let now $k \in \mathbb{N}$. Again, we define $w=v \mathbb{1}_{B_{4}}$, but this time, since the equation only holds up to a polynomial, we obtain for any $R>4$

$$
L w=f_{R}-L\left(v \mathbb{1}_{B_{R} \backslash B_{4}}\right)+p_{R}=: \tilde{f} \quad \text { in } \Omega \cap B_{3},
$$

where $f_{R} \rightarrow f$ in $d^{s+1-\alpha} L^{\infty}\left(\Omega \cap B_{3}\right)$, as $R \rightarrow \infty$, and $p_{R} \in \mathcal{P}_{k-1}$. As in the proof of Lemma 2.10 (see also AbRo20, Lemma 3.6] and Kuk21, Lemma 4.8]), taking difference quotients of order $k-1+\delta$ of the equation for $w$, and using crucially that $K \in C^{k-1+\delta}\left(\mathbb{S}^{n-1}\right)$, we can find a polynomial $p \in \mathcal{P}\lfloor k-1+\delta\rfloor$ and $h$ with $d^{s+1-\alpha} h \in L^{\infty}\left(\Omega \cap B_{3}\right)$ such that

$$
\left\{\begin{array}{lll}
L w & =h+p & \text { in } \Omega \cap B_{3}, \\
w & =0 & \text { in } \mathbb{R}^{n} \backslash\left(\Omega \cap B_{4}\right),
\end{array}\right.
$$

and moreover, $h$ satisfies the estimate

$$
\begin{equation*}
\left\|d_{\Omega}^{s+1-\alpha} h\right\|_{L^{\infty}\left(\Omega \cap B_{3}\right)} \leq C\left(\left\|d_{\Omega}^{s+1-\alpha} f\right\|_{L^{\infty}\left(\Omega \cap B_{3}\right)}+\left\|v|\cdot|^{-n-2 s-(k-1+\delta)}\right\|_{L^{1}\left(\mathbb{R}^{n} \backslash B_{4}\right)}\right) . \tag{4.12}
\end{equation*}
$$

Next, let us take a bounded domain $D \subset \mathbb{R}^{n}$ with $\partial D \in C^{1, \gamma}$ such that $\Omega \cap B_{2} \subset D \subset \Omega \cap B_{3}$. Moreover, we find $w_{1}, w_{2}$ such that $w_{1} / d_{D}^{s-1}, w_{1} / d_{D}^{s-1} \in C(\bar{D})$ and $w=w_{1}+w_{2}$ satisfying

$$
\left\{\begin{array} { l l } 
{ L w _ { 1 } } & { = h \text { in } D , } \\
{ w _ { 1 } } & { = w \text { in } \mathbb { R } ^ { n } \backslash D , } \\
{ w _ { 1 } / d _ { D } ^ { s - 1 } } & { = v / d _ { D } ^ { s - 1 } \text { on } \partial D , }
\end{array} \quad \text { and } \quad \left\{\begin{array}{ll}
L w_{2} & =p \text { in } D, \\
w_{2} & =0 \text { in } \mathbb{R}^{n} \backslash D, \\
w_{2} / d_{D}^{s-1} & =0
\end{array} \text { on } \partial D .\right.\right.
$$

Note that the existence of $w_{2} \in L^{\infty}\left(\mathbb{R}^{n}\right)$ follows by standard arguments, and we obtain $w_{2} / d_{D}^{s} \in C^{\gamma}(\bar{D})$ from [FeRo24a, Theorem 2.7.1], which yields $w_{2} / d_{D}^{s-1}=d_{D}\left(w_{2} / d_{D}^{s}\right) \in C^{\gamma}(\bar{D})$ since $\partial D \in C^{1, \gamma}$. Then, we can define $w_{1}:=w-w_{2}$. We claim that

$$
\begin{equation*}
\left\|w_{1} / d_{D}^{s-1}\right\|_{L^{\infty}(D)} \leq c\left(\left\|v / d_{\Omega}^{s-1}\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}+\left\|d_{\Omega}^{s+1-\alpha} h\right\|_{L^{\infty}\left(\Omega \cap B_{3}\right)}\right) . \tag{4.13}
\end{equation*}
$$

To see this, let us recall the function $\psi_{1}$ (with respect to $D$ ) from Lemma 2.7, and observe that by Lemma 2.3, we can take it in such a way that

$$
\begin{equation*}
L\left(\psi_{1}+d_{\Omega}^{s-1}\right) \geq c_{0} d_{D}^{\alpha-s-1} \quad \text { in } D \tag{4.14}
\end{equation*}
$$

for some $c_{0}>0$. Moreover, recall $\psi_{1} / d_{D}^{s-1}=1$ on $\partial D$. Then, let us define
$\Psi(x)=c_{1} \psi_{1}(x)\left(\left\|v / d_{D}^{s-1}\right\|_{L^{\infty}(\partial D)}+\left\|d_{D}^{s+1-\alpha} h\right\|_{L^{\infty}(D)}+\left\|w / d_{\Omega}^{s-1}\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}\right)+c_{1} d_{\Omega}^{s-1}(x)\left\|w / d_{\Omega}^{s-1}\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}$,
where $c_{1}:=\max \left\{c_{0}^{-1}, 1\right\}$, and observe that by (4.14) we have

$$
\left\{\begin{array}{lll}
L w_{1} & \leq L \Psi & \text { in } D \\
w_{1} & \leq \Psi & \text { in } \mathbb{R}^{n} \backslash D \\
w_{1} / d_{D}^{s-1} & \leq \Psi / d_{D}^{s-1} & \text { on } \partial D
\end{array}\right.
$$

which, recalling that $\psi_{1} \leq c_{1} d_{D}^{s-1}$ in $D$, and $d_{D} \leq d_{\Omega}$, as well as the definition of $D$, imply that

$$
\begin{aligned}
\frac{w_{1}}{d_{D}^{s-1}} & \leq c_{2} c_{1}\left(\left\|v / d_{D}^{s-1}\right\|_{L^{\infty}(\partial D)}+\left\|d_{D}^{s+1-\alpha} h\right\|_{L^{\infty}(D)}+\left\|w / d_{\Omega}^{s-1}\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}\right)+c_{2} c_{1} \frac{d_{\Omega}^{s-1}}{d_{D}^{s-1}}\left\|w / d_{\Omega}^{s-1}\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)} \\
& \leq c\left(\left\|v / d_{\Omega}^{s-1}\right\|_{L^{\infty}\left(\partial \Omega \cap B_{3}\right)}+\left\|d_{\Omega}^{s+1-\alpha} h\right\|_{L^{\infty}\left(\Omega \cap B_{3}\right)}+\left\|v / d_{\Omega}^{s-1}\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}\right)
\end{aligned}
$$

which yields our claim in (4.13). As a direct consequence of (4.13), we deduce

$$
\begin{align*}
\left\|w_{2} / d_{D}^{s-1}\right\|_{L^{\infty}(D)} & \leq\left\|w / d_{D}^{s-1}\right\|_{L^{\infty}(D)}+\left\|w_{1} / d_{D}^{s-1}\right\|_{L^{\infty}(D)}  \tag{4.15}\\
& \leq c\left(\left\|v / d_{\Omega}^{s-1}\right\|_{L^{\infty}\left(\Omega \cap B_{4}\right)}+\left\|d_{\Omega}^{s+1-\alpha} h\right\|_{L^{\infty}\left(\Omega \cap B_{3}\right)}\right)
\end{align*}
$$

Finally, we claim that

$$
\begin{equation*}
\|p\|_{L^{\infty}(D)} \leq c\left\|w_{2} / d_{D}^{s-1}\right\|_{L^{\infty}(D)} . \tag{4.16}
\end{equation*}
$$

Note that once we show (4.16), then the proof is complete after combination of (4.16), (4.15), (4.12), and application of the boundary Hölder regularity estimate (see Theorem 1.6) to $w$ in $\Omega$, as in the
case $k=0$. We prove (4.16) by contradiction. Suppose there are sequences $\left(L_{j}\right)_{j},\left(w_{j}\right)_{j},\left(p_{j}\right)_{j}$ with

$$
\left\|p_{j}\right\|_{L^{\infty}(D)}=1, \quad \text { and } \quad \begin{cases}L_{j} w_{j} & =p_{j} \quad \text { in } D \\ w_{j} & =0 \quad \text { in } \mathbb{R}^{n} \backslash D \\ w_{j} / d_{\Omega}^{s-1} & =0 \quad \text { on } \partial D \\ \lim _{j \rightarrow \infty}\left\|w_{j} / d_{D}^{s-1}\right\|_{L^{\infty}(D)} & =0\end{cases}
$$

Then, up to subsequences, it holds $L_{j_{m}} \rightharpoonup L, w_{j_{m}} / d_{D}^{s-1} \rightarrow u_{0}$ in $L^{\infty}(D)$ for some $u_{0} \in L^{\infty}(D)$, $p_{j_{m}} \rightarrow p_{0}$ in $L^{\infty}(D)$. While the first convergence statement follows from AbRo20, Lemma 3.7], the second convergence statement follows from Theorem 1.6 and the Arzelà-Ascoli theorem, and the third one is immediate from the boundedness of $\left(p_{j_{m}}\right)$ in a finite dimensional space.
We can now make use of the stability result in FeRo24a, Proposition 2.2.36], and deduce that for $w_{0}=d_{D}^{s-1} u_{0}$, it holds

$$
\left\|p_{0}\right\|_{L^{\infty}(D)}=1, \quad \text { and } \quad \begin{cases}L w_{0} & =p_{0} \quad \text { in } D \\ w_{0} & =0 \quad \text { in } \mathbb{R}^{n} \backslash D \\ w_{0} / d_{D}^{s-1} & =0 \quad \text { on } \partial D \\ \left\|w_{0} / d_{D}^{s-1}\right\|_{L^{\infty}(D)} & =0\end{cases}
$$

Clearly, $w_{0}=0$ is not a solution to $L w_{0}=p_{0}$ in $D$, so we have obtained a contradiction, and conclude the proof of (4.16).

## 5. Liouville theorem in the half-SPACE

The proof of our main result (see Theorem 1.2) is based on a blow-up argument. A crucial ingredient in such proof is a suitable Liouville theorem in the half-space. In this section, we will establish such result for nonlocal problems with local Neumann boundary conditions:
Theorem 5.1. Let $L \in \mathcal{L}_{s}^{h o m}(\lambda, \Lambda)$. Let $k \in \mathbb{N}, \gamma \in(0,1)$ with $\gamma \neq s$, and $K \in C^{k-1+\gamma-s+\delta}\left(\mathbb{S}^{n-1}\right)$ for some $\delta>0$. Let $u \in C\left(\mathbb{R}^{n}\right)$ be a viscosity solution to

$$
\left\{\begin{array}{lll}
L\left(\left(x_{n}\right)_{+}^{s-1} u\right) & \stackrel{k-1+[\gamma-s\rceil}{=} 0 & \text { in }\left\{x_{n}>0\right\} \\
\partial_{n} u & =p & \text { in }\left\{x_{n}=0\right\} \\
|u(x)| & \leq C(1+|x|)^{k+\gamma} & \forall x \in\left\{x_{n}>0\right\}
\end{array}\right.
$$

for some $C>0, p \in \mathcal{P}_{k-1}$. Then, there exist $a_{\beta} \in \mathbb{R}$ for any $\beta \in(\mathbb{N} \cup\{0\})^{n}$ with $|\beta| \leq k$ such that

$$
u(x)=\sum_{|\beta| \leq k} a_{\beta} x_{1}^{\beta_{1}} \ldots x_{n}^{\beta_{n}} \quad \forall x \in\left\{x_{n}>0\right\} .
$$

In order to prove Theorem 5.1, we first establish the following one-dimensional version, which can be proved by combination of the arguments in RoSe16a, Lemma 6.2] and [AbRo20, Lemma 3.3].

Lemma 5.2. Let $k \in \mathbb{N}, \gamma \in(0,1)$ with $\gamma \neq s$, and $u \in C(\mathbb{R})$ satisfying

$$
\left\{\begin{array}{lcl}
(-\Delta)^{s}\left(\left(x_{+}\right)^{s-1} u\right) & \stackrel{k-1+\lceil\gamma-s\rceil}{=} 0 & \text { in }(0, \infty), \\
|u(x)| & \leq C(1+|x|)^{k+\gamma} & \forall x>0
\end{array}\right.
$$

for some $C>0$. Then, the exist $a_{0}, a_{1}, \ldots, a_{k} \in \mathbb{R}$ such that

$$
u(x)=\sum_{j=0}^{k} a_{j} x^{j} \quad \forall x>0 .
$$

Proof. In case $k=1$ and $\gamma<s$, the proof is an application of RoSe16a, Lemma 6.2] with $u(x):=$ $\left(x_{+}\right)^{s-1} u(x)$, and $\delta=s>0, \beta=s+\gamma \in(0,2 s)$.
In case $k>1$ or $\gamma>s$, we have $k-1+\lceil\gamma-s\rceil \geq 1$, and we combine the ideas from AbRo20, Proposition 3.11] with the ones from RoSe16a, Lemma 6.2]. Indeed, let us define $v(x)=\left(x_{+}\right)^{s-1} u(x)$, let $V: \mathbb{R} \times[0, \infty) \rightarrow \mathbb{R}$ be the harmonic extension of $v$ in the sense of [AbRo20, Lemma 3.3], and finally define $\tilde{V}(x, y)=\int_{-\infty}^{x} V(z, y) \mathrm{d} z$. Note that $\tilde{V}$ satisfies (see AbRo20, Lemma 3.3])

$$
\left\{\begin{array}{lll}
\operatorname{div}\left(y^{1-2 s} \nabla \tilde{V}(x, y)\right) & =0 & \text { in } \mathbb{R} \times(0, \infty) \\
\tilde{V}(x, y) & & \text { on } \mathbb{R} \times\{0\} \\
|\tilde{V}(x, y)| & \leq C\left(1+|x|^{2(k-1+\lceil\gamma-s\rceil)+1+\gamma+s}+|y|^{(k-1+\lceil\gamma-s\rceil)+1+\gamma+s}\right) & \text { in } \mathbb{R} \times(0, \infty)
\end{array}\right.
$$

Next, by the proof of RoSe16a, Lemma 6.2], we have the representation formula

$$
\tilde{V}(x, y)=\tilde{V}(r \cos \theta, r \sin \theta)=\sum_{j=0}^{\infty} a_{j} \Theta_{j}(\theta) r^{j+s}, \quad \forall x \in \mathbb{R}, y \in[0, \infty)
$$

where $a_{j} \in \mathbb{R}$, and $\left(\Theta_{j}\right)_{j}$ is a complete orthogonal system in the subspace of even functions in $L^{2}\left((0, \pi),(\sin \theta)^{1-2 s} \mathrm{~d} \theta\right)$. By the arguments in RoSe16a, Lemma 6.2], the bounds on $|\tilde{V}|$ imply

$$
\sum_{j=0}^{\infty} a_{j}^{2} R^{2+2 j}=\int_{\partial B_{R} \cap\{y>0\}} \tilde{V}(x, y)^{2} y^{1-2 s} \mathrm{~d} \sigma \leq C R^{4(k-1+\lceil\gamma-s\rceil)+2+2 \gamma+2}=C R^{4(k+\lceil\gamma-s\rceil)+2 \gamma} .
$$

Therefore, it must be $a_{j}=0$ for any $j>j_{0}$, where $j_{0}=\min \{j \in \mathbb{N}: 2+2 j>4(k+\lceil\gamma-s\rceil)+2 \gamma\}$, which implies

$$
\tilde{V}(x, y)=\sum_{j=0}^{j_{0}} a_{j} \Theta_{j}(\theta) r^{j+s} \quad \forall x \in \mathbb{R}, y \in[0, \infty)
$$

Upon recalling the definition of $V$ and $\tilde{V}$, this implies

$$
v(x)=\left(x_{+}\right)^{s} \sum_{j=0}^{j_{0}-1} b_{j} x^{j}
$$

for some $b_{j} \in \mathbb{R}$, and since $|v(x)| \leq C(1+|x|)^{k+\gamma-1+s}$ and $\gamma \in(0,1)$ by assumption, it must be $b_{j}=0$ for any $j \geq k$. Recalling that by definition $u(x)=v(x)\left(x_{+}\right)^{1-s}$, we deduce that $u$ must be a polynomial of degree at most $k$ in $\{x>0\}$, as desired.

Moreover, we will need the following lemma (see also [Kuk21, Proposition 4.3]):
Lemma 5.3. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $k \in \mathbb{N}, K \in C^{k-2+\delta}\left(\mathbb{S}^{n-1}\right)$ for some $\delta>0$. Let $f \in \mathcal{P}_{k}$. Then,

$$
L\left(\left(x_{n}\right)_{+}^{s-1} f\right) \stackrel{k=1}{=} 0 \quad \text { in }\left\{x_{n}>0\right\} .
$$

Proof. Let us first give a simple proof in case $k=1$. Then, it suffices to prove that for any $i \in\{1, \ldots, n\}$

$$
L\left(\left(x_{n}\right)_{+}^{s-1} x_{i}\right)=0 \quad \text { in }\left\{x_{n}>0\right\} .
$$

First, by integrating $x \mapsto\left(x_{n}\right)_{+}^{s-1}$ in $x_{i}$, and using that $L\left(\left(x_{n}\right)_{+}^{s-1}\right)=0$, we deduce

$$
L\left(\left(x_{n}\right)_{+}^{s-1} x_{i}\right) \equiv c \quad \text { in }\left\{x_{n}>0\right\}
$$

for some constant $c \in \mathbb{R}$. Then, since $x \mapsto\left(x_{n}\right)_{+}^{s-1} x_{i}$ is homogeneous of degree $s$, we deduce that for any $\lambda>0$ and $x \in\left\{x_{n}>0\right\}$ :

$$
c=L\left(\left(x_{n}\right)_{+}^{s-1} x_{i}\right)(\lambda x)=\lambda^{-2 s} L\left(\left(\lambda x_{n}\right)_{+}^{s-1} \lambda x_{i}\right)(x)=\lambda^{-s} L\left(\left(x_{n}\right)_{+}^{s-1} x_{i}\right)(x)=\lambda^{-s} c .
$$

This implies that $c=0$, as desired.
For $k \geq 2$, we prove the result by induction. Assume that we know already

$$
\begin{equation*}
L\left(\left(x_{n}\right)_{+}^{s-1} p\right) \stackrel{k-2}{=} 0 \quad \text { in }\left\{x_{n}>0\right\} \tag{5.1}
\end{equation*}
$$

for every $p \in \mathcal{P}_{k-1}$. Now, let $q \in \mathcal{P}_{k}$. Then, by integrating (5.1) with $p:=\partial_{i} q$ for $i \in\{1, \ldots, n\}$, by Lemma 2.12 we find that there exists a constant $c \in \mathbb{R}$ such that

$$
L\left(\left(x_{n}\right)_{+}^{s-1} q\right) \stackrel{k-1}{=} c \quad \text { in }\left\{x_{n}>0\right\}
$$

Since $c \stackrel{k-1}{=} 0$ for any $k \geq 2$, we conclude the proof.
Finally, we state a Hölder regularity estimate in the half-space, which follows from Corollary 4.4.
Corollary 5.4. Let $L \in \mathcal{L}_{s}^{\text {hom }}(\lambda, \Lambda)$. Let $k \in \mathbb{N} \cup\{0\}$, $\gamma>0$, and $K \in C^{k-1+\delta}\left(\mathbb{S}^{n-1}\right)$ for some $\delta>0$. Let $f \in C\left(\left\{x_{n}>0\right\} \cap B_{2}\right), g \in C\left(\overline{\left\{x_{n}=0\right\} \cap B_{2}}\right)$, and $u \in C\left(\left\{x_{n} \geq 0\right\}\right)$ be a viscosity solution to

$$
\left\{\begin{array}{lll}
L\left(\left(x_{n}\right)_{+}^{s-1} u\right) & \stackrel{k}{=} f & \text { in }\left\{x_{n}>0\right\} \cap B_{2}, \\
\partial_{n} u & =g & \text { on }\left\{x_{n}=0\right\} \cap B_{2} .
\end{array}\right.
$$

Then, there exists $\alpha_{0}>0$ such that if $\left(x_{n}\right)_{+}^{s+1-\alpha} f \in L^{\infty}\left(\left\{x_{n}>0\right\} \cap B_{2}\right)$ for some $\alpha \in\left(0, \alpha_{0}\right]$, then the following holds true: If $k=0$ and $\left(x_{n}\right)_{+}^{s-1} u \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ it holds $u \in C_{l o c}^{\alpha}\left(\left\{x_{n} \geq 0\right\} \cap B_{2}\right)$, and

$$
\begin{aligned}
\|u\|_{C^{\alpha}\left(\left\{x_{n} \geq 0\right\} \cap B_{1}\right)} \leq c\left(\|u\|_{L^{\infty}\left(\left\{x_{n}>0\right\} \cap B_{4}\right)}\right. & +\left\|\left(x_{n}\right)_{+}^{s+1} u\right\|_{L_{2 s}^{1}\left(\mathbb{R}^{n} \backslash B_{4}\right)} \\
& \left.+\left\|\left(x_{n}\right)_{+}^{s+1-\alpha} f\right\|_{L^{\infty}\left(\left\{x_{n}>0\right\} \cap B_{2}\right)}+\|g\|_{L^{\infty}\left(\left\{x_{n}=0\right\} \cap B_{2}\right)}\right)
\end{aligned}
$$

and if $k \in \mathbb{N}$ and $\left(x_{n}\right)_{+}^{s-1} u \in L_{2 s+(k-1+\delta)}^{1}\left(\mathbb{R}^{n}\right)$ it holds $u \in C_{\text {loc }}^{\alpha}\left(\left\{x_{n} \geq 0\right\} \cap B_{2}\right)$, and

$$
\begin{aligned}
\|u\|_{C^{\alpha}\left(\left\{x_{n} \geq 0\right\} \cap B_{1}\right)} \leq c\left(\|u\|_{L^{\infty}\left(\left\{x_{n}>0\right\} \cap B_{4}\right)}\right. & +\left\|\left[\left(x_{n}\right)_{+}^{s-1} u\right]|\cdot|^{-n-2 s-(k-1+\delta)}\right\|_{L^{1}\left(\left\{x_{n}>0\right\} \backslash B_{4}\right)} \\
& \left.+\left\|\left(x_{n}\right)_{+}^{s+1-\alpha} f\right\|_{L^{\infty}\left(\left\{x_{n}>0\right\} \cap B_{2}\right)}+\|g\|_{L^{\infty}\left(\left\{x_{n}=0\right\} \cap B_{2}\right)}\right)
\end{aligned}
$$

where $c>0$ and $\alpha_{0}$ depend only on $n, s, \lambda, \Lambda, \gamma, k, \delta$.
Proof. The result follows directly from Corollary 4.4 applied to some domain $\Omega \subset \mathbb{R}^{n}$ with $\partial \Omega \in C^{1, \gamma}$, which satisfies $\left\{x_{n}>0\right\} \cap B_{2} \subset \Omega \subset\left\{x_{n}>0\right\} \cap B_{4}$.

With the help of the one-dimensional Liouville theorem in the half-space and the Hölder regularity estimate up to the boundary (see Corollary 5.4), the proof of Theorem 5.1 follows by a standard procedure, which is explained in detail for instance in AbRo20, Proof of Theorem 3.10].

Proof of Theorem 5.1. First, we observe that by scaling Corollary 5.4, we obtain that for any $R \geq 1$ :

{[u]_{C^{\alpha}\left(B_{R}\right)} \leq c R^{-\alpha}[ } & \|u\|_{L^{\infty}\left(B_{4 R}\right)}+R^{1+s}\left\|\left(x_{n}\right)_{+}^{s-1} u|\cdot|^{-n-2 s}\right\|_{L^{1}\left(\mathbb{R}^{n} \backslash B_{4 R}\right)} \mathbb{1}_{\{k=1 \text { and } \gamma<s\}} \\
& +R^{s+k-1+\lceil\gamma-s\rceil+\eta}\left\|\left[\left(x_{n}\right)_{+}^{s-1} u\right]|\cdot|^{-n-2 s-(k-2+\lceil\gamma-s\rceil+\eta)}\right\|_{L^{1}\left(\left\{x_{n}>0\right\} \backslash B_{4 R}\right)} \mathbb{1}_{\{k \geq 2 \text { or } \gamma>s\}} \\
& \left.+R\|p\|_{L^{\infty}\left(\left\{x_{n}=0\right\} \cap B_{4 R}\right)}\right] \leq c R^{k+\gamma-\alpha}, \tag{5.2}
\end{align*}
$$

where we take $\eta=1+\gamma-s-\lceil\gamma-s\rceil+\delta$ and used in the last estimate the growth condition on $u$, the fact that $\|p\|_{L^{\infty}\left(\left\{x_{n}=0\right\} \cap B_{R}\right)} \leq c R^{k-1}$, and the following computation using polar coordinates with $y_{n}=r \cos \theta$ for some $\theta \in[0,2 \pi)$ (similar to the proof of Lemma 4.2), which is slightly different in case ( $k=1$ and $\gamma<s$ ) and ( $k \geq 2$ or $\gamma>s$ ). In case $k=1$ and $\gamma<s$, we obtain:

& \leq c R^{1+s} \int_{0}^{2 \pi} \cos (\theta)_{+}^{s-1}\left(\int_{4 R}^{\infty} r^{s-1} r^{-1-2 s+1+\gamma} \mathrm{d} r\right) \mathrm{d} \theta  \tag{5.3}\\
& \leq c R^{1+s} R^{\gamma-s}\left(\int_{0}^{2 \pi} \cos (\theta)_{+}^{s-1} \mathrm{~d} \theta\right) \leq c R^{1+\gamma}
\end{align*}
$$

In case ( $k \geq 2$ or $\gamma>s$ ), we obtain, using that $\eta>1+\gamma-s-\lceil\gamma-s\rceil$ :

& \leq C R^{s+k-1+\lceil\gamma-s\rceil+\eta} \int_{\mathbb{R}^{n} \backslash B_{4 R}}\left(y_{n}\right)_{+}^{s-1}|y|^{-n-2 s-(k-2+\lceil\gamma-s\rceil+\eta)+k+\gamma} \mathrm{d} y \\
& \leq c R^{s+k-1+\lceil\gamma-s\rceil+\eta} \int_{0}^{2 \pi} \cos (\theta)_{+}^{s-1}\left(\int_{4 R}^{\infty} r^{s-1} r^{-1-2 s+2-\lceil\gamma-s\rceil+\gamma-\eta} \mathrm{d} r\right) \mathrm{d} \theta \\
& \leq c R^{k+s} R^{\gamma-s}\left(\int_{0}^{2 \pi} \cos (\theta)_{+}^{s-1} \mathrm{~d} \theta\right) \leq c R^{k+\gamma} .
\end{aligned}
$$

Next, let us take any $\tau \in \mathbb{S}^{n-1}$ such that $\tau_{n}=0$ and $0<h<R / 2$. We consider the difference quotient

and deduce from (5.2) (after applying the estimate to smaller balls of radius comparable to $R$ inside $B_{R}$ ) that

Clearly, since $\tau_{n}=0, w_{1, \tau}$ satisfies in the viscosity sense

\partial_{n} w_{1, \tau} & =p_{1, \tau} & \text { on }\left\{x_{n}=0\right\}
\end{array}\right.
$$

Here, we are using that sums of viscosity solutions are again viscosity solutions by Lemma 2.14. Using (5.4) and also that $\left|p_{1, \tau}(x)\right| \leq c|x|^{k-1-\alpha}$ since $p \in \mathcal{P}_{k-1}$, we can apply the previous arguments to $w_{1, \tau}$. Eventually, this implies that $w_{2, \tau}(x)=\frac{w_{1, \tau}(x+h \tau)-w_{1, \tau}(x)}{h^{\alpha}}$ satisfies $\left\|w_{2, \tau}\right\|_{L^{\infty}\left(B_{R}\right)} \leq c R^{k+\gamma-2 \alpha}$. This way, we obtain higher order difference quotients $w_{j, \tau}, j \in \mathbb{N}$, and they satisfy

L\left(\left(x_{n}\right)_{+}^{s-1} w_{j, \tau}\right) & \stackrel{k-1+\lceil\gamma-s\rceil}{=} 0 & \text { in }\left\{x_{n}>0\right\} \\
\partial_{n} w_{j, \tau} & =p_{j, \tau} & \text { on }\left\{x_{n}=0\right\} \\
\left\|w_{j, \tau}\right\|_{L^{\infty}\left(B_{R}\right)} & \leq c R^{k+\gamma-j \alpha} & \forall R \geq 1 \\
\left\|p_{j, \tau}\right\|_{L^{\infty}\left(B_{R}\right)} & \leq c R^{k-1-j \alpha} & \forall R \geq 1
\end{array}\right.
$$

Then, taking $j_{0} \in \mathbb{N}$ as the smallest number such that $j_{0} \alpha>k+\gamma$, and upon taking the limit $R \rightarrow \infty$, we deduce that

$$
\lim _{R \rightarrow \infty}\left\|w_{j_{0}, \tau}\right\|_{L^{\infty}\left(B_{R}\right)} \leq c \lim _{R \rightarrow \infty} R^{k+\gamma-j_{0} \alpha}=0
$$

i.e., $w_{j_{0}, \tau} \equiv 0$ in $\mathbb{R}^{n}$. Thus, $w_{j_{0}-1, \tau}$ is a function that is constant in the $\tau$-direction. Clearly, we can also take difference quotients of $w_{j_{0}-1, \tau}$ in other directions $\tau^{\prime} \in \mathbb{S}^{n-1}$ with $\tau_{n}^{\prime}=0$, and the same arguments as before apply. Therefore, $w_{j_{0}-1, \tau}(x)=w_{j_{0}-1, \tau}\left(x_{n}\right)$ is one-dimensional for any $\tau \in \mathbb{S}^{n-1}$ with $\tau_{n}=0$.
Unraveling the higher order difference quotients, we get that $w_{j_{0}-2, \tau}(x)=\left(V_{1}\left(x_{n}\right), x^{\prime}\right)+V_{2}\left(x_{n}\right)$ for some one-dimensional functions $V_{1}: \mathbb{R} \rightarrow \mathbb{R}^{n-1}$ and $V_{2}: \mathbb{R} \rightarrow \mathbb{R}$, and continuing this argument $j_{0}-1$ times, we deduce that $u$ must be a polynomial in $x^{\prime}$ with coefficients that are one-dimensional functions from $\mathbb{R} \rightarrow \mathbb{R}$ in $x_{n}$.
Then, by the growth condition on $u$, for any multi-index $\beta \in(\mathbb{N} \cup\{0\})^{n-1}$ with $|\beta| \leq k$, we obtain functions $A_{\beta}$ in $x_{n}$ such that

$$
u(x)=\sum_{|\beta| \leq k}\left(x^{\prime}\right)^{\beta} A_{\beta}\left(x_{n}\right) .
$$

In particular, this implies that $D_{x^{\prime}}^{\beta} u(x)=c(\beta) A_{\beta}\left(x_{n}\right)$ for any $|\beta|=k$ and some constant $c(\beta)>0$, where $D_{x^{\prime}}^{\beta}$ denotes an incremental quotient approximating the partial derivative $\partial_{x^{\prime}}^{\beta}$ in the $x^{\prime}$-variables. Therefore, discretely differentiating the equation for $u$, we deduce

c(\beta) L\left(\left(x_{n}\right)_{+}^{s-1} A_{\beta}\right)(x)=L\left(\left(x_{n}\right)_{+}^{s-1} D_{x^{\prime}}^{\beta} u\right)(x)=L\left(D_{x^{\prime}}^{\beta}\left[\left(x_{n}\right)_{+}^{s-1} u\right]\right)(x) \stackrel{k-1+\lceil\gamma-s\rceil}{=} 0 \quad \text { in }\left\{x_{n}>0\right\} .
$$

By the growth condition on $u$, it must be $\left|A_{\beta}\left(x_{n}\right)\right| \leq c\left(1+\left|x_{n}\right|\right)^{k-|\beta|+\gamma}=c(1+|x|)^{\gamma}$, and since $A_{\beta}$ was also one-dimensional, i.e., $L A_{\beta}=(-\Delta)_{\mathbb{R}}^{s} A_{\beta}$, we can apply Lemma 5.2 to $A_{\beta}$, which yields $A_{\beta}\left(x_{n}\right)=p_{\beta}\left(x_{n}\right)$ for some polynomial $p_{\beta} \in \mathcal{P}_{k-|\beta|}=\mathcal{P}_{0}$. Next, we recall from Lemma 5.3

L\left(\left(x_{n}\right)_{+}^{s-1}\left(x^{\prime}\right)^{\beta} p_{\beta}\left(x_{n}\right)\right) \stackrel{k-1+\lceil\gamma-s\rceil}{=} 0 \quad \text { in }\left\{x_{n}>0\right\} .

Thus, repeating the arguments from above, we deduce that, for every $\beta$ with $|\beta| \leq k$ it holds

\left|A_{\beta}(x)\right| & \leq C(1+|x|)^{k-|\beta|+\gamma} & \forall x \in\left\{x_{n}>0\right\},
\end{array}\right.
$$

and hence $A_{\beta}\left(x_{n}\right)=p_{\beta}\left(x_{n}\right)$ for some polynomial $p_{\beta} \in \mathcal{P}_{k-|\beta|}$. This implies $u(x)=p(x)$ for some polynomial $p$, and by the growth condition on $u$, it must be $p \in \mathcal{P}_{k}$, as desired.

## 6. Higher order boundary regularity

The goal of this section is to prove the desired higher order boundary regularity for nonlocal equations with local Neumann conditions (see Theorem 1.2). The proof goes by a blow-up argument and heavily uses the Liouville theorem in the half-space (see Theorem 5.1), as well as the boundary Hölder estimate (see Theorem 1.6).

Lemma 6.1. Let $L \in \mathcal{L}_{s}^{h o m}(\lambda, \Lambda)$. Let $k \in \mathbb{N}$ and $\Omega \subset \mathbb{R}^{n}$ be an open, bounded domain with $\partial \Omega \in$ $C^{k+1, \gamma}$ for some $\gamma \in(0,1)$ with $\gamma \neq s$, and $K \in C^{2 k+2 \gamma+3}\left(\mathbb{S}^{n-1}\right)$. Let $v \in L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ with $v / d^{s-1} \in C(\bar{\Omega})$ be a viscosity solution to

L v & =f & \text { in } \Omega \cap B_{1} \\
v & =0 & \text { in } B_{1} \backslash \Omega \\
\partial_{\nu}\left(v / d^{s-1}\right) & =g \quad \text { on } \partial \Omega \cap B_{1}

(i) If $k=1$ and $\gamma<s, f \in C\left(\Omega \cap B_{1}\right)$ with $d^{s-\gamma} f \in L^{\infty}\left(\Omega \cap B_{1}\right)$, $g \in C^{\gamma}\left(\partial \Omega \cap B_{1}\right)$, then for any $x_{0} \in \partial \Omega \cap B_{1 / 2}$ and $x \in \Omega \cap B_{1 / 2}$ it holds

$$
\begin{aligned}
& \left|\frac{v}{d^{s-1}}(x)-\left(\frac{v}{d^{s-1}}\left(x_{0}\right)-A\left(x_{0}\right) \cdot\left(x-x_{0}\right)\right)\right| \\
& \quad \leq c\left(\left\|\frac{v}{d^{s-1}}\right\|_{L^{\infty}(\Omega)}+\|v\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \Omega\right)}+\left\|d^{s-\gamma} f\right\|_{L^{\infty}\left(\Omega \cap B_{1}\right)}+\|g\|_{C^{\gamma}\left(\partial \Omega \cap B_{1}\right)}\right)\left|x-x_{0}\right|^{1+\gamma}
\end{aligned}
$$

for some $c>0$, which only depends on $n, s, \lambda, \Lambda, \gamma$, and the $C^{2, \gamma}$ radius of $\Omega$. If in addition, it holds $g \equiv 0$, then $A\left(x_{0}\right) \cdot \nu_{x_{0}}=0$.
(ii) If $k \geq 2$ or $\gamma>s, f \in C^{(k-1)-s+\gamma}\left(\Omega \cap B_{1}\right), g \in C^{k-1+\gamma}\left(\partial \Omega \cap B_{1}\right)$, then for any $x_{0} \in \partial \Omega \cap B_{1 / 2}$, there is $Q\left(\cdot ; x_{0}\right) \in \mathcal{P}_{k}$ such that for any $x \in \Omega \cap B_{1 / 2}$ it holds

\begin{aligned}
& \left|\frac{v}{d^{s-1}}(x)-Q\left(x ; x_{0}\right)\right| \\
& \quad \leq c\left(\left\|\frac{v}{d^{s-1}}\right\|_{L^{\infty}(\Omega)}+\|v\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \Omega\right)}+\|f\|_{C^{(k-1)-s+\gamma\left(\Omega \cap B_{1}\right)}}+\|g\|_{C^{k-1+\gamma}\left(\partial \Omega \cap B_{1}\right)}\right)\left|x-x_{0}\right|^{k+\gamma}
\end{aligned}
$$

for some $c>0$, which only depends on $n, s, \lambda, \Lambda, \gamma, k$, and the $C^{k+1, \gamma}$ radius of $\Omega$.
Proof. Let us assume without loss of generality that $x_{0}=0 \in \partial \Omega$ with $\partial_{\nu_{0}}=e_{n}$. We set $u:=v / d^{s-1}$. We will prove the desired result by a blow-up argument. To do so, we assume by contradiction that for any $j \in \mathbb{N}$ there exist $C^{k+1, \gamma}$ domains $\Omega_{j} \subset \mathbb{R}^{n}, f_{j} \in C^{k-1}\left(\Omega_{j} \cap B_{1}\right), g_{j} \in C^{k-1+\gamma}\left(\partial \Omega_{j} \cap B_{1}\right)$, $r_{j}>0$, operators $L_{j}$ with ellipticity constants $\lambda, \Lambda$, and $v_{j} \in C\left(\Omega_{j}\right) \cap L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ viscosity solutions to

$$
\left\{\begin{array}{lll}
L_{j} v_{j} & =f_{j} & \text { in } \Omega_{j} \cap B_{1} \\
v_{j} & =0 & \text { in } B_{1} \backslash \Omega_{j} \\
\partial_{\nu}\left(v_{j} / d_{j}^{s-1}\right) & =g_{j} & \text { on } \partial \Omega_{j} \cap B_{1}
\end{array}\right.
$$

such that

$$
\begin{aligned}
\left|\operatorname{diam} \Omega_{j}\right| & +\left\|u_{j}\right\|_{L^{\infty}\left(\Omega_{j}\right)}+\left\|v_{j}\right\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash \Omega_{j}\right)}+\mathbb{1}_{\{k=1 \text { and } \gamma<s\}}\left\|d_{j}^{s-\gamma} f_{j}\right\|_{L^{\infty}\left(\Omega_{j} \cap B_{1}\right)} \\
& +\mathbb{1}_{\{k \geq 2 \text { or } \gamma>s\}}\left\|f_{j}\right\|_{C^{(k-1)-s+\gamma}\left(\Omega_{j} \cap B_{1}\right)}+\left\|g_{j}\right\|_{C^{k-1+\gamma}\left(\Omega_{j} \cap B_{1}\right)}+\left\|d_{j}\right\|_{C^{k+1, \gamma\left(\Omega_{j} \cap B_{1}\right)}} \leq C
\end{aligned}
$$

for some $C>0$, denoted $d_{\Omega_{j}}=d_{j}$, and used that $d_{j} \in C^{k+1, \gamma}$ by [FeRo24a, Definition 2.7.5]. Finally, we assume by contradiction

Observe that up to a rotation, $r_{m}^{-1} \Omega_{j_{m}} \cap B_{r_{m}^{-1}} \rightarrow\left\{x_{n}>0\right\}$. Moreover, we will write $\tilde{d}_{j_{m}} \mathbb{1}_{r_{m}^{-1} \Omega_{j_{m}}}:=$ $\tilde{d}_{j_{m}}=: r_{m}^{-1} d_{j_{m}}\left(r_{m} \cdot\right)$ for the (regularized) distance with respect to $r_{m}^{-1} \Omega_{j_{m}}$.
We consider the $L^{2}\left(\Omega_{j} \cap B_{r}\right)$-projections of $u_{j}$ over $\mathcal{P}_{k}$, and denote them by $Q_{j, r} \in \mathcal{P}_{k}$. They satisfy the following properties:

\int_{\Omega_{j} \cap B_{r}}\left(u_{j}(x)-Q_{j, r}(x)\right) Q(x) \mathrm{d} x & =0 & & \forall Q \in \mathcal{P}_{k} .
\end{array}
$$

Next, we introduce

\theta(r):=\sup _{j \in \mathbb{N}} \sup _{\rho \geq r} \rho^{-k-\gamma}\left\|u_{j}-Q_{j, \rho}\right\|_{L^{\infty}\left(\Omega_{j} \cap B_{r}\right)} .
$$

Observe that $\theta(r) \nearrow \infty$, as $r \searrow 0$. This follows in the same way as the proof of AbRo20, Lemma 4.3].

As a consequence, there exist sequences $\left(r_{m}\right)_{n}$ and $\left(j_{m}\right)_{m}$ such that

Let us define for any $m \in \mathbb{N}$,

and observe that by construction, we have

\end{equation*}

Next, we claim that

\end{equation*}
$$

To see this, we estimate for any $R \geq 1$, using the definition of $\theta\left(R r_{m}\right)$ :

r_{m}^{k+\gamma} \theta\left(r_{m}\right) \\
\end{array} \frac{\left(R r_{m}\right)^{k+\gamma} \theta\left(R r_{m}\right)}{r_{m}^{k+\gamma} \theta\left(r_{m}\right)}+\frac{\left\|Q_{j_{m}, R r_{m}}-Q_{j_{m}, r_{m}}\right\|_{L^{\infty}\left(\Omega_{j_{m}} \cap B_{R r_{m}}\right)}^{r_{m}^{k+\gamma} \theta\left(r_{m}\right)} .}{} .
\end{aligned}

Moreover, by the same argument as in the proof of AbRo20, Proposition 4.1], it follows that for any $j \in \mathbb{N}, r>0$, and $R \geq 1$ :

By the boundary Hölder regularity estimate for solutions to the nonlocal Neumann problem (see Corollary 4.4 applied with $k:=k+\lceil\gamma-s\rceil, \delta:=0, \Omega:=r_{m}^{-1} \Omega_{j_{m}}, v:=\tilde{d}_{j_{m}}^{s-1} w_{m}, f:=L_{j_{m}}\left(\tilde{d}_{j_{m}}^{s-1} w_{m}\right)$, and $g:=$ $\left.\partial_{\nu} w_{m}\right)$, together with the Arzelà-Ascoli theorem, the sequence $\left(w_{m}\right)_{m}$ converges in $L_{l o c}^{\infty}\left(\left\{x_{n} \geq 0\right\}\right)$ to some $w \in C\left(\left\{x_{n} \geq 0\right\}\right)$. Note that all the quantities on the right hand side of the estimate in Corollary 4.4 will be bounded uniformly in $k$, due to (6.4), (6.8), (6.11), and (6.12). Thus, in particular $\tilde{d}_{j_{m}}^{s-1}\left(r_{m} \cdot\right) w_{m} \rightarrow\left(x_{n}\right)_{+}^{s-1} w$ locally uniformly in $\left\{x_{n}>0\right\}$. Finally, in order to apply the stability result
in Lemma 2.13, it remains to establish $\tilde{d}_{j_{m}}^{s-1}\left(r_{m} \cdot\right) w_{m} \rightarrow\left(x_{n}\right)_{+}^{s-1} w$ in $L_{2 s+(k+\lceil\gamma-s\rceil-1)}^{1}\left(\mathbb{R}^{n}\right)$. To see this, we also observe that by (6.3),

Thus, by stability of viscosity solutions (see Lemma 2.13), we deduce that in the viscosity sense

Finally, note that if $k=1$ and $\gamma<s$, then by the Liouville theorem (see Theorem 5.1), there exist $a \in \mathbb{R}^{n}$ and $b \in \mathbb{R}$ such that

Note that improving the global $L^{\infty}$ norm to the $L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ norm, or the $L_{k+\gamma}^{1}\left(\mathbb{R}^{n} \backslash B_{2}\right)$ norm, respectively, in the estimate goes by the exact same arguments as in the proofs of Lemma 2.10 and Corollary 4.4.
To see (6.15), let us take $z \in \partial \Omega \cap B_{1 / 2}$ such that $\left|x_{0}-z\right|=d\left(x_{0}\right)=r$, and apply Lemma 6.1 to see that there exists a polynomial $Q \in \mathcal{P}_{k}$ such that the function

u_{r}(x):=\frac{u\left(x_{0}+r x\right)-Q\left(x_{0}+r x\right)}{r^{k+\gamma}} \quad \text { satisfies } \quad\left\|u_{r}\right\|_{L^{\infty}\left(B_{R}\right)} \leq C R^{k+\gamma} \forall R \in\left[1, r^{-1}\right] .
$$

Moreover, since $\|u\|_{L^{\infty}\left(\mathbb{R}^{n}\right)} \leq 1$, and $Q \in \mathcal{P}_{k}$, we deduce

$$
\left\|u_{r}\right\|_{L^{\infty}\left(B_{R}\right)} \leq C r^{-k-\gamma}\left(1+(r R)^{k}\right) \leq C R^{k+\gamma} \quad \forall R \geq r^{-1} .
$$

Together, this implies
$\int_{\mathbb{R}^{n} \backslash B_{3 / 4}} \frac{d^{s-1}\left(x_{0}+r x\right)\left|u_{r}(x)\right|}{|x|^{n+k+\gamma}} \mathrm{d} x \leq c \int_{\mathbb{R}^{n} \backslash B_{3 / 4}} \frac{d^{s-1}\left(x_{0}+r x\right)}{|x|^{n}} \mathrm{~d} x=c \int_{\mathbb{R}^{n} \backslash B_{3 r / 4}} \frac{d^{s-1}\left(x_{0}+x\right)}{|x|^{n}} \mathrm{~d} x \leq c\left(1+r^{s-1}\right)$,
where we used Lemma 2.2 with $\gamma:=s-1<0=: \beta$. Moreover, we have by the definition of $r$

$$
\left\|d^{s-1}\left(x_{0}+r \cdot\right) u_{r}\right\|_{L^{\infty}\left(B_{3 / 4}\right)} \leq c r^{s-1}
$$

Now, we apply the interior regularity theory for nonlocal problems (see Lemma 2.10). To do so, we distinguish between the cases (i) $k=1$ and $k+\gamma=1+\gamma \leq 2 s$ and (ii) $k+\gamma>2 s$. In case (i), we apply Lemma 2.10(i) with $\beta=1+\gamma$, observe that automatically $\gamma<s$, and obtain

$$
\begin{aligned}
{\left[d^{s-1}(u-Q)\right]_{C^{1+\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)}=} & {\left[d^{s-1}\left(x_{0}+r \cdot\right) u_{r}\right]_{C^{1+\gamma}\left(B_{1 / 2}\right)} } \\
\leq & c\left\|d^{s-1}\left(x_{0}+r \cdot\right) u_{r}\right\|_{L^{\infty}\left(B_{3 / 4}\right)}+c\left\|\frac{d^{s-1}\left(x_{0}+r \cdot\right) u_{r}}{|x|^{n+1+\gamma}}\right\|_{L^{1}\left(\mathbb{R}^{n} \backslash B_{3 / 4}\right)} \\
& +c\left\|L\left(d^{s-1}\left(x_{0}+r \cdot\right) u_{r}\right)\right\|_{L^{\infty}\left(B_{3 / 4}\right)} \\
\leq & c r^{s-1}+c r^{2 s-(1+\gamma)}\|L v\|_{L^{\infty}\left(B_{3 r / 4}\left(x_{0}\right)\right)} \\
& +c r^{2 s-(1+\gamma)}\left\|L\left(d^{s-1} Q\right)\right\|_{L^{\infty}\left(B_{3 r / 4}\left(x_{0}\right)\right)} \\
\leq & c r^{s-1}+c r^{s-1}\left\|d^{s-\gamma} f\right\|_{L^{\infty}\left(B_{r}\left(x_{0}\right)\right)}+c r^{s-1} \leq c r^{s-1}
\end{aligned}
$$

where we used Corollary 2.5(i) and that $d \geq r / 4$ in $B_{3 r / 4}\left(x_{0}\right)$ by construction, and $r \leq 1$.
In case (ii), we apply Lemma 2.10(ii) with $\alpha:=k+\gamma-2 s>0$ and obtain

$$
\begin{aligned}
{\left[d^{s-1}(u-Q)\right]_{C^{k+\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)}=} & {\left[d^{s-1}\left(x_{0}+r \cdot\right) u_{r}\right]_{C^{k+\gamma}\left(B_{1 / 2}\right)} } \\
\leq & c\left\|d^{s-1}\left(x_{0}+r \cdot\right) u_{r}\right\|_{L^{\infty}\left(B_{3 / 4}\right)}+c\left\|\frac{d^{s-1}\left(x_{0}+r \cdot\right) u_{r}}{|x|^{n+k+\gamma}}\right\|_{L^{1}\left(\mathbb{R}^{n} \backslash B_{3 / 4}\right)} \\
& +c\left[L\left(d^{s-1}\left(x_{0}+r \cdot\right) u_{r}\right)\right]_{C^{k+\gamma-2 s}\left(B_{3 / 4}\right)} \\
\leq & c r^{s-1}+c[L v]_{C^{k+\gamma-2 s}\left(B_{3 r / 4}\left(x_{0}\right)\right)}+c\left[L\left(d^{s-1} Q\right)\right]_{C^{k+\gamma-2 s}\left(B_{3 r / 4}\left(x_{0}\right)\right)} \\
\leq & c r^{s-1}+c r^{s-1}\|f\|_{C^{k+\gamma-2 s}\left(B_{r}\left(x_{0}\right)\right)}+c r^{s-1} \leq c r^{s-1},
\end{aligned}
$$

where we used Corollary 2.5 (iii) in the second to last step.
Moreover, using again the $L^{\infty}$ estimate for $u_{r}$ with $R=1$, we have

$$
\left\|d^{s-1}(u-Q)\right\|_{L^{\infty}\left(B_{r / 2}\left(x_{0}\right)\right)} \leq c r^{s-1}\|u-Q\|_{L^{\infty}\left(B_{r / 2}\left(x_{0}\right)\right)} \leq c r^{s+(k-1)+\gamma}\left\|u_{r}\right\|_{L^{\infty}\left(B_{1}\right)} \leq c r^{s+(k-1)+\gamma}
$$

and hence by Hölder interpolation, we obtain that for any $\delta \in(0, k+\gamma)$ it holds

$$
\left[d^{s-1}(u-Q)\right]_{C^{\delta}\left(B_{r / 2}\left(x_{0}\right)\right)} \leq c r^{s-1+k+\gamma-\delta} .
$$

Therefore, altogether by the product rule

$$
\begin{align*}
& {[(u-Q)]_{C^{k+\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)}=\left[D^{k}\left(d^{1-s} d^{s-1}(u-Q)\right)\right]_{C^{\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)}} \\
& \quad \leq \sum_{|\beta|=k} \sum_{\alpha \leq \beta}\left[\left(\partial^{\alpha} d^{1-s}\right)\left(\partial^{\beta-\alpha} d^{s-1}(u-Q)\right)\right]_{C^{\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)} \\
& \leq \sum_{|\beta|=k} \sum_{\alpha \leq \beta}\left(\left\|\partial^{\alpha} d^{1-s}\right\|_{L^{\infty}\left(B_{r / 2}\left(x_{0}\right)\right)}\left[\partial^{\beta-\alpha} d^{s-1}(u-Q)\right]_{C^{\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)}\right. \\
& \quad \quad+\left\|\partial^{\beta-\alpha} d^{s-1}(u-Q)\right\|_{L^{\infty}\left(B_{r / 2}\left(x_{0}\right)\right)}\left[\partial^{\alpha} d^{1-s}\right]_{\left.C^{\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)\right)}  \tag{6.16}\\
& \leq c \sum_{|\beta|=k} \sum_{\alpha \leq \beta}\left(r^{1-s-|\alpha|} r^{s-1+k+\gamma-(k-|\alpha|+\gamma)}+r^{s-1+k+\gamma-(k-|\alpha|)} r^{1-s-|\alpha|-\gamma}\right) \\
& \quad \leq c \sum_{|\beta|=k} \sum_{\alpha \leq \beta} \leq c,
\end{align*}
$$

where we used that $r \leq 1$, and the following observation based on the fact that $d \in C^{k+1, \gamma}(\bar{\Omega})$ together with corresponding estimates $\left|D^{j} d\right| \leq c_{j} d^{1-j}$, resp. $\left|D^{j} d^{1-s}\right| \leq c_{j} d^{1-s-j}$ in $\Omega$ for every $j \leq k$ (see [FeRo24a, Lemma B.0.1]):

$$
\begin{equation*}
\left[\partial^{\alpha} d^{1-s}\right]_{C^{\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)} \leq\left\|D^{|\alpha|+1} d^{1-s}\right\|_{L^{\infty}\left(B_{r / 2}\left(x_{0}\right)\right)} \sup _{x, y \in B_{r / 2}\left(x_{0}\right)}|x-y|^{1-\gamma} \leq c r^{1-s-|\alpha|-\gamma} \forall|\alpha| \leq k \tag{6.17}
\end{equation*}
$$

This proves our claim (6.15). Note that we can replace the $L^{\infty}$ norm of $u$ in $\mathbb{R}^{n} \backslash B_{2}$ by the $L_{2 s}^{1}\left(\mathbb{R}^{n}\right)$ norm via a standard truncation argument, as in the proof of Corollary 4.4. We conclude the proof.

Finally, we explain how to prove Theorem 1.7.
Proof of Theorem 1.7. The result follows immediately from Theorem 1.2, however it remains to prove that the result only requires $K \in C^{k-2 s+\gamma}\left(\mathbb{S}^{n-1}\right)$ if $\Omega=\left\{x_{n}=0\right\}$. First of all, we recall the Hölder estimate (see Corollary 5.4), which holds true without any regularity assumption on $K$ if $k=0$. Note that for the Liouville theorem (see Theorem 5.1), we only require $K \in C^{k-1-s+\gamma+\delta}\left(\mathbb{S}^{n-1}\right)$ for an arbitrarily small $\delta>0$ and $k-1-s+\gamma<k-2 s+\gamma$. In Lemma 6.1, additional regularity for $K$ is assumed in order to apply Corollary 2.5. However, if $\Omega=\left\{x_{n}>0\right\}$, we have

$$
L\left(d^{s-1} Q\right)=L\left(\left(x_{n}\right)_{+}^{s-1} Q\right) \stackrel{k-1}{=} 0 \quad \text { in }\left\{x_{n}>0\right\}
$$

for any $Q \in \mathcal{P}_{k}$. Hence, in case $k=1$ and $\gamma<s$, the proof goes through exactly as before, without any restrictions on $K$. If $k \geq 2$ or $\gamma>s$, (6.9) needs to be interpreted as an equation up to a polynomial, but the rest of the proof remains the same. Moreover, we apply the Hölder estimate (see Corollary 5.4 , which would force us to impose $K \in C^{k-1}\left(\mathbb{S}^{n-1}\right)$ in case $k \geq 2$ or $\gamma>s$. Therefore, in this case, we need to proceed a little different. Indeed, we replace the computation in (6.4) by the following estimate, based on polar coordinates (see also (5.3)) for $\eta=1+\gamma-s-\lceil\gamma-s\rceil+\delta$ for some very small $\delta>0$ :
$\left\|\left(x_{n}\right)_{+}^{s-1} w_{m}|\cdot|^{-n-2 s-(k-2+\lceil\gamma-s\rceil+\eta)}\right\|_{L^{1}\left(\mathbb{R}^{n} \backslash B_{R}\right)} \leq c \int_{\mathbb{R}^{n} \backslash B_{R}}\left(x_{n}\right)_{+}^{s-1}|x|^{-n-2 s-\lceil\gamma-s\rceil+2+\gamma+\eta} \mathrm{d} x$

$$
\leq c \int_{0}^{2 \pi} \cos (\theta)_{+}^{s-1}\left(\int_{R}^{\infty} r^{s-1} r^{-1-2 s-\lceil\gamma-s\rceil+2+\gamma+\eta} d r\right) \mathrm{d} \theta=c \int_{0}^{2 \pi} \cos (\theta)_{+}^{s-1}\left(\int_{R}^{\infty} r^{-1-\delta} d r\right) \mathrm{d} \theta \leq c R^{-\delta} \rightarrow 0
$$

as $R \rightarrow \infty$. Then, we can apply Corollary 5.4 with $k:=k-1$ and $\delta:=\eta$ and only need to assume that $K \in C^{k-2+\eta}\left(\mathbb{S}^{n-1}\right)$, which is fine by the same reasoning as for the Liouville theorem above. Moreover, the stability theorem (see Lemma 2.13) can still be applied since $k-2+\eta \leq k-1$ if we choose $\delta<s-\eta$. Finally, the proof of Theorem 1.2 relies on an application of the interior regularity result (see Lemma 2.10). In case $k=1$ and $1+\gamma \leq 2 s$, we apply Lemma 2.10(i), so in this case, no regularity assumption on $K$ is required, at all. In case $1+\gamma>2 s$, we apply Lemma 2.10(ii) with $\alpha:=k+\gamma-2 s$ (and interpret the equation up to a polynomial of degree $k-1$, which is possible due to Remark 2.11), so in this case, we need to assume only that $K \in C^{k-2 s+\gamma}\left(\mathbb{S}^{n-1}\right)$, as desired.

## 7. Nonlocal equations with local Dirichlet boundary conditions

Finally, we give the proof of the boundary regularity for nonlocal equations with Dirichlet boundary conditions (see Theorem 1.4).

Proof of Theorem 1.4. Let us first extend $h$ in such a way that $h \in C^{k+\gamma}\left(\mathbb{R}^{n}\right)$. Then, we define $w:=v-d^{s-1} h$ and observe that $w$ solves

$$
\left\{\begin{array}{lll}
L w & =\tilde{f} & \text { in } \Omega, \\
w & =0 & \text { in } \mathbb{R}^{n} \backslash \Omega, \\
w / d^{s-1} & =0 & \text { on } \partial \Omega,
\end{array}\right.
$$

where $\tilde{f}:=f-L\left(d^{s-1} h\right)$. Moreover, for $x_{0} \in \Omega$ an application of Corollary 2.5 yields $\left|\tilde{f}\left(x_{0}\right)\right| \leq$ $c_{1} d^{s-\gamma}\left(x_{0}\right)$ in case $k+\gamma<1+s$, as well as $[\tilde{f}]_{C^{k-1-s+\gamma}(\bar{\Omega})} \leq c_{2}$ in case $k+\gamma>1+s$, and also $[\tilde{f}]_{C^{k-2 s+\gamma}\left(B_{d\left(x_{0}\right) / 2}\left(x_{0}\right)\right)} \leq c_{3} d^{s-1}\left(x_{0}\right)$ in case $k+\gamma>2 s$. Note that since $w / d^{s-1}=0$ on $\partial \Omega$, by the maximum principle (see Proposition 1.3) and a standard barrier argument (see for instance the proof of (FeRo24a, Lemma 2.3.9]) it holds $w \in L^{\infty}(\Omega)$ and

$$
\begin{equation*}
\|w\|_{L^{\infty}(\Omega)} \leq C\|\tilde{f}\|_{L^{\infty}(\Omega)} . \tag{7.1}
\end{equation*}
$$

Thus $w$ is a solution in the setting of RoSe17, AbRo20. We assume without loss of generality

$$
\|w\|_{L^{\infty}(\Omega)}+\left\|d^{s-\gamma} \tilde{f}\right\|_{L^{\infty}(\bar{\Omega})} \mathbb{1}_{\{k+\gamma<1+s\}}+\|\tilde{f}\|_{C^{k-1-s+\gamma}(\Omega)} \mathbb{1}_{\{k+\gamma>1+s\}} \leq 1 .
$$

Then, RoSe17, AbRo20 imply that for any $z \in \partial \Omega$ there exists a polynomial $Q_{z} \in \mathcal{P}_{k-1}$ such that

$$
\left|w(x)-Q_{z}(x) d^{s}\right| \leq c|x-z|^{k-1+\gamma+s} \leq c|x-z|^{k+\gamma} d^{s-1}(x) \quad \forall x \in B_{1}(z) .
$$

By adjusting the proof of RoSe17, Proposition 3.2] in case $k+\gamma<1+s$, or the second part of the proof of AbRo20, Proposition 4.1] in case $k+\gamma>1+s$, respectively, according to the slight modification of the upper bound in the previous estimate, we get that for any $x_{0} \in \Omega \cap B_{1}(z)$, denoting $r:=d\left(x_{0}\right)$,

$$
\begin{equation*}
\left\|w-Q_{z} d^{s}\right\|_{L^{\infty}\left(B_{r / 2}\left(x_{0}\right)\right)} \leq c r^{k+\gamma+s-1}, \quad\left[w-Q_{z} d^{s}\right]_{C^{k+\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)} \leq c r^{s-1} \tag{7.2}
\end{equation*}
$$

Indeed, while the first estimate is immediate from the expansion, the second result follows by denoting

$$
v_{r}(x)=r^{-k-\gamma}\left(u\left(x_{0}+r x\right)-Q_{z}\left(x_{0}+r x\right) d^{s}\left(x_{0}+r x\right)\right),
$$

and observing that by the previous estimate and the properties of $\tilde{f}$ it holds

$$
\left\|v_{r}\right\|_{L^{\infty}\left(B_{R}\right)} \leq c\left(1+r^{s-1}\right) \quad \forall R>0, \quad[\tilde{f}]_{C^{k+\gamma-2 s}\left(B_{r / 2}\left(x_{0}\right)\right)} \mathbb{1}_{\{k+\gamma>2 s\}} \leq c r^{s-1}
$$

Plugging these findings into the remainder of RoSe17, Proof of Theorem 1.2], AbRo20, Proof of Theorem 1.4], we obtain (7.2). From there we can show, using Hölder interpolation, and also $d \in$ $C^{k+1+\gamma}(\bar{\Omega})$ that for any $\delta \in(0, k+\gamma]$ it holds:
$\left[w-Q_{z} d^{s}\right]_{C^{\delta}\left(B_{r / 2}\left(x_{0}\right)\right)} \leq c r^{k+\gamma+s-1-\delta}, \quad\left\|d^{s-1}\right\|_{L^{\infty}\left(B_{r / 2}\left(x_{0}\right)\right)} \leq c r^{1-s}, \quad\left[d^{s-1}\right]_{C^{\delta}\left(B_{r / 2}\left(x_{0}\right)\right)} \leq c r^{1-s-\delta}$.
Thus, proceeding in a similar way as in the proof of Theorem 1.2, and using (7.2) as well as the previous estimate, we obtain

$$
\begin{aligned}
{\left[\frac{w}{d^{s-1}}-Q_{z} d\right]_{C^{k+\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)} } & =\left[D^{k}\left(d^{1-s}\left(w-Q_{z} d^{s}\right)\right)\right]_{C^{\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)} \\
\leq & \sum_{|\beta|=k} \sum_{\alpha \leq \beta}\left[\left(\partial^{\alpha} d^{1-s}\right)\left(\partial^{\beta-\alpha}\left(w-Q_{z} d^{s}\right)\right)\right]_{C^{\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)} \\
\leq & \sum_{|\beta|=k} \sum_{\alpha \leq \beta}\left(\left\|\partial^{\alpha} d^{1-s}\right\|_{L^{\infty}\left(B_{r / 2}\left(x_{0}\right)\right)}\left[\partial^{\beta-\alpha}\left(w-Q_{z} d^{s}\right)\right]_{C^{\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)}\right. \\
& \left.+\left[\partial^{\alpha} d^{1-s}\right]_{C^{\gamma}\left(B_{r / 2}\left(x_{0}\right)\right)}\left\|\partial^{\beta-\alpha}\left(w-Q_{z} d^{s}\right)\right\|_{L^{\infty}\left(B_{r / 2}\left(x_{0}\right)\right)}\right) \\
\leq & c \sum_{|\beta|=k} \sum_{\alpha \leq \beta}\left(r^{1-s-|\alpha|} r^{s-1+|\alpha|}+r^{1-s-|\alpha|-\gamma} r^{\gamma+s-1+|\alpha|}\right) \leq c .
\end{aligned}
$$

From here, by a standard covering argument, and using the continuity of the extension operator,

$$
\begin{aligned}
\left\|\frac{v}{d^{s-1}}\right\|_{C^{k, \gamma}(\bar{\Omega})} & \leq c\left(\left\|v-d^{s-1} h\right\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}+\|f\|_{C^{k-1-s+\gamma}(\Omega)}+\|h\|_{C^{k+\gamma}(\partial \Omega)}\right) \\
& \leq c\left(\|f\|_{C^{k-1-s+\gamma}(\Omega)}+\|h\|_{C^{k+\gamma}(\partial \Omega)}\right)
\end{aligned}
$$
