# On Structural Non-commutativity in Affine Feedback of SISO Nonlinear Systems

#### Abstract

The affine feedback connection of SISO nonlinear systems modeled by Chen-Fliess series is shown to be a group action on the plant which is isomorphic to the semi-direct product of shuffle and additive group of non-commutative formal power series. The additive and multiplicative feedback loops in an affine feedback connection are thus proven to be structurally non-commutative. A flip in the order of these loops results in a net additive feedback loop.


Keywords: Nonlinear Systems, Affine Feedback, Structural Non-commutativity, Chen-Fliess Series, Formal Groups, Formal Lie Algebras.

## 1. INTRODUCTION

The goal of this paper is to quantify the structural noncommutativity between the additive and multiplicative feedback loops in an affine feedback connection of singleinput single-output(SISO) nonlinear systems modeled by Chen-Fliess series. Chen-Fliess series is an weighted iterated integral series that models the input-output behavior of a (input-affine) nonlinear system. The prologue of using input-output maps for analysis of systems is that it is unique to the system (under analysis) and hence a coordinate free approach. Thus any properties proven via this paradigm is intrinsic while the state space realizations are co-ordinate dependent. The argument is akin to significance of Laplace-domain transfer functions/ timedomain input-output maps to state-space modeling in the domain of linear time-invariant systems. Affine feedback (as shown in Figure 1) is a pivotal interconnection in the design of both static and dynamic feedback linearization of nonlinear systems (Isidori, 1995; Gray \& Ebrahimi-Fard, 2017).

The affine feedback interconnection of nonlinear systems modeled by Chen-Fliess was first dealt in the work of Gray \& Ebrahimi-Fard (2017). The affine feedback group (transformation group in the affine feedback interconnection) was explicitly detailed there along with the Hopf algebra of coordinate functions on formal power series which provides a computational framework to compute the group product and the inverse. The work of Foissy (2018) has defined a post-Lie algebra purely from the Hopf algebra of coordinate functions corresponding to the affine feedback.

[^0]Recently in the work of Ebrahimi-Fard et al. (2023), the affine feedback group is proved to be the Grossman-Larson or derived group of a post-group (post group is the image of exponential map in the universal enveloping algebra of the post-Lie algebra). The document will not delve into post-groups and post-Lie algebras. For more details on post-groups and post-Lie algebras, refer Al-Kaabi et al. (2023).

The document shows firstly that affine feedback is a group action on the plant, where the group is same as the group in the definition of post-group (explained in Section 4). The commutator of two subgroups, corresponding to the multiplicative feedback loop and additive feedback loop in Figure 1 quantifies the structural non-commutativity between the loops viz., if one flips the order between the inner(additive) and outer(multiplicative) loops, the overall input-output map ( $v \mapsto y$ ) will not remain the same. As such, proving the existence of structural noncommutativity is not a difficult question but the contribution of the paper stands out in quantifying it via the commutator of subgroups corresponding to additive and multiplicative feedback loops (in its Lie algebra at the infinitesimal level).
The organization of the document is as follows: Section 2 introduces notations and defines the shuffle algebra of formal power series. Section 3 gives a brief on Chen-Fliess series. Section 4 defines the affine feedback transformation group and recollects some of the material from the works of Gray \& Ebrahimi-Fard (2017) and Ebrahimi-Fard et al. (2023). Further, this section leads up to the main results of this document.

## 2. FORMAL POWER SERIES OVER $\mathbb{R}$

The section recalls some preliminaries on non-commutative formal power series and bialgebras. For more details regarding the latter, we refer to (Sweedler, 1969).

Let $X=\left\{x_{0}, x_{1}\right\}$ denote an alphabet, i.e., a set of noncommuting indeterminates.
(i) $\mathbb{R}\langle X\rangle$ is the $\mathbb{R}$-algebra of non-commutative polynomials with indeterminates in $X$. As a vector space, it is spanned by the set of words, denoted by $X^{*}$, with letters from $X$. The unit is the empty word, which we
write 1, and the set of non-empty words is denoted by $X^{+}:=X^{*} \backslash\{\mathbf{1}\}$.
(ii) $\mathbb{R}\langle X\rangle$ is a cocommutative Hopf algebra, graded (by the word length, $\left.|w| \geq 0, w \in X^{*}\right)$ and connected, with catenation product and counit $\epsilon$ such that $\epsilon(w)=\delta_{|w|, 0}$ for any $w \in X^{*}$. The coproduct is unshuffle $\Delta_{\boldsymbol{w}}$ for which the elements $x_{i} \in X$ are primitive, i.e., $\Delta_{\amalg}\left(x_{i}\right)=x_{i} \otimes \mathbf{1}+\mathbf{1} \otimes x_{i}$. A few examples of the unshuffle coproduct are given next. For letters $x_{i}, x_{j} \in X$ :

Remark: Traditionally, the counit of $\mathbb{R}\langle X\rangle$ is denoted by $\emptyset$ in the Chen-Fliess literature; for the rest of the article the presentation also follows this custom.
(iii) The convolution algebra of linear maps from the counital coalgebra $\left(\mathbb{R}\langle X\rangle, \Delta_{\amalg}\right)$ to $\mathbb{R}$, is given by the space of formal power series denoted by $\mathbb{R}\langle\langle X\rangle\rangle$. The dual basis is given by $\{\emptyset\} \cup X^{+}$, such that $\eta(\xi)=1$ if $\eta=\xi$ in $X^{+}$, and zero else. An element $c \in \mathbb{R}\langle\langle X\rangle\rangle$ is represented by

In the following, $\emptyset$ is not explicitly written unless needed. The convolution product on $\mathbb{R}\langle\langle X\rangle\rangle$ is the shuffle product, which is defined for all $c, d \in \mathbb{R}\langle\langle X\rangle\rangle$ and $p \in \mathbb{R}\langle X\rangle$ by

Here, $m_{\mathbb{R}}$ is the usual product in $\mathbb{R}$ and the unit element is the counit $\emptyset$.
(iv) The maximal ideal of $\mathbb{R}\langle\langle X\rangle\rangle$ is denoted by $\mathbb{R}_{p}\langle\langle X\rangle\rangle:=$ $\{c \in \mathbb{R}\langle\langle X\rangle\rangle: c(\mathbf{1})=0\}$. The unit group is denoted by $G_{\text {ш }}:=\mathbb{R}\langle\langle X\rangle\rangle \backslash \mathbb{R}_{p}\langle\langle X\rangle\rangle$. The shuffle group $(M, ш)$ is the normal subgroup of the unit group of $\mathbb{R}\langle\langle X\rangle\rangle$ where

The group inverse in $M$ is defined as:

(v) The additive group of formal power series, denoted by $G_{+}$is defined on the set $\delta+\mathbb{R}\langle\langle X\rangle\rangle$, where the group product $\diamond$ respectively inverse are defined by

for $c \in \mathbb{R}\langle\langle X\rangle\rangle$. The unit element is $\delta$. The group $G_{+}$ can be interpreted as translation of additive group of formal power series $(\mathbb{R}\langle\langle X\rangle\rangle,+, 0)$ by the (fictitious) element $\delta$ such that $F_{\delta}[u]=u$. The context of $\delta$ becomes more lucid with the document.
Looking ahead, we define for $c \in \mathbb{R}\langle\langle X\rangle\rangle$ the ChenFliess series $F_{c}[u](t)$ as a functional series such that the basis (dual words) of $\mathbb{R}\langle\langle X\rangle\rangle$ are identified with iterated integrals of the function $u$, a control signal (detailed in Section 3). In the context of a dynamical system, a Chen-Fliess series expresses its input-output behavior and provides a coordinate-independent framework to analyze the intrinsic properties of the system.

## 3. CHEN-FLIESS SERIES

The section acts as a review of Chen-Fliess series and the affine feedback interconnection. Let $u:[0, T] \longrightarrow \mathbb{R}$ be a $L_{1}$ measurable map over the compact interval $[0, T]$. Define the absolutely continuous function $U:[0, T] \longrightarrow \mathbb{R}$ such that $U(0)=0$ as

Define a monoid morphism $F$ from the monoid of (dual) words $\{\emptyset\} \cup X^{+}$to the monoid of time-ordered iterated integrals of $u$ (where unit is constant map 1) as

where $\eta \in X^{+} \cup\{\emptyset\}$. The monoid morphism implies $F_{\emptyset}[u](t)=1$. Given input $u:[0, T] \longrightarrow \mathbb{R}$ and a noncommutative formal power series $c$, the associated ChenFliess series, denoted by $F_{c}[u]$ is formal functional series defined as:

The map $F: c \mapsto F_{c}$ is an algebra homomorphism from $A_{\text {ш }}$ to algebra of functions viz. $\left(F_{c} \cdot F_{d}\right)[u]=F_{c}[u] F_{d}[u]=$ $F_{c \pm d}[u]$ for all $c, d \in \mathbb{R}\langle\langle X\rangle\rangle$ (Ree, 1958).
The composition of Chen-Fliess series $F_{c}[u] \circ F_{d}[u]$, as illustrated in Figure 2, is a Chen-Fliess series $F_{\text {cod }}[u]$. The formal power series $c \circ d$ is called the composition product of $c$ and $d$ and is defined as

where the composition product restricted to words is inductively defined as (Ferfera, 1980):

for all $\eta \in X^{+} \cup\{\emptyset\}$. The following theorem states that composition product distributes over the shuffle product on the left.
Theorem 3.1. (Ferfera, 1980) Let $c, d$ and $e \in \mathbb{R}\langle\langle X\rangle\rangle$, then $(c ゅ d) \circ e=(c \circ e) ш(d \circ e)$.

Let $B_{p}(R, T):=\left\{u \in L_{p}[0, T]:\|u\|_{p}<R\right\}$ where $\|\cdot\|_{p}$ is the usual $L_{p}$-norm. A Chen-Fliess $F_{c}$ is called convergent if is a well-defined mapping from $B_{1}(R, T)$ to $B_{\infty}(R, T)$ for $R, T>0$ viz $F_{c}[u] \in L_{\infty}([0, T] ; \mathbb{R})$. For more details on convergence of Chen-Fliess series see (Gray \& Wang, 2002; Thitsa \& Gray, 2012; Venkatesh, 2021). If convergence is guaranteed, a Chen-Fliess series $F_{c}$ is called a Fliess operator. A Fliess operator $F_{c}$ can be realized by a statespace realization if and only if its underlying formal power series $c$ has a finite Lie-rank (Fliess, 1981). Thus, Fliess operators provide more general descriptors of an inputoutput relation of the underlying system.

## 4. AFFINE FEEDBACK INTERCONNECTION OF CHEN-FLIESS SERIES

The goal of this section is to review and refurbish certain concepts of affine feedback in the context of Chen-Fliess series, as illustrated in Figure 1, and defined in the work of Gray \& Ebrahimi-Fard (2017). Prior going to details of how the closed-loop affine feedback product is defined, in the context of Chen-Fliess series, it is necessary to review the affine feedback group.

### 4.1 Affine Feedback Group

The affine feedback group is defined on a subset $G$ of two-dimensional vectors of formal power series, $\mathbb{R}\langle\langle X\rangle\rangle^{2}$, expressed in the basis $\left\{\mathrm{e}_{1}, \mathrm{e}_{2}\right\}$. The set $G \subset \mathbb{R}\langle\langle X\rangle\rangle^{2}$ is defined as

whence $G \cong M \times \mathbb{R}\langle\langle X\rangle\rangle$ as sets. The elements of $G$ are represented by bold-face font. Interchangeably, $\mathbf{c}=c_{1} \mathrm{e}_{1}+$ $c_{2} \mathrm{e}_{2} \in G$ is represented as vector $\left[\begin{array}{ll}c_{1} & c_{2}\end{array}\right]^{t}$, given the basis of $\mathbb{R}\langle\langle X\rangle\rangle^{2}$ is fixed ${ }^{1}$. The series $1 e_{1}+0 e_{2}$ in $G$ is denoted by $\mathbf{e}$.

If $\mathbf{c}=\left[\begin{array}{ll}c_{1} & c_{2}\end{array}\right]^{t} \in G$ then we define

The component of $\mathrm{e}_{1}$ is called multiplicative component (or channel) while the component of $\mathrm{e}_{2}$ is termed as additive component (or channel). The composition of two formal power series, o defined in Section 3 is extended, when its right argument is in the set $G$.
Definition 4.1. Let $\mathbf{d} \in G$, with $\mathbf{d}=\left[\begin{array}{ll}d_{1} & d_{2}\end{array}\right]^{t}$, and $c \in \mathbb{R}\langle\langle X\rangle\rangle$, then the composition product of $\mathbf{d}$ and $c$.

Remark: Given $\mathbf{d} \in G$ and $c \in \mathbb{R}\langle\langle X\rangle\rangle$, it is to be noted that the composition of Chen-Fliess series $\left(F_{\mathbf{d}} \circ F_{c}\right)[u] \neq$ $F_{\text {dōc }}[u]$. The $\bar{o}$ is merely extension of composition product, $\circ$, componentwise in $G$.
The composition of Chen-Fliess series $F_{c} \circ F_{\mathbf{d}}$ where $c \in$ $\mathbb{R}\langle\langle X\rangle\rangle$ and $\mathbf{d} \in G$ (illustrated in Figure 3), is given by the mixed composition product of $c$ and $\mathbf{d}$ giving a formal power series denoted by $c$ õd.
Definition 4.2. (Definition 3.1; (Gray \& Ebrahimi-Fard, 2017)) Let $c \in \mathbb{R}\langle\langle X\rangle\rangle$ and $\mathbf{d}=\left[\begin{array}{ll}d_{1} & d_{2}\end{array}\right]^{t} \in G$, then the mixed composition product $c \tilde{o} \mathbf{d} \in \mathbb{R}\langle\langle X\rangle\rangle$ is defined as

where the mixed composition product (restricted to dual words) is defined inductively as

The mixed composition product is linear in its left argument (by definition) and distributes over the shuffle product, formally stated in the following theorem

Theorem 4.1. (Lemma 3.3, (Gray \& Ebrahimi-Fard, 2017)) Let $c, d \in \mathbb{R}\langle\langle X\rangle\rangle$ and $\mathbf{z} \in G$, then

From (4), the following observations are evident and can be proved by induction on the length of words:
(i) $x_{0}^{k} \tilde{o} \mathbf{d}=x_{0}^{k}$ for all $k \geq 0$ and $\mathbf{d} \in G$.
(ii) If $\mathbf{d} \neq \mathbf{e}, n \geq 1$ and $\eta=x_{i_{1}} x_{i_{2}} \cdots x_{i_{n}}$ such that $\exists j \in\{1,2, \ldots, n\}$ with $x_{i_{j}}=x_{1}$, then $\eta \tilde{o} \mathbf{d} \neq \eta$.
(iii) If for some $\mathbf{d} \in G, c \tilde{o} \mathbf{d}=c$ for all $c \in \mathbb{R}\langle\langle X\rangle\rangle$, then $\mathbf{d}=\mathbf{e}$.
Thus, if $\mathbb{R}\langle\langle X\rangle\rangle_{q}:=\mathbb{R}\langle\langle X\rangle\rangle / \sim$, where the equivalence relation $\sim$ on $\mathbb{R}\langle\langle X\rangle\rangle$ is defined as:

Lemma 4.1. If $c \in \mathbb{R}\langle\langle X\rangle\rangle$, then its corresponding coset in $\mathbb{R}\langle\langle X\rangle\rangle_{q}$ is denoted by $[c]$. Let $\mathbf{d} \in G$, then define $[c] \tilde{o} \mathbf{d}=[c \tilde{o} \mathbf{d}]$. The following statements are true:
(1) If $h \in[c]$ then $[h o \tilde{d}]=[c$ õ d] (Mixed Composition product is well-defined on $\left.\mathbb{R}\langle\langle X\rangle\rangle_{q}\right)$.
(2) If $[c] \neq[0]$, then $[c] \tilde{o} \mathbf{d}=[c]$ if and only if $\mathbf{d}=\mathbf{e}$.

Lemma 4.1 states that if the Chen-Fliess series $F_{c}$ in Figure 3 is affected by the input $u$ (having a least one word containing $x_{1}$ in the support of $c$ ), then $y=F_{c} \tilde{d} \mathbf{d}=F_{c}[u]$ if and only if $F_{\mathbf{d}}[u]=u$.
The following theorem asserts a sort of mixed associativity of composition product $\circ$ and mixed composition product o.

Theorem 4.2. (Ebrahimi-Fard et al., 2023)Let $h, c \in$ $\mathbb{R}\langle\langle X\rangle\rangle$ and $\mathbf{d} \in G$, then $h \circ(c \tilde{\sim} \mathbf{d})=(h \circ c) \tilde{o} \mathbf{d}$.

The definition of mixed composition product, $\tilde{o}$, is extended as a set endomorphism of $G$ by applying the product componentwise. The extended product is denoted by $\triangleleft$ which is formally defined next.
Definition 4.3. Let $\mathbf{c}, \mathbf{d} \in G$ with $\mathbf{c}=\left[\begin{array}{ll}c_{1} & c_{2}\end{array}\right]^{t}$, then

For Definition 4.3 to be valid, one needs to prove that $\left(c_{1} \tilde{o} \mathbf{d}\right)(\mathbf{1})=1$ which is evident from (4). Both $\triangleleft$ and $\tilde{o}$ shall be addressed as mixed composition product in the document with no loss of clarity as the domain of both maps are not identical.
Remark: Given $\mathbf{c}, \mathbf{d} \in G$, it is to be noted that the composition of Chen-Fliess series $\left(F_{\mathbf{c}} \circ F_{\mathbf{d}}\right)[u] \neq F_{\mathbf{c} \triangleleft \mathbf{d}}[u]$. The $\triangleleft$ is merely extension of the mixed composition product, $\tilde{o}$, componentwise in $G$. The product on $G$ encoding the composition $\left(F_{\mathbf{c}} \circ F_{\mathbf{d}}\right)[u]$ is in definition 4.4.

The following theorem asserts the interplay between the extended composition product $\overline{\bar{o}}$ and modified composition products $\tilde{o}$ and $\triangleleft$.
Theorem 4.3. Let $\mathbf{d}, \mathbf{y} \in G$, with $\mathbf{d}=\left[\begin{array}{ll}d_{1} & d_{2}\end{array}\right]^{t}$, and $c \in \mathbb{R}\langle\langle X\rangle\rangle$, then

The set $G$ can be endowed with two different group structures that are vital in affine feedback interconnection, the first of which is explained next.
Theorem 4.4. (Ebrahimi-Fard et al., 2023) Let $\mathbf{c}, \mathbf{d} \in G$ with $\mathbf{c}=\left[\begin{array}{ll}c_{1} & c_{2}\end{array}\right]^{t}$ and $\mathbf{d}=\left[\begin{array}{ll}l_{1} & d_{2}\end{array}\right]^{t}$. Define a binary product $\odot$ on $G$ as ${ }^{2}$

then $(G, \odot)$ is a group with identity element being $\mathbf{e}:=$ $\left[\begin{array}{ll}1 & 0\end{array}\right]^{t}$. The group inverse for $\mathbf{c} \in G$ is defined as

The group $(G, \odot)$ is isomorphic to the semi-direct product of $M$ and the additive group of formal power series.

where the monomorphism $i(c)=1 e_{1}+c e_{2}$ for all $c \in$ $\mathbb{R}\langle\langle X\rangle\rangle$ and $\pi_{1}$ is the canonical projection onto the first component. Observe that the additive group $G_{+}=$ $(\delta+\mathbb{R}\langle\langle X\rangle\rangle, \diamond)$ defined in Section 2 is the embedding of $(\mathbb{R}\langle\langle X\rangle\rangle,+)$ in $G$.
Theorem 4.5. (Ebrahimi-Fard et al., 2023) Let $\mathbf{x}, \mathbf{y}, \mathbf{z}$ in $G$, then
(i) $(\mathbf{x} \odot \mathbf{y}) \triangleleft \mathbf{d}=(\mathbf{x} \triangleleft \mathbf{d}) \odot(\mathbf{y} \triangleleft \mathbf{d})$.
(ii) $\mathbf{e} \triangleleft \mathbf{d}=\mathbf{e}$,
where $\mathbf{e}$ is the identity element of $(G, \odot)$.
Theorem 4.5 infers that $\triangleleft$ respects the group structure $(G, \odot)$ in its left argument. Identical to $\triangleleft$, the extended composition product, $\bar{\sigma}$, respects the group structure in its left argument and is stated in the following theorem.
Theorem 4.6. Let $\mathbf{x}, \mathbf{y}$ be elements of the group $(G, \odot)$ and $c \in \mathbb{R}\langle\langle X\rangle\rangle$, then
(i) $(\mathbf{x} \odot \mathbf{y}) \bar{o} c=(\mathbf{x} \bar{\circ} 0 c) \odot(\mathbf{y} \bar{o} c)$,
(ii) $\mathbf{e} \bar{o} c=\mathbf{e}$,
where $\mathbf{e}$ is the identity element of the group $(G, \odot)$.
Proof: (ii) is a straightforward verification from definition 4.1. (i) Suppose $\mathbf{x}=x_{1} e_{1}+x_{2} e_{2}$ and $\mathbf{y}=y_{1} e_{1}+y_{2} e_{2}$, then using (5) and definition 4.1,

Remark: Theorem 4.5 and Theorem 4.6 infers that should a composition product on formal power series $\mathbb{R}\langle\langle X\rangle\rangle$ distribute over shuffle product on the left, then its component extension to set $G$ respects the group structure $(G, \odot)$ in the left argument.

The set $G$ possess another group structure, called affine feedback group and the group product is denoted by $\star$ whose definition as a binary product on the set $G$ is stated next. The definition for the product $\star$ stems $^{3}$ from encoding the composition of two Chen-Fliess series whose generating series are from the set $G$ viz. $\left(F_{\mathbf{c}} \circ F_{\mathbf{d}}\right)[u]=$ $F_{\mathbf{c} \star \mathrm{d}}[u]$.
Definition 4.4. Let $\mathbf{c}, \mathbf{d}$ in $G$, with $\mathbf{c} \star \mathbf{d}$, assuming $\mathbf{c}=$ $c_{1} e_{1}+c_{2} e_{2}$ and $\mathbf{d}=d_{1} e_{1}+d_{2} e_{2}$, then

Theorem 4.7. (Theorem 3.8; (Gray \& Ebrahimi-Fard, 2017)) The tuple $(G, \star, \mathbf{e})$ is a group where $\mathbf{e}:=\left[\begin{array}{ll}1 & 0\end{array}\right]^{t}$ is the identity element.

The group inverse of $\mathbf{c} \in(G, \star)$ is denoted by $\mathbf{c}^{\star-1}$. Given $\mathbf{c}, \mathbf{c}^{\star-1}$ can be computed by the antipode of Hopf algebra of coordinate maps on $\mathbb{R}\langle\langle X\rangle\rangle$ (Gray \& Ebrahimi-Fard, 2017; Foissy, 2018).
Theorem 4.8. (Theorem 3.9, (Gray \& Ebrahimi-Fard, 2017)) Let $c \in \mathbb{R}\langle\langle X\rangle\rangle$ and $\mathbf{x}, \mathbf{y} \in(G, \star)$, then
(i) $(c \tilde{\circ} \mathbf{x}) \tilde{\circ} \mathbf{y}=c \tilde{\circ}(\mathbf{x} \star \mathbf{y})$,
(ii) $c \tilde{o} \mathbf{e}=c$.

Theorem 4.8 asserts that $\tilde{o}$ is a right action on the set of formal power series $\mathbb{R}\langle\langle X\rangle\rangle$ by the affine feedback group $(G, \star)$. An important but evidently straightforward observation from Theorem 4.8 and Lemma 4.1 is the following theorem.
Theorem 4.9. The following statements are true:
(1) $\tilde{o}$ is an effective but not a free right group action of affine feedback group $(G, \star)$ on the set $\mathbb{R}\langle\langle X\rangle\rangle$.
(2) $\tilde{o}$ is a free right group action of feedback group $(G, \star)$ on the quotient set $\mathbb{R}\langle\langle X\rangle\rangle_{q} \backslash[0]$.

Following Theorem 4.8, Theorem 4.5 and definition 4.3, the following theorem is evident stating that mixed composition product,$\triangleleft$, is a right group action of affine feedback group $(G, \star)$ on the group $(G, \odot)$.

Theorem 4.10. (Ebrahimi-Fard et al., 2023) Let x in the set $G$ and $\mathbf{y}, \mathbf{z}$ in the group $(G, \star)$, then

where $\mathbf{e}$ is the identity element of the group $(G, \star)$.
Theorem 4.9 asserts that the group action $\triangleleft$ is effective but not free on $(G, \odot)$. A simple counterexample to the freeness of the group action is the following: Let $\mathbf{c}=[1+$ $\left.\begin{array}{ll}x_{0} & x_{0}\end{array}\right]^{t} \in(G, \odot)$. Then, $\mathbf{c} \triangleleft \mathbf{d}=\mathbf{c}$ for all $\mathbf{d} \in(G, \star)$. The stabilizer subgroup of $c$ being the whole of $(G, \star)$ implies that the right action $\triangleleft$ is not free.

Remark: An interesting question would be to find a/the (or prove the non-existence of) non-trivial normal subgroup $H$ of $(G, \odot)$ such that $\triangleleft$ acts freely on the quotient group $(G / H, \odot)$ by the group $(G, \star)$. However, the question is deferred for the future work.

To summarize this section, the set $G$ has the following interacting double group structure : $(G, \odot, \star, \triangleleft)$, where $(G, \odot)$ and $(G, \star)$ are groups for which $\mathbf{e}=1 e_{1}+0 e_{2}$ is the identity element for both the groups while $\triangleleft$ is a right action on the group $(G, \odot)$ by the group $(G, \star)$.
Remark: $(G, \odot, \triangleleft)$ actually forms a post-group with the affine feedback group $(G, \star)$ as its Grossman-Larson group. For more on this, refer the work of Ebrahimi-Fard et al. (2023).

### 4.2 Affine Feedback Interconnection

The affine feedback product describing the closed-loop of the affine feedback interconnection (as illustrated in Figure 4) is explained with the newer group structures endowed with interaction (called post-group) $(G, \odot, \triangleleft, \star)$. The affine feedback is shown to be a group action on plant and the structural non-commutativity between the additive and multiplicative feedback loops is proven and quantified.
Remark: The affine feedback product was first worked out in (Gray \& Ebrahimi-Fard, 2017). However the group action describing the closed-loop of the affine feedback and the structural non-commutativity of feedback loops are not evident from the cited work.

Theorem 4.11. Let $c \in \mathbb{R}\langle\langle X\rangle\rangle$ and $\mathbf{d}=d_{1} e_{1}+d_{2} e_{2} \in$ $(G, \odot, \triangleleft, \star)$. The affine feedback interconnection of the Chen-Fliess series $F_{c}$ with the Chen-Fliess series $F_{\mathbf{d}}$, as in Figure 4, is represented by a Chen-Fliess series $F_{c @ \mathbf{d}}$, where the affine feedback product $c @ \mathbf{d} \in \mathbb{R}\langle\langle X\rangle\rangle$ is defined as

The expression on the RHS is exactly the affine feedback product defined in (3.7) of (Gray \& Ebrahimi-Fard, 2017).

The notion that feedback can described mathematically as a transformation group acting on the plant is well established in control theory (Brockett, 1978). The following theorem asserts the group action in the context of affine feedback as illustrated in Figure 4.
Theorem 4.12. Let $c \in \mathbb{R}\langle\langle X\rangle\rangle$ and $\mathbf{x}, \mathbf{y} \in(G, \odot, \triangleleft, \star)$, then

where $e$ is the identity element of $(G, \odot, \triangleleft, \star)$. The affine feedback is thus a right action by the group $(G, \odot)$ on the set $\mathbb{R}\langle\langle X\rangle\rangle$.
Proof: Using Theorem 4.11,

The statement $c @ \mathbf{e}=c$ can be verified straightforward from the definition.
Thus, the affine feedback product is a right action by the group $(G, \odot)$ on the set of formal power series $\mathbb{R}\langle\langle X\rangle\rangle$.
Remark: Additive feedback is an affine feedback whose multiplicative component is 1 , while multiplicative feedback is an affine feedback whose additive component is 0 . Thus, by (8), additive feedback product is action on the plant by the additive group of formal power series $(\mathbb{R}\langle\langle X\rangle\rangle,+, 0)$ and respectively, the multiplicative feedback product is action on the plant by the shuffle group $(M, ш, 1 \emptyset)$. The assertions are in accordance with the literature (Gray et al., 2014a; Venkatesh, 2022; EbrahimiFard \& Venkatesh, 2023).

The additive and multiplicative feedback loops in the affine feedback configuration do not commute in general. This structural non-commutativity is illustrated via the Figure 5. Let $F_{\omega}[v]=y$, then the closed-loop generating series $\omega$ for the Figure 5 can be described as:

Hence, if the loops commuted, Figure 5 is equivalent to the following diagram.

Hence, $\omega=c @\left[1 d_{2} ш\left(1-d_{1}\right)\right]^{t}$ infers that the feedback loops do not negate each other completely, and there is a residual additive feedback loop (since multiplicative component is 1) amounting to $F_{c}$ being in additive feedback with the $F_{d_{2} \amalg\left(1-d_{1}\right)}$. Hence, the diagram 5 is equivalent to the Figure 6.

Theorem 4.13. The commutator subgroup $\left[\widehat{M, G_{+}}\right]_{\odot}$, defined as the group generated by the commutators $\left[M, G_{+}\right]_{\odot}$, is a normal subgroup of $G_{+}$.

Proof: (i) Let $\mathbf{x} \in M$ and $\mathbf{y} \in G_{+}$, then

$(G, \odot)$ isomorphic to the character group of the graded connected combinatorial Hopf algebra of coordinate functions as discussed in (Ebrahimi-Fard et al., 2023). $(G, \odot) \cong$ $M \ltimes(\mathbb{R}\langle\langle X\rangle\rangle,+)$ is thus a formal Lie group. The formal Lie algebra of $G$ is denoted by $(\mathfrak{g},[\cdot, \cdot])$. The Lie algebras of formal Lie subgroups $M$ and $G_{+}$are denoted $\mathfrak{g}_{w}$ and $\mathfrak{g}_{+}$respectively.
Observe that $g_{w}$ is isomorphic to the vector space of $\mathbb{R}_{p}\langle\langle X\rangle\rangle$. If for some $c \in \mathbb{R}\langle\langle X\rangle\rangle, \mathbf{e}+t c e_{1} \in M$ for $t \in \mathbb{R}$ implies

$$
t^{-1}\left(\left(\left(\mathbf{e}+t c e_{1}\right)-\mathbf{e}\right)(\mathbf{1})\right)=0 \Leftrightarrow c(\mathbf{1})=0 .
$$

Thus $c$ is a proper series. Similarly, $\mathfrak{g}_{+} \cong \mathbb{R}\langle\langle X\rangle\rangle$ as vector spaces. If for some $c \in \mathbb{R}\langle\langle X\rangle\rangle, 1 e_{1}+t c e_{2} \in\left(G_{+}, \diamond\right)$ for $t \in \mathbb{R}$ implies

$$
t^{-1}\left(\left(\mathbf{e}+t c e_{2}\right)-\mathbf{e}\right)=0 e_{1}+c e_{2}
$$

Therefore, $\mathfrak{g}_{+} \cong \mathbb{R}\langle\langle X\rangle\rangle$ as vector spaces.
The commutator in (13) is a map on the formal Lie groups given by:

$$
\begin{aligned}
{[\cdot, \cdot]_{\odot}: M \times G_{+} } & \longrightarrow G_{+} \\
\left(c e_{1}+0 e_{2}, 1 e_{1}+d e_{2}\right) & \mapsto 1 e_{1}+(d ш(1-c)) e_{2}
\end{aligned}
$$

where $c \in M$ and $d \in \mathbb{R}\langle\langle X\rangle\rangle$. Linearizing the group commutator map at $\mathbf{e}$, the identity of $(G, \odot)$, gives the Lie bracket between the Lie subalgebras $\mathfrak{g}_{ \pm}$and $\mathfrak{g}_{+}$. Let $d_{1} e_{1} \in \mathfrak{g}_{\mathrm{w}}$ and $d_{2} e_{2} \in \mathfrak{g}_{+}$, where $d_{1} \in \mathbb{R}_{p}\langle\langle X\rangle\rangle, d_{2} \in$ $\mathbb{R}\langle\langle X\rangle\rangle$. Then using (13),

$$
\begin{aligned}
& {\left[d_{1} e_{1}, d_{2} e_{2}\right]=\left(\left[\left(1+d_{1}\right) e_{1}, d_{2} e_{2}\right]_{\odot}-\left[1 e_{1}, 0 e_{2}\right]_{\odot}\right)} \\
& =\left[\begin{array}{cc}
1 & \\
d_{2} & \amalg \\
d_{1}
\end{array}\right]-\left[\begin{array}{l}
1 \\
0
\end{array}\right]=\left[\begin{array}{c}
0 \\
d_{1} \stackrel{\rightharpoonup}{~} d_{2}
\end{array}\right] .
\end{aligned}
$$

Therefore the formal Lie group $(G, \odot)$ has a formal Lie algebra $\mathfrak{g} \cong \mathbb{R}_{p}\langle\langle X\rangle\rangle \times \mathbb{R}\langle\langle X\rangle\rangle$ (as vector spaces), whose Lie bracket is defined as the following

$$
\begin{align*}
{\left[d_{1} e_{1}, d_{2} e_{2}\right]=-\left[d_{2} e_{2}, d_{1} e_{1}\right] } & =\left(d_{1} ш d_{2}\right) e_{2}  \tag{14}\\
{\left[d_{1} e_{1}, f_{1} e_{1}\right]=\left[d_{2} e_{2}, f_{2} e_{2}\right] } & =0,
\end{align*}
$$

where $d_{1}, f_{1} \in \mathbb{R}_{p}\langle\langle X\rangle\rangle$ and $d_{2}, f_{2} \in \mathbb{R}\langle\langle X\rangle\rangle$. Note that $\mathfrak{g}_{\omega}$ and $\mathfrak{g}_{+}$are Abelian Lie algebras (as the corresponding group products are commutative). Henceforth in (14),

$$
\left[d_{i} e_{i}, f_{i} e_{i}\right]=0 \quad \text { for } i=1,2 .
$$

Remark: The Lie algebra $(\mathfrak{g},[\cdot, \cdot])$ in (14) is the Lie algebra which is a part of definition of the post-Lie algebra that is obtained by linearizing the affine feedback post group ( $G, \odot, \triangleleft$ ), in Ebrahimi-Fard et al. (2023). The postLie algebra was however first observed from the Hopf algebra of coordinate functions corresponding to affine feedback (Foissy, 2018).
