# AN EFFECTIVE VERSION OF FEKETE'S THEOREM 

NORM LEVENBERG AND MAYURESH LONDHE


#### Abstract

A classical result of Fekete gives necessary conditions on a compact set in the complex plane so that it contains infinitely many sets of conjugate algebraic integers. We prove an effective version of Fekete's theorem in terms of a height function. As an application, we give a lower bound on the growth of the leading coefficient of certain polynomial sequences, generalizing a result by Schur. Lastly, we give an upper bound on minimal asymptotics of height over sequences of algebraic numbers.


## 1. Introduction

Let $\Sigma$ be a compact set in the complex plane $\mathbb{C}$. Fekete studied which compact sets $\Sigma$ contain only a finite number of sets of conjugate algebraic integers. This involves the notion of the transfinite diameter of $\Sigma$; it is given by

$$
d(\Sigma)=\lim _{n \rightarrow \infty}\left(\sup _{\xi_{1}, \ldots, \xi_{n} \in \Sigma} \prod_{i<j}\left|\xi_{i}-\xi_{j}\right|^{\frac{2}{n(n-1)}}\right)
$$

The transfinite diameter of a circle of radius $r$ is equal to $r$, and for a line segment of length $l$ it is equal to $l / 4$. It turns out that the quantity $d(\Sigma)$ coincides with the logarithmic capacity of $\Sigma$, denoted by $c(\Sigma)$; see Subsection 2.1 for the definition. The product $\prod_{i<j}\left|\xi_{i}-\xi_{j}\right|$ is related to the resultant of $P$ and its derivative $P^{\prime}$, where $P(z)=\prod_{j=1}^{n}\left(z-\xi_{j}\right)$; see (2.4). This motivates the use of potential-theoretic tools in studying sets of conjugate algebraic numbers. We now state a result by Fekete:

Result 1.1 (Fekete, Fek23). Let $\Sigma \subset \mathbb{C}$ be compact and symmetric about the real axis. If $c(\Sigma)<1$ then there exists a neighborhood $U$ of $\Sigma$ such that there are only a finite number of algebraic integers $\alpha$ so that $\alpha$ and all its conjugates lie in $U$.

The above result is not true if we replace algebraic integers by algebraic numbers in the statement, for example, if $\Sigma=\{|z|=1 / 2\}$ then all roots of $2^{n} z^{n}-1$ are in $\Sigma$. In [FS55], Fekete, together with Szegö showed that the converse of Result 1.1 is also true.

Our main results involve a notion of height $h_{\Sigma}(\alpha)$ of an algebraic number $\alpha$ relative to a compact set $\Sigma$ as defined in Rum99. Let $\overline{\mathbb{Q}}$ denote the set of algebraic numbers in $\mathbb{C}$. Given a nonzero $\alpha \in \overline{\mathbb{Q}}$, there is a polynomial $P_{\alpha}$ with integer coefficients and leading coefficient $b_{\alpha}$ and degree $\operatorname{deg} \alpha$ that is irreducible over the integers and satisfies $P_{\alpha}(\alpha)=0\left(P_{\alpha}\right.$ is unique up to the sign of $\left.b_{\alpha}\right)$. For an algebraic integer $\alpha, b_{\alpha}=1$ or -1 .

[^0]We denote by $\operatorname{Conj}(\alpha)$ the set of all conjugates of $\alpha$ which is same as the set of all roots of $P_{\alpha}$ in $\mathbb{C}$. Recall that the (absolute logarithmic) Weil height of $\alpha \in \overline{\mathbb{Q}}$ is given by

$$
h(\alpha)=\frac{1}{\operatorname{deg} \alpha}\left(\log \left|b_{\alpha}\right|+\sum_{x \in \operatorname{Conj}(\alpha)} \max \{0, \log |x|\}\right) .
$$

We refer the reader to BG06] for an introduction to the theory of heights. Note that $\log ^{+}|z|:=\max \{0, \log |z|\}$ is the Green's function of the unit circle centered at 0 with pole at $\infty$. For an arbitary compact set $\Sigma$ with positive capacity, the height of $\alpha \in \overline{\mathbb{Q}}$ with respect to $\Sigma$ is defined as

$$
\begin{equation*}
h_{\Sigma}(\alpha)=\frac{1}{\operatorname{deg} \alpha}\left(\log \left|b_{\alpha}\right|+\sum_{x \in \operatorname{Conj}(\alpha)} \mathrm{g}_{\Sigma}(x, \infty)\right), \tag{1.1}
\end{equation*}
$$

where $\mathrm{g}_{\Sigma}(z, \infty)$ denotes the Green's function of the set $\Sigma$ with pole at $\infty$. Loosely speaking, $h_{\Sigma}(\alpha)$ quantifies the distances of conjugates of $\alpha$ from $\Sigma$. See Section 2 for more details about the Green's function and height $h_{\Sigma}$. Also, see Rum99] and Pri11] for an application of this height to limit distributions of sets of conjugate algebraic numbers.

In the case $c(\Sigma) \geq 1$ and $\Sigma$ is symmetric about the real axis, it follows from the FeketeSzegö result in FS55] that there exists a sequence $\left\{\alpha_{n}\right\}$ in $\overline{\mathbb{Q}}$ satisfying $h_{\Sigma}\left(\alpha_{n}\right) \rightarrow 0$. When $0<c(\Sigma)<1$, we show a nonzero uniform lower bound on $\liminf _{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right)$.

Theorem 1.2. Let $\Sigma \subset \mathbb{C}$ be compact and symmetric about the real axis. Assume that $0<c(\Sigma)<1$. Then for every sequence $\left\{\alpha_{n}\right\}$ in $\overline{\mathbb{Q}}$ such that $\operatorname{deg} \alpha_{n} \rightarrow \infty$, we have

$$
\liminf _{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right) \geq \frac{1}{2} \log \frac{1}{c(\Sigma)}
$$

For any $\Sigma$ with positive capacity, $\mathrm{g}_{\Sigma}(z, \infty)-\log ^{+}|z|$ is bounded, thus there exist a constant $C$ such that $\left|h(\alpha)-h_{\Sigma}(\alpha)\right|<C$ for every $\alpha \in \overline{\mathbb{Q}}$. Therefore, the height $h_{\Sigma}$ also has the Northcott property: for every $M>0$ and $D>0$, the set $\{\alpha \in \overline{\mathbb{Q}}$ : $\left.h_{\Sigma}(\alpha) \leq M, \operatorname{deg} \alpha \leq D\right\}$ is a finite set. Theorem 1.2 and the Northcott property of $h_{\Sigma}$ immediately give us the following effective version of Result 1.1.

Corollary 1.3. Let $\Sigma \subset \mathbb{C}$ be compact and symmetric about the real axis. Assume that $0<c(\Sigma)<1$. Then for any $\epsilon>0$ there are only a finite number of algebraic numbers $\alpha$ such that

$$
h_{\Sigma}(\alpha) \leq \frac{1}{2} \log \frac{1}{c(\Sigma)}-\epsilon
$$

It follows from the properties of $\mathrm{g}_{\Sigma}(x, \infty)$ that if $\alpha$ is an algebraic integer all of whose conjugates are in a small neighborhood of $\Sigma$ then $h_{\Sigma}(\alpha)$ is also small.

We next give an application of Theorem 1.2 to the growth of the leading coefficient of certain polynomial sequences. Let $\mathbb{Z}[z]$ denote the set of polynomials with integer coefficients. Issai Schur showed that restricting the location of zeros of polynomials in $\mathbb{Z}[z]$ with simple zeros to $[-1,1]$ leads to geometric growth of the leading coefficients of these polynomials.

Result 1.4 (Schur Sch18, Satz VII). Let $\left\{Q_{n}\right\}$ be a sequence of polynomials in $\mathbb{Z}[z]$ with simple zeros such that $\operatorname{deg} Q_{n} \rightarrow \infty$ and all roots of $Q_{n}$ are in $[-1,1]$. Then

$$
\liminf _{n \rightarrow \infty}\left|\operatorname{lead}\left(Q_{n}\right)\right|^{1 / \operatorname{deg} Q_{n}} \geq \sqrt{2}
$$

where $\operatorname{lead}\left(Q_{n}\right)$ is the leading coefficient of $Q_{n}$.
For $k \in \mathbb{N}$, we denote by $\mathbb{Z}^{k}[z]$ the set of polynomials in $\mathbb{Z}[z]$ whose zeroes are repeated at most $k$ times. A version of Theorem [1.2, Theorem 3.5, is valid in a more general setting of a sequence of polynomials in $\mathbb{Z}^{k}[z]$, using the notion of Mahler measure of a polynomial in place of the height of an algebraic number (see Subsection 2.2). As an application, we get a lower bound on the growth of the leading coefficients of a sequence of polynomials in $\mathbb{Z}^{k}[z]$ whose roots are "near" $\Sigma$.

Corollary 1.5. Let $\Sigma$ be as in the statement of Theorem 1.2. Let $k \in \mathbb{N}$. Assume that $\left\{Q_{n}\right\}$ is a sequence of polynomials in $\mathbb{Z}^{k}[z]$ such that $\operatorname{deg} Q_{n} \rightarrow \infty$ and

$$
\frac{1}{\operatorname{deg} Q_{n}} \sum_{Q_{n}(x)=0} g_{\Sigma}(x, \infty) \rightarrow 0
$$

(e.g., if all roots of $\left\{Q_{n}\right\}$ eventually belong to any neighborhood of $\Sigma$ ). Then

$$
\liminf _{n \rightarrow \infty}\left|\operatorname{lead}\left(Q_{n}\right)\right|^{1 / \operatorname{deg} Q_{n}} \geq \frac{1}{\sqrt{c(\Sigma)}}
$$

For the interval $[-1,1]$ we have $c([-1,1])=1 / 2$; compare with Result 1.4. Pritsker (Proposition 1.7 in Pri05]) proved a similar bound with the assumption that the roots lie in the set and with an additional hypothesis of irreducibility.

Having given a lower bound on heights in Theorem 1.2, we now turn our attention to an upper bound. By Result 1.1, if $c(\Sigma)<1$, then there exists a neighborhood $U$ of $\Sigma$ such that there are only finitely many algebraic integers $\alpha$ with the property that $\alpha$ and all its conjugates lie in $U$. We then ask: can we find a sequence $\left\{\alpha_{n}\right\}$ of algebraic integers such that "most" conjugates of $\alpha_{n}$ are eventually near $\Sigma$ ? In general, this can be achieved if the heights $h_{\Sigma}\left(\alpha_{n}\right)$ go to $\infty$; we show that this can also be achieved while keeping the heights bounded.

Theorem 1.6. Let $\Sigma \subset \mathbb{C}$ be compact and symmetric about the real axis. If $0<c(\Sigma)<$ 1 , then for every neighborhood $U$ of $\Sigma$, there exists a sequence $\left\{\alpha_{n}\right\}$ of distinct algebraic integers such that

$$
\begin{equation*}
\frac{\sharp\left\{\operatorname{Conj}\left(\alpha_{n}\right) \cap U\right\}}{\operatorname{deg} \alpha_{n}} \longrightarrow 1 \quad \text { as } \quad n \longrightarrow \infty . \tag{1.2}
\end{equation*}
$$

Moreover, there exists a sequence $\left\{\alpha_{n}\right\}$ of distinct algebraic integers such that $\left\{\alpha_{n}\right\}$ satisfy (1.2) for any neighborhood $U$ of $\Sigma$ and $h_{\Sigma}\left(\alpha_{n}\right) \rightarrow-\log c(\Sigma)$ as $n \rightarrow \infty$.

Owing to Result 1.1, $\operatorname{deg} \alpha_{n} \rightarrow \infty$ in the above theorem. In fact, we can find a sequence $\left\{\alpha_{n}\right\}$ as in Theorem 1.6 such that the limiting distribution of the probability measures uniformly distributed on all conjugates of $\alpha_{n}$ of is given by the equilibrium measure of $\Sigma$ (see Subsection 2.1 for the definition; also see Remark 4.1). Theorem 1.6 together with

Theorem 1.2 immediately give us uniform bounds on minimal asymptotics of $\left\{h_{\Sigma}\left(\alpha_{n}\right)\right\}$ over sequences of algebraic numbers.

Corollary 1.7. Let $\Sigma$ be as in the statement of Theorem 1.2. Let $L$ denote the infimum of $\lim \inf _{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right)$ over all sequences of algebraic numbers. Then

$$
\frac{1}{2} \log \frac{1}{c(\Sigma)} \leq L \leq \log \frac{1}{c(\Sigma)}
$$

Outine of proofs: We briefly mention the idea of the proof of Theorem 1.2. Let $\left\{\alpha_{n}\right\}$ be a sequence in $\overline{\mathbb{Q}}$ for which $\left\{h_{\Sigma}\left(\alpha_{n}\right)\right\}$ is convergent. Let $\mu_{n}$ be the probability measure uniformly distributed on all conjugates of $\alpha_{n}$, i.e.,

$$
\mu_{n}:=\frac{1}{\operatorname{deg} \alpha_{n}} \sum_{x \in \operatorname{Conj}\left(\alpha_{n}\right)} \delta_{x} .
$$

It follows from Lemma 2.4 that the sequence $\left\{\mu_{n}\right\}$ has a convergent subsequence. Although a limiting measure $\mu$ need not be compactly supported, it turns out that such a $\mu$ has finite logarithmic energy $I(\mu)$ and satisfies $\int \log ^{+}|z| d \mu<\infty$. This allows us to use potential-theoretic methods. Refining the argument in Serre [Ser19], we further show that $\mu$ satisfies the following arithmetic property: for any $Q \in \mathbb{Z}[z]$, we have

$$
\frac{1}{\operatorname{deg} Q} \int \log |Q(z)| d \mu(z) \geq-\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}-\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right),
$$

where $b_{n}:=b_{\alpha_{n}}$ and $\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right)$ is the escape rate of the sequence $\alpha_{n}$ as defined in (3.1). We use this property to get a bound on the logarithmic energy $I(\mu)$ :

$$
I(\mu) \leq 2\left(\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}+\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right)\right)
$$

Finally, we use a convexity property of the logarithmic energy to conclude our result.
To prove Theorem 1.6, we construct a sequence of auxiliary sets $E_{n}$ so that $c\left(\Sigma \cup E_{n}\right)=$ 1. The set $E_{n}$ is chosen to be a subset of the level set $\mathrm{g}_{\Sigma}(z, \infty)=n$ and symmetric about the real axis. Let $\nu_{n}$ be the equilibrium measure of $\Sigma \cup E_{n}$. We solve a Dirichlet problem to determine how much mass $\nu_{n}$ puts on the set $E_{n}$. Using this information in the definition of height together with the Fekete-Szegö result in [FS55], we construct the appropriate sequences $\left\{\alpha_{n}\right\}$.

Remarks on $c(\Sigma) \geq 1$ case: As noted earlier, in [FS55], Fekete-Szegö showed the converse of Result [1.1, i.e., if $c(\Sigma) \geq 1$, then every neighborhood $U$ of $\Sigma$ contains infinitely many algebraic integers $\alpha$ so that $\alpha$ and all its conjugates lie in $U$. By shrinking $U$, we can get a sequence $\left\{\alpha_{n}\right\}$ of algebraic integers such that the sets of conjugates of $\alpha_{n}$ are eventually contained in any neighborhood of $\Sigma$. Bilu [Bil97] studied limit distributions of the measures $\mu_{n}$ associated to such sequences of algebraic integers, more generally, sequences $\left\{\alpha_{n}\right\}$ in $\overline{\mathbb{Q}}$ satisfying $h\left(\alpha_{n}\right) \rightarrow 0$, in the case of the unit circle centered at 0 . Using potential-theoretic methods, limit distributions of $\mu_{n}$ associated to sequences $\left\{\alpha_{n}\right\}$ in $\overline{\mathbb{Q}}$ satisfying $h_{\Sigma}\left(\alpha_{n}\right) \rightarrow 0$ have been studied for general sets $\Sigma$ of logarithmic capacity 1 by Rumely [Rum99] and Pritsker [Pri11]. For such sequences
$\left\{\alpha_{n}\right\}$ in $\overline{\mathbb{Q}}$, they showed the limiting distribution of $\mu_{n}$ is given by the equilibrium measure of $\Sigma$. Recently potential-theoretic methods have been employed when $c(\Sigma)>1$ in Smi21 to study limit distributions in connection with the Schur-Siegel-Smyth trace problem (see also OS23).

We include the necessary potential-theoretic background in the next section, including a non-standard result on logarithmic potentials of certain measures with unbounded support. Sections 3 and 4 give the proofs of Theorems 1.2 and 1.6 respectively. We conclude in Section 5 with some further questions.

## 2. Preliminaries

2.1. Potential theory. We work exclusively in the complex plane $\mathbb{C}$. The term measure will refer to a positive Borel measure in $\mathbb{C}$ unless otherwise stated. Given such a measure $\mu$, we can form its logarithmic potential function

$$
U_{\mu}(z)=\int \log \frac{1}{|z-w|} d \mu(w)
$$

provided this integral exists. In this case, if $\mu$ has compact support, then

$$
\begin{equation*}
U_{\mu}(z)=\mu(\mathbb{C})(-\log |z|+O(1)) \text { as } z \rightarrow \infty . \tag{2.1}
\end{equation*}
$$

This is a lower semicontinuous, superharmonic function on $\mathbb{C}$ which is harmonic off of the support of $\mu$. The logarithmic energy of $\mu$ is

$$
I(\mu):=\iint \log \frac{1}{|z-w|} d \mu(w) d \mu(z)
$$

this may be $+\infty$. If $\mu$ is a positive measure with unbounded support such that

$$
\int \log ^{+}|z| d \mu(z)<\infty
$$

then $U_{\mu}$ is still locally integrable and superharmonic, and $I(\mu)>-\infty$ (see [CKL98]).
Given a compact set $K \subset \mathbb{C}$, let $\mathcal{M}(K)$ denote the cone of probability measures supported in $K$. The logarithmic capacity of $K$ is

$$
c(K):=\exp [-\inf \{I(\mu): \mu \in \mathcal{M}(K)\}] ;
$$

this coincides with the transfinite diameter $d(K)$ in the introduction (see, for instance, Ahl10, Ch 2] or Ran95, Ch 5]). If $c(K)>0$, the Frostman conditions (cf., Ran95]) tell us that there is a unique measure $\mu_{K} \in \mathcal{M}(K)$ with $c(K)=\exp \left[-I\left(\mu_{K}\right)\right]$ and $U_{\mu_{K}}=I\left(\mu_{K}\right)$ quasi-everywhere (abbreviated as q.e.) on $K$; i.e., on all of $K$ except for a polar set. Here, $E \subset \mathbb{C}$ is polar if there exists a subharmonic function $u \not \equiv-\infty$ on a neighborhood of $E$ with $E \subset\{u=-\infty\}$; for $E$ compact this is equivalent to $c(E)=0$. If $E \subset \mathbb{C}$ is compact and polar, for any $K \subset \mathbb{C}$ compact we have $c(K \cup E)=c(K)$. The measure $\mu_{K}$ is called the equilibrium measure of $K$.

For non-polar compact $K$, we will have use of the Green's function

$$
\mathrm{g}_{K}(z, \infty):=-U_{\mu_{K}}(z)+I\left(\mu_{K}\right)
$$

for (the unbounded component of the complement of) $K$ with pole at $\infty$; note that $\mathrm{g}_{K}(z, \infty)=0$ q.e. on $K$. This is an upper semicontinuous function which is harmonic outside of $K$; from (2.1), it follows that $\mathrm{g}_{\Sigma}(z, \infty)-\log ^{+}|z|$ is bounded as stated in the introduction. If $U_{\mu_{K}}$ (equivalently, $\mathrm{g}_{K}$ ) is continuous, we say that $K$ is regular. This is the same as $U_{\mu_{K}}=I\left(\mu_{K}\right)\left(\mathrm{g}_{K}=0\right)$ on $K$ (cf. Ran95). The Green's function of the circle (or closed disk) of radius $r$ centered at $a$ is $\log ^{+}(|z-a| / r)$. For the real interval $K=[-1,1]$, we have

$$
\mathrm{g}_{K}(z, \infty)=\log \left|z+\sqrt{z^{2}-1}\right| .
$$

More generally, the Green's function of $K=[a, b] \subset \mathbb{R}$ is given by

$$
\mathrm{g}_{K}(z, \infty)=\log \left|f(z)+\sqrt{f(z)^{2}-1}\right|
$$

where $f(z)=\frac{2}{b-a} z-\frac{a+b}{b-a}$, and $c(K)=\frac{b-a}{4}$. If $K$ is the Julia set of a polynomial $P$ of degree $n \geq 2$ then its Green's function is

$$
\mathrm{g}_{K}(z, \infty)=\lim _{j \rightarrow \infty} \frac{1}{n^{j}} \log ^{+}\left|P^{j}(z)\right|
$$

where $P^{j}$ is the $j$-fold composition of $P$ with itself and $c(K)=|\operatorname{lead}(P)|^{-1 /(n-1)}$.
It is a standard fact from potential theory that the logarithmic energy of compactly supported measures satisfies a convexity property (see [Ahl10, Lemma 2.1] or [ST97, Lemma I.1.8]). It turns out that this property also holds for certain measures that are not necessarily compactly supported; later we will need to consider measures $\mu$ with unbounded support.

Result 2.1 (Theorem 2.5 of CKL98). Let $\tau$ be a signed measure with $\tau(\mathbb{C})=0$ that satisfies $\int \log ^{+}|z| d|\tau|<\infty$ and $I(|\tau|)<\infty$. Then the logarithmic energy $I(\tau)$ of $\tau$ is well-defined and $I(\tau) \geq 0$. In particular, if $\tau_{1}$ and $\tau_{2}$ are probability measures satisfying $\int \log ^{+}|z| d \tau_{i}<\infty$ and $I\left(\tau_{i}\right)<\infty$ for $i=1,2$, then, considering $\tau=\tau_{1}-\tau_{2}$,

$$
2 \int U_{\tau_{1}}(z) d \tau_{2}(z) \leq I\left(\tau_{1}\right)+I\left(\tau_{2}\right)
$$

In the case where we consider $\tau=\tau_{1}-\tau_{2}$, the inequality follows because

$$
I(\tau)=I\left(\tau_{1}\right)+I\left(\tau_{2}\right)-2 \int U_{\tau_{1}}(z) d \tau_{2}(z)
$$

2.2. Heights and Mahler measure. We recall the notion of height of $\alpha \in \overline{\mathbb{Q}}$ with respect to a non-polar compact set $\Sigma$ as defined in (1.1). Let $P_{\alpha} \in \mathbb{Z}[z]$ be an irreducible polynomial with leading coefficient $b_{\alpha}$ and degree $\operatorname{deg} \alpha$. Then

$$
h_{\Sigma}(\alpha):=\frac{1}{\operatorname{deg} \alpha}\left(\log \left|b_{\alpha}\right|+\sum_{x \in \operatorname{Conj}(\alpha)} \mathrm{g}_{\Sigma}(x, \infty)\right) .
$$

The Mahler measure of a polynomial $P_{n}(z)=a_{n} \prod_{j=1}^{n}\left(z-\alpha_{j}\right)$ of degree $n$ (thus $\left.a_{n} \neq 0\right)$ is

$$
M\left(P_{n}\right):=\exp \left[\frac{1}{2 \pi} \int_{0}^{2 \pi} \log \left|P_{n}\left(e^{i t}\right)\right| d t\right]=\left|a_{n}\right| \prod_{j=1}^{n} \max \left\{1,\left|\alpha_{j}\right|\right\}
$$

the latter equality following from Jensen's formula. Since the Green's function for the unit circle $\Sigma=\{|z|=1\}$ is $g_{\Sigma}(z, \infty)=\log ^{+}|z|:=\max \{0, \log |z|\}$, we have

$$
\frac{1}{n} \log M\left(P_{n}\right)=\frac{1}{n} \log \left|a_{n}\right|+\frac{1}{n} \sum_{j} \mathrm{~g}_{\Sigma}\left(\alpha_{j}, \infty\right)
$$

This coincides, in the case where $P_{n} \in \mathbb{Z}[z]$ is an irreducible polynomial with roots $\alpha_{1}, \ldots, \alpha_{n} \in \overline{\mathbb{Q}}$, to the Weil height $h\left(\alpha_{j}\right)$.

More generally, following Pritsker Pri11, we define the Mahler measure of a polynomial $P_{n}(z)=a_{n} \prod_{j=1}^{n}\left(z-\alpha_{j}\right)$ of degree $n$ with respect to any non-polar compact set $\Sigma$ as

$$
M_{\Sigma}\left(P_{n}\right):=\left|a_{n}\right| \exp \left[\sum_{j=1}^{n} \mathrm{~g}_{\Sigma}\left(\alpha_{j}, \infty\right)\right]
$$

so that, if $P_{n} \in \mathbb{Z}[z]$ is an irreducible polynomial with roots $\alpha_{1}, \ldots, \alpha_{n} \in \overline{\mathbb{Q}}$, we again have the relation

$$
\begin{equation*}
\frac{1}{n} \log M_{\Sigma}\left(P_{n}\right)=h_{\Sigma}\left(\alpha_{j}\right) . \tag{2.2}
\end{equation*}
$$

Observe that if $P=P_{1} P_{2} \cdots P_{n}$ with deg $P_{i}>0$ for every $1 \leq i \leq n$, then we have

$$
\begin{equation*}
M_{\Sigma}(P)^{\frac{1}{\operatorname{deg} P}}=\prod_{i=1}^{n}\left(M_{\Sigma}\left(P_{i}\right)^{\frac{1}{\operatorname{deg} P_{i}}}\right)^{\frac{\operatorname{deg} P_{i}}{\operatorname{deg} P}} \tag{2.3}
\end{equation*}
$$

where $\sum_{i=1}^{n} \frac{\operatorname{deg} P_{i}}{\operatorname{deg} P}=1$.
Using this generalized notion of Mahler measure, Pritsker proved the following:
Result 2.2 (Pritsker, Pri11). Let $P_{n}(z)=a_{n} \prod_{j=1}^{n}\left(z-\alpha_{j, n}\right)$ be a sequence of polynomials with integer coefficients and simple zeros. Let $\Sigma \subset \mathbb{C}$ be compact with $c(\Sigma)=1$. Then

$$
\lim _{n \rightarrow \infty}\left(M_{\Sigma}\left(P_{n}\right)\right)^{1 / n}=1
$$

if and only if
(1) $\lim _{n \rightarrow \infty}\left|a_{n}\right|^{1 / n}=1$;
(2) $\lim _{R \rightarrow \infty} \lim _{n \rightarrow \infty}\left(\prod_{\left|\alpha_{j, n}\right| \geq R}\left|\alpha_{j, n}\right|\right)^{1 / n}=1$; and
(3) $\mu_{n}:=\frac{1}{n} \sum_{j=1}^{n} \delta_{\alpha_{j, n}} \rightarrow \mu_{\Sigma}$ in the weak ${ }^{*}$ topology as $n \rightarrow \infty$.

As an immediate corollary, we have the following result, which will be used later on.
Lemma 2.3. Let $\Sigma \subset \mathbb{C}$ be compact and symmetric about the real axis. Suppose that $c(\Sigma)=1$. Let $\left\{\alpha_{n}\right\}$ be a sequence of distinct algebraic integers such that for every neighborhood $U$ of $\Sigma$ there exist $N \in \mathbb{N}$ such that $\operatorname{Conj}\left(\alpha_{n}\right) \subset U$ for all $n \geq N$. Then

$$
\mu_{n}:=\frac{1}{\operatorname{deg} \alpha_{n}} \sum_{x \in \operatorname{Conj}\left(\alpha_{n}\right)} \delta_{x} \longrightarrow \mu_{\Sigma} \quad \text { as } \quad n \longrightarrow \infty
$$

where $\mu_{\Sigma}$ is the equilibrium measure of $\Sigma$.

Next, we recall that the resultant of two polynomials

$$
\begin{aligned}
& \quad P(z)=a_{n} z^{n}+\cdots+a_{0}=a_{n} \prod_{j=1}^{n}\left(z-\alpha_{j}\right) \\
& \text { and } \quad Q(z)=b_{m} z^{m}+\cdots+b_{0}=b_{m} \prod_{k=1}^{m}\left(z-\beta_{k}\right)
\end{aligned}
$$

is given by

$$
\operatorname{Res}(P, Q):=a_{n} b_{m} \prod_{j=1, \ldots, n ; k=1, \ldots, m}\left(\alpha_{j}-\beta_{k}\right)
$$

For $P, Q \in \mathbb{Z}[z]$ it follows that $\operatorname{Res}(P, Q) \in \mathbb{Z}$ (cf., CLO92, page 153). Thus, if $P, Q \in \mathbb{Z}[z]$ do not have any factor in common then $|\operatorname{Res}(P, Q)| \geq 1$. The discriminant of $P$ is related to the resultant of $P$ and $P^{\prime}$ :

$$
\begin{equation*}
\operatorname{Disc}(P)=\frac{(-1)^{n(n-1) / 2}}{a_{n}} \cdot \operatorname{Res}\left(P, P^{\prime}\right)=(-1)^{n(n-1) / 2} a_{n}^{2 n-2} \prod_{j \neq k}\left(\alpha_{j}-\alpha_{k}\right) \tag{2.4}
\end{equation*}
$$

The reader will notice the resemblance to the quantity $\prod_{i<j}\left|\xi_{i}-\xi_{j}\right|^{\frac{2}{n(n-1)}}$ in the definition of transfinite diameter from the introduction.

Finally, recall that a sequence of measures $\left\{\mu_{\beta}\right\}_{\beta \in B}$ on $\mathbb{C}$ is tight if for any $\epsilon>0$ there exists a compact set $K_{\epsilon}$ such that $\mu_{\beta}\left(\mathbb{C} \backslash K_{\epsilon}\right)<\epsilon$ for all $\beta \in B$. If $\left\{\mu_{\beta}\right\}_{\beta \in B}$ is tight and uniformly bounded in the total variation norm, Prokhorov's theorem implies that it has a convergent subsequence. We will need the following application.
Lemma 2.4. Let $\left\{\alpha_{n}\right\}$ be a sequence in $\overline{\mathbb{Q}}$ such that corresponding sequence of heights $\left\{h_{\Sigma}\left(\alpha_{n}\right)\right\}$ is bounded. If

$$
\mu_{n}:=\frac{1}{\operatorname{deg} \alpha_{n}} \sum_{x \in \operatorname{Conj}\left(\alpha_{n}\right)} \delta_{x}
$$

is the probability measure uniformly distributed on all conjugates of $\alpha_{n}$, then the sequence $\left\{\mu_{n}\right\}$ has a convergent subsequence in the weak* topology.

Proof. We shall show that the sequence $\left\{\mu_{n}\right\}$ is tight. Then the result follows from Prokhorov's theorem. Assume that the sequence $\left\{\mu_{n}\right\}$ is not tight. By definition, there exists $\rho>0$ such that for every compact set $K \subset \mathbb{C}$, we have $\mu_{n}(\mathbb{C} \backslash K)>\rho$ for some $n \in \mathbb{N}$. Since $\mathrm{g}_{\Sigma}(z, \infty) \rightarrow \infty$ as $z \rightarrow \infty$, by enlarging $K$, we get an $\alpha \in \overline{\mathbb{Q}}$ from the sequence $\left\{\alpha_{n}\right\}$ for which $h_{\Sigma}(\alpha)$ is arbitrarily large. This contradicts the assumption that $\left\{h_{\Sigma}\left(\alpha_{n}\right)\right\}$ is bounded. Thus the sequence $\left\{\mu_{n}\right\}$ is tight, and there exists a convergent subsequence of $\left\{\mu_{n}\right\}$.

## 3. Proof of Theorem 1.2

Let $\Sigma \subset \mathbb{C}$ be compact and symmetric about the real axis with $0<c(\Sigma)<1$. Given a sequence $\left\{\alpha_{n}\right\}$ in $\overline{\mathbb{Q}}$, for simplicity of notation, we let $b_{n}:=b_{\alpha_{n}}$ and $P_{n}:=P_{\alpha_{n}}$. We want a lower bound on $\liminf _{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right)$ when $\operatorname{deg} \alpha_{n} \rightarrow \infty$. If $\lim \inf _{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right)<\infty$, then
there exists a subsequence $\left\{\alpha_{n_{k}}\right\}$ for which $\left\{h_{\Sigma}\left(\alpha_{n_{k}}\right)\right\}$ and $\left\{\log \left|b_{n_{k}}\right| / \operatorname{deg} \alpha_{n_{k}}\right\}$ are both convergent. Thus, without loss of generality, we make the following assumptions:
(a) $\operatorname{deg} \alpha_{n} \rightarrow \infty$;
(b) the sequence of heights $\left\{h_{\Sigma}\left(\alpha_{n}\right)\right\}$ is convergent; and
(c) the sequence $\left\{\log \left|b_{n}\right| / \operatorname{deg} \alpha_{n}\right\}$ is convergent.

As in Lemma 2.4, we let

$$
\mu_{n}:=\frac{1}{\operatorname{deg} \alpha_{n}} \sum_{x \in \operatorname{Conj}\left(\alpha_{n}\right)} \delta_{x} .
$$

This lemma ensures that there exists a convergent subsequence of $\left\{\mu_{n}\right\}$. In general, the limiting measure $\mu$ of the subsequence need not be compactly supported. However, in the next result, we shall see that the limiting measure satisfies an interesting property that allows us to use potential-theoretic tools.
Result 3.1 (Theorem 2.1 of Pri15). Let $\left\{\alpha_{n}\right\}$ be a sequence in $\overline{\mathbb{Q}}$ satisfying (a) $(c)$. Let $\left\{\mu_{n}\right\}$ be as above. Assume that $\mu_{n}$ converges to a probability measure $\mu$ in the weak* topology. Then, $\mu$ has finite logarithmic energy $I(\mu)$. Furthermore, we have that

$$
\int \log ^{+}|z| d \mu(z)<\infty
$$

This result has been stated in Pri15 under the assumption that $h\left(\alpha_{n}\right)$ is bounded, where $h$ denotes the standard Weil height. However, as noted in the introduction, there exist a constant $C=C(\Sigma)$ such that $\left|h(\alpha)-h_{\Sigma}(\alpha)\right|<C$ for every $\alpha \in \overline{\mathbb{Q}}$. Thus the result holds with our assumptions as well.

By Result 3.1, if $\left\{\mu_{n}\right\}$ converges to a probability measure $\mu$, then the logarithmic energy of $\mu$ is finite. We shall now find a bound on its energy. We make a definition at this stage. Recall the notation: $\mathrm{g}_{\Sigma}(z, \infty)$ denotes the Green's function of $\Sigma$ with pole at $\infty$.

Definition 3.2. Let $\left\{\beta_{n}\right\}$ be a sequence in $\overline{\mathbb{Q}}$. The escape rate of the sequence $\left\{\beta_{n}\right\}$ with respect to $\Sigma$ is defined as

$$
\begin{equation*}
\mathcal{E}\left(\Sigma ;\left\{\beta_{n}\right\}\right)=\lim _{r \rightarrow \infty}\left(\liminf _{n \rightarrow \infty} \frac{1}{\operatorname{deg} \beta_{n}} \sum_{\substack{x \in \operatorname{Conj}\left(\beta_{n}\right) \\|x| \geq r}} \mathrm{~g}_{\Sigma}(x, \infty)\right) . \tag{3.1}
\end{equation*}
$$

Note that if $\left\{h_{\Sigma}\left(\beta_{n}\right)\right\}$ is bounded, the escape rate $\mathcal{E}\left(\Sigma ;\left\{\beta_{n}\right\}\right)$ is a finite positive number. We now show that the measures that give the limiting distribution of the conjugates of a sequence in $\overline{\mathbb{Q}}$ satisfy an interesting arithmetic property. In the case of a sequence of algebraic integers with bounded conjugates lying near a compact, symmetric set $\Sigma$ with $c(\Sigma) \geq 1$, the arithmetic property characterizes such measures (see Section 5: also see [Smi21, OS23]).
Lemma 3.3. Let $\left\{\alpha_{n}\right\}$ be a sequence in $\overline{\mathbb{Q}}$ satisfying (a) (c), If $\left\{\mu_{n}\right\}$ converges to a probability measure $\mu$ in the weak* topology, then for any polynomial $Q \in \mathbb{Z}[z]$, we have

$$
\frac{1}{\operatorname{deg} Q} \int \log |Q(z)| d \mu(z) \geq-\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}-\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right),
$$

where $\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right)$ is the escape rate of the sequence $\left\{\alpha_{n}\right\}$ as defined in (3.1).
Proof. Fix a polynomial $Q \in \mathbb{Z}[z]$. Let $\phi$ be a non-negative compactly supported continuous function. Since $\phi(z) \log |Q(z)|$ is an upper semicontinuous function that is bounded from above, we have

$$
\begin{align*}
\frac{1}{\operatorname{deg} Q} \int \log |Q(z)| d \mu(z) \geq & \limsup _{n \rightarrow \infty} \frac{1}{\operatorname{deg} Q} \int \phi(z) \log |Q(z)| d \mu_{n}(z) \\
\geq & \liminf _{n \rightarrow \infty} \frac{1}{\operatorname{deg} Q} \int \log |Q(z)| d \mu_{n}(z) \\
& -\liminf _{n \rightarrow \infty} \frac{1}{\operatorname{deg} Q} \int(1-\phi(z)) \log |Q(z)| d \mu_{n}(z) . \tag{3.2}
\end{align*}
$$

For the last inequality, we use the fact that $\lim \sup _{n \rightarrow \infty}\left(k_{n}+l_{n}\right) \geq \lim _{\inf }^{n \rightarrow \infty}{ }_{n}+$ $\lim \sup _{n \rightarrow \infty} l_{n}$. Note that, owing to Result 3.1, $\int \log |Q(z)| d \mu(z)$ makes sense.

Since $P_{n}$ and $Q$ do not have roots in common for large $n$, we have $\left|\operatorname{Res}\left(Q, P_{n}\right)\right| \geq 1$. Thus we get

$$
\begin{equation*}
\frac{1}{\operatorname{deg} Q} \int \log |Q(z)| d \mu_{n}(z)=\frac{\log \left|\operatorname{Res}\left(Q, P_{n}\right)\right|-\log \left|b_{n}^{\operatorname{deg} Q}\right|}{\operatorname{deg} Q \cdot \operatorname{deg} P_{n}} \geq-\frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}} \tag{3.3}
\end{equation*}
$$

Observe that, as $z \rightarrow \infty, \mathrm{~g}_{\Sigma}(z, \infty)=\log |z|+O(1)$ and $(1 / \operatorname{deg} Q) \log |Q(z)|=\log |z|+$ $O(1)$. We denote the disk of radius $r$ centered at the origin by $\mathbb{D}(0 ; r)$ and its complement by $\mathbb{D}(0 ; r)^{c}$. For every $\delta>0$ there exists $r \gg 1$ such that $\mu\left(\mathbb{D}(0 ; r)^{c}\right)<\delta$ and $\mu_{n}\left(\mathbb{D}(0 ; r)^{c}\right)<\delta$ for sufficiently large $n$. Thus if $0 \leq \phi \leq 1$ with $\phi \equiv 1$ on $\mathbb{D}(0 ; r)$ for sufficiently large $r$, we get

$$
\begin{align*}
\liminf _{n \rightarrow \infty} \frac{1}{\operatorname{deg} Q} \int & (1-\phi(z)) \log |Q(z)| d \mu_{n}(z) \\
& \leq \liminf _{n \rightarrow \infty} \frac{1}{\operatorname{deg} \alpha_{n}} \sum_{\substack{x \in \operatorname{Conj}\left(\alpha_{n}\right) \\
|x| \geq r}} \mathrm{~g}_{\Sigma}(x, \infty)+\delta \cdot O(1) \tag{3.4}
\end{align*}
$$

Since the choice of $\phi$ in (3.2) is arbitrary, by using (3.3) and (3.4) in (3.2), it follows that

$$
\frac{1}{\operatorname{deg} Q} \int \log |Q(z)| d \mu(z) \geq-\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}-\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right)
$$

We now use the above lemma to get an upper bound on $I(\mu)$. Here we continue with the same notation as above.

Proposition 3.4. Let $\left\{\alpha_{n}\right\}$ be a sequence in $\overline{\mathbb{Q}}$ satisfying (a) (c). If $\left\{\mu_{n}\right\}$ converges to a probability measure $\mu$ in the weak* topology, then

$$
I(\mu) \leq 2\left(\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}+\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right)\right)
$$

where $\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right)$ is the escape rate of the sequence $\left\{\alpha_{n}\right\}$ as defined in (3.1).

Proof. Let $\phi$ be a cut-off function as in Lemma 3.3 so that $0 \leq \phi \leq 1$ with $\phi \equiv 1$ on $\mathbb{D}(0 ; r)$ for sufficiently large $r>0$. Since $I(\mu)<\infty$ from Result 3.1, given $\delta>0$, we can choose $r \gg 1$ large so that $\int \phi(z) U_{\mu}(z) d \mu(z)>I(\mu)-\delta$; in addition, as in the previous lemma, for such $r$ we may assume $\mu\left(\mathbb{D}(0 ; r)^{c}\right)<\delta$ and $\mu_{n}\left(\mathbb{D}(0 ; r)^{c}\right)<\delta$. Then since $\phi(z) U_{\mu}(z)$ is a lower semicontinuous function that is bounded from below, we have

$$
\begin{align*}
I(\mu)-\delta<\int \phi(z) U_{\mu}(z) d \mu(z) \leq & \liminf _{n \rightarrow \infty} \int \phi(z) U_{\mu}(z) d \mu_{n}(z) \\
\leq & \limsup _{n \rightarrow \infty} \int U_{\mu}(z) d \mu_{n}(z) \\
& -\liminf _{n \rightarrow \infty} \int(1-\phi(z)) U_{\mu}(z) d \mu_{n}(z) . \tag{3.5}
\end{align*}
$$

For the last inequality, we use the fact that $\liminf _{n \rightarrow \infty}\left(k_{n}+l_{n}\right) \leq \limsup \sup _{n \rightarrow \infty} k_{n}+$ $\lim \sup _{n \rightarrow \infty} l_{n}$. By Fubini's theorem, we see that

$$
\int U_{\mu}(z) d \mu_{n}(z)=\int U_{\mu_{n}}(z) d \mu(z)=-\frac{1}{\operatorname{deg} P_{n}} \int \log \left|P_{n}(z)\right| d \mu(z)+\frac{\log \left|b_{n}\right|}{\operatorname{deg} P_{n}}
$$

Since Lemma 3.3 holds for an arbitrary polynomial $Q$ with integer coefficients, in particular it holds for the polynomials $P_{n}$. Therefore, fixing $Q=P_{n}$, for all $m$ sufficiently large, $P_{n}$ and $P_{m}$ have no common factors and we get

$$
\begin{equation*}
\limsup _{n \rightarrow \infty} \int U_{\mu}(z) d \mu_{n}(z) \leq \lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}+\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right)+\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} P_{n}} \tag{3.6}
\end{equation*}
$$

Now as $z \rightarrow \infty$,

$$
\begin{aligned}
U_{\mu}(z) & =\int_{\mathbb{D}(0 ; r)} \log \frac{1}{|z-w|} d \mu(w)+\int_{\mathbb{D}(0 ; r)^{c}} \log \frac{1}{|z-w|} d \mu(w) \\
& \geq(1-\delta)(-\log |z|+O(1))+\int_{\mathbb{D}(0 ; r)^{c}} \log \frac{1}{|z-w|} d \mu(w) .
\end{aligned}
$$

For any $M>0$ and $|z|>r$,

$$
\int_{\mathbb{D}(0 ; r)^{c}} \log \frac{1}{|z-w|} d \mu(w) \geq \int_{\mathbb{D}(0 ; r)^{c}} \min \left\{M, \log \frac{1}{|z-w|}\right\} d \mu(w)
$$

which is finite; hence, as $z \rightarrow \infty$,

$$
U_{\mu}(z) \geq-\log |z|+O(1)=-\mathrm{g}_{\Sigma}(z, \infty)+O(1)
$$

Therefore, it follows that

$$
\begin{equation*}
\liminf _{n \rightarrow \infty} \int(1-\phi(z)) U_{\mu}(z) d \mu_{n}(z) \geq-\liminf _{n \rightarrow \infty} \frac{1}{\operatorname{deg} \alpha_{n}} \sum_{\substack{x \in \operatorname{Conj}\left(\alpha_{n}\right) \\|x| \geq r}} g_{\Sigma}(x, \infty)+\delta \cdot O(1) \tag{3.7}
\end{equation*}
$$

Since $\delta>0$ is arbitrary, using (3.6) and (3.7) in (3.5), it follows that

$$
I(\mu) \leq 2\left(\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}+\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right)\right)
$$

We are now ready for
The proof of Theorem 1.2. We shall first prove the result when $\Sigma$ is regular (see Section (2). Let $\left\{\alpha_{n}\right\}$ be a sequence in $\overline{\mathbb{Q}}$ satisfying (a) $(c)$. Observe that the result follows if we show that $\lim _{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right) \geq-(1 / 2) \log c(\Sigma)$. With this notation, we have

$$
h_{\Sigma}\left(\alpha_{n}\right)=\frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}+\frac{1}{\operatorname{deg} \alpha_{n}} \sum_{x \in \operatorname{Conj}\left(\alpha_{n}\right)} g_{\Sigma}(x, \infty) .
$$

Recall $\mu_{n}$ is the probability measure uniformly distributed on all conjugates of $\alpha_{n}$. By Lemma [2.4, there exists a convergent subsequence of $\left\{\mu_{n}\right\}$. We simply denote this subsequence by $\left\{\alpha_{n}\right\}$ and the corresponding sequence of measures by $\left\{\mu_{n}\right\}$. Let $\mu$ be the weak* limit of $\left\{\mu_{n}\right\}$. Note that $\mu$ need not be compactly supported.

Let $\mu_{\Sigma}$ denote the equllibrium measure of $\Sigma$. We have $U_{\mu_{\Sigma}}(z)=-\mathrm{g}_{\Sigma}(z, \infty)-\log c(\Sigma)$ for $z \in \mathbb{C}$. Thus we get

$$
\begin{aligned}
h_{\Sigma}\left(\alpha_{n}\right) & =\frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}+\frac{1}{\operatorname{deg} \alpha_{n}} \sum_{x \in \operatorname{Conj}\left(\alpha_{n}\right)}\left(\log \frac{1}{c(\Sigma)}-U_{\mu_{\Sigma}}(x)\right) \\
& =\log \frac{1}{c(\Sigma)}+\frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}-\int U_{\mu_{\Sigma}}(z) d \mu_{n}(z) .
\end{aligned}
$$

Since $\left\{h_{\Sigma}\left(\alpha_{n}\right)\right\}$ and $\left\{\log \left|b_{n}\right| / \operatorname{deg} \alpha_{n}\right\}$ are both convergent, we get

$$
\begin{equation*}
\lim _{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right)=\log \frac{1}{c(\Sigma)}+\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}-\lim _{n \rightarrow \infty} \int U_{\mu_{\Sigma}}(z) d \mu_{n}(z) \tag{3.8}
\end{equation*}
$$

The last limit exists because all other limits in (3.8) exist. We now estimate the last limit in (3.8). By our assumption that $\Sigma$ is regular, $U_{\mu_{\Sigma}}$ is a continuous function. Let $\phi$ be a non-negative compactly supported continuous function. Thus $\phi(z) U_{\mu_{\Sigma}}(z)$ is bounded and continuous, and we get

$$
\begin{align*}
\int \phi(z) U_{\mu_{\Sigma}} d \mu(z) & =\lim _{n \rightarrow \infty} \int \phi(z) U_{\mu_{\Sigma}}(z) d \mu_{n}(z) \\
& =\lim _{n \rightarrow \infty} \int U_{\mu_{\Sigma}}(z) d \mu_{n}(z)-\lim _{n \rightarrow \infty} \int(1-\phi(z)) U_{\mu_{\Sigma}}(z) d \mu_{n}(z) \tag{3.9}
\end{align*}
$$

Fix $\delta>0$. Since $U_{\mu_{\Sigma}}(z)=-\log |z|+O(1)$ as $z \rightarrow \infty$, by Result 3.1, there exists $r>0$ such that if $\phi$ is a cut-off function as in Lemma 3.3 so that $0 \leq \phi \leq 1$ with $\phi \equiv 1$ on $\mathbb{D}(0 ; r)$ for sufficiently large $r$, then

$$
\begin{equation*}
\int \phi(z) U_{\mu_{\Sigma}}(z) d \mu(z) \leq(1+\delta) \int U_{\mu_{\Sigma}}(z) d \mu(z) \tag{3.10}
\end{equation*}
$$

As in the proof of Lemma 3.3, increasing $r$ if necessary, we have $\mu\left(\mathbb{D}(0 ; r)^{c}\right)<\delta$ and $\mu_{n}\left(\mathbb{D}(0 ; r)^{c}\right)<\delta$ for sufficiently large $n$. Since $U_{\mu_{\Sigma}}(z)=-\mathrm{g}_{\Sigma}(z, \infty)-\log c(\Sigma)$, for large
$r$, as in (3.7), we also have

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \int(1-\phi(z)) U_{\mu_{\Sigma}}(z) d \mu_{n}(z) \leq-\liminf _{n \rightarrow \infty} \frac{1}{\operatorname{deg} \alpha_{n}} \sum_{\substack{x \in \operatorname{Conj}\left(\alpha_{n}\right) \\|x| \geq r}} \mathrm{~g}_{\Sigma}(x, \infty)+\delta \cdot O(1) \tag{3.11}
\end{equation*}
$$

Since $\delta>0$ is arbitrary, (3.10) and (3.11) together with (3.9) give us

$$
\lim _{n \rightarrow \infty} \int U_{\mu_{\Sigma}}(z) d \mu_{n}(z) \leq \int U_{\mu_{\Sigma}}(z) d \mu(z)-\lim _{r \rightarrow \infty}\left(\liminf _{n \rightarrow \infty} \frac{1}{\operatorname{deg} \alpha_{n}} \sum_{\substack{x \in \operatorname{Conj}\left(\alpha_{n}\right) \\|x| \geq r}} g_{\Sigma}(x, \infty)\right)
$$

The limit on the right hand side of the last expression is the escape rate $\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right)$ of the sequence $\left\{\alpha_{n}\right\}$ as in Proposition 3.4. By invoking Result 2.1 and Proposition 3.4, it follows that

$$
\begin{aligned}
\lim _{n \rightarrow \infty} \int U_{\mu_{\Sigma}}(z) d \mu_{n}(z) & \leq \frac{I\left(\mu_{\Sigma}\right)+I(\mu)}{2}-\mathcal{E}\left(\Sigma ;\left\{\alpha_{n}\right\}\right) \\
& \leq \frac{1}{2} \log \frac{1}{c(\Sigma)}+\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}
\end{aligned}
$$

Using this in (3.8), we get

$$
\lim _{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right) \geq \log \frac{1}{c(\Sigma)}+\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}}-\frac{1}{2} \log \frac{1}{c(\Sigma)}-\lim _{n \rightarrow \infty} \frac{\log \left|b_{n}\right|}{\operatorname{deg} \alpha_{n}} \geq \frac{1}{2} \log \frac{1}{c(\Sigma)} .
$$

Since the sequence $\left\{\alpha_{n}\right\}$ is arbitrary, the result follows when $\Sigma$ is regular.
If $\Sigma$ is not regular, we consider a sequence $\left\{\Sigma_{m}\right\}$ of regular compact sets symmetric about the real axis such that $\Sigma_{m+1} \subset \Sigma_{m}$ for every $m \in \mathbb{N}$ and $\Sigma=\cap_{m} \Sigma_{m}$. For example, we can take $\Sigma_{m}=\{z \in \mathbb{C}: \operatorname{dist}(z, \Sigma) \leq 1 / m\}$. Note that $c\left(\Sigma_{m}\right) \downarrow c(\Sigma)$. Also, note that $\mathrm{g}_{\Sigma_{m}}(z, \infty) \leq \mathrm{g}_{\Sigma}(z, \infty)$ for every $m \in \mathbb{N}$ and $z \in \mathbb{C}$. Therefore, for any $\alpha \in \overline{\mathbb{Q}}$, we have $h_{\Sigma_{m}}(\alpha) \leq h_{\Sigma}(\alpha)$ for every $m \in \mathbb{N}$. Let $\left\{\alpha_{n}\right\}$ be a sequence in $\overline{\mathbb{Q}}$ such that $\operatorname{deg} \alpha_{n} \rightarrow \infty$. Since the sets $\Sigma_{m}$ are regular, it follows that $\lim _{\inf }^{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right) \geq$ $\liminf \operatorname{inc\infty } h_{\Sigma_{m}}\left(\alpha_{n}\right) \geq-(1 / 2) \log c\left(\Sigma_{m}\right)$ for every $m \in \mathbb{N}$. Thus

$$
\liminf _{n \rightarrow \infty} h_{\Sigma}\left(\alpha_{n}\right) \geq \frac{1}{2} \log \frac{1}{c(\Sigma)}
$$

We now prove a result alluded to in Section 1. Recall the definition of the Mahler measure of a polynomial from Subsection 2.2 and the relation (2.3). We shall use these in the proof of our next result. Recall that $\mathbb{Z}^{k}[z]$ denotes the set of polynomials in $\mathbb{Z}[z]$ whose zeroes are repeated at most $k$ times.

Theorem 3.5. Let $\Sigma$ be as in the statement of Theorem 1.2. Let $k \in \mathbb{N}$. Let $\left\{Q_{n}\right\}$ be a sequence of polynomials in $\mathbb{Z}^{k}[z]$ such that $\operatorname{deg} Q_{n} \rightarrow \infty$. Then we have

$$
\liminf _{n \rightarrow \infty} \frac{1}{\operatorname{deg} Q_{n}} \log M_{\Sigma}\left(Q_{n}\right) \geq \frac{1}{2} \log \frac{1}{c(\Sigma)}
$$

Proof. Fix $\epsilon>0$. As observed in Section 1, Theorem 1.2 and the Northcott property of $h_{\Sigma}$ imply that there are only finitely many $\alpha \in \overline{\mathbb{Q}}$ such that $h_{\Sigma}(\alpha) \leq-(1 / 2) \log c(\Sigma)-\epsilon$. Thus there are only finitely many irreducible polynomials $P \in \mathbb{Z}[z]$ satisfying

$$
\frac{1}{\operatorname{deg} P} \log M_{\Sigma}(P) \leq \frac{1}{2} \log \frac{1}{c(\Sigma)}-\epsilon
$$

Let $\mathcal{P}$ denote the set of such polynomials.
Let $\left\{Q_{n}\right\}$ be a sequence of polynomials in $\mathbb{Z}^{k}[z]$ such that $\operatorname{deg} Q_{n} \rightarrow \infty$. Write, for every $n, Q_{n}=Q_{n}^{1} Q_{n}^{2}$, where $Q_{n}^{1}$ is the product of factors of $Q_{n}$ that are also in $\mathcal{P}$ and $Q_{n}^{2}$ is the product of the remaining factors of $Q_{n}$. Thus, from (2.3),

$$
\begin{equation*}
\frac{1}{\operatorname{deg} Q_{n}} \log M_{\Sigma}\left(Q_{n}\right)=\frac{\operatorname{deg} Q_{n}^{1}}{\operatorname{deg} Q_{n}}\left(\frac{\log M_{\Sigma}\left(Q_{n}^{1}\right)}{\operatorname{deg} Q_{n}^{1}}\right)+\frac{\operatorname{deg} Q_{n}^{2}}{\operatorname{deg} Q_{n}}\left(\frac{\log M_{\Sigma}\left(Q_{n}^{2}\right)}{\operatorname{deg} Q_{n}^{2}}\right) \tag{3.12}
\end{equation*}
$$

Similar to (3.12), $\log M_{\Sigma}\left(Q_{n}^{1}\right) / \operatorname{deg} Q_{n}^{1}$ can be further written as a convex combination using its irreducible sub-factors. Since these sub-factors are from the set $\mathcal{P}$, we have

$$
\frac{\log M_{\Sigma}\left(Q_{n}^{1}\right)}{\operatorname{deg} Q_{n}^{1}} \leq \frac{1}{2} \log \frac{1}{c(\Sigma)}-\epsilon
$$

Also, $\log M_{\Sigma}\left(Q_{n}^{2}\right) / \operatorname{deg} Q_{n}^{2}$ can be further written as a convex combination using its irreducible sub-factors. Therefore,

$$
\frac{\log M_{\Sigma}\left(Q_{n}^{2}\right)}{\operatorname{deg} Q_{n}^{2}}>\frac{1}{2} \log \frac{1}{c(\Sigma)}-\epsilon
$$

Since the zeroes of each $Q_{n}$ are repeated at most $k$ times, $\left\{\operatorname{deg} Q_{n}^{1}\right\}$ is bounded. Therefore, by (3.12), there exists $N \in \mathbb{N}$ such that for every $n \geq N$, we have

$$
\frac{1}{\operatorname{deg} Q_{n}} \log M_{\Sigma}\left(Q_{n}\right)>\frac{1}{2} \log \frac{1}{c(\Sigma)}-\epsilon-\frac{\epsilon}{2} .
$$

Since $\epsilon>0$ is arbitrary, the result follows.
Corollary 1.5 follows from Theorem 3.5(if $\Sigma$ is not regular, for the case when all roots of $\left\{Q_{n}\right\}$ eventually belong to any neighborhood of $\Sigma$, we use an argument as in the last part of the proof of Theorem (1.2).

## 4. Proof of Theorem 1.6

In this section, we prove Theorem 1.6. As in the last section, we assume that $\Sigma \subset \mathbb{C}$ is compact and symmetric about the real axis with $0<c(\Sigma)<1$. Since $\Sigma$ is symmetric about the real axis, $\mathrm{g}_{\Sigma}(z, \infty)=\mathrm{g}_{\Sigma}(\bar{z}, \infty)$; thus level sets of $\mathrm{g}_{\Sigma}(z, \infty)$ are also symmetric about the real axis. For $n \in \mathbb{N}$, define

$$
L_{n}:=\left\{z \in \mathbb{C}: \mathrm{g}_{\Sigma}(z, \infty)=n\right\}
$$

We choose a compact subset $E_{n}$ of $L_{n}$ that is symmetric about the real axis and satisfies $c\left(\Sigma \cup E_{n}\right)=1$. For sufficiently large $n$, such a set always exists. To see this, we start with a compact subset $E$ of $L_{n}$ that is invariant under complex conjugation and which satisfies $c(\Sigma \cup E)>1$. For example, if we choose $E$ with $c(E)>1$ then $c(\Sigma \cup E)>1$.

Since capacity is a monotone function, by considering a decreasing family of subsets of $L_{n}$, we eventually get a compact subset $E_{n}$ of $L_{n}$ that satisfies $c\left(\Sigma \cup E_{n}\right)=1$. Since $c(\Sigma)<1$, the set $E_{n}$ is non-polar.

We recall the Fekete-Szegö result in FS55 discussed in the introduction, i.e., if $c(K) \geq 1$ and $K$ is symmetric about the real axis, then every neighborhood $U$ of $K$ contains infinitely many algebraic integers $\alpha$ so that $\alpha$ and all its conjugates lie in $U$. Let $\nu_{n}$ be the equilibrium measure of $\Sigma \cup E_{n}$. Since $c\left(\Sigma \cup E_{n}\right)=1$, we can get a sequence $\left\{\alpha_{n, j}\right\}$ of algebraic integers such that $\operatorname{Conj}\left(\alpha_{n, j}\right)$ eventually belongs to any neighborhood of $\Sigma \cup E_{n}$. By Lemma 2.3,

$$
\begin{equation*}
\mu_{n, j}:=\frac{1}{\operatorname{deg} \alpha_{n, j}} \sum_{x \in \operatorname{Conj}\left(\alpha_{n, j}\right)} \delta_{x} \longrightarrow \nu_{n} \quad \text { as } \quad j \longrightarrow \infty \tag{4.1}
\end{equation*}
$$

Fix a neighborhood $U$ of $\Sigma$. We want to determine what fraction of $\operatorname{Conj}\left(\alpha_{n, j}\right)$ is in $U$ for sufficiently large $j$; thus we want to determine the value of $\nu_{n}(\Sigma)$. To do this, we solve a Dirichlet problem on the domain $D_{n}$ in the Riemann sphere $\widehat{\mathbb{C}}$, where $D_{n}$ is the component of $\widehat{\mathbb{C}} \backslash\left(\Sigma \cup E_{n}\right)$ containing $\infty$.

Let $\phi$ be the function on the boundary $\partial D_{n}$ of $D_{n}$ such that $\phi \equiv 0$ on the exterior boundary of $\Sigma$ and $\phi \equiv 1$ on the exterior boundary of $E_{n}$. Since $\phi$ is continous on $\partial D_{n}$, there exists a unique bounded harmonic function $f$ on $D_{n}$ such that $\lim _{z \rightarrow \xi} f(z)=\phi(\xi)$ for q.e. $\xi \in \partial D_{n}$. Then, by definition, $f(\infty)=\nu_{n}\left(E_{n}\right)$. We show

$$
f(z)=\frac{\mathrm{g}_{\Sigma}(z, \infty)-\mathrm{g}_{\Sigma \cup E_{n}}(z, \infty)}{n}
$$

Observe that, since $g_{\Sigma}(z, \infty) \equiv n$ on $E_{n}, \lim _{z \rightarrow \xi} f(z)=\phi(\xi)$ for q.e. $\xi \in \partial D_{n}$. The function $f$ is harmonic and bounded on $D_{n}$ with

$$
\begin{aligned}
f(\infty) & =\lim _{z \rightarrow \infty} \frac{\mathrm{~g}_{\Sigma}(z, \infty)-\mathrm{g}_{\Sigma \cup E_{n}}(z, \infty)}{n} \\
& =-\frac{1}{n} \log c(\Sigma)
\end{aligned}
$$

Thus the function $f$ defined above solves the Dirichlet problem for $\phi$. Therefore, we have $\nu_{n}(\Sigma)=1+\frac{1}{n} \log c(\Sigma)$.

Now, owing to the above observations, there exist $j^{\prime} \in \mathbb{N}$ such that $\alpha_{n, j^{\prime}}=: \alpha_{n}$ satisfies

$$
\begin{equation*}
\frac{\sharp\left\{\operatorname{Conj}\left(\alpha_{n}\right) \cap U\right\}}{\operatorname{deg} \alpha_{n}} \geq 1+\frac{1}{n} \log c(\Sigma)-\frac{1}{n} . \tag{4.2}
\end{equation*}
$$

Note that, since $c(\Sigma)>0$, the right hand side of (4.2) converges to 1 as $n \rightarrow \infty$. Since $n$ is arbitrary, we get a sequence $\left\{\alpha_{n}\right\}$ of algebraic integers that satisfy (1.2).

We shall now construct a sequence $\left\{\alpha_{n}\right\}$ of distinct algebraic integers that satisfy (1.2) for any neighborhood $U$ of $\Sigma$ and $h_{\Sigma}\left(\alpha_{n}\right) \rightarrow-\log c(\Sigma)$ as $n \rightarrow \infty$. Let $\left\{\alpha_{n, j}\right\}$ be a sequence of algebraic integers as above. There exists $J \in \mathbb{N}$ such that for all $j \geq J$, we get $\mathrm{g}_{\Sigma}(z, \infty) \geq n-\frac{1}{n^{2}}$ for at least $\operatorname{deg} \alpha_{n, j} \cdot\left(\nu_{n}\left(E_{n}\right)-\frac{1}{n^{2}}\right)$ many $z \in \operatorname{Conj}\left(\alpha_{n, j}\right)$.

Therefore, for all $j \geq J$, we get

$$
\begin{equation*}
h_{\Sigma}\left(\alpha_{n, j}\right) \geq\left(n-\frac{1}{n^{2}}\right)\left(-\frac{1}{n} \log c(\Sigma)-\frac{1}{n^{2}}\right) \tag{4.3}
\end{equation*}
$$

Let $r>0$ be such that $\operatorname{Conj}\left(\alpha_{n, j}\right) \subset \mathbb{D}(0 ; r)$ for all $j$. Since $\mathrm{g}_{\Sigma}(z, \infty)$ is an upper semicontinuous function, by (4.1), we get

$$
\begin{equation*}
\limsup _{j \rightarrow \infty} h_{\Sigma}\left(\alpha_{n, j}\right)=\limsup _{j \rightarrow \infty} \int_{\{|z| \leq r\}} g_{\Sigma}(z, \infty) d \mu_{n, j}(z) \leq \int_{\{|z| \leq r\}} g_{\Sigma}(z, \infty) d \nu_{n}(z) \tag{4.4}
\end{equation*}
$$

Using the definition of $\mathrm{g}_{\Sigma}(z, \infty)$ and the fact that $U_{\nu_{n}}(z)=0$ q.e. on $\Sigma \cup E_{n}$, we get

$$
\begin{align*}
\int \mathrm{g}_{\Sigma}(z, \infty) d \nu_{n}(z)=\int\left(U_{\mu_{\Sigma}}(z)-\log c(\Sigma)\right) d \nu_{n}(z) & =-\log c(\Sigma)+\int U_{\nu_{n}}(z) d \mu_{\Sigma}(z) \\
& =-\log c(\Sigma) \tag{4.5}
\end{align*}
$$

By (4.3), (4.4) and (4.5), there exist $j^{\prime} \in \mathbb{N}$ such that $\alpha_{n, j^{\prime}}$ satisfies

$$
\left|h_{\Sigma}\left(\alpha_{n, j^{\prime}}\right)+\log c(\Sigma)\right|<\frac{1}{n}
$$

and

$$
\frac{\sharp\left\{\operatorname{Conj}\left(\alpha_{n, j^{\prime}}\right) \cap U_{n}\right\}}{\operatorname{deg} \alpha_{n, j^{\prime}}} \geq 1+\frac{1}{n} \log c(\Sigma)-\frac{1}{n},
$$

where $U_{n}:=\left\{z \in \mathbb{C}: \operatorname{dist}(x, z)<\frac{1}{n}\right.$ for some $\left.x \in \Sigma\right\}$. Since $n$ is arbitrary, we get a sequence $\left\{\alpha_{n}:=\alpha_{n, j^{\prime}}\right\}$ of algebraic integers that satisfy the required properties. This finishes the proof of Theorem 1.6.

Remark 4.1. We can show that the sequence of measures $\left\{\nu_{n}\right\}$ constructed above converge in the weak* topology to the equilibrium measure $\mu_{\Sigma}$ (and hence so does the appropriate subsequence of the measures $\left\{\mu_{n, j}\right\}$ ). First, by construction, $\left\{\nu_{n}\right\}$ is tight and uniformly bounded in the total variation norm, so by Lemma 2.4 there exists a weak* convergent subsequence which we continue to denote by $\left\{\nu_{n}\right\}$. Let $\mu$ be its weak* limit. Writing $\nu_{n}:=\gamma_{n}+\zeta_{n}$ where $\gamma_{n}:=\left.\nu_{n}\right|_{\Sigma}$ and $\zeta_{n}:=\left.\nu_{n}\right|_{E_{n}}$, we have $\gamma_{n}(\Sigma)=1+\frac{1}{n} \log c(\Sigma) \rightarrow 1$ so that $\mu$ is the weak* limit of $\left\{\gamma_{n}\right\}$ and $\mu$ is a probability measure supported in $\Sigma$. Since the logarithmic potential $U_{\mu}$ is lower semicontinuous, we have

$$
\liminf _{n \rightarrow \infty} U_{\gamma_{n}}\left(z_{n}\right) \geq U_{\mu}(z) \quad \text { for } z \in \mathbb{C}
$$

where $z_{n} \rightarrow z$ (cf., Theorem I.6.8 of [ST97]). We will show that $U_{\mu}(z) \leq-\log c(\Sigma)$ for q.e. $z \in \Sigma$. For then $I(\mu) \leq-\log c(\Sigma)=I\left(\mu_{\Sigma}\right)$ and the result follows.

To this end, since $\nu_{n}$ is the equilibrium measure of a set of logarithmic capacity equal to 1 , we have

$$
U_{\nu_{n}}(z)=U_{\gamma_{n}}(z)+U_{\zeta_{n}}(z)=0 \quad \text { for q.e. } z \in \Sigma \cup E_{n} .
$$

In particular, the above holds for q.e. $z \in \Sigma$. Thus

$$
-\limsup _{n \rightarrow \infty} U_{\zeta_{n}}(z) \geq U_{\mu}(z) \quad \text { for q.e. } z \in \Sigma \text {. }
$$

Now for $z \in \Sigma$, since $E_{n} \rightarrow \infty$ and $\zeta_{n}\left(E_{n}\right) \rightarrow 0$,

$$
\begin{aligned}
\limsup _{n \rightarrow \infty} U_{\zeta_{n}}(z)=\limsup _{n \rightarrow \infty} \int_{E_{n}} \log \frac{1}{|z-w|} d \zeta_{n}(w) & =\limsup _{n \rightarrow \infty} \int_{E_{n}} \log \frac{1}{|w|} d \zeta_{n}(w) \\
& =\limsup _{n \rightarrow \infty}\left(-\int_{E_{n}} g_{\Sigma}(w, \infty) d \zeta_{n}(w)\right)
\end{aligned}
$$

Since $\mathrm{g}_{\Sigma}(w, \infty) \equiv n$ on $E_{n}$, we get

$$
\int_{E_{n}} \mathrm{~g}_{\Sigma}(w, \infty) d \zeta_{n}(w)=n \zeta_{n}\left(E_{n}\right)=n\left(-\frac{1}{n} \log c(\Sigma)\right)=-\log c(\Sigma)
$$

Therefore, we have

$$
U_{\mu}(z) \leq-\limsup _{n \rightarrow \infty} U_{\zeta_{n}}(z)=-\log c(\Sigma) \quad \text { for q.e. } z \in \Sigma
$$

## 5. Further discussion

There remain several relevant questions related to Theorems 1.2 and 1.6 .
(1) Can the lower bound $-(1 / 2) \log c(\Sigma)$ in Theorem 1.2 be improved?
(2) Does there exist a sequence of distinct algebraic integers $\left\{\alpha_{n}\right\}$ such that 1.2 holds for every neighborhood $U$ of $\Sigma$ and $h_{\Sigma}\left(\alpha_{n}\right) \rightarrow L<-\log c(\Sigma)$ as $n \rightarrow \infty$ ?
(3) Let $\left\{\alpha_{n}\right\}$ be a sequence of distinct algebraic integers such that $\left\{\alpha_{n}\right\}$ satisfy (1.2) for any neighborhood $U$ of $\Sigma$ and $h_{\Sigma}\left(\alpha_{n}\right) \rightarrow-\log c(\Sigma)$ as $n \rightarrow \infty$. Does the corresponding sequence of probability measures $\left\{\mu_{n}\right\}$ converge to the equilibrium measure $\mu_{\Sigma}$ ? If not, what other measures $\mu$ can be realized in this fashion?
Note that, in the case where $\Sigma$ is a compact set symmetric about the real axis with $c(\Sigma) \geq 1$, Orloski and Sardari [OS23] have recently characterized the so-called arithmetic probability measures on $\Sigma$, i.e., probability measures $\mu$ on $\Sigma$ which are weak* limits of measures $\left\{\mu_{n}\right\}$ coming from $\left\{\alpha_{n}\right\}$ where all all conjugates of $\alpha_{n}$ eventually lie inside any fixed neighborhood of $\Sigma$. In our setting when $c(\Sigma)<1$, necessarily in the second question above we consider the less restrictive hypothesis (1.2).
