# On the effect of a large cloud of rigid particles on the motion of an incompressible non-Newtonian fluid

#### Abstract

We show that the collective effect of $N$ rigid bodies $\left(\mathcal{S}_{n, N}\right)_{n=1}^{N}$ of diameters $\left(r_{n, N}\right)_{n=1}^{N}$ immersed in an incompressible non-Newtonian fluid is negligible in the asymptotic limit $N \rightarrow \infty$ as long as their total packing volume $\sum_{n=1}^{N} r_{n, N}^{d}, d=2,3$ tends to zero exponentially $-\sum_{n=1}^{N} r_{n, N}^{d} \approx A^{-N}$ - for a certain constant $A>1$. The result is rather surprising and in a sharp contrast with the associated homogenization problem, where the same number of obstacles can completely stop the fluid motion in the case of shear thickening viscosity. A large class of non-Newtonian fluids is included, for which the viscous stress is a subdifferential of a convex potential.


Keywords: Non-Newtonian fluid, fluid-structure interaction problem, small rigid body

## 1 Introduction

We consider the motion of $N$ rigid bodies $\left(\mathcal{S}_{n, N}\right)_{n=1}^{N}$ of diameters $\left(r_{n, N}\right)_{n=1}^{N}$,

immersed in a non-Newtonian fluid confined to a bounded spatial domain $\Omega \subset \mathbb{R}^{d}, d=2,3$. By nonNewtonian we mean that the viscous stress $\mathbb{S}$ is determined as a subdifferential of a convex function $F$ depending on the symmetric velocity gradient

\mathbb{D}_{x} \mathbf{u}=\frac{1}{2}\left(\nabla_{x} \mathbf{u}+\nabla_{x}^{t} \mathbf{u}\right) .
$$

Specifically, we consider the viscous stress $\mathbb{S}$ satisfying

\mathbb{S} \in \partial F\left(\mathbb{D}_{x} \mathbf{u}\right), \quad \text { where } \mathbb{D}_{x} \mathbf{u}=\frac{1}{2}\left(\nabla_{x} \mathbf{u}+\nabla_{x}^{t} \mathbf{u}\right), F: R_{\mathrm{sym}}^{d \times d} \rightarrow[0, \infty) \text { convex. }
$$

In addition, we assume the fluid is incompressible, specifically the fluid velocity $\mathbf{u}=\mathbf{u}(t, x)$ is solenoidal,

\end{equation*}

We focus on the case of a super-quadratic growth of $F$, where the associated capacity of the family of rigid bodies is strictly positive. We show that the presence of rigid bodies has no influence on the fluid motion in the asymptotic limit $N \rightarrow \infty$ as soon as

for a certain constant $A>1$, see Theorem 2.1 below. The result shows a substantial difference between the fluid-structure interaction problem, where the rigid objects share the same velocity with the adjacent fluid, and the homogenization limit, where the fluid velocity is fixed to be zero on static obstacles.

For the sake of simplicity, we consider the potential $F$ in the form to fit the $L^{p}$-framework. Generalizations to a larger class of potentials satisfying the so-called $\Delta_{2}^{2}$ condition are possible.

### 1.1 Fluid structure interaction problem

The bodies are represented by connected compact sets $\left(\mathcal{S}_{n, N}\right)_{n=1}^{N}$. For the sake of simplicity we suppose the mass density of each body is a positive constant $\rho_{n, N}>0, n=1, \ldots, N$. Accordingly, without loss of generality, we fix the barycentres of $\mathcal{S}_{n, N}$ to be located at the origin,

The positions of $\mathcal{S}_{n, N}(t)$ at the time $t \geqslant 0$ are determined by a family of affine isometries

\left(\sigma_{n, N}(t)\right)_{t \geqslant 0}, \sigma_{n, N}(t) \mathbf{x}=\mathbf{h}_{n, N}(t)+\mathbb{O}_{n, N}(t) \cdot \mathbf{x}, \mathbb{O}_{n, N}(t) \in S O(d)
$$

\mathcal{S}_{n, N}(t)=\sigma_{n, N}(t)\left[\mathcal{S}_{n, N}\right], n=1, \ldots, N, t \geqslant 0
$$

with the associated rigid velocities

$$
\mathbf{w}_{n, N}(t, x)=\mathbf{Y}_{n, N}(t)+\mathbb{Q}_{n, N}(t)\left(x-\mathbf{h}_{n, N}(t)\right), \mathbf{Y}_{n, N}=\frac{\mathrm{d}}{\mathrm{~d} t} \mathbf{h}_{n, N}(t), \mathbb{Q}_{n, N}(t)=\left[\frac{\mathrm{d}}{\mathrm{~d} t} \mathbb{O}_{n, N}(t)\right] \circ \mathbb{O}_{n, N}^{-1}(t)

The time evolution of the fluid velocity is determined by the linear momentum balance

$$

where $\rho_{f}>0$ is the fluid density, $\Pi$ the pressure, and $\mathbf{g}$ a given external driving force. We consider a general form of the viscous stress $\mathbb{S}$,

where $F$ is a convex potential defined on the space $R_{\text {sym }}^{d \times d}$ of symmetric tensors. More specifically, we suppose

where $\underline{F}, \bar{F}$ are positive constants. The class of potentials is large enough to accommodate the scale of models ranging from the standard Navier-Stokes fluid with $F=\mu|\mathbb{D}|^{2}$ to the power-law fluids $F(\mathbb{D})=$ $\left(\alpha|\mathbb{D}|^{2}+\beta|\mathbb{D}|^{p}\right), \beta>0$, referred to as shear-thickening if $p>2$. Moreover, the potential $F$ need not be differentiable at $\mathbb{D}=0$, which is characteristic for Bingham fluids

and other types of "implicitly" constituted fluids discussed by Málek and Rajagopal [27, [28].
The standard fluid structure interaction problem requires continuity of the velocities and stresses on the fluid-body interface. Keeping in mind the mass densities $\rho_{n, N}$ are constant, we introduce the mass of the bodies,

The inertial tensor is given by

Here, the symbol $\mathbf{a} \wedge \mathbf{b}$ denotes the standard cross product of vectors $\mathbf{a}, \mathbf{b} \in \mathbb{R}^{3}$, while

The continuity of the velocity field, or the no-slip boundary conditions read

where the angular velocities $\boldsymbol{\omega}_{n, N}$ are defined through the identity

Finally, we suppose the whole system occupies a bounded regular domain $\Omega \subset \mathbb{R}^{d}, d=2,3$, and impose the no-slip conditions

### 1.2 Asymptotic limit

We consider global-in-time solutions to the fluid-structure interaction problem specified in Section 1.1 in the asymptotic limit of a large number of rigid bodies $N \rightarrow \infty$ and vanishing total packing volume

$$
\operatorname{vol}\left[\cup_{n=1}^{N} \mathcal{S}_{n, N}\right] \lesssim \sum_{n=1}^{N} r_{n, N}^{d} \equiv \operatorname{vol}[N] \rightarrow 0 \text { as } N \rightarrow \infty
$$

We adapt the elegant framework of weak solutions introduced by Judakov [22], see also Gunzburger, Lee, and Seregin [18]. The existence of global-in-time solutions in Judakov's class was proved in [12] for Newtonian fluids and $d=3$, by San Martin, Starovoitov, and Tucsnak [29] for Newtonian fluids and $d=2$, and in [13] for a particular case of a non-Newtonian fluid corresponding to $F(\mathbb{D})=\left(\alpha|\mathbb{D}|^{2}+\beta|\mathbb{D}|^{p}\right)$, $\beta>0, p \geqslant 4, d=3$. Besides, there is a large number of existence results "up to the first contact". In
the case of an increasing number of rigid bodies, however, the time of the first contact may be short and even approach zero in the asymptotic limit unless $p$ is large enough, see e.g. Starovoitov [30, 31.

Intuitively, one might expect that the presence of a "small" moving object wouldn't significantly alter the fluid motion. Indeed, there are several results available concerning the motion of a single rigid body in viscous Newtonian fluids. Dashti and Robinson [9] consider a system involving a viscous fluid interacting with a non-rotating rigid disc, demonstrating that the presence of the disc has no impact on the flow in the asymptotic regime. Iftimie et al. [21] investigated the flow around a small rigid obstacle, while Lacave [23] examined the limit of a viscous fluid's flow around the exterior of a thin obstacle that contracts to a curve. Further results have been obtained by Lacave and Takahashi [24], He and Iftimie [19, 20], and Chipot et al. [8]. More recently, Bravin and Nečasová [5] demonstrated that when the density is very high, the rigid object continues to move at its initial velocity, unaffected by the surrounding fluid.

In [15], we have shown that a large family of rigid bodies has no impact on the motion of a viscous Newtonian fluid as long as their number and the diameter are properly related. Our goal is to extend this result to the non-Newtonian case. In particular, we consider the situation

where $p$ is the exponent in (1.5). The result is quite surprising in particular for $p>d$. Indeed, for $p>d$, the velocity field $\mathbf{u}$ is continuous and the total $p$ - capacity of any (even finite) number of points is positive. In the limit case $p=d$, we show the same result still allowing positive $p$-capacity of the total ensemble of rigid bodies. It is worth noting that for $d=p=2$, the Newtonian case considered already in [15] is included. Here, we improve the result of [15] by showing strong convergence of the velocity gradients.

The key ingredient of our approach is the time dependent restriction operator constructed in [15], well adapted to the fluid-structure interaction problems including collisions of several rigid bodies. The new difficulty compared to the linear Newtonian case is the non-linear dependence of the stress tensor on $\mathbb{D}_{x} \mathbf{u}$. This problem is overcome replacing the dissipation term $\mathbb{S}: \mathbb{D}_{x} \mathbf{u}$ in the energy inequality by the expression

where $F^{*}$ is the convex conjugate. The strong convergence of $\mathbb{D}_{x} \mathbf{u}$ in the asymptotic limit is then obtained by the methods of convex analysis.

The paper is organized as follows. In Section 2, we introduce the weak formulation, formulate the main hypotheses, and state our main result. In Section 3, we recall the definition of the restriction operator and its basic properties adapted to the regularity class of non-Newtonian fluids. The main result, concerning the asymptotic limit in the large $N /$ small vol $[N]$ regime is proved in Section 4. The paper is concluded by a short discussion in Section 5 .

## 2 Weak formulation, main result

Adapting the original definition of Judakov [22], we introduce a weak formulation of the fluid-structure interaction problem specified in Section 1.1.

### 2.1 Weak formulation

Given the positions of the right bodies $\mathcal{S}_{n, N}(t)$, we introduce the fluid domain

The total density of the fluid-structure system satisfies the transport equation

in the weak sense, meaning

for any $\varphi \in C_{c}^{1}\left([0, T) \times \mathbb{R}^{d}\right)$. Here the velocity field

$$
\mathbf{u} \in L^{\infty}\left(0, T ; L^{2}\left(\Omega ; \mathbb{R}^{d}\right)\right) \cap L^{p}\left(0, T ; W_{0}^{1, p}\left(\Omega ; \mathbb{R}^{d}\right)\right)
$$

has been set to be zero outside $\Omega$, and

The velocity $\mathbf{u}$ belongs to the class

The momentum balance (1.3) is rewritten in the form

### 2.2 Main result

Having collected the preliminary material, we are ready to formulate our main result.
Tw1 Theorem 2.1. Let $\Omega \subset \mathbb{R}^{d}, d=2,3$ be a bounded domain of class $C^{2+\nu}$. Suppose the following hypotheses are satisfied:

- The potential $F$ is convex satisfying (1.5), where $p \geqslant d$.
- The volume force $\mathbf{g}$ belongs to the class $\mathbf{g} \in L^{\infty}\left(\Omega ; \mathbb{R}^{d}\right)$.
- For a positive integer $N$, the initial configuration of the rigid bodies is represented by a family of connected compact sets $\left(\mathcal{S}_{n, N}(0)\right)_{n=1}^{N}$ with diameters $\left(r_{n, N}\right)_{n=1}^{N}$,

- The (initial) mass density distribution

uniformly for $N \rightarrow \infty$.

- The rigid bodies are of positive volume (the d-dimensional Lebesgue measure),

## 3 Restriction operator

Selecting an appropriate restriction operator holds paramount importance in our analysis. Diverging from the predominant approach found in the existing literature, which typically involves modifying test functions to vanish on the body, we leverage the flexibility granted by condition (2.5). Instead, we substitute the function on a ball with its integral average over that same ball. This approach has previously been employed in [15, Section 4.1], where comprehensive proofs of the following assertions can be found.

Remark 3.5. The constant $c(p)$, depending on the norm of the Bogovskii operator, is one of the factors determining the specific value of the quantity $A$ in (2.16).

& \quad \leqslant c(r)^{N}\|\boldsymbol{\varphi}\|_{W^{1, r}(\Omega)}\left\|\rho_{N}\right\|_{L^{q}(\Omega)}\left\|\mathbf{u}_{N}\right\|_{L^{s}\left(\Omega ; \mathbb{R}^{d}\right)}\left|\mathbf{Y}_{n, N}(t)\right|\left(\sum_{n=1}^{N}\left|B_{2\left(5^{n-1} r_{n, N}\right)}\right|\right)^{1-\frac{1}{r}-\frac{1}{q}-\frac{1}{s}}, \tag{4.26}
\end{align*},
$$

where $q>1$ and $r$ and $s$ are arbitrary finite.
Now, in view of hypothesis (2.9),

$$
\int_{\mathcal{S}_{n, N}(t)}\left|\mathbf{w}_{n, N}\right|^{2} \mathrm{~d} x=\int_{\mathcal{S}_{n, N}(t)}\left(\left|\mathbf{Y}_{n, N}(t)\right|^{2}+\left|\boldsymbol{\omega}_{n, N} \wedge\left(x-\mathbf{h}_{n, N}(t)\right)\right|^{2}\right) \mathrm{d} x
$$

Consequently, following the arguments of [15, Section 3.1] and making use of hypothesis (2.10) as the case may be, we obtain the bound on the rigid translation velocities

$$
\begin{equation*}
\left\|\mathbf{Y}_{n, N}\right\|_{L^{p}(0, T)} \lesssim\left|\mathcal{S}_{n, N}\right|^{\alpha}, \alpha>0 \text { arbitrary if } p=d, \alpha=0 \text { if } p>d \tag{4.27}
\end{equation*}
$$

Thus we may fix $A=A(p, q)$ in hypothesis (2.16) so that the right-hand side of (4.26) tends to zero in $L^{1}(0, T)$ as $N \rightarrow \infty$ for any fixed test function $\varphi \in C_{c}^{1}\left([0, T) \times \Omega ; \mathbb{R}^{d}\right), \operatorname{div}_{x} \boldsymbol{\varphi}=0$.

### 4.2 Identifying the limit in the viscous stress

Summarizing the preceding part we have obtained the system of equations

$$
\begin{equation*}
\int_{0}^{T} \int_{\Omega}\left[\bar{\rho} \mathbf{u} \cdot \partial_{t} \boldsymbol{\varphi}+\bar{\rho}(\mathbf{u} \otimes \mathbf{u}): \nabla_{x} \boldsymbol{\varphi}\right] \mathrm{d} x \mathrm{~d} t=\int_{0}^{T} \int_{\Omega}\left[\mathbb{S}: \mathbb{D}_{x} \boldsymbol{\varphi}-\bar{\rho} \mathbf{g} \cdot \boldsymbol{\varphi}\right] \mathrm{d} x-\int_{\Omega} \mathbf{u}_{0} \cdot \boldsymbol{\varphi}(0, \cdot) \mathrm{d} x \tag{4.28}
\end{equation*}
$$

for any $\varphi \in C_{c}^{1}\left([0, T) \times \Omega ; \mathbb{R}^{3}\right), \operatorname{div}_{x} \varphi=0$, together with the incompressibility constraint

$$
\begin{equation*}
\operatorname{div}_{x} \mathbf{u}=0 \text { a.a. in }(0, T) \times \Omega \tag{4.29}
\end{equation*}
$$

Our ultimate goal is to identify the weak limit of the viscous stresses. Specifically, we want to show that

$$
\mathbb{S} \in \partial F\left(\mathbb{D}_{x} \mathbf{u}\right) \text { for a.a. } t \in(0, T)
$$

As shown in (4.11),

$$
\mathbb{S}_{N} \rightarrow \mathbb{S} \text { weakly in } L^{p^{\prime}}\left(0, T ; L^{p^{\prime}}\left(\Omega ; \mathbb{R}^{d}\right)\right)
$$

We recall that

$$
\mathbf{u}_{N} \rightarrow \mathbf{u} \text { weakly in } L^{p}\left(0, T ; W_{0}^{1, p}\left(\Omega ; \mathbb{R}^{d}\right)\right) \text { and (strongly) in } L^{2}\left(0, T ; L^{2}\left(\Omega ; \mathbb{R}^{d}\right)\right) .
$$

Moreover $\left(\rho_{N}, \mathbf{u}_{N}\right)$ satisfy the energy inequality (4.1). In addition, using hypothesis (2.13) concerning (strong) convergence of the initial data, we get

$$
\lim _{N \rightarrow \infty} \frac{1}{2} \int_{\Omega} \rho_{0, N}\left|\mathbf{u}_{0, N}\right|^{2} \mathrm{~d} x+\int_{0}^{\tau} \int_{\Omega} \rho_{N} \mathbf{g} \cdot \mathbf{u}_{N} \mathrm{~d} x \mathrm{~d} t=\frac{1}{2} \int_{\Omega} \bar{\rho}\left|\mathbf{u}_{0}\right|^{2} \mathrm{~d} x+\int_{0}^{\tau} \int_{\Omega} \bar{\rho} \mathbf{g} \cdot \mathbf{u} \mathrm{d} x \mathrm{~d} t .
$$

Finally, as convex functions are weakly lower semi-continuous, we may infer that

$$
\begin{align*}
\frac{1}{2} \int_{\Omega} \bar{\rho}|\mathbf{u}|^{2}(\tau, \cdot) \mathrm{d} x & +\int_{0}^{\tau} \int_{\Omega}\left[F\left(\mathbb{D}_{x} \mathbf{u}\right)+F^{*}(\mathbb{S})\right] \mathrm{d} x \\
& \leqslant \limsup _{N \rightarrow \infty}\left[\frac{1}{2} \int_{\Omega} \rho_{N}\left|\mathbf{u}_{N}\right|^{2}(\tau, \cdot) \mathrm{d} x+\int_{0}^{\tau} \int_{\Omega}\left[F\left(\mathbb{D}_{x} \mathbf{u}_{N}\right)+F^{*}\left(\mathbb{S}_{N}\right)\right] \mathrm{d} x\right] \\
& \leqslant \frac{1}{2} \int_{\Omega} \bar{\rho}\left|\mathbf{u}_{0}\right|^{2} \mathrm{~d} x+\int_{0}^{\tau} \int_{\Omega} \bar{\rho} \mathbf{g} \cdot \mathbf{u} \mathrm{d} x \mathrm{~d} t \text { for a.a. } \tau \in(0, T) \tag{4.30}
\end{align*}
$$

The next step is to derive the energy balance for the limit system (4.28), (4.29). As $p \geqslant d$, we have, by the standard Sobolev embedding relations,

$$
\mathbf{u} \otimes \mathbf{u} \in L^{\frac{p}{2}}\left(0, T ; L^{s}(\Omega)\right) \cap L^{\infty}\left(0, T ; L^{2}\left(\Omega ; \mathbb{R}^{d}\right)\right) \text { for any finite } s \geqslant 1
$$

In particular,

$$
\mathbf{u} \otimes \mathbf{u} \in L^{p^{\prime}}\left(0, T ; L^{p^{\prime}}\left(\Omega ; \mathbb{R}^{d \times d}\right) .\right.
$$

Thus the limit system (4.28) can be interpreted as

$$
\partial_{t} \mathbf{u}=-\operatorname{div}_{x}(\mathbf{u} \otimes \mathbf{u})+\frac{1}{\bar{\rho}} \operatorname{div}_{x} \mathbb{S}+\mathbf{g} \in L^{p^{\prime}}\left(0, T ; L^{p^{\prime}}\left(\Omega ; \mathbb{R}^{d}\right)\right)+\nabla_{x} \Pi,
$$

where the solenoidal field $\mathbf{u}$ can be used as "test function" (see e.g. von Wahl [32]). Accordingly, we deduce the energy equality

$$
\begin{equation*}
\frac{1}{2} \int_{\Omega} \bar{\rho}|\mathbf{u}(\tau, \cdot)|^{2} \mathrm{~d} x+\int_{0}^{\tau} \int_{\Omega} \mathbb{S}: \mathbb{D}_{x} \mathbf{u} \mathrm{~d} x=\frac{1}{2} \int_{\Omega} \bar{\rho}\left|\mathbf{u}_{0}\right|^{2} \mathrm{~d} x+\int_{\Omega} \bar{\rho} \mathbf{g} \cdot \mathbf{u} \mathrm{d} x \tag{4.31}
\end{equation*}
$$

Plugging (4.31) in (4.30), we conclude

$$
\begin{align*}
\int_{0}^{\tau} & \int_{\Omega}\left[F\left(\mathbb{D}_{x} \mathbf{u}\right)+F^{*}(\mathbb{S})\right] \mathrm{d} x \\
\quad & \leqslant \limsup _{N \rightarrow \infty} \int_{0}^{\tau} \int_{\Omega}\left[F\left(\mathbb{D}_{x} \mathbf{u}_{N}\right)+F^{*}\left(\mathbb{S}_{N}\right)\right] \mathrm{d} x \leqslant \int_{0}^{\tau} \int_{\Omega} \mathbb{S}: \mathbb{D}_{x} \mathbf{u} \mathrm{~d} x \mathrm{~d} t . \text { for a.a. } \tau \in(0, T) \tag{4.32}
\end{align*}
$$

A direct application of Fenchel's inequality yields the desired conclusion

$$
\begin{equation*}
F\left(\mathbb{D}_{x} \mathbf{u}\right)+F^{*}(\mathbb{S})=\mathbb{S}: \mathbb{D}_{x} \mathbf{u} \Rightarrow \mathbb{S} \in \partial F\left(\mathbb{D}_{x} \mathbf{u}\right) \text { for a.a. } t \in(0, T) \tag{4.33}
\end{equation*}
$$

### 4.3 Strong Convergence

Finally, we discuss the problem of strong convergence of the velocity gradients. It follows from (4.32) that

$$
\limsup _{N \rightarrow \infty} \int_{0}^{\tau} \int_{\Omega}\left[F\left(\mathbb{D}_{x} \mathbf{u}_{N}\right)-F\left(\mathbb{D}_{x} \mathbf{u}\right)\right] \mathrm{d} x+\int_{0}^{\tau} \int_{\Omega}\left[F^{*}\left(\mathbb{S}_{N}\right)-F^{*}(\mathbb{S})\right] \mathrm{d} x
$$

$$
\leqslant \int_{0}^{\tau} \int_{\Omega}\left[\mathbb{S}: \mathbb{D}_{x} \mathbf{u}-F\left(\mathbb{D}_{x} \mathbf{u}\right)-F^{*}(\mathbb{S})\right] \mathrm{d} x \mathrm{~d} t \leqslant 0
$$

As both $F$ and $F^{*}$ are convex, we may infer that

$$
\begin{equation*}
\int_{0}^{\tau} \int_{\Omega} F\left(\mathbb{D}_{x} \mathbf{u}_{N}\right) \mathrm{d} x \rightarrow \int_{0}^{\tau} \int_{\Omega} F\left(\mathbb{D}_{x} \mathbf{u}\right) \mathrm{d} x, \int_{0}^{\tau} \int_{\Omega} F^{*}\left(\mathbb{S}_{N}\right) \mathrm{d} x \rightarrow \int_{0}^{\tau} \int_{\Omega} F^{*}(\mathbb{S}) \mathrm{d} x \tag{4.34}
\end{equation*}
$$

Thus if $F$ is strictly convex, we conclude, passing to a subsequence as the case may be,

$$
\mathbb{D}_{x} \mathbf{u}_{N} \rightarrow \mathbb{D}_{x} \mathbf{u} \text { a.a. in }(0, T) \times \Omega
$$

yielding (for the original sequence)

$$
\begin{equation*}
\mathbb{D}_{x} \mathbf{u}_{N} \rightarrow \mathbb{D}_{x} \mathbf{u} \text { in } L^{1}\left((0, T) \times \Omega ; \mathbb{R}_{\mathrm{sym}}^{d \times d}\right) \tag{4.35}
\end{equation*}
$$

cf. [14, Appendix, Theorem 11.27].
Finally, as $F$ complies with the growth restriction (1.5), we combine (4.34), (4.35) to conclude

$$
\int_{0}^{T} \int_{\Omega}\left|\mathbb{D}_{x} \mathbf{u}_{N}\right|^{p} \mathrm{~d} x \mathrm{~d} t \rightarrow \int_{0}^{T} \int_{\Omega}\left|\mathbb{D}_{x} \mathbf{u}\right|^{p} \mathrm{~d} x \mathrm{~d} t \Rightarrow \mathbb{D}_{x} \mathbf{u}_{N} \rightarrow \mathbb{D}_{x} \mathbf{u} \text { in } L^{p}\left((0, T) \times \Omega ; R_{\mathrm{sym}}^{3 \times 3}\right)
$$

## 5 Concluding remarks

We conclude by several remarks concerning possible extensions of the above result.

### 5.1 Total volume

If $d=p=2$, the hypothesis (2.16) is compatible with the so-called critical distribution of fixed balls in the homogenization problem, see e.g. Allaire [2], while it is super-critical if $p>d$, where any compact set has non-zero $p$-capacity. We actually conjecture that the conclusion of Theorem 2.1 remains if

$$
\operatorname{vol}[N] \approx A^{-N} \text { for some } A>1
$$

The value of the exponential factor $A=A(p, q)$ in Theorem 2.1 results from the specific construction of the restriction operator $\mathbf{R}$ that must account for possible collisions of several rigid bodies. This stumbling block could be possibly removed if a qualitative information on the mutual distance of two bodies were available.

### 5.2 Heavy bodies

Hypotheses (2.8), (2.16) allow for "heavy bodies", for which the mass densities are allowed to grow as $N \rightarrow \infty$. Indeed it is easy to check that (2.8) follows from (2.16) if

$$
0<\rho_{n, N} \leqslant N^{\beta}, n=1, \ldots, N, \beta>0 \text { arbitrary }
$$

### 5.3 More general viscous stresses

We deliberately focused on shear thickening fluids, more precisely we consider $p \geqslant d$. Similar results can be expected for general $p>1$ at least on a short time interval $\left[0, T_{\max }\right)$. Here $T_{\max }>0$ is the life-span of the smooth solution of the limit problem (2.15). Indeed using the same method one could establish convergence to generalized dissipative solutions introduced in [1] and use the weak-strong uniqueness result proved therein.
