

ASYMPTOTICS OF BERGMAN POLYNOMIALS FOR DOMAINS WITH REFLECTION-INVARIANT CORNERS

ABSTRACT. We study the asymptotic behavior of the Bergman orthogonal polynomials $(p_n)_{n=0}^\infty$ for a class of bounded simply connected domains D . The class is defined by the requirement that conformal maps φ of D onto the unit disk extend analytically across the boundary L of D , and that φ' has a finite number of zeros $z_1, \dots, z_q$ on L . The boundary L is then piecewise analytic with corners at the zeros of φ' . A result of Stylianopoulos implies that a Carleman-type strong asymptotic formula for p_n holds on the exterior domain $\mathbb{C} \setminus \overline{D}$. We prove that the same formula remains valid across $L \setminus \{z_1, \dots, z_q\}$ and on a maximal open subset of D . As a consequence, the only boundary points that attract zeros of p_n are the corners. This is in stark contrast to the case when φ fails to admit an analytic extension past L , since when this happens the zero counting measure of p_n is known to approach the equilibrium measure for L along suitable subsequences.

1 INTRODUCTION.

1.1 Zeros of Bergman polynomials for domains with corners.

For a domain D in the complex plane $\mathbb{C}$, we write $A^2(D)$ for the Bergman space of holomorphic functions f on D with finite norm

$$\|f\|_{L^2(D)} := \left(\int_D |f(z)|^2 dA(z) \right)^{1/2} < \infty,$$

where $dA(z) = \pi^{-1} dx dy$ denotes the standard area measure normalized by π . In this work, D will always stand for the interior domain of a Jordan curve L . That is, D is the bounded component of $\mathbb{C} \setminus L$. We will denote by $\mathbb{D}(z, r)$ the open disk of radius r centered at z , by $\mathbb{T}(z, r)$ its boundary, and by $\Delta(z, r)$ the exterior disk $\Delta(z, r) = \overline{\mathbb{C}} \setminus \overline{\mathbb{D}(z, r)}$.

The space of polynomials forms a linear subspace of $A^2(D)$. By applying the Gram-Schmidt orthonormalization procedure to the standard monomial sequence, we obtain a unique sequence of polynomials $(p_n)_{n=0}^\infty$ such that p_n has degree n and positive leading coefficient, and the following planar orthonormality conditions are satisfied:

$$\int_D p_n(z) \overline{p_m(z)} dA(z) = \begin{cases} 0, & m \neq n, \\ 1, & n = m. \end{cases}$$

These polynomials are often called the Bergman polynomials for the domain D . Their study dates back at least to Carleman's 1922 paper [2], and the name Carleman polynomials also occurs in the literature.

For a positive integer $N \geq 3$, we denote by R_N the regular N -gon with vertices at the N -th roots of unity. The zeros of the associated Bergman polynomials are known to exhibit a curious dichotomy depending on the value of N . In numerical experiments carried out in [7], it was observed that for $N \in \{3, 4\}$, the zeros of p_n appear to lie on the set Γ_N formed by joining the N vertices of R_N to its center, and indeed this observation was later confirmed to be a fact in [9]. However, for $D = R_N$ with $N \geq 5$, the experiments in [7] strongly indicate that the zeros of p_n move away from Γ_N as n increases. The reason behind this dichotomy was partially explained in the work [8], and as we describe in what follows, it is related to the analytic continuation properties of the interior conformal maps of D onto the unit disk.

Denote by ν_n , $n \geq 1$, the normalized counting measure for the zeros set of p_n . That is, if $\zeta_{1,n}, \dots, \zeta_{n,n}$ denote the zeros of p_n (counted with multiplicity), we put

$$\nu_n := \frac{1}{n} \sum_{j=1}^n \delta_{\zeta_{j,n}}.$$

For a measure ν , we write $\nu_n \xrightarrow{*} \nu$ as $n \rightarrow \infty$ to mean that

$$\lim_{n \rightarrow \infty} \int f d\nu_n = \int f d\nu$$

for every compactly supported continuous function f on $\mathbb{C}$. We denote by Z the set of points $z_0 \in \mathbb{C}$ with the property that for every open neighborhood U of z_0 , one can find infinitely many polynomials in the sequence (p_n) that have a zero in U . It is easy to see that if $\nu_n \xrightarrow{*} \nu$, then every point in the support of ν belongs to Z . The following result was proven in [8] (see Theorem 2.1 and Fact B therein).

Theorem 1.1 (Levin, Saff, Stylianopoulos [8]). *Let D be the interior domain of a Jordan curve L , and let σ_L be the equilibrium measure of L . The following statements are equivalent:*

- (i) *No conformal map of D onto $\mathbb{D}(0, 1)$ can be analytically continued to a domain containing $\overline{D}$.*
 - (ii) *There exists a subsequence (ν_{n_k}) with*
- $$(1.1) \quad \nu_{n_k} \xrightarrow{*} \sigma_L \quad \text{as } k \rightarrow \infty.$$

- (iii) *For every $z \in D$,*

$$\limsup_{n \rightarrow \infty} |p_n(z)|^{1/n} = 1.$$

Note that (i) is equivalent to the existence of *one* conformal map φ which cannot be analytically continued past L .

We remark that there are classes of domains for which the convergence in (1.1) is known to hold for the full sequence (ν_n) , see [14, Cor. 3.1].

Since the support of σ_L is all of L , the convergence (1.1) implies that if φ has a singularity on L , then $L \subset Z$. When $D = R_N$ with $N \geq 5$, the conformal map φ has singularities at the vertices of D , so that every point of L attracts zeros of the polynomials p_n . As a consequence, it is not possible for the zeros to stay on the set Γ_N , as it otherwise happens when D is the equilateral triangle ($D = R_3$) or the square ($D = R_4$). We note that when $N \in \{3, 4\}$, not only are the zeros of every p_n located on the set Γ_N , but we also have that $\Gamma_N \subset Z$. This is a consequence of Theorem 9 of [9].

Definition 1.2. We let $\mathcal{A}_1$ denote the collection of bounded Jordan domains D with the property that a conformal map φ of D onto $\mathbb{D}(0, 1)$ has an analytic continuation to an open set containing $\overline{D}$, and the derivative φ' has at least one zero on the boundary L of D .

A domain $D \in \mathcal{A}_1$ is said to have *reflection-invariant corners*. For an explanation of this terminology, see the last paragraph of this section.

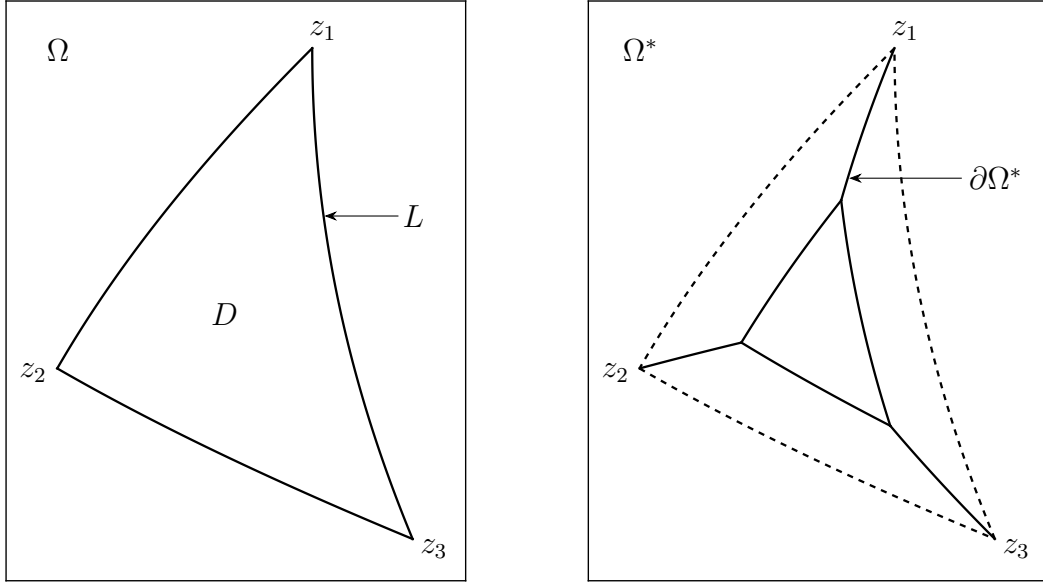


FIGURE 1. Illustration of the curve $L = \partial D$ and sets Ω and Ω^* , for a domain $D \in \mathcal{A}_1$ with three corners z_1 , z_2 , and z_3 .

If $D \in \mathcal{A}_1$, then L is a piecewise analytic curve with corners at each of the zeros of φ' on L . We denote this set of corners by $C(L) = \{z_1, \dots, z_q\}$ (see Figure 1). The interior angle formed by the two arcs of L that meet at a given corner z_j is equal to π/m_j , where $m_j \geq 2$ is the order of φ at z_j . The equilateral triangle and the square both belong to the class $\mathcal{A}_1$. We might also mention the example of the lens-shaped domain D bounded by two circular arcs that are symmetric about the imaginary axis and that meet at $-i$ and i , forming two corners with

interior angles $\pi/2$. This domain is also in $\mathcal{A}_1$, and it was proven in [8, Cor. 3.2] that the zeros of each p_n lie on the segment $(-i, i)$, and that $[-i, i] \subset Z$.

These examples suggest the hypothesis that for every $D \in \mathcal{A}_1$, the set $L \cap Z$ contains every corner of L but no other boundary point (i.e. $L \cap Z = C(L)$). That this is indeed the case will follow from the main result of this paper, namely, that the strong asymptotic formula known to describe the asymptotic behavior of p_n as $n \rightarrow \infty$ on the exterior of L in fact extends across the analytic arcs of L to a portion of the domain D . We state this result in more precise terms in what follows.

1.2 Strong asymptotics on a maximal open set.

Denote by Ω the unbounded component of $\overline{\mathbb{C}} \setminus L$, so that $\Omega = \overline{\mathbb{C}} \setminus \overline{D}$ (see Figure 1, left side). We let $\phi : \Omega \rightarrow \Delta(0, 1)$ be the conformal map of Ω onto the exterior disk $\Delta(0, 1)$, such that $\phi(\infty) = \infty$ and $\gamma := \phi'(\infty) > 0$. By Carathéodory's theorem, the map ϕ extends to a homeomorphism of $\overline{\Omega}$ onto $\overline{\Delta(0, 1)}$.

In [15], Stylianopoulos proved that if the orthogonality domain D is bounded by a piecewise analytic curve without cusps, then p_n satisfies a Carleman-type strong asymptotic formula on the exterior domain Ω . The error term was later improved in [1], and the (sharp) asymptotic formula reads

$$(1.2) \quad p_n(z) = \sqrt{n+1} \phi'(z) \phi(z)^n (1 + O(n^{-1})), \quad z \in \Omega,$$

as $n \rightarrow \infty$, with the implicit constant being uniformly bounded on closed subsets of Ω . In particular, (1.2) applies whenever $D \in \mathcal{A}_1$. Note that if the piecewise analytic curve L is such that an interior conformal map $\varphi : D \rightarrow \mathbb{D}(0, 1)$ has a singularity on L (for instance, if the interior angle α formed at a corner is such that $\pi/\alpha \notin \mathbb{N}$), then the asymptotic formula (1.2) cannot possibly hold on an open set larger than Ω . Indeed, by Theorem 1.1 every point of L attracts zeros of the polynomials p_n , and furthermore, the $\limsup_{n \rightarrow \infty} \sqrt[n]{|p_n(z)|}$ remains constant (equal to 1) throughout D . However, the opposite turns out to be true when $D \in \mathcal{A}_1$. This is a direct consequence of the following theorem, which is the main result of this paper.

Theorem 1.3. *Assume $D \in \mathcal{A}_1$. There exists an open set $\Omega^* \supset \bar{\Omega} \setminus C(L)$ and a univalent function $\Phi : \Omega^* \rightarrow \bar{\mathbb{C}}$ with $\Phi|_{\Omega} = \phi$, such that the asymptotic formula*

$$(1.3) \quad p_n(z) = \sqrt{n+1} \Phi'(z) \Phi(z)^n \left(1 + O\left(\frac{\log n}{n}\right) \right), \quad z \in \Omega^*,$$

holds uniformly on closed subsets of Ω^ as $n \rightarrow \infty$.*

The set Ω^* is illustrated in Figure 1 (right side), and will be precisely defined in Section 2. This set is maximal in the sense that no formula such as (1.3) can hold on an open set larger than Ω^* , since $\limsup_{n \rightarrow \infty} \sqrt[n]{|p_n(z)|}$ will be shown to remain constant on the interior of $\mathbb{C} \setminus \Omega^*$.

In the examples where $D = R_N$ with $N \in \{3, 4\}$, we have $\Omega^* = \bar{\mathbb{C}} \setminus \Gamma_N$ and Φ is the analytic continuation to Ω^* of the exterior conformal map ϕ . However, we do not know whether Ω^* is always a connected set, and so we can only say that Φ coincides with the analytic continuation of ϕ on the unbounded component of Ω^* .

Prior to [15], asymptotic formulas like (1.2) (but with different estimates of the error terms) had been established for orthogonality domains D that are bounded either by an analytic Jordan curve [2], or by a curve with some degree of smoothness [16]. For the class $\mathcal{A}_2$ of domains with analytic boundary, Carleman found already in 1922 [2] that (1.2) indeed holds on the largest domain $\Omega_\rho \supset \bar{\Omega}$ that admits a univalent continuation of ϕ with $\phi(\Omega_\rho) = \Delta(0, \rho)$, $0 \leq \rho < 1$. More recently in [4] (see also [5, 6, 10]), it was found that when L is analytic, it is possible to characterize the largest open set $\Omega^* \supset \Omega_\rho$ on which a formula of the form (1.3) is valid.

Notice that a domain D is in the union $\mathcal{A} = \mathcal{A}_1 \cup \mathcal{A}_2$ precisely when a conformal map of D onto $\mathbb{D}(0, 1)$ is analytic in $\bar{D}$ (i.e., if the first statement of

Theorem 1.1 does not hold). For $D \in \mathcal{A}$, it turns out that the dominant behavior of $p_n(z)$ on D as $n \rightarrow \infty$ is given by the integral formula

$$(1.4) \quad p_n(z) \sim \frac{\sqrt{n+1}\varphi'(z)}{2\pi i} \int_{|w|=1} \frac{w^n}{h(w) - \varphi(z)} dw, \quad z \in D,$$

where h is the homeomorphism $h : \mathbb{T}(0, 1) \rightarrow \mathbb{T}(0, 1)$ given by

$$h(w) := \varphi(\psi(w))$$

and ψ is the inverse of the exterior map ϕ . Since the right-hand side of (1.4) makes sense for every Jordan domain, it may well be that this representation of p_n is valid also for other domains outside the class $\mathcal{A}$. However, there is one feature which accounts for the distinguished behavior of the Bergman polynomials for domains in the class $\mathcal{A}$. Namely, the fact that $D \in \mathcal{A}$ if and only if the function $h(w)$ appearing in the denominator of (1.4) is analytic in a neighborhood of the unit circle $\mathbb{T}(0, 1)$. This is the key feature that makes possible to extend the asymptotic formula (1.2) beyond Ω to a maximal subset of the orthogonality domain.

Theorem 1.3 has several implications for the limiting zero distribution of the Bergman polynomial p_n for a domain $D \in \mathcal{A}_1$. The most immediate is that for any closed subset E of Ω^* , there is an index n_E such that no polynomial p_n of degree $n > n_E$ has a zero on E . As a consequence, the zero limit set Z is contained in $\mathbb{C} \setminus \Omega^*$, and the only points of L that attract zeros of the p_n 's are the corners of L .

The fact that every corner point of L is in Z can easily be seen by applying standard arguments from potential theory. Indeed, the support $\text{supp}(\nu)$ of any measure ν that is a weak $*$ -limit of the sequence of zero counting measures (ν_n) is contained in Z , and ν is an *inverse Balayage measure* of the equilibrium measure σ_L of L . This means that the logarithmic potential $U^\nu(z)$ of ν equals the logarithmic potential $U^{\sigma_L}(z)$ of σ_L for all $z \in \Omega$. The potential U^ν is harmonic outside $\text{supp}(\nu)$, and $U^{\sigma_L}(z) = \log \phi'(\infty) - \log |\phi(z)|$ for $z \in \Omega$. Since $\log |\phi(z)|$ cannot be harmonically extended past a corner of L , every corner has to be an element of $\text{supp}(\nu)$.

In a forthcoming work, we will carry out a more comprehensive analysis on the distribution of the zeros of p_n and on the structure of $\mathbb{C} \setminus \Omega^*$. Some of the results are similar to those obtained in [4] for domains with analytic boundary, but others are more specific to the class $\mathcal{A}_1$ and a manifestation of the presence of corners on ∂D .

To conclude this section, we briefly mention that the class $\mathcal{A}_1$ can be characterized purely in geometric terms. Suppose that D is a domain bounded by a piecewise analytic curve L , and that for every corner z of L , two small sub-arcs L_z^0 and L_z^1 of L that meet at z form an interior angle of the form π/m , with $m \geq 2$ an integer. Applying a Schwarz reflection across L_z^1 , we obtain a local holomorphic extension of φ to a wedge-shaped region between L_z^0 and a new arc L_z^2 (the conformal reflection of L_z^0 about L_z^1). Iterating this, reflecting each time L_z^j about L_z^{j+1} , we obtain after $2m - 1$ steps an arc L_z^{2m} which is tangent to L_z^0 . The domain D belongs to $\mathcal{A}_1$ if and only if each point of L_z^0 is mapped to itself by this $(2m - 1)$ -step reflection procedure, so that in particular $L_z^0 = L_z^{2m}$. This is the *reflection invariance* alluded to in the title.

2 STRONG ASYMPTOTICS ACROSS L .

2.1 Asymptotic behavior of p_n on Ω .

Let $A_n(z)$ be the analytic function on Ω defined implicitly by the relation

$$p_n(z) = \sqrt{n+1} \phi'(z) \phi(z)^n (1 + A_n(z)), \quad z \in \Omega.$$

As mentioned in the introduction, it was proven in [15] that if D is bounded by a piecewise analytic curve without cusps, then $\lim_{n \rightarrow \infty} A_n(z) = 0$ and the convergence is uniform on closed subsets of Ω . This is a consequence of the inequality (1.9) of [15], which asserts that for some constant C ,

$$|A_n(z)| \leq \frac{C}{\sqrt{n}(|\phi(z)| - 1)} + \frac{C}{n}, \quad z \in \Omega, \quad n \geq 1.$$

We will make use of a different inequality which provides a better estimate on the rate of decay of $A_n(z)$ for z in Ω and away from the corners of L . We use $d_{\mathbb{C}}(E, F)$ to denote the Euclidean distance between two closed sets E and F , and when $E = \{z\}$ is a singleton, we simply write $d_{\mathbb{C}}(z, F)$.

Proposition 2.1. *Suppose that the boundary L of D is a piecewise analytic curve without cusps whose set of corners is denoted by $C(L)$. For every $\epsilon > 0$, there exists a constant c_{ϵ} such that*

$$(2.1) \quad |A_n(z)| \leq \frac{c_{\epsilon} |\phi(z)|}{n(|\phi(z)| - 1)}, \quad z \in \mathcal{E}_{\epsilon}, \quad n > 1,$$

where $\mathcal{E}_{\epsilon} := \{z \in \Omega : d_{\mathbb{C}}(z, C(L)) > \epsilon\}$. In particular, $A_n(z) = O(1/n)$ uniformly on closed subsets of Ω as $n \rightarrow \infty$.

Though not explicitly stated, the inequality (2.1) is to a large extent contained in the proof of Theorem 1.1 in [1]. We will briefly go over the details at the start of Section 4.

2.2 Asymptotic behavior of p_n on D .

Among the conformal maps of D onto the unit disk $\mathbb{D}(0,1)$, we fix any one of them and call it φ .

If $D \in \mathcal{A}_1$, then L is a piecewise analytic curve with corners at the zeros of φ' on L . This set of corners is denoted by $C(L)$. In this case, the map ϕ (and thus its derivative ϕ' as well) extends analytically to an open set containing $\bar{\Omega} \setminus C(L)$. The derivative ϕ' is integrable over L , since

$$\int_L |\phi'(z)| |dz| = \int_{\mathbb{T}(0,1)} |dw| = 2\pi.$$

This allows us to define the functions

$$(2.2) \quad Q_n(z) := \frac{(n+1)\varphi'(z)}{2\pi i} \int_L \frac{\phi'(\zeta)\phi(\zeta)^n}{\varphi(\zeta) - \varphi(z)} d\zeta, \quad z \in D, \quad n \geq 0.$$

We denote by λ_n the leading coefficient of p_n , which is a positive number. Recall also the notation $\gamma := \phi'(\infty)$. The first step towards extending the exterior strong asymptotics is the following series representation of p_n on D .

Theorem 2.2. *The Bergman polynomials p_n for a domain $D \in \mathcal{A}_1$ admit the series representation*

$$(2.3) \quad \frac{\lambda_n}{\gamma^{n+1}} p_n(z) = \sum_{j=0}^{\infty} h(n,j) Q_{n+j}(z), \quad z \in D, \quad n \geq 0,$$

where the coefficients $h(n,j)$ are numbers such that $h(n,0) = 1$ and

$$(2.4) \quad |h(n,j)| \leq \frac{B}{n+j+1} \left(1 + \frac{j-1}{n+1}\right)^B, \quad j \geq 1,$$

for a certain constant $B > 0$ that is independent of n and j .

Formula (2.3) will be deduced from a well-known connection between the Bergman polynomials and the reproducing kernel of the space $A^2(D)$, that is, from the equality

$$\frac{\varphi'(z)\overline{\varphi'(\zeta)}}{(1 - \varphi(z)\overline{\varphi(\zeta)})^2} = \sum_{k=0}^{\infty} \overline{p_k(\zeta)} p_k(z), \quad z, \zeta \in D,$$

see Subsection 4.2 for details. In doing so, we make use of some inequalities previously obtained in [15].

The dominant term of the series in (2.3) happens to be the first one, and the behavior of the leading coefficient λ_n is known from [15]:

$$\lambda_n = \sqrt{n+1} \gamma^{n+1} (1 + O(1/n)), \quad n \rightarrow \infty.$$

With proper control over the error terms, this will lead us to conclude that for $z \in D$, $p_n(z) \sim (n+1)^{-1/2} Q_n(z)$ as $n \rightarrow \infty$, which is the same as the integral formula (1.4). This can be seen by making the change of variables $\zeta = \psi(w)$ in (2.2).

By analyzing the large n behavior of the integral in (1.4), we will extend the exterior asymptotics (1.2) to a certain maximal open set D_1 of D . The construction of D_1 is carried out in what follows and applies more generally to any domain $D \in \mathcal{A}$. Let us set

$$L_r := \{z \in \overline{\Omega} : |\phi(z)| = r\}, \quad r \in [1, \infty].$$

Each L_r with $1 < r < \infty$ is an analytic Jordan curve contained in Ω , $L_1 = L$, and $L_\infty = \{\infty\}$. We denote by $\mathcal{D}_r$ the component of $\overline{\mathbb{C}} \setminus L_r$ that does not contain ∞ . Then, $\mathcal{D}_1 = D$ and $\mathcal{D}_\infty = \mathbb{C}$.

Let $\mu \in [0, 1]$ be the smallest positive number with the property that φ extends meromorphically to $\mathcal{D}_{1/\mu}$. Since, by assumption, φ extends analytically across L , we have $\mu < 1$. Recall that

$$\psi : \Delta(0, 1) \rightarrow \Omega$$

denotes the inverse of ϕ , which extends continuously to $\overline{\Delta(0, 1)}$. The composite

$$h(w) := \varphi(\psi(w))$$

is well-defined and meromorphic in the annulus $1 < |w| < 1/\mu$, extending continuously to $1 \leq |w| < 1/\mu$ and mapping the unit circle $|w| = 1$ onto itself. By the reflection principle (see e.g. [3, Ch. 8]), $h(w)$ can be extended as a meromorphic function to the bigger annulus $\mu < |w| < 1/\mu$, the extension being given by

$$h(w) := \frac{1}{\overline{\varphi(\psi(1/\overline{w}))}}, \quad \mu < |w| < 1.$$

Moreover, it is not difficult to see that $\mu < |w| < 1/\mu$ is the largest annulus about the origin that supports a meromorphic extension of h .

We next split D into subregions, determined by the zeros of the function

$$f_z(w) := h(w) - \varphi(z).$$

First, we let D_0 denote the set of points $z \in D$ for which the function $f_z(w)$ has no zeros in the annulus $\mu < |w| < 1$. Then, consider a point $z \in D \setminus D_0$. Among the

zeros of $f_z(w)$ in the region $\mu < |w| < 1$, only finitely many, say $w_{z,1}, w_{z,2}, \dots, w_{z,s}$ ($s \geq 1$), will have largest modulus. Let $m_{z,k}$ denote the multiplicity of $f_z(w)$ at $w_{z,k}$. For every integer $p \geq 1$, we define D_p as the set of points $z \in D \setminus D_0$ such that

$$m_{z,1} + m_{z,2} + \dots + m_{z,s} = p.$$

Thus, D_p consists of those $z \in D$ for which $f_z(w)$ has exactly p zeros in $\mu < |w| < 1$ of largest modulus, counted according to multiplicity.

Define next the function $r : D \rightarrow [\mu, 1)$ by

$$(2.5) \quad r(z) := \begin{cases} |w_{z,1}|, & z \in D \setminus D_0, \\ \mu, & z \in D_0. \end{cases}$$

If $z \in D_1$, then $f_z(w)$ has exactly one zero in $\mu < |w| < 1$ of largest modulus, say $w_{z,1}$, and this zero is simple. Let us set

$$\phi_1(z) := w_{z,1}, \quad z \in D_1,$$

so that $|\phi_1(z)| > \mu$.

One can easily verify by using Lemma 4.1 (see also Corollary 12 in [4]) that D_1 and $D \setminus D_0$ are open, that the map ϕ_1 is a univalent function, and that the function $r(z)$ is continuous.

Theorem 2.3. *Assume $D \in \mathcal{A}_1$. The analytic function $A_n : D_1 \rightarrow \mathbb{D}(0, 1)$ implicitly defined by*

$$(2.6) \quad p_n(z) = \sqrt{n+1} \phi_1'(z) \phi_1(z)^n (1 + A_n(z)), \quad z \in D_1,$$

satisfies that $A_n(z) = O(n^{-1})$ as $n \rightarrow \infty$, uniformly on compact subsets of D_1 . Moreover,

$$(2.7) \quad \limsup_{n \rightarrow \infty} |p_n(z)|^{1/n} = r(z), \quad z \in D.$$

It will be important to provide a more precise interior bound for $|A_n(z)|$ near L , similar to the exterior bound (2.1). We will obtain an inequality of the form

$$(2.8) \quad |A_n(z)| \leq \frac{M_1}{n(1 - |\phi_1(z)|)} + \frac{M_1}{n^{B_1}(1 - |\phi_1(z)|)^{B_1}},$$

valid for all $z \in D$ sufficiently close to L but away from the corners, see Section 4.4 below. Here, M_1 and $B_1 > 1$ are some constants that do not depend on n .

2.3 Gluing interior and exterior asymptotics.

As a consequence of Proposition 4.2 (the statement and proof of which we defer to Section 4.4), we have that the set

$$\Omega^* := D_1 \cup \overline{\Omega} \setminus C(L)$$

is open, and the function $\Phi : \Omega^* \rightarrow \Delta(0, \mu)$ defined by

$$\Phi(z) := \begin{cases} \phi(z), & z \in \overline{\Omega}, \\ \phi_1(z), & z \in D_1, \end{cases}$$

is univalent. Hence

$$A_n(z) := \frac{p_n(z)}{\sqrt{n+1}\Phi'(z)\Phi(z)^n} - 1, \quad z \in \Omega^*,$$

is analytic in Ω^* . The main goal is to show that $A_n(z) \rightarrow 0$ on Ω^* . To prove this, we start from the two bounds (2.1) and (2.8), which both degenerate as z approaches L . These bounds show that $A_n(z)$ is small, except for possibly near L . More concretely, we have that $A_n(z) = O(n^{-1} \log n)$ on the portion of Ω^* outside the shrinking band

$$\left\{ z \in \mathbb{C} : d_{\mathbb{C}}(z, L) \leq \frac{1}{\log n} \right\}$$

around L . Applying a Phragmén–Lindelöf-type argument in this narrow band but away from the corners, we are able to deduce the following key lemma, which immediately implies Theorem 1.3.

Lemma 2.4. *Assume $D \in \mathcal{A}_1$, and fix any $z_0 \in L \setminus C(L)$. There exists a neighborhood $\mathcal{U}_{z_0} \subset \Omega^*$ of z_0 and a corresponding constant C_{z_0} such that*

$$|A_n(z)| \leq \frac{C_{z_0} \log n}{n} \quad z \in \mathcal{U}_{z_0}, \quad n > 1.$$

Remark 2.5. Our extension of the strong asymptotics across L comes at the expense of a factor $\log n$ in the estimate of the rate of decay. Without too much effort it is possible to improve Lemma 2.4 to give $A_n(z) = O(n^{-1} \log^\ell(n))$ for any fixed $\ell \geq 1$, where $\log^\ell(n)$ denotes the iterated logarithm

$$\log^\ell(n) := \underbrace{\log \log \dots \log n}_{\ell \text{ times}}.$$

However, we will not present the details here, since most likely the loss in precision is artificial.

The asymptotic results presented in this section as well as Theorem 1.3 will be proven in Section 4. The proofs will rely on several auxiliary estimates that will be convenient to have established beforehand.

3 AUXILIARY ESTIMATES.

In this section, we make use of some key estimates obtained in [15], and so for the most part we try to follow the notation employed therein.

Let $n \geq 0$ be an integer. The Faber polynomial F_n associated to the map ϕ is the polynomial part of the Laurent expansion of $\phi(z)^n$ at infinity. Thus, $F_n(z) = \gamma^n z^n + \cdots$ is a polynomial of degree n whose leading coefficient is γ^n . Let $E_n(z)$ be defined by the equation

$$\phi(z)^n = F_n(z) + E_n(z), \quad z \in \Omega,$$

so that for every r such that $\Delta(0, r) \subset \Omega$, we have the Laurent expansion

$$(3.1) \quad E_n(z) = \frac{c_{n,1}}{z} + \frac{c_{n,2}}{z^2} + \frac{c_{n,3}}{z^3} + \cdots, \quad z \in \Delta(0, r).$$

Note that since the map ϕ is continuous on $\overline{\Omega}$, so is E_n . If we differentiate the identity

$$\phi(z)^{n+1} = F_{n+1}(z) + E_{n+1}(z)$$

we get

$$(3.2) \quad \phi'(z)\phi(z)^n = G_n(z) + H_n(z), \quad z \in \Omega,$$

with

$$(3.3) \quad G_n(z) := \frac{F'_{n+1}(z)}{n+1} = \gamma^{n+1} z^n + \cdots, \quad n \geq 0,$$

$$H_n(z) := \frac{E'_{n+1}(z)}{n+1} = \frac{a_{2,n}}{z^2} + \frac{a_{3,n}}{z^3} + \cdots, \quad n \geq 0.$$

One can verify, see e.g. [15, Lemma 2.1], that

$$H_n \in A^2(\Omega), \quad n \geq 0.$$

Lemma 3.1. *Suppose that L is rectifiable. For integers $n \geq 0$ and $m \geq -1$, we have*

$$(3.4) \quad \int_L \phi^m(z) \phi'(z) \overline{E_n(z)} \, dz = 0.$$

This is one of three identities stated in Lemma 2.2 of [15]. We quickly verify its validity.

By (3.1), we have $\lim_{z \rightarrow \infty} \phi(z)E_n(z) = \gamma c_{n,1} \in \mathbb{C}$, so that we can write $E_n(z) = \phi(z)^{-1}E_n^*(z)$, with $E_n^*(z)$ analytic in Ω and continuous on $\bar{\Omega}$. Making the change of variables $z = \psi(w)$ (recall that ψ is the inverse of ϕ) and using that $w = 1/\bar{w}$ for w on the unit circle, we get

$$\int_L \phi(z)^m \phi'(z) \overline{E_n(z)} dz = \int_{|w|=1} w^{m+1} \overline{E_n^*(\psi(1/\bar{w}))} dw.$$

The function $\overline{E_n^*(\psi(1/\bar{w}))}$ is analytic in the unit disk $\mathbb{D}(0,1)$ and continuous on $\overline{\mathbb{D}(0,1)}$. It follows from Cauchy's theorem that the latter integral equals zero, completing the proof of (3.4).

Let us now define the polynomial

$$q_{n-1}(z) := G_n(z) - \frac{\gamma^{n+1}}{\lambda_n} p_n(z), \quad n \geq 0.$$

Note that $q_{-1} \equiv 0$ and that q_{n-1} is a polynomial of degree $\leq n-1$ for all $n \geq 1$. We also define, for a rectifiable L , the quantities

$$(3.5) \quad \beta_{k,n} := -\frac{1}{2\pi i} \int_L q_{k-1}(z) \overline{E_{n+1}(z)} dz, \quad k \geq n \geq 0,$$

and

$$(3.6) \quad \varepsilon_{k,n} := -\frac{1}{2\pi i} \int_L H_k(z) \overline{E_{n+1}(z)} dz, \quad k \geq n \geq 0.$$

Using the complex version of Green's formula in the domain Ω (see the proof of Lemma 2.3 of [15]), one finds the alternative expression

$$(3.7) \quad \varepsilon_{k,n} = (n+1) \int_{\Omega} H_k(z) \overline{H_n(z)} dA(z).$$

In particular,

$$(3.8) \quad \varepsilon_{n,n} = (n+1) \|H_n\|_{L^2(\Omega)}^2.$$

One can also verify without much difficulty that

$$(3.9) \quad \varepsilon_{n,n} = 1 - (n+1) \|G_n\|_{L^2(D)}^2.$$

It was also proved in [15, Eq. (2.22)] that

$$(3.10) \quad \beta_{n,n} = (n+1) \|q_{n-1}\|_{L^2(D)}^2.$$

Let us now define, for integers $n, k \geq 0$, the quantities

$$(3.11) \quad \alpha_{n,k} := -\frac{1}{2\pi i} \int_L p_k(\zeta) \phi(\zeta)^{-n-1} d\zeta.$$

By an application of Cauchy's theorem, it readily follows that

$$(3.12) \quad \alpha_{n,k} = \begin{cases} 0, & 0 \leq k < n, \\ \lambda_n / \gamma^{n+1}, & k = n. \end{cases}$$

Lemma 3.2. *If L is rectifiable, then we have*

$$(3.13) \quad \frac{\gamma^{n+1}}{\lambda_n} \overline{\alpha_{n,n}} = (n+1) \frac{\gamma^{2(n+1)}}{\gamma_n^2} + \beta_{n,n} + \varepsilon_{n,n}, \quad n \geq 0,$$

$$(3.14) \quad \frac{\gamma^{k+1}}{\lambda_k} \overline{\alpha_{n,k}} = \beta_{k,n} + \varepsilon_{k,n}, \quad k > n \geq 0.$$

Proof. We assume throughout the proof that $k \geq n \geq 0$. We have

$$(3.15) \quad \begin{aligned} \overline{\alpha_{n,k}} &= \frac{1}{2\pi i} \int_L p_k(\zeta) \overline{F_{n+1}(\zeta)} d\zeta + \frac{1}{2\pi i} \int_L p_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta \\ &= \int_D p_k(z) \overline{F'_{n+1}(z)} dA(z) + \frac{1}{2\pi i} \int_L p_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta \\ &= (n+1) \int_D p_k(z) \overline{G_n(z)} dA(z) + \frac{1}{2\pi i} \int_L p_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta. \end{aligned}$$

By the orthonormality property of the polynomials p_n , we have

$$\int_D p_k(z) \overline{G_n(z)} dA(z) = \begin{cases} \gamma^{n+1} / \lambda_n, & k = n, \\ 0, & k > n. \end{cases}$$

It follows from the latter equality and (3.15) that

$$\frac{\gamma^{k+1}}{\lambda_k} \overline{\alpha_{n,k}} = \frac{\gamma^{k+1}}{\lambda_k} \cdot \frac{1}{2\pi i} \int_L p_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta + \begin{cases} \gamma^{2(n+1)} / \lambda_n^2, & k = n, \\ 0, & k > n. \end{cases}$$

Thus, the proof of Lemma 3.2 will be complete once we show that

$$(3.16) \quad \frac{\gamma^{k+1}}{\lambda_k} \cdot \frac{1}{2\pi i} \int_L p_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta = \beta_{k,n} + \varepsilon_{k,n}, \quad k \geq n \geq 0.$$

Making the substitution

$$\frac{\gamma^{k+1}}{\lambda_k} p_k(z) = G_k(z) - q_{k-1}(z)$$

in (3.16) yields

$$(3.17) \quad \frac{\gamma^{k+1}}{\lambda_k} \cdot \frac{1}{2\pi i} \int_L p_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta = \frac{1}{2\pi i} \int_L G_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta + \beta_{k,n}.$$

We can now use (3.2) and (3.4) to compute

$$\begin{aligned} \frac{1}{2\pi i} \int_L G_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta &= \frac{1}{2\pi i} \int_L \phi(\zeta)^k \phi'(\zeta) \overline{E_{n+1}(\zeta)} d\zeta \\ &\quad - \frac{1}{2\pi i} \int_L H_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta \\ &= - \frac{1}{2\pi i} \int_L H_k(\zeta) \overline{E_{n+1}(\zeta)} d\zeta = \varepsilon_{k,n}, \end{aligned}$$

which together with (3.17) yields (3.16), proving Lemma 3.2. $\square$

Since $\alpha_{n,n} = \lambda_n / \gamma^{n+1}$, we get from (3.13) that

$$(3.18) \quad (n+1) \frac{\gamma^{2(n+1)}}{\lambda_n^2} = 1 - (\beta_{n,n} + \varepsilon_{n,n}), \quad n \geq 0.$$

This important identity was established in [15, Lemma 2.4]. It shows that for L rectifiable,

$$(3.19) \quad \frac{\gamma^{n+1}}{\lambda_n} = \frac{1}{\alpha_{n,n}} \leq \frac{1}{\sqrt{n+1}}, \quad n \geq 0,$$

and that

$$\lim_{n \rightarrow \infty} (n+1) \frac{\gamma^{2(n+1)}}{\lambda_n^2} = 1$$

if and only if $\lim_{n \rightarrow \infty} \beta_{n,n} = \lim_{n \rightarrow \infty} \varepsilon_{n,n} = 0$.

The quantity $\varepsilon_{n,n}$ only depends on the geometry of the curve L via the exterior map ϕ , while $\beta_{n,n}$ still depends on the polynomial p_n . It turns out that if L is also a quasiconformal curve, then $\beta_{n,n}$ can be uniformly bounded by $\varepsilon_{n,n}$. This observation, made precise in our next proposition, was first realized in [15, Thm. 2.1].

A Jordan curve L is quasiconformal provided that there is a constant M such that $\text{diam } L(z, \zeta) \leq M|z - \zeta|$ for all $z, \zeta \in L$, where $L(z, \zeta)$ is the arc of L between z and ζ of smallest diameter. In particular, every piecewise analytic curve without cusps is quasiconformal. For the definition of the reflection factor κ of a quasiconformal curve and other details, see [15].

Proposition 3.3. *If L is a rectifiable quasiconformal curve, with a reflection factor of κ , then*

$$(3.20) \quad 0 \leq \beta_{n,n} \leq \frac{\kappa^2}{1 - \kappa^2} \varepsilon_{n,n}, \quad n \geq 0.$$

The proof of (3.20) (take $k = n$ in (3.25) below) is based on the following inequality taken from [15, Lemma 2.5].

Proposition 3.4. *Suppose L is quasiconformal and rectifiable, and let κ denote the reflection factor of L . For every f analytic in D and continuous on $\overline{D}$, and for every g analytic in Ω and continuous on $\overline{\Omega}$, with $g' \in A^2(\Omega)$, we have*

$$(3.21) \quad \left| \frac{1}{2i\pi} \int_L f(z) \overline{g(z)} dz \right| \leq \frac{\kappa}{\sqrt{1-\kappa^2}} \|f\|_{L^2(D)} \|g'\|_{L^2(\Omega)}.$$

We will moreover find use for the following result.

Proposition 3.5. *Suppose L is quasiconformal and rectifiable, and let κ denote the reflection factor of L . The following inequalities hold true:*

$$(3.22) \quad 0 \leq 1 - (n+1) \frac{\gamma^{2(n+1)}}{\lambda_n^2} \leq \frac{1}{1-\kappa^2} \varepsilon_{n,n}, \quad n \geq 0,$$

$$(3.23) \quad \frac{\gamma^{k+1}}{\lambda_k} |\alpha_{n,k}| \leq \frac{1}{1-\kappa^2} \sqrt{\frac{\varepsilon_{k,k}}{k+1}} \sqrt{(n+1)\varepsilon_{n,n}}, \quad k > n \geq 0.$$

Proof. The inequality (3.22) is a clear consequence of (3.18) and (3.20).

To prove (3.23), we apply the triangle inequality to (3.14) to get

$$(3.24) \quad \frac{\gamma^{k+1}}{\lambda_k} |\alpha_{n,k}| \leq |\beta_{k,n}| + |\varepsilon_{k,n}|, \quad k > n \geq 0,$$

and proceed to estimate the right-hand side of (3.24). First, we apply the inequality (3.21) to the integral that defines $\beta_{k,n}$ in (3.5) to deduce that (recall (3.8) and (3.10))

$$\begin{aligned} |\beta_{k,n}| &= \left| \frac{1}{2\pi i} \int_L q_{k-1}(\zeta) \overline{E_{n+1}(\zeta)} d\zeta \right| \\ &\leq \frac{\kappa}{\sqrt{1-\kappa^2}} \|q_{k-1}\|_{L^2(\Omega)} (n+1) \|H_{n+1}\|_{L^2(D)} \\ &\leq \frac{\kappa}{\sqrt{1-\kappa^2}} \sqrt{\frac{\beta_{k,k}}{k+1}} \sqrt{(n+1)\varepsilon_{n,n}}, \end{aligned}$$

which in view of (3.20) yields

$$(3.25) \quad |\beta_{k,n}| \leq \frac{\kappa^2}{1-\kappa^2} \sqrt{\frac{\varepsilon_{k,k}}{k+1}} \sqrt{(n+1)\varepsilon_{n,n}}.$$

Next, we take absolute values in (3.7) and apply the Cauchy-Schwarz inequality to obtain

$$\begin{aligned} |\varepsilon_{k,n}| &= (n+1) \left| \int_{\Omega} H_k(z) \overline{H_n(z)} dA(z) \right| \\ (3.26) \quad &\leq (n+1) \|H_k\|_{L^2(\Omega)} \|H_{n+1}\|_{L^2(\Omega)} \\ &\leq \sqrt{\frac{\varepsilon_{k,k}}{k+1}} \sqrt{(n+1)\varepsilon_{n,n}}. \end{aligned}$$

The inequality (3.23) now follows by replacing $|\beta_{k,n}|$ and $|\varepsilon_{k,n}|$ in (3.24) by their upper bounds found in (3.25) and (3.26). $\square$

Having established (3.23), we then look for a good estimate for $\varepsilon_{n,n}$. This is provided by the following result proven in [15, Thm. 2.4].

Proposition 3.6. *If L is piecewise analytic without cusps, then there exists a constant c_1 , that depends only on L , such that*

$$\varepsilon_{n,n} \leq \frac{c_1}{n+1}, \quad n \geq 0.$$

As a consequence of Proposition 3.6, one obtains from (3.22) that

$$(3.27) \quad \alpha_{n,n} = \frac{\lambda_n}{\gamma^{n+1}} = \sqrt{n+1}(1 + O(1/n)).$$

as $n \rightarrow \infty$.

Corollary 3.7. *If L is piecewise analytic without cusps, then there exists a constant C , that depends only on L , such that*

$$(3.28) \quad |\alpha_{n,k}| \leq \frac{C}{\sqrt{k+1}}, \quad k > n \geq 0.$$

Proof. Using the estimate afforded by Proposition 3.6 on the right-hand side of (3.23), we can find a constant c_2 , depending only on L , such that

$$\frac{\gamma^{k+1}}{\lambda_k} |\alpha_{n,k}| \leq \frac{c_2}{k+1}, \quad k > n \geq 0.$$

This and (3.27) yield (3.28). $\square$

We finish this section with a lemma about the asymptotic behavior of the polynomials G_n that were introduced in (3.3). The result is a direct corollary of the asymptotic analysis carried out in [12] for the Faber polynomials associated to a domain Ω with piecewise analytic boundary.

Lemma 3.8. *Suppose that L is a piecewise analytic Jordan curve without cusps, and let $C(L)$ denote the corners of L . For every $\epsilon > 0$, there exists a constant m_ϵ such that*

$$\left| \frac{G_n(z)}{\phi'(z)\phi(z)^n} - 1 \right| \leq \frac{m_\epsilon}{n+1}, \quad z \in \mathcal{E}_\epsilon, \quad n \geq 0,$$

where $\mathcal{E}_\epsilon := \{z \in \Omega : d_{\mathbb{C}}(z, C(L)) > \epsilon\}$.

Proof. In [12], fine asymptotic formulas were derived for the Faber polynomials F_n associated to a domain Ω whose boundary L is a piecewise analytic curve without inner cusps (L not necessarily a Jordan curve). This is a more general assumption than the one we make in Lemma 3.8. Let $\lambda\pi \in (0, 2\pi)$ be the smallest of the exterior angles formed at the corners of L . Since $\bar{\mathcal{E}}_\epsilon$ is a closed subset of $\bar{\Omega} \setminus C(L)$, Theorem 2.4 of [12] implies that there exists an open set $U \supset \bar{\mathcal{E}}_\epsilon$ such that ϕ extends as a univalent function to U , and

$$F_{n+1}(z) = \phi(z)^{n+1} + O(n^{-\lambda}), \quad z \in U, \quad n \geq 1,$$

uniformly on closed subsets of U . By differentiating this relation, we find that

$$\frac{G_n(z)}{\phi'(z)\phi(z)^n} = \frac{F'_{n+1}(z)}{(n+1)\phi'(z)\phi(z)^n} = 1 + O(n^{-\lambda-1}|\phi(z)|^{-n}), \quad n \geq 1,$$

uniformly on closed subsets of U , and the lemma follows since $|\phi(z)| > 1$ for $z \in \mathcal{E}_\epsilon$. $\square$

4 PROOF OF THE ASYMPTOTIC RESULTS.

4.1 Proof of Proposition 2.1.

The inequality (2.1) is essentially contained in the proof of Theorem 1.1 of [1], but the authors restrict attention to the exterior asymptotics away from the boundary. To obtain Proposition 2.1 we only need to go through their proof, paying attention to precisely how their bounds degenerate as we approach $\partial\Omega$.

In terms of the polynomials G_n introduced in (3.3), the function $A_n(z)$ can be expressed as

$$\begin{aligned} A_n(z) &= \left(\frac{G_n(z)}{\phi'(z)\phi(z)^n} - 1 \right) + \frac{p_n(z) - \sqrt{n+1}G_n(z)}{\sqrt{n+1}\phi'(z)\phi(z)^n} \\ &=: A_n^1(z) + A_n^2(z). \end{aligned}$$

This is the same as [1, Eq. (4.1)], if we take into account that we are using a different normalization of the area measure, and that the functions f_n in [1] are precisely defined as

$$f_n(z) := \frac{F'_{n+1}(z)}{\sqrt{\pi(n+1)}} = \sqrt{\frac{n+1}{\pi}} G_n(z).$$

Let us fix $\epsilon > 0$ and let $\mathcal{E}_\epsilon = \{z \in \Omega : d_{\mathbb{C}}(z, C(L)) > \epsilon\}$. By Lemma 3.8, there exists a constant m_ϵ such that

$$(4.1) \quad |A_n^1(z)| \leq \frac{m_\epsilon}{n+1}, \quad z \in \mathcal{E}_\epsilon, \quad n \geq 0.$$

In particular, this implies that

$$(4.2) \quad \left| \frac{G_n(z)}{\phi'(z)\phi(z)^n} \right| \leq 1 + m_\epsilon, \quad z \in \mathcal{E}_\epsilon, \quad n \geq 0.$$

In view of the inequality (2.14) of [1] and the one preceding (4.3) therein, we have the bound

$$(4.3) \quad |A_n^2(z)| \leq c_2 \frac{\sqrt{\varepsilon_{n,n}}}{\sqrt{n+1}} \sum_{j=0}^n \sqrt{\varepsilon_{j,j}} \sqrt{j+1} |\phi(z)|^{j-n} \left| \frac{G_j(z)}{\phi'(z)\phi(z)^j} \right|, \quad z \in \Omega,$$

where c_2 is a certain constant, and the numbers $\varepsilon_{n,n}$ are those previously introduced in (3.6) ($\varepsilon_{n,n}$ is called ε_n in [1] and defined by the alternative expression (3.9)).

Since L is piecewise analytic without cusps, we have in view of Proposition 3.6 (see also [1, Eq. (1.12)]) that $\varepsilon_{n,n} \leq c_1(n+1)^{-1}$ for some constant c_1 independent of n . Incorporating this and (4.2) into (4.3), we find

$$|A_n^2(z)| \leq \frac{c_1 c_2 (1 + m_\epsilon)}{n+1} \sum_{j=0}^n |\phi(z)|^{j-n}, \quad z \in \mathcal{E}_\epsilon, \quad n \geq 0,$$

which together with (4.1) yields

$$|A_n^1(z)| + |A_n^2(z)| \leq \frac{(m_\epsilon + c_1 c_2 (1 + m_\epsilon)) |\phi(z)|}{(n+1)(|\phi(z)| - 1)}, \quad z \in \mathcal{E}_\epsilon, \quad n \geq 0,$$

completing the proof of Proposition 2.1.

4.2 Proof of Theorem 2.2.

The Bergman kernel of $A^2(D)$ is the function $K(z, \zeta)$ on $D \times D$ which is analytic in z and conjugate-analytic in ζ , with finite norm

$$\int_D |K(z, \zeta)|^2 dA(\zeta) < \infty, \quad z \in D,$$

and such that for any $f \in A^2(D)$, the reproducing property holds:

$$f(z) = \int_D f(\zeta) K(z, \zeta) dA(\zeta).$$

This kernel can be expressed in terms of the conformal map φ of D onto $\mathbb{D}(0, 1)$ by the formula

$$K(z, \zeta) = \frac{\varphi'(z) \overline{\varphi'(\zeta)}}{(1 - \varphi(z) \overline{\varphi(\zeta)})^2}.$$

It is well-known that the polynomials are dense in $A^2(D)$, and therefore

$$(4.4) \quad \frac{\varphi'(z) \overline{\varphi'(\zeta)}}{(1 - \varphi(z) \overline{\varphi(\zeta)})^2} = \sum_{k=0}^{\infty} \overline{p_k(\zeta)} p_k(z), \quad z, \zeta \in D.$$

Here it is important to know that this equality actually holds in a bigger domain. Indeed, for $\zeta \in D$ fixed, we can easily see that $K(z, \zeta)$ is analytic in the variable z in some open set that contains $\overline{D}$. Let $\tau(\zeta) < 1$ be the smallest number such that $K(\cdot, \zeta)$ is analytic in the domain $\mathcal{D}_{1/\tau(\zeta)}$ (the sets $\mathcal{D}_r$ were previously defined in Subsection 2.2). Then (4.4) holds for all $\zeta \in D$ and $z \in \mathcal{D}_{1/\tau(\zeta)}$. Moreover, for $\zeta \in D$ fixed, the convergence is uniform for z on compact subsets of $\mathcal{D}_{1/\tau(\zeta)}$. We also have

$$(4.5) \quad \limsup_{n \rightarrow \infty} |p_n(\zeta)|^{1/n} = \tau(\zeta) < 1, \quad \zeta \in D.$$

These stronger statements follow from the overconvergence results of Walsh, see [17, pp. 130-131] (see also [13, p. 336]).

By the Hermitian symmetry of the kernel, for $z \in D$ fixed, we have uniform convergence in (4.4) for $\zeta \in L$. We then multiply (4.4) by

$$\frac{\phi(\zeta)^{n+1} \varphi'(\zeta) d\zeta}{\overline{\varphi'(\zeta)} \varphi(\zeta)^2}$$

and integrate with respect to ζ over $L = \partial D$ to get (bearing in mind that when $\zeta \in L$, we have $\overline{\varphi(\zeta)} = 1/\varphi(\zeta)$)

$$(4.6) \quad \frac{\varphi'(z)}{2\pi i} \int_L \frac{\varphi'(\zeta) \phi(\zeta)^{n+1}}{(\varphi(\zeta) - \varphi(z))^2} d\zeta = \sum_{k=0}^{\infty} \frac{p_k(z)}{2\pi i} \int_L \frac{\overline{p_k(\zeta)} \phi(\zeta)^{n+1} \varphi'(\zeta) d\zeta}{\overline{\varphi'(\zeta)} \varphi(\zeta)^2}, \quad z \in D.$$

Now we note that

$$d\overline{\zeta} = -\frac{\varphi'(\zeta) d\zeta}{\overline{\varphi'(\zeta)} \varphi(\zeta)^2},$$

meaning that for every function f continuous on L ,

$$\overline{\int_L f(\zeta) d\zeta} = \int_L \overline{f(\zeta)} \underbrace{\left(-\frac{\varphi'(\zeta) d\zeta}{\overline{\varphi'(\zeta)} \varphi(\zeta)^2} \right)}_{“d\overline{\zeta}”}.$$

We then integrate by parts on the left-hand side of (4.6) to get

$$\frac{\varphi'(z)(n+1)}{2\pi i} \int_L \frac{\phi'(\zeta) \phi(\zeta)^n}{\varphi(\zeta) - \varphi(z)} d\zeta = \sum_{k=0}^{\infty} \alpha_{n,k} p_k(z), \quad z \in D,$$

where

$$\alpha_{n,k} = -\frac{1}{2\pi i} \int_L \overline{p_k(\zeta)} \phi(\zeta)^{n+1} d\overline{\zeta} = -\frac{1}{2\pi i} \overline{\int_L p_k(\zeta) \phi(\zeta)^{-n-1} d\zeta}.$$

The coefficients $\alpha_{n,k}$ are the same quantities previously introduced in (3.11). From (3.19) and (3.28), we know that

$$(4.7) \quad \frac{1}{\alpha_{n,n}} \leq \frac{1}{\sqrt{n+1}}, \quad |\alpha_{n,k}| \leq \frac{C}{\sqrt{k+1}}, \quad k > n \geq 0,$$

where C is a constant independent of k and n . We have also seen in (3.12) that $\alpha_{n,k} = 0$ for $0 \leq k < n$, so that we can write

$$(4.8) \quad \alpha_{n,n} p_n(z) = Q_n(z) - \sum_{k=n+1}^{\infty} \alpha_{n,k} p_k(z),$$

with $Q_n(z)$ as defined in (2.2).

The identity (4.8) is similar to the identity (6.5) obtained in [11] for polynomials orthogonal with weights on the unit disk. The remaining part of the proof is essentially a repetition of the steps carried out in the proofs of Lemmas 6.1 and 6.2 of [11], but we will quickly summarize them for the sake of keeping the presentation self-contained.

The idea is to iterate (4.8) to eliminate the polynomials p_k for all $k \geq n+1$, and end up with the right-hand side of (4.8) written as a series in the Q_n 's. The identity (4.8) for $n+1$ in place of n reads

$$(4.9) \quad p_{n+1}(z) = \frac{1}{\alpha_{n+1,n+1}} Q_{n+1}(z) - \frac{1}{\alpha_{n+1,n+1}} \sum_{k=n+2}^{\infty} \alpha_{n+1,k} p_k(z).$$

If we now substitute the right-hand side of (4.9) for p_{n+1} in the series of (4.8), we get a new series where the only polynomials p_k that remain are those of degree $k \geq n+2$. Repeating this process m times, we obtain (cf. Lemma 6.1 of [11])

$$(4.10) \quad \alpha_{n,n} p_n(z) = \sum_{j=0}^m h(n,j) Q_{n+j}(z) + \sum_{k=n+m+1}^{\infty} g(n,m,k) p_k(z),$$

where the coefficients $h(n,j)$ and $g(n,m,k)$ are recursively defined by the relations

$$(4.11) \quad h(n,0) = 1, \quad g(n,0,k) = -\alpha_{n,k}, \quad k > n \geq 0,$$

$$(4.12) \quad h(n,m+1) = \frac{g(n,m,n+m+1)}{\alpha_{n+m+1,n+m+1}},$$

and

$$(4.13) \quad g(n,m+1,k) = g(n,m,k) - h(n,m+1) \alpha_{n+m+1,k}, \quad k \geq n+m+2.$$

Combining (4.11), (4.12), and (4.13) with (4.7) we find

$$(4.14) \quad h(n, 0) = 1, \quad |g(n, 0, k)| \leq \frac{C}{\sqrt{k+1}}, \quad k \geq n+1,$$

$$(4.15) \quad |h(n, m+1)| \leq \frac{|g(n, m, n+m+1)|}{\sqrt{n+m+2}},$$

$$(4.16) \quad |g(n, m+1, k)| \leq |g(n, m, k)| + \frac{C}{\sqrt{k+1}} |h(n, m+1)|,$$

with the inequality (4.16) being valid for $k \geq n+m+2$.

By induction in the second variable m , we get from (4.14), (4.15) and (4.16) that (c.f. Lemma 6.2 of [11] and its proof)

$$(4.17) \quad |h(n, j)| \leq \frac{C}{n+j+1} \prod_{\ell=1}^{j-1} \left(1 + \frac{C}{n+\ell}\right), \quad j \geq 1,$$

$$(4.18) \quad |g(n, m, k)| \leq \frac{C}{\sqrt{k+1}} \prod_{\ell=1}^m \left(1 + \frac{C}{n+\ell}\right), \quad m \geq 0, \quad k \geq n+m+1.$$

We now write

$$(4.19) \quad \begin{aligned} \prod_{\ell=1}^m \left(1 + \frac{C}{n+\ell}\right) &= \exp \left(\sum_{\ell=1}^m \log \left(1 + \frac{C}{n+\ell}\right) \right) \\ &\leq \exp \left(\sum_{\ell=1}^m \frac{C}{n+\ell} \right) = \left(1 + \frac{m}{n+1}\right)^C \exp(C \varrho_{n,m}) \\ &< e^C \left(1 + \frac{m}{n+1}\right)^C, \end{aligned}$$

where

$$\varrho_{n,m} = \left(\sum_{k=1}^{n+m} \frac{1}{k} - \log(n+m+1) \right) - \left(\sum_{k=1}^n \frac{1}{k} - \log(n+1) \right) < 1.$$

Replacing the product in (4.17) by the estimate (4.19) (with $m = j-1$) readily yields (2.4) with the choice of $B = Ce^C$. Similarly, applying (4.19) to (4.18) we obtain

$$(4.20) \quad |g(n, m, k)| \leq \frac{B}{\sqrt{k}} \left(1 + \frac{m}{n}\right)^B, \quad m \geq 0, \quad k \geq n+m+1.$$

To finish the proof of Lemma 2.3 we just need to show that the second series in (4.10) converges to zero as $m \rightarrow \infty$ for $z \in D$. Let us then think of $z \in D$ as being fixed. Since

$$\tau(z) = \limsup_{k \rightarrow \infty} |p_k(z)|^{1/k} < 1,$$

we can find $\epsilon > 0$ and a constant M_ϵ such that $\tau(z) + \epsilon < 1$ and $|p_k(z)| \leq M_\epsilon(\tau(z) + \epsilon)^k$ for all $k \geq 0$. This together with (4.20) imply that

$$\begin{aligned} \sum_{k=n+m+1}^{\infty} |g(n, m, k)p_k(z)| &\leq M_\epsilon B \left(1 + \frac{m}{n}\right)^B \sum_{k=n+m+1}^{\infty} \frac{(\tau(z) + \epsilon)^k}{\sqrt{k}} \\ &\leq \frac{M_\epsilon B (\tau(z) + \epsilon)^{n+1}}{\sqrt{n+m+1}(1 - (\tau(z) + \epsilon))} \left(1 + \frac{m}{n}\right)^B (\tau(z) + \epsilon)^m. \end{aligned}$$

In view of the convergence

$$\lim_{m \rightarrow \infty} \left(1 + \frac{m}{n}\right)^B (\tau(z) + \epsilon)^m = 0,$$

we conclude that for $z \in D$, we have

$$\lim_{m \rightarrow \infty} \sum_{k=n+m+1}^{\infty} g(n, m, k)p_k(z) = 0,$$

as desired.

4.3 Proof of Theorem 2.3.

We begin by making the change of variable $\zeta = \psi(w)$ in the integral on the right-hand side of (2.2). This yields

$$(4.21) \quad Q_n(z) = \frac{(n+1)\varphi'(z)}{2\pi i} \int_{|w|=1} \frac{w^n}{f_z(w)} dw, \quad z \in D.$$

We will use (2.3) to derive the behavior of p_n as $n \rightarrow \infty$ from that of Q_n . Broadly speaking, the dominant behavior of the integral in (4.21) is found by computing the residues of its integrand at the zeros of $f_z(w)$ of largest modulus.

We recall that $z \in D_p$ means that among the zeros of the meromorphic function

$$f_z(w) := h(w) - \varphi(z)$$

in $\mu < |w| < 1$, those of largest modulus, say $w_{z,1}, \dots, w_{z,s}$, have a total multiplicity of p . That is, if $m_{z,k}$ denotes the multiplicity of h at $w_{z,k}$, then $\sum_{k=1}^s m_{z,k} = p$.

The following lemma is proven by a standard application of Rouché's theorem. It is practically a repetition of Lemma 11 of [4].

Lemma 4.1. *Let $z_0 \in D_p$ be fixed, and let μ_0 be chosen in the range $\mu < \mu_0 < r(z_0)$ such that the only zeros of $f_{z_0}(w)$ in the region $\mu_0 \leq |w| < 1$ are precisely those of largest modulus $w_{z_0,1}, \dots, w_{z_0,s}$, $1 \leq s \leq p$. Let $\delta > 0$ be small enough*

that the closed disks $\overline{\mathbb{D}(w_{z_0,k}, \delta)}$, $1 \leq k \leq s$, are pairwise disjoint, contained in the annulus $\mu_0 < |w| < 1$, and such that $h'(w) \neq 0$ whenever $0 < |w - w_{z_0,k}| \leq \delta$ for some $1 \leq k \leq s$. Then there exists $\epsilon > 0$ such that $\overline{\mathbb{D}(z_0, \epsilon)} \subset D$ and for every $z \in \mathbb{D}(z_0, \epsilon)$, the zeros of $f_z(w)$ that lie in $\mu_0 < |w| < 1$ are all simple and contained in $\cup_{k=1}^s \mathbb{D}(w_{z_0,k}, \delta)$, with each disk $\mathbb{D}(w_{z_0,k}, \delta)$ containing a number $m_{z_0,k}$ of them.

It is easy to conclude from Lemma 4.1 (c.f. Corollary 12 in [11]) that D_1 and $D \setminus D_0$ are open, that $\phi_1(z) := w_{z,1}$ is univalent on D_1 , and that $r(z)$ is continuous on D .

In order to prove Theorem 2.3, it suffices to show that every $z_0 \in D_1$ has a neighborhood $\mathbb{D}(z_0, \epsilon)$ such that $A_n(z) = O(n^{-1})$ uniformly for $z \in \mathbb{D}(z_0, \epsilon)$ as $n \rightarrow \infty$. We then fix $z_0 \in D_1$ and pick δ and ϵ as specified in Lemma 4.1 with the choice $p = 1$. In particular, we have

$$(4.22) \quad \mu_0 < |\phi_1(z_0)| - \delta < |\phi_1(z)| < |\phi_1(z_0)| + \delta < 1, \quad z \in \mathbb{D}(z_0, \epsilon).$$

For every $z \in \mathbb{D}(z_0, \epsilon)$, the function $f_z(w)$ has a single zero in $\mu_0 \leq |w| \leq 1$, say $w_{z,1} = \phi_1(z)$, which is simple and contained in $\mathbb{D}(w_{z_0,1}, \delta)$. It follows that the integrand in (4.21) has a simple pole at $w_{z,1}$ and is analytic at any other point of the annulus $\mu_0 \leq |w| \leq 1$. We can then apply the residue theorem to deduce that for all $z \in \mathbb{D}(z_0, \epsilon)$,

$$(4.23) \quad Q_n(z) = (n+1)\varphi'(z) \frac{\phi_1(z)^n}{f'_z(\phi_1(z))} + \frac{(n+1)\varphi'(z)}{2\pi i} \int_{|w|=\mu_0} \frac{w^n}{f_z(w)} dw.$$

The fact that $\phi_1(z)$ is a zero of $f_z(w)$ means that $h(\phi_1(z)) = \varphi(z)$. By differentiating this identity we obtain

$$(4.24) \quad f'_z(\phi_1(z)) = h'(\phi_1(z)) = \frac{\varphi'(z)}{\phi'_1(z)}, \quad z \in \mathbb{D}(z_0, \epsilon).$$

Since $|h(w) - \varphi(z)| : \mathbb{T}(0, \mu_0) \times \overline{\mathbb{D}(z_0, \epsilon)} \rightarrow (0, \infty]$ is continuous in (w, z) and never vanishes, and since $|\varphi'|$ is bounded on $\overline{\mathbb{D}(z_0, \epsilon)}$, we deduce from (4.23) and (4.24) that

$$(4.25) \quad Q_n(z) = (n+1)\phi'_1(z)\phi_1(z)^n + O((n+1)\mu_0^n), \quad z \in \mathbb{D}(z_0, \epsilon),$$

with the constant involved in the O -term being independent of n and z . We now combine (4.25) with (2.3) and (3.27) to find

$$(4.26) \quad \begin{aligned} A_n(z) &= \frac{1 + O(1/n)}{n+1} \sum_{j=1}^{\infty} h(n, j)(n+j+1)\phi_1(z)^j \\ &\quad + O\left(\tau_0^n \sum_{j=0}^{\infty} \frac{h(n, j)(n+j+1)}{n+1} \mu_0^j\right) + O(1/n) \end{aligned}$$

uniformly for $z \in \mathbb{D}(z_0, \epsilon)$ as $n \rightarrow \infty$, where $\tau_0 = \mu_0/(|\phi_1(z_0)| - \delta) < 1$.

By (2.4), we have that if $|\zeta| < 1$, then

$$\begin{aligned} \sum_{j=1}^{\infty} |h(n, j)|(n+j+1)|\zeta|^j &\leq B \sum_{j=1}^{\infty} \left(1 + \frac{j-1}{n}\right)^B |\zeta|^j \\ &\leq B2^B \left(\sum_{j=1}^{\infty} |\zeta|^j + \sum_{j=1}^{\infty} \left(\frac{j-1}{n}\right)^B |\zeta|^j \right) \\ &\leq \frac{B2^B}{1-|\zeta|} + \frac{B2^B}{n^B} \sum_{k=0}^{\infty} k^B |\zeta|^k. \end{aligned}$$

By increasing B if necessary, we may assume that B is a positive integer. Making use of the identity

$$\sum_{k=0}^{\infty} (k+1) \cdots (k+B) \zeta^k = \left(\frac{\zeta^B}{1-\zeta} \right)^{(B)},$$

one easily verifies that

$$\sum_{k=0}^{\infty} (k+1) \cdots (k+B) |\zeta|^k \leq \frac{E}{(1-|\zeta|)^{B+1}}, \quad |\zeta| < 1,$$

for some constant E that only depends on B . Therefore,

$$(4.27) \quad \sum_{j=1}^{\infty} \frac{|h(n, j)|(n+j+1)}{n+1} |\zeta|^j \leq \frac{E_1}{n(1-|\zeta|)} + \frac{E_1}{n^{B_1}(1-|\zeta|)^{B_1}},$$

with $E_1 = B2^B E$ and $B_1 = B+1$. Since $\mu_0 < 1$ and $|\phi_1(z)| < 1$ for $\zeta \in D_1$, we can use (4.22) and (4.27) to estimate the right-hand side of (4.26) and conclude that $A_n(z) = O(n^{-1})$ uniformly for $z \in \mathbb{D}(z_0, \epsilon)$ as $n \rightarrow \infty$.

It remains to prove (2.7). Fix $z \in D$. By the very definition of $r(z)$ in (2.5), the function $1/f_z(w)$ is analytic in the annulus $r(z) < |w| < 1$, with a singularity on the circle $|w| = r(z)$ in case $r(z) > 0$. We then look at its Laurent expansion

$$\frac{1}{f_z(w)} = \sum_{k=-\infty}^{\infty} a_k(z) w^k, \quad r(z) < |w| < 1,$$

whose coefficients

$$a_{-n}(z) = \frac{1}{2\pi i} \int_{|w|=1} \frac{w^{n-1}}{f_z(w)} dw, \quad n \geq 0,$$

satisfy

$$\limsup_{n \rightarrow \infty} |a_{-n}(z)|^{1/n} = r(z).$$

By (4.21), we have

$$\limsup_{n \rightarrow \infty} |Q_n(z)|^{1/n} = r(z).$$

Let $\tau(z) = \limsup_{n \rightarrow \infty} |p_n(z)|^{1/n} < 1$ (recall (4.5)). We need to show that $\tau(z) = r(z)$, or equivalently, that for every $\epsilon > 0$,

$$(4.28) \quad r(z) - \epsilon \leq \tau(z) \leq r(z) + \epsilon.$$

Let N_ϵ be an index such that

$$|Q_n(z)|^{1/n} \leq r(z) + \epsilon < 1, \quad |p_n(z)|^{1/n} < \tau(z) + \epsilon < 1,$$

for all $n > N_\epsilon$. Combining (2.3), (3.19), and (4.27), we find that for all $n > N_\epsilon$,

$$\begin{aligned} |p_n(z)| &\leq \frac{1}{\sqrt{n+1}} \sum_{j=0}^{\infty} |h(n, j)| |Q_{n+j}(z)| \\ &\leq \frac{(r(z) + \epsilon)^n}{\sqrt{n+1}} (1 + O(1/n)), \end{aligned}$$

which yields the second inequality in (4.28). Similarly, we use (4.8), (4.7), and (3.27) to find that for all $n > N_\epsilon$,

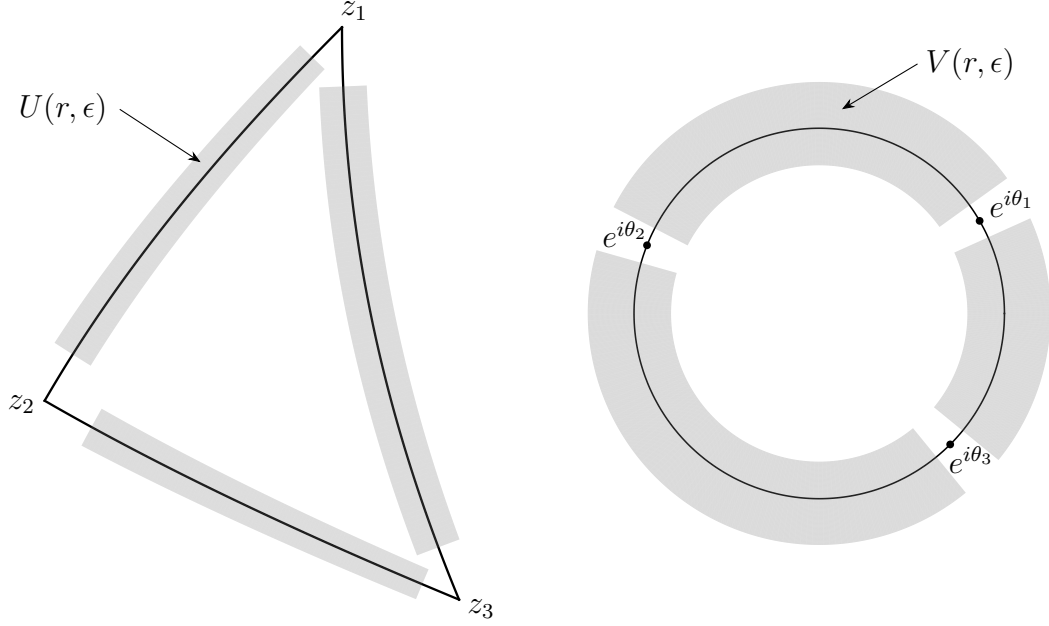
$$\begin{aligned} |Q_n(z)| &\leq \alpha_{n,n} |p_n(z)| + \sum_{k=n+1}^{\infty} |\alpha_{n,k}| |p_k(z)| \\ &\leq \sqrt{n+1} (\tau(z) + \epsilon)^n (1 + O(1/n)), \end{aligned}$$

which yields the first inequality in (4.28).

4.4 Interior asymptotic estimates near L .

Let us denote the corners of L by $z_1, \dots, z_q$. Since ϕ takes L onto the unit circle, we can write $\phi(z_k) = e^{i\theta_k}$, with $\theta_k \in [0, 2\pi)$, $1 \leq k \leq q$. For $\epsilon > 0$ small enough to ensure that, for all $1 \leq k \leq q$,

$$(4.29) \quad \{e^{i\theta} : \theta_k - \epsilon \leq \theta \leq \theta_k + \epsilon\} \cap \{e^{i\theta_1}, \dots, e^{i\theta_q}\} = \{e^{i\theta_k}\},$$

and for every $0 < r < 1$, we define

$$(4.30) \quad V(r, \epsilon) := \bigcap_{k=1}^q \left\{ te^{i\theta} : r < t < \frac{1}{r}, \theta_k + \epsilon < \theta < \theta_k - \epsilon + 2\pi \right\},$$

$$(4.31) \quad V_-(r, \epsilon) := V(r, \epsilon) \cap \mathbb{D}(0, 1), \quad V_+(r, \epsilon) := V(r, \epsilon) \cap \Delta(0, 1).$$

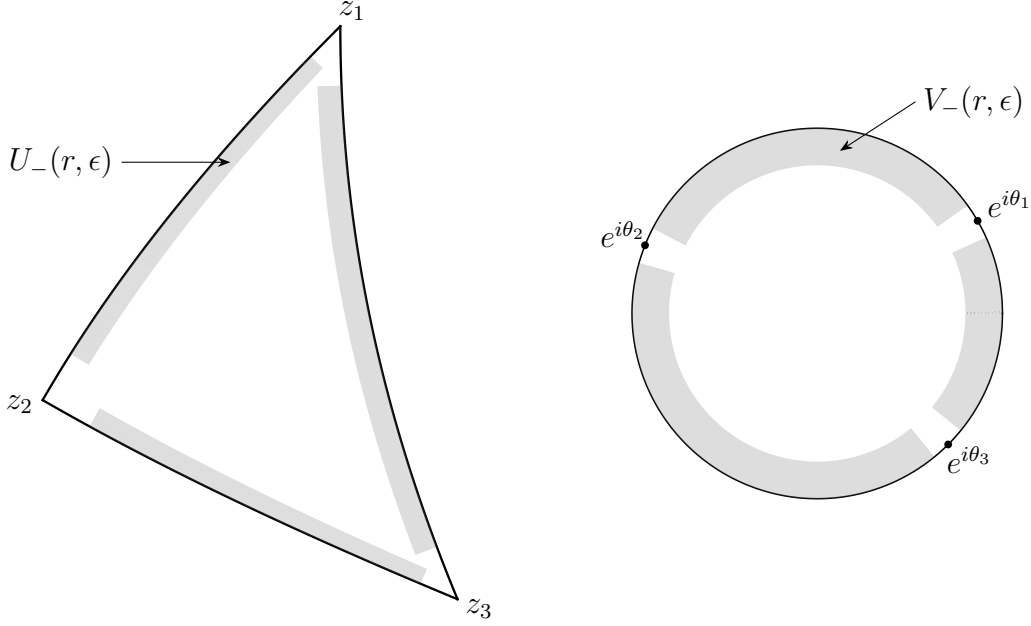
Note that $V(r, \epsilon)$ is its own reflection about the unit circle. Because L is piecewise analytic, the reflection principle (see e.g. [3, Ch. 8]) allows us to find $0 < r_\epsilon < 1$ such that the map ψ has a conformal extension to $\Delta(0, 1) \cup V(r_\epsilon, \epsilon)$, which we also denote by ψ . Then for all $r_\epsilon \leq r < 1$, we set

$$(4.32) \quad U(r, \epsilon) := \psi(V(r, \epsilon)), \quad U_\pm(r, \epsilon) := \psi(V_\pm(r, \epsilon)),$$

see Figures 2 and 3. The inverse of ψ is the conformal extension of ϕ to $\Omega \cup U(r_\epsilon, \epsilon)$, which we also denote by ϕ .

Proposition 4.2. *For every $\epsilon > 0$ satisfying (4.29), there exists $r_\epsilon < r_0 < 1$ such that:*

- (1) $U_-(r_0, \epsilon) \subset D_1$ and $\phi_1(z) = \phi(z)$ for all $z \in U_-(r_0, \epsilon)$.

(2) *There exists positive constants $M_1 > 0$ and $B_1 > 1$, with B_1 independent of ϵ and r_0 , such that*

$$(4.33) \quad |A_n(z)| \leq \frac{M_1}{n(1 - |\phi_1(z)|)} + \frac{M_1}{n^{B_1}(1 - |\phi_1(z)|)^{B_1}}$$

for all $z \in U_-(r_0, \epsilon)$ and $n \geq 1$.

Proof. Recall that the function $h(w)$ is the meromorphic extension to the annulus $\mu < |w| < 1/\mu$ of the homeomorphism of the unit disk $\varphi \circ \psi : \mathbb{T}(0, 1) \rightarrow \mathbb{T}(0, 1)$. Since φ is analytic on $\overline{D}$, we can choose $0 < \rho < 1$ sufficiently close to 1 so that φ extends analytically to the interior domain of the level curve $L_{1/\rho} = \{z \in \mathbb{C} : |\phi(z)| = 1/\rho\}$ without ever attaining the value 0 in said domain. Then

$$h(w) = \varphi(\psi(w)), \quad 1 \leq |w| < 1/\rho,$$

and by the reflection principle, $h(w)$ is also analytic in $\rho < |z| < 1/\rho$. Let us fix $\epsilon > 0$ satisfying (4.29), and let $\epsilon' := \epsilon/2$. We choose $r_{\epsilon'} < r' < 1$ such that $r' > \rho$. By the reflection principle, the map φ is conformal on $D \cup U(r', \epsilon')$, so that the composite $\varphi(\psi(w))$ (which then coincides with $h(w)$) is univalent on $V(r', \epsilon')$.

We now pick r_0 such that $r' < 2r_0 - 1 < 1$, and observe that for any such choice, we have $\overline{U(r_0, \epsilon)} \subset U(r', \epsilon')$, and since ϕ and φ are conformal on $U(r', \epsilon')$,

then

$$(4.34) \quad \beta_0 := \max \left\{ |\varphi'(z)|/|\phi'(z)| : z \in \overline{U_-(r_0, \epsilon)} \right\} < \infty.$$

We claim that if r_0 is sufficiently close to 1, then for all $z \in \overline{U_-(r_0, \epsilon)}$, the equation $h(w) - \varphi(z) = 0$ has at most one solution in $2r_0 - 1 \leq |w| \leq 1$. For otherwise, we are able to find a sequence $r_n \nearrow 1$ and a corresponding sequence of points $z_n \in \overline{U_-(r_n, \epsilon)}$, such that $z_n = h(w_{n,1}) = h(w_{n,2})$, where $w_{n,1}$ and $w_{n,2}$ are two distinct points of the annulus $2r_n - 1 \leq |w| \leq 1$.

Since $h(w) = \varphi(\psi(w))$ on $V(r', \epsilon')$, and since $\overline{U_-(r_n, \epsilon)} \subset U(r', \epsilon')$, we may assume that one of these solutions, say $w_{n,1}$, is $\phi(z_n)$, which lies in $\overline{V_-(r_n, \epsilon)}$. Therefore, there exists n_0 such that

$$w_{n,1} \in \overline{V_-((1+r')/2, \epsilon)} \subset V(r', \epsilon'), \quad n > n_0.$$

Note that this $\in$ relation is also satisfied by any limit point of the sequence $(w_{n,1})$.

By taking subsequences if necessary, we can assume that $w_{n,k} \rightarrow w_k$, $k = 1, 2$, as $n \rightarrow \infty$. By continuity, $h(w_1) = h(w_2)$, and since $|w_1| = |w_2| = 1$ and h is injective on $|w| = 1$, this can only happen if $w_1 = w_2$. Because $V(r', \epsilon')$ is an open set containing w_1 , the points $w_{n,1}$ and $w_{n,2}$ belong to $V(r', \epsilon')$ for all n sufficiently large, which in view of the equality $h(w_{n,1}) = h(w_{n,2})$ contradicts the fact that h is univalent on $V(r', \epsilon')$.

We have just proved the existence of a number r_0 in the range $(1+r')/2 < r_0 < 1$ such that for all $z \in \overline{U_-(r_0, \epsilon)}$, the function $f_z(w) = h(w) - \varphi(z)$ has exactly one zero in $2r_0 - 1 \leq |w| \leq 1$, which is given by $\phi(z) \in \overline{V_-(r_0, \epsilon)}$. In particular, $|\phi(z)| \geq r_0$, and so

$$(4.35) \quad \beta_1 := \min \left\{ |h(w) - \varphi(z)| : |w| = 2r_0 - 1, z \in \overline{U_-(r_0, \epsilon)} \right\} > 0.$$

Note also that for all $z \in U_-(r_0, \epsilon)$, $\phi(z)$ is a simple zero of $f_z(w)$ because $h(w)$ is conformal on $V(r', \epsilon') \supset V_-(r_0, \epsilon)$. Thus, $U_-(r_0, \epsilon) \subset D_1$ and $\phi(z) = \phi_1(z)$ for $z \in U_-(r_0, \epsilon)$.

Moreover, just as in the proof of Theorem 2.3, we can use the residue theorem to get from (4.21) that for all $z \in U_-(r_0, \epsilon)$,

$$Q_n(z) = (n+1)\phi'(z)\phi(z)^n + \frac{(n+1)\varphi'(z)}{2\pi i} \int_{|w|=2r_0-1} \frac{w^n}{f_z(w)} dw.$$

Combining this with (2.3), (3.19), (4.34) and (4.35), we obtain the inequality

$$(4.36) \quad |A_n(z)| \leq \left| \frac{\sqrt{n+1}}{\alpha_{n,n}} - 1 \right| + \sum_{j=1}^{\infty} \frac{|h(n,j)|(n+j+1)|}{n+1} |\phi(z)|^j \\ + \beta_0 \beta_1 \tau_0^n \sum_{j=1}^{\infty} \frac{|h(n,j)|(n+j+1)|}{n+1} (2r_0 - 1)^{j+1},$$

which is valid for $z \in U_-(r_0, \epsilon)$, where $\tau_0 = (2r_0 - 1)/r_0 < 1$.

On $U_-(r_0, \epsilon)$, we have $|\phi(z)| \geq r_0$, and by (3.27), there exists a constant β independent of n such that

$$\left| \frac{\sqrt{n+1}}{\alpha_{n,n}} - 1 \right| \leq \frac{\beta_2}{n}, \quad n \geq 1.$$

This and (4.27) allow us to deduce from (4.36) that for $z \in U_-(r_0, \epsilon)$ and some constant β_3 ,

$$|A_n(z)| \leq \frac{\beta_2}{n} + \frac{E_1}{n(1 - |\phi(z)|)} + \frac{E_1}{n^{B_1}(1 - |\phi(z)|)^{B_1}} + \frac{\beta_3 \tau_0^n}{n} \\ \leq \frac{\beta_2 + E_1 + \beta_3}{n(1 - |\phi(z)|)} + \frac{E_1}{n^{B_1}(1 - |\phi(z)|)^{B_1}},$$

whence (4.33) follows. $\square$

4.5 Proof of Lemma 2.4.

As in the previous subsection, we use $z_1, \dots, z_q$ to denote the corners of L . We need to show that for every $z_0 \in L \setminus \{z_1, \dots, z_q\}$, there exists a neighborhood $\mathcal{U}_{z_0}$ of z_0 and a constant C_{z_0} such that $\mathcal{U}_{z_0} \subset \Omega^*$ and

$$(4.37) \quad |A_n(z)| \leq \frac{C_{z_0} \log n}{n}, \quad z \in \mathcal{U}_{z_0}.$$

We use the notation introduced in (4.30), (4.31), and (4.32). Let $\epsilon > 0$ be chosen so small that (4.29) is satisfied and

$$w_0 := \phi(z_0) \notin \bigcup_{k=1}^q \{e^{i\theta} : \theta_k - \epsilon \leq \theta \leq \theta_k + \epsilon\}.$$

By Proposition 4.2, for such a ϵ we can find $0 < r < 1$ such that

$$(4.38) \quad |A_n(z)| \leq \frac{M_1}{n(1 - |\phi(z)|)} + \frac{M_1}{n^{B_1}(1 - |\phi(z)|)^{B_1}}, \quad z \in U_-(r, \epsilon), \quad n \geq 1,$$

where M_1 and B_1 are independent of n and z . By increasing r if necessary, we can guarantee that $\overline{U(r, \epsilon)} \subset \Omega^*$, so that

$$(4.39) \quad \inf\{|\phi'(z)| : z \in U(r, \epsilon)\} > 0.$$

The estimate (2.1) holds on $U_+(r, \epsilon)$, and $|\phi(z)| < 1/(1-r)$ for all $z \in U_+(r, \epsilon)$. In combination with (4.38), this yields an inequality of the form

$$(4.40) \quad |A_n(z)| \leq \frac{M_2}{n(1-|\phi(z)|)} + \frac{M_2}{n^{B_1}(1-|\phi(z)|)^{B_1}},$$

which is valid for $z \in U_-(r, \epsilon) \cup U_+(r, \epsilon)$ and $n \geq 1$, with M_2 some constant.

By (2.1), on the level curve

$$L_{1/(1-r)} := \{z \in \mathbb{C} : |\phi(z)| = 1/(1-r)\},$$

we have the bound

$$|p_n(z)| \leq \frac{M_3 \sqrt{n+1}}{(1-r)^n}, \quad z \in L_{1/(1-r)}, \quad n \geq 0,$$

where the constant M_3 only depends on r . By the maximum principle, the same bound holds inside $L_{1/(1-r)}$, and in particular, on the set $U(r, \epsilon)$. This and (4.39) imply that for all $n \geq 0$,

$$(4.41) \quad |A_n(z)| = \left| \frac{p_n(z)}{\sqrt{n+1}\phi'(z)\phi(z)^n} - 1 \right| \leq \frac{M_4}{(1-r)^{2n}}, \quad z \in U(r, \epsilon),$$

where M_4 is some constant.

For $\eta > 0$, the Möbius transformation

$$J(\zeta) = w_0 \frac{i - \eta\zeta}{i + \eta\zeta},$$

maps the real line onto the unit circle, while it takes the lower-half plane $H_- := \{\zeta : \text{Im}(\zeta) < 0\}$ onto the unit disk $\mathbb{D}(0, 1)$, and the upper half-plane $H_+ := \{\zeta : \text{Im}(\zeta) > 0\}$ onto $\Delta(0, 1)$. Since $J(0) = w_0$, by choosing η sufficiently small we can guarantee that $J(\Sigma_1) \subset V(r, \epsilon)$, where Σ_1 is the open unit square, that is, the set corresponding to $\delta = 1$ in the definition

$$\Sigma_\delta := \{\zeta \in \mathbb{C} : |\text{Re}(\zeta)| < \delta, |\text{Im}(\zeta)| < \delta\}.$$

The set $\psi(J(\Sigma_1))$ is open, contains z_0 , and we have the inclusions

$$\psi(J(\Sigma_1 \cap H_+)) \subset U_+(r, \epsilon), \quad \psi(J(\Sigma_1 \cap H_-)) \subset U_-(r, \epsilon).$$

Combining (4.40) and (4.41) with the equality

$$|1 - |J(\zeta)|| = \frac{4\eta |\text{Im}(\zeta)|}{|i + \eta\zeta|^2(1 + |J(\zeta)|)},$$

we find that the functions

$$u_n(t) := A_n(\psi(J(\zeta))), \quad \zeta \in \Sigma_1,$$

satisfy the following properties, where M_5 is a certain constant independent of the index n :

- (i) $u_n(\zeta)$ is analytic in Σ_1 ;
- (ii) $|u_n(\zeta)| \leq \frac{M_5}{n|\operatorname{Im}(\zeta)|} + \frac{M_5}{n^{B_1}|\operatorname{Im}(\zeta)|^{B_1}}, \quad \zeta \in \Sigma_1 \setminus (-1, 1);$
- (iii) $|u_n(\zeta)| \leq M_5 a^n, \quad a = (1-r)^{-2}, \quad \zeta \in \Sigma_1.$

If we prove that for every $0 < \delta < 1$, there is a constant C_δ such that

$$(4.42) \quad |u_n(\zeta)| = C_\delta \frac{\log n}{n}, \quad \zeta \in \Sigma_\delta, \quad n > 1,$$

then (4.37) would hold with the choice of neighborhood $\mathcal{U}_{z_0} = \psi(J(\Sigma_\delta))$, $\delta < 1$. The assertion (4.42) is an immediate consequence of the following proposition.

Proposition 4.3. *Let $\{u_n\}_{n \geq 1}$ be a sequence of holomorphic functions on Σ_1 , such that for some numbers $1 = b_1 \leq b_2 \leq \dots \leq b_m$, it holds that*

$$(4.43) \quad |u_n(z)| \leq \sum_{j=1}^m \frac{1}{n^{b_j} |\operatorname{Im}(z)|^{b_j}}, \quad z \in \Sigma_1 \setminus (-1, 1).$$

Assume, in addition, that for some real number $a \geq 1$, we have the uniform bound

$$(4.44) \quad |u_n(z)| \leq a^n, \quad z \in \Sigma_1.$$

Then for any $0 < \delta < 1$, there exists a constant C_δ such that

$$|u_n(z)| \leq \frac{C_\delta \log n}{n}, \quad z \in \Sigma_\delta, \quad n > 1.$$

In particular, $u_n(z)$ converges to 0 locally uniformly on Σ_1 .

Proof. Fix $0 < \delta < 1$, and put

$$(4.45) \quad \sigma := \frac{4(1+\epsilon)}{\pi(1-\delta)} > 1,$$

where $\epsilon > 0$ is some arbitrary positive number. For $n > 1$, we denote by S_n the thin rectangle

$$S_n = \left\{ z \in \Sigma_1 : |\operatorname{Im}(z)| \leq \frac{1}{\sigma \log n} \right\}.$$

For $z \in \Sigma_1 \setminus S_n$, we have $|\operatorname{Im}(z)| \geq (\sigma \log n)^{-1}$, so the bound (4.43) gives

$$|u_n(z)| \leq \sum_{j=1}^m \frac{\sigma^j (\log n)^{b_j}}{n^{b_j}} \leq m \sigma^{b_m} \frac{\log n}{n}, \quad z \in \Sigma_1 \setminus S_n.$$

It remains to establish a similar bound on the set $\Sigma_\delta \cap S_n$. For this, it is in turn sufficient to prove that for any fixed $x_0 \in (-\delta, \delta)$, we have

$$|u_n(x_0 + iy)| \leq \frac{C_\delta \log n}{n}, \quad |y| \leq \frac{1}{\sigma \log n},$$

where C_δ is a constant independent of x_0 .

The proof will be based on rescaling

$$\{z \in S_n : |\operatorname{Re}(z) - x_0| < \delta'\}, \quad \delta' := 1 - \delta,$$

to a rectangle of fixed (unit) height and growing width, and then apply a quantitative analogue of the Phragmén-Lindelöf principle in a strip. To that end, we denote by T_n the rescaled rectangle

$$\begin{aligned} T_n &:= \{(\sigma \log n)(z - x_0) : z \in S_n, |\operatorname{Re}(z) - x_0| \leq \delta'\} \\ &= \{\zeta \in \mathbb{C} : |\operatorname{Im}(\zeta)| \leq 1, |\operatorname{Re}(\zeta)| \leq \delta' \sigma \log n\}, \end{aligned}$$

and consider the sequence $\{g_n\}_{n \geq 0}$ of holomorphic functions on T_n defined by

$$g_n(\zeta) := u_n(x_0 + \zeta(\sigma \log n)^{-1}), \quad \zeta \in T_n.$$

On the horizontal parts of the boundary ∂T_n , the bound (4.43) implies that

$$\begin{aligned} (4.46) \quad |g_n(x \pm i)| &= \left| u_n \left(x_0 + \frac{x}{\sigma \log n} \pm \frac{i}{\sigma \log n} \right) \right| \\ &\leq m \sigma^{b_m} \frac{\log n}{n}, \quad |x| \leq \delta' \sigma \log n. \end{aligned}$$

In addition, the uniform bound (4.44) translates to

$$(4.47) \quad |g_n(\zeta)| \leq a^n, \quad \zeta \in T_n.$$

We next introduce the auxiliary function

$$h(\zeta) := \exp \left(-\sqrt{2} (e^{\pi \zeta/4} + e^{-\pi \zeta/4}) \right).$$

The function h is entire and $|h(x + iy)|$ tends to zero rapidly as $|x| \rightarrow \infty$. In analogy with standard proofs of the Phragmén-Lindelöf principle in a strip, we will use h to subdue any growth of $|g_n(\zeta)|$ in the horizontal direction, allowing us to apply the maximum principle to $|g_n h|$ in T_n . More specifically, for $\zeta = x + iy \in T_n$, we have

$$\begin{aligned} (4.48) \quad |h(\zeta)| &= \exp \left(-\sqrt{2} \cos(\pi y/4) (e^{\pi x/4} + e^{-\pi x/4}) \right) \\ &\leq \exp \left(-\exp(\pi |x|/4) \right), \end{aligned}$$

where the inequality follows from the fact that $\cos(\pi y/4) \geq \frac{1}{\sqrt{2}}$ for $|y| \leq 1$ together with the elementary bound $e^t + e^{-t} \geq e^{|t|}$.

We have $|h(\zeta)| \leq 1$ throughout the strip $\{\zeta : |\operatorname{Im}(\zeta)| \leq 1\}$, so (4.46) implies that

$$(4.49) \quad |h(\zeta)g_n(\zeta)| \leq m\sigma^{b_m} \frac{\log n}{n}, \quad \zeta = x \pm i \in \partial T_n.$$

On the vertical parts of the boundary, (4.48) and (4.45) instead give

$$\begin{aligned} |h(\pm\delta'\sigma \log n + iy)| &\leq \exp\left(-e^{\frac{\pi\delta'\sigma \log n}{4}}\right) \\ &\leq \exp(-n^{1+\epsilon}), \quad |y| \leq 1. \end{aligned}$$

Combining this with the uniform bound (4.47), we see that the product satisfies

$$(4.50) \quad |(g_n \cdot h)(\pm\delta'\sigma \log n + iy)| \leq a^n \exp(-n^{1+\epsilon}), \quad |y| \leq 1$$

on the vertical parts of ∂T_n . Since the right-hand side of (4.50) tends to 0 faster than $(\log n)/n$, there exists some constant $C_\delta > m\sigma^{b_m}$ such that

$$|(g_n \cdot h)(\pm\delta'\sigma \log n + iy)| \leq \frac{C_\delta \log n}{n}, \quad |y| \leq 1, \quad n \geq 1.$$

When combined with (4.49), (4.50) gives

$$|g_n(\zeta)h(\zeta)| \leq \frac{C_\delta \log n}{n}, \quad \zeta \in \partial T_n,$$

which, by the standard maximum principle, also holds for all $\zeta \in T_n$. In other words, for $\zeta = x + iy \in T_n$, we have

$$(4.51) \quad |g_n(\zeta)| \leq \frac{C_\delta \log n}{n|h(\zeta)|} = \frac{C_\delta \log n}{n} \exp\left(\sqrt{2} \cos(\pi y/4) (e^{\pi x/4} + e^{-\pi x/4})\right).$$

Recall that we want to analyze the size of $u_n(z)$ on the line $\operatorname{Re}(z) = x_0$, which corresponds to evaluating $g_n(\zeta)$ along the imaginary axis. Invoking the bound (4.51) for $\zeta = iy$ and $|y| \leq 1$, we obtain

$$\begin{aligned} |u_n(x_0 + iy(\sigma \log n)^{-1})| &= |g_n(iy)| \leq \frac{C_\delta \log n}{n} \exp\left(2\sqrt{2} \cos(\pi y/4)\right) \\ &\leq \frac{C_\delta e^{2\sqrt{2}} \log n}{n}. \end{aligned}$$

This completes the proof. □

4.6 Proof of Theorem 1.3.

We know from (2.1) and (2.6) that $|A_n(z)| = O(1/n)$ uniformly as $n \rightarrow \infty$ on closed subsets of $\Omega \cup D_1$. Hence, it is sufficient to show that the bound $A_n(z) = O(\log n/n)$ holds near any $z_0 \in L$ away from the set of corners $C(L)$, which is precisely the assertion of Lemma 2.4.
