# One-dimensional quasi-uniform Kronecker sequences*

#### Abstract

In this short note, we prove that the one-dimensional Kronecker sequence io mod $1, i=0,1,2, \ldots$, is quasi-uniform if and only if $\alpha$ is a badly approximable number. Our elementary proof relies on a result on the three-gap theorem for Kronecker sequences due to Halton (1965).

## 1 Introduction and the main result

Motivated primarily by applications to scattered data approximation [18, we are concerned with the quasi-uniformity of infinite sequences of points. Let $\mathcal{X}$ be a compact subset of $\mathbb{R}^{d}$ for a dimension $d$ with $\operatorname{vol}(\mathcal{X})>0$. For an infinite sequence of points $\mathcal{S}=\left(\boldsymbol{x}_{i^{\prime}}\right)_{i=0,1,2, \ldots}$ in $\mathcal{X}$, we say that $\mathcal{S}$ is quasi-uniform over $\mathcal{X}$ if there exists a constant $C>1$ such that

$$
\rho_{n}(\mathcal{S}):=\frac{h_{n}(\mathcal{S})}{q_{n}(\mathcal{S})} \leq C
$$

for all positive integers $n$, where $h_{n}(\mathcal{S})$ and $q_{n}(\mathcal{S})$ denote the fill distance and the separation radius of the first $n$ points of $\mathcal{S}$, respectively, i.e.,

$$
h_{n}(\mathcal{S}):=\sup _{\boldsymbol{x} \in \mathcal{X}} \min _{0 \leq i<n}\left\|\boldsymbol{x}-\boldsymbol{x}_{i}\right\| \quad \text { and } \quad q_{n}(\mathcal{S}):=\frac{1}{2} \min _{0 \leq i<j<n}\left\|\boldsymbol{x}_{i}-\boldsymbol{x}_{j}\right\|,
$$

with $\|\cdot\|$ representing the Euclidean norm on $\mathbb{R}^{d}$. Note that $\rho_{n}(\mathcal{S})$ is known as the mesh ratio of the first $n$ points of $\mathcal{S}$. From the definition, it is evident that $h_{n}(\mathcal{S}) \geq q_{n}(\mathcal{S})$, and thus $\rho_{n}(\mathcal{S}) \geq 1$. Quasi-uniformity refers to the property of infinite sequences in which successive points fill the domain $\mathcal{X}$ evenly while keeping some distances from each other. This property is desirable for sampling nodes for function evaluation in scattered data approximation [6, 14, 19].

Another popular measure of uniformity is the discrepancy, which has been widely studied in the field of quasi-Monte Carlo (QMC) methods [1, [8]. In fact, the fill distance $h_{n}(\mathcal{S})$ has also been studied in this context, often referred to as "dispersion" instead of "fill distance". A sequence $\mathcal{S}$ in the unit cube $[0,1]^{d}$ is said to be a low-dispersion sequence if $\lim \sup _{n \rightarrow \infty} n^{1 / d} h_{n}(\mathcal{S})<\infty$. Many explicit constructions of low-discrepancy sequences have already been proven to exhibit low dispersion as well [8, Chapter 6]. However, it remains largely unknown whether low-discrepancy or low-dispersion sequences are also quasi-uniform. While a recent paper by the author 3 has proven that the Sobol'

[^0]sequence [11, one of the best-known low-discrepancy sequences, is not quasi-uniform in dimension 2 over the unit square $[0,1]^{2}$, it is far from trivial whether higher-dimensional Sobol' sequences or other common low discrepancy sequences are quasi-uniform over the $d$-dimensional unit cube $[0,1]^{d}$.

In this short note, we focus on the simplest one-dimensional case and investigate the quasiuniformity of one of the well-known sequences, the Kronecker sequence, over the unit interval $[0,1]$. The Kronecker sequence is defined as

$$
\begin{equation*}
x_{i}=i \alpha \bmod 1, \quad i=0,1,2, \ldots, \tag{1}
\end{equation*}
$$

for a real number $\alpha>0$. It is known that this sequence achieves the star discrepancy of $O((\log n) / n)$ if and only if $\alpha$ is irrational and its continued fraction expansion $\left[a_{0} ; a_{1}, a_{2}, \ldots\right]$ satisfies $(1 / m) \sum_{j=1}^{m} a_{j}$ being uniformly bounded above for all $m \geq 1$ [1, Corollary 1.65]. This order is best possible from a general lower bound on the star discrepancy by Schmidt [10]. Additionally, it has been shown in [2, (7) that the Kronecker sequence is also a low-dispersion sequence if and only if $\alpha$ is a badly approximable number, i.e., $\alpha=\left[a_{0} ; a_{1}, a_{2}, \ldots\right]$ is irrational and $a_{m}$ is uniformly bounded above for all $m \geq 1$. Beyond that, Kronecker sequences have recently been studied in terms of (week) Poissonian pair correlations [16, 17 .

In this note, we prove the following result on the quasi-uniformity of Kronecker sequences. It turns out that the "if and only if" condition coincides with the one for the Kronecker sequence to be a low-dispersion sequence. As we will see, our elementary proof relies on a result on the three-gap theorem for Kronecker sequences due to Halton (1965).

Theorem 1. The Kronecker sequence $\mathcal{S}=\left(x_{i}\right)_{i=0,1,2, \ldots}$, defined by (11), is quasi-uniform over $[0,1]$ if and only if $\alpha$ is a badly approximable number.

Remark 2. The van der Corput sequence, another well-known low-discrepancy sequence in dimension 1, can be easily proven to be quasi-uniform in any base $b \geq 2$. In fact, the greedy packing algorithm from [9] reproduces the van der Corput sequence in base 2 by placing the first point at $1 / 2$, and the mesh ratio $\rho_{n}$ is bounded above by 2 for any $n$.

## 2 Proof

As introduced already, let us denote the continued fraction of $\alpha>0$ by $\left[a_{0} ; a_{1}, a_{2}, \ldots\right]$, i.e.,

$$
\alpha=a_{0}+\frac{1}{a_{1}+\frac{1}{a_{2}+\frac{1}{\ddots}}} .
$$

This continued fraction is finite if and only if $\alpha$ is rational. In such cases, the corresponding Kronecker sequence becomes periodic, with only finitely many distinct values appearing infinitely often. Consequently, there exists $n_{0} \geq 1$ such that the separation radius $q_{n}$ equals 0 for all $n \geq n_{0}$, making the mesh ratio $\rho_{n}$ unbounded. We will now proceed under the assumption that $\alpha$ is irrational, indicating an infinite continued fraction.

Let us introduce the following notation:

$$
\alpha_{0}=\alpha \bmod 1 \quad \text { and } \quad \alpha_{m+1}=1 / \alpha_{m} \bmod 1, \quad m=0,1,2, \ldots
$$

In fact, it is easy to check that $\alpha_{m}=\left[0 ; a_{m+1}, a_{m+2}, \ldots\right]$ for all $m$. Furthermore, let

$$
\begin{gathered}
\eta_{-1}=1 \quad \text { and } \quad \eta_{m}=\prod_{j=0}^{m} \alpha_{m}, \quad m=0,1,2, \ldots, \\
s_{0}=1, \quad s_{1}=a_{1}, \quad \text { and } \quad s_{m+2}=a_{m+2} s_{m+1}+s_{m}, \quad m=0,1,2, \ldots,
\end{gathered}
$$

and

$$
n_{0}=1, \quad \text { and } \quad n_{m}=s_{m}+s_{m-1}, \quad m=1,2,3, \ldots
$$

Then the following result was proven by Halton 4, Corollary 2] about the famous three-gap theorem for Kronecker sequences [5, 12, 13, 15].

Lemma 3 (Halton). Let $n_{m} \leq n<n_{m+1}$ for some $m \geq 0$, and consider the first $n$ points of the Kronecker sequence (1) with an irrational $\alpha$. Rearrange these points in ascending order and denote them by $x^{(0)} \leq x^{(1)} \leq \cdots \leq x^{(n-1)}$ with $x^{(0)}=0$ and $x^{(n-1)}<1=x^{(n)}$. Let $n=n_{m}+h s_{m}+k$ with $0 \leq h \leq a_{m+1}-1$ and $0 \leq k \leq s_{m}-1$. Then, among the $n$ gap lengths $x^{(1)}-x^{(0)}, x^{(2)}-x^{(1)}, \ldots, x^{(n)}-$ $x^{(n-1)}$, there exist at most three distinct values. In particular, $s_{m-1}+h s_{m}+k$ lengths are equal to $\eta_{m}, s_{m}-k$ lengths are equal to $\eta_{m-1}-h \eta_{m}$, and $k$ lengths are equal to $\eta_{m-1}-(h+1) \eta_{m}$.

Now we are ready to prove Theorem 1
Proof of Theorem 1. First, we prove that the Kronecker sequence is quasi-uniform for any $\alpha$ being a badly approximable number. For some $m \geq 0$, let $n=n_{m}+h s_{m}+k$ with $0 \leq h \leq a_{m+1}-1$ and $0 \leq k \leq$ $s_{m}-1$. For the three gap lengths given in Lemma 3 we have $\eta_{m-1}-h \eta_{m}=\eta_{m}+\left(\eta_{m-1}-(h+1) \eta_{m}\right)$, i.e., one length is the sum of the other two. Therefore, for the separation radius, we have

$$
\begin{aligned}
q_{n}(\mathcal{S}) & =\frac{1}{2} \min _{0 \leq i<j<n}\left|x_{i}-x_{j}\right|=\frac{1}{2} \min _{0 \leq i<n-1}\left|x^{(i+1)}-x^{(i)}\right| \geq \frac{1}{2} \min _{0 \leq i<n}\left|x^{(i+1)}-x^{(i)}\right| \\
& =\frac{1}{2} \min \left\{\eta_{m}, \eta_{m-1}-h \eta_{m}, \eta_{m-1}-(h+1) \eta_{m}\right\}=\frac{1}{2} \min \left\{\eta_{m}, \eta_{m-1}-(h+1) \eta_{m}\right\} .
\end{aligned}
$$

Similarly, for the fill distance, we have

$$
\begin{aligned}
h_{n}(\mathcal{S}) & =\sup _{x \in[0,1]} \min _{0 \leq i<n}\left|x-x_{i}\right|=\max \left\{\frac{1}{2} \max _{0 \leq i<n-1}\left|x^{(i+1)}-x^{(i)}\right|,\left|x^{(n)}-x^{(n-1)}\right|\right\} \\
& \leq \max _{0 \leq i<n}\left|x^{(i+1)}-x^{(i)}\right|=\max \left\{\eta_{m}, \eta_{m-1}-h \eta_{m}, \eta_{m-1}-(h+1) \eta_{m}\right\}=\eta_{m-1}-h \eta_{m}
\end{aligned}
$$

These lead to an upper bound on the mesh ratio as

$$
\rho_{n}(\mathcal{S})=\frac{h_{n}(\mathcal{S})}{q_{n}(\mathcal{S})} \leq \frac{2\left(\eta_{m-1}-h \eta_{m}\right)}{\min \left\{\eta_{m}, \eta_{m-1}-(h+1) \eta_{m}\right\}}=\frac{2\left(1-h \alpha_{m}\right)}{\min \left(\alpha_{m}, 1-(h+1) \alpha_{m}\right)} .
$$

Since it immediately follows from the definition of $\alpha_{m}$ 's that

$$
\frac{1}{a_{m+1}+1}<\alpha_{m}<\frac{1}{a_{m+1}+1 / a_{m+2}}
$$

the mesh ratio is further bounded above by

$$
\begin{aligned}
\rho_{n}(\mathcal{S}) & \leq 2 \max \left\{\frac{1-h \alpha_{m}}{\alpha_{m}}, \frac{1-h \alpha_{m}}{1-(h+1) \alpha_{m}}\right\}=2 \max \left\{\frac{1}{\alpha_{m}}-h, \frac{1}{1-\frac{1}{\frac{1}{\alpha_{m}}-h}}\right\} \\
& \leq 2 \max \left\{a_{m+1}+1-h, \frac{1}{1-\frac{1}{a_{m+1}+1 / a_{m+2}-h}}\right\} \\
& \leq 2 \max \left\{a_{m+1}+1, a_{m+2}+1\right\} \leq 2+2 \sup _{j \geq 1} a_{j} .
\end{aligned}
$$

Thus, if $\alpha$ is a badly approximable number, the mesh ratio is bounded by a constant $C \leq 2+2 \sup _{j \geq 1} a_{j}$ for all $n$, showing that the corresponding Kronecker sequence is quasi-uniform.

Next, we prove that the Kronecker sequence is not quasi-uniform if $\alpha$ is not a badly approximable number. For this, let us consider the case where $n=n_{m}$ for $m \geq 3$, i.e., $n=n_{m}+h s_{m}+k$ with $h=k=0$. Then, it follows from Lemma 3 that there exist exactly two distinct values among the $n$ gap lengths, which are $\eta_{m}$ for $s_{m-1}$ gaps and $\eta_{m-1}$ for $s_{m}$ gaps. Since we assume $m \geq 3$, we have $s_{m}>s_{m-1} \geq 2$. Therefore, for the separation radius, we have

$$
\begin{aligned}
q_{n}(\mathcal{S}) & =\frac{1}{2} \min _{0 \leq i<j<n}\left|x_{i}-x_{j}\right|=\frac{1}{2} \min _{0 \leq i<n-1}\left|x^{(i+1)}-x^{(i)}\right|=\frac{1}{2} \min _{0 \leq i<n}\left|x^{(i+1)}-x^{(i)}\right| \\
& =\frac{1}{2} \min \left\{\eta_{m}, \eta_{m-1}\right\}=\frac{1}{2} \eta_{m} .
\end{aligned}
$$

Similarly, for the fill distance, we have

$$
\begin{aligned}
h_{n}(\mathcal{S}) & =\sup _{x \in[0,1]} \min _{0 \leq i<n}\left|x-x_{i}\right|=\max \left\{\frac{1}{2} \max _{0 \leq i<n-1}\left|x^{(i+1)}-x^{(i)}\right|,\left|x^{(n)}-x^{(n-1)}\right|\right\} \\
& \geq \frac{1}{2} \max _{0 \leq i<n}\left|x^{(i+1)}-x^{(i)}\right|=\frac{1}{2} \max \left\{\eta_{m}, \eta_{m-1}\right\}=\frac{1}{2} \eta_{m-1}
\end{aligned}
$$

This leads to a lower bound on the mesh ratio as

$$
\rho_{n}(\mathcal{S})=\frac{h_{n}(\mathcal{S})}{q_{n}(\mathcal{S})} \geq \frac{\eta_{m-1}}{\eta_{m}}=\frac{1}{\alpha_{m}} \geq a_{m+1}+\frac{1}{a_{m+2}}
$$

Thus, we have shown that the mesh ratio cannot be uniformly bounded above in all $n$ if $a_{m}$ 's are not uniformly bounded above, indicating that the corresponding Kronecker sequence is not quasiuniform.
