# A Notion of Uniqueness for the Adversarial Bayes Classifier*

#### Abstract

We propose a new notion of uniqueness for the adversarial Bayes classifier in the setting of binary classification. Analyzing this concept produces a simple procedure for computing all adversarial Bayes classifiers for a well-motivated family of one dimensional data distributions. This characterization is then leveraged to show that as the perturbation radius increases, certain the regularity of adversarial Bayes classifiers improves. Various examples demonstrate that the boundary of the adversarial Bayes classifier frequently lies near the boundary of the Bayes classifier.

1. Introduction. A crucial reliability concern for machine learning models is their susceptibility to adversarial attacks. Neural nets are particularly sensitive to small perturbations to data. For instance, $[5,20]$ show that perturbations imperceptible to the human eye can cause a neural net to misclassify an image. In order to reduce the susceptibility of neural nets to such attacks, several methods have been proposed to minimize the adversarial classification risk, which incurs a penalty when a data point can be perturbed into the opposite class. However, state-of-the-art methods for minimizing this risk still achieve significantly lower accuracy than standard neural net training on simple datasets, even for small perturbations. For example, on the CIFAR10 dataset, [17] achieves $71 \%$ robust accuracy for $\ell_{\infty}$ perturbations size $8 / 255$ while [8] achieves over $99 \%$ accuracy without an adversary.

In the setting of standard (non-adversarial) classification, a Bayes classifier is defined as a minimizer of the classification risk. This classifier simply predicts the most probable class at each point. If multiple classes have the same probability, then the Bayes classifier may not be unique. The Bayes classifier has been a helpful tool in the development of machine learning classification algorithms [13, Chapter 2.4]. On the other hand, in the adversarial setting, computing minimizers of the adversarial classification risk in terms of the data distribution is a challenging problem. These minimizers are referred to as adversarial Bayes classifiers. Prior work $[1,4,18]$ calculates these classifiers by first proving a minimax principle relating the adversarial risk with a dual problem, and then showing that the adversarial risk of a proposed set matches the dual risk of a point in the dual space.

In this paper, we propose a new notions of 'uniqueness' and 'equivalence' for adversarial Bayes classifiers in the setting of binary classification under the evasion attack. In the nonadversarial setting, two classifiers are equivalent if they are equal a.e. with respect to the data distribution, and one can show that any two equivalent classifiers have the same classi-

[^0]fication risk. The Bayes classifier is unique if any two minimizers of the classification risk are equivalent. However, under this equivalence relation, two equivalent sets can have different adversarial classification risks. This discrepancy necessitates a new definition of equivalence for adversarial Bayes classifiers.

Further analyzing this new equivalence relation in one dimension results in a method for calculating all possible adversarial Bayes classifiers for a well-motivated family of distributions. We apply this characterization to demonstrate that certain forms of regularity in adversarial Bayes classifiers improve as $\epsilon$ increases. Subsequent examples show that different adversarial Bayes classifiers achieve varying levels of (standard) classification risk. These examples illustrate that the accuracy-robustness tradeoff could be mitigated by a careful selection of an adversarial Bayes classifier (see [23] for a further discussion of this phenomenon). Followup work [9] demonstrates that the concepts presented in this paper have algorithmic implications - when the data distribution is absolutely continuous with respect to Lebesgue measure, adversarial training with a convex loss is adversarially consistent iff the adversarial Bayes classifier is unique, according to the new notion of uniqueness defined in this paper. Hopefully, a better understanding of adversarial Bayes classifiers will aid the design of algorithms for robust classification.

## 2. Background.

2.1. Adversarial Bayes Classifiers. We study binary classification on the space $\mathbb{R}^{d}$ with labels $\{-1,+1\}$. The measure $\mathbb{P}_{0}$ describes the probability of data with label -1 occurring in regions of $\mathbb{R}^{d}$ while the measure $\mathbb{P}_{1}$ describes the probability of data with label +1 occurring in regions of $\mathbb{R}^{d}$. Most of our results will assume that $\mathbb{P}_{0}$ and $\mathbb{P}_{1}$ are absolutely continuous with respect to the Lebesgue measure $\mu$. Vectors in $\mathbb{R}^{d}$ will be denoted in boldface ( x ). Many of the results in this paper focus on the case $d=1$ for which we will use non-bold letters $(x)$. The functions $p_{0}$ and $p_{1}$ will denote the densities of $\mathbb{P}_{0}, \mathbb{P}_{1}$ respectively. A classifier is represented as the set of points $A$ with label +1 . The classification risk of the set $A$ is then the proportion of incorrectly classified data:

R(A)=\int \mathbf{1}_{A^{C}} d \mathbb{P}_{1}+\int \mathbf{1}_{A} d \mathbb{P}_{0} . \tag{2.1}
\end{equation*}

A minimizer of the classification risk is called a Bayes classifier. Analytically finding the minimal classification risk and Bayes classifiers is a straightforward calculation: Let $\mathbb{P}=$ $\mathbb{P}_{0}+\mathbb{P}_{1}$, representing the total probability of a region, and let $\eta$ be the the Radon-Nikodym derivative $\eta=d \mathbb{P}_{1} / d \mathbb{P}$, the conditional probability of the label +1 at a point $\mathbf{x}$. Thus one can re-write the classification risk is

R(f)=\int C(\eta(\mathbf{x}), f(\mathbf{x})) d \mathbb{P}(\mathbf{x}) \tag{2.2}
\end{equation*}

and the minimum classification risk as $\inf _{f} R(f)=\int C^{*}(\eta) d \mathbb{P}$ with

C(\eta, \alpha)=\eta \mathbf{1}_{\alpha \leq 0}+(1-\eta) \mathbf{1}_{\alpha>0}, \quad C^{*}(\eta)=\inf _{\alpha} C(\eta, \alpha) . \tag{2.3}
\end{equation*}

The set $B=\{\mathbf{x}: \eta(\mathbf{x})>1-\eta(\mathbf{x})\}$ is then a Bayes classifier. Note that the set of points with $\eta(\mathbf{x})=1 / 2$ can be arbitrarily split between $B$ and $B^{C}$. The Bayes classifier is unique if
this ambiguous set has $\mathbb{P}$-measure zero. Equivalently, the Bayes classifier is unique if the value of $\mathbb{P}_{0}(B)$ or $\mathbb{P}_{1}\left(B^{C}\right)$ are the same for each Bayes classifier. When $p_{0}$ and $p_{1}$ are continuous, points in the boundary of the Bayes classifier must satisfy

p_{1}(\mathbf{x})-p_{0}(\mathbf{x})=0 \tag{2.4}
\end{equation*}
$$

A central goal of this paper is extending (2.4) and a notion of uniqueness to adversarial classification.

In the adversarial scenario, an adversary tries to perturb the data point $\mathbf{x}$ into the opposite class of a classifier $A$. We assume that perturbations are in a closed $\epsilon$-ball $\overline{B_{\epsilon}(\mathbf{0})}$ in some norm $\|\cdot\|$. The proportion of incorrectly classified data under an adversarial attack is the adversarial classification risk, ${ }^{1}$

R^{\epsilon}(A)=\int S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right) d \mathbb{P}_{1}+\int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{P}_{0} \tag{2.5}
\end{equation*}
$$

where the $S_{\epsilon}$ operation on a function $g$ is defined as

$$
\begin{equation*}
S_{\epsilon}(g)(\mathbf{x})=\sup _{\|\mathbf{h}\| \leq \epsilon} g(\mathbf{x}+\mathbf{h}) . \tag{2.6}
\end{equation*}
$$

Under this model, a set $A$ incurs a penalty wherever $\mathbf{x} \in A \oplus \overline{B_{\epsilon}(\mathbf{0})}$, and thus we define the $\epsilon$-expansion of a set $A$ as

A^{\epsilon}=A \oplus \overline{B_{\epsilon}(\mathbf{0})}
$$

Hence the adversarial risk can also be written as

$$
R^{\epsilon}(A)=\int \mathbf{1}_{\left(A^{C}\right)^{\epsilon}} d \mathbb{P}_{1}+\int \mathbf{1}_{A^{\epsilon}} d \mathbb{P}_{0}
$$

Prior work shows that there always exists minimizers to (2.5), referred to as adversarial Bayes classifiers $[2,4,10,19]$, see [10, Theorem 1] for an existence theorem that matches the setup of this paper. Finding minimizers to (2.5) is difficult because unlike the standard classification problem, one cannot write the integrand of (2.5) so that it can be minimized in a pointwise manner. Furthermore, prior research [6] on the structure of minimizers to $R^{\epsilon}$ proves:

Lemma 2.1. If $A_{1}, A_{2}$ are two adversarial Bayes classifiers, then so are $A_{1} \cup A_{2}$ and $A_{2} \cap A_{1}$. See Appendix A for a proof.

Next, we focus on classifiers in one dimension as this case is simple to analyze yet still yields non-trivial behavior. Prior work shows that when $\mathbb{P}_{0}, \mathbb{P}_{1} \ll \mu$ and $p_{0}, p_{1}$ are continuous, if the adversarial Bayes classifier is sufficiently 'regular', one can find necessary conditions describing the boundary of the adversarial Bayes classifier [22]. Assume that an adversarial Bayes classifier $A$ can be expressed as a union of disjoint intervals $A=\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$, where the $m, M, a_{i}$, and $b_{i}$ can be $\pm \infty$. Notice that one can arbitrarily include/exclude the endpoints

[^1]$\left\{a_{i}\right\},\left\{b_{i}\right\}$ without changing the value of the adversarial risk $R^{\epsilon}$. If $b_{i}-a_{i}>2 \epsilon$ and $a_{i+1}-b_{i}>$ $2 \epsilon$, the adversarial classification risk can then be expressed as:

R^{\epsilon}(A)=\cdots+\int_{b_{i-1}-\epsilon}^{a_{i}+\epsilon} p_{1}(x) d x+\int_{a_{i}-\epsilon}^{b_{i}+\epsilon} p_{0}(x) d x+\int_{b_{i}-\epsilon}^{a_{i+1}+\epsilon} p_{1}(x) d x+\cdots \tag{2.7}
\end{equation*}

When the densities $p_{0}$ and $p_{1}$ are continuous, differentiating this expression in $a_{i}$ and $b_{i}$ produces necessary conditions
(2.8a) $\quad p_{1}\left(a_{i}+\epsilon\right)-p_{0}\left(a_{i}-\epsilon\right)=0$
(2.8b) $\quad p_{0}\left(b_{i}+\epsilon\right)-p_{1}\left(b_{i}-\epsilon\right)=0$
which describe the boundary of the adversarial Bayes classifier. When $\epsilon=0$, these equations reduce to the condition describing the boundary of the Bayes classifer in (2.4). Prior work shows that when $p_{0}, p_{1}$ are well-behaved, this necessary condition holds for sufficiently small $\epsilon$.

Theorem 2.2 ([22]). Assume that $p_{0}, p_{1}$ are $C^{1}$, the relation $p_{0}(x)=p_{1}(x)$ is satisfied at finitely many points $x \in \operatorname{supp} \mathbb{P}$, and that at these points, $p_{0}^{\prime}(x) \neq p_{1}^{\prime}(x)$. Then for sufficiently small $\epsilon$, there exists an adversarial Bayes classifier for which the $a_{i}$ and $b_{i}$ satisfy the necessary conditions (2.8).
For a proof, see the discussion of Equation (4.1) and Theorem 5.4 in [22]. A central goal of this paper is producing necessary conditions analogous to (2.8) that hold for all $\epsilon$.
2.2. Minimax Theorems for the Adversarial Classification Risk. We analyze the properties of adversarial Bayes classifiers by expressing the minimal $R^{\epsilon}$ risk in a 'pointwise' manner analogous to (2.2). The Wasserstein- $\infty$ metric from optimal transport and the minimax theorems in $[10,19]$ are essential tools for expressing $R^{\epsilon}$ in this manner.

Informally, the measure $\mathbb{Q}^{\prime}$ is in the Wasserstein- $\infty$ ball of radius $\epsilon$ around $\mathbb{Q}$ if one can produce the measure $\mathbb{Q}^{\prime}$ by moving points in $\mathbb{R}^{d}$ by at most $\epsilon$ under the measure $\mathbb{Q}$. Formally, the $W_{\infty}$ metric is defined in terms the set of couplings $\Pi\left(\mathbb{Q}, \mathbb{Q}^{\prime}\right)$ between two positive measures $\mathbb{Q}, \mathbb{Q}^{\prime}:$

\Pi\left(\mathbb{Q}, \mathbb{Q}^{\prime}\right)=\left\{\gamma \text { positive measure on } \mathbb{R}^{d} \times \mathbb{R}^{d}: \gamma\left(A \times \mathbb{R}^{d}\right)=\mathbb{Q}(A), \gamma\left(\mathbb{R}^{d} \times A\right)=\mathbb{Q}^{\prime}(A)\right\} .
$$

The Wasserstein- $\infty$ distance between two positive finite measures $\mathbb{Q}^{\prime}$ and $\mathbb{Q}$ with $\mathbb{Q}\left(\mathbb{R}^{d}\right)=$ $\mathbb{Q}^{\prime}\left(\mathbb{R}^{d}\right)$ is then defined as

\left.W_{\infty}\left(\mathbb{Q}, \mathbb{Q}^{\prime}\right)=\inf _{\gamma \in \Pi\left(\mathbb{Q}, \mathbb{Q}^{\prime}\right)} \operatorname{ess} \sup , \mathbf{x}\right) \sim \gamma(\mathbf{x}-\mathbf{y} \| .
$$

The $W_{\infty}$ metric is in fact a metric on the space of measures, as it is a limit of the Wasserstein- $p$ metrics as $p \rightarrow \infty$, see [7,14] for details. We denote the $\epsilon$-ball in the $W_{\infty}$ metric around a measure $\mathbb{Q}$ by

\mathcal{B}_{\epsilon}^{\infty}(\mathbb{Q})=\left\{\mathbb{Q}^{\prime}: \mathbb{Q}^{\prime} \text { Borel, } W_{\infty}\left(\mathbb{Q}, \mathbb{Q}^{\prime}\right) \leq \epsilon\right\} .5
$$

Prior work $[19,21]$ applies properties of the $W_{\infty}$ metric to find a dual problem to the minimization of $R^{\epsilon}$ : let $\mathbb{P}_{0}^{\prime}, \mathbb{P}_{1}^{\prime}$ be finite Borel measures and define

\begin{equation*}
\bar{R}\left(\mathbb{P}_{0}^{\prime}, \mathbb{P}_{1}^{\prime}\right)=\int C^{*}\left(\frac{d \mathbb{P}_{1}^{\prime}}{d\left(\mathbb{P}_{0}^{\prime}+\mathbb{P}_{1}^{\prime}\right)}\right) d\left(\mathbb{P}_{0}^{\prime}+\mathbb{P}_{1}^{\prime}\right) \tag{2.9}
\end{equation*}
$$

where $C^{*}$ is defined by (2.3). Prior results $[10,19]$ relate this risk to $R^{\epsilon}$.
Theorem 2.3. Let $\bar{R}$ be defined by (2.9). Then

\inf _{A \text { Borel }} R^{\epsilon}(A)=\sup _{\substack{\mathbb{P}_{\mathbf{P}}^{\prime} \in \mathcal{B}^{\infty} \in\left(\mathbb{P}_{0}\right) \\ \mathbb{P}_{1}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)}} \bar{R}\left(\mathbb{P}_{0}^{\prime}, \mathbb{P}_{1}^{\prime}\right) \tag{2.10}
\end{equation*}
$$

and furthermore equality is attained for some Borel measurable $A$ and $\mathbb{P}_{1}^{*}, \mathbb{P}_{0}^{*}$ with $W_{\infty}\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{0}\right) \leq$ $\epsilon$ and $W_{\infty}\left(\mathbb{P}_{1}^{*}, \mathbb{P}_{1}\right) \leq \epsilon$.
See Theorem 1 of [10] for the above result. This minimax theorem then implies complementary slackness conditions that characterize optimal $A$ and $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$, see Appendix B for a proof.

Theorem 2.4. The set $A$ is a minimizer of $R^{\epsilon}$ and $\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right)$ is a maximizer of $\bar{R}$ over the $W_{\infty}$ balls around $\mathbb{P}_{0}$ and $\mathbb{P}_{1}$ iff $W_{\infty}\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{0}\right) \leq \epsilon, W_{\infty}\left(\mathbb{P}_{1}^{*}, \mathbb{P}_{1}\right) \leq \epsilon$, and

1) $(2.11)$

\int_{\mathbb{D}^{*}-\mathbb{D}^{*}+\mathbb{D}^{*}} S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right) d \mathbb{P}_{1}=\int_{n^{*}} \mathbf{1}_{A^{C}} d \mathbb{P}_{1}^{*} \quad \text { and } \quad \int_{\epsilon} S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{P}_{0}=\int \mathbf{1}_{A} d \mathbb{P}_{0}^{*}

2) If we define $\mathbb{P}^{*}=\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$ and $\eta^{*}=d \mathbb{P}_{1}^{*} / d \mathbb{P}^{*}$, then

## 3. Main Results.

Definitions. As discussed in subsection 2.1, a central goal of this paper is describing the regularity of adversarial Bayes classifiers and finding necessary conditions that hold for every $\epsilon$ in one dimension.

As an example of non-regularity, consider a data distribution defined by $p_{0}(x)=1 / 5$, for $|x| \leq 1 / 4$ and $p_{0}(x)=0$ elsewhere; and $p_{1}(x)=3 / 5$ for $1 \geq|x|>1 / 4$ and $p_{1}(x)=0$ elsewhere (see Figure 2c for a depiction of $p_{0}$ and $p_{1}$ ). If $\epsilon=1 / 8$, an adversarial Bayes classifier is $A=\mathbb{R}$. However, any subset $S$ of $[-1 / 4+\epsilon, 1 / 4-\epsilon]$ satisfies $R^{\epsilon}\left(S^{C}\right)=R^{\epsilon}(\mathbb{R})$, and thus $S^{C}$ is an adversarial Bayes classifier as well. (These claims are rigorously justified in Example 4.6.) Consequently there are many adversarial Bayes classifiers lacking regularity, but they all seem to be morally equivalent to the regular set $A=\mathbb{R}$. The notion of equivalence up to degeneracy encapsulates this behavior.

Definition 3.1. Two adversarial Bayes classifiers $A_{1}$ and $A_{2}$ are equivalent up to degeneracy if for any Borel set $E$ with $A_{1} \cap A_{2} \subset E \subset A_{1} \cup A_{2}$, the set $E$ is also an adversarial Bayes classifier. We say that that the adversarial Bayes classifier is unique up to degeneracy if any two adversarial Bayes classifiers are equivalent up to degeneracy.

Due to Lemma 2.1, to verify that an adversarial Bayes classifier is unique up to degeneracy, it suffices to show that if $A_{1}$ and $A_{3}$ are any two adversarial Bayes classifiers with $A_{1} \subset A_{3}$, then any set satisfying $A_{1} \subset E \subset A_{3}$ is an adversarial Bayes classifier as well. In the example presented above, the non-regular portion of the adversarial Bayes classifier could only be some subset of $D=[-1 / 4+\epsilon, 1 / 4-\epsilon]$. The notion of 'degenerate sets' formalizes this behavior.

Definition 3.2. A set $D$ is degenerate for an adversarial Bayes classifier $A$ if for all Borel $E$ with $A-D \subset E \subset A \cup D$, the set $E$ is also an adversarial Bayes classifier.

Equivalently, a set $D$ is degenerate for $A$ if for all disjoint subsets $D_{1}, D_{2} \subset D$, the set $A \cup D_{1}-D_{2}$ is also an adversarial Bayes classifier. In terms of this definition: the adversarial Bayes classifiers $A_{1}$ and $A_{2}$ are equivalent up to degeneracy iff the set $A_{1} \triangle A_{2}$ is degenerate for either $A_{1}$ or $A_{2}$.

This paper first studies properties of these new notions, and then uses the resulting insights to characterize adversarial Bayes classifiers in one dimension. To start, we show that when $\mathbb{P} \ll \mu$, equivalence up to degeneracy is in fact an equivalence relation (Theorem 3.3) and furthermore, every adversarial Bayes classifier has a 'regular' representative when $d=1$ (Theorem 3.5). The differentiation argument in subsection 2.1 then produces necessary conditions characterizing regular adversarial Bayes classifiers in one dimension (Theorem 3.7). These conditions provide a tool for understanding how the adversarial Bayes classifier depends on $\epsilon$; see Theorem 3.9 and Propositions 4.7 to 4.10. Identifying all adversarial Bayes classifiers then requires characterizing degenerate sets, and we provide such a criterion under specific assumptions. Lastly, Theorem 3.4 provides alternative criteria for equivalence up to degeneracy.

Theorem Statements. First, equivalence up to degeneracy is in fact an equivalence relation for many common distributions.

Theorem 3.3. If $\mathbb{P} \ll \mu$, then equivalence up to degeneracy is an equivalence relation.
Example 5.4 shows that the assumption $\mathbb{P} \ll \mu$ is necessary for this result. Additionally, uniqueness up to degeneracy generalizes certain notions of uniqueness for the Bayes classifier.

Theorem 3.4. Assume that $\mathbb{P} \ll \mu$ and $\epsilon>0$. Then the following are equivalent:
A) The adversarial Bayes classifier is unique up to degeneracy
B) Amongst all adversarial Bayes classifiers $A$, either the value of $\mathbb{P}_{0}\left(A^{\epsilon}\right)$ is unique or the value of $\mathbb{P}_{1}\left(\left(A^{C}\right)^{\epsilon}\right)$ is unique
C) There are maximizers $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$ of $\bar{R}$ for which $\mathbb{P}^{*}\left(\eta^{*}=1 / 2\right)=0$, where $\mathbb{P}^{*}=\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$ and $\eta^{*}=d \mathbb{P}_{1}^{*} / d \mathbb{P}^{*}$
When $\epsilon=0$, Item B) and Item C) are equivalent notions of uniqueness of the Bayes classifier (see subsection 2.1). However, if $B_{1}$ and $B_{2}$ are Bayes classifiers, any set $E$ satisfying $B_{1} \cap B_{2} \subset E \subset B_{1} \cup B_{2}$ is always a Bayes classifier. Thus Item A) is not necessarily equivalent to Items B) and C) when $\epsilon=0$. When $\mathbb{P} \nless \mu$, Theorem 3.3 is false although Item B) and Item C) are still equivalent (see Example 5.4 and Lemma C.6). This equivalence suggests a different notion of uniqueness for such distributions, see the subsection 5.1 for more details.

A central result of this paper is that degenerate sets are the only form of non-regularity possible in the adversarial Bayes classifier in one dimension.

Theorem 3.5. Assume that $d=1$ and $\mathbb{P}_{0}, \mathbb{P}_{1} \ll \mu$. Then any adversarial Bayes classifier is equivalent up to degeneracy to an adversarial Bayes classifier $A^{\prime}=\bigsqcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ with $b_{i}-a_{i}>$ $2 \epsilon$ and $a_{i+1}-b_{i}>2 \epsilon$.

This result motivates the definition of regularity in one dimension.
Definition 3.6. We say $E \subset \mathbb{R}$ is a regular set of radius $\epsilon$ if one can write both $E$ and $E^{C}$ as a disjoint union of intervals of length strictly greater than $2 \epsilon$.
We will drop 'of radius $\epsilon$ ' when clear from the context.

When $p_{0}, p_{1}$ are continuous, the necessary conditions (2.8) always hold for a regular adversarial Bayes classifier.

Theorem 3.7. Let $d=1$ and assume that $\mathbb{P} \ll \mu$. Let $A=\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ be a regular adversarial Bayes classifier.

If $p_{0}$ is continuous at $a_{i}-\epsilon$ (resp. $b_{i}+\epsilon$ ) and $p_{1}$ is continuous at $a_{i}+\epsilon$ (resp. $b_{i}-\epsilon$ ), then $a_{i}$ (resp. $b_{i}$ ) must satisfy the first order necessary conditions (2.8a) (resp. (2.8b)). Similarly, if $p_{0}$ is differentiable at $a_{i}-\epsilon$ (resp. $b_{i}+\epsilon$ ) and $p_{1}$ is differentiable at $a_{i}+\epsilon$ (resp. $b_{i}-\epsilon$ ), then $a_{i}$ (resp. $b_{i}$ ) must satisfy the second order necessary conditions (3.1a) (resp. (3.1b)).
(3.1a) $\quad p_{1}^{\prime}\left(a_{i}+\epsilon\right)-p_{0}^{\prime}\left(a_{i}-\epsilon\right) \geq 0$
(3.1b) $\quad p_{0}^{\prime}\left(b_{i}+\epsilon\right)-p_{1}^{\prime}\left(b_{i}-\epsilon\right) \geq 0$

This theorem provides a method for identifying a representative of every equivalence class of adversarial Bayes classifiers under equivalence up to degeneracy.

1) Let $\mathfrak{a}, \mathfrak{b}$ be the set of points that satisfy the necessary conditions for $a_{i}, b_{i}$ respectively
2) Form all possible open regular sets $\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ with $a_{i} \in \mathfrak{a}$ and $b_{i} \in \mathfrak{b}$.
3) Identify which of these sets would be be equivalent up to degeneracy, if they were adversarial Bayes classifiers.
4) Compare the risks of all non-equivalent sets from step 2) to identify which are adversarial Bayes classifiers.
One only need to consider open sets in step 2) because the boundary of a regular adversarial Bayes classifier is always a degenerate set when $\mathbb{P} \ll \mu$, as noted in subsection 2.1 (see Lemma I. 3 for a formal proof). Section 4 applies this procedure above to several example distributions, see Example 4.1 for a crisp demonstration. This analysis reveals some interesting patterns. First, boundary points of the adversarial Bayes classifier are frequently within $\epsilon$ of boundary points of the Bayes classifier. Proposition 4.9 and Proposition 4.10 prove that this phenomenon occurs when either $\mathbb{P}$ is a uniform distribution on an interval or $\eta \in\{0,1\}$, and Proposition 4.7 shows that this occurrence can reduce the accuracy-robustness tradeoff. Second, uniqueness up to degeneracy often fails only for a small number of values of $\epsilon$ when $\mathbb{P}_{0}(\mathbb{R}) \neq \mathbb{P}_{1}(\mathbb{R})$. Understanding both of these occurrences in more detail is an open problem.

Theorem 3.7 is a tool for identifying a representative of each equivalence class of adversarial Bayes classifiers under equivalence up to degeneracy. Can one characterize all the members of a specific equivalence class? Answering this question requires understanding properties of degenerate sets.

Theorem 3.8. Assume that $d=1, \mathbb{P} \ll \mu$, and let $A$ be an adversarial Bayes classifier.

- If some interval $I$ is degenerate for $A$ and $I$ is contained in supp $\mathbb{P}$, then $|I| \leq 2 \epsilon$.
- Conversely, the connected components of $A$ and $A^{C}$ of length less than or equal to $2 \epsilon$ are contained in a degenerate set.
- A countable union of degenerate sets is degenerate.
- Assume that $\operatorname{supp} \mathbb{P}$ is an interval and $\mathbb{P}(\eta \in\{0,1\})=0$. If $D$ is a degenerate set for $A$, then $D$ must be contained in the degenerate set $\left(\overline{\left.\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}} \cup \partial A\right.$.

The first two bullets state that within the support of $\mathbb{P}$, degenerate intervals must have length at most $2 \epsilon$, and conversely a component of size at most $2 \epsilon$ must be degenerate. The last bullet implies that when $\operatorname{supp} \mathbb{P}$ is an interval and $\mathbb{P}(\eta \in\{0,1\})=0$, the equivalence class of an adversarial Bayes classifier $A$ consists of all Borel sets that differ from $A$ by a measurable
subset of $\overline{\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}} \cup \partial A$. Specifically, under these conditions, $A$ cannot have a degenerate interval contained in supp $\mathbb{P}^{\epsilon}$. This result is a helpful tool for identifying sets which are equivalent up to degeneracy in step 3) of the procedure above. Both of the assumptions present in the fourth bullet are necessary - Example 4.6 presents a counterexample where supp $\mathbb{P}$ is an interval and $\mathbb{P}(\eta \in\{0,1\})>0$ while Example 6.5 presents a counterexample for which $\mathbb{P}(\eta \in\{0,1\})=0$ but supp $\mathbb{P}$ is not an interval.

Prior work $[2,6]$ shows that a certain form of regularity for adversarial Bayes classifiers improves as $\epsilon$ increases. Theorem 3.5 is an expression of this principle: this theorem states that each adversarial Bayes classifier $A$ is equivalent to a regular set of radius $\epsilon$, and thus the regularity guarantee improves as $\epsilon$ increases. Another form of regularity also improves as $\epsilon$ increases - the number of components of $A$ and $A^{C}$ must decrease for well-behaved distributions. Let $\operatorname{comp}(A) \in \mathbb{N} \cup\{\infty\}$ be the number of connected components of a set $A$.

Theorem 3.9. Assume that $d=1, \mathbb{P} \ll \mu, \operatorname{supp} \mathbb{P}$ is an interval $I$, and $\mathbb{P}(\eta \in\{0,1\})=0$. Let $\epsilon_{2}>\epsilon_{1}$ and let $A_{1}, A_{2}$ be regular adversarial Bayes classifiers corresponding to perturbation radiuses $\epsilon_{1}$ and $\epsilon_{2}$ respectively. Then $\operatorname{comp}\left(A_{1} \cap I^{\epsilon_{1}}\right) \geq \operatorname{comp}\left(A_{2} \cap I^{\epsilon_{2}}\right)$ and $\operatorname{comp}\left(A_{1}^{C} \cap I^{\epsilon_{1}}\right) \geq$ $\operatorname{comp}\left(A_{2}^{C} \cap I^{\epsilon_{2}}\right)$.
Subsection 6.3 actually proves a stronger statement: typically, no component of $A_{1} \cap I^{\epsilon_{1}}$ can contain a connected component of $A_{2}^{C}$ and no component of $A_{1}^{C} \cap I^{\epsilon_{1}}$ can contain a connected component of $A_{2}$. Due to the fourth bullet of Theorem 3.8, the assumptions of Theorem 3.9 imply that there is no degenerate interval within int $\operatorname{supp} \mathbb{P}^{\epsilon}$, and hence every adversarial Bayes classifier is regular. When computing adversarial Bayes classifiers, Theorem 3.9 and the stronger version in subsection 6.3 are useful tools in ruling out some of the sets in step 2) of the procudure above without explicitly computing their risk.

When $d>1$, we show:
Theorem 3.10. Let $A$ be an adversarial Bayes classifier. Then $A$ is equivalent up to degeneracy to a classifier $A_{1}$ for which $A_{1}=C^{\epsilon}$ and a classifier $A_{2}$ for which $A_{2}^{C}=E^{\epsilon}$, for some sets $C, E$.

Further understanding uniqueness up to degeneracy in higher dimension is an open question.
Paper Outline. Section 4 applies the tools presented above to compute adversarial Bayes classifiers for a variety of distributions. Subsequently, section 5 presents properties of equivalence up to degeneracy, including proofs of Theorems 3.3, 3.4, and 3.10. Subsections 5.2 and 5.3 further study degenerate sets, and these results are later applied in subsection 6.1 to prove Theorems 3.5 and 3.7. Subsection 6.2 further studies degenerate sets in one dimension to prove Theorem 3.8. Lastly, subsection 6.3 proves Theorem 3.9. Technical proofs and calculations appear in the appendix, which is organized so that it can be read sequentially.
4. Examples. The examples below find the equivalence classes under equivalence up to degeneracy for any $\epsilon>0$. Examples 4.2 and 4.6 demonstrate distributions for which the adversarial Bayes classifier is unique up to degeneracy for all $\epsilon$ while Example 4.5 demonstrates a distribution for which the adversarial Bayes classifier is not unique up to degeneracy for any $\epsilon>0$, even though the Bayes classifier is unique. Example 4.1 and Example 4.4 describe intermediate situations - uniqueness up to degeneracy fails only for a single value of $\epsilon$ in

Example 4.4 and only for sufficiently large $\epsilon$ in Example 4.1. Lastly, Example 4.6 presents an example with a degenerate set.

Examples 4.5 and 4.6 exhibit situations where different adversarial Bayes classifiers have varying levels of (standard) classification risk. For such distributions, a deliberate selection of the adversarial Bayes classifier would mitigate the tradeoff between robustness and accuracy.

Furthermore, all the examples below except Example 4.2 exhibit a curious occurrencethe boundary of the adversarial Bayes classifier is within $\epsilon$ of the boundary of the Bayes classifier. Propositions 4.9 and 4.10 state conditions under which this phenomenon must occur. Next, Proposition 4.7 shows that if furthermore the Bayes and adversarial Bayes have the same number of components, then one can bound the (standard) classification risk of the adversarial Bayes classifier in terms of the Bayes risk and $\epsilon$, suggesting a reduced robustnessaccuracy tradeoff.

The first two examples study Gaussian mixtures: $p_{0}=(1-\lambda) g_{\mu_{0}, \sigma_{0}}(x), p_{1}=\lambda g_{\mu_{1}, \sigma_{1}}(x)$, where $\lambda \in(0,1)$ and $g_{\mu, \sigma}$ is the density of a gaussian with mean $\mu$ and variance $\sigma^{2}$. Prior work [18] calculates a single adversarial Bayes classifier for $\lambda=1 / 2$ and any value of $\mu_{i}$ and $\sigma_{i}$. Below, our goal is to find all adversarial Bayes classifiers.

Example 4.1 (Gaussian Mixtures- equal variances, equal weights). Consider a gaussian mixture with $p_{0}(x)=\frac{1}{2} \cdot \frac{1}{\sqrt{2 \pi} \sigma} e^{-\left(x-\mu_{0}\right)^{2} / 2 \sigma^{2}}, p_{1}(x)=\frac{1}{2} \cdot \frac{1}{2} \frac{1}{\sqrt{2 \pi} \sigma} e^{-\left(x-\mu_{1}\right)^{2} / \sigma^{2}}$, and $\mu_{1}>\mu_{0}$, depicted in Figure 1a. The solutions to the first order necessary conditions $p_{1}(b-\epsilon)-p_{0}(b+\epsilon)=$ 0 and $p_{1}(a+\epsilon)-p_{0}(a-\epsilon)=0$ from (2.8) are

$$
a(\epsilon)=b(\epsilon)=\frac{\mu_{0}+\mu_{1}}{2}
$$

However, one can show that $b(\epsilon)$ does not satisfy the second order necessary condition (3.1b) (see Appendix K.1). Thus the candidate sets for the Bayes classifier are $\mathbb{R}, \emptyset$, and $(a(\epsilon),+\infty)$. The fourth bullet of Theorem 3.8 implies that none of these sets could be equivalent up to degeneracy. By comparing the adversarial risks of these three sets, one can show that the
set $(a(\epsilon),+\infty)$ is an adversarial Bayes classifier iff $\epsilon \leq \frac{\mu_{1}-\mu_{0}}{2}$ and $\mathbb{R}, \emptyset$ are adversarial Bayes classifiers iff $\epsilon \geq \frac{\mu_{1}-\mu_{0}}{2}$ (see Appendix K. 1 for details). Thus the adversarial Bayes classifier is unique up to degeneracy only when $\epsilon<\frac{\mu_{1}-\mu_{0}}{2}$.

When $\epsilon \leq \frac{\mu_{1}-\mu_{0}}{2}$, the set $(a(\epsilon),+\infty)$ is both a Bayes classifier and an adversarial Bayes classifier, and thus there is no accuracy-robustness tradeoff. In this example, uniqueness up to degeneracy fails for all sufficiently large $\epsilon$. In contrast, the example below demonstrates a distribution for which the adversarial Bayes classifier is unique up to degeneracy for all $\epsilon$.

Example 4.2 (Gaussian Mixtures- equal means). Consider a Gaussian mixture with $p_{0}(x)=\frac{1-\lambda}{\sqrt{2 \pi} \sigma_{0}} e^{-x^{2} / 2 \sigma_{0}^{2}}$ and $p_{1}(x)=\frac{\lambda}{\sqrt{2 \pi} \sigma_{1}} e^{-x^{2} / 2 \sigma_{1}^{2}}$. Assume that $p_{0}$ has a larger variance than $p_{1}$ but that the peak of $p_{0}$ is below the peak of $p_{1}$, or other words, $\sigma_{0}>\sigma_{1}$ but $\frac{\lambda}{\sigma_{1}}>\frac{1-\lambda}{\sigma_{0}}$, see Figure 1b for a depiction. Calculations similar to Example 4.1 show that the adversarial Bayes classifier is unique up to degeneracy for every $\epsilon$, and is given by $(-b(\epsilon), b(\epsilon))$ where

$$
\begin{equation*}
b(\epsilon)=\frac{\epsilon\left(\frac{1}{\sigma_{1}^{2}}+\frac{1}{\sigma_{0}^{2}}\right)+\sqrt{\frac{4 \epsilon^{2}}{\sigma_{0}^{2} \sigma_{1}^{2}}-2\left(\frac{1}{\sigma_{1}^{2}}-\frac{1}{\sigma_{0}^{2}}\right) \ln \frac{(1-\lambda) \sigma_{1}}{\lambda \sigma_{0}}}}{\frac{1}{\sigma_{1}^{2}}-\frac{1}{\sigma_{0}^{2}}} . \tag{4.1}
\end{equation*}
$$

The computational details are similar to those of Example 4.1, and thus are delayed to Appendix K.2.
Unlike Example 4.1, the Bayes and adversarial Bayes classifiers for this distribution can differ substantially.

The next three examples are distributions for which $\operatorname{supp} \mathbb{P}$ is a finite interval. In such situations, it is often helpful to assume that $a_{i}, b_{i}$ are not near $\partial \operatorname{supp} \mathbb{P}$.

Lemma 4.3. Consider a distribution for which $\mathbb{P} \ll \mu$ and $\operatorname{supp} \mathbb{P}$ is an interval. Then every adversarial Bayes classifier is equivalent up to degeneracy to a regular adversarial Bayes classifier $A=\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ for which the finite $a_{i}, b_{i}$ are contained in int supp $\mathbb{P}^{-\epsilon}$.

See Appendix K. 3 for a proof.
Example 4.4 (Uniqueness fails for a single value of $\epsilon$ ). Consider a distribution for which

$$
p_{0}=\left\{\begin{array}{ll}
\frac{1}{6}(1+x) & \text { if }|x| \leq 1 \\
0 & \text { otherwise }
\end{array} \quad p_{1}= \begin{cases}\frac{1}{3}(1-x) & \text { if }|x| \leq 1 \\
0 & \text { otherwise }\end{cases}\right.
$$

The only solutions to the first order necessary conditions $p_{1}(a+\epsilon)-p_{0}(a-\epsilon)=0$ and $p_{0}(b+\epsilon)-p_{1}(b-\epsilon)=0$ within $\operatorname{supp} \mathbb{P}^{\epsilon}$ are

$$
a(\epsilon)=\frac{1}{3}(1-\epsilon) \quad \text { and } \quad b(\epsilon)=\frac{1}{3}(1+\epsilon)
$$

We first consider $\epsilon$ small enough so that both of these points lie in int supp $\mathbb{P}^{-\epsilon}$, or in other words, $\epsilon<1 / 2$. Then $p_{0}^{\prime}(a(\epsilon)-\epsilon)=p_{0}^{\prime}(b(\epsilon)+\epsilon)=1 / 6$ and $p_{1}^{\prime}(a(\epsilon)+\epsilon)=p_{1}^{\prime}(b(\epsilon)-\epsilon)=$ $-1 / 3$. Consequently, the point $a(\epsilon)$ fails to satisfy the second order necessary condition (3.1a). To identify all adversarial Bayes classifiers under uniqueness up to degeneracy for $\epsilon<1 / 2$, Lemma 4.3 imply it remains to compare the adversarial risks of $\emptyset, \mathbb{R}$, and $(-\infty, b(\epsilon))$.

Theorem 3.8 implies that none of these sets could be equivalent up to degeneracy. The risks of these sets compute to $R^{\epsilon}(\emptyset)=2 / 3, R^{\epsilon}(\mathbb{R})=1 / 3$, and $R^{\epsilon}((-\infty, b(\epsilon)))=\frac{2}{9}(1+\epsilon)^{2}$. Therefore, for all $\epsilon<1 / 2$, the set $(-\infty, b(\epsilon))$ is an adversarial Bayes classifier iff $\epsilon \leq \sqrt{3 / 2}-1$ while $\mathbb{R}$ is an adversarial Bayes classifier iff $\epsilon \geq \sqrt{3 / 2}-1$. Theorem 3.9 then implies that this last statement holds without the restriction $\epsilon<1 / 2$.

Uniqueness up to degeneracy fails for only a single value of $\epsilon$ in the example above. In contrast, uniqueness up to degeneracy fails for all $\epsilon$ in the distribution below.

Example 4.5 (Non-uniqueness for all $\epsilon>0$ ). Let $p$ be the uniform density on the interval $[-1,1]$ and let

$$
\eta(x)= \begin{cases}\frac{1}{4} & \text { if } x \leq 0 \\ \frac{3}{4} & \text { if } x>0\end{cases}
$$

Calculations for this example are similar to those in Example 4.4, so we delay the details to Appendix K.4. For this distribution, the set $(y, \infty)$ is an adversarial Bayes classifier for any $y \in[-\epsilon, \epsilon]$ iff $\epsilon \leq 1 / 3$ and $\emptyset, \mathbb{R}$ are adversarial Bayes classifiers iff $\epsilon \geq 1 / 3$. Theorem 3.8 implies that none of these sets could be equivalent up to degeneracy. Therefore, the adversarial Bayes classifier is not unique up to degeneracy for all $\epsilon>0$ even though the Bayes classifier is unique.

Again, the adversarial Bayes classifier $(0, \infty)$ is also a Bayes classifier when $\epsilon \leq 1 / 3$, and thus there is no accuracy-robustness tradeoff for this distribution.

A distribution is said to satisfy Massart's noise condition if $|\eta(\mathbf{x})-1 / 2| \geq \delta \mathbb{P}$-a.e. for some $\delta>0$. Prior work [15] relates this condition to the sample complexity of learning from a function class. For the example above, Theorem 3.4 implies that Massart's noise condition cannot hold for any maximizer of $\bar{R}$ even though $|\eta-1 / 2| \geq 1 / 4 \mathbb{P}$-a.e.

The next example exhibits a degenerate set that has positive measure under $\mathbb{P}$.
Example 4.6 (Example of a degenerate set). Consider a distribution on $[-1,1]$ with

$$
p_{0}(x)=\left\{\begin{array}{ll}
\frac{1}{5} & \text { if }|x| \leq 1 / 4 \\
0 & \text { otherwise }
\end{array} \quad p_{1}(x)= \begin{cases}\frac{3}{5} & \text { if } 1 \geq|x|>1 / 4 \\
0 & \text { otherwise }\end{cases}\right.
$$

Theorem 3.7 and Lemma 4.3 imply that one only need consider $a_{i}, b_{i} \in\left\{-\frac{1}{4} \pm \epsilon, \frac{1}{4} \pm \epsilon\right\}$ when identifying a regular representative of each equivalence class of adversarial Bayes classifiers. By comparing the adversarial risks of the regular sets satisfying this crieterion, one can show that when $\epsilon \leq 1 / 8$, every adversarial Bayes classifier is equivalent up to degeneracy to the regular set $(-\infty,-1 / 4+\epsilon) \cup(1 / 4-\epsilon, \infty)$ but when $\epsilon \geq 1 / 8$ then every adversarial Bayes classifier is equivalent up to degeneracy to the regular set $\mathbb{R}$ (see Appendix K. 5 for details.)

Next consider $\epsilon \in[1 / 8,1 / 4]$. If $S$ is an arbitrary subset of $[-1 / 4+\epsilon, 1 / 4-\epsilon]$, then $R^{\epsilon}(\mathbb{R})=R^{\epsilon}\left(S^{C}\right)$. Thus the interval $[-1 / 4+\epsilon, 1 / 4-\epsilon]$ is a degenerate set.

When $\epsilon \in[1 / 8,1 / 4]$, the (standard) classification error of $\mathbb{R}$ and $(-\infty,-1 / 4+\epsilon) \cup(1 / 4-\epsilon)$ differ by $\frac{2}{5}(1-4 \epsilon)$, which is close to $1 / 5$ for $\epsilon$ near $1 / 8$. Thus a careful selection of the adversarial Bayes classifier can mitigate the accuracy-robustness tradeoff.

In each of the prior example distributions except Example 4.2 , the boundary of the adversarial Bayes classifier is always within $\epsilon$ of the boundary of the Bayes classifier. The last three propositions in this section specify conditions under which this phenomenon must occur. If in addition the Bayes and adversarial Bayes classifiers have the same number of components, one can bound the minimal adversarial Bayes error in terms of the Bayes error rate and $\epsilon$.

Proposition 4.7. Let $B=\bigcup_{i=1}^{M}\left(c_{i}, d_{i}\right), A=\bigcup_{i=1}^{M}\left(a_{i}, b_{i}\right)$ be Bayes and adversarial Bayes classifiers respectively. Assume that $p_{0}, p_{1}$ are bounded above by $K$. Then if $\left|a_{i}-c_{i}\right| \leq \epsilon$ and $\left|b_{i}-d_{i}\right| \leq \epsilon$, then $R(A)-R(B) \leq 4 \epsilon M K$.

Thus there will be a minimal robustness-accuracy tradeoff so long as $\epsilon \ll 1 / M K$.
Proof.

$$
R(A)-R(B) \leq \sum_{i=1}^{M} \int_{\min \left(a_{i}, c_{i}\right)}^{\max \left(a_{i}, c_{i}\right)}\left|p_{1}(x)-p_{0}(x)\right| d x+\int_{\min \left(b_{i}, d_{i}\right)}^{\max \left(b_{i}, d_{i}\right)}\left|p_{1}(x)-p_{0}(x)\right| d x \leq 4 \epsilon M K
$$

The next proposition stipulates a widely applicable criterion under which there is always a solution to the necessary conditions $p_{1}(a+\epsilon)-p_{0}(a-\epsilon)=0$ and $p_{1}(b-\epsilon)-p_{0}(b+\epsilon)=0$ within $\epsilon$ of solutions to $p_{1}(x)=p_{0}(x)$ (which specifies the boundary of the Bayes classifier).

Proposition 4.8. Let $z$ be a point with $p_{1}(z)-p_{0}(z)=0$ and assume that $p_{0}$ and $p_{1}$ are continuous on $[z-r, z+r]$ for some $r>0$. Furthermore, assume that one of $p_{0}, p_{1}$ is nonincreasing and the other is non-decreasing on $[z-r, z+r]$. Then for all $\epsilon \leq r / 2$ there is a solution to the first order necessary conditions (2.8a) and (2.8b) within $\epsilon$ of $z$.

Proof. Without loss of generality, assume that $p_{1}$ is non-increasing and $p_{0}$ is non-decreasing on $[z-r, z+r]$. The applying the relation $p_{1}(z)=p_{0}(z)$, one can conclude that

$$
p_{1}((z-\epsilon)+\epsilon)-p_{0}((z-\epsilon)-\epsilon)=p_{1}(z)-p_{0}(z-2 \epsilon)=p_{0}(z)-p_{0}(z-2 \epsilon) \geq 0
$$

An analogous argument shows that $p_{1}((z+\epsilon)+\epsilon)-p_{0}((z+\epsilon)-\epsilon) \leq 0$. Thus the intermediate value theorem implies that there is a solution to (2.8a) within $\epsilon$ of $z$. Analogous reasoning shows that there is a solution to $(2.8 \mathrm{~b})$ within $\epsilon$ of $z$.
However, this proposition does not guarantee that the solution to the necessary conditions within $\epsilon$ of $z$ must be a boundary point of the adversarial Bayes classifier. To illustrate
the utility of this result, consider a gaussian mixture with $p_{1}(x)=\frac{\lambda}{\sqrt{2 \pi} \sigma} e^{-\frac{\left(x-\mu_{1}\right)^{2}}{2 \sigma^{2}}}, p_{0}(x)=$ $\frac{1-\lambda}{\sqrt{2 \pi} \sigma} e^{-\frac{\left(x-\mu_{0}\right)^{2}}{2 \sigma^{2}}}$ for which $p_{1}\left(\mu_{1}\right)>p_{0}\left(\mu_{1}\right)$ and $p_{0}\left(\mu_{0}\right)>p_{1}\left(\mu_{0}\right)$, see Figure 1 c) for an illustration. Just as in Example 4.1, the necessary conditions (2.8) reduce to linear equations and so there is at most one $a(\epsilon)$ solving (2.8a) and at most one $b(\epsilon)$ solving (2.8b). Thus Proposition 4.8 implies that the solutions to the first order necessary conditions (2.8) must be within $\epsilon$ of the boundary of the Bayes classifier. The second order condition (3.1b) would rule out the solution $b(\epsilon)$.

Next, if $\mathbb{P}$ is the uniform distribution on an interval, an argument similar to the proof of Proposition 4.8 implies that solutions to the first order necessary conditions (2.8) are within $\epsilon$ of solutions to $p_{0}(z)=p_{1}(z)$.

Proposition 4.9. Assume that $\mathbb{P}$ is the uniform distribution on an finite interval, $p$ and $\eta$ are continuous on $\operatorname{supp} \mathbb{P}$, and $\eta(x)=1 / 2$ only at finitely many points within $\operatorname{supp} \mathbb{P}$. Then any adversarial Bayes classifier is equivalent up to degeneracy to an adversarial Bayes classifier $A=\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ for which each $a_{i}, b_{i}$ is at most $\epsilon$ from some point $z$ satisfying $\eta(z)=1 / 2$.

The proof is very similar to that of Proposition 4.8, see Appendix K. 6 for details.
Finally, under fairly general conditions, when $\eta \in\{0,1\}$, the boundary of the adversarial Bayes classifier must be within $\epsilon$ of the boundary of the Bayes classifier.

Proposition 4.10. Assume that $\operatorname{supp} \mathbb{P}$ is an interval $\mathbb{P} \ll \mu, \eta \in\{0,1\}$, and $p$ is continuous on supp $\mathbb{P}$ and strictly positive. Then any adversarial Bayes classifier is equivalent up to degeneracy to a regular adversarial Bayes classifier $A=\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ for which each $a_{i}, b_{i}$ is at most $\epsilon$ from $\partial\{\eta=1\}$.

Again, the proof is very similar to that of Proposition 4.8, see Appendix K. 7 for details.

## 5. Equivalence up to Degeneracy.

5.1. Equivalence up to Degeneracy as an Equivalence Relation. When $\mathbb{P} \ll \mu$, there are several useful characterizations of equivalence up to degeneracy.

Proposition 5.1. Let $\mathbb{P} \ll \mu$ and $\epsilon>0$. Let $\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right)$ be a maximizer of $\bar{R}$ and set $\mathbb{P}^{*}=$ $\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$. Let $A_{1}$ and $A_{2}$ be adversarial Bayes classifiers. Then the following are equivalent:

1) The adversarial Bayes classifiers $A_{1}$ and $A_{2}$ are equivalent up to degeneracy
2) Either $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right)-\mathbb{P}_{0}$-a.e. or $S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)-\mathbb{P}_{1}$-a.e.
3) $\mathbb{P}^{*}\left(A_{2} \triangle A_{1}\right)=0$

Item 2) states that $A_{1}, A_{2}$ are equivalent up to degeneracy if the 'attacked' classifiers $A_{1}^{\epsilon}, A_{2}^{\epsilon}$ are equal $\mathbb{P}_{0}$-a.e. Item 3) further states that the adversarial Bayes classifiers $A_{1}, A_{2}$ are unique up to degeneracy if they are equal under the measure of optimal adversarial attacks.

Proposition 5.1 is proved in Appendix C.2, and we provide an overview of this argument below. In this proof, we show that Item 3) is equivalent to Item 2), Item 2) implies Item 1), and Item 1) implies Item 3). First, the complementary slackness conditions of Theorem 2.4 implies that Item 2) and Item 3) equivalent, (see the proof of Lemma C. 6 in Appendix C). To show that Item 2) implies Item 1), we prove that Item 2) implies $S_{\epsilon}\left(\mathbf{1}_{A_{1} \cup A_{2}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{1} \cap A_{2}}\right)$ $\mathbb{P}_{0}$-a.e. and $S_{\epsilon}\left(\mathbf{1}_{\left(A_{1} \cup A_{2}\right)^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{\left(A_{1} \cap A_{2}\right)^{C}} \mathbb{P}_{1}\right.$-a.e. (Lemma C.4). Consequently, any two sets
between $A_{1} \cap A_{2}$ and $A_{1} \cup A_{2}$ must have the same adversarial risk.
Lastly, to show that Item 1) implies Item 3), we apply the complementary slackness condition of (2.11) of Theorem 2.4 to argue that $D=A_{1} \triangle A_{2}$ has $\mathbb{P}^{*}$-measure zero. First, we show that if $D_{1}=\operatorname{int} D \cap \mathbb{Q}^{d}, D_{2}=\operatorname{int} D \cap\left(\mathbb{Q}^{d}\right)^{C}$ and $\epsilon>0$, then $D_{1}^{\epsilon}=D_{2}^{\epsilon}=(\operatorname{int} D)^{\epsilon}$ (see Lemma C.7). Thus $\int \mathbf{1}_{\left(A_{1} \cap A_{2} \cup D_{1}\right)^{\epsilon}} d \mathbb{P}_{0}=\int \mathbf{1}_{\left(A_{1} \cap A_{2} \cup D_{2}\right)^{\epsilon} d \mathbb{P}_{0}=\int \mathbf{1}_{\left(A_{1} \cap A_{2} \cup \text { int } D\right)^{\epsilon}} d \mathbb{P}_{0} \text { and }, ~}^{\text {and }}$ the complementary slackness condition (2.11) implies that $\mathbb{P}_{0}^{*}($ int $D)=0$. Similarly, one can argue that $\mathbb{P}_{1}^{*}(\operatorname{int} D)=0$. The assumption $\epsilon>0$ is essential for this step of the proof. Next, to prove $\mathbb{P}^{*}(D \cap \partial D)=0$, we prove the boundary $\partial A$ is always a degenerate set for an adversarial Bayes classifier $A$ when $\mathbb{P} \ll \mu$ and $\epsilon>0$. Consequently:

Lemma 5.2. Let $A$ be an adversarial Bayes classifier. If $\mathbb{P} \ll \mu$ and $\epsilon>0$, then $A, \bar{A}$, and $\operatorname{int} A$ are all equivalent up to degeneracy.
See Appendix C. 1 for a proof. Again, the assumption $\epsilon>0$ is essential for this result.
Proposition 5.1 has several useful consequences for understanding degenerate sets, which we explore in subsection 5.3. Specifically, when $\mathbb{P} \ll \mu$, equivalence up to degeneracy is in fact an equivalence relation.

Proof of Theorem 3.3. Item 3) of Proposition 5.1 states that two adversarial Bayes classifiers $A_{1}, A_{2}$ are equivalent up to degeneracy iff $\mathbf{1}_{A_{1}}=\mathbf{1}_{A_{2}} \mathbb{P}^{*}$-a.e. Equality of functions $\mathbb{P}^{*}$-a.e. is an equivalence relation and consequently equivalence up to degeneracy is an equivalence relation.

In the following discussion, we assume that the adversarial Bayes classifier is unique up to degeneracy and show that Proposition 5.1 is equivalent to Theorem 3.4. Item 2) of Proposition 5.1 implies to Item B) of Theorem 3.4, and Lemma 2.1 together with Item B) imply Item 2).

Next, we discuss the equivalence of Item 3) of Proposition 5.1 and to Item C) of Theorem 3.4. First, to show Item C) $\Rightarrow$ Item 3), notice that the complementary slackness condition in (2.12) implies that

$$
\begin{equation*}
\mathbf{1}_{\eta^{*}>1 / 2} \leq \mathbf{1}_{A} \leq \mathbf{1}_{\eta^{*} \geq 1 / 2} \quad \mathbb{P}^{*} \text {-a.e. } \tag{5.1}
\end{equation*}
$$

for any adversarial Bayes classifier $A$ and any maximizer $\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right)$ of $\bar{R}$. Thus, if $\mathbb{P}^{*}\left(\eta^{*}=\right.$ $1 / 2)=0$ then every adversarial Bayes classifier must satisfy $\mathbf{1}_{A}=\mathbf{1}_{\eta^{*}>1 / 2} \mathbb{P}^{*}$-a.e. and thus $\mathbb{P}^{*}\left(A_{1} \triangle A_{2}\right)=0$ for any two adversarial Bayes classifiers $A_{1}$ and $A_{2}$.

It remains to prove that Item 3) implies Item C). To relate the quantity $\mathbb{P}^{*}\left(A_{1} \triangle A_{2}\right)$ to $\mathbb{P}^{*}\left(\eta^{*}=1 / 2\right)$, we show that there are adversarial Bayes classifiers $\hat{A}_{1}, \hat{A}_{2}$ which match $\left\{\eta^{*}>1 / 2\right\}$ and $\left\{\eta^{*} \geq 1 / 2\right\} \mathbb{P}^{*}$-a.e.

Lemma 5.3. There exists $\mathbb{P}_{0}^{*} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{0}\right), \mathbb{P}_{1}^{*} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)$ which maximize $\bar{R}$ and adversarial Bayes classifiers $\hat{A}_{1}, \hat{A}_{2}$ for which $\mathbf{1}_{\eta^{*}>1 / 2}=\mathbf{1}_{\hat{A}_{1}} \mathbb{P}^{*}$-a.e. and $\mathbf{1}_{\eta^{*} \geq 1 / 2}=\mathbf{1}_{\hat{A}_{2}} \mathbb{P}^{*}$-a.e., where $\mathbb{P}^{*}=\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$ and $\eta^{*}=d \mathbb{P}_{1}^{*} / d \mathbb{P}^{*}$.

Item B) in conjunction with this lemma implies that $0=\mathbb{P}^{*}\left(\hat{A}_{2} \triangle \hat{A}_{1}\right)=\mathbb{P}^{*}\left(\eta^{*}=1 / 2\right)$ for the $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$ in Lemma 5.3. See Appendix D for proofs of Theorem 3.4 and Lemma 5.3. The classifiers $\hat{A}_{1}$ and $\hat{A}_{2}$ can be interpreted as minimal and maximal adversarial Bayes classifiers, in the sense that $\int S_{\epsilon}\left(\mathbf{1}_{\hat{A}_{1}}\right) d \mathbb{P}_{0} \leq \int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{P}_{0} \leq \int S_{\epsilon}\left(\mathbf{1}_{\hat{A}_{2}}\right) d \mathbb{P}_{0}$ and $\int S_{\epsilon}\left(\mathbf{1}_{\hat{A}_{1}^{C}}\right) d \mathbb{P}_{1} \geq$
$\int S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right) d \mathbb{P}_{1} \geq \int S_{\epsilon}\left(\mathbf{1}_{\hat{A}_{2}^{C}}\right) d \mathbb{P}_{1}$ for any adversarial Bayes classifier $A$ (see Lemma D. 2 in Appendix D.1).

Theorem 3.3 is false when $\mathbb{P}$ is not absolutely continuous with respect to $\mu$ :
Example 5.4. Consider a distribution defined by $\mathbb{P}_{0}=\frac{1}{2} \delta_{-\epsilon}$ and $\mathbb{P}_{1}=\frac{1}{2} \delta_{\epsilon}$. If $0 \in A$ then $S_{\epsilon}\left(\mathbf{1}_{A}\right)(\epsilon)=1$ and if $0 \notin A$ then $S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right)(-\epsilon)=1$. In either case, $R^{\epsilon}(A) \geq 1 / 2$. The classifier $A=\mathbb{R}$ achieves adversarial classification error $1 / 2$ and therefore the adversarial Bayes risk is $R_{*}^{\epsilon}=1 / 2$. The sets $\mathbb{R}^{\geq 0}$ and $\mathbb{R}^{>0}$ also achieve error $1 / 2$ and thus are also adversarial Bayes classifiers. These two classifiers are equivalent up to degeneracy because they differ by one point. Furthermore, the classifiers $\mathbb{R}$ and $\mathbb{R}^{\geq 0}$ are equivalent up to degeneracy: if $D \subset \mathbb{R}^{<0}$, then $S_{\epsilon}\left(\mathbf{1}_{\mathbb{R} \geq 0 \cup D}\right)(-\epsilon)=1$ while $S_{\epsilon}\left(\mathbf{1}_{(\mathbb{R} \geq 0 \cup D)^{C}}\right)(\epsilon)=0$ and hence $R^{\epsilon}\left(\mathbb{R}^{\geq 0} \cup D\right)=1 / 2$. However, if $D \subset(-2 \epsilon, 0)$ then $R^{\epsilon}\left(\mathbb{R}^{>0} \cup D\right)=1$ and thus $\mathbb{R}$ and $\mathbb{R}^{>0}$ cannot be equivalent up to degeneracy.

In short - the classifiers $\mathbb{R}^{>0}$ and $\mathbb{R}^{\geq 0}$ are equivalent up to degeneracy, the classifiers $\mathbb{R}^{\geq 0}$ and $\mathbb{R}$ are equivalent up to degeneracy, but $\mathbb{R}^{>0}$ and $\mathbb{R}$ are not equivalent up to degeneracy. Thus equivalence up to degeneracy cannot be an equivalence relation for this distribution.

However, Item 2) and Item 3) of Proposition 5.1 are still equivalent when $\mathbb{P} \nless \mu$, as are Item B) and Item C) of Theorem 3.4 (see Lemma C. 6 and Proposition D. 3 in Appendices C. 2 and D. 2 respectively.). As the proof of Theorem 3.3 relies only on Item 3), one could use Item 2) and Item 3) to define a notion of equivalence for adversarial Bayes classifiers even when $\mathbb{P} \nless \mu$.
5.2. The Universal $\sigma$-algebra, Measurability, and Fundamental Regularity Results. We introduce another piece of notation to state our regularity results: define $A^{-\epsilon}=\left(\left(A^{C}\right)^{\epsilon}\right)^{C}$. The set $A^{\epsilon}$ represents all points in $\mathbb{R}^{d}$ that can be moved into $A$ by a perturbation of size at most $\epsilon$ and $A^{-\epsilon}$ is the set of of points inside $A$ that cannot be perturbed outside of $A$ :

$$
\begin{equation*}
A^{\epsilon}=\left\{\mathbf{x}: \overline{B_{\epsilon}(\mathbf{x})} \text { intersects } A\right\} \tag{5.2}
\end{equation*}
$$

$$
\begin{equation*}
A^{-\epsilon}=\left\{\mathbf{x}: \overline{B_{\epsilon}(\mathbf{x})} \subset A\right\} \tag{5.3}
\end{equation*}
$$

See Appendix E for a proof. Prior works [2, 6] note that applying the $\epsilon,-\epsilon$ operations in succession can improve the regularity of an adversarial Bayes classifier and reduce the adversarial Bayes risk. Specifically:

Lemma 5.5. For any set $A, R^{\epsilon}\left(\left(A^{-\epsilon}\right)^{\epsilon}\right) \leq R^{\epsilon}(A)$ and $R^{\epsilon}\left(\left(A^{\epsilon}\right)^{-\epsilon}\right) \leq R^{\epsilon}(A)$.
See Appendix E for a proof. Thus applying the ${ }^{\epsilon}$ and ${ }^{-\epsilon}$ operations in succession can only reduce the adversarial risk of a set. In order to perform these regularizing operations, one must minimize $R^{\epsilon}$ over a $\sigma$-algebra $\Sigma$ that is preserved by the ${ }^{\epsilon}$ operation: in other words, one would wish that $A \in \Sigma$ implies $A^{\epsilon} \in \Sigma$.

To illustrate this concern, [19] demonstrate a Borel set $C$ for which $C^{\epsilon}$ is not Borel measurable. However, prior work shows that if $A$ is Borel, then $A^{\epsilon}$ is measurable with respect to a larger $\sigma$-algebra called the universal $\sigma$-algebra $\mathscr{U}\left(\mathbb{R}^{d}\right)$. A set in the universal $\sigma$-algebra is referred to as universally measurable. Theorem 29 of [11] states that

Theorem 5.6. If $A$ is universally measurable, then $A^{\epsilon}$ is as well.
See Appendix F for the definition of the universal $\sigma$-algebra $\mathscr{U}\left(\mathbb{R}^{d}\right)$.

Thus, in order to guarantee the existence of minimizers to $R^{\epsilon}$ with improved regularity properties, one could minimize $R^{\epsilon}$ over the universal $\sigma$-algebra $\mathscr{U}\left(\mathbb{R}^{d}\right)$. However, many prior papers such as $[10,18,19]$ study this minimization problem over the Borel $\sigma$-algebra. We show that these two approaches are equivalent:

Theorem 5.7. Let $\mathcal{B}\left(\mathbb{R}^{d}\right)$ denote the Borel $\sigma$ algebra on $\mathbb{R}^{d}$. Then

$$
\inf _{A \in \mathcal{B}\left(\mathbb{R}^{d}\right)} R^{\epsilon}(A)=\inf _{A \in \mathscr{U}\left(\mathbb{R}^{d}\right)} R^{\epsilon}(A)
$$

See Appendix F for a proof. Due to this result, in the remainder of the paper, we treat the minimization of $R^{\epsilon}$ over $\mathscr{U}\left(\mathbb{R}^{d}\right)$ and $\mathcal{B}\left(\mathbb{R}^{d}\right)$ as interchangable.
5.3. Describing Degenerate Sets and Proof of Theorem 3.10. Proposition 5.1 together with fundamental properties of the ${ }^{\epsilon}$ and ${ }^{-\epsilon}$ operations imply several results on degenerate sets.

First, Lemma 2.1 implies that countable unions and intersections of adversarial Bayes classifiers are adversarial Bayes classifiers. Item 3) of Proposition 5.1 then necessitates that countable unions and intersections preserve equivalence up to degeneracy. As a result:

Lemma 5.8. Let $\mathbb{P} \ll \mu$. Then a countable union of degenerate sets is degenerate.
See Appendix G. 1 for a formal proof.
Next, using the regularizing ${ }^{\epsilon}$ and ${ }^{-\epsilon}$ operations, we study the relation between uniqueness up to degeneracy and regular adversarial Bayes classifiers. First notice that $\left(A^{-\epsilon}\right)^{\epsilon}$ is smaller than $A$ while $\left(A^{\epsilon}\right)^{-\epsilon}$ is larger than $A$ :

Lemma 5.9. Let $A$ be any set. Then $\left(A^{-\epsilon}\right)^{\epsilon} \subset A \subset\left(A^{\epsilon}\right)^{-\epsilon}$.
Furthermore, one can compare $S_{\epsilon}\left(\mathbf{1}_{A}\right)$ with $S_{\epsilon}\left(\mathbf{1}_{\left(A^{-\epsilon}\right)^{\epsilon}}\right)$ and $S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right)$ with $S_{\epsilon}\left(\mathbf{1}_{\left(A^{\epsilon}\right)^{-\epsilon}}\right)$ :
Lemma 5.10. For any set $A \subset \mathbb{R}^{d}$, the following set relations hold: $\left(\left(A^{\epsilon}\right)^{-\epsilon}\right)^{\epsilon}=A^{\epsilon}$, $\left(\left(A^{\epsilon}\right)^{-\epsilon}\right)^{-\epsilon} \supset A^{-\epsilon},\left(\left(A^{-\epsilon}\right)^{\epsilon}\right)^{-\epsilon}=A^{-\epsilon},\left(\left(A^{-\epsilon}\right)^{\epsilon}\right)^{\epsilon} \subset A^{\epsilon}$.

See Appendix E for proofs of Lemma 5.9 and Lemma 5.10. Lemma 5.10 then implies:
Corollary 5.11. Assume $\mathbb{P} \ll \mu$ and let $A$ be an adversarial Bayes classifier. Then $A,\left(A^{\epsilon}\right)^{-\epsilon},\left(A^{-\epsilon}\right)^{\epsilon}$ are all equivalent up to degeneracy.

Proof. Lemma 5.10 implies that $\left(A^{-\epsilon}\right)^{\epsilon},\left(A^{\epsilon}\right)^{-\epsilon}$ are both adversarial Bayes classifiers satisfying $S_{\epsilon}\left(\mathbf{1}_{A}\right)=S_{\epsilon}\left(\mathbf{1}_{\left(A^{\epsilon}\right)^{-\epsilon}}\right)$ and $S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{\left(\left(A^{-\epsilon}\right)^{\epsilon}\right)^{C}}\right)$. Therefore, when $\mathbb{P} \ll \mu$, Item 2) of Proposition 5.1 implies that $\left.A,\left(A^{-\epsilon}\right)^{\epsilon}\right)$, and $\left(A^{\epsilon}\right)^{-\epsilon}$ are all equivalent up to degeneracy.

Theorem 3.10 is an immediate consequence of Corollary 5.11. Furthermore, Corollary 5.11 implies that "small" components of $A$ and $A^{C}$ are degenerate sets: specifically, if $C$ is a component with $C^{-\epsilon}=\emptyset$, then $C$ is contained in $\left(A^{\epsilon}\right)^{-\epsilon}-\left(A^{-\epsilon}\right)^{\epsilon}$.

Proposition 5.12. Let $A$ be an adversarial Bayes classifier and let $C$ be a connected component of $A$ or $A^{C}$ with $C^{-\epsilon}=\emptyset$. Then $C$ is contained in $\left(A^{\epsilon}\right)^{-\epsilon}-\left(A^{-\epsilon}\right)^{\epsilon}$, and thus the set

$$
\begin{equation*}
\bigcup\left\{C: \text { connected components of } A \text { or } A^{C} \text { with } C^{-\epsilon}=\emptyset\right\} \tag{5.4}
\end{equation*}
$$

is contained in a degenerate set of $A$.

See Appendix G. 2 for a proof. This result has a sort of converse: A degenerate set $D$ must satisfy $\mathbf{1}_{D^{-\epsilon}}=\mathbf{1}_{\emptyset} \mathbb{P}$-a.e:

Lemma 5.13. Assume that $\mathbb{P} \ll \mu$ and let $D$ be a degenerate set for an adversarial Bayes classifier $A$. Then $\mathbb{P}\left(D^{-\epsilon}\right)=0$.

See Appendix G. 3 for a proof.
The adversarial classification risk heavily penalizes the boundary of a classifier. This observation suggests that if two connected components of a degenerate set are close together, then they must actually be included in a larger degenerate set. The ${ }^{\epsilon}$ and ${ }^{-\epsilon}$ operations combine to form this enlarging operation.

Lemma 5.14. Assume that $\mathbb{P} \ll \mu$. If $D$ is a degenerate set for an adversarial Bayes classifier $A$, then $\left(D^{\epsilon}\right)^{-\epsilon}$ is as well.

Proof. Let $A_{2}=A \cup\left(D^{\epsilon}\right)^{-\epsilon}$. Then $S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right) \geq S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right)$. We will show that $S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right)=$ $S_{\epsilon}\left(\mathbf{1}_{A}\right) \mathbb{P}_{0}$-a.e., which will then imply that $A_{2}$ is an adversarial Bayes classifier, and furthermore $A$ and $A_{2}$ are equivalent up to degeneracy by Proposition 5.1. Notice that the set $A_{2}$ satisfies

$$
A \subset A_{2} \subset\left((A \cup D)^{\epsilon}\right)^{-\epsilon}
$$

and then Lemma 5.10 implies that $A^{\epsilon} \subset\left(A \cup\left(D^{\epsilon}\right)^{-\epsilon}\right)^{\epsilon} \subset(A \cup D)^{\epsilon}$. Because $D$ is a degenerate set, $A_{3}=A \cup D$ is an adversarial Bayes classifier and thus Proposition 5.1 implies that

6. The Adversarial Bayes Classifier in One Dimension. In this section, we assume that $d=1$ and the length of an interval $I$ will be denoted $|I|$. Recall that connected subsets of $\mathbb{R}$ are either intervals or single point sets.
6.1. Regular adversarial Bayes classifiers-Proof of Theorem 3.5 and Theorem 3.7. Notice that if $I$ is a connected component of $A$ and $A^{C}$ and $|I|<2 \epsilon$, then $I^{-\epsilon}=\emptyset$. Thus the set of connected components of $A$ or $A^{C}$ of length strictly less than $2 \epsilon$ is contained in a degenerate set by Proposition 5.12.

However, if $|I|=2 \epsilon$, then $I^{-\epsilon}$ could contain a single point: if $I=[x-\epsilon, x+\epsilon]$ then $I^{-\epsilon}=\{x\}$ while $I^{-\epsilon}=\emptyset$ if $I$ is not closed. Due to this observation, the set of connected components of $A$ and $A^{C}$ of length $2 \epsilon$ is actually degenerate set as well. Thus one can argue:

Lemma 6.1. Let $\mathbb{P}_{0}, \mathbb{P}_{1} \ll \mu, A$ be an adversarial Bayes classifier. Then there are adversarial Bayes classifiers $\tilde{A}_{1}, \tilde{A}_{2}$ satisfying $\tilde{A}_{1} \subset A \subset \tilde{A}_{2}$ which are equivalent to $A$ up to degeneracy and

$$
\tilde{A}_{1}=\bigcup_{i=m}^{M}\left(\tilde{a}_{i}, \tilde{b}_{i}\right), \quad \tilde{A}_{2}^{C}=\bigcup_{j=n}^{M}\left(\tilde{e}_{j}, \tilde{f}_{j}\right)
$$

where the intervals $\left(\tilde{a}_{i}, \tilde{b}_{i}\right),\left(\tilde{e}_{i}, \tilde{f}_{i}\right)$ satisfy $\tilde{b}_{i}-\tilde{a}_{i}>2 \epsilon$ and $\tilde{f}_{i}-\tilde{e}_{i}>2 \epsilon$.
This statement is a consequence of Proposition 5.12 and Lemma 5.2.
Proof of Lemma 6.1. Lemma 5.2 implies that int $A$ and $\bar{A}$ are both adversarial Bayes classifiers equivalent to $A$, and thus Corollary 5.11 implies that $D_{1}=\left((\operatorname{int} A)^{\epsilon}\right)^{-\epsilon}-\left((\text { int } A)^{-\epsilon}\right)^{\epsilon}$ and
$D_{2}=\left((\bar{A})^{\epsilon}\right)_{\tilde{A}_{1}}^{-\epsilon}-\left((\bar{A})^{-\epsilon}\right)^{\epsilon}$ are degenerate sets. Consequently, Lemma 5.2 and Corollary 5.11 imply that $\tilde{A}_{1}=\operatorname{int} A-D_{1}, \tilde{A}_{2}=\bar{A} \cup D_{2}$, and $A$ are all equivalent up to degeneracy.

The adversarial Bayes classifier int $A$ is an open set, and thus every connected component of int $A$ is open. Therefore, if $I$ is a connected component of int $A$ of length less than or equal $2 \epsilon$, then $I^{-\epsilon}=\emptyset$ and Proposition 5.12 implies that $I \subset D_{1}$. Hence every connected component of $\tilde{A}_{1}$ has length strictly larger than $2 \epsilon$.

As $(\bar{A})^{C}$ is an open set and $\tilde{A}_{2}^{C}=(\bar{A})^{C}-D_{2}$, the same argument implies that every connected component of $\tilde{A}_{2}^{C}$ has length strictly larger than $2 \epsilon$.

This result suffices to prove Theorem 3.5, which is detailed in Appendix H, and we discuss an overview of this proof below. The classifiers $\tilde{A}_{1}$ and $\tilde{A}_{2}$ have "one-sided" regularity- the connected components of $\tilde{A}_{1}$ and $\tilde{A}_{2}^{C}$ have length strictly greater than $2 \epsilon$. Next, we use these classifiers with one-sided regularity to construct a classifier $A^{\prime}$ for which both $A^{\prime}$ and $\left(A^{\prime}\right)^{C}$ have components larger than $2 \epsilon$.

As $\tilde{A}_{1} \subset \tilde{A}_{2}$, the sets $\tilde{A}_{1}$ and $\tilde{A}_{2}^{C}$ are disjoint. Therefore, one can express $\mathbb{R}$ as a disjoint union

$$
\mathbb{R}=\tilde{A}_{1} \sqcup \tilde{A}_{2}^{C} \sqcup D
$$

Both $\tilde{A}_{1}$ and $\tilde{A}_{2}^{C}$ are a disjoint union of intervals of length greater than $2 \epsilon$, and thus the degenerate set $D=\tilde{A}_{1}^{C} \cap \tilde{A}_{2}$ must be a disjoint union of countably many intervals and isolated points. Notice that because $D$ is degenerate, the union of $\tilde{A}_{1}$ and an arbitrary measurable portion of $D$ is an adversarial Bayes classifier as well. To construct a regular adversarial Bayes classifier, we let $D_{1}$ be the connected components of $D$ that are adjacent to some open interval of $\tilde{A}_{1}$. The remaining components of $D, D_{2}=D-D_{1}$, must be adjacent to $\tilde{A}_{2}$. Therefore, if $A^{\prime}=\tilde{A}_{1} \cup D_{1}$ the connected components of $A^{\prime}=\tilde{A}_{1} \cup D_{1}$ and $\left(A^{\prime}\right)^{C}=\tilde{A}_{2} \cup D_{2}$ must have length strictly greater than $2 \epsilon$.

Next, Theorem 3.7 is a consequence of the fact that the adversarial risk of $A=\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ equals (2.7) when $A$ is regular.

Proof of Theorem 3.7. Because $b_{i}-a_{i}>2 \epsilon$ and $a_{i}-b_{i-1}>2 \epsilon$, we can treat $R^{\epsilon}(A)$ as a differentiable function of $a_{i}$ on a small open interval around $a_{i}$ as described by (2.7). The first order necessary conditions for a minimizer then imply the first relation of (2.8) and the second order necessary conditions for a minimizer then imply the first relation of (3.1). The argument for $b_{i}$ is analogous.
6.2. Degenerate Sets in One Dimension-Proof of Theorem 3.8. First, every component of $A$ or $A^{C}$ with length less than equal to $2 \epsilon$ must be degenerate. In comparison, notice that this statement is strictly stronger than Proposition 5.12.

Lemma 6.2. If a connected component $C$ of $A$ or $A^{C}$ has length less than or equal to $2 \epsilon$, then $C$ is degenerate.

Proof. Let $A$ be an adversarial Bayes classifier and let $\tilde{A}_{1}$ and $\tilde{A}_{2}$ be the two equivalent adversarial Bayes classifiers of Lemma 6.1. Because every connected component of component of $\tilde{A}_{1}$ has length strictly larger than $2 \epsilon$, the connected components of $A$ of length less than or equal to $2 \epsilon$ must be included in the degenerate set $A-\tilde{A}_{1}$. Similarly, the connected components of $A^{C}$ of length less than or equal to $2 \epsilon$ are included in $\tilde{A}_{2}^{C}-A^{C}$, which is a degenerate set.

Conversely, the length of a degenerate interval contained in $\operatorname{supp} \mathbb{P}$ is at most $2 \epsilon$.
Corollary 6.3. Let $\mathbb{P} \ll \mu$. Assume that $I \subset \operatorname{supp} \mathbb{P}$ is a degenerate interval for an adversarial Bayes classifier $A$. Then $|I| \leq 2 \epsilon$.

Proof. Lemma 5.13 implies that if $I$ is a degenerate interval then $\mathbb{P}\left(I^{-\epsilon}\right)=0$. Because $I$ is an interval, the set $I^{-\epsilon}$ is either empty, a single point, or an interval. As $I \subset \operatorname{supp} \mathbb{P}$ and every interval larger than a single point has positive measure under $\mu$, it follows that $I^{-\epsilon}$ is at most a single point and thus $|I| \leq 2 \epsilon$.

This result is then sufficient to prove the fourth bullet of Theorem 3.8. To start:
Lemma 6.4. Let $\mathbb{P} \ll \mu$ and let $A$ be an adversarial Bayes classifier. If supp $\mathbb{P}$ is an interval and the adversarial Bayes classifier $A$ has a degenerate interval I contained in $\operatorname{supp} \mathbb{P}^{\epsilon}$, then $\eta(x) \in\{0,1\}$ on a set of positive measure.
A formal proof is provided in Appendix I.1, we sketch the main ideas below, assuming that $I$ is a degenerate interval contained in int supp $\mathbb{P}^{-\epsilon}$. Let $I$ be a degenerate interval in supp $\mathbb{P}$. One can then find a 'maximal' degenerate interval $J=\left[d_{3}, d_{4}\right]$ containing $I$ inside supp $\mathbb{P}$, in the sense that if $J^{\prime}$ is a degenerate interval and $J \subset J^{\prime}$ then $J^{\prime}=J$. Corollary 6.3 implies that $|J| \leq 2 \epsilon$ and Lemma 5.14 implies that $J$ is of distance strictly more than $2 \epsilon$ from any other degenerate set. Thus the intervals $\left[d_{3}-\epsilon, d_{3}\right),\left(d_{4}, d_{4}+\epsilon\right]$ do not intersect a degenerate subset of $A$, and these intervals must be entirely contained in $A$ or $A^{C}$ due to Lemma 6.2. Thus one can compute the difference $R^{\epsilon}(A \cup J)-R^{\epsilon}(A-J)$ under four cases: 1) $\left[d_{3}-\epsilon, d_{3}\right) \subset A$, $\left.\left.\left(d_{4}, d_{4}+\epsilon\right] \subset A ; 2\right)\left[d_{3}-\epsilon, d_{3}\right) \subset A,\left(d_{4}, d_{4}+\epsilon\right] \subset A^{C} ; 3\right)\left[d_{3}-\epsilon, d_{3}\right) \subset A^{C},\left(d_{4}, d_{4}+\epsilon\right] \subset A ;$ 4) $\left[d_{3}-\epsilon, d_{3}\right) \subset A^{C},\left(d_{4}, d_{4}+\epsilon\right] \subset A^{C}$.

In each case, this difference results in $\int_{I^{\prime}} p_{1}(x) d x=0$ or $\int_{I^{\prime}} p_{0}(x) d x=0$ on some interval $I^{\prime} \subset \operatorname{int} \operatorname{supp} \mathbb{P}$, which implies either $\eta=1$ or $\eta=0$, respectively, on a set of positive measure.

Lemma 6.4 and Lemma 5.14 together imply the fourth bullet of Theorem 3.8. The argument is outlined below, with a formal proof in Appendix I.2. If $D \subset \operatorname{intsupp} \mathbb{P}^{\epsilon}$ is a degenerate set which contains two points $x \leq y$ at most $2 \epsilon$ apart, then Lemma 5.14 implies that $[x, y] \subset\left(D^{\epsilon}\right)^{-\epsilon}$ is degenerate, which would contradict Lemma 6.4. Thus $D \cap \operatorname{int} \operatorname{supp} \mathbb{P}^{\epsilon}$ must be comprised of points that are strictly more than $2 \epsilon$ apart. However, if $x \in D$ is more than $2 \epsilon$ from any point in $\partial A$, then one can argue that $R^{\epsilon}(A-\{x\})-R^{\epsilon}(A)>0$ if $x \in A$ and $R^{\epsilon}(A \cup\{x\})-R^{\epsilon}(A)>0$ if $x \notin A$. Thus if $D$ is a degenerate set is disjoint from $\overline{\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}}$, then $D$ must be contained in $\partial A$.

Combining previous results then proves Theorem 3.8- The first bullet of Theorem 3.8 is Lemma 6.2, the second bullet is Corollary 6.3, the third bullet is Lemma 5.8, and the fourth bullet is shown in Appendix I.2.

Lemma 6.4 and the fourth bullet of Theorem 3.8 are false when supp $\mathbb{P}$ is not an interval.
Example 6.5. Consider a probability distribution for which

\frac{4}{25 \epsilon} & \text { if }-\frac{1}{2} \epsilon \leq x \leq+\frac{1}{2} \epsilon \\
\frac{8}{25 \epsilon} & \text { if }+\frac{3}{2} \epsilon \leq x \leq+\frac{5}{2} \epsilon \\
0 & \text { otherwise }\end{cases}\right.
$$



Figure 3: The distribution of Example 6.5.

See Figure 3 for an illustration. Then there are no solutions $x$ to the necessary conditions (2.8) within supp $\mathbb{P}^{\epsilon}$ at which $p_{0}$ is continuous at $x \pm \epsilon$ and $p_{1}$ continuous at $x \mp \epsilon$. Thus the only possible values for the $a_{i} \mathrm{~S}$ and $b_{i} \mathrm{~S}$ within supp $\mathbb{P}^{\epsilon}$ are $\left\{-\frac{7}{2},-\frac{5}{2} \epsilon,-\frac{3}{2} \epsilon,-\frac{1}{2} \epsilon,+\frac{1}{2} \epsilon,+\frac{3}{2} \epsilon,+\frac{5}{2} \epsilon,+\frac{7}{2} \epsilon\right\}$. By comparing the risks of all adversarial Bayes classifiers with endpoints in this set, one can show that $\left(-\infty,-\frac{1}{2} \epsilon\right)$ is an adversarial Bayes classifier. At the same time, $R^{\epsilon}\left(\left(-\infty,-\frac{1}{2} \epsilon\right) \cup S\right)=$ $R^{\epsilon}\left(\left(-\infty,-\frac{1}{2} \epsilon\right)\right)$ for any subset $S$ of $\left[-\frac{1}{2} \epsilon,+\frac{1}{2} \epsilon\right]$. Thus $\left[-\frac{1}{2} \epsilon,+\frac{1}{2} \epsilon\right]$ is a degenerate set, but $\eta(x)=\frac{1}{5}$ on $\left[-\frac{1}{2} \epsilon,+\frac{1}{2} \epsilon\right]$. See Appendix K. 8 for details.
6.3. Regularity as $\epsilon$ Increases—Proof of Theorem 3.9. Let $A_{1}$ and $A_{2}$ be two regular adversarial Bayes classifiers corresponding to perturbation radiuses $\epsilon_{1}$ and $\epsilon_{2}$ respectively. Notice that the adversarial classification risk in (2.5) pays a penalty of 1 within $\epsilon$ of each $a_{i}$ and $b_{i}$. This consideration suggests that as $\epsilon$ increases, there should be fewer transitions between the two classes. The key observation is that so long as $A_{1}$ is non-trivial, no connected component of $A_{2}$ should contain a connected component of $A_{1}^{C}$ and no connected component of $A_{2}^{C}$ should contain a connected component of $A_{1}$.

We adopt additional notation to formally state this principle. When $\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ is a regular adversarial Bayes classifier and $M$ is finite, define $a_{M+1}$ to be $+\infty$. Similarly, if $m$ is finite, define $b_{m-1}$ as $-\infty$.

Lemma 6.6. Assume that $\mathbb{P} \ll \mu$ is a measure for which $\operatorname{supp} \mathbb{P}$ is an interval $I$ and $\mathbb{P}(\eta(x)=0$ or 1$)=0$. Let $A_{1}=\bigcup_{i=m}^{M}\left(a_{i}^{1}, b_{i}^{1}\right)$ and $A_{2}=\bigcup_{j=n}^{N}\left(a_{j}^{2}, b_{j}^{2}\right)$ be two regular adversarial Bayes classifiers corresponding to perturbation sizes $\epsilon_{1}<\epsilon_{2}$.

- If both $\mathbb{R}$ and $\emptyset$ are adversarial Bayes classifiers for perturbation radius $\epsilon_{1}$, then both $\mathbb{R}$ and $\emptyset$ are adversarial Bayes classifiers for perturbation radius $\epsilon_{2}$.
- Assume that $\mathbb{R}$ and $\emptyset$ are not both adversarial Bayes classifiers for perturbation radius $\epsilon_{1}$. Then for each interval $\left(a_{i}^{1}, b_{i}^{1}\right)$, the set $\left(a_{i}^{1}, b_{i}^{1}\right) \cap I^{\epsilon_{1}}$ cannot contain any non-empty $\left(b_{j}^{2}, a_{j+1}^{2}\right) \cap I^{\epsilon_{1}}$ and for each interval $\left(b_{i}^{1}, a_{i+1}^{1}\right)$, the set $\left(b_{i}^{1}, a_{i+1}^{1}\right) \cap I^{\epsilon_{1}}$ cannot contain any non-empty $\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}}$.

Example 4.1 demonstrates the the exception to the second bullet - when $\epsilon \geq\left(\mu_{1}-\mu_{0}\right) / 2$, both $\mathbb{R}$ and $\emptyset$ are adversarial Bayes classifiers.

To prove Lemma 6.6, notice that if $A_{2}=\bigcup_{i=1}^{M}\left(a_{i}^{2}, b_{i}^{2}\right)$ is a regular adversarial Bayes
classifier and $\left(a_{j}^{2}, b_{j}^{2}\right) \subset I^{-\epsilon_{2}}$, then $R^{\epsilon_{2}}\left(A_{2}-\left(a_{j}^{2}, b_{j}^{2}\right)\right) \geq R^{\epsilon_{2}}\left(A_{2}\right)$ which is equivalent to
$0 \leq \int_{a_{j}^{2}-\epsilon_{2}}^{b_{j}^{2}+\epsilon_{2}} p_{1} d x-\left(\int_{a_{j}^{2}-\epsilon_{2}}^{a_{j}^{2}+\epsilon_{2}} p d x+\int_{a_{j}^{2}+\epsilon_{2}}^{b_{j}^{2}-\epsilon_{2}} p_{0} d x+\int_{b_{j}^{2}-\epsilon_{2}}^{b_{j}^{2}+\epsilon_{2}} p d x\right)=\int_{a_{j}^{2}+\epsilon_{2}}^{b_{j}^{2}-\epsilon_{2}} p_{1}(x) d x-\int_{a_{j}^{2}-\epsilon_{2}}^{b_{j}^{2}+\epsilon_{2}} p_{0}(x) d x$
As $p_{0}, p_{1}$ are non-zero on $\operatorname{supp} \mathbb{P}$, replacing $\epsilon_{2}$ with $\epsilon_{1}$ in this last expression would increase the first integral and decrease the second, thereby increasing the entire expression.

Thus, if $\left(a_{j}^{2}-\epsilon_{1}, b_{j}^{2}+\epsilon_{1}\right) \subset A_{1}^{C}$, this calculation would imply that $R^{\epsilon_{1}}\left(A_{1} \cup\left(a_{i}^{2}, b_{i}^{2}\right)\right)<$ $R^{\epsilon_{1}}\left(A_{1}\right)$, which would contradict the fact that $A_{1}$ is an adversarial Bayes classifier. Similar but more technical calculations performed in Appendix J show that if $\left(a_{i}^{2}, b_{i}^{2}\right) \subset A_{1}^{C} \cap I^{\epsilon_{1}}$ then $R^{\epsilon_{1}}\left(A_{1} \cup\left(a_{i}^{2}, b_{i}^{2}\right)\right)<R^{\epsilon_{1}}\left(A_{1}\right)$ and so $A_{1}$ cannot be an adversarial Bayes classifier.
7. Related Works. Prior work analyzes several variations of our setup, such as perturbations in open balls [6], alternative perturbation sets [4], attacks using general Wasserstein $p$-metrics [22, 21], minimizing $R^{\epsilon}$ over Lebesgue measurable sets [19], the multiclass setting [21], and randomized classifiers [12, 21]. Due to the plethora of attacks present in the literature, this paper contains proofs of all intermediate results that appear in prior work. Understanding the uniqueness of the adversarial Bayes classifier in these contexts remains an open question. Establishing a notion of uniqueness for randomized classifiers in the adversarial context is particularly interesting, as randomized classifiers are essential in calculating the minimal possible error in adversarial multiclass classification [21] but not binary classification [12].

Prior work $[1,4,18]$ adopts a different method for identifying adversarial Bayes classifiers for various distributions. To prove a set is an adversarial Bayes classifier, [4] first show a strong duality result $\inf _{A} R^{\epsilon}(A)=\sup _{\gamma} \tilde{D}(\gamma)$ for some dual risk $\tilde{D}$ on the set of couplings between $\mathbb{P}_{0}$ and $\mathbb{P}_{1}$. Subsequently, $[1,4,18]$ exhibit a set $A$ and a coupling $\gamma$ for which the adversarial risk of $A$ matches the dual risk of $\gamma$, and thus $A$ must minimize the adversarial classification risk. This approach involves solving the first order necessary conditions (2.8), and [1] relies on a result of [22] which states that these relations hold for sufficiently small $\epsilon$ under reasonable assumptions. In contrast, this paper uses equivalence up to degeneracy to show that it suffices to consider sets with enough regularity for the first order necessary conditions to hold; and the solutions to these conditions typically reduce the possibilities for the adversarial Bayes classifier to a finite number of sets.

Prior work on regularity [2, 6] prove the existence of adversarial Bayes classifiers with one sided tangent balls. Theorem 3.10 states that each equivalence class under equivalence up to degeneracy has a representative with this type of regularity. Furthermore, results of [1] imply that under reasonable assumptions, one can choose adversarial Bayes classifiers $A(\epsilon)$ for which $\operatorname{comp}(A(\epsilon))+\operatorname{comp}\left(A(\epsilon)^{C}\right)$ is always decreasing in $\epsilon$. Specifically, they show that for increasing $\epsilon$, the only possible discontinuous changes in $A(\epsilon)$ are merged components, deleted components, or a endpoint of a component changing discontinuously in $\epsilon$. This statement does not imply Lemma 6.6, and Lemma 6.6 does not imply this result of [1].
8. Conclusion. We defined a new notion of uniqueness for the adversarial Bayes classifier, which we call uniqueness up to degeneracy, that generalizes the definition of uniqueness for the Bayes classifier. The concept of uniqueness up to degeneracy produces a method for calculating the adversarial Bayes classifier for a reasonable family of distributions in one dimension, and
assists in understanding their regularity properties. We hope that the theoretical insights in this paper will assist in the development of algorithms for robust learning.

## Appendix A. Proof of Lemma 2.1.

First, the $S_{\epsilon}$ operation satisfies a subadditivity property:
Lemma A.1. Let $S_{1}$ and $S_{2}$ be two subsets of $\mathbb{R}^{d}$. Then

S_{\epsilon}\left(\mathbf{1}_{S_{1}}\right)+S_{\epsilon}\left(\mathbf{1}_{S_{2}}\right) \geq S_{\epsilon}\left(\mathbf{1}_{S_{1} \cap S_{2}}\right)+S_{\epsilon}\left(\mathbf{1}_{S_{1} \cup S_{2}}\right) \tag{A.1}
\end{equation*}
$$

Proof. First, notice that

$$
\begin{align*}
& S_{\epsilon}\left(\mathbf{1}_{S_{1}}\right)(\mathbf{x})+S_{\epsilon}\left(\mathbf{1}_{S_{2}}\right)(\mathbf{x})= \begin{cases}0 & \text { if } \mathbf{x} \notin S_{1}^{\epsilon} \text { and } \mathbf{x} \notin S_{2}^{\epsilon} \\
1 & \text { if } \mathbf{x} \in S_{1}^{\epsilon} \triangle S_{2}^{\epsilon} \\
2 & \text { if } \mathbf{x} \in S_{1}^{\epsilon} \cap S_{2}^{\epsilon}\end{cases}  \tag{A.2}\\
& =\mathbf{1}_{S_{1}^{\epsilon} \cap S_{2}^{\epsilon}}(\mathbf{x})+\mathbf{1}_{S_{1}^{\epsilon} \cup S_{2}^{\epsilon}}(\mathbf{x})
\end{align*}
$$

Next, one can always swap the order of two maximums but a min-max is always larger than a max-min. Therefore:

$$
\begin{align*}
& S_{\epsilon}\left(\mathbf{1}_{S_{1} \cap S_{2}}\right)+S_{\epsilon}\left(\mathbf{1}_{S_{1} \cup S_{2}}\right)=S_{\epsilon}\left(\min \left(\mathbf{1}_{S_{1}}, \mathbf{1}_{S_{2}}\right)\right)+S_{\epsilon}\left(\max \left(\mathbf{1}_{S_{1}}, \mathbf{1}_{S_{2}}\right)\right) \\
& \leq \min \left(S_{\epsilon}\left(\mathbf{1}_{S_{1}}\right), S_{\epsilon}\left(\mathbf{1}_{S_{2}}\right)\right)+\max \left(S_{\epsilon}\left(\mathbf{1}_{S_{1}}\right), S_{\epsilon}\left(\mathbf{1}_{S_{2}}\right)\right)=\mathbf{1}_{S_{1}^{\epsilon} \cap S_{2}^{\epsilon}}+\mathbf{1}_{S_{1}^{\epsilon} \cup S_{2}^{\epsilon}} \tag{A.3}
\end{align*}
$$

Comparing (A.2) and (A.3) results in (A.1).
Therefore, the adversarial classification risk is sub-additive.
Corollary A.2. Let $S_{1}$ and $S_{2}$ be any two sets. Then

$$
R^{\epsilon}\left(S_{1} \cap S_{2}\right)+R^{\epsilon}\left(S_{1} \cup S_{2}\right) \leq R^{\epsilon}\left(S_{1}\right)+R^{\epsilon}\left(S_{2}\right)
$$

This result then directly implies Lemma 2.1:
Proof of Lemma 2.1. Let $A_{1}$ and $A_{2}$ be two adversarial Bayes classifiers, and let $R_{*}^{\epsilon}$ be the minimal adversarial Bayes risk. Then Corollary A. 2 implies that

$$
2 R_{*}^{\epsilon} \geq R^{\epsilon}\left(A_{1} \cup A_{2}\right)+R^{\epsilon}\left(A_{1} \cap A_{2}\right)
$$

and hence $A_{1} \cap A_{2}$ and $A_{1} \cup A_{2}$ must be adversarial Bayes classifiers as well.

## Appendix B. Complementary Slackness- Proof of Theorem 2.4.

The complementary slackness relations of Theorem 2.4 are a consequence of the minimax relation of Theorem 2.3 and properties of the $W_{\infty}$ metric.

Integrating the maximum of an indicator function over an $\epsilon$-ball is intimately linked to maximizing an integral over a $W_{\infty}$ ball of measures:

Lemma B.1. Let $\mathbb{Q}$ be a positive measure. Then for any Borel set $A$

$$
\int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{Q} \geq \sup _{\mathbb{Q}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}(\mathbb{Q})} \int g d \mathbb{Q}^{\prime}
$$

Lemma 5.1 of [19] and Lemma 3 of [11] proved slightly different versions of this result, so we include a proof here for completeness.

Proof. Let $\mathbb{Q}^{\prime}$ be any measure with $W_{\infty}\left(\mathbb{Q}, \mathbb{Q}^{\prime}\right) \leq \epsilon$ and let $\gamma$ be any coupling between for which

$$
\underset{(\mathbf{x}, \mathbf{y}) \sim \gamma}{\operatorname{ess} \sup }\|\mathbf{x}-\mathbf{y}\|=W_{\infty}\left(\mathbb{Q}, \mathbb{Q}^{\prime}\right) .
$$

Such a coupling exists by Theorem 2.6 of [14]. Then $S_{\epsilon}\left(\mathbf{1}_{A}\right)(\mathbf{x}) \geq \mathbf{1}_{A}(\mathbf{y}) \gamma$-a.e. Thus

$$
\int S_{\epsilon}\left(\mathbf{1}_{A}\right)(\mathbf{x}) d \mathbb{Q}(\mathbf{x})=\int S_{\epsilon}\left(\mathbf{1}_{A}\right)(\mathbf{x}) d \gamma(\mathbf{x}, \mathbf{y}) \geq \int \mathbf{1}_{A} d \gamma(\mathbf{x}, \mathbf{y})=\int \mathbf{1}_{A}(\mathbf{y}) d \mathbb{Q}^{\prime}(\mathbf{y})
$$

Now taking a supremum over all $\mathbb{Q}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}(\mathbb{Q})$ concludes the proof.
One can prove Theorem 2.4 with this result.

## Proof of Theorem 2.4.

## Forward Direction:

Let $A$ be a minimizer of $R^{\epsilon}$ and assume that $\mathbb{P}_{0}^{*} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{0}\right), \mathbb{P}_{1}^{*} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)$ maximize $\bar{R}$. Then:

$$
\begin{align*}
& R^{\epsilon}(A)=\int S_{\epsilon}\left(\mathbf{1}_{A}{ }^{C}\right) d \mathbb{P}_{1}+\int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{P}_{0} \geq \int \mathbf{1}_{A^{C}} d \mathbb{P}_{1}^{*}+\int \mathbf{1}_{A} d \mathbb{P}_{0}^{*}  \tag{B.1}\\
& =\int \eta^{*} \mathbf{1}_{A} d \mathbb{P}_{1}+\int\left(1-\eta^{*}\right) \mathbf{1}_{A} d \mathbb{P}_{0}^{*} \geq \int C^{*}\left(\eta^{*}\right) d \mathbb{P}^{*}=\bar{R}\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right) \tag{B.2}
\end{align*}
$$

The first inequality follows from Lemma B. 1 while the second inequality follows from the definition of $C^{*}$ in (2.3). By Theorem 2.3, the first expression of (B.1) and the last expression of (B.2) are equal. Thus all the inequalities above must in fact be equalities. Thus the fact that the inequality in (B.2) is an equality implies (2.12). Lemma B. 1 and the fact that the inequality in (B.1) must be an equality implies (2.11).

## Backward Direction:

Let $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$ be measures satisfying $W_{\infty}\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{0}\right) \leq \epsilon, W_{\infty}\left(\mathbb{P}_{1}^{*}, \mathbb{P}_{1}\right) \leq \epsilon$, and let $A$ be a Borel set. Assume that $A, \mathbb{P}_{0}^{*}$, and $\mathbb{P}_{1}^{*}$ satisfy (2.11) and (2.12). We will argue that $A$ is must be a minimizer of $R^{\epsilon}$ and $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$ must maximize $\bar{R}$.

First, notice that Theorem 2.3 implies that $R^{\epsilon}\left(A^{\prime}\right) \geq \bar{R}\left(\mathbb{P}_{0}^{\prime}, \mathbb{P}_{1}^{\prime}\right)$ for any Borel $A^{\prime}$ and $\mathbb{P}_{0}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{0}\right), \mathbb{P}_{1}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)$. Thus if one can show

$$
\begin{equation*}
R^{\epsilon}(A)=\bar{R}\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right) \tag{B.3}
\end{equation*}
$$

then $A$ must minimize $R^{\epsilon}$ because for any other $A^{\prime}$,

$$
R^{\epsilon}\left(A^{\prime}\right) \geq \bar{R}\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right)=R^{\epsilon}(A)
$$

Similarly, one could conclude that $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$ maximize $\bar{R}$ because for any other $\mathbb{P}_{0}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{0}\right)$ and $\mathbb{P}_{1}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)$,

$$
\bar{R}\left(\mathbb{P}_{0}^{\prime}, \mathbb{P}_{1}^{\prime}\right) \leq R^{\epsilon}(A)=\bar{R}\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right)
$$

Hence it remains to show (B.3). Applying (2.11) followed by (2.12), one can conclude that

$$
\begin{align*}
R^{\epsilon}(A) & =\int S_{\epsilon}\left(\mathbf{1}_{A}^{C}\right) d \mathbb{P}_{1}+\int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{P}_{0}=\int \mathbf{1}_{A} C d \mathbb{P}_{1}^{*}+\int \mathbf{1}_{A} d \mathbb{P}_{0}^{*}  \tag{2.11}\\
& =\int \eta^{*} \mathbf{1}_{A^{C}}+\left(1-\eta^{*}\right) \mathbf{1}_{A} d \mathbb{P}^{*}=\int C^{*}\left(\eta^{*}\right) d \mathbb{P}^{*}=\bar{R}\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right) \tag{2.12}
\end{align*}
$$

Appendix C. Proof of Proposition 5.1 and Lemma 5.2.
The proof of Proposition 5.1 relies on Lemma 5.2.
C.1. Proof of Lemma 5.2. The ${ }^{\epsilon}$ operation on sets interacts particularly nicely with Lebesgue measure.

Lemma C.1. For any set $A$ and $\epsilon>0, \partial A^{\epsilon}$ has Lebesgue measure zero.
This result is standard in geometric measure theory, see for instance Lemma 4 in [2] for a proof. Next, the closure and ${ }^{\epsilon}$ operations commute:

Lemma C.2. Let $A$ be any set in $\mathbb{R}^{d}$. Then $\overline{A^{\epsilon}}=\bar{A}^{\epsilon}$.
Proof. We show the two inclusions $\overline{A^{\epsilon}} \subset \bar{A}^{\epsilon}$ and $\overline{A^{\epsilon}} \supset \bar{A}^{\epsilon}$ separately.
Showing $\overline{A^{\epsilon}} \subset \bar{A}^{\epsilon}$ : First, because the direct sum of a closed set and a compact set must be closed, $\bar{A}^{\epsilon}$ is a closed set that contains $A^{\epsilon}$. Therefore, because $\overline{A^{\epsilon}}$ is the smallest closed set containing $A^{\epsilon}$, the set $\overline{A^{\epsilon}}$ must be contained in $\bar{A}^{\epsilon}$.

Showing $\overline{A^{\epsilon}} \supset \bar{A}^{\epsilon}$ : Let $\mathbf{x} \in \bar{A}^{\epsilon}$, we will show that $\mathbf{x} \in \overline{A^{\epsilon}}$. If $\mathbf{x} \in \overline{A^{\epsilon}}$, then $\mathbf{x}=\mathbf{a}+\mathbf{h}$ for some $\mathbf{a} \in \bar{A}$ and $\mathbf{h} \in \overline{B_{\epsilon}(\mathbf{0})}$. Let $\mathbf{a}_{i}$ be a sequence of points contained in $A$ that converges to a. Then $\mathbf{a}_{i}+\mathbf{h} \in A^{\epsilon}$, and $\mathbf{a}_{i}+\mathbf{h}$ converges to $\mathbf{a}+\mathbf{h}$. Therefore, $\mathbf{a}+\mathbf{h} \in \overline{A^{\epsilon}}$.

Next, this result implies that the sets $(\operatorname{int} A)^{\epsilon}, A^{\epsilon}$ and $\bar{A}^{\epsilon}$ all have equal $\mathbb{P}_{0}$ measure while $\left((\operatorname{int} A)^{C}\right)^{\epsilon},\left(A^{C}\right)^{\epsilon}$, and $\left(\bar{A}^{C}\right)^{\epsilon}$ have equal $\mathbb{P}_{1}$-measure.

Lemma C.3. If $A$ is any adversarial Bayes classifier and $\epsilon>0$, then $\mathbb{P}_{0}\left(A^{\epsilon}\right)=\mathbb{P}_{0}\left(\bar{A}^{\epsilon}\right)=$ $\mathbb{P}_{0}\left((\operatorname{int} A)^{\epsilon}\right)$ and $\mathbb{P}_{1}\left(\left(A^{C}\right)^{\epsilon}\right)=\mathbb{P}_{1}\left(\left((\operatorname{int} A)^{C}\right)^{\epsilon}\right)=\mathbb{P}_{1}\left(\left(\bar{A}^{C}\right)^{\epsilon}\right)$.

Proof. First, Lemmas C. 1 and C. 2 imply that

$$
\begin{equation*}
\mathbb{P}_{0}\left(A^{\epsilon}\right)=\mathbb{P}_{0}\left(\overline{A^{\epsilon}}\right)=\mathbb{P}_{0}\left(\bar{A}^{\epsilon}\right) \tag{C.1}
\end{equation*}
$$

Furthermore, $\mathbb{P}_{1}\left(\left(A^{C}\right)^{\epsilon}\right) \geq \mathbb{P}_{1}\left(\left(\bar{A}^{C}\right)^{\epsilon}\right)$ and thus $R^{\epsilon}(A) \geq R^{\epsilon}(\bar{A})$. Consequently, $\bar{A}$ must be an adversarial Bayes classifier and

$$
\begin{equation*}
\mathbb{P}_{1}\left(\left(A^{C}\right)^{\epsilon}\right)=\mathbb{P}_{1}\left(\left(\bar{A}^{C}\right)^{\epsilon}\right) \tag{C.2}
\end{equation*}
$$

A similar line of reasoning shows that

$$
\begin{equation*}
\mathbb{P}_{1}\left(\overline{\left(A^{C}\right)^{\epsilon}}\right)=\mathbb{P}_{1}\left(\overline{\left(A^{C}\right)^{\epsilon}}\right)=\mathbb{P}_{1}\left(\left(\operatorname{int} A^{C}\right)^{\epsilon}\right) \tag{C.3}
\end{equation*}
$$

and thus

$$
\begin{equation*}
\mathbb{P}_{0}\left(A^{\epsilon}\right)=\mathbb{P}_{0}\left((\operatorname{int} A)^{\epsilon}\right) \tag{C.4}
\end{equation*}
$$

Equations (C.1)-(C.4) imply the desired result.
Finally, Lemma C. 3 implies that $\operatorname{int} A, A$ and $\bar{A}$ are all equivalent up to degeneracy.
Proof of Lemma 5.2. Lemma C. 3 implies that if $E$ is any measurable set with int $A \subset E \subset$ $\bar{A}$, then $\mathbb{P}_{0}\left(E^{\epsilon}\right)=\mathbb{P}_{0}\left(A^{\epsilon}\right)$ and $\mathbb{P}_{1}\left(\left(E^{C}\right)^{\epsilon}\right)=\mathbb{P}_{1}\left(\left(A^{C}\right)^{\epsilon}\right)$. Therefore, $E$ must be an adversarial Bayes classifier.
C.2. Proof of Proposition 5.1. The following lemma show that Item 2) implies Item 1).

Lemma C.4. Let $A_{1}$ and $A_{2}$ be adversarial Bayes classifiers for which either $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=$ $S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right) \mathbb{P}_{0}$-a.e. or $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right)$ - $\mathbb{P}_{1}$-a.e. Then

S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{1} \cap A_{2}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{1} \cup A_{2}}\right) \quad \mathbb{P}_{0} \text {-a.e. } \tag{C.5}
\end{equation*}
$$

and

$$
\begin{equation*}
S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{\left(A_{1} \cap A_{2}\right)^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{\left(A_{1} \cup A_{2}\right)^{C}}\right) \quad \mathbb{P}_{1} \text {-a.e. } \tag{C.6}
\end{equation*}
$$

See Appendix C.2.1 for a proof. As a result:
Corollary C.5. Let $A_{1}$ and $A_{2}$ be two adversarial Bayes classifiers. Then $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right)$ $\mathbb{P}_{0}$-a.e. iff $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right) \mathbb{P}_{1}$-a.e.
Furthermore, the last equality in (C.5) and (C.6) implies that $A_{1}$ and $A_{2}$ are equivalent up to degeneracy.

This result suffices to prove the equivalence between Item 2) and Item 3), even when $\mathbb{P}$ is not absolutely continuous with respect to Lebesgue measure.

Lemma C.6. Let $A_{1}$ and $A_{2}$ be two adversarial Bayes classifiers for $\epsilon>0$, and let $\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right)$ be a maximizer of $\bar{R}$. Define $\mathbb{P}^{*}=\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$.

The following are equivalent:
2) Either $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right)-\mathbb{P}_{0}$-a.e. or $S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)-\mathbb{P}_{1}$-a.e.
3) $\mathbb{P}^{*}\left(A_{2} \triangle A_{1}\right)=0$

Proof. Assume that $A_{1}$ and $A_{2}$ are both adversarial Bayes classifiers. Lemma 2.1 then implies that $A_{1} \cup A_{2}, A_{1} \cap A_{2}$ are both adversarial Bayes classifiers. Equation (2.11) of Theorem 2.4 implies that
$\int S_{\epsilon}\left(\mathbf{1}_{A_{1} \cup A_{2}}\right) d \mathbb{P}_{0}=\int \mathbf{1}_{A_{1} \cup A_{2}} d \mathbb{P}_{0}^{*}=\int \mathbf{1}_{A_{1} \cap A_{2}} d \mathbb{P}_{0}^{*}+\mathbb{P}_{0}^{*}\left(A_{1} \triangle A_{2}\right)=\int S_{\epsilon}\left(\mathbf{1}_{A_{1} \cap A_{2}}\right) d \mathbb{P}_{0}+\mathbb{P}_{0}^{*}\left(A_{1} \triangle A_{2}\right)$
Because $S_{\epsilon}\left(\mathbf{1}_{A_{1} \cap A_{2}}\right) \leq S_{\epsilon}\left(\mathbf{1}_{A_{1} \cup A_{2}}\right), \mathbb{P}_{0}^{*}\left(A_{1} \triangle A_{2}\right)=0$ is equivalent to $S_{\epsilon}\left(\mathbf{1}_{A_{1} \cap A_{2}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{1} \cup A_{2}}\right)$ $\mathbb{P}_{0}$-a.e. Next, $S_{\epsilon}\left(\mathbf{1}_{A_{1} \cap A_{2}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{1} \cup A_{2}}\right) \mathbb{P}_{0}$-a.e. is equivalent to $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right) \mathbb{P}_{0}$-a.e. by Lemma C.4. Therefore, Corollary C. 5 implies that $\mathbb{P}_{0}^{*}\left(A_{1} \triangle A_{2}\right)=0$ is equivalent to Item 2).

The same argument implies that $\mathbb{P}_{1}^{*}\left(A_{1} \triangle A_{2}\right)=0$ is equivalent to Item 2). Lastly, $\mathbb{P}^{*}\left(A_{1} \triangle A_{2}\right)=0$ is equivalent to $\mathbb{P}_{0}^{*}\left(A_{1} \triangle A_{2}\right)=0$ and $\mathbb{P}_{1}^{*}\left(A_{1} \triangle A_{2}\right)=0$.

Next, the equivalence of Item 1) with Item 3) in Proposition 5.1 is a consequence of Lemma C. 3 and an additional result on the ${ }^{\epsilon}$ operation.

Lemma C.7. Let $U$ be an open set and let $\mathbb{Q}$ be the set of rational numbers. Further assume $\epsilon>0$. Then $U^{\epsilon}=\left(U \cap \mathbb{Q}^{d}\right)^{\epsilon}=\left(U \cap\left(\mathbb{Q}^{d}\right)^{C}\right)^{\epsilon}$.

See Appendix C.2.2 for a proof.
Proof of Proposition 5.1. Lemma C. 6 states that Item 3) implies Item 2). It remains to show Item 2) implies Item 1) and Item 1) implies Item 3).

Item 2) $\Rightarrow$ Item 1): Assume that Item 2) holds; then Corollary C. 5 implies that both $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right) \mathbb{P}_{0}$-a.e. and $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right) \mathbb{P}_{1}$-a.e. Lemma C. 4 implies than any set
$A$ with $A_{1} \cap A_{2} \subset A \subset A_{1} \cup A_{2}$ satisfies $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A}\right) \mathbb{P}_{0}$-a.e. and $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right)$ $\mathbb{P}_{1}$-a.e. Therefore $R^{\epsilon}(A)=R^{\epsilon}\left(A_{1}\right)$ so $A$ is also an adversarial Bayes classifier.

Item 1) $\Rightarrow$ Item 3): Assume that for all $A$ satisfying $A_{1} \cap A_{2} \subset A \subset A_{1} \cup A_{2}$, the set $A$ is an adversarial Bayes classifier. Define $A_{3}=A_{1} \cap A_{2}, A_{4}=A_{1} \cup A_{2}$, and $D=A_{1} \triangle A_{2}$. As $A_{3} \sqcup D \sqcup A_{4}^{C}=\mathbb{R}^{d}$, the boundary $\partial D$ is included in $\partial A_{3} \cup \partial A_{4}$.

We split $D$ into four disjoint sets, $D_{1}=\operatorname{int} D \cap \mathbb{Q}^{d}, D_{2}=\operatorname{int} D \cap\left(\mathbb{Q}^{d}\right)^{C}, D_{3}=D \cap \partial D \cap \partial A_{3}$, and $D_{4}=D \cap \partial D \cap \partial A_{4}-D_{3}$. Notice that these four sets satisfy $D=D_{1} \sqcup D_{2} \sqcup D_{3} \sqcup D_{4}$. Next, we will prove that each for these four sets has $\mathbb{P}^{*}$-measure zero.

Because $D$ is a degenerate set, the sets $A_{3} \cup D_{1}, A_{3} \cup D_{2}$, and $A_{3} \cup$ int $D$ are all adversarial Bayes classifiers. However, Lemma C. 7 implies that $D_{1}^{\epsilon}=D_{2}^{\epsilon}=\operatorname{int} D^{\epsilon}$ and therefore $S_{\epsilon}\left(\mathbf{1}_{A_{3} \cup D_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{3} \cup \text { int } D}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{3} \cup D_{2}}\right)$. Because each of these sets is an adversarial Bayes classifier, Equation (2.11) of Theorem 2.4 implies that $\mathbb{P}_{0}^{*}\left(A_{3} \cup D_{1}\right)=\mathbb{P}_{0}^{*}\left(A_{3} \cup\right.$ int $\left.D\right)=\mathbb{P}_{0}^{*}\left(A_{3} \cup\right.$ $\left.D_{2}\right)$. As $D_{1}$ and $D_{2}$ are disjoint sets whose union is int $D$, it follows that $\mathbb{P}_{0}^{*}(\operatorname{int} D)=0$. Analogously, comparing $S_{\epsilon}\left(\mathbf{1}_{\left(A_{4}-D_{1}\right)^{C}}\right), S_{\epsilon}\left(\mathbf{1}_{\left(A_{4}-D_{2}\right)^{C}}\right)$, and $S_{\epsilon}\left(\mathbf{1}_{\left(A_{4}-\text { int } D\right)^{C}}\right)$ results in $\mathbb{P}_{1}^{*}(\operatorname{int} D)=0$.

Next we argue that $\mathbb{P}^{*}\left(D_{3}\right)=0$. Lemma C. 3 implies that $S_{\epsilon}\left(\mathbf{1}_{A_{3} \cup D_{3}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{3}}\right) \mathbb{P}_{0}$-a.e., and (2.11) of Theorem 2.4 then implies that $\mathbb{P}_{0}^{*}\left(A_{3} \cup D_{3}\right)=\mathbb{P}_{0}^{*}\left(A_{3}\right)$. Thus $\mathbb{P}_{0}^{*}\left(D_{3}\right)=0$ because $A_{3}$ and $D_{3}$ are disjoint. Similarly, Lemma C. 3 implies that $S_{\epsilon}\left(\mathbf{1}_{\left(A_{3} \cup D_{3}\right)^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{3}^{C}-D_{3}}\right)=$ $S_{\epsilon}\left(\mathbf{1}_{A_{3}^{C}}\right) \mathbb{P}_{1}$-a.e., and (2.11) of Theorem 2.4 then implies that $\mathbb{P}_{1}^{*}\left(A_{3}^{C}-D_{3}\right)=\mathbb{P}_{1}^{*}\left(A_{3}^{C}\right)$, and thus $\mathbb{P}_{1}^{*}\left(D_{3}\right)=0$.

Similarly, one can conclude that $\mathbb{P}^{*}\left(D_{4}\right)=0$ by comparing $A_{4}, A_{4}-D_{4}$, and $A_{4} \cup D_{4}$.

## C.2.1. Proof of Lemma C.4.

Proof of Lemma C.4. We will assume that $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right) \mathbb{P}_{0}$-a.e., the argument for $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right) \mathbb{P}_{1}$-a.e. is analogous. If $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right) \mathbb{P}_{0}$-a.e., then

$$
S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=\max \left(S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right), S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right)\right)=S_{\epsilon}\left(\max \left(\mathbf{1}_{A_{1}}, \mathbf{1}_{A_{2}}\right)\right)=S_{\epsilon}\left(\mathbf{1}_{A_{1} \cup A_{2}}\right) \quad \mathbb{P}_{0} \text {-a.e. }
$$

However, $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right) \geq S_{\epsilon}\left(\mathbf{1}_{\left(A_{1} \cup A_{2}\right)^{C}}\right)$. If this inequality were strict on a set of positive $\mathbb{P}_{1^{-}}$ measure, we would have $R^{\epsilon}\left(A_{1} \cup A_{2}\right)<R^{\epsilon}\left(A_{1}\right)$ which would contradict the fact that $A_{1}$ is an adversarial Bayes classifier. Thus $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{\left(A_{1} \cup A_{2}\right)^{C}}\right) \mathbb{P}_{1}$-a.e. The same argument applied to $A_{2}$ then shows that $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{\left(A_{1} \cup A_{2}\right)^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right) \mathbb{P}_{1}$-a.e.

Now as $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right) \mathbb{P}_{1}$-a.e., one can conclude that

$$
S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right)=\max \left(S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right), S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right)\right)=S_{\epsilon}\left(\mathbf{1}_{\left.\left(A_{1} \cap A_{2}\right)^{C}\right)} \quad \mathbb{P}_{1}\right. \text {-a.e. }
$$

An analogous argument implies (C.5).
C.2.2. Proof of Lemma C.7. Before proving Lemma C.7, we reproduce another useful intermediate result from [2].

Lemma C.8. Let $\mathbf{a}_{n}$ be a sequence that approaches $\mathbf{a}$. Then $B_{\epsilon}(\mathbf{a}) \subset \bigcup_{n=1}^{\infty} B_{\epsilon}\left(\mathbf{a}_{n}\right)$.
Proof. Let $\mathbf{y}$ be any point in $B_{\epsilon}(\mathbf{a})$ and let $\delta=\|\mathbf{y}-\mathbf{a}\|$. Pick $n$ large enough so that $\left\|\mathbf{a}-\mathbf{a}_{n}\right\|<\epsilon-\delta$. Then

$$
\left\|\mathbf{y}-\mathbf{a}_{n}\right\| \leq\left\|\mathbf{a}-\mathbf{a}_{n}\right\|+\|\mathbf{y}-\mathbf{a}\|<\epsilon-\delta+\delta=\epsilon
$$

and thus $\mathbf{y} \in B_{\epsilon}\left(\mathbf{a}_{n}\right)$.

Proof of Lemma C.7. We will argue that $U^{\epsilon}=\left(U \cap \mathbb{Q}^{d}\right)^{\epsilon}$, the argument for $U \cap\left(\mathbb{Q}^{d}\right)^{C}$ is analogous.

First, $U \cap \mathbb{Q}^{d} \subset U$ implies that $\left(U \cap \mathbb{Q}^{d}\right)^{\epsilon} \subset U^{\epsilon}$.
For the opposite containment, let $\mathbf{u}$ be any point in $U$. We will argue that $\overline{B_{\epsilon}(\mathbf{u})} \subset(U \cap \mathbb{Q})^{\epsilon}$. Because $U$ is open, there is a ball $B_{r}(\mathbf{u})$ contained in $U$. Because $\mathbb{Q}^{d}$ is dense in $\mathbb{R}^{d}$, for every $\mathbf{y} \in B_{r}(\mathbf{u})$, there is a sequence $\mathbf{y}_{n} \in \mathbb{Q}$ converging to $\mathbf{y}$. Thus Lemma C. 8 implies that

$$
\overline{B_{\epsilon}(\mathbf{u})} \subset B_{r}(\mathbf{u})^{\epsilon} \subset\left(B_{r}(\mathbf{u}) \cap \mathbb{Q}^{d}\right)^{\epsilon} \subset\left(U \cap \mathbb{Q}^{d}\right)^{\epsilon}
$$

Taking a union over all $\mathbf{u} \in U$ results in $U^{\epsilon} \subset\left(U \cap \mathbb{Q}^{d}\right)^{\epsilon}$.

## Appendix D. Proof of Theorem 3.4.

D.1. Proof of Lemma 5.3. Lemma 24 of [11] show that there exists a function $\hat{\eta}$ and maximizers $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$ of $\bar{R}$ for which optimal attacks on $\hat{\eta}$ are are given by $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$ :

Proposition D.1. There exists a function $\hat{\eta}: \mathbb{R}^{d} \rightarrow[0,1]$ and measures $\mathbb{P}_{0}^{*} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{0}\right)$, $\mathbb{P}_{1}^{*} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)$ with the following properties:

1. Let $\mathbb{P}^{*}=\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$ and $\eta^{*}=d \mathbb{P}_{1}^{*} / d \mathbb{P}^{*}$. Then

$$
\hat{\eta}(\mathbf{y})=\eta^{*}(\mathbf{y}) \quad \mathbb{P}^{*}-\text { a.e. }
$$

2. Let $\gamma_{i}^{*}$ be a coupling between $\mathbb{P}_{i}$ and $\mathbb{P}_{i}^{*}$ for which $\operatorname{ess} \sup _{(\mathbf{x}, \mathbf{y}) \sim \gamma_{i}^{*}}\|\mathbf{x}-\mathbf{y}\| \leq \epsilon$. Then for these $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}, \hat{\eta}$ satisfies

$$
I_{\epsilon}(\hat{\eta})(\mathbf{x})=\hat{\eta}(\mathbf{y}) \quad \gamma_{1}^{*} \text {-a.e. } \quad \text { and } \quad S_{\epsilon}(\hat{\eta})(\mathbf{x})=\hat{\eta}(\mathbf{y}) \quad \gamma_{0}^{*} \text {-a.e. }
$$

Recall that Theorem 2.6 of [14] proves that when $W_{\infty}\left(\mathbb{Q}, \mathbb{Q}^{\prime}\right) \leq \epsilon$, there always exists a coupling $\gamma$ between $\mathbb{Q}$ and $\mathbb{Q}^{\prime}$ with $\operatorname{ess} \sup _{(\mathbf{x}, \mathbf{y}) \sim \gamma}\|\mathbf{x}-\mathbf{y}\| \leq \epsilon$.

Next, we prove that one can take $\hat{A}_{1}=\{\hat{\eta}>1 / 2\}$ and $\hat{A}_{2}=\{\hat{\eta} \geq 1 / 2\}$ in Lemma 5.3.
Proof of Lemma 5.3. Let $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}, \gamma_{0}^{*}$, and $\gamma_{1}^{*}$ be the measures given by Proposition D. 1 and set $\mathbb{P}^{*}=\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$ and $\eta^{*}=d \mathbb{P}_{1}^{*} / d \mathbb{P}^{*}$. Let $\hat{\eta}$ be the function described by Proposition D.1. We will show that the classifiers $\hat{A}_{1}=\{\hat{\eta}>1 / 2\}$ and $\hat{A}_{2}=\{\hat{\eta} \geq 1 / 2\}$ satisfy the required properties by verifying the complementary slackness conditions in Theorem 2.4.

Below, we verify these conditions for $\{\hat{\eta}>1 / 2\}$, the argument for $\{\hat{\eta} \geq 1 / 2\}$ is analogous. First, Item 1 of Proposition D. 1 implies that $\mathbf{1}_{\{\hat{\eta}>1 / 2\}}=\mathbf{1}_{\eta^{*}>1 / 2} \mathbb{P}^{*}$-a.e. and $\mathbf{1}_{\{\hat{\eta}>1 / 2\}^{C}}=$ $\mathbf{1}_{\{\hat{\eta} \leq 1 / 2\}}=\mathbf{1}_{\eta^{*} \leq 1 / 2} \mathbb{P}^{*}$-a.e.

Therefore,

$$
\eta^{*} \mathbf{1}_{\{\hat{\eta}>1 / 2\}^{C}}+\left(1-\eta^{*}\right) \mathbf{1}_{\{\hat{\eta}>1 / 2\}}=C^{*}\left(\eta^{*}\right) \quad \mathbb{P}^{*} \text {-a.e. }
$$

Next, Item 2 of Proposition D. 1 implies that $\hat{\eta}$ assumes its maximum over closed $\epsilon$-balls $\mathbb{P}_{0^{-}}$ a.e. and hence $S_{\epsilon}\left(\mathbf{1}_{\hat{\eta}>1 / 2}\right)(\mathbf{x})=\mathbf{1}_{S_{\epsilon}(\hat{\eta}(\mathbf{x}))>1 / 2} \mathbb{P}_{0}$-a.e. Additionally, Item 2 of Proposition D. 1 implies that $\mathbf{1}_{S_{\epsilon}(\hat{\eta})(\mathbf{x})>1 / 2}=\mathbf{1}_{\hat{\eta}(\mathbf{y})>1 / 2} \gamma_{0}^{*}$-a.e. Therefore, one can conclude that

$$
\begin{equation*}
\int S_{\epsilon}\left(\mathbf{1}_{\hat{\eta}>1 / 2}\right)(\mathbf{x}) d \mathbb{P}_{0}(\mathbf{x})=\int \mathbf{1}_{\hat{\eta}(\mathbf{y})>1 / 2} d \gamma_{0}^{*}(\mathbf{x}, \mathbf{y})=\int \mathbf{1}_{\hat{\eta}>1 / 2} d \mathbb{P}_{0}^{*} \tag{D.1}
\end{equation*}
$$

Similarly, using the fact that $I_{\epsilon}(\hat{\eta})(\mathbf{x})=\hat{\eta}(\mathbf{y}) \gamma_{1}^{*}$-a.e., one can show that $\int S_{\epsilon}\left(\mathbf{1}_{\hat{\eta} \leq 1 / 2}\right) d \mathbb{P}_{1}=$ $\int \mathbf{1}_{\hat{\eta} \geq 1 / 2} d \mathbb{P}_{1}^{*}$. This statement together with (D.1) verifies (2.11).

The classifiers $\hat{A}_{1}$ and $\hat{A}_{2}$ are minimal and maximal classifiers in the sense that $\int S_{\epsilon}\left(\mathbf{1}_{\hat{A}_{1}}\right) d \mathbb{P}_{0} \leq$ $\int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{P}_{0} \leq \int S_{\epsilon}\left(\mathbf{1}_{\hat{A}_{2}}\right) d \mathbb{P}_{0}$ for any other adversarial Bayes classifier $A$.

Lemma D.2. Let A be any adversarial Bayes classifier and let $\hat{A}_{1}, \hat{A}_{2}$ be the two adversarial Bayes classifiers of Lemma 5.3. Then

\end{equation*}

and

$$
\begin{equation*}
\int S_{\epsilon}\left(\mathbf{1}_{\hat{A}_{2}^{C}}\right) d \mathbb{P}_{1} \leq \int S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right) d \mathbb{P}_{1} \leq \int S_{\epsilon}\left(\mathbf{1}_{\hat{A}_{1}^{C}}\right) d \mathbb{P}_{1} . \tag{D.3}
\end{equation*}
$$

Proof. Let $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}, \mathbb{P}^{*}$, and $\eta^{*}$ be as described by Lemma 5.3. Then the complementary slackness condition (2.11) implies that $\int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{P}_{0}=\int \mathbf{1}_{A} d \mathbb{P}_{0}^{*}$ and (2.12) implies (5.1), and hence $\int \mathbf{1}_{\eta^{*}>1 / 2} d \mathbb{P}_{0}^{*} \leq \int \mathbf{1}_{A} d \mathbb{P}_{0}^{*} \leq \int \mathbf{1}_{\eta^{*} \geq 1 / 2} d \mathbb{P}_{0}^{*}$. Lemma 5.3 implies that $\int \mathbf{1}_{\hat{A}_{1}} d \mathbb{P}_{0}^{*} \leq$ $\int \mathbf{1}_{A} d \mathbb{P}_{0}^{*} \leq \int \mathbf{1}_{\hat{A}_{2}} d \mathbb{P}_{0}^{*}$. The complementary slackness condition (2.11) applied to $\hat{A}_{1}$ and $\hat{A}_{2}$ then implies (D.2).

The fact that $\int S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right)=R_{*}^{\epsilon}-\int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{P}_{0}$ for any adversarial Bayes classifier $A$ then implies (D.3).
D.2. Proving Theorem 3.4. To start, we prove that Item B) and Item C) are equivalent even when $\mathbb{P} \nless \mu$ :

Proposition D.3. The following are equivalent:
B) For all adversarial Bayes classifiers $A$, either the value of $\mathbb{P}_{0}\left(A^{\epsilon}\right)$ is unique or the value of $\mathbb{P}_{1}\left(\left(A^{C}\right)^{\epsilon}\right)$ is unique
C) There are maximizers $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$ of $\bar{R}$ for which $\mathbb{P}^{*}\left(\eta^{*}=1 / 2\right)=0$, where $\mathbb{P}^{*}=\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$ and $\eta^{*}=d \mathbb{P}_{1}^{*} / d \mathbb{P}^{*}$
Proof. Item B) $\Rightarrow$ Item C): Assume that $\mathbb{P}_{0}\left(A_{1}^{\epsilon}\right)=\mathbb{P}_{0}\left(A_{2}^{\epsilon}\right)$ for any two adversarial Bayes classifiers. Then Lemma 2.1 implies that $\mathbb{P}_{0}\left(\left(A_{1} \cup A_{2}\right)^{\epsilon}\right)=\mathbb{P}_{0}\left(\left(A_{1} \cap A_{2}\right)^{\epsilon}\right)$. Consequently, $\mathbf{1}_{\left(A_{1} \cup A_{2}\right)^{\epsilon}}=\mathbf{1}_{\left(A_{1} \cap A_{2}\right)^{\epsilon}} \mathbb{P}_{0}$-a.e. because $\left(A_{1} \cap A_{2}\right)^{\epsilon} \subset\left(A_{1} \cup A_{2}\right)^{\epsilon}$. As $A_{1}^{\epsilon}$ and $A_{2}^{\epsilon}$ are strictly between $\left(A_{1} \cap A_{2}\right)^{\epsilon}$ and $\left(A_{1} \cup A_{2}\right)^{\epsilon}$, one can conclude that

$$
S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=\mathbf{1}_{A_{1}^{\epsilon}}=\mathbf{1}_{A_{2}^{\epsilon}}=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right) \quad \mathbb{P}_{0} \text {-a.e. }
$$

Similarly, if $\mathbb{P}_{1}\left(\left(A_{1}^{C}\right)^{\epsilon}\right)=\mathbb{P}_{1}\left(\left(A_{2}^{C}\right)^{\epsilon}\right)$ implies $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right)$. Therefore, Item B) implies Item 2) of Lemma C.6. Consequently, Lemma C. 6 implies that $\mathbb{P}^{*}\left(\hat{A}_{1} \triangle \hat{A}_{2}\right)=\mathbb{P}^{*}\left(\eta^{*}=1 / 2\right)=$ 0 , where $\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}$ are the measures described by Lemma 5.3 and $\hat{A}_{1}$ and $\hat{A}_{2}$ are the adversarial Bayes classifiers described by Lemma 5.3.

Item $\mathbf{C}) \Rightarrow$ Item $B)$ : Assume there is a maximizer $\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right)$ of $\bar{R}$ for which $\mathbb{P}^{*}\left(\eta^{*}=1 / 2\right)=$ 0 , where $\mathbb{P}^{*}=\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$ and $\eta^{*}=d \mathbb{P}_{1}^{*} / d \mathbb{P}^{*}$. Then (5.1) must hold, and $\mathbb{P}^{*}\left(\eta^{*}=1 / 2\right)=0$ implies that $\mathbf{1}_{A}=\mathbf{1}_{\eta^{*}>1 / 2} \mathbb{P}^{*}$-a.e. for any adversarial Bayes classifier $A$. Consequently, $\mathbf{1}_{A_{1}}=\mathbf{1}_{A_{2}}$ $\mathbb{P}^{*}$-a.e. for any two adversarial Bayes classifiers $A_{1}, A_{2}$ or equivalently, $\mathbb{P}^{*}\left(A_{1} \triangle A_{2}\right)=0$. Corollary C. 5 and Lemma C. 6 imply that $S_{\epsilon}\left(\mathbf{1}_{A_{1}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}}\right) \mathbb{P}_{0}$-a.e. and $S_{\epsilon}\left(\mathbf{1}_{A_{1}^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A_{2}^{C}}\right)$ $\mathbb{P}_{1}$-a.e., which implies Item B).

Finally, this result together with Proposition 5.1 implies Theorem 3.4.
Proof of Theorem 3.4. Proposition D. 3 states that Item B) implies Item C). It remains to show Item A) implies Item B) and Item C) implies Item A).

Item $\mathbf{A}) \Rightarrow$ Item B): Assume that the the adversarial Bayes classifier is unique up to degeneracy. Then Item 2) of Proposition 5.1 implies that $\mathbb{P}_{1}\left(A_{1}^{\epsilon}\right)=\mathbb{P}_{1}\left(A_{2}^{\epsilon}\right)$ for any two adversarial Bayes classifiers $A_{1}$ and $A_{2}$.

Item C) $\Rightarrow$ Item A): Assume that $\mathbb{P}^{*}\left(\eta^{*}=1 / 2\right)=0$ for some $\left(\mathbb{P}_{0}^{*}, \mathbb{P}_{1}^{*}\right)$ that maximize $\bar{R}$, where $\mathbb{P}^{*}=\mathbb{P}_{0}^{*}+\mathbb{P}_{1}^{*}$ and $\eta^{*}=d \mathbb{P}_{1}^{*} / d \mathbb{P}^{*}$. Then (5.1) implies that $\mathbf{1}_{\eta^{*}>1 / 2}=\mathbf{1}_{A} \mathbb{P}^{*}$-a.e. for any adversarial Bayes classifier $A$. Thus if $\mathbb{P}^{*}\left(\eta^{*}=1 / 2\right)=0$ then $\mathbf{1}_{A_{1}}=\mathbf{1}_{A_{2}} \mathbb{P}_{0}^{*}$-a.e. for any two adversarial Bayes classifiers $A_{1}, A_{2}$, or in other words, $\mathbb{P}^{*}\left(A_{1} \triangle A_{2}\right)=0$. Item 3) of Proposition 5.1 then implies that $A_{1}$ and $A_{2}$ are equivalent up to degeneracy. As these adversarial Bayes classifiers were arbitrary, the adversarial Bayes classifier is unique up to degeneracy.

Appendix E. More about the ${ }^{\epsilon},{ }^{-\epsilon}$, and $S_{\epsilon}$ operations. This appendix provides a unified exposition of several results relating to the ${ }^{\epsilon}$ and ${ }^{-\epsilon}$ relations-namely Equations (5.2) and (5.3), Lemmas 5.5, 5.9, and 5.10. These results have all appeared elsewhere in the literature $-[2,6]$.

The characterizations of the ${ }^{\epsilon}$ and ${ }^{-\epsilon}$ operations provided by (5.2) and (5.3) are an essential tool for understanding how ${ }^{\epsilon}$ and ${ }^{-\epsilon}$ interact.

Proof of Equation (5.2). To show (5.2), notice that $\mathbf{x} \in A^{\epsilon}$ iff $\mathbf{x} \in \overline{B_{\epsilon}(\mathbf{a})}$ for some element a of $A$. Thus:
$\mathbf{x} \in A^{\epsilon} \Leftrightarrow \mathbf{x} \in \overline{B_{\epsilon}(\mathbf{a})}$ for some $\mathbf{a} \in A \Leftrightarrow \mathbf{a} \in \overline{B_{\epsilon}(\mathbf{x})}$ for some $\mathbf{a} \in A \Leftrightarrow \overline{B_{\epsilon}(\mathbf{x})}$ intersects $A$
Equation (5.3) then follows directly from Equation (5.2):
Proof of Equation (5.3). By Equation (5.2),

$$
\mathbf{x} \in\left(A^{C}\right)^{\epsilon} \Leftrightarrow \overline{B_{\epsilon}(\mathbf{x})} \text { intersects } A^{C}
$$

Now $A^{-\epsilon}=\left(\left(A^{C}\right)^{\epsilon}\right)^{C}$, and so taking compliments of the relation above implies

$$
\mathbf{x} \in A^{-\epsilon} \Leftrightarrow \overline{B_{\epsilon}(\mathbf{x})} \text { does not intersect } A^{C} \Leftrightarrow \overline{B_{\epsilon}(\mathbf{x})} \subset A
$$

Next, Equation (5.2) and Equation (5.3) immediately imply Lemma 5.9:
Proof of Lemma 5.9. By Equation (5.2), Equation (5.3), ( $\left.A^{\epsilon}\right)^{-\epsilon}$ is the set of points $\mathbf{x}$ for which $\overline{B_{\epsilon}(\mathbf{x})} \subset A^{\epsilon}$. For any point $\mathbf{a} \in A, \overline{B_{\epsilon}(\mathbf{a})} \subset A^{\epsilon}$ and thus $A \subset\left(A^{\epsilon}\right)^{-\epsilon}$. Applying this statement to the set $A^{C}$ and then taking compliments results in $\left(A^{-\epsilon}\right)^{\epsilon} \subset A$.

Lemma 5.9 then immediately implies Lemma 5.10:
Proof of Lemma 5.10. First, Lemma 5.9 implies that $A \subset\left(A^{\epsilon}\right)^{-\epsilon}$ and thus $A^{\epsilon} \subset\left(\left(A^{\epsilon}\right)^{-\epsilon}\right)^{\epsilon}$. At the same time, Lemma 5.9 implies that $\left(\left(A^{\epsilon}\right)^{-\epsilon}\right)^{\epsilon}=\left(\left(A^{\epsilon}\right)^{-\epsilon}\right)^{\epsilon} \subset A^{\epsilon}$. Therefore, $\left(\left(A^{\epsilon}\right)^{-\epsilon}\right)^{\epsilon}=$ $A^{\epsilon}$. Applying this result to $A^{C}$ and then taking compliments then results in $\left(\left(A^{-\epsilon}\right)^{\epsilon}\right)^{-\epsilon}=A^{-\epsilon}$.

Next, Lemma 5.9 implies that $\left(A^{-\epsilon}\right)^{\epsilon} \subset A$ and hence $\left(\left(A^{-\epsilon}\right)^{\epsilon}\right)^{\epsilon} \subset A^{\epsilon}$. Applying this result to $A^{C}$ and then taking compliments $\left(\left(A^{\epsilon}\right)^{-\epsilon}\right)^{-\epsilon} \supset A^{-\epsilon}$.

Lemma 5.5 is then an immediate consequence of Lemma 5.10.

## Appendix F. Measurability.

F.1. Defining the Universal $\sigma$-algebra. Let $\mathcal{M}_{+}\left(\mathbb{R}^{d}\right)$ be the set of finite positive measures on the Borel $\sigma$-algebra $\mathcal{B}\left(\mathbb{R}^{d}\right)$. For a Borel measure $\nu$ in $\mathcal{M}_{+}\left(\mathbb{R}^{d}\right)$, let $\mathcal{L}_{\nu}\left(\mathbb{R}^{d}\right)$ be the completion of $\mathcal{B}\left(\mathbb{R}^{d}\right)$ under $\nu$. Then the universal $\sigma$-algebra $\mathscr{U}\left(\mathbb{R}^{d}\right)$ is defined as

$$
\mathscr{U}\left(\mathbb{R}^{d}\right)=\bigcap_{\nu \in \mathcal{B}\left(\mathbb{R}^{d}\right)} \mathcal{L}_{\nu}\left(\mathbb{R}^{d}\right)
$$

In other words, $\mathscr{U}\left(\mathbb{R}^{d}\right)$ is the $\sigma$-algebra of sets which are measurable with respect to the completion of every finite positive Borel measure $\nu$. See [3, Chapter 7] or [16] for more about this construction.

Due to Theorem 5.6, throughout this paper, we adopt the convention that $\int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \nu$ is the integral of $S_{\epsilon}\left(\mathbf{1}_{A}\right)$ with respect to the completion of $\nu$.
F.2. Proof of Theorem 5.7. First, notice that because every Borel set is universally measurable, $\inf _{A \in \mathcal{B}\left(\mathbb{R}^{d}\right)} R^{\epsilon}(A) \geq \inf _{A \in \mathscr{U}\left(\mathbb{R}^{d}\right)} R^{\epsilon}(A)$. The opposite inequality relies on a duality statement similar to Theorem 2.3, but with the primal minimized over universally measurable sets and the dual maximized over measures on $\mathscr{U}\left(\mathbb{R}^{d}\right)$.

For a Borel measure $\mathbb{Q}$, there is a canonical extension to the universal $\sigma$-algebra called the universal completion.

Definition F.1. The universal completion $\widetilde{\mathbb{Q}}$ of a Borel $\mathbb{Q}$ is the completion of $\mathbb{Q}$ restricted to the universal $\sigma$-algebra.
Notice that $\mathbb{Q}(E)=\widetilde{\mathbb{Q}}(E)$ for any Borel measure $\mathbb{Q}$ and Borel set $E$. As a consequence,

$$
\begin{equation*}
\int g d \mathbb{Q}=\int g d \widetilde{\mathbb{Q}} \quad \text { for any Borel function } g . \tag{F.1}
\end{equation*}
$$

In addition to the $W_{\infty}$-ball of Borel measures $\mathcal{B}_{\epsilon}^{\infty}(\mathbb{Q})$ around $\mathbb{Q}$, one can consider the $W_{\infty}$ ball of universal completions of measures around $\mathbb{Q}$, which we will call $\widetilde{\mathcal{B}}_{\epsilon}^{\infty}(\mathbb{Q})$.

Explicitly, for a Borel measure $\mathbb{Q}$, define

$$
\widetilde{\mathcal{B}}_{\epsilon}^{\infty}(\mathbb{Q})=\left\{\widetilde{\mathbb{Q}}^{\prime}: \mathbb{Q}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}(\mathbb{Q})\right\} .
$$

The following result shows that if $\mathbb{Q}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}(\mathbb{Q})$, then $W_{\infty}\left(\widetilde{\mathbb{Q}}, \widetilde{\mathbb{Q}^{\prime}}\right) \leq \epsilon$, and thus $\widetilde{\mathcal{B}}_{\epsilon}^{\infty}(\mathbb{Q})$ contains only measures that are within $\epsilon$ of $\widetilde{\mathbb{Q}}$ in the $W_{\infty}$ metric.

Lemma F.2. Let $\mathbb{Q}$ and $\mathbb{Q}^{\prime}$ be Borel measures with $W_{\infty}\left(\mathbb{Q}, \mathbb{Q}^{\prime}\right) \leq \epsilon$ and let $\widetilde{\mathbb{Q}}, \widetilde{\mathbb{Q}}^{\prime}$ be their universal completions. Then $W_{\infty}\left(\widetilde{\mathbb{Q}}, \widetilde{\mathbb{Q}}^{\prime}\right) \leq \epsilon$.

Next, to compare the values of $\bar{R}$ on $\mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{0}\right) \times \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)$ and $\widetilde{\mathcal{B}}_{\epsilon}^{\infty}\left(\mathbb{P}_{0}\right) \times \widetilde{\mathcal{B}}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)$, we show:
Corollary F.3. Let $\mathbb{P}_{0}, \mathbb{P}_{1}$ be two Borel measures and let $\widetilde{\mathbb{P}}_{0}, \widetilde{\mathbb{P}}_{1}$ be their universal completions. Then $\bar{R}\left(\mathbb{P}_{0}, \mathbb{P}_{1}\right)=\bar{R}\left(\widetilde{\mathbb{P}}_{0}, \widetilde{\mathbb{P}}_{1}\right)$.

Thus Lemma F. 2 and Corollary F. 3 imply that

Furthermore,Lemma B. 1 and (F.1) imply:
Corollary F.4. Let $\mathbb{Q}$ be a finite positive measure on $\mathscr{U}\left(\mathbb{R}^{d}\right)$. Then for any universally measurable set $A$,

$$
\int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{Q} \geq \sup _{\mathbb{Q}^{\prime} \in \widetilde{\tilde{\mathcal{B}}_{\epsilon}^{\infty}(\mathbb{Q})}} \int \mathbf{1}_{A} d \mathbb{Q}^{\prime}
$$

See Appendix F.3.3 for a proof.
This result implies a weak duality relation between the primal $R^{\epsilon}$ minimized over $\mathscr{U}\left(\mathbb{R}^{d}\right)$ and the dual $\bar{R}$ maximized over $\widetilde{\mathcal{B}}_{\epsilon}^{\infty}\left(\mathbb{P}_{0}\right) \times \widetilde{\mathcal{B}}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)$ :

Lemma F. 5 (Weak Duality). Let $\mathbb{P}_{0}, \mathbb{P}_{1}$ be two Borel measures. Then

$$
\inf _{A \in \mathscr{U}\left(\mathbb{R}^{d}\right)} R^{\epsilon}(A) \geq \sup _{\substack{\mathbb{P}_{0}^{\prime} \in \widetilde{\mathcal{B}^{\infty}}\left(\mathbb{P}_{0}\right) \\ \widetilde{\mathbb{P}}_{1}^{\prime} \in \tilde{\mathcal{B}}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)}} \bar{R}\left(\widetilde{\mathbb{P}}_{0}^{\prime}, \widetilde{\mathbb{P}}_{1}^{\prime}\right)
$$

Proof. Let $A$ be any universally measurable set and let $\widetilde{\mathbb{P}}_{0}^{\prime}, \widetilde{\mathbb{P}}_{1}^{\prime}$ be any measures in $\widetilde{\mathcal{B}}_{\epsilon}^{\infty}\left(\mathbb{P}_{0}\right)$ and $\widetilde{\mathcal{B}}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)$ respectively.

Then Corollary F. 4 implies that

However, because inf-sup is always larger than a sup-inf, one can conclude that

This observation suffices to prove Theorem 5.7:
Proof of Theorem 5.7. First, because every Borel set is universally measurable, $\inf _{A \in \mathcal{B}\left(\mathbb{R}^{d}\right)} R^{\epsilon}(A) \geq$ $\inf _{A \in \mathscr{U}\left(\mathbb{R}^{d}\right)} R^{\epsilon}(A)$. Thus the strong duality result of Theorem 2.3 and (F.2) imply that

$$
\inf _{A \in \mathscr{U}\left(\mathbb{R}^{d}\right)} R^{\epsilon}(A) \leq \inf _{A \in \mathcal{B}\left(\mathbb{R}^{d}\right)} R^{\epsilon}(A)=\sup _{\substack{\mathbb{P}_{0}^{\prime} \in \mathcal{B}^{\infty} \in\left(\mathbb{P}_{0}\right) \\ \mathbb{P}_{1}^{\prime} \in \mathcal{B}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)}} \bar{R}\left(\mathbb{P}_{0}^{\prime}, \mathbb{P}_{1}^{\prime}\right)=\sup _{\substack{\widetilde{\mathbb{P}}_{0}^{\prime} \in \widetilde{\mathcal{B}}^{\infty}\left(\mathbb{P}_{0}\right) \\ \widetilde{\mathbb{P}}_{1}^{\prime} \tilde{\mathcal{B}}_{\epsilon}^{\infty}\left(\mathbb{P}_{1}\right)}} \bar{R}\left(\widetilde{\mathbb{P}}_{0}^{\prime}, \widetilde{\mathbb{P}}_{1}^{\prime}\right) .
$$

However, the weak duality statement of Lemma F. 5 implies that the inequality above must actually be an equality.
F.3. Proofs of Lemma F. 2 and Corollaries F. 3 and F.4. Lemma 7.26 of [3] provides a useful result for translating statements for $\mathcal{B}\left(\mathbb{R}^{d}\right)$ to $\mathcal{B}\left(\mathbb{R}^{d}\right)$.

Lemma F.6. The set $E$ is universally measurable iff given any Borel measure $\mathbb{Q}$, there are Borel sets $B_{1}, B_{2}$ for which $B_{1} \subset E \subset B_{2}$ and $\mathbb{Q}\left(B_{1}\right)=\mathbb{Q}\left(B_{2}\right)$.

The proofs of Lemma F. 2 and Corollaries F. 3 and F. 4 all rely on this result.
F.3.1. Proof of Lemma F.2. Notice that if $\gamma$ is a coupling between two Borel measures, ess $\sup _{(\mathbf{x}, \mathbf{y}) \sim \gamma}\|\mathbf{x}-\mathbf{y}\| \leq \epsilon \operatorname{iff} \gamma\left(\Delta_{\epsilon}^{C}\right)=0$, where $\Delta_{\epsilon}$ is the set defined by

$$
\begin{equation*}
\Delta_{\epsilon}=\left\{(\mathbf{x}, \mathbf{y}) \in \mathbb{R}^{d} \times \mathbb{R}^{d}:\|\mathbf{x}-\mathbf{y}\| \leq \epsilon\right\} \tag{F.3}
\end{equation*}
$$

This notation is helpful in the proof of Lemma F.2.
Proof of Lemma F.2. Let $\gamma$ be a Borel coupling between $\mathbb{Q}$ and $\mathbb{Q}^{\prime}$ for which $\operatorname{ess} \sup _{(\mathbf{x}, \mathbf{y}) \sim \gamma} \| \mathbf{x}-$ $\mathbf{y} \| \leq \epsilon$. Such a coupling exists by Theorem 2.6 of [14]. Let $\bar{\gamma}$ be the completion of $\gamma$ restricted to $\sigma\left(\mathscr{U}\left(\mathbb{R}^{d}\right) \times \mathscr{U}\left(\mathbb{R}^{d}\right)\right)$, the $\sigma$-algebra generated by $\mathscr{U}\left(\mathbb{R}^{d}\right) \times \mathscr{U}\left(\mathbb{R}^{d}\right)$. We will show $\bar{\gamma}$ is the desired coupling between $\widetilde{\mathbb{Q}}$ and $\widetilde{\mathbb{Q}}^{\prime}$.

Let $S$ be an arbitrary universally measurable set in $\mathbb{R}^{d}$. Then Lemma F. 6 states that there are Borel sets $E_{1}, E_{2}$ for which $E_{1} \subset S \subset E_{2}$ and $\widetilde{\mathbb{Q}}\left(E_{1}\right)=\widetilde{\mathbb{Q}}(S)=\widetilde{\mathbb{Q}}\left(E_{2}\right)$. Then because $\gamma$ and $\bar{\gamma}$ are equal on Borel sets,

$$
\widetilde{\mathbb{Q}}\left(E_{1}\right)=\mathbb{Q}\left(E_{1}\right)=\gamma\left(E_{1} \times \mathbb{R}^{d}\right)=\bar{\gamma}\left(E_{1} \times \mathbb{R}^{d}\right)
$$

and similarly,

$$
\widetilde{\mathbb{Q}}\left(E_{2}\right)=\mathbb{Q}\left(E_{2}\right)=\gamma\left(E_{2} \times \mathbb{R}^{d}\right)=\bar{\gamma}\left(E_{2} \times \mathbb{R}^{d}\right)
$$

Therefore,

$$
\widetilde{\mathbb{Q}}(S)=\bar{\gamma}\left(E_{1} \times \mathbb{R}^{d}\right)=\bar{\gamma}\left(E_{2} \times \mathbb{R}^{d}\right)=\bar{\gamma}\left(S \times \mathbb{R}^{d}\right)
$$

Similarly, one can argue

$$
\widetilde{\mathbb{Q}}^{\prime}(S)=\bar{\gamma}\left(\mathbb{R}^{d} \times S\right)
$$

Therefore, $\bar{\gamma}$ is a coupling between $\widetilde{\mathbb{Q}}$ and $\widetilde{\mathbb{Q}}^{\prime}$. Next, recall that ess $\sup _{(\mathbf{x}, \mathbf{y}) \sim \gamma}\|\mathbf{x}-\mathbf{y}\| \leq \epsilon$ iff $\gamma\left(\Delta_{\epsilon}^{C}\right)=0$, where $\Delta_{\epsilon}$ defined by (F.3).

Therefore, because $\Delta_{\epsilon}$ is closed (and thus Borel),

$$
\bar{\gamma}\left(\Delta_{\epsilon}^{C}\right)=\gamma\left(\Delta_{\epsilon}^{C}\right)=0
$$

Consequently, $\operatorname{ess} \sup _{(\mathbf{x}, \mathbf{y}) \sim \bar{\gamma}}\|\mathbf{x}-\mathbf{y}\| \leq \epsilon$ and thus $W_{\infty}\left(\widetilde{\mathbb{Q}}, \widetilde{\mathbb{Q}}{ }^{\prime}\right) \leq \epsilon$.

## F.3.2. Proof of Corollary F.3. Next, we will show:

Lemma F.7. Let $\nu, \lambda$ be two Borel measures with $\nu \ll \lambda$, and let $d \nu / d \lambda$ be the RadonNikodym derivative. Then $d \widetilde{\nu} / d \widetilde{\lambda}=d \nu / d \lambda \widetilde{\lambda}$-a.e.

This result together with (F.1) immediately implies Corollary F.3.

Proof. First, if a function $g$ is Borel measurable, $\left(g^{-1}:(\mathbb{R}, \mathcal{B}(\mathbb{R})) \rightarrow\left(\mathbb{R}, \mathcal{B}\left(\mathbb{R}^{d}\right)\right)\right.$, then it is necessarily universally measurable $\left(g^{-1}:(\mathbb{R}, \mathcal{B}(\mathbb{R})) \rightarrow\left(\mathbb{R}^{d}, \mathscr{U}\left(\mathbb{R}^{d}\right)\right)\right)$. Thus the RadonNikodym derivative $d \nu / d \lambda$ is both Borel measurable and universally measurable.

Next, if $S \in \mathscr{U}\left(\mathbb{R}^{d}\right)$ then Lemma F. 6 implies there is a Borel set $E$ and $\lambda$-null sets $N_{1}, N_{2}$ for which $S=E \cup N_{1}-N_{2}$. Because $\nu$ is absolutely continuous with respect to $\lambda$, the sets $N_{1}$ and $N_{2}$ are null under $\nu$ as well. Therefore, by the defintion of the Radon-Nikodym derivative $d \nu / d \lambda$ and the fact that $\int g d \lambda=\int g d \widetilde{\lambda}$ for all Borel functions $g$,

$$
\widetilde{\nu}(S)=\nu(E)=\int_{E} \frac{d \nu}{d \lambda} d \lambda=\int_{E} \frac{d \nu}{d \lambda} d \widetilde{\lambda}=\int_{S} \frac{d \nu}{d \lambda} d \widetilde{\lambda}
$$

Because the Radon-Nikodym derivative is unique $\widetilde{\lambda}$-a.e., it follows that $d \widetilde{\nu} / d \widetilde{\lambda}=d \nu / d \lambda \widetilde{\lambda}$-a.e.

## F.3.3. Proof of Corollary F.4.

Proof of Corollary F.4. Fix a $\mathbb{Q}^{\prime} \in \widetilde{\mathcal{B}}_{\epsilon}^{\infty}(\mathbb{Q})$ and assume that $\mathbb{Q}^{\prime}=\tilde{\lambda}$ for some $\lambda \in \mathcal{B}_{\epsilon}^{\infty}(\mathbb{Q})$. Then Lemma F. 6 states that there is a Borel set $B_{1} \subset A$ for which

$$
\lambda\left(B_{1}\right)=\tilde{\lambda}\left(B_{1}\right)=\mathbb{Q}^{\prime}\left(B_{1}\right)=\mathbb{Q}^{\prime}(A)
$$

Thus Lemma B. 1 and (F.1) imply that $\int \mathbf{1}_{B_{1}} d \mathbb{Q}^{\prime} \leq \int S_{\epsilon}\left(\mathbf{1}_{B_{1}}\right) d \mathbb{Q}$. Furthermore, $B_{1} \subset A$ implies $S_{\epsilon}\left(\mathbf{1}_{B_{1}}\right) \leq S_{\epsilon}\left(\mathbf{1}_{A}\right)$ and consequently:

$$
\int \mathbf{1}_{A} d \mathbb{Q}^{\prime}=\int \mathbf{1}_{B_{1}} d \mathbb{Q}^{\prime} \leq \int S_{\epsilon}\left(\mathbf{1}_{B_{1}}\right) d \mathbb{Q} \leq \int S_{\epsilon}\left(\mathbf{1}_{A}\right) d \mathbb{Q}
$$

Taking the supremum over all $\mathbb{Q}^{\prime} \in \widetilde{\mathcal{B}}_{\epsilon}^{\infty}(\mathbb{Q})$ proves the result.

## Appendix G. Deferred Proofs From subsection 5.3.

## G.1. Proof of Lemma 5.8.

Proof of Lemma 5.8. Let $\left\{D_{i}\right\}_{i=1}^{\infty}$ be a countable sequence of degenerate sets for an adversarial Bayes classifier $A$. Then by Proposition 5.1, one can conclude that $S_{\epsilon}\left(\mathbf{1}_{A}\right)=$ $S_{\epsilon}\left(\mathbf{1}_{A \cup D_{i}}\right)=\mathbf{1}_{A^{\epsilon} \cup D_{i}^{\epsilon}} \mathbb{P}_{0}$-a.e. and $S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right)=S_{\epsilon}\left(\mathbf{1}_{A^{C} \cup D_{i}}\right)=\mathbf{1}_{\left(A^{C}\right)^{\epsilon} \cup D_{i}^{\epsilon}} \mathbb{P}_{1^{-a}}$ a.e. for every $i$. Countable additivity then implies that $S_{\epsilon}\left(\mathbf{1}_{A}\right)=\mathbf{1}_{A^{\epsilon} \cup \bigcup_{i=1}^{\infty} D_{i}^{\epsilon}}=S_{\epsilon}\left(\mathbf{1}_{A \cup \cup_{i=1}^{\infty} D_{i}}\right) \mathbb{P}_{0}$-a.e. and $S_{\epsilon}\left(\mathbf{1}_{A^{C}}\right)=\mathbf{1}_{\left(A^{C}\right)^{\epsilon} \cup \bigcup_{i=1}^{\infty} D_{i}^{\epsilon}}=S_{\epsilon}\left(\mathbf{1}_{A^{C} \cup \bigcup_{i=1}^{\infty} D_{i}}\right)$. Therefore, Proposition 5.1 implies that $A$, $A \cup \bigcup_{i=1}^{\infty} D_{i}$, and $A-\bigcup_{i=1}^{\infty} D_{i}$ are all equivalent up to degeneracy. Consequently, $\bigcup_{i=1}^{\infty} D_{i}$ is a degenerate set.

## G.2. Proof of Proposition 5.12.

Lemma G.1. Let $A$ be an adversarial Bayes classifier. If $C$ is a connected component of $A$ with $C^{-\epsilon}=\emptyset$, then

$$
\begin{equation*}
C^{\epsilon}=\left\{\mathbf{y} \in A^{C}: \overline{B_{\epsilon}(\mathbf{y})} \text { intersects } C\right\}^{\epsilon} \tag{G.1}
\end{equation*}
$$

If $C$ is a component of $A^{C}$ with $C^{-\epsilon}=\emptyset$, then

$$
\begin{equation*}
C^{\epsilon}=\left\{\mathbf{y} \in A: \overline{B_{\epsilon}(\mathbf{y})} \text { intersects } C\right\}^{\epsilon} \tag{G.2}
\end{equation*}
$$

Proof. We will prove (G.1), the argument for (G.2) is analogous. Assume that $C$ is a component of $A,(5.2)$ implies the containment $\supset$ of (G.1).

Next, we prove the containment $\subset$ in (G.1). Specifically, we will show that for every $\mathbf{x} \in C^{\epsilon}$, there is a $\mathbf{y} \in A^{C}$ for which $\mathbf{x} \in \overline{B_{\epsilon}(\mathbf{y})}$ and $\overline{B_{\epsilon}(\mathbf{y})}$ intersects $C$.

To show the opposite containment, we show that for every $\mathbf{x} \in C^{\epsilon}$, there is a $\mathbf{y} \in A^{C}$ for which $\mathbf{x} \in \overline{B_{\epsilon}(\mathbf{y})}$ and $\overline{B_{\epsilon}(\mathbf{y})}$ intersects $C$.

Let $\mathbf{x} \in C$. Because $C^{-\epsilon}=\emptyset$, Equation (5.3) implies that $\overline{B_{\epsilon}(\mathbf{x})}$ is not entirely contained in $C$. Thus the set $C \cup \overline{B_{\epsilon}(\mathbf{x})}$ is connected and strictly contains $C$. Recall that a connected component of a set $A$ is a maximal connected subset. If $\overline{B_{\epsilon}(\mathbf{x})}$ were entirely contained in $A$, $C \cup \overline{B_{\epsilon}(\mathbf{x})}$ would be a connected subset of $A$ that strictly contains $C$, and then $C$ would not be a maximal connected subset of $A$. Therefore, $\overline{B_{\epsilon}(\mathbf{x})}$ contains a point $\mathbf{y}$ in $A^{C}$, and $\overline{B_{\epsilon}(\mathbf{y})}$ intersects $C$ at the point $\mathbf{x}$.

Next assume that $\mathbf{x} \in C^{\epsilon}$ but $\mathbf{x} \notin C$. Then Equation (5.2) states that the ball $\overline{B_{\epsilon}(\mathbf{x})}$ intersects $C$ at some point $\mathbf{z}$. Consider the line defined by $\ell:=\{t \mathbf{x}+(1-t) \mathbf{z}: 0 \leq t \leq 1\}$. Again $\ell$ is a connected set that intersects $C$, so $\ell \cup C$ is connected as well. However, $\ell$ also contains a point not in $C$ and thus if $\ell$ were entirely contained in $A$, then $C \cup \ell$ would be a connected subset of $A$ that strictly contains $C$. As $C$ is a maximal connected subset of $A$, the set $\ell$ is not entirely contained in $A$. Let $\mathbf{y}$ be any point in $A^{C} \cap \ell$, then $\overline{B_{\epsilon}(\mathbf{y})}$ intersects $C$ at the point $\mathbf{z}$ and contains $\mathbf{x}$.

Proof of Proposition 5.12. First assume that $C$ is a connected component of $A$ with $C^{-\epsilon}=$ $\emptyset$. We will argue that $C \subset\left(A^{\epsilon}\right)^{-\epsilon}-\left(A^{-\epsilon}\right)^{\epsilon}$, and then Corollary 5.11 will imply that $C$ is a degenerate set for $A$.

If $C$ is a component of $A$, then $C^{\epsilon} \subset A^{\epsilon}$ and thus $C \subset\left(C^{\epsilon}\right)^{-\epsilon} \subset\left(A^{\epsilon}\right)^{-\epsilon}$. Next, (G.1) of Lemma G. 1 implies that $C^{\epsilon} \subset\left(A^{C}\right)^{\epsilon}$ and thus $C \subset\left(C^{\epsilon}\right)^{-\epsilon} \subset\left(\left(A^{C}\right)^{\epsilon}\right)^{-\epsilon}=\left(\left(A^{-\epsilon}\right)^{\epsilon}\right)^{C}$. Therefore, $C$ is disjoint from $\left(A^{-\epsilon}\right)^{\epsilon}$. Consequently, $C$ is contained in $\left(A^{\epsilon}\right)^{-\epsilon}-\left(A^{-\epsilon}\right)^{\epsilon}$, which is degenerate by Lemma 5.10.

The argument for a connected component of $A^{C}$ is analogous, with (G.2) in place of (G.1)
As each connected component of $A$ or $A^{C}$ is contained in the degenerate set $\left(A^{\epsilon}\right)^{-\epsilon}-\left(A^{-\epsilon}\right)^{\epsilon}$, it follows that the set in (5.4) is contained in the degenerate set $\left(A^{\epsilon}\right)^{-\epsilon}-\left(A^{-\epsilon}\right)^{\epsilon}$.

## G.3. Proof of Lemma 5.13.

Proof of Lemma 5.13. We will show that $\mathbb{P}_{0}\left(D^{-\epsilon}\right)=0$, the argument for $\mathbb{P}_{1}$ is analogous. As both $A-D$ and $A \cup D$ are adversarial Bayes classifiers, Proposition 5.1 implies that $\mathbb{P}_{0}\left((A-D)^{\epsilon} \cup D^{\epsilon}\right)=\mathbb{P}_{0}\left((A-D)^{\epsilon}\right)$ and thus $\mathbb{P}_{0}\left(D^{\epsilon}-(A-D)^{\epsilon}\right)=0$. However, (5.2) and (5.3) imply that

$$
\begin{aligned}
& D^{\epsilon}-(A-D)^{\epsilon}=\left\{\mathbf{x}: \overline{B_{\epsilon}(\mathbf{x})} \text { intersects } D \text { but not } A-D\right\} \\
& \supset\left\{\mathbf{x}: \overline{B_{\epsilon}(\mathbf{x})} \subset D\right\}=D^{-\epsilon}
\end{aligned}
$$

Thus $\mathbb{P}_{0}\left(D^{-\epsilon}\right)=0$.

## Appendix H. Proof of Theorem 3.5.

Proof of Theorem 3.5. Let $\tilde{A}_{1} \subset \tilde{A}_{2}$ be the adversarial Bayes classifiers defined in Lemma 6.1
with

$$
\tilde{A}_{1}=\bigcup_{i=m}^{M}\left(\tilde{a}_{i}, \tilde{b}_{i}\right), \quad \tilde{A}_{2}^{C}=\bigcup_{j=n}^{N}\left(\tilde{e}_{j}, \tilde{f}_{j}\right) .
$$

for which $D=\tilde{A}_{2}-\tilde{A}_{1}$ is a degenerate set. Then one can write

$$
\begin{equation*}
\mathbb{R}=D \sqcup \bigcup_{i=m}^{M}\left(\tilde{a}_{i}, \tilde{b}_{i}\right) \sqcup \bigcup_{i=n}^{N}\left(\tilde{e}_{i}, \tilde{f}_{i}\right) \tag{H.1}
\end{equation*}
$$

For each $i$, define

$$
\begin{aligned}
& \hat{a}_{i}=\inf \left\{x:\left(x, \tilde{b}_{i}\right) \text { does not intersect } \tilde{A}_{2}^{C}\right\} \\
& \hat{b}_{i}=\sup \left\{x:\left(\tilde{a}_{i}, x\right) \text { does not intersect } \tilde{A}_{2}^{C}\right\}
\end{aligned}
$$

and let

$$
\hat{A}=\bigcup_{i=m}^{M}\left(\hat{a}_{i}, \hat{b}_{i}\right)
$$

Notice that $\left(\hat{a}_{i}, \hat{b}_{i}\right) \supset\left(\tilde{a}_{i}, \tilde{b}_{i}\right)$ so that $\hat{b}_{i}-\hat{a}_{i}>2 \epsilon$. Similarly, by the definition of the $\hat{a}_{i}$ and $\hat{b}_{i}$, every interval ( $\hat{b}_{i}, \hat{a}_{i+1}$ ) with $i, i+1 \in[m, M]$ must include some ( $\tilde{e}_{j}, \tilde{f}_{j}$ ) and thus $\hat{b}_{i}-\hat{a}_{i+1}>2 \epsilon$. As $\tilde{A} \triangle A \subset D$, the set $\tilde{A}$ is an adversarial Bayes classifier equivalent to $A$.

Next, we will show that any two intervals $\left(\hat{a}_{k}, \hat{b}_{k}\right),\left(\hat{a}_{p}, \hat{b}_{p}\right)$ are either disjoint or equal. Assume that $\left(\hat{a}_{k}, \hat{b}_{k}\right)$ and $\left(\hat{a}_{p}, \hat{b}_{p}\right)$ intersect at a point $x$. By the definition of $\hat{b}_{k},\left(x, \hat{b}_{k}\right)$ does not intersect $\tilde{A}_{2}^{C}$ and thus $\hat{b}_{p} \geq \hat{b}_{k}$. Reversing the roles of $\hat{b}_{p}$ and $\hat{b}_{k}$, one can then conclude that $\hat{b}_{p}=\hat{b}_{k}$. One can show that $\hat{a}_{p}=\hat{a}_{k}$ via a similar argument. Thus we can choose $\left(a_{i}, b_{i}\right)$ be unique disjoint intervals for which

$$
\bigsqcup_{i=k}^{K}\left(a_{i}, b_{i}\right)=\bigsqcup_{i=m}^{M}\left(\hat{a}_{i}, \hat{b}_{i}\right)
$$

## Appendix I. Deferred Proofs from subsection 6.2.

I.1. Proof of Lemma 6.4. First, we show Lemma 6.4 for intervals near the boundary of $\operatorname{supp} \mathbb{P}$.

Lemma I.1. Assume $\mathbb{P} \ll \mu$ and let $A=\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ be a regular adversarial Bayes classifier for radius $\epsilon$. Let $y$ represent any of the $a_{i} s$ or $b_{i} s$. Let $I$ be an interval for which $\operatorname{supp} \mathbb{P} \subset I$

- Assume that $I=[\ell, \infty)$ or $I=[\ell, r]$.

If $y \in(\ell-\epsilon, \ell+\epsilon]$ then $[\ell-\epsilon, y]$ is a degenerate set. If furthermore supp $\mathbb{P}=I$, then for some $\delta>0$, either $\eta \equiv 0$ or $\eta \equiv 1 \mu$-a.e. on $[\ell, \ell+\delta]$.

- Assume that $I=(-\infty, r]$ or $I=[\ell, r]$.

If $y \in[r-\epsilon, r+\epsilon)$ then $[y, r-\epsilon]$ is a degenerate set. If furthermore $\operatorname{supp} \mathbb{P}=I$, then for some $\delta>0$, either $\eta \equiv 0$ or $\eta \equiv 1 \mu$-a.e. on $[r-\delta, r]$.

Proof. We will prove the first bullet; the second bullet follows from the first by considering distributions with densities $\tilde{p}_{0}(x)=p_{0}(-x)$ and $\tilde{p}_{1}(x)=p_{1}(-x)$.

Assume that some $y=a_{i}$ is in $(\ell-\epsilon, \ell+\epsilon]$, the argument for $y=b_{i}$ is analogous. Then because $A$ is adversarial Bayes classifier:

$$
\begin{equation*}
0 \geq R^{\epsilon}(A)-R^{\epsilon}\left(A \cup\left[\ell-\epsilon, a_{i}\right]\right)=\int_{\ell}^{a_{i}+\epsilon} p d x-\int_{\ell}^{a_{i}+\epsilon} p_{0} d x=\int_{\ell}^{a_{i}+\epsilon} p_{1}(x) d x \tag{I.1}
\end{equation*}
$$

Consequently, $\int_{\ell}^{a_{i}+\epsilon} p_{1}(x) d x=0$ and thus the set $A \cup\left[\ell-\epsilon, a_{i}\right]$ must be an adversarial Bayes classifier as well.

First, we prove that the interval $\left[\ell-\epsilon, a_{i}\right]$ is a degenerate set. Let $D_{1}, D_{2}$ be arbitrary measurable subsets of $\left[\ell-\epsilon, a_{i}\right]$. Then

$$
R^{\epsilon}\left(A \cup D_{1}-D_{2}\right)-R^{\epsilon}\left(A \cup\left[\ell-\epsilon, a_{i}\right]\right) \leq \int_{\ell}^{a_{i}+\epsilon} p d x-\int_{\ell}^{a_{i}+\epsilon} p_{0} d x=\int_{\ell}^{a_{i}+\epsilon} p_{1}(x) d x
$$

and this quantity must be zero by (I.1). Therefore, the set $A \cup D_{1}-D_{2}$ is an adversarial Bayes classifier.

Next, we will show that if $\operatorname{supp} \mathbb{P}=I$, then $\eta=0 \mu$-a.e. on a set of positive measure. By assumption $a_{i}>\ell-\epsilon$ and thus $\delta=a_{i}+\epsilon-\ell>0$. As $[\ell, \ell+\delta] \subset \operatorname{supp} \mathbb{P}$, Equation (I.1) implies that $\eta \equiv 0 \mu$-a.e. on $[\ell, \ell+\delta]$.

Proof of Lemma 6.4. Assume that the endpoints of $I$ are $d_{1}, d_{2}$, so that $I=\left[d_{1}, d_{2}\right]$ (Corollary 6.3 implies that $|I|<\infty)$. Define an interval $J$ via


Because each interval $I^{\prime}$ includes $I$, the interval $J$ can be expressed as a countable union of intervals of length at least $|I|$ and thus is a degenerate set as well by Lemma 5.8. The interval $J$ must be closed because the boundary of every adversarial Bayes classifier is a degenerate set when $\mathbb{P} \ll \mu$. If $J \cap\left(\operatorname{supp} \mathbb{P}^{\epsilon}-\operatorname{int} \operatorname{supp} \mathbb{P}^{-\epsilon}\right)$ is nonempty, Lemma I. 1 implies that $\eta \in\{0,1\}$ on a set of positive measure under $\mathbb{P}$. It remains to consider the case $J \subset \operatorname{int} \operatorname{supp} \mathbb{P}^{-\epsilon}$. Corollary 6.3 implies that $J$ has finite length and so one can express $J$ as $J=\left[d_{3}, d_{4}\right]$. Now if any point $\{x\}$ in $\left[d_{3}-\epsilon, d_{3}\right.$ ) were a degenerate set, then Lemma 5.8 and Lemma 5.14 would imply that $\left((J \cup\{x\})^{\epsilon}\right)^{-\epsilon}=\left[x, d_{4}\right]$ would be a degenerate interval strictly containing $J$, which would contradict the definition of $J$. Thus $\left[d_{3}-\epsilon, d_{3}\right)$ cannot contain any degenerate sets. Similarly, if this interval contains both points in $A$ and $A^{C}$, Corollary 5.11 and Proposition 5.12 imply that there would be an interval $I^{\prime}$ that strictly contains $J$. Thus $\left[d_{3}-\epsilon, d_{3}\right)$ must be contained entirely in $A$ or $A^{C}$. Similarly, $\left(d_{4}, d_{4}+\epsilon\right]$ must be contained entirely in $A$ or $A^{C}$.

We will analyze the two cases $\left(d_{3}-\epsilon, d_{3}\right],\left[d_{4}, d_{4}+\epsilon\right) \subset A$ and $\left(d_{3}-\epsilon, d_{3}\right] \subset A,\left[d_{4}, d_{4}+\epsilon\right) \subset$ $A^{C}$. The cases $\left(d_{3}-\epsilon, d_{3}\right],\left[d_{4}, d_{4}+\epsilon\right) \subset A^{C}$ and $\left(d_{3}-\epsilon, d_{3}\right] \subset A^{C},\left[d_{4}, d_{4}+\epsilon\right) \subset A$ are analogous.

Assume first that $\left(d_{3}-\epsilon, d_{3}\right]$, $\left[d_{4}, d_{4}+\epsilon\right) \subset A$. Then because $J \subset \operatorname{supp} \mathbb{P}$ is degenerate, Corollary 6.3 implies that $|J| \leq 2 \epsilon$. Hence one can conclude
$0=R^{\epsilon}(A-J)-R^{\epsilon}(A \cup J)=\int_{d_{3}-\epsilon}^{d_{4}+\epsilon} p(x) d x-\int_{d_{3}-\epsilon}^{d_{4}+\epsilon} p_{0}(x) d x=\int_{d_{3}-\epsilon}^{d_{4}+\epsilon} p_{1}(x) d x \geq \int_{d_{1}-\epsilon}^{d_{2}+\epsilon} p_{1}(x) d x$.

Thus on the interval [ $d_{1}-\epsilon, d_{2}+\epsilon$ ], one can conclude that $p_{1}(x)=0 \mu$-a.e. As $\left[d_{1}, d_{2}\right] \subset$ int supp $\mathbb{P}^{-\epsilon}$ and $d_{2}>d_{1}$, the interval $\left[d_{1}-\epsilon, d_{2}+\epsilon\right]$ intersects supp $\mathbb{P}$ on an open set. Thus $\eta(x)=0 \mu$-a.e. on a set of positive measure.

Next assume that $\left(d_{3}-\epsilon, d_{3}\right] \subset A,\left[d_{4}, d_{4}+\epsilon\right) \subset A^{C}$. Again, Corollary 6.3 implies that $|I| \leq 2 \epsilon$. Then:

\begin{aligned}
0=R^{\epsilon}\left(A \cup(J \cap \mathbb{Q})-\left(J \cap \mathbb{Q}^{C}\right)\right)-R^{\epsilon}(A \cup J) & =\int_{d_{3}-\epsilon}^{d_{4}+\epsilon} p(x) d x-\left(\int_{d_{3}-\epsilon}^{d_{4}-\epsilon} p_{0}(x) d x+\int_{d_{4}-\epsilon}^{d_{4}+\epsilon} p(x) d x\right) \\
& \geq \int_{d_{3}-\epsilon}^{d_{4}+\epsilon} p_{1}(x) d x \geq \int_{d_{1}-\epsilon}^{d_{2}-\epsilon} p_{1}(x) d x
\end{aligned}
$$

Thus $p_{1}(x)=0$ on $\left[d_{1}-\epsilon, d_{2}-\epsilon\right]$.
Now $\left[d_{1}, d_{2}\right] \subset \operatorname{intsupp} \mathbb{P}^{-\epsilon}$ implies that $\left[d_{1}-\epsilon, d_{2}-\epsilon\right]$, intersects supp $\mathbb{P}$ on an open interval. Thus $\eta(x)=0$ on a set of positive measure.
I.2. Proof of the fourth bullet of Theorem 3.8. The following lemma implies $\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}$ is a degenerate set.

Lemma I.2. If $A$ and $B^{\epsilon}$ are disjoint, then $A^{\epsilon}$ and $B$ are disjoint.
Proof. We will show the contrapositive of this statement: if $A^{\epsilon}$ and $B$ intersect, then $A$ and $B^{\epsilon}$ intersect.

If $A^{\epsilon}$ an $B$ intersect, then there are $\mathbf{a} \in A, \mathbf{b} \in B$ and $\mathbf{h} \in \overline{B_{\epsilon}(\mathbf{0})}$ for which $\mathbf{a}+\mathbf{h}=\mathbf{b}$ and thus $\mathbf{a}=\mathbf{b}-\mathbf{h} \in B^{\epsilon}$. Thus $A$ and $B^{\epsilon}$ intersect.
Next, we argue that the set $\overline{\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}} \cup \partial A$ is indeed degenerate for any regular adversarial Bayes classifier $A$. The proof of this result relies on Lemma C.1.

Lemma I.3. Assume that $\mathbb{P} \ll \mu$ and let $A$ be a regular adversarial Bayes classifier. Then the set $\overline{\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}} \cup \partial A$ is degenerate for $A$.

Proof. First, supp $\mathbb{P}^{\epsilon}$ and $\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}$ are disjoint, so Lemma I. 2 implies that supp $\mathbb{P}$ and $\left.\left(\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}\right)^{\epsilon}\right)$ are disjoint. Thus $\left.\mathbb{P}\left(\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}\right)^{\epsilon}\right)=0$, and so $\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}$ is a degenerate set. Next, Lemma 5.2 implies that both $\overline{\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}}$ and $\partial A$ are degenerate sets. Finally, Lemma 5.8 implies that the union of $\partial A$ and $\partial\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}$ is a degenerate set.

Next, using the fact that $\overline{\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}}$ is degenerate, one can prove the fourth bullet of Theorem 3.8 for regular adversarial Bayes classifiers.

Lemma I.4. Assume that $\mathbb{P} \ll \mu, \mathbb{P}(\eta=0$ or 1$)=0$, and $\operatorname{supp} \mathbb{P}$ is an interval. Then if $D$ is a degenerate set for a regular adversarial Bayes classifier $A$, then $D \subset\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C} \cup \partial A$.

Proof. Let $D$ be a degenerate set disjoint from $\overline{\left(\operatorname{supp} \mathbb{P}^{\epsilon}\right)^{C}}$. We will show that $D \subset \partial A$. First, we use a proof by contradiction to argue that the points in $D \cup \partial A$ are strictly greater than $2 \epsilon$ apart.

If $\partial A$ and $D$ are both degenerate, Lemma 5.8 implies that $D \cup \partial A$ is degenerate as well. For contradiction, assume that $x \leq y$ are two points in $(D \cup \partial A) \cap \operatorname{supp} \mathbb{P}$ with $y-x \leq 2 \epsilon$. Then Lemma 5.14 implies that $[x, y] \subset\left((D \cup \partial A)^{\epsilon}\right)^{-\epsilon}$ is a degenerate set as well contained in supp $\mathbb{P}$. This statement contradicts Lemma 6.4. Therefore, $D \cup \partial A$ is comprised of points that are at least $2 \epsilon$ apart.

Next, we will show that a degenerate set cannot include any points in int supp $\mathbb{P}^{\epsilon}$ which are more than $2 \epsilon$ from $\partial A$. Let $z$ be any point in int supp $\mathbb{P}^{\epsilon}$ that is strictly more than $2 \epsilon$ from $\partial A$. Assume first that $z \in A$. Then

$$
R^{\epsilon}(A-\{z\})-R^{\epsilon}(A)=\int_{z-\epsilon}^{z+\epsilon} \eta(x) d \mathbb{P}
$$

However, if $z \in \operatorname{int} \operatorname{supp} \mathbb{P}^{\epsilon}$ then $(z-\epsilon, z+\epsilon) \not \subset \operatorname{supp} \mathbb{P}^{C}$ and thus has positive measure under $\mathbb{P}$. As $\eta(x)>0$ on $\operatorname{supp} \mathbb{P}$, one can conclude that $R^{\epsilon}(A-\{z\})-R^{\epsilon}(A)>0$. Similarly, if $z \in A^{C}$, then one can show that $R^{\epsilon}(A \cup\{z\})-R^{\epsilon}(A)>0$. Therefore $z$ cannot be in any degenerate set.

In summary: $D \cup \partial A$ is comprised of points that are at least $2 \epsilon$ apart, but no more than $2 \epsilon$ from $\partial A$. Therefore, one can conclude that $D \subset \partial A$.
Finally, one can extend Lemma I. 4 to all adversarial Bayes classifiers by comparing the boundary of a given adversarial Bayes classifier $A$ to the boundary of an equivalent regular adversarial Bayes classifier $A_{r}$.

Proof of the fourth bullet of Theorem 3.8. Any adversarial Bayes classifier $A$ is equivalent up to degeneracy to a regular adversarial Bayes classifier $A_{r}$. Lemma I. 4 implies that $\left(A_{r} \triangle A\right) \cap$ int supp $\mathbb{P}^{\epsilon} \subset \partial A_{r} \cap \operatorname{int} \operatorname{supp} \mathbb{P}^{\epsilon}$, where $E_{1} \triangle E_{2}=E_{1} \cap E_{2}^{C} \cup E_{2} \cap E_{1}^{C}$ is the symmetric difference between two sets. Thus there are disjoint sets $S_{1}, S_{2} \subset \partial A_{r}$ for which $A \cap \operatorname{int} \operatorname{supp} \mathbb{P}^{\epsilon}=$ $\left(A_{r} \cup S_{1}-S_{2}\right) \cap$ int supp $\mathbb{P}^{\epsilon}$. Because $A_{r}, A_{r}^{C}$ are unions of intervals of length at least $2 \epsilon$, then $\partial A_{r}=\partial\left(A_{r} \cup S_{1}-S_{2}\right)$ and consequently, $\partial A_{r} \cap$ int supp $\mathbb{P}^{\epsilon}=\partial A \cap$ int supp $\mathbb{P}^{\epsilon}$. This statement together with Lemma I. 3 implies the result.

Appendix J. Deferred Proofs from subsection 6.3. In this appendix, we adopt the same notational convention as subsection 6.3 regarding the $a_{i} \mathrm{~S}$ and $b_{i} \mathrm{~s}$ : Namely, when $A=$ $\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ is a regular adversarial Bayes classifier, $a_{M+1}$ is defined to be $+\infty$ if $M$ is finite and $b_{m-1}$ is defined to be $-\infty$ if $m$ is finite.

The following observation will assist in proving the first bullet of Lemma 6.6.
Lemma J.1. Let $\epsilon_{2}>\epsilon_{1}$. If $\mathbb{R}$ minimizes $R^{\epsilon_{2}}$ but $\emptyset$ minimizes $R^{\epsilon_{1}}$, then the sets $\mathbb{R}$ and $\emptyset$ minimize both $R^{\epsilon_{1}}$ and $R^{\epsilon_{2}}$.

Similarly, if $\emptyset$ minimizes $R^{\epsilon_{2}}$ but $\mathbb{R}$ minimizes $R^{\epsilon_{1}}$, then the sets $\mathbb{R}$ and $\emptyset$ minimize both $R^{\epsilon_{1}}$ and $R^{\epsilon_{2}}$.

Proof. First, assume that $\mathbb{R}$ minimizes $R^{\epsilon_{2}}$ and $\emptyset$ minimizes $R^{\epsilon_{1}}$. The quantities

$$
R^{\epsilon}(\mathbb{R})=\int_{\mathbb{R}} d \mathbb{P}_{0} \quad R^{\epsilon}(\emptyset)=\int_{\mathbb{R}} d \mathbb{P}_{1}
$$

are independent of the value of $\epsilon$. Next, notice that $R^{\epsilon_{2}}(A) \geq R^{\epsilon_{1}}(A)$ for an set $A$. Therefore,

$$
R_{*}^{\epsilon_{2}} \geq R_{*}^{\epsilon_{1}}=R^{\epsilon_{1}}(\emptyset)=R^{\epsilon_{2}}(\emptyset),
$$

where $R_{*}^{\epsilon}=\inf _{A} R^{\epsilon}(A)$. Thus $\emptyset$ also minimizes $R^{\epsilon_{2}}$. As a result, the sets $\mathbb{R}$ and $\emptyset$ achieve the same $R^{\epsilon_{2}}$ risk, and so

$$
R^{\epsilon_{1}}(\mathbb{R})=R^{\epsilon_{2}}(\mathbb{R})=R^{\epsilon_{2}}(\emptyset)=R^{\epsilon_{1}}(\emptyset) .
$$

Consequently, $\mathbb{R}$ is also a minimizer of $R^{\epsilon_{1}}$.
Next, swapping the roles of $\mathbb{P}_{0}$ and $\mathbb{P}_{1}$ shows that if $\emptyset$ minimizes $R^{\epsilon_{2}}$ and $\mathbb{R}$ minimizes $R^{\epsilon_{1}}$ then $\mathbb{R}, \emptyset$ minimize both $R^{\epsilon_{1}}$ and $R^{\epsilon_{2}}$

Next, recall that Lemma I. 1 implies that if the an endpoint of an adversarial Bayes classifier is too close to the boundary of $\operatorname{supp} \mathbb{P}$, then that endpoint must be in the boundary of a degenerate interval. As a result:

Corollary J.2. Assume $\mathbb{P} \ll \mu$ is a measure for which supp $\mathbb{P}$ is an interval $I$, and $\mathbb{P}(\eta=$ 0 or 1$)=0$. Then if $A$ is a regular adversarial Bayes classifier for radius $\epsilon$, then $A$ has no finite endpoints in $I^{\epsilon}-\operatorname{int} I^{-\epsilon}$.

This result implies that one only need consider $a_{i}^{1}, b_{i}^{1}, a_{j}^{2}, b_{j}^{2}$ contained in $I^{-\epsilon_{2}}$ in the proof of Lemma 6.6.

Proof of Lemma 6.6. We will show that $\left(b_{i}^{1}, a_{i+1}^{1}\right) \cap I^{\epsilon_{1}}$ does not include any non-empty $\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}}$, the argument for $\left(a_{i}^{1}, b_{i}^{1}\right) \cap I^{\epsilon_{1}}$ and $\left(a_{j}^{2}, b_{j+1}^{2}\right) \cap I^{\epsilon_{1}}$ is analogous. Fix an interval $\left(a_{j}^{2}, b_{j}^{2}\right)$ and assume that $\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}} \neq \emptyset,\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}} \subset\left(b_{i}^{1}, a_{i+1}^{1}\right) \cap I^{\epsilon_{1}}$. We will show that these relations imply that $\emptyset, \mathbb{R}$ must both be adversarial Bayes classifiers.

First, notice that the assumption $\eta \neq 0,1$ implies that none of the $a_{j}^{2} \mathrm{~s}, b_{j}^{2} \mathrm{~s}$ are in $I^{\epsilon_{2}}-$ int $I^{-\epsilon_{2}}$ due to Corollary J.2. Thus because the intersection $\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}}$ is non-empty, then either $I^{\epsilon_{2}} \subset\left(a_{j}^{2}, b_{j}^{2}\right)$ or at least one endpoint of $\left(a_{j}^{2}, b_{j}^{2}\right)$ is in int $I^{-\epsilon_{2}}$.

If in fact $\left(a_{j}^{2}, b_{j}^{2}\right) \supset I^{\epsilon_{2}}$, then $\left(b_{i+1}^{1}, a_{i}^{1}\right) \supset\left(a_{j}^{2}, b_{j}^{2}\right)$ must include $I^{\epsilon_{1}}$. Thus $R^{\epsilon_{1}}\left(A_{1}\right)=R^{\epsilon_{1}}(\emptyset)$ while $R^{\epsilon_{2}}\left(A_{2}\right)=R^{\epsilon_{2}}(\mathbb{R})$. Lemma J. 1 then implies that $\mathbb{R}$, $\emptyset$ are both adversarial Bayes classifiers for both perturbation sizes $\epsilon_{1}$ and $\epsilon_{2}$, which implies the first bullet of Lemma 6.6.

Thus, to show the second bullet of Lemma 6.6, it remains to consider $\left(a_{j}^{2}, b_{j}^{2}\right) \not \supset I^{\epsilon_{2}}$. We will show $\left(a_{j}^{2}, b_{j}^{2}\right) \supsetneq I^{\epsilon_{2}}$ but $\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}} \neq \emptyset$ and $\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}} \subset\left(b_{i}^{1}, a_{i+1}^{1}\right) \cap I^{\epsilon_{1}}$ results in a contradiction. As $b_{j}^{2}-a_{j}^{2}>2 \epsilon_{2}$ and the interval $\left(a_{j}^{2}, b_{j}^{2}\right)$ is included in the adversarial Bayes classifier $A_{2}$, it follows that $R^{\epsilon}\left(A_{2}\right) \leq R^{\epsilon}\left(A_{2}-\left(a_{j}^{2}, b_{j}^{2}\right)\right)$ which implies

$$
\int_{a_{j}^{2}-\epsilon_{2}}^{a_{j}^{2}+\epsilon_{2}} p d x+\int_{a_{j}^{2}+\epsilon_{2}}^{b_{j}^{2}-\epsilon_{2}} p_{0} d x+\int_{b_{j}^{2}-\epsilon_{2}}^{b_{j}^{2}+\epsilon_{2}} p d x \leq \int_{a_{j}^{2}-\epsilon_{2}}^{b_{j}^{2}+\epsilon_{2}} p_{1} d x
$$

and consequently

$$
\begin{equation*}
\int_{a_{j}^{2}-\epsilon_{2}}^{b_{j}^{2}+\epsilon_{2}} p_{0} d x \leq \int_{a_{j}^{2}+\epsilon_{2}}^{b_{j}^{2}-\epsilon_{2}} p_{1} d x . \tag{J.1}
\end{equation*}
$$

Next, $b_{j}^{2}-a_{j}^{2}>2 \epsilon_{2}$ and thus $\left(b_{j}^{2}-\left(\epsilon_{2}-\epsilon_{1}\right)\right)-\left(a_{j}^{2}+\left(\epsilon_{2}-\epsilon_{1}\right)\right)>2 \epsilon_{1}$. Notice that

$$
\left(a_{j}^{2}+\epsilon_{2}-\epsilon_{1}, b_{j}^{2}-\left(\epsilon_{2}-\epsilon_{1}\right)\right) \cap I^{\epsilon_{1}} \subset\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}} \subset\left(b_{i}^{1}, a_{i+1}^{1}\right) \cap I^{\epsilon_{1}}
$$

is then a connected component of $\left(A_{1} \cup\left(a_{j}^{2}+\left(\epsilon_{2}-\epsilon_{1}\right), b_{j}^{2}-\left(\epsilon_{2}-\epsilon_{1}\right)\right)\right) \cap I^{\epsilon_{1}}$. Therefore,

R^{\epsilon_{1}}\left(A_{1}\right)-R^{\epsilon_{1}}\left(A_{1} \cup\left(a_{j}^{2}+\epsilon_{2}-\epsilon_{1}, b_{j}^{2}-\left(\epsilon_{2}-\epsilon_{1}\right)\right)\right)=\int_{c_{i, j}}^{d_{i, j}} p_{1} d x-\left(\int_{c_{i, j}}^{a_{j}^{2}+\epsilon_{2}} p d x+\int_{a_{j}^{2}+\epsilon_{2}}^{b_{j}^{2}-\epsilon_{2}} p_{0} d x+\int_{b_{j}^{2}-\epsilon_{2}}^{d_{i, j}} p d x\right)
$$

where $c_{i, j}=\max \left(b_{i}^{1}+\epsilon_{1}, a_{j}^{2}+\epsilon_{2}-2 \epsilon_{1}\right)$ and $d_{i, j}=\min \left(a_{i+1}^{1}+\epsilon_{1}, b_{j}^{2}-\epsilon_{2}+2 \epsilon_{1}\right)$. We will now argue that this quantity is positive, which will contradict the fact that $A_{1}$ is an adversarial Bayes classifier.

Adding

to both sides of (J.1) implies that

& \int_{c_{i, j}}^{d_{i, j}} p_{1} d x \geq \int_{c_{i, j}}^{a_{j}^{2}+\epsilon_{2}} p d x+\int_{b_{j}^{2}-\epsilon_{2}}^{d_{i, j}} p d x+\int_{a_{j}^{2}+\epsilon_{2}}^{b_{j}^{2}-\epsilon_{2}} p_{0} d x+\int_{a_{j}^{2}-\epsilon_{2}}^{c_{i, j}} p_{0} d x+\int_{d_{i, j}}^{b_{j}^{2}+\epsilon_{2}} p_{0} d x \\
& >\int_{c_{i, j}}^{a_{j}^{2}+\epsilon_{2}} p d x+\int_{b_{j}^{2}-\epsilon_{2}}^{d_{i, j}} p d x+\int_{a_{j}^{2}+\epsilon_{2}}^{b_{j}^{2}-\epsilon_{2}} p_{0} d x \tag{J.2}
\end{align*}
$$

We will now prove that this last inequality is in fact strict. First, recall that the interval $\left(a_{j}^{2}, b_{j}^{2}\right)$ does not contain $I^{\epsilon_{2}}$ and thus Corollary J. 2 implies that at least one of $a_{j}^{2}, b_{j}^{2}$ must be in int $I^{-\epsilon_{2}}$. Consequently, supp $\mathbb{P}$ must contain at least one of $a_{j}^{2}-\epsilon$ and $b_{j}^{2}+\epsilon$. Lastly, $c_{i, j}-\left(a_{j}^{2}-\epsilon_{2}\right) \geq 2\left(\epsilon_{2}-\epsilon_{1}\right)>0$ and $b_{j}^{2}+\epsilon-d_{i, j} \geq 2\left(\epsilon_{2}-\epsilon_{1}\right)>0$ and thus at least one of the intervals $\left[a_{j}^{2}-\epsilon, c_{i, j}\right],\left[d_{i, j}, b_{j}^{2}+\epsilon_{2}\right]$ must have positive $\mathbb{P}$-measure. The assumption $\mathbb{P}(\eta=0$ or 1$)=0$ implies $\operatorname{supp} \mathbb{P}_{0}=\operatorname{supp} \mathbb{P}_{1}$ and consequently one of these intervals must have positive $\mathbb{P}_{0}$-measure.

The strict inequality in (J.2) implies $R^{\epsilon_{1}}\left(A_{1}\right)-R^{\epsilon_{1}}\left(A \cup\left(a_{j}^{2}+\epsilon_{2}-\epsilon_{1}, b_{j}^{2}-\left(\epsilon_{2}-\epsilon_{1}\right)\right)>0\right.$, which contradicts the fact that $A$ is an adversarial Bayes classifier.

Theorem 3.9 then directly follows from Lemma 6.6.
Proof of Theorem 3.9. The first bullet of Lemma 6.6 together with the fourth bullet of Theorem 3.8 imply that if both $\emptyset, \mathbb{R}$ are adversarial Bayes classifiers for perturbation size $\epsilon_{i}$, then either $A \cap I^{\epsilon_{i}}=\mathbb{R} \cap I^{\epsilon_{i}}$ and $A^{C} \cap I^{\epsilon_{i}}=\emptyset \cap I^{\epsilon_{i}}$, or $A \cap I^{\epsilon_{i}}=\emptyset \cap I^{\epsilon_{i}}$ and $A^{\epsilon} \cap I^{\epsilon_{i}}=$ $\mathbb{R} \cap I^{\epsilon_{i}}$. In either case, one can conclude that $\operatorname{comp}\left(A \cap I^{\epsilon_{1}}\right)+\operatorname{comp}\left(A^{C} \cap I^{\epsilon_{1}}\right)=1$ and $\operatorname{comp}\left(A \cap I^{\epsilon_{2}}\right)+\operatorname{comp}\left(A^{C} \cap I^{\epsilon_{2}}\right)=1$.

Next, assume that for perturbation size $\epsilon_{1}$, the sets $\mathbb{R}, \emptyset$ are not both adversarial Bayes classifiers. Corollary J. 2 implies that there are no $a_{j}^{2}, b_{j}^{2} \in I^{\epsilon_{2}}-I^{-\epsilon_{2}}$. As $I^{-\epsilon_{2}} \subset I^{\epsilon_{1}} \subset I^{\epsilon_{2}}$ are all intervals which are connected sets, one can conclude that $\operatorname{comp}\left(A_{2} \cap I^{\epsilon_{2}}\right)=\operatorname{comp}\left(A_{2} \cap I^{\epsilon_{1}}\right)$ and $\operatorname{comp}\left(A_{2}^{C} \cap I^{\epsilon_{2}}\right)=\operatorname{comp}\left(A_{2}^{C} \cap I^{\epsilon_{1}}\right)$. Therefore, it remains to show that $\operatorname{comp}\left(A_{1} \cap I^{\epsilon_{1}}\right) \geq$ $\operatorname{comp}\left(A_{2} \cap I^{\epsilon_{1}}\right)$ and $\operatorname{comp}\left(A_{1}^{C} \cap I^{\epsilon_{1}}\right) \geq \operatorname{comp}\left(A_{2}^{C} \cap I^{\epsilon_{1}}\right)$. We will show the statement for $A_{1} \cap I^{\epsilon_{1}}$ and $A_{2} \cap I^{\epsilon_{1}}$, the argument for $A_{1}^{C} \cap I^{\epsilon_{1}}$ and $A_{2}^{C} \cap I^{\epsilon_{1}}$ is analogous.

Let

$$
A_{1}=\bigcup_{i=m}^{M}\left(a_{i}^{1}, b_{i}^{1}\right), \quad A_{2}=\bigcup_{j=n}^{N}\left(a_{j}^{2}, b_{j}^{2}\right) .
$$

Because $I^{\epsilon_{1}}$ is an interval, the intersections $\left(a_{i}^{1}, b_{i}^{1}\right) \cap I^{\epsilon_{1}},\left(b_{j}^{2}, a_{j+1}^{2}\right) \cap I^{\epsilon_{1}}$ are intervals for $i \in[m, M]$ and $j \in[n, N]$. If the interval $\left(a_{i}^{1}, b_{i}^{1}\right) \cap I^{\epsilon_{1}}$ intersects both the intervals $\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}}$ and $\left(a_{j+1}^{2}, b_{j+1}^{2}\right) \cap I^{\epsilon_{1}}$ for some $j$, then $\left(a_{i}^{1}, b_{i}^{1}\right) \cap I^{\epsilon_{1}}$ must contain some $\left(b_{j}^{2}, a_{j+1}^{2}\right) \cap I^{\epsilon_{1}}$ for some
$j$, which contradicts Lemma 6.6. Thus there is at most one interval $\left(a_{j}^{2}, b_{j}^{2}\right) \cap I^{\epsilon_{1}}$ for each interval $\left(a_{i}^{1}, b_{i}^{1}\right) \cap I^{\epsilon_{1}}$, which implies that $\operatorname{comp}\left(A_{1} \cap I^{\epsilon_{1}}\right) \geq \operatorname{comp}\left(A_{2} \cap I^{\epsilon_{1}}\right)=\operatorname{comp}\left(A_{2} \cap I^{\epsilon_{2}}\right)$.

Appendix K. Computational Details of Examples and proofs of Propositions 4.9 and 4.10. The following lemma is helpful for verifying the second order necessary conditions for gaussian mixtures.

Lemma K.1. Let $g(x)=\frac{t}{\sqrt{2 \pi} \sigma} e^{-\frac{(x-\mu)^{2}}{2 \sigma^{2}}}$. Then $g^{\prime}(x)=-\frac{x-\mu}{\sigma^{2}} g(x)$.
Proof. The chain rule implies that

g^{\prime}(x)=-\frac{x-\mu}{\sigma^{2}} \cdot \frac{t}{\sqrt{2 \pi} \sigma} e^{-\frac{(x-\mu)^{2}}{2 \sigma^{2}}}=-\frac{x-\mu}{\sigma^{2}} g(x)
$$

K.1. Further details from Example 4.1. It remains to verify two of the claims made in Example 4.1- namely, 1) that $b(\epsilon)$ does not satisfy the second order necessary condition (3.1b), and 2) Comparing the adversarial risks of $\mathbb{R}, \emptyset,(a(\epsilon),+\infty)$ to prove that $(a(\epsilon),+\infty)$ is an adversarial Bayes classifier iff $\epsilon \leq \frac{\mu_{1}-\mu_{0}}{2}$ and $\mathbb{R}, \emptyset$ are adversarial Bayes classifiers iff $\epsilon \geq \frac{\mu_{1}-\mu_{0}}{2}$.

1) Showing $b(\epsilon)$ doesn't satisfy the second order necessary condition (3.1b). Due to Lemma K. 1 the equation (3.1b) reduces to

$$
p_{0}^{\prime}(b(\epsilon)+\epsilon)-p_{1}^{\prime}(b(\epsilon)-\epsilon)=-\frac{b(\epsilon)+\epsilon-\mu_{0}}{\sigma^{2}} p_{0}(b(\epsilon)-\epsilon)+\frac{b(\epsilon)-\epsilon-\mu_{1}}{\sigma^{2}} p_{1}(b(\epsilon)+\epsilon)
$$

Furthermore, the first order necessary condition $p_{0}(b(\epsilon)-\epsilon)-p_{1}(b(\epsilon)+\epsilon)=0$ implies that
$p_{0}^{\prime}(b(\epsilon)+\epsilon)-p_{1}^{\prime}(b(\epsilon)-\epsilon)=\frac{p_{1}(b+\epsilon)}{\sigma^{2}}\left(-\left(b(\epsilon)+\epsilon-\mu_{0}\right)+\left(b(\epsilon)-\epsilon-\mu_{1}\right)\right)=\frac{p_{1}(b+\epsilon)}{\sigma^{2}}\left(\mu_{0}-\mu_{1}-2 \epsilon\right)$
This quantity is negative due to the assumption $\mu_{1}>\mu_{0}$.
2) Comparing the adversarial risks of $\mathbb{R}, \emptyset$, and $(a(\epsilon),+\infty)$. First, notice that $R^{\epsilon}(\emptyset)=$ $R^{\epsilon}(\mathbb{R})=\frac{1}{2}$.

Thus it suffices to compare the risks of $(a(\epsilon),+\infty)$ and $\mathbb{R}$. Let

$$
\Phi(x)=\int_{-\infty}^{x} \frac{1}{\sqrt{2 \pi}} e^{-\frac{t^{2}}{2}} d t
$$

be the cdf of a standard gaussian. Then $R^{\epsilon}((a(\epsilon),+\infty)) \leq R^{\epsilon}(\mathbb{R})$ iff

$$
\int_{-\infty}^{a(\epsilon)+\epsilon} p_{1}(x) d x+\int_{a(\epsilon)-\epsilon}^{+\infty} p_{0}(x) d x \leq \int_{-\infty}^{+\infty} p_{0}(x) d x
$$

Furthermore, because $p_{0}$ and $p_{1}$ are strictly positive the equation above is equivalent to

$$
\int_{-\infty}^{a(\epsilon)+\epsilon} \frac{1}{\sqrt{2 \pi} \sigma} e^{-\frac{\left(x-\mu_{1}\right)^{2}}{2 \sigma^{2}}} d x \leq \int_{-\infty}^{a(\epsilon)-\epsilon} \frac{1}{\sqrt{2 \pi} \sigma} e^{-\frac{\left(x-\mu_{0}\right)^{2}}{2 \sigma^{2}}}
$$

which is also equivalent to $\Phi\left(\frac{a(\epsilon)+\epsilon-\mu_{1}}{\sigma}\right) \leq \Phi\left(\frac{a(\epsilon)-\epsilon-\mu_{0}}{\sigma}\right)$. As the function $\Phi$ is strictly increasing, this relation is equivalent to the inequality

$$
\frac{a(\epsilon)+\epsilon-\mu_{1}}{\sigma} \leq \frac{a(\epsilon)-\epsilon-\mu_{0}}{\sigma}
$$

which simplifies as $\epsilon \leq \frac{\mu_{1}-\mu_{0}}{2}$. Therefore, $(-\infty, a(\epsilon))$ is an adversarial Bayes classifier iff $\epsilon \leq \frac{\mu_{1}-\mu_{0}}{2}$ and $\mathbb{R}, \emptyset$ are adversarial Bayes classifiers iff $\epsilon \geq \frac{\mu_{1}-\mu_{0}}{2}$.
K.2. Further details of Example 4.2. The constant $k=\ln \frac{(1-\lambda) \sigma_{1}}{\lambda \sigma_{0}}$ will feature prominently in subsequent calculations, notice that the assumption $\frac{\lambda}{\sigma_{1}}>\frac{1-\lambda}{\sigma_{0}}$ implies that $k<0$. The equation (2.8b) requires solving $\frac{1-\lambda}{\sigma_{0}} e^{-(b+\epsilon)^{2} / 2 \sigma_{0}^{2}}=\frac{\lambda}{\sigma_{1}} e^{-(b-\epsilon)^{2} / 2 \sigma_{1}^{2}}$, with solutions (4.1) and

$$
\begin{equation*}
y(\epsilon)=\frac{\epsilon\left(\frac{1}{\sigma_{1}^{2}}+\frac{1}{\sigma_{0}^{2}}\right)-\sqrt{\frac{4 \epsilon^{2}}{\sigma_{0}^{2} \sigma_{1}^{2}}-2\left(\frac{1}{\sigma_{1}^{2}}-\frac{1}{\sigma_{0}^{2}}\right) k}}{\frac{1}{\sigma_{1}^{2}}-\frac{1}{\sigma_{0}^{2}}} . \tag{K.1}
\end{equation*}
$$

The discriminant is positive as $k<0$ and $\sigma_{0}>\sigma_{1}$. However, one can show that $y(\epsilon)$ does not satisfy the second order necessary condition (3.1b) (see below). Similarly, the only solution to the necessary conditions (2.8a) and (3.1a) is $a(\epsilon)=-b(\epsilon)$.

Thus there are five candidate sets for the adversarial Bayes classifier: $\emptyset, \mathbb{R},(-\infty, b(\epsilon))$, $(a(\epsilon),+\infty)$ and $(a(\epsilon), b(\epsilon))$. Theorem 3.8 implies that none of these sets could be equivalent up to degeneracy. By comparing the adversarial classification risks, one can show that $(a(\epsilon), b(\epsilon))$ has the strictly smallest adversarial classification risk from these five options (see Appendix K.2). Therefore, $(a(\epsilon), b(\epsilon))$ is the adversarial Bayes classifier for all $\epsilon$.

It remains to verify two of the claims above - namely, 1) that $y(\epsilon)$ does not satisfy the second order necessary condition (3.1b), and 2) Proving that $(a(\epsilon), b(\epsilon))$ is always the adversarial Bayes classifier by comparing the risks of $(a(\epsilon), b(\epsilon), \mathbb{R}, \emptyset,(a(\epsilon), \infty)$, and $(-\infty, b(\epsilon))$.

1) The point $y(\epsilon)$ does not satisfy the second order necessary condition (3.1b). First, notice that

$$
\begin{equation*}
y(\epsilon) \leq \frac{\epsilon\left(\frac{1}{\sigma_{1}^{2}}+\frac{1}{\sigma_{0}^{2}}\right)-\sqrt{\frac{4 \epsilon^{2}}{\sigma_{0}^{2} \sigma_{1}^{2}}}}{\frac{1}{\sigma_{1}^{2}}-\frac{1}{\sigma_{0}^{2}}}=\frac{\epsilon\left(\frac{1}{\sigma_{1}^{2}}+\frac{1}{\sigma_{0}^{2}}\right)-\frac{2 \epsilon}{\sigma_{0} \sigma_{1}}}{\frac{1}{\sigma_{1}^{2}}-\frac{1}{\sigma_{0}^{2}}} \tag{K.2}
\end{equation*}
$$

This bound shows that $y(\epsilon)$ fails to satisfy the second order necessary condition (3.1b). One can compute the derivative $p_{i}^{\prime}$ in terms of $p_{i}$ using Lemma K.1. Specifically, $p_{i}^{\prime}(x)=\frac{-x}{\sigma_{i}^{2}} p_{i}(x)$ and therefore

$$
p_{0}^{\prime}(y(\epsilon)+\epsilon)-p_{1}^{\prime}(y(\epsilon)-\epsilon)=-\frac{y(\epsilon)+\epsilon}{\sigma_{0}^{2}} p_{0}(y(\epsilon)+\epsilon)+\frac{y(\epsilon)-\epsilon}{\sigma_{1}^{2}} p_{1}(y(\epsilon)-\epsilon)
$$

The first order condition $p_{0}(y(\epsilon)+\epsilon)-p_{1}(y(\epsilon)-\epsilon)=0$ implies

$$
p_{0}^{\prime}(y(\epsilon)+\epsilon)-p_{1}^{\prime}(y(\epsilon)-\epsilon)=p_{0}(y(\epsilon)+\epsilon)\left(y(\epsilon)\left(\frac{1}{\sigma_{1}^{2}}-\frac{1}{\sigma_{0}^{2}}\right)-\epsilon\left(\frac{1}{\sigma_{1}^{2}}+\frac{1}{\sigma_{0}^{2}}\right)\right)
$$

However, (K.2) implies that

$$
p_{0}(y(\epsilon)+\epsilon)\left(y(\epsilon)\left(\frac{1}{\sigma_{1}^{2}}-\frac{1}{\sigma_{0}^{2}}\right)-\epsilon\left(\frac{1}{\sigma_{1}^{2}}+\frac{1}{\sigma_{0}^{2}}\right)\right) \leq p_{0}(y(\epsilon)+\epsilon) \cdot \frac{-2 \epsilon}{\sigma_{0} \sigma_{1}}<0
$$

Thus, the only solution to first (2.8b) and (3.1b) is $b(\epsilon)$.
2) Comparing the risks of $(a(\epsilon), b(\epsilon)), \mathbb{R}, \emptyset,(a(\epsilon), \infty)$, and $(-\infty, b(\epsilon))$. First, we argue that $R^{\epsilon}((a(\epsilon), \infty))>R^{\epsilon}((a(\epsilon), b(\epsilon))$ :

$$
\begin{align*}
R^{\epsilon}((a(\epsilon), \infty))-R^{\epsilon}((a(\epsilon), b(\epsilon))) & =\int_{b(\epsilon)+\epsilon}^{+\infty} p_{0}(x)-p_{1}(x) d x-\int_{b(\epsilon)-\epsilon}^{b(\epsilon)+\epsilon} p_{1}(x) d x  \tag{K.3}\\
& =\int_{b(\epsilon)}^{\infty} p_{0}(x+\epsilon)-p_{1}(x-\epsilon) d x
\end{align*}
$$

The same calculation that solves for $b(\epsilon)$ in (4.1) and $y(\epsilon)$ in (K.1) then shows that $p_{0}(x+$ $\epsilon)-p_{1}(x-\epsilon)$ is strictly positive when $x>b(\epsilon)$.

Additionally, $R^{\epsilon}((a(\epsilon),+\infty))=R^{\epsilon}((-\infty, b(\epsilon)))$ because $a(\epsilon)=-b(\epsilon)$ and $p_{0}, p_{1}$ are symmetric around zero. Furthermore, by writing out the integrals as in the first line of (K.3), one can show that $R^{\epsilon}(\mathbb{R})-R^{\epsilon}((-\infty, b(\epsilon)))=R^{\epsilon}((a(\epsilon), \infty))-R^{\epsilon}((a(\epsilon), b(\epsilon)))$. Thus

$$
R^{\epsilon}(\mathbb{R})-R^{\epsilon}((a(\epsilon), b(\epsilon)))=2\left(R^{\epsilon}((a(\epsilon), \infty))-R^{\epsilon}((a(\epsilon), b(\epsilon)))>0\right.
$$

and hence one can conclude that $R^{\epsilon}((a(\epsilon), b(\epsilon)))<R^{\epsilon}(\mathbb{R})$ and $R^{\epsilon}((a(\epsilon), b(\epsilon)))<R^{\epsilon}((-\infty, b(\epsilon)))$. Similarly, one can show that

$$
R^{\epsilon}(\emptyset)-R^{\epsilon}((a(\epsilon), b(\epsilon)))=2\left(R^{\epsilon}((a(\epsilon), \infty))-R^{\epsilon}((a(\epsilon), b(\epsilon)))\right)>0
$$

and thus $R^{\epsilon}(\emptyset)>R^{\epsilon}((a(\epsilon), b(\epsilon)))$.
K.3. Proof of Lemma 4.3. Lemmas I. 1 and I. 3 of Appendix I. 1 are used in the proof of Lemma 4.3.

Proof of Lemma 4.3. Without loss of generality one can assume that $A$ is a union of open intervals due to Lemma 5.2.

There is nothing to show if $\operatorname{supp} \mathbb{P}=\mathbb{R}$.
We now consider smaller support- for concreteness, we will assume that supp $\mathbb{P}=[\ell, \infty)$, the cases $\operatorname{supp} \mathbb{P}=[\ell, r], \operatorname{supp} \mathbb{P}=(-\infty, r]$ have analogous reasoning.

Let

$$
\begin{aligned}
& i^{*}=\underset{a_{i} \geq \ell}{\operatorname{argmin}} a_{i}-\ell \\
& j^{*}=\underset{b_{i} \geq \ell}{\operatorname{argmin}} b_{i}-\ell
\end{aligned}
$$

We will now consider four cases:
I) $\left|\ell-a_{i^{*}}\right| \leq\left|\ell-b_{j^{*}}\right|$ and $a_{i^{*}}>\ell+\epsilon$; in which case $A^{\prime}=\left(a_{i^{*}},+\infty\right) \cap A$ is the desired adversarial Bayes classifier
II) $\left|\ell-a_{i^{*}}\right| \leq\left|\ell-b_{j^{*}}\right|$ and $a_{i^{*}} \leq \ell+\epsilon$; in which case $A^{\prime}=\left(-\infty, a_{i^{*}}\right] \cup A$ is the desired adversarial Bayes classifier
III) $\left|\ell-a_{i^{*}}\right|>\left|\ell-b_{j^{*}}\right|$ and $b_{j^{*}}>\ell+\epsilon$; in which case $A^{\prime}=\left(-\infty, b_{j^{*}}\right) \cup A$ is the desired adversarial Bayes classifier
IV) $\left|\ell-a_{i^{*}}\right|>\left|\ell-b_{j^{*}}\right|$ and $b_{j^{*}} \leq \ell+\epsilon$; in which case $A^{\prime}=\left(b_{j^{*}}, \infty\right) \cap A$ is the desired adversarial Bayes classifier
We will show Items I) and II), the arguments for Items III) and IV) is analogous.
Item I): First, we argue that $A$ and $A^{\prime}$ are equivalent. Lemma I. 3 implies that $(-\infty, \ell-\epsilon]$ is a degenerate set. Next, there can be at most one point of $\partial A$ in $[\ell-\epsilon, \ell]$ because $A$ is regular. By the definition of $i_{*}$, if there is some point of $\partial A$ in $[\ell-\epsilon, \ell]$, that point must be $b_{i^{*}-1}$. If $b_{i^{*}-1} \in[\ell-\epsilon, \ell]$, then Lemma I. 1 implies that $\left[\ell-\epsilon, b_{i^{*}-1}\right]$ is a degenerate set, and thus $A^{\prime}=A-\left((-\infty, \ell-\epsilon] \cup\left[\ell-\epsilon, b_{i^{*}-1}\right]\right)$ and consequently $A$ and $A^{\prime}$ are equivalent. On the other hand, if $b_{i^{*}-1} \notin[\ell-\epsilon, \ell]$, then $A^{\prime}=A-(-\infty, \ell-\epsilon]$ and thus $A$ and $A^{\prime}$ are equivalent.

Next, we show that $A^{\prime}:=\left(a_{i^{*}}, \infty\right) \cap A$ is a regular set. Because $A$ is regular, the point $a_{i^{*}}$ is more than $2 \epsilon$ from any other boundary point of $\partial A$. As $\partial\left(\left(a_{i^{*}},+\infty\right) \cap A\right) \subset \partial\left(-\infty, a_{i^{*}}\right) \cup \partial A=$ $\partial A$, the point $a_{i}^{*}$ must be more than $2 \epsilon$ from any other boundary point of $\left(a_{i^{*}},+\infty\right) \cap A$. Therefore, $A^{\prime}$ is regular.

The assumption $a_{i^{*}}>\ell+\epsilon$ implies that $A^{\prime} \subset(\ell+\epsilon+\delta,+\infty)$ for some $\delta>0$ and consequently $A^{\prime}$ can only have boundary points in $(\ell+\epsilon,+\infty)=\operatorname{int} \operatorname{supp} \mathbb{P}^{-\epsilon}$.

Finally, $A^{\prime}$ is open as it is the intersection of open sets.
Item II): First, we argue that $A$ and $A^{\prime}$ are equivalent. Lemmas I. 1 and I. 3 imply that the sets $\left[\ell-\epsilon, a_{i^{*}}\right]$ and $(-\infty, \ell-\epsilon]$ are degenerate sets for $A$. Therefore, $A$ and $A^{\prime}$ are equivalent up to degeneracy.

Next, the same argument as Item I) shows that $A^{\prime}=A \cup\left(-\infty, a_{i^{*}}\right]$ is a regular set: $\partial\left(A \cup\left(-\infty, a_{i^{*}}\right]\right) \subset \partial A \cup \partial\left(-\infty, a_{i^{*}}\right]=\partial A$. Thus the boundary points of $A^{\prime}$ must be at least $2 \epsilon$ apart because $A$ is regular.

Further, the set $A^{\prime}$ is open because $\left(-\infty, a_{i^{*}}\right] \cup\left(a_{i^{*}}, b_{i^{*}}\right)=\left(-\infty, b_{i^{*}}\right)$ and consequently, $A^{\prime}=\left(-\infty, b_{i^{*}}\right) \cup A$.

Finally, to show that $\partial A^{\prime} \subset \operatorname{intsupp} \mathbb{P}^{-\epsilon}$, we argue that $A^{\prime}$ has no boundary points in $(-\infty, \ell+\epsilon]=\left(\operatorname{int} \operatorname{supp} \mathbb{P}^{-\epsilon}\right)^{C}$. As $\left(-\infty, b_{i^{*}}\right) \subset A^{\prime}$, the set $A^{\prime}$ has no boundary points in $\left(-\infty, b_{i^{*}}\right]$. However, the interval $\left(-\infty, b_{i^{*}}\right]$ contains $(-\infty, \ell+\epsilon]$ as $b_{i^{*}}-a_{i^{*}}>2 \epsilon$ because $A$ is regular.
K.4. Example 4.5 details. Theorem 3.7 implies that when $\epsilon<1 / 2$ the candidate solutions for the $a_{i}, b_{i}$ are $[-\epsilon, \epsilon] \cup\{-1-\epsilon,-1+\epsilon, 1-\epsilon, 1+\epsilon\}$. However, Lemma 4.3 implies that one only needs to consider points $a_{i}, b_{i}$ in $[-\epsilon, \epsilon]$ when identifying adversarial Bayes classifiers under equivalence up to degeneracy. However, $R^{\epsilon}((y, \infty))<R^{\epsilon}((-\infty, y))$ for any $y \in[-\epsilon, \epsilon]$ because $p_{1}(x)>p_{0}(x)$ for $x>\epsilon$ while $p_{1}(x)-p_{0}(x)<0$ for any $x<-\epsilon$. Thus, the candidate sets for the adversarial Bayes classifier are $\mathbb{R}, \emptyset$, and $(y, \infty)$ for any $y \in[-\epsilon, \epsilon]$. Next, any point $y \in[-\epsilon, \epsilon]$ achieves the same risk: $R^{\epsilon}((y, \infty))=\epsilon+\frac{1}{4}(1-\epsilon)$ while $R^{\epsilon}(\mathbb{R})=R^{\epsilon}(\emptyset)=1 / 2$. Thus $\emptyset, \mathbb{R}$ are adversarial Bayes classifiers when $\epsilon \in[1 / 3,1 / 2)$ and $(y, \infty)$ is an adversarial Bayes classifier only when $\epsilon \leq 1 / 3$. Thus Theorem 3.9 implies that $(y, \infty)$ is an adversarial Bayes classifier for any $y \in[-\epsilon, \epsilon]$ iff $\epsilon \leq 1 / 3$ while $\mathbb{R}, \emptyset$ are adversarial Bayes classifiers iff $\epsilon \geq 1 / 3$.
K.5. Example 4.6 details. It remains to compare the adversarial risks of all sets whose boundary is included in $\{-1 / 4 \pm \epsilon, 1 / 4 \pm \epsilon\}$ for all $\epsilon>0$. As points in the boundary of a regular adversarial Bayes classifier must be more than $2 \epsilon$ apart, the boundary of a regular adversarial Bayes classifier can include at most one of $\left\{-\frac{1}{4}-\epsilon,-\frac{1}{4}+\epsilon\right\}$ and at most one of $\left\{\frac{1}{4}-\epsilon, \frac{1}{4}+\epsilon\right\}$. Let $\mathcal{S}$ be the set of open sets with at most one boundary point in $\left\{-\frac{1}{4}-\epsilon,-\frac{1}{4}+\epsilon\right\}$, at most one boundary point in $\left\{\frac{1}{4}-\epsilon, \frac{1}{4}+\epsilon\right\}$, and no other boundary points.

Instead of explicitly computing the adversarial risk of each set in $\mathcal{S}$, we will rule out most combinations by understanding properties of such sets, and then comparing to the adversarial risk of $\mathbb{R}$, for which $R^{\epsilon}(\mathbb{R})=1 / 10$ for all possible $\epsilon$. We consider three separate cases:

When $\epsilon>1 / 4$ : If a set $A$ includes at least one endpoint in int $\operatorname{supp} \mathbb{P}^{-\epsilon}$, then

$$
R^{\epsilon}(A) \geq 2 \epsilon \inf _{x \in \operatorname{supp} \mathbb{P}} p(x) \geq \frac{2 \epsilon}{5}>\frac{1}{10}=R^{\epsilon}(\mathbb{R})
$$

The only two sets in $\mathcal{S}$ that have no endpoints in int supp $\mathbb{P}^{-\epsilon}$ are $\mathbb{R}$ and $\emptyset$, but $R^{\epsilon}(\emptyset)=9 / 10$. Thus if $\epsilon>1 / 4$, then $\mathbb{R}$ is an adversarial Bayes classifier, and this classifier is unique up to degeneracy.

When $1 / 8 \leq \epsilon \leq 1 / 4$ : If either $1 / 4+\epsilon,-1 / 4-\epsilon$ are in the boundary of a set $A$, then

$$
R^{\epsilon}(A) \geq \int_{y-\epsilon}^{y+\epsilon} p(x) d x=\frac{3}{5} \cdot 2 \epsilon \geq \frac{3}{20}>R^{\epsilon}(\mathbb{R}) .
$$

(The value $y$ above is either $1 / 4+\epsilon$ or $-1 / 4-\epsilon$.) Consequently, for these values of $\epsilon$, only sets in $\mathcal{S}$ with at most one endpoint in $\{-1 / 4+\epsilon\}$ and at most one endpoint in $\{1 / 4-\epsilon\}$ can be adversarial Bayes classifiers.

Next, if a set $A$ in $\mathcal{S}$ excludes either $(-\infty,-1 / 4)$ or $(1 / 4, \infty)$, then

$$
R^{\epsilon}(A) \geq \int_{S} p_{1}(x) d x \geq \frac{3}{5} \cdot \frac{3}{4}>R^{\epsilon}(\mathbb{R})
$$

(The set $S$ above represents either $(-\infty,-1 / 4)$ or $(1 / 4, \infty)$.) As a result, such a set cannot be an adversarial Bayes classifier.

However, $\mathbb{R}$ and $(-\infty,-1 / 4+\epsilon) \cup(1 / 4-\epsilon, \infty)$ are the only two sets in $\mathcal{S}$ with at most one endpoint in $\{-1 / 4+\epsilon\}$ and at most one endpoint in $\{1 / 4-\epsilon\}$, that include $(-\infty,-1 / 4) \cup$ $(1 / 4, \infty)$. The set $(-\infty,-1 / 4+\epsilon) \cup(1 / 4-\epsilon, \infty)$ is not a regular set when $\epsilon \geq 1 / 8$. Consequently, When $\epsilon \in(1 / 8,1 / 4]$, the set $\mathbb{R}$ is an adversarial Bayes classifier, and this classifier is unique up to degeneracy.

When $\epsilon<1 / 8$ : First, if $A$ excludes $[-1-\epsilon,-1 / 4-\epsilon)$ or $(1 / 4+\epsilon, 1+\epsilon$ ], then

$$
R^{\epsilon}(A) \geq \frac{3}{5} \cdot\left(\frac{3}{4}-\epsilon\right) \geq \frac{3}{5} \cdot\left(\frac{3}{4}-\frac{1}{8}\right)=\frac{3}{8}>R^{\epsilon}(\mathbb{R})
$$

There are only five sets in $\mathcal{S}$ that satisfy this requirement: $A_{1}=(-\infty,-1 / 4+\epsilon) \cup(1 / 4-\epsilon, \infty)$, $A_{2}=(-\infty,-1 / 4-\epsilon) \cup(1 / 4-\epsilon, \infty), A_{3}=(-\infty,-1 / 4+\epsilon) \cup(1 / 4+\epsilon, \infty), A_{4}=(-\infty,-1 / 4-$ $\epsilon) \cup(1 / 4+\epsilon, \infty)$, and $A_{5}=\mathbb{R}$. All of these sets are regular when $\epsilon<1 / 8$. One can compute:

$$
R^{\epsilon}\left(A_{1}\right)=\frac{4 \epsilon}{5}, R^{\epsilon}\left(A_{2}\right)=R^{\epsilon}\left(A_{3}\right)=\frac{8 \epsilon}{5}, \text { and } R^{\epsilon}\left(A_{4}\right)=\frac{6}{5} \epsilon
$$

Of these five alternatives, the set $A_{1}$ has the strictly smallest risk when $\epsilon \in(0,1 / 8)$. Consequently, when $\epsilon \in(0,1 / 8)$, the set $A_{1}$ is the adversarial Bayes classifier and is unique up to degeneracy.

## K.6. Proof of Proposition 4.9.

Proof of Proposition 4.9. Due to Theorem 3.5 and Lemma 4.3, any adversarial Bayes classifier is equivalent up to degeneracy to a regular adversarial Bayes classifier $A=\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ for which all the finite $a_{i}$ and $b_{i}$ are contained in int supp $\mathbb{P}^{-\epsilon}$. Consequently, if there is some $a_{i}$ or $b_{i}$ in int supp $\mathbb{P}^{-\epsilon}$, then $\epsilon<|\operatorname{supp} \mathbb{P}| / 2$.

For every point $x$ in int supp $\mathbb{P}^{-\epsilon}$, the densities $p_{0}$ and $p_{1}$ are both continuous at $x-\epsilon$ and $x+\epsilon$. Consequently, the necessary conditions (2.8) reduce to

$$
\text { (K.4a) } \quad \eta(a+\epsilon)=1-\eta(a-\epsilon) \quad \text { and } \quad(\mathrm{K} .4 \mathrm{~b}) \quad . \quad \eta(b-\epsilon)=1-\eta(b+\epsilon)
$$

on this set. If $a$ is more than $\epsilon$ away from a point $z$ satisfying $\eta(z)=1 / 2$, the continuity of $\eta$ implies that $\eta(a+\epsilon), \eta(a-\epsilon)$ are either both strictly larger than $1 / 2$ or strictly smaller than $1 / 2$, and thus $a$ would not satisfy (K.4a). As a result, every $a_{i}$ must be within $\epsilon$ of a solution to $\eta(z)=1 / 2$. An analogous argument shows that the same holds for solutions to (K.4b).

## K.7. Proof of Proposition 4.10.

Proof of Proposition 4.10. Due to Theorem 3.5 and Lemma 4.3, any adversarial Bayes classifier is equivalent up to degeneracy to a regular adversarial Bayes classifier $A=\bigcup_{i=m}^{M}\left(a_{i}, b_{i}\right)$ for which all the finite $a_{i}$ and $b_{i}$ are contained in int supp $\mathbb{P}^{-\epsilon}$. Consequently, if there is some $a_{i}$ or $b_{i}$ in int supp $\mathbb{P}^{\epsilon}$, then $\epsilon<|\operatorname{supp} \mathbb{P}| / 2$.

For contradiction, assume that $a_{i}$ is not within $\epsilon$ of any point in $\partial\{\eta=1\}$. Then for some $r>0, \eta$ is either identically 1 or identically 0 on $\left(a_{i}(\epsilon)-\epsilon-r, a_{i}(\epsilon)+\epsilon+r\right)$ and thus $p_{1}=p \eta$ is continuous on this set. Furthermore, because $a_{i} \in \operatorname{int} \operatorname{supp} \mathbb{P}^{-\epsilon}$ but $\epsilon<|\operatorname{supp} \mathbb{P}| / 2, p_{1}\left(a_{i}+\epsilon\right)$ is strictly positive while $p_{0}\left(a_{i}-\epsilon\right)=0$. Consequently, $a(\epsilon)$ cannot satisfy the necessary condition (2.8a), thus contradicting Theorem 3.7.
K.8. Example 6.5 details. It remains to compare the risks of all regular sets with endpoints in $\left\{-\frac{7}{2},-\frac{5}{2} \epsilon,-\frac{3}{2} \epsilon,-\frac{1}{2} \epsilon,+\frac{1}{2} \epsilon,+\frac{3}{2} \epsilon,+\frac{5}{2} \epsilon,+\frac{7}{2} \epsilon\right\}$, and show that $\mathbb{R}$ is indeed an adversarial Bayes classifier. Rather than explicitly writing out all such sets and computing their adversarial risks, we show that one need not consider certain sets in $\mathcal{S}$ because if they were adversarial Bayes classifiers, they would be equivalent up to degeneracy to other sets in $\mathcal{S}$.

First, Lemma I. 1 with $I=\left[-\frac{5}{2} \epsilon,+\frac{5}{2} \epsilon\right]$ implies that if $A$ is a regular adversarial Bayes classifier and $y \in\left\{-\frac{7}{2} \epsilon,-\frac{5}{2} \epsilon,-\frac{3}{2} \epsilon\right\}$ is in $\partial A$, then $\left[-\frac{7}{2} \epsilon, y\right]$ is a degenerate set. This observation rules out sets with endpoints in $\left\{-\frac{7}{2} \epsilon,-\frac{5}{2} \epsilon,-\frac{3}{2} \epsilon\right\}$ when identifying all possible adversarial Bayes classifiers under equivalence up to degeneracy. Similarly, Lemma I. 1 also implies that there is no need to consider $\left\{+\frac{3}{2} \epsilon,+\frac{5}{2} \epsilon,+\frac{7}{2} \epsilon\right\}$ as possible values of the $a_{i}$ S or $b_{i}$ s. Thus it remains to compare the risks of regular sets whose boundary is contained in $\left\{-\frac{1}{2} \epsilon,-\frac{1}{2} \epsilon\right\}$. As points in the boundary of a regular set are at least $2 \epsilon$ apart, one can rule out sets with more than one boundary point in $\left\{-\frac{1}{2} \epsilon,+\frac{1}{2} \epsilon\right\}$.

Consequently, it remains to compare the adversarial risks of six sets: $\mathbb{R}, \emptyset,\left(-\frac{1}{2} \epsilon,+\infty\right)$,
$\left(-\infty,-\frac{1}{2} \epsilon\right),\left(+\frac{1}{2} \epsilon,+\infty\right)$, and $\left(-\infty,+\frac{1}{2} \epsilon\right)$. The adversarial risks of these sets are:

$$
\begin{gathered}
R^{\epsilon}(\mathbb{R})=\frac{14}{25} \quad R^{\epsilon}(\emptyset)=\frac{11}{25} \\
R^{\epsilon}\left(\left(-\frac{1}{2} \epsilon,+\infty\right)\right)=R^{\epsilon}\left(\left(+\frac{1}{2} \epsilon,+\infty\right)\right)=\frac{21}{25} \\
R^{\epsilon}\left(\left(-\infty,-\frac{1}{2} \epsilon\right)\right)=R^{\epsilon}\left(\left(-\infty,+\frac{1}{2} \epsilon\right)\right)=\frac{9}{25}
\end{gathered}
$$

Therefore, the set $\left(-\infty,-\frac{1}{2} \epsilon\right)$ is an adversarial Bayes classifier.
