

Perception in Pixels: Understanding Avatar Representation in Video-Mediated Collaborative Interactions

Despite the abundance of research concerning virtual reality (VR) avatars, the impact of screen-based or augmented reality (AR) avatars for real-world applications remain relatively unexplored. Notably, there is a lack of research examining video-mediated collaborative interaction experiences using AR avatars for goal-directed group activities. This study bridges this gap with a mixed-methods, quasi-experimental user study that investigates video-based small-group interactions when employing AR avatars as opposed to traditional video for user representation. We found that the use of avatars positively influenced self-esteem and video-based collaboration satisfaction. In addition, our group interview findings highlight experiences and perceptions regarding the dynamic use of avatars in video-mediated collaborative interactions, including benefits, challenges, and factors that would influence a decision to use avatars. This study contributes an empirical understanding of avatar representation in mediating video-based collaborative interactions, implications and perceptions surrounding the adoption of AR avatars, and a comprehensive comparison of key characteristics between user representations.

1 INTRODUCTION

The increasingly ubiquitous adoption of remote environments, reliant on synchronous video-based platforms, has underscored the fundamentals of collaborative interactions within group settings. These interactions are crucial for effective communication, teamwork, and productivity. However, the inevitability of these platforms has introduced a growing challenge known as “Zoom anxiety” [13, 37]. This phenomenon is characterized by individuals feeling self-conscious and burdened by the camera during video-mediated interaction, ultimately affecting their self-esteem, participation, and experience when using these platforms. “Zoom anxiety” is often driven by the fear of being watched and can lead to users turning off their cameras to mitigate discomfort. Such withdrawals have been shown to further hinder the participants’ full engagement and effectiveness of the collaborative interactions by reducing self-focused attention and active participation [2, 5, 23, 49].

As technology continues to shape the way we engage, connect, and interact within digitally-mediated spaces, the role of avatars, which serve as user representations, has become increasingly relevant. Avatars offer a potential solution to the challenges posed by “Zoom anxiety” and can enhance the overall experience of video-mediated collaborative interactions. While employing an audio-only modality can reduce “Zoom anxiety,” that modality can also lead to the feeling of exclusion from the group [33]. Avatars can bridge this gap between audio and video representation by augmenting the physical self, thus enhancing presence while mitigating “Zoom anxiety” [34, 38, 50]. Some previous research has explored the use of VR avatars to alleviate the “Zoom anxiety,” with promising results, but these studies did not fully consider the unique challenges of online, video-based communication. Unlike VR or fully digitized avatars, which tend to obscure important live non-verbal cues, such as accurate hand gestures and subtle head and body movements, AR or screen-based avatars partially overlay one’s live-streaming representation without blocking the visibility of some physical cues [31].

Despite the growing body of research on user representations and avatars, there has not yet been an empirical study of video-based collaborative interactions among groups using AR avatars. Most prior work on avatar use is narrowly focused on avatars in VR environments and for discussion-based interactions with little to no tasks involved in the interactions. As videoconferencing increases the flexibility of goal-directed activities, studying the use of AR avatars in video-based collaborative interactions provides the opportunity to understand how AR avatar representation affects user perceptions and mediated communication, compared to traditional video representation. Therefore, we conducted a mixed-methods, quasi-experimental study with groups of participants to address the following research questions (RQ):

- **RQ1:** What is the impact of using avatars as a user representation on self-esteem and collaboration satisfaction in video-mediated collaborative interactions compared to using real-time video representations?
- **RQ2:** How does the use of avatars as a user representation influence the perceptions of self and others in video-mediated collaborative interactions?
- **RQ3:** How does the shared experience of using avatars as a user representation influence their perceived appropriateness and likelihood for use in video-mediated collaborative interactions?

2 BACKGROUND AND RELATED WORK

To situate our research study on the impact of avatar representation in video-mediated collaborative interactions, we provide an overview of related work in three key areas pertaining to the potential use of avatars beyond VR, research on avatar-mediated communication in videoconferencing, and AR avatar technologies.

2.1 Beyond VR: Potential Use of AR Avatars

The rise of avatar usage is primarily associated with the proliferation of VR use for gaming and social applications, typically accessible through head-mounted displays like HTC Vive and Meta’s Quest [1, 28]. However, despite the potential of VR, its limited adoption is attributed to various trade-offs, including additional headset and software costs as well as the potential simulator sickness following prolonged usage [42, 48]. Similarly, avatars accessible through AR headset devices, such as Magic Leap and Microsoft HoloLens, are considered virtual objects superimposed into the physical surroundings. Recent studies suggest that prolonged use of AR headsets may lead to simulator sickness and that further developments to make interactions with virtual objects in an AR environment more closely resemble natural interactions are deemed necessary to enhance usability [45, 46].

In contrast, screen-based or AR avatars, such as Apple’s Memoji and Microsoft Teams’ Mesh avatars, facilitated by smartphone or web camera-based applications, remain a crucial focus for research due to their widespread availability and ease of use [9, 27]. The majority of AR avatar scenarios in existing literature notably are geared toward immediate and context-specific objectives, such as participation in online social events and team-building activities.

The use of AR avatars offers several advantages in practical applications, as highlighted in prior research. For instance, Liu et al. [26] demonstrated that AR avatars delivered a more realistic representation of garment try-outs as compared to their VR counterparts. Another study revealed that users engaging with AR avatars experienced reduced mental workloads when interacting with immersive information, unlike those using headsets [22]. This suggests that AR avatars can offer a more comfortable and less cognitively demanding experience during immersive tasks. Furthermore, Zibrek et al. [55] explored the likeability of avatars in both VR and videoconferencing, considering different levels of

realism. They found that AR avatars, when designed with sufficient visual and behavioral fidelity, were just as appealing and engaging as their VR counterparts, indicating their effectiveness in eliciting positive user interactions.

While the majority of avatar research in HCI and CSCW is centered around VR, these studies are often confined to controlled laboratory settings, which may limit their real-world applicability [4, 12, 19]. Additionally, the limited accessibility of VR devices restricts these investigations to specialized applications, largely in training and skill development [7, 17, 52]. Conversely, the availability of AR avatars on smartphones and video platforms has not only broadened the scope of potential research but also enabled access to larger participant pools [35]. With the accessibility of AR avatars, potential research at the interaction of the role of AR avatars and group collaborative interactions [54] offers a more realistic representation of real-world applications and a more extensive exploration of human experiences beyond controlled environments.

2.2 Avatar-Mediated Communication in Videoconferencing

The exploration of diverse communication modalities has been a subject of interest ever since the emergence of VR technology. Nevertheless, there remains an ongoing need for further research into the foundational principles and practical implications, particularly as new technologies continue to develop and reshape mediated communication. In this context, Schroeder [44] examined the fundamental differences in how individuals are represented via video and avatars (Table 1). While these key characteristics contribute to key aspects of interpersonal interaction, collaboration, and enjoyment in digital space, the avatar representation modality only captures VR avatars. Since VR avatars are different from AR avatars used in this study, we propose an updated comparison of user representations in our discussion (see Section 5.4), including key characteristics of video, VR avatar, and AR avatar. Over the past decade, research focused on group interactions using avatars within VR environments has gained substantial attention. These investigations have included a wide range of domains, such as transferability, performance, presence and co-presence, and trust [30, 32, 43, 51].

In Bente et al. [8], they conducted a comparative study involving text-chat, audio, video conferencing, and avatars. Their findings highlighted distinctions between text-chat and real-time modalities, but not among audio, video, or avatars. Comparing three different modalities of user representations, including VR avatars, video, and audio, Junuzovic et al. [21]

examined realism, presence, and non-verbal cues in small-group settings, where participants engaged in collaborative work within groups of four for brainstorming activities. They found avatars provided higher sociability but lower realism, possibly because of the low level of avatar fidelity. Inkpen and Sedlins [20] explored avatar appearance in work settings, finding varying user feedback, with some avatars akin to webcam photos and not unsettling, particularly when appearing formal and realistic. It is essential to acknowledge that the landscape of video conferencing has drastically evolved since the COVID-19 pandemic, specifically in work-related contexts. Users' acceptance and preferences for rich forms of video communication have likely evolved over time, with increased exposure to new technologies for everyday communication [33].

Although no research has specifically explored group collaboration with AR avatars in videoconferencing, a few prior studies have explored the use of AR avatars for realism, presence, and self-affirmation for camera shyness. A recent large-scale survey study found that avatar realism significantly influenced acceptability for work-related videoconferencing among knowledge workers, with less realistic avatars being more acceptable for known colleagues but less so for managers and unknown colleagues [35]. Critical attributes included professionalism, credibility, and seriousness, while some participants highlighted the added benefit of cuteness, fun, and liveliness when using AR avatars at work. Panda et al. [33] designed a low-fidelity, non-customizable AR avatar used to represent audio-only participants and conducted a user interview on presence and co-presence in mixed-modality conferencing environments, which included audio, avatar, and video representations. Their findings revealed that participants preferred having an avatar representing themselves and others when there is a lack of visual representation (i.e., audio-only), affecting both perceived presence and co-presence. Another recent study investigated the use of an AR avatar in videoconferencing for self-affirmation when participating in a one-on-one debate, indicating a positive influence of the use of AR avatars on active participation in discussions when used in conjunction with self-affirmation but negatively impacted how they responded to critical messages from others [34].

Prior research on VR avatars in the context of group or collaborative settings has primarily focused on comparing different types of representations, such as videos, avatars, and audio. However, research exploring on-screen AR avatars is scarce, and all previous research on AR avatars lacks group-based interactions and activities. Within the context of video-mediated collaborative interactions, a significant gap exists in understanding the dynamics and experiences within goal-directed group activities. To the best of our knowledge, no prior study has taken the initiative to design and empirically investigate the complexities associated with the use of video-based AR avatars for collective activity achievement within a group setting.

2.3 AR Avatar Technologies

Avatars, which represent users in digital space, offer a broad spectrum of fidelity, ranging from abstract to highly detailed. Their applications extend to various contexts, such as live video calls and gaming. These avatars can either be automatically generated to resemble a user's appearance or manually personalized by a user, allowing for extensive customization of features such as facial characteristics, body type, clothing, and accessories to align with their preferences and identity [33]. The capability to animate avatars for emotional expression and connection among users is a prominent feature. This is frequently achieved by rigging a skeletal system, with control methods including computer vision, speech sentiment analysis, or audio input for viseme-based animations [15]. Even avatars with minimal animations, like subtle facial movements, contribute to users' identification and embodiment with them, which enhances the overall experience, engagement, and behavior [16].

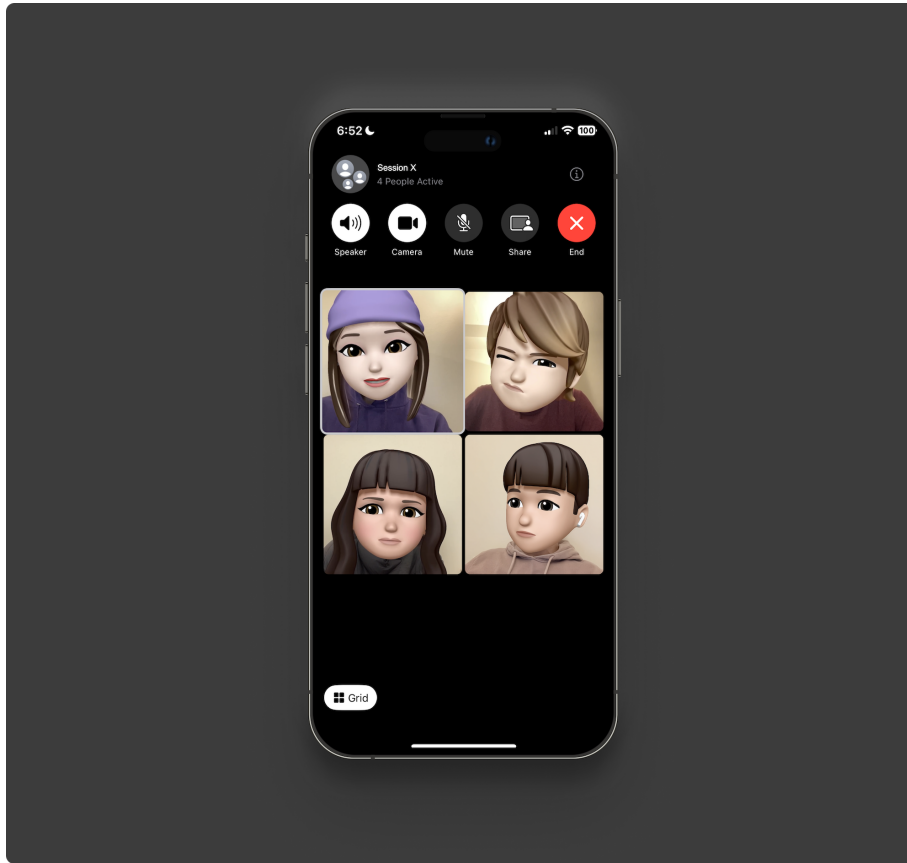


Fig. 1. Memoji avatars on FaceTime.

The role of avatars as powerful facilitators of user representation stands as a cornerstone of their effectiveness and experiences across a spectrum of applications. In this study, we used Memoji, a widely used AR animated humanoid avatar developed by Apple, which is known for its multi-functionality, allowing users to create static images or stickers that capture personalized expressions. Additionally, Memoji supports recorded motions that allow complete control over facial expressions and audio recording. Using an iOS device's camera, Memoji uses facial mapping and tracking technology for a real-time dynamic augmentation of three-dimensional graphics onto the user's head displayed on the iOS device screen (Figure 1). This process ensures high fidelity and performance, synchronously replicating facial expressions and movements, as demonstrated in live video communication through FaceTime [47].

3 METHODS

3.1 Study Design

In this study, we aimed to gain insights into the experience of video-based small-group interaction when considering the use of avatars as a user representation by answering the following questions:

- **RQ1:** What is the impact of using avatars as a user representation on self-esteem and collaboration satisfaction in video-mediated collaborative interactions compared to using real-time video representations?
- **RQ2:** How does the use of avatars as a user representation influence the perceptions of self and others in video-mediated collaborative interactions?
- **RQ3:** How does the shared experience of using avatars as a user representation influence their perceived appropriateness and likelihood for use in video-mediated collaborative interactions?

To address these questions, we adopted a mixed-methods approach to investigate the effects of avatar use in video-mediated collaborative interactions with goal-directed group activities. Employing a repeated-measures, quasi-experimental design, this study examined the independent variable of user representation conditions (avatar vs. traditional video) with the dependent variables including self-esteem, collaboration satisfaction, and group interview outcomes. In this context, avatar representation refers to the 3D digital embodiment that augments an individual's head using animated characters (i.e., Memoji) within a computer-mediated videoconferencing (i.e., FaceTime), whereas traditional video representation pertains to the direct streaming of real-time video, capturing participants' physical appearances during videoconferencing. The order in which the user representation conditions were presented was counterbalanced to mitigate potential order effects across participant groups.

3.2 Design of Game-Based Maps and Activities

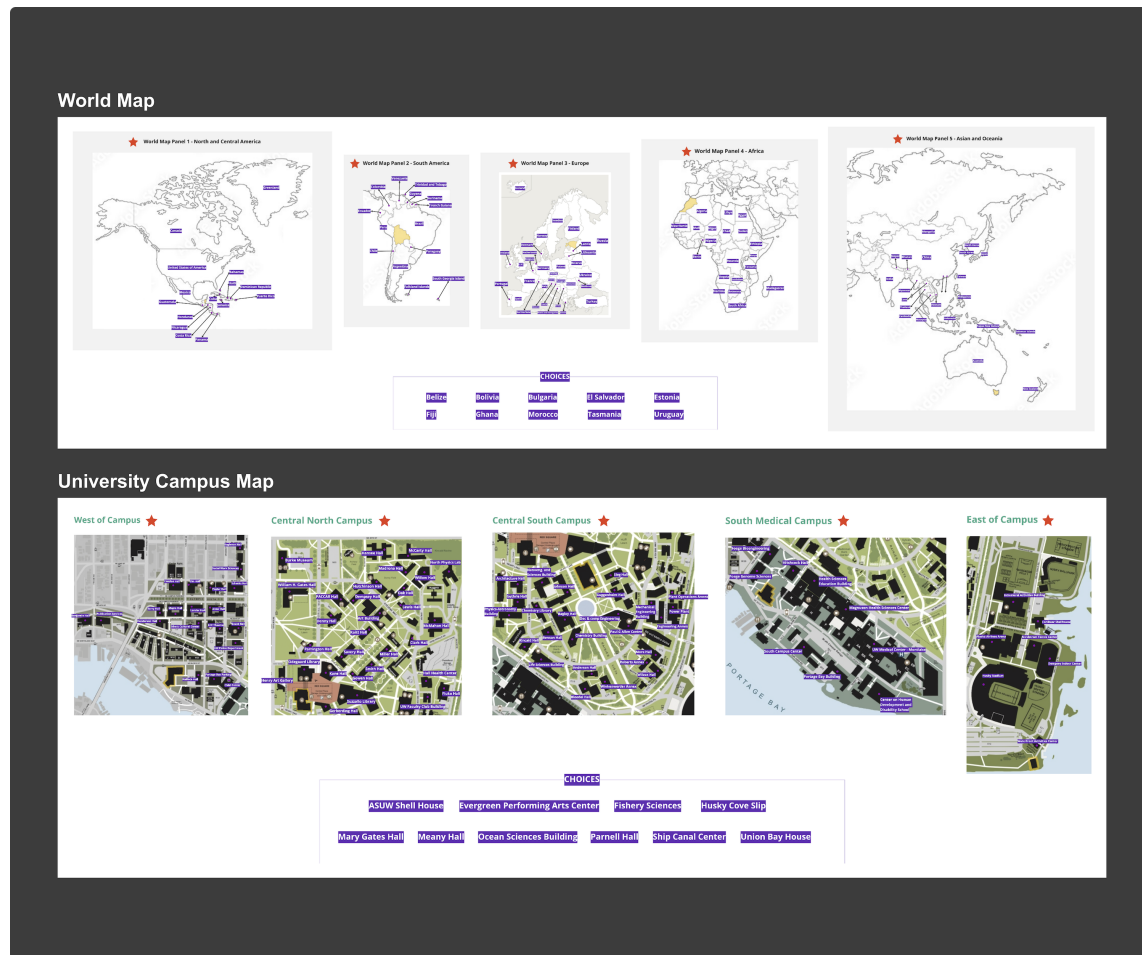


Fig. 2. Game-Based World Map and University Campus Map on Miro.

We thoroughly designed two game-based maps (Figure 2), including the world and university campus maps on Miro, a digital whiteboard for real-time remote group collaboration, to serve as the central element in structured puzzle-solving activities. These maps were instrumental in engaging participants in the collective identification of countries and campus buildings based on the activity prompts. This approach aimed to foster collaborative interactions and leverage the collective knowledge and engagement of the participants. The overarching intention behind this design was to simulate collaborative problem-solving scenarios in a synchronous digital environment.

We strategically integrated motivational aspects through gamification for interactive participation in our design, including a scoring with extra incentives and various game-based mechanics. Each participant group was informed that, besides their participant compensation, they had the opportunity to earn an extra \$15 per person if they achieved the highest score across all participant groups. These gamified strategies of the scoring system and the potential monetary reward for reaching a "winning" condition introduced competitive elements to the interaction and collaboration. Additionally, our game-based mechanics, including the time limit, text-based labels, multiple choices, and interactive actions for moving elements, further gamified the dynamic interactions, facilitating dynamic and engaging experiences.

The world map portrayed global geography divided into 5 panels, each representing a region along with its associated countries and names. In the first world map activity, participants were prompted to identify the second most populated country in each designated region by placing star icons on those countries. Subsequently, the second world map activity presented 5 missing country names across the panels, challenging participants to identify them by selecting from a pool of 10 choices, with 2 possible names for each panel. However, only 5 of these provided choices were correctly associated with the countries lacking names, adding an extra layer of complexity to the activity.

Similarly, the university campus map was divided into 5 panels, representing parts of the campus that mirrored recognizable buildings and landscapes. The first campus map activity asked participants to identify the building with the largest square footage in each panel by placing star icons accordingly. Following this, the second campus map activity introduced 5 missing building names across the panels. Participants were asked to identify these buildings from

a pool of 10 choices. In this case, while 5 of these provided choices correctly matched the buildings' missing names, the remaining 5 choices were fake building names.

3.3 Participants

Participants were recruited from a university through a combination of word-of-mouth and distribution of recruitment advertisements on social media platforms, including Slack and the university website. Due to the game-based map design of this study, we intentionally recruited groups of university students or recent graduates, ensuring some familiarity with the selected campus. Eligible participants signed up and participated in groups of four. We included participants who signed up as pre-formed groups of four, were already acquainted as friends or colleagues, and had individually created personalized Memoji on their mobile devices prior to the study session. During the recruitment, participants were informed that they would be engaging in collaborative activities with their pre-formed group members to solve

game-based activities. A total of 32 participants participated in this study, resulting in 8 participating groups with 4 participants per group. We present the self-reported demographics of each participant group in Table 2.

The virtual conferencing platforms for avatar self-presentation included FaceTime ($n = 16$), Google Meet ($n = 5$), Microsoft Teams ($n = 1$), Social VR (non-gaming) Platforms ($n = 6$), Zoom ($n = 7$). Participants also self-reflected their Memoji representation or design in three main categories: actual self ($n = 21$), ideal self ($n = 8$), and creative/expressive self ($n = 3$).

3.4 Procedure

Data collection sessions were conducted via video-based platforms using both Zoom and FaceTime. We controlled group dynamics by recruiting groups of four and restricting the relationship of each group’s members as prior real-life acquaintances, such as friends. After all group members had consented to participate, one participant per group assumed the role of “operator” who was able to manipulate elements on the game-based maps and received a brief tutorial on interacting with the Miro interface, which covered methods such as zooming, navigating the workspace, and moving on-screen elements. During each session, operators were provided access to Miro containing the game-based maps and shared their Miro screen on Zoom. The design of the game-based maps and activities ensured that these additional responsibilities did not hinder the collaborative process with others. Participants joined the FaceTime link using their personal mobile devices, keeping their laptop cameras off and audio muted as the screens featured Miro on Zoom. We pragmatically used FaceTime with Memoji alongside Zoom. This arrangement was necessary given the current absence of humanoid avatar technology available on other video-based platforms, such as Zoom, Microsoft Teams, and Google

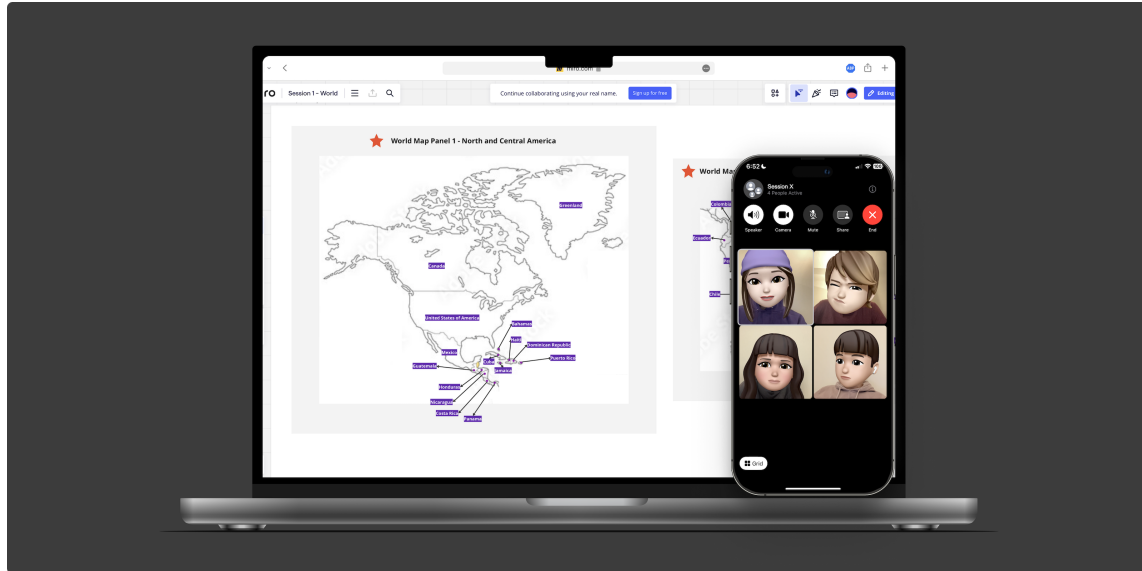


Fig. 3. Device Setup with Miro and FaceTime.

Meet. Participants were asked to work together to solve game-based activities on two different maps—the world map and the university campus map—on Zoom while communicating via FaceTime (Figure 3).

During FaceTime sessions, participating groups were presented with user representation conditions (avatar vs. video), counterbalanced across all groups. The on-screen layout is represented with a 2x2 grid with each squared-grid mirroring each user's real-time video, whether with or without a humanoid avatar representation. Both game-based maps consisted of two comparable activities each, resulting in a total of four activities (see Section 3.2). Before beginning each activity for each map, participants were explained and prompted on the activity, with a 5-minute time limit for each activity. Following the completion of each map, participants filled out a set of questionnaires, including the Rosenberg Self-Esteem Scale and the Collaboration Satisfaction. Demographic questions were included in the second set of questionnaires. Following this, participants engaged in group interviews to share their experiences and perceptions of the collaborative interaction experience during the study group activities: one map with avatar representation and the other with video representation. The interview portion was audio-transcribed for subsequent data analysis. After the group interviews, participants were debriefed and compensated for their participation and time. The average duration of study sessions was 60 minutes, and each participant received a \$15 gift card as compensation. The team with the highest score was awarded an additional \$15 gift card for each team member. This study was approved by the University's Institutional Review Board (IRB).

3.5 Measures

3.5.1 Self-Esteem. The Rosenberg Self-Esteem Scale [40] was used to measure participants' self-esteem and self-confidence, assessing both positive and negative feelings about self-image after engaging in each of the group activities. This scale is the most commonly used measurement of self-esteem and consists of 10 items measured on a 4-point Guttman-type rating scale, ranging from strongly agree to strongly disagree. The total possible score on the scale was

40, with higher scores indicating higher levels of self-esteem and self-confidence. Each item was adjusted by adding “during the recently completed group activity” to capture a more contextually relevant assessment of participants’ self-reflection within collaborative experiences of each group activity.

3.5.2 Video-Based Collaboration Satisfaction. The Collaboration Satisfaction instrument [39] measured collaboration satisfaction with the process and outcomes of group collaborative work. It comprises 8 items that rate two constructs on a 5-point scale: satisfaction with collaborative process (SP) and satisfaction with collaborative decision (SD). The SP construct includes 5 semantic differential items that represent satisfaction with group dynamics during collaborative interactions. Due to poor loading in factor analysis [18], the SD construct includes 3 Likert scale items—instead of the originally intended 5 items—representing satisfaction with collaborative outcomes. The total score is calculated as an average across all items, with higher average scores indicating a greater level of satisfaction with the group collaboration. SP items were adjusted by adding “during the recently completed group activity,” and SD items were modified by replacing “group’s solution” with “group’s decision.” These adjustments aimed to more accurately capture participants’ perceptions of both the process and decision/outcome within the group collaboration.

3.5.3 Group Interview. Group interviews were structured around a set of main questions designed to explore participants’ experiences and perceptions with avatar-mediated communication in group collaborative settings. The main questions included participants’ overall thoughts on team communication, ability to read others’ thoughts and feelings, sense of group cohesion, engagement and participation, as well as perceived appropriateness and influential factors to use or not use avatars. This set of questions was consistent across all groups, regardless of their background, with varied follow-up questions based on the discussion topics and available time during interviews.

3.6 Data Analysis

3.6.1 Quantitative Analysis. Paired-samples t-tests were conducted to examine the within-group differences in self-esteem and video-based collaboration satisfaction between the study conditions (avatar vs. traditional video) while collaboratively participating in group activities. Cohen’s d [11] was calculated to quantify the effect size of the observed mean difference. Correlations were calculated using Pearson correlation (r). Bonferroni corrections were applied to adjust for the family-wise error rate. These analyses were performed using the R statistical software (version 2023.09.0+463).

3.6.2 Qualitative Analysis. We conducted a combined approach of inductive summary annotation coding and deductive reflexive thematic analysis [10] to explore participants’ experiences and perceptions with avatars during collaborative interactions in videoconferencing. Aligning with qualitative analysis guidelines in CSCW and HCI practice [29], our analytical procedures focused on the generation of concepts and themes rather than seeking traditional qualitative coding agreement as uniform agreement on codes might lead to diverse interpretations of each code’s meaning. In addition, given that the first author solely conducted the group interview sessions, our analytical procedure intentionally did not pursue agreement and inter-rater reliability [29].

We followed specific procedures for thematic analysis, beginning with the first author reading through all eight group interview transcripts and dividing each transcript into multiple data segments corresponding to the questions and follow-up questions posed during each session. In the second phase, 20 student researchers (7 MS students; 13 BS students) independently coded the data using summary annotations. Each student researcher was randomly assigned two interview transcripts, resulting in 40 coding instances, with each of the eight transcripts coded five times. Instructions were given to the student researchers to carefully read each data segment and provide a written summary

and interpretation of the data as well as notable agreements and disagreements within the group. Subsequently, the third step involved the first author reviewing the summary annotations to gain an overall understanding and identifying recurrent topics. The fourth step involved the first author re-reading the eight original group interview transcripts, revising thematic topics, and developing sub-themes. Lastly, both authors iteratively examined and refined themes, along with our description and interpretation concerning the use of avatars in video-based collaborative interactions.

4 RESULTS

4.1 Self-Esteem

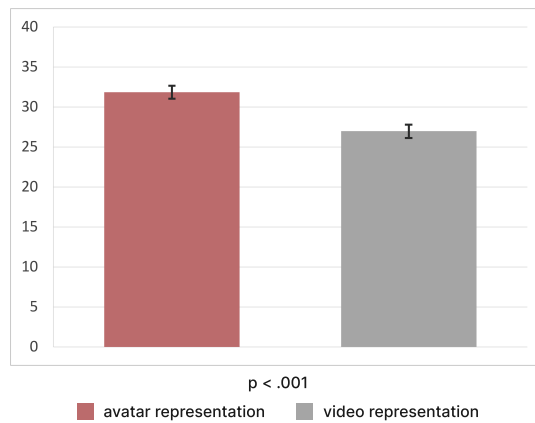


Fig. 4. Comparison of average self-esteem ratings. Error bars represent ± 1 standard error. Avatar representation demonstrates significantly higher self-esteem ratings compared to video representation, $p < .001$.

There was a statistically significant difference in self-esteem scores between the avatar representation ($M = 31.84$, $SD = 4.55$) and the traditional video representation condition ($M = 26.97$, $SD = 4.72$), $t(31) = 4.67$, $p < .001$; $d = 1.05$, indicating a large effect size (Figure 4). This finding implies that participants experienced significantly higher levels of self-esteem and self-confidence when represented with avatars compared to video representation during the video-based collaboration, potentially influencing their engagement and experiences in collaborative activities.

Although not significantly different, there is a noticeable trend among participants assigned the “operator” role, rating their self-esteem higher than other group members in both user representation conditions. In the avatar representation, operators rated their self-esteem ($M = 33.88$, $SD = 4.79$) higher than other group members ($M = 31.17$, $SD = 4.36$), mirroring the pattern seen in the traditional video representation condition (operators: $M = 29.50$, $SD = 4.31$; other group members: $M = 26.13$, $SD = 4.63$). This trend may require further exploration, with a possible explanation that operators may perceive their role as having more control and responsibility within the group, influencing their self-esteem.

4.2 Video-Based Collaboration Satisfaction

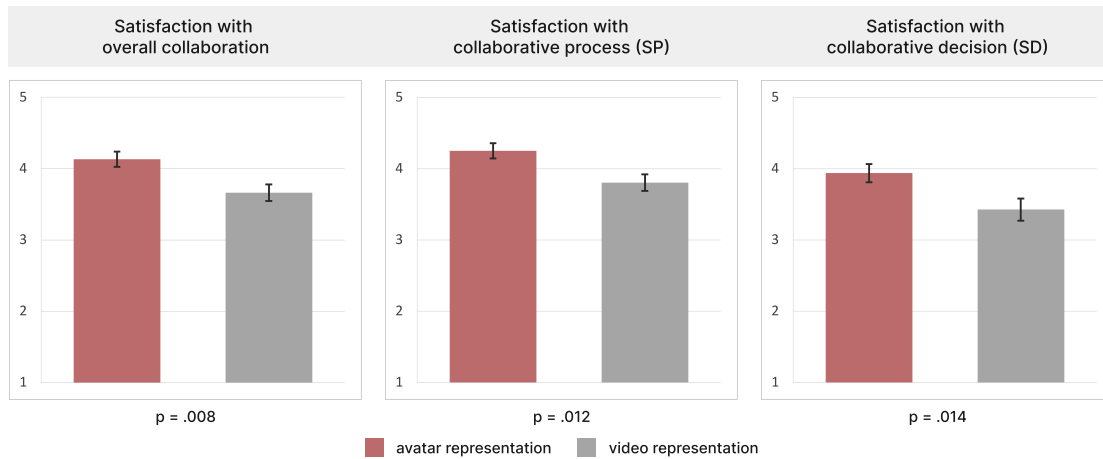


Fig. 5. Comparison of average video-based collaboration satisfaction ratings. Error bars represent ± 1 standard error. Compared to video representation, avatar representation demonstrates significantly higher ratings in satisfaction with overall collaboration ($p = .008$), with collaborative process ($p = .012$), and with collaborative decision ($p = .014$).

Significant differences in video-based collaboration satisfaction were found between user representation conditions. With the highest and lowest possible scores of 5 and 1, respectively, participants reported significantly higher overall collaboration satisfaction with avatar representation ($M = 4.13$, $SD = 0.61$) compared to video representation ($M = 3.66$, $SD = 0.66$), $t(31) = 2.81$, $p = .008$; $d = 0.74$ (Figure 5). This indicates a medium effect size and suggests that the choice of

user representation has a discernible impact on the overall satisfaction in video-based collaboration as incorporating avatar representations can significantly enhance overall collaboration satisfaction among group members.

Further analyses into specific aspects of video-based collaboration satisfaction revealed statistically significant differences between the user representation conditions (Figure 5). The satisfaction with collaborative process construct was significantly higher in the avatar representation ($M = 4.25$, $SD = 0.60$) compared to the traditional video representation condition ($M = 3.81$, $SD = 0.66$), $t(31) = 2.68$, $p = .012$; $d = 0.71$, indicating a medium effect size. This satisfaction with collaborative processes when using avatar representation suggests that avatars may positively influence the dynamics of the video-based collaborative process, which include perceived efficiency, coordination, fairness, understanding, and satisfaction. Similarly, the satisfaction with the collaborative decision construct demonstrated a significant difference between the avatar representation ($M = 3.94$, $SD = 0.73$) and video representation ($M = 3.43$, $SD = 0.88$) conditions, $t(31) = 2.61$, $p = .014$; $d = 0.63$, indicating a medium effect size. This suggests that avatar representation contributes to higher decision-making satisfaction during video-based collaborations, which could be related to the extent to which the group's final decision reflects their inputs, the extent to which they feel committed to the group decisions, and the extent to which they believe and trust that the group's decisions are correct.

4.3 Interrelationships between Self-Esteem and Video-Based Collaboration Satisfaction

Pearson correlation coefficients were used to assess the relationships between self-esteem, collaboration satisfaction, and decision-making processes in both avatar and video representation conditions. Particularly noteworthy were the strong positive correlations observed in the avatar representation between self-esteem and dimensions of video-based collaboration satisfaction: overall satisfaction, $r(30) = .72$, $p < .001$; process satisfaction, $r(30) = .72$, $p < .001$; and decision-making satisfaction, $r(30) = .62$, $p < .001$. These findings suggest that, in the context of avatar representation, higher levels of perceived self-esteem align with increased satisfaction in group collaboration, process, and decision-making activities. However, several other correlations either failed to reach statistical significance after Bonferroni correction

or exhibited weak correlations. The lack of correlations in the traditional video representation condition suggests that perceived levels of self-esteem may not necessarily be associated with video-based collaboration satisfaction.

4.4 Avatar Engagement in Video-Mediated Collaboration

Although the effects of avatars, detailed in Sections 4.1, 4.2, and 4.3, are essential to video-mediated participation and experience, participants reflected broader perceptions shaping their collaborative interactions with the use of avatar representation in Sections 4.4, 4.5, and 4.6. Drawn entirely from group interviews, we discuss observed themes on the ability of avatars to enhance self-confidence, engagement, and comfort while alleviating social awkwardness within video-based group settings.

4.4.1 Increased Self-Awareness and Confidence. An unexpected positive outcome was the heightened self-awareness and confidence reported by participants while using avatars. Many participants reflected on their elevated self-awareness, particularly regarding their facial expressions: *“Yeah, I think I paid more attention to my own expressions. Because I didn’t wanna come across like I was frowning. And I, it sort of forced me to. Maybe smile a little more. So just so it shows up”* (B4). This insight underscores the participant’s conscious effort to be more aware of their non-verbal communication and maintain a positive demeanor during a specific activity. In addition, F2 explained, *“it is kinda like I’m having a mask on, and so in a way I’m more confident with my own thoughts. Like the confidence to say it out loud.”* This metaphor suggests that their engagement in a particular activity or self-presentation enabled an increased sense of confidence in expressing their thoughts openly, which implies that this newfound confidence allowed them to reveal a more authentic self.

A few others discussed a shift from focusing primarily on the game-based activity to paying more attention to the actions and behaviors of other group members mediated by avatars. For instance, H4 noted, *“I wasn’t a hundred percent focused on the task like I would go back to seeing it and look at other people’s, but I feel like I paid more attention to what others are doing,”* serving as an example of an increased self-awareness regarding their group dynamics.

4.4.2 Enhanced Participation Engagement from Initial Self-Consciousness. Participants discussed the impact of their initial self-consciousness, primarily in response to avatars, on their own engagement during video-based group activities. Initially, participants expressed concerns about the avatar’s positioning and were preoccupied with their avatars. They actively experimented with the avatar’s ability to replicate their facial expressions due to their curiosity about its capabilities in real-time facial tracking on videoconferencing. For example, participant H3 conveyed their heightened self-awareness when using the avatar, noting that they paid closer attention to their body language and positioning, concerning the avatar being partially or completely out of the frame on their device screen:

“I was more conscious because I was leaning forward when I was looking at my screen. So I was like, oh, am I out of frame of my phone so the Memoji is not on my face at times. So it’s almost a reverse where I was conscious of the Memoji even being on my face in the first place.” (H3)

Some other participants shared similar sentiments that they found themselves gazing at their digital avatars and actively experimenting with the avatar’s ability to replicate their facial expressions. These observations underscored a collective curiosity about exploring the capabilities of the avatar and how they mirrored real-life expressions. Over time, this initial self-consciousness lessened, as participants *“worried about it less”* (E3 and E4), and evolved into a more casual and integrated aspect of their online interactions. With less time for self-monitoring and concerns, they had *“more time to talk and think through the activities”* (E2), allowing for more meaningful communication and collaboration.

4.4.3 Comfort in Augmented Physical Appearance. With the rise of video conferencing platforms, such as Zoom, our physical appearance in video-based interactions has become a central concern. For some, this shift has brought about a sense of unease and self-consciousness, connecting one's authentic self and the pressures of presenting in videoconferencing. Particularly when finding oneself in the spotlight or position of presenting to a larger audience, the act and need of turning on a camera can be an anxiety-inducing experience. To enable individuals to participate without the anxiety of being judged based on their physical attributes, a participant reflected on their past experiences and suggested avatars as a solution:

"When we turn on our camera [in] Zoom, we actually pay a lot of attention to our features, like how we look, especially when we are presenting. So, I think, [an avatar] will be very useful when one person does not really want to show their face in a large [video conference]." (G4)

C3 took this notion further, speculating that, "[an avatar] could be used ... if someone did not really feel confident with their appearance." This augmentation empowers individuals to present themselves in a manner that aligns with their self-image, thus mitigating the burden of self-doubt. Some participants, drawing on both past experiences and their participation in this study, pointed out how using avatars could mitigate self-consciousness when having a camera turned on during video-based group interactions. For instance:

"Sometimes, I get distracted when I'm doing work, like if my camera is on, I get conscious sometimes and I'm like, what is my face doing? So, I thought the avatar actually provided that mask kind of where the animation is not gonna look bad no matter what angle you're in." (H1)

Being aware that someone might be watching you on the screen can easily cause distraction. The use of avatars provides individuals with a sense of agency over how they are perceived and, in doing so, fosters a sense of comfort and self-confidence in videoconferencing.

4.4.4 Reduced Social Tension and Awkwardness. Within the context of group video-based collaboration, the adoption of avatars was viewed as a noteworthy strategy for mitigating social tension and alleviating any awkwardness. Participants stated that these avatars had the ability to "*create a relaxed atmosphere*" (C2, F4) during interactions, suggesting their utility in enhancing group dynamics and reducing the anxiety often associated with such collaboration.

These avatars were viewed as instrumental in steering conversations towards more engaging and diverse topics, which foster connections and conversations beyond the usual work-related topics. Recurring team avatars were speculated to serve as potential "*ice breakers, particularly in situations where participants were less familiar with each other*" (H2), essentially "*stimulating creativity and fostering camaraderie within the group*" (C1). The influence of avatars extended beyond being mere "ice breaker," as several participants reflected on their experience in this study that avatars transformed the collaboration experience, making it "feel less like work and more like to a group bonding session" (A1).

Participants, for the most part, did not perceive avatars as an essential component throughout the activities but rather as "*a valuable tool during specific segments*" (G3). They speculated that integrating avatars in the initial minutes of collaborative activities could set a positive tone, invoking laughter and elevating the overall atmosphere. Avatars were viewed as potentially effective in interactions designed for team-building and fostering group cohesion, such as "*fun Fridays*" (D3) or "*themed meetings*" (D2).

Furthermore, these avatars were regarded as "*a means of stress reduction*" (A2). The inherent charm of these cute and whimsical representations effectively alleviated tension and anxiety. Participants found that even when their

avatars displayed serious expressions, the playful and lighthearted nature of these virtual figures mitigated any self-consciousness (A3). This amalgamation of visual charm and the opportunity for individual expression was influential in creating an environment where social tension and awkwardness receded into the background, facilitating a more uninhibited and enjoyable collaboration experience.

4.5 Challenges in Avatar-Mediated Emotional and Authentic Expression

Despite the benefits that avatars may offer, participants acknowledged the challenges associated with using avatars in video-mediated communication. In this section, we discuss the critical aspects of avatar representation in both expressing and perceiving emotions to maintain effective collaborative interactions as well as in perceived authenticity for self-expression.

4.5.1 Fidelity of Emotion Expression through Avatars. Avatars have emerged as important tools for conveying human emotions and expressions within virtual communication. A particularly noteworthy challenge surfaced in participants' attempts to accurately express emotions through avatars, contributing to occasional distractions. The limitations in conveying nuanced emotional states underscore the current technological constraints in achieving seamless emotional expression. The emotive realism that avatars bring to mediated interactions is not accurate to that level of emotional communication as H3 astutely notes how avatars can induce a natural smile, even when one's facial expression is relaxed:

"[Avatars] bring more attention to like certain expressions that you'd be making. Like, it gives just a natural smile on your face when your face is just resting. [It] kind of accentuates that. I mean it's literally an animation so it's very animated with whatever you do with your face so seeing now and other people as well as yourself is interesting." (H3)

In contrast, while tone and expressions are fundamental for understanding emotional states, some participants raised a pertinent concern that avatars primarily and correctly illustrate head movements and mouth expressions but often neglect the expressive power of the eyes. This observation raises substantial questions about the efficacy of avatars as reliable tools for accurately portraying users' emotional states in addition to typical facial movements, such as winking. For instance, G1 mentioned:

"Sometimes it's very hard to gauge only from their tone. But you know, sometimes expressions give it away and I think you always pick up on these social cues and that's when you're like, okay, it doesn't seem like this person is, you know, 100% onboard on this idea, but I think avatars don't usually convey too much of an expression, except for the head movements and mouth. Like we also express emotions with other parts and it doesn't capture too much of, you know, the eyes and stuff." (G1)

On a similar note, avatars sometimes incorrectly displayed facial expressions, for example, displaying a frown when, in reality, they were feeling at ease. This experience raises the dilemma faced by individuals when navigating the delicate balance between authentic emotions and the need to maintain a composed professional appearance, particularly in work-related contexts:

"Yeah, I was gonna say the same thing because I noticed that it doesn't always translate your expressions well. So sometimes, I saw my avatar frowning when in fact I was, I just had a natural resting feel going on. So I had to put up a smile so it translates onto the screen. So, I think during work, that won't be acceptable, and it's just better to have your normal face on." (B4)

There are mixed viewpoints on the fidelity of emotion expression through avatars. While avatars hold the potential to enhance emotional expression and facilitate communication, they also bear limitations in faithfully capturing the intricacies of human emotion.

4.5.2 Difficulty in Interpreting Avatar-Mediated Thoughts and Emotions. The immersive experience of avatars posed challenges in accurately deciphering the thoughts and emotions of others during group communication. Participants expressed a need for more cues in avatars to enhance the interpretability of non-verbal communication. Interestingly, E3 found that, if you realize the limitation through trial and error with your own avatars, reading emotions through avatars was “*quite similar to reading faces. Not exactly at that level but it did not require extra cognitive effort.*” While a few participants were surprised by how “*big Memoji heads were*” (A3), and that “*having big heads would make it easier to see who’s at least listening from nodding and what not*” (A4), other participants shared contrasting viewpoints in the movement of head or nodding. Many participants started relying more on audio in both delivering and receiving messages due to the limitation of expressing subtle non-verbal cues when using avatars, as G2 mentioned, “*the only difference would be the subtle nods that people make when they’re talking, which we couldn’t see through the Memoji avatars. It was hard. You had to even say that you were still thinking, even if it was as simple as saying yes.*” Moreover, participants mentioned the importance of accurately perceiving the emotions of others in collaborative activities, for example:

“I think, especially when you have the Memoji on, it is hard to kind of gauge the person’s true feelings about any particular thing. And because it’s very subtle, I think the changes in expressions, especially if you are looking on another screen, it’s barely noticeable if [you are] not paying close attention. So, especially in a collaborative activity, I think it is important to know everyone’s true thoughts about a certain thing because I think that can help you arrive at a more accurate decision.” (G1)

In this case, avatars were seen as obscuring genuine emotions under the augmented 3D digital information. F2 also faced challenges in interpreting emotions through the avatars, saying, “*I feel like it’s harder to see their expressions. So sometimes I’m not really sure if they’re thinking or if the Memoji is simply not reacting.*” Similarly, D4 expressed her difficulty in discerning people’s emotions through avatars, “*I just sense that the pre-scripted remote responses often transform a small smile into the cheesiest grin you’ve ever seen. I don’t know, it all feels somewhat off, and I couldn’t read people as well.*” Being able to decode the subtleties of facial expressions in group settings is a core to collaborative interactions because “*we express our agreements, disagreements, and hunches with our faces*” (F4). It is more challenging to connect and comprehend what others are thinking without being able to see their actual faces. Likewise, F1 echoed the significance of visual cues and facial expressions, particularly in time-sensitive activities:

“It was harder to tell how other people were feeling, I guess. Like, I couldn’t really connect as well with my teammates. I think being able to see people’s faces is really important, especially if you are working on something that’s timed. And you kind of need all the information there in front of you, including visual cues.” (F1)

Even though these avatars may accentuate expressions, they often fall short in conveying subtle emotional cues. This deficiency can make it difficult to accurately gauge the thoughts and emotions of others, subsequently impacting the quality of communication, connection, and mutual understanding among group members.

4.5.3 Avatar Presence and Authentic Self-Expression. Avatar fidelity becomes a pivotal factor in creating a truly authentic emotional expression. Participants recognized an inherent difficulty in ensuring that avatars authentically mirrored

their emotions and identities, introducing a tension in video-based collaborative interactions. D1 pointed out that *“it is weird when the Memoji [avatars] don’t really look exactly like the person ... it just doesn’t feel as authentic as just talking face to face. It almost feels like they’re not really there [but] more like their voice coming out of an avatar.”* When technology tries to replicate human identity, even slight deviations from authenticity can disrupt the sense of genuine presence. This sentiment reveals an underlying uneasiness, a feeling that the other person on the screen is not truly present. E4 mentioned a unique aspect of the desire for authentic human presence in which it is not always about replicating one’s appearance, faithfully. Instead, E4 suggested that sometimes, embracing a whimsical and unconventional avatar absurdly fosters a more authentic sense of self-expression:

“From my past experience with avatars, I’m more likely to use the animal-like ones because I feel like they really emphasize the overall goofiness of me. I feel like using the one that looks exactly like me feels a little off because like I’m right here. But if I could look like a giraffe, that’s kind of fun.” (E4)

This suggests that embodying an avatar that looks different than your actual self might allow individuals to drop their guards and reveal their genuine selves. Authenticity does not always stem from literal representations; at times, it emerges from the freedom to be unfiltered. For authenticity in our mediated interactions, technology should complement, not supplant, our ability to create profound and meaningful connections.

4.6 Influential Factors for Avatar Adoption and Usage

In our investigation of the influential factors in the likelihood to use avatars within video-based collaborative contexts, we discovered several key insights that provide a nuanced understanding of the adoption and usage of avatars. Participants were specifically asked whether they would be likely to use an avatar while video conferencing if others were also using avatars, if the avatar could be easily customized before joining a video conference, and if the avatar represented facial expressions with greater accuracy, respectively.

4.6.1 Social Influence. Social influence emerged as a pivotal determinant, with unanimous agreement from all 32 participants (100%) that they would be more likely to use an avatar in a video-based collaboration if others were also using them. The consensus highlighted the significance of social dynamics and peer influence in shaping an individual’s inclination to use avatars during collaborative endeavors. This unanimous agreement highlights the powerful impact of social dynamics on individuals’ choices, emphasizing the collective nature of technology adoption within collaborative settings.

4.6.2 Customization Ability. With 31 out of 32 participants (97%) expressing agreement that they would be more likely to use an avatar if they could easily customize it before joining a video conference, the ability to personalize and tailor avatars to align with individual preferences and identities was strongly valued. The degree of personalization provided a sense of agency and ownership over one’s virtual representation, which, in turn, influenced the likelihood of adopting avatars in collaborative settings. One participant, however, thought otherwise and mentioned, *“I disagree just because I would prefer to actually just not use an avatar at all”* (H3). Despite the general preference for avatar customization, individual preferences and views towards the use of technology could vary significantly, emphasizing the diverse perspectives regarding the adoption of avatars in video-based collaboration settings.

4.6.3 Accuracy in Emotion Expression. Across all participant groups, 28 out of 32 participants (88%) agreed that they would be more likely to use an avatar if it accurately represented their facial expressions, acknowledging the critical role of accuracy in emotion expression as a determinant for avatar usage. The ability of avatars to accurately and

authentically mirror emotions at micro level was considered instrumental in conveying the subtleties of non-verbal communication. This factor played a significant role in shaping users' perceptions of the efficacy of avatars in fostering genuine human connections in virtual spaces. As participant B3 aptly put it, *"I mean like if it could pick up the exact level of expression, that would be ideal."* This sentiment highlights the participants' desire for avatars that excel in portraying emotions with the utmost precision.

However, one group ($n = 4$) held a dissenting opinion and argued that pure faces, unaltered by technology, were supposedly more accurate in conveying the intended emotion expression. For instance, H1 expressed a preference for using traditional video representation instead of an avatar with greater emotion expression accuracy, *"I disagree. Yeah, if I am intending on having a real conversation, I would probably just want my face"* (H1). This group believed that technology reduces the authenticity of emotional expression and that human interaction in its natural form was the superior medium for accurate emotional conveyance.

4.6.4 Contextual Appropriateness of Avatar Use. Participants imagined possible scenarios to speculate about the appropriateness of using avatars in a video-mediated environment, considering their suitability in different contexts. It was evident that the acceptability of avatars depended on the nature of the interaction. Participants acknowledged that avatars were more aligned with casual or informal settings, but the extent to which they were deemed suitable in professional contexts varied.

In organizations that embrace tradition and formality, avatars may be perceived as less suitable. Some participants questioned the appropriateness of avatar use in such environments because it might appear *"silly to discuss serious topics, such as financial or healthcare matters"* (A3). In addition, avatars are deemed as better suited for light-hearted interactions or as a means to infuse fun into conversations within a familiar context. Participants noted that avatars are *"perfect for a good night out with friends in FaceTime events"* (F2) and that they would use avatars with those whom they feel comfortable, such as *"sisters, mom, and dad, as they feel more casual than formal"* (F4).

Some participants aptly highlighted the pivotal role of organizational norms and practices on the acceptability of avatars in video-based collaborations. For example, A2 suggested that *"if the team is more traditional or formal, using avatars might not be appropriate. But using avatars in the team that values creativity and innovation could be fun and engaging"*. Moreover, participants noted that the use of avatars in more formal work-related situations is viewed with skepticism, as the presence of avatars can make it challenging to convey and interpret serious or critical information. For example, B2 imagined interacting with a manager who uses an avatar representation while assigning work and providing instructions:

"[The avatar might be] shouting at you, but [with] a very green hair mohawk-style Memoji, [which] would obviously be funny. I wouldn't be able to take their critique. No matter how much [the avatar] replicates their real expressions, [like] anger, frowning, and everything, I would still think it's adorable."
(B2)

The appropriateness of using avatars in video-mediated environments is contingent on factors such as the nature of the interaction. While there was consensus that avatars are well-suited for casual or informal settings, the tension between the perceived unseriousness and the potential for enhancing engagement and creativity contribute to the evolving nature of video-based communication norms, where context plays a key role in shaping the acceptance of avatars in collaborative interactions.

5 DISCUSSION

Our findings highlight the impact of avatar representation on self-esteem and collaboration satisfaction, as compared to traditional video representation, as well as the benefits, challenges, and influential factors to consider when using avatars as user representations. Therefore, we discuss the implications for avatar adoption and the evolving role of avatars in mediating the video-based collaborative interaction experience. In addition, we propose an updated user representation comparison with key characteristics.

5.1 Avatar Enhancing Video-Based Collaborative Interaction Experiences

Characterized by large effect sizes, our findings emphasize the notable positive impact of avatars on self-esteem and collaboration satisfaction during video-based collaborative interactions. The elevated self-esteem among participants in the avatar condition suggests that the choice of user representation has a profound impact on self-perception, influencing participant engagement and experiences in collaborative activities. In addition, the avatar representation positively affects the satisfaction experienced by participants of both the collaborative process and decision-making, contributing to multiple aspects of satisfaction such as increased collaboration efficiency, coordination, fairness, understanding, contentment with final group decisions, greater commitment to those decisions, and higher levels of trust in their correctness.

The distinction in the mechanisms driving higher self-esteem and increased collaboration satisfaction suggests that these two outcomes may be influenced by different factors, providing an explanation for their lack of correlation as demonstrated in Section 4.3. Drawing on prior research, the elevated self-esteem might be attributed to the overall cute-looking visual of the avatars, aligning with the Proteus effect’s proposition that physical characteristics and anticipated behaviors can influence the behavior and cognition of individuals [25, 36, 53]. In contrast, the enhanced collaboration satisfaction could be associated with a degree of visual consistency among avatars across participants, creating a higher sense of group or shared identity. This aligns with the social identity theory [3], which posits that similarity in representations contributes to the formation of a shared social identity and a sense of belonging within a collaborative setting.

While the Proteus effect [53] was not the primary focus of our study, it provides additional insights into the underlying rationale behind our qualitative findings. Participants initially showed a positive inclination towards using avatars, likely influenced by their agreement to participate in the study. However, they reported favorable collaborative experiences with avatars and expressed openness to using them in the future during the post-study group interview. This positive reaction may be related to the alignment of participants’ facial expressions with the perceived friendly and cute attributes of their avatars, adhering to societal expectations.

5.2 Avatars as a Middle Ground Between Camera On and Off

The decision of whether to activate or deactivate one’s camera in videoconferencing has become a pivotal aspect of video-based interactions. Balancing between the need for privacy and the necessity of being “presentable,” offering visual cues, remains a considerable challenge. Some recent research on Zoom fatigue [6, 38, 50] proposed avatars as a replacement for the camera-off modality. This suggestion is supported by previous work comparing different user representation modalities [20, 21, 33]. Although the context in which an avatar is employed remains one of the major considerations, the use of avatars can ultimately enhance the quality of video-based communication when compared to

audio-only modality. Some participants spoke up about the concept of avatars as a middle ground between the binary choices of having the camera either on or off, presenting a balanced and effective method of social connection:

“It was more like, you know that they’re present, you know that they’re there, but you can’t really make out like everything because their faces are animated, obviously. So I thought that was kind of nice for times when you don’t really want to have your camera on but you [would] just like to have a conversation.” (H1)

While avatars may not fully replicate the nuanced spectrum of human expressions, they provide a degree of visual interaction that would otherwise be absent, with the animated facial features and expressions of avatars maintaining a visual link and signifying the presence of the conversation partner without necessitating full camera engagement.

“So, I know a lot of times, especially since what you’re working virtually and remotely has become a thing, a lot of people tend to keep their cameras off. So I think [avatars] could be a good alternative. Rather than having no access to somebody’s facial expressions, I guess this could kind of bring in that element to some extent at least.” (C1)

While a blank screen offers a degree of anonymity, avatars provide a more engaging and personalized representation, potentially leading to elevated self-esteem and increased satisfaction. However, it is imperative to conduct a thoughtful assessment of the suitability of avatars within their specific contexts, taking into account factors such as company norms, the nature of the work, and individual preferences. The acknowledgment of avatars as a middle ground speaks to the evolving nature of video-based collaboration preferences and the importance of flexibility and customization in communication tools. Avatars serve as dynamic elements that facilitate individual agency in shaping the virtual collaborative experience by bridging the divide between an active camera and a deactivated camera screen.

5.3 Self-Prioritization in Collaborative Interactions

The observation of self-prioritization within collaborative interactions using avatars departs significantly from prior research. Existing studies [14, 38, 50] suggested that avatars, as representations of individuals within digital environments that mediate the real-world physical appearance and actions, diverted attention from the self. This redirection of focus was perceived to promote shared attention and group engagement while reducing self-consciousness. However, our study incorporated avatars capable of accurately tracking facial expressions without obscuring the physical surroundings, revealing a discernible paradigm shift. Participants emphasized concerns regarding the presentation of their own representation (i.e., avatar) rather than that of others, indicating an unconscious shift toward self-prioritization, even within a group setting with shared, goal-directed activities.

Notably, this phenomenon occurred within the context of collaborative interactions among small groups of individuals with pre-established relationships (i.e., friends or colleagues), contrary to the anticipated collective focus facilitated by pre-existing social connections and familiarity [41]. Interview findings in Liu et al. [24] indicate that emotional feedback facilitated through a mediator, namely an avatar in this study, contributed to a heightened self-awareness of one’s emotions, particularly with regard to inadvertent concerns about negative emotion leakage. This provides a plausible explanation for the observed apprehension of own facial expressions in this study. Additionally, in line with the Proteus effect [53], employing avatars, unfortunately, places a potential burden on users to express positive or “happy” emotions aligned with the avatar’s cute-looking design, thereby introducing a coercion process where user agency is cajoled by the mediator. The design and implementation strategy of avatars in various collaborative settings

should take into consideration the mindful balance between specific mechanisms and triggers behind self-prioritization in avatar-mediated interactions and the need to maintain collective engagement and group cohesion.

5.4 Toward a Comparison of User Representations

Originally introduced by Schroeder [44], the key characteristics compare and contrast the mediated interactions of video and avatar (i.e., VR avatar). However, AR avatar is another modality that has been widely adopted due to its accessibility via mobile and screen-based devices [35]. The avatar technology used in our study is representative of a new modality in real-time, video-based environments. Drawing from our experience observing, interacting with, and researching AR avatars in video-mediated interactions, we propose an updated comparison of user representations (Table 3).

We envision that this comparison could be valuable to researchers, video conferencing platform developers, and avatar designers. The current literature primarily targets VR avatars [4, 7, 12, 17, 19, 52] and often use and generalize the term “avatars” when mentioning VR avatars alone, thereby blurring the distinctions between the VR and AR avatar representations. This proposed comparison serves as a taxonomy to systematically understand the different characteristics in user representations. Furthermore, this comparison could guide the future design and development of AR avatars, complementing the ongoing efforts in system development of VR avatars. This, in turn, has the potential to stimulate an increase in empirical research on AR avatars in various contexts, such as video-mediated interactions, activity-directed scenarios, and collaborative settings.

6 LIMITATIONS AND FUTURE RESEARCH

Although our work presents new opportunities for exploring the impact of avatar representation on video-mediated collaborative interactions, it is important to address current limitations and outline potential future research directions. First, our design of game-based maps and activities relied heavily on collective knowledge and familiarity with the maps, which limited our participant demographics to the associated university students. To broaden the scope, future studies could include other types of collaborative activities that cater to a more diverse participant base. Furthermore, we examined only two user representations (i.e., avatars and video). Future research should consider involving multiple modalities, for instance, avatar, video, audio, and even mixed-modalities that combine these representations. Given the technology constraints, our study required two separate screens per participant, potentially leading participants to focus less on one of the screens or increasing mental workload. Future research could invest in the development of integrated avatar features for video-based platforms, such as Zoom, to eliminate the need for additional screens and open up the possibility to assess performance. The design of avatars, too, plays a significant role in shaping participants' perceptions. It is imperative for future research to not only recognize the impact of distinct avatar design choices but also to remain attentive to potential exclusions inherent in avatar development tools.

7 CONCLUSION

This study explores an untapped research area of how the use of screen-based or AR avatars as a user representation affects collaborative interactions in synchronous video-based environments when tasked with goal-oriented, group activities. Our experimental findings indicate that the avatar representation significantly enhances self-esteem and video-based collaborative interaction experience, compared to the traditional video representation. In addition, we identify benefits (e.g., increased self-confidence, participation engagement, comfort of physical self, and decreased social tension and awkwardness), challenges (e.g., authenticity in expressing and perceiving emotions), and key factors for avatar use within video-based collaboration contexts. This work provides empirical insights into how avatar representation mediates collaborative interactions in video-based settings as well as implications and discussions concerning the potential future use of avatars, offering a comprehensive comparison of essential features among user representations.
