P hase structure of self-gravitating system s

Abstract

The equilibrium properties of classical self-gravitating systems in the grand canonical ensemble are studied by using the correspondence with an euclidean eld theory with infrared and ultraviolet cuto s. It is shown that the system develops a rst order phase transition between a low and a high density regime. In addition, due to the long range of the gravitational potential, the system is close to criticality within each phase, with the exponents of mean eld theory. The coexistence of a sharp rst order transition and critical behavior can explain both the presence of voids in large regions of the universe as well as the self-sim ilar density correlations in terms of self-gravity alone.

1 Introduction

O ne of the outstanding problem s of m odern cosm ology is the understanding of structure form ation in the universe [1]. V isible m atter at astronom ical scales appears organized in a hierarchy of galaxies, cluster and supercluster of galaxies, which tend to be found in

lam entary aggregates or two-dim ensional sheets that encom pass large regions with much low er density of matter and structures. These regions, called voids, occupy a large fraction of the observed universe, and are also organized in a hierarchy [2, 3]. The theoretical investigation of void form ation is receiving increasingly attention [4].

There is general agreement that the galaxy two point correlation function is scale invariant (self-similar), at least at not too large scales, decaying as a power of the distance, 1=r. The exponent as well as the scale of hom ogeneity is still controversial. Pietronero and cow orkers found 1 and claim that the power law is obeyed up to the deepest distances [5]. O ther authors gave a di errent exponent (1:8) and support the existence of an observed scale of hom ogeneity [6, 7, 8]. Self-similar behaviour has also been found in the interstellar medium [9, 10, 11, 12].

A though certainly the dynam ics must be very important in order to explain these facts, and many physical e ects might play a prominent role, it is well possible that many aspects of the observed structures may be understood in terms of the equilibrium states of self-gravitating matter alone, as claim ed by the authors of Refs. [13, 14]. Indeed, it has been tried to apply them odynam ics to astrophysical systems since a long time (see for instance Ref. [15]). In this paper, we will analyze the general phase structure of a non-relativistic self-gravitating system at them al equilibrium. The results are general and can be applied to any such system that can be considered to be in these conditions. We will not be concerned here with the very interesting questions of whether them al equilibrium can be reached in such systems, or the way it is attained. We just assume that the self-gravitating system is at them al equilibrium.

Let us consider a system of N classical particles of mass m con ned in a region of volum eV and interacting each other via the New tonian gravitational potential. Its ham iltonian reads

The therm odynam ics of such a system is ill de ned: the entropy does not exist due to the singularity of the potential at short distances [19, 20]. Furtherm ore, even if one m odi es the potential to rem ove the short distance singularity, the usual therm odynam ical lim it does not exist, since the therm odynam ic potentials are not extensive, due to the long range gravitational force. In such cases, the m icrocanonical speci c heat can become negative and di erent statistical ensembles are not equivalent (see R efs. [21, 22, 23, 24, 25, 26, 27, 28, 29, 30]). In particular, the grand canonical ensemble is dom inated by com pletely collapsed con gurations, whatever the chem ical potential. To use the ordinary therm odynam ical tools, the potential m ust also be m odi ed at long distances¹.

¹ It has been proposed that a kind of therm odynam ical lim it for system s with potentials decaying as 1=r could be taken by considering the so called dilute regim e [31], but it can be shown that this statem ent cannot hold [32].

The them odynamics of self-gravitating system has been studied since a long time by conning a nite system on a nite box and using mean eld theory. The approach developed in this paper is di erent: we will describe the therm odynam ical properties of a self-gravitating system as the limiting case of a family of well behaved, short range system s, the interactions of which decay with distance more and more slow ly, thus resembling more and more the new tonian 1=r potential. For these systems the usual therm odynam ical limit, which is considered in this paper, does exist. To carry out this investigation, we will take advantage of the fact that the statistics of a self-gravitating ensemble of particles can be related to an euclidean eld theory of a single scalar eld [13, 14], in a similar way to the relation between the C oulomb gas and the Sine-G ordon eld theory [16, 17, 18]. Hence, the remaining of the paper will rely on the techniques of euclidean eld theory.

2 Field theoretical description of a self-gravitating system

The statistical mechanics of a self-gravitating system can be studied in the usual way if the gravitational potential is regularized at short and long distances. Let us choose as a regularized gravitational potential, denoted by U_R (r), an attractive Y ukaw a potential, with range 1=m₀, endowed with a hard core of size r_0 at short distances: U_R (r) = $Gm^2e^{m_0r}=r$ for $r > r_0$ and U_R (r) = 1 for $r < r_0$. After integrating out the momenta, the grand canonical partition function for chemical potential and tem perature T can be written as

where $= 1 = k_B T$, a is a constant with units of length, to be specified below, and

The partition function Z_N can be approximated by dividing the space volume in = $V=a^3$ cells of size a (the unit length introduced above), and replacing the integrals by appropriate R iem ann sum s, which can be reorganized as a sum over cell occupation numbers S_i , with the index i running from 1 to the number of cells, . If a is of the order of the hard core size, each cell can be either void or occupied by one particle: $S_i = 0;1$. This is sim ilar to consider self-gravitating ferm ions [29]. We get

where $b^2 = 4$ Gm², U_L (n n⁰) is a proper lattice version of U_R (r r⁰)=(4 Gm²), the factor 1=N ! has been canceled due to the distinguishability of classical particles, and the K ronecker delta takes into account that the num ber of particles is xed [33].

Since the Yukawa potential is the Green function of $r^2 + m_0^2$, we can choose its lattice version as the lattice Green function of $r_L^2 + m_0^2$, where r_L^2 is a discretization of the laplacian:

U sing (5) and the Hubbard-Stratonovich form ula, we can write the following identity:

where C is a number independent of S_n . Plugging Eq. (6) in (4) and the resulting equation for Z_N in the expression for Z_{gc} , and performing the summation over S_i , we can write the grand canonical partition function of the (regularized) self-gravitating system in terms of a local euclidean eld theory with a single scalar eld n:

the action of which is given by

where $g = e e^{\frac{b^2}{2}U_L(0)} (\frac{m a^2}{2 h^2})^{3=2}$ and $D = r_L^2 + m_0^2$. Notice the unusual form of the action: the interaction term, $\ln(1 + ge^b)$, is unbounded from below. It behaves as b for ! 1. The action, how ever, is bounded from below if $m_0^2 > 0$. This rejects the fact that the grand canonical ensemble does not exist for non-extensive (long range and/or purely attractive) systems. The infrared and ultraviolet cuto s, m_0 and a respectively, make the system short ranged and repulsive at short distances (hard core of size of the order of a), and therm odynam ics is well de ned. In the naive continuum limit, in which a ! 0 (g ! 0) and the relevant eld con gurations are smooth, we recover the action of R ef. [13]. This continuum action is not bounded from below and hence the corresponding functional integral diverges. Thus, the results of R ef. [13] are at most form al and the conclusions di erent from ours. The regulators, a and m_0 , play an essential role, although the conclusions, as we will see, are independent of them (provided they are small enough).

The action contains four parameters: the lattice spacing, a, which obviously has dimension of length; the inverse of the potential range, m₀, which has dimension of (length)¹; b, with dimension of (length)¹⁼²; and g, which is dimensionless. The eld is canonically normalized, so that its dimension is (length)¹⁼². It is convenient to rede ne the eld such that $_{n} = b_{n} + \ln g$, and to work in terms of the dimensionless quantities $= a=b^{2}$, $\overline{m}_{0}^{2} = a^{2}m_{0}^{2}$, and $h = 1=2 + \overline{m}_{0}^{2} \ln g$. Ignoring constant terms, the action reads

where $\overline{D} = a^2 r_{L}^2 + \overline{m}_{0}^2$. An action of the same form, with $\overline{m}_{0}^2 = 0$, has been obtained in Ref. [14] in a similar way. In that case, how ever, the parameter h has a dimensional dimensional notice that for h = 0 the action (9) has the symmetry n! n. Since the term linear

in n breaks this symmetry, we will have h i > 0 for h > 0 and h i < 0 for h < 0. At h = 0 we will have h i = 0 unless the symmetry is spontaneously broken.

The average of particle and energy densities, and , can be obtained as derivatives of the grand canonical partition function. This allows to express them in terms of the eld

in the following way:

One can easily identify the rst contribution to the energy in Eq. (11) as the kinetic energy and the second one as the potential energy. The later has the form $_{n}$ ($_{n}$ lng $^{1}\overline{D}_{nn}^{-1}$) $_{n}$, where $_{n} = e^{n} = (1 + e^{n})$ is the local particle density, what in plies that the eld $_{n}$ represents, up to an additive constant, lng + $^{1}\overline{D}_{nn}^{-1}$, the local gravitational potential².

A fler som e algebraic m anipulations, which are outlined in the appendix since they are not completely straightforward, we can write the following exact equation for the average energy, which has the expected form :

In the above equation and stand for the average energy and density, respectively. Remember that $\overline{D}_{n,n+r}^{-1}$ e^{$\overline{m}_0 r$}=r. Notices that the fact that the term with r = 0 is excluded from the sum over r in Eq. (12) in plies that the contact term does not contribute to the energy. This, and the bounds 0 < $_n$ < 1, are manifestations of the particle hard core.

3 Phase diagram

Perturbation theory in euclidean eld theory starts by identifying the minimum of the classical action and assuming that the relevant eld con gurations are small uctuations around this minimum. For the action (9) this is a good approximation if is large. We shall argue below that it is indeed a good approximation whatever $if m_0^2$ is small.

The minimum of the action obviously corresponds to the constant eld that minimizes the classical potential




Figure 1: Phase diagram in the $(\overline{m}_{0}^{2};g)$ plane. The solid line is a rst order transition that ends at the critical point.

The above equation has one, two or three solutions, depending on the values of \overline{m}_0^2 and h. When it has one solution, it correspond to the global minimum; if there are two solutions, one is the global minimum and the other one a point of in ection; three solutions correspond to a local maximum, a local minimum, and the global minimum. In the last case, the minima can only be degenerate if h = 0, and then symmetry implies that Eq. (14) has either one or three solutions: for $\overline{m}_0^2 > 1=4$ the only solution is = 0, while for $\overline{m}_0^2 < 1=4$ we have two solutions, $= 0 \notin 0$ (with 0 positive), which are the two degenerate global minima, besides the symmetric solution = 0, which is a local maximum. We will denote the two global minima by h = + 0 and 1 = -0. The densities of each phase are respectively

Hence, the solutions 1 and h describe phases of low and high density respectively.

The phase diagram in the plane (\overline{m}_0^2 ;g), at the classical level, is displayed in gure 1. For $\overline{m}_0^2 > 1=4$, the transition between the low (sm all g) and high (large g) density regimes is smooth. For $\overline{m}_0^2 < 1=4$, the low density phase is separated from the high density phase by a rst order transition which takes place at $g_{FO} = \exp[1=(2\overline{m}_0^2)]$ (i.e., h = 0). This rst order line ends at the critical point $c\overline{m}_0^2 = 1=4$, $g_c = 1=e^2$ (h = 0). The order parameters, $= h_{1}$ and $= h_{1}$, vanish at the critical point with the classical (m can eld) exponent 1=2. This mean eld critical behavior is a consequence of the classical approximation and could be modified by the neglected uctuations.

For small \overline{m}_0^2 and h = 0, Eq. (14) gives $h = 1 = (2 \ \overline{m}_0^2)$, $a^3 h = 1 e^{1-(2 \ \overline{m}_0^2)}$, $1 = (2 \ \overline{m}_0^2)$, and $a^3 h = 1 e^{1-(2 \ \overline{m}_0^2)}$. Thus, the low density phase is very dilute, while the high density phase is extremely dense. Most of the densities (including presum ably those of physical systems) are between h and h, and they correspond, therefore, to the phase coexistence region.

4 Critical behavior and correlations

The corrections to the classical approximation can be obtained perturbatively, by expanding the action around the corresponding minimum. For each phase we write $n = h + \prime_n$ and $n = 1 + \prime_n$ respectively, and, ignoring again constant terms, the corresponding actions can be written as

where the signs + and correspond to the low and high density phases respectively, and = 1 $a_{h}^{3} = a_{1}^{3}$.

When \overline{m}_0^2 is very small, is much smaller and the actions for either phase (16) are very close to the gaussian critical point, = 0. Therefore, the classical approximation we are using is very good. In addition, we have a very interesting situation: a very sharperst order transition that separates two phases which, in turn, are close to criticality. Hence, the actions (16) produce a very large correlation length and critical (self-similar) behavior over a vast range of scales. The question is to which universality class corresponds such critical behavior. In three dimensions, the gaussian xed point is infrared unstable under perturbations of relevant operators. This means that the critical behavior of actions de ned in the neighborhood of the gaussian xed point can be governed by a dimension dimension larger than one must be of the order of \overline{m}_0^2 . In our case \overline{m}_0^2 and we are in the opposite case: the actions (16) lie very close to the renormalized trajectory of the gaussian xed point, given by = 0, $\overline{m}_0^2 > 0$. Hence, the critical behavior is governed by the gaussian xed point, and thus belongs to the mean eld universality class.

The correlations can be computed to leading order in with good accuracy. For the eld we get $h_{r} r^{0}i = h_{r}ih_{r}i = G(r r^{0})$, with

where we have used the continuum expression since the lattice spacing ism uch smaller than the correlation length, = $a = (\overline{m}_0^2)^{1=2}$. At large distances, G (r) decays exponentially as exp($jr \neq$), but in a wide range of distances, a jr j, it is approximately self-sim ilar, G (r) 1=jr j.

The correlations of the density (10), $(r r^0)$, have the same long distance behavior as the correlations of the eld. To leading order in we have:

For large distances (r) G (r), and therefore the density correlations behave as 1=jrjfor a jrj. Hence, the present approach to self-gravitating systems predicts that density correlations decay as a power law with exponent = 1 over a vast range of scales. Since is proportional to the assumed range of the gravitational interaction, it is well possible that correlations be self-sim ilar at any observable scale. It is worthwhile stressing that the above analysis refers to the quasi-critical behaviour of each of the two phases as \overline{m}_0^2 ! 0. There is a true critical point at $_{\rm c}\overline{m}_0^2 = 1=4$ and $g = 1=e^2$ (or $_{\rm c} = 1=2$). In this case the parameters are not sm all and a non-perturbative analysis is required in order to investigate the nature of its universality class. This critical point m ight be relevant at very high tem peratures, when \overline{m}_0^2 is of order one.

A similar analysis can be made for small (strong coupling regime). The symmetry is broken at the classical level if $\overline{m}_0^2 < 1=4$. For small and small \overline{m}_0^2 short wavelength uctuations cannot induce tunneling between the two minima since it would imply huge uctuations of the action, of the order $1=\overline{m}_0^4$. Likewise, long wavelength uctuations cannot induce tunneling since the barrier is too high, of the order of $1=(8\ \overline{m}_0^2)$. The two minima describe phases of low and high density. The correlation length on each phase is of the order of $1=\overline{m}_0^2$. Hence, the conclusions are the same as in the weak coupling regime: an abrupt rst order transition separates the low and high energy phases, and each phase present critical behaviour of mean eld type.

5 Finite volume e ects: the Lane-Em den equation

It might seem paradoxical that the mean eld solution is hom ogeneous, since it is well known that the usual mean eld solutions of self-gravitating systems present density proles that depend on the distance to the center of the system. There is a simple explanation: since we are looking for the mean eld solution of a short ranged translational invariant system in the in nite volume limit it is natural that it be hom ogeneous. Had we looked for the minimum of the action (8) on a nite box of size L we would have obtained the equation

On a nite volume, the walls break translational invariance and the solution of Eq. (19) will not be hom ogeneous, due to the boundary conditions in posed to the operator ($r_{\rm L}^2$)_{nn⁰}. Since this operator is a discretization of the Laplacian, if L 1=m₀, Eq. (19) is similar to the isotherm al Lane-Em den equation [34, 35] (if m₀ = 0, to leading order in g we will have exactly the discretized Lane-Em den equation, and the corrections in g are due to the cut-o a), and we will get a solution similar to the known proles of self-gravitating systems in the mean eld approximation. On the other hand, if L 1=m₀, the spatial dependence of the solution will be washed out and we will have the reported constant solutions. However, the two solutions correspond to extrem ely high and extrem ely low densities, respectively. The system will only be hom ogeneous at such extrem e densities. For interm ediate densities, inhom ogeneities will necessarily develop: the system will be in a mixture of high and low density dom ains.

This instability as the volum e increases had been notice long ago by Antonov, who found that the solutions of the Lane-Em den equation ceases to be (local) m axim a of the entropy if the size of the box is larger than 0.335GM²=(E), where M is the total m ass and E < 0 the energy, and the system collapses [36]. This was called the gravotherm al catastrophe in Ref. [37].

6 Finalremarks

In therm al equilibrium, a self-gravitating system is made up of domains of low and high density (voids and clusters). The distribution of domains is a dynam ical question that has to do with the way equilibrium is reached. The correlations within each domain are self-sim ilar on a vast range of scales, decaying as 1=r. The transition to hom ogeneity³ [38] would take place on scales comparable to the range of the gravitational interaction, which m ay be larger than the deepest observed distances. A similar behavior (rst order phase transition and self-sim ilar correlations) was found for the two-dimensional self-gravitating system by using techniques of conform all eld theory [39].

It is straightforward to take into account the cosm ic expansion in a simpli ed way, as in Refs. [14, 13], by introducing comoving coordinates x in (1), such that the physical coordinates are r = R (t)x, where R (t) is the scale factor. As intuitively expected, this is equivalent to rescale the lattice spacing: a(t) = R (t)a and, consequently, we have the following rescaling of parameters: ! R (t) and \overline{m}_0^2 ! $R^2(t)\overline{m}_0^2$. This variation of the parameters in plies that the di erence between the densities of the two phases decreases. This is not surprising: the expansion of the universe acts as a pressure that competes with the tendency of gravity towards collapse.

It is remarkable that the picture of the self-gravitating system devised in this work is strikingly similar to the observed universe, despite it is not at therm al equilibrium . The scaling exponent of the the correlation function of the density, = 1, however, is far from the widely accepted exponent of the galaxy correlation function, 1:8 for distances between 0.2 and 20 M pc [1]. A sm entioned in the introduction, in the last years there has been a strong debate about the validity of this result. Pietronero and his group analyzed the data from a di erent perspective and claim ed that the exponent of the galaxy correlation function is 1, and that the self-sim ilar behavior extends up to the deepest explored distances. The controversy seems not resolved, although most astrophysicist 18. This is theoretically supported by the therm odynam ic believe the earlier result, argum ents given in [15]. These argum ents, how ever, are som ehow heuristic and their validity m ay be questioned. Indeed, using Eq. (12) as starting point, the sam e argum ents can be applied step by step to the formulation of the self-gravitating system given in this work, leading to the same predictions of Saslaw's book. However, the results of this work, based on a rather rigorous treatm ent of the self-gravitating system, are completely di erent.

Hence, the conclusion of this paper is clear: either P ietronero and cow orkers are right, and 1, or the therm odynam ical approach is not valid to describe the universe at such scales. The later possibility cannot be discarded, since it is di cult to argue that the universe is at therm al equilibrium, and dynam ical e ects may play a prominent role in the behavior of the galaxy correlation function. In any case, the results obtained in this paper need not be applied to the universe as a whole, or to the large scale structure of it, but to any self-gravitating system that are close to therm al equilibrium. The interstellar gas, where self-sim ilar behavior has also been observed, m ight be an instance. In this case the scaling exponent of the density correlations is compatible with = 1, but with large uncertainties [13].

Appendix

Let us outline in this appendix the derivation of equation (12), which is not completely straightforward. The eld $_n$ can be obtained from the derivative of the action as
