The Composition G radient in M 101 R evisited. II. E lectron Tem peratures and Im plications for the N ebular A bundance Scale

ABSTRACT

W e use high signal/noise spectra of 20 H II regions in the giant spiral galaxy M 101 to derive electron tem peratures for the H II regions and robust m etal abundances over radii $R = 0.19\{1.25 R_0 (6\{41 \text{ kpc}). W \text{ e com pare the consistency of electron tem peratures m easured from the [D III] 4363, [N II] 5755, [S III] 6312, and [D II] 7325 auroral lines. Tem peratures from [D III], [S III], and [N II] are correlated with relative o sets that are consistent with expectations from nebular photoionization m odels. However, the tem peratures derived from the [D II] 7325 line show a large scatter and are nearly uncorrelated with tem peratures derived from other ions. We tentatively attribute this result to observational and physical e ects, which m ay introduce large random and system atic errors into abundances derived solely from [D II] tem peratures. Our derived oxygen abundances are well tted by an exponential distribution over six disk scale lengths, from approximately 1.3 (O/H) in the center to 1/15 (O/H) in the outerm ost region studied (for solar 12 + log (O/H) = 8.7). We measure signi cant radial gradients in N/O and He/H abundance ratios, but relatively constant S/O and Ar/O. O ur results are in approximate agreement with previously published abundances studies of M 101$

based on tem perature m easurem ents of a few H II regions. How ever our abundances are system atically low erby $0.2\{0.5 \text{ dex than those derived from the m ost w idely used strong-line \empirical" abundance indicators, again consistent with previous studies based on sm aller H II region samples. Independent m easurem ents of the G alactic interstellar oxygen abundance from ultraviolet absorption lines are in good agreem ent with the T_e-based nebular abundances. W e suspect that m ost of the disagreem ent with the strong-line abundances arises from uncertainties in the nebular m odels that are used to calibrate the \empirical" scale, and that strong-line abundances derived for H II regions and em ission-line galaxies are as m uch as a factor of two higher than the actual oxygen abundances. How ever other explanations, such as the e ects oftem perature uctuations on the auroral line based abundance determ inations of a larger sam ple of extragalactic H II regions, especially for objects m ore m etal-rich than solar.$

1. IN TRODUCTION

The spiral galaxy M 101 (NGC 5457) has played a central role in our understanding of gas-phase abundance distributions in galaxies. Its large disk ($R_0 = 14.4 \text{ arcm}$ in = 32.4 kpc; de Vaucouleurs et al. 1991) contains well over 1000 catalogued H II regions (H odge et al. 1990; Scow en, D ufour, & H ester 1992) with a large radial range in excitations and m etal abundances. Spectrophotom etry of its brightest H II regions by Searle (1971) and Sm ith (1975) provided some of the rst quantitative m easurem ents of radial abundance gradients in disks.

The rst system atic studies of H II region abundances in galaxies were based on \direct" m ethods, in which m easurem ents of tem perature-sensitive auroral lines (usually [D III] 4363) were used to constrain the tem perature and em issivities of the abundance-sensitive forbidden lines directly. M 101 was the object of several such studies, each based on electron tem perature (T_e) m easurem ents of 1{5 bright H II regions (Searle 1971; Sm ith 1975; Shields & Searle 1978; Rosa 1981; Sedwick & A ller 1981; Rayo, Pein bert, & Torres-Pein bert 1982; Torres-Pein bert, Pein bert, & Fierro 1989; K inkel & Rosa 1994; G arnett & K ennicutt 1994). These studies established the existence of a roughly exponential abundance gradient in the disk, and with roughly a vefold range in abundance over the range of radii studied ($0.2{0.8 R_0}$). They also established that the pronounced nebular excitation variations observed am ong extragalactic H II regions are driven prim arily by changes in their electron tem peratures. For com positions typical of present-day disks the dom inant ionized gas coolants are ne-structure lines of heavy elements, so the average electron tem perature of an H II region decreases with increasing m etal abundance.

The application of this \direct" abundance technique has been ham pered by several technical

limitations, however. For oxygen abundances much above 0.5 (O/H), increased cooling by IR ne-structure lines causes the [O III] 4363 line to become increasingly weak and di cult to detect, rendering direct abundance determ inations based on this feature in possible. Questions about the linearity of photon-counting detectors used prior to the 1990s also reduced condence in the abundances even when the [O III] 4363 line was detected (e.g., Torres-Peimbert et al. 1989). Moreover, the [O III] temperature itself may not be a representative measure of the average temperature in regions where O^{++} occupies a small fraction of the nebular volume or have signi cant internal gradients in T_e (e.g., Stasinska 1978; G armett 1992; O ey & Kennicutt 1993). Local uctuations in electron temperature may also a ect the temperature derived from integrated measurements of collisionally excited lines in the optical part of the spectrum (e.g., Peimbert 1967).

The absence of direct abundance measurements for metal-rich objects led to the development of \empirical" methods, in which the ratios of strong lines ([D II] 3727, [D III] 4959, 5007, [N II] 6583, [S II] 6717,6731, [S III] 9069,9532) are used to estimate the oxygen abundance, without any direct electron temperature measurement (e.g., Pagel et al. 1979; A lloin et al. 1979; Edmunds & Pagel 1984; D opita & Evans 1986; M oG augh 1991; V Ichez & Esteban 1996; van Zee et al. 1998; D util & Roy 1999; D az & Perez-M ontero 2000; K ew ley & D opita 2002). These methods rely on the physical coupling between metal abundance and electron temperature, coupled with the observation of relatively tight correlations of forbidden-line ratios among extragalactic H II regions (e.g., Baldwin, Phillips, & Terlevich 1981; M cC all, Rybski, & Shields 1985). Early applications of these empirical methods were calibrated using a combination of T_e-based abundances for m etal-poor objects and nebular photoionization models at higher abundances (see G arnett 2003 for a review). However, most subsequent calibrations have relied increasingly on grids of H II region photoionization models (e.g., M cG augh 1991; K ew ley & D opita 2002).

O ver the past 15{20 years the overwhelm ing majority of published abundance studies of spiral galaxies have been based on these strong-line methods. These have included several comprehensive studies of the abundance trends across large galaxy samples (e.g., MoC all et al. 1985; Skillman, Kennicutt, & Hodge 1989; Vila-Costas & Edmunds 1992; Oey & Kennicutt 1993, Martin & Roy 1994; Zaritsky, Kennicutt, & Huchra 1994; Skillman et al. 1996; Pilyugin et al. 2002), and applications to the integrated spectra of high-redshift galaxies (e.g., Kobulnicky & Zaritsky 1999; Carollo & Lilly 2001; Kobulnicky et al. 2003). These methods have been applied to M 101 by Scowen et al. (1992), Kennicutt & Garnett (1996, hereafter Paper I) and Pilyugin (2001b).

The widespread application of these \empirical" abundances has hardly lessened the need for a foundation of abundance measurements based on high-quality, robust electron-temperature measurements. Fortunately, the introduction of high-eciency spectrographs with CCD detectors on 4{10 m class telescopes now makes such an undertaking possible, through measurements of other auroral lines such as [S III] 6312, [N II] 5755, and [D II] 7320,7330 (e.g., K inkel & Rosa 1994, C astellanos, D az, & Terlevich 2002 and references therein). The [S III] 6312 line is an especially attractive therm on eter, because it is observable to higher metal abundances than [D III] 4363, and offen samples a larger fraction of the nebular volume in these regions. Its chief disadvantage is the need for accurate spectrophotom etry of the corresponding nebular lines of [S III] 9069,9532 in the near-infrared, but with the advent of red-sensitive CCD detectors m easurem ents of these lines are feasible (e.g., G arnett 1989; B resolin, K ennicutt, & G arnett 1999 [hereafter BKG]; C astellanos et al. 2002).

This paper is the second in a series on the spectral properties and chem ical abundances in M 101. In Paper I we presented strong-line m easurem ents of [0 III], [0 IIII], [N III], [S III], and [S IIII] for 41 H II regions, and used several empirical abundance calibrations to exam ine the radial and azim uthal form of the oxygen abundance distribution. In this paper we use higher quality spectra for 26 of these H II regions obtained with the M M T telescope to m easure electron temperatures and temperature-based abundances. O ur study is motivated by several goals:

i) To enlarge the sam ple of M 101 H II regions with well-m easured direct abundances (from 6 to 20), thereby enabling us to separate genuine radial trends in the abundances from local variations or other spurious e ects.

ii) To extend by m ore than 50% the radial coverage of the abundance m easurem ents, to 0.19{ $1.25\ R_0.$

iii) To take advantage of the large hom ogeneous data set and the large range of oxygen abundances in M 101, to test for radial trends in N /O, S/O, A r/O, and H e/H abundance ratios, with im proved sensitivity over m ost previous studies.

iv) To obtain robust CCD-based [0 III] tem perature m easurem ents, without the system atic uncertainties introduced by detector nonlinearities in most of the previously published spectra.

v) To measure electron temperatures for two or more ions in a majority of the H II regions, which enables us to compare the temperature scales, test the reliability of the individual auroral lines, and test the relations between ionic temperatures that have been predicted by nebularm odels.

vi) To com pare our tem perature-based abundances with the published \empirical" strong-line calibrations, and with independent abundance constraints, in order to test the consistency of the respective scales and understand the physical origins of any system atic di erences.

The remainder of this paper is organized as follows. In x 2 we describe the observations and data analysis procedures, and present the spectrophotom etric data used in this analysis. In x 3 we use the data to derive electron temperatures and O, N, S, and N e abundances, and discuss the consistency of the temperature scales. We analyze the radial abundance distributions in M 101 them selves in x 4, and in x 5 we com bine our new data with high-quality direct abundances from the literature, to compare the consistency of the direct and strong-line abundance scales. We conclude with a general discussion of the zeropoint and reliability of the extragalactic nebular abundance scale in x 6. To maintain consistency with Paper I we will adopt a distance to M 101 of 7.5 M pc (K elson et al. 1995) throughout this paper. However, we now adopt the new solar oxygen abundance scale (12 + log (O/H)) = 8.70) following A llende Prieto et al. (2001) and Holweger (2001).

2. DATA

Table 1 lists the objects measured in this study. Following Paper I we have used the designations of Hodge et al. (1990) when available. Detailed information on the positions and alternate designations of these H II regions can be found in Paper I, and are not repeated here.

O ur sam ple was selected to cover the maximum range in radius and abundance possible. For the outer disk ($R > 0.3 R_0$) we measured most of the bright knots in the large complexes NGC 5447, 5455, 5461, 5462, and 5471, as well as other, isolated H II regions at intermediate radii. We also made an e ort to obtain good azimuthal coverage, to avoid any bias that might be introduced by the possible asymmetry in abundance distributions in M 101 (Paper I). Since we were aiming to detect at least one auroral line with high signal/noise, we concentrated on the brightest H II regions at any radius.

The metal-rich H II regions in the inner disk of M 101 presented particular challenges. The low excitation of the H II regions in the inner disk makes detection of the auroral lines di cult, and the problem is exacerbated by the stronger stellar continua in most regions (i.e., lower emission-line equivalent widths; see Paper I) and the relative absence of bright H II regions. We obtained multiple integrations for 4 H II regions with $R < 0.3 R_0$ (H 972, H 974, H 1013, H 336), but only the latter two objects yielded useful easurements of tem perature-sensitive lines (x 3.1).

In addition to H II regions from Paper I, we also observed the outerm ost H II region in the survey of Scowen et al. (1992) at (J2000) $RA = 14^{h} \ 03^{m} \ 50^{\circ}.09$, $Dec = 54 \ 38^{0} \ 05^{\circ}.0$, at a radial distance of $18^{0}.0$ (41 kpc) from the nucleus of M 101. It is designated as SD H 323 in Table 1 and the rem ainder of this paper. We also include in our analysis measurements of the outer disk H II region H 681 from G arnett & Kennicutt (1994) m ade with the M M T Red Channel Spectrograph, and analyzed using the same procedures as described below.

2.1. Spectrophotom etry

M ost of the spectroscopic data used in this paper were obtained in 1994{1997 with the B lue C hannel Spectrograph on the 4.5 m M M T Telescope. An additional spectrum of one object (H 336 = Searle 5) was obtained in 2002 January using the same spectrograph on the upgraded 6.5 m M M T. In addition, uxes of lines longward of 6800 A were taken from data obtained on the M M T with the Red C hannel Spectrograph, as described in Paper I.

Spectra covering the region 3650 { 7000 A were obtained using a 500 grooves mm¹ grating blazed at 5410 A, used in rst order with a 3600 A cuto blocking lter. A 2⁰⁰ 180⁰⁰ slit yielded a spectral resolution of 6 A FW HM. The spectrograph was equipped with a 3072 1024 element thinned Loral CCD detector, providing a spatial scale of 0⁰⁰ 6 per (binned) pixel. H II regions were observed for 1{3 integrations of 1200 s each. This provided high signal/noise (S/N 50) m easurem ents of the principle diagnostic em ission lines and m easurem ents of faint lines including

[O III] 4363 and [S III] 6312 in all but the lowest-excitation H II regions.

For the low-excitation m etal-rich H II regions, higher-resolution spectra were obtained to provide m ore sensitivity to the faint temperature-sensitive [S III] 6312 and [O II] 7320,7330 lines. H 336 (Searle 5), H 409 (NGC 5455), H 1013, and H 1105 (NGC 5461) were observed using a 1200 grooves m m⁻¹ grating blazed at 4830 A, tuned to cover the wavelength range 6000 { 7500 A with a resolution of 2.4 A FW HM. Integration times ranged from 600 s for the NGC regions to 2400 s for the fainter and m ore m etal-rich H 336 and H 1013. The ux scale of these spectra were tied to the full-coverage spectra described above at H .

For spectral lines longward of 7000 A (m ainly [0 II] 7320,7330 and [S III] 9069,9532) we used echellette spectra obtained with the Red Channel Spectrograph on the M M T, as described in detail in Paper I. These spectra cover the wavelength range 4700 { 10000 A, and were taken with a 2^{00} 20⁰⁰ slit, yielding a spectral resolution of 7 15A FW HM. The ux scales of the two sets of spectra were tied together at H .

Standard stars from the list of M assey et al. (1988) were observed several times per night to determ ine the ux calibration. C are was taken to orient the spectrograph slit with the atm ospheric dispersion direction for all standard star m easurements, and for the H II regions when the dispersion was signi cant. Standard dark, at eld (including twilight sky m easurements), and H eN eA r lamp exposures were taken to calibrate CCD sensitivity variations, cam era distortions, and the wavelength zeropoint.

The spectra were reduced using the TW OD SPEC package in the NOAO IRAF package², using standard procedures. Since m ore than one object som etim es was observed along the slit, the spectra were fully reduced and calibrated in two dimensions before extracting one-dimensional ux-calibrated spectra for each H II region. The size of the extraction aperture was adjusted depending on the size of the H II region (typically 6^{00} { 10^{00}), and was matched to the aperture used in the Red Channel spectra from Paper I.

Line intensities were measured by integration of the ux under the line pro les between two continuum points identied on each side of the line. For partly overlapping lines (e.g., H + [N II] 6563;6548;6583 and [SII] 6716;6731) gaussian pro les have been assumed to deblend the dierent components. A verage spectra were measured in those cases where multiple observations with the same grating were taken. When available, line uxes from the higher resolution spectra were retained for the subsequent analysis, after a consistency check with the lower resolution spectra was carried out.

The accuracy of the spectrophotom etry was checked in several ways, from consistency of the standard star calibrations on a given run (typically $2\{3\%$ m s over the entire wavelength range),

com parison of multiple measurements of the same H II regions, and, in the case of the faint lines, by Poisson statistics. Uncertainties for individual line measurements are listed in Table 1.

The observed spectra were corrected for interstellar reddening using the Balmer emission line decrement and the interstellar reddening law of Cardelli, Clayton, & Mathis (1989). We corrected for underlying stellar Balmer absorption by determining iteratively the equivalent width of the underlying stellar absorption that provides consistent values of the extinction c(H) for all the lines considered (H through H). For the intrinsic Balmer line ratios we have assumed the theoretical Case B values of Hummer & Storey (1987) at the temperature determined from the auroral lines.

3. ELECTRON TEM PERATURES AND ABUNDANCES

Analysis of the spectra was performed using the ve-level atom program of Shaw & Dufour (1995), as in plemented in the IRAF package with the exception of [S III], where we used updated collision strengths from Tayal & Gupta (1999). These yield [S III] temperatures that are about 200 K cooler and S^{+2} abundances that are approximately 0.1 dex higher than produced by the 5-level program. Inspection of the [S III] 6717,6731 doublet ratios in our H II regions shows that most of the emitting gas is at low electron densities (n_e 100 cm⁻³), so collisional elects on the derived temperatures and abundances should be negligible form ost of the measured lines (possible exceptions are discussed below).

3.1. Electron Tem peratures

Electron tem peratures were derived using four sets of auroral/nebular line intensity ratios: [p III] 4363/[p III] 4959,5007, [p III] 6312/[p III] 9069,9532, [n II] 5755/[n II] 6548,6583, and [p II] 7319,7330/[p II] 3726,3729. In many of the H II regions one or more of the auroral lines was too faint to yield a reliable tem perature measurement. Care must be taken to exclude low signal/noise auroral line measurements, to avoid having the tem peratures biased by incompleteness e ects. We propagated the measured line ux errors directly into the T_e determination, and in the subsequent abundance analysis we discarded any data for which (T_e) 1000 K or 10% (whichever was larger). This left 20 H II regions with a T_e measurement from at least one auroral line, 17 objects with at least two temperature measurements, and 14 regions with three measurements. Three regions originally in the sample, H 203, H 972 and H 974, did not yield any reliable auroral line detection, and these objects were dropped from the remaining analysis. Table 2 lists the derived electron temperatures and uncertainties for the sample. For most objects the uncertainties in the T_e values are in the range 200{700 K}.

The availability of multiple T_e m easurem ents for a large sample of H II regions allow sus to com – pare the consistency of the various ionic tem perature scales. Photoionization m odels can be used to predict scaling relations between tem peratures m easured in di erent ions, and these are com m only

used in abundance analyses when only a single temperature measurement (usually [0 III] 4363) is available. G arnett (1992) carried out an extensive analysis of ion-weighted temperatures over the abundance range of interest, and we can compare the actual temperature relationships with those predicted by his models.

Figure 1 com pares the m easured [0 III], [S IIII], and [N III] tem peratures with [0 IIII] tem peratures derived for the M 101 H II regions in Table 2 (solid points). In order to enlarge the com parison and check the reliability of our results we also include data from a study of NGC 2403 by G armett et al. (1997). These latter data are plotted as open points. The dashed lines show the scaling relations predicted by the photoionization m odels of G armett (1992):

The best correlation is between [0 III] and [5 III] tem peratures (T [0 III] and T [5 III], respectively), as shown in the top panel of Figure 1. Apart from a few objects with large uncertainties in one or both auroral line m easurements, the respective tem peratures roughly follow the theoretically predicted relationship from G arnett (1992). A similar correlation was observed by Vermeij & van der Hulst (2002) for a sample of M agellanic C loud H II regions, albeit with larger observational uncertainties than in this study. This correlation is reassuring, and m ay alleviate some of the concerns raised about the utility of [0 III] tem peratures in m oderate-abundance H II regions (e.g., Stasinska 2002). Despite the di erent ionization thresholds for S⁺⁺ and O⁺⁺ (23 eV vs 35 eV, respectively), the ions yield consistent m easurements of T_e over the range of tem peratures where both auroral lines can be observed. In particular there is no evidence for [0 III] tem peratures being system atically higher in the higher-abundance, lower-tem perature H II regions, as m ight be expected from tem perature uctuation e ects.

The comparison of N II] and D III] tem peratures (m iddle panel in Fig.1) is less clear, because only a few regions have measured N II] 5755 lines, and for most of them the T N II] is uncertain ($(T_e) > 1000 \text{ K}$). The four regions with the best-determ ined tem peratures show good agreement with the expectations from the Garnett (1992) models, but more data are needed to draw any meaningful conclusions. The discrepant points with the unphysically high N II] tem peratures all have very large uncertainties, and are probably the result of the susceptibility to anom alously large T_e values for marginally detected lines that was alluded to earlier.

The most surprising comparison is between [0 II] and [0 III] temperatures, as shown in the bottom panel of Fig. 1. A lthough there may be a hint of a correlation in the extremes of the temperature range (e.g., $T_e < 9000 \text{ K} \text{ vs } T_e > 13000 \text{ K}$), for most objects the two temperatures are uncorrelated. In order to assure ourselves that this result was not an artifact of an error in our data (e.g., poorly determined reddening corrections), we compiled data from other sources (Peimbert,

Torres-Peimbert, & Rayo 1978; Haw ley 1978; Talent & Dufour 1979; Vermeij & van der Hulst 2002) and these data show a similar inconsistency in temperatures.

The source of this disagreem ent remains unresolved, but we can speculate on possible sources. First, the ${}^{2}P$ ° level that gives rise to the [0 II] 7319,7330 com plex (actually a pair of doublets) can be populated by direct dielectronic recombination into that level, as wellby radiative cascade (R ubin 1986). Thism echanism also a ects the [N II] 5755 line and the [0 II] 3727 doublet as well, although to a lesser degree. The net e ect is that the electron temperature derived from the [0 II] line ratio can be overestim ated if the recombination contribution is not accounted for. The magnitude of the recombination increases with both temperature and the 0⁺² abundance, and so is a greater problem for hotter nebulae with large 0⁺² fractions. Liu et al. (2000) provide correction form ulae for the recombination contributions to the [0 II] and [N II] line intensities:

where $I_R = I$ (H) is the intensity of the recombination contribution to the [O II] line relative to H $\,$.

We have estimated the likely contribution of recombination to the [O II] 7319,7330 feature, using the [O III] electron temperatures from Table 3 and O^{+2}/H^+ ratios computed in Table 4. We not recombination typically contributes < 5% to the [O II] line ux, which corresponds to a temperature error of only 2{3%, or less than 400 K in our worst case. Hence it cannot be a signi cant contributor to the discrepancy observed here. Note that recombination into [O II] would be expected to scatter the derived [O II] temperatures to system atically higher values.

It should also be noted that the [D II] 7325/ 3727 ratio is much more severely a ected by collisional de-excitation than other T_e -sensitive ratios. A simple ve-level atom analysis shows that the derived T [D II] can dier by as much as 1,000-2,000 K when changing n_e from 10 to 200 cm⁻³. A lthough our [S II] 6717/ 6731 line ratios typically are consistent with n_e being in the low density limit, in practice the uncertainties in the [S II] ratios are such that the 3 upper limits are of the order 200-300 cm⁻³, thus permitting a fairly considerable range in electron density.

O ther physical origins for discrepant [0 II] tem peratures m ight include radiative transfer effects, such as part of the [0 II] em ission arising in shadowed regions preferentially ionized by the di use radiation eld, or a signi cant contribution of the [0 II] from shocked regions. Shocks m ay be a signi cant contributor when one considers the supersonic turbulence that typi es giant H II regions (e.g., Chu & Kennicutt 1994; Melnick, Tenorio-Tagle, & Terlevich 1995 and references therein)³.

Observational uncertainties undoubtedly contribute to the scatter in T [O II] as well. The large wavelength di erence between the [O II] features (3727 { 7325 A) makes their ratio more sensitive

to uncertainties in interstellar reddening. This is compounded by the fact that the two features can not be observed in a single spectroscopic setting, because of second-order contam ination. The

7325 feature is located in a region of relatively strong OH airglow emission, and is in the middle of a telluric water vapor band as well. All these e ects probably raise the uncertainty in the [O II] line ratio considerably over the form al uncertainty based on photon statistical uctuations. It is di cult to estimate the contributions to the uncertainties from some of these e ects, and it is likely that the form al uncertainties for T [O II] in Table 2 underestimate the true errors.

Until the origin of the discrepancy of $[0 \ II]$ tem peratures with other ions is understood, abundances derived solely on the basis of T $[0 \ II]$ measurements should be treated with skepticism.

3.2. Ionic and TotalE lem entalA bundances

The very good correlation between T [S III] and T [O III] in Figure 1, and its consistency with the predicted relation from ionization models, led us to calculate ionic abundances using a threezone model for the electron temperature structure of an H II region (G armett 1992). In this model the [O III] temperature is used to characterize the highest-ionization zone (O^{+2} , Ne^{+2}), [S III] temperatures are used to characterize the moderate-ionization zone (S^{+2} , Ar^{+2}), and the [N II] and [O II] temperatures to characterize the low-ionization zone. However, in view of the problem s apparent in the [O III] temperatures, we needed to adopt an alternative procedure for setting the temperature in the low-ionization region.

We have used the scaling relations between [P II], [S III], and [P III] tem peratures from G arnett (1992) to reduce the uncertainties in the individual T_e m easurem ents, and to estim ate one or m ore of the zone tem peratures above when a direct T_e m easurem ent was not available (G arnett et al. 1997). Instead of applying the m easured T [P III] directly, we used equation [1] to derive a second estim ate of T [P III] and averaged the two values to set the tem peratures in the high-ionization zone. The same process was applied in reverse to set T_e in the m oderate-ionization zone. A lthough this procedure introduces some dependence between the tem peratures in the high- and m oderate-ionization zones, it is justified by the tight correlation in the top panel of F ig. 1, and it reduces the random error in the derived abundances without introducing any system atic errors. We used equations [1] and [2] to estim ate the tem perature in the low-ionization zone, unless a direct T_e m easurem ent was available from [N II]. Table 3 sum marizes these adopted electron tem peratures.

Of the 22 H II regions in Table 1 with auroral line m easurem ents, 19 objects have su cient quality tem perature m easurem ents to provide reliable abundances. Two regions (H 237, H 875) were excluded because only [D II] tem peratures were m easured, and one region (H 140) was dropped because the remaining [S III] or [D III] tem peratures were too poorly m easured to provide accurate abundances m easurem ents on their own. The addition of H 681 from G armett & K ennicutt (1994) leaves us with robust T_e -based abundances for 20 H II regions. Table 4 lists the ionic abundances for 0⁺, 0⁺², S⁺, S⁺², N⁺, Ne⁺², and Ar⁺² (all with respect to hydrogen), computed using the

adopted electron tem peratures in Table 3. Table 5 lists the total elemental abundances for O, N, S, and Ne.

The current data set is unique in that it provides a large number of T_e -based abundances for a spiral galaxy, over large ranges in m etal abundance and nebular ionization. This enables us explore the behavior of the ionization (and the reliability of the commonly applied ionization corrections) for several heavy elements. We discuss helium separately in x 4.4.

For oxygen, we know from the weakness of HeII 4686 that a negligible fraction of the gas is in 0^{+3} , so the oxygen abundance is simply the sum $(0^{+} + 0^{+2})$. For nitrogen we made the usual assumption that N /O scales with N⁺/O⁺, although this has not yet been demonstrated to be generally applicable (G arnett 1990).

Sulfur requires a correction for unobserved S^{+3} in high-ionization regions. This is illustrated in Figure 2, where we show the ratio $(S^{+} + S^{+2})/(O^{+} + O^{+2})$ vs the O^{+} fraction, for H II regions in M 101 and other objects from G arnett (1989) and G arnett et al. (1997). The sharp drop in S^{+} + S^{+2} relative to 0 in highly-ionized regions (i.e., low O^{+}/O) is symptom atic of an increasing contribution from unobserved S^{+3} . To account for the S^{+3} contribution we used the correction form ula of Stasinska (1978) and French (1981):

using = 2.5, which is consistent with the sulfur ionization trends derived from photoionization m odels by G arnett (1989). This relation is plotted as the solid curve in Figure 2, for an assumed (constant) intrinsic log (S/O) = 1.60. W hile this relation appears to adequately follow the data for O⁺ fractions greater than 0.2 (including m ost or all of the M 101 H II regions in this paper), the objects with higher ionization appear to fall below the curve. This could indicate that the m odels underpredict the S⁺³ fraction in high-ionization nebulae. This remains to be explored through further m odeling and observations of [S IV] 10.5 m. Observations of m any G alactic and LM C H II regions with the Infrared Space Observatory (ISO) indeed show strong [S IV] em ission (e.g., Peeters et al. 2002a, b; M artin-H emandez et al. 2002).

A rgon presents problem s sim ilar to those for sulfur, because three ionization states can be present in H II regions. A r^+ is present in low-ionization nebulae, while A r^{+3} can appear in H II regions of the highest degree of ionization. The ionization potentials of sulfur and oxygen bracket the respective levels in argon, so we have tested whether the observed ionic ratios in O or S can be used to derive a useful ionization correction factor (ICF) for argon. Figure 3 (top panel) shows that A r^{+2}/O^{+2} is a poor predictor of A r/O, as this ion ratio is strongly correlated with O⁺/O over the entire range sam pled by our H II regions. O n the other hand a plot of A r^{+2}/S^{+2} vs O⁺ fraction (bottom panel of Figure 3) shows very little correlation; only the low est-ionization region (H 336) shows any signi cant deviation from a constant A r^{+2}/S^{+2} . O ur m easurem ents of 15 H II regions in M 101 (excluding H 336) and 8 H II regions in NGC 2403 (G arnett et al. 1997) yield a

m ean log (A r^{+2}/S^{+2}) = {0.60 0.05. Thus for the purposes of this study we will assume that A r/S = A r^{+2}/S^{+2} .

Neon is observed mostly in high-ionization, low -abundance H II regions via the [NeIII] 3869 line, and in those cases it is usually assumed that $Ne^{+2}/O^{+2} = Ne/O$. This line is rarely observed in metal-rich H II regions, however, so the ionization corrections are less well constrained. A further diculty is that models for the ionization of neon are sensitive to the input stellar atmosphere uxes, which are them selves sensitive to the treatment of opacity and stellar winds. For this reason ionization models have had diculty reproducing [Ne III].

The determ ination of the form of an ICF for Ne requires infrared m easurem ents of [NeII] and [NeIII] lines along with optical m easurem ents of [D II] and [D III]. Few such m easurem ents exist over a large range of 0⁺/O.W e have exam ined recent results from ISO spectroscopy of H II regions in M 33 by W illner & Nelson-Patel (2002) and in the M agellanic C buds by Verm eij & van der Hulst (2002). Figure 4 shows Ne⁺²/Ne vs. 0⁺/O for the regions in these studies having both optical and IR m easurem ents. The data clearly indicate that Ne⁺²/Ne declines strongly as the 0⁺ fraction increases. On the other hand, the observational scatter is signi cant, and there are too few m easurem ents for low-ionization regions (0⁺/O > 0.5) to reliably derive a functional form for the Ne ICF at this time. Figure 5 shows the Ne⁺²/O⁺² ratios for our M 101 H II regions. The data are consistent with a constant ratio over a wide range of ionization, but the scatter increases considerably as 0⁺/O increases. This is partly due to observational scatter, but probably also re ects greater sensitivity to the local radiation eld as Ne⁺² and O⁺² becom eminor constituents. The data are consistent with a constant Ne/O abundance ratio in M 101, but do not establish this unam biguously. In view of the uncertainty in the Ne ICF swe shall not discuss the neon abundances further in this paper.

4. The Abundance G radient in M 101

These new abundance measurements provide largest and most complete radial coverage of any galaxy measured to date. We is the discuss the radial behavior of the overall heavy element abundance gradient (via O/H), and then exam ine the other heavy element and helium abundance properties.

4.1. O xygen A bundances

Figure 6 shows the radial dependence of the oxygen abundances for the 20 H II regions in our sample with reliable T_e measurements. The error bars show the uncertainty in abundance as propagated from errors in the line measurements; these are dominated by the auroral line measurements. For most of the H II regions in the sample, the choice of ionic temperature for the low-ionization zone has a smalle ect on the derived abundance (0.05 dex). This is a rejection of

the consistency of the [S III] and [O III] tem peratures discussed earlier, combined with the milder dependence of abundance on T_e for interm ediate-abundance H II regions. However the choice of tem perature is signi cant at the extrem es of the abundance distribution, especially for the three innerm ost H II regions.

In term s of the revised solar value of $12 + \log (O/H) = 8.7$, the gas-phase oxygen abundances in M 101 range from $1.2 \quad 0.2 (O/H)$ in the center to $0.07 \quad 0.01 (O/H)$ at R = 41 kpc. The abundance in the outerm ost disk is comparable to that of all but the most extrem e m etal-poor dwarf irregular galaxies. For comparison IZw 18, the most m etal-poor H II galaxy known, has an abundance $12 + \log (O/H) = 7.2 \text{ or } 0.03 (O/H)$ on the new solar scale.

N um erous other authors have m easured T_e -based abundances for sm all sam ples of H II regions in M 101, as com piled in Table 6. Figure 7 shows that our results are generally in good agreem ent with these previous m easurements. The rm s di erence between our O/H values and those from the literature is 0.11 dex, or 0.09 dex if we exclude H 336, the most discrepant point, and we see no large-scale system atic di erences. A sone might expect the di erences are larger for the more m etalrich H II regions, which have lower and more di cult to measure temperatures. The abundances for these regions are very sensitive to the adopted T_e ; for example in the innerm ost region H 336 a di erence in T_e of only 600 K in T [D II] accounts for about 0.2 dex of the di erence between our abundance and that of K inkel& Rosa (1994). The rest com es from their use of an ionization m odel to derive 0 /H; if we use their measured T_e values, we derive 12 + log (O /H) = 8.79.

The observed abundances are well tted by an exponential distribution, as shown by the solid line in Figure 6. This line shows a least squares to the points, yielding:

An independent T_e -based abundance measurem ent to H 336 (Searle 5) is available from K inkel & Rosa (1994). Those authors derived 12 + log (O/H) = 8.88 (no uncertainty quoted), which is signi cantly higher than our value of 8.55 0.16. Their measurem ent is plotted as an open circle in F igure 6, and the dashed line shows the resulting tted exponential abundance distribution if we use their measurem ent instead of ours:

The di erence propagates to an uncertainty of 0.1 dex in the extrapolated central abundance At the adopted distance of M 101 (7.5 M pc), $R_0 = 32.4 \text{ kpc}$, so the corresponding gradients from equations [5] and [6] are 0.029 and 0.032 dex kpc^1 respectively. of M 101 and 10% in the slope of the gradient. For a B-band disk scale length of 5.4 kpc (O kam ura, K anazawa, & K odaira 1976), the corresponding gradient is 0.16 = 0.01 dex per unit scale length.

The fact that the gradient in 0 /H remains closely exponential over six disk scale lengths is

rem arkable. There have been claims for a change in slope of the gradient in M 101 at $0.3\{0.5 R_0, based on strong-line estim ates of O/H, and it has been argued that such a change could be related to the change in slope of the rotation curve (Scowen et al. 1992; Zaritsky 1992). M ore recently Henry & Howard (1995) and Pilyugin (2003) have argued that an exponential gradient was the best t to the published data. Our results con im that the purported changes in gradient slope are spurious and probably a result of system atic errors in the strong-line abundance estim ates should be regarded as uncertain.$

Exponential heavy element abundance gradients have important consequences for chemical evolution m odels. A generic feature of chem ical evolution m odels is that the composition gradients atten with time, as a result of the breakdown of the instantaneous recycling approximation; as old, m etal-poor stars die, they eject relatively m etal-poor gas into the ISM at late tim es, and thus inhibit the enrichment of the ISM . This process proceeds more quickly in the dense inner regions of spirals, so that the models predict a atter gradient in the inner disk than in the outer (e.g., Prantzos & Boissier 2000; Chiappiniet al. 2002). However, such attening of the gradients is rarely observed. This implies that some input assumption of the models is inadequate. Two possible explanations are that: (1) D isks are younger than assumed in the published chem ical evolution models. In the models, the abundance gradients steepen with time early on, and then atten from the inside out as the galaxy ages. In young disks the composition gradients are close to exponential. Thus if disks are younger than often assumed in the models (13-15 G yr), then more uniform gradients would be expected. (2) Slow radial gas ows may redistribute gas and metals so as to maintain an exponential composition gradient. Lin & Pringle (1987) showed that viscous evolution of matter and angular momentum in disks can lead to exponential density distributions, while Clarke (1989) and Sommer-Larsen & Yoshii (1989) demonstrated that this can give rise to exponential composition gradients as well. It is as yet unclear how such radial gas ows can be maintained, or even what the magnitude of radial ows could be. Numerical simulations should help to address these questions (e.g., Churches, Nelson, & Edmunds 2001). If steep exponential abundance gradients are a com m on feature in disks this will need to be taken into account in galaxy evolution m odels.

Despite the well-de ned exponential distribution, the points in Figure 6 show considerable scatter. Inspection of the data on a point-by-point basis shows that most or all of this scatter is due to uncertainties in the individual abundance measurements. For example, the scattering of points near $R = R_0 = 0.42$ and 0.53 are mainly dimension regions in the NGC 5462 and NGC 5447 complexes, respectively, which presumably have the same physical abundances. The mms residual between the data points and the t is 0.09 dex, which is only marginally larger than the mms uncertainty of the individual measurements (0.07 dex), and only one object (H 128) deviates by more than 3 from the tted gradient. As a result our data set is neither large enough nor accurate enough to test for local variations in abundances, such as the azim uthal asymmetry in nebular excitation and empirical abundance that was reported in Paper I.

4.2. N/O Abundance Ratios

N itrogen shows a strong radial abundance gradient as well, and the behavior of the the di erential N /O abundance ratio can place contraints on its nucleosynthetic origin.

Figure 8 shows the behavior of N/O with galactocentric radius (top panel) and as a function of oxygen abundance (bottom panel). There is a strong gradient in N/O across M 101, as suspected from previous studies, and a signi cant correlation of N/O with overall O/H abundance. The two outerm ost H II regions in M 101 have N/O values sim ilar to those seen in dwarf irregular galaxies (e.g., G armett 1990). The data in Figure 8 suggest a possible attening of the N/O gradient in the outer parts of M 101, consistent with the roughly constant value observed in dwarf galaxies, but we do not have enough data points to draw strong conclusions.

O ne region, NGC 5471-C, stands out as having a signi cantly higher N/O than expected. This is not an artifact of the data, as we saw relatively strong [N II] in our spectrum of this position from Paper I, and a similar enhancem ent was seen in observations of the region by Skillm an (1985). NGC 5471 is known to contain a lum inous supernova remnant at the position of NGC 5471-B (Skillm an 1985; Chu & K ennicutt 1994; Chen et al. 2002), which can enhance the [N II] and [S II] lines. High resolution H and [S II] in ages of NGC 5471 from HST do not show any anom alous structure in NGC 5471-C (Chen et al. 2002), but echelle observations by Chu & K ennicutt (1986) do reveal a region of high-velocity gas located within 0° 3 of the object. These fast-expanding regions often are associated with supernova remnants (e.g., Chu & K ennicutt 1994). A nother possibility is a selective enhancem ent of nitrogen by the presence of W olff-Rayet stars (K obulnicky et al. 1997).

There is some debate over the existence of an N/O gradient within the M ilky W ay disk, with optical measurements giving relatively shallow N/O gradients while infrared studies show steeper gradients (cf. Shaver et al. 1983 vs Lester et al. 1987). It is not clear whether this discrepancy is due to ionization e ects or observational errors (G annett 1990). But the N/O gradient in M 101 is unm istakable (Fig. 8), even without infrared measurements.

It is also instructive to compare the behavior of the N/O abundances in M 101 with expectations from chem ical evolution m odels. In the simple instantaneous chem ical evolution m odel (Pagel 1997), prim ary'elements (i.e., those that are the ultimate product of the original H and He in a star at birth), are expected to vary in lockstep. A 'secondary' element (i.e., one produced from a heavy element seed present in the star at birth), on the other hand, is expected to grow in proportion to the abundance of primary elements. The solid line in the bottom panel of Figure 8 shows a simple m odel which includes a component with constant log (N /O) = {1.5, representing primary nitrogen, and a component for which log (N /O) = log (O /H) + 2.2, representing secondary nitrogen production. This simple representation provides an adequate description of the M 101 data.

For comparison the dashed line in Fig.8 shows a num erical one-zone model for the evolution of N/O vs. O/H from Henry, Edmunds, & Koppen (2000; hereafter HEK 00). The line corresponds to their \best" M odelB, which best reproduces the trend of N/O vs O/H in the data set they compiled

for the study. Supprisingly, this model fails to reproduce our M 101 results; the predicted N/O is too low at intermediate abundance (log O/H = 8.2 to 8.6), and rises too steeply at high abundance. Comparison with their other M odels A and C (with lower and higher star formation e ciencies, respectively) does not alter this conclusion. We suspect that this discrepancy is mainly due to the oxygen abundance scale adopted by HEK00. Their data for spirals consisted largely of H II regions with abundances derived from strong-line calibrations, which yield systematically higher O/H than T_e -based abundance measurements (x5). In contrast, N/O is only modestly a ected by the di erent abundance determination methods, because of its much weaker dependence on electron temperature. The result is that we observe N/O to increase more steeply at intermediate O/H than the HEK00 models. This example illustrates the critical importance of robust abundance measurements of extragalactic H II regions, and of establishing the normalization of the nebular abundance scale, for modeling and understanding the chemical evolution of galaxies.

On the basis of their models, HEK 00 suggested that the secondary component of nitrogen in spiral disks arises mainly from processing of carbon, that is, mainly from CN cycling in intermediate mass stars. On the other hand, our M 101 data suggest that nitrogen enhancement (relative to oxygen) is initiated at much lower metal abundances than in the HEK 00 models. The fact that we can reproduce the trend in N/O with a component that grows proportionately with O/H suggests that secondary nitrogen is produced mainly from oxygen, and in plies that the main source is full CNO cycling in massive stars. A comparison of the variation of nitrogen with carbon and oxygen abundances would be very inform ative in this regard, but this awaits the acquistion of much more data on carbon abundances in galaxies.

4.3. S/O and Ar/O Abundance Ratios

E lem entary nucleosynthesis theory predicts a common primary origin for oxygen, sulfur, and argon in the cores of massive stars, so one would expect much less systematic variation in the S/O and Ar/O abundance ratios. Figure 9 shows the behavior of S/O and Ar/O in M 101 (where Ar/O is derived from Ar/S and S/O, as discussed in x 42). Excluding the lower limit for the outerm ost region (SD H 323), we see no dependence of S/O on absolute abundance. The two most metal-rich regions in our sample do appear to have systematically smaller Ar/O than the bulk of the sample, and it is not clear whether the low values might be the result of observational errors or uncertainties in the ionization correction. The dashed lines in Figure 9 show the average S/O and Ar/O ratios for H II regions in dwarf irregular galaxies (as compiled by Izotov & Thuan 1999). Our results are consistent with the extrapolation of these trends, although our average S/O appears to be slightly smaller (and our average Ar/O slightly larger) than those reported by Izotov & Thuan.

Observations of M 51 by D az et al. (1991) suggest evidence for a lower S/O ratio in very m etal-rich H II regions. We do not see any of a sim ilar decline in S/O in the inner disk of M 101, but our m easurem ents do not extend to as high m etallicities as in M 51. On the other hand, we do see hints of a lower Ar/O at high m etallicity in M 101. It should be noted that if the electron

tem peratures are higher in the M 51 regions than those predicted by the photoionization m odels (x5), then D az et al. (1991) would have derived higher S/O ratios. A decrease in S/O and A r/O in m etal-rich environments would be of considerable interest, as it would indicate some dependence of stellar nucleosynthesis or the stellar initial m ass function with m etallicity.

4.4. Helium Abundances

The large abundance range in our data set allows us to test for a system atic change in the helium abundance with m etallicity. A lthough our data were not taken for this purpose, we have high S=N m easurements of several H e I lines form any of the H II regions, as sum m arized in Table 7. Listed are the H e I line strengths (relative to H), along with the corresponding uncertainties and equivalent widths (EW s). The H e I lines are in uenced by underlying stellar absorption, and this will introduce spurious gradients in the derived H e abundances if corrections for the absorption are not applied. O lofsson (1995) computed equivalent widths of stellar H I and H e I lines for O B star associations; how ever, these calculations do not include H e I from B stars. This is unfortunate since the H e I EW s in stars are a maximum at spectral type B 0. G onzalez-D elgado, Leitherer, & H eckm an (1999) m odel starbursts consistently over a wide range of ages, but provide H e I EW s only for lines bluew and of 5000 A. Self-consistent calculations of H I and H e I EW s for O B associations for the stronger red H e I lines are needed to estim ate corrections for H e abundances in H II regions. This is especially in portant at low m etallicities for the prim ordial H e problem (e.g., O live, Skillm an, & Steigm an 1997; Izotov & Thuan 1999).

W e derived approxim ate connections for $H \in I$ absorption based on direct m easurements of $H \in I$ EW s for stars by C onti & A ltschuler (1971), and C onti (1973, 1974), which provide a comprehensive complation of $H \in EW$ s as a function of spectral type for O stars. G uided by the results of G on zalez-D elgado et al. (1999) for the $H \in I$ 4026 and 4471 lines in 2-3 M yr old starbursts, we assumed a lum inosity-weighted average spectral type of O 7 for our M 101 regions and obtain estimated EW s of 0.5 A for 4026, 0.5 A for 4471, 0.8 A for 5876, and 0.3 A for 6678. In computing H e abundances we used the $H \in I$ em issivities of B enjam in et al. (1999). Correcting our $H \in I$ em ission line strengths for these absorption EW syields m uch better agreement between the $H e^+$ abundances computed from dierent lines. The $H e^+$ abundances computed from each measured $H \in I$ line are listed in Table 8, along with the weighted average for all measured $H \in I$ lines in each H II region. N ote that the $H e^+$ abundances for the outerm ost region SD H 23 dier considerably for the 4471 and 5876 A lines; the 5876 A line is a ected by a cosm ic ray, and so we adopt the value derived from 4471 as the $H e^+$ abundance for this object.

The nal correction in our derivation of He/H is accounting for neutral He, which is not directly observable in the ionized region. As shown in Figure 10 (open circles), the derived He^+/H^+ abundance ratio declines in the metal-rich inner disks of M 101 and other spiral galaxies (also see BKG). This is probably due to the presence of cooler ionizing stars and low ionization in these H II regions (BKG). We estimated ionization correction factors for He using the ionization models of

Stasinska (1990). The He⁺ fraction is roughly correlated with O⁺/O, with the He⁺ fraction close to unity for O⁺/O < 0.2, and He almost entirely neutral for O⁺/O > 0.9. At interm ediate values, however, the He⁺ fraction can vary considerably at xed O⁺/O due to variations in ionization parameter, making the He ICF rather degenerate. This degeneracy can be broken if the ionization parameter can be constrained, for instance using the S⁺/S⁺² ratio. We therefore use our measured values of S⁺/S⁺² and O⁺/O to estimate more accurately the ICFs for He.

The resulting H e abundances are plotted as a function of radius in Figure 10 (solid points), and as a function of 0/H in Figure 11. A though the measurement uncertainties are substantial, the plots show the presence of a signi cant radial gradient in H e/H, after the neutral H e corrections are applied. Only the outermost region (SD H 323) shows much deviation from this gradient, but its measurement is very uncertain due to the lack of a [S III] 9069,9532 measurement for this object. The trend suggests we have likely overestimated the ICF for SD H 323, but this should be con rm ed by observations of [S III].

The solid and dashed curves in Figure 11 show ts by O live et al. (1997) to He abundance measurements in two samples of metal-poor dwarf galaxies (their sets B and C, respectively; see their Table 1 for parameters of the ts). The M 101 He abundances appear to extrapolate the dwarf galaxy trends very well. We can not yet clearly di erentiate between the two ts, although our abundances appear to be more consistent with the shallower dependence on O/H.A larger set of precise He line measurements for metal-rich regions would provide better limits on the slope of the He/O relation, which is an important constraint on stellar nucleosynthesis and the e ects of stellar mass beson yields (M aeder 1992), as well as on the prim ordial He abundance.

5. Comparison with Empirical A bundance Scales

A s discussed in x1, abundance estim ates based on strong-line \empirical" m ethods have largely supplanted direct, T_e -based determ inations for large-scale abundance surveys and cosm ological lookback studies. W ith the large dynam ic range in O /H in our data set, it is instructive to com pare our direct abundances with those derived for the sam e H II regions using the m ost popular strong-line calibrations. In order to enlarge the comparison we have also included recent high-quality direct abundance m easurem ents of H II regions in other galaxies from the literature (G armett et al. 1997, van Zee et al. 1998; D eharveng et al. 2000; D az & Perez-M ontero 2000; C astellanos et al. 2002).

Figure 12 shows the well-known plot of oxygen abundance against the empirical abundance index R_{23} (Pagelet al. 1979), where:

H II regions from this paper are plotted with solid points, while objects from the other papers

cited above are indicated with open squares. The superimposed lines show examples of widelyused calibrations for R_{23} , as taken from the references indicated in each panel. These particular examples were selected to illustrate the range of R_{23} calibrations in the literature. The R_{23} index shows the well-known double-valued behavior, with oxygen line strength increasing monotonically with abundance at low metallicities, and decreasing at high metallicities, the latter rejude the dominance of oxygen cooling over abundance in metal-rich regions. Since most of the H II regions observed in spiral galaxies have metallicities that place them on the \upper" branch of this diagram, we will restrict the discussion in this paper to that part of the strong-line calibration, roughly corresponding to $12 + \log (0 = H) = 8:0$.

A lthough the measured H II region abundances trace a locus which is roughly consistent in shape with most of the empirical calibrations, there is a pronounced o set in abundance in most cases, as has been pointed out previously (see Stasinska 2002 and references therein). In all cases the empirical calibrations yield oxygen abundances that are system atically higher than the T_e -based abundances, by am ounts ranging from 0.1 to 0.5 dex, depending on the calibration and the excitation range considered. The calibrations of Pilyugin (2000, 2001a) shown in the lower right panel of Figure 12 show a smaller o set, mainly because those calibrations are partly based on T_e -based abundances.

Sim ilar discrepancies are seen in most of the other \empirical" abundance indices, as is illustrated in Figure 13. Here we directly compare the T_e -based abundances with those derived from several di erent empirical indices, all calibrated with a common grid of photoionization models (Kew ley & Dopita 2002), so the di erent indices can be evaluated on the same basis. The symbols are the same as in Figure 12. A snoted earlier, there is a system atic shift toward larger abundances in the empirical calibrations, ranging from 0.2 to 0.5 dex on average.

The discrepancies shown in Figures 12 and 13 can be traced to two main origins, an insu cient number of calibrating H II regions with accurate T_e -based abundances in the earliest calibrations, and a system atic o set between the nebular electron temperatures in the calibrating photoionization m odels and the observed forbidden-line temperatures, for a given strong-line spectrum (e.g., Stasinska 2000). Because of the exponential temperature dependence on the strengths of these collisionally-excited forbidden lines (/ exp =kT), an o set in T_e will have the strongest e ect on the shorter wavelength features at a given abundance. The better consistency of S_{23} in Figure 13 can be attributed in part to the relatively low excitation of the [S III] 9069,9532 lines that dom - inate this index; note that at higher abundances, where the characteristic electron temperatures are very low, even this index deviates signi cantly from the direct abundance determ inations.

Figure 14 shows a comparison of direct abundances with empirical values derived using the P m ethod" of Pilyugin (2001a). At interm ediate abundances (12 + log (0 /H) ' 8.5) the two abundance scales are in approximate agreement, in part because the m ethod is calibrated with direct abundance m easurements in this region. However the P m ethod results break down for 12 + log (0 /H) 8.4. As can be seen in Figure 12, these regions fall into the abundance range where

m ost of the empirical indicators become multiple-valued or very sensitive to nebular ionization parameter. M ost authors are aware of these limitations and restrict the application of the various empirical tracers to the abundance range for which they are valid (see Pilyugin 2001a; K ew ley & D opita 2002 for detailed discussions). However the comparison in Figure 14 illustrates a pitfall in this approach. The P method as calibrated is supposedly only valid for $12 + \log (O/H) = 8.2$ (Pilyugin 2001a), but in the absence of electron temperature measurements when does one know for sure that an H II region falls within the applicable abundance range? If the empirical abundances overestim ate the actual abundances by a signi cant factor, they may be applied in regions for which the calibration is invalid.

6. DISCUSSION

The results in the previous section m ay have signi cant consequences for the nebular abundance scale as a whole. If the forbidden-line abundances are correct, it implies that most studies of galactic abundances (locally and at high redshift) based on \empirical" nebular calibrations have over-estim ated the true absolute oxygen abundances by factors of $1.5\{3, \text{ for } 12 + \log (0 = H) > 8.2$ (about 1/3 Z/Z). Our results do not apply to the low-m etallicity part of the abundance scale, so another net e ect of this change would be to reduce the total range of nebular abundances observed in galaxies. This m ay have signi cant e ects on the m easured abundance gradient slopes in som e galaxies, and on applications such as the m etallicity dependence of the Cepheid period-lum inosity relation (e.g., K ennicutt et al. 1998).

It is not completely clear whether the discrepancies in Figures 12 and 13 are the result of a system atic error in the T_e -based abundances, the model-based \empirical" abundances, or both. There are well-docum ented reasons for questioning the accuracy of both abundance scales (also see Peim bert 2002, Stasinska 2002, and references therein).

It has been argued form any years that directly m easured electron tem peratures and the corresponding abundances from collisionally-excited lines m ay have system atic errors due to tem perature uctuations (Peimbert 1967). Because of the exponential tem perature dependences of forbidden line em issivities, their uxes will tend to be weighted tow and regions of higher tem perature, and in the presence of signi cant T_e uctuations they will yield anom alously high T_e m easurem ents, and thus low abundances. The in portance of this e ect on the nebular abundance scale depends on the magnitude of the actual tem perature uctuations in extragalactic H II regions. O bærvational evidence for signi cant T_e uctuations has been contradictory. Early com parisons of T [D III] in the O rion nebula with the tem perature derived from the Balm er continuum [T (B a_c)] revealed a large discrepancy, but this has not been con rm ed by subsequent m easurem ents with in proved detectors (Lin et al. 1995a). Signi cant di erences between T [D III] and T (B a_c) are observed in planetary nebulae (Lin et al. 2001), but it is not clear whether the two tem peratures should be the sam e, given tem perature strati cation in ionized nebulae (Stasinska 1978; G amett 1992). D irect searches for sm all-scale tem perature uctuations using high resolution H ST im aging of planetary nebulae have yet to reveal any signi cant variations (Rubin et al. 2002).

M easurements of recombination lines of heavy elements (O II, C II, N II) provide an independent means of measuring nebular abundances, and they tend to yield higher values than the corresponding forbidden lines, by a factor that varies considerably (Liu et al. 1995b, 2001; G arnett & D inerstein 2002). Recently E steban et al. (2002) reported measurements of the O II recombination lines in the M 101 H II regions NGC 5461 (H 1105) and NGC 5471. These yielded O^{+2}/H abundances that are 0.34 dex and 0.15 dex higher than our forbidden-line abundances, respectively, and this is consistent with the trends observed in other H II regions and planetary nebulae. How - ever in m any objects the abundance discrepancies are so large that they can not be explained by temperature uctuations. The real explanation is not yet clear; Liu et al. (2001) postulate the presence of cold, dense, H-poor knots which produce m ost of the enhanced recom bination line em ission, while G arnett & D inerstein (2002) note that dielectronic recom bination m ay play a signi cant role.

A third concern is relevant to metal-rich H II regions. At high abundances, strong cooling by infrared ne-structure lines of [> III] and [> III] greatly depresses the electron temperature in the high-ionization zone of H II regions relative to the lower-ionization zones, leading to a strong temperature gradient (Stasinska 1978). Under these conditions, the measured electron temperature can be higher than the ion-weighted mean temperature for a given species, and the optical forbidden lines can be weighted tow and the higher temperature zones, leading one to underestim ate the true abundances. The temperature gradient m in ics the e ects of temperature of up to 2000 K (see F ig. 6b in G amett 1992). The results are sensitive to ionization parameter (which a ects the am ount of 0⁺², and density (which a ects the cooling rate in the infrared lines through collisional quenching).

D espite these concerns, how ever, there are good reasons to believe that the forbidden lines give close to the correct abundances, at least for the range of O/H of interest here. Recent measurements of infrared forbidden lines (which have weak temperature dependences) in the spectra of planetary nebulae yield abundances that are in good agreement with those from optical forbidden lines, even where there is a large discrepancy with recombination line abundances (Liu et al. 2000, 2001). Likewise, measurements of radio recombination line temperatures of G alactic H II regions give results that are consistent with forbidden line measurements of the same objects (Shaver et al. 1983; D eharveng et al. 2000).

A dditional support for the reliability of the forbidden-line abundance scale comes from independent measurements of the local interstellar O/H from G alactic H II regions and ultraviolet absorption line measurements of the di use ISM . A recent determination of the G alactic abundance gradient by D eharveng et al. (2000), based on [D III] 4363 measurements for 6 H II regions with $R_G = 6.6$ 14.8 kpc, yields a local oxygen abundance 12 + log (O/H) = 8.48. This value is in excellent agreement with local di use abundances of 8.50 0.02, 8.48 0.03, and 8.54 0.01 derived from HST and FUSE spectroscopy of multiple local sightlines (M eyer, Jura, & C ardelli 1998; M oos et al. 2002). These values are also in reasonable accord with the solar abundance (8.7), assuming m odest grain depletion factors.

If the discrepancies in F igures 12{13 are due to errors in the m odel-derived \empirical" abundances, then what m ight be the cause? The typical H II region m odel is spherically sym m etric, w ith a uniform density of 100 (or 10) cm⁻³ and a central point ionizing source. In reality, the density distribution in m any giant H II regions is dom inated by lam entary, shell-like structures, often w ith dispersed, multiple ionizing sources w ithin the boundaries of the ionized gas (e.g., K ennicutt 1984). In m oderate to high-abundance H II regions the cooling is dom inated by a few ions such as O^{++} , and this introduces a physical coupling between the therm al and ionization structures, which in turn can be in uenced by the detailed distributions of gas and ionizing sources.

Unfortunately there are relatively few direct m easurements of the electron density distributions, or even the characteristic densities in these regions. Density measurements from the [S II] 6717,6731 line ratios generally lie at the low density limit, indicating N_e < 200 cm⁻³. Corroborating density measurements from other diagnostic ratios such as [D II] 3726,3729 are rare. A courate know ledge of the gas densities are particular in portant form etal-rich regions, because of the dramatic e ect of collisional quenching on ne-structure cooling and the therm al structure of the nebulae (O ey & Kennicutt 1993).

The geometry of the ionizing sources within this complex structure may also in uence the emergent spectra. The ionizing star clusters in some regions are centrally concentrated (e.g., 30 D oradus in the LMC, NGC 5461 in M 101), but in others (e.g., NGC 604 in M 33, I Zw 18), the ionizing stars are loosely distributed. Even in the 30 D oradus nebula, O 3 stars are known to be located among the ionized laments (W albom 1991, B osch et al. 1999). Since the ionization param – eter depends in part on the distance of the ionizing source from the gas, an extended distribution of stars might be expected to a ect the resulting nebular spectrum. D ust also a ects the ionized gas, depleting Lym an-continuum photons, and by photoelectric heating and recombination cooling of the gas.

Finally, uncertainties in the input ionizing continua may play a role. A lthough the situation is improving here, with increasing use of non-LTE, spherical calculations which include realistic opacities and stellar winds, models for Lym an-continuum uxes are still in the development stage. A s shown by BKG and B resolin & K ennicutt (2002), the improper treatment of the stellar ionizing ux, especially during the W olffR ayet phase, can lead to large discrepancies between observed H II spectra and those predicted by photoionization models based on synthetic spectral energy distributions. This situation is improving, thanks to advances in the codes describing massive star atm ospheres. Recent stellar models (M artins, Schaerer, & Hillier 2002; Herrero, Puls, & Najarro 2002) show that the inclusion of mass loss and more realistic stellar opacities has an important e ect on the elective temperature scale for O stars. Evolutionary models based on these new stellar atm ospheres by Sm ith, Norris, & C row ther (2002) appear to be in good agreement with the ionization properties of extragalactic H II regions. Further study should determ ine if the directly m easured and predicted H II region sequences are consistent.

In sum m ary, we cannot be certain whether the discrepancies in abundance scales sum m arized in F igures 12{13 are due to biases in the T_e -based results, or problem s in the theoretical models that are used to calibrate m ost of the strong-line \empirical" abundance scales. H igh-quality far-infrared m easurem ents of a sample of extragalactic H II regions, including som e of the principal ne-structure cooling lines, m ay help to resolve these inconsistencies. In the meantime it is important for users of the various abundance calibration methods to be aware of this discrepancy, and until it is resolved users should beware of combining strong-line abundance estimates with direct abundance m easurem ents.

An accurate extragalactic m etallicity scale is fundam ental for constraining m odels of chem ical enrichment, the chemical evolution of galaxies, and the cosmic baryon cycle. In this context it is sobering to recognize that there is a system atic uncertainty of a factor 2{3 in the zeropoints of one or more of the metal abundance calibrations. A few specic observational and theoretical investigations would go far toward resolving this problem . High signal/noise spectroscopy and electron tem perature m easurem ents for other extragalactic H II regions, especially m etal-rich ob jects, would nail down the T_e -based abundance scale across the full 0 /H range, and help to quantify the disagreem ent between observations and ionization models across the full spectrum of abundances, densities, and ionization properties. Measurements of multiple auroral lines in the same objects (e.g., Fig. 1) would be especially valuable for reducing system atic errors in the T_e-based abundances, testing the reliability of speci c nebular therm on eters, and com paring with the predictions of the nebular models. Independent tem perature and abundance measurements for H II regions, and extension of the wavelength coverage to the mid-and far-infrared emission lines would also help. And com parisons with young stellar abundances will provide independent constraints on the metallicity zeropoints (e.g., Venn et al. 2000; Trundle et al. 2002). On the theoretical side, explorations of the e ects of nebular geometry, structure, and ionizing spectrum on the thermal structure of H II regions would be useful, along with targeted studies of speci c transitions such as the [0 II] therm on eter (x3.1). Solving the abundance zeropoint problem is in portant not only for the observations of m etallicities of galaxies, but also for validating our theoretical m odeling and understanding of photoionized regions in galaxies.
