Light curve solutions for bright detached eclipsing binaries in SM C : absolute dim ensions and distance indicators

ABSTRACT

This paper presents a careful and detailed light curve analysis of bright detached eclipsing binaries (DEB) in the Sm all M agellanic C loud, discovered by OGLE collaboration, on the basis of recently available di erence in age analysis (DIA) photom etry. The 19 binaries brighter than 16.4 m ag in I band and with the depth of prim ary and secondary eclipse greater than 0.25 m ag were investigated. The solutions were obtained by a m odi ed version of the W ilson-D evinney program. The quality of DIA light curves { a good phase coverage and relatively sm all scatter { is enough to calculate realistic estim ates for the third light l_3 and the argument of periastron ! ... It was found that solutions of detached, eccentric system s with at light curve between eclipses usually m ay su er from indeterm ination of l_3 in contrast to those of sim ilar system s having som e proxim ity e ects.

The physical properties of the stars were estimated on the basis of their photom etric elements and indices assuming the distance modulus to SMC 18:9 and consistency between an empirical mass-luminosity relation and the ux scaling. The method was tested on three LMC stars of known absolute dimensions and a good agreement was found form M 18:5. Such an approach may give fast and accurate estimates of absolute dimensions for large and hom ogeneous samples of eclipsing binaries in the M agellanic C buds and other close galaxies. Moreover, this method allows also for independent estimation of E (B V) in the direction to a particular binary. The subset of six bright DEB's worth future intensive investigations as likely distance indicators to SMC, was chosen. They are SC 3 139376, SC 4 53898, SC 5 129441, SC 6 67221, SC 6 215965 and SC 9 175336.

1 IN TRODUCTION

A courate determ ination of absolute dim ensions of eclipsing binaries based, am ong others, on detailed light curve analysis is still a very important task of modern astronomy. It gives an opportunity for testing advanced evolutionary m odels of stars (e.g. Pols et al. 1997) but also allow s for very precise distance determ ination. The method, at least in principle, is quite straightforward (see Paczynski 1997 for an outline and C lausen 2000 for a review). Three distance determ ination for eclipsing binaries in the Large M agellanic C loud were quite recently presented: HV 2274 (Guinan et al. 1998), HV 982 (Fitzpatrick et al. 2001) and EROS 1044 (Ribas et al. 2002) giving the distance modulus m M 18:4. Light curve solutions together with estim ation of physical param eters and the distance to the Sm all M agellanic C loud were obtained also for two eclipsing binaries: HV 2226 (Bell et

al.1991) and HV 1620 (P ritchard et al.1998) giving for the distance modulus m M 18:6. Very recently ten eclipsing binaries have been analysed in the central part of the SM C giving mean distance modulus m M = 18:9 0:1 (H arries, H ilditch & H ow arth 2003). The light curve analysis in their paper was based on D oPHOT OGLE photom etry (U dalski et al.1998).

In recent years, extensive CCD photom etry have been undertaken during the projects of microlensing searching toward the Magellanic C louds and Galactic Bulge. As a byproduct, thousands of eclipsing binaries were discovered and placed in catalogs (Grison et al. 1995, Alcock et al. 1997, Udalski et al. 1998). Prelim inary solutions for MACHO LMC catalog were found by Alcock et al. (1997). They tted 611 light curves of eclipsing binaries using the EBOP code (Etzel 1993). That code uses a tri-axial ellipsoid approximation what makes this code very fast. But the code cannot properly account for the proximity e ects present in most of the eclipsing binaries detected by MACHO.For SMC eclipsing binaries OGLE collaboration (U dalskiet al. 1998) extracted from their catalog a sample of 153 detached binaries with well de ned, narrow eclipses of similar depth and relatively good photom etry. It was argued that the sample contains the best systems for distance determ ination. W yithe & W ilson (2001, 2002 { hereafter W W 1, W W 2) presented an excellent analysis of the whole OGLE data containing 1459 eclipsing binaries using an autom ated version of the W ilson-Devinney (1971, W ilson 1992) code. This program can provide very detailed treatment of proximity e ects. They used public domain DOPHOT photom etry available at OGLE hom epage http://sirius.astrouw.edu.pl/ogle/ogle2/var stars/sm c/ecl in the analysis. They extracted in an objective way two subsets of detached binaries with very narrow eclipses and complete eclipses as the most likely good distance indicators. Subset of sem i-detached eclipsing binaries was also chosen as distance indicators on the basis of similar surface brightness between components and complete eclipses. The authors intend, also, to extract such subsets for contact binaries. In general it is believed that the close-to-ideal system chosen as a distance indicator, should have two stars of sim ilar tem perature and lum inosity and the separation of the components should be signi cantly larger than their radii. But well-detached, eccentric system s m ay su er from the aliasing of photom etric solutions.W W 2 argued that sem i-detached and contact binaries, and also detached eclipsing binaries showing larger proximity e ects, have their photom etric solutions better de ned and may serve as potential best distance indicators as in the case of recently analyzed 15-th magnitude binary EROS 1044 (Ribas et al. 2002). In this paper I focused my attention only on detached eclipsing binaries.

The release of new D IA photom etry by OGLE collaboration motivated me to reanalyse the light curves of eclipsing binaries in SMC for the purpose of extracting a sam ple of the best distance indicators. This sam ple was chosen using additional in portant criteria which were not used in the selections made by W yithe & W ilson. The analysis was restricted only for bright system s. It is obvious that those system s have, in general, the largest probability of obtaining high-quality light curves and radial velocity curves. Thus the searching for distance indicators should start from the analysis of the brightest candidates. Moreover using D IA photom etry we can achieve more realistic determ ination of the light curve param eters than in the case of using the older D oP HOT photom etry.

2 THE DATA

2.1 Photom etry

CCD di erential photom etric observations of SMC eclipsing binaries were obtained by OGLE between 1997 and 2000. The data were acquired using 1.3 m W arsaw Telescope at Las Campanas Observatory. The photom etric I indices were calculated using the technique of di erence im age analysis (DIA) as was reported in Zebrun, Soszynski & W ozniak (2001a). The new photom etry was quite recently facilitated on OGLE hom epage http://sirius.astrouw.edu.pl/ogle/ogle2/dia (Zebrun et




Figure 1. The light curves of SM C SC1 25589 eclipsing binary based on OGLE DoPHOT photom etry (upper panel) and OGLE DIA photom etry (lower panel).P relim in ary solutions were m arked by solid lines.

al. 2001b). The OGLE database contains all variables detected in the LMC and SMC (68 thousand) during the course of the OGLE-II project. The DIA is argued as a superior m ethod over classicalD oPHOT m ethod because of its better accuracy, especially in crowded elds (Zebrun et al. 2001a). The light curves based on OGLE-DIA photom etry are characterized by considerably sm aller scatter of observations and higher sm oothness of the light curves. A lso, in m ost cases the phase coverage is better because the DIA photom etry includes OGLE observations which have extended alm ost two years after the m om ent when original catalog of SMC eclipsing binaries (U dalski et al. 1998) was published.

The quality of OGLE-DIA photom etry can be dem onstrated by a comparison of the I light curves obtained with both m ethods. As an example I present a 17-th m agnitude eccentric eclipsing binary SM C SC1 25589 { Fig.1 { together with prelim inary light curve solutions. Note that according to the analysis of DIA light curve the system has apparently total eclipses and much larger separation between components than in the case of the analysis of D oPHOT data.

The candidates for the analysis were chosen after the visual inspection of the light curves of eclipsing binaries in SMC released by Udalski et al. (1998). A preliminary set of about 25 binaries were selected brighter than I = 16.4 m ag at maximum brightness and with the depth of the primary and secondary eclipses greater than 0.25 m ag. The candidates fall into three separate groups. The rst group,





Figure 2. The light curves of SM C SC 6 67221: from Udalski et al. (1998) (upper panel) and from the analysis of OG LE-D IA photom etry in this paper (low er panel).

hereafter called A, consist of well-detached, eccentric system s with, usually, deep narrow eclipses. The second group, hereafter called B, com prise the short-period system s with apparently circular orbits and the sm all separation between components. As a result, the system s from group B show quite large proximity e ects in their light curves. The third group C comprises well separated long period system s with circular orbits. As we expect long period system s to be, in general, eccentric this is m ost probably a chance selection.

A flerwards, the photom etric data for each selected star were extracted, using the coordinates as identi er. Som e stars were not found in OGLE-DIA database because they probably passed undetected through the variability checking lters (I. Soszynski 2002, private communication). The Table 1 gives the names and identication of 19 selected systems together with a summary of photom etric parameters.

2.2 Initial data preparation

The observations were folded with trialperiods following the m ethod given by K aluzny et al. (1998). The searches were usually restricted to a period close to the period given by U dalskiet al. (1998). The nalperiod was found by tuning to the shape of the m inim a. It was found that in m ost cases the resulting periods agreed very well with those given by U dalskiet al. (1998). However, for SC 6 67221, I have found a new period resulting from observations of both eclipses. This binary turned out to be a very eccentric system with the orbital period of 10.977 days. The period is close to a whole num ber of 11 days and this is the reason for spurious secondary eclipse detection in the original O G LE catalog. Fig. 2 presents the light curve based on the proper period

and, for com parison, the light curve from the original OGLE catalog.

Two eccentric binaries SC 3 139376 and SC 5 311566 show small changes in the light curve most probably due to the apsidal motion. In both cases the tuning to the shape of the primary and the secondary minimum gives signicantly di erent periods { see as an example SC 5 311566 (Fig.3). Sm ooth light curves were obtained assuming that the change of the shape of minima is small and the secondary minimum was progressively shifting in respect to the primary minimum during the period of observations. The linear correction was applied to all phases corresponding to the secondary eclipse (phases: 0.35-0.55 for SC 3 139376 and 0.4-0.6 for SC 5 311566) in the form :

i-th observation.D enoting the period resulting from the tuning to the prim ary eclipse by $P_{\rm p}$ and to the secondary one by $P_{\rm s}$, the factor was calculated by form ula: = $(P_{\rm p} \ P_{\rm s})=P_{\rm p}$ and was 7.5 10^5 and 7.0 10^5 for SC 3 139376 and SC 5 311566, respectively.

The old reference epochs T_o given by U dalski et al. (1998) were used to fold up the observations. New reference epochs were determ ined later during the light curve analysis { see x 3.1. For each star I calculated out-of-eclipse I m agnitude at them axim um of the brightness. The D IA data does not include the B and V photom etry. For the purpose of obtaining them ost accurate B V and V I colours I recal-culated the out-of-eclipse B, V and I m agnitudes using the old D oP H O T photom etry. Note, that the m agnitudes which I have found refer to the m ean m agnitudes at the m axim um brightness rather than to the m axim alm agnitudes given in the original O G LE catalog. Resulting out-of-eclipse I m agnitudes were then used to norm alize the light curves.


In two cases (SC 6 11143 and SC 9 163575) the light curve shows considerable am ount of scatter, much larger than the average error of the observations. The light curves of both system s are presented on Fig. 4 (upper panel). I have rem oved observational points when the eclipses occurred and rerun the period nding program to nd som e periodicity in the scatter. It turns out that in the case of SC 6 11143 the out-of-eclipse observations assemble with the period of 2.618 days and form a light curve with two well-de ned, narrow minim a of di erent depth (middle panel of Fig. 4). It is likely that the binary SC 6 11143 blends with another short period and slightly eccentric eclipsing binary. The sim ilar analy-

sis done for the system SC 9 163575 shows that the out-ofeclipse observations assemble with the period of 1.985 days and form two minim a separated by a half of the period. It seems that the system SC 9 163575 blends also with a short period eclipsing binary. Their periods are very close to each other and in the original light curve the points, corresponding to the minim a of the blend, form two clumps situated around the m in in a of SC 9 163575. The light curves of both system swere cleaned by removing from the light curve all points corresponding to the mom ents when the eclipses occurred in the blended binary. The resulting light curves are presented in the lower panel of Fig. 4. A lso the system SC 5 38089 in spite of its relatively high brightness ($I_{m ax} = 15.26$) has quite large scatter of observations. The analysis done for this system shows that the changes of the brightness are random ly distributed and thus, it is likely that the reason of the scatter is some kind of an intrinsic variability.

3 LIGHT CURVE ANALYSIS

3.1 M ethod

All ts to the light curves were obtained using a modied version of the W ilson-Devinney(1971, W ilson 1979, 1992, hereafter W D) program with a model atmosphere procedure based on the ATLAS9 code and developed by M ilone, Stagg & Kurucz (1992). An autom ated iterations scheme of W D program was employed. For A subset a detached conguration (mode 2) was chosen for all solutions and simple re ection treatment was used (MREF=1, NREF=1). In the

case of B subset both detached and sem i-detached (m ode 5) con gurations were used to obtain solutions. For B and C subsets the detailed re ection treatment with a double reection was taken into account (M REF=2, NREF=2). For all stars $\log g = 4.0$ was xed except for stars from C subset for which $\log g = 2.0$ was assumed.

I have found the initial guess via trial-and-error tting of the light curves. The convergence is de ned to have been achieved if the parameters corrections given by W D program are smaller than 0.75 times the standard errors (1.0 in the case of eccentricity and argument of periastron) on two consecutive iterations. The adjusted parameters were the surface potentials ($_1$; $_2$), the elective temperature of the secondary (T₂), the luminosity of the primary (L₁), orbital inclination (i) and the zero epoch o set (). For A subset I have adjusted two more parameters: eccentricity (e) and the argument of periastron (!_o).

If for an eccentric system the convergence was not

vided the correction were smaller than the standard error for these parameters on three consecutive iterations. It turned out that such procedure allowed for better convergence and the solution was achieved in all cases. A flerwards I have run additional iterations, allow ing all parameters to vary, to nd error estimates of the nal solution. Similar procedure was employed for the systems from B and C subsets, just xing the circular orbit and the suppressing included only the zero phase o set. A mong the system s in B subset the third light (13) adjustment was needed to get the convergence in most cases. For all system s correction T o to the epoch given by U dalskiet al. (1998) was applied in the form : T $_{\circ}$ = Ρ, where is the zero epoch o set of the nal solution and P is the period of the system .

W W 1 introduced a quantity F_e which is greater than unity for system s with complete eclipses:

where r_g is the fractional the radius of larger star and r_s is the fractional radius of the smaller star, both expressed in units of sem im a jor axis A .F_e is valid, in the form presented above, for circular orbits or perpendicular orbits (i= 90) and also for eccentric orbits provided the fractional radii of components are expressed in units of the distance between stars at the moment of the mid-eclipse. In general case of eccentric orbits, if one eclipse occurs in the neighbourhood of periastron and is complete, the other may be partial and in the extrem e cases, there may be an eclipse near periastron and none near apastron. The instantaneous distance between components d, in units of sem im a jor axis A, is given by the equation:

where is the true anom aly. The prim ary and secondary m inim a occur when the true anom alies $_1$ and $_2$ are (neglecting higher powers of e, see K opal1959, C hapter 6, equation (9-22)):

respectively.Substituting $_1$ and $_2$ into Eq.3 the distances were calculated at the moments of both mid-eclipses.Then appropriate quantities F_e^1 and F_e^2 referring to the primary and the secondary eclipse, respectively, were computed.

Sem idetached con guration (m ode 5) were investigated for all stars from the B subset in order to check which system s are de nitively separated. W hen the sem idetached con-

guration was investigated the mass ratio (q) of the components was adjusted and secondary surface potential $(_2)$ was set by q. However, it turned out that no solution could be found in this mode for any star from B subset in spite of many tests for di erent sets of adjustable parameters. A c-cordingly, in subsequent part of the paper I will refer only to detached solutions found in mode 2.

3.2 Param eter choice

In the analysis presented here I have included the temperature of binary's components resulting from an intrinsic colour (B V)_o of the system .All (B V) colours from Table 1 were dereddened using the average reddening toward SMCE (B V) = 0.087 (M assey et al. 1995, U dalski2000). I set the temperature of the prim ary (T₁) respectively to the (B V)_o colour of the system using F lower's (1996) empirical calibration.A lm ost all the selected binaries have m inim a of sim ilar depth what indicates that the di erence between the temperatures of the components is small. Thus such a procedure is justi able. For those stars for which (B V)_o colour suggested a very high temperature (410^4 K for SC 5 38089, SC 6 215965, SC 9 163575, SC 9 175336) I set up T₁ = 35000 K.

I used a logarithm ic law for the lim b darkening (e.g. van H am m e 1993). The I lim b darkenings $x_{1,2}$; $y_{1,2}$ and bolom etric lim b darkenings $x_{1,2}^{bol}$; $y_{1,2}^{bol}$ were calculated from van H am m e's (1993) tables of lim b darkenings for appropriate log g and T. D uring the iterations the secondary's lim b dark-

ening coe cients were calculated according to its tem perature T_2 . The bolom etric albedo and gravity brightening exponent were set to the canonical value of 1.0 for stars with radiative envelopes (von Zeipel1924). However, for two red long-period system s SC 4 192903 and SC 8 201484 values typical for convective envelopes were assumed { bolom etric albedo was set to 0.5 and gravity brightening exponent to 0.32. The synchronous rotation of both com ponents was assumed ($F_1 = F_2 = 1$). No level depending weighting of observations was applied { parameter NO ISE was set to 0.

The mass ratio was assumed to be $q = m_2 = m_1 = 1$ in all calculations. W W 2 pointed out that in the case of detached eclipsing binary the light curve is almost insensitive to the mass ratio parameter. Only if one of the components is highly evolved (when its radius R increase to about a half of the total separation A) or if the system has a very low mass ratio, the light curve becomes sensitive for this parameter. The preliminary tests show that no component from the set of binaries has fractional radius $r_1 = R_1 = a$ larger than 0.4. However, for two systems from B subset it was necessary to adjust the mass ratio in order to get a good solution (see x3.4).

3.3 Solutions for A subset

For each system from A group the autom ated tting scheme described in x3.1 was employed. Only in three cases: SC 6 67221, SC 6 221543 and SC 6 272453 was the convergence achieved by adjusting simultaneously all free parameters. The Figure 5 shows the best-tting model light curves, together with O C residuals, whose photom etric parameters are given in Table 2. All arguments of the periastron refer to the epoch 1999.0.

For all systems from the A subset reasonable solutions were found assuming $l_3 = 0$. However, in the case of SC 6 11143 and SC 9 163575 we expect that some amount of the third light is present in the system because of the blending with another eclipsing variable. In order to estimate third light component an additional grid of solutions for dierent values of l_3 was calculated in the range of 0.05–0.40 with a step of 0.05. For SC 6 11143 the best solution was found at $l_3 = 0.30$, while for SC 9 163575 { at $l_3 = 0.10$. It is worth noting that the solutions found with $l_3 = 0$ for these system s have alm ost no system atic trends in 0 –C 's residuals, thus the intrinsic variability of the blend is the only sign of the third light component.

The solutions for SC 6 67221 converged very rapidly and had the sm allest residuals. Only slight system atic residuals are visible near phase 0.04 (just after the egress from primary minimum), most probably due to the strong mutual re ection e ect. Sim ilar but even stronger system atic e ect is visible near rst quadrature (0:11) in SC 5 129441.Because of the presence of the proxim ity e ects both system s were additionally investigated in order to estim ate possibly the third light contribution by adjusting l₃ as a free param eter. In each case synthetic light curves produce a tiny in provem ent only for unphysical values $l_3 < 0$, but such solutions were invariably unstable. The conclusion is that these binaries show virtually insigni cant third light contribution what is consistent with $l_3 = 0$. For a brief discussion of both system s see x 5.1.2.

Sm all residuals and relatively quick convergence charac-

terize also SC 3 139376 and SC 9 163575, whereas, the largest residuals are visible in SC 5 221543 mostly due to a big in-trinsic scatter in observations.

Having calculated e and ! we could estimate the rate of apsidalmotion for two binaries from the sample. The change of displacement of minima of an eccentric binary with central eclipses (i=90) is given by (see e.g. Kopal 1959, Chapter 6, equations (9-8), (9-9)):

However for our purpose we can still use this form ula also for inclination close to 90 provided the timescale of a displacement change is small with respect to an apsidal period U. The change of displacement per one orbital revolution (P) is simply (Eq.1) so the rate of advance of periastron is approximated by:

Substituting num erical values we get 5:8/yr and 1:8/yr for SC 3 139376 and SC 5 311566, respectively.

3.4 Solutions for B and C subsets






Figure 7. The light curves solutions and their residuals for the system s from the C subset.

The photom etric parameters for the stars from B and C subsets are presented in Table 2. Appropriate light curve solutions are shown in Figs. 6 and 7. In contrast to the A subset, almost all solutions from B subset (beside SC 6 215956) were found only by adjusting the third light l_3 in the system. There is a simple explanation of this e ect – see a discussion in section 6.1. SC 6 215956 was also investigated for possible third light contribution but values of

 l_3 suggested by W D program were invariably negative. SC 6 215965 has very sm all residuals and the solution for this system converged rapidly. A lso it seem ed to be most stable of all in B subset.


The solution for SC 5 38089 was obtained using the spectroscopic mass ratio q = 1:12 and more appropriate tem – peratures ($T_{1,2}$ 29000 K) determined for this binary by H arries et al. (2003). Third light contribution in this system is spurious although some improvements to the ts can be obtained for $l_3 > 0.2$.


In spite of the small residuals in SC9 175336 its solution was extremely unstable and exhibited large system atic 0 C deviations, especially near external contacts. The tests showed that the reason was the sensitivity of the light curve to the mass ratio q as the larger and cooler com ponent seem ed to be noticeably more evolved than the hotter one. The same problems arose for SC4 53898 which seems to be similar in many respects to the former, although its light curve is less sensitive for q. Both systems show complete eclipses which allow for more accurate determ ination of photom etric param eters including the photom etric m ass ratio. Thus I allowed for adjusting of q for both systems in detached con guration. The convergence was achieved and a stable solution obtained: in the case of SC 9 175336 for q = 1:15 0:05 and in the case of SC 4 53898 for q = 1:36 0:12.

The solutions for two systems from C subset converged very rapidly. No third light l_3 was adjusted in both cases because of the lack of any system atic residuals in the solutions (Fig. 7). M oreover the solution for SC 8 201484 has the sm allest residuals from all of the subsets.



F igure 5. The light curves solutions and their residuals for the system s from the A subset.

4 PHYSICAL PARAM ETERS

We cannot directly calculate absolute dimensions and m asses without knowing spectroscopic orbit. However it is possible to estim ate stellar parameters using the inversion of the method of parallaxes of eclipsing binaries. The method of parallaxes was elaborated by D worak (1974) who based it on G aposchkin (1938) algorithm. We assume that we know distance to SM C and we use it to calculate absolute dimensions by scaling the system to obtain the observed ux at Earth. The calculations are quite straightforward. For early B or O type stars the Rayleigh-Jeans approximation may be used in visible and near-infrared region of the spectrum so total V or I luminosity of each star is a linear function of tem perature $L_{1,2}$ $T_{1,2}$. U sing this approximation we can disentangle the tem peratures T_1 and T_2 of both components:

where $L_{21}^{I} = L_{2}^{I} = L_{1}^{I} = l_{2} = l_{1}$ is the lum inosity ratio of the components known from the light curve solution (Table 2) and $T_{\rm 0}\,$ is the "mean" temperature corresponding to the total (B V)0 colour of the system . The temperature T_2 is then directly calculated from the temperature ratio. Initially (B V), was found for each binary assum ing total, foreground and internal, mean reddening to SM C E (B V) = 0.087 (M assey et al. 1995). The foreground reddening of E (B V) = 0:037 was assumed (Schlegel, Finkebeiner & Davis 1998) with the ratio of the selective to the total extinction R = 3:1, while for the internal reddening I assumed R = 2:7 (Bouchet et al. 1985). The resulting tem peratures T1;2 were used to calculate approximate intrinsic colours (B V) $_0$ and bolom etric corrections BC $_{1,2}$ ofboth components via Flower's (1996) calibration form ain sequence stars. The "standard" mean value m M = 18:9of the distance modulus (DM) for SMC was assumed. The sem im a jor axis A can be then computed by the following form ula:

where M $^{\rm V}$ is the V absolute m agnitude of the Sun (assumed + 4.75), V₁ is the out-of-eclipse V m agnitude of the prim ary

(calculated assuming $L_2^V = L_1^V$ $l_2 = l_1$ and that l_3 contribution in V band is comparable to that in I band). The total mass of the system results simply from application of Kepler's third law. The absolute scale of the system gives in mediately the bolom etric lum inosity L of each component.

Now we proceed to the second step of the method. We can represent the lum inosity of the star as a function of its mass, which is well-known as Eddington's relation. This relation works only for main sequence stars, but it should be kept in m ind that for an early spectral type star (m assive and lum inous at the sam e tim e) its lum inosity is not a strong function of the age. The dependence is rather weak and such star tends to evolve from ZAMS along alm ost horizontal line on HR diagram. Moreover, no binary from the sam ple (beside two red systems from C subset) seems to contain considerably evolved com ponents.


Fig. 8 presents the m ass-lum inosity relation. The data for m assive (M > 2.2M) G alactic stars were taken from compilation of detached, double lined eclipsing binaries done by Pols et al. (1997 and references therein) and for three LMC eclipsing systems from R ibas et al. (2000), Fitzpatrick et al. (2001) and R ibas et al. (2002). The inclusion of LMC stars gives an opportunity to check how this relation depends on the metallicity. Indeed the G alactic stars seems to have a little smaller lum inosity then LMC stars (having [Fe/H] 0.35) at a given mass. For a G alactic star the mass-lum inosity M L relation may be approxim ated by a simple linear function in wide range of m asses (2.2M < M < 20M):

i.e. L M^{3:66}. The sam ple of LM C stars do not cover such wide range of m asses and I assumed that the slope of the M L relation is the same like for the G alactic stars. Then the data can be tted by:

Above equation (labeled 2 in Fig. 8) gives the approximate M L relation for LMC stars. This relation can be compared with a mass determination for two detached eclipsing systems in SMC done by Harries et al. (2003) { see Fig. 8. C om ponents of SC 6 215965 lie very close to the predicted M - L relation, but there are some problem s with components of set M = 1 relation.

SC 5 38089: especcially a more massive component of 38089 seems to be a less lum inous one. A sthe physical parameters of 215965 are more precisely determined than in the case of 38089 I decided to adopt the mass-lum inosity relation given by Eq.11 for SM C stars. Relying on this assumption we can check the consistency between parameters found from the ux scaling (Eq.9) and from M L relation (Eq.11).

Such treatm ent allows for independent determ ination of the unknown reddening in the direction to the particular binary and thus a reasonable $(B \quad V)_0$ intrinsic colour can be obtained. A lthough the m ean foreground reddening toward SMC is quite low some large random internal reddenings (up to 0.2) were reported for individualB type stars (Larsen, Clausen & Storm 2000). It is obvious (e.g. Flower's 1996 calibration) that for early type stars the tem perature is a very strong function of the (B V)₀ colour and a sm all change of this colour causes a large change of the tem perature. A s the tem perature enters Eq.9 at a relative high power even a sm all error in determ ination of reddening E (B V) produces large errors in lum inosities and masses. Let us return to the problem of the determ ination of physical parameters. W e can compute the expected m ass ratio q as follows:

where $L_{1;2}$ are the absolute lum inosities computed by using Eq.9. Then the masses of individual components M_{1;2} are calculated from Eq.11. If there is a consistency between the ux scaling and M L relation a quantity :

should be equal or close to the free term in Eq.11 i.e. 0.38. I have allowed parameter to vary in the range of 0.36-0.40. If were in allowed range the consistency was achieved, the E (B V) = 0.087 was approved as the nal reddening and calculations stopped. If not, the iterative determ ination of the reddening were done. For greater than 0.40 the correction of 0.001 were added to E (B V), while for sm aller than 0.36 the correction of + 0.001 was applied and all calculations were repeated for this new value of reddening, until the fell in the allowed range.

The above method was tested on three LMC eclipsing binaries which have their physical parameters known with high accuracy. As a free param eter I assum ed distance m odulus to the LMC. The best "t" to the original data were M = 18:5 what is a value still accepted obtained for m as close to the true one (e.g. G ibson 1999) and m arginally consistent with D M obtained using eclipsing binaries (R ibas et al. 2002). The com parison between original data and param eters given in Table 3 (lowest panel) show that the "t" is excellent { the method allows for consistent and accurate estimation of masses, sizes, temperatures, lum inosities and reddenings of all three system s. It may serve as a proof that such an approach of estim ation of physical parameters works well and m ay give fast and proper inform ation about the absolute dim ensions for large sam ples of eclipsing binaries { see x 6.2 for a discussion. It is worth to note that the initial value of reddening is irrelevant to the method and the sam e results we obtain adopting another initial E (B V).

Table 3 gives the nallestimation of the physical parameters of each component of binaries in the sample. The spectral type and lum inosity class of each starwas estimated from T and log g.SC453898 and SC9175336 were treated in a slightly dimensional the mass ratio for both systems was not calculated from Eq.12 but was assumed to be equal to the photom etric mass ratio determined from the light curve solution (see x 3.4). The further calculations were done in a similar way like for the rest of the sample. For two binaries from C subset which host evolved and cool components the reddening was assumed to be equal to the initial value and just the simple ux scaling was applied.

The tem peratures T_1 from Table 3 in a few cases (SC 4 163552, SC 5 311566, SC 9 175336) signi cantly di er from initial T_1 for which light curve solutions were found. A d-ditional tests show, however, that photom etric parameters recalculated for the tem peratures resulted from the ux scaling were consistent with those from Table 2 within quoted errors.

5 DISTANCE INDICATORS

Below the discussion of individual eclipsing binaries as distance indicators to SM C is presented. Six candidates were chosen according to the following criteria: the presence of complete eclipses, sm all residuals, sm all and well determined third light contribution and the spectral type. Two binaries from this subset were also advocated to be possible distance indicators by W W 1. Another four systems which were selected by W W 1 and W W 2 were also brie y discussed in a separate subsection, where reasons against their selection were given and additionally SC 5 38089 used recently for distance determination to SM C is also discussed.

5.1 M ost likely candidates

5.1.1 SC 4 53898 and SC 9 175336

These two binaries may serve as the best candidates because of the presence of complete eclipses, high brightness (especially SC 9 175336), modest proximity e ects allowing

for reasonable determ ination of the third light contribution to the system and at last, sm all residuals. In both cases the prim ary is slightly cooler and considerably larger than the secondary component. As a result there is a quite high lum inosity ratio between components $l_2 = l_1$ 3 (see Table 2) which m ay by regarded as the only disadvantage of using these system s. The expected velocity sem iam plitudes should be K₁ 250 km /s and K₂ 190 km /s for SC 4 53898, while K₁ 220 km /s and K₂ 190 km /s for SC 9 175336. The latter lies near the large H II em ission region and O B association { NGC 371. B oth stars were not included by W W 1 or W W 2 as likely distance indicators.

5.1.2 SC 5 129441 and SC 6 67221

Very high eccentricity and clear proximity e ects visible near the periastron passage are features of both systems. SC 5 129441 consists of two somewhat evolved B3 stars of equaltem peratures. In the second system { SC 6 67221 { during the primary eclipse (phase 1.0) the cooler and probably larger component is eclipsed and the strong mutual re ection causes the brightening of the system visible as a hum p around phase 1.0. Both systems may serve as ideal testers of mutual re ection treatment used in modern light curve synthesis program s. Indeed, the presence of sm all residuals visible near phase 1.1 in SC 5 129441 and near the primary eclipse in SC 6 67221 may (Fig. 5) suggest that simple reection used in the analysis (see x3.1) m ight be too crude a simpli cation. Unfortunately the use of the detailed re ection (which should be more appropriate for these binaries) together with the eccentric orbits m akes W D program practically unsuitable for analysis due to an enorm ously large computational time (W ilson 1992).

Both systems show no substantial third light contribution. The expected velocity sem iam plitudes should be K₁ K₂ 140 km/s for SC 5 129441 and K₁ 150 km/s and K₂ 140 km/s for SC 6 67221. SC 5 129441 was suggested by W W 1 to have complete eclipses, but the present light curve analysis did not support this thesis. SC 6 67221 was not included by W W 1.

5.1.3 SC 3 139376

This binary seems to be the most massive and the most lum inous in the sample (beside SC 9 163575), consisting of two B0 V-IV stars of similar temperature: T 32000 K. It is the only "classical" well-detached system included in the subset of likely distance indicators { the fractional radii of both components are below 0.2. The residuals of solution are very sm all and only some larger scatter can be seen during eclipses due to very fast apsidal motion. The rate of the motion is ! 5:8/year, so the apsidal period U is only 60 years. Thus the analysis of this system can give parallel inform ation about the components and an independent check of stellar evolution m odels. The expected velocity sem iam plitudes should be K $_1$ $\,$ 190 km /s and K $_2$ $\,$ 180 km /s.

5.1.4 SC 6 215965

The brightest binary in the sample (V = 13.94) with the spectrum BOV-IV + B1 IV. Table 3 suggests that the cooler component is more massive one and it is slightly evolved. The light curve solution showed that the contribution of the third light to this system m ight be neglected and photom etric param eters such as the tem perature ratio (surface brightness ratio) could be very accurately determ ined. A lso very sm all residuals suggested that the system had no essential intrinsic variability. This system was yet used by Harries et al. (2003) for a distance determ ination to SMC giving m M = 18:83 0:15. The physical parameters of both components are reasonably close to that presented in Table 3. It can be considered as an independent check of the m ethod given in Section 4 and an additional argum ent for use this star for an accurate individual distance determ ination.WW1 included this binary in their catalog on the basis of having complete eclipses but the present analysis (and results of H arries et al.) exludes this suggestion.

5.2 SC 5 38089 and the candidates suggested recently by W yithe & W ilson

5.2.1 SC 5 38089

H arries et al. (2003) determ ined absolute dimensions and a distance to this $B \, 0V + B \, 0V$ system : m M = 18:92 0:19. Their light curve solution is essentially the same as the solution reported in this paper. However, there is an apparent discrepancy between the observational data on SC 5 38089 and the mass-lum inosity relationship shown on Fig 8. Thus I would not recommended this star for individual distance determ ination, although it is very interested target for spectroscopic investigations in the future. Table 3 gives the estimate of physical parameters assuming that both components are norm alm ain sequence stars. The expected B lum inosity ratio is very close to unity what indeed was reported by H arries et al.

5.2.2 SC 4 103706

Form ally this binary also seems to have complete eclipses (it was included by W W 1 in their subset of binaries showing totality) but the very large third light contribution (l_3 0:4) m ay cause serious problems during modelling of the spectral energy distribution and thus I decided not to include this star into the most suitable candidates.

5.2.3 SC 4 163552

W W 2 included this binary according to the presence of com – plete eclipses, but as in the case of SC 6 215965, the light curve analysis contradicted this thesis. The third light contribution to this system is sunstantial, at about 26%. This binary has sm all residuals, a very sm ooth light curve and can be considered as a "reserve" candidate. The m ass ratio and tem perature ratio are very close to unity. The expected velocity amplitude is K 250 km/s for both components.

5.2.4 SC 6 11143

W W 1 classi ed this system as a well-detached. Indeed, my analysis showed that the components had the sm allest fractional radii of all the sample (beside SC 6 67221) and are norm al B2 V stars. However, this binary happens to blend with another eclipsing binary (see x2.2) which contributes about 30% to the total light of system. Thus any detailed analysis of SC 6 11143 should at the same time take into account a careful analysis of the blending binary. Probably this includes simultaneous solution of multicolour light curves of both binaries what is, in principle, possible, but may give am biguous results.

5.2.5 SC 6 319966

This binary was included by W W 1 according to the presence of complete eclipses which seems to be incorrect in the view of my analysis. This binary had the highest l_3 contribution from all the sample { nearly 50 % { which is most probably too large for a detailed m odelling of spectrophotom etry.

6 CONCLUDING REMARKS

6.1 Third light contribution problem

The observed di erence of the l_3 contribution to the total light between binaries from A and B subsets may be understood as follows. The components of binaries from B subset are relatively much closer to each other than those from A subset and the proximity e ects, depending on the gravitational distortion and overall geometry of the system, are much more distinct. Thus proximity e ects give us additional constraints to the solution. W hen we consider the third light l_3 we see that its in uence on the light curve of well-detached systems is of little importance: equally good solutions can be obtained for wide range of l_3 values.

The situation is dierent for closer systems { sm all changes of la produce noticeably system atic 0 -C residuals, especially near quadratures. This is an important reason for preferring such system s over classical well-detached system s in determ ination of the distance using individual eclipsing binaries, especially in the case of the extragalactic binaries observed usually on a rich stellar background of a host galaxy. The probability of blending with another star(s) in such environment is high (crowding e ect). A lso the blend may be a member of the system itself as at least 30% of binaries (Batten 1973) are found to form hierarchicalmultiple system s of stars. Indeed, neglecting of the third light contribution in the case of HV 2274 and HV 982 m ay be one of the prim e sources of sm all di erences on the level 1.5 between distances derived for three LM C system s as was announced by R ibas et al. (2002).

6.2 Fast inform ation about absolute dim ensions

The idea of deriving the absolute properties of binary stars from knowledge of their photom etric properties alone has

long tradition (e.g. Gaposchkin 1938, Kopal 1959 - Chapter 7). The m ethods based on this idea use som ew hat statistical approach: one or both com ponents of a binary conform an empirical mass-lum inosity relation and the temperature is imposed by observed spectral type. There are two important advantages of such statisticalm ethod 1) it m ay be used for large sam ples of binaries and 2) it gives fast, though approxim atephysical parameters of binaries. A flerward we can choose from the sample most interesting systems and investigate them m ore accurately using spectroscopy, spectrophotom etry or multicolor photom etry. How ever, past m ethods neglected the interstellar reddening (which in uences both the brightness and the colours) and, what is more im portant, the distance to the binary. A sam atter of fact the distance is irrelevant to these m ethods and thus it can be derived sim ply by comparison with the apparent magnitude m, even without any radial velocity measurements (e.g. Gaposchkin 1968, Dworak 1974). Moreover, they based their reasoning on quite crude spectral type -tem perature calibrations and, of course, as the tem perature com e in high powers into equations involved in the method, the obtained parameters were usually very inaccurate.

In present paper this "old-fashioned" m ethod was innovated to account for the interstellar reddening E (B V) and recent B V colour - tem perature calibration (F low er 1996). It turns out that such approach causes a big im provement in the tem perature determ ination and overall physical parameters as was dem onstrated by an accurate "reproducing" of absolute dimensions of three LMC eclipsing binaries. How ever, it was done for a little bit larger distance to LMC than the distance derived, on average, from these LMC stars. A shift of the distance m odulus (m M) = +0:1 is quite sm all and com es probably from som e inaccuracies of F low er's tem perature or/and bolom etric corrections calibration for hot stars.

A nyw ay we should expect that this kind ofm ethod m ay give fast approxim ate determ ination of absolute dimensions form any binaries in the M agellanic C buds, especially as we have large archives of binaries discovered by OGLE, MA-CHO and EROS projects at our disposal, and m ay be used also for eclipsing binaries in other close galaxies in the near future.
