# MASS{TO {LIGHT RATIOS OF 2DF GALAX IES

### ABSTRACT

We compute M  $_{260}^{\rm dyn}$ , the dynam icalm ass interior to a radius of 260h  $^1$  kpc, for a set of 809 isolated host galaxies in the 100k data release of the 2dF G alaxy R edshift Survey. The hosts are surrounded by 1556 satellite galaxies, as de ned by a set of speci c selection criteria. O urm ass estim ator and host/satellite selection criteria are taken from those used by the Sban D igital Sky Survey (SD SS) collaboration for an analysis of M  $_{260}^{\rm dyn}$  for SD SS galaxies and, overall, our results com pare well with theirs. In particular, for L  $^>$  2L we nd (M  $_{260}^{\rm dyn}$ =L) $_{\rm by}$  = (193 14)h M =L , with a weak tendency for hosts with L < 2L to have a somewhat higher M =L. A dditionally, we investigate M =L for bright (b\_J < 18) galaxies with elliptical, S0, and spiralm orphologies. There are 159 hosts in the elliptical/S0 sample and, sim ilar to the full sample, we nd (M  $_{260}^{\rm dyn}$ =L) $_{\rm b_J}$  = (271 26)h M =L for galaxies with L > 2L , and a weak tendency for intrinsically fainter galaxies to have a som ewhat higher M =L. In stark contrast to this, we nd the line of sight velocity dispersion for the 243 spiral hosts to be independent of the host lum inosity, with a value of  $_{\rm v}$  = 189 19 km s  $^1$ . Thus, for spiral hosts we nd that (M  $_{260}^{\rm dyn}$ =L) $_{\rm by}$  / L  $^{1:0}$   $^{0:2}$ , where M  $_{260}^{\rm dyn}$ =L) $_{\rm by}$  for a 2L spiral is of order 200h M =L .

#### 1. INTRODUCTION

It is generally accepted that large, bright galaxies reside within m assive dark m atter halos; how ever, the radial extent of the halos is not well{constrained and, hence, neither is the total m ass nor the m ass{to{light ratio of these objects. G alaxy{galaxy lensing, in which the halos of foreground galaxies weakly distort the shapes of background galaxies, has recently proven to be a powerfulm ethod by which the m asses and m ass{to{light ratios of galaxies m ay be constrained. G alaxy{galaxy lensing has been detected by a number of di erent groups (see, e.g., the review by B rainerd & B landford 2003 and references therein) and, in particular, the Sloan D igital Sky Survey (SD SS) collaboration has obtained m easurem ents of the galaxy{galaxy lensing shear with extrem ely high statistical signi cance (e.g., F ischer et al. 2000; M cK ay et al. 2001).

Using weak lensing measurements of the projected m ass correlation function, M cK ay et al. (2001), hereafter SD SS01, found that M  $\frac{lens}{260}$ , the m ass of lens galaxies interior to a radius of 260h <sup>1</sup> kpc, scaled roughly linearly with the lum inosities of the lens galaxies in all bandpasses except u<sup>0</sup>. Since the galaxy {galaxy lensing shear is sm all ( 0.5% in the case of the SD SS galaxies) and is not without its own sources of error (including the the separation of lenses from sources), M cK ay et al. (2002) perform ed an independent estim ate of the masses of dark matter halos surrounding SD SS galaxies using the dynam ics of satellite galaxies. Their sample consisted of 618 host galaxies and 1225 satellites, which was considerably smaller and shallower than the sample in the weak lensing analysis due to the necessity of redshifts for all of the galaxies. Nevertheless, McKay et al. (2002), hereafter SDSS02, found that their dynam ical analysis led to trends in the dependence of M  $_{260}^{\rm dyn}$  on the host galaxy lum inosity that

were reasonably consistent with the trends obtained from their previous weak lensing analysis. However, the mass{ to{light ratios found from the dynamical analysis were system atically lower than those from the lensing analysis  $M_{260}^{dyn}=L_{0.8M} \frac{lens}{260}=L$ ).

Here we perform a dynam ical analysis of the m asses of isolated host galaxies in the 100k public data release of the 2dF G alaxy R edshift Survey, hereafter 2dFGRS. The 2dFGRS is a spectroscopic survey in which the objects are selected in the  $b_J$  band from the APM galaxy survey (M addox et al. 1990a,b), and extensions to the original survey. Ultim ately, the survey will provide spectra for 250;000 galaxies brighter than  $b_J = 19:45$  and will cover an area of order 2000 square degrees (see, e.g., C olless et al. 2001).

O ur host galaxies span a redshift range which is similar to that of the SD SS02 galaxies, and our sample is of a similar size. We select host/satellite combinations and determ ine dynamical masses for the host galaxies based upon the methods outlined in SD SS02 in order to compare most easily to their results. In particular, we investigate the apparent lack of dependence of M  $_{260}^{dyn}$ =L on the host luminosity found by SD SS02, and the som ewhat low value of the dynamical mass{to{light ratio in comparison to the lensing mass{to{light ratio.

Throughout, we adopt a at, {dominated universe with parameters  $_0 = 0.3$ ,  $_0 = 0.7$ , and H $_0 = 100$ h km s  $^1$  M pc  $^1$ . Consistent with this, we take the absolute magnitude of an L galaxy in the b<sub>J</sub> band to be M<sub>br</sub>  $5 \log_{10} h = 19:66 0:07$  (N orberg et al., 2002).

### 2. HOST AND SATELLITE SELECTION

In order to compare to the results of SD SS02, we select host and satellite galaxies from the 2dF survey according to the SD SS02 criteria: Host galaxies must be \isolated". They must be at least twice as lum incus as any other galaxy that falls within a projected radius of  $2h^{-1}$  Mpc, as well as within a velocity di erence of jivj 1000 km s<sup>-1</sup>.

Potential satellite galaxies must be at least 4 times fainter than their host, must fall within a projected radius of 500h  $^{1}$  kpc of their host, and the satellite { host velocity di erence must be jdvj 1000 km s  $^{1}$ .

These basic selection criteria result in 864 hosts and 2340 satellites. As noted by SD SS02, how ever, m any of the hosts have a large number of satellites around them (in one case, a potential host in our sample has 605 satellites). These are, therefore, m ost likely to be associated with cluster systems, rather than being truly isolated. To elim inate these objects, we impose a further restriction that the lum inosity of the host be greater than the sum total of the lum inosities of the satellites. This, too, was done by SD SS02, and reduces our 2dF sample to 859 hosts and 1693 satellites.




Figure 1. a) Probability distribution for lum inosities of the 809 host galaxies in the full sample. Lum inosities are in units of L . b) Probability distribution for the num ber of satellites surrounding the host galaxies in the full sample. c) Probability distribution for the di erence in apparent magnitude between the host and satellite galaxies in the full sample. d) Velocity dispersion of satellite galaxies in the full sample as a function of median host lum inosity. Solid line shows  $_{\rm v}$  / L, which is the best t to the data. D ashed line shows  $_{\rm v}$  /

Finally, we impose two additional cuts on the host galaxies. First, eyeball morphologies are available for the 2dF galaxies with  $b_J < 18$ , and 29 of the above hosts are classied as galaxy (galaxy mergers. We delete these hosts from the sample on the basis that they are unlikely to be fully relaxed systems. Second, we delete all hosts with L > 6L because the velocity dispersions of their satellites are poorly t by the technique we adopt (see below), and the num ber of interloper galaxies (as opposed to genuine satellites) appears to be both large (> 45%) and have a large dispersion ( 20%). These additional cuts leave us

with a nalsam ple of 809 host galaxies and 1556 satellites. O fthese, 75 are classi ed as ellipticals, 84 are classi ed as S0, and 243 are classi ed as spirals. The sam ple of spirals is uniform ly distributed in inclination angle, and there is no correlation between host lum inosity and median inclination angle. The ellipticals have a total of 171 satellites, the S0's have a total of 303 satellites, and the spirals have a total of 478 satellites. The median redshift of the 809 host galaxies in the full sam ple is  $z_{m\,ed} = 0.073$ , while for the spiralhosts  $z_{m\,ed} = 0.055$ , and for the elliptical and S0 hosts  $z_{m\,ed} = 0.062$ .




Figure 2. Sam e as Fig. 1, but for elliptical and S0 host galaxies.




Figure 3. Sam e as Fig.1, but for spiral host galaxies. Solid line in panel d shows  $_{\rm V}$  = 198 km sec  $^1$ , which is the best t to the data.

The probability distribution of the lum inosities of the host galaxies, the probability distribution of the number of satellites around individual hosts, and the probability distribution of the di erence in apparent  $b_J$  m agnitude between the hosts and their satellites are shown in panels a, b, and c of Figs. 1, 2, and 3. Fig. 1 shows results for the entire sample of 809 hosts, while Fig. 2 shows the results for the 159 hosts classi ed as elliptical or S0, and Fig. 3 show s the results for the 243 hosts classi ed as spirals.

## 3. HALO VELOCITY DISPERSIONS

In order to com pare with SD SS02, we adopt an analysis technique that is identical to theirs. The radial velocity dispersions of the host galaxy halos, v, are computed by tting a combination of a Gaussian and a constant o set to histogram s of the velocity di erences between the hosts and satellites. The width of the best { tting G aussian is a measure of v, while the o set accounts for the fact that there will, necessarily, be som e fraction of interloper galaxies that are selected as satellites when, in fact, they are not dynam ically associated with the host galaxy. Like SD SS02, we nd that this technique provides very good ts to the velocity di erence histogram s, yielding values of  $^2$ per degree of freedom ,  $2^{2}$  , that are < 1 for hosts with L 6L . In the case of hosts with L > 6L ,  $^{2}$ = > 2:5 and, hence, we do not consider these objects further.

Because it is likely that more interlopers will have velocities that are greater than their hosts (e.g., Zartisky & W hite 1994), we determ ined  $_{\rm v}$  for the host galaxies by tting Gaussians plus constant o sets to 3 di erent velocity di erence histogram s: (i) velocity di erences taken to be the absolute value, jdvj of the measured di erence, (iii) negative velocity di erences, and (iiii) positive velocity di erences. We de ne the velocity di erence to be vhost vsat, so that negative values of dv correspond dv to satellites which arem ore distant in velocity space. In all cases, the best { tting velocity dispersions are in very good agreem ent am ongst the 3 histogram s. In addition, we nd a clear di erence in the num ber of interlopers. In the case of the full sample of 809 hosts, the interloper fraction is (31 3)% for host { satellite pairs with dv < 0, (20 3)% for host { satellite pairs with dv > 0, and (27 2)% on average (i.e., tting to the distribution of dv). For the hosts with spiral m orphologies, the mean interloper fraction is (33 3)% while for hosts with elliptical and S0 m orphologies the interloper fraction is much lower,  $(14 \quad 4)$ %. Lastly, for all of our samples of host galaxies, we nd that  $_{\rm v}$  is independent of the radius at which it is determined.

Results for v as a function of median host lum inosity are shown in paneld of Figs. 1, 2, and 3. In the case of the full host sam ple and the elliptical/S0 host sam ple, the relationship between velocity dispersion and median host lum inosity is t best by linear relations, and these are shown by the solid lines in paneld of Figs. 1 and 2. For the full host sample we nd v = (31)8)L=L + (141)18) km s<sup> $\perp$ </sup>, and for the elliptical/S0 sample we nd v = (43 7)L=L + (149 22) km s<sup>1</sup>. This is som ewhat di erent from the results of SD SS02 who found  $_{v}$  / L.W e note, how ever, that our data are consistent with such a relationship, and the best { tting function of the form v / L is shown by the dashed lines in these gures. Strikingly di erent from these results, however, is the relationship of velocity dispersion and median host lum inosity for the spiral hosts. From paneld of Fig. 3, it is clear that v for the spiral hosts is independent of host lum inosity, and we nd  $_{v}$  = 189 9 km s<sup>1</sup> for these

objects.

#### 4. HOST MASSES AND MASS (TO (LIGHT RATIOS

To determ ine the m asses of the dark m atter halos which surround our host galaxies, we adopt the following m ass estim ator:

(e.g., B inney & Trem aine, 1987). Here r is a 3-dimensional radius,  $v_r^2$  is the mean square radial velocity of the satellites, (r) is the number density of satellites, and is a measure of the anisotropy in the velocity dispersion of the satellites:

A though other m ethods of obtaining dynam icalm asses using satellite galaxies have been adopted in the literature (see, e.g., Bahcall & Trem aine 1982; Zaritsky & W hite 1994; Zaritsky et al. 1997), this is the method adopted by SD SS02 and, therefore, we adopt it as well. SD SS02 have used the G IF simulation, which incorporates sem i{analytic galaxy form ation within a large cosm ological N {body sim ulation (e.g., K au m ann et al. 1999), to evaluate thism ass estimator. In particular, SD SS02 nd that the velocity anisotropy of the satellite galaxies in the GF simulation is small (i.e., is consistent with zero at the 2{ level), and that the mean square line of sight velocity dispersion,  $_{\rm v}^2$ , is consistent with the mean square radial velocity dis-fact that the line of sight velocity dispersion is observed to be independent of radius, the mass estimator used by SD SS02 reduces to:

We compute (r) for the satellites in our sample and nd (r) /  $r^{2:11}$  <sup>0:06</sup> for the satellites surrounding the hosts in the full sample, (r) /  $r^{2:11}$  <sup>0:09</sup> for the satellites surrounding elliptical and S0 hosts, and (r) /  $r^{2:2}$  <sup>0:1</sup> for the satellites surrounding spiral hosts. These are all consistent with the results of SD SS02 who nd (r) /  $r^{2:1}$ for their sample.




Figure 4. M ass{to{light ratios for the host galaxies interior to a radius of 260h  $^1$  kpc. Top panel: all 809 host galaxies, m iddle panel: hosts with elliptical and S0 m orphologies, bottom panel: hosts with spiral m orphologies. Solid lines in the top and m iddle panels show the m ean m ass{to{light ratio for hosts with L > 2L}. Solid line in the bottom panel show the best{ tting power law for (M  $_{260}^{dyn}$ =L)<sub>b1</sub>.

Having obtained the number density of satellites as a function of radius, we now use the values of  $_v$  from Figs. 1, 2, and 3 to determ ine the mass{to{light ratios of the host galaxies. For consistency with SDSS02, we adopt a ducial projected radius of 260h  $^1$  kpc. Shown in Fig. 4 are the results for (M  $_{260}^{\rm dyn}$ =L)<sub>by</sub> in units of h M =L as a function of median host luminosity. The top panel shows results for the full sam ple of host galaxies, the middle panel show s results for the elliptical and S0 hosts, and the bottom panel show s results for the spiralhosts.

From Fig. 4, then, we nd that  $(M_{260}^{dyn}=L)_{b_J}$  for the 809 hosts in our full sample is fairly constant for hosts with L > 2L and has a value of (193 14)h M =L. For hosts with L < 2L there is a weak suggestion of a somewhat higher mass{to{light ratio. Sim ilarly,  $(M_{260}^{dyn}=L)_{b_J}$  for the elliptical and S0 hosts is fairly constant for hosts

with L  $^>$  2L and has a value of (271 26)h M =L . Again, there is a slight suggestion that elliptical and S0 hosts with L < 2L have a som ew hat higher mass{to{light ratio. In contrast, over the range of host lum inosities explored here, (M  $_{260}^{\rm dyn}$ =L)\_{\rm by} for the spiral hosts shows a clear m onotonic decrease with lum inosity, and is consistent with a power{law of the form (M  $_{260}^{\rm dyn}$ =L)\_{\rm by} / L  $^{1:0}$   $^{0:2}$ .

## 5. DISCUSSION

The 2dF and SD SS02 host/satellite sam ples are of comparable depths and have sim ilar sizes, so it is not unreasonable to make comparisons between them. The comparison is, however, somewhat limited by the fact that the 2dF galaxies are selected in  $b_J$ , while the SD SS02 galaxies are selected in  $r^0$ , with host luminosities obtained in  $u^0$ ,  $g^0$ ,  $r^0$ ,  $i^0$ , and  $z^0$ . (The transformation from the SD SS photom etry is given by  $b_J = g^0 + 0.155 + 0.152 (g^0 r^0)$ ; N orberg et al. 2002). A lso, SD SS02 did not perform separate dynamical analyses for the hosts of early { and late {type galaxies, so a direct comparison is not possible in this case.

In all 5 SD SS photom etric bands, SD SS02 nd M  $_{260}^{\rm dyn}$  / L, so that in a given band, a single mass{to{light ratio characterizes the hosts. That mass{to{light ratio is a sharply decreasing function of the central wavelength of the bandpass (e.g., a factor of order 3 higher in  $u^0$  than in  $z^0$ ). In  $g^0$ , SD SS02  $\,$  nd M  $_{260}^{\rm dyn}=\!L$  = (171  $\,$  40)h M  $\,$  =L and in  $r^0$  M  $_{260}^{\rm dyn}=\!L$  = (145  $\,$  34)h M  $\,$  =L  $\,$ . These com – pare well with the mass{to{light ratio that we obtain, (193  $\,$  14)h M  $\,$  =L  $\,$ , for the host galaxies our full sam – ple that have lum inosities of L  $^>$  2L  $\,$ .

Since we cannot compare our M  $_{260}^{dyn}$ =L for host galaxies of di erent m orphologies to the results of SD SS02, we instead compare them to the weak lensing results of SD SS01. SD SS01 did not classify their galaxies according to visual m orphology but, instead, used spectral features to place subsets of their lens galaxies into broad \early { " and \late{ type" categories. The early {types represent about 40% of the total num ber of lens galaxies, and the late{types represent another 40% of the total num ber of lens galaxies. Table 3 of SD SS01 shows that in the bluer bands, M  $\frac{\text{lens}}{260}$ =L is somewhat morphology { dependent, with the mass { to { light ratio of the ellipticals exceeding that of the entire lens sample by a factor of  $1.5 \quad 0.2$  in  $g^0$  and by a factor of 1:3 0:2 in r<sup>0</sup>. Again, this com pares well with our results for the elliptical/SO hosts in the 2dF sample, where we nd that M  $_{260}^{\text{dyn}}$ =L for the elliptical/S0 hosts exceeds that of the full sample by a factor of 1:4 0:2 for hosts with L > 2L (e.g., Fig. 4).

O ur result that M  $_{260}^{\rm dyn}$ =L / L  $^1$  for the spiralhosts is in clear con ict with the results of SD SS01, who found that M  $_{260}^{\rm lens}$ =L was independent of lum inosity in allbut the very bluest band (u<sup>0</sup>). However, our result stems from the fact that the line of sight velocity dispersion is independent of lum inosity for the spiralhosts. W hile this is inconsistent with the dynam ical results of SD SS01, it is consistent with the velocity di erence, dv, between 69 isolated spiral galaxies (22:4 < M <sub>B</sub> < 18:8) and 115 satellites was independent of the inclination (corrected H –I linew idth of the host and was, therefore, independent of the line site of the spiral spiral (corrected H –I linew idth).

W hether the con ict between the lensing and dynam ical results for the halos of spiral galaxies is due to di erences in sample selection or due to system atic e ects in one or both of the mass estimators remains to be determined. However, the ultimate completion of both the SDSS and the 2dFGRS will aid tremendously in the resolution of this issue, and we look forward to the wealth of data that both surveys will provide in the near future.
