The growth of supermassive black holes in the centers of galaxies: absorption of stars and activity of galactic nuclei.

Abstract

The evolution of a supermassive black hole in the center of galaxy is considered. We analyze the kinetic equation describing relaxation processes associated with stellar encounters. The initial distribution function of stars is assumed to be isothermal, and it changes in accordance with consumption of stars by the black hole. We calculate the consumption rate and obtain the law of growth of supermassive black hole, i.e. the dependence of the black hole mass on time and on the velocity dispersion of stars. The obtained values of mean black hole mass and mean rate of stars consumption by a black hole are in reasonable agreement with observational data.

1. Introduction.

The massive compact concentrations of mass in the centers of galaxies are believed to be supermassive black holes with masses 10^6 10^6 solar mass (M). The recent observations [1] provide signic cant evidences for this hypothesis.

There are two global approaches to the origin of these black holes: they could either form together with the galaxy or even earlier [2], or grow up during galaxy evolution, capturing matter from the surrounding. We throughout the paper consider the second approach.

Up to the present time there has been no consistent theory how the growth of black holes in the galactic centers goes on.

B lack hole can capture lum inous (stars and gas) and cold dark matter from the central parts of galactic core (bulge). Consumption rate of stars has been investigated in [3, 4, 5, 6, 7]. (The rst statement of the problem of distribution and absorption of particles in the C oulom b potential has been considered in [8]). In [5, 6, 7] the di usion in two-dimensional energy-momentum space has rst been discussed as the main process. However, all these authors considered the dynamics of stars in the C oulom b potential of black hole, whereas, as it has already been pointed out in [6], in the case of giant black holes the consumption rate is determined by distances where it is negligible and the stars move in their own self-consistent potential eld. On the other hand, in all these papers stationary solution has been considered; as we will show below, the solution of the real problem is non-stationary.

The kinetic theory describing dynam ics of non-baryon cold dark m atter (CDM) alone (w ithout baryon fraction and central black hole) has been developed in [9]. It has been shown that the dark m atter should have form ed quasi-stationary spherical structures w ith singular density distribution, bound by gravitational forces. These structures are now observed as galactic halos. The baryon m atter should have fallen after recombination in the potential wells form ed by dark m atter, beginning form ation of galaxies and form ing seed black holes in the centers of the wells [10]. This picture explains well why the black holes are situated exactly in the dynam ical centers of galaxies [11]: the potential is very smooth in the central part, and the black hole could not reach the center unless it would be form ed just in the center, in the potential well already existing.

The contemporary infall of CDM particles into the black hole caused by gravitational interaction with stars and the corresponding growth of black hole has been investigated in [12]. It was shown that this process leads to form ation of black holes whose m asses are consistent with the most part of superm assive black hole m asses m easured now adays.

In the present paper we analyze the mutual dynam ics of cold dark matter and stars in central parts of a galaxy. In accordance with previous papers, we not that the most important process leading to the black hole grow this (for both components) far encounters causing the relaxation in the energy-momentum space, or, to be more precise, in the space of adiabatic invariants. The in uence of black hole appears both in gravitational potential (i.e. the view of adiabatic invariants) and { even stronger { in boundary condition.

We derive the equations describing time-dependence of stars- and dark matter-distribution functions, and calculate the coe cients in one particular assumption of isotherm al distribution of stars and the potential dom inated by stars, either (Section 2).

In Section 3 we discuss the boundary condition caused by presence of black hole, and the in uence of the black hole potential.

Further, we does not an approximate solution of the equation for stars, ignoring presence of dark matter and gas (Section 4). The result shows that black hole mass should grow in time as $t^{1=2}$, and is proportional to $^{3=2}$, where distinguished is the result of bulge.

In discussion, we review brie y the results of the paper. We show that them ean energy released due to stellar matter absorption is in reasonable agreement with the observed AGN activity.

2. Two-component dynam ics.

W e denote by f (r;v) and $f_d(r;v)$ the distribution functions of stars and dark m atter, respectively. This means that fraction of m ass of sort contained inside the interval d^3r , d^3v is f d^3rd^3v .

The mutual dynamics of dark matter particles and stars including di usion in the momentum space is described by kinetic equation with Landau scattering integral in the right part [13]:

C om paring the term s in (1) one can see that scattering of both dark m atter and stars by stars is $M = M_{dm}$ times more elective than scattering by dark m atter particles, and in the case of dark m atter the second term is $M_{dm} = M$ times smaller than the rst. and are corresponding angles. One of the advantages of these variables is that the adiabatic invariant I of a particle (unlike the energy E) does not change during slow changes of the potential.

In these variables, the left side of the kinetic equation does not contain derivatives over action variables I_k [12, 14]:

W e assume that in the vicinity of the center the distribution function is spherically sym - metric, i.e. does not depend on the direction of angular momentum. Then, there is a cylindrical symmetry in the space of adiabatic invariants. Making use of

W e see that evolution of distribution functions is described by axially symmetric di usion in three-dimensional space of adiabatic invariants.

3. The black hole, and setting the problem .

The scattering of dark matter particles by stars and their consumption by a black hole has been discussed in [12]. It has been assumed in that paper that growth of black holes is fully determined by dark matter. Here we discuss an opposite assumption of full absence of dark matter. From now on, we discuss only dynamics of stars. A coordingly, we hereafter om it the index in f. Black hole can e ect the dynam ical evolution of surrounding matter in two ways: consuming matter from the loss-cone and changing the gravitational potential. We now consider the rst e ect as principal one, and later on will brie y discuss the second.

The black hole with m ass M $_{bh}$ disrupts (and after that consumes) all stars that come nearer than the tidal radius $r_t = \frac{6 M _{bh}}{2}^{1=3}$, where is the density of the star. We assume it to be approximately equal to solar density . In terms of variables (I;m) this means that during one oscillation period all stars inside the loss-cone

the star will anyway fall into the black hole [15], independently of m_t . (If the black hole m ass M_{bh} is greater than 3 M, the tidal radius becomes smaller than the gravitational radius r_g , and stars become consumed without disruption. For dark matter particles the loss cone is always de ned by m_g .) For brevity, we shall hereafter denote the boundary value by m_t , assuming maximal of the two values m_g and m_t : $m_t = maxfm_g$; m_tg .

O ne can easily estim ate the growth of the black hole caused by direct capture of matter from the loss-cone: taking, e.g., the isotherm alfunction (14), we have $M_{bh} = 2 m_t = G$. For black holes with masses more than $10^3 M$ relative increase of mass $M_{bh} = M_{bh}$ is less than 10° . Hence the main growth is connected with di usion of matter into the loss-cone.

The condition that the particles vanish as they get into the area $m = m_t m$ ay be expressed in terms of equation (8) by boundary condition

It is the change of gradient of distribution function @f=@m near the boundary that causes shift of particles in the momenta space into the loss-cone. This mechanism may lead to consum ing much more mass than has initially been inside the loss-cone.

Applying G auss theorem to the equations (6),(8) we see that the rate of black hole grow th dM $_{\rm bh}$ =dt, i.e. loss of whole m ass of stars in the surrounding space, is equal to ux through the boundary m $_{\rm t}$:

So, to nd the contemporary mass of black hole and distribution of stars in its vicinity one should solve equation (8) with boundary conditions (10) and (17). The isothermal function (14) is the most natural choice of initial distribution because it is stationary

distribution with self-consistent potential and with no ows. If there were no black hole, the isotherm aldistribution remained constant. The boundary condition (17) disturbs the equilibrium and makes the distribution change.

Furtherm ore, we take the same isotherm alfunction to calculate the coe cients R_k ; R_{kp} at any moment of time. We suppose that one may neglect the changes in distribution of scatterers, because (7) includes only integrated function f, and changes in f do not e ect the coe cients signi cantly. We will check the convenience of this approximation in Section 4.

Let us now estimate the in uence of gravitational potential of black hole. the region of in uence of the black hole potential does not reach up to characteristic distances (19). In this case only a small fraction of particles enters the region, and, because of ellipticity of most orbits, spends there rather small part of time. This is in full conform ity with conclusions by [6].

The same arguments are applicable to the region $r < r_{coll}$ R M_{bh}=M where orbital velocities become comparable to the escape velocity from a typical star, and inelastic scatterings are important [5, 6]. One can easily check that r_{coll} r_{a} for values under discussion.

4. A sym ptotic solution.

The equation (8) is di cult to solve. In this section we obtain at least some integrated characteristics that make us able to estimate the total consumption rate S of stars and its evolution in time.

Let us not discuss the vicinity of the black hole boundary, $m_t = m \frac{P_{R_{22}t}}{R_{22}t}$ and I > m. Comparing dimensions in equation 8) we not out that, e.g., the term containing R_{22} is of the order of $R_{22}f = m^2$ (f=@t, which means that the picture near the boundary is quasi-stationary at contemporary time. All the other terms except the two (with $R_{11}; R_1$) that are singular at m ! 0 (see (13)) are maximum of the order of R_{22} f=Im, i.e. much smaller. The remarkable fact is that the result depends only weakly on the boundary m_t . This is why the solution (24)-(26) remains the same (up to the same accuracy) if we account the change of m_t with time ((15) or (16)) according to change of the black hole mass (26).

We note that mass of black hole is no more than half the mass that was initially (when there was isothermal distribution) in the area m m_1 . The same is correct for any time (excluding the very beginning). This proves our initial assumption that change of distribution function does not a lect signil cantly the coellicity R_p .

Possible constraint.

Let us now discuss brie y possible constraints on di usion model. A llequations beginning with (6) are averaged over orbital period. The boundary condition (17) also assumes that all particles with average angular momentum less than m_t become captured into the black hole. This means that during one period the change of trajectory is negligible. But for very elongated and large trajectories change of angular momentum of particle during one orbital period is comparable with the boundary angular momentum m_t . Hence, whether the star will or not be captured by black hole during one period depends not on the mean trajectory, but on its small uctuations caused by individual collisions.² In terms of adiabatic invariants this may be form ulated as follows.

The di usion approximation and equation (17) may not be applied at very large values I (i.e., for very long orbits). Namely, mean change of angular momentum m during one period T (I;m) is of the order of m RT (I;m), hence the constraint on (17) is q

On the other hand, we have seen in Section 3 that main changes in the distribution function, and hence main contribution to the ux occur at scales I P are the state age of the black hole. This means that the consumption rate of stars is not disturbed by in unce of $I_{\rm rit}$ if $p_{\rm rit}$

. At su ciently large values I m_t the orbital period is approximately equal to $T(I;m_t) = I^2$ (see Appendix). Substituting m_t from (15) we obtain that one anyway should not take the existence of I_{crit} into account if the black hole mass is greater than

Now adays, this corresponds to minimal $M_{\rm bh}$ 2 10 . Comparing the time dependence in (29) with that in (27) we not that (if has not changed dramatically) the masses of the black holes that have grown as a result of the described relaxation mechanism have always been greater than the critical limit as far as galaxies exist. On the other hand, for black holes with su ciently smaller masses additional investigations of in uence produced by $I_{\rm crit}$ are needed.

5. D iscussion

In the paper we derived the equations describing kinetic relaxation of two-com ponent (stars + dark matter) system in the vicinity of supermassive black hole, in self-consistent gravitational potential. The equations have been expressed in terms of H am iltonian variables.

We have analyzed the growth of black hole caused by consumption of stars, without taking non-baryon dark matter and lum inous gas into account. We have seen that for black holes smaller than 10^{6} M (29) individual collisions near pericentrem ight play crucial role. For black holes larger than 10^{8} M (20) one should take the potential of the black hole into account. However, the most part of discovered black holes [11] have masses in the range between 10^{6} M and 10^{8} M where the main mechanism leading to consumption of stars is di usion in the momenta space, or in the space of adiabatic invariants.

A nalogous mechanism has been discussed previously in a set of papers [3, 4, 5, 6, 7]. But all of them have examined stationary distribution in the Coulomb potential of the black hole. We have considered the evolution in self-consistent potential and found that there is no stationary state in presence of black hole. A loo in previous papers only di usion along one axis (either m or E) was taken into account. The advantage of H am iltonian variables m; I is that in this variables the di usion along m axis contains both shifts along m - and E -axes in the (E;m) plane and makes the main contribution into the ux on the black hole. The di usion along I axis plays less important role in the absorption process, being merely responsible for change of form of stars trajectories. Flux along I - axis increases sm oothly as m decreases, reaching its maximum at the black hole boundary $m = m_t$, where $S_I = S_m = 0.6$ (i.e., the particles in the I m plane intersect the black hole boundary m = m_t at the same angle independently on I).

The solution (27) obtained in Section 4 gives reasonable estimate for contemporary characteristic black hole mass which lies in the middle of observed range of masses. The estimate for ux of matter onto a black hole (28) also corresponds to average observed activity of galactic centers.

Equation (27) also shows that M_{bh} should change very slow ly in time, M_{bh} t (1 + z) ³⁼⁴. Hence, the corresponding di erence between black hole masses in far and nearby galaxies is too sm all and hidden by other e ects. On the other hand, the obtained M relation di ers from that derived from observations (from ^{3:7} in [16] to ^{5:3} in [17]) However, this discrepancy is not critical, since black hole masses depend not on one parameter only, but also on the bulge mass [11], mass of halb [18, 12], am ount of interstellar gas etc. For example, the contribution of dark matter could increase the resulting black hole mass in those galaxies where am ount of dark matter in the central parts is signi cant.

In the previous paper [12] we have discussed the growth of black hole caused by consumption of dark matter scattered by stars. The result was that the characteristic black hole mass is

where M $_{\rm H}\,$ and R $_{\rm H}\,$ are the mass and the radius of the dark matter halo.

This result and solution (27) correspond to two lim it cases describing the black hole grow th caused either by dark or by lum inous matter consumption. We see that contributions of stars and dark matter into the black hole grow thare comparable for galaxies where densities of dark and lum inous matter in the bulge are of the same order. But dark matter plays in this case a dom inant role. This, in particular, means that in galaxies where observations show very small amount of dark matter the black hole mass should be in average smaller than in others. With account of real variations of all parameters (27) and (30) cover the range

which includes the most part of observed black holes.

The common point of view is that the consumption of stars by a black hole in the galactic centre is them ain source of energy providing activity of the galactic nuclei [19,20]. To verify this hypothesis we compared the observed X-ray lum inosity of the galactic centres with the central black hole masses for 46 galaxies (Table 1). From the Table it follows that:

1. The most part of the black holes have masses in the range (31) restricted by (27) and (30).

- 2. The observed intensity of X-ray emission is in a reasonable agreem ent with the mean energy released as a result of stars consumption (28).
- 3. The analysis of the data show svery strong variations in observed lum inosity of galactic nuclei. But no correlation with the black hole masses was found. This indicates that the lum inosity of one nucleus should vary strongly in time. In other words, the duration _e of energy emission following a star absorption is much less than the mean time interval between two absorption events T M =S 2000 years &8). From observed variations (3-4 orders of magnitude), assuming an exponential fall of emission in time, we nd an estimate _e T=10 200 years. It follows that the most part of galaxies containing supermassive black holes are not active at present (as, e.g., Milky W ay). On the other hand, maxim al intensity of emission caused by star consumption should be much more than the average value S obtained in (28).
- 4. In Fig.1, the histogram of average lum inosity versus the black hole mass is presented. The histogram is based on Table 1. It shows clearly that the lum inosity breaks sharply at $M_{bh} > 3$ for . This corresponds to the fact mentioned in Section 3 that for such black holes the gravitational radius is greater than the tidal radius, and stars sink into the black hole without disruption and energy emission. The observed cuto proves that it is the infall of stars { not gas etc. { that provides the main contribution in the emission activity. On the contrary, in quasars with large redshifts the main mechanism causing energy emission may be consumption of gas [22].

Thus, in this paper and in [12] we present the theory of growth of supermassive black holes in the galactic centers caused by C oulomb scattering on stars and further consum ption of stars and dark matter. The theory is in reasonable agreement with observations.
