## P ropagation of E lectrom agnetic W aves on a R ectangular Lattice of Polarizable Points

## ABSTRACT

We discuss the propagation of electrom agnetic waves on a rectangular lattice of polarizable point dipoles. For wavelengths long compared to the lattice spacing, we obtain the dispersion relation in terms of the lattice spacing and the dipole polarizabilities. We also obtain the dipole polarizabilities required for the lattice to have the same dispersion relation as a continuum medium of given refractive index m; our result di ers from previous work by D raine & G oodm an (1993). Our new prescription can be used to assign dipole polarizabilities when the discrete dipole approximation is used to study scattering by nite targets. Results are shown for selected cases.

### 1. Introduction

The discrete dipole approximation (DDA) provides a exible and general method to calculate scattering and absorption of light by objects of arbitrary geometry (D raine 1988; D raine & F latau 1994). The approximation consists of replacing the continuum target of interest by an array of polarizable points, which acquire oscillating electric dipole moments in response to the electric eld due to the incident wave plus all of the other dipoles. Broadly speaking, there are two criteria determ ining the accuracy of the approximation:

the interdipole separation d should be small compared to the wavelength of the radiation in the material (jn kd < 1, where m is the complex refractive index, and k = !=c is the wavenum ber in vacuo);

the interdipole separation d should be small enough to resolve structural dimensions in the target.

W ith modern workstations, it is now feasible to carry out DDA calculations on targets containing up to  $10^6$  dipoles (D raine & F latau 1994). In addition to calculation of scattering and absorption cross sections, the DDA has recently been applied to computation of forces and torques on illum inated particles (D raine & W eingartner 1996, 1997) If the dipoles are located on a cubic lattice, then in the lim it where the interdipole separation kd ! 0, the fam iliar C lausius-M ossotti relation (see, e.g., Jackson (1962)) can be used to determ ine the choice of dipole polarizabilities required so that the dipole array will approxim ate a continuum target with dielectric constant . D raine (1988) showed how this estimate for the dipole polarizabilities should be modiled to include radiative reaction corrections, and D raine & G codm an (1993) derived the O  $[(kd)^2]$  corrections required so that an in nite cubic lattice would have the same dispersion relation as a continuum of given dielectric constant.

Nearly allDDA calculations to date have assumed the dipoles to be located on a cubic lattice. If, instead, a rectangular lattice is used, it will still be possible to apply FFT techniques to the discrete dipole approximation, in essentially the same way as has been done for a cubic lattice (Goodman, Draine & Flatau 1991). However, the ability to use di erent lattice constants in di erent directions might be useful in representing certain target geom etries.

The objective of the present report is to obtain the dispersion relation for propagation of electrom agnetic waves on a rectangular lattice of polarizable points. This dispersion relation will be expanded in powers of (kd), where d is the characteristic interdipole separation. For a lattice of specified dipole polarizabilities, this will allow us to determ ine the dispersion relation for electrom agnetic waves propagating on the lattice when  $(kd)^2$  1. A lternatively, if we require the lattice to propagate waves with a particular dispersion relation, inversion of the lattice dispersion relation will provide a prescription for assigning dipole polarizabilities when seeking to approxim ate a continuum material with a rectangular lattice of polarizable points.

#### 2. M ode Equation for a R ectangular Lattice

The problem of wave propagation on an in nite polarizable cubic lattice of point dipoles has been solved previously by D raine & G oodm an (1993, herafter DG 93). Here we describe the generalization of this problem to rectangular lattices.

Consider an in nite rectangular lattice with lattice sites at

For x = 0 and t = 0 and given values of  $_{ij}$ , equation (23) is the mode equation, i.e., it allows determ ination of the dispersion relation k = k (!). However, in the present case, we know the dispersion relation, and wish to determ ine values of  $_{ij}$  such that the known dispersion relation and equation (23) are satisfied simultaneously. It should be noted that the mode equation for a cubic lattice has the same form as equation (31). The matrix elements M  $_{ij}$  in equation (32) also have the same form as the matrix elements for a cubic lattice but with the vector n replaced by Q for a rectangular lattice. Since the matrix elements for a cubic lattice have been calculated previously, it is convenient to rewrite (32) as

### 3. Dispersion Relation in the Long-W avelength Lim it

For a given polarizability tensor , the mode equation (31) allows one to determ ine the dispersion relation = (). In the present case, the dispersion relation is known:

where  $m = {}^{1=2}$  is the (com plex) refractive index and a is a unit vector in the direction of propagation, which is xed. From equation (33) for a rectangular lattice, the polarization rather than the vector potential is perpendicular to the direction of propagation, i.e.,

In the limit of cubic lattice,  $Q_i$ !  $n_i$ , and all the sum s  $R_n$  in equations (45) - (49) vanish. For a general rectangular lattice, these sum s must be evaluated for each set of new lattice constants. C are must be used in evaluation of these sum s as described in the next section. ## 3.1. Static Lim it

It is evident from equation (55) that the static polarizability for a cubic lattice reduces to the C lausius M ossotti result.

If  $e_i^{(0)} = 0$  in one of the directions, then the polarizability in this direction is undetermined by equation (54). However, since the result (55) is valid for values of  $e_i^{(0)}$  arbitrarily close to zero, we take (55) to be the solution for all directions of the electric eld subject to equation (53).

# 3.2. Finite W avelength Corrections

We now proceed to obtain the leading corrections for small  $\$ . The  $\$  rst order m ode equation and transversality condition are:

Equation (65) makes it explicit that the frequency-dependent term in the dipole polarizability depends on the direction of propagation of the wave.

W e observe, how ever, that this solution is not unique. In fact, the transversality condition (58) perm its the m ore general solution

where  $c_4$  could, in principle, be a function of m<sup>2</sup>, the direction of propagation, or the polarization. We note, however, that if  $c_4 \in 0$  then eq. (60) is no longer satisfied term by term, but only after sum mation.

Since we appear to have freedom in the choice of  $c_4$ , num erical experiments using dierent choices for  $c_4$  could be used to see what value of  $c_4$  appears to be optimal for scattering calculations using the discrete dipole approximation.

## 3.3. Special Case of a Cubic Latttice

P ropagation of electrom agnetic waves on a cubic lattice has been discussed by DG 93. In their analysis it was assumed that if the dielectric material is isotropic, the polarizability  $_{ij} = {(0) \atop ij} + {(1) \atop ij}$  can be taken to be isotropic:  ${(0) \atop ij} = {(0) \atop ij}$  and  ${(1) \atop ij} = {(1) \atop ij}$ . as in eq.(4.14) of D raine & G oodm an (1993). However, we have seen above that for a cubic lattice (for which K<sub>ij</sub> =  $c_3$ ),  $_{ij}^{(1)}$  can be made diagonal but not isotropic: if we choose  $c_4 = c_3$  so that  $_{ij}^{(1)}$  is diagonal, we obtain

which di ers from the result of D raine & G oodm an (1993) since  $a_j^2 \in S$ , except for the special case of propagation in the (1,1,1) direction, for which  $a_i^2 = S = 1=3$ .

## 4. DDA Scattering Tests

We now compare discrete dipole approximation (DDA) calculations of scattering and absorption using (1) the polarizability prescription (67) from DG 93 and (2) the present result (69). We

consider spheres where we can use M is theory to easily calculate the exact result for comparison. Let  $C_{sca}$  and  $C_{abs}$  be the cross sections for scattering and absorption, and let  $Q_{sca}$   $C_{sca} = a^2$  and  $Q_{abs}$   $C_{abs} = a^2$  be the dimensionless scattering and absorption e ciency factors for a sphere of radius a.

Figure 1 shows Q<sub>sca</sub> and Q<sub>abs</sub> calculated using the DDA with a target consisting of N = 17904 dipoles, with radius a =  $a_e$  (3N = 4)<sup>1=3</sup>d. The DDA calculations used a cubic lattice, and were carried out using the public dom ain code DD SCAT.6.1 (D raine & F latau 2004). C alculations were done for values of the scattering parameters x 2 a= satisfying jn kd < 0.8, as this appears to be a good validity criterion for DDA calculations. The upper panel shows scattering and absorption e ciencies calculated with M is theory and using the DDA with the present prescription for polarizabilities . The m iddle and low er panels show fractional errors [Q (DDA)=Q (M ie) 1] of the DDA scattering and absorption cross sections.

Because the DDA target (dipoles on a cubic lattice) is not rotationally symmetric, the scattering problem was solved for 12 di erent incident directions, in each case for two orthogonal polarizations. The cross sections shown in Fig. 1 are averages over the 12 incident directions and two incident polarizations.

In the limit x ! 0, identical results are obtained for both polarizability prescriptions; this is expected since they di er only in terms of O ( $jn^2j(kd)^2$ ). Note that even at x = 0 (i.e., kd = 0) { for which the polarizabilities are exactly given by the C lausius-M ossottipolarizabilities { the DDA calculation has a nonzero error even as x ! 0 and kd ! 0. This is because (1) the dipole array only approximates a spherical geometry and (2) when the \lattice dispersion relation " polarizabilities are used, the DDA does not accurately m odel the \screening" of the target m aterial close to the surface by the polarization at the target surface. For m odest dielectric functions, and su cient num bers of dipoles, the errors are small { for the case shown in Figure 1 the fractional errors in the x ! 0 limit are < 0.3%.

As x increases, the two prescriptions result in di erences in computed values of  $Q_{sca}$  and  $Q_{abs}$ , although the di erences are small, and comparable in magnitude to the errors in the x ! 0 lim it. In Figure 1 our new prescription appears to result in small in provements in accuracy (relative to DG 93) for  $Q_{sca}$  for jn kd < 0.8, and likewise for  $Q_{abs}$  for jn kd < 0.5. For 0.5 < jn kd < 0.8, however, the DG 93 prescription appears to give more accurate results for  $Q_{abs}$ . Note, however, that for both polarizability prescriptions the fractional errors in  $Q_{sca}$  and  $Q_{abs}$  for jn kd = 0.5 are of the same order as the fractional errors for kd ! 0, so it is not clear that the errors should be attributed to the lattice dispersion relation { the errors in  $Q_{sca}$  and  $Q_{abs}$  m ay instead be associated with errors in the computed polarization eld near the surfaces, arising from the fact that in the DDA the dipoles in the surface layer are imperfectly \screened" from the external eld by their

neighbors.

For jn kd < 0.8, the errors in  $Q_{sca}$  using the new polarizabilities are of order 1% for m = 1:33 + 0:01i (Figure 1), m = 1:7 + 0:1i (Figure 2) and m = 2 + i (Figure 3), and of order 5% for m = 3 + 4i (Figure 4). In all four cases, for wavelengths satisfying jn kd < 0.8, the m agnitude of the error in  $Q_{sca}$  is of the same order as the error at zero frequency, suggesting that it is mainly due to the surface.

The errors in  $Q_{abs}$  tend to be somewhat larger than for  $Q_{sca}$ , especially for large values of Im (m). For m = 3 + 4i (Figure 4), the new polarizabilities result in a fractional error of 50% for x = 2.6 and N = 17904 dipoles.

Figure 5 shows results calculated form = 1:7+0:1i spheres represented by N = 140408 dipoles { 8 times as many as in Fig. ??. Note that the fractional error for x ! 0 is now only 0.5% { half as large as for N = 17904. This can be ascribed to the fact that the fraction of the dipoles in the surface monolayer was reduced by a factor of 2. Note also that the errors for nite x are also about a factor of 2 sm aller than for N = 17904. These results appear to con m the suspicion that the errors arise prim arily from the surface layer.

R ahm ani et al. (2002) recently proposed a method for assigning dipole polarizabilities that takes into account the e ects of target geom etry, resulting in dipole polarizabilities that are location-dependent even when the target being approxim ated has hom ogeneous composition. Collinge &

D raine (2004) have extended this treatment by adding nite-wavelength corrections to the \surface-corrected" polarizability prescription, and used DDA calculations for spheres and ellipsoids to show that accurate results for  $Q_{sca}$  and  $Q_{abs}$  can be obtained for modest numbers of dipoles even when the target material has a large refractive index jm j 5. The current calculations does not include such \surface corrections", { the prescription (69) depends only on local properties { so it comes as no surprise that there are system atic errors even in the lim it x ! 0.

Collinge & D raine (2004) show that the error can be greatly reduced if the polarizabililities are assigned in a way that allows for both target geom etry (i.e., surface corrections) and the nite wavelength corrections obtained from the lattice dispersion relation analysis. U sing these \surface-corrected lattice dispersion relation polarizabilities", Collinge & D raine (2004) show that for the case m = 3 + 4i, the error in Q<sub>abs</sub> can be reduced to of order 1% for x = 0.83 using as few as N = 5904 dipoles, whereas for x = 0.83, the error is seen from Figure 4 to be 20% even with N = 17904 dipoles. Such surface corrections will obviously be of value for DDA calculations, but at the moment have been applied only to sperical, spheroidal, or ellipsoidal targets (Collinge & D raine 2004).

5. Sum m ary

The principal results of this paper are as follow s:

- 1. We have derived the exact mode equation (31) for propagation of electrom agnetic waves through a rectangular lattice of polarizable points.
- 2. If the electric polarizability tensor for the lattice points is specified, then we can solve the mode equation to obtain the dispersion relation for waves propagating on the lattice. A lternatively, if we wish the lattice to have the same dispersion relation as a continuum medium of complex refractive index m, then we can solve the mode equation for the appropriate polarizability tensor.
- 3. In the case of a cubic lattice, our derived \lattice dispersion relation" polarizability tensor (69) is diagonal but anisotropic, and di ers from the isotropic polarizabilities obtained by DG 93.
- 4. The new polarizability prescription has been tested in DDA scattering calculations for spheres. The resulting cross sections have accuracies comparable to those obtained with the DG 93 prescription.

### A. Num erical R esults for $R_0$ (i), $R_1$ , $R_2$ (i), and $R_3$ (i; j)

The coe cients  $R_0$  (i) are obtained numerically from the sum s (45). Note that eq. (45) for  $R_0$  involves the dimension between two sums which separately divergent in mity. To handle this divergence, one notes that in nature one is always interested in mite wavelengths and nonzero frequencies; when dealing with mite wavelengths, the lattice sum s converge because of the oscillations introduced at large distances by retardation elects. To obtain the proper behavior when going to the zero frequency limit, we modify the sum mations to suppress the contribution from large distances. The manner in which this is achieved is not critical. We compute

The exponential cuto allows one to limit the summations to  $j_1 j_1^4 < 20$  and  $j_2 j_1^4 < 20$ . The summation (A1) is carried out for various small values of and it is found, as anticipated, that for  $< 10^8$  the numerical result for  $R_0$  is insensitive to the choice of . Each of the sum s in (A1) is over a lattice;  $j_1 j_1^2$  de nes the distance from the origin for the cubic lattice, and  $j_2 j_1^2$  is the distance from the origin for the reciprocal lattice. Each sum diverges at in nity, where we can replace the discrete summation by an integration; the reason why the divergences cancel is that the two lattices have the same density of lattice points, so that at large distances, both approach the same integration.

The quantities  $R_1$ ,  $R_2$ , and  $R_3$  appearing in the dispersion relation in the limit of sm all but nonzero frequency have been obtained by direct evaluation of  $R_3$  (i; j) using eq. (49) followed by use of equations (50) and (51) to obtain  $R_1$  and  $R_2$  (i). Six elements of the symmetric matrix  $R_3$  (i; j) are given in Table 2.
