KH 15D : A SPECTROSCOPIC BINARY ¹

ABSTRACT

We present the results of a high-resolution spectroscopic monitoring program of the eclipsing pre{main-sequence star K H 15D that reveal it to be a single-line spectroscopic binary. We nd that the best- tK eplerian model has a period P = 48:38 days, which is nearly identical to the photom etric period. Thus, we nd the best explanation for the periodic dimming of K H 15D is that the binary motion carries the currently visible star alternately above and below the edge of an obscuring cloud. The data are consistent with the models involving an inclined circum stellar disk, as recently proposed by W inn et al. (2004) and Chiang & M urray-C lay (2004). We show that the mass ratio expected from models of PM S evolution, together with the mass function to 0:125 $F_{\rm M} = \sin^3 i = 0.5M$.

1. INTRODUCTION

КΗ 15D is a K6-K7 pre{main-sequence star dramatic photometric variability that. exhibits (Keams & Herbst 1998). Every 48 days, the star's brightness dim s by 3.5 m agnitudes and rem ains in this faint state for nearly half of the photom etric period. These deep brightness minima are accompanied by a slight blueing of the star's color indices (Herbst et al. 2002, hereafter He02), little or no change in spectral type (Hamilton et al. 2001) and an increase in linear polarization (Agolet al. 2004). This implies that the star is completely eclipsed by an optically thick, extended collection of dust grains, possibly in the form of a circum stellar disk. If this is the case, the serendipitous alignment of the KH 15D star/disk system may provide insights into the evolution of young stars and their interactions with their circum stellar environm ents.

W hile KH 15D has periodic eclipses, it cannot be an ordinary eclipsing binary because of the long duration of m inim um light. Recent theories postulate that there is, nonetheless, a currently unseen binary companion to the visible star. In a study of archival photographic plates, Johnson & W inn (2004, hereafter JW 04) discovered that the historical light curve of KH 15D is sim ilar to them odem light curve but appears to be diluted by light from a second star. M otivated by these ndings, W inn et al. (2004, hereafter W 04) constructed a m odel com posed of

a binary system with the orbital plane inclined with respect to the edge of an optically thick screen. As the two stars orbit one another, the re ex motion carries one star alternately above and below the edge of an opaque screen, causing the eclipses. The long-term evolution of the light curve is reproduced by allowing the screen to move slowly across the binary orbit a feature of the model that led the authors to envision the screen as a precessing, circum binary disk. A sim ilar model is proposed by Chiang & Murray-Clay (2004, hereafter CM 04) who also envision the opaque screen as an inclined, precessing circum binary disk, or \ring," with an inner edge truncated by tidal interactions with the binary and an outer edge possibly shepherded by a planetary com panion. Both models provide explanations of the unique features of KH 15D 's light curve. The W 04 m odelm akes quantitative predictions about the orbital param eters of the binary system, while the CM 04 m odel provides a physical description of the circum binary ring.

A fundamental question that has not yet been answered is whether K H 15D is a single or multiple stellar system. He02 (see also H am ilton et al. 2003, hereafter Ha03) rst searched for evidence of orbital companions using high-resolution VLT spectra and reported a radial velocity change of +3:3 0.6 km s¹ over two widely spaced epochs. However, one of the measurements was made during egress when there was a strong possibility of contamination from scattered light or line pro le distortions from a sharp-edged cloud only partially occulting the stellar disk.

O ver the past two years we have conducted a highresolution, multi-site spectroscopic monitoring cam paign to determ inewhether or not K H 15D exhibits orbital motion indicative of a multiple system. Here we present the results of our study, which show that K H 15D undergoes signi cant radial velocity variations. The variations are consistent with a binary companion with an orbital period equal to the 48-day photom etric period. In x2 we sum marize our observations and reduction procedures.

The radial velocity m easurem ents and best-tK eplerian orbital parameters are presented in x3. We conclude in x4 with a discussion of our notings and implications for existing m odels of the KH 15D eclipse m echanism.

2. DATA

During the 2002-2003 and 2003-2004 observing seasons we made 16 observations of KH 15D at maximum light including 11 spectra with the Keck 10-m eter telescope and HIRES echelle spectrom eter; 2 spectra with the 6.5-m eterM agellan II (C lay) telescope and the M IK E echelle spectrom eter; and 3 spectra with the 2.1-m eter Otto Struve Telescope at M cD onald Observatory with the Sandiford Cassegrain Echelle Spectrometer (CE). The observations are summarized in Table 1. Additional Keck/HIRES spectra were obtained during minim um light. How ever, since it is unlikely that the star's photosphere is visible through the obscuring m aterial, we decided to exclude from our analysis spectra that were obtained within 10 days of mid-eclipse. In addition to our own m easurem ents, we also include the out-of-eclipse radial velocity measurement, $v_r = 9.0$ 0.2 km s¹, reported by (Ha03) based on their VLT /UVES spectra.

M ost of the Keck/HIRES observations were made as part of the California & Carnegie Planet Search.⁶ For these observations, the relatively faint apparent magnitude of KH 15D (V = 16) at maximum light precluded the the use of the iodine cell to establish a wavelength scale. The cellwas therefore rem oved from the light path during observations of KH 15D to increase the throughput of the spectrom eter. The raw CCD frames from all telescopes were reduced using reduction packages written in IDL. The details of the reduction procedures are fundam entally identical to the algorithm presented by Valenti (1994). A flerbias-subtraction, each echelle fram e is divided by a norm alized median at-eld im age. Order de nition is perform ed using a bright star or at-eld exposure, and scattered light is rem oved by tting a twodim ensionalB-spline to the inter-order regions and interpolating across each spectral order. A fler the scatteredlight is subtracted, each order is recti ed, sky-subtracted and sum m ed in the cross-dispersion direction to form the nal one-dim ensional spectrum.

Instead of a sum mation in the cross-dispersion direction, the recti ed orders of the M cD onald spectra are reduced to one-dimensional spectra using the optimalextraction algorithm described by H inkle et al. (2000). In the case of the M IK E reductions, the standard code is m odi ed to correct for the tilt of the spectrom eter entrance slit with respect to the CCD columns. The correction of the slit tilt is necessary because the sky subtraction algorithm we employ requires that the projected slit in age lie parallel to the detector columns.

The radial velocity of KH 15D relative to the Solar System barycenter is measured from each spectral observation by means of a cross-correlation analysis. For the spectra of KH 15D obtained as part of the P lanet Search observing program, the program stars observed on each night provided an extensive selection of reference stars with known barycentric radial velocities listed in N idever et al. (2002). We selected reference stars that were observed within 30 m inutes of KH 15D and with spectral types ranging from M 0 to G 5. Since the P lanet Search target stars are observed through an iodine cell, orders containing iodine absorption lines are avoided in the analysis. For KH 15D observations obtained as part of program s other than the P lanet Search, a single K type reference star observed either before or

after KH 15D is used as the reference star.

The cross-correlation of each KH 15D spectrum with respect to the reference spectra is perform ed using custom routines written in ID L. The procedure involves rst rebinning each one-dim ensional spectral order onto a new wavelength scale that is linear in log . This ensures that each pixel in the rebinned spectrum represents a velocity interval that is uniform over the entire spectral order (Tonry & Davis 1979). Regions containing telluric lines, strong em ission features, and CCD defects are masked out and each spectral order is cross-correlated with respect to the corresponding order of the reference spectrum. Each spectral order thus yields an independent m easurem ent of the radial velocity of KH 15D relative to the reference star. The average of the ensemble set of velocities from all orders is then adopted as the relative radial velocity of KH 15D for a given epoch.

The relative radial velocities from each night are converted into absolute barycentric radial velocities using the relation

In Eqn. (1), v is the relative velocity from the crosscorrelation analysis; B C_{kh} and B C_{ref} are the barycentric corrections for K H 15D and reference star, respectively; and v_{ref} is the absolute barycentric radial velocity of the reference star as listed in N idever et al. (2002). The m ean m easured velocities from each epoch are listed in the nal column of Table 1. Table 2 lists the velocities obtained from our cross-correlation analysis for each individual reference star on each night.

For nights when only one reference spectrum is available, the uncertainty is estim ated using the standard deviation of the mean radial velocity measured from all echelle orders. For nights with multiple reference spectra, the standard deviation of the velocities computed from each target-reference pair is adopted as the uncertainty. This latter m ethod of error estimation typically yields a larger value than the order-to-order scatter seen for an v 0:6 km s¹ com pared individual observation (0:2 to 0:1 0:3). The larger scatter in velocity meav surem ents am ong the target-reference star com binations is likely due to external system atic e ects such as small. shifts in the position of the CCD throughout the night caused by thermal relaxation of the detector mount. Thus, the standard deviation measured from the echelle orders in a single observation likely underestimates the true uncertainty by approxim ately a factor of two.

3. RESULTS

Figure 1 illustrates how the radial velocity of KH 15D varies temporally out of eclipse over a range of 10.7 km s¹. These data indicate that there must be an unseen star in the system, as had previously been inferred from the analysis of the historical light curve (JW 04). Hereafter we will adopt the naming convention of W 04 and refer to the currently visible star as A and

the hidden companion as B.

3.1. Orbit Solution

U sing a nonlinear least-squares algorithm, we found a best-t model orbit with a period P = 48:38 days, eccentricity e 0:27 and velocity sem iam plitude K 8:15 km s¹. The other orbit parameters are listed in Table 3. Figure 2 shows a plot of radial velocity versus orbital phase for P = 48:38 days. The ms scatter of the t residuals is 0.38 km s¹ and the reduced $\frac{1}{2} = 1.5$. The vertical lines at = 0:33 and = 0:73 denote the approximate phases of ingress and egress, respectively, based on the He02 ephemeris. We have no radial velocity measurements between these phases because of the eclipse of star A.

We nd that the orbit solution is not well constrained due to the lack of data near periapse, which allows the velocity sem i-am plitude of the orbit solution to compensate for changes in the eccentricity. As such, we were able to obtain reasonable ts by xing the eccentricity at values e > 0.27, with each solution yielding di erent values of the orbit parameters and values of $\frac{1}{2}$ that are equivalent at the 97.5% con dence level (based on the 9 degrees of freedom in the t).

Figure 3 show show $\frac{1}{2}$ and the orbit parameters vary

as a function of eccentricity. W hile the period varies little over a wide range of eccentricities, it is apparent that the radial velocity data alone provide poor constraints for the other orbit param eters. However, the implied mass ratio from other K H 15D observations, together with the m easured mass limits of star A, can be used to place limits on the orbital eccentricity, as we now show.

32. O rbit Param eter Constraints

JW 04 determ ined from photom etric m easurements of archival plates that the out-of-eclipse m agnitude of KH 15D was 0.9 m ag brighter (at I-band) 40 years ago compared to the modern bright state. The two most probable explanations for the brighter apparent m agnitude in the past are that either both stars were visible, or that star B alone was visible. If both stars were visible, then $L_B = L_A = 1.3$. If only B were visible, then $L_B = L_A = 2.3$. In either case, the condition $L_B = L_A > 1$ m ust hold.

M ulti-color photom etric m easurem ents obtained during m inim um light show a slight blueing of the color indices (Ha03) compared to the colors at m axim um light. Sim ilarly, Agolet al. (2004) m easure slightly bluer colors during eclipse from their low-resolution spectropolarim etric observations com pared to their out-of-eclipse

observations. O ne possibility for the bluer color indices during eclipse is that the scattered light is dom inated by Rayleigh scattering. However, HeO2 show that there is no reddening of the light from star A during ingress and egress. This suggests that the opacity of the occulting m aterial is wavelength { independent and that the bluer colors are due to a bluer ob ject. Therefore the tem perature of B must be hotter than the tem perature of A, assum ing both stars contribute nearly equally to the scattered com ponent of the light observed during the eclipse of A. How ever, since the colors are only 0.1 m ag bluer atm inim um light (HeO2), $T_{\rm B}$ cannot be much larger than $T_{\rm A}$.

For most low-mass (M $\,<\,$ 1:0 M) pre{main-sequence evolutionary models (e.g Chabrier & Bara e 1997; D'Antona & Mazzitelli 1997) the stellar mass is monotonic with both lum inosity and temperature. For coeval stars on their Hayashi tracks, T_B & T_A and $L_B=L_A\,>\,1$ imply that M $_B$ & M $_A$ or, in terms of the mass ratio, M $_A$ =M $_B$. 1.

The mass function of a Keplerian orbit can be expressed as

where P is the orbital period and K is the velocity sem iam plitude. Solving Eqn. (2) for M $_{\rm A}$ yields

The m ass function $F_M = \sin^3 i$ in Eqn. (3) is calculated from the parameters of the best-t orbit to the radial velocity data with the value of e xed in the tting procedure. Figure 4 shows plots of M_A versus e for M_A=M_B = 0.7, 0.8, 0.9 and 1.0. Also shown is the value of M_A=M_B = 1:6 obtained by W 04 based on their m odel t to the KH 15D light curve (see x4). Since the m ass of the visible star is known to fall within the lim its 0:5 M_A 1:0 M (Flaccom io et al. 1999; Park et al. 2000), it can be seen by inspection of Figure 4 that acceptable choices of the eccentricity fall within the range 0:68 e 0:80.

The resulting range of acceptable orbit parameter values is shown in Figure 3 between the solid, vertical lines in each panel. Column two of Table 3 lists the best-t parameter values obtained using the mean acceptable value of the eccentricity, e = 0.74 (see also Figure 2). The uncertainties in the t parameters were estimated using a M onte C arb simulation. We generated 10^3 statistical realizations of the velocity time series assuming the errors are norm ally distributed with standard deviations equal to the measurement uncertainties. The estimated uncertainties are also displayed in Figure 3 as error bars on the points located at e = 0.74.

3.3. Periodicity

As discussed in x3.1, we nd the best-tK eplerian has an orbital period of P = 48.38 0.01 days. He02 report a period of P = 48.35 0.02 days from their photom etric m on itoring and JW 04 report P = 48.42 0.02 days from

a periodogram analysis of archival photographic plates photom etry. Thus, our measured orbital period di ers by 1:5 and 2 from the modern and historical photometric periods, respectively. Since the evolving shape of the light curve may complicate the accurate determ ination of the photom etric period, we conclude that the orbital period and photom etric period of KH 15D are indistinguishable within measurement errors.

He02 noted that the shape of the light curve varies from eclipse to eclipse in such a way as to suggest a 96day period for the system, with each cycle containing two brightness minima. In order to investigate this alternative periodicity, we xed the period in our t at P = 96.76 days and obtained a reduced $^{-2}$ of 47.5. Based on this poor quality of t, we nd that a 96-day period is incom patible with our radial velocity m easurem ents.

4. DISCUSSION

The results of our spectroscopic monitoring cam paign show that KH 15D is a spectroscopic binary system. The observed radial velocities are consonant with a stellar companion with an orbital period equal to the photometric period. We now discuss the implications of the binarity of KH 15D for current models of the photom etric variability mechanism.

Existing models of the KH 15D eclipse mechanism fall into two classes di erentiated by whether it is the orbital motion of the starora feature of a circum stellar disk that causes the photom etric variability. The rst class of m odels posits the existence of a single star surrounded by a circum stellar disk containing a nonaxisym m etric density enhancem ent or alternatively, a warp. As the disk feature orbits the star with a 48-day period, it periodically blocks the line-of-sight to the stellar surface. Based on their spectropolarim etric observations that showed an increase in polarization during m in im um light, Agolet al. (2004) developed a model of a warped disk with an extended atm osphere and obtained a reasonable t to the 2001-2002 light curve. A sim ilar analysis was perform ed by Barge & Viton (2003) using a model involving a large dusty vortex.

W hile these single{starm odels are able to m atch the light curve of K H 15D at one point in time, they do not

adequately explain the tem poral changes in the observed light curve. Perhaps more im portantly, it is not clear if a binary companion to KH 15D is compatible with an eclipsing disk feature. If a density enhancem ent in a circum stellar disk is responsible for the 48 { day photom etric period, the feature must orbit the central star at a distance of 0:22 AU, assuming a Keplerian orbit. This geometry would restrict the stellar companion to orbit either at a distance less than 0.22 AU or beyond the outer extent of the circum stellar disk. However, since our best-t orbit yields a period of 48:38 0:01 days and asini= 0:21 AU (assuming e = 0:74) for the binary com panion, neither of these scenarios seems plausible. Thus, it does not seem possible for both an eclipsing disk feature and a stellar-mass companion to coexist with the sam e orbital period.

In the second class of models, proposed by W 04 and CM 04, there exists an unseen binary companion of com – parable mass to the visible K -type star seen today. Surrounding the two stars is a circumbinary disk viewed nearly edge-on. The orbital plane of the two stars is tilted at a small angle with respect to the disk plane and the present day light curve is produced as the re ex m otion of Star A carries it above and below the disk plane.

Independent evidence for the binary nature of KH 15D has emerged from studies of archival photographic plates. In a study of photographic plates obtained from A siago O bservatory, JW 04 show that the apparent m agnitude of KH 15D was variable from 1968 to 1983, but the light curve from this epoch wasmarkedly di erent from the one observed today. The bright state was nearly a factor of 2 brighter in the past and the eclipse depth was a factor of 5 shallower. These ndings can be explained by invoking the presence of a second star that was visible in the past but is unseen today (JW 04).

M otivated by these ndings, W 04 constructed a m odel of an eccentric binary with a fraction of the orbital plane obscured by an opaque screen (or circum binary disk) and found a quantitative orbital solution by tting sim ultaneously to the 2001-2002 photom etry of H e02, the historical photom etry of JW 04 and the radial velocity m easurem ents of H a03. B ased on a prelim inary investigation of the radial velocities presented here, CM 04 independently used physical arguments to propose a similar model of an eccentric binary surrounded by a nodally precessing circum binary ring. As the ring precesses, the light curve gradually changes from the one recovered from the archival plates to the shape seen today. Perhaps the greatest advantage of the two-starm odels is their ability to explain not only the present-day light curve, but also its evolution over the past half century.

In addition to explaining the photom etric phenom enology of K H 15D, the two-star models make predictions about the nature of the binary orbit. Both CM 04 and W 04 predict that (1) periastron passage occurs during minimum light, (2) the orbital companion has a mass comparable to the currently visible star, and (3) the binary orbit is highly eccentric. These predictions are precisely what we nd from our orbit solution.

The W 04 m odelm akes additional, quantitative predictions about the orbital param eters of the binary. For an assumed xed period of 48.35 days, the model produces a velocity sem i-am plitude of 27.5 km s¹, eccentricity e = 0.7, a mass ratio M_A=M_B = 1.6, argument of pericenter ! = 7 2 and a center of mass radial velocity = +15.5 km s¹. As can be seen in Table 3, the W 04 M odel 1 predictions agree well with our orbital solution with xed eccentricity, e = 0.74 (see x3.2). We note here that our center of mass velocity for the binary system of = +14.7 0.9 km s¹ clearly rules out W 04 M odel 2, which predicts = +5.7 km s and negative velocity at periapse.

The W 04 m odel also predicts the inclination of the binary orbit, a property of the system that our radial velocities do not. W 04 M odel 1 predicts i = 84 :6 or sin i = 0.996. Sim ilarly, using the geom etry of the circum binary ring proposed by CM 04, an upper lim it on the inclination of i < 80 can be assigned to the binary orbit based on the time lag between periastron passage and m id-eclipse (Chiang, private com m unication).

W e note that the W 04 m odel has the peculiar feature that the less massive star is the m ore lum inous star. Using Equation 3, the values of P, K and e produced by the W 04 m odel lead to a m ass function $F_M = 0.038$ M and $M_A = 0.41$ M. This mass is signi cantly less than the lower lim it of 0.5 M m easured by P ark et al. (2000) and the value of 0.6 M m easured by F laccom io et al. (1999). Figure 4 shows a plot of M_A as a function of e for the W 04

m ass ratio M $_{\rm B}$ =M $_{\rm A}$ = 1:6. For our best-tting m odelparam eters, only eccentricities between 0.58 and 0.65 yield a mass of A between 0.5 and 1.0 M $\,$. Therefore, for a mass ratio of 1.6, the eccentricity reported by W 04 (e = 0.7) is larger than the value allowed by our radial velocity measurements assuming 0:5 Μ_A 1:0 M . However, this discrepancy is not too surprising since the W 04 m odel used only two radial velocity m easurem ents. It is also in portant to note that the mass lim its of star A are derived by placing KH 15D on a theoretical HR diagram and are therefore subject to the accuracy of the PMS evolutionary model employed. In all other features of the KH 15D binary system, there is a rem arkable agreem ent between the W 04 m odel and the orbital solution calculated from the radial velocities. Because of the strong evidence of a second star from our radial velocity measurements and the historical photometry, we nd the two-star class of model to be the most com pelling explanation of the KH 15D photom etric variability m echanism .

H ow ever, the case of the \w inking star" is still far from closed. A key m issing aspect of the two-star models is direct detection of a circum binary disk around K H 15D. H e02 report a lack of near-IR excess and a null detection atm illim eterw avelengths. CM 04 state that such ndings are consistent w ith a circum binary ring having an inner radius of 1 AU that is tidally truncated by the central binary, and an outer radius of 5 AU that is possibly shepherded by an as yet unseen planet. They predict m id-infrared uxes that are observable w ith the Spitzer Space Telescope. C learly such observations w ill be vital in further developm ent of m odels of the K H 15D system.
