# $S^{4} \mathrm{~N}:$ A Spectroscopic Survey of Stars in the Solar N eighborhood ? ? ?

#### Abstract

. W e report the results of a high-resolution spectroscopic survey of all the stars m ore lum inous than $M_{V}=6: 5 \mathrm{~m}$ ag w ithin 14.5 pc from the Sun. The H ipparoos catalog's com pleteness lim its guarantee that our survey is com prehensive and free from som $e$ of the selection e ects in other sam ples of nearby stars. The resulting spectroscopic database, which we have $m$ ade publicly available, includes spectra for 118 stars obtained w ith a resolving pow er of R ' 50;000, continuous spectral coverage between 362921 nm , and typical signal-to-noise ratios in the range $150 \quad 600 . \mathrm{W}$ e derive stellar param eters and perform a prelim inary abundance and kinem atic analysis of the $F-G-K$ stars in the sam ple. The in ferred m etallicity ( $\mathrm{Fe} / \mathrm{H}]$ ) distribution is centered at about $0: 1 \mathrm{dex}$, and show s a standard deviation of 0.2 dex. A com parison w ith larger sam ples of $H$ ipparoos stars, som e of which have been part of previous abundance studies, suggests that our lim ited sam ple is representative of a larger volum e of the local thin disk. W e identify a num ber of $m$ etal-rich $K$-type stars which appear to be very old, con m ing the claim sfor the existence of such stars in the solar neighborhood. W ith atm ospheric e ective tem peratures and gravities derived independently of the spectra, we nd that our classical LTE m odel-atm osphere analysis of $m$ etal-rich (and $m$ ainly $K$-type) stars provides discrepant abundances from neutral and ionized lines of several $m$ etals. This ionization im balance could be a sign of departures from LTE or inhom ogeneous structure, which are ignored in the interpretation of the spectra. A ltematively, but seem ingly unlikely, the $m$ ism atch could be explained by system atic errors in the scale of e ective tem peratures. B ased on transitions of $m$ a jority species, we discuss abundances of 16 chem ical elem ents. In agreem ent with earlier studies we nd that the abundance ratios to iron of Si, Sc, Ti, C o, and Zn become sm aller as the iron abundance increases until approach ing the solar values, but the trends reverse for higher iron abundances. At any given $m$ etallicity, stars $w$ ith a low galactic rotational velocity tend to have high abundances of $\mathrm{M} \mathrm{g}, \mathrm{Si}, \mathrm{Ca}, \mathrm{Sc}, \mathrm{T}$ i, $\mathrm{Co}, \mathrm{Zn}$, and Eu , but low abundances of $\mathrm{Ba}, \mathrm{Ce}$, and Nd . The Sun appears de cient by roughly 0.1 dex in $\mathrm{O}, \mathrm{Si}, \mathrm{Ca}, \mathrm{Sc}, \mathrm{T}$ i, $\mathrm{Y}, \mathrm{Ce}, \mathrm{Nd}$, and Eu, com pared to its $\mathrm{m} m$ ediate neighbors $w$ ith sim ilar iron abundances.

## 1. Introduction

The study of the stellar population of the solar neighborhood is of interest for a w ide range of investigations. $N$ earby stars are the only ones for which we can obtain crucial $m$ easurem ents, such as parallaxes or angular diam eters. T hey are typically the best candidates for very precise spectroscopic follow ups, such as searches for low erm ass com panions (stellar, brow n dw arf, or planetary), circum stellar disks, or solar-like cycles. T heir proxim ity involves obvious advantages that should be exploted.

From a wider perspective, the stellar population of the solar neighborhood $m$ ay be representative of larger parts of the $G$ alactic disk. E arly studies revealed that the sim plest $m$ odels of $G$ alactic chem ical evolution could not $m$ atch the observed $m$ etallicity distribution \{ the so-called G-dw arfproblem (van den Bergh 1962). R ecent investigations have shown that $m$ ore com plex scenarios, such as those including inhom ogeneous evolution ( $M$ alinie et al. 1993) or infall (Chiappini et al 1997), m ore closely resem ble the observations. H ow ever, alm ost all the derived $m$ etallicity distributions of sam ples approxim ately lim ited in volum e, have been obtained from photom etry (T warog 1980; R ocha-P into \& M aciel 1996, 1998a; F lynn \& M orell 1997; K otoneva et al 2002). This is worrying, as it has been recognized that som e of the em ployed photom etric indices $m$ ay be seriously a ected by chrom ospheric activIty (R ocha-P into \& M aciel 1998b; Favata et al 1997a) and other system atic e ects (H ayw ood 2002; R eid 2002; Twarog, A nthony-T warog \& Tanner 2002). These uncertainties can be avoided by using spectra. Favata et al. (1997b) carried out the only existing spectroscopic study of a volum e-lim ited sam ple of nearby stars, and found a $m$ etallicity distribution for $K$ dwarfs which is rem arkably $m$ ore $m$ etal-rich than those obtained through photom etric analyses.

W e have conducted a com plete $\mathrm{M}_{\mathrm{v}}$-lim ited volum elim ited survey ofnearby stars in an attem pt to settle these and other issues. In addition to the C atalogue of $N$ earby Stars (G liese \& Jahrei 1991, hereafter CNS3) \{ used by $m$ ost of the previous studies\{ we have taken advantage of the H ipparcos catalog ( $E$ SA 1997). H ipparcos is com plete down to $V=7: 3^{1}$. Restricting the study to stars brighter than $\mathrm{M}_{\mathrm{V}}=6: 5(\mathrm{r} \mathrm{K} 2 \mathrm{~V})$, H ipparoos' com pleteness reaches out to 14.5 pc. F igur how sthat nearly $25 \%$ of the stars included in CNS3 w ithin 14.5 pc from the Sun (parallaxes larger than 69.18 m as) are in fact farther aw ay according to the accurate parallaxes $m$ easured by $H$ ipparcos.

H igh-dispersion high signal-to-noise optical spectra were acquired for 118 stars: all the ob jects m ore lum inous than $M_{v}=6: 5 \mathrm{w}$ thin 14.5 pc from the Sun. Figure
how s the sam ple's distribution of absolute and visualV m agnitudes: $M_{\mathrm{V}}$ (solid line) and V (dashed line). A s a ref erence, spectral types for dw arfs are assigned to di erent ranges in $M_{v}$. This sam ple, as a result of the dependence of stellar lifetim $e$ on $m$ ass and the shape of the initial $m$ ass function, is dom inated by the coolest stars $w$ ithin our range of spectral types. $T$ his should be bome in $m$ ind when com paring to $m$ ost other high-resolution spectroscopic studies of disk stars, which tend to select warm er targets.

We provide a high-quality spectroscopic archive of these nearest stars. T he data acquisition, reduction and archival, are the sub ject of Sectior M any properties of these stars have been com piled: radial velocities, parallaxes, and proper $m$ otions. O ther properties have been

determ ined afresh: stellar atm ospheric param eters, kinem atics, ages, and chem_icalabundances. T he resulting catalog is described in Sectio xam ines the consistency of the inferred abundances. Section discusses our ndings. Section rom pares the kinem atics and m etallicities of the nearest stars $w$ th larger sam ples of thin-disk stars, and resents a short sum $m$ ary and provides suggestions for future work.
2. Observations, data processing, and nalarchive

The observations were obtained w ith the H arlan J. Sm ith 2.7 m telescope at M CD onald O bservatory and the ESO 1.52 m telescope on La Silla. The spectra have a resolving power of $510^{4}$, fully cover the optical range, and extend into the near $\mathbb{R} . A$ totalofsix observing cam paigns were necessary, as sum $m$ arized in Table 1.

The McD onald spectra were obtained with the 2dcoude spectrograph (Tull et al 1995). This cross-

dispersed echelle spectrograph provides, in a single exposure, fill coverage from about 360 nm to 510 nm , but has increasingly larger gaps betw een redder orders. This problem was circum vented by using two di erent overlapping settings. The detector was TK3, a thinned 20482048 Tektronix CCD with 24 m pixels, which was installed at the F 3 focus. W e used grating E 2, a 53.67 gr $\mathrm{mm}{ }^{1}$ R 2 echelle from M ilton R oy Co. and slit \# 4, which has a central width of 511 m (or approx. 12 arcsec on the sky).

The ESO (La Silla) data were acquired w ith FEROS (K aufer et al. 2000), a ber fed cross-dispersed spectrograph w ith an R2 $79 \mathrm{gr} \mathrm{mm}{ }^{1}$ echelle grating. The detector was a 20484096 EEV CCD w ith 15 m pixels. The FEROS resolving power was about 45000, which is roughly 20 \% lower than that of the 2dcoude spectra. T his instrum ent has a xed con guration, but provides better coverage than the 2dcoude for a single setting: approxim ately from 350 to 920 nm , leaving two gaps at 853 and 870 nm . M ost of the observations from the $M$ ay and Septem ber 2001 runs w ere obtained in bb ject-calibration' mode w th FEROS: the Th-Arlamp was on during the stellar observations and its light fed to the spectrograph. $T$ his $m$ ode was selected due to the fact that the spectra were obtained in betw een observations for a di erent program, for which an accurate wavelength calibration was crucial. T his tumed out to be a disadvantage as, in som e cases, scattered light from A $r$ lines in the red a ected the stellar spectra.

A im ing for very high signal-to-noise ratios, at least tw o exposures per setting w ere obtained at M CD onald. D ue to a $m$ ore lim tited observing tim e, a lower $S=N$ was reached for the stars observed from E SO, for which a single exposure w as typically obtained. About 2/3 of the sam ple was observed from M CD onald. F if rom pares the M CD onald and ESO spectra of H $\mathbb{P} 10798 \mathrm{In}$ the region of the Ca I line at 6162 nm .

The spectra were reduced with $\mathbb{R} A F^{2}$, using the im red, codred, and echelle packages. T he processing included

overscan subtraction, at elding, scattered light rem oval, optim al extraction and wavelength calibration. Th-Ar observations were very frequent at McD onald. These were combined into an atlas available from the $W$ W W ${ }^{3}$ (A llende P rieto 2002a). T he instrum ental response, dom inated by the blaze function characteristic of an echelle spectrograph, was carefully rem oved by two-dim ensional m odeling follow ing Barklem et al. (2002). The blue and red setups (MCD onald spectra) were com bined. Finally, the orders w ere $m$ erged into a continuous spectrum .

In an attem pt to produce a highly hom ogeneous archive, the nal spectra were velocity corrected using the central w avelengths of hundreds of solar atom ic lines as reference (A llende P rieto \& G arc a Lopez 1998). The M CD onald spectra w ere then truncated to the w avelength range $362\{1044 \mathrm{~nm}$, while the E SO spectra were restricted to the range $362\{921 \mathrm{~nm}$. Errors in the uxes were esti$m$ ated from three sources: the P oisson noise ( $\mathrm{p} \overline{\text { photons }), ~}$ the continuum placem ent, and an absolute lim it im posed by the best correction of pixel-to-pixel sensitivity variations we can achieve. The uncertainty in the continuum placem ent for McD onald spectra w as estim ated by com paring our sky-light' spectrum, obtained through a port that brings day light from the sky to the slit room, with the solar ux atlas of K urucz et al. (1984). For the E SO spectra we com pared spectra of stars observed both from ESO and M CD onald. Fis tributions adopted for the $M$ CD onald sky (solar) spectrum .

In $F$ ic sky spectrum and the Kurucz et al. (1984) solar atlas (thick solid line) are due to di culties in selecting uniquely

the position of the pseudo-continuum in the blue wavelengths due to severe line absorption, and to the presence of telluric features and di erent observing conditions in the red and infrared part of the spectrum. T he zigzagging shape of the P oissonian lim it curve (thin solid line) is caused by the com bination ofm ultiple observations of the sam e spectral segm ents in contiguous orders of the sam e setting, and also by the overlapping wavelength coverage betw een the tw o settings. T he wide peak at 500 nm corresponds to the so-called picket fence' in the McD onald spectrum \{ stray light re ected by the CCD back to the grating. It is also worthwhile to mention that the ESO spectra at and near $H$ have large error bars due to a reection from the ber, and thus the $H$ spectrum in the ESO spectra is unreliable. An error spectrum has been assem bled along w th each stellar spectrum, which re ects the com bined error as discussed above.

The spectra are archived in FIT S ${ }^{4}$ form at, and are available through the intemet at the $S^{4} \mathrm{~N}$ site ${ }^{5}$.

## 3. The $S^{4} \mathrm{~N}$ catalog

### 3.1. Stellar param eters

The traditional' procedure to derive stellar param eters for a spectroscopic analysis involves the use of photom etry and the spectra them selves. Am ong the photom etric calibrations available to derive the stellar e ective tem perature, those based on the infrared ux m ethod ( $\mathbb{R F M}$, B lackwell et al. 1977) have been proven very precise and were adopted here \{ alw ays assum ing that the reddening m ust be negligible w ithin 15 pc .0 ptical and in frared colors are only weakly sensitive to other stellar param eters.


The extrem e accuracy of the parallaxes provided by the $H$ ipparoosm ission for the nearest stars, can be exploited to tightly constrain their brightness and gravity. Such gravities are practically independent from $m$ odelatm ospheres. O ur atm ospheric stellar param eters are, therefore, independent from the high-resolution spectra, and can be considered fairly robust against the subtleties involved in the interpretation of the high-resolution spectra.

### 3.1.1. P hotom etry

V isualm agnitudes, b y and $\mathrm{C}_{1}$ indiges w ere com piled from H auck \& M erm illiod (1998). Som etim es this source does not provide uncertainties for the data, and we adopted 0.01 m ag. W hen V m agnitudes were not available from H auck \& M erm illiod, we searched K omilov et al. (1991), correcting their values using

where the subscript $K^{\prime}$ indicates $K$ omilov et al. magnitudes, for which we adopted an error of 0.01 m ag. This correction follow $s$ the recom $m$ ended transform ation by K omilov, M ironov, \& Zakharov (1996).W hen a star was not in any of these sources, we used $H_{p}$ from $H$ ipparcos, the H ipparoos ( $\mathrm{B} \quad \mathrm{V}$ ) and the Simbad ( $\mathrm{U} \quad \mathrm{B}$ ) ${ }^{6}$ w ith H arm anec's (1998) form ulae to estim ate $V$, and assign either 0.01 m ag of error or the 1 uncertainty in H p , whatever is larger. W e also com piled B V,V I, $H_{p}, V$, and their uncertainties from the $H$ ipparoos catalog. T hese data are available on the $S^{4} \mathrm{~N}$ w eb site.

### 3.12. E ective tem perature

W e used the Strom grem photom etry and the ( $B \quad V$ ) index w th the A lonso et al. (1996; 1999a) calibrations to derive $T_{e}$. The $\mathbb{R F M}$ is based on the com parison betw een the bolom etric $u x$ and the $m$ onochrom atic $u x$ at a selected wavelength in the infrared. Follow ing the application of the $\mathbb{R} F M$ to derive $T_{e}$ for a large num ber of stars, A lonso et al derived photom etric calibrations. U se ofsuch calibrations does not require bolom etric uxes and bene ts from the statistical elim ination of outliers. O ure ective tem peratures are based on such photom etric calibrations, which are also dependent (although weakly) on the stellar $m$ etallicity and surface gravity. W e begin by assum ing $\mathbb{F e} / \mathrm{H}=0^{7}$. Then, other stellar param eters, inchuding $\mathbb{E e} / \mathrm{H}]$, are determ ined from the spectrum (see below ), and a second iteration is applied to derive the $T_{e} S$ in $T$ ables 2-4. T he error bars assigned to the tem peratures have been derived from propagating the uncertainties in the photom etry through A lonso et al.'s polynom ials. W e

found the calibration based on (b $y$ ) and $C_{1}$ to provide slightly wam ertem peratures than the values from (B V) by an average of $42 \quad 6 \mathrm{~K}$, w th an ms di erence of 61 K .

An independent assessm ent of the scale of e ective tem peratures can be obtained by exploiting the sensitivIty of the wings of Balm er lines to the therm al structure ofdeep atm ospheric layers. E chelle spectrographs are not ideally suited for $m$ easuring the shape of broad features such as the wings of Balm er lines, but as we explained in we paid particular attention to the continuum nom allzation of our spectra. The $H$ pro les in the ESO spectra are unreliable, as suggested by the di culties encountered in the nom alization process. H ow ever, we deem $H$ for these spectra as reliable', and both $H$ and H in the 2dcoude spectra, as highly reliable'. We calculated synthetic pro les for $H$ and $H$ as described by Barklem et al. (2002). Stark broadening is described by the $m$ odelm icro eld $m$ ethod calculations of Stehle \& Hutcheon (1999) and selffbroadening by calculations of Barklem, P iskunov \& O M ara (2000a,2000b). R adiative broadening is included, and so is an estim ate of the helium collisionalbroadening (based on rescaling ofB ark lem \& $O \mathbb{M}$ ara 1997), although both e ects are small. The m odel atm ospheres w ere com puted w ith the sam e version of the MARCS ande as the models em ployed to derive abundances (see $\quad$ The only di erences a ect the convection param eters.C onvection is described by them ixing length treatm ent, where for our purposes the most im portant param eters are the $m$ ixing-length $l$, which is usually expressed in units of the pressure scale height as the $m$ ixing-length param eter $=l=H_{p}$, and a second param eter $y$ describing the tem perature structure $w$ thin convective elem ents (see $H$ enyey et al. 1965 for details). T he standard set of param eters in the MARCS code are $=1: 5$ and $y=3=(4)^{2}$, and these are adopted for the $m$ odels used in the abundance analysis. A s seen in Barklem et al. (2002; see also Fuhm ann 1998 and references therein), a better $m$ atch to the observed pro les can be achieved by reducing the $m$ ixing length. Thus, for our analysis of hydrogen lines we adopted a model grid with $=0: 5$ and $y=0: 5$ as in Barklem et al. (2002). We note that the di erent values have a negligible im pact on the overall tem perature scale (B arklem et al 2002). The e ective tem peratures were determ ined by 2 tting as described in Barklem et al. (2002).

Figure shows the di erences betw een the $\mathbb{R} F M$ based $T_{e} S$ and those from B alm er lines (w eighted average of $H$ and $H$ ). The agreem ent is satisfying; B alm er lines tem peratures are warm er with a m ean di erence of just 3515 K , and an m s di erence of $84 \mathrm{~K} . \mathrm{F}$ ig ndicates that the Balm er-line tem peratures $m$ ay be sligntly higher for stars w ith $\mathrm{T}_{\mathrm{e}}<4900 \mathrm{~K}^{8}$. A sim ilar e ect was also

noted by B arklem et al. (2002) for a di erent sam ple, but, as they rem arked, the reader should bear in $m$ ind that errors in B alm er-line tem peratures are largest in that do$m$ ain due to a) the reduced sensitivity of the line $w$ ings, and $b$ ) an increasing contam ination by $m$ etallic lines. T he second e ect can potentially induce a bias in the observed sense. Balm er-line $T_{e}$ s might also be slightly cooler for the w arm er stars in our sam ple.

Recently, $K$ ovtyukh et al. (2003) have derived e ective tem peratures for late-type dw arfs using line-depth ratios. From 13 stars in com $m$ on, we nd their tem peratures system atically higher by $11912 \mathrm{~K}(=43 \mathrm{~K})$ in the range $5000<\mathrm{T}_{\mathrm{e}}<6000 \mathrm{~K}$. An aberrant exception takes place for H $\mathbb{P} 23311$ (HR 1614), forwhich they derived 4945 K , but our preferred value is $4641 \mathrm{~K} . \mathrm{W}$ e note that Feltzing \& G ustafsson (1998) found 4625 K from Strom grem photom etry, and Feltzing \& G onzalez (2001) arrived at 4680 K from the excitation equilibrium ofneutraliron and nickel ${ }^{9}$. From tting the wings of B alm er lines, we obtain an interm ediate value of $4789 \quad 110 \mathrm{~K}$.

### 3.1.3. M etallicity, surface gravity, age, $m$ icro and m acroturbulence

M etallicities are rst estim ated from the autom ated system described by A llende P rieto (2003). G ravities (and ageswhen possible) are then estim ated from $\mathrm{T}_{\mathrm{e}} ; \mathrm{M}_{\mathrm{V}}$, and $\mathbb{F e} / \mathrm{H}]$, by using B ertelliet al. (1994) isochrones in a sim ilarm anner to $A$ llende $P$ rieto et al. (2003) and $R$ eddy et al. (2003). M ore details are provided in A ppendix A. A rst abundance run $w$ ith the selected spectral line pro les and using MARCS m odels (see provided re ned values for $\mathbb{F e} / \mathrm{H}]$, the $m$ icroturbulence ( ), and the $m$ acroturbu-

lence ( ), that were also used to determ ine the nal $T_{e}$ (from photom etry) and gravities (from the isochrones). The nal stellar param eters are listed in T ables 2-4. Fig. lisplays the distribution of the stars in the $\mathrm{M}_{\mathrm{v}}$ vs. $\mathrm{T}_{\mathrm{e}}$ plane. T w o solar-com position isochrones of ages 1 and 10 G yr are also shown.
$T$ he derived values for the $m$ icroturbulence ( ${ }^{P_{2}}$, where is the standard deviation of a G aussian distribution) are a function of the $T_{e}$ and logg of the stars, as previously found by other authors (e.g. N issen 1981; Edvardsson et al. 1993; Reddy et al. 2003). For our sam ple, the expression

## 32. K inem atics

Radial velocities were compiled from the catalogs of $B$ arbier $B$ rossat \& $F$ igon (2000) and $M$ alaroda, Levato \& G alliani (2001). P roper $m$ otions and parallaxes w ere extracted from the H ipparoos catalog (ESA 1997). W e derived stellar UVW galactic velocities follow ing Johnson \& Soderblom (1987), but as all H ipparoos astrom etry is given in the ICRS system J199125 (TT), we use ${ }_{\mathrm{NGP}}=192: 85948$ deg, $\mathrm{NGP}=27: 12825 \mathrm{deg}$, and $0=$ 122:93192 deg (ESA 1997; vol 1). W e m odi ed Johnson \& Soderblom 's form ulation to account for the correlations betw een the astrom etric param eters given in the $H$ ipparcos catalog. T he details are explained in A ppendix B.N o corrections have been introduced for the solar peculiar motion. The derived galactic velocities and input data are given in the electronic Table 5.

### 3.3. Chem ical abundances

W e carried out an extensive search for atom ic data, $m$ ainly transition probabilities, for elem ents producing lines in the spectral range of our observations. O ur search concentrated on reliable laboratory $m$ easurem ents and accurate theoretical calculations. C andidate lines were exam ined in the high-dispersion atlases of A rcturus ( H inkle et al. 2001), Procyon (G ri n \& G ri n 1979; A llende P rieto et al. 2002c), and the Sun (K unucz et al. 1984), to identify the best abundance indicators.

A total of 68 features were selected. These features w ere single-com ponent lines, or the result ofm ultiple transitions ( hfs , isotopic shifts, and blends), requiring 275 com ponents and providing abundances for 22 chem icalelem ents. O ur analysis considers line pro les and, therefore, we were able to use full pro les or parts of line pro les. $N$ atural and van der $W$ aals broadening were accounted for using data from VA LD ${ }^{10}$ (K upka et al 1999) and the calculations of $\mathrm{Barklem}, \mathrm{P}$ iskunov \& O M ara (2000c, and references therein) respectively. Hyper ne structure and isotopic splittings w ere considered for lines of Cu I (K unucz's web site ${ }^{11}$ ), Sc II (data com piled by Prochaska \& M dV illiam 2000 for 6245.622 and 6604.6; from M ansour et al. 1989 for 6300.684 and 6320.843), M n I (com piled by Prochaska \& M cW illiam 2000), B a II (com piled by M CW illiam 1998) and Eu II (Law ler et al. 2001). Solar isotopic ratios were alw ays assum ed. Table 6, available only electronically, provides a sum m ary of our adopted w avelengths, excitation potentials, and transition probabilities.

The parts of the spectrum selected for the analysis de ne a 'm ask' that we use for all late-type stars. W e exclude the core of strong lines (relative ux lower than $60 \%$ of the pseudo-continuum level), in an attem pt to $m$ inim ize the im pact of departures from LTE. W e analyze the spectra w ith M ISS (A llende P rieto et al 1998,

[^7]2001), adopting theoretical ' 97 M ARCS LTE blanketed m odelatm ospheres (G ustafsson et al. 1975; A splund et al. 1997), to nd the set of abundances, $m$ icroturbulence, and $m$ acroturbulence that best reproduces the observations. W e chose to use a G aussian broadening function (referred to as $m$ acroturbulence' or ) to account for large-scale turbulence (proper $m$ acroturbulence), rotational and instrum entalbroadening. $T$ he determ ination ofabundances, m icro, and m acrotunbulence, is accom plished by m inim izing the ${ }^{2}$ between synthetic and observed line pro les, and this can be carried out w ith all lines sim ultaneously, or line-by-line. A fter prelim inary all-lines runs to determ ine the $m$ icro and $m$ acroturbulence, and the overall $m$ etallicIty to be adopted in the calculation of the model atm ospheres, we used a line-by-line approach to identify outliers and estim ate intemaluncertainties. Table 7, available only electronically, provides the naladopted abundances for all stars. These abundances are discussed in Section The stated uncertainties are the standard deviation from di erent lines (w hich is set to zero w hen there is only one line involved).

Them edian m sscatterwe nd for the abundance of a given elem ent in a given star is 0.04 dex, but other system atic contributors exist. D epartures from LTE and stellar granulation in the real photospheres w ill bias abundance estim ates from individual lines di erently. W e refer every single abundance estim ate from a line to the solar abundance from the same line. Thus, our approach is strictly di erential. This should reduce system atic errors due to the shortcom ings of our $m$ odeling, but given the large spread in atm ospheric param eters of our stars, w ill certainly not succeed in rem oving them com pletely. D ealing w ith N LTE and inhom ogeneities is very im portant in som e cases, but exceeds the scope of this w ork. T hese errors add to the pool of uncontrolled uncertainties together with unrecognized blends, and errors in the continuum nom alization. F inally, even for these nearby stars, errors in the atm ospheric param eters are a signi cant, fortunately controlled, source of uncertainty. $W$ e have estim ated such errors by repeating the calculations $w$ ith $m$ odelatm ospheres w ith perturbed atm ospheric param eters. As the gravities and $m$ etallicities are precisely determ ined and these param eters only produce $m$ inor changes in the abundances com pared to variations in the $T_{e}$, we have estim ated the $e$ ect of increasing the $T_{e} s$ by 3 and added that information to Table 7.

A dopting $K$ urucz (1993) non-overshooting $m$ odel atm ospheres instead of M ARCS m odels, we system atically change the tem perature and pressure strati cation, and then the derived abundances. A though the changes are generally less than 0:1 dex, for som e ranges of the atm ospheric param eters and som e particular elem ents they can be som ew hat larger. This is illustrated in $F$ ic or a solarlike star (H $\mathbb{P}$ 22263), two late G type stars W ith extrem e m etallicities in our sam ple ( $\mathrm{H} \mathbb{P} 171 \mathrm{w}$ ith $\mathbb{F e} / \mathrm{H}]^{\prime} \quad 0: 8$ and $H \mathbb{P} 43587$ w th $\left.\mathbb{F e} / \mathrm{H}]^{r}+0: 3\right)$, and an F -type star w th solar-like abundances ( $\mathrm{H} \mathbb{P}$ 37279).

## 4. Ionization and excitation balance

As a consistency check of the high-dispersion spectroscopic analysis, we exam ine whether the abundances derived from di erent lines of the sam e elem ent agree. Inspection of the abundances from lines of di erent excitation for Fe I (TiI, or Ca I) reveals no clear sign of correlations. H ow ever, it soon becam e obvious that iron abundances derived from lines of neutral or ionized iron provided system atically di erent values. This e ect is ilhustrated in F if or Fe and C a, where it can be seen that the di erences can reach $0: 5$ dex for the $m$ ost $m$ etal-rich stars in the sam ple. Sim ilare ects are apparent for Siand Ti. A parallel analysis of the nearby star sam ple based on K unucz's m odel atm ospheres show s a sim ilar pattem and $m$ agnitude for the ionization im balance to that found w ith MARCSm_odels, although the detailed shape of the trends in F io hanges.

### 4.1. P recedents

Serious worries about the ionization balance in $K$-type dwarfs appeared in the work by O inas (1974). Perrin, C ayrelde Strobel \& C ayrel (1975) revisited the issue and concluded that the $m$ agnitude of the problem was overestim ated by $O$ inas and the discrepancies perhaps not signi cant.

In $m$ ore recent tim es, Feltzing \& G ustafsson (1998) reported the case of ve $K$-type dwarfs that show ed dra$m$ atic di erences betw een the abundances from lines of neutral and ionized Fe , and the sam e ect was apparent for C a and Cr. Thoren \& Feltzing (2000) reanalyzed som e of the problem atic stars in Feltzing \& G ustafsson (1998), suggesting adjustm ents to the the $\mathrm{T}_{\mathrm{e}}$ scale to solve the discrepancy.

Very recently, Schuler et al. (2003) have reported sim ilar problem s w ith several K dwarfs in the open cluster M 34.W ith e ective tem peratures set to satisfy the excitation equilibrium ofFe $I$, and gravities assigned from the positions of the stars on the $m$ ain sequence, their standard LTE analysis resulted in consistent abundances from Fe I and Fe II lines for warm stars ( $T_{e} \quad 5500 \mathrm{~K}$ ), but signi cant deviations from the ionization balance for $m$ ost of the cooler dwarfs. Sim ilar to the cases of the nearby K dwarfs and those in the Feltzing \& Gustafsson sam ples, Schuler et al found signi cantly larger abundances (up to 0.6 dex) from Fe II lines. The abundances they derived for the $K$-type stars from $F e ~ I ~ l i n e s ~ w e r e ~ s i m ~ i l a r ~$
to the abundances for warm er chuster stars that did not show the problem. T he sym ptom s are not unique to M 34, as show $n$ by Yong et al. (2004) for the $H$ yades. T he iron abundance inferred from Fe II lines continues to diverge at coolere ective tem peratures, exceeding the values from Fe I lines by $m$ ore than an order of $m$ agnitude for stars w th $\mathrm{T}_{\mathrm{e}} \quad 4000 \mathrm{~K}$ in this chuster.

A s we discuss below, adjusting the stellar param eters to $m$ ake ends $m$ eet is not easily justi ed for our sam ple. W e should note that $m$ ost of the previous high-resolution spectroscopic surveys have been forw arm ( $F$ - and early G) stars w ith m odest iron enrichm ents (see, e.g. Edvardsson et al. 1993; Reddy et al. 2003). From inspection of $F$ iq
we would expect those studies to nd only m inor (< 0.2 dex) deviations from the LTE ionization balance.

## 42. Errors in the atm ospheric param eters?

To reconcile the abundances from neutraland ionized lines for the $m$ ost $m$ etal-rich (and cool) stars in $F$ if y m odifying the trigonom etric gravities w ould require to decrease them from $\log g^{\prime} 4: 6$ to $3: 8$. Sim ilarly, the abundances could be reconciled by increasing the $\mathrm{T}_{\mathrm{e}}$ sby 350 K .0 ur list of Fe I w as punctiliously selected for being clean and having accurate atom ic data, but it spans a lim ited range in excitation energy. A test for $H \mathbb{P} 69972$ ( $\mathrm{T}_{\mathrm{e}} \quad 4700 \mathrm{~K}$ ) w th 47 Fe I lines draw $n$ from the lists ofB lackw ell, LynasG ray \& Sm th (1995) and H olw eger, K ock \& B ard (1995) spanning a range ofexcitation potential from 0.1 to 4.7 eV show sthat a change of 300 K (from 4671 K to 4971 K ) results in a change in the slope of the abundances from 0.06 to $0.01 \mathrm{dex} / \mathrm{eV}$, increasing the m ean abundance from Fe I by only 0.05 dex, and bringing a $m$ arginal im provem ent in the standard deviation from 0.14 dex to 0.13 dex. The sam e change is able to bring down the $m$ ean abundance derived from Fe II lines by roughly 0.5 dex.

The lines of neutral $m$ etals $w$ ith weak-to-m oderate strength in a solar like star tend to becom e very strong in cool m etal-rich stars. $W$ ith stronger lines the role of the dam ping constants is enhanced (see, e.g., R yan 1998). O ur analysis m akes use of line pro les, rather than equivalent widths, and adopts, when available, the dam ping param eters calculated by Barklem et al. (see x3), which we consider reliable to w ithin $10 \%$. O ur neutral iron lines are signi cantly stronger (equivalent w idths betw een 7 and 14 pm ) for a star like H $\mathbb{P} 69972$ than in the Sun. The selected Fe II lines, in tum, are all w eaker than 8 pm in the spectrum of $H \mathbb{P}$ 69972. The situation for our calcium lines, how ever, is quite di erent, and yet the sam e shiff betw een the abundances from lines of neutral and ionized species is found. As shown in F ig even if we only consider the wings of strong $C$ a lines in the analysis, C a I and C a II lines point to quite di erent abundances. These di erences could again be bridged by reducing the surface gravily by 0:6 dex, or increasing the e ective tem perature by 280 K (w eakening the C a I line).

H ow ever, a system atic m odi cation by 300 K of the e ective tem perature from the $\mathbb{R}$ FM calibrationswellexceeds the expected uncertainties. For exam ple, the $T_{e}$ calibration based on (B V) for dw arfs and subgiants, w as derived from data for 410 stars, yielding a standard deviation of $130 \mathrm{~K} . \mathrm{T}$ he calibration for the Strom grem photom etry was based on 289 stars w ith a standard deviation of 141 K . In addition, we nd an excellent agreem ent betw een the $T_{e} s$ derived from ( $B \quad V$ ) and Strom grem photom etry, and, independent $\mathrm{lv}_{\mathrm{y}}$ from the analysis of the wings of Balm er lines (see Finally, we should em phasize that the stellar param eters for our sam ple are well bracketed by those of the stars used to de ne the A lonso et al. calibrations.

It is intriguing to consider that the problem $m$ ay be associated w ith the trigonom etric gravities, but this is extrem ely unlikely given the size of the discrepancy. From inspection of $T$ ables 2-4, one notices that the corrections required are about 10 tim es the estim ated uncertainties in this param eter. A dditionally, Feltzing \& G ustafsson arrived at sim ilar gravities for their $K$ dw arfs (in som e cases very di erent from those determ ined spectroscopically) from trigonom etric parallaxes and the pressure-sensitive $w$ ings of strong $m$ etal lines. Interestingly, com parison betw een precise stellar radii for stars in eclipsing binaries w ith evolutionary isochrones has shown that $G$ and K type stars in detached system s are brighter than predicted (see, e.g., C lausen et al. 1999; A llende P rieto 2001; T orres \& $R$ ibas 2002; $R$ ibas 2003). For a reliably determ ined $M_{V}$, predicted radii are sm aller by $10 \%$ and therefore gravities larger by 0.1 dex. This e ect is as yet not well understood (see, e.g., Lastennet et al 2003 for a possible solution), but cannot explain the ionization shift we nd, because it is too sm all.

A stem pting as it $m$ ay be to $m$ odify the stellar param eters to com ply w ith the ionization balance, we cannot do so w ithout violating robust observational constraints.

### 4.3. Possible explanations

Ionization shifts w ith respect to theoretical predictions have been previously reported for $m$ etal-poor stars in the form ofdi erences betw een spectroscopic and trigonom etric gravities, and are often attributed to departures from LTE. In fact, deriving higher abundances from Fe II lines seem s consistent w th the hypothesis of non-LT E overionization as a plausible explanation. The m ild correlation of the e ect with $T_{e}$ in $F$ ig serious discrepancies appear at $\mathrm{I}_{\mathrm{e}}<5000 \mathrm{~K}$, which is $w$ here $m$ ost of the iron becom os neutral in the line form ation region, as show in Fis Departures from LTE are believed to cause an overionization of iron com pared to LTE predictions in solar-like stars (see, e.g. Shchukina \& Tru ملحتز B ueno 2001). The e ects are felt in the analysis of Fe I lines, but not for Fe II lines for a solar-tem perature dw arf, because $m$ ost of the iron atom $s$ are ionized in the
line-form ing region. H ow ever, the argum ent reverses for stars w ith an e ective tem perature low er than about 5000 K . B esides, a higher $m$ etal abundance in the photosphere decreases gas pressure and enhances electron pressure, shifting the Saha ionization balance tow ards neutral iron. Thus, departures from LTE in Fe II levels would qualitatively agree with the inconsistencies shown in F ig How ever, as shown also in Fig the situation for C a I, which is ionized w ith only 6.1 eV in com parison to 8.9 eV for Fe I , is very di erent. C a is still com pletely ionized everyw here in a solar-com position $m$ odelatm osphere even for an $T_{e}$ as low as 3700 K . Yet, calcium show sa sim ilar ionization problem as iron.

O ther factors, such as surface inhom ogeneities (granulation, spots, etc.), incom plete opacities (due to, e.g., m olecules), chrom ospheric or $m$ agnetic activity, $m$ ay be responsible instead. In an early $K$ dw arf, the region where the largest velocity and tem perature am plitudes of granulation take place is slightly beneath the visible layer (N ordlund \& D ravins 1990). A s discussed by D ravins \& Nordlund (1990a, 1990b) based on 3D hydrodynam ical sim ulations, this results in relatively sm all line asym $m$ etries and shifts com pared to w arm er stars, but causes the physical conditions to change very rapidly with the for$m$ ation height of a line. $T$ he form ation of high excitation lines $m$ ay be biased tow ards the hotter granules, $m$ aking the lines of ionized species stronger than predicted with a hom ogeneous m odel.

In any event, it appears safer in the context of this study to embrace the abundances from the dom inant species for the cooler stars (w hich are also the m orem etalrich stars) of our sam ple. A s the abundances from Fe I and II lines are roughly in agreem ent form ost of the warm er stars, in what follow $s$ we adopt the $m$ ean iron abundance derived from Fe I lines as our m etallicity indicator. W e still will use line-to-line di erential abundances with respect to the Sun, and therefore the notation $\mathbb{F e} / \mathrm{H}] \mathrm{w}$ ill, from now on, refer to Fe I abundances relative to the Sun.

## 5. D iscussion

### 5.1. Selection of 'norm al' stars

Som e of the observed stars rotate too fast to be handled sim ilarly to the rest of the sam ple and were not included in the subsequent analysis. $T$ hese are: $\mathrm{H} \mathbb{P}$ 32349, $\mathrm{H} \mathbb{P}$ 57632, H $\mathbb{P}$ 77952, H $\mathbb{P}$ 86032, H $\mathbb{P}$ 91262, H $\mathbb{P}$ 97649, H $\mathbb{P}$ 107556, and H $\mathbb{P}$ 113368. H $\mathbb{P} 24608 \mathrm{was}$ found to have peculiar pro les and should be studied separately, and H $\mathbb{P} 61941$ is a visual binary w ith a separation of about 1.6 arcsec that could not be resolved at the tim e of the observations. H $\mathbb{P}$ 69673, A rcturus, is the star w ith the low est gravity in the sam ple. Its surface com position does not $m$ atch that of typical disk stars (P eterson et al. 1993), and w as also excluded.

Spectroscopic binaries were not set aside a priori, unless double lines were obvious. $T$ he doubled-lined $K$ type spectroscopic binaries H $\mathbb{P} 97944$ (HR 7578) and H $\mathbb{P}$

117712 (HR 9038) w ill not be discussed here. B oth system $s$ w ere observed when the lines are well separated. H R 7578 has a period of 46.8 days, and an eccentricity of 0.68 (Fekel \& Beavers 1983). It is known to exhibit peculiar abundances (Taylor 1970; O inas 1974). HR 9038 is part of a m ultiple system, $w$ ith at least a nearby M 2 . It has a period of 7.8 days and a circular onbit (H albw achs et al. 2003), but no abundances have been reported before. T he spectra of these system $s$ deserve a m ore detailed study which would depart from the scope of this paper.

Fast rotators and single-lined binaries are included in the discussion of kinem atics. Ignoring the possibility of cleaning our sam ple w ith extemal in form ation will allow us to perform a m eaningful com parison $w$ th larger sam ples ofm-ore distant, and therefore less-studied, stars (see Section Even if the multiplicity fraction is as high as

 (Halbwachs et al 2003; M ason et al 2003), this will have only a lim ited e ect on the derived velocty distributions. Fast rotating and double-lined binaries discussed above are excluded from the abundance analysis, but single-lined spectroscopic binaries with apparently clean spectra are not, as no signi cant di erences w ere noted betw een those identi ed as m em bers ofbinary system $S$ in SIM BAD and the rest (see below).
## 52. K inem atics and m etallicity distribution

In $F$ is ponents and iron abundances for the sam ple. G aussian distributions have been $t$ to the data, and are usually fair approxim ations. T he zero points of the velocity com ponents re ect the solar m otion w th respect to its nearest neighbors (w hat has been som etim es tem ed the solar basic $m$ otion). T hese num bers are in good agreem ent w ith older determ inations (see, e.g.D elhaye 1965;W oolley 1965) and for $U$ and $W$, but not for $V$ due to the dependence of this param eter on the stellar population (asym $m$ etric drift), they also agree very well $w$ th the solar peculiar $m$ otion $w$ ith respect to the local standard of rest (circularm otion; see D ehnen \& B inney 1998). Thew idths of the distributions are consistent $w$ ith values derined from larger sam ples, but we w ill revisit this issue in To explore the e ect ofbiases due to evolutionary e ects (m ore m assive stars that have already died), we have restricted the sample to stars w th $T_{e}$ cooler than 5500 K. Such distributions (dashed lines) have been rescaled to $m$ atch the $m$ axim a of the total distributions and help the eye in the com parison. N o signi cant di erences are apparent in the velocities.

Them etallicity distribution of nearby late-type stars hasbeen extensively discussed in the literature. T his is the rst tim e, how ever, that it hasbeen derived for an absolute m agnitude-lim ited sam ple using spectroscopy. A G aussian provides a fair approxim ation to the $\mathrm{Fe} / \mathrm{H}]$ distribution of our sam ple. W hile the w idth of the distribution is in good agreem ent $w$ th $m$ ost previous results, the center of the G aussian, at 0:11 dex, is slightly higher than $m$ ost stud-

ies (but see H ayw ood 2001, 2002). R estricting the analysis to the coolest stars ( $\mathrm{T}_{\mathrm{e}}<5500 \mathrm{~K}$ ), the resulting m etallicity distribution is shifted to higher values. Further reduction of the $m$ axim um $\mathrm{T}_{\mathrm{e}}$ to 5000 K does not alter the $\mathbb{F e} / \mathrm{H}]$ distribution anpreciably. T he discussion on the ionization balance in $n$ ay leave som e readers worried about how uncertainties in theoreticalm odelatm ospheres $m$ ight a ect the derived distribution. It su ces to say that adopting the average ( $\mathrm{Fe} \mathrm{I}+\mathrm{Fe}$ II) abundances, would shift the center of the (full sample \{ solid line) $\mathbb{F e} / \mathrm{H}$ ] distribution in the $F$ igure to $0: 06$ dex.
$T$ he existence of super-solar $m$ etallicity stars in the local disk has been known for a long time (e.g. Spinrad 1966; Spinrad \& Taylor 1969; Taylor 1970). C uriously, the m ost m etal-rich stars are m ainly dwarfs and subgiants w ith spectral types $F$ or later (e.g. Feltzing, H olm berg \& H urley 2001; A llende P rieto 2002b; Taylor 2002). Fig. show clearly that the $m$ ost $m$ etal-rich stars in our volum e-lim ted sam ple are also the coolest. M etal-poor

$m$ ain-sequence stars are less lum inpus than their $m$ etalrich counterparts, and in $F$ igur stars at the low est tem peratures 15 , at least in part, the result of having a $M_{v}$-lim ited sam ple.

H $\mathbb{P} 69972$ (HD 125072) appears to be them ost m etalrich star in the sample. The Fe I-based metallicity is roughly $+0: 5$ dex, am ong the largest values reported in the literature (e.g.B uzzoniet al2001; T aylor2002; C hen et al. 2003). T he Fe II-based m etallicity of this star is about one dex higher than solarbut, given the inconsistency betw een Fe I and Fe II abundances, and the $m$ uch higher sensitivity of the Fe II lines to tem perature changes, we think such a higher abundance is unlikely. This star was previously analyzed by Perrin, C ayrel de Strobel \& D ennefeld (1988), who derived a low er value of $\mathbb{F e} / \mathrm{H}]=+0: 26$ dex $^{12}$. R einforcing the discrepancy, their adopted e ective tem perature was nearly 300 K wam er than our $\mathbb{R}$ FM value. At least part of the di erence can be attributed to their Fe I equivalent widths, which we found, on average, to be
$30 \% \mathrm{sm}$ aller than those wem easure in the m odem C C D spectrum. Such a large discrepancy is unexpected, given that the reticon spectrum ofP errin et al. had a $S / \mathrm{N}$ of 60 , and a resolving power sim ilar to ours. V ariability could be a possible explanation, but the H ipparoos epoch photom etry of the star show s a negligible broad-band variability of just 0.015 m ag over 2.5 years.

Interesting correlationshetwreen abundances and kinem atics are apparent in F io $\quad \mathrm{T}$ he velocity com ponents of the stars show the sm allest scatter at high iron abundances. The gure for the $V$ com ponent show $s$ an unusually low density ofstars w ith low m etallicity and solar-like galactic rotation: the $m$ ost $m$ etal-poor stars either lag or lead the typical thin-disk rotation velocity, with no half $m$ easures, but this $m$ ay be a selection e ect introduced by poor statistics. The low er-right panel in the $F$ igure show $S$

[^8]the age $m$ etallicity relation for the stars whose age could be estim ated w ith an uncertainty of 0.7 dex or less. A ges could only be determ ined for the few stars visibly evolved from the $m$ ain sequence, but this is stillquite inform ative. T his panelwams against interpreting $\mathbb{F e} / \mathrm{H}]$ as a clock.

A though the $m$ ost $m$ etal-poor stars are also am ong the oldest (> 10 Gyr ), they share ages with som e of the $m$ ost $m$ etal-rich stars in the sam ple, which show thin-disk kinem atics. M etal-rich subgiants w ith old ages have been known for a long tim e (see, e.g. Schw arzschild 1958; E ggen 1960) and have been con m ed in post H ipparoos studies of the localdisk (e.g. Feltzing \& H olm berg 2000; Feltzing et al 2001). Recently, Sandage, Lubin \& Vandenberg (2003) have found that evolutionary tracks $w$ ith a m etallicity of $+0: 37$ and an age of 8 Gyr were needed to reproduce the reddest subgiants in a H ipparcos color$m$ agnitude diagram. Chen et al. (2003) report on spectroscopy of severalm etal-rich stars with ages > 10 Gyr . W e estim ate, for exam ple, an age of 13 G yrand a m etallicity of $+0: 3$ for $H \mathbb{P} 99240$. Som e of the coolest stars in our sam ple appear to be slightly o the $m$ ain sequence, and they are $m$ ost likely binaries. The $m$ ost notable case is $H \mathbb{P}$ 97944, a B Y D ra variable clearly noticeable in $F$ ig.

### 5.3. M etalabundance ratios

T he abundance ratios betw een iron and otherm etals have been show $n$ to correlatew ith the iron abundance form any elem ents. Such correlationsprovide a rich database to confront w th m odels of chem icalevolution and nucleosynthesis predictions. Because the derived trends $m$ ay be highly sensitive to $m$ odeling errors (see we have chosen to restrict our study to elem ents represented in the spectrum w th low excitation lines from m a jority species. Such lines are only weakly sensitive to changes in the adopted m odel atm osphere and stellar param eters.W ith this ltering, we lim it signi cantly the num ber of chem ical elem ents to explore, but we feel that given the apparent inconsistencies discussed earlier, th is is the only feasible ctrategy to obtain $m$ eaningful results. Figure an how the ratios of 16 elem ents to iron in our sam ple. Stars $w$ th a galactic rotational velocity $\mathrm{V}<62 \mathrm{~km} \mathrm{~s}{ }^{1}$ (or $<50 \mathrm{~km} \mathrm{~s}{ }^{1}$ relative to the local standard of rest) are show $n$ in red; all others in blue. Stars labeled in SIM BAD as spectroscopic binaries are also identi ed w th open circles.

C arb on is represented in our analysis by the forbidden line at 8727 A. This feature is a ected by neighbor lines, but we believe they can be properly accounted for at solar $T_{e}$ s (G ustafsson et al. 1999; A llende P rieto et al. 2002d) A straight least-squares linear $t$ to the data in $F$ ig (top left panel) suggests a slope of $0: 4 \quad 0: 1$ dex/dex, signi cantly steeper that the results of $G$ ustafsson et al. (1999) for a sam ple ofdisk stars spanning a sim ilar range in $m$ etallicity. O ur C /Fe ratios exhibit $m$ ore scatter, $m$ ost likely due to the larger range in stellar param eters of our nearby stars. $G$ iven the weakness and location of the for-

bidden line in a crow ded region, further analysis w illbene t from a higher resolving pow er to clarify this issue.

O xygen is represented very sparsely in stellar spectra. The only features we use to derive abundances and discuss here are the [ I] line at 630 nm , and the high excitation $\mathbb{R}$ triplet at 770 nm . W hile the forbidden line has been show $n$ to be nearly im m une to departures from LTE, it is w eak and blended w ith a N i I line (A llende P rieto et al. 2001; A splund et al 2004). The near-infrared triplet lines are an extrem e exam ple of departures from LTE, but are stronger and clean for $m$ easuring in solar-like and $m$ etalpoor stars. The high excitation of the triplet lines also argues against their use for our study, given the problem s w ith the ionization balance (see rigorously di erential analysis, we notice that an analysis of the triplet lines for stars w ith atm ospheric param eters close to solar, suggests that the Sun is oxygen poor by $0: 2$ dex.

Som e insight can be obtained from a com parison between the triplet-based and [0 I]-based [0/Fe] for a solarlike star such as H $\mathbb{P}$ 7918. W e have derived an $\mathrm{T}_{\mathrm{e}}$ of 5768107 K , a logg of $4: 422 \quad 0: 079$, and a m etallicity of Fe/H ] = 0:11 0:07. The m icro and m acroturbulence,
as well as the pro jected rotational velocity are also close to solar. Yet, analysis of the [ O I]- N i I blend leads to an abundance $[\mathrm{O} / \mathrm{H}]=0.04$, while analysis of the infrared triplet leads to $[0 / H]=0: 20$. If departures from LTE in the triplet lines are responsible for this discrepancy, they $m$ ust depend on param eters other than those onsidered in a standard analysis (age is a candidate; see An altemative explanation could be related to the fact that we cannot derive the solar param eters in the sam e fashion as those for the other stars. T he trend ofo / Fe in F id las been de ned from the analysis of the forbidden line. W e have accounted for the N i I blending transition using the N i abundanœes determ ined for each individual star from isolated N i lines (see below ). Som e stars arti cially show very high values due to blending $w$ ith telluric lines (above the dashed line). H $\mathbb{P} 109176$ is an exception, but it is a spectroscopic binary and our spectra show signs of a second star. H IP 4148 shows an unusually low upper lim it, but the [ O I]-N iIblend appears a ected by em ission. T he rest of the stars appear aligned in a pattem very sim ilar to that found by $N$ issen et al. $T$ he $M$ agnesium abundance is derived from the $\mathrm{M} g$ I lines at $473.0,631.9$ and 880.6 nm . The strongest line at 880.6 gives a low er abundance than the other tw o by $02-0.4$ dex, but it is unclear which is to be preferred. O ur di erentialanalysis, how ever, largely suppresses such system atic di erences. T his elem ent show s a pattem sim ilar to other alpha elem ents, but with som ew hat m ore hoise'. The alpha elem ents Si and T i show sim ilar trends. Sc m im ics their behavior (com pare in particular with T i). $T$ he di erences in the abundances of these elem ents am ong stars at a given $[\mathrm{Fe} / \mathrm{H}]$ are very likely real, as they appear the sam $e$ in the three panels. Silicon is m easured
through num erous lines of neutralSithat show quite consistent abundances for solar and $m$ etal-poor stars, but their behavior degrades slightly for $\mathbb{F e} / \mathrm{H} \gg 0$, even after the abundances derived from two lines in our list that are likely a icted by blends are rejected. T he abundances from di erent Sc and $T$ ilines, how ever, are intemally consistent in our fiull range of $\mathbb{F e} / \mathrm{H}]$. A s these two elem ents are fully ionized in the entire tem perature range of our stars, and we use ionized lines, the derived abundances are extrem ely robust to errors in the stellar param eters.

Form etal-poor stars, the ratio of $S i, T$ i, or $S c$ to iron grow steadily from solar reaching $0: 4 \quad 0: 5$ dex at $\mathbb{F e} / \mathrm{H}]$

1, suggesting a slope betw een $0: 3$ and $0: 4$ dex per dex \{ signi cantly steeper than in some of the previous studies. At super-solar $m$ etallicities, the trend reverses. This feature contrasts with other analyses, which found such ratios approxim ately at in $m$ etal-rich disk stars (e.g. B odaghee et al.2003;Feltzing et al.2003; C hen et al.2003; but see Feltzing \& G onzalez 2001, who reported an average [Si/Fe] $=+0: 12$ for seven m etal-rich stars and $[\mathrm{Ti} / \mathrm{Fe}]$ as high as $+0: 38$ for HD 32147).

The stars w ith a galactic rotational velocity less than about $62 \mathrm{~km} \mathrm{~s}{ }^{1}$ (or $50 \mathrm{~km} \mathrm{~s}{ }^{1}$ mlative to the local standard of rest), show $n$ in red in $F$ igs tend to have abundance ratios near the upper envelope in the trends observed for M g, $\mathrm{Si}, \mathrm{Ca}, \mathrm{Sc}, \mathrm{T}$ i, Co , $\mathrm{Cu}, \mathrm{Zn}$, and Eu , in



agreem ent w ith previous analyses (e.g., R eddy et al. 2003; Feltzing et al 2003) but close to the lower envelope for $\mathrm{Ba}, \mathrm{Ce}$, and probably Nd .

C alcium was studied with the $w$ ings of the strong C a II lines at 849.8 and 8662 nm , obtaining fairly sim ilar abundances from both features. T he nalabundances, how ever, were derived only from the 866.2 nm line, as this was less contam inated by blending features in the m ost m etallic spectra. This elem ent's ratio to iron appears attened com pared to $\mathrm{Si}, \mathrm{Sc}$ or T i. N ickel show s a rem arkably at ratio to iron for $m$ etal-poor stars, in agreem ent w th the results from F -type stars (e.g. Reddy et al 2003). T he pattem, how ever, changes abruptly for the $m$ ost $m$ etal-rich stars. At the coolest tem peratures

for our stars, a variation of 300 K can alter the abundances of our two NiI lines by 0.05 dex, although in opposite senses due to their di erent excitation energy. Ni has an ionization potential of 7.64 eV , which is close to the 7.90 eV for iron. T he sm all di erence in energy m ight be enough to introduce signi cant system atic di erences in the variation of their ionization balances, and therefore little w eight should be given to the high abundances found for the $m$ ost $m$ etal-rich (and also the coolest) stars in our sam ple. C obalt, how ever, is ionized w th 7.88 eV , and therefore the ratio $\mathrm{C} \circ / \mathrm{Fe}$ derived from our list ofFe I and C o I transitions should be a som ew hat $m$ ore robust quantity. This is particularly true for the coolest stars in the sam ple, for which C O I and Fe I are the dom inant species.



W e observe that [ $\mathrm{C} \circ / \mathrm{Fe}$ ] increases for low er $\mathbb{F e} / \mathrm{H}]$ values, but the $m$ ost $m$ etal-rich stars show even large enrichm ents in cobalt.

C opper is studied w th the $C u$ I lines at $510.55,521.82$ and 578.2 nm . The abundances they provide are in fairly good agreem ent for solar-likem etallicities and $m$ orem etalpoor stars, but progressively diverge for higher m etallicities ${ }^{13}$. The at trend w ith increased dispersion close to solar m etallicity is not new (see e.g. Reddy et al 2003),

[^9]but the enrichm ent for $m$ etal-rich stars has not been reported before. W e have only used the line at 578.21 nm , which gives lower abundances than other transitions in the m ost m etal-rich stars. $T$ his feature, again, is insensitive to large corrections in $\mathrm{T}_{\mathrm{e}}$. . N evertheless, it would be very useful to carry out a m ore detailed study checking for possible blends in the high-m etallicity regim e. If real, the large enhancem ent in $\mathrm{Cu} / \mathrm{Fe}$ is opposite to the values found in very $m$ etal-poor halo stars in the eld or clusters ( $M$ ishenina et al. 2002; Sim m erer et al. 2003).

W e analyzed the Zn I transitions at 472.22 and 481.05 nm , which provide sim ilar abundances for $m$ etalpoor stars, but grow ing discrepancies at larger m etallicities. W e notioed that the line at 472.22 nm has significant dam ping wings, which are system atically underestim ated by the U nsold approxim ation (adopted lacking better data), leading to higher abundances for $m$ etal-rich stars. Thus, we decided to adopt the abundance derived exclusively from the line centered at $481.05 \mathrm{~nm} . Z$ inc appears $m$ ore abundant than iron in $m$ etal-poor stars than at solarm etallicity, and even $m$ ore enhanced in super-solar $m$ etallicity stars.

Y ttrium shows a ratio to iron roughly at, perhaps with a slightly negative slope. The B a abundances, as derived from the resonance line at 455.4 nm and the highexcitation transition at 585.4 nm , show signi cant scatter, in agreem ent with previous results (Reddy et al 2003). The other neutron-capture elem ents in F ig $\mathrm{Ce}, \mathrm{N} \mathrm{d}$, and Eu , show less scatter as their s-process contribution decreases, although caution should be exercised, as the abundances of som e of these elem ents are derived from a single feature.

D espite the scatter, our E u abundances indicate a decrease in the ratio Eu/Fe with metallicity just slightly faster (slope of $0: 5$ ) than proposed by W oolf et al. (1995; slope' $0: 4$ ) or K och \& Edvardsson (2002; slope , 0:3), and especially Reddy et al. (2003; slope 0). $T$ he di erences w ith $W$ oolfet $a l$. and $K$ ock \& Edvardsson could be related to the Fe scale, which in their case was set by Fe II lines (the dom inant species for the tem peratures of their stars), or to sam pling of di erent populations w thin the disk. In our favor we should stress that our analysis of this elem ent bene ts from the recent laboratory study of Eu II by Law ler et al. (2001) not available to $m$ ost authors above. A satisfying agree$m$ ent (w ithin 0.15 dex) betw een the abundances that we derive from the resonance line at 412.97 nm and the excited line at 664.51 nm supports our con dence in the new values. W e have only used the abundances from the redder feature, which is weaker but we believe cleaner. K ock \& Edvardsson (2002) also found a non-zero Eu/Fe ratio at solar m etallicity ( $\mathbb{E u} / \mathrm{Fe}]=+0: 04$ ), albeit slightly low er than ours $(\mathbb{E} u / F e]=+0: 15)$.

## 6. Representativity of the sam ple

In this study we o er for the rst time a census of nearby stars lim ited in absolute $m$ agnitude and distance.

N onetheless, by lim iting the distance to only 14.5 pc we are sam pling a volum e so sm all that peculiarities of som e stars could be erroneously intenpreted as representative of the thin disk. D ue to H ipparoos' com pleteness lim its, expanding signi cantly the volum e for a com plete sam ple requires restricting the analysis to earlier spectral types. W e can, how ever, com pose extended sam ples for which som e properties are readily available and explore w hether some of the characteristics derived from the $S^{4} \mathrm{~N}$ stars are $m$ ore generally shared by stars in the local thin disk. U nfortunately, at this tim e an expanded sam ple requires use of di erent, incom plete, catalogs, inevitably introducing new and com plex selection e ects. K eeping this in $m$ ind, we proceed to carry out such an exercise.

### 6.1. K inem atics, $m$ etallicity, and age for an extended sam ple

W e collected a sam ple of stars whose astrom etric positions, properm otions, and parallaxes w ere included in the H ípparoos catalog and whose radial velocities w ere part of the H ipparcos input catalog, or those com piled by B arbierB rossat \& Figon (2000) and M alaroda, Levato \& G alliani (2001). U sing a 0.05 degree $w$ indow to $m$ atch stars in the H ipparoos catalog w ith the B arbier-B rossat \& Figon radial velocity catalog we identify 23742 stars in com $m$ on. W e found 9312 stars in com $m$ on betw een H ipparoos and the M alaroda et al. catalog, which concentrates on fainter stars than B arbier-B rossat \& Figon's. W ith a sm aller 0.01 deg window we uniquely $m$ atch 19072 stars $w$ th radial velocities in the H ipparcos input catalog $w$ ith their counterparts in H ipparoos. A total of 28416 stars w ere in one orm ore of the radial velocity catalogs and H ipparoos. W e searched form etallicities ( $\mathrm{Fe} / \mathrm{H}]$ ) for the sam ple stars in the catalog ofC ayrelde Strobel, Soubiran \& R alite (2001). This catalog inchudes $m$ etallicities collected from the literature based on one or $m$ ore sources for 2427 eld stars and 582 stars in clusters and associations. 0 ur extended' sam ple of stars $w$ th $m$ etallicities, astrom etry, and radial velocities includes 2144 ob jects.

If we restrict the analysis to the region $w$ ith $V>40$ $\mathrm{km} \mathrm{s}^{1}$ and $80<\mathrm{W}<+50 \mathrm{~km} \mathrm{~s}{ }^{1}$, contam ination by the thick disk and halo should be negligible. $F$ ig reveals that the distribution of stellar velocities can be reasonably well m odeled by $G$ aussians in each direction. $K$ inem atically, these stars belong to the sam e population as those in the $S^{4} \mathrm{~N}$ sam ple. $T$ he slight di erences in the w idths for each velocity com ponent can be easily explained by the statisticalerrors in the sm aller sam ple and the different distribution of spectral types (this a ects mostly V ; both sam ples are dom inated by late-type stars, but w ith som ew hat di erent proportions). The zero o sets \{ the solar peculiar $m$ otion $w$ ith respect to its neighbors \{ derived from the extended sam ple agree w th those determ ined from the $S^{4} \mathrm{~N}$ stars w ithin $1 \mathrm{~km} \leqslant{ }^{1}$ Som e spikes in the velocity distributions show $n$ in $F$ is re statistically signi cant. T hese are w ell-know n realstructures in the so-

lar neighborhood. A lthough the observed star counts are $m$ odeled here as a single $G$ aussian distribution, the velocity structure of the solar neighborhood is quite com plex. C hereul, C reze \& B ienaym e (1999) have studied the positions and kinem atics of A $\mp$ H ipparoos stars w ithin 125 pc from the Sun, identifying severalw ell-known groups as w ellas som e new clusters, associations and $m$ oving groups. For exam ple, in a plot of $W$ vs. U or V vs. U, the H yades cluster can be im m ediately recognized as a clum $p$ centered at $(\mathrm{U}, \mathrm{V}, \mathrm{W})^{\prime} \quad(43 ; 18 ; 2) \mathrm{km} \mathrm{s}^{1}$, which is clearly visible in the panel for $V$ in $F$ ig Far from being in perfectly circular orbits, the thin alsk stars in the solar neighborhood \{ and likely elsew here\{ show a rich structure in phase space (see, e.g., E ggen 1998).
$F$ io lso show $s$ the $m$ etallicity distribution for thin disk stars. It is centered at $\mathbb{F e} / \mathrm{H}=0: 09$ and has a 1w idth of 0.19 dex. T his w idth is obviously convolved w ith the $m$ easurem ent errors. In this particular case, given the very inhom ogeneous character of the C ayrelde Strobelet al. catalog, o sets betw een the $m$ etallicity scales of di erent authors are expected to contribute signi cantly to the observed width, yet, it is virtually identical to the esti$m$ ates from the $S^{4} N$ sam ple.

W e can repeat the $t$ to velocities of the thin disk stars in our extended sam ple for which we have kinem atics, but not spectroscopic $m$ etallicities. T he results for those stars w ithin $100 \mathrm{pc}\{$ a restriction im posed in order to contain the errors in the astrom etry $\{$ are in good agreem ent with
those derived from the $m$ ore restricted sam ple, as show $n$ in F ig $\quad \mathrm{T}$ he G aussian distributions becom e a poorer m odel for the observed distributions.

W e can conclude that our sam ple of stars w thin 14.5 pc is representative, kinem atically and chem ically, of a m uch larger volum e of the local thin disk.

## 62. On the peculiarity of the solar abundance ratios

The distributions of the $\mathrm{Si}, \mathrm{Sc}$, and T i abundance ratios relative to iron at solar m etallicity show a positive o set w th respect to the solar ratios. Even if we restrict the com parison to stars w ith atm ospheric param eters close to solar, this o set rem ains. It is di cult to attribute this to system atic errors. O ur sky spectrum, obtained with the sam e instrum entation and setup as the stellar spectra, is in very good agreem ent with a sm oothed version (to com pensate for the higher spectral resolution) of the solar ux atlas of K unucz et al. (1984). The solar analysis is identical to the stellar analysis, except that the atm ospheric param eters for the Sun w ere not derived in the sam em anner as for the stars. H ow ever, this is unlikely to induce such a shift in the abundances ofdi erent elem ents. T herefore we are inclined to suggest that the Sun is probably de cient in these elem ents com pared to its $\mathrm{im} m$ ediate neighbors. This situation may also apply to O, Ca, Y, La, Ce and Nd 。

Edvardsson et al. (1993) found a sim ilar e ect but when they restricted the com parison to stars w th the sam e \birth galactocentric distance" and age as the Sun the di erences tumed out to be insigni cant. M ost stars in our sam ple, how ever, have solar-like (or thin-disk like) kinem atics, so if their onbits are integrated $m$ ost of them w ill give sim ilar galactocentric distances at birth. A second issue is age. The Sun has an age in the $m$ iddle of the age distribution for the stars in Edvardsson et al. sam ple, and the density of stars was roughly constant at all ages, but the sam ple is a icted w ith severe selection e ects.
$M$ ost of the stars in our very local ( $S^{4} N$ ) sam ple are still relatively close to the zero agem ain sequence (ZAM S) and therefore, we cannot derive ages for them by them ethods described in lisplays a histogram of the ages derived for the stars for which a $2-$ precision of 0.5 dex or better could be achieved in our extended sam ple (see The age distribution covers from 0.16 G yr ( lg A ge 8:2) to 10 Gyr , w ith a m a jor concentration at 1 Gyr. This result is in qualitative agreem ent with the results of C hereul et al. (1999) and Feltzing et al. (2001).

Interpretation of this distribution is a $m$ a jor task and falls outside the scope of this paper. $W$ e refer the reader to the recent papers by Bertelli \& N asi (2001), B inney, D ehnen \& B ertelli (2002), and Vergely et al. (2002). T he key fact that we will highlight is that the Sun (log A ge 9:7) is am ong the oldest stars in our extended sam ple.
$T$ he $S^{4} \mathrm{~N}$ sam ple, we have seen, includes a num ber of stars which are older than the Sun. B eing dom inated by K type dw arfs. it is natural old stars $w$ ill appear preferentially in $F$ id $K$-type stars tend to be excluded from abundance studres, which prefer cleaner and brighter targets. $T$ hus, $m$ etal-rich $K$-type dw arfs $w$ hich are ubiquitous in $S^{4} \mathrm{~N}$ are discrim inated against in the extended sample. Selection e ects, how ever, for $G$-type stars are $m$ ost certainly less serious. T herefore, it is plausible that the G type stars in $S^{4} N$ share the age distribution of the extended sam ple. Then, if the Sun is som ew hat older than the other G type dwarfs in $S^{4} N$, this would provide an explanation for the low abundance ratios to iron of som e elem ents. The peculiarity of the Sun would be lim ited to its age: older than $m$ ost thin disk dw arfs.

## 7. Sum $m$ ary and Conclusions

O ur spectroscopic analysis of the closest stellar neighbors reveals severalinteresting features. T he derived $\mathbb{F e} / H$ ] distribution for our sam ple is centered at $\mathbb{F e} / \mathrm{H}]^{\prime} 0: 1$, a value slightly higher than in $m$ ost previous studies, which concentrated $m$ ainly on earlier spectral types. For a subsam ple of stars, com parison w th evolutionary m odels can provide age estim ates $w$ th $m$ oderate or $s m$ all uncertainties. T his reveals a num ber ofm etal-rich stars that appear to be as old as the $m$ ost $m$ etal-poor stars in the sam ple ( 10 Gyr ), and older than m ost solar-m etallicity thindisk stars. T hese old $m$ etal-rich stars show thin-disk kine$m$ atics, and disnupt a mild correlation betw een age and $m$ etallicity suggested by the stars w ith $\mathbb{F e} / \mathrm{H} \ll 0$.

We nd that our LTE abundance analysis does not satisfy the ionization balance for several elem ents. The
discrepancies grow w th m etallicity, and appear to decrease w ith e ective tem perature, reaching extrem e levels (nearly 0.5 dex ) for the coolest and $m$ ost $m$ etal-rich stars. Sim ilar discrepancies w ere previously reported by Feltzing \& G ustafsson (1998) for several $K$-type $m$ etal-rich eld dwarfs as well as Schuler et al. (2003) and Yong et al. (2004) for K type m em bers of the open chusters M 34 and the $H$ yades, respectively. System atic errors in the trigono$m$ etric gravities can be ruled out, as satisfying the ionization balance by m odifying the gravity w ould require low er values by as much as 0.8 dex .

System atic errors in the $T_{e}$ appear unlikely, as they would need upw ard revisions of up to $300 \mathrm{~K} . \mathrm{W}$ e should em phasize that i) the sam ple of stars used by A lonso et al. (1996) to build the photom etric calibrations em ployed here reach m etallicities as high as $\mathbb{F e} / \mathrm{H}]=+0: 5 \mathrm{dex}$, covering adequately the range of ( Fe I ) abundances of our stars, $i i)$ there is good agreem ent betw een the $T_{e}$ s derived from Strom grem photom etry and the ( $\mathrm{B} V$ ) color index, and iii) the tem peratures derived from the $\mathbb{R}$ FM calibrations and from tting the $w$ ings of $B$ alm er lines are also in good agreem ent. T he only requirem ent of the $\mathbb{R} F M$ from m odel atm ospheres is to correctly predict the $\mathbb{R}$ continuum ux. The fact that uxes for the stars used in the A lonso et al. calibrations were obtained with the $K$ unucz (1993) m odel atm ospheres, which have been tested here and show the ionization im balance, indicates an inconsistency betw een observations and the predictions of such m odels. W e recall that adopting other fam ilies of LTE line-blanketed hom ogeneous $m$ odel atm ospheres is of no help. T he problem is probably connected to som e of the assum ptions involved in the $m$ odeling ( $m$ aybe the usual suspects: LT E and surface convection). A direct com parison, how ever, of high-accuracy spectrophotom etry with m odel uxes should be carried out, before it is possible to de nitely state that the inconsistencies are not related to uncertainties in the $T_{e}$ scale. Further study of open clusters, double, and multiple system s w ill help to clarify the source of the problem described.

D espite the the ionization problem, we use spectral lines of species that are dom inant in $K$ type atm ospheres to investigate abundance ratios to iron for a num ber of chem ical elem ents. O ur study suggests that the ele$m$ ents and Sc are enhanced relative to iron for $m$ etal-rich stars. In an analysis strictly di erential to the Sun, we nd that som e elem ents' ratios to iron are higher than solar at $\mathrm{Fe} / \mathrm{H}]=0 . T$ his e ect is detected, for instance, for $m$ ost elem ents and am ounts roughly to $0: 1$ dex. This fact could be connected to, if not explained by, the Sun being som ew hat older than $m$ ost other dw arfs $w$ ith sim ilar spectral types in the thin disk \{ a conclusion that we reach from exam ining an extended sam ple of $H$ ipparoos stars $w$ ith $m$ etallicities from the literature.

Our e orts to obtain high-quality spectra for a distance- and $M_{v}$-lim ited sam ple of stars, have resulted in the identi cation of som e serious problem s in classical abundance analyses, rather than the very accurate relative abundances we hoped for. The spectra used in this
work have been placed in a public archive. W e propose this dataset as a standard test for $m$ odeling techniques to pass before the retrieved abundances are to be fully trusted.

## 8. A ppendix A : D eterm ination of stellar ages and surface gravities

W e estim ated ages for the stars in the sam ple by com paring the position in the $\mathrm{M}_{\mathrm{V}} \quad \mathrm{T}_{\mathrm{e}}$ plane of the starw ith the isochrones published by B ertelliet al. (1994). O urm ethod is sim ilar to that described by Reddy et al. (2003), but we have introduced som e re nem ents. The procedure $m$ akes no assum ption on the intial $m$ ass function, the $m$ etallicIty distribution, or the star form ation rate. $T$ he isochrones provide stellar properties such as $M_{v}, T_{e}$, or $\log g$, as a function of three param eters: in itialm ass ( $\mathrm{M}_{\mathrm{i}}$ ), age (A ge), and metallicity ( $\mathrm{Z}=\mathrm{Z}$ ). W e start out by adopting at distribution functions for those three param eters in the range:

Iron abundances were translated to $m$ etal $m$ ass fractions assum ing $\log (Z=Z \quad)=\mathbb{F e} / H]$, and therefore we use them interchangeably below. A dopting a G aussian probability density for $T_{e}, M_{v}$, and $\left.\mathbb{F e} / H\right]$ centered at the $m$ easured values

The isochrones em ployed do not consider enhance$m$ ents in the abundances of the elem ents for $m$ etalpoor stars. M ore realistic relations should take this into account, but as we are $m$ ainly concemed $w$ ith thin disk stars, it w ill have no e ect on our analysis.
