# S<sup>4</sup>N: A Spectroscopic Survey of Stars in the Solar Neighborhood ? ??

The Nearest 15 pc

#### Abstract.

W e report the results of a high-resolution spectroscopic survey of all the stars m ore lum inous than M  $_{\rm V}$  = 65 m ag within 14.5 pc from the Sun. The Hipparcos catalog's completeness limits quarantee that our survey is comprehensive and free from some of the selection e ects in other samples of nearby stars. The resulting spectroscopic database, which we have m ade publicly available, includes spectra for 118 stars obtained with a resolving power of R ' 50;000, continuous spectral coverage between 362 921 nm, and typical signal-to-noise ratios in the 600. We derive stellar parameters and perform a prelim inary abundance and kinematic analysis of range 150 the F-G-K stars in the sample. The inferred metallicity (Fe/H]) distribution is centered at about 0:1 dex, and shows a standard deviation of 0.2 dex. A comparison with larger samples of Hipparcos stars, som e of which have been part of previous abundance studies, suggests that our limited sample is representative of a larger volum e of the local thin disk. We identify a number of metal-rich K-type stars which appear to be very old, con mig the claims for the existence of such stars in the solar neighborhood. With atmospheric e ective tem peratures and gravities derived independently of the spectra, we nd that our classical LTE m odel-atm osphere analysis of m etal-rich (and m ainly K-type) stars provides discrepant abundances from neutral and ionized lines of several m etals. This ionization in balance could be a sign of departures from LTE or inhom ogeneous structure, which are ignored in the interpretation of the spectra. A Itematively, but seem ingly unlikely, the mism atch could be explained by system atic errors in the scale of e ective tem peratures. Based on transitions of m a jority species, we discuss abundances of 16 chem ical elements. In agreement with earlier studies we nd that the abundance ratios to iron of Si, Sc, Ti, Co, and Zn become smaller as the iron abundance increases until approaching the solar values, but the trends reverse for higher iron abundances. At any given m etallicity, stars with a low galactic rotational velocity tend to have high abundances of Mg, Si, Ca, Sc, Ti, Co, Zn, and Eu, but low abundances of Ba, Ce, and Nd. The Sun appears de cient by roughly 0.1 dex in O, Si, Ca, Sc, Ti, Y, Ce, Nd, and Eu, com pared to its im m ediate neighbors with sim ilar iron abundances.

#### 1. Introduction

The study of the stellar population of the solar neighborhood is of interest for a wide range of investigations. Nearby stars are the only ones for which we can obtain crucial m easurem ents, such as parallaxes or angular diam eters. They are typically the best candidates for very precise spectroscopic follow ups, such as searches for low erm ass com panions (stellar, brown dwarf, orplanetary), circum stellar disks, or solar-like cycles. Their proxim ity involves obvious advantages that should be exploited.

From a wider perspective, the stellar population of the solar neighborhood may be representative of larger parts of the Galactic disk. Early studies revealed that the simplest models of Galactic chemical evolution could not m atch the observed m etallicity distribution { the so-called G-dwarfproblem (van den Bergh 1962). Recent investigations have shown that more complex scenarios, such as those including inhomogeneous evolution (Malinie et al. 1993) or infall (Chiappini et al. 1997), more closely resem ble the observations. However, alm ost all the derived m etallicity distributions of sam ples approxim ately limited in volume, have been obtained from photom etry (Twarog 1980; Rocha-Pinto & Maciel 1996, 1998a; Flynn & Morell 1997; K otoneva et al. 2002). This is worrying, as it has been recognized that some of the employed photom etric indices may be seriously a ected by chrom ospheric activity (Rocha-Pinto & Maciel 1998b; Favata et al. 1997a) and other system atic e ects (Haywood 2002; Reid 2002; Twarog, Anthony-Twarog & Tanner 2002). These uncertainties can be avoided by using spectra. Favata et al. (1997b) carried out the only existing spectroscopic study of a volum e-lim ited sam ple of nearby stars, and found a m etallicity distribution for K dwarfs which is remarkably m ore m etal-rich than those obtained through photom etric analyses.

We have conducted a complete M  $_{\rm V}$  -lim ited volum elim ited survey of nearby stars in an attempt to settle these and other issues. In addition to the C atalogue of N earby Stars (G liese & Jahrei 1991, hereafter CNS3) { used by m ost of the previous studies{ we have taken advantage of the H ipparcos catalog (ESA 1997). H ipparcos is complete down to V =  $7.3^1$ . Restricting the study to stars brighter than M  $_{\rm V}$  = 6.5 (' K 2V), H ipparcos' completeness reaches out to 14.5 pc.F igure 1 shows that nearly 25 % of the stars included in CNS3 within 14.5 pc from the Sun (parallaxes larger than 69.18 m as) are in fact farther aw ay according to the accurate parallaxes m easured by H ipparcos.

H igh-dispersion high signal-to-noise optical spectra were acquired for 118 stars: all the objects more lum inous than M<sub>V</sub> = 6.5 within 14.5 pc from the Sun.Figure 2 shows the sample's distribution of absolute and visual V magnitudes: M<sub>V</sub> (solid line) and V (dashed line). As a reference, spectral types for dwarfs are assigned to di erent ranges in M<sub>V</sub>. This sample, as a result of the dependence of stellar lifetime on mass and the shape of the initial mass function, is dominated by the coolest stars within our range of spectral types. This should be borne in m ind when comparing to most other high-resolution spectroscopic studies of disk stars, which tend to select warm er targets.

We provide a high-quality spectroscopic archive of these nearest stars. The data acquisition, reduction and archival, are the subject of Section 2. M any properties of these stars have been com piled: radial velocities, parallaxes, and proper m otions. O ther properties have been

determ ined afresh: stellar atm ospheric param eters, kinem atics, ages, and chem ical abundances. The resulting catalog is described in x3. Section 4 exam ines the consistency of the inferred abundances. Section 5 discusses our ndings. Section 6 com pares the kinem atics and m etallicities of the nearest stars with larger sam ples of thin-disk stars, and x7 presents a short sum m ary and provides suggestions for future work.

### 2.0 bservations, data processing, and nalarchive

The observations were obtained with the Harlan J. Sm ith 2.7m telescope at M cD onald O bservatory and the E SO 1.52m telescope on La Silla. The spectra have a resolving power of  $5 \ 10^4$ , fully cover the optical range, and extend into the near IR .A totalofsix observing cam paigns were necessary, as sum marized in Table 1.

The McDonald spectra were obtained with the 2dcoude spectrograph (Tull et al. 1995). This cross-

dispersed echelle spectrograph provides, in a single exposure, full coverage from about 360 nm to 510 nm, but has increasingly larger gaps between redder orders. This problem was circum vented by using two di erent overlapping settings. The detector was TK 3, a thinned 2048 2048 Tektronix CCD with 24 m pixels, which was installed at the F3 focus. We used grating E2, a 53.67 gr mm<sup>-1</sup> R2 echelle from M ilton Roy Co. and slit # 4, which has a central width of 511 m (or approx.12 arcsec on the sky).

The ESO (La Silla) data were acquired with FEROS (Kaufer et al. 2000), a ber fed cross-dispersed spectrograph with an R2 79 gr mm<sup>1</sup> echelle grating. The detector was a 2048 4096 EEV CCD with 15 m pixels. The FEROS resolving power was about 45000, which is roughly 20% lower than that of the 2d coude spectra. This instrum ent has a xed con guration, but provides better coverage than the 2d coude for a single setting: approximately from 350 to 920 nm, leaving two gaps at 853 and 870 nm.Most of the observations from the May and September 2001 runswere obtained in bbject-calibration' mode with FEROS: the Th-Ar lamp was on during the stellar observations and its light fed to the spectrograph. This mode was selected due to the fact that the spectra were obtained in between observations for a dierent program, for which an accurate wavelength calibration was crucial. This turned out to be a disadvantage as, in some cases, scattered light from Ar lines in the red a ected the stellar spectra.

A im ing for very high signal-to-noise ratios, at least two exposures per setting were obtained at M cD onald.D ue to a more limited observing time, a lower S=N was reached for the stars observed from ESO, for which a single exposure was typically obtained. About 2/3 of the sam ple was observed from M cD onald.Fig. 3 com pares the M cD onald and ESO spectra of H IP 10798 in the region of the Ca I line at 6162 nm.

The spectra were reduced with  $\mathbb{R}AF^2$ , using the imred, codred, and echelle packages. The processing included

overscan subtraction, at elding, scattered light rem oval, optim al extraction and wavelength calibration. Th-Ar observations were very frequent at M cD onald. These were combined into an atlas available from the W W W<sup>3</sup> (A llende P rieto 2002a). The instrum ental response, dom - inated by the blaze function characteristic of an echelle spectrograph, was carefully rem oved by two-dim ensional m odeling following Barklem et al. (2002). The blue and red setups (M cD onald spectra) were com bined. Finally, the orders were m erged into a continuous spectrum.

In an attempt to produce a highly homogeneous archive, the nal spectra were velocity corrected using the central wavelengths of hundreds of solar atom ic lines as reference (Allende Prieto & Garc a Lopez 1998). The M cD onald spectra were then truncated to the wavelength range 362 {1044 nm, while the ESO spectra were restricted to the range 362 { 921 nm . Errors in the uxes were estim ated from three sources: the Poisson noise ( photons), the continuum placement, and an absolute lim it im posed by the best correction of pixel-to-pixel sensitivity variations we can achieve. The uncertainty in the continuum placem ent for M cD onald spectra was estimated by com paring our 'sky-light' spectrum, obtained through a port that brings day light from the sky to the slit room, with the solar ux atlas of K unucz et al. (1984). For the ESO spectra we compared spectra of stars observed both from ESO and M cD onald. Fig. 4 shows the di erent error contributions adopted for the McDonald sky (solar) spectrum .

In Fig.4, the largest di erences between the M cD onald sky spectrum and the K unucz et al. (1984) solar atlas (thick solid line) are due to di culties in selecting uniquely

the position of the pseudo-continuum in the blue wavelengths due to severe line absorption, and to the presence of telluric features and di erent observing conditions in the red and infrared part of the spectrum. The zigzagging shape of the Poissonian lim it curve (thin solid line) is caused by the combination of multiple observations of the sam e spectral segments in contiguous orders of the sam e setting, and also by the overlapping wavelength coverage between the two settings. The wide peak at 500 nm corresponds to the so-called 'picket fence' in the M cD onald spectrum { stray light re ected by the CCD back to the grating. It is also worthwhile to mention that the ESO spectra at and near H have large error bars due to a reection from the ber, and thus the H spectrum in the ESO spectra is un reliable. An error spectrum has been assembled along with each stellar spectrum, which re ects the combined error as discussed above.

The spectra are archived in FIT  $S^4$  form at, and are available through the intermet at the  $S^4N$  site<sup>5</sup>.

# 3. The S<sup>4</sup>N catabg

#### 3.1. Stellar param eters

The traditional' procedure to derive stellar parameters for a spectroscopic analysis involves the use of photom etry and the spectra them selves. Am ong the photom etric calibrations available to derive the stellar e ective tem perature, those based on the infrared ux m ethod (IRFM, B lackwell et al. 1977) have been proven very precise and were adopted here { always assuming that the reddening m ust be negligible within 15 pc. Optical and infrared colors are only weakly sensitive to other stellar parameters.

Such gravities are practically independent from m odel atm ospheres. O ur atm ospheric stellar parameters are, therefore, independent from the high-resolution spectra, and can be considered fairly robust against the subtleties involved in the interpretation of the high-resolution spectra.

#### 3.1.1. Photom etry

V isualm agnitudes, b y and  $c_1$  indices were compiled from H auck & M erm illiod (1998). Sometimes this source does not provide uncertainties for the data, and we adopted 0.01 m ag. W hen V m agnitudes were not available from H auck & M erm illiod, we searched K ornilov et al. (1991), correcting their values using

where the subscript K' indicates K omilov et al. m agnitudes, for which we adopted an error of 0.01 m ag. This correction follows the recommended transformation by K omilov, M ironov, & Zakharov (1996). When a star was not in any of these sources, we used H<sub>p</sub> from H ipparcos, the H ipparcos (B V) and the Sim bad (U B)<sup>6</sup> with H arm anec's (1998) form ulae to estimate V, and assign either 0.01 m ag of error or the 1 uncertainty in H p, whatever is larger. We also compiled B V, V I, H<sub>p</sub>, V, and their uncertainties from the H ipparcos catalog. These data are available on the S<sup>4</sup>N web site.

#### 3.1.2.E ective tem perature

W e used the Strom gram photom etry and the (B  $\,$  V ) index with the A lonso et al. (1996; 1999a) calibrations to derive  $\mathrm{T}_{\mathrm{e}}$  . The IRFM is based on the comparison between the bolom etric ux and the monochrom atic ux at a selected wavelength in the infrared. Following the application of the IRFM to derive T<sub>e</sub> for a large number of stars, A lonso et al. derived photom etric calibrations. Use of such calibrations does not require bolom etric uxes and bene ts from the statistical elimination of outliers. Our e ective tem peratures are based on such photom etric calibrations, which are also dependent (although weakly) on the stellar metallicity and surface gravity. We begin by assuming  $[Fe/H] = 0^7$ . Then, other stellar parameters, including Fe/H], are determined from the spectrum (see below ), and a second iteration is applied to derive the  $T_{\rm e}~$  s in Tables 2-4. The error bars assigned to the tem peratures have been derived from propagating the uncertainties in the photom etry through A lonso et al.'s polynom ials. W e

found the calibration based on (b y) and  $c_1$  to provide slightly warm ertem peratures than the values from (B V) by an average of 42 6 K, with an rm s di erence of 61 K.

An independent assessment of the scale of e ective tem peratures can be obtained by exploiting the sensitivity of the wings of Balmer lines to the thermal structure of deep atm ospheric layers. E chelle spectrographs are not ideally suited for measuring the shape of broad features such as the wings of Balmer lines, but as we explained in x2, we paid particular attention to the continuum normalization of our spectra. The H pro les in the ESO spectra are unreliable, as suggested by the di culties encountered in the norm alization process. However, wedeem H for these spectra as 'reliable', and both H in the 2dcoude spectra, as highly reliable'. We and H calculated synthetic pro les for H and H as described by Barklem et al. (2002). Stark broadening is described by the model-micro eld method calculations of Stehle & Hutcheon (1999) and self-broadening by calculations of Barklem, Piskunov & O'Mara (2000a,2000b). Radiative broadening is included, and so is an estimate of the helium collisional broadening (based on rescaling of Barklem & O'M ara 1997), although both e ects are small. The m odel atm ospheres were com puted with the sam e version of the MARCS code as the models employed to derive abundances (see x3.3). The only di erences a ect the convection param eters. C onvection is described by the m ixing length treatment, where for our purposes the most im portant param eters are the mixing-length 1, which is usually expressed in units of the pressure scale height as the m ixing-length parameter =  $l=H_{p}$ , and a second parameter y describing the tem perature structure within convective elem ents (see H enyey et al. 1965 for details). The standard set of parameters in the MARCS code are = 1:5and  $y = 3=(4)^2$ , and these are adopted for the models used in the abundance analysis. As seen in Barklem et al. (2002; see also Fuhrm ann 1998 and references therein), a better m atch to the observed pro les can be achieved by reducing the mixing length. Thus, for our analysis of hydrogen lines we adopted a model grid with = 0:5 and y = 0.5 as in Barklem et al. (2002). We note that the di erent values have a negligible in pact on the overall tem perature scale (Barklem et al. 2002). The e ective tem peratures were determ ined by <sup>2</sup> tting as described in Barklem et al. (2002).

Figure 5 shows the di erences between the IRFM – based  $T_{\rm e}$  s and those from Balm er lines (weighted average of H and H ). The agreement is satisfying; Balmer lines temperatures are warm er with a mean di erence of just 15 K, and an rm s di erence of 84 K. Fig. 5 indicates that the Balmer-line temperatures may be slightly higher for stars with  $T_{\rm e}~<~4900~K^8$ . A similar e ect was also



noted by Barklem et al. (2002) for a di erent sam ple, but, as they remarked, the reader should bear in m ind that errors in Balm er-line tem peratures are largest in that domain due to a) the reduced sensitivity of the line wings, and b) an increasing contam ination by m etallic lines. The second e ect can potentially induce a bias in the observed sense. Balm er-line  $T_e$  s m ight also be slightly cooler for the warm er stars in our sam ple.

Recently, K ovtyukh et al. (2003) have derived e ective tem peratures for late-type dwarfs using line-depth ratios. From 13 stars in common, we nd their tem peratures system atically higher by 119 12 K (= 43 K) in the range 5000 < T<sub>e</sub> < 6000 K. An aberrant exception takes place for H IP 23311 (H R 1614), for which they derived 4945 K, but our preferred value is 4641 K. W e note that Feltzing & G ustafsson (1998) found 4625 K from Strom grem photom etry, and Feltzing & G onzalez (2001) arrived at 4680 K from the excitation equilibrium of neutraliron and nickel<sup>9</sup>. From tting the wings of B alm er lines, we obtain an interm ediate value of 4789 110 K.

# 3.1.3. M etallicity, surface gravity, age, m icro and m acroturbulence

M etallicities are rst estim ated from the autom ated system described by A llende Prieto (2003). G ravities (and ages when possible) are then estim ated from  $T_e$ ; M<sub>V</sub>, and [Fe/H], by using B ertelliet al. (1994) isochrones in a similarm anner to A llende Prieto et al. (2003) and R eddy et al. (2003). More details are provided in Appendix A. A rst abundance run with the selected spectral line proles and using M ARCS models (see x3.3) provided re ned values for [Fe/H], the microturbulence (), and the macroturbu-

lence ( ), that were also used to determ ine the nal  $T_e$  (from photom etry) and gravities (from the isochrones). The nal stellar parameters are listed in Tables 2-4. Fig. 6 displays the distribution of the stars in the M  $_V$  vs.  $T_e$  plane. Two solar-composition isochrones of ages 1 and 10 G yr are also shown.

The derived values for the microturbulence ( $^{P}\overline{2}$ , where is the standard deviation of a Gaussian distribution) are a function of the T<sub>e</sub> and logg of the stars, as previously found by other authors (e.g. Nissen 1981; Edvardsson et al. 1993; Reddy et al. 2003). For our sam – ple, the expression

predicts with an m s scatter of 0.14 km s<sup>1</sup>.

## 3.2.Kinematics

Radial velocities were compiled from the catalogs of Barbier-Brossat & Figon (2000) and Malaroda, Levato & Galliani (2001). Proper motions and parallaxes were extracted from the Hipparcos catalog (ESA 1997). We derived stellar UVW galactic velocities following Johnson & Soderblom (1987), but as all Hipparcos astrometry is given in the ICRS system J1991.25 (TT), we use  $_{\rm NGP}$  = 192:85948 deg,  $_{\rm NGP}$  = 27:12825 deg, and  $_{\rm O}$  = 122:93192 deg (ESA 1997; vol 1). We modi ed Johnson & Soderblom 's formulation to account for the correlations between the astrometric parameters given in the Hipparcos catalog. The details are explained in Appendix B.No corrections have been introduced for the solar peculiar motion. The derived galactic velocities and input data are given in the electronic Table 5.

#### 3.3. Chem ical abundances

W e carried out an extensive search for atom ic data, mainly transition probabilities, for elements producing lines in the spectral range of our observations. Our search concentrated on reliable laboratory measurements and accurate theoretical calculations. C and idate lines were exam ined in the high-dispersion at lases of Arcturus (Hinkle et al. 2001), Procyon (Grin & Grin 1979; Allende Prieto et al. 2002c), and the Sun (Kurucz et al. 1984), to identify the best abundance indicators.

A total of 68 features were selected. These features were single-component lines, or the result of multiple transitions (hfs, isotopic shifts, and blends), requiring 275 com ponents and providing abundances for 22 chem icaleements. Our analysis considers line pro les and, therefore, we were able to use full pro les or parts of line pro les. Natural and van der W aals broadening were accounted for using data from VALD<sup>10</sup> (K upka et al. 1999) and the calculations of Barklem, Piskunov & O'Mara (2000c, and references therein) respectively. Hyper ne structure and isotopic splittings were considered for lines of Cu I (Kunucz's web site<sup>11</sup>), Sc II (data com piled by Prochaska & M dW illiam 2000 for 6245.622 and 6604.6; from Mansour et al. 1989 for 6300.684 and 6320.843), Mn I (com piled by Prochaska & M cW illiam 2000), Ba II (com piled by M cW illiam 1998) and Eu II (Law ler et al. 2001). Solar isotopic ratios were always assumed. Table 6, available only electronically, provides a sum m ary of our adopted wavelengths, excitation potentials, and transition probabilities.

The parts of the spectrum selected for the analysis de ne a 'm ask' that we use for all late-type stars. We exclude the core of strong lines (relative ux lower than 60 % of the pseudo-continuum level), in an attempt to m inim ize the impact of departures from LTE. We analyze the spectra with M ISS (A llende Prieto et al. 1998,

2001), adopting theoretical '97 MARCS LTE blanketed m odelatm ospheres (Gustafsson et al. 1975; A splund et al. 1997), to nd the set of abundances, m icroturbulence, and m acroturbulence that best reproduces the observations. W e chose to use a G aussian broadening function (referred to as in acroturbulence' or ) to account for large-scale turbulence (proper m acroturbulence), rotational and instrum entalbroadening. The determ ination of abundances, m icro, and m acroturbulence, is accomplished by m inim izing the <sup>2</sup> between synthetic and observed line pro les, and this can be carried out with all lines simultaneously, or line-by-line. A fter prelim inary all-lines runs to determ ine the m icro and m acroturbulence, and the overall m etallicity to be adopted in the calculation of the model atm ospheres, we used a line-by-line approach to identify outliers and estim ate internal uncertainties. Table 7, available only electronically, provides the naladopted abundances for all stars. These abundances are discussed in Section 5.3. The stated uncertainties are the standard deviation from di erent lines (which is set to zero when there is only one line involved).

The median mmsscatterwe nd for the abundance of a given elem ent in a given star is 0.04 dex, but other system atic contributors exist. Departures from LTE and stellar granulation in the real photospheres will bias abundance estimates from individual lines di erently. We refer every single abundance estim ate from a line to the solar abundance from the same line. Thus, our approach is strictly di erential. This should reduce system atic errors due to the shortcom ings of our modeling, but given the large spread in atm ospheric param eters of our stars, will certainly not succeed in removing them completely. Dealing with NLTE and inhom ogeneities is very important in some cases, but exceeds the scope of this work. These errors add to the pool of uncontrolled uncertainties together with unrecognized blends, and errors in the continuum norm alization. Finally, even for these nearby stars, errors in the atm ospheric param eters are a signi cant, fortunately controlled, source of uncertainty. W e have estim ated such errors by repeating the calculations with m odel atm ospheres with perturbed atm ospheric param eters. As the gravities and metallicities are precisely determined and these param eters only produce m inor changes in the abundances com pared to variations in the  $\mathrm{T}_{\mathrm{e}}\,$  , we have estim ated the e ect of increasing the T<sub>e</sub> s by 3 and added that information to Table 7.

A dopting K unicz (1993) non-overshooting m odel atm ospheres instead of M ARCS m odels, we system atically change the tem perature and pressure stratication, and then the derived abundances. A lthough the changes are generally less than 0:1 dex, for some ranges of the atmospheric parameters and some particular elements they can be somewhat larger. This is illustrated in Fig. 7 for a solarlike star (H IP 22263), two late G-type stars with extreme m etallicities in our sample (H IP 171 with [Fe/H]' 0:8 and H IP 43587 with [Fe/H]' + 0:3), and an F-type star with solar-like abundances (H IP 37279).

#### 4. Ionization and excitation balance

As a consistency check of the high-dispersion spectroscopic analysis, we exam ine whether the abundances derived from dierent lines of the same element agree. Inspection of the abundances from lines of di erent excitation for Fe I (Ti I, or Ca I) reveals no clear sign of correlations. However, it soon became obvious that iron abundances derived from lines of neutral or ionized iron provided system atically di erent values. This e ect is illustrated in Fig. 8 for Fe and Ca, where it can be seen that the dierences can reach 0:5 dex for the most metal-rich stars in the sam ple. Sim ilar e ects are apparent for Siand Ti. A parallel analysis of the nearby star sample based on Kurucz's model atmospheres shows a similar pattern and m agnitude for the ionization in balance to that found with MARCS models, although the detailed shape of the trends in Fig. 8 changes.

#### 4.1. Precedents

Serious worries about the ionization balance in K-type dwarfs appeared in the work by O inas (1974). Perrin, Cayrelde Strobel & Cayrel (1975) revisited the issue and concluded that the magnitude of the problem was overestim ated by O inas and the discrepancies perhaps not signi cant.

In more recent times, Feltzing & Gustafsson (1998) reported the case of ve K-type dwarfs that showed dramatic di erences between the abundances from lines of neutral and ionized Fe, and the same e ect was apparent for C a and C r. Thoren & Feltzing (2000) reanalyzed some of the problem atic stars in Feltzing & Gustafsson (1998), suggesting adjustments to the the  $T_e$  scale to solve the discrepancy.

Very recently, Schuler et al. (2003) have reported similar problem s with several K dwarfs in the open cluster M 34. W ith e ective tem peratures set to satisfy the excitation equilibrium of Fe I, and gravities assigned from the positions of the stars on the main sequence, their standard LTE analysis resulted in consistent abundances from Fe I and Fe II lines for warm stars ( $\Gamma_e$  5500 K), but signi cant deviations from the ionization balance for most of the cooler dwarfs. Sim ilar to the cases of the nearby K dwarfs and those in the Feltzing & Gustafsson sam – ples, Schuler et al. found signi cantly larger abundances (up to 0.6 dex) from Fe II lines. The abundances they derived for the K-type stars from Fe I lines were sim ilar to the abundances for warm er cluster stars that did not show the problem . The sym ptom s are not unique to M 34, as shown by Yong et al. (2004) for the Hyades. The iron abundance inferred from Fe II lines continues to diverge at coolere ective tem peratures, exceeding the values from Fe I lines by m ore than an order of m agnitude for stars with  $T_e$  4000 K in this cluster.

As we discuss below, adjusting the stellar parameters to make ends meet is not easily justimed for our sample. We should note that most of the previous high-resolution spectroscopic surveys have been for warm (F-and early G) stars with modest iron enrichments (see, e.g. Edvardsson et al. 1993; Reddy et al. 2003). From inspection of Fig. 8 we would expect those studies to nd only m inor (< 0.2 dex) deviations from the LTE ionization balance.

## 4.2. Errors in the atm ospheric param eters?

To reconcile the abundances from neutral and ionized lines for the most metal-rich (and cool) stars in Fig.8 by modifying the trigonom etric gravities would require to decrease them from logg ' 4:6 to 3:8. Sim ilarly, the abundances could be reconciled by increasing the  $T_e$  sby 350 K .0 ur list of Fe I was punctiliously selected for being clean and having accurate atom ic data, but it spans a lim ited range in excitation energy. A test for HIP 69972 (Te 4700 K) with 47 Fe I lines drawn from the lists of B lackwell, Lynas-Gray & Sm ith (1995) and Holweger, Kock & Bard (1995) spanning a range of excitation potential from 0.1 to 4.7 eV shows that a change of 300 K (from 4671 K to 4971 K) results in a change in the slope of the abundances from 0.06 to 0.01 dex/eV, increasing the mean abundance from Fe I by only 0.05 dex, and bringing a marginal improvement in the standard deviation from 0.14 dex to 0.13 dex. The same change is able to bring down the mean abundance derived from Fe II lines by roughly  $0.5 \, \text{dex}$ .

The lines of neutral metals with weak-to-moderate strength in a solar like star tend to become very strong in cool metal-rich stars. With stronger lines the role of the dam ping constants is enhanced (see, e.g., R yan 1998). Our analysism akes use of line pro les, rather than equivalent widths, and adopts, when available, the damping parameters calculated by Barklem et al. (see x3), which we consider reliable to within 10%. Our neutral iron lines are signi cantly stronger (equivalent widths between 7 and 14 pm ) for a star like H IP 69972 than in the Sun. The selected Fe II lines, in turn, are all weaker than 8 pm in the spectrum of HIP 69972. The situation for our calcium lines, how ever, is quite di erent, and yet the same shift between the abundances from lines of neutral and ionized species is found. As shown in Fig. 9, even if we only consider the wings of strong Ca lines in the analysis, CaI and CaII lines point to quite di erent abundances. These di erences could again be bridged by reducing the 0:6 dex, or increasing the e ective surface gravity by tem perature by 280 K (weakening the Ca I line).

However, a system atic modi cation by 300 K of the e ective tem perature from the IRFM calibrations wellexceeds the expected uncertainties. For example, the Te V) for dwarfs and subgiants, calibration based on (B was derived from data for 410 stars, yielding a standard deviation of 130 K. The calibration for the Strom grem photom etry was based on 289 stars with a standard deviation of 141 K . In addition, we nd an excellent agreem ent between the  $T_{\rm e}$  s derived from (B V) and Strom grem photom etry, and, independently, from the analysis of the wings of Balmer lines (see x3.1). Finally, we should em phasize that the stellar param eters for our sample are well bracketed by those of the stars used to de ne the A lonso et al. calibrations.

It is intriguing to consider that the problem may be associated with the trigonom etric gravities, but this is extrem ely unlikely given the size of the discrepancy. From inspection of Tables 2-4, one notices that the corrections required are about 10 times the estimated uncertainties in this parameter. Additionally, Feltzing & Gustafsson arrived at sim ilar gravities for their K dwarfs (in som e cases very dierent from those determined spectroscopically) from trigonom etric parallaxes and the pressure-sensitive wings of strong m etal lines. Interestingly, com parison between precise stellar radii for stars in eclipsing binaries with evolutionary isochrones has shown that G and Ktype stars in detached system s are brighter than predicted (see, e.g., C lausen et al. 1999; A llende P rieto 2001; Torres & R ibas 2002; R ibas 2003). For a reliably determ ined M  $_{\rm V}$  , predicted radii are sm aller by 10 % and therefore gravities larger by 0.1 dex. This e ect is as yet not well understood (see, e.g., Lastennet et al. 2003 for a possible solution), but cannot explain the ionization shift we nd, because it is too sm all.

As tempting as it may be to modify the stellar param eters to comply with the ionization balance, we cannot do so without violating robust observational constraints.

#### 4.3. Possible explanations

Ionization shifts with respect to theoretical predictions have been previously reported for metal-poor stars in the form of di erences between spectroscopic and trigonom etric gravities, and are often attributed to departures from LTE. In fact, deriving higher abundances from Fe II lines seem s consistent with the hypothesis of non-LTE overionization as a plausible explanation. The mild correlation of the e ect with T<sub>e</sub> in Fig. 8 suggests that the most serious discrepancies appear at  $T_e < 5000$  K, which is where most of the iron becom es neutral in the line form ation region, as shown in Fig. 10.D epartures from LTE are believed to cause an overionization of iron compared to LTE predictions in solar-like stars (see, e.g. Shchukina & Trujillo Bueno 2001). The e ects are felt in the analysis of Fe I lines, but not for Fe II lines for a solar-tem perature dwarf, because most of the iron atoms are ionized in the line-form ing region. However, the argument reverses for stars with an elective temperature lower than about 5000 K. Besides, a higher metal abundance in the photosphere decreases gas pressure and enhances electron pressure, shifting the Saha ionization balance towards neutral iron. Thus, departures from LTE in Fe II levels would qualitatively agree with the inconsistencies shown in Fig. 8. However, as shown also in Fig. 10, the situation for Ca I, which is ionized with only 6.1 eV in comparison to 8.9 eV for Fe I, is very dilement. Ca is still completely ionized everywhere in a solar-composition model atmosphere even for an  $T_e$  as low as 3700 K. Yet, calcium shows a similar ionization problem as iron.

O ther factors, such as surface inhom ogeneities (granulation, spots, etc.), incomplete opacities (due to, e.g., m olecules), chrom ospheric or m agnetic activity, m ay be responsible instead. In an early K dwarf, the region where the largest velocity and temperature amplitudes of granulation take place is slightly beneath the visible layer (N ordlund & D ravins 1990). As discussed by D ravins & N ordlund (1990a, 1990b) based on 3D hydrodynam ical simulations, this results in relatively sm all line asymmetries and shifts compared to warm er stars, but causes the physical conditions to change very rapidly with the form ation height of a line. The form ation of high excitation lines m ay be biased towards the hotter granules, m aking the lines of ionized species stronger than predicted with a hom ogeneous m odel.

In any event, it appears safer in the context of this study to embrace the abundances from the dominant species for the cooler stars (which are also the more metalrich stars) of our sample. As the abundances from Fe I and II lines are roughly in agreement for most of the warm er stars, in what follows we adopt the mean iron abundance derived from Fe I lines as our metallicity indicator. We still will use line-to-line di erential abundances with respect to the Sun, and therefore the notation [Fe/H] will, from now on, refer to Fe I abundances relative to the Sun.

# 5.D iscussion

#### 5.1. Selection of 'norm al' stars

Some of the observed stars rotate too fast to be handled sim ilarly to the rest of the sam ple and were not included in the subsequent analysis. These are: H  $\mathbb{P}$  32349, H  $\mathbb{P}$ 57632, H  $\mathbb{P}$  77952, H  $\mathbb{P}$  86032, H  $\mathbb{P}$  91262, H  $\mathbb{P}$  97649, H  $\mathbb{P}$  107556, and H  $\mathbb{P}$  113368. H  $\mathbb{P}$  24608 was found to have peculiar pro les and should be studied separately, and H  $\mathbb{P}$  61941 is a visual binary with a separation of about 1.6 arcsec that could not be resolved at the tim e of the observations. H  $\mathbb{P}$  69673, A returns, is the star with the low est gravity in the sam ple. Its surface com position does not m atch that of typical disk stars (Peterson et al. 1993), and was also excluded.

Spectroscopic binaries were not set aside a priori, unless double lines were obvious. The doubled-lined K -type spectroscopic binaries HIP 97944 (HR 7578) and HIP 117712 (HR 9038) will not be discussed here. Both system swere observed when the lines are well separated. HR 7578 has a period of 46.8 days, and an eccentricity of 0.68 (Fekel & Beavers 1983). It is known to exhibit peculiar abundances (Taylor 1970; O inas 1974). HR 9038 is part of a multiple system, with at least a nearby M 2. It has a period of 7.8 days and a circular orbit (H albwachs et al. 2003), but no abundances have been reported before. The spectra of these systems deserve a more detailed study which would depart from the scope of this paper.

Fast rotators and single-lined binaries are included in the discussion of kinem atics. Ignoring the possibility of cleaning our sample with external information will allow us to perform a meaningful comparison with larger sam – ples of more distant, and therefore less-studied, stars (see Section 6). Even if the multiplicity fraction is as high as 10 20 % (Halbwachs et al. 2003; Mason et al. 2003), this will have only a limited e ect on the derived velocity distributions. Fast rotating and double-lined binaries discussed above are excluded from the abundance analysis, but single-lined spectroscopic binaries with apparently clean spectra are not, as no signi cant di erences were noted between those identi ed as mem bers of binary system s in SIM BAD and the rest (see below).

#### 5.2. K inem atics and m etallicity distribution

In Fig.11 we show histogram softhe galactic velocity com ponents and iron abundances for the sample. Gaussian distributions have been t to the data, and are usually fair approxim ations. The zero points of the velocity com ponents re ect the solar motion with respect to its nearest neighbors (what has been som et in es term ed the solar basic motion). These numbers are in good agreement with older determ inations (see, e.g.D elhave 1965; W oolley 1965) and for U and W , but not for V due to the dependence of this parameter on the stellar population (asymm etric drift), they also agree very well with the solar peculiar motion with respect to the local standard of rest (circularm otion; see Dehnen & Binney 1998). The widths of the distributions are consistent with values derived from larger sam ples, but we will revisit this issue in x6. To explore the e ect of biases due to evolutionary e ects (m ore m assive stars that have already died), we have restricted the sample to stars with  $T_e$  cooler than 5500 K. Such distributions (dashed lines) have been rescaled to match the maxim a of the total distributions and help the eye in the com parison. No signi cant di erences are apparent in the velocities.

The m etallicity distribution of nearby late-type stars has been extensively discussed in the literature. This is the rst time, how ever, that it has been derived for an absolute m agnitude-limited sample using spectroscopy. A G aussian provides a fair approximation to the Fe/H] distribution of our sample. While the width of the distribution is in good agreement with most previous results, the center of the G aussian, at 0:11 dex, is slightly higher than most stud-

ies (but see H aywood 2001, 2002). Restricting the analysis to the coolest stars ( $T_e$  < 5500 K), the resulting m etallicity distribution is shifted to higher values. Further reduction of the maximum  $T_e$  to 5000 K does not alter the [Fe/H] distribution appreciably. The discussion on the ionization balance in x4 m ay leave some readers worried about how uncertainties in theoreticalm odel atm ospheres m ight a ect the derived distribution. It su ces to say that adopting the average (Fe I + Fe II) abundances, would shift the center of the (full sample { solid line) [Fe/H] distribution in the Figure to 0:06 dex.

The existence of super-solar metallicity stars in the local disk has been known for a long time (e.g. Spinrad 1966; Spinrad & Taylor 1969; Taylor 1970). Curiously, the most metal-rich stars are mainly dwarfs and subgiants with spectral types F or later (e.g. Feltzing, Holmberg & Hurley 2001; A llende Prieto 2002b; Taylor 2002). Fig. 12 shows clearly that the most metal-rich stars in our volum e-limited sample are also the coolest. Metal-poor

m ain-sequence stars are less lum inous than their m etalrich counterparts, and in Figure 12, the lack of m etal-poor stars at the lowest temperatures is, at least in part, the result of having a M  $_{\rm V}$  -lim ited sam ple.

H  $\mathbb{P}$  69972 (HD 125072) appears to be the m ost m etalrich star in the sample. The Fe I-based m etallicity is roughly + 0.5 dex, am ong the largest values reported in the literature (e.g.Buzzoniet al2001; Taylor 2002; Chen et al. 2003). The Fe II-based m etallicity of this star is about one dex higher than solar but, given the inconsistency between Fe I and Fe II abundances, and the m uch higher sensitivity of the Fe II lines to tem perature changes, we think such a higher abundance is unlikely. This star was previously analyzed by Perrin, Cayrel de Strobel & Dennefeld (1988), who derived a lower value of Fe/H] = + 0.26 dex<sup>12</sup>. Reinforcing the discrepancy, their adopted e ective tem – perature was nearly 300 K warm er than our IRFM value. At least part of the di erence can be attributed to their Fe I equivalent widths, which we found, on average, to be

30 % sm aller than those we measure in the modern CCD spectrum. Such a large discrepancy is unexpected, given that the reticon spectrum of Perrin et al. had a S/N of 60, and a resolving power sim ilar to ours. Variability could be a possible explanation, but the H ipparcos epoch photom – etry of the star shows a negligible broad-band variability of just 0.015 m ag over 2.5 years.

Interesting correlations between abundances and kinem atics are apparent in Fig. 13. The velocity components of the stars show the smallest scatter at high iron abundances. The gure for the V component shows an unusually low density of stars with low m etallicity and solar-like galactic rotation: the most m etal-poor stars either lag or lead the typical thin-disk rotation velocity, with no half m easures, but thism ay be a selection e ect introduced by poor statistics. The low er-right panel in the Figure shows the age m etallicity relation for the stars whose age could be estimated with an uncertainty of 0.7 dex or less. Ages could only be determined for the few stars visibly evolved from the main sequence, but this is still quite informative. This panel warms against interpreting [Fe/H] as a clock.

Although the most metal-poor stars are also among the oldest (> 10 G yr), they share ages with some of the most metal-rich stars in the sample, which show thin-disk kinem atics. M etal-rich subgiants with old ages have been known for a long time (see, e.g. Schwarzschild 1958; Eggen 1960) and have been con med in post-H ipparcos studies of the local disk (e.g. Feltzing & Holm berg 2000; Feltzing et al. 2001). Recently, Sandage, Lubin & Vandenberg (2003) have found that evolutionary tracks with a metal-+0:37 and an age of licity of 8 Gyr were needed to reproduce the reddest subgiants in a H ipparcos colormagnitude diagram. Chen et al. (2003) report on spectroscopy of several m etal-rich stars with ages > 10 Gyr. W e estim ate, forexam ple, an age of 13 G yrand a m etallicity of + 0:3 for H IP 99240. Som e of the coolest stars in our sample appear to be slightly o the main sequence, and they are most likely binaries. The most notable case is H IP 97944, a BY D ra variable clearly noticeable in Fig. 6.

## 5.3. M etal abundance ratios

The abundance ratios between iron and otherm etals have been shown to correlate with the iron abundance form any elem ents. Such correlations provide a rich database to confront with models of chemical evolution and nucleosynthesis predictions. Because the derived trends m ay be highly sensitive to m odeling errors (see x4), we have chosen to restrict our study to elements represented in the spectrum with low excitation lines from majority species. Such lines are only weakly sensitive to changes in the adopted model atm osphere and stellar param eters. W ith this Itering, we lim it signi cantly the num ber of chem ical elem ents to explore, but we feel that given the apparent inconsistencies discussed earlier, this is the only feasible strategy to obtain m eaningful results. Figures 14, 15, and 16 show the ratios of 16 elements to iron in our sample. Stars with a galactic 62 km s <sup>1</sup> (or < rotational velocity V <  $50 \text{ km s}^{\perp}$ relative to the local standard of rest) are shown in red; all others in blue. Stars labeled in SIM BAD as spectroscopic binaries are also identi ed with open circles.

C arbon is represented in our analysis by the forbidden line at 8727 A. This feature is a ected by neighbor lines, but we believe they can be properly accounted for at solar  $T_e$  s (G ustafsson et al. 1999; A lende P rieto et al. 2002d). A straight least-squares linear t to the data in Fig. 14 (top left panel) suggests a slope of 0:4 0:1 dex/dex, signi cantly steeper that the results of G ustafsson et al. (1999) for a sam ple of disk stars spanning a sim ilar range in m etallicity. O ur C /Fe ratios exhibit m ore scatter, m ost likely due to the larger range in stellar param eters of our nearby stars. G iven the weakness and location of the for-

bidden line in a crowded region, further analysis will bene t from a higher resolving power to clarify this issue.

0 xygen is represented very sparsely in stellar spectra. The only features we use to derive abundances and discuss here are the [O I] line at 630 nm, and the high excitation IR triplet at 770 nm . W hile the forbidden line has been shown to be nearly imm une to departures from LTE, it is weak and blended with a Nilline (Allende Prieto et al. 2001; A splund et al. 2004). The near-infrared triplet lines are an extrem e exam ple of departures from LTE, but are stronger and clean for m easuring in solar-like and m etalpoor stars. The high excitation of the triplet lines also argues against their use for our study, given the problem s with the ionization balance (see x4). In fact, despite our rigorously di erential analysis, we notice that an analysis of the triplet lines for stars with atm ospheric param eters close to solar, suggests that the Sun is oxygen poor by 02 dex.

Some insight can be obtained from a comparison between the triplet-based and [D I]-based [D /Fe] for a solarlike star such as H IP 7918. We have derived an  $T_e$  of 5768 107 K, a logg of 4:422 0:079, and a metallicity of [Fe/H] = 0:11 0:07. The m icro and macroturbulence,

as well as the projected rotational velocity are also close to solar. Yet, analysis of the [0 I]-NiI blend leads to an abundance [0/H] = 0.04, while analysis of the infrared triplet leads to [0/H] = 0.20. If departures from LTE in the triplet lines are responsible for this discrepancy, they must depend on parameters other than those considered in a standard analysis (age is a candidate; see x6). An alternative explanation could be related to the fact that we cannot derive the solar param eters in the sam e fashion as those for the other stars. The trend of 0 /Fe in Fig. 14 has been de ned from the analysis of the forbidden line. We have accounted for the Nilblending transition using the Ni abundances determined for each individual star from isolated Nilines (see below). Some stars articially show very high values due to blending with telluric lines (above the dashed line). HIP 109176 is an exception, but it is a spectroscopic binary and our spectra show signs of a second star. H IP 4148 shows an unusually low upper lim it, but the [O I]-NiIblend appears a ected by emission. The rest of the stars appear aligned in a pattern very sim ilar to that found by N issen et al. (2002) for 0.7 < [Fe/H]< +0.25, with a slope of ' 0:5 below [Fe/H] 0 that attens out at super-solar m etallicities.

The M agnesium abundance is derived from the M g I lines at 473.0, 631.9 and 880.6 nm. The strongest line at 880.6 gives a lower abundance than the other two by 0.2-0.4 dex, but it is unclear which is to be preferred.0 ur di erential analysis, how ever, largely suppresses such system atic di erences. This element shows a pattern sim ilar to other alpha elements, but with som ewhat more hoise'. The alpha elements Si and T i show sim ilar trends. Sc m in ics their behavior (com pare in particular with T i). The di erences in the abundances of these elements am ong stars at a given [Fe/H] are very likely real, as they appear the same in the three panels. Silicon is measured

through num erous lines of neutral Sithat show quite consistent abundances for solar and metal-poor stars, but their behavior degrades slightly for  $Fe/H \ge 0$ , even after the abundances derived from two lines in our list that are likely a icted by blends are rejected. The abundances from di erent Sc and T i lines, how ever, are internally consistent in our full range of Fe/H]. As these two elements are fully ionized in the entire temperature range of our stars, and we use ionized lines, the derived abundances are extrem ely robust to errors in the stellar param eters.

For m etal-poor stars, the ratio of Si, T i, or Sc to iron grows steadily from solar reaching 0:4 0.5 dex at [Fe/H]

1, suggesting a slope between 0:3 and 0:4 dex per dex { signi cantly steeper than in some of the previous studies. At super-solar metallicities, the trend reverses. This feature contrasts with other analyses, which found such ratios approximately at in metal-rich disk stars (e.g. Bodaghee et al. 2003; Feltzing et al. 2003; Chen et al. 2003; but see Feltzing & Gonzalez 2001, who reported an average [Si/Fe] = +0.12 for seven metal-rich stars and [T i/Fe] as high as +0.38 for HD 32147).

The stars with a galactic rotational velocity less than about 62 km s<sup>1</sup> (or 50 km s<sup>1</sup> relative to the local standard of rest), show n in red in F igs. 14–16, tend to have abundance ratios near the upper envelope in the trends observed for M g, Si, Ca, Sc, T i, Co, Cu, Zn, and Eu, in agreem ent with previous analyses (e.g., Reddy et al. 2003; Feltzing et al. 2003) but close to the lower envelope for Ba, Ce, and probably Nd.

Calcium was studied with the wings of the strong Ca II lines at 849.8 and 866.2 nm, obtaining fairly sim ilar abundances from both features. The nalabundances, how ever, were derived only from the 866.2 nm line, as this was less contaminated by blending features in the most metallic spectra. This element's ratio to iron appears attened compared to Si, Sc or Ti. N ickel shows a remarkably at ratio to iron for metal-poor stars, in agreement with the results from F-type stars (e.g. Reddy et al. 2003). The pattern, how ever, changes abuptly for the most metal-rich stars. At the coolest temperatures

for our stars, a variation of 300 K can alter the abundances of our two N i I lines by 0.05 dex, although in opposite senses due to their di erent excitation energy. N i has an ionization potential of 7.64 eV, which is close to the 7.90 eV for iron. The small di erence in energy m ight be enough to introduce signi cant system atic di erences in the variation of their ionization balances, and therefore little weight should be given to the high abundances found for the m ost m etal-rich (and also the coolest) stars in our sam ple. C obalt, how ever, is ionized with 7.88 eV, and therefore the ratio C o/Fe derived from our list of Fe I and C o I transitions should be a som ew hat m ore robust quantity. This is particularly true for the coolest stars in the sam ple, for which C o I and Fe I are the dom inant species. W e observe that [C o/Fe] increases for low er [Fe/H ] values, but the m ost m etal-rich stars show even large enrichments in cobalt.

C opper is studied with the C u I lines at 510.55, 521.82 and 578.2 nm. The abundances they provide are in fairly good agreem ent for solar-likem etallicities and m orem etalpoor stars, but progressively diverge for higher m etallicities<sup>13</sup>. The at trend with increased dispersion close to solar m etallicity is not new (see e.g. Reddy et al. 2003),

but the enrichment for metal-rich stars has not been reported before. We have only used the line at 578.21 nm, which gives lower abundances than other transitions in the most metal-rich stars. This feature, again, is insensitive to large corrections in  $T_e$ . Nevertheless, it would be very useful to carry out a more detailed study checking for possible blends in the high-metallicity regime. If real, the large enhancement in Cu/Fe is opposite to the values found in very metal-poor halo stars in the eld or clusters (M ishenina et al. 2002; Simmerer et al. 2003).

We analyzed the Zn I transitions at 472.22 and 481.05 nm, which provide sim ilar abundances for m etalpoor stars, but growing discrepancies at larger m etallicities. We noticed that the line at 472.22 nm has significant damping wings, which are system atically underestim ated by the Unsold approximation (adopted lacking better data), leading to higher abundances for m etal-rich stars. Thus, we decided to adopt the abundance derived exclusively from the line centered at 481.05 nm.Z in c appears m ore abundant than iron in m etal-poor stars than at solarm etallicity, and even m ore enhanced in super-solar m etallicity stars.

Y ttrium shows a ratio to iron roughly at, perhaps with a slightly negative slope. The B a abundances, as derived from the resonance line at 455.4 nm and the high-excitation transition at 585.4 nm, show signi cant scatter, in agreement with previous results (R eddy et al. 2003). The other neutron-capture elements in Fig. 16, C e, N d, and E u, show less scatter as their s-process contribution decreases, although caution should be exercised, as the abundances of som e of these elements are derived from a single feature.

Despite the scatter, our E u abundances indicate a decrease in the ratio Eu/Fe with metallicity just slightly faster (slope of 0:5) than proposed by W oolf et al. (1995; slope ' 0:4) or Koch & Edvardsson (2002; slope 0:3), and especially Reddy et al. (2003; slope 0). The dierences with W oolf et al. and K ock & E dvardsson could be related to the Fe scale, which in their case was set by Fe II lines (the dom inant species for the tem peratures of their stars), or to sampling of di erent populations within the disk. In our favor we should stress that our analysis of this element bene ts from the recent laboratory study of Eu II by Law ler et al. (2001) not available to most authors above. A satisfying agreement (within 0.15 dex) between the abundances that we derive from the resonance line at 412.97 nm and the excited line at 664.51 nm supports our con dence in the new values.W e have only used the abundances from the redder feature, which is weaker but we believe cleaner. Kock & Edvardsson (2002) also found a non-zero Eu/Fe ratio at solar m etallicity (Eu/Fe] = + 0:04), albeit slightly lower than ours (Eu/Fe] = +0:15).

# 6. Representativity of the sam ple

In this study we over for the st time a census of nearby stars limited in absolute magnitude and distance.

N onetheless, by limiting the distance to only 14.5 pc we are sampling a volum e so sm all that peculiarities of som e stars could be enroneously interpreted as representative of the thin disk. Due to H ipparcos' completeness limits, expanding signi cantly the volum e for a complete sample requires restricting the analysis to earlier spectral types. W e can, how ever, compose extended samples for which som e properties are readily available and explore whether som e of the characteristics derived from the  $S^4N$  stars are m ore generally shared by stars in the local thin disk. U nfortunately, at this tim e an expanded sample requires use of di erent, incomplete, catalogs, inevitably introducing new and complex selection e ects. K eeping this in m ind, we proceed to carry out such an exercise.

# 6.1. K inem atics, m etallicity, and age for an extended sample

We collected a sample of stars whose astrometric positions, properm otions, and parallaxes were included in the H ipparcos catalog and whose radial velocities were part of the H ipparcos input catalog, or those com piled by B arbier-Brossat & Figon (2000) and Malaroda, Levato & Galliani (2001). Using a 0.05 degree window to match stars in the Hipparcos catalog with the Barbier-Brossat & Figon radial velocity catalog we identify 23742 stars in common. We found 9312 stars in common between Hipparcos and the M alaroda et al. catalog, which concentrates on fainter stars than Barbier-Brossat & Figon's.W ith a smaller 0.01 deg window we uniquely match 19072 stars with radial velocities in the H ipparcos input catalog with their counterparts in Hipparcos. A total of 28416 stars were in one orm ore of the radial velocity catalogs and H ipparcos. W e searched for m etallicities (Fe/H ]) for the sample stars in the catalog of Cayrelde Strobel, Soubiran & Ralite (2001). This catalog includes m etallicities collected from the literature based on one or more sources for 2427 eld stars and 582 stars in clusters and associations. Our 'extended' sam ple of stars with m etallicities, astrom etry, and radial velocities includes 2144 objects.

If we restrict the analysis to the region with V >40 km s  $^{1}$  and 80 < W < +50 km s  $^{1}$ , contam ination by the thick disk and halo should be negligible. Fig. 17 reveals that the distribution of stellar velocities can be reasonably well modeled by Gaussians in each direction. K inem atically, these stars belong to the sam e population as those in the S<sup>4</sup>N sample. The slight di erences in the widths for each velocity component can be easily explained by the statistical errors in the sm aller sam ple and the different distribution of spectral types (this a ects mostly V; both samples are dominated by late-type stars, but with somewhat dierent proportions). The zero o sets { the solar peculiar motion with respect to its neighbors { derived from the extended sample agree with those determ ined from the  $S^4N$  stars within 1 km s<sup>1</sup>. Some spikes in the velocity distributions shown in Fig. 17 are statistically signi cant. These are well-known real structures in the so-

lar neighborhood. A lthough the observed star counts are m odeled here as a single G aussian distribution, the velocity structure of the solar neighborhood is quite com plex. C hereul, C reze & B ienaym e (1999) have studied the positions and kinem atics of A  $\pm$  H ipparcos stars within 125 pc from the Sun, identifying several well-known groups as wellas some new clusters, associations and m oving groups. For example, in a plot of W vs. U or V vs. U, the H yades cluster can be immediately recognized as a clum p centered at (U,V,W) ' (43; 18; 2) km s<sup>-1</sup>, which is clearly visible in the panel for V in Fig. 17. Far from being in perfectly circular orbits, the thin disk stars in the solar neighborhood { and likely elsewhere{ show a rich structure in phase space (see, e.g., Eggen 1998).

F ig. 17 also shows the m etallicity distribution for thin disk stars. It is centered at  $Fe/H \models 0.09$  and has a 1w idth of 0.19 dex. This width is obviously convolved with the m easurem ent errors. In this particular case, given the very inhom ogeneous character of the C ayrel de Strobel et al. catalog, o sets between the m etallicity scales of di erent authors are expected to contribute signi cantly to the observed width, yet, it is virtually identical to the estim ates from the S<sup>4</sup>N sam ple.

We can repeat the t to velocities of the thin disk stars in our extended sample for which we have kinem atics, but not spectroscopic m etallicities. The results for those stars within 100 pc { a restriction im posed in order to contain the errors in the astrom etry { are in good agreem ent with those derived from the more restricted sample, as shown in Fig. 18. The Gaussian distributions become a poorer model for the observed distributions.

We can conclude that our sample of stars within 14.5 pc is representative, kinematically and chemically, of a much larger volume of the local thin disk.

#### 62.0 n the peculiarity of the solar abundance ratios

The distributions of the Si, Sc, and Tiabundance ratios relative to iron at solar m etallicity show a positive o set with respect to the solar ratios. Even if we restrict the com parison to stars with atm ospheric param eters close to solar, this o set remains. It is di cult to attribute this to system atic errors. Our sky spectrum, obtained with the same instrum entation and setup as the stellar spectra, is in very good agreem ent with a sm oothed version (to com pensate for the higher spectral resolution) of the solar ux atlas of K urucz et al. (1984). The solar analysis is identicalto the stellar analysis, except that the atm ospheric param eters for the Sun were not derived in the sam em anner as for the stars. However, this is unlikely to induce such a shift in the abundances of di erent elem ents. Therefore we are inclined to suggest that the Sun is probably de cient in these elements compared to its immediate neighbors. This situation may also apply to O, Ca, Y, La, Ce and Nd.

Edvardsson et al. (1993) found a similar e ect but when they restricted the comparison to stars with the same \birth galactocentric distance" and age as the Sun the di erences turned out to be insigni cant. Most stars in our sample, however, have solar-like (or thin-disk like) kinem atics, so if their orbits are integrated most of them will give similar galactocentric distances at birth. A second issue is age. The Sun has an age in the middle of the age distribution for the stars in Edvardsson et al. sample, and the density of stars was roughly constant at all ages, but the sample is a icted with severe selection e ects.

M ost of the stars in our very local ( $S^4N$ ) sample are still relatively close to the zero agemain sequence (ZAM S) and therefore, we cannot derive ages for them by the methods described in x3.1.3. Fig. 19 displays a histogram of the ages derived for the stars for which a 2- precision of 0.5 dex or better could be achieved in our extended sample (see x6). The age distribution covers from 0.16 Gyr (log Age 8.2) to 10 Gyr, with a major concentration at 1 Gyr. This result is in qualitative agreement with the results of Chereul et al. (1999) and Feltzing et al. (2001).

Interpretation of this distribution is a m a jor task and falls outside the scope of this paper. W e refer the reader to the recent papers by Bertelli & Nasi (2001), Binney, Dehnen & Bertelli (2002), and Vergely et al. (2002). The key fact that we will highlight is that the Sun (log Age 9:7) is am ong the oldest stars in our extended sam ple.

The S<sup>4</sup>N sample, we have seen, includes a number of stars which are older than the Sun. Being dom inated by K-type dwarfs, it is natural old stars will appear preferentially in Fig. 13. K-type stars tend to be excluded from abundance studies, which prefer cleaner and brighter targets. Thus, m etal-rich K-type dwarfs which are ubiquitous in S<sup>4</sup>N are discriminated against in the extended sam – ple. Selection e ects, how ever, for G-type stars are most certainly less serious. Therefore, it is plausible that the G-type stars in S<sup>4</sup>N share the age distribution of the extended sam ple. Then, if the Sun is somewhat older than the other G-type dwarfs in S<sup>4</sup>N, this would provide an explanation for the low abundance ratios to iron of some elements. The peculiarity of the Sun would be limited to its age: older than most thin disk dwarfs.

#### 7.Sum m ary and Conclusions

O ur spectroscopic analysis of the closest stellar neighbors reveals several interesting features. The derived [Fe/H] distribution for our sample is centered at [Fe/H]' 0.1, a value slightly higher than in m ost previous studies, which concentrated m ainly on earlier spectral types. For a subsample of stars, com parison with evolutionary m odels can provide age estimates with m oderate or small uncertainties. This reveals a number of m etal-rich stars that appear to be as old as the most m etal-poor stars in the sample  $(\geq 10 \text{ G yr})$ , and older than most solar-m etallicity thindisk stars. These old m etal-rich stars show thin-disk kinem atics, and disrupt a m ild correlation between age and m etallicity suggested by the stars with [Fe/H] < 0.

We nd that our LTE abundance analysis does not satisfy the ionization balance for several elements. The discrepancies grow with m etallicity, and appear to decrease with e ective tem perature, reaching extrem e levels (nearly 0.5 dex) for the coolest and m ost m etal-rich stars. Sim ilar discrepancies were previously reported by Feltzing & Gustafsson (1998) for several K-type m etal-rich eld dwarfs as well as Schuler et al. (2003) and Yong et al. (2004) for K-type m em bers of the open clusters M 34 and the H yades, respectively. System atic errors in the trigonom etric gravities can be ruled out, as satisfying the ionization balance by m odifying the gravity would require low er values by as m uch as 0.8 dex.

System atic errors in the T<sub>e</sub> appear unlikely, as they would need upward revisions of up to 300 K.W e should em phasize that i) the sam ple of stars used by A lonso et al. (1996) to build the photom etric calibrations em ployed here reach m etallicities as high as  $Fe/H \models +0.5 \text{ dex}, \text{ cov}$ ering adequately the range of (Fe I) abundances of our stars, ii) there is good agreem ent between the Te s derived from Strom green photom etry and the (B  $\,$  V ) color index, and iii) the tem peratures derived from the IRFM calibrations and from thing the wings of Balmer lines are also in good agreem ent. The only requirem ent of the IRFM from m odel atm ospheres is to correctly predict the IR continuum ux. The fact that uxes for the stars used in the A lonso et al. calibrations were obtained with the K urucz (1993) model atm ospheres, which have been tested here and show the ionization in balance, indicates an inconsistency between observations and the predictions of such m odels. W e recall that adopting other fam ilies of LTE line-blanketed hom ogeneous model atm ospheres is of no help. The problem is probably connected to some of the assumptions involved in the modeling (maybe the usual suspects: LTE and surface convection). A direct com parison, how ever, of high-accuracy spectrophotom etry with model uxes should be carried out, before it is possible to de nitely state that the inconsistencies are not related to uncertainties in the  $\mathrm{T}_{\mathrm{e}}$   $\,$  scale. Further study of open  $\,$ clusters, double, and multiple system s will help to clarify the source of the problem described.

Despite the the ionization problem, we use spectral lines of species that are dom inant in K-type atm ospheres to investigate abundance ratios to iron for a number of chem ical elements. Our study suggests that the elem ents and Sc are enhanced relative to iron for m etal-rich stars. In an analysis strictly di erential to the Sun, we nd that som e elem ents' ratios to iron are higher than solar at [Fe/H] = 0. This e ect is detected, for instance, for elements and amounts roughly to 0:1 dex. This m ost fact could be connected to, if not explained by, the Sun being som ew hat older than most other dwarfs with sim ilar spectral types in the thin disk { a conclusion that we reach from examining an extended sample of Hipparcos stars with m etallicities from the literature.

Our e orts to obtain high-quality spectra for a distance- and M  $_{\rm V}$  -lim ited sam ple of stars, have resulted in the identi cation of som e serious problem s in classical abundance analyses, rather than the very accurate relative abundances we hoped for. The spectra used in this

work have been placed in a public archive. We propose this dataset as a standard test for modeling techniques to pass before the retrieved abundances are to be fully trusted.

# 8. Appendix A: D eterm ination of stellar ages and surface gravities

W e estim ated ages for the stars in the sam ple by com paring the position in the M $_{\rm V}$   $T_{\rm e}$  plane of the starw ith the isochrones published by Bertelliet al. (1994). O urm ethod is sim ilar to that described by R eddy et al. (2003), but we have introduced some re nem ents. The procedure m akes no assumption on the initial m ass function, the m etallicity distribution, or the star form ation rate. The isochrones provide stellar properties such as M $_{\rm V}$ , Te $_{\rm e}$ , or logg, as a function of three param eters: initial mass (M $_{\rm i}$ ), age (Age), and m etallicity (Z=Z $_{\rm of}$ ). We start out by adopting at distribution functions for those three param eters in the range:

In practice, to nd the best age estimate for each star, we discretized the problem by sampling the isochrones of Bertelli et al. with constant steps of 0.006 M in the initial mass M<sub>i</sub>, 0.05 in log Age (Age in years), and 0.125

in [Fe/H]. We took advantage of a further simplication to speed up the calculation: the Gaussian component for [Fe/H] in Eq. 4 was replaced by a boxcar with a width of 0.25 dex after checking that this introduced negligible di erences. W e then converted the integral in Eq. 5 into a sum over the area con ned by an ellipsoid centered at the adopted values of  $T_{\rm e}$  , M  $_{\rm V}$  , and [Fe/H ], with sem iaxes three times the estimated 1- uncertainties in these param eters. From the probability distribution we nd the mean and 1 lim its for the age of a star.

The isochrones employed do not consider enhancements in the abundances of the elements for metalpoor stars. M ore realistic relations should take this into account, but as we are mainly concerned with thin disk stars, it will have no e ect on our analysis.

The uncertainties in and provided in Hipparcos are de ned regarding the reference direction (, ) as xed. Therefore, the derivatives of the velocity components with respect to the direction need not be considered, and the matrix elements  $F_{11}$ ;  $F_{12}$ ;  $F_{21}$ ;  $F_{22}$ ;  $F_{31}$  and  $F_{32}$  should be exactly zero. The standard errors (<sub>i</sub>) and correlation coe cients ( ij) involving can be substituted by those for cos (provided in the Hipparcos cat-() ′ alog), and ()=cos.Use of Eq.12 instead of that given by Johnson & Soderblom produces non-negligible di erences in the estimated uncertainties in the galactic velocities, which generally become smaller for nearby H ipparcos stars.
