N eutral hydrogen absorption at the center of N G C 2146

ABSTRACT

We present 1.4 GHz H i absorption line observations towards the starburst in NGC 2146, made with the VLA and MERLIN. The H i gas has a rotating disk/ring structure with column densities between 6 and 18 10^{21} atom scm². The H i absorption has a uniform spatial and velocity distribution, and does not revealany anom alous material concentration or velocity in the central region of the galaxy which m ight indicate an encounter with another galaxy or a far{evolved merger. We conclude that the signs of an encounter causing the starburst should be searched for in the outer regions of the galaxy.

1 IN TRODUCTION

A tom ic hydrogen absorption measurements on (sub)arcsecond scales allow us to investigate the distribution and dynamics of neutral gas in the inner regions of starburst galaxies and active galactic nuclei (AGN). While H i em ission measurements with current instruments are sensitivity { limited to a maximum resolution of a few arcseconds, absorption studies are limited only by the angular resolution of the telescope and the brightness distribution of the background radio continuum. We present H i absorption measurements of the peculiar spiral galaxy NGC 2146.

It is well established that NGC 2146 is undergoing a strong starburst, even stronger than that in M 82 (e.g. K ronberg & B iem ann 1981; Tarchiet al. 2000; later TNG); however, the origin of this starburst is still unclear. A starburst is often triggered by an interaction with another galaxy, which perturbs the potential equilibrium of the gas, causing a ow of gas towards the center which results in an increase in density and thus fueling of the star{form ation process.

It therefore seems plausible that a starburst in a galaxy is triggered by an encounter if the galaxy belongs to a group which contains and still is connected by large H i tails, for instance like M 81 { M 82 { NGC 3077 (Yun, Ho & Lo 1994, W alter et al. 2002) and NGC 3627 {NGC 3628 {NGC 3623 (the Leo triplet; Zhang, W right, & A lexander 1993). Such an interaction has been searched for in NGC 2146 since the presence of a large H i cloud is known since 1976.

Using the NRAO 91{m telescope, Fisher & Tully (1976) detected a huge H i cloud extending out to six Holm berg radii (120 kpc) around NGC 2146. This cloud could be the consequence of a tidal interaction or of an explosion/ejection in the galaxy. However, there exists no kinem atic evidence for the explosion hypothesis, and no companion has been found which may have interacted with NGC 2146. The higher resolution observations of the extended H i around NGC 2146 with the W SRT (Caspers & Shane 1986) and the VLA (Taram opoulos, Payne & Briggs 1996) resolved the cloud into a prom inent tail, extending out to 90 kpc SE of the body of the galaxy, but no further evidence of an interaction was found at that time. In 1990, Hutchings et al. (1990) suggested instead that NGC 2146 appears to be in the nal stage of a fairly gentle far{evolved m erger, with the dom inant galaxy (NGC 2146) now seen close to edge { on and the stripped companion being on a nalplunge toward its center. The putative traces of this m erger are, how ever, not particularly com pelling. Evidence of a collision with another galaxy which did not remain embedded in NGC 2146 has been suggested as an alternative triggering mechanism by Young et al. (1988). They drew especially attention to the 10 kpc extended sem i{arc of H ii regions (observed in H

and [SII]), which is not coplanar with the rotating disk of the galaxy. A more recent analysis by Taram opoulos, Payne & Briggs (2001) (later TPB) of the H i stream suggests today a tidal interaction between NGC 2146 and a Low Surface Brightness (LSB) companion of which a remnant is apparently still seen as a 1.5 10^8 M H i concentration in the southern tail.

In order to study the kinem atics and density of gas in the central region of NGC 2146 in the light of the proposed m erger/encounter hypothesis, we have m apped the H i absorption towards the nuclear radio continuum em ission using the VLA (198 resolution = 130 pc) and MERLIN (092 resolution = 15 pc). At the distance of NGC 2146 (14.5 M pc, Benvenuti, Capaccioli & D'O dorico 1975), 1^{00} is equivalent to 70 pc.

2 THE OBSERVATIONS AND IMAGE PROCESSING

VLA Observation The Hi line was observed towards NGC 2146 for a total of 11 hours on M arch 16 (5.5 hrs) and 17 (5.5 hrs), 2001, with the Very Large A rray 1 (VLA) in A {con guration.W e observed with four 6.25 M H z IF s centered on the system ic velocity of the galaxy (893 km s¹; D e Vaucouleurs et al. 1991). The Q SO 0542+498 (21.94 Jy) was used as a ux calibrator; the QSO 0626+820 was used for phase and bandpass calibration. The data were Fourier{transform ed using natural weighting to create a 512 512 30 data cube with a restoring beam of 2^{10} : 1^{10} : and a noise level per channel of 0.2 m Jy/beam . The radio continuum was subtracted using the A IPS task UVLSF. This task ts a straight line to the real and in aginary parts of selected channels and subtracts the tted baseline from the spectrum, optionally agging data having excess residuals. In addition, this procedure provides the tted continuum as a UV data set, which has been used to create the naturally weighted m ap (Fig. 1).

M ERLIN Observation The Hiline in NGC 2146 was observed in June 1999 for 23 hours with MERLIN (6 antennas). The total bandwidth of 8 MHz was divided into 32 adjacent channels of 250 kHz width (52.6 km s¹). Three bad channels, two at the beginning and one at the end of the band, were removed, so that only 29 channels are present in the spectra. The frequency of channel 14 corresponds to a heliocentric velocity of 893 km s¹. The relative gains of the antennas were determ ined using the point source calibrator 0552+398, with a ux density of 1.754 Jy. The Q SO s 3C 286 (13.7 Jy) and 0602+ 780 were used for absolute ux density and phase calibration, respectively. The data were Fourier-transform ed using natural weighting to produce a 2048 2048 29 spectral line data cube. A naturally weighted continuum in age was obtained by averaging 19 channels free of line absorption (channels 2 to 10 and 19 to 28). This uncleaned in age was subtracted from the spectral line cube. Both the continuum im age and the continuum subtracted cube were then deconvolved using the CLEAN algorithm (Hogbom 1974) and convolved with the same

beam $(0^{\circ}20 \quad 0^{\circ}19)$. The cleaned continuum was added back to the continuum-subtracted cube. The rm s noise levels in source-free areas of the continuum maps and the spectral maps are 65 Jy beam ¹ and 300 Jy beam ¹, respectively, consistent with the expected therm al noise.

3 THE RESULTS

3.1 Spatial features and sources

Fig. 1 shows the VLA A {array 1.4 G H z naturally weighted continuum in age of the central 4.2 kpc 1.8 kpc region of NGC 2146. The 24m Jy peak is at the center of the galaxy; three other weaker regions of emission are also detected. The higher resolution 1.4 G H z M ERLIN m ap, shown in Fig. 3, resolves these emission peaks into individual supernova rem – nants and com pact/ultra{dense H ii regions (TNG). The inserts in Fig. 1 are H i absorption spectra integrated over the brightest 9 pixels (1^{00} 1^{00} 5000 pc^2) surrounding six selected regions of NGC 2146. Four of these regions are associated with radio continuum emission peaks and two coincide with the position of the water masers reported by Tarchiet al. (2002).

The spectra taken across the $1.4\,G\,H\,z\,m$ ap contain the H iabsorption line. An optical depth cube has been created using the relation

$$= \ln (1 T_{\rm L} = T_{\rm C}); \qquad (1)$$

where $T_{\rm L}$ is the brightness tem perature of the line, $T_{\rm C}$ the brightness tem perature of the continuum, and the optical depth of the line. We assume that the adopted excitation tem perature of $T_{\rm ex}$ = 100 K is much sm aller than $T_{\rm C}$.

Fig. 2 shows the average opacity () distribution derived in this way from the optical depth cube, blanking pixels with signal to (noise ratio below 4. This map is not bi-

ased by the strength of the continuum .The H iabsorption is seen as an elongated region of 2.4 kpc 0.6 kpc extent, thus sim ilar in extent to the starburst region, at a position angle of the m a pr axis of NGC 2146 (PA 140°). The extent and axial ratio of the H i absorption (and of the underlying emission) region of 1/4 is also seen in synchrotron

em ission maps taken at higher frequencies by Lisenfeld et al. (1996). Superim posed on the map of Fig. 2 are the positions of some prominent features in the nuclear region of NGC 2146, viz. the H i kinem atic center (H I), the CO kinem atic center (CO (C)), the 2.2 m peak of stellar radiation (IR), and the strong central radio continuum point

source (P). For the position of the H i kinem atic center we adopt the H i em ission peak at the system ic velocity (see Fig. 4); the CO kinem atic center is taken from G reve et al. (2004); the 2.2 peak is taken from the 2M ASS Extended Source Im age Server of the NASA/IPAC Infrared Science A rchive (http://irsa.ipac.caltech.edu/index.htm l); the position of the central source is taken from TNG. The coordinates of these features are given in Table 1. W hen we consider that the CO emission peaks have extensions of a few hundred parsecs, we nd from Fig.2 that the H i opacity peaks coincide clearly with the tangential directions CO (NW, SE) of the molecular ring, but also to some extent with the centralCO emission. It appears that the kinem atic center of the H i gas coincides with the center of the m olecular gas and the stars of the starburst region (see Fig. 2 in Young et al. 1988) to within the errors of the measurem ents (100 pc). Since in addition the orientation (PA) of the H i gas agrees with the orientation of the molecular gas and the

stars, we believe that the H i gas is to a large extent ∞ { spatial with these other constituents, thus belonging to the sam e kinem atic body of m aterial of the starburst region.

W e have used the optical depth cube to compute the peak and the integrated optical depth of the lines extracted at the six positions m entioned above. The column density N (in atom s cm 2) of the absorbing m aterial is calculated from

$$N = \frac{T_{ex}}{5.49 \ 10^{19}} dv; \qquad (2)$$

where $dv = 52.6 \text{ km s}^1$ is the velocity resolution of the observation, and $T_{ex} = 100 \text{ K}$ as typically used for starburst galaxies (e.g. W eliachew, Fom alont & Greisen 1984). The quantities derived in this way are listed in Table 2. Colum ns 1 and 2 give the radio continuum peak locations at which the spectra of Fig. 1 are taken; their 1.4 G H z continuum peak ux densities are listed in Colum n 3. Colum ns 4

to 8 sum marize the H i absorption properties at these locations, i.e. the line velocity and width, and the peak and integrated optical depth derived from G aussian pro les tted to the spectra. C olum n 9 gives the corresponding H i colum n density.

In the 1.4 G H z naturally weighted continuum MERLIN map (Fig. 3) we nd 10 of the 18 compact sources detected at 5GHz as reported by TNG.0fthese 10 sources, only the central one, 37.6+24.2 (for the source notation see TNG), shows a clear H i absorption line as illustrated in Fig. 3. This MERLIN spectrum is obtained from an integration over the brightest 9 pixels surrounding the source peak $(0^{\circ\circ}.045 \quad 0^{\circ\circ}.045 \quad 10 \text{ pc}^2)$. The absorption properties of this line are derived in the same way as described for the VLA data and are reported in boldface in Table 2; there exists good agreem ent between the VLA and MERLIN data. The higher sensitivity VLA observation does not con m the three other weak absorption features tentatively detected with MERLIN and reported by Tarchiet al. (2001). The other 1.4 G H z M E R L IN detected sources are too weak at the MERLIN resolution, and do not show any absorption above the noise level. W hen assum ing an excitation tem perature of 100K and a linewidth of 100 km s¹ (two channels), the indicative upper lim it for a com pact source of 0.7 m Jy beam 1 is 3:5 10^{22} atom s cm 2 . This lim it is consistent with the H i column density derived from the VLA data.

3.2 Rotation velocities

Individual velocity channel m aps with signi cant H i absorption extracted from the continuum {subtracted naturally weighted cube are shown in Fig.4.A bsorption can be traced over 10 channels, with the m axim um of the emission shifting with increasing velocity from the east (1 kpc) to the west (0.9 kpc) of the center. This gure clearly shows the rotation of the H i absorption m aterial, and also indicates the feature of a ring{like emission as seen especially in the CO observations (Jackson & H o 1988; Young et al. 1988). Fig. 5 shows the integrated total intensity m ap of the H i absorption, extracted from the continuum subtracted cube, with superim posed the isovelocity contours of the absorbing H igas.U sing a system ic velocity of 893 km s¹, the rotation of the disk of H igas increases from { 150 km s¹ in the east to + 170 km s¹ in the west.

Finally, in Fig. 6 we compare the rotation velocity of the H i absorption with the rotation velocity of the m olecular gas (CO) and the ionized gas (H). We nd that the H i m aterial rotates in the same way as the other constituents

of the starburst region. This fact con m s that the H i gas seen in absorption is concentrated in, or close to, the starburst region. In addition we nd that the rotation of the H i gas, the m olecular gas, the ionized gas, and the stars within 2 kpc of the starburst region (G reve et al. 2004) is sm ooth and does not reveal evidence of any disturbance from a galaxy encounter or a m erger.

The H i line width (Table 2) agrees well with the width of the CO lines and the width of emission lines originating in the ionized gas. The spectra of Fig. 1 and the values in Table 2 suggest that the line widths of the absorption features at the maser positions are system atically broader by 28 5 km s¹ than those at the other closeby positions, perhaps indicating a more turbulent medium in the recent star form ation region.

4 DISCUSSION

The only previous single{dish study of H igas in NGC 2146 by Fisher & Tully (1976) did not reveal any absorption, because of the low spatial resolution of the observation

 $(10^{10} = 700 \,\mathrm{pc})$. The rst detection of H i absorption in NGC 2146 is mentioned by Taram opoulos, Payne & Briggs (1996); later TPB reported details of the detection. They found that the absorption is lying in the region of the obscuring dust, having a velocity width of 350 km s¹ (thus covering the whole velocity range of rotation) and an average optical depth of 0.03. However, their VLA D {array observation was unable to spatially resolve the absorption. The higher spatial resolution VLA A (array observation presented here reveals H i absorption in front of the radio continuum emitted in the central 2 kpc of NGC 2146, allowing the construction of a map of its spatial distribution and its rotation. W hen discussing H i absorption m easurem ents it must be rem em bered that any absorption depends on the continuum strength against which it is seen. The optical depth im ages, on the other hand, are less dependent, if not independent, of the continuum and represent the column density distribution of H i (Eq.(2)). The strongest absorption is therefore observed against the brightest com pact radio source at the center of NGC 2146, while in the optical depth m ap of Fig. 2 the regions with the highest column density of H i are instead distributed alm ost sym m etrically with respect to the central source. The optical depth lies between a m inim um value of 0.3 and a m axim um of 0.9, which for a typical linewidth of 100 km s¹ corresponds to H i colum n densities between 6 and 18 10^{21} atom scm², respectively. W hen using the relation between the H i colum n density N_{H i} (cm²) and the optical extinction A_V (m ag) = 0.62 10^{21} N_{H i} derived by Savage & M athis (1979), and assuming for NGC 2146 the same gas{ to{dust ratio as in our Galaxy, we obtain A_V = 4 :::11^m which is consistent with the extinction of 4^m :::7^m derived by e.g. Benvenuti, Capaccioli & D'O dorico (1975), Sm ith, H arvey & Lester (1995), and Jackson & Ho (1988).

The H iabsorption velocity eld (Fig. 5) is very smooth and sim ilar to the rotation of the m olecular and ionized gas as shown in Fig. 6, which supports the structure of a rotating disk of H igas. The coincidence of the spatial distribution of the H im aterial with the extent of the continuum radiation of the starburst region, and the agreem ent with the rotation curves of the other constituents, suggests that the observed H im aterial is close to, or m ixed with, the m aterial of the central region. This is also supported by the fact that the H i absorption seem s to trace the m olecular ring (see Fig.2) although it is not seen as a distinct feature in the synchrotron radiation (Lisenfeld et al. 1996). The rotation of the gas

shown in Fig. 6 indicates a dynam ic mass inside 2 kpc of $1.2 \ 10^{10} \text{ M}$, for a galaxy inclination between 65 to 60. The dynam ic mass concentrated in this region is probably about 1/5 th, or less, of the total mass of the galaxy of at least 5 10^{10} M (Benvenuti et al. 1975).

Neutral hydrogen absorption studies of other starburst (and Seyfert) galaxies appear to trace gas in the central disks of the host galaxies to radial extents of a few hundred parsec only (Gallim ore et al. 1999). The H i gas is usually aligned to the larger outer disk of the host galaxy. None of the H i absorption studies of the other starburst galaxies shows a clear indication of an interaction by infall or outow of gaseous material, and NGC 2146 is in this respect no exception. Following the argum entation of Gallim ore et al. (1999, their Eq.(2)), the param eters N_{21} $5 \ 10^{21} \text{ cm}^{2}$ 150 km s¹ at r 1000pc (Fig.6) give (Table 2), Vrot a surface deposity ratio of the visible disk of H i absorption $_{\rm C}$ = 0:028N ₂₁ v_{rot}=r н I = m aterial of 0:02 which is wellbelow the critical density necessary to push the disk to instability.

In other starburst galaxies the interaction is prim arily evident from extended H i em ission tails linking the interacting companions, as for example clearly seen in the M 81{tiplet (Yun, H o & Lo 1994, W alter et al. 2002) and the NGC 3628{triplet (Schmelz, Baan & Haschick 1987). This interaction has apparently produced a bar in M 82 and NGC 3628, which fuels the starburst. W hile NGC 2146 has prom inent H i tails, a link to an interacting companion has not been found, and a bar has not been established. W hile num erical simulations do con m that mergers and yby encounters (with proper geom etrical constraints) can be successfull triggers of starburst (e.g.M ihos, R ichstone & Bothun 1992), the rapid gas depletion due to the star form ation activity limits the duration of such starbursts to between 50 to 150 M yr depending on the interaction's details (e.g.M ihos & Hemquist 1996).

For NGC 2146, TPB conclude that the trajectory of extended H i gas suggests that a possible interaction was in its most violent phase about 10^9 years ago. Then there should have been enough time for the gas in the inner region to relax, as observed, into a disk². However, the starburst, if coevalw ith the interaction, should be already term inated. On the contrary, the starburst in NGC 2146 is presently powerful (e.g. K ronberg & Bierm ann 1981) and relatively young (e.g. TNG), e.g. younger than the one in M 82, and thus contradicting a possible age of 10^9 years. The additional suggestion by TPB that the extended gas is falling into, and w ill continue to fall into NGC 2146 could explain how the present starburst is fueled. How ever, in this case we would also expect a sign of gas in ow, while we nd instead that

the distribution of the gas and stars in the inner 6 kpc is undisturbed and sm ooth.

W e m ight speculate that recursive short (10^7 years) starbursts have occured since the m erging/tidal encounter event, and that today we are witnessing the youngest of them, as it has likely happened in M 82 (e.g. de Grijs, O'C onnell & G allagher 2001). In such a case the necessary am ount of gas to fuel the star form ation activity would be sm aller and the infall of gas less m andatory. This speculation does, however, not cast any light on the origin of the starburst.

W hatever possibility m ay be correct, the origin and fueling mechanism of the starburst in NGC 2146 m ust, in our opinion, be searched for at large distances from the center, i.e. outside the body of the galaxy, where distortions of the distribution of gas and stars are seen.

5 SUMMARY AND CONCLUSIONS

From the $1.4\,G\,H\,z$ H i absorption line observations towards the starburst in NGC 2146, m ade with the VLA and MER-LIN, we reach the following conclusions:

{ the H i absorption is observed over the entire continuum radiation background which coincides with the starburst region;

{ the H i gas towards the starburst region has a column density between 6 and 18 $10^{21}~{\rm atom~s~cm}^{-2}$;

{ the H ivelocity eld has the structure of a rotating disk and ring, as often found in the inner region of sim ilar starburst system s;

{ the H iabsorption has a uniform spatial and velocity distribution without any indication of an encounter with another galaxy or a far-evolved m erger; there is no indication of a bar;

{ the absence of anom abus gas concentration or velocities and the agreem ent of the H i absorption rotation curve with those of di erent constituents (CO and H), suggest that the inner gas has had time to relax after the encounter; the signs of an encounter causing the starburst m ust be searched for in the outer regions of the galaxy.
