A SUB-M ILLIMETER SEARCH OF NEARBY YOUNG STARS FOR COLD DUST: DISCOVERY OF DEBRIS DISKS AROUND TW O LOW -MASS STARS

ABSTRACT

We present results from a JCM T/SCUBA 850 m search for cold dust around eight nearby young stars belonging to the Pic (t 12 M yr) and the Local A sociation (t 50 M yr) m oving groups. Unlike m ost past sub-mm studies, our sample was chosen solely on the basis of stellar age. Our observations achieve about an order of m agnitude greater sensitivity in dust m ass com pared to previous work in this age range. We detected two of the three M dwarfs in our sample at 850 m, GJ 182 and GJ 803 (M 2 0:5 M), with inferred dust masses of only 0.01{0.03 M .GJ 182 may also possess a 25 m excess, indicative of warm dust in the inner few AU of its disk. For GJ 803 (AU M ic; HD 197481), sub-mm m apping nds that the 850 m em ission is unresolved. A non-detection of the CO 3{2 line indicates the system is gas-poor, and the spectral energy distribution suggests the presence of a large inner disk hole (17 AU $= 1.7^{\circ}$ in radius for blackbody grains). These are possible indications that planets at large separations can form around M dwarfs within 10 Myr. In a companion paper (Kalas, Liu & Matthews 2004), we con m the existence of a dust disk around GJ 803 using optical coronagraphic in aging. Given its youthfulness, proximity, and detectability, the GJ 803 disk will be a valuable system for studying disk, and perhaps planet, form ation in great detail. O verall, sub-mm m easurem ents of debris disks point to a drop in dust mass by a factor of 10^3 within the rst 10 M yr, with the subsequent decline in the m asses of sub-m m detected disks consistent with $t^{0:5}$ to t^1 .

1. introduction

C ircum stellar disks are com m on around stars at ages of a few million years. Rotationally supported disks are a natural outcom e of the star form ation process, because of the need to conserve angular m om entum during the collapse of the natal molecular core. In addition, disks are central to current theories of planet form ation. These young disks are com posed of gas and dust, with estim ated m asses as large as several percent of the stellar m ass. By virtue of their large optical depths, they can be easily detected and have been intensively studied.

Over the span of 5{10 Myr, these prim ordial disks are thought to dissipate (e.g. Strom et al. 1993; Haisch et al. 2001b), based on the observed decline of IR excesses, which originate from warm dust in the inner disk. At older ages, planetesim als and planets com prise the rem aining circum stellar population. Collisions between the planetesim als produce dust grains, which form a "second-generation" disk. The Infrared Astronom ical Satellite (IRAS) discovered the rst example of a such dusty debris disk around Vega (Aum ann et al. 1984). O verall, volum e-lim ited far-IR surveys have found that about 15% of main-sequence stars have debrisdisks (Backman & Paresce 1993; Fajardo-A costa et al. 1999; G aidos 1999; P lets & V ynckier 1999; Habing et al. 2001; Laureits et al. 2002). Such disks have a small amount of dust, little evidence for gas, low characteristic tem peratures indicative of grains at tens of AU separations, and a dearth of warm material in their inner regions (e.g., Zuckerm an 2001). These attributes make

debris disks physically distinct from prim ordial disks and lead to much weaker observational signatures.

Loss processes for the dust in debris disks act quickly compared to the age of the host stars, and the debrism ust be continually replenished. Thus, studying debris disks over a wide range of ages can provide insight into their evolution and physical origin. Most studies have focused on stars with ages of & 200 M yr (Habing et al. 1999, 2001; Spangler et al. 2001; Laureijs et al. 2002), a re ection of the fact that most nearby stars are old.

The last few years have seen the discovery ofm any stars which are both young (t 10{100 M yr}) and close to E arth (d. 100 pc). These stars have largely been found in kinem atically associated m oving groups, by com bining accurate space m otions with evidence for youthfulness (e.g., Li abundances, X -ray em ission, and chrom ospheric activity). They include the Pic (8{20 M yr; Zuckerm an et al. 2001a) and the Local A sociation (20{150 M yr; Je ries 1995; M ontes et al. 2001) m oving groups. These are im portant system s for disk studies as they span an age range which is poorly studied. In addition, this tim escale is associated with assem blage of terrestrial planets in our ow n Solar System (e.g. W adhwa & Russell 2000), so understanding disk properties at this epoch can illum inate the overall physical context for planet form ation.

G iven the cold characteristic tem peratures of the dust ($40\{100 \text{ K}; e.g., D \text{ ent et al. } 2000\}$, sub-mm continuum observations of debris disks are valuable. The em ission is optically thin and hence can be used to estim ate the disk m asses, with the caveat that large bodies are m issed. P re-

vious sub-m m studies have focused on stars already known to have strong IR excesses (Zuckerm an & Becklin 1993; Sylvester et al. 1996; Holland et al. 1998; G reaves et al. 1998; Sylvester & M annings 2000; Sylvester et al. 2001; Holland et al. 2003; Holm es et al. 2003), with the most outstanding exam ples being spatially resolved at sub-m m wavelengths (Pic, Eri, Fom alhaut, Vega).

Much less has been done in the way of "blind" searches of stars in a given age range to understand their sub-mm disk frequency and properties. W yatt et al. (2003) have recently surveyed the secondary stars of binaries with 0 and B-type prim aries, a sam ple originally identied by Lindroos (1986). By virtue of the prim ary stars being on the main sequence, the systems are . 100 M yr old. Previous searches for dust around this sample had relatively poor sensitivity (G ahm et al. 1994; Jew itt 1994; Ray et al. 1995). O fparticular interest is the suggestion by W yattet al. that som e stars m ay harbor very cold (. 40 K) disks, which would be missed by previous far-IR searches and only detected in the sub-mm. However, one limitation of the Lindroos sample is that most of the systems are fairly distant, which impacts the resulting disk sensitivity of sub-mm observations.

In this Letter, we present an 850 m search for cold dust around young stars in the Pic and Local A ssociation moving groups. Unlike most previous sub-mm studies, our sample was chosen solely on the basis of stellar age. Our sample includes three M dwarfs (GJ 182, 799 and 803) which Barrado y Navascues et al. (1999) identied as the youngest of the nearby M dwarfs, based on the stars' pre-main sequence location on the color-magnitude diagram. The majority of debris disks from IR studies have been identi ed around A, F, and G-type dwarfs, sim ply due to observational sensitivity bias (e.g., com pilations by G reaves & W yatt 2003 and Zuckerm an & Song 2003). The loss processes for circum stellar dust depend on the host star lum inosity and gravity. Therefore, studying debris disks over a range of stellar m asses m ay also advance our understanding of this phenom enon.

2. observations

Sub-mm observations were made from December 2002 to November 2003 using the SCUBA bolom eterarray (Holland et al. 1999) at the 15-m Jam es Clerk Maxwell Telescope (JCMT) on Mauna Kea, Hawaii.⁴ Zenith optical depths ranged from 0.25 to 0.35 at 850 m.GJ 803 was rst observed on October 5, 2003 and well-detected at 850 m; additional 450 m data were obtained on Novem ber 12{13, 2003 in dry, stable conditions, with 450 m zenith optical depths ranging from 1.37 to 1.47. We used the photom etry mode to maxim ize observing e ciency, with integration times ranging from 18 to 96 m in on-source. The data were reduced using Starlink software and standard reduction techniques (see Jenness et al. 2002). Pointing was checked approximately once per hour and was accurate to better than 2^{00} m s over each night. Flux calibration factors were derived from observations of U ranus or N eptune w hen available, but secondary calibrators (CRL 618 or CRL 2688) were also used.

13, 2003 in jiggle-m apping m ode. The weather was stable during the observations with 850 m zenith optical depths ranging from 0.26 to 0.29. Pointing was checked every 1{2 hours using N eptune and was accurate to an m s error of 2^{00} . F lux calibrations were performed by observing U ranus and N eptune at the start of each night and were consistent between the two nights to within 10%. A total of 24 individualm aps were m ade at a range of in age rotation angles on the array. G J 803 was well-detected though the em ission is not extended at the signal-to-noise level (S/N 8) and angular resolution (14^{00} = 140 AU) of the map. The integrated 850 m ux in the map is consistent with earlier m easurem entsm ade in photom etry m ode. The em ission is also consistent with being centered on the star given the

pointing uncertainties. A sensitive search for CO J = 3{2 line emission from GJ 803 was conducted with the B3 dual-channel heterodyne receiver and digital autocorrelating spectrom eter (DAS) backend on the JCMT on N ovem ber 5, 2003. O beservations were performed in beam -switching mode with a $60^{\circ\circ}$ throw. We eather conditions were good, and the system tem perature ranged from 400 to 450 K over the elevation range of the observations (30{40}). A total of 200 m in of on-source integration was obtained. No signal was detected to a 1 level of 13 m K per 1 km s¹ velocity channel.

3. results

Table 1 presents our sample and SCUBA photom etry. We detected GJ 182 and GJ 803 at 850 m, with a possible (form ally 2) detection of GJ 803 at 450 m. GJ 803 is also detected at 60 m in the IRAS Faint Source Catalog (FSC) (M athioudakis & Doyle 1991; Song et al. 2002). In addition, we searched for all our targets in the IRAS dataset using the SCANPI algorithm (Helou et al. 1988), via the Infrared Processing and Analysis Center (IPAC) web site. This search revealed 25 m (color-corrected) uxes of 65 14 and 157 26 m Jy for GJ 182 and GJ 803, respectively, which were not included in the FSC.

For GJ 803, Figure 1 shows the 60 and 850 m excess em ission modeled with a single tem perature t. (The 25 m ux is consistent within 1 with being purely photospheric in origin.) For the t, we use a modied blackbody, where the em issivity is constant for < 100 m and for longer wavelengths. The spectral energy follow s distributions (SED s) of debris disks with more extensive multi-wavelength data are well described by this prescription, with = 1.1 to 0.5 (D ent et al. 2000). For this range of , the GJ 803 data are twith T = 35 + 45 K, with T = 40 2 K for a nom inal = 0.8, where the uncertainty is the form all error in the t. (Fitting a pure blackbody to the data gives 62 5 K.) Note that the IRAS nondetection at 100 m is a good m atch to = 0.8 and rules out & 1.W ith slightly greater sensitivity, IRAS should have detected this source. In addition, the marginal detection at 450 m agrees well with the = 0.8 t, but is inconsistent with a pure blackbody. The integrated fractional dust lum inosity $L_{dust}=L_{star}$ is 6:1 10⁴ for the nominal = 0:8, T = 40 K m odel.

W e also observed G J 803 w ith SCUBA on N ovem ber 12{

For GJ 182, the excess em ission at 25 m and 850 m

cannot be t with a single modi ed blackbody that also satis es the IRAS non-detections. Ignoring the 25 m ux for the moment, a 40 K, = 0.8 modi ed blackbody, like that which ts the G J 803 SED, is consistent with the 60, 100, and 850 m data (Figure 1). A higher dust tem perature would violate the 60 m upper limit. Of course, a lower dust tem perature would also be consistent with the 850 m detection. Firm er constraints on the dust tem peratures await more sensitive IR /sub-mm m measurem ents.

The m id-IR SED s are sensitive to the presence of warm dust in the inner disk regions. GJ 182 shows a strong 25 m excess (but see x 4.2). If we add a 150 (200 K com – ponent which em its as a = 0.8 m odi ed blackbody, a dust m ass of (4 12) 10⁵ M is needed to account for the 25 m excess, or 0.3 (0.9% of the T = 40 K dust component which satis es the 850 m ux (Figure 1). For GJ 803, the largem id-IR dip indicates an absence of warm dust in the inner regions. If we add a warm component which em its as a = 0.8 m odi ed blackbody, only a very sm all am ount of 150 (200 K dust is perm itted, since the IRAS 25 m ux is consistent with being photospheric. Taking the marginal 25 m excess at face value gives a warm dust mass of (3 9) 10⁶ M , or 0.03 (0.08% of the T = 40 K dust component.

For the entire sample, we compute dust masses from the 850 m uxes in the standard fashion, assuming optically thin emission characterized by a single temperature:

where F is the ux density, d is distance, is the dust opacity at the observing frequency, and B is the P lanck function for a dust tem perature T. W e adopt a dust opacity of 1.7 cm² g¹, in agreem ent with past studies (Zuckerm an & Becklin 1993; G reaves et al. 1998; H olland et al. 1998; Sylvester et al. 2001; W yatt et al. 2003; W illiam s et al. 2003; Sheret et al. 2003). This value is on the upper end of the 0.4{1.7 cm² g¹ range discussed by P ollack et al. (1994). For non-detections, we use 3 upper limits on the 850 m ux and assume T = 30 100 K, in agreement with previously detected debris disks (D ent et al. 2000). For G J 803, we adopt the 40 K tem perature from the SED tting. The calculated dust m asses are presented in Table 1.

It is unlikely that our detections are due to background galaxies. Scott et al. (2002) estim ate a surface density of about 500 objects per square degree brighter than an 850 m ux of 6 m Jy, about the 3 sensitivity of our survey. The probability of any background objects to be within an angular distance of a target is $1 \exp(2^{\circ})$, where is the surface density of background objects above a speci ed ux level. We compute the ensemble probability of detecting any background objects in SCUBA's central bolom eter for our entire sample of 8 objects, accounting for the fact that we mapped G J 803. This gives a 4% probability that background sources would produce at least one detection in our survey.

The GJ 803 system appears to have very little m olecular gas. The CO 3{2 intensity is 45 49 mK km s¹ integrated over 7 km s¹ about the stellar velocity. (This velocity range corresponds to the maximum orbital speed for a disk viewed at an inclination of 80 with the inner disk edge of 17 AU derived from the SED t.) A ssuming the gas is optically thin and in them al equilibrium with 40 K dust, the 3 upper limit im plies a CO column density of 62 10^{13} cm 2 . Tem peratures as warm as 150 K , e.g., if the gaswere located in the inner few AU, would give inferred CO colum n densities of a factor of 2 larger. D eterm ining an upper lim it on the total gas m ass is uncertain, since this is dom inated by H_2 and the H_2 to CO conversion is highly uncertain. CO may freeze-out onto grains, making it a poor tracer of the total disk mass. A lso, photo ionization may a ect the H_2 to CO conversion factor. To attempt to account for photoionization by the interstellar UV eld, we refer to calculations by van D ishoeck & Black (1988), slightly extrapolated to lower CO colum n densities, and adopt an H₂ to CO abundance ratio of 10 7 (cf., norm all abundance ratio of 10 4). This results in an H_2 mass of 1.3 M , if we ignore the possibility of CO freeze-out. O verall, the gas non-detection lim its for G J 803 are comparable to those for older solar-type stars (D ent et al. 1995; G reaves et al. 2000a) and rules out the possibility of GJ 803 having a gas-rich disk comparable to those detected around younger stars (Zuckerm an et al. 1995; G reaves et al. 2000b).

4. discussion

4.1. Sub-M illim eter Evolution of D ebris D isks

Figure 2 sum m arizes the known debris disk m ass estimates based on sub-m m observations from our work and the published literature. Our SCUBA survey adds a signi cant number of stars of $10\{50 \text{ M yr}$. Our raw 850 m sensitivity (m edian mm s of 1.9 m Jy) is poorer than the W yatt et al. (2003) survey of Lindroos binaries (m edian mm s of 1.6 m Jy). But given the much closer distances of our targets, our dust m ass sensitivity is better by around an order of m agnitude. In particular, Figure 2 shows the follow ing:

- 1. Com pared to prim ordial disks around T Tauri and Herbig A e/Be stars which have dust m asses of 10{ 300 M (e.g.O sterbh & Beckw ith 1995; N atta et al. 2000), the dust m asses for the detected young stars are 10³ sm aller. This points to very rapid evolution of the circum stellar dust m ass within the rst 10 M yr, likely arising from grain rem oval (e.g., via accretion onto the central star) and/or grain grow th into larger bodies, which would greatly dim inish the sub-m m/m m em ission.
- The upper envelope for disk m asses around A stars exceeds that for later-type stars. This may reect the distribution of prim ordial disk m asses; for T Tauri stars a sim ilar trend is seen, where the upper envelope of prim ordial disk m asses is larger for m ore m assive stars (N atta 2003).
- 3. For stars of 10 100 M yr old, nearly all the detected disks at a given spectral type (i.e., stellarm ass) are less massive than the upper limits on non-detections. This highlights the fact that existing sub-mm m easurements are only sensitive to the most massive of the young debris disks.
- 4. The apparent correlation of dust m ass with stellar age arises from observational bias: the young stars

detected in the sub-mm are at larger distances than the old stars. How ever, the decline in the upper envelope of disk masses with age is probably a real e ect. W hile there are no published sub-mm data in the upper right of Figure 2 (i.e., old stars with massive disks), the existing sub-mm detections of nearby, old stars come from sources known to possess large IR excesses in IRAS and ISO data. Any old stars with even more massive disks would have been detected by these IR surveys, unless the dust was unprecedentedly cold. Based on the data in Figure 2, the masses of sub-mm detected disks evolve roughly as M_{dust} t^{0:5} to t¹, with a simple unweighted t giving M_{dust} / t^(0:7 0:2).

4.2. Debris Disks and Planets around Low-Mass Stars

GJ 182 and GJ 803 are the rst M -star debris disks detected at sub-millim eter wavelengths.⁵ The dust lifetime is short compared to the stars' ages (e.g. Backman & Paresce 1993). Therefore, the dust must be replenished by collisions between planetesimals, either in situ or else from regions farther out. Note that for these low luminosity stars (0.1{0.2 L}), radiation pressure on the grains is negligible compared to the star's gravity, unlike debris disks around A stars, e.g., Pic where micron-sized and smaller grains are expelled (Artym ow icz 1988).

Ourwork shows that most debrisdisks around low-mass stars probably lie at or below the sensitivity lim its of the IRAS survey and JCMT/SCUBA observations. GJ 182 is just at the practical lim it for IRAS and SCUBA detection. GJ 803 is the nearest object in our sample, and am ong the nearest known young stars, which makes detection of its very tenuous dust mass feasible. The one undetected M dwarf in our sam ple, G J 799, is just as close and young as G J 803. G J 799 is known to be a 3^{00} binary of com parable m agnitude (M ason et al. 2001), which m ay im pact its dust content. In addition, its M 4.5 spectral type corresponds to M $_2$ 0.10{0.15 M , about 3{4 sm aller than for GJ 182 and GJ 803 (e.g., see models presented in Hillenbrand 1997 and Luhm an 1999). Hence, the nondetection m ay simply be due to insu cient sensitivity; our JCM T data for GJ 799 would have to be 4 deeper in order to reach the sam eM dust=M star as for the two detected M dwarfs. Prim ordial disks are common around low mass stars (Haisch et al. 2001a) and even brown dwarfs (Liu et al. 2003) at ages of a few M yr, and these system s m ay very well generate debris disks as they age. The Spitzer Space Telescope will o er the requisite sensitivity for detecting and studying such disks.

For GJ 182, the 25 m excess suggests that dust resides in the inner regions of its disk: $150{200 \text{ K}}$ blackbody grains would lie at $1{2 \text{ AU}}$ from the star. Given the sparse sam pling of the current SED, one cannot determ ine if the dust distribution is continuous throughout the disk, or if there is a gap in the middle regions of the disk (e.g., from planet form ation) between the 25 m and 850 m em itting dust. However, as shown by Song et al. (2002), single band excesses near the sensitivity lim it of the IRAS catalog m ay not be reliable. Though the SCANPI detection

of G J 182 has S/N = 4.6, higher than the $S/N = 2\{4 \text{ objects exam ined by Song et al., for now we treat the 25 m excess of G J 182 as tentative. M ore detailed SED m easurem ents, in particular with Spitzer, would be invaluable to characterize this star's disk.$

The absence of warm dust in the inner regions of GJ 803 (and perhaps GJ 182, if the 25 m detection is spurious) is naturally explained by an unseen inner com panion. The 40 K temperature characteristic of the SED is too cold to be explained by sublimation or melting of icy grains (100-170 K).W ithout an inner companion, the e ect of Poynting-Robertson drag would cause grains to spiral inward and produce signi cantmid-IR emission. Such inner holes are typical for debris disk system s. Indeed, the few debris disks with resolved dust em ission show morphologies highly suggestive of the dynam ical in uence of an unseen com panion at m ean-m otion resonances (H olland et al. 1998; G reaves et al. 1998; O zemoy et al. 2000; K oemer et al. 2001; W ilner et al. 2002; Q uillen & Thorndike 2002; Wahhajet al. 2003; Kuchner & Holm an 2003; Thommes & Lissauer 2003).

The 40 K characteristic tem perature from the SED tting m eans that blackbody grains around GJ 803 would be at a distance of 17 AU, or an in pressively large angular separation of $1.7^{\circ\circ}$. (For GJ 182, 17 AU corresponds to only $0.6^{\circ\circ}$.) This provides only a rough guide as to the angular separation of any interior companion, since it is di cult to use the SEDs of debris disks to predict the spatial dust distribution (Sheret et al. 2003). Shallow IR adaptive optics in aging from the K eck O bservatory with $0.05^{\circ\circ}$ resolution shows no stellar or m assive brown dwarf companion, suggesting that an even lower m ass companion is present. To date, GJ 876 is the only M dwarfknown to have extrasolar planets (M arcy et al. 1998, 2001); its two planets have sem im a pr axes of 0.13 and 0.21 AU.

Thus the GJ 803 inner disk hole may indicate that planets can exist at larger separations around M dwarfs than known so far and that such planets can form within

10 M yr. Furtherm ore, given the very young age of the system, a planetary com panion is predicted to have signi - cant therm alem ission (e.g. B urrow set al. 1997) and hence m ight be detectable with deeper AO im aging. M dwarfs are by far the most num erous type of star, so a better understanding of their planet-bearing frequency is needed for a com plete census of the extrasolar planet population.

Follow -up coronagraphic in aging by K alas et al. (2004) nds that G J 803 has a large, nearly edge-on disk seen in scattered optical light. This disk is detected from 5{ 21^{00} (50{210 AU}), though the inner and outer extent are not well-constrained. Our sub-m m in aging nds that the 850 m dust em ission is unresolved. This is entirely com – patible with the large optical disk, given that the grains responsible for scattering m ay be very cold and/or sm all, and hence poor sub-m m em itters. Deeper sub-m m m apping is needed for stronger constraints on any extended em ission. In general, the proxim ity and youthfulness of G J 803, com bined with the high sub-m m and optical detectability of its disk, make this system an excellent op-

portunity to study disk evolution, and perhaps planet formation, in great detail.

The onset and duration of the debris disk phenom enon remain open questions. As discussed by G reaves & W yatt (2003), the disk masses might slow ly decay over time, or perhaps the mass distribution is bim odal, re ecting \on" and \o "states for detectability. The G J 803 debris disk o ers som e insight into this issue. Using the Hipparcos catalog, which is nearly complete for early-type M dwarfs (M 0{M 2) within 10 pc, Song et al. (2002) found GJ 803 was the only object out of a sam ple of 152 M dwarfs to possess an ${\rm I\!R}$ excess in the ${\rm I\!R}{\rm A\,S}$ FSC. This is not due to detection bias, as there are many early-type M dwarfs which have closer distances than GJ 803. GJ 803 is also known to be among the youngest of the nearby M dwarfs (Barrado y Navascues et al. 1999; Zuckerm an et al. 2001a). If the appearance of debrisdisks was an intermittent event, Song et al. should have detected older M dwarfs with IR

excesses at both 60 and 100 m, if their disks were like the GJ 803 one. Either these older M dwarfs do not have disks, or their disks are much less massive than GJ 803. Therefore, at least for the case of M dwarfs, the GJ 803 system suggests that the time evolution of debris disks is driven primarily by age, with the youngest stars having the largest disk m asses.
