# Large-scale wind structures in OB supergiants: a search for rotationally modulated H variability?

#### ABSTRACT

We present the results of a long-term monitoring campaign of the H line in a sample of bright OB-supergiants (O7.5{B9) that aim s at detecting rotationally modulated changes potentially related to the existence of large-scale wind structures. A total of 22 ob jects were monitored during 36 nights spread over 6 months in 2001{2002.Coordinated broad-band photom etric observations were also obtained for som e targets. Conspicuous evidence for variability in H is found for the stars displaying a feature contam inated by wind em ission. Most changes take place on a daily time-scale, although hourly variations are also occasionally detected. Convincing evidence for a cyclical pattern of variability in H has been found in 2 stars: HD 14134 and HD 42087 (periodic signals are also detected in other stars, but independent con mation is required). Rotationalmodulation is suggested from the similarity between the observed recurrence tim e-scales (in the range 13{25 days) and estim ated periods of stellar rotation.We call attention to the atypical case of HD 14134 which exhibits a clear 12.8-d periodicity both in the photom etric and in the spectroscopic data sets. This places this object among a handful of early-type stars where one may observe a clear link between extended wind structures and photospheric disturbances. Further modelling m ay test the hypothesis that azim uthally-extended wind stream s are responsible for the patterns of spectral variability in our target stars.

#### 1 IN TRODUCTION

O ne of the m a pr legacies of the International U Braviolet Explorer (IUE) was to establish the ubiquity of UV line-pro le variability in OB stars. The pattern of variability predom - inantly consists of extra absorption features (the so-called 'discrete absorption com ponents'; hereafter DACs) m oving blueward across the (unsaturated) absorption troughs of P C ygni lines (e.g., K aper et al. 1996). The repetitive nature of DACs and the fact that the recurrence tim e-scale is com - m ensurate with the (otherw ise ill-de ned) stellar rotational

period suggest that rotation plays a key role in inducing the patterns of variability (e.g., K aper et al. 1999). UV timeseries with a long temporal baseline (i.e., sam pling several rotational periods) have revealed that OB stars exhibit a great diversity of behaviours that cannot always be strictly related to the stellar rotation period (e.g., H ow arth, Prinja & M assa 1995; Prinja, M assa & Fullerton 1995; Prinja, M assa & Fullerton 2002). Nevertheless, this global phenom enon has been successfully interpreted in several cases in the fram ework of a m odel in which the changes are caused by the rotational m odulation of large-scale, azim uthally-extended wind stream s (e.g., Fullerton et al. 1997).

The hydrodynam ical sim ulations of C ranm er & O wocki (1996) suggest that large-scale photospheric perturbations (e.g., bright 'spots' causing a local enhancem ent of the radiative driving force) m ay lead to the developm ent of these

structures. A lthough the underlying physical mechanism remains elusive, pulsational instability can be invoked as a trigger of the wind variability (e.g., Fullerton, Gies & Bolton 1996). Large-scale or 'surface' magnetic eld structures could be a viable alternative in view of the growing evidence for (weak) magnetic elds in OB stars (e.g., Henrichs, Neiner & Geers 2003). Photospheric perturbations arising from these two phenomena are likely to have a signi cant im pact on the global wind morphology (e.g., ud-Doula & O wocki 2002).

W ith the dem ise of IUE, further progress on this issue is likely to stem in the foreseeable future from tim e-resolved studies of line variability in the optical. Firstly, intensive UV observations have been carried out over several rotation periods for few stars (M assa et al. 1995; Prinja et al. 1998; de Jong et al. 2001). For practical reasons, an optical survey is much more am enable at collecting high-quality observations covering several cycles for a large, representative sam ple of OB stars. Secondly, in contrast to the UV resonance lines, optical recombination lines are (at least partly) form ed in OB supergiants in the dense, strongly accelerating part of the out ow close to the stellar core. In virtue of their densitysquared dependence, they are good probes of the large density gradients expected to prevail in the co-rotating interaction regions (Cranmer & Owocki1996). Revealing a cyclical pattern of variability in these lines would give further credence to the idea that the origin of an isotropic out ows in OB stars is deep-seated and causally linked to processes taking place at the stellar photosphere. Here we discuss the tem poralbehaviour of H , which is typically form ed at r 1.5 R<sub>?</sub> in O -type stars (e.g., Prinja, Fullerton & Crow ther 1996). A lthough the line-form ation region is likely to be more extended in B-type supergiants, this transition still probes the few inner radii of the stellar wind.

P revious surveys have been very useful in docum enting H line-pro le variability in OB stars (e.g., Ebbets 1982), but frequently su ered from a poor tem poral sam pling ham – pering the study of the line-pro le variations on a rotational tim e-scale (up to several weeks in the case of B supergiants). D espite the persistent and num erous searches for optical line-pro le variability in OB stars, evidence for rotational m odulation has been found in only few cases (e.g., M o at & M ichaud 1981; K aper et al. 1997, 1998). In the UV and optical dom ains the tim e-scales associated with the changes are often identical, within the uncertainties (e.g., H owarth et al. 1995; K aper et al. 1999; de Jong et al. 2001; K aufer, Prinja & Stahl2002). This suggests that H variability and DACs diagnose the sam e underlying physical phenom enon.

The long-term monitoring of the H line presented in this paper aim s at better establishing the incidence of rotationaly modulated variability in OB supergiants. To potentially link the photospheric and wind activity, coordinated broad-band photom etic observations were also carried out for a subset of this sample. Our survey primarily targets early B-type stars and can thus be regarded as com plementary to others that concentrate on O-type (K aper 1998; K aper et al. 1998) or late B- to early A-type supergiants (K aufer et al. 1996). The results presented in the following supersede previous preliminary reports (M orel et al. 2004a, b).

# 2 TARGET SELECTION AND TEMPORAL SAMPLING OF THE OBSERVATIONS

Our targets are drawn from a magnitude-limited (V < 7.5) sam ple of early-type supergiants (07.5 (B9) with evidence for an emission-like H prole or, in the case of stars with an absorption feature, for previous claim s of a wind-related variability (e.g., lling-in of the pro le). Known close binaries were discarded from this list in order to avoid contam ination from the wind collision e ects (e.g., Thaller et al. 2001). The wide binary orbit of HD 37742 rules out the formation of a bow shock created from the interaction with an O-type companion (Hummelet al. 2000). In our data only HD 13854 and HD 47240 present signi cant velocity variations of the photospheric HeI 6678.15 line which might be attributed to binary motion (see below). D warfs and giant stars were not included in this list, as H is of photospheric origin in the vast majority of these objects. The only exception was the 07.5 giant HD 24912 ( Per) because of previous claims of a cyclical, wind-related pattern of variability in H (Kaper et al. 1997; de Jong et al. 2001). For the other stars in our list, no clear evidence for cyclical linepro le variations in optical wind lines was found prior to our survey. Som e physical param eters of our program stars are given in Table 1.

The basic requirem ent of this survey was to achieve a tim e sam pling allow ing a proper assessm ent of the variability pattern on a rotational tim e-scale (typically 1{2 weeks). Although the rotational periods of our program stars are unknown, the critical and projected rotational velocities can be used, along with the estim ates of the stellar radii, to set a lower and an upper lim it on this quantity. A s can be seen in Table 2, the estim ated rotational periods span a wide range of values (12{144 d).Our 22 program stars were monitored during a total of 36 nights spread over 6 m onths, with 1{2 spectra obtained every night. This long-term monitoring was necessary to cover at least one rotational cycle for the slow ly rotating objects. W e also obtained intranight observations, expecting signi cant hourly changes in som e cases (e.g., HD 24912). In general, this temporal sampling appears to be adequate for our purpose (see Table 3). For 5 stars, how ever, the observations were too sparse to reliably investigate a potential cyclical behaviour (HD 14818, HD 21291, HD 119608, HD 151804, and HD 152236). No period search was performed in this case (see Section 5.2), but a qualitative description of the changes is presented in Section 4.

# 3 OBSERVATIONS AND REDUCTION PROCEDURE

# 3.1 Spectroscopy

O urobservations were obtained during 4 observing runs conducted between 2001 N ovem ber and 2002 M ay at the 40-inch telescope of the Vainu B appu O bservatory (K avalur, India). The spectograph was equipped with a TK 1k CCD chip. W e used the 651 1/m m grating blazed in the 1st order at 7500 A, which yields at H a reciprocal dispersion of 1.45 A pixel <sup>1</sup> (we used a 120 m -wide slit), thus covering the spectral region 5810{7205 A. The slit of the spectrograph was rotated for HD 37742 in order to avoid contam ination from the visual com panion. The speckle interferom etric ob-

servations of M ason et al. (1998) exclude the existence in HD 24912, HD 30614 and HD 151804 of bright (m < 3 m ag), close companions ( $0.035^{\circ\circ} < 1.5^{\circ\circ}$ ). A part from HD 37742, a search in the H ipparcos database reveals only one star in our sample with a close visual component (HD 42087: H  $_{\rm p}$ = 2.58 m ag and = 0.6 $^{\circ\circ}$ ).

The IRAF<sup>2</sup> tasks were used to carry out standard reduction procedures (i.e., bias subtraction, at-ekking, extraction of the spectra, and wavelength calibration). Spectra of FeN e lamps were taken immediately before and/or after the stellar exposure. The spectra were subsequently put in the heliocentric velocity frame. The H line proles were found to be signi cantly a ected by telluric lines, as the observations were often carried out under unfavourable atm ospheric conditions (e.g., high humidity). Therefore, we have obtained spectra of the rapid rotator HD 65810 (A1V) to create a library of telluric lines that would be used on the target stars. Since this procedure proved unsatisfactory, we

used instead the high-resolution telluric spectrum of Hinkle et al. (2000) degraded to our resolution. The water vapour lines in the pseudo-continuum regions around H were interactively shifted and scaled with the IRAF task telluric until the residuals between the observed spectra and the tem plate telluric spectrum were minimized. The spectra were nally continuum - recti ed by tting a low - order spline3 polynomial to xed line-free spectral regions on both sides of H . W e generally obtained three consecutive exposures to allow a more robust rectication of the spectra and ltering of cosm ic ray events. Any individual exposure with evidence for an imperfect continuum normalization was excluded during the co-adding operation. The typical signal-to-noise ratio (S/N) at H in the combined spectrum is quoted for each star in Table 3, and lies in the range 125{335 per pixel in the continuum . Large velocity variations of the photospheric HeI 6678 line, which m ight arise from binary motion, were found in HD 13854 and HD 47240 ( 15 and 30 km s  $^{1}$ , respectively). The spectra were hence realigned and put in the same reference frame. The remaining stars may have com panions (e.g., HD 37742), but the radial velocity variations are sm all, i.e., com parable to the typical uncertainties in the wavelength calibration ( 5 km s  $^{1}$ ). Hence, all the discussed spectral variations should be intrinsic to the star.

#### 3.2 Photom etry

Coordinated B - and I-band (Johnson) photom etric observations were carried out with the 24-inch telescope of the Bell Observatory operated by the W estern Kentucky University (USA). Six stars were observed during 7 nights in January, February and April 2002: HD 13854, HD 14134, HD 14818, HD 42087, HD 47240, and HD 52382. A typical observation (repeated up to 3 tim esper night) com prises up to 10 short-exposure (1{10 sec}) CCD in ages of the target and the surrounding eld (0.53<sup>co</sup> pixel <sup>1</sup> scale, providing an 4:4<sup>o</sup> 6:6<sup>o</sup> eld).

The standard processing routines were perform ed with IRAF tasks and included bias and at eld correction, followed by measurements of all available comparison stars in the elds surrounding the targets. Pre-selection of appropriate comparison stars was based on their brightness and non-variability. All the di erentialm easurements performed on the stars from individual fram es were com bined into norm al observation, thus producing 1{3 data points per night for each star. This resulted in overall accuracy 0.01 m ag per data point for each com parison star. This relatively low accuracy was mainly dictated by the lack of appropriately bright com parison stars, the problem being especially acute for HD 14818, HD 42087, and HD 47240. For HD 42087, in particular, there was only one very faint com parison star in the eld, resulting in a much lower accuracy ( 0.02 m ag). These data are not discussed in the follow ing.

# 4 OVERVIEW OF THE SURVEY AND QUANTITATIVE ANALYSIS

The H time-series are shown in Fig.1, along with the tem - poral variance spectra (TVS; Fullerton et al. 1996). As can be seen, all stars display signi cant variability across most

of the H pro le (the extent of the variability in velocity space is well correlated with the wind term inal velocity: v

 $0.3 v_1$ ). O ne can note that m orphological evidence for a H feature partly form ed in the out ow (i.e., a line pro le clearly departing from a pure photospheric one) is system atically accompanied by much more prominent changes. The detected variability is qualitatively similar to the cases reported by Ebbets (1982). Noteworthy is the emission-like episode experienced by HD 14134 and HD 43384. The dramatic variations previously reported in HD 21291 (Denizman & Hack 1988; Zeinalov & Rzaev 1990) and HD 91316 (Sm ith & Ebbets 1981) are not seen in our data.

M ost changes take place on a daily tim e-scale, although signi cant hourly variations are som etim es observed. These subtle, short-term changes should be considered with some caution. In some cases, we cannot exclude the possiblity that they largely arise from an imperfect continuum normalization and/or rem oval of telluric features (Section 3.1). To better assess the reality of these short-term variations, we use a 'quality ag' de ned as the num ber of co-added consecutive exposures (indicated for each spectrum in Fig.1). Hourly changes between spectra rated as '1' should be regarded with some suspicion (e.g., HD 14134), whereas they are very likely to be real between spectra rated as '3' (e.g., HD 37128). Our data support the hourly changes found in HD 38771 by Rusconiet al. (1980), but not the variations on a tim e-scale of 30 m inutes reported for HD 53138 by van Helden (1972).

O ne should bear in m ind that the observed variations in H may not be straightforwardly associated to w ind activity. It is likely that tim e-dependent changes, possibly arising from pulsations, as commonly observed in early-type super-

giants (e.g., de Jong et al. 1999; K aufer et al. 1997), also affect the underlying photospheric pro le.A lthough our modest spectral resolution precludes a detailed study, we choose to illustrate the tem poral changes in photospheric lines by means of HeI 6678. With the exception of HD 152236 which occasionally exhibits a P Cygnipro le, this feature appears to be primarily of photospheric origin for all the stars in our sam ple. The changes a ecting this line are generally signi cant (see Fig.1), and are likely paralleled in the H photospheric com ponent. Because of substantial pressure broadening in B-type supergiants, such variations will extend in velocity space wellbeyond the projected rotational velocity (e.g., R yans et al. 2002). In m any cases the observed HeI 6678 variability barely exceeds the detection thresholds, which prevents us from linking the patterns observed in H and HeI 6678. The limited spectral resolution also precludes a straightforward interpretation of the variability as arising either from a variable, incipient em ission or from tem poral uctuations in the shape of the absorption pro le (e.g., HD 31327). A direct com parison between the patterns of variability in HeI 6678 and H will be presented for two illustrative cases in Section 6.1.

To quantify the level of spectral and photom etric variability, we de ne the two activity indices  $a_{phot}$  and  $a_{lpv}$  (Table 4). The form erwas calculated both from H ipparcos data and from our photom etric observations, and is de ned as:  $a_{phot}^2 = \frac{2}{obs} \{ \frac{2}{instr}, where obs and instr are the scatter of the scatter$

observations and the instrum ental noise, respectively (see M archenko et al. 1998). The spectral variability index,  $a_{lpv}$ , is the fractional amplitude of the line-prole variations, i.e., the amplitude of the changes norm alized by the strength of the feature (see equation [15] of Fullerton et al. 1996). This index was calculated both for H and for HeI 6678.

## 5 PERIOD SEARCH

W e perform ed a period search analysis by calculating the power spectra (hereafter PS) using the technique of Scargle (1982) on: (a) the photom etric H ipparcos data (our observations are not am enable to a period search), (b) the pixel-topixel H time-series, (c) the equivalent widths (EW s) m easured within xed wavelength intervals encom passing the whole of H (even in the case of P Cygnipro les). D espite the fact that the EW and pixel-to-pixel line-pro le variations are not, strictly speaking, two independent quantities, a period search in the two data sets helps assessing the reality of the detected signals. Subsequent correction of the frequency spectrum by the CLEAN algorithm was perform ed in order to rem ove aliases and spurious features induced by the uneven spacing of the data in the time dom ain (R oberts, Lehar & D reher 1987).

#### 5.1 Photom etric data set

Periodicities in the range 1{27 days have been found for 9 stars in our sam ple. Several stars display signi cant variability at the 0.03{0.07 m ag level without, how ever, evidence for cyclical changes. A com plex, multi-periodic behaviour cannot be ruled out in this case. As can be seen in Fig2, our photom etric observations of HD 13854, HD 14134, HD 14818, and HD 47240 support the periodic nature of the variations suggested by the H ipparcos data. This dem onstrates the rem arkable long-term (years) coherency in the patterns of variability: folded with the appropriate periods, practically all the new data points stay well within the scatter lim its (m ainly intrinsic, considering the typical accuracy of the H ipparcos photom etry), without any adjustment of the initially chosen zero phases.

## 5.2 Spectroscopic data set

The signi cance of the peaks in the PS can be, in principle, rigourously estim ated after norm alization by the variance of the data (e.g., Scargle 1982). In the case of unevenly spaced tim e-series, however, the false alarm probability (hereafter FAP) is only indicative and cannot be used as a robust indicator of the presence of periodic signals in the data (see, e.g., Antokhin et al. 1995). While assessing the reality of the periods found in our spectroscopic data set, we therefore took into account additional criteria. Nam ely, we inspected the period-folded EW /line-pro le data, and com pared the

EW and 2D pixel-to-pixelPS (even though the line-pro le variations are obviously not necessarily accompanied by signicant EW changes). The existence of a cyclical pattern of variability is suggested for 9 stars out of the 17 included in the analysis. These cases are individually discussed below.No indication of a cyclical behaviour was found in HD 24398, HD 30614, HD 31327, HD 43384, HD 52382, HD 53138, HD 58350, and HD 91316. K aper et al. (1998) and M arkova (2002) report variations on a time-scale of about one week in HD 30614. A search for periodic m odulations of the UV lines in HD 53138 proved inconclusive, in line with our non detection (Prinja et al. 2002).

HD 13854: Signi cant power at  $0.955 \text{ d}^{-1}$  is found in the EW data (Fig.3), but not in the H time-series.

H D 14134: This star does not exhibit any evidence for binarity (Abt & Levy 1973). The photom etric variability of HD 14134 is relatively well documented (Rufener & Bartholdi 1982; W aelkens et al. 1990; K rzesinski, Pigulski & Kołaczkowski 1999; A delman, Yuce & Engin 2000), but the H ipparcos data provide the rst clear evidence for a periodic pattern with P 12.823 d (Fig.2). Two periodic signals at  $_1$ =0.045 and  $_2$ =0.080 d  $^1$  (P 22.2 and 12.5 d, respectively) are unam biguously detected in the 2D PS, with FAP<0.1 per cent (see Fig.4). The latter frequency is also found in the EW PS (once again with FAP<0.1 per cent) and is, within the errors, identical to the value found in the photom etric data. The non-detection of  $_1$  both

in the EW and in the photom etric data sets leads us to take  $_2$  as the fundam ental frequency. The two signals are likely to be simple harmonics ( $_2$   $_2$ \_1). As can be seen in Fig.5, maximum H emission nearly coincides with maximum light. We use the photom etric ephemeris when folding the EW s (P = 12.823 days and T\_0=2,447,867.8), as this period is undistinguishable, but more accurate, than the value derived from the spectroscopic data.

The clearly phase-locked nature of the variations is reminiscent of som e early-type stars displaying evidence for a decentered, dipole magnetic eld (e.g., Stahl et al. 1996). A single circular polarization spectrum of HD 14134 was therefore obtained on 29 July 2003 using the M uSiC oS spectropolarim eter at the 2-m Bernard Lyot telescope (P ic du M idi O bservatory). The peak S/N was 250 (weather conditions were relatively poor). The mean pro les obtained using the Least-Squares D econvolution procedure (LSD; D onati et al. 1997) show no signi cant circular polarization within spectral lines. The measured longitudinal magnetic eld is 45 145 G (G.A.W ade, private com munication).

H D 24912: de Jong et al. (1999) discussed periodic changes in photospheric lines that may arise from pulsations (P 3.45 hours). This star presents a strong case for a persistent, cyclical variability in the UV wind line-pro les with P 2 days (K aper et al. 1997). From an analysis of an extensive data set of UV and optical observations, de Jong et al. (2001) reported a 2.086-d m odulation of the line pro les, notably in H . In our data we nd indication for a period tantalizingly close to, but apparently signi cantly di erent

from this value: P 2.20 d (with a typical uncertainty of 0.03 d). There is also some evidence for long-term changes in the pattern of variability. W hile cyclical variations are suggested here in the red wing of H (Fig.4), such changes predom in nantly occured in the blue wing on O ctober 1994 (de Jong et al. 2001). A lthough the periodic signal found in our data is present both in the H line-pro le and EW time-series, we warm that its form al signi cance is low in the 2D PS (Fig.4), while the phase-locked nature of the EW variations is only

m arginal (Fig.3).

H D 37128:Prinja et al. (2002) discussed the UV line-prole variations in this star, but the limited time span of the IUE observations (17 hours) precluded the detection of a cyclical behaviour on a rotational time-scale. Three signals are detected at the 99.0 per cent con dence level in the pixelto-pixel H PS at:  $_1=0.055$ ,  $_2=1.070$ , and  $_3=1.280$  d<sup>1</sup> (Fig.4).  $_2$  can be identified as the 1-d alias of  $_1$ . Interestingly, the highest peaks in the EW PS correspond to the two remaining signals, although with low signi cance level, as con med by the poorly coherent patterns of variability. Our data therefore suggest the existence of two periods at P 18.2 and 0.78 d, but at a low con dence level.

H D 37742: Line-pro le variations on a tim e-scale of about 6 days as suggested both in H and in UV wind lines (K aper et al. 1998, 1999). Several signi cant peaks (all with FAP < 1 per cent) are found in the pixel-to-pixel PS at:  $_1$  = 5 10 <sup>3</sup>,  $_2$  = 0.020,  $_3$  = 0.880, and  $_4$  = 1.148 d <sup>1</sup> (Fig.4). Only 4 is found in the EW data set, but this signal is likely spurious, as judged from the lack of coherent variations. A lternatively, the EW variations appear reasonably phase-locked when folded with  $_5$  = 0.075 d <sup>1</sup> (Fig.3). This signal is also found in the pixel-to-pixel PS, but the con dence level is low. H D 38771: Two signals are found in the 2D PS (see Fig.4): at  $_1$ =0.210 (FAP 5 per cent) and  $_2$ =0.955 d <sup>1</sup> (FAP 1 per cent), but there is no evidence for periodicity in the EW tim e-series.

H D 41117: Several peaks are found in the 2D PS (all with FAP < 1 per cent) at:  $_1$ =5 10 <sup>3</sup>,  $_2$ =0.025 (and its rst harm onic at 0.050 d <sup>1</sup>),  $_3$ =1.045, and  $_4$ =1.085 d <sup>1</sup> (Fig.4). The highest peaks in the EW PS are found at  $_5$ =0.025,  $_6$ =0.065, and  $_7$ =0.205 d <sup>1</sup>. Am ong these,  $_6$  and  $_7$  can be ruled out from the lack of phase-locked EW variations.D espite the detection of  $_5$  both in the 2D and in the EW PS, the poorly coherent pattern of variability casts serious doubt on the existence of this 40-d signal.

H D 42087: This star does not exhibit signi cant radial velocity variations (M ayer et al. 1999). The highest peak in the 2D PS is found at  $_1 = 0.040$  d  $^1$ , and appears both in the em ission component and in the absorption trough of the H P C ygnipro le (Fig.4). A lthough its form al signi cance is relatively low (FAP 5 per cent), the existence of a 25-d periodicity is supported by the EW data (Fig.3).

H D 47240: There is a tentative indication that the changes in SiIV 1400 are repetitive over a 3- to 5-d time-scale (Prinja et al. 2002). An ill-de ned, long-term periodic signal is found in the EW data set at  $_1 = 0.0075$  d<sup>-1</sup>, along with sm aller peaks at  $_2$  = 0.105 and  $_3$  = 0.247 d<sup>-1</sup>. The two latter frequencies are likely spurious, as judged from the poorly coherent nature of the phased EW variations. Interestingly, 1 is also found in the pixel-to-pixel H PS with a con dence level close to 95 per cent (Fig.4). However, both the close correspondence with the total time span of the observations (see Table 3) and the sparsely sam pled EW data (Fig.3) lead us to discard it from further consideration. Furtherm ore, the H morphology is typical of a fast-rotating star seen nearly equator-on (Conti & Leep 1974; Petrenz & Puls 1996). It is therefore unlikely that spectral changes operating on such a long time-scale would be associated to rotation. Variations intrinsic to a circum stellar disc-like enhancem ent cannot be ruled out a priori, but they would manifest them selves as V/R variations of the line em ission peaks, which are not observed (Fig.4).

#### 6 D ISC U SSIO N

#### 6.1 Incidence of cyclical line-pro le variations

The results of our period search are summarized in Table 2. Several of the listed periods must be regarded as tentative, especially those detected either in the 2D or in the EW PS. Independent con mation is clearly needed in this case. We also recall that HD 13854 and HD 47240 might be part of a close, massive binary system (Section 3.1). Since our survey was not designed to detect short-term periodicities, the found periods close to one day must also be regarded with some caution. They might arise from rotationalm odulation only for the fastest rotators. Conversely, they might be associated with the pseudo-periodic ejection of 'pu s' of m aterial. Such an outward propagation of density perturbations has been proposed to account for the recurrent changes (with a time-scale of 20 days) in the H line of the B0.5 hypergiant HD 152236 (Rivinius et al. 1997). Changes on a time-scale of about one day might be compatible with the characteristic ow time through the H line-form ation region in our program stars, provided that these putative, spatially–localized density enhancem ents follow a -type ve– locity law with an exponent close to unity. { A lthough such an interpretation cannot be completely ruled out, it should be noted that HD 152236 is considered as a candidate lum inous blue variable and is likely not representative of the stars in our sam ple (Sterken et al. 1997). Pulsations can also operate on a 1-d time-scale, but we nd no trivial relation between the spectroscopic and photom etric periods (the latter presum ably related to pulsations, as argued below).

Sum marising, we consider that the two stars with a relatively long-term periodic modulation seen both in the EW and in the line-pro le data sets present the strongest cases for a cyclical behaviour: HD 14134 and HD 42087 (with P 12.8 and 25.0 d, respectively). The phase-related patterns of variability are remarkably similar (see Fig.6). In addition, the line-pro le changes in H and HeI 6678 also seem to be correlated in both stars, with excess emission in H being accompanied by a weakening of HeI 6678. A scan be seen in Fig.5, thism ay also apply to weak m etal lines such as C II 6578.05 and C II 6582.88 (note that variations in the continuum levelm ay be invoked in the case of HD 14134 in view of the large, phase-locked photom etric variations). Since a signi cant amount of incipient wind emission is not expected for stars with such relatively low mass-loss rates (Table 1), this phenom enon may point to a link between the wind variability and photospheric disturbances. Higher resolution data are, however, needed to reveal an organized pattern of variability in photospheric lines, as observed in other B-type supergiants (K aufer et al. 1997, 2002).

The lack of cyclical variations for several stars in our sample can have a physical origin or may be ascribed to the limitations of the current data set (e.g., insu cient time sam pling). Concerning the latter point, it is suggestive that the stars with a detected period in H are among those displaying the highest level of variability. The large am plitude of the variations exhibited by most stars suggests that an imperfect removal of telluric features or S/N issues are probably irrelevant. One may be more concerned by the fact that our observations were relatively few and spread out over several months. If we accept the idea that large-scale wind stream s give rise to the variability, substantial variations in the global wind m orphology m ight be expected on a tim escale of m onths/years (as in the case of the B0.5 lb star HD 64760; Fullerton et al. 1997). A lack of coherency in the pattern of variability on a monthly tim e-scale would thus not be surprising, especially for the fastest rotators in our sam ple. It is unlikely in this case that a strong periodic signal would appear in the data. A nother issue which may lead to a loss of periodic signal is the com plex pattern of variability

presented by H in B supergiants (see, e.g., K aufer et al. 1996; de Jong et al. 2001; Prinja et al. 2001), em phasizing the need for high spectral/tim e resolution.

#### 6.2 Evidence for rotational m odulation?

Detailed studies of the line-pro le variations in the UV dom ain have inferred a rather sim ple geom etrical structure for the wind of som e B supergiants, with generally two (or four) symmetrical, spatially-extended wind streams (e.g., Fullerton et al. 1997). Consequently, one generally expects the recurrence tim e-scale of the line-pro le variations to be an integer fraction of the stellar rotational period, rather than the period itself. In HD 24912, for instance, the period found in H can be identied, within the uncertainties, with one half of the rotation period (de Jong et al. 2001). The fact that the periodicity found in the spectroscopic data set for HD 42087 is longer than the estim ated m axim um rotational period is therefore puzzling in this respect (Table 2). A part from rotation, however, there is a clear indication for the existence of an additional (perhaps dom inating) line broadening mechanism in B-type supergiants (plausibly tangential m acroturbulence; H ow arth 2004). The projected rotational velocities are thus likely to be grossly overestim ated for the stars in our sample, with the result that the true rotational periods m ay be signi cantly longer than anticipated (R yans et al. 2002). The modulation time-scale of H in HD 14134 and HD 42087 is commensurate with the probable rotation periods, but rotational modulation cannot be m ly established in view of these uncertainties. For the form er, the 12.8-d period found is close to the estim ate of the m inim um rotational period ( 10 days), which would im ply that this star is a fast rotator view ed alm ost equator-on. How ever, because in HD 14134 the v sin i is typical of stars of the sam e spectral type (Howarth et al. 1997), this 12.8-d tim e-scale is m ore likely to be an integer fraction of the rotation period.

The prom inent changes a ecting the P Cygniabsorption component of the H  $\,$  line in HD 14134 and HD 42087  $\,$ 

(Fig.6) m ay diagnose variations in the am ount of w ind m aterial seen projected against the stellar disk because of an azim uthal dependence of the mass-loss rate. Note in this respect that in HD 14134 maximum H emission and maxin um light do not seem to exactly coincide (see Fig.5). The existence of such a phase o set (which needs to be con med thanks to a more accurate ephemeris) would be consistent with a picture in which photospheric perturbations lead to the developm ent of large-scale, spiral-shaped wind structures (Cranmer & Owocki 1996). Let us suppose a bright photospheric region causing a local enhancement of the mass-loss rate. One observes a classical P Cygniprole when this 'overloaded' portion of the wind is projected against the stellar disk. However, the motion of this wind feature towards the stellar limb because of rotation will cause the growth of H emission. A small phase lag (i.e.,

< 0.25) would be expected if the spot has signi cant azim uthal extent. A substantial modulation of the boal massboss rate may also be invoked to explain the large, phaseboked EW s variations seen in other stars (e.g., HD 13854; Fig.3).

## 6.3 Relation to photospheric variability

The hypothesis that the developm ent of azim uthally structured out ows in early-type stars is intim ately linked to processes taking place at the photosphere (C ranm er & O wocki 1996) has received considerable observational support (e.g., Henrichs, K aper & N ichols 1994; Reid & Howarth 1996). M uch m ore controversial, how ever, is the nature of the 'seed' perturbations, w ith pulsational and m agnetic activity as the m ost straightforward candidates. In the light of our results, we discuss below the relevance of these two scenarios in Btype supergiants.

## 6.3.1 Pulsations

The H ipparcos data have revealed the existence of a large population of B-type supergiants with daily, quasi-periodic light variations. These stars m ight constitute the extension to higher lum inosities of the slow ly pulsating B stars, suggesting the -m echanism excitation of multiple, non-radial gravity modes arising from a metal opacity bump at T  $2 \quad 10^5$  K in stellar interiors (e.g., W aelkens et al. 1998).

B oth the am plitude and the tim e-scale of the photom etric variations are compatible to what is observed in our sam – ple. To investigate this issue in m ore detail, we plot in F ig.7 our stars on a HR diagram, along with the theoretical instability strips for non-radial g m odes calculated without m ass loss and rotation (P am yatnykh 1999). The stars with a clear cyclical behaviour (a sam ple evidently biased towards the stars with large photom etric am plitudes) do not appear to fall in the predicted dom ains of pulsational instability. The N LTE spectral synthesis of K udritzki et al. (1999) suggests system atically higher e ective tem peratures and lum inosities for som e stars included in our study. However, such a tem perature o set m ay not be su cient to bring these stars in the instability zone. Furtherm ore, only the late B-type

stars in our sample seem to follow the period-lum inosity relation for g m odes (see g.3 of W aelkens et al. 1998). M assive stars are also believed to experience a variety of strange-m ode and resonance instabilities (K iriakidis, Fricke & G latzel 1993), but there is no indication that the photom etric variations are related to this phenom enon (Fig.7). The ubiquity of pulsational instability in this part of the HR diagram (e.g., Fullerton et al. 1996; Kaufer et al. 1997) leads us to consider pulsations as most likely responsible for the photom etric variations, although it is clear from the above discussion that the pulsation modes have yet to be identi ed in this case. The apparent dichotom y between the photom etric properties of 0 and B supergiants seen in Fig.7 (the form er exhibiting signi cantly low er variability am plitudes) suggests that the pulsations are of di erent nature in these 2 class of objects (e.g., higher modes are excited in 0 -type stars).

The complete absence of the photom etric periods in the H time-series (HD 14134 excluded) seems at rst glance to argue against pulsations as driver of the wind variability (once again under the assumption that the light variations can be ascribed to this mechanism). As can be seen in Fig.7, the stars displaying the highest level of H variability

are not preferentially found close to the zones of pulsational instability. This hypothesis can be investigated further by looking for a correlation between the am plitude of the photom etric and H changes, as param etrized by the activity indices  $a_{pv}$  and  $a_{phot}$  (the latter calculated from H ipparcos data; Section 4). A lihough there is a hint of a positive correlation (FA P 2.3 per cent), this trend disappears when the 4 stars displaying line-pro le variations that cannot be unam biguously related to wind activity, but can be of purely photospheric origin, are excluded (i.e., HD 21291, HD 24398, HD 31327, and HD 119608). In addition, there is also no correlation between  $a_{lpv}$  (H ) and  $a_{lpv}$  (HeI 6678).

The lack of a clear statistical relationship between the levels of activity at the photosphere and at the base of the out ow (as diagnosed by the photom etric changes/H e I 6678 and H , respectively) suggests that the same physical

m echanism (i.e., presum ably pulsations) is not responsible for the photospheric and wind activity. This conclusion relies, how ever, on statistical grounds and should be in principle exam ined on a star-to-star basis: here we note the exam ple of HD 64760, where the same periodic signal seem s to appear in photospheric and wind lines (K aufer et al. 2002). A lthough detailed m odels are still lacking, one m ay also expect a com plex interplay between any pulsation signal and wind changes (e.g., beating of som e pulsation m odes). This is likely to result in a bose (if any) relationship between photom etric and H changes, for instance.

## 6.3.2 Magnetic elds

A growing amount of evidence suggests the existence of weak magnetic elds in early-type stars, although m detections are still scarce and might be restricted to some atypical cases. Spectropolarim etric observations of the very young 04{6 star <sup>1</sup> 0 rion is C have revealed a relatively strong magnetic eld, 1.1 0.1 kG (Donatiet al. 2002). The existence of a weaker eld in the B1 IV star Cephei (with a polar component of 360 30 G) has also been reported recently. This eld appears to be su cient to control the outow at large distances from the star (out to 9R ?; D onati et al. 2001). Magnetic activity in OB stars is also hinted at by X-ray observations of the 09.5 II star HD 36486 ( Ori) and HD 37742 (Waldron & Cassinelli 2000; Miller et al. 2002) which challenge the generally accepted view that the X -ray em ission in early-type stars solely arises from outwardly propagating shocks developing as the result of the inherently unstable nature of radiation-driven winds (see also Feigelson et al. 2002). Recent theoretical studies indicate that a magnetic eld of a moderate strength can be produced via dynam o action at the interface between the convective core and the outer radiative envelope, and brought up to the surface on a time-scale typically sm aller than the main-sequence lifetime (Charbonneau & MacGregor 2001; M acG regor & Cassinelli 2003).

Apart from our observations of HD 14134 (Section 5.2), HD 24912 is the only star in our sample for which a magnetic eld has been searched for via spectropolarim etric observations. A 3- upper lim it of 210 G in the longitudinal component was derived (de Jong et al. 2001). It is worth noting that this does not set stringent constraints on the potential role played by m agnetic activity, as even relatively weak elds (B < 100 G ) are suspected to signi cantly perturb line-driven ows (Owocki1994). This issue has been recently worked out in more detailby ud-Doula & Owocki (2002) who studied the in uence of a large-scale magnetic eld with a dipole con guration on the radiatively-driven out ow of an early-type star. They found that the disturbance imposed by the magnetic forces can be parametrized by a con nem ent param eter,  $= B_{eq}^2 R_{?}^2 / M - v_1$ , where  $B_{eq}$  is the equatorial eld strength at the stellar surface. The magnetic eld appears to signi cantly in pact on the wind m orphology and dynamics even for values as low as = 0.1, while the em ergent ow is channeled along closed magnetic loops for >1. For the physical parameters typical of our program stars (e.g., HD 14134; see Table 1), we obtain = 1 for  $B_{eq}$  70 G. In this case the Alfven radius would be about 2 R<sub>2</sub>, i.e., comparable to the extent of the H line-form ation region (ud-Doula & Owocki2002). This rough estim ate shows that

m agnetic activity cannot be ruled out as driver of the wind activity at this stage. A much stronger eld is unlikely in HD 14134, considering our spectropolarim etric observations together with the lack of strong X -ray emission ( $L_X$  [0.2{ 4.0 keV] < 33.0 ergs s<sup>1</sup>; G rillo et al. 1992). Fields of the same m agnitude can also be expected in other stars from our sam ple in view of their relatively low X -ray lum inosities (Berghofer, Schm itt & Cassinelli 1996).

#### 7 CONCLUSION

Our long-term monitoring has con med the ubiquity of H line-pro le variations in OB supergiants. The changes result from the combined e ect of a varying amount of incipient wind em ission and an intrinsically variable underlying photospheric pro le, with the relative contribution of these two phenom ena varying from one star to another. As a consequence of the large am plitude of the H variations observed, a precise determ ination of the stellar atm ospheric param eters will not be generally possible from proletting of the Balmer lines in snapshot spectra. Taken at face value, for instance, the EW variations shown in Fig. 3 would translate in the most extreme cases into a 0.8 dex uncertainty in the derived m ass-loss rate (Puls et al. 1996; equation [43]). A lthough it rem ains to be seen whether a sophisticated m odelling would result in drastically di erent gures, the large changes intrinsic to the early-type supergiants m ay be Н one of the most im portant factors lim iting the accuracy with which these objects can be used as extragalactic distance indicators (see discussion in Kudritzki 1999).

This survey has revealed the existence of cyclical H line-pro le variations in HD 14134 and HD 42087. The low detection rate (2 cases out of 17) may have several explanations, including observational limitations or a loss of coherency in the patterns of variability. HD 14134 is of particular interest, as it is one of the very few early-type stars clearly exhibiting the same pattern of variability in the photom etric and spectroscopic m odes. The existence of azim uthally structured out ow s in our program stars m ight explain the dram atic H changes, but m conclusions must await detailed m odelling (see H arries 2000 for the rst e ort in this direction). Sensitive searches for close com panions (e.g., via long-baseline optical interferom etric observations) are also needed to m ly rule out a variability arising from wind interaction.

We do not indevidence for a direct coupling between the wind activity and base perturbations arising from pulsations, but we caution that our data are not well suited to exam ine this aspect in detail. It is conceivable that in several instances the globally anisotropic nature of the out ow prim arily results from the putative existence of sm all-scale m agnetic loops anchored at the stellar photosphere (or alternatively a presum ably fossil, large-scale dipole eld). A m a probservational e ort is currently undertaken to detect such weak m agnetic elds in early-type stars (e.g., Henrichs et al. 2003). Firm detections can be expected in the forseeable future. They would place the above conclusions on a quantitative footing and directly address the relevance of this scenario.
