T he cosm ic infrared background (C IR B) and the role of the \local environm ent of galaxies" in the origin ofpresent-day stars

A bstract. A com bination of evidence is presented suggesting that the m a prity of the stars in today's galaxies were born during a lum inous infrared phase (LIR P) triggered by the local environm ent of galaxies. T he C IR B is a fossil record of these LIR Ps and therefore re ects the in uence of triggered star form ation through galaxy-galaxy interactions, including non m erging tidal encounters. This scenario, in which galaxies experienced several LIR Ps in their history, is consistent with the m easured redshift evolution of the cosm ic density of star form ation rates and of stellarm asses of galaxies.

1 Introduction

Stars represent only 15% of the cosm ic baryonic density, itself only equal to about 4% of the critical density (b ' 0.04), and are unequally distributed into spheroids (10% of b, including spiral bulges) and disks (5% of μ , Fukugita, H ogan & Peebles). It is usually assum ed that disk stars form ed quiescently while bulge stars form ed m ore e ciently and rapidly, as suggested by their redder colors and overabundance in -elem ent over iron ratio, typical of a SN II origin. H owever recent studies ofthe history of the star form ation ofthe disk of the M ilky W ay indicate that during the last 2 G yr it has experienced about  ve m a pr events of star form ation, starbursts, w hose signatures can be found in the peaked agesofthese open clusters(de la Fuente M arcos& de la Fuente M arcos 2004, and references therein). As a result we m ay wonder whether quiescent star form ation did play a m a pr role in the form ation of present-day stars at all. There are som e evidence that star form ation m ostly takes place in globular clusters and is rarely isolated. These clusters are thought to evolve into unbound stellar associations, w hich evolve and dissolve in a tim e-scale of about 50 M yr. T his tim escale is longer than the lifetim e ofm assive stars which dom inate the lum inosity of starbursting galaxies or regions of galaxies. H ence, it is logical to expect that if star form ation occured m ainly in starburst episodes w ithin galaxies, then the bulk of galaxies lum inosity w ill be absorbed by dust in the giant m olecular clouds,w hile if star form ation is quiescent then only a m inor fraction ofa galaxy'slum inosity w illbea ected by dustextinction.W ew illargue in the follow ing that there is presently a solid collection ofevidence suggesting thatm ost stars that we see in the localuniverse form ed during starburst episodes.

A m a pr peace of evidence for that com es from the detection of a strong di use cosm ic infrared background (C IR B, Puget et al. 1996, H auser & D wek and

references therein) w hich is m a pritarily produced by lum inous infrared phases $(LIRP)$ w ithin galaxies located around z 0.7, for the peak of the C IR B at 140 m, while the 240 m is due to galaxies at z 2 and above $\mathbb E$ baz et al. 2002, Chary & E lbaz 2001). We have introduced the term LIRP instead of the classical one, lum inous and ultra-lum inous infrared galaxies, i.e. LIRG s and ULIRG s, because we w ish to em phasize the idea that the scenario that is em erging from the study of distant galaxies is that LIRG s do not represent a population of galaxies that would require to be studied independantly in order to determ inew hich present-day galaxies are the rem nants of these LIRG s, but w hat is suggested instead is that they illustrate the omnipresence of rapid and e cient star form ation as a leading process in shaping the present-day universe, i.e. that any galaxy that we see today m ust have experienced a phase w hen it radiated the bulk of its light in the infrared (see also Elbaz & C esarsky 2003). This phase should not be restricted to $LIRG$ s and $ULIRG$ s, i.e. galaxies with infrared (IR) lum inosities larger than 10^{11} L or star form ation rates (SFR) larger than 20 M yr 1 , since the closest starburst M 82, for exam ple, presents a spectral energy distribution typical of m ost LIRG s, w ith the bulk of its lum inosity radiated in the IR although its lum inosity is only 4 10^{10} L.

W e present evidence suggesting that the bulk of boal stars form ed during a LIRP. A spectroscopic diagnostic is used to quantify the typical duration of this phase and the am ount of stars that form ed during $#$. From the combination of both we will advocate that not only did all galaxies experience a LIRP but that they m ust have experienced several of them . Finally we will discuss the physical origin of the LIRP and present evidence that a m a pr event in the lifetime of galaxies was probably underestim ated: the e ect of the \local environm ent of galaxies" (LEG) and its im pact in term s of driving the conversion of gas into stars through passing-by galaxies.

2 Lum inous IR phases and the origin ofpresent-day stars

The detection of a C IR B cam e as a surprise since local galaxies only radiate 30% of their bolom etric lum inosity in the m id to far IR range, i.e. sharing as a com m on origin stellarphotonsreprocessed by dustabove 3 m .W ith about half of the di use background light radiated above and below this wavelength cuto, the extragalactic background light tells us that in the past, m a pr star form ation events were strongly a ected by dust extinction even w hen galaxies were less m etal rich. D eep surveys in the m id infrared (15 m w ith ISO CAM onboard ISO, E lbaz et al. 1999) brought independant evidence that infrared was m ore ubiquitous in the past.T hese surveys detected ten tim es m ore objects at faint ux levels than expected from the extrapolation of the local universe (no evolution m odels). These galaxies turned out to belong to the class of LIRG s and U LIRG s discovered by IR A S in the localuniverse but located at a m edian redshift of z 0.7. They do not exhibit any optical signature of such strong SFR s neither in their optical colors nor in their em ission lines, except if careful correction for extinction is applyied using the Balm er decrem ent (C ardielet al.2003,

F lores et al. 2004). Only less than 20% of them were found to harbor or be dom inated by an active galactic nucleus (AGN; see Fadda et al. 2002). Unexpectedly, because of the complex and m ultiple physicalorigins of the m id and far IR photons (PAH s, Very Sm all G rains, B ig G rains), local galaxies do exhibit a strong correlation between their m id and far IR lum inosities over three decades in lum inosity, including the extrem e $LIRG$ s and $ULIRG$ s $(E$ lbaz et al. 2002). W hen applyied to galaxies up to z 1 these correlations can be used to derive far $\mathbb R$ lum inosities, i.e. SFR s, w hich are consistent w ith those derived from the radio, using the radio-far $\mathbb R$ correlation, suggesting that these correlations are still valid at these redshifts (E lbaz et al. 2002).

The m edian SFR of the galaxies responsible for the evolution of the m id IR counts is $50 M$ yr 1 and their contribution to the C IRB from 100 to 1000 m is derived to be as large as two thirds of its m easured intensity. Hence the bulk of the C IRB results from LIRP satredshifts of the order of z 1, but due to ∞ sm ologicaldim m ing the in
uence ofm ore distantgalaxiesis m ore lim ited to the largewavelength tailoftheC IR B.Som em odelshavebeen designed to reproduce num bercounts in the m id $\mathbb R$ (ISO CAM, 15 m), far $\mathbb R$ (ISO PHOT-90, 175 m) and sub-m m $(CUBA, 850 m)$ together w ith the CIRB which can be used to derive the cosm ic star form ation history of the universe (CSFH) una ected by dust extinction and to disentangle the relative roles of rapid $(LIR P s)$ and quiescent star form ation. In Chary & Elbaz (2001), we suggested to de ne a region delim iting all possible histories of star form ation (see Fig.1a), instead of a single line for any favorite m odel that would not represent the uncertainties of the m odel and observational constraints. O ne way to check the robustness of such m odels consists in com paring to directm easurem ents the resulting cosm ic stellar

m asses history (CSM H), i.e. the redshift evolution of \rightarrow , the m ass density of stars per com oving volum e over the critical density of the universe. The hatched area of Fig. [1a](#page-2-0) w hich represents the range of possible C SFH was converted into a range of possible C SM H in Fig. 1b, w ith the thin plain line show ing the mean value and the range of possible histories delim ited by the two dot-dashed thin lines. The m odel ts the data collected in D ickinson et al. (2003), where stellar m asses were directly m easured from optical-near IR m agnitudes.

Before deriving any conclusion, we w ish to rem ind our assum ptions: the C SFH was derived assum ing m id to far IR correlations sim ilar to locally (in agreem ent w ith the radio), the $A G N$ fraction was supposed to m ake a m inor contribution (see above), we assum ed a universal IM F (we used the one of G ould et al. 1996, which combines a Salpeter IM F with the now standard in exion of the M F below 1 M). If these assum ptions are indeed justi ed, then the tof the data in Fig. [1b](#page-2-0) illustrates the fact that the photons em itted by star form ing regions do re ect the stellar m ass building of galaxies and as a consequence, it is now possible to derive which fraction of present-day stars were formed in a LIRP. The modelCSFH was separated into three components shown as thick grey lines in the Fig. 1b, w ith 63% of present-day stars born during an IR phase ofthe LIRG type,w hich would be the dom inant m ode ofstar form ation in the universe. The shape of the redshift evolution of $\frac{1}{2}$ im plies that 80% of presentday stars were born below $z=2$, and 50% below $z=1$, m ost of which during a LIRP, leaving little room for quiescent star form ation.

If m ost of today's stars form ed during a LIRP and if this phase re ects e cient and rapid star form ation then this suggests that som e \positive feedback", i.e. triggering, m ight be at play. This idea is com forted by the m orphology and localenvironm ent (LEG) of distant LIRG s.It is well-know n that galaxies lie in large-scale structures m ade ofwalls, lam ents and clusters but LIRG s tend to appear exclusively in high density environm ents around z 0.7. The deepest ISO CAM survey was performed in a region of 27° centered on the Hubble D eep Field N orth (HDFN), detecting 95 galaxies am ong w hich 47 lie above the com pleteness lim it of 0.1 m Jy.

The histogram of eld galaxies presents several redshift peaks. The location and the extent of these peaks can be quanti ed by adopting a tresholding S/N ratio of 3, w here the "background" is simply the redshift distribution sm oothed w ith a gaussian w ith $= 15,000$ km s $^{-1}$. M onte-C arlo simulations performed by extracting 100 random sam ples from the realdistribution of  eld galaxies show that the probability of reproducing by chance the level of clustering of the ISO CAM galaxies is much less than one chance over ten (largest error bars). These results are illustrated on Fig. [2](#page-4-0)a, where we plot the fraction of ISO CAM galaxies included in redshift peaks above a given S/N ratio as a function of this S/N. The correponding curves for the eld galaxies and the simulated samples are also indicated. The thin (resp.thick) error bars show the 68 % (resp. 90 %) con dence level. The strong clustering of ISO CAM galaxies illustrates that at z 0.7, galaxies experiencing a L IRP are m ore clustered on average than eld galaxies. On the contrary, the study of LIRPs in the local universe using the

shallower ELA IS survey (O liver et al., in these proceedings) show s that they are less clustered than  eld galaxies locally.T he naturalexplanation for this behavior is that galaxies m ight experience a LIRP when located in a region which is collapsing over a large scale, i.e. star form ation would be triggered by large-scale structures in the process of form ation.

How much stellar m ass does a LIRG form ? We addressed this question using an optical spectroscopic diagnostic com bining the equivalent width of the high order Balm er absorption line H 8 to the 4000A break to caracterize these starburst events M arcillac et al., in prep.). The advantage of using H 8 instead of H is that it is in a bluer side of the spectrum, hence less a ected by sky lines, and that its underlying nebular em ission line can be neglected. Fig. 2b show s a sub-sam ple of 22 LIRG s, at z 0.7 , selected in three di erent locations of the sky com pared to a M onte C arlo sim ulation of 200,000 galaxies using the code of Bruzual & C harlot (2004) such as those used by K au m ann et al. (2003) to reproduce the behavior of localgalaxies in the Sloane survey.T his sim ulation can be used to determ ine w hich histories of star form ation would reproduce these galaxies. It is found that only galaxies presently experiencing a burst of star form ation can fall in this region of the diagram and that this burst lasts approxim ately 10^8 years and produce about 10% of the stars of the galaxies.T hese num berswere both derived by the sim ulation butthey perfectly agree w ith the m easured m edian m ass of the ISO CAM galaxies of 5×10^{10} M (from D ickinson et al. 2003). Indeed in 10^8 years and with their median SFR 50 M yr¹, they produce 5 10⁹ M of stars, i.e. 10 % of the galaxy m ass.T he m ass ofnew ly form ed stars is also consistent w ith the typicalm ass ofm olecular gas found in localLIRG s.T he m odelused in the Fig.[1](#page-2-0) predicts that nearly 50% of present-day stars were form ed in a LIRP below z 1, hence

if this phase only m akes up 10% of a galaxy's stars then the m a prity if not all of today's galaxies experienced up to ve or even m ore LIRPs. This suggests that the dense surrounding of galaxies can trigger successive lum inous IR phases, LIRPs, in galaxies. Finally, the optical m orphology of $z = 0.7$ LIRG s derived from $HSTACS$ observations $(E$ lbaz et al., in prep, see also H am m er et al. in these proceedings) show sthatless than half of them look like the m a prm ergers that we see locally in LIRG s. M a \overline{p} rm ergersm ight not be num erous enough to explain such a behavior and passing-by galaxies m ight play an important role by triggering strong star form ation events through tidale ects. Hence the local environm ent of galaxies, or LEG, m ight be considered as a better candidate to understand the origin of distant LIRG s.T he cosm ic star form ation history is therefore probably strongly dependant on the local density of galaxies w hich w ill also possibly determ ine their nalm orphology, i.e. spirals versus ellipticals, instead of the standard picture of the m erger of two m assive disks.

The recently launched Spitzer satellite will provide ideal observations to check the robustness of this scenario by observing larger patches of the sky (in particular the SW IRE legacy program), lowering the e ect of $\cos m$ ic variance, and to extend the study of lum inous IR phases to higher redshifts and lower lum inosities (w ith the M IPS G TO and GOODS legacy program).
