BeppoSAX observations of the quasar M arkarian 205

Abstract.We present the rst BeppoSAX observation (0.1 to 220 keV) of the quasar M rk 205.We have searched for the unusual Fe line pro le claim ed in the XMM-Newton spectrum which has been widely discussed in recent literature.We nd no evidence for a broad, ionized Fe line component in our data.We detect for the rst time a C ompton hump in this object. Besides, when this component is included in the t, the line strength diminishes, in agreement with a recent re-analysis of the XMM-Newton data, but with better constraints on the re ection component thanks to the PDS instrument (15-220 keV).We interpret this fact as another indication for illumination of a distant and cold material rather than reprocessing in the highly ionized inner parts of an accretion disk.

We cannot constrain the presence of a high energy cuto but we con m the existence of a variable soft excess (one year timescale).

1. Introduction

D iscovered by W eedman (1970), the quasar M rk 205 is seen through the southern spiral arm of the nearby spiral, barred galaxy NGC 4319 at a projected distance of roughly 40^{00} from its center. From its radio lum inosity at 6 cm, M rk 205 is classi ed as a radio-quiet quasar (R ush et al. 1996a), but it is still not clear whether it belongs to the radio-quiet quasar class (e.g. Bahcall et al. 1992) or to the Seyfert 1 class (e.g. Veron-Cetty & Veron 2001). M rk 205 has a redshift z = 0.07085 (Huchra et al. 1990) while NGC 4319 has z = 0.00468 (Bowen et al. 1991).

In the standard paradigm of (radio-quiet) Active G alactic Nuclei (AGN), X-ray photons result from C om pton upscattering of optical-UV photons in a hot therm al corona above the accretion disk surrounding a superm assive black hole. A large fraction of the seed photons are thought to be produced by therm alem ission of the accretion disk itself, but M rk 205 was found by M cD ow ell et al. (1989) to have a weak blue bum p. O ne of the possible scenarios which could explain this spectral m orphology is that the bum p m ay be highly variable and thus observed in a particularly weak state. In the therm al

com ptonisation fram ework, blue bum p variability would also induce hard X -ray variations.

A soft X -ray excess component may be interpreted as the hard tail of the blue bump (W alter & Fink 1993; B runner et al. 1997). So far, evidence for a soft excess in M rk 205 was only reported in two observations; with EIN STEIN IPC (W ilkes & Elvis 1987) and XMM -N ewton (R eeves et al. 2001).

BeppoSAX, with its unique broad-band capabilities allows to extend the observation of M rk 205 for the st time above 20 keV to study the properties of the hard X -ray em ission as well as of a potential re ection com ponent. Indeed, som e of the X -ray photons can be reprocessed in the surroundings, in particular in the disk itself giving rise to neutral (or low -ionization) Fe K line. W hile it is a common feature of Seyfert 1 galaxies (Nandra & Pounds 1994), only a few quasars present a clear detection of such a component (W illiams et al. 1992; Nandra et al. 1997). Furtherm ore, the centroid of the line was often measured at energies close to 6.7 keV suggesting that its origin may be in an ionized layer of the accretion disk (Reeves & Turner 2000), the neutral Fe K being emitted in distant and cold material lying outside the broad line region. Reeves et al. (2001), who analysed the XMM-Newton data of Mrk 205, claim ed the existence of



a broad ionized component in addition to the neutral one in this object. However, Page et al. (2003) reprocessed the data including a re ection hump component in the t and found little evidence for a broad, ionised component in the data.

In this paper, we present the analysis of three B eppoSAX observations of M rk 205 for a total of 200 ks of exposure time. In Section 2, we summarize the knowledge we had on M rk 205 prior to our B eppoSAX observation. In Section 3, we describe the data and their analysis while in Section 4 we compare our results and discuss them in the fram ework of the uni ed m odel.

2. Previous X-ray observations of M rk 205

M rk 205 was observed by EINSTEIN HRI (Tananbaum et al. 1979: [a]; Zam orani et al. 1981), EINSTEIN IPC (W ilkes & Elvis 1987: [b]), EINSTEIN A-2 (Della Ceca et al. 1990), EXOSAT (Singh et al. 1991: [c]), GINGA (W illiam set al. 1992: [d]), ASCA (Reeves & Turner 2000: [f]), ROSAT PSPC (Fiore et al. 1994:[e]; Fiore 1994; Rush et al. 1996b; Ciliegi & Maccacaro 1996; Fiore et al. 1997), ROSAT HRI (Arp 1996), XMM -Newton (Reeves et al. 2001: [g]; Page et al. 2003) and BeppoSAX (this work).

M rk 205 was neither observed by RXTE nor Chandra to date.

W e sum marize the spectral parameters found in Fig. 1 and Table 1. The spectral variability was important over the 24 years spanned by the data (Fig. 1, upper panel). The photon indexes were measured mostly over the range 2 10 keV and thus were not a ected by a soft excess component. However, the two ROSAT points (1991, 1992) are extrapolated values from the 0.11 2:45 keV, i.e. a spectral range very sensitive to the presence of a soft excess. They are certainly overestimated. In addition, several papers discuss the ROSAT PSPC calibration problem s which results in a measure of the AGN X-ray spectral slopes being signi cantly steeper than those from otherm issions (Beckmann et al. 2002 and references therein).

W e will discuss further in Section 4 the possible origin of the observed spectral variability in this object.

Little variations of the Hydrogen column density were observed during the same period (Fig. 1, second panel from the top). An excess of absorption may be present in the XMM -Newton 2000 observation, its reality will be discussed in Section 3.7.

The 2 10 keV ux seems to have decreased during the rst 18 years of observation, a trend possibly correlated with a similar trend seen in the 1300 A IUE light curve (Fig. 1, third panel from the top). Here again, the two ROSAT estimates of the 2 10 keV ux may be underestimated due to the overestimation of the 2 10 keV photon index. In the remainder of this section, we will focus on the XMM -Newton observation which took place one and a half year before our BeppoSAX pointings.

2.1.XMM -Newton observation

Reeves et al. (2001) reported an observation done with XMM-Newton on 6 M ay 2000. They measured a photon = $1.86^{+0.02}_{0.02}$ with an absorbing column in excess of index the Galactic one limited to N_H < 1:5 10^{20} cm². Fitting the MOS data only they found evidence for an ionized Fe line component at 6.7 keV along with the neutral Fe K component. The same result was obtained using only the PN data, and thus the simultaneous t of the data from both instrum ents gave tight constraints. They nally obtained the best twith a narrow line resulting from neutralFeK em ission at 6:39 0:02 keV (EW = 56 23 eV) and a broad component at 6:74 0:12 keV (EW = 135^{+65}_{60} eV). They did not detect Fe K edge, nor a re ection com ponent but claim ed that they could not rule out its presence.

The observations were consistent with a relativisticallybroadened accretion disk line model (Fabian et al. 1989) only if the disk ionization was high enough to produce H elike Fe at 6.7 keV and the neutral component was present. A clear soft excess was also detected, but thing it with a black body gave a much too high temperature (kT = $120 \quad 8 \text{ eV}$) to be direct emission from the accretion disk. An explanation is enhanced emission from the up-

< 0:15 respectively.

Page et al. (2003) reprocessed these data and found that an acceptable twas obtained with a power law plus neutralem ission line at 6.4 keV. They noticed that a better t was obtained either with a C om pton re ection com ponent or with an ionized em ission line, with a similar goodness of t. The presence of ionized relativistic material was thus not unambiguously detected in this object, the illum ination of a distant cold material providing a simpler self-consistent explanation.

3.BeppoSAX observation

M rk 205 was observed by BeppoSAX (Boella et al. 1997a) on 21 December 2001 (LECS: 47582 s, MECS: 165458 s, PDS: 70549 s) and on 5 January 2002 (LECS: 3611 s, MECS: 32603 s, PDS: 12606 s). In addition, public data from the archive (12 M arch 1997, LECS: 2525 s, MECS: 14727 s, PDS: 6646 s; part of the core program and pointed on NGC 4319) are included in the present study.

LECS (Low Energy Concentrator Spectrom eter, Parm ar et al. 1997) and MECS (Medium Energy Concentrator Spectrom eter, Boella et al. 1997b) data were reduced following the standard procedures. For PDS (Phoswich Detector System, Frontera et al. 1997) data, high level products from the Sax D ata Centerwere used.LECS and MECS data have been screened according to Fiore et al.

> For the longest exposure (2001), the average source ux in the 2 10 keV band (MECS data only, power law model with Galactic absorption) was (1:11 0:01) 10¹¹ erg cm² s¹ corresponding to a lum inosity $L = 2:55 \quad 10^{44}$ erg s¹ in the 2 10 keV band rest fram e (here and in the following H $_0$ = 50 km s 1 M pc 1). From that luminosity, a black hole m ass of about 2 10^6 M L_{E dd}=L could be inferred. These values are more typical of a lum inous Seyfert 1 galaxy than a guasar. The 2 10 keV ux measured in 2001 was twice the value m easured one and a half year before by XMM -Newton (Fig. 1).

3.1. In age analysis: unprobable in uence from NGC 4319 and other sources

We analysed the MECS1:3 10 keV im age (angular resolution $42^{(0)}$) of the 2001 observation and compared it with a RO SAT HRI0:1 2:4 keV in age (angular resolution of $5^{(0)}$. For the HRI in age, App (1996) evaluated the shift of the position from the optical to X-ray to be of at most $7^{\circ\circ}$, equivalent to one MECS pixel. Three sources were identied in the MECS im age, Mrk 205 included. Being in the eld of view of the PDS also (1.4 degrees while the MECS eld of view is 28°), we investigated if one of the other two

sources could contribute to the M rk 205 PDS spectra. In addition, one had to make sure that NGC 4319 located at 40^{00} from Mrk 205 (and thus not resolved by this instrument) was not emitting in the X-rays (we used the following J2000 coordinates for M rk 205: 12h 21° 44.12^{$\circ\circ\circ$} + 75 18^{$\circ\circ\circ}$ 38.2^{$\circ\circ\circ\circ}$ and for NGC 4319:</sup></sup>

12h 21° 44.07^{\circ} + 75 19^{\circ} 21.3^{\circ}, these are located by circles on Fig.2).W e discuss those points below .

- 1. According to the prole displayed in Fig. 2 (right panel), NGC 4319 is located in a zone in which half of the MECS peak count rate is received. Furtherm ore the shape itselfdoes not allow to tell if NGC 4319 is really detected (the break in the prole can be a feature of the MECS PSF). It was not detected by ROSAT HRI (Arp 1996) in the soft X-ray domain, but it could be C om pton thick with em ission only detected above 5-10 keV. However, there are no radio sources (apart from Mrk 205) above 2.5 m Jy within a radius of 1.5⁰ of Mrk 205 in the NVSS catalog (C ondon et al. 1998). Thus it is very unlikely that NGC 4319 is an AGN;
- 2. We have tted the 2001 M ECS spectrum with a power law, extrapolated the model in the PDS dom ain and added the PDS data without thing them but including an intercalibration constant M ECS/PDS frozen to

the recommended value of 0.88 (see Fibre et al. 1999). This is of course not taking into account any rejection component. Fig. 3 shows the resulting spectra along with the residuals of both data sets with respect to the MECS best the odel. It is very unlikely that emission from NGC 4319 contributes to the excess at 20 keV and matches the extrapolation of the MECS ux at high energies.

3. The other sources in the MECS are XMMU J122206.4+752613¹ which is a narrow emission line galaxy and NGC 4291, a non-active elliptical galaxy. The rst has a MECS count rate 10 times sm aller than Mrk 205 while for the latter it is 100 times sm aller. A coording to Fiore et al. (1999), those sources are certainly in the residual PDS count rate (estimated by comparing to the known MECS

count rate) obtained in blank elds (Guainazzi & Matteuzzi 1997);

From these di erent arguments, we conclude that neither NGC 4319 nor one of the two other sources detected in MECS contribute signi cantly to the X-ray spectrum of M rk 205.

3.2. Possible absorption in the spiralarm s of NGC 4319

Of type S_{pec} , NGC 4319 is an extrem ely disrupted spiral galaxy (A pp 1996) with an ISM very di erent from the Miky W ay's ISM. The ISM of NGC 4319 has been thoroughly studied by various authors which have found C a II K and Mg I b absorption features at the redshift of NGC 4319 (Stockton et al. 1979).

Bahcall et al. (1992) succeeded in the detection of M g II doublet in NGC 4319 and deduced an approximative H I column density of about 3 10^{18} cm² from the M g II column density, precised by W om ble et al. (1993) to be N (H I)< 52 10^{19} cm².

The gas in the inter-arm region of NGC 4319 shows a higher grade of ionisation than in the M ilky W ay and the unusually low amount of HI (or M g II) is not understood for this kind of late-type galaxy.

The X-ray absorption in the 0.5 2.0 keV energy range is how ever dom inated by CNO K-shell absorption, but no evidence for an enhanced abundance of heavy elements is reported in the literature. To conclude, we do not nd evidence for absorption in the M rk 205 data due to the presence of NGC 4319 in the line of sight.

3.3. Variability

We produced light-curves from the event les using X ronos 5.16 in a single binning of 2500 s to ease inter-

com parison between the di erent observations (Fig. 4). Note that 15 days separate the middle panel of Fig. 4 to the right panel. LECS and MECS light curves of the statistically best observation (2001) were surprisingly different. Cross-correlation analysis gave a weak correlation

coe cient between these two light curves.

From 1997 to 2001, the LECS and MECS count rates remained constant. Since a MECS unit was lost between those 2 observations, we have plotted in Fig. 4 the MECS light curves for a single unit. The average PDS count rate seems to have increased by about 40%, but this latter value is very inaccurate due to the few points in 1997.

From 2001 to 2002, the LECS average count rate seem ed to have dropped by about 16% percent, but this latter value is based on a sm all fraction of the observation time. The MECS average count rate dropped by 15%, while the PDS count rate rem ained constant.

From the December 2001 observation (Fig. 4, middle panels; see also Fig. 5) one sees that no signi cant variability was observed on very short timescales (of the order of hours). On the other hand, long term variability (on week and year timescale) can be quite important (Fig. 1).

In Fig.5, we display the light curves 2 5 keV and 5 10 keV along with the hardness ratio, for the longest observation (2001). The 2 5 keV energy band showed a weak m inim um (10% below the average ux) around 4 10⁴ s which was not present in the 5 10 keV range. The resulting hardness ratio thus showed an hardening around that time. The di erences in the two light curves are certainly not due to N_H variations as a value of the order of 10^{20} cm² is unlikely to change the spectra above 2 keV.

3.4. M odel independent spectral analysis

To study the spectral variations between the di erent observations, we have divided the 3 spectra (LECS, MECS, PDS) of the 2001 observation from the 3 spectra of the 2002 observation (Fig. 6). We have also divided the 3 spectra of the 2001 observation from the 3 spectra of the 1997 observation (Fig. 7). We have taken the ratios for each energy bins. One sees an important variation in the 10 keV energy range between the 2001 and 2002 ob-2 servation which did not occur between the 1997 and 2001 observation, in agreement with Fig. 4. A rough comparison of Fig. 6 and Fig. 7 shows that the LECS and PDS points m ay have been enhanced as well in Fig. 6, but the signal-to-noise is not good enough to conclude that the soft 0:1 2:0 keV or hard 10 220 keV bands varied signi cantly.

3.5. Spectral analysis

The spectral tting was perform ed with X SPEC 112.0. In the following, all errors are quoted at the 90% condence level for one interesting parameter. We have used the recommended energy bounds (LECS: 0:12 4:0 keV, MECS: 1:65 10:5 keV, PDS: 15 220 keV), and the intercalibration \constants" were free to vary in the intervals 0:7 1:0 and 0:82 0:90 for LECS/MECS, PDS/MECS respectively (Fiore et al. 1999).

The upper panel of Fig. 8 represents a t of the 2001 data with a power law model modi ed by interstellar photoelectric absorption. The photoelectric absorption cross sections used were those of M orrison and M cC am m on (1983).

The lower panels of Fig. 8 show the ts residuals with the same model for the 1997 and 2002 observations respectively. The best t spectral parameters found are presented in Table 2. The t of the 2001 observation is poor with an excess in the 15 40 keV range as well as in the soft X -rays, up to about 1 keV, nally a sm all feature around 6 keV is present.

For the 1997 and 2002 observations, the ts are already acceptable with this simple model for the continuum. In the 2002 observation, a line-like feature is clearly detected around 1 keV while a small excess in the range 15 40 keV may be present. The signal-to-noise ratio of the

continuum is not good enough to accurately constrain more complex physical models.

3.6. Spectral analysis: re ection component

W e started a more detailed analysis by tting the 2001 observation data above 2 keV, i.e. using MECS and PDS data only.As N_H was not constrained in this case, we xed it to the Galactic value. We tried 2 di erent

models for the continuum shape.

The rst was a cut-o power law plus a Compton reection from dense, neutral matter (pexrav: Magdziarz & Zdziarski 1995). This model is meant to describe the e ects of Compton scattering of photons from an X-ray source associated with the inner parts of the accretion disk. The spectrum of re ected X-ray was computed as a function of disk inclination using the transfer function of Magdziarz & Zdziarski (1995). The free parameters of

this model are the spectral index of the primary power black-body) was frozen to 10 eV while the inclination law, the folding (upper cuto) energy E_c of the primary X-ray spectrum and the normalization of the relection Both continuum models were completed by the addition component R. In our ts, the inclination angle of the disk was frozen to 30 degrees as it is usually adm itted for Seyfert 1 galaxies, while the abundances of Fe and other heavy elements were xed to the solar values.

The second model was a more physical model of therm al Comptonisation for a disk-corona con guration in a slab geometry (compha: Haardt 1993; Haardt et al. 1997). The table model for $X SPEC^2$ includes both the primary continuum and the re ection. The re ection component F-test value 1.70 and probability 0.196) and the line was computed following W hite et al. (1988) and Lightman & W hite (1988) assuming re ection on neutral matter and a constant spectral shape (angle-averaged) for the re ected photons. To summarize, tting with the thermal comptonisation model compha does not im prove the tof the 2001 observation in comparison to the Compton re ection from cold material pexrav ts.

3.7. Spectral analysis: soft excess

W e now consider the broad band 2001 spectrum, adding the LECS 0.12-4.0 keV data to the MECS and PDS data. Freezing all the parameters of the best t pexrav model tion and add a Gaussian emission line. The above 2 keV and thing again the broad band spectrum, improved ($^2 = 6.07$ for 1 m ore parameter; F-test 5.39

we get an N $_{\rm H}$ = (3:46 $^{+0.26}_{0:22}$) 10^{20} cm 2 , and a 2 of 138.49 for 142 degrees of freedom (dof).W e found no clear evidence for a soft excess of photons in the LECS, even if the intercalibration constant is set to its lowest value of 0.7. To have an upper limit on a soft excess component, we add a black body to our model, xing its tem perature to the one obtained by Reeves et al. (2001) with the XMM -Newton data, i.e. kT = 120 eV.W e found an $N_{\rm H} = (3.60^{+0.36}_{0.29})$ 10^{20} cm 2 and a 2 = 1:73 for 1 m ore param eter; F-test value 1.78 and probability 0:184. The soft excess is here much weaker (3% of the em ission over the range 0.5-2.0 keV) than it was claim ed in the XMM-Newton observation (15% of the emission in the range 0.5-2.0 keV).

W e re-analysed the XMM -N ewton PN data to see whether the soft excess component was as important as claimed by Reeves et al. (2001) when the re ection component was present. Indeed, Reeves et al. (2001) discussed the soft excess component modeling the continuum with a power law while Page et al. (2003) used the Compton re ection m odel but stopped their analysis at 3 keV. As before, we deduced the param eters of the continuum thing the data above 2 keV (Table 3). The pexrav m odel produced a ² of 75.24 (54 dof) with a realistic re ection parameter R of 0.48.W e then xed the continuum and included the 0.5 to 2.0 keV points. The residuals showed a clear excess below 2 keV. Adding a black body with a tem perature of 120 eV did not produce a good t ($^2 = 463.29$ for 232 dof) but, when this parameter was released, the twas much better and the tem perature signi cantly increased (see Table 4 and Fig. 11). We did not nd an unusual value of N_H (Fig. 1) anym ore.

The contribution of the soft excess component is thus more in portant than previously claim ed: it represents 23% of the em ission in the range 0.5 to 2.0 keV.

However, the black body parameters do show suspicious values m eaning that the em ission is probably not a sim ple black body.

3.8. Spectral analysis: Fe K line

To assess the importance of an Fe K line in our data, we concentrate on the MECS data. In this case, N $_{\rm H}\,$ is not constrained, we thus xed it to the Galactic value. Using only the power law model, it is clear from the residuals in the lower panel of Fig. 8 that a line feature is detected in the 2001 observation, while it does not seem to be present in the 2002 observation (sam e gure). The statistics of the 1997 observation is too poor to give conclusive results.

On the other hand, after thing the continuum of the 2001 data with the C om pton re ection m odel, the residuals do not show a clear evidence for a line feature anym ore.

We thus concentrate on the 2001 best t observat is Table 4. Soft excess: ts of the LECS, MECS, PDS data and comparison with XMM-Newton data. A stands for photoelectric absorption, pexrav for the Compton relection from cold material, G for a Gaussian line and BB for a black body. We is consider the spectra above 2 keV, freezing all the parameters of the continuum ($, R, E_c$) to their best tvalue of Table 3. We then add the data below 2 keV, add a soft excess component, and t again the broad band spectrum

and probability 2:29 10^2) with a line at 6.53 keV consistent with neutral Fe K and weakly ionized species. Note that the line is not resolved as $_{\rm Fe}$ < 500 eV is sm aller than the MECS energy resolution.

Both C ompton re ection from cold material and thermal comptonisation model give a line energy of 6.53 keV but the latter gives a slightly larger equivalent width. A coording to G eorge & Fabian (1991), if a re ection is present, it has to be associated with an Fe line. In the neutral case, they computed an equivalent width of the order of 1.7 keV with respect to the re ection or 150 eV with respect to the continuum, for R = 1 (see also

Zdziarskiet al.2002).Ourm easures of the line equivalent width and R are inconsistent with the predictions of George & Fabian (1991).We shall discuss in Section 4 a possible reason to this deviation.

Unlike Reeves et al. (2001) and Page et al. (2003), no residuals are found at 7 keV, but the line equivalent width and centroid suggest that it could also be a blend of a neutral narrow component and a weakly ionized one. Adding a second G aussian to the model while freezing the line energies to 6.4 keV and 6.7 keV rest fram e following Reeves et al. (2001) was not signi cant and neither was

the relativistically-broadened accretion disk line model (Fabian et al. 1989) which was preferred by Reeves et al. (2001). For the 2002 observation, the residuals were not im proved when using the Compton re ection model and thus were identical to Fig. 8.

3.9. Line feature at 1 keV

The spectrum of the 2002 observation contains a narrow em ission line feature centered at about 1 keV (see Fig. 8, low er right panel). We have tted a model composed of a power law plus G alactic absorption and a G aussian com – ponent (Fig. 12) and found the following results. The line is centered at $0.98^{+0.08}_{-0.34}$ keV (quasar rest fram e) has a width of $0.11^{+0.33}_{-0.11}$ keV (not resolved; the LECS energy resolution at 1 keV is 0.2 keV) and an equivalent width of 518 eV. The addition of the line signi cantly in proves the t at better than the 98% con dence level according to the F-test. N ote how ever that even if this sim ple m odel allows us to estim ate the line centroid energy and total

ux, it is physically unrealistic as it is likely that this line results from a blend of several emission lines, predom inantly from ionized species of Ne and possibly from Fe L shell.

A similar feature was also found in the ASCA spectrum of the quasar PG 1244+026 (Fibre et al. 1998; George et al.2000) as well as in the ASCA spectrum of the Seyfert 1 galaxies TON S180 (Turner et al. 1998) and Akn 564 (Turner et al. 1999).

W e searched the XMM -Newton data for this feature but did not nd a clear evidence for it (the equivalent width reached a maximum of 10 eV).

4.D iscussion-Conclusion

The nature of M rk 205. It has been noted that, in contrast to the Seyfert 1 case, the detection of Fe K line in quasars was more seldom and that if detected, the line energy was around 6.7 keV instead of 6.4 keV (Reeves & Turner 2000). It was thus suggested that sensitive instruments like the EPIC camera on XMM-Newton could observe the Fe K emission of quasar in detail. From our X-ray observations of M rk 205, and from the lum inosity we obtained from them, we suggest to be careful in classifying this object. Its lum inosity is found in the region in which it is di cult to choose for a Seyfert 1 or for a quasar. It seems thus di cult to generalize any ndings m ade on this object to a whole class.

The soft excess variability. The soft excess seems to be variable in this source although a very strong soft excess was never reported. It seems to be absent/not detected in 1997, strong in 2000, weak in 2001 and absent again in 2002 (thus varied in a 2 weeks tim escale). The variability of the soft excess cannot be associated with variability of a cold absorber as we have shown in Fig. 1 and Section 3 that the absorbing column density deduced from spectralm odeling was roughly constant over all the observations.

Note that the soft excess component measured here should not be associated with direct therm all emission from the accretion disk because its temperature is much too high.

Therm al comptonisation. The historic variations of the photon index can be explained in the framework of therm al comptonisation. M rk 205 showed large 2 10 keV ux variations between the 1997 (high ux state), 2000 (low ux state), 2001 (high ux state) and 2002 (low ux state) observations which do not seem to be correlated with variability of the soft excess.

However, in therm alcom ptonisation processes, the index of the comptonised component is inversely correlated with the ratio of the photon seed ux to the comptonised power law ux.We can test this hypothesis if we assume that the soft excess strength is proportional to the strength of the soft photon eld (Walter & Fink 1993; Walter & Courvoisier 1990). The index for 2000 was 1:73 0:02 for a ratio of 23% while for 2001 the index was 2:00 0:03 for a ratio of 3%. This is thus in disagreem ent with our expectations.

On the other hand, using the compha model to estimate the UV ux, we found that an increase of the photon index goes with a larger UV ux, in agreement with \sin ple thermal comptonization model expectation. Similar conclusions were found by Petrucci et al. (2000) for the Seyfert 1 galaxy NGC 5548. The contradiction between the soft X-ray and UV variations is not very surprising. Indeed the soft excess component is certainly linked to the UV bump through complex radiative transfer (e.g. comptonization in the warm (few keV) upper layer of the accretion disk). Consequently, its expected spectral behavior is not straightforward and may be at odds from the zeroth order expectations.

C onstraints on the rejecting material. The nature of the reprocessing medium can be the accretion disk or some obscuring, distant material. If the Fe K line is produced in the inner parts of the accretion disk, its pro le should be considerably broader, with very distinct asymmetries due to D oppler and gravitational redshift. This is not possible to test with the BeppoSAX data while Page et al. (2003) report that they did not nd evidence for it in the XMM -N ewton data either.

The strength of the C ompton relection R is here system – atically higher than what was found in Seyfert galaxies (R ' 0.8 0.2, N andra & Pounds 1994), while on the contrary, the iron line equivalent width EW is smaller than the mean EW value. It is worth noting however that our measures of R are consistent with R < 1 at 90% con dence, see Fig. 9.

The inconsistency between the best t values of R and the line EW may then occur by chance and the re ecting m aterial in M rk 205 m ay simply cover a solid angle < 2 as seen from the X-ray source. The line energy then also suggests the m aterial to be neutral. A low Fe abundance will make the line weaker and the C ompton re ection hump stronger (as observed) by reducing the opacity above the Fe K edge (George & Fabian 1991).

G iven these constraints a simple solution could be that the reprocessing is done in a distant material e.g. the dust torus.

However, we cannot rule out the presence of close mildly ionized material. Indeed Nayakshin & Kallman (2001) have shown that in the case of relatively strong illum ination by local X -ray ares, the upper layer of the re ecting material may become strongly ionized. In this case the rejection features are mainly produced by the neutral depth layer and the expected line energy is 6.4 keV as we observed. The line EW is how ever sm aller than the one expected in the case of neutral re ector since the line may be partly comptonized in the hot skin. But clearly this skin cannot be highly ionized since in this case it would act like a perfect m irror and the re ection hum p would be suppressed contrary to what we observe. Lines in the soft band are also expected in the case of a mildly ionized medium and it may explain the poor tof the soft excess with a simple black body component.

The 1 keV line. The spectrum of January 2002 contains a narrow emission feature centered at an energy of 1 keV which was also found in at least 3 other AGN. This feature could be explained by a blend of several emission lines, predominantly from ionized species of Ne and possibly from Fe L shell. The line emission could be a result of re ection in photoionized matter. It could also be resulting from recombination in an optically thin therm al plasm a.
