Jeans Instability in the linearized Burnett regime

A bstract

Jeans instability is derived for the case of a low density self-gravitating gas beyond the N avier-Stokes equations. The Jeans instability criterium is shown to depend on a Burnett coe cient if the form alism is taken up to fourth order in the wave number. It is also shown that previously known viscosity corrections to the Jeans wave-number are enhanced if the full fourth order form alism is applied to the stability analysis.

1 Introduction

The physics of low density system s is relevant in the description of therm odynam ic processes which presum ably occurred in the universe some time between its age of $10^6 \, \sec$, tem perature T = 1 KeV and the stage after matter decoupled from radiation when the matter density reached values of $10^{18} \, \frac{g}{cm^3}$ and T = 1 eV. It is also known that these types of regimes prevail in many other astrophysical systems [1]. Since a hydrodynam ical, N avier-Stokes, description of a low density uid breaks down for small K nudsen numbers, it is desirable to go beyond this regime and analyze the uid with the tools that statistical physics provide as the particle collision frequency decreases. One simple tool useful for this purpose is, on the one hand, the phenomenological form alism now known as Linear Irreversible Therm odynamics (LIT), which provides a good grasp about how non-equilibrium processes evolve in time [2]. On the other hand, kinetic

theory provides a solid mesoscopic foundation for this theory, specially if we want to deal with hydrodynam ics beyond the Navier-Stokes regim e [3] [4].

The relevance of transport coe cients in cosm obgical and astrophysical problem s has already been widely recognized [1] [5] [6]. Nevertheless, the Burnett equations [3] [4] have rarely been applied to structure form ation problem s in a phenom enological context, although the Burnett regim e itself has been addressed in the context of transport theory in special relativity [7] [8] [9]. One possible motivation for the study of the Burnett regime in cosmological situations is the well-known relation between wave scattering processes, density uctuations and dissipative e ects [10] [11] [12]. Dynamic structure factors, possibly relevant for describing CMB distortions, can be derived from the hydrodynam ical Burnett approach, as it has already been done for collisionless plasm as [13]. The use of these structure factors has appeared to be useful in the study of scattering laws to describe the Sunyaev-Zel'dovich e ect and can, in principle, be applied to study density-density correlation functions to deal with hydrodynam ical instabilities [14] or tem perature-tem perature correlation functions, a problem that remains to be studied via a therm odynamical approach. For the background m icrow ave radiation this is done at present using the well-known multipole expansion. In this work we analyze the solutions to the phenom enological linearized Burnett equations in the context of Jeans instability theory, generalizing previous work [15] [16]. The main reason for doing this is that the introduction of the Burnett regime allows to take into account all k^4 order terms in the dispersion relation. Furthermore, the general tenets behind this form alism are worth emphasizing in view of its wide range of applicability [17]. To accomplish this task, the paper is divided as follows: section 2 reviews the basic phenom enological equations governing the Burnett regime. Section three is dedicated to the analysis of the dispersion relation obtained form the linearized form alism . Final remarks about the implications of the Burnett regime in structure form ation are included in the last section.

2 Basic form alism

The starting point for our calculation concerns the m ethod whereby for a simple uid which is not in equilibrium we can apply the adequate inform ation to transform the well-known conservation equations for m ass, m om entum and energy into a complete set. For this purpose, we assume that the uid is isotherm al and, therefore, the energy equation m ay be ignored. This leaves us with the continuity and m om entum equations. The second one has the form,

where f^i is the external force per unit of volum e. To relate the stress tensor i^j with the mass density and the local velocity u^i , one must appeal to experiment or to kinetic theory. The main problem here is that Eq. (1) together with the continuity equation involve 4 variables, and u^i . Thus, there are four equations

but ten unknowns assuming that the uid is isotropic and, therefore, ^{ij} is symmetric. So, we require knowledge of the constitutive equations relating ^{ij} to the set of local variables. When this procedure is accomplished, keeping all those terms which are at most quadratic in the gradients of and uⁱ we refer to it as the Burnett regime. How to accomplish this using kinetic theory is now brie y described. We assume that the uid is a dilute inert gas whose dynamics is governed by the Boltzm ann equation [3] [4]. For such a model, it is well known that through the Chapman-Enskog method one can obtain the solutions to the equation which are consistent with the macroscopic hydrodynamic equations. This is achieved by expanding the single particle distribution function in power series of the K nudsen parameter , which is a measure of the spatial gradients present in the gas, responsible for its deviations from the equilibrium states. W hen this procedure is carried over, one obtains, to order zero in the Euler regime, and to rst order in the N avier-Stokes regime with zero bulk viscosity, so that

where ^{ij} is the symmetric traceless part of the velocity gradient, is the shear viscosity, p is the local pressure, ^{ij} is K ronecker's delta and $\frac{\partial U^i}{\partial x^i}$. To next order in one gets the Burnett regime, in which ^{ij} becomes a rather complicated expression [4] containing both, nonlinear as well as linear terms in the velocity gradient. If we further assume that the gas is slightly deviating form its local equilibrium state, the linearized Burnett contribution to the stress tensor $\frac{ij}{B}$ is then given by:

In this equation s_2 is a transport ∞ cient whose value is known for rigid spheres and M axwellm olecules as well, $_{\circ}$ and p_{\circ} are the equilibrium values for the density and pressure, respectively and p the local pressure $p(x^i;t)$. ^{ij} in Eq. (1) is the total stress tensor, $_{NS}^{ij} + _{B}^{ij}$, where $_{NS}^{ij}$ is given in Eq. (2). When we add these contributions, take their divergence and use the local equilibrium assumption, p = p(;T = const), so that $\frac{@p}{@x^i} = \frac{@p}{@}\frac{@}{@x^i} = C_s^2\frac{@}{@x^i}$ one nally gets that the linearized B unnett approximation to Eq.(1) is given by:

where C_s^2 is the speed of sound.

The linearization procedure, which is identical to the one followed in a previous publication [14], has clearly invoked that local state variables and u^i deviate form its equilibrium values through linear uctuations, namely

The continuity equation now reads as

where $=\frac{(0 u^i)}{(0 x^i)}$. Eqs. (4)-(7) constitute the set of linearized coupled equations for and u^i which can be solved for a given conservative force f^i . In our case of interest, the external force density is taken to be the gravitational force and, m oreover, we assume that the uctuating part of the gravitational eld ' is governed by Poisson's equation

where G = 6:67 $10^{11} \frac{m^3}{kgs^2}$ is the gravitational constant.

To elim inate uⁱ from this set we simply take the divergence of Eq. (4) and make use of Eq. (8) plus the fact that $\frac{\theta}{\theta t}r = r \frac{\theta}{\theta t}$ so that after a straightforward arrangement of terms we not that

Eq. (9) is the main result in this calculation. It is a single equation describing the density uctuations of an isothermal uid when subject to the action of a uctuating gravitational eld taking into account all linearized contributions up to second order in the K nudsen parameter. Its implications on the Jeans number will be studied in the following section. Before we do so, how ever, it is interesting to point out the main features that in Eq. (9) originate from the B unnett approximation, those proportional to ². The one of fourth order in the spatial derivatives, the next to the last term in the left hand side, corresponds to what was to be expected. But the other one namely, the third term in the left hand side shows a coupling between the gravitational eld and the dynamics of the density uctuations. This coupling is totally absent both at the Euler and the N avier-Stokes level. Its implications will be discussed later.

3 A nalysis of the dispersion relation

In order to solve Eq. (9) we propose that the density uctuations are represented by plane waves, so that

where the amplitude A needs not to be specified and the rest of the symbols have their standard meaning. Substitution of Eq. (10) into Eq. (9) yields:

Eq.(11) is the sought dispersion relation from which we must exam ine the conditions leading to values of !, necessarily com plex, giving rise to runaway term s in Eq. (10). In fact, it may be rewritten as

W hen exam ining the roots of this quadratic equation we see that the runaw ay solutions require that ! be complex and the threshold values for k to m eet this requirement is that $a(k)^2 + f(k) = 0$. This condition reduces to a quadratic equation for the minimum value of k^2 namely,

Calculating the roots of Eq. (15), taking the root with the positive sign, $k^2 > 0$, and expanding the square root we nd, after a few trivial algebraic steps, that

where the ordinary Jeans wave number is given by $k_J^2 = \frac{4}{C_s^2} \frac{G}{c_s^2}$. Eq.(18) is the sought result. In its derivation we have consistently neglected all terms of order ⁴ and higher.

To what extent this result has an in uence on the ordinary Jeans num berw ill be discussed below. Twom inor points should be noticed. Firstly, if $\$_2 = 0$ the corrective term, which is of order of k⁴ is the one obtained within the Navier-Stokes approximation when ignoring the bulk viscosity [16]. Secondly, as we have pointed out initially, the Burnett linearized term s have to be included to have a consistent correction to order k⁴.

4 D iscussion

As Eq. (18) clearly indicates, the inclusion of the Burnett linearized term provides a contribution to the correction of k_J^2 which is opposite in sign to the one arising form the Navier-Stokes equations. This may have a signi cant e ect on the Jeans mass, which is inversely proportional to k_J^3 [6] [13] [15].

O nem ay now ask about the conditions in which dissipative e ects are indeed relevant in structure form ation problem s. In order to address this question we start with typicalm onatom ic gases such as H, He, Ar, etc which we know, are reasonably described by a hard-sphere m odel whose shear viscosity extracted from kinetic theory is given by [4]:

Here is the atom ic diameter, m the mass of the particles, k_B is Boltzmann's constant and T is the temperature of the system. The most relevant contribution will arise from the term within brackets. To estimate its value we recall that for hard spheres p_2 ' 2 and the equation of state is $p_o = \frac{oRT}{M}$, where R is the universal gas constant and M the molecular weight of the gas. Then, the correction is determined by the expression

U sing the equation of state, the value of \$ $_2$ and the fact that for a monatom ic gas $C_s^2 = \frac{5}{3} \frac{k_B T}{M m_H}$, then for hydrogen M = 2 whence Eq.(20) reduces to

Since 1:7 for m onatom ic gases, this equation nally reads as

Eq. (22) has to be taken as a result which requires some care before conclusions may be extracted from it. As we said in the introduction, the Burnett regime is an adequate form alism to deal with uids in the so called transition regime. This implies the regime prevailing between the rare ed regime and the continuous one. In the latter, the well-known N avier-Stokes equations of hydrodynam ics provide an accurate description of the uid. It appears that this transition regime could have prevailed in the U niverse for temperatures T 10⁴ (K) and densities 10¹⁵ $\frac{\text{kg}}{\text{m}^3}$, but these gures are merely qualitative. If such conditions existed, then Eq. (22) simply asserts that structure form ation would have been enhanced due to the coupling between hydrodynam ic and gravitational modes. Notice that this coupling is the dominant term of Eq. (21). C learly the importance of the correction critically depends on $_{0}$ and T. If $_{0}$ T

is larger than 10¹⁹ as it probably occurred in earlier stages, the correction \hat{C} will be negligible so that, in order to reach a more de nite statement, more reliable data is required. As a nalcomment, it should be mentioned here that in this calculation we have ignored taking into account the expansion in a commoving reference frame. Whether or not this improves the results is a subject of further study.
