SP IF F I observations of the starburst SM M J14011+ 0252:¹ A lready old, fat, and rich by z = 2.565

ABSTRACT

Using the SPectrom eter for Infrared Faint Field Im aging (SPIFFI) on the ESO VLT, we have obtained J, H, and K band integral eld spectroscopy of the z = 2:565 lum inous subm illim eter galaxy SM M J14011+ 0252. A global spectrum reveals the brighter of this spatially resolved system's two components as an intense starburst that is remarkably old, massive, and metal-rich for the early epoch at which it is observed. We see a strong Balmer break implying a 100 M yr tim escale for continuous star formation, as well as nebular emission line ratios implying a supersolar oxygen abundance on large spatial scales. O verall, the system is rapidly converting a large baryonic mass into stars over the course of only a few hundred M yr. O ur study thus adds new arguments to the growing evidence that submillim eter galaxies are more massive than Lym an break galaxies, and more numerous at high redshift than predicted by current semi-analytic models of galaxy evolution.

1. Introduction

D eep in aging in the optical and near-IR has made it possible to constrain both the evolution of the cosm ic star form ation rate density (e.g., M adau et al. 1996) and its time integral, the growth of the cosm ic stellar mass density (e.g., D ickinson et al. 2003). Short-wavelength studies give an incomplete picture of these trends, however, since an important population of high-redshift galaxies is too obscured to be easily detected. These submillimeter galaxies (SM G s; see B lain et al. 2002 and references therein) have large IR lum inosities that are predom inantly generated by star form ation rather than accretion (B arger et al. 2001; A lm aini et al. 2003); as a result, they contribute substantially to cosm ic star form ation (B arger et al. 2000). M oreover, as the strikingly di erent appearances of the H ubble D eep Field at 0:83 m (W illiam s et al. 1996) and 850 m (Hughes et al. 1998) exemplify, SM G s are rarer and form ing stars much m ore intensely than typical optically selected system s.

To understand the evolutionary state of SM G s, we have conducted a detailed rest-fram e optical case study using SP IFFI, the SP ectrom eter for Infrared Faint Field Im aging (Tecza et al. 2000; E isenhauer et al. 2000, 2003). Our target is SM M J14011+ 0252 (hereafter J14011), a z = 2.565 galaxy lying behind the z = 0.25 cluster A 1835 and the second SM G to have an optical counterpart identication (Barger et al. 1999) validated by CO interferom etry (Frayer et al. 1999). Recent m aps of J14011's molecular gas have led to divergent conclusions about its intrinsic size: Ivison et al. (2001) suggest that a large background source undergoes a factor M 2.5 m agni cation by A 1835 as a whole, while D ownes & Solom on (2003) argue that a fortuitously located cluster m ember further boosts m agni cation of a sm all background source to M 25. W e defer a full discussion of lensing to a future paper; here, we focus primarily on the lensing-independent conclusions of high age and m etallicity that can be drawn from J14011's global spectrum alone. Throughout the paper we assume a at = 0:7 cosm ology with H $_0$ = 70 km s 1 M pc 1 .

2. Observations and data reduction

In three SP FFI\G uest Instrum ent" nunsbetween February and April2003, we observed J14011 in the J, H, and K bands on Kueyen (UT2 of the ESO VLT). Weather conditions were extremely stable within and between nights, and the near-R seeing was better than 0.6° . SP FFI obtains simultaneous spectra for all pixels in a 32 32 array; our data were obtained with the 0.25° pixel scale, and with spectral resolving power R = 1500 at 1.3 m, 2000 at 1.6 m, and 2400 at 2.2 m. Individual exposure times in the three bands were 10, 5, and 10 m inutes, respectively; we obtained an \o " frame at a sky position (o set by 20° 25°) for each \on" frame, and jittered the telescope by two-pixel o sets

between the \circ m frames them selves. The total on-source integration times were 60 m inutes in J, 95 m inutes in H, and 340 m inutes in K.

We reduced the data within IRAF using modied versions of long-slit spectroscopy tools. A first subtracting dark frames and at-elding all data (object and sky frames), we masked out bad pixels and interpolated new values using all available three-dimensional inform ation. Object and sky frames were then wavelength calibrated using arc lamp spectra and/or night sky em ission lines. The \circ " sky fram es were then subtracted, and a linear t to the background was subtracted across each spectral and spatial row of the data. At this point the data cubes for each on-o pair were reconstructed, using only integer pixel shifts and assuming that each spatial row of the eld covered exactly 32 pixels; although this was not strictly correct, it only slightly reduced the spatial resolution and avoided loss of signalto-noise due to resampling. A nalbackground subtraction exploited the two-dimensional eld of view: objects in the fram e were masked out, and the mean of the remaining pixels in a given wavelength plane was subtracted from that plane. Using telescope o sets, we spatially aligned and then combined the data cubes, clipping any deviant pixels in each cell. Telluric correction was applied to the nalmerged cubes. Fluxes were calibrated by integrating SP IFFI observations of the UK IRT faint standard FS135 only over the M auna Kea Observatory J, H, and K Iter bandpasses; the reference photom etry of FS135 itself has a scatter of less than 1% (Hawarden et al. 2001).

3. Results

Figure 1 shows J14011 in continuum -subtracted H and line-free K -band continuum. W ithin the bright eastern \J1" component, the SP IFFI data reveal substantial spatial variation in H equivalent width: nebular emission is strongest away from the central continuum peak. A fler using this peak to align all three data cubes, we extracted a spectrum of J1 from the 2^{0} 1.5^{0} region shown in Figure 1. This box encloses about two thirds of the total continuum associated with J1 in the K -band cube, and virtually all the emission we detect in J and H. Figure 2 shows the result and reveals that J14011 has a continuum break between the observed J and H bands. The lack of a similar break in blank-sky spectra extracted from elsewhere in the SP IFFI eld proves that this cannot be an artifact of poor sky subtraction; the J H color of FS135, meanwhile, is accurate to 0.3% (Hawarden et al. 2001). The feature's most likely origin is the Balm er break of a 100M yr old stellar population at z ' 2:565. Quantitatively, the strength of the break can be reproduced by a population synthesis m odel constructed with the STARS package (Stemberg 1998) for a 200M yr old episode of continuous star form ation with a 1 100M solar m etallicity, and an extinction $A_V = 0.7$. A crucial implication of this result is that the near-IR continuum em ission must be dom inated by the high-redshift background source, rather than by a foreground cluster galaxy.

We have also used the spectrum in Figure 2 to measure uxes and centroids for eleven nebular em ission lines; taken together, they im ply J1 has a system ic redshift $z_{H II} = 2.5652$ 0.0006, in perfect agreement with the z_{CO} derived from millimeter interferometry (D ownes & Solom on 2003). Hem ission from the fainter western \J2" component is blueshifted by z = 0.00210:0003 with respect to J1, consistent with the o set measured by Ivison et al. (2000) from rest-UV spectra. The J1 line uxes allow us to measure the R_{23} estimator for its oxygen abundance (Pagelet al. 1979). A fter correcting for reddening with a Galactic extinction curve (Howarth 1983) and the color excess E (B V) = $0.18^{+0.13}_{0.12}$ in plied by the $I_{5007}=3$, we derive $\log(R_{23}) = 0.32$ 0:16. Translation Balmer decrement, and $xing I_{4959}$ of this index to an oxygen abundance depends on ionization parameter, as quantied by log (O₃₂) = 0:24 0:22. Using the ts of K obulnicky, K ennicutt, & Pizagno (1999) to the calibrations of M cG augh (1991), we infer that $12 + \log (O = H) = 8.96^{+0.06}_{0.10}$. Relative to the m easurem ent of Allende Prieto, Lambert, & Asplund (2001), this represents an abundance that is supersolar by $0.27^{+0.11}_{0.15}$ dex. A high [N II]/H ratio means J14011 cannot fall on the lower-m etallicity branch of the [O/H] vs. R_{23} relation.

4. The high m ass of J14011

A lthough we reserve a full lensing model of J14011 for a future paper, our SP IFFI data already allow us to evaluate the sm all source/high M and large source/low M scenarios. As noted above, the strength of the apparent B alm erbreak in J1 leaves little room for continuum em ission from an \extra" lensing galaxy in A1835. The new ly con im ed velocity di erence between J1 and J2, on top of Ly and C III] 1909 A equivalent width di erences in their published spectra (Barger et al. 1999; Ivison et al. 2000), indicates that these com ponents are not multiple in ages of the same background source, contrary to the suggestion of D ownes & Solom on (2003). Finally, SP IFFI spatially resolves J1 in an east-west direction; the observed $0.95^{\circ0}$ FW HM of H em ission exceeds the $0.65^{\circ0}$ east-west PSF dimension. This would not occur if J1 were form ed from the merging of a triple in age set.

These direct arguments for a low lensing magnication are nicely complemented by the wealth of self-consistent evidence that J14011 as a whole has a large mass and age. Our estimate of J1's high oxygen abundance is independent of M , provided there is minimal di erential lensing from 3726 to 5007 A rest wavelength. For a closed-box model with solar yield, this metallicity corresponds to a gas/baryonic mass fraction of exp (Z=Z) ' 0:16.

Frayer et al. (1999) m easure a 82 10^{10} M 1 K km s 1 pc² CO (3{2) line lum inosity for J14011. For gas that is dense and warm enough to produce detectable CO (7{6) em ission, D ow nes & Solom on (2003) suggest that m olecular gas m ass and CO lum inosity are related by M gas=L⁰_{CO (3 2)} = 0.8M (K km s 1 pc²) 1 . Adopting M 5 as a ducial value for the cluster only lensing case, we infer a molecular gas m ass M gas ' 1:3 10^{10} M , and therefore a total baryonic m ass M _{bary} ' 7:9 10^{10} M and stellar m ass M _{stars} = M _{bary} M _{gas} ' 6:6 10^{10} M . This last value (and with it, our assumption of moderate M) is empirically supported by the m ass-m etallicity relation, as recently rederived by Trem onti et al. (2004) from a sample of 51;000 galaxies at z 0:1. Their favored translation of R₂₃ to m etallicity gives 12 + log (O=H) ' 9:1 for J1, at which the median stellar m ass is 6:2 10^{10} M

For a sinple closed-box model, assumption of continuous star formation and a return fraction R = 0.2 uniquely sets the length of time for which a galaxy has been forming stars: $t_{SF} = fexp$ (Z=Z) 1g (1 R) ¹M _{gas} SFR ¹. For J14011, t_{SF} will be independent of lensing because M _{gas} and SFR depend identically on M. We can estimate the star formation rate in J14011 from its $S_{850} = 12.3$ M ¹m Jy (Sm ail et al. 2002); for the ducial SED of B lain et al. (1999) with $T_d = 40$ K, = 1.5, and = 2.2, L_R ' 1.9 10^{12} (S₈₅₀=m Jy) L = 2.3 10^{13} M ¹L. Adjusting the conversion factor of K ennicutt (1998) to match a 1 100 M Salpeter MF, we infer SFR ' 1920 M ¹M yr ¹ and t_{SF} ' 220 M yr. This age is consistent with the strength of the Balm er break seen in Figure 2, suggesting that the closed-box assumption m ade above is not unreasonable. J14011's powerful starburst thus appears to be converting m ost of its baryons into stars on a fairly rapid (few hundred M yr) timescale.

5. The high m asses of SM G s

Its star form ation history and m etallicity allow J14011 to join SM M J02399-0136{ whose M _{bary} G enzelet al. (2003) infer from its spatially resolved gas kinem atics{ as an SM G whose large baryonic m ass is secure. Thanks to CO con m ation of K eck/LR IS redshifts obtained by C hapm an et al. (2003b), this category prom ises to expand rapidly. N eriet al. (2003) have published CO data con m ing the K eck redshifts for three new SM G s; the totalset of ve has hzi = 2:72 and a m edian CO linew idth of 420 km s⁻¹ (FW HM). A fruitful com parison can be m ade between this SM G sam ple and the well-studied Lym an break galaxy (LBG) population at z - 3. In the list of sixteen LBGs for which Pettini et al. (2001) report ionized gas kinem atics, the m edian velocity width is 170 km s⁻¹ (FW HM) at a slightly larger hzi = 3:12. A ssum ing that the (few kpc) size scales of the starbursts are com parable in LBG s and SM G s, the higher velocity widths in ply SM G s' dynam icalm asses should also be larger by a typical factor of 6. If the two populations' dark m atter fractions are com parable, we would expect a

m edian SM G baryonic m ass exceeding the m edian 1:1 10^{10} M stellar m ass estim ated for 74 LBGs (Shapley et al. 2001)⁶ by the same factor, i.e., 6:6 10^{10} M . A lthough the strong clustering of LBGs (e.g., G iavalisco & D ickinson 2001) suggests they share their host halos with m uch m ore baryonic m ass than is seen in their inner regions, SM G s appear already to have assembled m easurably larger m asses of baryons, or to have been m ore successful in retaining those baryons in the face of energetic winds. C om plem entary constraints on the star form ation histories and m etallicities of m ore SM G s, like those obtained here for J14011, would further strengthen this case.

In the hierarchical merging scenario for structure form ation, massive galaxies are assem bled in greater num bers with the passage of time. As several authors have pointed out, the observed number densities of high-redshift galaxies with large stellar masses exceed the predictions of sem i-analytic models of galaxy evolution within this fram ework (C in atti et al. 2002; Daddiet al. 2004; Saracco et al. 2004). As in Genzel et al. (2003), we can also use the num ber densities of SM G s to apply the sam e \baryonic m ass assembly test" to the models. Smail et al. (2002) report the surface density of SMGs with $S_{850} > 5m$ Jy (the threshold above which SMG optical redshifts 1:8 Z 3:5 have been con med with CO interferom etry) to be $880^{+530}_{330} \text{ deg}^2$. The Chapman et al. (2003b) sample includes two (of nine) sources above this threshold lying at z < 1.3, and excludes the 35 5% of bright SM G s that lack radio counterparts (Ivison et al. 2002; Chapm an et al. 2003a). Two of the 510 km s¹ FW HM line widths that would correspond ve SMGswithCO detections have 10¹¹ M by the above rescaling of LBG stellar m asses. This leaves an estim ated to M _{bary} surface density of 180^{+110}_{70} deg ² for SM G s with baryonic masses $10^{11} \, {\rm M}$ in the range 3.5, and a comoving number density of $8.9^{+5.3}_{-3.3}$ $10^{6} M pc^{3}$. 1**:**8 z

W e must still correct this density upward to account for sources that are com parably m assive but no longer lum inous enough to have been detected at 850 m. Adding $t_{\rm SF}$ and the gas exhaustion timescale M $_{\rm gas}\,{\rm SF\,R}^{-1}$ for J14011 implies that the total duration of its current burst will be of order 250M yr. Relative to the 1.8G yr elapsed over the range 35, this would imply a correction factor of 7 for the population as a whole. 1:8 z Figure 3 plots this prediction, together with the com oving num ber densities of galaxies with stellarm asses above the 10^{11} M threshold at z 0 (Cole et al. 2001) and z 1 (D rory et al. 2004). A loo plotted are the predictions of sem i-analytic models, one of which is taken from Kau mann et al. (1999) and the other an update of Baugh et al. (2003). Since all theoretical and observational values assume the same cosm ology and a consistent (either M iller-Scalo Salpeter) IMF, we are secure in concluding that the models underpredict or 1 100 M

the number densities of massive galaxies at z 2:7. Couching Figure 3 in terms of mass emphasizes that the observed surface densities of SM G s cannot be explained using a very at IM F alone. We also note that the models contain su ciently many dark halos of total mass 10^{11} ($_{\rm M} = _{\rm b}$) M to account for the observed number densities of massive SM G s, provided their baryons can be rapidly and e ciently assembled into galaxies.

Correcting the observed num ber density of SM G s to account for their less dust-lum inous descendants raises the question of what types of galaxies SMGs can plausibly evolve into. A lthough LBG s are clearly excluded due to their sm aller m asses, an intriguing alternative is the new ly identi ed population whose red J K colors can stem from a strong Balmer break 2.5 (Franx et al. 2003). These galaxies appear to be strongly clustered (D addiet al. at z 2003) and { assuming a uniform distribution in the redshift range 2 z 3:5 (van Dokkum 10⁴ Mpc³. Relatively few sources et al. 2003) { have a com oving num ber density 1:8 K > 2.3 also have 1.2 mm ux densities > 3 mJy (D annerbauer et al. 2004), with J indicating little direct overlap with the bright end of the SM G population (see also Frayer et al. 2004), although fainter (sub)m illim eter counterparts m ay still be present (e.g., W ehner, Barger, & Kneib 2002). With three examples in the HDF-S having (for a Miller-Scalo IMF) $10^{11}\,{
m M}$ stellarmasses (0:6 1:4) (Saracco et al. 2004), it would seem plausible that the more lum inous objects with red J K colors at this epoch could have passed through an SM G phase at higher redshift.
